# Introduction

The Western idea of landscape, as a means to comprehend space in an intellectual, economic and aesthetic sense, is often considered to be the product of new environmental relations that developed at the beginning of the early modern period. According to cultural geographers, “[l]andscape first emerged as a term, an idea, or better still, *a way of seeing* the external world, in the fifteenth and early sixteenth centuries” (Cosgrove, 1985: 46-47), in connection with the emergence of individual land ownership and a “new spirit of place identity” (Olwig, 1996). The specific artistic practices and techniques—such as linear perspective—that were developed at about the same time and allowed the emergence of landscape as a pictorial genre and aesthetic concept (Gombrich, 1966; Cauquelin, 2000) have been said to partake of the same political operation of representation, which conferred both economic and cultural power over the natural world (Cosgrove, 1985; Williams, 1977). The golden age of Dutch landscape painting of the seventeenth century, whose relevant intellectual contexts are less related to linear perspective than to the art of surveying, is inextricable from economic and ideological concerns of land ownership and the political freedom to picture the land as a map (Alpers, 1983: 148-149). In addition, as Lytle Shaw suggests, Dutch painters such as van Goyen and Ruisdael showed Holland as “an intricate landscape made entirely by man” and their paintings were “performing dramatic re-enactments [...] of the Dutch creation of Holland” (Shaw, 2012: 82).

While these orientations point to growing confidence and increased control over space, the aestheticization of the natural world has also been understood as a form of separation from the latter. Landscape, it has been pointed out, is necessarily a cultural mediation, only possible at a remove, from the moment the viewer is no longer

immersed in the land (by working it for example) and perceives it in a cultural or aesthetic manner. As Raymond Williams argued, “a working country is hardly ever a landscape. The very idea of landscape implies separation and observation” (Williams, 1973: 120). Or, to use Malcolm Andrews’s words: “Landscape, whether as *parergon* or Argument, is mediated land, land that has been aesthetically processed. It is land that has arranged itself, or has been arranged by the artistic vision, so that it is ready to sit for its portrait” (Andrews, 1999: 7). Such a separation from the natural world has been connected with the development of urbanization in the early modern period. Alain Roger, for instance, argues that the perception of landscape is specific to city dwellers, whose culture and distance from nature it presupposes: “La perception d’un paysage, cette invention de citadins, [...] suppose   la fois du recul et de la culture, une sorte de *reculture* en somme” (Roger, 1997: 26).

Anthropologists and geographers have insisted on the fact that landscape can also be defined as lived and built (Voisenat, 1995; Descola, 2013). Art historians have also reflected on the nexus of representing, constructing and experiencing space. One of the reasons why the art historical term “landscape” is so “desperately confused” has to do with the fact that it is “both our subject and the thing within which we exist” (DeLue and Elkins, 2008: 8-9). W.J.T. Mitchell’s thesis that “landscape is not a genre of art but a medium” (Mitchell, 2002: 5) grasps the double-edged character of the notion. As Olwig puts it, the notion of landscape lies at the intersection of “domain” (which belongs to the discourse of politics, economics, society) and “art of place” (which belongs to the discourse of aesthetics) (quoted in DeLue and Elkins, 2008: 158). The word thus contains two different words which have become intertwined.

Landscape may be understood as a perceived space to which is given aesthetic value, but also as a construct whose necessity seems to have arisen from an original separation. Beyond this initial separation, the history of the idea of landscape is articulated by episodes of tension between nature and culture, in which the urge to aestheticize natural environments appears to be related to a sense of loss. The idea of landscape both provided a solution and evolved to adapt to changing circumstances. Just as the drift away from the rural world, at the dawn of the modern period, is contemporaneous with the initial development of the idea of landscape—although not always directly correlated to it as Alpers’s analysis of Dutch landscape painting suggests (Alpers, 1983: 152)—the flourishing of landscape painting and nature poetry in the Romantic period could be seen as a response to industrialization and destruction. The success of the American sublime in the second half of the nineteenth century points to a need to capture—and also construct as part of the national myth—the fantasy of an untouched wilderness, at the same time as it was receding. As Braddock and Kusserow point out, 19<sup>th</sup> century American landscape painting (Cole, Moran, Bierstadt) inherited European aesthetic conventions and institutionalized a model of viewing the West and the national parks which prompted the neglect of other natural environments considered to be less impressive and less worthy of

attention (Braddock and Kusserow, 2018: 12-43). The resurgence of pastoral themes in British literature and arts of the 1930s and 1940s is intricately connected with the sense of decline conveyed by the succession of depression and war.

The premise of this issue of *Recherches Anglaises et Nord-Américaines* is that the current environmental emergency is not only a new moment of tension and loss, but possibly an ultimate crisis, one that has so considerably altered the balance between human and natural habitats that the idea of landscape itself needs to be re-examined, and new artistic and aesthetic spatialities need to be negotiated. We seek to highlight the environmental, social and political stakes of landscape, reflect on the entanglements of man and nature as represented in literature, art and film, and consider the assumptions and perspectives that cultural representations and practices offer to current discussions of the Anthropocene.

Rival conceptions of the Anthropocene have been formulated and polemical debates about its starting date exist. The age of Anthropocene is defined as an epoch in which ecological transformations driven by human activity are taking place on such a scale that they leave a perceptible trace on the planet's geological record. Paul Crutzen, who contributed to the recent popularization of the concept, traced its origins to the first industrial revolution and the invention of the steam engine by James Watt in the late 18<sup>th</sup> century, as it marks "the beginning of growing global concentrations of carbon dioxide and methane" (Crutzen, 2002). This first stage of the Anthropocene is often considered to have paved the way for a much more radical second stage, referred to as the "Great Acceleration," which is considered to have unfolded from the early days of the atomic age in 1945 (Steffen et al., 2004; McNeill and Engelke, 2016; Williston, 2015 and 2016; Waters et al., 2016). Since then, "the human impact on the Earth and the biosphere, measured and judged in several different ways ... has escalated" (McNeill and Engelke, 2016: 4). The planetary changes caused by human consumption and urbanisation have been perceptible in dramatic ways, what with global warming, the rapid decrease of natural habitats, the disappearance of animal and vegetal species at an unprecedented pace, or the growing levels of visible and invisible pollution. The pressure exerted by human action on ecosystems has been such that in many cases its effects are considered to be irreversible. While observers who lived through the first industrial revolution could still see nature as a force to reckon with and pondered about the frailty of human intervention and its ultimate erasure with the passing of time, contemporary observers note above all the growing imprint of humanity, the shrinking place of nature at a planetary level, and the growing awareness of the fact that Earth's natural resources are finite (Latour, 2015). The concept of Anthropocene and its implementation have been largely discussed and critiqued by the social sciences, for relying on universalist and anthropocentric assumptions (Demos, 2017), excluding whole populations from the "Anthropos" and remaining racially blind (Yusoff, 2019), depoliticizing the issue of ecology, masking the inherent inequalities in the



face of the climate and environmental crises, or minimizing the role of capitalism in the catastrophe (Beau and Larr  re, 2018). Still, the term provides a useful framework to analyze the evolutions in the artistic representations of landscape, to reflect on the current renegotiations of the boundaries between nature and culture and to reassess the relevance of aesthetic perceptions of space. Braddock and Kusserow, in the introduction to *Nature's Nation*, discuss the critical charge against the term "Anthropocene," but decide to preserve it for a variety of reasons: it appears preferable to other alternatives ("Capitalocene" or "Chthulhucene"<sup>1</sup>), it "productively refracts and reframes the history of art" and offers a far-reaching periodization that blurs the distinction between human and geological history (Braddock and Kusserow, 2018: 12). Similarly, Vermeulen contends that the term "becomes useful if we accept that it is inevitably a misnomer" (Vermeulen, 2020: 9) and proceeds to use it in his study of literature and the Anthropocene. We will also keep this nebulous and difficult term which remains intellectually productive.

With the rapid degradation of our natural environments and the observable disjunction between the economic uses of territories and their aesthetic value, the need to give aesthetic meaning to the spaces in which we live has been more pressing than ever. Some recent exhibitions and publications have drawn attention to the continued relevance of the landscape idea and of landscape strategies that were developed to address earlier environmental crises. The aesthetics of the sublime has notably been invoked as a means to address the current sense of helplessness in the face of irremediable destruction, as well as convey ecological disaster (Guenin, 2016). Other strategies have consisted in challenging this Western-centric aesthetic which has historically been used to erase Indigenous people from the represented landscape, hence justifying their erasure from the actual territory. Contemporary Indigenous artists and researchers thus challenge the colonial narrative of a pre-anthropized land as well as the concept of Anthropocene itself, claiming it is intrinsically linked with the colonial project of severing "relations between mind, body and land," and can thus only be addressed by recognizing the value of Indigenous knowledge (Davis and Todd, 2017). Along similar lines, Mirzoeff urges for a "planetary countervisualisation" to the Anthropocene, a resistance to the forces that have made the Anthropocene possible. Part of this resistance lies in an attempt to reinterpret Western art with a critical eye. Mirzoeff shows that many famous examples of Western painting (Monet's *Impression: Sun Rising* of 1873, for instance) implicitly visualize anthropogenic effects (smog) but are not perceived as such, which leads him to describe an anaesthetic effect, or an "Anthropocene An(aesthetics)"

(Mirzoeff 2014: 220). The term “critical” is an important one and it keeps resurfacing in discussions of art, literature and the Anthropocene. The critical components in contemporary art practices have been emphasized, in particular the attempts to engage with the politics of land use, border conflicts, climate change and normative spatial representation (Scott and Swenson, 2015). The landscapes thus emerging are necessarily “critical landscapes” and the contemporary artists who imagine them negotiate distinct art historical legacies and rely on distinct frameworks or disciplines. Thus, the legacy of Earthworks and Land Art is fundamental for some, while others mobilize references from geography, urban planning, geopolitics, also embracing activism. Scott and Swenson aptly call this heterogenous constellation a “critical mass of land-focused practices” (Scott and Swenson, 2015: 1). Land Art and Earthworks, from which sprang a plethora of artistic expressions later on, remain important references for understanding the conceptualization and practice of landscape art beyond painting and into sculpture, installation, video and performance art (Kaiser and Kwon, 2012: 31). The notion of “site” in Earthworks and Land Art sought to abolish the distance between observer and the space observed, between artist and environment thought to be inherent in earlier landscape painting, by introducing concrete elements from the site (rocks, earth) in the representation of the latter and thus rematerializing an abstract and removed relation. For Robert Smithson, this opened up the possibility of a “representation without resemblance” (Smithson, 1996: 364). This abolished distance, which went hand in hand with a refusal of the idealization of nature and of any proprietary claims over it, was and still is considered to be a salutary basis for a positive reconfiguration of the relationship between man and the environment (Demos, 2016). The notion of “landscape” is present in certain studies on the relationship between art, literature and the Anthropocene, as we saw in Scott and Swenson (2015) and also in *Arts of Living on an Endangered Planet*, where it features from the very title of the introduction (“Haunted landscapes of the Anthropocene,” Tsing et al., 2017) and is expanded throughout the volume. The notion is not elaborated on in *Art in the Anthropocene* (Davis and Turpin, 2015), for instance, nor in *Broken Nature* (Antonelli and Tannir, 2019), which prefer to use other terms such as “nature” or “environment.”

The prominent visual dimension present in the notion of “landscape” tends to create a strong association with a specific pictorial genre, but the notion is highly relevant for literature and literary studies as well. The “scape” in landscape refers both to the scopic regime and to the shaping of the land, which are both central to spatial representations in literature. In European Romanticism, the centrality of nature, the rise of landscape painting and the onset of the Industrial Revolution articulate landscape and the Anthropocene in many ways, having to do not only with the expression of a lament over natural destruction, but also with the attitude of nefarious idealization of nature that we have already mentioned. The tension and opposition between countryside and urban spaces becomes particularly prominent

in Romantic literature and is exacerbated in the early 20<sup>th</sup> century in the literary productions of modernism, both in Europe and North America. In the United States, landscapes abound in 19<sup>th</sup> century art and literature, where the American landscape placed under the sign of the rhetoric of the wilderness becomes a national symbol (pitted against the cultured landscapes of Europe) and also the focus of colonial expansion. Ironically, just as the American landscape was celebrated, its shaping involved destructive exploitation and the parallel creation of national parks. While some writers, like Cooper, presented an already vanishing wilderness in his novels, others like Thoreau focused on the texture of the familiar in Concord, Massachusetts and elaborated an environmental imagination that influences American culture to this day (Buell, 1995). Within the large body of studies on literature and space, on literature and the Anthropocene, the notion of “landscape” is more present in certain studies than in others. Gersdorf, for instance, points to its absence from most studies of 20<sup>th</sup> century American literature and considers it a very useful concept that she deploys in a study of literary representations of the American desert (Gersdorf, 2019). The notion of “landscape” also features repeatedly in Pieter Vermeulen’s recent *Literature and the Anthropocene* (2020), where the term refers to the mutual shaping of humans and environment as represented in literary texts. Studies of the Anthropocene in literature insist on the relevance of the latter in reflecting critically on our present condition, on the necessity to uncover the contemporary legacy of existing literary and intellectual traditions of thinking about nature (pastoralism, Romanticism), in continuously revisiting and enriching ecocritical theory and in investigating alternative spatialities and practices of thinking and writing about nature that are the blind spot of the dominant model of the Anthropocene. The analysis of literary and artistic discourses of women, minorities, the dispossessed and the formerly colonized seeks to “provincialize” the Anthropocene and deprive it of its universalist assumptions (DeLoughrey, 2019: 2).

This volume aims to explore the notion of landscape and its current relevance, as well as the possibility of new aesthetic spatialities, with a focus on the English-speaking world. The latter’s unique experience of the first industrial revolution, coupled with its colonial experience, means that it has long engaged with some of the environmental issues of our times (Bate, 1991; Davies, 2018), and developed the landscape idea in a way which resonates within the work of contemporary artists, as several articles in this volume show. Its early artistic response to the first stage of the Anthropocene provided long-lasting strategies to express the sense of disconnection from natural environments that has recurred throughout the industrial age, but also to cope with it, often in idealized and nostalgic representations of a fast-vanishing rural world. Constable’s paintings of rural Suffolk come to mind, as well as the ubiquitous picturesque idiom used by artist travellers from the late eighteenth century onwards. At the same time, the history of Britain and its former colonies over the last two and a half centuries has demonstrated the dangers of aestheticization, of

viewing industrialized, colonized and deforested lands through the conventions of the pastoral, the picturesque or the sublime, and thus of using landscape aesthetics as a denial of environmental destruction or as a tool for spatial appropriation.

The mediation of former landscape aesthetics, and the way they have informed more recent perceptions and representations of contemporary natural scenery, is examined in several articles, some of which look to Romantic aesthetics as revealing an early form of environmentalism and response to the first stage of the Anthropocene, while others examine the tensions between the possibility of escapism or idealization that these earlier conventions of landscape have offered and environmental concerns. Pascale Guibert draws suggestive analogies between Wordsworth's strategies for reconnection with nature and Gloria Anzaldúa's reflections, in her *Borderland* poems, about ways of healing both the Earth and our interaction with it. Mark Niemeyer's study of *The Last of the Mohicans* shows how Cooper's use of the aesthetics of the picturesque and the sublime partook of the construction of an idealized American wilderness that was to be central to the creation of a distinctive American literature. Elin Käck examines the representation of nature in modernist poems published in *The Dial*, focusing on the way they articulated tradition (pastoral conventions in particular) and an awareness of shifting relations between nature and culture. In her study of the wartime paintings of John Piper and Paul Nash, Hélène Iбата explores the Romantic influences that were still at work in their approach to landscape, arguing that both artists used them with critical distance and a new awareness of irremediable human destructiveness. Claire Omhovère's article refers to the way pastoralism is deconstructed in the works under scrutiny and to the survivance of the codes of the sublime in the visual representations of petrosapes in the case of the "Oil" series by Canadian photographer Edward Burtynsky (1999-2010). Certain articles discuss the contradictions between idealized depictions of the wilderness (North American, but not exclusively) and the reality of natural destruction, as Mark Niemeyer shows in the case of Cooper. Monica Manolescu's article also reflects on the way art historical traditions are reworked in the work of two major 20<sup>th</sup> century artists, Helen Mayer and Newton Harrison, which revisits certain procedures inherited from Land Art. Sophie Gergaud's article similarly engages with canonical cinematographic representations of Indigenous peoples and landscapes, and representations produced by Indigenous peoples themselves in order to reclaim their proper place in North American space and history.

Some of the articles also share terrain insofar as they elucidate the shifts in geographical imagination that have occurred since World War II, resulting in a more interconnected world, a new understanding of environmental issues at a global level and a growing awareness of the frailty of the Earth, in the postindustrial and atomic age. This new geographical imagination necessarily led to new representations and practices of space, as becomes clear in the articles written by Monica Manolescu, who examines climate change and pollution in *The Lagoon Cycle*, Cécile Whiting,

who analyzes war representations in Peter Blume's *The Rock* and Claire Omhovère, who explores Canadian literary and artistic petroscares. The scale of modern warfare plays an important role in some of the articles, with parallels drawn between wartime destruction and the human impulse to damage the environment, as Cécile Whiting and Hélène Ibata show.

Several articles converge in addressing Indigenous and minority aesthetics and practices of space. They examine the confrontation with normative settler narratives tending to render them invisible. This is the case in Mark Niemeyer's elucidation of the Native American presence within the construction of the wilderness in Cooper, in Sophie Gergaud's analysis of cultural resistance and visual sovereignty in Indigenous cinema, in Claire Omhovère's discussion of the subversive connotations of the representation of oil in minority discourses, in Pascale Guibert's exploration of the renewed potential of landscape in Anzaldúa's poetics and in Monica Manolescu's reflection on how *The Lagoon Cycle* unveils the decline of the traditional dam system and of a depleted species in the lagoons of Sri Lanka.

Formal experimentation in literature as a means to address or at times heal the divisions between human and natural worlds is explored by several contributors. Elin Käck's analysis of anthropomorphism and of the bodily act of looking in modernist poetry, as well as Pascale Guibert's interpretation of Anzaldúa's text as the locus where the process of bodily reconstruction merges with that of reconciliation with the natural world, demonstrate the importance of textual form as a meeting ground and a place to reinvent landscape. Claire Omhovère examines postwar and contemporary Canadian narrative forms that are traditionally considered less noble than the novel (short stories in particular), that dare present petroscares otherwise absent from novels, that rely on irony or parody and that dramatize point of view to show the complicity between viewer and landscape. Monica Manolescu considers the hybrid nature of *The Lagoon Cycle* (textual and visual), in particular the graphic means employed by the artists Helen Mayer and Newton Harrison (use of extra blanks within verse) to suggest a dialogic approach to the ecological reshaping of the landscape.

The present issue thus highlights writers' and artists' use and awareness of existing conventions and their connotations, as well as their quest for new spatialities that would enable a more responsible approach to environmental issues. Can the writers' and artists' take on the natural world be anything other than an acknowledgement of irremediable change? Can they, as in the past, reclaim the ruins of the world in order to find in them fragments of new compositions? Or should they inevitably remind us of reality by confronting us with the scars of nature or the signs of humanity's destructive action? Is the paradigm of landscape still relevant in such a context? Can earlier forms of landscape, that were evolved to deal with past crises, provide partial solutions, or should we consider as some have claimed that we are living in a "post-landscape" era (Wall, 2017) and that new artistic practices of space are

necessary? These are some of the questions that are addressed by the authors of the following texts, which focus on contemporary literary and artistic spatialities while highlighting the aesthetic traditions that they engage with.

### ***Keeping Humans Out of the Picture: The (Almost) Pristine Wilderness of The Last of the Mohicans***

This article examines the depiction of the wilderness in James Fenimore Cooper's *The Last of the Mohicans*. It begins by recalling that in the early decades of the nineteenth century, descriptions of pristine landscapes were relatively common in American writings, whose authors were often striving to create a distinctively national literature for the new country. Cooper drew on the traditions of the picturesque and the sublime and made use of "painterly" techniques to create a "constructed" wilderness setting for his romance. By 1826, however, when the book was published, the American environment was already in the process of significant transformation, not to say devastation, brought about by human activity. And some people, including Cooper, were already decrying this destruction. In *The Last of the Mohicans*, however, the author does not address environmental questions directly, as he had, for example, in his previous work, *The Pioneers*, but rather offers an image of untouched nature—of the way things used to be. Cooper does nevertheless incorporate reminders—which are all marginalized in one way or another to keep them out of the literary picture he creates—of the fact that the American landscape was already in the process of undergoing disfiguring change.

## *A Landscape for Early 20<sup>th</sup>-Century Poetry: Pastorals of the Little-Magazine Avant-Garde*

This article considers four poems published in the little magazine *The Dial* in its 71<sup>st</sup> volume, which appeared in 1921. A forum for the transnational avant-garde at the time and home to Modernist poets such as Marianne Moore, Ezra Pound and others, this magazine provides insight into the main concerns of the writers of its time and constitutes a space where the relationship between Modernism, pastoral, landscape, and geology is explored. Marianne Moore's "A Graveyard," Hart Crane's "Pastorale," Maxwell Bodenheim's "Summer Evening: New York Subway Station," and Malcolm Cowley's "Mountain Valley" will be discussed together with both historical and more recent theories on landscape and aesthetics, nature, and the Anthropocene, including Alexander Blok's response to the 1908 earthquake in Sicily and Ludwig Mediner's 1914 call for new forms and techniques for the representation of urban environments in the visual arts. Placing these poems in a conversation with both contemporaneous and more recent theories on landscape and aesthetics, nature, and the Anthropocene makes it possible to discern how these poets' awareness of the aestheticizing practices involved in representations of nature informs their work, and to understand how they work to destabilize simplistic nature-culture dichotomies.

## *A questionable 'pleasure': Ruins in John Piper's and Paul Nash's wartime landscape paintings*

The resurgence of Romantic influences in British art, from the late 1930s through the 1940s, has often been understood as an escapist answer to the turmoils of the time, and a longing for a lost pastoral idyll. This essay, which focuses on the wartime production of John Piper and Paul Nash, argues that while Romantic associations were undeniable and painters harked back to the landscape aesthetics of the late 18<sup>th</sup> and early 19<sup>th</sup> centuries, such references were both self-conscious and critical. It suggests that just as they engaged in a dialogue with the traditions of the picturesque and the sublime, Piper and Nash underlined the impossibility of a return to these earlier strategies. Their awareness of an irreversible disjunction with the natural world meant that far from providing a reassuring refuge, their wartime landscapes and ruin paintings mostly made it apparent that the aestheticisation of devastation was in itself problematic, and that the artist had to confront the destructive impact of human action.

The work explores the lagoon as *topos* that stands in between the concreteness of site and the abstraction of metaphor. The article discusses the genealogies of the artists in relation to their use of site and their inscription in a critical reflection on landscape, it elucidates their use of fieldwork as a cultural practice and it uncovers the performative and conceptual dimensions of the lagoon. The main objective of *The Lagoon Cycle* is not to successfully restore degradation, even if a lot of speculative energy is channelled towards imagining the technological, economic and pragmatic frameworks that would make it possible. As a conceptual project whose utopian ambitions prevent it from materializing, *The Lagoon Cycle* asserts the role of art in elaborating an ethics and aesthetics of attention, in reflecting critically on the present and in projecting the
