1 The end of the word

(1) General

- a. This talk contributes to the debate on the representation of **word edges**.
- b. We discuss the status of the end of words in three unrelated languages: Italian, Bosnian and (Mandarin) Chinese.
- c. We assume the theoretical framework of Government Phonology (Kaye et al., 1990) in general; the CV-hypothesis (Lowenstamm, 1996) and the Theory of Elements in particular (Kaye et al., 1985).
- d. We follow a syntactic approach to word formation (Distributed Morphology, Halle & Marantz 1993; Embick 2010).

(2) Goals

- a. To argue for the existence of an underlying final CV unit.
- b. To sketch the shape of a minimal word in Italian, Bosnian and Chinese

(3) How morphosyntactic information is analyzed in phonology (see Scheer 2011) ?

- In CVCV approach, it has been argued that the minimal unit handled by morphosyntax is CV (Lowenstamm, 1999, 2003; Guerssel & Lowenstamm, 1990).
- Templatic restrictions have been detected in languages other than Semitic: Portuguese (Brandão de Carvalho, 2004), German (Bendjaballah & Haiden, 2003), Czech (Scheer, 2003), Somali (Barillot, 2002), Turkish (Denwood, 1998), etc..

(4) In this talk, we propose, following ideas previously found in Afuta (2002); Charette (2006) and Passino (2008), that minimal words in Italian, Bosnian and Chinese end in a CV unit.

2 Final CV in Italian

- (5) It is a well known fact that:
- Italian roots do not display templatic restrictions
 - The overwhelming majority of Italian words end in a vowel.
- (6) Italian nouns
- VARIABLE nouns end in a **vowel**:
 - the final vowel is **unstressed**
 - the final vowel **changes** between the singular and the plural
 - INVARIABLE nouns:
 - end in a stressed vowel, *città* ‘town(s)’
 - end in a consonant (= loans), *film* ‘movie(s)’
 - are truncated forms of variable nouns, *moto* ‘moto(s)’ (*motociclett-a/e*)

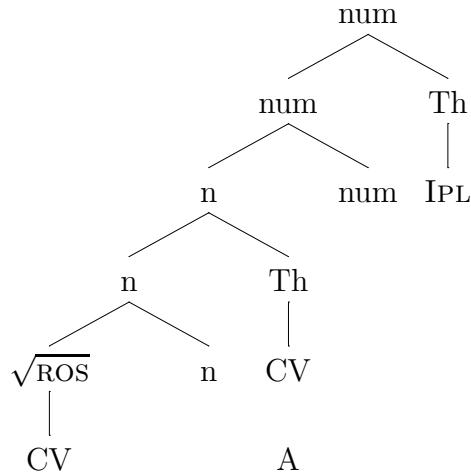

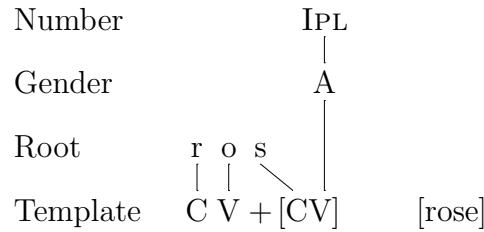
- (7) The final vowel does not enforce a phonological constraint avoiding final Cs:
- consonant-final nouns exist, *film* ‘movie’;
 - if the final vowel were an epenthetic vowel, we’d expect only one and not four different ones;
 - some final-hiatus words exist: *mare-a* ‘tide’, *nucle-o* ‘nucleus’, etc...
- (8) Consonant-final nouns:

- (9) The representations in (8) show two things:
- the final vowel is not a phonological object
 - the final V slot remains empty (contra the traditional view of Italian empty nuclei)

- (10) The final vowel is a morpho-syntactic object:
- it is the exponent of gender and number,
 - it appears under a specific lexical condition: following Lampitelli (2011, 2014), we assume that this corresponds to the presence of the feature **Theme Element** (henceforth [TE]):
- [TE] is a lexical property of the root
 - It spells out as a CV unit
- (11) The representation of roots
- 'wolf' $\iff \begin{array}{c} l \ u \ p \\ | \quad | \\ C \ V \end{array}$
 - 'rose' $\iff \begin{array}{c} r \ o \ s \\ | \quad | \\ C \ V \end{array}$
 - 'movie' $\iff \begin{array}{cccc} f & i & l & m \\ | & | & | & | \\ C & V & C & V \end{array}$
- (12)
- Roots like $\sqrt{\text{LUP}}$, $\sqrt{\text{ROS}}$ have floating consonant (in other words, **they need a template**);
 - Roots like $\sqrt{\text{FILM}}$ have a fully formed template.
- (13) Basic structures of *lupo* 'wolf' M sg, *rosa* 'rose' F sg, *cane* 'dog' M sg:

- (14) Final vowels can be decomposed (Kaye et al., 1985):
- $[\text{a}] = /A.I/$
 - $[\text{o}] = /A.U/$
 - etc...
- (15) Each Element is the exponent of either number or gender (Lampitelli, 2011):
- Element $/A/ = \text{sg}$
 - Element $/I/ = \text{pl}$
 - Element $/A/ = \text{F}$
 - Element $/U/ = \text{M}$

- (16) Complex head of *rose* F, pl.



- (17) Phonological linearization of *rose* F, sg.



- (18) The minimal unit CV vs. Italian nouns

- morphosyntax handles minimally a CV (nor *Cs neither *Vs alone are tolerated in the template)
- in Italian, nouns end in a vowel and (the majority of) roots end in a consonant
- the presence of a final CV unit explains both these restrictions.

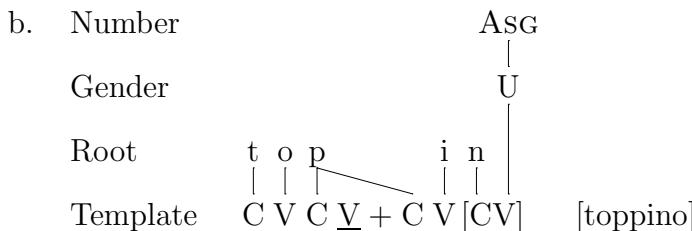
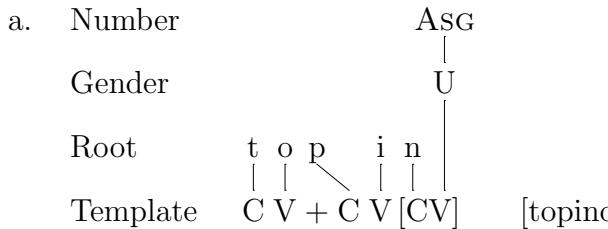

- The underlined V position **is not the site of inflection.**

- (20) *topino* ‘small mouse’ vs. *toppino* ‘small top (bra of a bikini)’ (see Passino, 2008:100-ff)



- (21) a. According to Passino (2008), an extra CV is inserted to host final consonant gemination in derivation (cf. *toppino*)
 b. In our terms, the extra CV is inserted at the right edge: this CV is the site of inflection.
 c. The final [CV] syllable appears in *toppino* but not in *top* because of the diminutive suffix *-ino* (see also: *nav-e* ‘boat-F.sg’ vs. *nav-in-a* ‘boat-small-F.sg’, **nav-in-e* ‘boat-small-F.sg’)

3 Bosnian

- (22) Bosnian nouns
- a. Are inflected for gender, number and case¹
 - b. Are organized in three main groups:
 - (i) M nouns: *okvir* sg Nom vs. *okvir-i* pl Nom ‘frame(s)’
 - (ii) F nouns: *kuća* sg Nom vs. *kuće* pl Nom ‘house(s)’
 - (iii) Neu nouns: *selo* sg Nom vs. *sel-a* pl Nom ‘village(s)’
 - c. Loans are generally inflected for gender, number and case:
 - (i) consonant-final loans: *facebook* M sg Nom, *facebook-a* M sg Gen, etc...
 - (ii) vowel-final loans: *tabure* M sg Nom, *tabure-a* M sg Gen, *tabure-i* M pl Nom ‘stool’; *viski* M sg Nom, *viski-(j)a* M sg Gen ‘whiskey’.

(23) The Bosnian final vowel

- a. it is the spell out of three distinct morphosyntactic properties: gender, number and case (cf. Lampitelli 2013)
- b. is associated to an external final CV unit:
 - (i) the projection KP introduces the final CV
 - (ii) it belongs to the representation of the syntactic case.

(24) Nom and Gen spell-outs (non-exhaustive list):²

- a. Nom \iff templatic spell-out

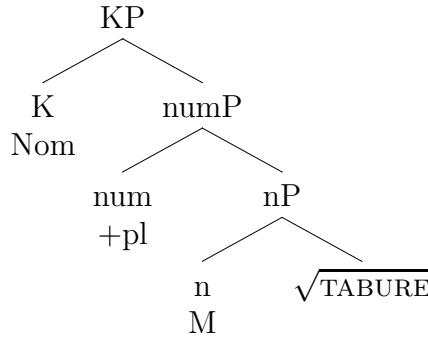

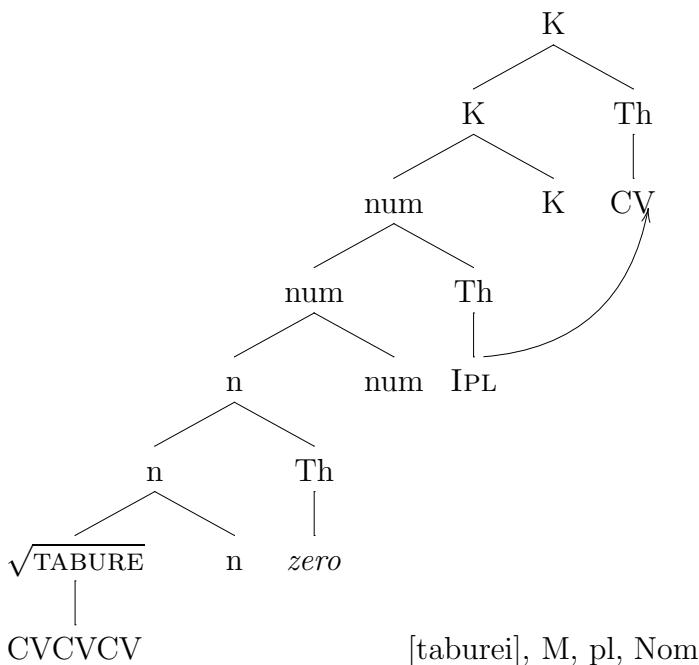

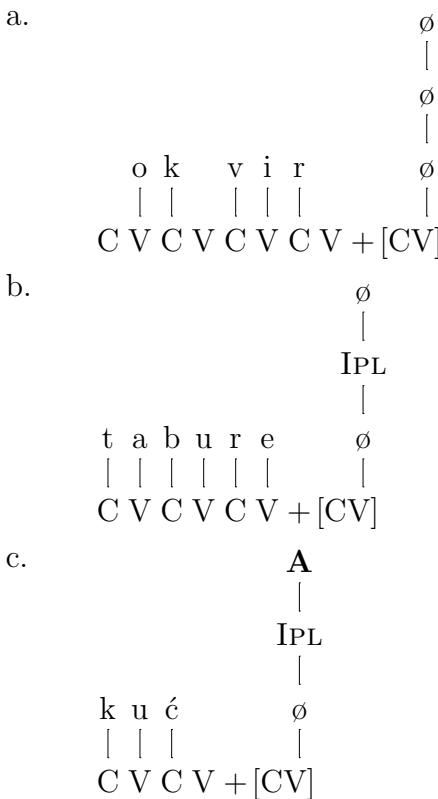

- (26) *okvir* M sg. Nom *taburei* M pl. Nom and *kuće* F pl. Nom.



- (27) **Loanwords³**

- a. *tabure* (M sg Nom) can be pronounced as [tabure] as well as [taburee]
- b. *taburee* (M pl Acc) is always pronounced as [tabure?e], *[taburee]
- c. The final CV is always present even if there is no overt case marker (recall that Nom = \emptyset)

- (28) a. *tabure* M sg Nom [tabure(e)]

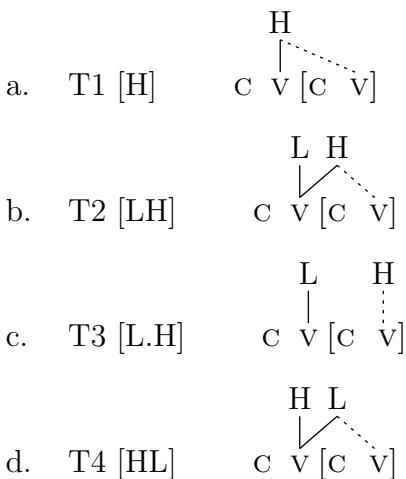

4 Mandarin Chinese (MC)

- (29) a. Basic syllables in MC have the following shape: CV(X) (X being a glide or a nasal)
 - b. Most syllables in MC can be either morphemes or wellformed words.
- (30) a. Goh (1997) argues that the minimal phonological word in MC has a template CVCV.
 - b. Charette (2006) considers MC as a final CV language.

³We thank Nina Rendulić for the data. Loanwords ending in a vowel can be stressed on the last syllable (*taburé*) or on the penultimate (*bife* ‘beef’, *víski* ‘whiskey’, etc...)

- (31) Luo (2013) suggests that the template of a minimal phonological word CVCV must be re-analyzed as CV[CV], [CV] being **an external final phonological unit**.
- (32) The four MC lexical tones have the following contours⁴:
- a. T1 : H, [55]
 - b. T2 : LH, [35]
 - c. T3 : B.H, [21.4]
 - d. T4 : HB, [51]
- (33) In addition, there is a neutral tone (absence of lexical tone), noted T0.
- (34) In MC, the Tone Bearing Unit (TBU) is the syllable.
- a. Minimal phonological words can be realized as long syllables or as short syllables, the length of lexical tones depending on the length of the syllable;
 - b. Suffixes can only be realized as short syllables, with a neutral tone (cf. (42)).
- (35) a. Long syllables: C^HV, CVX⁵
- b. Short syllables: CV
- (36) When realized as short syllables, the four lexical tones have the following contours:⁶
- a. T1 : H, [55]
 - b. T2 : LH, [34]
 - c. T3 : L, [21]
 - d. T4 : HL, [53]
- (37) Following Luo (2013), we assume that the four tones are represented as follows:



- e. The dotted lines represent the optional realization of the tone.
- (38) We focus on T3 [21(4)]:
- a. The complete realization of T3, on long syllables, is L.H [21.4]
 - b. The incomplete realization of T3, on short syllables, is L [21]

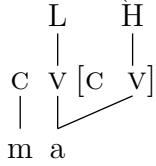
⁴We adopt the convention of five pitch levels (from lowest to highest: 1-5) proposed by Chao (1929). IPA follows the same system.

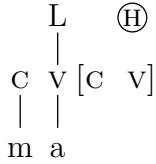

- (39) In monosyllabic words, both complete and incomplete realizations are correct:

- a. *ma3* 'horse' (complete realization)

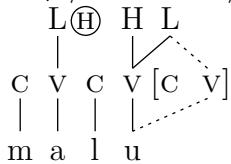


- b. *ma3* 'horse' (incomplete realization)



- (40) In non-final positions of plurisyllabic words, only the incomplete realization is possible.

- a. *ma3-lu4* /horse-road/ 'highway'

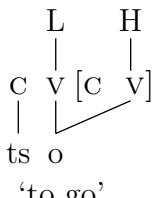


- b. The floating H tone of *ma3* can not be pronounced since it lacks a free V position to attach to.

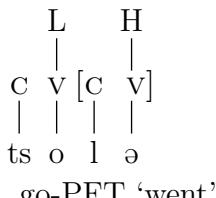
- (41) MC has a limited number of suffixes (cf. Li & Thompson, 1989): we argue that the final CV unit is the realizational site of these suffixes.

- (42) Examples:

- a. perfective *leθ*

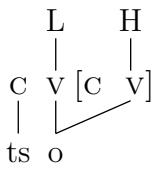

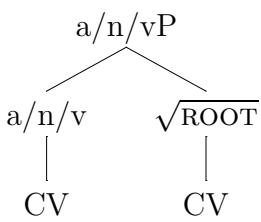
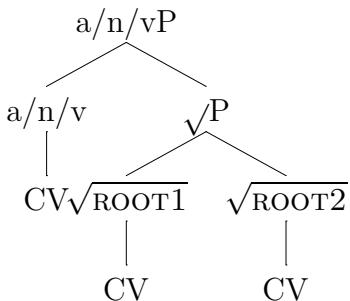


f. In the examples above, the suffix attached to a T3 lexical unit receives the floating H tone of the T3.

(43) A compound: *jin1-shu3* ‘metal’ vs. *jin1-shu3-de0* ‘metallic’

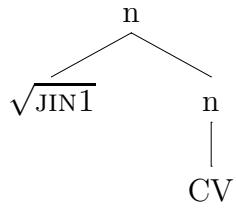

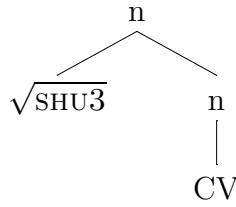

(47) In MC a well-formed word requires a final CV unit.

- a. It is the site of optional (segmental and tonal) spreading when there are no suffixes;
- b. It hosts the suffix when there is one.

Conclusion

- (48) In this talk we have argued that words end in a CV unit in three unrelated languages: Italian, Bosnian and Mandarin Chinese.
- (49) The final CV is a phonological object spelling out a morphological property of words:
 - a. in MC, it is a property of all major categories (n, v, a), cf. the initial CV as in Lowenstamm 1999.
 - b. in Bosnian and Italian, its distribution is restricted:
 - (i) to nouns (Bosnian)
 - (ii) to nouns displaying overt inflection (Italian)
