# REGULAR AUTOMORPHISMS AND CALOGERO-MOSER FAMILIES

#### Abstract

We study the subvariety of fixed points of an automorphism of a Calogero-Moser space induced by a regular element of finite order of the normalizer of the associated complex reflection group $W$. We determine some of (and conjecturally all) the $\mathbb{C}^{\times}$-fixed points of its unique irreducible component of maximal dimension in terms of the character table of $W$. This is inspired by the mysterious relations between the geometry of Calogero-Moser spaces and unipotent representations of finite reductive groups, which is the theme of another paper [Bon3].


Let $V$ be a finite dimensional vector space and let $W$ be a finite subgroup of $\mathbf{G L}_{\mathbb{C}}(V)$ generated by reflections. To some parameter $k$, Etingof and Ginzburg [EtGi] have associated a normal irreducible affine complex variety $\mathscr{I}_{k}=\mathscr{L}_{k}(V, W)$ called a (generalized) CalogeroMoser space. If $\tau$ is an element of finite order of the normalizer of $W$ in $\mathbf{G L}_{\mathbb{C}}(V)$ stabilizing the parameter $k$, it induces an automorphism of $\mathscr{I}_{k}$.

We denote by $V_{\text {reg }}$ the open subset of $V$ on which $W$ acts freely, and we assume that $V_{\text {reg }}^{\tau} \neq \varnothing$ (then $\tau$ is called regular). In this case, there exists a unique irreducible component $\left(\mathscr{E}_{k}^{\tau}\right)_{\text {max }}$ of $\mathscr{X}_{k}^{\tau}$ of maximal dimension (as it will be explained in Section 2). Recall that $\mathscr{I}_{k}$ is endowed with a $\mathbb{C}^{\times}$-action and that we have a surjective map $\operatorname{Irr}(W) \rightarrow \mathscr{L}_{k}^{\mathbb{C}^{\times}}$defined by Gordon [Gor] (induced by the action of the center of a rational Cherednik algebra on baby Verma modules) whose fibers are called the Calogero-Moser $k$-families of $W$. If $p \in \mathscr{X}_{k}^{\mathbb{C}^{\times}}$, we denote by $\mathfrak{F}_{p}$ its associated Calogero-Moser $k$-family. It is a natural question to wonder which $\mathbb{C}^{\times}$-fixed points of $\mathscr{E}_{k}^{\tau}$ belong to $\left(\mathscr{E}_{k}^{\tau}\right)_{\text {max }}$. The aim of this note is to provide a partial answer in terms of the character table of $W$ :

Theorem A. - Assume that $V_{\text {reg }}^{\tau} \neq \varnothing$. Let $p \in \mathscr{I}_{k}^{\mathbb{C}^{\times}}$be such that $\tau(p)=p$. If $\sum_{\chi \in \mathfrak{F}_{p}^{\tau}}|\tilde{\chi}(\tau)|^{2} \neq 0$, then $p \in\left(\mathscr{E}_{k}^{\tau}\right)_{\text {max }}$.

In this statement, if $\chi$ is a $\tau$-stable irreducible character of $W$, we denote by $\tilde{\chi}$ an extension of $\chi$ to the finite group $W\langle\tau\rangle$ (note that $|\tilde{\chi}(\tau)|^{2}$ does not depend on the choice of $\tilde{\chi}$ ). Our proof of Theorem A makes an extensive use of the Gaudin operators introduced in [BoRo, §8.3.B]. This result is also inspired by the theory of unipotent representations of finite reductive groups and some conjectures of Broué-Michel [ BrMi ] on the cohomology of Deligne-Lusztig varieties associated with regular elements in the sense of Springer [ $\mathbf{S p r}$ ] and

by [BMM2, Rem. 4.21] (this will also be discussed in [Bon3]). If we believe in this analogy, we can conjecture that the converse of Theorem A holds:

> Conjecture B. - Assume that $V_{\text {reg }}^{\tau} \neq \varnothing$. Let $p \in \mathscr{I}_{k}^{\mathbb{C}^{\times}}$be such that $\tau(p)=p$. Then $p \in\left(\mathscr{X}_{k}^{\tau}\right)_{\text {max }}$ if and only if $\sum_{\chi \in \mathfrak{F}_{p}^{\tau}}|\tilde{\chi}(\tau)|^{2} \neq 0$.

General notation. Throughout this paper, we will abbreviate $\otimes_{\mathbb{C}}$ as $\otimes$ and all varieties will be algebraic, complex, quasi-projective and reduced. If $x$ is an affine variety, we denote by $\mathbb{C}[X]$ its coordinate ring.

If $X$ is a subset of a vector space $V$ (or of its dual $V^{*}$ ), and if $\Gamma$ is a subgroup of $\mathbf{G L}_{\mathbb{C}}(V)$, we denote by $\Gamma_{X}$ the pointwise stabilizer of $X$. If moreover $\Gamma$ is finite, we will identify $\left(V^{\Gamma}\right)^{*}$ and $\left(V^{*}\right)^{\Gamma}$.

## 1. Set-up

Hypothesis and notation. We fix in this paper a finite dimensional complex vector space $V$ and a finite subgroup $W$ of $\mathbf{G L}_{\mathbb{C}}(V)$. We set

$$
\operatorname{Ref}(W)=\left\{s \in W \mid \operatorname{codim}_{\mathbb{C}} V^{s}=1\right\}
$$

and we assume throughout this paper that

$$
W=\langle\operatorname{Ref}(W)\rangle,
$$

i.e. that $W$ is a complex reflection group.
1.A. About $\boldsymbol{W}$. - We set $\varepsilon: W \rightarrow \mathbb{C}^{\times}, w \mapsto \operatorname{det}(w)$. We identify $\mathbb{C}[V]$ (resp. $\mathbb{C}\left[V^{*}\right]$ ) with the symmetric algebra $\mathrm{S}\left(V^{*}\right)$ (resp. $\mathrm{S}(V)$ ).

We denote by $\boldsymbol{A}$ the set of reflecting hyperplanes of $W$, namely

$$
\mathscr{A}=\left\{V^{s} \mid s \in \operatorname{Ref}(W)\right\} .
$$

If $H \in \mathscr{A}$, we denote by $\alpha_{H}$ an element of $V^{*}$ such that $H=\operatorname{Ker}\left(\alpha_{H}\right)$ and by $\alpha_{H}^{\vee}$ an element of $V$ such that $V=H \oplus \mathbb{C} \alpha_{H}^{\vee}$ and the line $\mathbb{C} \alpha_{H}^{\vee}$ is $W_{H}$-stable. We set $e_{H}=\left|W_{H}\right|$. Note that $W_{H}$ is cyclic of order $e_{H}$ and that $\operatorname{Trr}\left(W_{H}\right)=\left\{\operatorname{Res}_{W_{H}}^{W} \varepsilon^{j} \mid 0 \leqslant j \leqslant e-1\right\}$. We denote by $\varepsilon_{H, j}$ the (central) primitive idempotent of $\mathbb{C} W_{H}$ associated with the character $\operatorname{Res}_{W_{H}}^{W} \varepsilon^{-j}$, namely

$$
\varepsilon_{H, j}=\frac{1}{e_{H}} \sum_{w \in W_{H}} \varepsilon(w)^{j} w \in \mathbb{C} W_{H} .
$$

If $\Omega$ is a $W$-orbit of reflecting hyperplanes, we write $e_{\Omega}$ for the common value of all the $e_{H}$, where $H \in \Omega$. We denote by $\aleph$ the set of pairs $(\Omega, j)$ where $\Omega \in \mathscr{A}$ and $0 \leqslant j \leqslant e_{\Omega}-1$. The vector space of families of complex numbers indexed by $\aleph$ will be denoted by $\mathbb{C}^{\aleph}$ : elements of $\mathbb{C}^{\aleph}$ will be called parameters. If $k=\left(k_{\Omega, j}\right)_{(\Omega, j) \in \aleph} \in \mathbb{C}^{\aleph}$, we define $k_{H, j}$ for all $H \in \Omega$ and $j \in \mathbb{Z}$ by $k_{H, j}=k_{\Omega, j_{0}}$ where $\Omega$ is the $W$-orbit of $H$ and $j_{0}$ is the unique element of $\left\{0,1, \ldots, e_{H}-1\right\}$ such that $j \equiv j_{0} \bmod e_{H}$.

We denote by $V_{\text {reg }}$ the set of elements $v$ of $V$ such that $W_{v}=1$. It is an open subset of $V$ and recall from Steinberg-Serre Theorem [Bro, Theo. 4.7] that

$$
\begin{equation*}
V_{\mathrm{reg}}=V \backslash \bigcup_{H \in \mathscr{A}} H . \tag{1.1}
\end{equation*}
$$

1.B. Rational Cherednik algebra at $t=\mathbf{0}$. - Let $k \in \mathbb{C}^{\aleph}$. We define the rational Cherednik algebra $\mathbf{H}_{k}(a t t=0)$ to be the quotient of the algebra $\mathrm{T}\left(V \oplus V^{*}\right) \rtimes W$ (the semi-direct product of the tensor algebra $\mathrm{T}\left(V \oplus V^{*}\right)$ with the group $\left.W\right)$ by the relations

$$
\left\{\begin{array}{l}
{\left[x, x^{\prime}\right]=\left[y, y^{\prime}\right]=0,}  \tag{1.2}\\
{[y, x]=\sum_{H \in \mathscr{A}} \sum_{j=0}^{e_{H}-1} e_{H}\left(k_{H, j}-k_{H, j+1}\right) \frac{\left\langle y, \alpha_{H}\right\rangle \cdot\left\langle\alpha_{H}^{\vee}, x\right\rangle}{\left\langle\alpha_{H}^{\vee}, \alpha_{H}\right\rangle} \varepsilon_{H, j},}
\end{array}\right.
$$

for all $x, x^{\prime} \in V^{*}, y, y^{\prime} \in V$. Here $\langle\rangle:, V \times V^{*} \rightarrow \mathbb{C}$ is the standard pairing. The first commutation relations imply that we have morphisms of algebras $\mathbb{C}[V] \rightarrow \mathbf{H}_{k}$ and $\mathbb{C}\left[V^{*}\right] \rightarrow$ $\mathbf{H}_{k}$. Recall [EtGi, Theo. 1.3] that we have an isomorphism of $\mathbb{C}$-vector spaces

$$
\begin{equation*}
\mathbb{C}[V] \otimes \mathbb{C} W \otimes \mathbb{C}\left[V^{*}\right] \xrightarrow{\sim} \mathbf{H}_{k} \tag{1.3}
\end{equation*}
$$

induced by multiplication (this is the so-called PBW-decomposition).

Remark 1.4. - Let $\left(l_{\Omega}\right)_{\Omega \in \mathcal{A} / W}$ be a family of complex numbers and let $k^{\prime} \in \mathbb{C}^{\aleph}$ be defined by $k_{\Omega, j}^{\prime}=k_{\Omega, j}+l_{\Omega}$. Then $\mathbf{H}_{k}=\mathbf{H}_{k^{\prime}}$. This means that there is no restriction to generality if we consider for instance only parameters $k$ such that $k_{\Omega, 0}=0$ for all $\Omega$, or only parameters $k$ such that $k_{\Omega, 0}+k_{\Omega, 1}+\cdots+k_{\Omega, e_{\Omega}-1}=0$ for all $\Omega$ (as in [BoRo]).
1.C. Calogero-Moser space. - We denote by $\mathbf{Z}_{k}$ the center of the algebra $\mathbf{H}_{k}$ : it is wellknown [EtGi, Theo 3.3 and Lem. 3.5] that $\mathbf{Z}_{k}$ is an integral domain, which is integrally closed. Moreover, it contains $\mathbb{C}[V]^{W}$ and $\mathbb{C}\left[V^{*}\right]^{W}$ as subalgebras [Gor, Prop. 3.6] (so it contains $\mathbf{P}=$ $\left.\mathbb{C}[V]^{W} \otimes \mathbb{C}\left[V^{*}\right]^{W}\right)$, and it is a free $\mathbf{P}$-module of rank $|W|$. We denote by $\mathscr{I}_{k}$ the affine algebraic variety whose ring of regular functions $\mathbb{C}\left[\mathscr{I}_{k}\right]$ is $\mathbf{Z}_{k}$ : this is the Calogero-Moser space associated with the datum $(V, W, k)$. It is irreducible and normal.

We set $\mathscr{P}=V / W \times V^{*} / W$, so that $\mathbb{C}[\mathscr{P}]=\mathbf{P}$ and the inclusion $\mathbf{P} \hookrightarrow \mathbf{Z}_{k}$ induces a morphism of varieties

$$
\Upsilon_{k}: \mathscr{I}_{k} \longrightarrow \mathscr{P}
$$

which is finite and flat.
1.D. Calogero-Moser families. - Using the PBW-decomposition, we define a $\mathbb{C}$-linear map $\boldsymbol{\Omega}^{\mathbf{H}_{k}}: \mathbf{H}_{k} \longrightarrow \mathbb{C} W$ by

$$
\boldsymbol{\Omega}^{\mathbf{H}_{k}}(f w g)=f(0) g(0) w
$$

for all $f \in \mathbb{C}[V], g \in \mathbb{C}\left[V^{*}\right]$ and $w \in \mathbb{C} W$. This map is $W$-equivariant for the action on both sides by conjugation, so it induces a well-defined $\mathbb{C}$-linear map

$$
\boldsymbol{\Omega}^{k}: \mathbf{Z}_{k} \longrightarrow \mathrm{Z}(\mathbb{C} W) .
$$

Recall from [BoRo, Cor. 4.2.11] that $\Omega^{k}$ is a morphism of algebras.
Calogero-Moser families were defined by Gordon using his theory of baby Verma modules [Gor, $\S 4.2$ and §5.4]. We explain here an equivalent definition given in [BoRo, §7.2]. If $\chi \in \operatorname{Irr}(W)$, we denote by $\omega_{\chi}: \mathrm{Z}(\mathbb{C} W) \rightarrow \mathbb{C}$ its central character (i.e., $\omega_{\chi}(z)=\chi(z) / \chi(1)$ is the scalar by which $z$ acts on an irreducible representation affording the character $\chi$ ). We say that two characters $\chi$ and $\chi^{\prime}$ belong to the same Calogero-Moser $k$-family if $\omega_{\chi} \circ \boldsymbol{\Omega}^{k}=\omega_{\chi^{\prime}} \circ \boldsymbol{\Omega}^{k}$.

In other words, the map $\omega_{\chi} \circ \boldsymbol{\Omega}^{k}: \mathbf{Z}_{k} \rightarrow \mathbb{C}$ is a morphism of algebras, so it might be viewed as a point $\varphi_{k}(\chi)$ of $\mathscr{I}_{k}$, which is easily checked to be $\mathbb{C}^{\times}$-fixed. This defines a surjective map

$$
\varphi_{k}: \operatorname{Irr}(W) \longrightarrow \mathscr{I}_{k}^{\mathbb{C}^{\times}}
$$

whose fibers are the Calogero-Moser $k$-families. If $p \in \mathscr{L}_{k}^{\mathbb{C}^{\times}}$, we denote by $\mathfrak{F}_{p}$ the corresponding Calogero-Moser $k$-family.
1.E. Other parameters. - Let $\mathscr{C}$ denote the space of maps $\operatorname{Ref}(W) \rightarrow \mathbb{C}$ which are constant on conjugacy classes of reflections. The element

$$
\sum_{(\Omega, j) \in \aleph} \sum_{H \in \Omega}\left(k_{H, j}-k_{H, j+1}\right) e_{H} \varepsilon_{H, j}
$$

of $\mathrm{Z}(\mathbb{C} W)$ is supported only by reflections, so there exists a unique map $c_{k} \in \mathscr{C}$ such that

$$
\sum_{(\Omega, j) \in \mathbb{M}} \sum_{H \in \Omega}\left(k_{H, j}-k_{H, j+1}\right) e_{H} \varepsilon_{H, j}=\sum_{s \in \operatorname{Ref}(W)}(\varepsilon(s)-1) c_{k}(s) s
$$

Then the map $\mathbb{C}^{\aleph} \rightarrow \mathscr{C}, k \mapsto c_{k}$ is linear and surjective. With this notation, we have

$$
\begin{equation*}
[y, x]=\sum_{s \in \operatorname{Ref}(W)}(\varepsilon(s)-1) c_{k}(s) \frac{\left\langle y, \alpha_{s}\right\rangle \cdot\left\langle\alpha_{s}^{\vee}, x\right\rangle}{\left\langle\alpha_{s}^{\vee}, \alpha_{s}\right\rangle} s, \tag{1.5}
\end{equation*}
$$

for all $y \in V$ and $x \in V^{*}$. Here, $\alpha_{s}=\alpha_{V^{s}}$ and $\alpha_{s}^{\vee}=\alpha_{V^{s}}^{\vee}$.
1.F. Actions on the Calogero-Moser space. - The Calogero-Moser space $\mathscr{E}_{k}$ is endowed with a $\mathbb{C}^{\times}$-action and an action of the stabilizer of $k$ in $\mathbf{N}_{\mathbf{G L}_{\mathbb{C}}(V)}(W)$, which are described below.
1.F.1. Grading, $\mathbb{C}^{\times}$-action. - The algebra $\mathrm{T}\left(V \oplus V^{*}\right) \rtimes W$ can be $\mathbb{Z}$-graded in such a way that the generators have the following degrees

$$
\begin{cases}\operatorname{deg}(y)=-1 & \text { if } y \in V \\ \operatorname{deg}(x)=1 & \text { if } x \in V^{*} \\ \operatorname{deg}(w)=0 & \text { if } w \in W\end{cases}
$$

This descends to a $\mathbb{Z}$-grading on $\mathbf{H}_{k}$, because the defining relations (1.2) are homogeneous. Since the center of a graded algebra is always graded, the subalgebra $\mathbf{Z}_{k}$ is also $\mathbb{Z}$-graded. So the Calogero-Moser space $\mathscr{E}_{k}$ inherits a regular $\mathbb{C}^{\times}$-action. Note also that by definition $\mathbf{P}=\mathbb{C}[V]^{W} \otimes \mathbb{C}\left[V^{*}\right]^{W}$ is clearly a graded subalgebra of $\mathbf{Z}_{k}$.
1.F.2. Action of the normalizer. - The group $\mathrm{N}_{\mathbf{G L}_{\mathbb{C}}(V)}(W)$ acts on the set $\aleph$ and so on the space of parameters $\mathbb{C}^{\aleph}$. If $\tau \in \mathrm{N}_{\mathbf{G L}_{\mathbb{C}}(V)}(W)$, then $\tau$ induces an isomorphism of algebras $\mathbf{H}_{k} \longrightarrow \mathbf{H}_{\tau(k)}$. So, if $\tau(k)=k$, then it induces an action on the algebra $\mathbf{H}_{k}$ (and so on its center $\mathbf{Z}_{k}$ and on the Calogero-Moser space $\mathscr{E}_{k}$ ).

We say that $\tau$ is a regular element of $\mathrm{N}_{\mathbf{G L}_{\mathbb{C}}(V)}(W)$ if $V_{\text {reg }}^{\tau} \neq \varnothing$.
Notation. From now on, and until the end of this paper, we fix a parameter $k \in \mathbb{C}^{\aleph}$ and a regular element $\tau$ of finite order of $\mathrm{N}_{\mathbf{G} \mathbf{L}_{\mathbb{C}}(V)}(W)$ such that $\tau(k)=k$.

We denote by $\mathscr{L}_{k}^{\tau}$ the variety of fixed points of $\tau$ in $\mathscr{E}_{k}$, endowed with its reduced structure. All the above constructions are $\tau$-equivariant: for instance, the map $\varphi_{k}: \operatorname{Irr}(W) \longrightarrow \mathscr{E}_{k}^{\mathbb{C}^{\times}}$is $\tau$-equivariant.

Let us recall the following consequence [Spr, Prop. 3.5 and Theo. 4.2] of the above hypothesis:

Theorem 1.6 (Springer). - The group $W^{\tau}$ acts as a reflection group on $V^{\tau}$ and the natural map $V^{\tau} / W^{\tau} \rightarrow(V / W)^{\tau}$ is an isomorphism of varieties.

Corollary 1.7. - The natural map $\left(V_{\mathrm{reg}}^{\tau} \times V^{* \tau}\right) / W^{\tau} \rightarrow\left(\left(V_{\mathrm{reg}} \times V^{*}\right) / W\right)^{\tau}$ is an isomorphism of varieties.

Proof. - Since $W$ acts freely on $V_{\text {reg }} \times V^{*}$, the quotient $\left(V_{\text {reg }} \times V^{*}\right) / W$ is smooth. Consequently, the variety of fixed points $\left(\left(V_{\text {reg }} \times V^{*}\right) / W\right)^{\tau}$ is also smooth. Similarly, ( $V_{\text {reg }}^{\tau} \times$ $\left.V^{* \tau}\right) / W^{\tau}$ is smooth. Since a bijective morphism between smooth varieties is an isomorphism, we only need to show that the above natural map is bijective.

First, if $\left(v_{1}, v_{1}^{*}\right)$ and $\left(v_{2}, v_{2}^{*}\right)$ are two elements of $V_{\text {reg }}^{\tau} \times V^{* \tau}$ belonging to the same $W$ orbit, there exists $w \in W$ such that $v_{2}=w\left(v_{1}\right)$. Since $v_{1}$ and $v_{2}$ are $\tau$-stable, we also have $\tau(w)\left(v_{1}\right)=v_{2}$, and so $v_{1}=w^{-1} \tau(w)\left(v_{1}\right)$. Since $v_{1} \in V_{\text {reg, }}$, this forces $\tau(w)=w$ and the injectivity follows.

Now, if $\left(v, v^{*}\right) \in V_{\text {reg }} \times V^{*}$ is such that its $W$-orbit is $\tau$-stable, then the $W$-orbit of $v$ is $\tau$-stable. So Theorem 1.6 shows that we may assume that $\tau(v)=v$. The hypothesis implies that there exists $w \in W$ such that $\tau(v)=w(v)$ and $\tau\left(v^{*}\right)=w\left(v^{*}\right)$. But $\tau(v)=v \in V_{\text {reg, }}$, so $w=1$. In particular, $\tau\left(v^{*}\right)=v^{*}$, and the surjectivity follows.

## 2. Irreducible component of maximal dimension

Let $\left(\mathscr{E}_{k}\right)_{\text {reg }}$ denote the open subset $\Upsilon_{k}^{-1}\left(V_{\text {reg }} / W \times V^{*} / W\right)$. By [EtGi, Prop. 4.11], we have a $\mathbb{C}^{\times}$-equivariant and $\tau$-equivariant isomorphism

$$
\begin{equation*}
\left(\mathscr{E}_{k}\right)_{\mathrm{reg}} \simeq\left(V_{\mathrm{reg}} \times V^{*}\right) / W . \tag{2.1}
\end{equation*}
$$

This shows that $\left(\mathscr{E}_{k}\right)_{\text {reg }}$ is smooth and so $\left(\mathscr{E}_{k}\right)_{\text {reg }}^{\tau}$ is also smooth. By Corollary 1.7, this implies that

$$
\begin{equation*}
\left(\mathscr{L}_{k}\right)_{\mathrm{reg}}^{\tau} \simeq\left(V_{\mathrm{reg}}^{\tau} \times V^{* \tau}\right) / W^{\tau} . \tag{2.2}
\end{equation*}
$$

In particular it is irreducible. We denote by $\left(\mathscr{E}_{k}^{\tau}\right)_{\max }$ its closure: it is an irreducible closed subvariety of $\mathscr{I}_{k}^{\tau}$.

Moreover, $\left(\mathscr{I}_{k}\right)_{\text {reg }}^{\tau}$ has dimension $2 \operatorname{dim} V^{\tau}$ by Corollary 1.7. So $\operatorname{dim} \mathscr{X}_{k}^{\tau} \geqslant 2 \operatorname{dim} V^{\tau}=$ $\operatorname{dim}\left(\mathscr{F}_{k}^{\tau}\right)_{\max }$. But, on the other hand, $\Upsilon_{k}\left(\mathscr{F}_{k}^{\tau}\right) \subset(V / W)^{\tau} \times\left(V^{*} / W\right)^{\tau}$. Since $\Upsilon_{k}$ is a finite morphism, we get from Theorem 1.6 that $\operatorname{dim} \mathscr{E}_{k}^{\tau} \leqslant 2 \operatorname{dim} V^{\tau}$. Hence

$$
\begin{equation*}
\operatorname{dim} \mathscr{X}_{k}^{\tau}=\operatorname{dim}\left(\mathscr{E}_{k}^{\tau}\right)_{\max }=2 \operatorname{dim} V^{\tau} . \tag{2.3}
\end{equation*}
$$

This shows that $\left(\mathscr{E}_{k}^{\tau}\right)_{\text {max }}$ is an irreducible component of maximal dimension of $\mathscr{E}_{k}^{\tau}$.
Proposition 2.4. - The closed subvariety $\left(\mathscr{F}_{k}^{\tau}\right)_{\max }$ of $\mathscr{L}_{k}^{\tau}$ is the unique irreducible component of maximal dimension.

Proof. - Let $X$ be an irreducible component of $\mathscr{X}_{k}^{\tau}$ of dimension $2 \operatorname{dim} V^{\tau}$. Since $\Upsilon_{k}$ is finite, the image $\Upsilon_{k}(X)$ is closed in $V / W \times V^{*} / W$, irreducible of dimension $2 \operatorname{dim}\left(V^{\tau}\right)$ and contained in $(V / W)^{\tau} \times\left(V^{*} / W\right)^{\tau}$. By Theorem 1.6, we get that $\Upsilon_{k}(X)=(V / W)^{\tau} \times\left(V^{*} / W\right)^{\tau}$.

Let $U=\Upsilon_{k}^{-1}\left(V_{\text {reg }} / W \times V^{*} / W\right) \cap X$. Then $\mathscr{U}$ is a non-empty open subset of $X$ : since $X$ is irreducible, this forces $\mathcal{U}$ to have dimension $2 \operatorname{dim}\left(V^{\tau}\right)$. But $\mathcal{U}$ is contained in $\left(\mathscr{I}_{k}\right)_{\text {reg }}^{\tau}$ which is irreducible of the same dimension, so the closure of $U$ contains $\left(\mathscr{X}_{k}\right)_{\text {reg }}^{\tau}$. This proves that $X=\left(\mathscr{E}_{k}^{\tau}\right)_{\text {max }}$.

Corollary 2.5. $-\Upsilon_{k}\left(\left(\mathscr{£}_{k}^{\tau}\right)_{\max }\right)=(V / W)^{\tau} \times\left(V^{*} / W\right)^{\tau}$.
It is natural to ask which $\mathbb{C}^{\times}$-fixed points of $\mathscr{I}_{k}$ belong to $\left(\mathscr{E}_{k}^{\tau}\right)_{\text {max }}$. Inspired by the representation theory of finite reductive groups (see [BrMi] and [BMM2, Rem. 4.21]), we propose an answer to this question in terms of the character table of the finite group $W\langle\tau\rangle$ (see [Bon3, Ex. 12.9] for some explanations). We first need some notation.

If $\chi \in \operatorname{Irr}(W)$, we denote by $E_{\chi}$ a $\mathbb{C} W$-module affording the character $\chi$. If moreover $\chi$ is $\tau$-stable, we fix a structure of $\mathbb{C} W\langle\tau\rangle$-module on $E_{\chi}$ extending the structure of $\mathbb{C} W$-module, and we denote by $\tilde{\chi}$ its associated irreducible character of $W\langle\tau\rangle$. Note that the real number $|\tilde{\chi}(\tau)|^{2}$ does not depend on the choice of $\tilde{\chi}$.

Conjecture 2.6. - Recall that $\tau$ is regular. Let $p \in \mathscr{I}_{k}^{\mathbb{C}^{\times}}$be such that $\tau(p)=p$.
Then $p$ belongs to $\left(\mathscr{E}_{k}^{\tau}\right)_{\max }$ if and only if $\sum_{\chi \in \mathfrak{F}_{p}^{\tau}}|\tilde{\chi}(\tau)|^{2} \neq 0$.
Remark 2.7. - Let $\mathfrak{F}$ be a $\tau$-stable Calogero-Moser family. Then $\mathfrak{F}$ contains a unique irreducible character $\chi_{\mathfrak{F}}$ with minimal $b$-invariant [BoRo, Theo. 7.4.1], where the $b$-invariant of an irreducible character $\chi$ is the minimal natural number $j$ such that $\chi$ occurs in the $j$-th symmetric power of the natural representation $V$ of $W$. From this characterization, we see that $\chi_{\mathfrak{F}}$ is $\tau$-stable. In particular, any $\tau$-stable Calogero-Moser family contains at least one $\tau$-stable character.

In general, we are only able to prove the "if" part of Conjecture 2.6.
Theorem 2.8. - Recall that $\tau$ is regular. Let $p \in \mathscr{E}_{k}^{\mathbb{C}^{\times}}$be such that $\tau(p)=p$. If $\sum_{\chi \in \mathfrak{F}_{p}^{\tau}}|\tilde{\chi}(\tau)|^{2} \neq 0$, then $p$ belongs to $\left(\mathscr{F}_{k}^{\tau}\right)_{\max }$.

The next two sections are devoted to the proof of Theorem 2.8.

## 3. Verma modules

3.A. Definition. - Recall that $\mathbb{C}[V] \rtimes W$ is a subalgebra of $\mathbf{H}_{k}$ (it is the image of $1 \otimes \mathbb{C} W \otimes$ $\mathbb{C}[V]$ by the PBW-decomposition 1.3). If $E$ is a $\mathbb{C} W$-module, we denote by $E^{\#}$ the $\left(\mathbb{C}\left[V^{*}\right] \rtimes\right.$ $W$ )-module extending $E$ by letting any element $f \in \mathbb{C}\left[V^{*}\right]$ acting by multiplication by $f(0)$. If $\chi \in \operatorname{Irr}(W)$, we define an $\mathbf{H}_{k}$-module $\Delta(\chi)$ as follows:

$$
\Delta(\chi)=\mathbf{H}_{k} \otimes_{\mathbb{C}\left[V^{*}\right] \times W} E_{\chi}^{\#} .
$$

Then $\Delta(\chi)$ is called a Verma module of $\mathbf{H}_{k}$ (see [BoRo, §5.4.A]: in this reference, $\Delta(\chi)$ is denoted by $\Delta\left(E_{\chi}^{\#}\right)$ ). Let $\mathbf{H}_{k}^{\text {reg }}$ denote the localization of $\mathbf{H}_{k}$ at $\mathbf{P}_{\text {reg }}=\mathbb{C}\left[V_{\text {reg }} / W\right] \otimes \mathbb{C}\left[V^{*}\right]$. By [EtGi, Prop. 4.11], we have an isomorphism $\mathbb{C}\left[V_{\text {reg }} \times V^{*}\right] \rtimes W \simeq \mathbf{H}_{k}^{\text {reg }}$. We denote by $\Delta^{\text {reg }}(\chi)$ the localization of $\Delta(\chi)$ at $\mathbf{H}_{k}^{\text {reg }}$. So, by restriction to $\mathbb{C}\left[V_{\text {reg }} \times V^{*}\right]$, the Verma module $\Delta(\chi)$ might be viewed as a $W$-equivariant coherent sheaf on $V_{\text {reg }} \times V^{*}$. We also view $e \Delta(\chi)$ as a coherent sheaf on $\mathscr{E}_{k}$, so that $e \Delta^{\text {reg }}(\chi)$ may be viewed as a coherent sheaf on $\left(V_{\text {reg }} \times V^{*}\right) / W$. If $p \in \mathscr{I}_{k}$ (or if $\left(v, v^{*}\right) \in V_{\text {reg }} \times V^{*}$ ), we denote by $e \Delta(\chi)_{p}$ (respectively $e \Delta(\chi)_{W \cdot\left(v, v^{*}\right)}=e \Delta^{\mathrm{reg}}(\chi)_{W \cdot\left(v, v^{*}\right)}$, respectively $\left.\Delta^{\mathrm{reg}}(\chi)_{v, v^{*}}\right)$ the restriction of $e \Delta(\chi)$ (respectively of $e \Delta(\chi)$ or $e \Delta^{\mathrm{reg}}(\chi)$, respectively $\left.\Delta^{\mathrm{reg}}(\chi)\right)$ at the point $p$ (respectively $W \cdot\left(v, v^{*}\right) \in$ $\left(V_{\text {reg }} \times V^{*}\right) / W \simeq\left(\mathscr{E}_{k}\right)_{\text {reg }}$, respectively $\left.\left(v, v^{*}\right)\right)$. It follows from the definition that the support of $e \Delta(\chi)$ is contained in $\Upsilon_{k}^{-1}(V / W \times 0)$, and recall that, through the isomorphism $\mathscr{E}_{k}^{\text {reg }} \simeq\left(V_{\text {reg }} \times V^{*}\right) / W, \Upsilon_{k}^{-1}\left(V_{\text {reg }} / W \times 0\right)$ is not necessarily contained in $\left(V_{\text {reg }} \times\{0\}\right) / W$.

Lemma 3.1. - Let $\chi \in \operatorname{Irr}(W)$ and let $p \in \mathscr{I}_{k}^{\mathbb{C}^{\times}}$. Then $e \Delta(\chi)_{p} \neq 0$ if and only if $\chi \in \mathfrak{F}_{p}$.

Proof. - Let $\mathfrak{p}_{0}$ denote the maximal ideal of the algebra $\mathbf{P}=\mathbb{C}[\mathscr{P}]$ consisting of functions which vanish at 0 . Then $\Delta(\chi) / \mathfrak{p}_{0} \Delta(\chi)$ is a representation of the restricted rational Cherednik algebra $\mathbf{H}_{k} / \mathfrak{p}_{0} \mathbf{H}_{k}$ which coincides with the baby Verma module defined by Gordon [Gor, §4.2]. As $\mathscr{E}_{k}^{\mathbb{C}^{\times}}=\Upsilon_{k}^{-1}(0)$, the result follows from the very definition of Calogero-Moser families in terms of baby Verma modules and the fact that it is equivalent to the definition given in §1.D.
3.B. Bialynicki-Birula decomposition. - We denote by $\mathscr{I}_{k}^{\text {att }}$ the attracting set of $\mathscr{I}_{k}$ for the action of $\mathbb{C}^{\times}$, namely

$$
\mathscr{E}_{k}^{\text {att }}=\left\{p \in \mathscr{E}_{k} \mid \lim _{\xi \rightarrow 0} \xi_{p} \text { exists }\right\} .
$$

Recall from [BoRo, Chap. 14] the following facts:

Proposition 3.2. - With the above notation, we have:
(a) The map $\lim : \mathscr{E}_{k}^{\text {att }} \longrightarrow \mathscr{E}_{k}^{\mathbb{C}^{\times}}, p \mapsto \lim _{\xi \rightarrow 0} \xi_{p}$ is a morphism of varieties.
(b) $\mathscr{I}_{k}^{\text {att }}=\Upsilon_{k}^{-1}(V / W \times\{0\})$.
(c) If $\mathcal{F}$ is an irreducible component of $\mathscr{L}_{k}^{\text {att }}$, then $\mathscr{F}$ is $\mathbb{C}^{\times}$-stable and $\Upsilon_{k}(\mathscr{F})=V / W \times\{0\}$ and $\lim (\mathscr{F})$ is a single point.
(d) If $\chi \in \operatorname{Irr}(W)$, then the support of $e \Delta(\chi)$ is a union of irreducible components of $\mathscr{E}_{k}^{\text {att }}$.
(e) If $\mathcal{F}$ is an irreducible component of $\mathscr{E}_{k}^{\text {att }}$, then there exists $\chi \in \operatorname{Irr}(W)$ such that the support of $e \Delta(\chi)$ contains $\mathcal{F}$.

We first propose a characterization of points $p \in \mathscr{L}_{k}^{\mathbb{C}^{\times}}$which belong to $\left(\mathscr{E}_{k}^{\tau}\right)_{\max }$ in terms of Verma modules.

Lemma 3.3. - Let $p \in \mathscr{E}_{k}^{\mathbb{C}^{\times}}$and assume that $\tau(p)=p$. Then $p \in\left(\mathscr{I}_{k}^{\tau}\right)_{\max }$ if and only if there exist $\chi \in \mathfrak{F}_{p}^{k}$ and $\left(v, v^{*}\right) \in V_{\text {reg }}^{\tau} \times V^{* \tau}$ such that $e \Delta(\chi)_{W \cdot\left(v, v^{*}\right)} \neq 0$.

Proof. - Let $\left(\mathscr{I}_{k}^{\tau}\right)_{\max }^{\text {att }}$ denote the attracting set of $\left(\mathscr{I}_{k}^{\tau}\right)_{\max }$. Then Corollary 2.5 implies that $\Upsilon_{k}\left(\left(\mathscr{I}_{k}^{\tau}\right)_{\max }\right)=(V / W)^{\tau} \times\{0\}$. Since $\Upsilon_{k}$ is a finite morphism, the same arguments used in [BoRo, Chap. 14] to prove the Proposition 3.2 above yields the following statements:
(a) The map $\lim :\left(\mathscr{E}_{k}^{\tau}\right)_{\max }^{\text {att }} \longrightarrow\left(\mathscr{E}_{k}^{\tau}\right)_{\max }^{\mathbb{C}}, p \mapsto \lim _{\xi \rightarrow 0} \xi^{\times} p$ is a morphism of varieties.
(b) $\left(\mathscr{E}_{k}^{\tau}\right)_{\max }^{\text {att }}=\left(\mathscr{E}_{k}^{\tau}\right)_{\max } \cap \Upsilon_{k}^{-1}\left((V / W)^{\tau} \times\{0\}\right)$.
(c) If $\mathscr{F}$ is an irreducible component of $\left(\mathscr{I}_{k}^{\tau}\right)_{\text {max }}^{\text {att }}$, then $\mathscr{F}$ is $\mathbb{C}^{\times}$-stable and $\Upsilon_{k}(\mathscr{F})=(V / W)^{\tau} \times$ $\{0\}$ and $\lim (\mathscr{F})$ is a single point.
Assume that $p \in\left(\mathscr{E}_{k}^{\tau}\right)_{\max }$. Let $\mathscr{F}$ be an irreducible component of $\left(\mathscr{E}_{k}^{\tau}\right)_{\max }^{\text {att }} \cap \lim ^{-1}(p)$. Then $\mathscr{F}$ is contained in an irreducible component $\mathscr{J}^{\prime}$ of $\left(\mathscr{F}_{k}^{\tau}\right)_{\text {max }}^{\text {att }}$. Since $\lim \left(\mathscr{J}^{\prime}\right)$ is a single point by (c), we have $\lim \left(\mathscr{J}^{\prime}\right)=\{p\}$ and so $\mathscr{F}=\mathscr{J}^{\prime}$. Still by (c), this says that $\Upsilon_{k}(\mathscr{F})=$ $(V / W)^{\tau} \times\{0\}$. So let $q \in \mathscr{F}$ be such that $\Upsilon_{k}(q) \in\left(V_{\mathrm{reg}} / W\right)^{\tau} \times\{0\}$.

Now, let $\mathscr{F}$ be an irreducible component of $\mathscr{E}_{k}^{\text {att }}$ containing $\mathscr{F}$. By Proposition 3.2(e), there exists $\chi \in \operatorname{Irr}(W)$ such that the support of $e \Delta(\chi)$ contains $\mathscr{F}$. In particular, $e \Delta(\chi)_{p} \neq 0$ and so $\chi \in \mathfrak{F}_{p}$ by Lemma 3.1. But also $e \Delta(\chi)_{q} \neq 0$. Since $q \in\left(\mathscr{E}_{k}^{\tau}\right)_{\max }$ and $\Upsilon_{k}(q) \in V_{\text {reg }} / W$, it follows that there exists $\left(v, v^{*}\right) \in V_{\text {reg }}^{\tau} \times V^{* \tau}$ such that $e \Delta(\chi)_{W \cdot\left(v, v^{*}\right)} \neq 0$, as desired.

Conversely, assume that there exist both $\chi \in \mathfrak{F}_{p}^{k}$ and $\left(v, v^{*}\right) \in V_{\text {reg }}^{\tau} \times V^{* \tau}$ such that $e \Delta(\chi)_{W \cdot\left(v, v^{*}\right)} \neq 0$. Let $\mathscr{F}$ be an irreducible component of $\mathscr{E}_{k}^{\text {att }}$ contained in the support of $e \Delta(\chi)$. Then $p \in \mathscr{F}$ and so $p=\lim W \cdot\left(v, v^{*}\right)$. Since $W \cdot\left(v, v^{*}\right) \in\left(\mathscr{E}_{k}^{\tau}\right)_{\max }$ by the definition of $\left(\mathscr{I}_{k}^{\tau}\right)_{\text {max }}$, this implies that $p \in\left(\mathscr{E}_{k}^{\tau}\right)_{\max }$, as desired.

## 4. Gaudin algebra

4.A. Definition. - We recall here the definition of Gaudin algebra [BoRo, §8.3.B]. First, let $\mathbb{C}\left[V_{\text {reg }}\right][W]$ denote the group algebra of $W$ over the algebra $\mathbb{C}\left[V_{\text {reg }}\right]$ (and not the semi-direct product $\left.\mathbb{C}\left[V_{\text {reg }}\right] \rtimes W\right)$. For $y \in V$, let

$$
\mathscr{D}_{y}^{k}=\sum_{s \in \operatorname{Ref}(W)} \varepsilon(s) c_{k}(s) \frac{\left\langle y, \alpha_{s}\right\rangle}{\alpha_{s}} s \in \mathbb{C}\left[V_{\mathrm{reg}}\right][W] .
$$

Now, let $\operatorname{Gau}_{k}(W)$ be the sub- $\mathbb{C}\left[V_{\text {reg }}\right]$-algebra of $\mathbb{C}\left[V_{\text {reg }}\right][W]$ generated by the $\mathscr{D}_{y}^{k \prime}$ s (where $y$ runs over $V$ ): it will be called the Gaudin algebra (with parameter $k$ ) associated with $W$.

Let $\mathbb{C}(V)$ denote the function field of $V$ (which is the fraction field of $\mathbb{C}[V]$ or of $\mathbb{C}\left[V_{\text {reg }}\right]$ ) and let $\mathbb{C}(V) \operatorname{Gau}_{k}(W)$ denote the subalgebra $\mathbb{C}(V) \otimes_{\mathbb{C}\left[V_{\text {reg }}\right]} \mathrm{Gau}_{k}(W)$ of the group algebra $\mathbb{C}(V)[W]$. Recall [BoRo, §8.3.B] that
$\mathrm{Gau}_{k}(W)$ is a commutative algebra,
but that $\mathrm{Gau}_{k}(W)$ is generally non-split, as shown by the examples treated in [Bon1, §4] and [Lac].
4.B. Generalized eigenspaces. - If $v \in V_{\text {reg, }}$, we denote by $\mathscr{D}_{y}^{k, v}$ the specialization of $\mathscr{D}_{y}^{k}$ at $v$, namely $\mathscr{D}_{y}^{k, v}$ is the element of the group algebra $\mathbb{C} W$ equal to

$$
\mathscr{D}_{y}^{k}=\sum_{s \in \operatorname{Ref}(W)} \varepsilon(s) c_{k}(s) \frac{\left\langle y, \alpha_{s}\right\rangle}{\left\langle v, \alpha_{s}\right\rangle} s .
$$

Now, if $v^{*} \in V^{*}$ and if $M$ is a $\mathbb{C} W$-module, we define $M^{k, v, v^{*}}$ to be the common generalized eigenspace of the operators $\mathscr{D}_{y}^{k, v}$ for the eigenvalue $\left\langle y, v^{*}\right\rangle$, for $y$ running over $V$. Namely,

$$
M^{k, v, v^{*}}=\left\{m \in M \mid \forall y \in V,\left(\mathscr{D}_{y}^{k, v}-\left\langle y, v^{*}\right\rangle \operatorname{Id}_{M}\right)^{\operatorname{dim}(M)}(m)=0\right\} .
$$

Then

$$
\begin{equation*}
M=\bigoplus_{v^{*} \in V^{*}} M^{k, v, v^{*}}, \tag{4.2}
\end{equation*}
$$

since $\mathrm{Gau}_{k}(W)$ is commutative.

Lemma 4.3. - Let $\chi \in \operatorname{Irr}(W)$ and let $\left(v, v^{*}\right) \in V_{\mathrm{reg}} \times V^{*}$. Then the following are equivalent:
(1) $e \Delta(\chi)_{W \cdot\left(v, v^{*}\right)} \neq 0$.
(2) $\Delta^{\mathrm{reg}}(\chi)_{v, v^{*}} \neq 0$.
(3) $E_{\chi}^{k, v, v^{*}} \neq 0$.

Proof. - The equivalence between (1) and (2) follows from the Morita equivalence between $\mathbb{C}\left[V_{\text {reg }} \times V^{*}\right]^{W}$ and $\mathbb{C}\left[V_{\text {reg }} \times V^{*}\right] \rtimes W$ proved in [BoRo, Lem. 3.1.8(b)]. Now, as a $\mathbb{C}\left[V_{\text {reg }}\right]-$ module, $\Delta^{\mathrm{reg}}(\chi) \simeq \mathbb{C}\left[V_{\mathrm{reg}}\right] \otimes E_{\chi}$, and the equivalence between (2) and (3) follows from the computations in [BoRo, §8.3.B].
4.C. Proof of Theorem A (i.e. Theorem 2.8). - Let $\chi \in \operatorname{Irr}(W)$ be $\tau$-stable and such that $\tilde{\chi}(\tau) \neq 0$ and let $v \in V_{\mathrm{reg}}^{\tau}$. By Lemmas 3.1 and 4.3, it is sufficient to show that there exists $v^{*} \in V^{* \tau}$ such that $E_{\chi}^{k, v, v^{*}} \neq 0$.

For this, let $\mathscr{E}$ denote the set of $v^{*} \in V^{*}$ such that $E_{\chi}^{k, v, v^{*}} \neq 0$. Then it follows from (4.2) that

$$
\begin{equation*}
E_{\chi}=\bigoplus_{v^{*} \in \mathscr{B}} E_{\chi}^{k, v, v^{*}} \tag{*}
\end{equation*}
$$

Since $\tau(v)=v$, we have

$$
{ }^{\tau} \mathscr{D}_{y}^{k, v}=\sum_{s \in \operatorname{Ref}(W)} \varepsilon(s) c_{k}(s) \frac{\left\langle y, \alpha_{s}\right\rangle}{\left\langle v, \alpha_{s}\right\rangle} \tau s \tau^{-1}=\sum_{s \in \operatorname{Ref}(W)} \varepsilon(s) c_{k}(s) \frac{\left\langle y, \tau^{-1}\left(\alpha_{s}\right)\right\rangle}{\left\langle v, \tau^{-1}\left(\alpha_{s}\right)\right\rangle} s=\mathscr{D}_{\tau(y)}^{k, v} .
$$

Consequently,

$$
{ }^{\tau} E_{\chi}^{k, v, v^{*}}=E_{\chi}^{k, v, \tau\left(v^{*}\right)} .
$$

But $\tilde{\chi}(\tau)=\operatorname{Tr}\left(\tau, E_{\chi}\right) \neq 0$, so $\tau$ must fix at least one of the generalized eigenspaces in the decomposition (*). In other words, this implies that there exists $v^{*} \in \mathscr{E}$ such that $\tau\left(v^{*}\right)=v^{*}$, as desired. The proof is complete.

## 5. Complements

5.A. Conjectures. - The variety $\mathscr{E}_{k}$ is endowed with a Poisson structure $[E t G i, \S 1]$ and so the variety of fixed points $\mathscr{E}_{k}^{\tau}$ inherits a Poisson structure too, as well as all its irreducible components. Recall from Springer Theorem 1.6 that $W^{\tau}$ is a reflection group for its action on $V^{\tau}$, so we can define a set of pairs $\aleph_{\tau}$ for the pair $\left(V^{\tau}, W^{\tau}\right)$ as well as $\aleph$ has been defined for the pair $(V, W)$ and, for each parameter $l \in \mathbb{C}^{\aleph_{\tau}}$, we can define a Calogero-Moser space $\mathscr{I}_{l}\left(V^{\tau}, W^{\tau}\right)$. The following conjecture is a particular case of [Bon2, Conj. B] (see [Bon2] for a discussion about the cases where this conjecture is known to hold):

Conjecture 5.1. - Recall that $\tau$ is regular. Then there exists a linear map $\lambda: \mathbb{C}^{\aleph} \rightarrow$ $\mathbb{C}^{\aleph_{\tau}}$ and, for each $k \in \mathbb{C}^{\aleph}, a \mathbb{C}^{\times}$-equivariant isomorphism of Poisson varieties

$$
\iota_{k}:\left(\mathscr{I}_{k}^{\tau}\right)_{\max } \xrightarrow{\sim} \mathscr{I}_{\lambda(k)}\left(V^{\tau}, W^{\tau}\right) .
$$

Assume that Conjecture 5.1 holds and keep its notation. Then $\iota_{k}$ restricts to a map $\iota_{k}$ : $\left(\mathscr{I}_{k}\right)_{\max }^{\mathbb{C}^{\times}} \xrightarrow{\sim} \mathscr{I}_{\lambda(k)}\left(V^{\tau}, W^{\tau}\right)^{\mathbb{C}^{\times}}$. If $p \in \mathscr{I}_{\lambda(k)}\left(V^{\tau}, W^{\tau}\right)^{\mathbb{C}^{\times}}$, we denote by $\mathfrak{F}_{\lambda(k)}^{(\tau)}$ the corresponding Calogero-Moser $\lambda(k)$-family of $W^{\tau}$. The next conjecture, still inspired by the representation theory of finite reductive groups (see again [Bon3, Ex. 12.9] for some explanations), makes Conjecture B more precise:

Conjecture 5.2. - Recall that $\tau$ is regular and assume that Conjecture 5.1 holds. If $p \in\left(\mathscr{E}_{k}^{\tau}\right)_{\text {max }} \mathbb{C}^{\times \times}$then

$$
\sum_{\chi \in \mathfrak{F}_{p}^{\tau}}|\tilde{\chi}(\tau)|^{2}=\sum_{\psi \in \mathfrak{F}_{\lambda(k)}^{(\tau)}} \psi(1)^{2} .
$$

Note that this last conjecture is compatible with the fact that

$$
\sum_{\chi \in \operatorname{Irr}(W)^{\tau}}|\tilde{\chi}(\tau)|^{2}=\left|W^{\tau}\right|=\sum_{\psi \in \operatorname{Irr}\left(W^{\tau}\right)} \psi(1)^{2},
$$

where the first equality follows from the second orthogonality relation for characters.
5.B. Roots of unity. - We consider in this subsection a particular (but very important) case of the general situation studied in this paper. We fix a natural number $d \geqslant 1$ and a primitive $d$-th root of unity $\zeta_{d}$. The group of $d$-th roots of unity is denoted by $\boldsymbol{\mu}_{d}$. An element $w \in W$ is called $\zeta_{d}$-regular if the element $\zeta_{d}^{-1} w$ of $\mathrm{N}_{\mathbf{G L}_{\mathbb{C}}(V)}(W)$ is regular. In other words, $w$ is $\zeta_{d^{-}}$ regular if and only if its $\zeta_{d}$-eigenspace meets $V_{\text {reg. }}$. The existence of a $\zeta_{d}$-regular element is not guaranteed: we say that $d$ is a regular number of $W$ if such an element exists.

Hypothesis. We assume in this subsection, and only in this subsection, that dis a regular number of $W$. We denote by $w_{d}$ a $\zeta_{d}$-regular element and we also set $\tau_{d}=\zeta_{d}^{-1} w_{d}$, so that $\tau_{d}$ is a regular element of $\mathrm{N}_{\mathbf{G L}_{\mathbb{C}}(V)}(W)$.

Recall from [ $\mathbf{S p r}$ ] that $w_{d}$ is uniquely defined up to conjugacy. Note that

$$
\begin{equation*}
V^{\tau_{d}}=\operatorname{Ker}\left(w_{d}-\zeta_{d} \mathrm{Id}_{V}\right), \quad W^{\tau_{d}}=C_{W}\left(w_{d}\right) \quad \text { and } \quad \mathscr{X}_{k}^{\tau_{d}}=\mathscr{X}_{k}^{\mu_{d}} . \tag{5.3}
\end{equation*}
$$

Since $\tau_{d}$ induces an inner automorphism of $W$, all the irreducible characters are $\tau_{d}$-stable. Moreover, if $\chi \in \operatorname{Irr}(W)$, then $\tilde{\chi}\left(\tau_{d}\right)=\xi \chi\left(w_{d}\right)$ for some root of unity $\xi$, so $\left|\tilde{\chi}\left(\tau_{d}\right)\right|^{2}=\left|\chi\left(w_{d}\right)\right|^{2}$. This allows to reformulate both Theorem A and Conjecture B in this case:

Conjecture 5.4. - Recall that $d$ is a regular number. Let $p \in \mathscr{L}_{k}^{\mathbb{C}^{\times}}$. Then $p$ belongs to $\left(\mathscr{E}_{k}^{\mu_{d}}\right)_{\text {max }}$ if and only if $\sum_{\chi \in \mathfrak{F}_{p}}\left|\chi\left(w_{d}\right)\right|^{2} \neq 0$.

Theorem 5.5. - Recall that $d$ is regular. Let $p \in \mathscr{I}_{k}^{\mathbb{C}^{\times}}$be such that $\sum_{\chi \in \mathfrak{F}_{p}^{\tau}}\left|\chi\left(w_{d}\right)\right|^{2} \neq 0$. Then $p$ belongs to $\left(\mathscr{£}_{k}^{\mu_{d}}\right)_{\max }$.

Example 5.6 (Symmetric group). - We assume here, and only here, that $W=\mathfrak{S}_{n}$ acting on $V=\mathbb{C}^{n}$ by permutation of the coordinates, for some $n \geqslant 2$. The canonical basis of $\mathbb{C}^{n}$ is denoted by $\left(y_{1}, \ldots, y_{n}\right)$. Then there is a unique orbit of hyperplanes, that we denote by $\Omega$, and $e_{\Omega}=2$. To avoid too easy cases, we also assume that $k_{\Omega, 0} \neq k_{\Omega, 1}$ (so that $\mathscr{L}_{k}$ is smooth [ $\mathbf{E t G i}$, Cor. 1.14]) and that $d \geqslant 2$. Saying that $d$ is a regular number is equivalent to say that $d$ divides $n$ or $n-1$. Therefore, we will denote by $j$ the unique element of $\{0,1\}$ such that $d$ divides $n-j$ and we set $r=(n-j) / d$. Then $w_{d}$ is the product of $r$ disjoint cycles of length $d$, so one can choose for instance

$$
w_{d}=(1,2, \ldots, d)(d+1, d+2, \ldots, 2 d) \cdots((r-1) d+1,(r-1) d+2, \ldots, r d) .
$$

Then $V^{\tau_{d}}$ is $r$-dimensional, with basis $\left(v_{1}, \ldots, v_{r}\right)$ where $v_{a}=\sum_{b=1}^{d} \zeta_{d}^{-b} e_{(a-1) d+b}$ and the group $C_{W}\left(w_{d}\right) \simeq G(d, 1, r)$ acting "naturally" as a reflection group on $V^{\tau_{d}}=\bigoplus_{a=1}^{r} \mathbb{C} v_{a}$.

We also need some combinatorics. We denote by $\operatorname{Part}(n)\left(\right.$ resp. $\left.\operatorname{Part}^{d}(r)\right)$ the set of partitions of $n$ (resp. of $d$-partitions of $r$ ). If $\lambda \in \operatorname{Part}(n)$, we denote by $\chi_{\lambda}$ the irreducible character of $\mathfrak{S}_{n}$ (with the convention of [GePf]: for instance $\chi_{n}=1$ and $\chi_{1^{n}}=\varepsilon$ ), by $\operatorname{cor}_{d}(\lambda)$ the $d$-core of $\lambda, \operatorname{by~quo}_{d}(\lambda)$ its $d$-quotient. We let $\operatorname{Part}(n, d)$ denote the set of partitions of $n$ whose $d$-core is the unique partition of $j \in\{0,1\}$. Then the map

$$
\operatorname{quo}_{d}: \operatorname{Part}(n, d) \longrightarrow \operatorname{Part}^{d}(r)
$$

is bijective. Finally, if $\mu \in \operatorname{Part}^{d}(r)$, we denote by $\chi_{\mu}$ the associated irreducible character of $C_{W}\left(w_{d}\right)=G(d, 1, r)$ (with the convention of [GeJa]). It follows from Murnaghan-Nakayama rule that

$$
\begin{equation*}
\chi_{\lambda}\left(w_{d}\right) \neq 0 \text { if and only if } \lambda \in \operatorname{Part}(n, d), \tag{5.7}
\end{equation*}
$$

and that

$$
\begin{equation*}
\chi_{\lambda}\left(w_{d}\right)= \pm \chi_{\operatorname{quo}_{d}(\lambda)}(1) \tag{5.8}
\end{equation*}
$$

for all $\lambda \in \operatorname{Part}(n, d)$ (see for instance [BMM1, Page 47]).
Now, the smoothness of $\mathscr{E}_{k}$ implies that the map $\varphi_{k}: \operatorname{Irr}\left(\mathfrak{S}_{n}\right) \longrightarrow \mathscr{X}_{k}^{\mathbb{C}^{\times}}$is bijective (so that Calogero-Moser $k$-families of $\mathfrak{S}_{n}$ are singleton) and it follows from [BoMa] that Conjecture 5.1 holds (except that we do not know if the isomorphism respects the Poisson structure), so that we have a $\mathbb{C}^{\times}$-equivariant isomorphism of varieties

$$
\iota_{k}:\left(\mathscr{E}_{k}^{\mu_{d}}\right)_{\max } \xrightarrow{\sim} \mathscr{I}_{\lambda(k)}\left(V^{\tau_{d}}, G(d, 1, r)\right)
$$

for some explicit $\lambda(k) \in \mathbb{C}^{\aleph_{\tau_{d}}}$. Moreover, $\mathscr{I}_{\lambda(k)}\left(V^{\tau_{d}}, G(d, 1, r)\right)$ is smooth so that the map $\varphi_{\lambda(k)}^{\tau_{d}}: \operatorname{Irr}(G(d, 1, r)) \longrightarrow \mathscr{I}_{\lambda(k)}\left(V^{\tau_{d}}, G(d, 1, r)\right)^{\mathbb{C}^{\times}}$is bijective (that is, Calogero-Moser $\lambda(k)$ families of $G(d, 1, r)$ are singleton). Now, by [BoMa], we have that

$$
\begin{equation*}
\varphi_{k}\left(\chi_{\lambda}\right) \in\left(\mathscr{X}_{k}^{\mu_{d}}\right)_{\max } \text { if and only if } \lambda \in \operatorname{Part}(n, d) \tag{5.9}
\end{equation*}
$$

and that

$$
\begin{equation*}
\iota_{k}\left(\varphi_{k}\left(\chi_{\lambda}\right)\right)=\varphi_{\lambda(k)}^{\tau_{d}}\left(\chi_{\operatorname{quo}_{d}(\lambda)}\right) \tag{5.10}
\end{equation*}
$$

for all $\lambda \in \operatorname{Part}(n, d)$. Then (5.7), (5.8), (5.9) and (5.10) show that Conjectures 5.4 and 5.2 hold for the symmetric group.
