PEG-cored phosphorus dendrimers: Synthesis and functionalization

ABSTRACT

Dendrimers are macromolecular hyperbranched nano-structures, which properties are mainly driven by the type of their terminal functions. This paper reports the synthesis of dendritic structures built from difunctional polyethylene glycols (PEGs) used as core. Three different PEG lengths have been used: PEG_{300} (ca 6 CH_2CH_2 -O units), PEG_{1000} (ca 22 CH_2CH_2 -O units), and PEG_{2000} (ca 45 CH_2CH_2 -O units). The first level of branching units is based on a dialdehyde of a dipiperazine triazine derivative. The second and third level of branching units are constituted of phosphorhydrazone linkages. The growing of the dendritic branches was found extremely slow with both PEG_{1000} and PEG_{2000} used as core, and was stopped early, whereas this problem was not observed with PEG_{300} used as core. These PEG-cored dendritic structures were finally functionalized on the surface with two types of nitrogen ligands.

Introduction

Dendrimers are monodispersed macromolecular hyperbranched structures, consisting of three basic architectural components, namely a core, an interior of monomer shells (named generations) consisting of repeating branch-cell units, and terminal functional groups which constitute the outer shell or periphery [1,2]. Most properties of dendrimers are governed by the nature of the terminal functional groups, even if the internal structure can play a key role, in particular for biology/nanomedicine [3]. The solubility in water of dendrimers is of utmost importance when considering their biological properties. In many cases, water-solubility is attained when having either positive [4] or negative charges on the surface. The most classical dendrimers such as PAMAM (polyamidoamine) [5] and PPI (polypropyleneimine) dendrimers [6,7] have nitrogen atoms as branching points, which can be easily protonated to increase the solubility in water. Besides charged entities, in the internal structure or on the surface, polyethylene glycol (PEG) is widely used as a neutral polymer, soluble in a large variety of solvents, including in water. A large number of dendrimers have been functionalized on their surface with PEGs of variable length, either on all the terminal functions [8], or on some of the terminal functions

(stochastic grafting) [9]. Another way to increase the solubility of dendrimers in water, based on using a PEG polymer as core, with a dendritic wedge (dendron) grown on each side, has been developed. A non-exhaustive list of references concerning hybrid PEG-cored dendrimers comprises PAMAM dendrons [10–13], 1,3,5-triazine dendrons [14], L-Lysine dendrons [15–17], ether dendrons [18,19], ester dendrons [20,21], small citric acid dendrons [22], and special dendrons synthesized through orthogonal amine/epoxy and thiol-yne chemistries [23], but there is no example to date of PEG-cored phosphorus dendrimers.

However, phosphorus dendrimers [24], and especially phosphorhy-drazone dendrimers have outstanding properties for catalysis [25], materials [26], and above all for nanomedicine [27,28]. The synthesis of such dendrimers has been already carried out starting from different cores, in particular P(S)Cl₃ [29], N₃P₃Cl₆ [30,31], which can be specifically functionalized [32], but also an octaaldehyde phthalocyanine [33,34], or a fluorescent linker [35]. This paper will present our results concerning the synthesis of the first PEG-cored phosphorhydrazone dendrimers, and representative examples of their surface functionalization with nitrogen ligands. Indeed, such type of ligands is able to complex diverse metals, and was recently found suitable for catalyzing

Heck and Sonogashira couplings when complexing $PdCl_2$ on the periphery of phosphorhydrazone dendrimers [36]. The same family of dendrimers functionalized with nitrogen ligands also displays original anti-cancer properties when complexing $CuCl_2$ [37], or $[AuCl_2^+]$ [AuCl₄] [38], but not $FeCl_2$ [39]. However, none of these complexes is soluble in water, which precludes real practical use in nanomedicine. We report here our efforts to try to increase the solubility in water of dendritic nitrogen ligands by introducing a PEG of variable length at the core.

Results and discussions

Synthesis of PEG-cored phosphorhydrazone dendrimers

Dihydroxy polyethylene glycols (PEGs) with different molar masses were chosen as core (**1a**, **1b**, and **1c**, Scheme **1**). Small, medium, and large PEGs, with MW = 300, 1000, and 2000 g mol⁻¹ (in average, 6, 22 and 45 O-CH₂-CH₂- units, respectively) were selected. As the classical synthesis of phosphorus dendrimers necessitates at one step the presence of aldehydes [29], we choose a di-(piperazinoaldehyde) (compound **2**) built from 2,4,6-trichloro-1,3,5-triazine, which was previously used as precursor of a building block suitable for the synthesis of original dendrimers. The presence of such structure (compound **2**) induces special color features, as the dendritic structures in which it is incorporated are either yellow or orange/red, depending on the synthetic step considered, and on the environment [40].

The reaction was carried out with 2 equiv. of the dialdehyde 2, and one equiv. of the dihydroxy-PEGs 1a-c, with KOH as base in refluxing dichloromethane, to afford generation zero dendrimers 3a-G'0, 3b-G'0 and 3c-G'₀ (Scheme 1). The reaction was monitored by ¹³C {¹H} NMR, showing the disappearance of the signals at 61 and 72.5 ppm corresponding to the carbon atoms in the α and β position of the PEG hydroxyl group, in favour of the appearance of signals at 66.9 and 69.2 ppm. Concurrently, ¹H NMR spectra of the three compounds **3a-G'**₀, **3b-G'**₀ and 3c-G'₀ showed signals related to the aldehyde functions at ca 9.82 ppm, aromatic protons at ca 6.95 and 7.80 ppm and the signals for the piperazine protons at ca 3.48 and 4.00 ppm. The PEG chain displayed a broad signal between 3.4 and 3.8 ppm, whatever the chain length was. The ¹³C {¹H} NMR showed the presence of two signals for the carbon atoms of the 1,3,5-triazine ring, one at 170.75 ppm for the carbon atom bearing the oxygen atom and the other at 165.6 ppm for the carbon atoms bearing the piperazine cycles. Compounds, 3a-G'0, 3b-G'0 and 3c-G'₀ were isolated in 79%, 65% and 87% yield, respectively. Deceptively, dendrimer 3a-G'0 with a PEG300 as core is not soluble in water, but dendrimers 3b-G'0 and 3c-G'0 with PEG1000 and PEG2000 as core, respectively, are water-soluble.

As in the "classical" synthesis of phosphorus dendrimers [29], the next step involved the condensation of the phosphorhydrazide 4 on the aldehyde functions of compounds $3a\text{-c-G'}_0$, in chloroform. The reaction was monitored with $^{31}\text{P}\{^{1}\text{H}\}$ NMR, by the appearance of a singlet at ca 63 ppm, and with ^{1}H NMR, by the disappearance of the aldehyde proton signal. The synthesis of the first generation dendrimer $3a\text{-G}_1$ was

performed at room temperature for 24 h, whereas the synthesis of the first generation dendrimers $3b\text{-}G_1$ and $3c\text{-}G_1$ required heating at 40° C for three weeks (Scheme 2). After completion of the reaction and purification, these first generation dendrimers were isolated in 56%, 68% and 71% yield, respectively.

These differences, i.e. the increase in temperature but also time to perform the reaction, could be explained by the fact that increasing the size of PEGs can create different geometries (Fig. 1), as already proposed [14]. It is obvious that the terminal functions should be more easily accessible for the PEG $_{300}$ core than for the PEG $_{2000}$ core, which could hide the functional groups.

In view of the very long reaction times needed for the synthesis of dendrimers $3b\text{-}G_1$ and $3c\text{-}G_1$, only $3a\text{-}G_1$ was used for the preparation of higher generation dendrimers. The chlorine atoms of $3a\text{-}G_1$ were substituted with 8 equiv. of 4-hydroxybenzaldehyde 5, in the presence of cesium carbonate, at room temperature in THF, to afford dendrimer $3a\text{-}G'_1$, functionalized with 8 aldehydes (Scheme 3). The reaction was monitored by $^{31}\text{P}\{^1\text{H}\}$ NMR, which showed that the signal corresponding to the phosphorus atoms in the P(S)Cl₂ group at 63.12 ppm disappeared in favor of a more shielded signal at 60.85 ppm. Furthermore, the signal for aldehyde protons was clearly observable in ^1H NMR at 9.95 ppm. Dendrimer $3a\text{-}G'_1$ was obtained as yellow-orange solid with 65% yield.

The 2nd generation dendrimer 3a- G_2 was obtained by condensation reaction of the phosphorhydrazide 4 on the aldehyde functions of 3a- G'_1 , as was done previously for the synthesis of 3a- G_1 from 3a- G'_0 (Scheme 4). The reaction was followed by 1 H NMR, via the disappearance of the aldehyde signal. Dendrimer 3a- G_2 is characterized in particular by the presence of two singlets in 31 P{ 1 H} NMR, at 62.04 ppm, corresponding to the internal layer of phosphorus atoms, and at 63.03 ppm corresponding to the terminal P(S)Cl $_2$ functions. Dendrimer 3a- G_2 was obtained as a red solid in 86% yield.

The synthesis of the second generation dendrimer bearing aldehyde terminal functions, 3a- G'_2 was carried out by substituting the chlorine atoms of 3a- G_2 by 16 equiv. of 4-hydroxybenzaldehyde 5 in the presence of cesium carbonate (Scheme 5), as done previously for the synthesis of 3a- G'_1 from 3a- G_1 . The reaction was followed by 31 P 1 H 1 H 1 NMR spectroscopy, which displayed a shielding of the signal of the phosphorus atoms at the periphery of the dendritic structure, from 63.03 ppm for 3a- G_2 (P(S)Cl₂) to 60.55 ppm for 3a- G'_2 (P(S)(OAr)₂). The obtained compound 3a- G'_2 was isolated as red solid in 62% yield. In view of the facility of the reactions carried out at each step, higher generations could be obtained, but we decided to stop the growing of this hybrid dendrimer/polymer at this step.

Functionalization of the surface of PEG-cored dendrimers with N,N-ligands

We have already shown the usefulness of diverse types of nitrogen ligands for catalysis and for biology [41], as indicated in the introduction. In a first attempt, we have functionalized the PEG-cored dendrimers bearing aldehyde terminal functions with 2-hydrazinopyridine, 6. The condensation reactions were first carried out with the generation

zero dendrimers 3a-c-G'0, by heating in THF, to afford compounds 7a-c-G'0 (Scheme 6). Under these conditions, the condensation was relatively fast (2 days) with dendrimer 3a-G'0, but very slow with dendrimers 3b-G'0 which needed 9 days at 40 °C and above all with dendrimer 3c-G'0, which needed 9 days at 40 °C, followed by 10 days at reflux, to go to completion. Such behavior is reminiscent to what we have observed for the condensation of the same dendrimers with the phosphorhydrazide 4,

and is certainly due here also to the shielding of the active functions by the long PEG chain. The reaction was monitored with ^1H NMR by the disappearance of the characteristic signals of aldehyde functions at 9.82 ppm. Compounds **7a-c-G'0** were characterized with ^{13}C { ^1H } NMR by a signal at 126.2 ppm, characteristic of the carbon atom of the CH = N bond formed and a signal at 7.74 ppm in ^1H NMR for the corresponding proton. Compounds **7a-G'0**, **7b-G'0**, and **7c-G'0** were isolated in 75%,

98%, and 99% yield, respectively.

The condensation reaction of 2-hydrazinopyridine with the 1st generation dendrimer $3a\text{-}G'_1$ was also carried out at room temperature, but it needed 7 days to afford $7a\text{-}G'_1$ (Scheme 7). The reaction was monitored by $^{31}\text{P}\{^1\text{H}\}$ NMR spectroscopy, which showed a slight signal shielding, from 60.85 ppm to 60.25 ppm. The ^1H NMR spectrum displayed both the disappearance of the signal corresponding to the aldehyde functions, and the appearance of the signal of the CH = N at 7.92 ppm. Dendrimer $7a\text{-}G'_1$ was isolated as a red powder in 93 % yield.

The second type of reaction used for grafting nitrogen ligands on the PEG-cored dendrimers was carried out with the phenol 8, synthesized by condensation reaction, between tyramine and di-2-pyridyl ketone, as recently published [36]. Such phenol is suitable for the grafting to P(S) Cl_2 terminal functions of the dendrimers. The reaction was performed with dendrimer $3a\text{-}G_1$, in THF, in the presence of cesium carbonate, at room temperature, to afford dendrimer $9a\text{-}G_1$ in 65% yield (Scheme 8). The reaction was monitored by $^{31}\text{P}\{^{1}\text{H}\}$ NMR, which showed the

shielding of the signal from 62.56 ppm to 60.45 ppm in CDCl₃.

Complexation of copper has been attempted with some of the dendrimers bearing the iminopyridine N,N-ligands as terminal functions. Dendrimers 7a-G'0 and 7a-G'1 were dissolved in DMF, then an excess of a solution of CuCl2 was gradually added (8.78 equiv. for 7a-G'0, for maximum 8 equiv. needed; 17.37 equiv. for 7a-G'1, for maximum 12 equiv. needed), considering that both the pyridine imine, and the piperazine could complex copper. Afterwards, this excess of copper was removed by washing with methanol until a colorless washing solution was obtained. The copper species were obtained as dark brown powders in good yields, 91 and 92% yield, respectively. They are slightly soluble in DMF and DMSO, but not in water or in other organic solvents. Their NMR spectra could not be recorded, as these species are both very poorly soluble as indicated, and paramagnetic, due to the presence of copper (II). Thus, these species have neither been characterized, nor been tested in biology.

Conclusion

The first PEG-cored phosphorus dendrimers have been synthesized, characterized, and functionalized with nitrogen ligands. A large difference in the reactivity and in the properties has been observed, depending on the PEG length. Dendritic structures incorporating as core the smallest PEG (PEG $_{300}$) can be easily processed. No difference in reactivity was observed, when compared with "classical" phosphorhydrazone dendrimers built from a N₃P₃ core. However, deceptively $\ensuremath{\mathsf{PEG}}_{300}$ is not large enough to induce solubility in water. The reactions of compounds in which the largest PEGs (medium PEG₁₀₀₀ and large PEG₂₀₀₀) were used as core needed several weeks of heating to go to completion, most probably because the terminal "reactive" functions are buried inside the PEG, and thus shielded. So, despite the fact that the presence of a larger PEG could induce solubility in water, at least for the smallest synthesized dendritic wedges, the lengthy reaction time precludes a really practical use of such PEG as core. Incorporation of PEG moiety -only- as core of phosphorus dendrimers was inadequate to attain sufficient water solubility. Probably, it would be more advantageous to include PEG chain within the branches of dendrimers, which could potentially solve also the shielding of terminal functional groups by the long PEG chain. However, the resulting compounds would be more

hyperbranched polymers than dendrimers.

On the other hand, due to the very poor solubility of the copper complexes formed with PEG-cored dendrimers, they could not be characterized and exploited. However, this work confirms the usefulness of the 1,3,5-triazine piperazine dialdehyde derivative (compound 2) to afford colored compounds [40]. Indeed, even if present in relatively small quantities, such as in dendrimer 3a-G'2, a red powder could be obtained. In contrast, the synthesis of "normal" phosphorhydrazone dendrimers always leads to white powders. Therefore, in our group work is in progress to develop the design of new dendrimers incorporating synthon 2, as potential tools for staining cells or for coloring hard surfaces.

Experimental section

General

All reactions were carried out in the absence of air using standard Schlenk techniques and vacuum-line manipulations. Commercial samples were used as received. All solvents were dried and purified with MBraun SPS 800 solvent purification system before use. 1 H, 13 C, and 31 P NMR measurements were performed on Bruker AV300 and AV400.

Coupling constants are reported in Hz and chemical shifts in ppm relative to TMS for ¹H and ¹³C NMR. Chemical shifts for ³¹P NMR spectra are calibrated with phosphoric acid as an internal reference. The first-order peak patterns are indicated as s (singlet), d (doublet), t (triplet), q (quadruplet), qn (quintuplet). Complex non-first-order signals are indicated as m (multiplet); broad signals are indicated as br. ¹³C NMR signals were assigned using Jmod, HMQC and HMBC sequences when required. Due to the presence of solvents inside the dendrimers, no reliable elemental analyzes could be obtained. The presence of solvents is necessary to ensure the solubility of the dendrimers in the next synthetic step. If they are removed, the dendrimers could not be solubilized again, even when using ultrasounds or heating. Compound 2 was synthesized as published [40], as well as compound 8 [36]. The numbering used for the assignment of NMR signals is shown in Fig. 2.

Synthesis of dendrimer 3a-G'0

A solution of PEG₃₀₀, 1.0 g (3.34 mmol) in 10 mL of dichloromethane (DCM) was added dropwise to a solution of 20 mL of DCM containing 3.62 g of **2** (7.35 mmol) and 412 mg of KOH, at T = 40° C. The reaction mixture was heated to reflux for 24 h. After thin layer chromatography (TLC) control, a filtration followed by column purification was performed (DCM/ethyl acetate 3/1 then 10% ethanol, v/v). After evaporation of the solvents under vacuum, 3.17 g of **3a-G'**₀ as a reddish solid were obtained (79% yield). ¹H NMR (400 MHz, CDCl₃): δ (ppm) = 3.48 (br s, H-C₆, 16H), 3.66–3.71 (m, H-Cp, 16H), 3.85 (t, H-C₂, $^3J_{\text{HH}}$ = 5.1 Hz, 4H), 4.00 (br s, H-C₅, 16H), 4.49 (t, H-C₁, $^3J_{\text{HH}}$ = 5.7 Hz, 4H), 6.96 (d, H-C₈, $^3J_{\text{HH}}$ = 9 Hz, 8H), 7.81 (d, H-C₉, $^3J_{\text{HH}}$ = 8.7 Hz, 8H), 9.82 (s, H-C₁₁, 4H). ¹³C {¹H} NMR (100 MHz, CDCl₃): δ (ppm) = 42.8 (s, C₅), 47.0 (s, C₆), 65.7 (s, C₁), 69.2 (s, C₂), 70.6 (s, C_p), 113.7 (s, C₈), 127.5 (s, C₁₀),

131.9 (s, C_9), 154.8 (s, C_7), 166.0 (s, C_4), 170.9 (s, C_3), 190. 4 (s, C_{11}).

Synthesis of dendrimer 3b-G'o

A solution of PEG₁₀₀₀, 2.0 g (2.0 mmol) in 10 mL of DCM was added dropwise to a solution of 15 mL of DCM containing 2.01 g of **2** (4.1 mmol) and 230 mg of KOH, at T = 40° C. The reaction mixture was refluxed for 48 h. After separating the salts by centrifugation and evaporating the solvent, 10 mL of water were added to precipitate the excess of **2**. After filtration, the aqueous solution was placed in freeze dryer to remove water. 2.44 g of **3b-G'**₀ were obtained as a yellow solid (65% yield). ¹H NMR (400 MHz, CDCl₃): δ (ppm) = 3.43 (br s, H-C₆, 16H), 3.60–3.67 (m, H-Cp, 80H), 3.78 (t, H-C₂, $^3J_{\rm HH}$ = 5.1 Hz, 4H), 3.94 (br s, H-C₅, 16H), 4.48 (t, H-C₁, $^3J_{\rm HH}$ = 5.7 Hz, 4H), 6.90 (d, H-C₈, $^3J_{\rm HH}$ = 9 Hz, 8H), 7.73 (d, H-C₉, $^3J_{\rm HH}$ = 8.7 Hz, 8H), 9.74 (s, H-C₁₁, 4H). ¹³C (¹H} NMR (100 MHz, CDCl₃): δ (ppm) = 42.7 (s, C₅), 46.8 (s, C₆), 66.9 (s, C₁), 69.2 (s, C₂), 70.6 (s, C_p), 113.6 (s, C₈), 127.3 (s, C₁₀), 131.9 (s, C₉), 154.8 (s, C₇),166.2 (s, C₄), 170.8 (s, C₃), 190.4 (s, C₁₁).

Synthesis of dendrimer 3c-G'o

Synthesis of dendrimer 3a-G1
