GLOBAL WEAK SOLUTIONS OF THE SERRE–GREEN–NAGHDI EQUATIONS WITH SURFACE TENSION

ABSTRACT. We consider in this paper the Serre–Green–Naghdi equations with surface tension. Smooth solutions of this system conserve an H^1 -equivalent energy. We prove the existence of a strongly continuous semigroup of global weak dissipative solutions for any relatively small-energy initial data. We prove also that the Riemann invariants of the solutions satisfy the one-sided Oleinik inequality.

1. Introduction

The Euler equations are usually used to describe water waves in oceans and Channels. Due to the difficulties to resolve the Euler equations numerically and analytically, several simpler approximations have been proposed in the literature for different regimes. In the shallow water regime, the main assumption is on the ratio of the mean water depth \bar{h} to the wave wave-length ι , the shallowness parameter $\sigma = \bar{h}^2/\iota^2$ is considered to be small. Beside the shallowness condition, a restriction on the amplitude of the wave a can be considered assuming that the nonlinearity (or the amplitude) parameter $\epsilon = a/\bar{h}$ is small. Considering the shallow water regime with the small-amplitude condition [28, 34] ($\sigma \ll 1$, $\epsilon \ll 1$). Many equations have been derived to model the propagation of the waves, such

as the Camassa–Holm equation [9], the Korteweg–deVries (KdV) equation [33] and some variants of the Boussinesq equations [7, 8]. Considering shallow water with possibly large-amplitude waves ($\sigma \ll 1$, $\epsilon \approx 1$), by neglecting the terms of order $O(\sigma)$ in the water waves equations, Saint-Venant obtained the Nonlinear Shallow Water (or Saint-Venant) equations [50]. Smooth solutions of the Saint-Venant equations have a precision of order $O(\tau)$, where t denotes the time [34]. In order to obtain a better precision, one can keep the $O(\sigma)$ terms in the equations and only neglect the $O(\sigma^2)$ terms. This leads to the Serre–Green–Naghdi equations. Those equations were firstly derived by Serre [46], rediscovered independently by Su and Gardner [49] and another time by Green, Laws and Naghdi [22, 23]. The Serre–Green–Naghdi equations are the most general with the best precision, but also the most complicated of the models of shallow water equations presented above. Of course, one can always keep higher order terms in the equation (keeping terms of order $O(\sigma^2)$ for example), this will lead to equations with a better precision, but with higher order derivatives. Those equations are not accurate due to the high order derivative terms which make their numerical resolution much slower.

The influence of the surface tension is generally neglected on water waves problems. However, in certain cases, the effect of the surface tension is appreciable. Indeed, Longuet-Higgins [39] showed that the surface tension is locally important, and cannot be neglected near the sharp crest of the breaking wave. Other experimental studies showed the importance of the surface tension on thin layers [20, 42, 43]. Those experimentations have been done for different fluids including water and mercury. Various mathematical studies of water waves equations with surface tension exit in the literature, we refer to [2, 3, 4, 6, 11, 12, 40, 45, 47, 52].




Figure 1. Fluid domain.

Considering a two-dimensional coordinate system Oxy (Figure 1) and an incompressible fluid layer. Considering the still fluid level at y=0, the fluid layer is bounded between the flat bottom at $y=-\bar{h}$ and a free surface $y=h(t,x)-\bar{h}$, where h is the total water depth. Assuming long waves in shallow water with possibly large-amplitude. The Serre-Green-Naghdi system (without neglecting the surface tension influence) reads

$$h_t + [hu]_x = 0,$$
 (1.1a)

$$[hu]_t + [hu^2 + \frac{1}{2}gh^2 + \mathcal{R}]_x = 0,$$
 (1.1b)

$$\mathscr{R} \stackrel{\text{def}}{=} \frac{1}{3} h^3 \left(-u_{tx} - u u_{xx} + u_x^2 \right) - \gamma \left(h h_{xx} - \frac{1}{2} h_x^2 \right), \tag{1.1c}$$

where u denotes the depth-averaged horizontal velocity, g is the gravitational acceleration and $\gamma > 0$ is a constant (the ratio of the surface tension coefficient to the density). The classical Serre–Green–Naghdi equations (without surface tension) are recovered taking $\gamma = 0$. The Serre–Green–Naghdi (SGN $_{\gamma}$) equations (1.1) have been derived in [16] as a generalisation of the classical SGN equations ($\gamma = 0$). Due to the appearance of time derivatives in (1.1c), it is convenient to apply the inverse of the Sturm–Liouville operator

$$\mathcal{L}_h \stackrel{\text{def}}{=} h - \frac{1}{3} \partial_x h^3 \partial_x, \tag{1.2}$$

the system (1.1) becomes then

$$h_t + [hu]_x = 0,$$
 (1.3a)

$$u_t + u u_x + g h_x = -\mathcal{L}_h^{-1} \partial_x \left\{ \frac{2}{3} h^3 u_x^2 - \left[\gamma h - \frac{1}{3} g h^3 \right] h_{xx} + \frac{1}{2} \gamma h_x^2 \right\}.$$
 (1.3b)

When h > 0, the operator \mathcal{L}_h^{-1} is well defined and smoothes two derivatives (see Lemma 4.2 below). This is not enough to control the term containing h_{xx} on the right-hand side of (1.3b). To overcome this problem, we use the definition of \mathcal{L}_h to rewrite the system (1.3) in the equivalent form

$$h_t + [hu]_x = 0,$$
 (1.4a)

$$u_t + u u_x + 3\gamma h^{-2} h_x = -\mathcal{L}_h^{-1} \partial_x \left\{ \frac{2}{3} h^3 u_x^2 - \frac{3}{2} \gamma h_x^2 + \frac{1}{2} g h^2 - 3\gamma \ln(h) \right\}.$$
 (1.4b)

Smooth solutions of the SGN_{γ} equations (1.4) satisfy the energy equation (see Appendix B)

$$\mathscr{E}_t + \mathscr{D}_x = 0, \tag{1.5}$$

where

$$\mathscr{E} \stackrel{\text{def}}{=} \frac{1}{2}h u^2 + \frac{1}{2}g (h - \bar{h})^2 + \frac{1}{6}h^3 u_x^2 + \frac{1}{2}\gamma h_x^2, \tag{1.6}$$

$$\mathscr{D} \stackrel{\text{def}}{=} u \mathscr{E} + u \left(\mathscr{R} + \frac{1}{2} g h^2 - \frac{1}{2} g \bar{h}^2 \right) + \gamma h h_x u_x. \tag{1.7}$$

Linearising the SGN $_{\gamma}$ equations (1.4) around the constant state $(h, u) = (\bar{h}, 0)$ and looking for travelling waves having the form $\exp\{(kx - \omega t)i\}$ we obtain the dispersion relation $\omega^2 = g\bar{h}k^2(1 + \gamma k^2/g) / (1 + \bar{h}^2k^2/3)$. Defining the Bond number $B = g\bar{h}^2/\gamma$, the SGN $_{\gamma}$ equations are linearly dispersive if and only if $B \neq 3$. In the dispersionless case (B = 3), the SGN $_{\gamma}$ equations admit weakly singular peakon travelling wave solutions [18, 41]. A mathematical study of the Serre–Green–Naghdi equations with or without surface tension have been widely studied in the literature. We refer to [1, 27, 31, 32, 34, 36] for the case inf $h_0 > 0$ and to [35] for the shoreline problem (sign $(h) = \mathbb{1}_{x>x_0}$). In [1, 27, 36], a proof of the local well-posedness of the SGN equations without surface tension $(\gamma = 0)$ is given. Kazerani has proved in [31] the existence of global smooth solutions of the SGN equations with viscosity for small initial data. A full justification of the model (1.4) is given in [32, 34]. By "full justification" we mean local well-posedness of the system and, the solution is close to the solution of the water waves equations with the same initial data. In a recent work [24], we have obtained a precise blow-up criterion of (1.4) (Theorem 2.3)

below) and we proved that such scenario occurs for a class of small-energy initial data (Theorem 2.6 below). Then, in general, smooth (strong) solutions cannot exist globally in time.

The aim of present paper is to study the existence and the stability of global weak solutions of (1.4). To the author's knowledge, the existence of global weak solutions of all the different variants of the inviscid Serre–Green–Naghdi equations has not been established before. We consider $\gamma > 0$ and initial data satisfying $\int \mathcal{E}_0 dx < \sqrt{g\gamma} \bar{h}^2$, using a Sobolev-like inequality (essentially $H^1 \hookrightarrow L^{\infty}$, see Proposition 2.4 below) we obtain a lower bound of h. The energy conservation (1.5) insures that this bound holds for all time. For this class of initial data, we prove in this paper the existence of a strongly continuous semigroup of global weak solutions dissipating the energy and satisfying the one-sided Oleinik inequality

$$u_x \pm \sqrt{3\gamma} h^{-\frac{3}{2}} h_x \leqslant C (1+t^{-1}).$$

In order to obtain the global solutions of (1.4), we note that the blow-up of smooth solutions given in Theorem 2.6 below is due to the quadratic terms on the write-hand side of the Riccati-type equations. Then, as in [55, 56], we use cut-off functions to overcome the quadratic growth. This leads to an approximation of the system (1.4) which admits global smooth solutions. In order to obtain the global weak solutions of (1.4), uniform estimates are needed. In the previous studies of smooth solutions of the SGN equations, estimates of the operator \mathcal{L}_h^{-1} are presented, those estimates usually depend on the L^{∞} norm of h_x . This is not practical for weak solutions, then, we present in Lemma 4.2 below some estimates depending only on the L^{∞} norm of h and 1/h. Using the uniform estimates and some compactness arguments with Young measures we can prove that the limit is a weak solution of (1.4).

In order to obtain the stability result, we prove firstly that the difference between two solutions of the approximate system is controlled by the difference between the initial data in H^1 with constant that goes to ∞ when passing to the limit. At the first sight, since the constant is not bounded, it seems that the stability of (1.4) cannot be established by taking the limit. However, following [14] and with a suitable choice of a subsequence, we obtain the stability result of (1.4).

The SGN_{γ} equations (1.1) can be compared with the dispersionless regularised Saint-Venant (rSV) system presented in [10]. The rSV system can be obtained replacing \mathscr{R} in (1.1c) by $\varepsilon \mathscr{R}_{rSV}$ with

$$\mathcal{R}_{rSV} \stackrel{\text{def}}{=} h^3 \left(u_x^2 - u_{xt} - u u_{xx} \right) - g h^2 \left(h h_{xx} + \frac{1}{2} h_x^2 \right)$$

and $\varepsilon \geqslant 0$, the classical Saint-Venant system is recovered taking $\varepsilon = 0$. Weakly singular shock profiles of the rSV equations are studied in [44]. In [38], Liu et al. proved the local well-posedness of the rSV equations and identified a class of initial data such that the corresponding solutions blow-up in finite time. The rSV system have been generalised recently to obtain a regularisation of any unidimensional barotropic Euler (rE) system [25]. The system (1.1) can also be compared with the modified Serre–Green–Naghdi (mSGN) equations derived in [13] to improve the dispersion relation of the classical SGN system.

The mSGN system presented in [13] can be obtained replacing \mathcal{R} in (1.1c) by

$$\mathscr{R}_{mSGN} \stackrel{\text{def}}{=} \frac{1}{3} \left(1 + \frac{3}{2} \beta \right) h^3 \left(-u_{tx} - u u_{xx} + u_x^2 \right) - \frac{1}{2} \beta g h^2 \left(h h_{xx} + \frac{1}{2} h_x^2 \right).$$

where β is a positive parameter. The rSV, rE and mSGN conserve H^1 -equivalent energies and have similar properties as the SGN $_{\gamma}$ system (1.1). One may can obtain the existence of global weak solutions of those equations following the proof given in this paper.

The study of the classical Serre-Green-Naghdi equations is more challenging. Indeed, when $\gamma = 0$, the energy (1.6) fails to control the H^1 norm of $h - \bar{h}$, then, a lower bound of h cannot be obtained. This bound is crucial to obtaining the blow-up result [24] and the global existence in this paper for $\gamma > 0$. To the author's knowledge, the questions of the blow-up of smooth solutions and the existence of global solutions of the SGN equations without surface tension are still open. However, Bae and Granero-Belinchén [5] proved recently that for a class of periodic initial data satisfying inf $h_0 = 0$, smooth solutions cannot exist globally in time. For this class of initial data, it is not known if smooth solutions exist locally in time, but if they do, a singularity must appear in finite time.

This paper is organised as follows. In Section 2 we present the local well-posedness of (1.4) and the blow-up result, then, we define the weak solutions and we present the existence of the strongly continuous semigroup of global weak solutions. We discuss in Section 3 the properties needed of the approximate system and we propose a suitable choice. Section 4 is devoted to prove the existence of global smooth solutions of the approximate system and to obtain some uniform estimates. We obtain strong precompactness results in Section 5. The existence of global weak solutions is proved in Section 6. The proof of the existence and the stability of the semigroup is given in Section 7. In Appendix A we recall some classical lemmas that are used in this paper. Appendix B is devoted to obtain the energy equations of the approximate system and of (1.4).

2. Main results

We consider in this section the Serre–Green–Naghdi equations with surface tension in this form

$$h_t + [hu]_x = 0,$$
 (2.1a)

$$u_t + u u_x + 3 \gamma h^{-2} h_x = -\mathcal{L}_h^{-1} \partial_x \{ \mathscr{C} + F(h) \},$$
 (2.1b)

$$u(0,x) = u_0(x), h(0,x) = h_0(x), (2.1c)$$

with

$$\mathscr{C} \stackrel{\text{def}}{=} \frac{2}{3} h^3 u_x^2 - \frac{3}{2} \gamma h_x^2, \tag{2.2}$$

$$F(h) \stackrel{\text{def}}{=} \frac{1}{2} g h^2 - \frac{1}{2} g \bar{h}^2 - 3 \gamma \ln(h/\bar{h}). \tag{2.3}$$

The system (2.1) is locally well-posed in the Sobolev space

$$H^{s}(\mathbb{R}) \stackrel{\text{def}}{=} \left\{ f, \|f\|_{H^{s}(\mathbb{R})}^{2} \stackrel{\text{def}}{=} \int_{\mathbb{R}} \left(1 + |\xi|^{2}\right)^{s} |\hat{f}(\xi)|^{2} d\xi < \infty \right\}$$

where $s \geqslant 2$ is a real number.

Theorem 2.1. Let $\gamma > 0$, $\bar{h} > 0$ and $s \ge 2$, then, for any $(h_0 - \bar{h}, u_0) \in H^s(\mathbb{R})$ satisfying $\inf_{x \in \mathbb{R}} h_0(x) > 0$ there exists T > 0 and $(h - \bar{h}, u) \in C([0, T], H^s(\mathbb{R})) \cap C^1([0, T], H^{s-1}(\mathbb{R}))$ a unique solution of (2.1) such that

$$\inf_{(t,x)\in[0,T]\times\mathbb{R}} h(t,x) > 0.$$

Moreover, the solution satisfies the conservation of the energy

$$\frac{\mathrm{d}}{\mathrm{d}t} \int_{\mathbb{R}} \left(\frac{1}{2} h \, u^2 + \frac{1}{2} g \, (h - \bar{h})^2 + \frac{1}{6} h^3 \, u_x^2 + \frac{1}{2} \gamma \, h_x^2 \right) \, \mathrm{d}x = 0. \tag{2.4}$$

Remark 2.2. The solution given in Theorem 2.1 depends continuously on the initial data, i.e., If $(h_0^1 - \bar{h}, u_0^1), (h_0^2 - \bar{h}, u_0^2) \in H^s$, such that $h_0^1, h_0^2 \geqslant h_{min} > 0$, then for all $t \leqslant T$ there exists a constant $C(\|(h^2 - \bar{h}, u^2)\|_{L^{\infty}([0,t],H^s)}, \|(h^1 - \bar{h}, u^1)\|_{L^{\infty}([0,t],H^s)}) > 0$, such that

$$\left\| \left(h^1 - h^2, u^1 - u^2 \right) \right\|_{L^{\infty}([0,t],H^{s-1})} \, \, \leqslant \, \, C \, \left\| \left(h_0^1 - h_0^2, u_0^1 - u_0^2 \right) \right\|_{H^s}.$$

The proof of Theorem 2.1 is classic and omitted in this paper. See [25, 27, 34, 38] and Theorem 3 of [26] for more details. It is clear from Theorem 2.1 that if the solution at time T remains in H^s and $\inf_x h(T,x) > 0$ then one can extend the interval of existence. This leads to the blow-up criterion

$$T_{max} < \infty \implies \liminf_{t \to T_{max}} \inf_{x \in \mathbb{R}} h(t, x) = 0 \text{ or } \limsup_{t \to T_{max}} \|(h - \bar{h}, u)\|_{H^s} = \infty,$$

where T_{max} is the maximum time existence of the solution. This criterion can be improved as in [24] to

Theorem 2.3. ([24]) Let T_{max} be the maximum time existence of the solution given by Theorem 2.1, then

$$T_{max} < \infty \implies \liminf_{t \to T_{max}} \inf_{x \in \mathbb{R}} h(t, x) = 0 \text{ or } \begin{cases} \liminf_{t \to T_{max}} \inf_{x \in \mathbb{R}} u_x(t, x) = -\infty, \\ \text{ and } \\ \limsup_{t \to T_{max}} \|h_x(t, x)\|_{L^{\infty}} = \infty, \end{cases}$$

which is equivalent to the second criterion

$$T_{max} < \infty \implies \limsup_{t \to T_{max}} \|u_x(t,x)\|_{L^{\infty}} = \infty \text{ and } \begin{cases} \liminf_{t \to T_{max}} \inf_{x \in \mathbb{R}} h(t,x) = 0, \\ \text{or } \\ \limsup_{t \to T_{max}} \|h_x(t,x)\|_{L^{\infty}} = \infty. \end{cases}$$

Noting that the energy conserved in (2.4) is equivalent to the H^1 norm of $(h - \bar{h}, u)$. Due to the continuous embedding $H^1 \hookrightarrow L^{\infty}$ we can obtain a uniform (on time) estimate of $\|(h - \bar{h}, u)\|_{L^{\infty}}$, and, if the initial energy is not very large compared to \bar{h} we can obtain a lower bound of h. For that purpose, we present the following proposition.

Proposition 2.4. For $\gamma > 0$, $\bar{h} > 0$, let E be a positive number such that

$$0 < E < \sqrt{g\gamma} \,\bar{h}^2, \tag{2.5}$$

Defining

$$h_{min} \stackrel{\text{def}}{=} \bar{h} - (g\gamma)^{-\frac{1}{4}} \sqrt{E}, \qquad h_{max} \stackrel{\text{def}}{=} \bar{h} + (g\gamma)^{-\frac{1}{4}} \sqrt{E},$$

$$u_{max} \stackrel{\text{def}}{=} -u_{min} \stackrel{\text{def}}{=} 3^{\frac{1}{4}} \sqrt{E}/h_{min}.$$

Then, for any $(h - \bar{h}, u) \in H^1$ satisfying $\int \mathcal{E} dx \leqslant E$, we have

$$0 < h_{min} \leqslant h \leqslant h_{max} < 2\bar{h}, \qquad u_{min} \leqslant u \leqslant u_{max}, \tag{2.6}$$

Remark 2.5. Taking an initial data satisfying $\int_{\mathbb{R}} \mathscr{E}_0 dx \leq E$, then, due to the energy conservation (2.4) and Proposition 2.4 the depth h cannot vanish. The blow-up criteria given in Theorem 2.3 becomes then

$$T_{max} < \infty \implies \inf_{[0,T_{max}) \times \mathbb{R}} u_x(t,x) = -\infty \quad \text{and} \quad \limsup_{t \to T_{max}} \|h_x(t,x)\|_{L^{\infty}} = \infty.$$

Proof of Proposition 2.4. The Young inequality $\frac{1}{2}a^2 + \frac{1}{2}b^2 \geqslant \pm ab$ implies that

$$E \geqslant \int_{\mathbb{R}} \mathscr{E} \, \mathrm{d}y \geqslant \int_{\mathbb{R}} \left(\frac{1}{2} g (h - \bar{h})^2 + \frac{1}{2} \gamma h_x^2 \right) \, \mathrm{d}x$$

$$\geqslant \sqrt{g \gamma} \left(\int_{-\infty}^x (h - \bar{h}) h_x \, \mathrm{d}y - \int_x^\infty (h - \bar{h}) h_x \, \mathrm{d}y \right)$$

$$\geqslant \sqrt{g \gamma} |h - \bar{h}|^2,$$

which implies that $h_{min} \leq h \leq h_{max}$. Doing the same estimates with u one obtains

$$E \geqslant \int_{\mathbb{R}} \mathscr{E} \, \mathrm{d}y \geqslant \int_{\mathbb{R}} \left(\frac{1}{2} h \, u^2 + \frac{1}{6} h^3 \, u_x^2 \right) \, \mathrm{d}y$$
$$\geqslant \frac{1}{\sqrt{3}} h_{min}^2 \left(\int_{-\infty}^x u \, u_x \, \mathrm{d}y - \int_x^\infty u \, u_x \, \mathrm{d}y \right)$$
$$\geqslant \frac{1}{\sqrt{3}} h_{min}^2 \, |u|^2,$$

the last inequality ends the proof of $u_{min} \leq u \leq u_{max}$.

As in [24], we can build some initial data with small initial data such that the corresponding solutions blow-up in small time.

Theorem 2.6. ([24]) For any T > 0 and E satisfying (2.5), there exist

• $(h_0 - \bar{h}, u_0) \in C_c^{\infty}(\mathbb{R})$ satisfying $\int_{\mathbb{R}} \mathscr{E}_0 dx \leqslant E$ such that the corresponding solution of (2.1) blows-up at finite time $T_{max} \leqslant T$ and

$$\inf_{[0,T_{max})\times\mathbb{R}}u_x(t,x) = -\infty, \quad \sup_{[0,T_{max})\times\mathbb{R}}h_x(t,x) = \infty, \quad \inf_{[0,T_{max})\times\mathbb{R}}h_x(t,x) > -\infty.$$

• $(\tilde{h}_0 - \bar{h}, \tilde{u}_0) \in C_c^{\infty}(\mathbb{R})$ satisfying $\int_{\mathbb{R}} \tilde{\mathcal{E}}_0 dx \leqslant E$ such that the corresponding solution of (2.1) blows-up at finite time $\tilde{T}_{max} \leqslant T$ and

$$\inf_{[0,\tilde{T}_{max})\times\mathbb{R}}\tilde{u}_x(t,x) \ = \ -\infty, \quad \inf_{[0,\tilde{T}_{max})\times\mathbb{R}}\tilde{h}_x(t,x) \ = \ -\infty, \quad \sup_{[0,\tilde{T}_{max})\times\mathbb{R}}\tilde{h}_x(t,x) \ < \ \infty.$$

Since smooth solutions fail to exist globally in time, even for arbitrary small-energy initial data, we shall define weak solutions of the SGN_{γ} system (2.1). For that purpose, we define the domain $\mathfrak{D} \subset H^1$

$$\mathfrak{D} \stackrel{\text{def}}{=} \left\{ \left(h - \bar{h}, u \right) \in H^1, \int_{\mathbb{R}} \mathscr{E} \, \mathrm{d}x < \sqrt{g\gamma} \bar{h}^2 \right\}. \tag{2.7}$$

Definition 2.7. We say that $(h - \bar{h}, u) \in L^{\infty}(\mathbb{R}^+, H^1) \cap \text{Lip}(\mathbb{R}^+, L^2)$ is a weak solution of (2.1) if it satisfies the initial condition (2.1c) with (2.1a) in L^2 and for all $\varphi \in C_c^{\infty}((0, \infty) \times \mathbb{R})$ we have

$$\int_{\mathbb{R}^{+}\times\mathbb{R}} \left\{ \left\{ u_{t} + u u_{x} + 3 \gamma (h)^{-2} h_{x} \right\} \mathcal{L}_{h} \varphi - \varphi_{x} \left\{ \mathscr{C} + F(h) \right\} \right\} dx dt = 0.$$
 (2.8)

Moreover, $(h(t,\cdot) - \bar{h}, u(t,\cdot))$ belongs to \mathfrak{D} for all $t \ge 0$ and $(h - \bar{h}, u) \in C_r(\mathbb{R}^+, H^1)$. More precisely, for all $t_0 \ge 0$ we have

$$\lim_{\substack{t \to t_0 \\ t > t_0}} \| (h(t, \cdot) - h(t_0, \cdot), \ u(t, \cdot) - u(t_0, \cdot)) \|_{H^1} = 0.$$

Now we can state the main result of this paper.

Theorem 2.8. For any $\bar{h}, g, \gamma > 0$ there exists a strongly continuous semigroup

 (2.10) associated to the Cauchy problem (2.1) satisfying the following properties.

- For any $(h_0 \bar{h}, u_0) \in \mathfrak{D}$ the map $(h \bar{h}, u) \stackrel{def}{=} S(h_0 \bar{h}, u_0)$ is a global weak solution of (2.1) in the sense of Definition 2.7.
- For any bounded set $\Omega = [t_1, t_2] \times [a, b] \subset (0, \infty) \times \mathbb{R}$ and $\alpha \in [0, 1)$ the exists $C_{\alpha,\Omega} > 0$ such that

$$\int_{\Omega} \left[|h_t|^{2+\alpha} + |h_x|^{2+\alpha} + |u_t|^{2+\alpha} + |u_x|^{2+\alpha} \right] dx dt \leqslant C_{\alpha,\Omega}.$$
 (2.11)

• The solution dissipates the energy

$$\int_{\mathbb{R}} \mathscr{E} \, \mathrm{d}x \leqslant \int_{\mathbb{R}} \mathscr{E}_0 \, \mathrm{d}x. \tag{2.12}$$

• There exists C > 0 such that the solution satisfies the Oleinik inequality

$$u_x \pm \sqrt{3\gamma} h^{-\frac{3}{2}} h_x \leqslant C \left(1 + \frac{1}{t}\right), \quad a.e. \ (t, x) \in (0, \infty) \times \mathbb{R}.$$
 (2.13)

• The semigroup is stable in the following sense. As $n \to \infty$, if

$$(h_{0,n} - \bar{h}, u_{0,n}) \to (h_0 - \bar{h}, u_0)$$
 in $H^1(\mathbb{R})$,

then

$$S\left(h_{0,n}-\bar{h},u_{0,n}\right)\to S\left(h_0-\bar{h},u_0\right)\quad \text{in }L^{\infty}([0,T],H^1(\mathbb{R})),$$

for any $\{(h_{0,n} - \bar{h}, u_{0,n})\}_n \subset \mathfrak{D}$ and any T > 0.

Remark 2.9. The constants $C_{\alpha,\Omega}$ and C depend on \bar{h}, γ, g and $\int_{\mathbb{R}} \mathscr{E}_0 dx$ but not on the initial data.

In order to obtain global solutions of (2.1), we use a suitable approximation of the system (2.1) that admits global smooth solutions. Using some compactness arguments and taking the limit we recover a global weak solution of (2.1). In the next section we present the choice of the suitable approximate system.

3. An approximate system

The blow-up of the solutions given in Theorem 2.6 is due to the Riccati-type equations. In order to prevent the singularities from appearing, we modify slightly the Riccati-type equations.

3.1. Riccati-type equations. Defining the Riemann invariants 1 R and S

$$R \stackrel{\text{def}}{=} u + 2\sqrt{3\gamma} h^{-\frac{1}{2}}, \qquad S \stackrel{\text{def}}{=} u - 2\sqrt{3\gamma} h^{-\frac{1}{2}},$$
 (3.1)

$$\lambda \stackrel{\text{def}}{=} u - \sqrt{3\gamma} h^{-\frac{1}{2}}, \qquad \eta \stackrel{\text{def}}{=} u + \sqrt{3\gamma} h^{-\frac{1}{2}}. \tag{3.2}$$

The system (2.1) can be rewritten as

$$Q \stackrel{\text{def}}{=} h S_x = h u_x + \sqrt{3\gamma} h^{-\frac{1}{2}} h_x,$$

we have

$$u_x = \frac{P + Q}{2h}, \qquad h_x = h^{\frac{1}{2}} \frac{Q - P}{2\sqrt{3\gamma}}.$$

From the definition of \mathcal{L}_h in (1.2), we obtain that

 (3.5)

for any smooth function Ψ satisfying $\Psi(\pm \infty) = 0$. Then,

$$\mathscr{C} + \frac{1}{3} h^3 \partial_x \mathcal{L}_h^{-1} \partial_x \mathscr{C} = h^3 \partial_x \mathcal{L}_h^{-1} \left(h \int_{-\infty}^x h^{-3} \mathscr{C} \right). \tag{3.6}$$

From (1.1c) and (2.1b) we obtain

$$\mathcal{R} = -\frac{1}{3}h^3 \left[u_t + u u_x + 3\gamma h^{-2} h_x \right]_x + \mathcal{C}$$

$$= \mathcal{C} + \frac{1}{3}h^3 \partial_x \mathcal{L}_h^{-1} \partial_x \left\{ \mathcal{C} + F(h) \right\}$$
(3.7)

¹Those quantities are constants along the characteristics if the right-hand side of (2.1) is zero.

$$= h^3 \partial_x \mathcal{L}_h^{-1} \left(h \int_{-\infty}^x h^{-3} \mathscr{C} \right) + \frac{1}{3} h^3 \partial_x \mathcal{L}_h^{-1} \partial_x F(h). \tag{3.8}$$

Let the characteristics X_x, Y_x starting from x defined as the solutions of the ordinary differential equations

$$\frac{\mathrm{d}}{\mathrm{d}t}X_x(t) = \eta(t, X_x(t)), \qquad X_x(0) = x, \tag{3.9}$$

$$\frac{\mathrm{d}}{\mathrm{d}t}Y_x(t) = \lambda(t, Y_x(t)), \qquad Y_x(0) = x. \tag{3.10}$$

Differentiation (3.3) with respect to x, and using (3.8) we obtain the Ricatti-type equations

$$\frac{\mathrm{d}^{\lambda}}{\mathrm{d}t}P \stackrel{\text{def}}{=} P_t + \lambda P_x = -\frac{1}{8h}P^2 + \frac{1}{8h}Q^2 - 3h^{-2}\mathcal{R}, \tag{3.11a}$$

$$\frac{\mathrm{d}^{\eta}}{\mathrm{d}t}Q \stackrel{\text{def}}{=} Q_t + \eta Q_x = -\frac{1}{8h}Q^2 + \frac{1}{8h}P^2 - 3h^{-2}\mathcal{R}, \tag{3.11b}$$

where $\frac{\mathrm{d}^{\lambda}}{\mathrm{d}t}$, $\frac{\mathrm{d}^{\eta}}{\mathrm{d}t}$ denote the derivatives along the characteristics with the speed λ , η respectively. We prove below that the term \mathscr{R} is bounded. Also, we obtain a bound of the integral of P^2 (respectively Q^2) on the characteristics X_x (respectively Y_x). Then, the singularities given in Theorem 2.6 appear due to the term P^2 in (3.11a) and/or the term Q^2 in (3.11b).

3.2. The choice of the approximate system. In order to obtain a system that admits global smooth solutions, we linearise the negative quadratic terms on the right-hand side of (3.11) on the neighbourhood of $-\infty$. For that purpose, let $\varepsilon > 0$ and we define as in [55, 56]

$$\chi_{\varepsilon}(\zeta) \stackrel{\text{def}}{=} \left(\zeta + \frac{1}{\varepsilon}\right)^2 \mathbb{1}_{(-\infty, -\frac{1}{\varepsilon}]}(\zeta).$$
(3.12)

Noting that (3.11) is like a derivative of (2.1), then, adding terms to (3.11) will involve some primitive terms in (2.1) which are not uniquely defined and cannot vanish at ∞ and $-\infty$. That is why the system (2.1) will not be approximated simply by adding χ_{ε} to (3.11) as in [55, 56].

Our goal is to obtain a system on the form

$$h_t + [h u]_x = h^+,$$

$$u_t + u u_x + 3\gamma h^{-2} h_x = -\mathcal{L}_h^{-1} \partial_x \{ \mathcal{C} + F(h) \} + u^+,$$

where h^+, u^+ are suitable terms to be chosen. As in Section 3.1, we obtain

$$Q_t + \eta Q_x = -\frac{1}{8h} Q^2 + \frac{1}{8h} \chi_{\varepsilon}(Q) + \frac{1}{8h} P^2 - 3h^{-2} \mathcal{R} + \underline{Q},$$

$$\underline{P} \stackrel{\text{def}}{=} h(u^{+})_{x} + u_{x} h^{+} - \sqrt{3\gamma} h^{-1/2} (h^{+})_{x} + \frac{1}{2} \sqrt{3\gamma} h^{-3/2} h_{x} h^{+} - \frac{1}{8h} \chi_{\varepsilon}(P),
Q \stackrel{\text{def}}{=} h(u^{+})_{x} + u_{x} h^{+} + \sqrt{3\gamma} h^{-1/2} (h^{+})_{x} - \frac{1}{2} \sqrt{3\gamma} h^{-3/2} h_{x} h^{+} - \frac{1}{8h} \chi_{\varepsilon}(Q).$$

Due to the definition (3.12), when ζ is near $-\infty$, the term $\chi_{\varepsilon}(\zeta) - \zeta^2$ behaves as a linear map. This prevents singularities from appearing in finite time. From (1.6), we have

$$\mathscr{E} = \frac{1}{2} h u^2 + \frac{1}{2} g (h - \bar{h})^2 + \frac{1}{12} h P^2 + \frac{1}{12} h Q^2.$$

$$\leq h u u^{+} + \frac{1}{2} u^{2} h^{+} + g \left(h - \bar{h} \right) h^{+} + \left(\frac{1}{6} h^{2} u_{x}^{2} + \frac{\gamma}{2h} h_{x}^{2} \right) h^{+}$$

$$+ \frac{1}{6} h P \underline{P} + \frac{1}{6} h Q \underline{Q}.$$

$$(3.13)$$

The goal is to find h^+ and u^+ such that

- The right-hand side of (3.13) is a derivative of some quantity (i.e., $[\cdots]_x$), which will insure that $\int_{\mathbb{R}} \mathscr{E} dx$ is a decreasing function of time.
- When P, Q are large, we have $\underline{P} = \mathcal{O}(P)$ and $\underline{Q} = \mathcal{O}(Q)$. This insures (with Gronwall inequality) that no singularity will appear in finite time.

We can write the right-hand side of (3.13) as $T_1 + T_2$ such that

Then, a sufficient condition to obtain $T_1 = [\cdots]_x$ is

$$gh^{+} = \left[\gamma\left(h^{+}\right)_{x} + \frac{\sqrt{3\gamma}}{48h^{1/2}}\left(\chi_{\varepsilon}(P) - \chi_{\varepsilon}(Q)\right)\right]_{x}.$$
 (3.14)

On another hand we have

$$T_{2} = \frac{1}{3} h^{3} u_{x} \left(u^{+}\right)_{x} + \frac{1}{2} h^{2} u_{x}^{2} h^{+} + \frac{1}{2} u^{2} h^{+} + h u u^{+} - \frac{1}{48} h \left(\chi_{\varepsilon}(P) + \chi_{\varepsilon}(Q)\right) u_{x}$$

$$= \left(\frac{1}{2} u h^{+} + h u^{+}\right) u + \left[\frac{1}{3} h^{3} \left(u^{+}\right)_{x} + \frac{1}{2} h^{2} u_{x} h^{+} - \frac{1}{48} h \left(\chi_{\varepsilon}(P) + \chi_{\varepsilon}(Q)\right)\right] u_{x}$$

Then, a sufficient condition to obtain $T_2 = [\cdots]_x$ is

$$\frac{1}{2} u h^{+} + h u^{+} = \left[\frac{1}{3} h^{3} \left(u^{+} \right)_{x} + \frac{1}{2} h^{2} u_{x} h^{+} - \frac{1}{48} h \left(\chi_{\varepsilon}(P) + \chi_{\varepsilon}(Q) \right) \right]_{x}. \tag{3.15}$$

In next section we prove the global existence of smooth solutions of the approximated system, and we obtain some uniform estimates that do not depend on ε .

4. Uniform estimates

In this section, we consider $\gamma > 0$, h > 0, and $h_0 - \bar{h}$, $u_0 \in H^1$ such that $\int_{\mathbb{R}} \mathscr{E}_0 \, \mathrm{d}x < \sqrt{g\gamma} \bar{h}^2$. Let also j_{ε} be a Friedrichs mollifier, we define $h_0^{\varepsilon} \stackrel{\mathrm{def}}{=} ((h_0 - \bar{h}) * j_{\varepsilon}) + \bar{h}$ and $u_0^{\varepsilon} \stackrel{\mathrm{def}}{=} (u_0 * j_{\varepsilon})$ where $(f * g)(x) \stackrel{\mathrm{def}}{=} \int_{\mathbb{R}} f(x - x')g(x')\mathrm{d}x'$. Using that $\|(h_0 - h_0^{\varepsilon}, u_0 - u_0^{\varepsilon})\|_{H^1} \to 0$ as $\varepsilon \to 0$, we can prove

$$\mathscr{A}^{\varepsilon} \stackrel{\text{def}}{=} \left(g - \gamma \, \partial_{x}^{2} \right)^{-1} \left\{ \frac{\sqrt{3 \, \gamma}}{48 \, (h^{\varepsilon})^{1/2}} \left(\chi_{\varepsilon}(P^{\varepsilon}) - \chi_{\varepsilon}(Q^{\varepsilon}) \right) \right\},
= \mathfrak{G} * \left\{ \frac{\sqrt{3 \, \gamma}}{48 \, (h^{\varepsilon})^{1/2}} \left(\chi_{\varepsilon}(P^{\varepsilon}) - \chi_{\varepsilon}(Q^{\varepsilon}) \right) \right\}, \tag{4.4}$$

$$\mathscr{B}^{\varepsilon} \stackrel{\text{def}}{=} \mathcal{L}_{h^{\varepsilon}}^{-1} \left\{ -\frac{1}{2} u^{\varepsilon} \mathscr{A}_{x}^{\varepsilon} + \partial_{x} \left\{ \frac{1}{2} (h^{\varepsilon})^{2} u_{x}^{\varepsilon} \mathscr{A}_{x}^{\varepsilon} - \frac{1}{48} h^{\varepsilon} \left(\chi_{\varepsilon}(P^{\varepsilon}) + \chi_{\varepsilon}(Q^{\varepsilon}) \right) \right\} \right\}, \tag{4.5}$$

$$\frac{\mathrm{d}^{\eta}}{\mathrm{d}t}Q^{\varepsilon} \stackrel{\mathrm{def}}{=} Q_{t}^{\varepsilon} + \eta^{\varepsilon}Q_{x}^{\varepsilon} = -\frac{1}{8h^{\varepsilon}}(Q^{\varepsilon})^{2} + \frac{1}{8h^{\varepsilon}}\chi_{\varepsilon}(Q^{\varepsilon}) + \frac{1}{8h^{\varepsilon}}(P^{\varepsilon})^{2} - \frac{1}{2h^{\varepsilon}}\mathscr{A}_{x}^{\varepsilon}Q^{\varepsilon} + \mathscr{N}^{\varepsilon}, \quad (4.7b)$$

The first result on this section is the global well-posedness of (4.3).

Theorem 4.1. Let $\bar{h} > 0$, $(h_0 - \bar{h}, u_0) \in \mathfrak{D}$ and $\varepsilon \in (0, \varepsilon_0]$ then there exists a global smooth solution $(h^{\varepsilon} - \bar{h}, u^{\varepsilon}) \in C(\mathbb{R}^+, H^3(\mathbb{R})) \cap C^1(\mathbb{R}^+, H^2(\mathbb{R}))$ of (4.3) and for all t > 0 we have

$$\int_{\mathbb{R}} \mathscr{E}^{\varepsilon} dx - \int_{0}^{t} \int_{\mathbb{R}} \frac{1}{48} \left(P^{\varepsilon} \chi_{\varepsilon}(P^{\varepsilon}) + Q^{\varepsilon} \chi_{\varepsilon}(Q^{\varepsilon}) \right) dx dt = \int_{\mathbb{R}} \mathscr{E}_{0}^{\varepsilon} dx. \tag{4.12}$$




FIGURE 2. Characteristics.

Moreover, there exist A, B > 0 depending only on \bar{h}, γ, g and E such that for any t > 0, $x_2 \in \mathbb{R}$, and for $x_1 \in (-\infty, x_2)$ the solution of $X_{x_1}(t) = Y_{x_2}(t)$ (see Figure 2) we have

$$\int_{\tau}^{t} \left[P^{\varepsilon}(s, X_{x_1}(s)) \right]^2 ds + \int_{\tau}^{t} \left[Q^{\varepsilon}(s, Y_{x_2}(s)) \right]^2 ds \leqslant A(t - \tau) + B \quad \forall \tau \in [0, t].$$

In order to prove Theorem 4.1, we need to prove the invertibility of the operator \mathcal{L}_h and to obtain some estimates of its inverse.

Lemma 4.2. Let $0 < h \in H^1(\mathbb{R}) + \bar{h}$ with $h^{-1} \in L^{\infty}$. Then the operator \mathcal{L}_h is an isomorphism from H^2 to L^2 . Moreover, if $\psi \in C_{\lim} \stackrel{def}{=} \{ f \in C(\mathbb{R}), \ f(\infty), f(-\infty) \in \mathbb{R} \}$, then $\mathcal{L}_h^{-1} \psi$ is well defined and there exists constants $C = C(\bar{h}, \|h^{-1}\|_{L^{\infty}}, \|h\|_{L^{\infty}}) > 0$ such that

$$\|\mathcal{L}_h^{-1}\psi\|_{W^{1,\infty}} \leqslant C \|\psi\|_{L^{\infty}},$$
 (4.14)

$$\left| \partial_x^2 \mathcal{L}_h^{-1} \psi \right| (x) \leqslant C \left(1 + |h_x(x)| \right) \|\psi\|_{L^{\infty}} \quad \forall x \in \mathbb{R}, \tag{4.15}$$

$$\|\mathcal{L}_h^{-1}\psi\|_{H^1} \leqslant C \|\psi\|_{L^1},$$
 (4.16)

$$\left\| \mathcal{L}_h^{-1} \, \partial_x \, \psi \right\|_{L^{\infty}} \leqslant C \, \left\| \psi \right\|_{L^1}, \tag{4.17}$$

$$\|\partial_x \mathcal{L}_h^{-1} \partial_x \psi\|_{L^{\infty}} \le C[\|\psi\|_{L^1} + \|\psi\|_{L^{\infty}}],$$
 (4.18)

$$\|\mathcal{L}_{h}^{-1} \,\partial_{x} \,\psi\|_{L^{2}} \leqslant C \,\|\psi\|_{L^{1}} \,(\|h_{x}\|_{L^{2}} + 1) \,, \tag{4.19}$$

$$\left\| \mathcal{L}_{h}^{-1} \, \partial_{x} \, \psi \right\|_{H^{1}} + \left\| \mathcal{L}_{h}^{-1} \, \psi \right\|_{H^{1}} \leqslant C \, \|\psi\|_{L^{2}}, \tag{4.20}$$

$$\left\| \mathcal{L}_{h}^{-1} \psi \right\|_{W^{1,\infty}} \leqslant \left\| \mathcal{L}_{h}^{-1} \psi \right\|_{H^{2}} \leqslant C \left[1 + \left\| h_{x} \right\|_{L^{2}}^{2} \right] \left\| \psi \right\|_{L^{2}}, \tag{4.21}$$

$$\left| \partial_x^2 \mathcal{L}_h^{-1} \psi \right| (x) \leqslant C \left[(1 + \|h_x\|_{L^2}) (1 + |h_x|(x)) \|\psi\|_{L^2} + |\psi|(x) \right]. \tag{4.22}$$

Also, if $h - \bar{h} \in H^2(\mathbb{R})$ we have

$$\left\| \mathcal{L}_{h}^{-1} \, \partial_{x} \, \varphi \right\|_{H^{3}} \, \leqslant \, C \left[\left(1 \, + \, \|h_{x}\|_{L^{\infty}}^{2} \right) \|\varphi\|_{H^{2}} \, + \, \left\| h \, - \, \bar{h} \right\|_{H^{2}} \, \left\| \mathcal{L}_{h}^{-1} \, \partial_{x} \, \varphi \right\|_{W^{1,\infty}} \right], \quad (4.23a)$$

$$\left\| \mathcal{L}_{h}^{-1} \psi \right\|_{H^{3}} \leq C \left[\left(1 + \|h_{x}\|_{L^{\infty}}^{2} \right) \|\psi\|_{H^{2}} + \left\| h - \bar{h} \right\|_{H^{2}} \left\| \mathcal{L}_{h}^{-1} \psi \right\|_{W^{1,\infty}} \right]. \tag{4.23b}$$

Moreover, there exists a constant $\tilde{C} = \tilde{C}(\gamma, g)$ such that

$$\left\| \left(g - \gamma \, \partial_x^2 \right)^{-1} \psi \right\|_{H^3} \leqslant \tilde{C} \left\| \psi \right\|_{H^1}, \qquad \left\| \partial_x \left(g - \gamma \, \partial_x^2 \right)^{-1} \psi \right\|_{H^3} \leqslant \tilde{C} \left\| \psi \right\|_{H^2}. \tag{4.24}$$

The proof of (4.14), (4.18) and (4.23) is inspired by [38].

Proof. Step 0. Let (\cdot, \cdot) be the scalar product in L^2 . Defining the bilinear map $a: H^1 \times H^1 \to \mathbb{R}$

$$a(u,v) \stackrel{\text{def}}{=} (h u, v) + \frac{1}{3} (h^3 u_x, v_x).$$

It is easy to check that a is continuous and coercive. Then, Lax–Milgram theorem insures the existence of a continuous bijective linear operator $J: H^1 \to H^{-1}$ satisfying

$$a(u,v) = \langle J u, v \rangle_{H^{-1} \times H^1} \quad \forall u, v \in H^1.$$

If $Ju \in L^2$, an integration by parts shows that $(h^3u_x)_x = hu - Ju \in L^2$ and $J = \mathcal{L}_h$, this implies that $u \in H^2$ which finishes the proof that \mathcal{L}_h is an isomorphism from H^2 to L^2 .

Defining now $C_0 \stackrel{\text{def}}{=} \{ f \in C, \ f(\pm \infty) = 0 \}$, using that $L^2 \cap C_0$ is dense in C_0 one can define \mathcal{L}_h^{-1} on C_0 . If φ is in C_{lim} , we use the change of functions (see Lemma 4.4 in [38])

$$\varphi_0(x) \stackrel{\text{def}}{=} \varphi(x) - \mathcal{L}_{h\frac{1}{h}} \left(\varphi(-\infty) + (\varphi(\infty) - \varphi(-\infty)) \frac{e^x}{1 + e^x} \right) \in C_0,$$

the operator \mathcal{L}_h^{-1} can be defined as

$$\mathcal{L}_h^{-1} \varphi \stackrel{\text{def}}{=} \mathcal{L}_h^{-1} \varphi_0 + \frac{1}{h} \left(\varphi(-\infty) + (\varphi(\infty) - \varphi(-\infty)) \frac{e^x}{1 + e^x} \right).$$

Step 1. Let

$$\psi = \mathcal{L}_h u = h u - \frac{1}{3} (h^3 u_x)_{\pi}, \tag{4.25}$$

using the change of variables

we obtain

The maximum principle insures that $||u||_{L^{\infty}} \leqslant C||\psi||_{L^{\infty}}$ which implies with (4.27) that

Using Landau–Kolmogorov inequality we obtain $||u_z||_{L^{\infty}} \leq C||\psi||_{L^{\infty}}$. The estimate (4.15) follows directly from the change of variables (4.26), (4.28) and (4.14).

Multiplying (4.25) by u and using and integration by parts one obtains

The inequality (4.16) follows directly using the embedding $H^1 \hookrightarrow L^{\infty}$. Using (4.14) and

 (4.30)

we obtain (4.17) and (4.18). Using the definition of \mathcal{L}_h we obtain

$$\mathcal{L}_{h}^{-1} \partial_{x} \psi = \mathcal{L}_{h}^{-1} \partial_{x} h^{3} \mathcal{L}_{h} \mathcal{L}_{h}^{-1} h^{-3} \psi
= \mathcal{L}_{h}^{-1} \partial_{x} \left[h^{4} \mathcal{L}_{h}^{-1} h^{-3} \psi - \frac{1}{3} h^{3} \partial_{x} h^{3} \partial_{x} \mathcal{L}_{h}^{-1} h^{-3} \psi \right]
= \mathcal{L}_{h}^{-1} \left[4 h^{3} h_{x} \mathcal{L}_{h}^{-1} h^{-3} \psi + h^{4} \partial_{x} \mathcal{L}_{h}^{-1} h^{-3} \psi - \frac{1}{3} \partial_{x} h^{3} \partial_{x} h^{3} \partial_{x} \mathcal{L}_{h}^{-1} h^{-3} \psi \right]
= \mathcal{L}_{h}^{-1} \left[4 h^{3} h_{x} \mathcal{L}_{h}^{-1} h^{-3} \psi \right] + h^{3} \partial_{x} \mathcal{L}_{h}^{-1} h^{-3} \psi.$$
(4.31)

The inequality (4.19) follows from (4.16) and the Cauchy–Schwarz inequality.

Let $\mathcal{L}_h u = \psi + \varphi_x$, then

$$||u||_{H^{1}}^{2} = (u, u) + (u_{x}, u_{x})$$

$$\leq C \left[(h u, u) + \frac{1}{3} (h^{3} u_{x}, u_{x}) \right]$$

$$= C \left(\mathcal{L}_{h} u, u \right) = C \left[(\psi, u) - (\varphi, u_{x}) \right]$$

$$\leq C ||u||_{H^{1}} (||\psi||_{L^{2}} + ||\varphi||_{L^{2}}),$$

which implies that

$$||u||_{H^1} \leqslant C ||\psi||_{L^2} + ||\varphi||_{L^2}. \tag{4.32}$$

Taking $\psi = 0$ (respectively $\varphi = 0$) we obtain (4.20). Replacing $h^{-3}\psi$ by ψ in (4.31), we multiply by h^{-3} and we differentiate with respect to x to obtain

$$\partial_x^2 \mathcal{L}_h^{-1} \psi = -3 h^{-2} h_x \left[\mathcal{L}_h^{-1} \partial_x h^3 \psi - \mathcal{L}_h^{-1} \left[4 h^3 h_x \mathcal{L}_h^{-1} \psi \right] \right]$$
(4.33)

+
$$h^{-3} \partial_x \mathcal{L}_h^{-1} \partial_x h^3 \psi$$
 - $h^{-3} \partial_x \mathcal{L}_h^{-1} \left[4 h^3 h_x \mathcal{L}_h^{-1} \psi \right]$. (4.34)

Using (4.20) and the embedding $H^1 \hookrightarrow L^{\infty}$ we obtain

$$\begin{split} \left\| \partial_{x}^{2} \mathcal{L}_{h}^{-1} \psi \right\|_{L^{2}} & \leqslant C \, \|h_{x}\|_{L^{2}} \left[\left\| \mathcal{L}_{h}^{-1} \, \partial_{x} \, h^{3} \, \psi \right\|_{H^{1}} \, + \, \left\| \mathcal{L}_{h}^{-1} \, \left[4 \, h^{3} \, h_{x} \, \mathcal{L}_{h}^{-1} \, \psi \right] \right\|_{H^{1}} \right] \\ & + \, C \, \left\| \partial_{x} \, \mathcal{L}_{h}^{-1} \, \partial_{x} \, h^{3} \, \psi \, \right\|_{L^{2}} \, + \, C \, \left\| \partial_{x} \, \mathcal{L}_{h}^{-1} \, \left[4 \, h^{3} \, h_{x} \, \mathcal{L}_{h}^{-1} \psi \right] \right\|_{L^{2}} \\ & \leqslant C \, \|h_{x}\|_{L^{2}} \left[\left\| \psi \right\|_{L^{2}} \, + \, \left\| h_{x} \right\|_{L^{2}} \left\| \mathcal{L}_{h}^{-1} \, \psi \right\|_{H^{1}} \right] \\ & + \, C \, \left\| \psi \right\|_{L^{2}} \, + \, C \, \left\| h_{x} \right\|_{L^{2}} \left\| \mathcal{L}_{h}^{-1} \, \psi \right\|_{H^{1}} \\ & \leqslant C \, \left[1 \, + \, \left\| h_{x} \right\|_{L^{2}}^{2} \right] \left\| \psi \right\|_{L^{2}} \, . \end{split}$$

This with (4.20) imply (4.21).

Differentiating now (4.31) with respect to x, using the definition of \mathcal{L}_h and replacing $h^{-3}\psi$ by ψ we obtain

$$\partial_x \mathcal{L}_h^{-1} \, \partial_x \, h^3 \, \psi \; = \; \partial_x \mathcal{L}_h^{-1} \, \left[4 \, h^3 \, h_x \, \mathcal{L}_h^{-1} \, \psi \right] \; + \; 3 \, h \, \mathcal{L}_h^{-1} \, \psi \; - \; 3 \, \psi.$$

Then (4.33) becomes

$$= C \left[-(h u, u_{xx}) - (h_{x} u, u_{x}) + \frac{1}{3} ((h^{3} u_{x})_{x} - (h^{3})_{x} u_{x}, u_{xx}) \right]$$

$$= C \left[-(\mathcal{L}_{h} u, u_{xx}) - (h_{x} u, u_{x}) - (h^{2} h_{x} u_{x}, u_{xx}) \right]$$

$$\leq C \left[\alpha ||u_{xx}||_{L^{2}}^{2} + \frac{1}{\alpha} ||\mathcal{L}_{h} u||_{L^{2}}^{2} + C_{\alpha} (1 + ||h_{x}||_{L^{\infty}}^{2}) ||u||_{H^{1}}^{2} \right].$$

Taking $\alpha > 0$ small enough we obtain that

$$||u_x||_{H^1}^2 \leqslant C \left[||\mathcal{L}_h u||_{L^2}^2 + (1 + ||h_x||_{L^{\infty}}^2) ||u||_{H^1}^2 \right],$$

then

$$||u_x||_{H^1} \leqslant C[||\mathcal{L}_h u||_{L^2} + (1 + ||h_x||_{L^{\infty}}) ||u||_{H^1}].$$

Taking $\psi = 0$ (respectively $\varphi = 0$) and using (4.32), we obtain

$$\left\| \mathcal{L}_{h}^{-1} \, \partial_{x} \, \varphi \right\|_{H^{2}} \leqslant C \left(1 + \|h_{x}\|_{L^{\infty}} \right) \|\varphi\|_{H^{1}}, \qquad \left\| \mathcal{L}_{h}^{-1} \, \psi \right\|_{H^{2}} \leqslant C \left(1 + \|h_{x}\|_{L^{\infty}} \right) \|\psi\|_{L^{2}}. \tag{4.35}$$

Let Λ be defined as $\widehat{\Lambda f} = (1 + \xi^2)^{\frac{1}{2}} \widehat{f}$. Since $\mathcal{L}_h u = \psi + \varphi_x$, we have

$$\mathcal{L}_h \, \Lambda^2 u \; = \; [h, \Lambda^2] \, u \; + \; \Lambda^2 \psi \; + \; \partial_x \, \left\{ - \, \frac{1}{3} \, [h^3, \Lambda^2] \, u_x \; + \; \Lambda^2 \varphi \right\}.$$

Defining $\tilde{u} = \Lambda^2 u$, $\tilde{\psi} = [h, \Lambda^2] u + \Lambda^2 \psi$ and $\tilde{\varphi} = -\frac{1}{3} [h^3, \Lambda^2] u_x + \Lambda^2 \varphi$ and using (4.32), (A.6) we obtain

$$\begin{split} \|\Lambda^2 u\|_{H^1} \; \leqslant \; C \left[\left\| [h, \Lambda^2] \, u \right\|_{L^2} \; + \; \left\| [h^3, \Lambda^2] \, u_x \right\|_{L^2} \; + \; \left\| \psi \right\|_{H^2} \; + \; \left\| \varphi \right\|_{H^2} \right] \\ \leqslant \; C \left[\|h_x\|_{L^\infty} \, \|u\|_{H^2} \; + \; \|h \; - \; \bar{h}\|_{H^2} \, \|u\|_{W^{1,\infty}} \; + \; \left\| \psi \right\|_{H^2} \; + \; \left\| \varphi \right\|_{H^2} \right]. \end{split}$$

Taking $\psi = 0$ (respectively $\varphi = 0$) and using (4.32) with (4.35), we obtain (4.23).

Step 3. It remains only to prove the inequalities (4.24). Since the operator $(g - \gamma \partial_x^2)^{-1}$ is nothing but a convolution with the function \mathfrak{G} , the result follows directly using the Young inequality.

Lemma 4.3. Let $(h - \bar{h}, u) \in H^1(\mathbb{R})$ such that $\int_{\mathbb{R}} \mathscr{E} dx \leqslant E < \sqrt{g\gamma} \bar{h}^2$, then, there exists a constant $C = C(\gamma, \bar{h}, E) > 0$ independent on ε and h such that

$$\left\| \mathcal{L}_{h}^{-1} \partial_{x} \mathscr{C} \right\|_{L^{\infty}(\mathbb{R})} + \left\| \mathscr{R} \right\|_{L^{\infty}(\mathbb{R})} \leqslant C, \tag{4.36}$$

$$\int_{\mathbb{R}} (\chi_{\varepsilon}(P) + \chi_{\varepsilon}(Q)) \, dx \leqslant C, \tag{4.37}$$

$$\left\| \mathcal{L}_{h}^{-1} \partial_{x} \left\{ h \left(\chi_{\varepsilon}(P) + \chi_{\varepsilon}(Q) \right) \right\} \right\|_{L^{\infty}(\mathbb{R})} \leqslant C, \tag{4.38}$$

$$\left\| \left(\mathcal{L}_h^{-1} \partial_x \left\{ h^2 \, u_x \, \mathscr{A}_x^{\varepsilon} \right\}, \mathcal{L}_h^{-1} \left\{ u \, \mathscr{A}_x^{\varepsilon} \right\} \right) \right\|_{L^{\infty}(\mathbb{R})} \leq C, \tag{4.39}$$

$$\|\mathscr{A}_{x}^{\varepsilon}\|_{L^{2}} + \|(\mathscr{A}^{\varepsilon}, \mathscr{A}_{x}^{\varepsilon}, \mathscr{B}^{\varepsilon}, \mathscr{V}_{1}^{\varepsilon}, \mathscr{V}_{2}^{\varepsilon})\|_{L^{\infty}(\mathbb{R})} \leqslant C, \tag{4.40}$$

where $\mathscr{A}^{\varepsilon}$, $\mathscr{B}^{\varepsilon}$, $\mathscr{V}_{1}^{\varepsilon}$ and $\mathscr{V}_{2}^{\varepsilon}$ are defined as in (4.4), (4.5), (4.9) and (4.10) by replacing $(h^{\varepsilon}, u^{\varepsilon})$ with (h, u).

Proof. From $\int_{\mathbb{R}} \mathscr{E} \, \mathrm{d}x \leqslant E$ we have $\|(\mathscr{E}, P^2, Q^2)\|_{L^1} \leqslant C$, then the proof of (4.36) follows from (3.8), (4.14), (4.17) and (4.21). Since $\chi_{\varepsilon}(\lambda) \leqslant \lambda^2$ we obtain (4.37). Then, (4.37) with (4.17) imply (4.38). In remains to prove (4.40). For that purpose, we use Young inequality, (4.4) and (4.10) to obtain

$$\|\mathscr{A}\|_{L^{\infty}} + \|\mathscr{A}_x\|_{L^2} + \|\mathscr{A}_x\|_{L^{\infty}} + \|\mathscr{V}_2\|_{L^{\infty}} \leqslant C. \tag{4.41}$$

The estimates (4.14), (4.17), (4.37), (4.9), (4.41), (4.5) and the Cauchy–Schwarz inequality imply (4.40).

Proof of Theorem 4.1. Following [25, 26, 27, 34, 38], we can prove easily the local existence of solutions of (4.3). Integrating the energy equation (4.11) on $[0,t] \times \mathbb{R}$, we obtain (4.12).

Step 1. Defining

$$U^{\varepsilon} \stackrel{\text{def}}{=} (h^{\varepsilon} - \bar{h}, u^{\varepsilon})^{\top} \qquad A(U^{\varepsilon}) \stackrel{\text{def}}{=} \begin{pmatrix} 3\gamma (h^{\varepsilon})^{-3} & 0 \\ 0 & h^{\varepsilon} \end{pmatrix}, \qquad B(U^{\varepsilon}) \stackrel{\text{def}}{=} \begin{pmatrix} u^{\varepsilon} & h^{\varepsilon} \\ 3\gamma (h^{\varepsilon})^{-3} & u^{\varepsilon} \end{pmatrix},$$

$$\mathscr{F}^{\varepsilon}(U^{\varepsilon}) \stackrel{\text{def}}{=} \begin{pmatrix} \mathscr{A}_{x}^{\varepsilon} \\ -\mathcal{L}_{h^{\varepsilon}}^{-1} \partial_{x} \left\{ \mathscr{C}^{\varepsilon} + F(h^{\varepsilon}) \right\} + \mathscr{B}^{\varepsilon} \end{pmatrix},$$

the system (4.3) becomes

$$U_t^{\varepsilon} + B(U^{\varepsilon}) U_x^{\varepsilon} = \mathscr{F}^{\varepsilon}(U^{\varepsilon}). \tag{4.42}$$

Let (\cdot, \cdot) be the scalar product in L^2 and $E(U^{\varepsilon}) \stackrel{\text{def}}{=} (\Lambda^3 U^{\varepsilon}, A^{\varepsilon} \Lambda^3 U^{\varepsilon})$. Since $A^{\varepsilon} B^{\varepsilon}$ is a symmetric matrix, straightforward calculations with (4.42) imply that

Using (4.12), (4.17), (4.18), (4.20) and Lemma 4.3 we obtain that

From Lemma 4.3 we deduce that $\mathscr{H}_1^{\varepsilon}$ and $\mathscr{H}_2^{\varepsilon}$ are bounded, then, integrating (4.11) on the set (see Figure 2)

$$\int_{\mathbb{R}^+} \int_{\mathbb{R}} \left(\chi_{\varepsilon}(P^{\varepsilon}) + \chi_{\varepsilon}(Q^{\varepsilon}) \right) \, \mathrm{d}x \, \mathrm{d}t \leqslant \varepsilon C, \tag{4.60}$$

$$\int_{\mathbb{R}^+} \left\| \mathcal{L}_{h^{\varepsilon}}^{-1} \partial_x \left\{ h^{\varepsilon} \left(\chi_{\varepsilon}(P^{\varepsilon}) + \chi_{\varepsilon}(Q^{\varepsilon}) \right) \right\} \right\|_{L^{\infty}(\mathbb{R})} dt \leqslant \varepsilon C, \tag{4.61}$$

$$\int_{\mathbb{R}^{+}} \left\| \left(\mathcal{L}_{h^{\varepsilon}}^{-1} \partial_{x} \left\{ (h^{\varepsilon})^{2} u_{x}^{\varepsilon} \mathscr{A}_{x}^{\varepsilon} \right\}, \mathcal{L}_{h^{\varepsilon}}^{-1} \left\{ u^{\varepsilon} \mathscr{A}_{x}^{\varepsilon} \right\} \right) \right\|_{L^{\infty}(\mathbb{R}^{\varepsilon})} dt \leqslant \varepsilon C$$

$$(4.62)$$

$$\int_{\mathbb{R}^+} \| (\mathscr{A}^{\varepsilon}, \mathscr{A}_x^{\varepsilon}, \mathscr{B}^{\varepsilon}, \mathscr{V}_1^{\varepsilon}, \mathscr{V}_2^{\varepsilon}) \|_{L^{\infty}(\mathbb{R})} dt \leqslant \varepsilon C.$$

Proof. The inequality (4.59) follows from (4.12), (4.36) and (4.40). Note that

The goal is to prove that for all t and x we have $P^{\varepsilon}(t, X_x(t)) \leq \mathcal{G}(t)$ and $Q^{\varepsilon}(t, Y_x(t)) \leq \mathcal{G}(t)$. Since the proof is the same, we only prove the inequality for P^{ε} .

Let $x \in \mathbb{R}$ be fixed, we suppose that there exist $t_1 > 0$ such that $P^{\varepsilon}(t_1, X_x(t_1) = \mathcal{F}(t_1))$ and $P^{\varepsilon}(t, X_x(t) \ge \mathcal{F}(t))$ for all $t \in [t_1, t_2]$. Since the solution $(h^{\varepsilon} - \bar{h}, u^{\varepsilon}) \in L^{\infty}(\mathbb{R}^+, H^3)$, then initially we have $P^{\varepsilon}(0^+, X_x(0^+) < \mathfrak{F}(0^+) = \infty$. The inequality (4.67) shows that if P^{ε} crosses \mathfrak{F} at some $t_1 > 0$, P^{ε} remains always smaller than \mathfrak{F} for $t \geq t_1$. This completes the proof of $P^{\varepsilon}(t, X_x(t)) \leq \mathfrak{F}(t)$ for all t > 0. The proof for Q^{ε} can be done similarly.

Remark 4.7. The constant $C_{\alpha,\Omega}$ depends also on h, γ and E but not on ε and the initial data.

$$\tau \stackrel{\text{def}}{=} t, \qquad z \stackrel{\text{def}}{=} \frac{1}{2} \left(\int_{-\infty}^{x} - \int_{x}^{\infty} \right) \left(h^{\varepsilon}(t, y) - \bar{h} \right) dy + \bar{h} x,$$

we obtain with (4.3a) that

$$\partial_x = h^{\varepsilon} \partial_z, \qquad \partial_t = \partial_{\tau} + (\mathscr{A}^{\varepsilon} - h^{\varepsilon} u^{\varepsilon}) \partial_z, \qquad \partial_t + u^{\varepsilon} \partial_x = \partial_{\tau} + \mathscr{A}^{\varepsilon} \partial_z.$$

The map

$$\Phi: \mathbb{R}^+ \times \mathbb{R} \to \mathbb{R}^+ \times \mathbb{R}, \qquad (t, x) \mapsto \Phi(t, x) = (\tau, z)$$

is bijective. Then (4.7) becomes

$$P_{\tau}^{\varepsilon} + \left(\mathscr{A}^{\varepsilon} - \sqrt{3\gamma} (h^{\varepsilon})^{1/2} \right) P_{z}^{\varepsilon} = -\frac{1}{8h^{\varepsilon}} (P^{\varepsilon})^{2} + \frac{1}{8h^{\varepsilon}} \chi_{\varepsilon} (P^{\varepsilon}) + \frac{1}{8h^{\varepsilon}} (Q^{\varepsilon})^{2} - \frac{1}{2h^{\varepsilon}} \mathscr{A}_{x}^{\varepsilon} P^{\varepsilon} + \mathscr{M}^{\varepsilon}, \qquad (4.70a)$$

$$Q_{\tau}^{\varepsilon} + \left(\mathscr{A}^{\varepsilon} + \sqrt{3\gamma} (h^{\varepsilon})^{1/2} \right) Q_{z}^{\varepsilon} = -\frac{1}{8h^{\varepsilon}} (Q^{\varepsilon})^{2} + \frac{1}{8h^{\varepsilon}} \chi_{\varepsilon} (Q^{\varepsilon}) + \frac{1}{8h^{\varepsilon}} (P^{\varepsilon})^{2} - \frac{1}{2h^{\varepsilon}} \mathscr{A}_{x}^{\varepsilon} Q^{\varepsilon} + \mathscr{N}^{\varepsilon}. \qquad (4.70b)$$

Without loss of generality, we suppose that $\alpha = 2k/(2k+1)$ with $k \in \mathbb{N}$. Multiplying (4.70a) by $(P^{\varepsilon})^{\alpha}$, using $\frac{2}{\alpha+1} = 1 + \frac{1-\alpha}{\alpha+1}$, $(P^{\varepsilon})^{\alpha}\chi_{\varepsilon}(P^{\varepsilon}) \geqslant 0$ and (4.59) one obtains

$$\frac{1}{8h^{\varepsilon}} \left\{ \frac{1-\alpha}{\alpha+1} \left(P^{\varepsilon} \right)^{\alpha+1} \left(P^{\varepsilon} - Q^{\varepsilon} \right) - \left(P^{\varepsilon} \right)^{\alpha} Q^{\varepsilon} \left(P^{\varepsilon} - Q^{\varepsilon} \right) \right\} \\
\leqslant \left(\frac{(P^{\varepsilon})^{\alpha+1}}{\alpha+1} \right)_{\tau} + \left(\frac{\mathscr{A}^{\varepsilon} - \sqrt{3\gamma} (h^{\varepsilon})^{1/2}}{\alpha+1} (P^{\varepsilon})^{\alpha+1} \right)_{\tau} + C \left(|P^{\varepsilon}|^{\alpha+1} + (P^{\varepsilon})^{\alpha} \right).$$

Doing the same with (4.7b), we obtain

$$\frac{1}{8h^{\varepsilon}} \left\{ \frac{1-\alpha}{\alpha+1} \left(Q^{\varepsilon} \right)^{\alpha+1} \left(Q^{\varepsilon} - P^{\varepsilon} \right) - \left(Q^{\varepsilon} \right)^{\alpha} P^{\varepsilon} \left(Q^{\varepsilon} - P^{\varepsilon} \right) \right\} \\
\leqslant \left(\frac{(Q^{\varepsilon})^{\alpha+1}}{\alpha+1} \right)_{\tau} + \left(\frac{\mathscr{A}^{\varepsilon} + \sqrt{3\gamma} (h^{\varepsilon})^{1/2}}{\alpha+1} (Q^{\varepsilon})^{\alpha+1} \right)_{z} + C \left(|Q^{\varepsilon}|^{\alpha+1} + (Q^{\varepsilon})^{\alpha} \right).$$

Adding both equations yields to

$$\frac{1}{8h^{\varepsilon}} \left\{ \frac{1-\alpha}{\alpha+1} \left((P^{\varepsilon})^{\alpha+1} - (Q^{\varepsilon})^{\alpha+1} \right) \left(P^{\varepsilon} - Q^{\varepsilon} \right) + \left(P^{\varepsilon} \right)^{\alpha} \left(Q^{\varepsilon} \right)^{\alpha} \left((P^{\varepsilon})^{1-\alpha} - (Q^{\varepsilon})^{1-\alpha} \right) \left(P^{\varepsilon} - Q^{\varepsilon} \right) \right\} \\
\leqslant \left(\frac{(P^{\varepsilon})^{\alpha+1} + (Q^{\varepsilon})^{\alpha+1}}{\alpha+1} \right)_{\tau} + \left(\frac{\sqrt{3\gamma} \left(h^{\varepsilon} \right)^{1/2} \left((Q^{\varepsilon})^{\alpha+1} - (P^{\varepsilon})^{\alpha+1} \right) + \mathscr{A}^{\varepsilon} \left((Q^{\varepsilon})^{\alpha+1} + (P^{\varepsilon})^{\alpha+1} \right)}{\alpha+1} \right)_{z} \\
+ C \left(|Q^{\varepsilon}|^{\alpha+1} + (Q^{\varepsilon})^{\alpha} + |P^{\varepsilon}|^{\alpha+1} + (P^{\varepsilon})^{\alpha} \right). \tag{4.71}$$

Let $\varphi \in C_c^{\infty}((t_1/2, t_2 + 1) \times (a - 1, b + 1))$ be a non negative function such that $\varphi(t, x) = 1$ on Ω . Multiplying (4.71) by $\varphi(\Phi^{-1}(\tau, z))$ and using integration by parts with (4.12) we

obtain

$$\begin{split} &\frac{1-\alpha}{\alpha+1}\int_{\mathbb{R}^{+}\times\mathbb{R}}\varphi\left(P^{\varepsilon}-Q^{\varepsilon}\right)^{2}((P^{\varepsilon})^{\alpha}+(Q^{\varepsilon})^{\alpha})\,\mathrm{d}x\,\mathrm{d}t\\ \leqslant &\int_{\mathbb{R}^{+}\times\mathbb{R}}\left\{\frac{1-\alpha}{\alpha+1}((P^{\varepsilon})^{\alpha+1}-(Q^{\varepsilon})^{\alpha+1})\,(P^{\varepsilon}-Q^{\varepsilon})\right\}\varphi(t,x)\,\mathrm{d}x\,\mathrm{d}t\\ &+\int_{\mathbb{R}^{+}\times\mathbb{R}}\left\{(P^{\varepsilon})^{\alpha}(Q^{\varepsilon})^{\alpha}((P^{\varepsilon})^{1-\alpha}-(Q^{\varepsilon})^{1-\alpha})\,(P^{\varepsilon}-Q^{\varepsilon})\right\}\varphi(t,x)\,\mathrm{d}x\,\mathrm{d}t\\ &=\int_{\mathbb{R}^{+}\times\mathbb{R}}\left\{\frac{1-\alpha}{\alpha+1}((P^{\varepsilon})^{\alpha+1}-(Q^{\varepsilon})^{\alpha+1})\,(P^{\varepsilon}-Q^{\varepsilon})\right\}\varphi\left(\Phi^{-1}(\tau,z)\right)\frac{\mathrm{d}z\,\mathrm{d}\tau}{h}\\ &+\int_{\mathbb{R}^{+}\times\mathbb{R}}\left\{(P^{\varepsilon})^{\alpha}(Q^{\varepsilon})^{\alpha}((P^{\varepsilon})^{1-\alpha}-(Q^{\varepsilon})^{1-\alpha})\,(P^{\varepsilon}-Q^{\varepsilon})\right\}\varphi\left(\Phi^{-1}(\tau,z)\right)\frac{\mathrm{d}z\,\mathrm{d}\tau}{h}\\ &\leqslant 8\int_{\mathbb{R}^{+}\times\mathbb{R}}\left[C\left(|Q^{\varepsilon}|^{\alpha+1}+(Q^{\varepsilon})^{\alpha}+|P^{\varepsilon}|^{\alpha+1}+(P^{\varepsilon})^{\alpha}\right)\varphi\,\mathrm{d}z-\left(\frac{(P^{\varepsilon})^{\alpha+1}+(Q^{\varepsilon})^{\alpha+1}}{\alpha+1}\right)\varphi_{\tau}\right]\mathrm{d}z\,\mathrm{d}\tau\\ &-8\int_{\mathbb{R}^{+}\times\mathbb{R}}\left(\frac{\sqrt{3\gamma}(h^{\varepsilon})^{1/2}((Q^{\varepsilon})^{\alpha+1}-(P^{\varepsilon})^{\alpha+1})+\mathscr{A}^{\varepsilon}((Q^{\varepsilon})^{\alpha+1}+(P^{\varepsilon})^{\alpha+1})}{\alpha+1}\right)\varphi_{z}\,\mathrm{d}z\,\mathrm{d}\tau\\ &=8\int_{\mathbb{R}^{+}\times\mathbb{R}}\left((|Q^{\varepsilon}|^{\alpha+1}+(Q^{\varepsilon})^{\alpha}+|P^{\varepsilon}|^{\alpha+1}+(P^{\varepsilon})^{\alpha})\,\varphi\,h^{\varepsilon}\,\mathrm{d}x\,\mathrm{d}t\\ &-8\int_{\mathbb{R}^{+}\times\mathbb{R}}\left(\frac{(P^{\varepsilon})^{\alpha+1}+(Q^{\varepsilon})^{\alpha+1}}{\alpha+1}\right)h^{\varepsilon}\left(\varphi_{t}+u^{\varepsilon}\varphi_{x}-(h^{\varepsilon})^{-1}\mathscr{A}^{\varepsilon}\varphi_{x}\right)\,\mathrm{d}x\,\mathrm{d}t\\ &-8\int_{\mathbb{R}^{+}\times\mathbb{R}}\left(\frac{\sqrt{3\gamma}(h^{\varepsilon})^{1/2}((Q^{\varepsilon})^{\alpha+1}-(P^{\varepsilon})^{\alpha+1})+\mathscr{A}^{\varepsilon}((Q^{\varepsilon})^{\alpha+1}+(P^{\varepsilon})^{\alpha+1})}{\alpha+1}\right)\varphi_{x}\,\mathrm{d}x\,\mathrm{d}t\\ &\leqslant C_{\alpha,\Omega}. \end{split}$$

The last inequality follows from (4.12) and from the fact that φ is compactly supported. Then we have

$$\int_{\Omega} (P^{\varepsilon} - Q^{\varepsilon})^{2} ((P^{\varepsilon})^{\alpha} + (Q^{\varepsilon})^{\alpha}) \, \mathrm{d}x \, \mathrm{d}t \leqslant C_{\alpha,\Omega}. \tag{4.72}$$

Step 2. Multiplying (4.71) by $(h^{\varepsilon})^{-1/2}$ we obtain

$$\begin{split} \frac{1}{8 \, (h^\varepsilon)^{3/2}} \, & \left\{ \frac{1-\alpha}{\alpha+1} \left((P^\varepsilon)^{\alpha+1} - (Q^\varepsilon)^{\alpha+1} \right) \left(P^\varepsilon - Q^\varepsilon \right) \, + \, \left(P^\varepsilon \right)^\alpha (Q^\varepsilon)^\alpha ((P^\varepsilon)^{1-\alpha} \, - \, (Q^\varepsilon)^{1-\alpha} \right) \left(P^\varepsilon - Q^\varepsilon \right) \right\} \\ & \leqslant \, \left(\frac{(P^\varepsilon)^{\alpha+1} + (Q^\varepsilon)^{\alpha+1}}{(\alpha+1) \, (h^\varepsilon)^{1/2}} \right)_\tau \, + \left(\frac{\sqrt{3\gamma} \left((Q^\varepsilon)^{\alpha+1} - (P^\varepsilon)^{\alpha+1} \right)}{\alpha+1} \right)_z \, + \, \left(\frac{\mathscr{A}^\varepsilon \left((Q^\varepsilon)^{\alpha+1} + (P^\varepsilon)^{\alpha+1} \right)}{(\alpha+1) \, (h^\varepsilon)^{1/2}} \right)_z \\ & + \, \left(h^\varepsilon \right)^{-1/2} C \left(|Q^\varepsilon|^{\alpha+1} + (Q^\varepsilon)^\alpha + |P^\varepsilon|^{\alpha+1} + (P^\varepsilon)^\alpha \right) \, + \, \frac{1}{2} \, \mathscr{A}_x^\varepsilon \, \frac{(P^\varepsilon)^{\alpha+1} + (Q^\varepsilon)^{\alpha+1}}{(\alpha+1) \, (h^\varepsilon)^{3/2}} \\ & - \, \frac{1}{8 \, (h^\varepsilon)^{3/2}} \, \frac{4}{\alpha+1} \, \left\{ (P^\varepsilon)^{\alpha+1} \, Q^\varepsilon \, + \, (Q^\varepsilon)^{\alpha+1} \, P^\varepsilon \right\} \, . \end{split}$$

Using (4.59) one obtain

$$\frac{1}{8 \, (h^\varepsilon)^{3/2}} \left\{ \frac{1-\alpha}{\alpha+1} \left((P^\varepsilon)^{\alpha+1} + (Q^\varepsilon)^{\alpha+1} \right) \left(P^\varepsilon + Q^\varepsilon \right) \right. \\ + \left. \left(P^\varepsilon \right)^{\alpha} \left(Q^\varepsilon \right)^{\alpha} \left((P^\varepsilon)^{1-\alpha} + \left(Q^\varepsilon \right)^{1-\alpha} \right) \left(P^\varepsilon + Q^\varepsilon \right) \right\} \\ \leqslant \left. \left(\frac{(P^\varepsilon)^{\alpha+1} + (Q^\varepsilon)^{\alpha+1}}{(\alpha+1) \, (h^\varepsilon)^{1/2}} \right)_\tau + \left(\frac{\sqrt{3 \, \gamma} \left((Q^\varepsilon)^{\alpha+1} - (P^\varepsilon)^{\alpha+1} \right)}{\alpha+1} \right)_z \right. \\ + \left. \left(\frac{\mathscr{A}^\varepsilon \left((Q^\varepsilon)^{\alpha+1} + (P^\varepsilon)^{\alpha+1} \right)}{(\alpha+1) \, (h^\varepsilon)^{1/2}} \right)_z \right.$$

$$C(|Q^{\varepsilon}|^{\alpha+1} + (Q^{\varepsilon})^{\alpha} + |P^{\varepsilon}|^{\alpha+1} + (P^{\varepsilon})^{\alpha}).$$

As in the first step we obtain

$$\int_{\Omega} (P^{\varepsilon} + Q^{\varepsilon})^{2} ((P^{\varepsilon})^{\alpha} + (Q^{\varepsilon})^{\alpha}) \, \mathrm{d}x \, \mathrm{d}t \leqslant C_{\alpha,\Omega}. \tag{4.73}$$

Summing up (4.72) and (4.73) one obtains

$$\int_{\Omega} ((P^{\varepsilon})^{\alpha+2} + (Q^{\varepsilon})^{\alpha+2}) \, \mathrm{d}x \, \mathrm{d}t \leqslant C_{\alpha,\Omega} \qquad \Longrightarrow \qquad \int_{\Omega} \left[|u_x^{\varepsilon}|^{2+\alpha} + |h_x^{\varepsilon}|^{2+\alpha} \right] \, \mathrm{d}x \, \mathrm{d}t \leqslant C_{\alpha,\Omega}.$$

Step 3. The inequality (4.68) follows directly from (4.3) and Lemma 4.4. Finally, using (4.14), (4.15), (4.21), (4.22) and (4.68) we obtain (4.69).

5. Precompactness

The goal of this section is to obtain a compactness of the solution. Due to the non-linear terms of the equations, strong precompactness is needed to pass to the limit $\varepsilon \to 0$. The strong precompactness of $(h^{\varepsilon})_{\varepsilon}$ and $(u^{\varepsilon})_{\varepsilon}$ is easy to obtain. However, the strong precompactness of $(P^{\varepsilon})_{\varepsilon}$ and $(Q^{\varepsilon})_{\varepsilon}$ is more challenging. Several lemmas in this section are inspired by [14, 51, 53, 54, 55, 56]. Along this section, Lemma A.2 is used many times without mentioning it.

We start by strong precompactness of $(h^{\varepsilon})_{\varepsilon}$ and $(u^{\varepsilon})_{\varepsilon}$.

Lemma 5.1. There exist $(h, u) \in L^{\infty}([0, \infty), H^1(\mathbb{R}))$ and a subsequence of $(h^{\varepsilon}, u^{\varepsilon})$ such that we have the following convergences

$$(h^{\varepsilon} - \bar{h}, u^{\varepsilon}) \longrightarrow (h - \bar{h}, u) \quad \text{in } L^{\infty}_{loc}([0, \infty) \times \mathbb{R}),$$

$$(h^{\varepsilon} - \bar{h}, u^{\varepsilon}) \longrightarrow (h - \bar{h}, u) \quad \text{in } H^{1}([0, T] \times \mathbb{R}), \ \forall T > 0.$$

Remark 5.2. In Lemma 7.5 below, we prove that the limit $(h - \bar{h}, u)$ is unique and do not depend on the subsequence.

Proof. From the energy equation (4.12) we have that $(h^{\varepsilon} - \bar{h}, u^{\varepsilon})$ is uniformly bounded in $L^{\infty}([0, \infty), H^1(\mathbb{R}))$. Then, using (4.3), and (4.59) we obtain that

$$\|(h_t^{\varepsilon}, u_t^{\varepsilon})\|_{L^2([0,T]\times\mathbb{R})} \leqslant C_T. \tag{5.1}$$

The weak convergence in $H^1([0,T]\times\mathbb{R})$ follows directly. Using the inequality

$$\|\theta(t,\cdot) - \theta(s,\cdot)\|_{L^{2}(\mathbb{R})}^{2} = \int_{\mathbb{R}} \left(\int_{s}^{t} \theta_{t}(\tau,x) d\tau \right)^{2} dx \leqslant |t-s| \|\theta_{t}\|_{L^{2}([0,T]\times\mathbb{R})}^{2},$$

with (5.1) we obtain that

$$\lim_{t\to s} \|u^{\varepsilon}(t,\cdot) - u^{\varepsilon}(s,\cdot)\|_{L^2(\mathbb{R})} + \lim_{t\to s} \|h^{\varepsilon}(t,\cdot) - h^{\varepsilon}(s,\cdot)\|_{L^2(\mathbb{R})} = 0$$

uniformly on ε . Then, using Lemma A.6 we can deduce that up to a subsequence, $(h^{\varepsilon}, u^{\varepsilon})$ converges uniformly to (h, u) on any compact set of $[0, \infty) \times \mathbb{R}$ when $\varepsilon \to 0$. \square Now, we establish the weak precompactness of $(P^{\varepsilon})_{\varepsilon}$ and $(Q^{\varepsilon})_{\varepsilon}$.

Lemma 5.3. There exist a subsequence of $\{P^{\varepsilon}, Q^{\varepsilon}\}_{\varepsilon}$ denoted also $\{P^{\varepsilon}, Q^{\varepsilon}\}_{\varepsilon}$ and families of probability Young measures $\nu_{t,x}^{1}, \nu_{t,x}^{2}$ on \mathbb{R} and $\mu_{t,x}$ on \mathbb{R}^{2} , such that for all functions $f, \phi \in C_{c}^{\infty}(\mathbb{R}), g \in C^{\infty}(\mathbb{R}^{2})$ with $g(\xi, \zeta) = \mathcal{O}(|\xi|^{2} + |\zeta|^{2})$ at infinity, and for all $\varphi \in C_{c}^{\infty}((0, \infty) \times \mathbb{R})$ we have

$$\lim_{\varepsilon \to 0} \int_{\mathbb{R}} \phi(x) f(P^{\varepsilon}(t, x)) dx = \int_{\mathbb{R}} \phi(x) \int_{\mathbb{R}} f(\xi) d\nu_{t, x}^{1}(\xi) dx, \qquad (5.2)$$

$$\lim_{\varepsilon \to 0} \int_{\mathbb{R}} \phi(x) f(Q^{\varepsilon}(t, x)) dx = \int_{\mathbb{R}} \phi(x) \int_{\mathbb{R}} f(\zeta) d\nu_{t, x}^{2}(\zeta) dx, \qquad (5.3)$$

uniformly on any compact set $[0,T] \subset [0,\infty)$, and

$$\lim_{\varepsilon \to 0} \int_{\mathbb{R}^+ \times \mathbb{R}} \varphi(t, x) g(P^{\varepsilon}, Q^{\varepsilon}) dx dt = \int_{\mathbb{R}^+ \times \mathbb{R}} \varphi(t, x) \int_{\mathbb{R}^2} g(\xi, \zeta) d\mu_{t, x}(\xi, \zeta) dx dt.$$
 (5.4)

Moreover, the map

$$(t,x) \mapsto \int_{\mathbb{R}} \xi^2 d\nu_{t,x}^1(\xi) + \int_{\mathbb{R}} \zeta^2 d\nu_{t,x}^2(\zeta)$$
 (5.5)

belongs to $L^{\infty}(\mathbb{R}^+, L^1(\mathbb{R}))$, and

$$\mu_{t,x}(\xi,\zeta) = \nu_{t,x}^{1}(\xi) \otimes \nu_{t,x}^{2}(\zeta).$$
 (5.6)

We define

$$\overline{g(P,Q)} \stackrel{\text{def}}{=} \int_{\mathbb{R}^2} g(\xi,\zeta) \, \mathrm{d}\mu_{t,x}(\xi,\zeta) \tag{5.7}$$

which is from (5.4) the weak limit of $g(P^{\varepsilon}, Q^{\varepsilon})$.

Proof. Step 1. The pointwise convergence of (5.2) is a direct corollary of Lemma A.1 with $\mathscr{O} = \mathbb{R}$ and p = 2 and the energy equation (4.12). The key point to prove the uniform convergence is to show that the map

 (5.9)

Multiplying by $\phi(x)$ and integrating over $[t_1,t_2]\times\mathbb{R}$ we have

$$= \int_{t_{1}}^{t_{2}} \int_{\mathbb{R}} \left[\phi'(x) \lambda^{\varepsilon} f(P^{\varepsilon}) + \frac{1}{4h^{\varepsilon}} \phi(x) \left(P^{\varepsilon} + 3 Q^{\varepsilon} \right) f(P^{\varepsilon}) \right] dx dt$$

Using that $f \in C_c^{\infty}$, the the energy equation (4.12), Proposition 2.4, and Lemma 4.4 we find that the map (5.8) is equicontinuous. Then, the sequences $\left\{ (1 - \partial_x^2)^{-1} \left\{ \partial_x T_{\kappa}(P^{\varepsilon}) \right\} \right\}_{\varepsilon}$ is uniformly bounded in $W^{1,\infty}((0,\infty) \times \mathbb{R})$. Arzela–Ascoli theorem implies that, up to a subsequence, we have the convergence

- \int_{(0,\infty)\times\mathbb{R}} \left(1 - \partial_{x}^{2}\right)^{-1} \left\{T_{\kappa}(P^{\varepsilon})\right\} \cdot \left(1 - \partial_{x}^{2}\right) \left\{\varphi_{x} \, \mathscr{P}^{\varepsilon}\right\} \, \mathrm{d}x \, \mathrm{d}t.$$

Taking the limit $\varepsilon \to 0$ and using Step 2, Step 3 and Lemma A.2 we obtain

Step 5. Since $|T_{\kappa}(P^{\varepsilon})| \leq \kappa$, then, from (4.63) we have $\mathscr{V}_1 T_{\kappa}(P^{\varepsilon}) \rightharpoonup 0$ and $\mathscr{V}_2 T_{\kappa}(P^{\varepsilon}) \rightharpoonup 0$. Then, using (5.31) we obtain (5.25) with

$$\leqslant \overline{T_{\kappa}(P)^{2}} - 2\kappa\left[\overline{(P + \kappa)} \mathbb{1}_{P \leqslant -\kappa} - (\overline{P} + \kappa) \mathbb{1}_{\overline{P} \leqslant -\kappa}\right]$$

The last two identities with (5.37) imply (5.34).

Now we state the main result of this section.

Proof. Since the proof is the same, we present here only the proof of $\nu_{t,x}^1(\xi) = \delta_{\overline{P}(t,x)}(\xi)$. Note that if $\overline{P^2} = \overline{P}^2$ then $\int_{\mathbb{R}} \left(\overline{P} - \xi\right)^2 d\nu_{t,x}^1(\xi) = 0$ which implies that $\sup(\nu_{t,x}^1) = \{\overline{P}\}$. Since $\nu_{t,x}^1$ is a probability measure, necessarily $\nu_{t,x}^1 = \delta_{\overline{P}}$. It remains then only to prove that $\overline{P^2} = \overline{P}^2$. The goal is to obtain an evolutionary inequality of $\overline{P^2} - \overline{P}^2$, then, since it is equal to zero initially, we prove that it remains zero for all time. The proof is given in several steps.

$$\left[\sqrt{h^{3/2} f_{\kappa}^{\varepsilon} + \beta}\right]_{t} + \left[\lambda \sqrt{h^{3/2} f_{\kappa}^{\varepsilon} + \beta}\right]_{x} \leqslant \left(\widetilde{\mathscr{M}} + \frac{\overline{Q^{2}}}{8h}\right) \frac{\overline{T_{\kappa}(P)} - T_{\kappa}(\overline{P})}{2\sqrt{h^{3/2} f_{\kappa}^{\varepsilon} + \beta}} h^{3/2} + \tilde{\theta}_{\varepsilon} + \frac{(\overline{P} - T_{\kappa}(\overline{P}))h^{1/2} f_{\kappa}^{\varepsilon}}{8\sqrt{h^{3/2} f_{\kappa}^{\varepsilon} + \beta}} + \frac{\beta \lambda_{x}}{\sqrt{h^{3/2} f_{\kappa}^{\varepsilon} + \beta}},$$

where $\tilde{\theta}_{\varepsilon} \stackrel{\text{def}}{=} \theta_{\varepsilon} h^{3/2} \left(h^{3/2} f_{\kappa}^{\varepsilon} + \beta \right)^{-1/2} / 2 \to 0$ in $L^{1}_{loc}((0, \infty) \times \mathbb{R})$. Taking $\varepsilon \to 0$ we obtain

From (5.34) we have

Using that $|T_{\kappa}(\xi)| \leq |\xi|$ and $S_{\kappa}(\xi) \leq \xi^2/2$ we obtain

Hence $\overline{P^2} = \overline{P}^2$ almost everywhere, which implies that $\nu^1_{t,x}(\xi) = \delta_{\overline{P}(t,x)}(\xi)$. The proof of $\nu^2_{t,x}(\zeta) = \delta_{\overline{Q}(t,x)}(\zeta)$ can be done similarly.

6. The global weak solutions

We use in this section the precompactness results given in the previous section to prove that the limit (h, u) given in Lemma 5.1 is a weak solution of (2.1).

Let $(h^{\varepsilon} - \bar{h}, u^{\varepsilon})$ be the solution given in Theorem 4.1. Then, from Lemma 5.3, Lemma 5.7, Lemma 4.6, (3.4) and (5.13) we have that

for any $p \in [2,3)$ and compact set $\Omega \subset (0,\infty) \times \mathbb{R}$. This implies that

$$(P^{\varepsilon}, Q^{\varepsilon}, u_x^{\varepsilon}, h_x^{\varepsilon}) \to (\overline{P}, \overline{Q}, u_x, h_x)$$
 in $L^2_{loc}((0, \infty) \times \mathbb{R})$. (6.2)

Using Lemma 4.6 and Lemma 5.1 we obtain that for all $p \in [2,3)$, we have

From (6.2) and Lemma 5.1 we obtain the following convergence as $\varepsilon \to 0$

Lemma 4.5 implies (2.13). The inequality (2.11) follows from Lemma 4.6, (6.1) and (6.3). Finally, the energy inequality (2.12) follows from (5.17).

7. Stability

The goal of this section is to prove the existence and the stability of the semigroup. For that purpose, we consider $(h_0, u_0), (\rho_0, v_0) \in \mathfrak{D}$ and $\varepsilon, \delta > 0$. Let j_{ε} be a Friedrichs mollifier and

$$\left\| \mathscr{A}^{\varepsilon}[h^{\varepsilon}, u^{\varepsilon}] - \mathscr{A}^{\delta}[\rho^{\delta}, v^{\delta}] \right\|_{H^{2}} \leqslant \left(f_{T}(\varepsilon) + f_{T}(\delta) \right) \left(\left\| \left(h^{\varepsilon} - \rho^{\delta}, u^{\varepsilon} - v^{\delta} \right) \right\|_{H^{1}} + \left| \varepsilon - \delta \right| \right), \tag{7.13}$$

$$\left\| \mathscr{B}^{\varepsilon}[h^{\varepsilon}, u^{\varepsilon}] - \mathscr{B}^{\delta}[\rho^{\delta}, v^{\delta}] \right\|_{H^{1}} \leqslant \left(f_{T}(\varepsilon) + f_{T}(\delta) \right) \left(\left\| \left(h^{\varepsilon} - \rho^{\delta}, u^{\varepsilon} - v^{\delta} \right) \right\|_{H^{1}} + \left| \varepsilon - \delta \right| \right). \tag{7.14}$$

Remark 7.2. By f_T we mean a function satisfying (7.5). It can be a different function for such inequality.

Proof. Step 0. Since $\int_{\mathbb{R}} \mathcal{E}_0^{\varepsilon}(x) dx \leqslant E$ and $\int_{\mathbb{R}} \tilde{\mathcal{E}}_0^{\varepsilon}(x) dx \leqslant E$, we can prove using (4.52), (4.54), (4.55), (4.57) and (4.58) that

$$\left\| \left(h^{\varepsilon} - \bar{h}, u^{\varepsilon} \right) \right\|_{L^{\infty}_{x}W^{2,\infty}} \leqslant \left\| \left(h^{\varepsilon} - \bar{h}, u^{\varepsilon} \right) \right\|_{L^{\infty}_{x}H^{3}} \leqslant f_{T}(\varepsilon), \tag{7.15a}$$

$$\|\left(\rho^{\delta} - \bar{h}, v^{\delta}\right)\|_{L^{\infty}W^{2,\infty}} \leqslant \|\left(\rho^{\delta} - \bar{h}, v^{\delta}\right)\|_{L^{\infty}H^{3}} \leqslant f_{T}(\delta), \tag{7.15b}$$

where f_T do not depend on the initial data and $L_T^{\infty}X \stackrel{\text{def}}{=} L^{\infty}([0,T],X(\mathbb{R}))$.

Step 1. Using the definitions above we obtain

$$P^{\varepsilon} - T^{\varepsilon} = h^{\varepsilon} u_{x}^{\varepsilon} - \rho^{\varepsilon} v_{x}^{\varepsilon} + \sqrt{3\gamma} (\rho^{\varepsilon})^{-\frac{1}{2}} \rho_{x}^{\varepsilon} - \sqrt{3\gamma} (h^{\varepsilon})^{-\frac{1}{2}} h_{x}^{\varepsilon}$$

$$= h^{\varepsilon} (u_{x}^{\varepsilon} - v_{x}^{\varepsilon}) + v_{x}^{\varepsilon} (h^{\varepsilon} - \rho^{\varepsilon}) + \sqrt{3\gamma} (\rho^{\varepsilon})^{-\frac{1}{2}} (\rho_{x}^{\varepsilon} - h_{x}^{\varepsilon}) + \frac{\sqrt{3\gamma} h_{x}^{\varepsilon} (h^{\varepsilon} - \rho^{\varepsilon})}{h^{\varepsilon} \sqrt{\rho^{\varepsilon}} + \rho^{\varepsilon} \sqrt{h^{\varepsilon}}}.$$

Doing the same with $Q^{\delta} - V^{\delta}$ we obtain

$$Q^{\delta} - V^{\delta} = h^{\delta} \left(u_x^{\delta} - v_x^{\delta} \right) + v_x^{\delta} \left(h^{\delta} - \rho^{\delta} \right) - \sqrt{3\gamma} \left(\rho^{\delta} \right)^{-\frac{1}{2}} \left(\rho_x^{\delta} - h_x^{\delta} \right) - \frac{\sqrt{3\gamma} h_x^{\delta} \left(h^{\delta} - \rho^{\delta} \right)}{h^{\delta} \sqrt{\rho^{\delta}} + \rho^{\delta} \sqrt{h^{\delta}}}.$$

Using (7.15) we obtain directly (7.6).

Step 2. Using the definition $\mathcal{L}_{h^{\varepsilon}}$ we have

$$\partial_{x} \left(\mathcal{L}_{h^{\varepsilon}}^{-1} - \mathcal{L}_{\rho^{\delta}}^{-1} \right) \partial_{x} g = \partial_{x} \mathcal{L}_{h^{\varepsilon}}^{-1} \left(\mathcal{L}_{\rho^{\delta}} - \mathcal{L}_{h^{\varepsilon}} \right) \mathcal{L}_{\rho^{\delta}}^{-1} \partial_{x} g
= \partial_{x} \mathcal{L}_{h^{\varepsilon}}^{-1} \left(\rho^{\delta} - h^{\varepsilon} \right) \mathcal{L}_{\rho^{\delta}}^{-1} \partial_{x} g + \frac{1}{3} \partial_{x} \mathcal{L}_{h^{\varepsilon}}^{-1} \partial_{x} \left((h^{\varepsilon})^{3} - (\rho^{\delta})^{3} \right) \partial_{x} \mathcal{L}_{\rho^{\delta}}^{-1} \partial_{x} g.$$

Using (4.16), (4.20) we obtain

$$\left\| \partial_x \left(\mathcal{L}_{h^{\varepsilon}}^{-1} - \mathcal{L}_{\rho^{\delta}}^{-1} \right) \partial_x g \right\|_{L^2} \leqslant C \left[\left\| \left(\rho^{\delta} - h^{\varepsilon} \right) \mathcal{L}_{\rho^{\delta}}^{-1} \partial_x g \right\|_{L^1} + \left\| \left((h^{\varepsilon})^3 - (\rho^{\delta})^3 \right) \partial_x \mathcal{L}_{\rho^{\delta}}^{-1} \partial_x g \right\|_{L^2} \right].$$

Using the Cauchy–Schwarz inequality, the embedding $H^1 \hookrightarrow L^{\infty}$, (4.16), (4.19) with (4.20) we obtain

$$\left\| \partial_x \left(\mathcal{L}_{h^{\varepsilon}}^{-1} - \mathcal{L}_{\rho^{\delta}}^{-1} \right) \partial_x g \right\|_{L^2} \leqslant C \|g\|_{L^2} \|h^{\varepsilon} - \rho^{\delta}\|_{H^1}.$$

Doing the same with $\left(\mathcal{L}_{h^{\varepsilon}}^{-1} - \mathcal{L}_{\rho^{\delta}}^{-1}\right) \partial_x g$ we obtain (7.7). Similarly we can prove (7.8).

Step 3. Using the triangular inequality we have

$$\left\| \mathcal{L}_{h^{\varepsilon}}^{-1} \partial_x F(h^{\varepsilon}) - \mathcal{L}_{\rho^{\delta}}^{-1} \partial_x F(\rho^{\delta}) \right\|_{H^1} \leqslant \left\| \left(\mathcal{L}_{h^{\varepsilon}}^{-1} - \mathcal{L}_{\rho^{\delta}}^{-1} \right) \partial_x F(\rho^{\delta}) \right\|_{H^1} + \left\| \mathcal{L}_{h^{\varepsilon}}^{-1} \partial_x \left(F(h^{\varepsilon}) - F(\rho^{\delta}) \right) \right\|_{H^1}.$$

Using (4.20) we obtain

$$\left\| \mathcal{L}_{h^{\varepsilon}}^{-1} \partial_{x} \left(F(h^{\varepsilon}) - F(\rho^{\delta}) \right) \right\|_{H^{1}} \leqslant C \left\| F(h^{\varepsilon}) - F(\rho^{\delta}) \right\|_{L^{2}} \leqslant C \left\| h^{\varepsilon} - \rho^{\delta} \right\|_{H^{1}}.$$

Using (7.7) and (A.7) we obtain

$$\left\| \left(\mathcal{L}_{h^{\varepsilon}}^{-1} - \mathcal{L}_{\rho^{\delta}}^{-1} \right) \partial_{x} F(\rho^{\delta}) \right\|_{H^{1}} \leqslant C \left\| F(\rho^{\delta}) \right\|_{L^{2}} \left\| h^{\varepsilon} - \rho^{\delta} \right\|_{H^{1}} \leqslant C \left\| h^{\varepsilon} - \rho^{\delta} \right\|_{H^{1}}.$$

Summing up, we obtain (7.9).

Step 4. Using the triangular inequality we have

$$\begin{aligned} \left\| \mathcal{L}_{h^{\varepsilon}}^{-1} \partial_{x} \mathscr{C}[h^{\varepsilon}, u^{\varepsilon}] - \mathcal{L}_{\rho^{\delta}}^{-1} \partial_{x} \mathscr{C}[\rho^{\delta}, v^{\delta}] \right\|_{H^{1}} &\leq \left\| \mathcal{L}_{h^{\varepsilon}}^{-1} \partial_{x} \left(\mathscr{C}[h^{\varepsilon}, u^{\varepsilon}] - \mathscr{C}[\rho^{\delta}, v^{\delta}] \right) \right\|_{H^{1}} \\ &+ \left\| \left(\mathcal{L}_{h^{\varepsilon}}^{-1} - \mathcal{L}_{\rho^{\delta}}^{-1} \right) \partial_{x} \mathscr{C}[\rho^{\delta}, v^{\delta}] \right\|_{H^{1}}. \end{aligned}$$

Using (7.7) and (7.15) we obtain

$$\left\| \left(\mathcal{L}_{h^{\varepsilon}}^{-1} - \mathcal{L}_{\rho^{\delta}}^{-1} \right) \partial_{x} \mathscr{C}[\rho^{\delta}, v^{\delta}] \right\|_{H^{1}} \leqslant \left(f_{T}(\varepsilon) + f_{T}(\delta) \right) \left\| \left(h^{\varepsilon} - \rho^{\delta}, u^{\varepsilon} - v^{\delta} \right) \right\|_{H^{1}}.$$

Using (4.19) we obtain

$$\begin{split} \left\| \mathcal{L}_{h^{\varepsilon}}^{-1} \partial_{x} \left(\frac{2}{3} \left(h^{\varepsilon} \right)^{3} \left(u_{x}^{\varepsilon} \right)^{2} \; - \; \frac{3}{2} \, \gamma \left(h_{x}^{\varepsilon} \right)^{2} \; - \; \frac{2}{3} \left(\rho^{\delta} \right)^{3} \left(v_{x}^{\delta} \right)^{2} \; + \; \frac{3}{2} \, \gamma \left(\rho_{x}^{\delta} \right)^{2} \right) \right\|_{H^{1}} \\ \leqslant \; C \left\| \frac{2}{3} \left(h^{\varepsilon} \right)^{3} \left(u_{x}^{\varepsilon} \right)^{2} \; - \; \frac{3}{2} \, \gamma \left(h_{x}^{\varepsilon} \right)^{2} \; - \; \frac{2}{3} \left(\rho^{\delta} \right)^{3} \left(v_{x}^{\delta} \right)^{2} \; + \; \frac{3}{2} \, \gamma \left(\rho_{x}^{\delta} \right)^{2} \right\|_{L^{1}} \\ \leqslant \; \left(f_{T}(\varepsilon) \; + \; f_{T}(\delta) \right) \left\| \left(h^{\varepsilon} \; - \; \rho^{\delta}, u^{\varepsilon} \; - \; v^{\delta} \right) \right\|_{H^{1}} \, . \end{split}$$

Summing up the inequalities above we obtain (7.10).

Step 5. Since $|\chi'_{\varepsilon}(\zeta)| \leq 2|\zeta|$ we obtain that $|\chi_{\varepsilon}(\zeta) - \chi_{\varepsilon}(\xi)| \leq C(|\zeta| + |\xi|)|\zeta - \xi|$. Then, using (7.6) we obtain

$$\|\chi_{\varepsilon}(P^{\varepsilon}) - \chi_{\varepsilon}(T^{\delta})\|_{L^{2}} \leqslant (f_{T}(\varepsilon) + f_{T}(\delta)) \|(h^{\varepsilon} - \rho^{\delta}, u^{\varepsilon} - v^{\delta})\|_{H^{1}}.$$
 (7.16)

Now, we can suppose without loss of generality that $\delta > \varepsilon > 0$. Then, we have

$$\chi_{\varepsilon}\left(T^{\delta}\right) - \chi_{\delta}\left(T^{\delta}\right) = \begin{cases} 0, & T^{\delta} \geqslant -1/\delta > -1/\varepsilon, \\ -\left(T^{\delta} + 1/\varepsilon\right)^{2}, & -1/\delta \geqslant T^{\delta} \geqslant -1/\varepsilon, \\ \left(T^{\delta} + 1/\delta\right)^{2} - \left(T^{\delta} + 1/\varepsilon\right)^{2}, & -1/\delta > -1/\varepsilon \geqslant T^{\delta}. \end{cases}$$

Then

$$\left|\chi_{\varepsilon}\left(T^{\delta}\right) - \chi_{\delta}\left(T^{\delta}\right)\right| \leqslant \begin{cases} 0, & T^{\delta} \geqslant -1/\delta > -1/\varepsilon, \\ \left(1/\varepsilon - 1/\delta\right)^{2}, & -1/\delta \geqslant T^{\delta} \geqslant -1/\varepsilon, \\ -\left(2T^{\delta} + 1/\varepsilon + 1/\delta\right)\left(1/\varepsilon - 1/\delta\right), & -1/\delta > -1/\varepsilon \geqslant T^{\delta}. \end{cases}$$

The energy equation (4.12) implies that for all t > 0

$$\left|\left\{x, T^{\delta}(t, x) \leqslant -1/\delta\right\}\right| \leqslant C \delta^{2}.$$

Then, we can directly obtain

$$\|\chi_{\varepsilon}(T^{\delta}) - \chi_{\delta}(T^{\delta})\|_{L^{2}} \leqslant (f_{T}(\varepsilon) + f_{T}(\delta)) |\varepsilon - \delta|.$$

Summing up with (7.16) we obtain (7.11). The proof of (7.12) is the same.

Step 6. Using the Young inequality, (7.11) and (7.12) we obtain

$$\|\mathscr{A}^{\varepsilon}[h^{\varepsilon}, u^{\varepsilon}] - \mathscr{A}^{\delta}[\rho^{\delta}, v^{\delta}]\|_{H^{2}} \leqslant C \left\| \frac{1}{(h^{\varepsilon})^{1/2}} \left(\chi_{\varepsilon}(P^{\varepsilon}) - \chi_{\varepsilon}(Q^{\varepsilon}) \right) - \frac{1}{(\rho^{\delta})^{1/2}} \left(\chi_{\delta}(T^{\delta}) - \chi_{\delta}(V^{\delta}) \right) \right\|_{L^{2}}$$

$$\leqslant \left(f_{T}(\varepsilon) + f_{T}(\delta) \right) \left(\left\| \left(h^{\varepsilon} - \rho^{\delta}, u^{\varepsilon} - v^{\delta} \right) \right\|_{H^{1}} + |\varepsilon - \delta| \right).$$

This is (7.13).

Step 7. Using (4.12) and Lemma 4.4 one can check that

$$\|u^{\varepsilon} \mathscr{A}_{x}^{\varepsilon}[h^{\varepsilon}, u^{\varepsilon}]\|_{L^{1}} + \|(h^{\varepsilon})^{2} u_{x}^{\varepsilon} \mathscr{A}_{x}^{\varepsilon}[h^{\varepsilon}, u^{\varepsilon}]\|_{L^{1} \cap L^{2}} + \|h^{\varepsilon} (\chi_{\varepsilon}(P^{\varepsilon}) - \chi_{\varepsilon}(Q^{\varepsilon}))\|_{L^{1} \cap L^{2}} \leqslant f_{T}(\varepsilon).$$

Then, using (7.7), (7.8) one obtains

$$\left\| \left(\mathcal{L}_{h^{\varepsilon}}^{-1} - \mathcal{L}_{\rho^{\delta}}^{-1} \right) \left\{ -\frac{1}{2} u^{\varepsilon} \mathscr{A}_{x}^{\varepsilon} [h^{\varepsilon}, u^{\varepsilon}] + \partial_{x} \left\{ \frac{1}{2} (h^{\varepsilon})^{2} u_{x}^{\varepsilon} \mathscr{A}_{x}^{\varepsilon} [h^{\varepsilon}, u^{\varepsilon}] - \frac{1}{48} h^{\varepsilon} \left(\chi_{\varepsilon}(P^{\varepsilon}) - \chi_{\varepsilon}(Q^{\varepsilon}) \right) \right\} \right\} \right\|_{H^{1}} \\ \leqslant f_{T}(\varepsilon) \left\| h^{\varepsilon} - \rho^{\delta} \right\|_{H^{1}}. \tag{7.17}$$

On another hand we can prove that

$$\begin{aligned} \left\| u^{\varepsilon} \, \mathscr{A}_{x}^{\varepsilon} [h^{\varepsilon}, u^{\varepsilon}] \, - \, v^{\delta} \, \mathscr{A}_{x}^{\delta} [\rho^{\delta}, v^{\delta}] \right\|_{L^{2}} &\leqslant \, \left(f_{T}(\varepsilon) + f_{T}(\delta) \right) \left(\left\| \left(h^{\varepsilon} - \rho^{\delta}, u^{\varepsilon} - v^{\delta} \right) \right\|_{H^{1}} + \left| \varepsilon - \delta \right| \right), \\ \left\| h^{\varepsilon} \, \chi_{\varepsilon} (P^{\varepsilon}) \, - \, \rho^{\delta} \, \chi_{\delta} (T^{\delta}) \right\|_{L^{2}} &\leqslant \, \left(f_{T}(\varepsilon) + f_{T}(\delta) \right) \left(\left\| \left(h^{\varepsilon} - \rho^{\delta}, u^{\varepsilon} - v^{\delta} \right) \right\|_{H^{1}} + \left| \varepsilon - \delta \right| \right), \\ \left\| h^{\varepsilon} \, \chi_{\varepsilon} (Q^{\varepsilon}) \, - \, \rho^{\delta} \, \chi_{\delta} (V^{\delta}) \right\|_{L^{2}} &\leqslant \, \left(f_{T}(\varepsilon) + f_{T}(\delta) \right) \left(\left\| \left(h^{\varepsilon} - \rho^{\delta}, u^{\varepsilon} - v^{\delta} \right) \right\|_{H^{1}} + \left| \varepsilon - \delta \right| \right), \\ \left\| \left(h^{\varepsilon} \right)^{2} u_{x}^{\varepsilon} \, \mathscr{A}_{x}^{\varepsilon} [h^{\varepsilon}, u^{\varepsilon}] - \left(\rho^{\delta} \right)^{2} v_{x}^{\delta} \, \mathscr{A}_{x}^{\delta} [\rho^{\delta}, v^{\delta}] \right\|_{L^{2}} \end{aligned}$$

$$\leq (f_T(\varepsilon) + f_T(\delta)) (\|(h^{\varepsilon} - \rho^{\delta}, u^{\varepsilon} - v^{\delta})\|_{H^1} + |\varepsilon - \delta|).$$

Then, using (4.20) with (7.17) we obtain (7.14).

Now we can state the stability result of the systems (7.1) and (7.2).

Lemma 7.3. Let $(h^{\varepsilon}, u^{\varepsilon}), (\rho^{\delta}, v^{\delta})$ be the the solutions of (7.1) and (7.2) given by Theorem 4.1, then

$$\left\| \left(h^{\varepsilon} - \rho^{\delta}, u^{\varepsilon} - v^{\delta} \right) \right\|_{L^{\infty}_{x}H^{1}} \leqslant \left(f_{T}(\varepsilon) + f_{T}(\delta) \right) \left(\left\| \left(h_{0}^{\varepsilon} - \rho_{0}^{\delta}, u_{0}^{\varepsilon} - v_{0}^{\delta} \right) \right\|_{H^{1}} + \left| \varepsilon - \delta \right| \right). \tag{7.18}$$

Remark 7.4. Since $\lim_{\varepsilon\to 0} f_T(\varepsilon) = \infty$, the stability is not uniform on ε and δ . However, we prove below that (7.18) is sufficient to obtain the stability result of Theorem 2.8.

Proof. In order to prove (7.18), we define

$$E\left(h^{\varepsilon}, u^{\varepsilon}, \rho^{\delta}, v^{\delta}\right) \stackrel{\text{def}}{=} \int_{\mathbb{R}} \left[\left(h^{\varepsilon} - \rho^{\delta}\right)^{2} + \left(u^{\varepsilon} - v^{\delta}\right)^{2} + \left(h^{\varepsilon}_{x} - \rho^{\delta}_{x}\right)^{2} + \frac{(\rho^{\delta})^{3}}{3\gamma} \left(u^{\varepsilon}_{x} - v^{\delta}_{x}\right)^{2} \right] dx,$$

which is equivalent to $\|(h^{\varepsilon} - \rho^{\delta}, u^{\varepsilon} - v^{\delta})\|_{H^{1}}^{2}$. From (7.1a) and (7.2a) we have

$$\left(h^{\varepsilon} - \rho^{\delta}\right)_{t} = \rho^{\delta} \left(v^{\delta} - u^{\varepsilon}\right)_{x} + v^{\delta} \left(\rho^{\delta} - h^{\varepsilon}\right)_{x} + u_{x}^{\varepsilon} \left(\rho^{\delta} - h^{\varepsilon}\right) + h_{x}^{\varepsilon} \left(v^{\delta} - u^{\varepsilon}\right) + \mathscr{A}^{\varepsilon} [h^{\varepsilon}, u^{\varepsilon}]_{x} - \mathscr{A}^{\delta} [\rho^{\delta}, v^{\delta}]_{x}. \tag{7.19}$$

Multiplying by $2(h^{\varepsilon} - \rho^{\delta})$, integrating with respect to x, using the Cauchy–Schwarz inequality and (7.13) we obtain

$$\frac{\mathrm{d}}{\mathrm{d}t} \int_{\mathbb{R}} \left(h^{\varepsilon} - \rho^{\delta} \right)^{2} \mathrm{d}x \leqslant \left(f_{T}(\varepsilon) + f_{T}(\delta) \right) \left(E\left(h^{\varepsilon}, u^{\varepsilon}, \rho^{\delta}, v^{\delta} \right) + |\varepsilon - \delta|^{2} \right). \tag{7.20}$$

Differentiating (7.19) with respect to x we obtain

$$\begin{split} \left(h_{x}^{\varepsilon}-\rho_{x}^{\delta}\right)_{t} &= \rho^{\delta}\left(v_{x}^{\delta}-u_{x}^{\varepsilon}\right)_{x}+\rho_{x}^{\delta}\left(v^{\delta}-u^{\varepsilon}\right)_{x}+v_{x}^{\delta}\left(\rho^{\delta}-h^{\varepsilon}\right)_{x}+v^{\delta}\left(\rho_{x}^{\delta}-h_{x}^{\varepsilon}\right)_{x} \\ &+u_{xx}^{\varepsilon}\left(\rho^{\delta}-h^{\varepsilon}\right)+u_{x}^{\varepsilon}\left(\rho_{x}^{\delta}-h_{x}^{\varepsilon}\right)+h_{xx}^{\varepsilon}\left(v^{\delta}-u^{\varepsilon}\right)+h_{x}^{\varepsilon}\left(v_{x}^{\delta}-u_{x}^{\varepsilon}\right) \\ &+\mathscr{A}^{\varepsilon}[h^{\varepsilon},u^{\varepsilon}]_{xx}-\mathscr{A}^{\delta}[\rho^{\delta},v^{\delta}]_{xx}. \end{split}$$

Multiplying by $2(h_x^{\varepsilon} - \rho_x^{\delta})$, integrating over \mathbb{R} , using (7.13) and some integrating by parts we obtain

$$\frac{\mathrm{d}}{\mathrm{d}t} \int_{\mathbb{R}} \left(h_x^{\varepsilon} - \rho_x^{\delta} \right)^2 \mathrm{d}x \leqslant \left(f_T(\varepsilon) + f_T(\delta) \right) \left(E \left(h^{\varepsilon}, u^{\varepsilon}, \rho^{\delta}, v^{\delta} \right) + |\varepsilon - \delta|^2 \right) \\
- 2 \int_{\mathbb{R}} \rho^{\delta} \left(v_x^{\delta} - u_x^{\varepsilon} \right) \left(h_x^{\varepsilon} - \rho_x^{\delta} \right)_x \mathrm{d}x. \tag{7.21}$$

From (7.1b) and (7.2b) we have

$$\begin{aligned}
\left(u^{\varepsilon} - v^{\delta}\right)_{t} &= v^{\delta} \left(v_{x}^{\delta} - u_{x}^{\varepsilon}\right) + u_{x}^{\varepsilon} \left(v^{\delta} - u^{\varepsilon}\right) + 3\gamma \left(\rho^{\delta}\right)^{-2} \left(\rho_{x}^{\delta} - h_{x}^{\varepsilon}\right) + 3\gamma \frac{h^{\varepsilon} + \rho^{\delta}}{\left(\rho^{\delta}h^{\varepsilon}\right)^{2}} h_{x} \left(h^{\varepsilon} - \rho^{\delta}\right) \\
&+ \mathcal{L}_{\rho^{\delta}}^{-1} \partial_{x} \left\{ \mathscr{C}[\rho^{\delta}, v^{\delta}] + F(\rho^{\delta}) \right\} - \mathcal{L}_{h^{\varepsilon}}^{-1} \partial_{x} \left\{ \mathscr{C}[h^{\varepsilon}, u^{\varepsilon}] + F(h^{\varepsilon}) \right\} \\
&+ \mathscr{B}^{\varepsilon}[h^{\varepsilon}, u^{\varepsilon}] - \mathscr{B}^{\delta}[\rho^{\delta}, v^{\delta}].
\end{aligned} \tag{7.22}$$

Multiplying by $2(u^{\varepsilon} - v^{\delta})$, integrating with respect to x, using (7.9), (7.10) and (7.14) we obtain

$$\frac{\mathrm{d}}{\mathrm{d}t} \int_{\mathbb{R}} \left(u^{\varepsilon} - v^{\delta} \right)^{2} \, \mathrm{d}x \leqslant \left(f_{T}(\varepsilon) + f_{T}(\delta) \right) \left(E\left(h^{\varepsilon}, u^{\varepsilon}, \rho^{\delta}, v^{\delta} \right) + |\varepsilon - \delta|^{2} \right). \tag{7.23}$$

Differentiating (7.22) with respect to x we obtain

$$\begin{split} \left(u_{x}^{\varepsilon}-v_{x}^{\delta}\right)_{t} &= \left(v_{x}^{\delta}+u_{x}^{\varepsilon}\right)\left(v_{x}^{\delta}-u_{x}^{\varepsilon}\right)+v^{\delta}\left(v_{x}^{\delta}-u_{x}^{\varepsilon}\right)_{x}+u_{xx}^{\varepsilon}\left(v^{\delta}-u^{\varepsilon}\right)-6\gamma\left(\rho^{\delta}\right)^{-1}\rho_{x}^{\delta}\left(\rho_{x}^{\delta}-h_{x}^{\varepsilon}\right)\\ &+3\gamma\left(\rho^{\delta}\right)^{-2}\left(\rho_{x}^{\delta}-h_{x}^{\varepsilon}\right)_{x}+3\gamma\left[\frac{h^{\varepsilon}+\rho^{\delta}}{\left(\rho^{\delta}h^{\varepsilon}\right)^{2}}h_{x}\right]_{x}\left(h^{\varepsilon}-\rho^{\delta}\right)+3\gamma\frac{h^{\varepsilon}+\rho^{\delta}}{\left(\rho^{\delta}h^{\varepsilon}\right)^{2}}h_{x}\left(h_{x}^{\varepsilon}-\rho_{x}^{\delta}\right)\\ &+\partial_{x}\mathcal{L}_{\rho^{\delta}}^{-1}\partial_{x}\left\{\mathscr{C}[\rho^{\delta},v^{\delta}]+F(\rho^{\delta})\right\}-\partial_{x}\mathcal{L}_{h^{\varepsilon}}^{-1}\partial_{x}\left\{\mathscr{C}[h^{\varepsilon},u^{\varepsilon}]+F(h^{\varepsilon})\right\}\\ &+\mathscr{B}^{\varepsilon}[h^{\varepsilon},u^{\varepsilon}]_{x}-\mathscr{B}^{\delta}[\rho^{\delta},v^{\delta}]_{x}. \end{split}$$

Multiplying by $2(\rho^{\delta})^3 (u_x^{\varepsilon} - v_x^{\delta})/(3\gamma)$, using some integration by parts with (7.9), (7.10) and (7.14) one obtains

Using (7.2a) we obtain that

$$\gamma^{-1} (\rho^{\delta})^{2} \rho_{t}^{\delta} \int_{\mathbb{R}} \left(u_{x}^{\varepsilon} - v_{x}^{\delta} \right)^{2} dx \leqslant \left(f_{T}(\varepsilon) + f_{T}(\delta) \right) E \left(h^{\varepsilon}, u^{\varepsilon}, \rho^{\delta}, v^{\delta} \right). \tag{7.25}$$

Summing up (7.20), (7.21), (7.23), (7.24) and (7.25) we obtain that

(7.35)

Defining

$$k_n \stackrel{\text{def}}{=} \left[\frac{1}{2} \left(\varepsilon_n - \delta_n \right) g_T(\varepsilon_{n+1}) \right] + 1 \leqslant N_n, \qquad \ell_n \stackrel{\text{def}}{=} \left[\frac{1}{2} \left(\varepsilon_n - \delta_n \right) g_T(\delta_{n+1}) \right] + 1 \leqslant M_n.$$
 Then, since $g_T(\varepsilon) \geqslant 2/\varepsilon$, we have

$$\leqslant \lim_{n} \left\| \left(h^{\varepsilon_{N_{n-1,n}}} - \tilde{h}, u^{\varepsilon_{N_{n-1,n}}} - \tilde{u} \right) \right\|_{L^{\infty}(\Omega)} = 0. \tag{7.37}$$

Using now (7.35) we obtain

Summing up (7.36), (7.37) and (7.38) we obtain that $(h, u) = (\tilde{h}, \tilde{u})$ almost everywhere. \square

$$(h - \bar{h}, u) \stackrel{\text{def}}{=} S (h_{0} - \bar{h}, u_{0}), \qquad (h_{n} - \bar{h}, u_{n}) \stackrel{\text{def}}{=} S (h_{0,n} - \bar{h}, u_{0,n}).$$

Using (7.18) and (7.39) we obtain

$$\|(h_n^{\varepsilon} - h^{\varepsilon}, u_n^{\varepsilon} - u^{\varepsilon})\|_{L_T^{\infty} H^1} \leqslant f_T(\varepsilon) \|(h_{0,n}^{\varepsilon} - h_0^{\varepsilon}, u_{0,n}^{\varepsilon} - u_0^{\varepsilon})\|_{H^1}$$

$$\leqslant f_T(\varepsilon) \|(h_{0,n} - h_0, u_{0,n} - u_0)\|_{H^1}. \tag{7.40}$$

APPENDIX A. SOME CLASSICAL LEMMAS

Here, we recall simple versions of some classical lemmas that are needed in this paper. We start this section by the following lemma on the Young measures.

Lemma A.1. ([29]) Let \mathscr{O} be a subset of \mathbb{R}^n with a zero-measure boundary. For any bounded family $\{v^{\varepsilon}\}_{\varepsilon} \subset L^p(\mathscr{O}, \mathbb{R}^N)$ with p > 1 there exists a subsequence denoted also $\{v^{\varepsilon}\}_{\varepsilon}$ and a family of probability measures on \mathbb{R}^N , $\{\mu_y, y \in \mathscr{O}\}$ such that for all $f \in C^0(\mathbb{R}^N)$ with $f(\xi) = o(|\xi|^p)$ at infinity and for all $\phi \in C_c^{\infty}(\mathscr{O})$ we have

$$\lim_{\varepsilon \to 0} \int_{\mathscr{O}} \phi(y) f(v^{\varepsilon}(y)) dy = \int_{\mathscr{O}} \phi(y) \int_{\mathbb{R}} f(\xi) d\mu_{y}(\xi) dy$$
 (A.1)

with

$$\int_{\mathscr{O}} \int_{\mathbb{R}} |\xi|^p d\mu_y(\xi) dy \leqslant \liminf_{\varepsilon \to 0} ||u^{\varepsilon}||_{L^p(\mathscr{O})}^p. \tag{A.2}$$

Also, some other results on strong and weak precompactness are needed, then we recall.

is uniformly continues for $t \in [0,T]$ and $n \ge 1$, then $(f_n)_n$ is relatively compact in the space $C([0,T],L^2_w(\mathbb{R}))$, where L^2_w is the L^2 space equipped with its weak topology.

Lemma A.6. (Theorem 5 in [48]) Let [a,b] be a compact subset of \mathbb{R} and let $(f_n)_n$ be a sequence of functions bounded in $L^{\infty}([0,T],H^1([a,b]))$ and

$$||f_n(\cdot + \beta, \cdot) - f_n||_{L^{\infty}([0, T-\beta], L^2([a,b])} \to 0$$
 as $\beta \to 0$, uniformly on n .

Then $(f_n)_n$ is relatively compact in $L^{\infty}([0,T]\times[a,b])$.

Lemma A.7. (Compensated compactness [21]) Let Ω be an open set of \mathbb{R}^2 , let $a,b \in C(\Omega,\mathbb{R})$ such that for all $(x_1,x_2) \in \Omega$ we have $a(x_1,x_2) \neq b(x_1,x_2)$. Let also $(f_n),(g_n)$ be bounded sequences in $L^2_{loc}(\Omega,\mathbb{R})$ such that $f_n \rightharpoonup f$ and $g_n \rightharpoonup g$. If the sequences

$$\{\partial_{x_1} f_n + \partial_{x_2} (a f_n)\}_n$$
, and $\{\partial_{x_1} g_n + \partial_{x_2} (b g_n)\}_n$,

are relatively compact in $H_{loc}^{-1}(\Omega)$, then $f_ng_n \rightharpoonup fg$ in the sense of distributions.

Let Λ be defined such that $\widehat{\Lambda f} = (1+\xi^2)^{\frac{1}{2}}\widehat{f}$ and let $[A,B] \stackrel{\text{def}}{=} AB - BA$ be the commutator of the operators A and B. We recall now some estimates of the H^s norm of the product, the commutator and the composition of functions.

Lemma A.8. ([30]) If $r \ge 0$, then $\exists C > 0$ such that

$$||fg||_{H^r} \leqslant C (||f||_{L^{\infty}} ||g||_{H^r} + ||f||_{H^r} ||g||_{L^{\infty}}),$$
 (A.5)

$$\|[\Lambda^r, f] g\|_{L^2} \leqslant C (\|f_x\|_{L^{\infty}} \|g\|_{H^{r-1}} + \|f\|_{H^r} \|g\|_{L^{\infty}}). \tag{A.6}$$

Lemma A.9. ([15]) Let $F \in C^{\infty}(\mathbb{R})$ with F(0) = 0, then for any $m \in \mathbb{N}$ there exists a continuous function \tilde{F} , such that for all $f \in H^m$ we have

$$||F(f)||_{H^m} \leqslant \tilde{F}(||f||_{L^{\infty}}) ||f||_{H^m}.$$
 (A.7)

APPENDIX B. THE ENERGY EQUATION

The goal of this section is to prove that smooth solutions of (2.1) (respectively (4.3)) satisfy the energy equation (1.5) (respectively (4.11)). Taking $\varepsilon = 0$, we notice that (1.5) is a particular case of (4.11). We consider $\varepsilon \geq 0$ and $(h^{\varepsilon}, u^{\varepsilon})$ smooth solutions of (4.3). Then we have

$$\begin{split} &\frac{1}{2}\,g\left[\left(h^{\varepsilon}-\bar{h}\right)^{2}\right]_{t}\,=\,-\,g\left(h^{\varepsilon}-\bar{h}\right)\left(h^{\varepsilon}\,u^{\varepsilon}\right)_{x}\,+\,g\left(h^{\varepsilon}-\bar{h}\right)\,\mathscr{A}_{x}^{\varepsilon},\\ &\frac{1}{2}\,\gamma\left[\left(h_{x}^{\varepsilon}\right)^{2}\right]_{t}\,=\,-\,\gamma\,h_{x}^{\varepsilon}\left(h^{\varepsilon}\,u^{\varepsilon}\right)_{xx}\,+\,g\,h_{x}^{\varepsilon}\,\mathscr{A}^{\varepsilon}\,-\,\frac{\sqrt{3\,\gamma}}{48\,(h^{\varepsilon})^{1/2}}h_{x}^{\varepsilon}\left(\chi_{\varepsilon}(P^{\varepsilon})-\chi_{\varepsilon}(Q^{\varepsilon})\right). \end{split}$$

Summing up we obtain

$$\frac{1}{2}g\left[\left(h^{\varepsilon}-\bar{h}\right)^{2}\right]_{t}+\frac{1}{2}\gamma\left[\left(h_{x}^{\varepsilon}\right)^{2}\right]_{t}=g\left[\left(h^{\varepsilon}-\bar{h}\right)\mathscr{A}^{\varepsilon}\right]_{x}$$

$$-g\left(h^{\varepsilon}-\bar{h}\right)\left(h^{\varepsilon}u^{\varepsilon}\right)_{x}-\gamma h_{x}^{\varepsilon}\left(h^{\varepsilon}u^{\varepsilon}\right)_{xx}-\frac{1}{96}\left(Q^{\varepsilon}-P^{\varepsilon}\right)\left(\chi_{\varepsilon}(P^{\varepsilon})-\chi_{\varepsilon}(Q^{\varepsilon})\right).$$
(B.1)

Defining $\mathscr{X}^{\varepsilon} \stackrel{\text{def}}{=} \mathscr{C}^{\varepsilon} + F(h^{\varepsilon})$, from (4.3) we have

$$\frac{1}{6} \left[(h^{\varepsilon})^{3} (u_{x}^{\varepsilon})^{2} \right]_{t} = \frac{1}{2} (h^{\varepsilon})^{2} (u_{x}^{\varepsilon})^{2} \mathscr{A}_{x}^{\varepsilon} - \frac{1}{2} (h^{\varepsilon})^{2} (u_{x}^{\varepsilon})^{2} (h^{\varepsilon} u^{\varepsilon})_{x} - \frac{1}{3} (h^{\varepsilon})^{3} u_{x}^{\varepsilon} (u^{\varepsilon} u_{x}^{\varepsilon})_{x} - \gamma (h^{\varepsilon})^{3} u_{x}^{\varepsilon} ((h^{\varepsilon})^{-2} h_{x}^{\varepsilon})_{x} - \frac{1}{3} u_{x}^{\varepsilon} (h^{\varepsilon})^{3} \partial_{x} \mathcal{L}_{h^{\varepsilon}}^{-1} \partial_{x} \mathscr{X}^{\varepsilon} + \frac{1}{3} u_{x}^{\varepsilon} (h^{\varepsilon})^{3} \partial_{x} \mathscr{B}^{\varepsilon}. \tag{B.2}$$

- \frac{1}{3} (h^{\varepsilon})^{3} u_{x}^{\varepsilon} (u^{\varepsilon} u_{x}^{\varepsilon})_{x} - \frac{1}{2} \left[(u^{\varepsilon})^{3} h^{\varepsilon} \right]_{x} - \left[u^{\varepsilon} \mathcal{X}^{\varepsilon} \right]_{x} - \frac{1}{3} \left[u^{\varepsilon} (h^{\varepsilon})^{3} \partial_{x} \mathcal{L}_{h^{\varepsilon}}^{-1} \partial_{x} \mathcal{X}^{\varepsilon} \right]_{x}

- \gamma (h^{\varepsilon})^{3} u_{x}^{\varepsilon} \left((h^{\varepsilon})^{-2} h_{x}^{\varepsilon} \right)_{x} + \frac{1}{96} \left(P^{\varepsilon} + Q^{\varepsilon} \right) (\chi_{\varepsilon}(P^{\varepsilon}) + \chi_{\varepsilon}(Q^{\varepsilon})) . \tag{B.4}$$

Using (3.5) and (4.5) we obtain

$$= \frac{1}{3} (h^{\varepsilon})^{2} \mathscr{V}_{1}^{\varepsilon} - \frac{1}{2} (h^{\varepsilon})^{2} u_{x}^{\varepsilon} \mathscr{A}_{x}^{\varepsilon} + \frac{1}{48} h^{\varepsilon} (\chi_{\varepsilon}(P^{\varepsilon}) + \chi_{\varepsilon}(Q^{\varepsilon})).$$

Using now (3.7) and (B.4) we obtain

$$\frac{1}{2} \left[h^{\varepsilon} (u^{\varepsilon})^{2} \right]_{t} + \frac{1}{6} \left[(h^{\varepsilon})^{3} (u_{x}^{\varepsilon})^{2} \right]_{t} = -3 \gamma (h^{\varepsilon})^{-1} u^{\varepsilon} h_{x}^{\varepsilon} + u_{x}^{\varepsilon} \mathscr{X}^{\varepsilon} - \frac{1}{2} (h^{\varepsilon})^{2} (u_{x}^{\varepsilon})^{2} (h^{\varepsilon} u^{\varepsilon})_{x}

+ \frac{1}{2}gu^{\varepsilon}\left(h^{\varepsilon} - \bar{h}\right)^{2} + \frac{1}{6}(h^{\varepsilon})^{3}u^{\varepsilon}(u_{x}^{\varepsilon})^{2} + \frac{1}{2}\gamma u^{\varepsilon}(h_{x}^{\varepsilon})^{2} + \gamma h^{\varepsilon}h_{x}^{\varepsilon}u_{x}^{\varepsilon}\right]_{x} \\
= \frac{1}{48}P^{\varepsilon}\chi_{\varepsilon}(P^{\varepsilon}) + \frac{1}{48}Q^{\varepsilon}\chi_{\varepsilon}(Q^{\varepsilon}).$$

This is (4.11).
