1. General experimental procedures

Reagents were obtained from commercial suppliers and used without further purification. NMR spectra were recorded on Bruker Avance 400 MHz spectrometer. Spectra were recorded in deuterochloroform referenced to residual CHCl₃ (1H, 7.26 ppm) or CDCl₃ (13C, 77.2 ppm). Chemical shifts (δ) are reported in ppm and coupling constants (J) are reported in Hz. The following abbreviations are used to describe multiplicity; s singlet, d-doublet, t-triplet, q-quartet, m-multiplet. HRMS experiments were carried out on a Waters Q-Tof 2 (ESI-Electrospray Ionization, ASAP-Atmospheric Solids Analysis Probe) spectrometer. Analytical TLC was carried out on Merck 60 F245 aluminium backed silica gel plates. Short wave UV radiation (245 nm), KMnO₄ and vanillin were used to visualize components. Compounds were purified by flash column chromatography using Geduran[®] silica gel 60 (0.040-0.063 nm).

Single crystal diffraction data were collected at low temperature on a D8 Venture Bruker AXS CMOS diffractometer with multilayers monochromatized Mo K α radiation. Structures were solved by dual-space algorithm using SHELXT program. All non-hydrogen atoms were refined anisotropically by the full-matrix least-squares techniques using the program SHELXL-2018/3. Hydrogen atoms were located geometrically and treated using a riding model with isotropic atomic displacement parameter constrained to the equivalent adp of the bonded carbon atom. Powder X-ray diffraction data were obtained using a Bruker D8 Advance diffractometer working in the modified Bragg-Brentano geometry with a monochromatized Cu K α 1 radiation and equipped with a LynxEye fast detector. The

analysis of the powder X-ray diffraction patterns was performed by Rietveld refinement using the FullProf and WinPLOTR packages.

Cyclic voltammograms were recorded in dry CH₂Cl₂ solutions (containing 0.1 M [NⁿBu₄][PF₆], purged with nitrogen and maintained under an inert atmosphere) using a Pt disk as working electrode, a Pt wire as counter electrode and a SCE reference electrode; the FeCp₂^{0/+1} couple (E_{1/2}: 0.46 V,¹ Δ E_p = 0.09 V; I_{pa}/I_{pc} = 1) was used as an internal calibrant.

UV-visible spectra were recorded on a Jasco V-750 spectrophotometer using 1 cm² quartz cuvettes for solutions. The luminescence spectra were measured using Horiba-Jobin-Yvon Fluorolog-3 spectrofluorometers. The experiments were carried out using dilute solutions (A < 0.1 for the lowenergy band, where the excitations are performed) to minimize inner-filter effects and intermolecular interactions. Powders were placed in quartz tubes inserted in a G8 GMP integrating sphere. The steady-state luminescence was excited with unpolarized light from a 450 W xenon CW lamp and detected at an angle of 90° with a Hamamatsu R928 photomultiplier tube (PMT) or a Peltier cooled R2658 PMT as specified. Long-pass filters were used to reject scattered light. Spectra were reference-corrected for both the excitation source light intensity variation (lamp and grating) and the emission spectral response (detector and grating). Fluorescence decays were obtained using an EDEPL375 pulsed laser diode producing an excitation at 375 nm associated with an Edinburgh FLS920 fluorometer that was equipped with a Peltier cooled Hamamatsu R928P PMT. Detection was performed at the emission maximum of the studied molecule using an emission slit width of 3 nm.

2. Synthesis



A solution of **2a** (916 mg, 3.353 mmol) in Et₃N (2 mL) and dry THF (20 mL) was treated with trimethylsilylacetylene (1 mL, 7.322 mmol), Cul (139 mg, 0.732 mmol), [PdCl₂(PPh₃)₂] (257 mg, 0.366 mmol) and PPh₃ (196 mg, 0.745 mmol). The reaction mixture was stirred at 80°C over 21 h, then evaporated and purified by column chromatography (pentane) to give alkyne **3a** (766 mg, 2.637 mmol, 78%) as a yellow/orange oil.

A solution of alkyne **3a** (559 mg, 1.924 mmol) in MeOH (4 mL) and THF (4 mL) was treated with K₂CO₃ (580 mg, 4.196 mmol). After 3 h at room temperature, the reaction was diluted with Et₂O, filtered through celite and concentrated under reduced pressure. The residue obtained was purified by column chromatography (cyclohexane:dichloromethane 1:0 to 95:5) to give alkyne **4a** (372 mg, 1.711 mmol, 89%) as a yellow oil.

A solution of alkyne **4a** (130 mg, 0.596 mmol) in acetone (6 mL) was treated with Nbromosuccinimide (130.6 mg, 0.734 mmol) and AgNO₃ (10.5 mg, 0.062 mmol). After 15 h at room temperature in the dark, the reaction mixture was diluted with Et_2O and filtered through celite. The filtrate was concentrated under reduced pressure and purified by column chromatography (cyclohexane to cyclohexane:dichloromethane 1:0 to 9:1) to give brominated alkyne **5a** (136.9 mg, 0.462 mmol, 77%) as a yellow foiled solid.

A solution of TsNHCH₃ (139 mg, 0.751 mmol), CuSO₄.5H₂O (39 mg, 0.160 mmol), 1,10-phenanthroline (50 mg, 0.277 mmol), K₂CO₃ (380 mg, 2.749 mmol) and brominated alkyne **5a** (202 mg, 0.682 mmol) in dry toluene (14 mL) was heated to 90 °C under a nitrogen atmosphere for 61 h. The reaction was then cooled to room temperature, diluted with EtOAc and filtered through celite. The filtrate was concentrated under reduced pressure and purified by column chromatography (cyclohexane:ethyl acetate 1:0 to 9:1) to give ynamide **6a** (216 mg, 0.538 mmol, 79%) as a yellow solid.

A solution of ynamide **6a** (80 mg, 0.199 mmol) and TCNE (39 mg, 0.304 mmol) in CH_2Cl_2 (3 mL) was stirred at room temperature for 16 h. The reaction mixture was purified by column chromatography (pentane:dichloromethane 1:1) to give TCBD **1a** (100 mg, 0.190 mmol, 95%) as a red solid.

To a solution of 2-bromo-9,9-dimethylfluorene (2.0 g, 7.32 mmol) and acetyl chloride (1.1 mL, 15.47 mmol) in dichloromethane (30 mL) was added dropwise aluminium chloride (2.93 g, 21.96 mmol) at 0°C. The reaction mixture was then stirred at room temperature. After 1h15, the reaction mixture was quenched with 10 mL of HCl 1N with ice and extracted 3 times with dichloromethane (25 mL). Organic layers were dried over MgSO₄, filtered and concentrated. The residue obtained was purified by column chromatography (cyclohexane:dichloromethane 1:0 to 0:1) to give brominated alkyne **2b** (1.85 g, 5.89 mmol, 80%) as a yellow solid.

A solution of **2b** (164 mg, 0.522 mmol) in Et₃N (10 mL) was reacted with trimethylsilylacetylene (0.15 mL, 1.079 mmol), CuI (26 mg, 0.136 mmol) and [PdCl₂(PPh₃)₂] (39 mg, 0.056 mg). The reaction mixture was stirred at 85°C over 16 h. The reaction was quenched with 20 mL of water and extracted with 3 x 20 mL of EtOAc. The organic layers were dried over MgSO₄, filtered and concentrated under reduced pressure and purified by column chromatography (cyclohexane to cyclohexane:EtOAc 9:1) to give alkyne **3b** as an impure beige solid.

A solution of alkyne **3b** (0.522 mmol) in MeOH (2 mL) and THF (2 mL) was treated with K_2CO_3 (155 mg, 1.121 mmol). After 1 h at room temperature, the reaction was diluted with Et_2O , filtered through celite and concentrated under reduced pressure. The residue obtained was purified by column chromatography (cyclohexane:ethyl acetate 1:0 to 9:1) to give alkyne **4b** (42.5 mg, 0.163 mmol, 31% over 2 steps) as a yellow solid.

A solution of alkyne **4b** (40 mg, 0.154 mmol) in acetone (2 mL) was reacted with N-bromosuccinimide (33 mg, 0.185 mmol) and AgNO₃ (3 mg, 0.016 mmol). After 30 min at room temperature in the dark, the reaction mixture was diluted with pentane (10 mL) and the precipitate was filtered. The filtrate was concentrated under reduced pressure. The residue obtained was purified by column chromatography (cyclohexane:ethyl acetate 7:3) to give brominated alkyne **5b** (40 mg, 0.118 mmol, 77%) as a yellow solid.

A solution of TsNHCH₃ (25 mg, 0.134 mmol), CuSO₄.5H₂O (5 mg, 0.020 mmol), 1,10-phenanthroline (12 mg, 0.472 mmol), K₂CO₃ (65 mg, 0.472 mmol) and alkyne **5b** (40 mg, 0.118 mmol) in dry toluene (2.0 mL) was heated to 90 °C under nitrogen atmosphere for 50 h. A solution of compound **2b** (603 mg, 1.91 mmol) in chloroform (20 mL) was treated with *meta*chloroperbenzoic acid (695 mg, 3.10 mmol). The reaction mixture was stirred at rt for 89 h. The reaction was washed with 10 mL of a saturated aqueous solution of NaHCO₃, 10 mL of water and 10 mL of brine, then dried over N₂SO₄, filtered and concentrated under reduced pressure. The residue obtained was purified by column chromatography (cyclohexane:dichloromethane 1:0 to 3:7) to give compound **16** (541 mg, 1.63 mmol, 86%) as a beige solid.

A solution of compound **16** (1.42 g, 4.29 mmol) in methanol/water (30 mL, v/v 1:1) was reacted with KOH (2.4 g, 4.29 mmol). The reaction mixture was stirred at 80°C for 15 h. The reaction was neutralized by conc. HCl and extracted with 2 x 40 mL of Et₂O. The organic layers were washed with 40 mL of water and 40 mL of brine, then dried over N_2SO_4 , filtered and concentrated under reduced pressure. The residue obtained was purified by column chromatography (cyclohexane:dichloromethane 1:0 to 2:8) to give compound **17** (1.13 g, 3.73 mmol, 87%) as a pale yellow solid.

A solution of compound **17** (330 mg, 1.09 mmol) in acetonitrile (10 mL) was reacted with K₂CO₃ (304 mg, 2.20 mmol) and 1-bromohexane (0.17 mL, 1.21 mmol). The reaction mixture was stirred at reflux for 18 h. The reaction was quenched with 20 mL of water and extracted with 3 x 20 mL of Et₂O. The organic layers were washed with 20 mL of water and 20 mL of brine, then dried over N₂SO₄, filtered and concentrated under reduced pressure. The residue obtained was purified by column chromatography (cyclohexane:dichloromethane 1:0 to 9:1) to give compound **2c** (323 mg, 0.865 mmol, 80%) as a yellow solid.

5.2. Fluorescence spectroscopy

Considering the spectral characteristics and intensity of fluorescence of the family of compounds studied, to preserve consistency between the datasets all quantum yields were determined by the relative method using a select TCBD derivative, compound **1**, as a secondary reference. The quantum yield of **1** itself was found to be 6.9% (using the emission located below 800 nm) by comparison with 9,10-bis(phenylethynyl)anthracene (**BPEA**), as shown below.

Fluorescence lifetimes. The fluorescence decays were measured in cyclohexane at the maximum of emission of each compound using a 3-nm detection window. Surprisingly, they did not correspond to a monoexponential decay. The best fitting model was a sum of three exponentials in all cases, and the three components displayed lifetimes of the same order of magnitude. This complex decay was reproduced when exciting **1I** in the low-energy absorption band at 456 nm (instead of 375 nm), thus does not appear to vary with the initially populated state. The results obtained from this analysis are summarized in Table S4. While the longer component, which had a minor contribution and accounted for the noisy tail of the decay, did not show any clear tendency, the pre-exponential factors of the main components correlated well with the observed fluorescence quantum yield (Figure S50). A smaller contribution from the emissive state of shorter lifetime τ_1 , and conversely a more important contribution from τ_2 , are seemingly associated with larger values of quantum yield. It could be inferred that identifying and preventing the formation of the species responsible for τ_1 is an avenue worth exploring in the future in the design of bright fluorescent TCBD derivatives.
