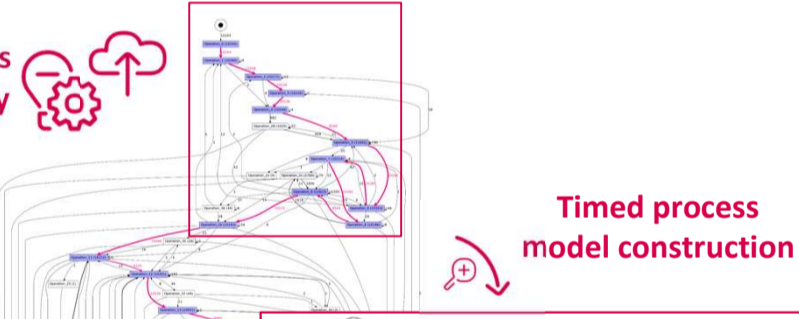

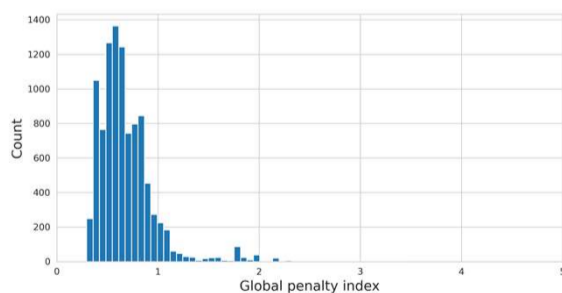


Timed process model construction

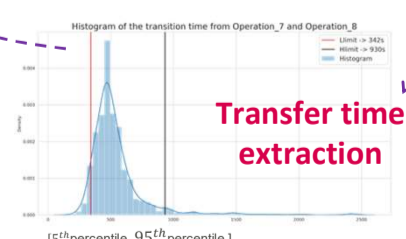
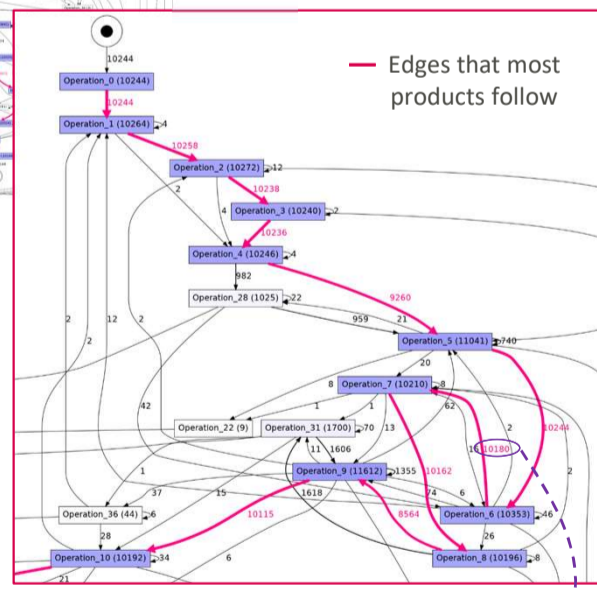
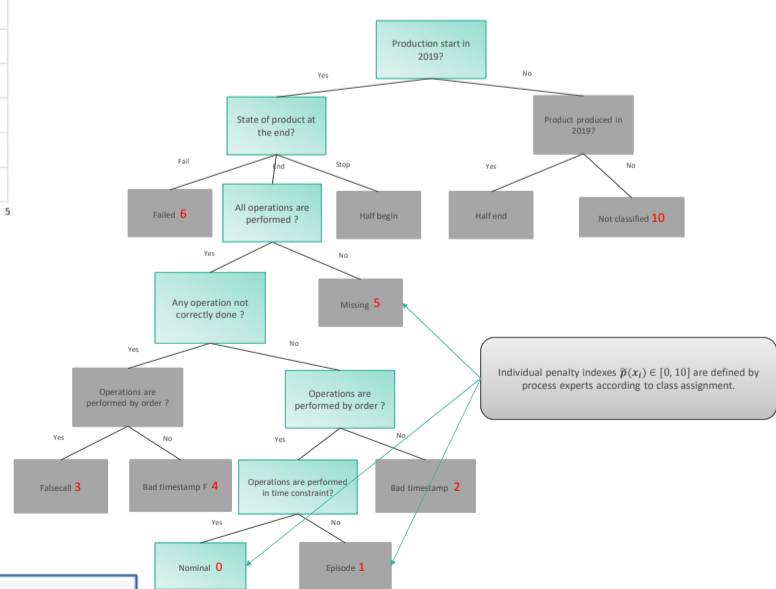
Global penalty index of product  $x_i$

$$p_g(x_i) = \sum_{k=1}^{|\phi|} \gamma_k \times (\lambda \times \tilde{p}_k(x_i) + (1 - \lambda) \times p_k(b_j))$$

$$\lambda, \gamma \in [0, 1], \sum_{k=1}^{|\phi|} \gamma_k = 1$$
