

Background & Objectives

Transfer of veterinary pharmaceuticals from sources to water



- ✓ Intensive livestock: curative and prophylactic use of pharmaceuticals
- √ 30 to 90% of (VP) excreted in feces and urine as parents molecules
- ✓ Degradation of the chemical quality of water is controlled by the presence of organic contaminants such as veterinary pharmaceuticals residues (VPR)
 - **⇒** Vulnerability of water resources

GOALS of the study


1/ Spatiotemporal occurrence of VPR in nested agricultural catchments, 2/ Spatiotemporal variability of VPR fluxes upstream and downstream from a WWTP. 3/ Fecal contamination and origin of the contamination (human, porcine, bovine). 4/ Contribution of livestock vs human fluxes in agricultural watersheds.

Samples & Methods

Study site and sampling

Brittany (Northwest of France): Haut-Rance Watershed

- √ 1st french region of livestock activities
- ✓ Recycling of farming waste on soils
- √ 75% of tap water is produced with surface waters



⇒ 6 campaigns from February to reflect spatial and temporal variation for the analysis of pharmaceutical concentration and sources in nested watersheds

Analytical methods

Twenty pharmaceuticals

Tandem MS E reversed phase

16 antibiotics:

amoxicillin, ampicillin, benzylpenicillin, bovine) (Derrien et al., 2011) ceftiofur, danofloxacin, doxycycline, enrofloxacin, flumequine, lincomycin, marbofloxacin, oxytetracycline, spiramycin, sulfadiazine, sulfamethazine, tetracycline, and trimethoprim,

3 non-steroidal anti-inflammatory drugs:

diclofenac, flunixin, ketoprofen,


1 anticonvulsive drug: carbamazepine.



Results & Discussion

Occurrence of pharmaceuticals




- ⇒Spatial occurrence of pharmaceutical according to their medical use:
- ✓ Animal-specific and mixed-use pharmaceuticals were detected at all 7 points, upstream and downstream WWTP.
- ✓ Human-specific pharmaceuticals concentration significantly increased from point #3 (upstream WWTP) to point #4 (downstream WWTP).
- ✓ Need to perform risk assessment studies of pharmaceuticals mixtures

Mitigation of diffuse pollutions: priority on headwater catchments.

Fecal contamination and origin

- ⇒Spatial origin of pharmaceutical according to co-markers of sources:
- √ Fecal stanols as co-tracers of pharmaceuticals (mixed-use) origin.
- ✓ Predominance of bovine faecal contamination, except after the WWTP at point #4

Livestock and human fluxes in watershed



- ⇒Spatio temporal variations of fluxes of pharmaceuticals:
- **✓ October: Predominance of animal specific pharmaceuticals (in black) from** headwater to water monitoring station after rainfall events and when runoff events connected agricultural soils to the river.
- **✓ December:** Increase of mixed-use and human pharmaceuticals contributions with decrease of runoff, suggesting a dilution of agricultural sources.
