# Primitive elements of the Hopf algebra of free quasi-symmetric functions

#### Abstract

Using the dendriform and the bidendriform Cartier-Quillen-Milnor-Moore theorem, we construct a basis of the space of primitive elements of the Hopf algebra of free quasisymmetric functions, indexed by a certain set of trees, and inductively computable.

## Introduction

The Hopf algebra of free quasi-symmetric functions FQSym, also known as the MalvenutoReutenauer Hopf algebra, is introduced in [7]. It is a graded self-dual Hopf algebra, with the set of all permutations as a basis. Certain interesting properties are shown in [2]: in particular, it is shown that it is both free and cofree, and a basis of the space of its primitive elements is given, using the self-duality and a monomial basis. Note that computing the primitive elements of degree $n$ by this method implies to inverse a certain $n!\times n!$ matrix.

The aim of this paper is to describe another basis of $\operatorname{Prim}_{\text {coAss }}(\mathbf{F Q S y m})$, which can be inductively computed. We use for this the dendriform structure of FQSym. Recall that a dendriform algebra is an associative algebra such that its product can be split into two nonassociative products $\prec$ and $\succ$, with good compatibilities [5, 6, 8]. It is known that FQSym, or more precisely its augmentation ideal, is dendriform. More precisely, it is a dendriform Hopf algebra, in the sense of [8]. This implies, by the dendriform Cartier-Quillen-Milnor-Moore theorem, that $\operatorname{Prim}_{\text {coAss }}(\mathbf{F Q S y m})$ is a brace algebra.

We introduced in [4] the notion of bidendriform bialgebra and showed that FQSym is bidendriform. The bidendriform Cartier-Quillen-Milnor-Moore theorem implies that FQSym is freely generated, as a dendriform algebra, by the space $\operatorname{Prim}_{\text {coDend }}(\mathbf{F Q S y m})$ of primitive elements
in the codendriform sense. Combining this result with the dendriform Cartier-Quillen-MilnorMoore theorem, we show that $\operatorname{Prim}_{\text {coAss }}($ FQSym $)$ is, as a brace algebra, freely generated by $\operatorname{Prim}_{\text {coDend }}(\mathbf{F Q S y m})$. We recall in section 2 a description of free brace algebras. If $\left(v_{i}\right)_{i \in I}$ is a basis of the vector space $V$, then the free brace algebra generated by $V$ has a basis indexed by planar rooted trees decorated by $I$, and the brace structure is described in this basis by the help of graftings. Hence, for any basis of $\operatorname{Prim}_{\text {coDend }}($ FQSym $)$, it is possible to recover a basis of $\operatorname{Prim}_{\text {coAss }}(\mathbf{F Q S y m})$, indexed by a certain set of planar rooted trees.

Let, for all $n \in \mathbb{N}$ :

$$
\left\{\begin{aligned}
p_{n} & =\operatorname{dim}\left(\operatorname{Prim}_{c o A s s}(\mathbf{F Q S y m})_{n}\right), \\
q_{n} & =\operatorname{dim}\left(\operatorname{Prim}_{\text {coDend }}(\mathbf{F Q S y m})_{n}\right) .
\end{aligned}\right.
$$

We then prove in section 3 that for $n \geq 2, q_{n}=(n-2) p_{n-1}$. We then give $n-2$ applications from $\operatorname{Prim}_{c o A s s}(\mathbf{F Q S y m})_{n-1}$ to $\operatorname{Prim}_{\text {coDend }}(\mathbf{F Q S y m})_{n}$, which give all elements of $\operatorname{Prim}_{\text {coDend }}(\mathbf{F Q S y m})_{n}$. These applications are given by the insertion of $n+1$ at a given place in elements of the symmetric group $S_{n}$, seen as words in letters $1, \ldots, n$.

Combining the results of the second and third sections, we define inductively in the fourth section a new basis of $\operatorname{Prim}_{\text {coAss }}(\text { FQSym })_{n}$, indexed by certain planar decorated rooted trees. The trees which are only a root give a basis of $\operatorname{Prim}_{\text {coDend }}(\mathbf{F Q S y m})_{n}$.

## Notations.

1. $K$ is a commutative field of any characteristic.
2. If $V$ is a $K$-vector field which is $\mathbb{N}$-graded, we shall denote by $V_{k}$ the space of homogeneous elements of $V$ of degree $k$.

## 1 Bidendriform bialgebras and FQSym

### 1.1 Bidendriform bialgebras

We introduced in [4] the following definition:
Definition 1 A bidendriform bialgebra is a family $\left(A, \prec, \succ, \Delta_{\prec}, \Delta_{\succ}\right)$ such that:

1. $A$ is a $K$-vector space and:

\begin{aligned}
& \prec:\left\{\begin{array}{rll}
A \otimes A & \longrightarrow & A \\
a \otimes b & \longrightarrow & a \prec b,
\end{array}\right. \\
& \succ:\left\{\begin{array}{rll}
A \otimes A & \longrightarrow & A \\
a \otimes b & \longrightarrow & a \succ b,
\end{array}\right. \\
& \Delta_{\prec}:\left\{\begin{array}{rll}
A & \longrightarrow & A \otimes A \\
a & \longrightarrow & \Delta_{\prec}(a)=a_{\prec}^{\prime} \otimes a_{\prec}^{\prime \prime},
\end{array}\right. \\
& \Delta_{\succ}:\left\{\begin{array}{rll}
A & \longrightarrow & A \otimes A \\
a & \longrightarrow & \Delta_{\succ}(a)=a_{\succ}^{\prime} \otimes a_{\succ}^{\prime \prime} .
\end{array}\right.
\end{aligned}
$$

2. (Dendriform axioms). $(A, \prec, \succ)$ is a dendriform algebra: for all $a, b, c \in A$,

$$
\begin{align*}
(a \prec b) \prec c & =a \prec(b \prec c+b \succ c),  \tag{1}\\
(a \succ b) \prec c & =a \succ(b \prec c),  \tag{2}\\
5 a \prec b+a \succ b) \succ c & =a \succ(b \succ c) . \tag{3}
\end{align*}
$$

3. (Codendriform axioms). $\left(A, \Delta_{\prec}, \Delta_{\succ}\right)$ is a codendriform coalgebra: for all $a \in A$,

$$
\begin{align*}
\left(\Delta_{\prec} \otimes I d\right) \circ \Delta_{\prec}(a) & =\left(I d \otimes \Delta_{\prec}+I d \otimes \Delta_{\succ}\right) \circ \Delta_{\prec}(a),  \tag{4}\\
\left(\Delta_{\succ} \otimes I d\right) \circ \Delta_{\prec}(a) & =\left(I d \otimes \Delta_{\prec}\right) \circ \Delta_{\succ}(a),  \tag{5}\\
\left(\Delta_{\prec} \otimes I d+\Delta_{\succ} \otimes I d\right) \circ \Delta_{\succ}(a) & =\left(I d \otimes \Delta_{\succ}\right) \circ \Delta_{\succ}(a) . \tag{6}
\end{align*}
$$

4. (Bidendriform axioms). For all $a, b \in A$,

$$
\begin{align*}
\Delta_{\succ}(a \succ b) & =a^{\prime} b_{\succ}^{\prime} \otimes a^{\prime \prime} \succ b_{\succ}^{\prime \prime}+a^{\prime} \otimes a^{\prime \prime} \succ b+b_{\succ}^{\prime} \otimes a \succ b_{\succ}^{\prime \prime}+a b_{\succ}^{\prime} \otimes b_{\succ}^{\prime \prime}+a \otimes b,  \tag{7}\\
\Delta_{\succ}(a \prec b) & =a^{\prime} b_{\succ}^{\prime} \otimes a^{\prime \prime} \prec b_{\succ}^{\prime \prime}+a^{\prime} \otimes a^{\prime \prime} \prec b+b_{\succ}^{\prime} \otimes a \prec b_{\succ}^{\prime \prime},  \tag{8}\\
\Delta_{\prec}(a \succ b) & =a^{\prime} b_{\prec}^{\prime} \otimes a^{\prime \prime} \succ b_{\prec}^{\prime \prime}+a b_{\prec}^{\prime} \otimes b_{\prec}^{\prime \prime}+b_{\prec}^{\prime} \otimes a \succ b_{\prec}^{\prime \prime},  \tag{9}\\
\Delta_{\prec}(a \prec b) & =a^{\prime} b_{\prec}^{\prime} \otimes a^{\prime \prime} \prec b_{\prec}^{\prime \prime}+a^{\prime} b \otimes a^{\prime \prime}+b_{\prec}^{\prime} \otimes a \prec b_{\prec}^{\prime \prime}+b \otimes a . \tag{10}
\end{align*}
$$

## Remarks.

1. If $A$ is a bidendriform bialgebra, then $K \oplus A$ is naturally a Hopf algebra, extending $\prec+\succ$ and $\Delta_{\prec}+\Delta_{\succ}$ on $K \oplus A$.
2. If $A$ is a bidendriform bialgebra, it is also a dendriform hopf algebra in the sense of $[8,9]$, with coassociative coproduct given by $\tilde{\Delta}=\Delta_{\prec}+\Delta_{\succ}$. The compatibilities of dendriform Hopf algebras are given by $(7)+(9)$ and $(8)+(10)$.

If $A$ is a bidendriform algebra, we define:

$$
\operatorname{Prim}_{\text {codend }}(A)=\operatorname{Ker}\left(\Delta_{\prec}\right) \cap \operatorname{Ker}\left(\Delta_{\succ}\right) .
$$

The following result is proved in [4] (theorem 35 and corollary 17):
Theorem 2 (Bidendriform Cartier-Quillen-Milnor-Moore theorem) Let $A$ be $a \mathbb{N}$ graded bidendriform bialgebra, such that $A_{0}=(0)$. Then $A$ is freely generated as a dendriform algebra by $\operatorname{Prim}_{\text {coDend }}(A)$. Moreover, consider the following formal series:

$$
R(X)=\sum_{n=1}^{+\infty} \operatorname{dim}(A), \quad Q(X)=\sum_{n=1}^{+\infty} \operatorname{dim}\left(\operatorname{Prim}_{\text {coDend }}\left(A_{n}\right)\right) X^{n}
$$

Then $Q(X)=\frac{R(X)}{(R(X)+1)^{2}}$.

### 1.2 An example: the Hopf algebra FQSym

See $[1,2,7]$. The algebra $\mathbf{F Q S y m}$ is the vector space generated by the elements $\left(\mathbf{F}_{u}\right)_{u \in \mathbb{S}}$, where $\mathbb{S}$ is the disjoint union of the symmetric groups $S_{n}(n \in \mathbb{N})$. Its product and its coproduct are given in the following way: for all $u \in S_{n}, v \in S_{m}$, putting $u=\left(u_{1} \ldots u_{n}\right)$,

$$
\begin{aligned}
\Delta\left(\mathbf{F}_{u}\right) & =\sum_{i=0}^{n} \mathbf{F}_{s t\left(u_{1} \ldots u_{i}\right)} \otimes \mathbf{F}_{s t\left(u_{i+1} \ldots u_{n}\right)} \\
\mathbf{F}_{u} \cdot \mathbf{F}_{v} & =\sum_{\zeta \in s h(n, m)} \mathbf{F}_{(u \times v) \cdot \zeta^{-1}}
\end{aligned}
$$

where $\operatorname{sh}(n, m)$ is the set of $(n, m)$-shuffles, and $s t$ is the standardisation. Its unit is $1=\mathbf{F}_{\emptyset}$, where $\emptyset$ is the unique element of $S_{0}$. Moreover, FQSym is a $\mathbb{N}$-graded Hopf algebra, by putting $\left|\mathbf{F}_{u}\right|=n$ if $u \in S_{n}$.

## Examples.

$$
\begin{aligned}
\mathbf{F}_{(12)} \mathbf{F}_{(123)}= & \mathbf{F}_{(12345)}+\mathbf{F}_{(13245)}+\mathbf{F}_{(13425)}+\mathbf{F}_{(13452)}+\mathbf{F}_{(31245)} \\
& +\mathbf{F}_{(31425)}+\mathbf{F}_{(31452)}+\mathbf{F}_{(34125)}+\mathbf{F}_{(34152)}+\mathbf{F}_{(34512)} \\
\Delta\left(\mathbf{F}_{(12543)}\right)= & 1 \otimes \mathbf{F}_{(12543)}+\mathbf{F}_{(1)} \otimes \mathbf{F}_{(1432)}+\mathbf{F}_{(12)} \otimes \mathbf{F}_{(321)} \\
& +\mathbf{F}_{(123)} \otimes \mathbf{F}_{(21)}+\mathbf{F}_{(1243)} \otimes \mathbf{F}_{(1)}+\mathbf{F}_{(12543)} \otimes 1 .
\end{aligned}
$$

Let $(\mathbf{F Q S y m})_{+}=\operatorname{Vect}\left(\mathbf{F}_{u} / u \in S_{n}, n \geq 1\right)$ be the augmentation ideal of FQSym. We define $\prec, \succ, \Delta_{\prec}$ and $\Delta_{\succ}$ on (FQSym $)_{+}$in the following way: for all $u \in S_{n}, v \in S_{m}$, by putting $u=\left(u_{1} \ldots u_{n}\right)$,

$$
\begin{aligned}
& \mathbf{F}_{u} \prec \mathbf{F}_{v}= \sum_{\substack{\zeta \in s h(n, m) \\
\zeta^{-1}(n+m)=n}} \mathbf{F}_{(u \times v) \cdot \zeta^{-1}}, \\
& \mathbf{F}_{u} \succ \mathbf{F}_{v}=\sum_{\substack{\zeta \in s h(n, m) \\
\zeta^{-1}(n+m)=n+m}} \mathbf{F}_{(u \times v) \cdot \zeta^{-1}}, \\
& \Delta_{\prec}\left(\mathbf{F}_{u}\right)=\sum_{i=u^{-1}(n)}^{n-1} \mathbf{F}_{s t\left(u_{1} \ldots u_{i}\right)} \otimes \mathbf{F}_{s t\left(u_{i+1} \ldots u_{n}\right)}, \\
& \Delta_{\succ}\left(\mathbf{F}_{u}\right)=\sum_{i=1}^{u^{-1}(n)-1} \mathbf{F}_{s t\left(u_{1} \ldots u_{i}\right)} \otimes \mathbf{F}_{s t\left(u_{i+1} \ldots u_{n}\right)} .
\end{aligned}
$$

## Examples.

$$
\begin{aligned}
& \mathbf{F}_{(12)} \prec \mathbf{F}_{(123)}=\mathbf{F}_{(13452)}+\mathbf{F}_{(31452)}+\mathbf{F}_{(34152)}+\mathbf{F}_{(34512)}, \\
& \mathbf{F}_{(12)} \succ \mathbf{F}_{(123)}=\mathbf{F}_{(12345)}+\mathbf{F}_{(13245)}+\mathbf{F}_{(13425)}+\mathbf{F}_{(31245)}+\mathbf{F}_{(31425)}+\mathbf{F}_{(34125)},
\end{aligned}
$$

$\Delta_{\prec}\left(\mathbf{F}_{(12543)}\right)=\mathbf{F}_{(123)} \otimes \mathbf{F}_{(21)}+\mathbf{F}_{(1243)} \otimes \mathbf{F}_{(1)}$,
$\Delta_{\succ}\left(\mathbf{F}_{(12543)}\right)=\mathbf{F}_{(1)} \otimes \mathbf{F}_{(1432)}+\mathbf{F}_{(12)} \otimes \mathbf{F}_{(321)}$.
The following result is proved in [4], theorem 38:
Theorem $3\left((\mathbf{F Q S y m})_{+}, \prec, \succ, \Delta_{\prec}, \Delta_{\succ}\right)$ is a connected bidendriform bialgebra.
Moreover, $(\mathbf{F Q S y m})_{+}$is $\mathbb{N}$-graded, by putting the elements of $S_{n}$ homogeneous of degree $n$. By theorem 2, with $q_{n}=\operatorname{dim}\left(\operatorname{Prim}_{\text {coDend }}(\mathbf{F Q S y m})_{n}\right)$, we obtain:

## 2 Recovering $\operatorname{Prim}_{\text {coAss }}($ FQSym $)$ from $\operatorname{Prim}_{\text {coDend }}($ FQSym $)$

### 2.1 Dendriform Cartier-Quillen-Milnor-Moore theorem and variations

Recall that a brace algebra is a $K$-vector space $A$ together with a $n$-multilinear operation for all $n \geq 2$ :

$$
\langle\ldots\rangle:\left\{\begin{aligned}
A^{\otimes n} & \longrightarrow A \\
a_{1} \otimes \ldots \otimes a_{n} & \longrightarrow\left\langle a_{1}, \ldots, a_{n}\right\rangle,
\end{aligned}\right.
$$

satisfying certain relations; see $[8,9]$ for more details. For example:

$$
\left\langle a_{1},\left\langle a_{2}, a_{3}\right\rangle\right\rangle=\left\langle a_{1}, a_{2}, a_{3}\right\rangle+\left\langle\left\langle a_{1}, a_{2}\right\rangle, a_{3}\right\rangle+\left\langle a_{2}, a_{1}, a_{3}\right\rangle .
$$

The following theorem is proved in $[8,9]$; more precisely, the first point of this theorem is proposition 2-8 and theorem 3-4 of [8] and the second point is theorem 4-6 of [9]:

Theorem 4 (Dendriform Cartier-Quillen-Milnor-Moore theorem) Let $A$ be a dendriform Hopf algebra. We denote $\operatorname{Prim}_{\text {coAss }}(A)=\operatorname{Ker}(\tilde{\Delta})$.

1. $\operatorname{Prim}_{\text {coAss }}(A)$ is a brace algebra, with brackets given by:

$$
\begin{gathered}
\left\langle p_{1}, \ldots, p_{n}\right\rangle \\
=\sum_{i=0}^{n-1}(-1)^{n-1-i}\left(p_{1} \prec\left(p_{2} \prec\left(\ldots \prec p_{i}\right) \ldots\right) \succ p_{n} \prec\left(\ldots\left(p_{i+1} \succ p_{i+2}\right) \succ \ldots\right) \succ p_{n-1}\right) .
\end{gathered}
$$

2. If $A$ is freely generated as a dendriform algebra by a subvector space $V \subseteq \operatorname{Prim}_{\text {coAss }}(A)$, then $\operatorname{Prim}_{\text {coAss }}(A)$ is freely generated as a brace algebra by $V$.

Let us precise the relation between $\operatorname{Prim}_{\text {coAss }}(A)$ and $\operatorname{Prim}_{\text {coDend }}(A)$ if $A$ is a bidendriform bialgebra. Combining the dendriform and the bidendriform Cartier-Quillen-Milnor-Moore theorems:

Theorem 5 Let $A$ be a $\mathbb{N}$-graded bidendriform bialgebra, with $A_{0}=(0)$. Then $\operatorname{Prim}_{c o A s s}(A)$ is, as a brace algebra, freely generated by $\operatorname{Prim}_{\text {coDend }}(A)$.

Proof. By the bidendriform Cartier-Quillen-Milnor-Moore theorem, $A$ is freely generated as a dendriform algebra by $\operatorname{Prim}_{c o D e n d}(A)$. By the second point of the dendriform Cartier-Quillen-Milnor-Moore theorem, $\operatorname{Prim}_{c o A s s}(A)$ is freely generated as a brace algebra by the space $\operatorname{Prim}_{\text {coDend }}(A)$.

Proposition 6 If $A$ is $\mathbb{N}$-graded dendriform Hopf algebra, such that $A_{0}=(0)$, then $A$ is generated as a dendriform algebra by $\operatorname{Prim}_{\text {coAss }}(A)$. Moreover, consider the following formal series:

$$
R(X)=\sum_{n=1}^{\infty} \operatorname{dim}\left(A_{n}\right) X^{n}, \quad P(X)=\sum_{n=1}^{+\infty} \operatorname{dim}\left(\operatorname{Prim}_{c o D e n d}\left((A)_{n}\right) X^{n}\right.
$$

Then $P(X)=\frac{R(X)}{1+R(X)}$.
Proof. First step. Let $p_{1}, \ldots, p_{n} \in \operatorname{Prim}_{\text {coAss }}(A)$. We define by induction on $n$ :

$$
\omega\left(p_{1}, \ldots, p_{n}\right)=\left\{\begin{array}{rll}
p_{1} & \text { if } & n=1, \\
p_{n} \prec \omega\left(p_{1}, \ldots, p_{n-1}\right) & \text { if } & n \geq 2 .
\end{array}\right.
$$

An easy induction on $n$ allows to show the following result, using (8) $+(10)$ :

$$
\tilde{\Delta}\left(\omega\left(p_{1}, \ldots, p_{n}\right)\right)=\sum_{i=1}^{n-1} \omega\left(p_{1}, \ldots, p_{i}\right) \otimes \omega\left(p_{i+1}, \ldots, p_{n}\right)
$$

We denote by $\tilde{\Delta}^{n}: A \longrightarrow A^{n+1}$ the iterated coproducts of $A$. It comes by induction:

$$
\tilde{\Delta}^{m}\left(\omega\left(p_{1}, \ldots, p_{n}\right)\right)=\left\{\begin{array}{rll}
0 & \text { if } \quad m \geq n \\
p_{1} \otimes \ldots \otimes p_{n} & \text { if } \quad m=n-1
\end{array}\right.
$$

Second step. We consider the tensor (non counitary) coalgebra $C=T\left(\operatorname{Prim}_{\text {coAss }}(A)\right)$ :

$$
C=\bigoplus_{n=1}^{\infty} \operatorname{Prim}_{c o A s s}(A)^{\otimes n}
$$

It is a coalgebra for the deconcatenation coproduct. As $\operatorname{Prim}_{\text {coAss }}(A)$ is $\mathbb{N}$-graded, $C$ is a graded coalgebra with formal series:

$$
S(X)=\frac{1}{1-P(X)}-1=\frac{P(X)}{1-P(X)}
$$

By the first step, the following application is a morphism of graded coalgebras:

$$
\Psi:\left\{\begin{aligned}
C & \longrightarrow A \\
p_{1} \otimes \ldots \otimes p_{n} & \longrightarrow \omega\left(p_{1}, \ldots, p_{n}\right) .
\end{aligned}\right.
$$

Third step. Suppose that $\operatorname{Ker}(\Psi)$ is non zero. As it is a coideal of $C$, it contains primitive elements of $C$, that is to say elements of $\operatorname{Prim}_{\text {coAss }}(A)$. As $\Psi$ is obviously monic on $\operatorname{Prim}_{\text {coAss }}(A)$, this is impossible. So $\operatorname{Ker}(\Psi)=(0)$ and $\Psi$ is monic.

Let $a \in A$. As $A_{0}=(0)$, for a certain $N(a) \in \mathbb{N}^{*}, \tilde{\Delta}^{N(a)}(a)=0$. We prove that $a \in \operatorname{Im}(\Psi)$ by induction on $N(a)$. If $N(a)=1$, then $a \in \operatorname{Prim}_{c o A s s}(A)$ and the result is obvious. Suppose that the result is true for all $b \in A$ such that $N(b)<N(a)$. As $\tilde{\Delta}^{N(a)}(a)=0$, necessarily $\tilde{\Delta}^{N(a)-1}(a) \in \operatorname{Prim}_{\text {coAss }}(A)^{\otimes N(a)}$. We put:

$$
\tilde{\Delta}^{N(a)-1}(a)=a_{1} \otimes \ldots \otimes a_{n}, \quad b=a-\omega\left(a_{1}, \ldots, a_{n}\right)
$$

By the first step, $\tilde{\Delta}^{N(a)-1}(b)=0$, so $N(b)<N(a)$. By the induction hypothesis, $b \in \operatorname{Im}(\Psi)$. As $\omega\left(a_{1}, \ldots, a_{n}\right) \in \operatorname{Im}(\Psi), a \in \operatorname{Im}(\Psi)$.

Last step. As $\Psi$ in an isomorphism of graded coalgebras, $S(X)=R(X)$. Hence:

$$
R(X)=\frac{P(X)}{1-P(X)}
$$

so $R(X)-R(X) P(X)=P(X)$ and $P(X)=\frac{R(X)}{1+R(X)}$.

### 2.2 Free brace algebras

Using a description of the free dendriform algebra generated by a set $\mathcal{D}$ with planar decorated forests, we gave a description of the free brace algebra $\operatorname{Brace}(\mathcal{D})$ in [3]. A basis of this brace algebra is given by the set $T^{\mathcal{D}}$ of planar rooted trees decorated by $\mathcal{D}$. For example:

$$
\begin{aligned}
& \operatorname{Brace}(\mathcal{D})_{1}=\operatorname{Vect}\left(\cdot{ }_{a}, a \in \mathcal{D}\right) \text {, } \\
& \operatorname{Brace}(\mathcal{D})_{2}=\operatorname{Vect}\left(\mathfrak{l}_{a}^{b}, a, b \in \mathcal{D}\right) \text {, } \\
& \operatorname{Brace}(\mathcal{D})_{3}=\operatorname{Vect}\left({ }^{c} \bigvee_{a}{ }^{b}, \mathfrak{!}_{a}^{c}, a, b, c \in \mathcal{D}\right),
\end{aligned}
$$

The brace bracket satisfies, for all $t_{1}, \ldots, t_{n-1} \in T^{\mathcal{D}}, d \in \mathcal{D}$ :

$$
\left\langle t_{1}, \ldots, t_{n-1}, \cdot{ }_{d}\right\rangle=B_{d}\left(t_{n-1} \ldots t_{1}\right)
$$

where $B_{d}\left(t_{n-1} \ldots t_{1}\right)$ is the tree obtained by grafting the trees $t_{n-1}, \ldots, t_{1}$ (in this order) on a common root decorated by $d$. For example, if $a, b, c, d \in \mathcal{D}$,

$$
\left\langle\cdot a, \boldsymbol{q}_{b}^{c}, \cdot{ }_{d}\right\rangle={ }^{c}{ }^{c} \bigvee_{d}{ }^{a} .
$$

As a consequence, if $A$ is a connected bidendriform bialgebra and if $\left(q_{d}\right)_{d \in \mathcal{D}}$ is a basis of $\operatorname{Prim}_{\text {coDend }}(A)$, then a basis of $\operatorname{Prim}_{\text {coAss }}(A)$ is given by $\left(p_{t}\right)_{t \in T^{\mathcal{D}}}$ defined inductively by:

$$
\left\{\begin{aligned}
p_{\cdot d} & =q_{d} \\
p_{B_{d}^{+}\left(t_{1} \ldots t_{n}\right)} & =\left\langle p_{t_{n}}, \ldots, p_{t_{1}}, q_{d}\right\rangle
\end{aligned}\right.
$$

## 3 Recovering $\operatorname{Prim}_{\text {coDend }}($ FQSym $)$ from $\operatorname{Prim}_{c o A s s}($ FQSym $)$

For all $n \in \mathbb{N}^{*}$, we put:

$$
\left\{\begin{aligned}
p_{n} & =\operatorname{dim}\left(\operatorname{Prim}_{c o A s s}(\mathbf{F Q S y m})_{n}\right) \\
q_{n} & =\operatorname{dim}\left(\operatorname{Prim}_{c o D e n d}(\mathbf{F Q S y m})_{n}\right)
\end{aligned}\right.
$$

Proposition 7 For all $n \geq 2, q_{n}=(n-2) p_{n-1}$.
Proof. We put:

$$
R(X)=\sum_{n=1}^{\infty} n!X^{n}, \quad P(X)=\sum_{n=1}^{\infty} p_{n} X^{n}, \quad Q(X)=\sum_{n=1}^{\infty} q_{n} X^{n} .
$$

By theorem 2 and proposition 6:

$$
P(X)=\frac{R(X)}{1+R(X)}, \quad Q(X)=\frac{R(X)}{(1+R(X))^{2}}
$$

Hence:

$$
P^{\prime}(X)=\frac{R^{\prime}(X)}{(1+R(X))^{2}}
$$

Moreover:

$$
\begin{aligned}
R^{\prime}(X) & =\sum_{n=1}^{\infty} n n!X^{n-1} \\
& =\sum_{n=1}^{\infty}(n+1)!X^{n-1}-\sum_{n=1}^{\infty} n!X^{n-1} \\
& =\frac{R(X)-X}{X^{2}}-\frac{R(X)}{X} \\
& =\frac{R(X)-X(1+R(X))}{X^{2}} .
\end{aligned}
$$

We deduce:

$$
X^{2} P^{\prime}(X)=\frac{R(X)-X(1+R(X))}{(1+R(X))^{2}}=Q(X)-\frac{X}{1+R(X)}=Q(X)-X+X P(X)
$$

So:

$$
X^{2} P^{\prime}(X)+X P(X)=\sum_{n=1}^{\infty}(n-1) p_{n} X^{n+1}=Q(X)-X=\sum_{n=2}^{\infty} q_{n} X^{n} .
$$

As a conclusion, for all $n \geq 2, q_{n}=(n-2) p_{n-2}$.
Definition 8 Let $i \in \mathbb{N}^{*}$. We define $\Phi_{i}:$ FQSym $\longrightarrow$ FQSym in the following way: for all $n \in \mathbb{N}$, for all $\sigma=\left(\sigma_{1}, \ldots, \sigma_{n}\right) \in S_{n}$,

$$
\Phi_{i}\left(\mathbf{F}_{\sigma}\right)=\left\{\begin{array}{l}
0 \text { if } i \geq n, \\
\mathbf{F}_{\left(\sigma_{1}, \ldots, \sigma_{i}, n+1, \sigma_{i+1}, \ldots, \sigma_{n}\right)} \text { if } i<n .
\end{array}\right.
$$

Theorem 9 Let $n \geq 2$. The following application is bijective:

$$
\Phi:\left\{\begin{aligned}
\left(\operatorname{Prim}_{c o A s s}(\text { FQSym })_{n-1}\right)^{n-2} & \longrightarrow \operatorname{Prim}_{\text {coDend }}(\mathbf{F Q S y m})_{n} \\
\left(p_{1}, \ldots, p_{n-2}\right) & \longrightarrow \Phi_{1}\left(p_{1}\right)+\ldots+\Phi_{n-2}\left(p_{n-2}\right) .
\end{aligned}\right.
$$

Proof. First step. Let us first prove that $\Phi$ takes its values in $\operatorname{Prim}_{\text {coDend }}(\mathbf{F Q S y m})$. Let $p \in \operatorname{Prim}_{c o A s s}(\mathbf{F Q S y m})$ and $1 \leq i \leq n-2$. For all $k \in \mathbb{N}$, let $\pi_{k}$ be the projection on FQSym $_{k}$. By definition of $\Delta_{\prec}$ and $\Delta_{\succ}$, for all $\sigma \in S_{n-1}$ :

$$
\begin{aligned}
& \Delta_{\prec}\left(\Phi_{i}\left(\mathbf{F}_{\sigma}\right)\right)=\left(\sum_{j=i+1}^{n-2} \pi_{j} \otimes \pi_{n-1-j}\right) \circ \tilde{\Delta}\left(\mathbf{F}_{\sigma}\right), \\
& \Delta_{\succ}\left(\Phi_{i}\left(\mathbf{F}_{\sigma}\right)\right)=\left(\sum_{j=1}^{i} \pi_{j} \otimes \pi_{n-1-j}\right) \circ \tilde{\Delta}\left(\mathbf{F}_{\sigma}\right) .
\end{aligned}
$$

By linearity, we obtain:

$$
\begin{aligned}
& \Delta_{\prec}(p)=\left(\sum_{j=i+1}^{n-2} \pi_{j} \otimes \pi_{n-1-j}\right) \circ \tilde{\Delta}(p)=0 \\
& \Delta_{\succ}(p)=\left(\sum_{j=1}^{i} \pi_{j} \otimes \pi_{n-1-j}\right) \circ \tilde{\Delta}(p)=0 .
\end{aligned}
$$

This proves the first step.

Second step. We now prove that $\Phi$ is monic. Let $\left(p_{1}, \ldots, p_{n-2}\right) \in \operatorname{Ker}(\Phi)$. Let be $1 \leq i \leq$ $n-2$. We define:

$$
\varpi_{i}:\left\{\begin{aligned}
\mathbf{F Q S y m}_{n} & \longrightarrow \mathbf{F Q S y m}_{n} \\
\mathbf{F}_{\sigma} & \longrightarrow\left\{\begin{array}{rll}
0 & \text { if } & \sigma^{-1}(n) \neq i+1 \\
\mathbf{F}_{\sigma} & \text { if } & \sigma^{-1}(n)=i+1
\end{array}\right.
\end{aligned}\right.
$$

Then, in an obvious way, $\varpi_{i}\left(\Phi\left(p_{1}, \ldots, p_{n-2}\right)\right)=\Phi_{i}\left(p_{i}\right)=0$. As $\Phi_{i}$ is obviously monic on $\operatorname{FQSym}_{n-1}$ (because $i \leq n-2$ ), $p_{i}=0$. So $\Phi$ is monic.

Last step. As $\operatorname{dim}\left(\left(\operatorname{Prim}_{\text {coAss }}(\mathbf{F Q S y m})_{n-1}\right)^{n-2}\right)=\operatorname{dim}\left(\operatorname{Prim}_{\text {coDend }}(\mathbf{F Q S y m})_{n}\right)$, from proposition $7, \Phi$ is bijective.

## 4 An inductive basis of $\operatorname{Prim}_{\text {coAss }}$ (FQSym)

We now combine results of the second and third sections to obtain an basis of the space $\operatorname{Prim}_{\text {coAss }}($ FQSym $)$. We first define inductively some set of partially planar decorated trees $\mathbb{T}(n)$ in the following way:

1. $\mathbb{T}(0)$ is the set of non decorated planar trees. The weight of an element of $\mathbb{T}(0)$ is the number of its vertices.
2. Suppose that $\mathbb{T}(n)$ is defined. Then $\mathbb{T}(n+1)$ is the set of planar trees defined by :
(a) The elements of $\mathbb{T}(n+1)$ are partially decorated planar trees.
(b) The vertices of the elements of $\mathbb{T}(n+1)$ can eventually be decorated by a pair $(t, k)$, with $t \in \mathbb{T}(n)$ and $k$ an integer in $\{1, \ldots$, weight $(t)-1\}$.
(c) The weight of an element of $\mathbb{T}(n)$ is the sum of the number of its vertices and of the weights of the trees of $\mathbb{T}(n)$ that appear in its decorations.

Inductively, for all $n \in \mathbb{N}, \mathbb{T}(n) \subseteq \mathbb{T}(n+1)$. We put $\mathbb{T}=\bigcup_{n \in \mathbb{N}} \mathbb{T}(n)$.

## Examples.

1. Elements of $\mathbb{T}$ of weight 1 :
2. Elements of $\mathbb{T}$ of weight $2: ~: ~$
3. Elements of $\mathbb{T}$ of weight $3: ~ \mho,!, \cdot(\mathfrak{\swarrow}, 1)$.
4. Elements of $\mathbb{T}$ of weight 4 :
(a) $\mathscr{V}, \dot{V}, \dot{\vee}, Y, \vdots$

(c) $\mathfrak{l}^{(\mathfrak{\ell}, 1)}, \mathfrak{l}_{(\mathfrak{!}, 1)}$.

We can then define a basis $\left(p_{t}\right)_{i \in \mathbb{T}}$ of $\operatorname{Prim}_{\text {coAss }}(\mathbf{F Q S y m})$ inductively in the following way:

1. $p .=\mathbf{F}_{(1)}$.
2. If $t=\cdot\left(t^{\prime}, i\right)$, then $p_{t}=\Phi_{i}\left(p_{t^{\prime}}\right)$.
3. If $t$ is not a single root, let $t_{1}, \ldots, t_{n-1}$ be the children of its roots, from left to right, and $t_{n}$ its root. Then $p_{t}=\left\langle p_{t_{n-1}}, \ldots, p_{t_{1}}, p_{t_{n}}\right\rangle$.

By the preceding results:
Theorem $10\left(p_{t}\right)_{t \in \mathbb{T}}$ is a basis of $\operatorname{Prim}_{\text {coAss }}(\mathbf{F Q S y m})$. A basis of $\operatorname{Prim}_{\text {coDend }}(\mathbf{F Q S y m})$ is given by the $p_{t}$ 's, where $t$ is a single root.

## Examples.

1. $p .=\mathbf{F}_{(1)}$.
2. $p \boldsymbol{q}=-\mathbf{F}_{(21)}+\mathbf{F}_{(12)}$.
3. (a) $p_{\cdot_{(:, 1)}}=-\mathbf{F}_{(231)}+\mathbf{F}_{(132)}$.
(b) $p \boldsymbol{V}=\mathbf{F}_{(231)}-\mathbf{F}_{(132)}-\mathbf{F}_{(312)}+\mathbf{F}_{(213)}$.
(c) $p_{!}=\mathbf{F}_{(321)}-\mathbf{F}_{(231)}-\mathbf{F}_{(213)}+\mathbf{F}_{(123)}$.
4. (a) $p \boldsymbol{v}_{\left(\boldsymbol{\bullet}_{(, 1)}, 1\right)}=-\mathbf{F}_{(2431)}+\mathbf{F}_{(1432)}$.
(b) $p_{\left(\bullet_{(\boldsymbol{\ell}, 1), 2}\right)}=-\mathbf{F}_{(2341)}+\mathbf{F}_{(1342)}$.
(c) $p \boldsymbol{v}_{\left(\boldsymbol{V}_{, 1}\right)}=\mathbf{F}_{(2431)}-\mathbf{F}_{(1432)}-\mathbf{F}_{(3412)}+\mathbf{F}_{(2413)}$.
(d) $p \boldsymbol{v}_{\left(\boldsymbol{V}_{, 2}\right)}=\mathbf{F}_{(2341)}-\mathbf{F}_{(1342)}-\mathbf{F}_{(3142)}+\mathbf{F}_{(2143)}$.
(e) $p \boldsymbol{\bullet}_{\left(\vdots_{, 1}\right)}=\mathbf{F}_{(3421)}-\mathbf{F}_{(2431)}-\mathbf{F}_{(2413)}+\mathbf{F}_{(1423)}$.
(f) $p \boldsymbol{\bullet}_{\left(\vdots_{, 2}\right)}=\mathbf{F}_{(3241)}-\mathbf{F}_{(2341)}-\mathbf{F}_{(2143)}+\mathbf{F}_{(1243)}$.
$(\mathrm{g}) p_{\mathcal{V}}=-\mathbf{F}_{(2341)}+\mathbf{F}_{(1342)}+\mathbf{F}_{(3142)}+\mathbf{F}_{(3412)}-\mathbf{F}_{(2143)}-\mathbf{F}_{(2413)}-\mathbf{F}_{(4213)}+\mathbf{F}_{(3214)}$.
$\begin{aligned} & \text { (h) } p{\underset{\emptyset}{V}}=-\mathbf{F}_{(2431)}-\mathbf{F}_{(4231)}+\mathbf{F}_{(2341)}+\mathbf{F}_{(3241)}+\mathbf{F}_{(1432)}+\mathbf{F}_{(4132)}+\mathbf{F}_{(4312)}-\mathbf{F}_{(1342)}- \\ & \mathbf{F}_{(3142)}-\mathbf{F}_{(3412)}-\mathbf{F}_{(3214)}+\mathbf{F}_{(2314)} .\end{aligned}$
(i) $p, \mathfrak{V}=-\mathbf{F}_{(3241)}+\mathbf{F}_{(2341)}+\mathbf{F}_{(2143)}+\mathbf{F}_{(2413)}+\mathbf{F}_{(4213)}-\mathbf{F}_{(1243)}-\mathbf{F}_{(1423)}-\mathbf{F}_{(4123)}-$ $\mathbf{F}_{(2314)}-\mathbf{F}_{(3214)}+\mathbf{F}_{(1324)}+\mathbf{F}_{(3124)}$.
(j) $p \underset{Y}{ }=-\mathbf{F}_{(3421)}+\mathbf{F}_{(2431)}+\mathbf{F}_{(4231)}-\mathbf{F}_{(3241)}+\mathbf{F}_{(2314)}-\mathbf{F}_{(1324)}-\mathbf{F}_{(3124)}+\mathbf{F}_{(2134)}$.
(k) $p_{\vdots}=-\mathbf{F}_{(4321)}+\mathbf{F}_{(3421)}+\mathbf{F}_{(3241)}-\mathbf{F}_{(2341)}+\mathbf{F}_{(3214)}-\mathbf{F}_{(2314)}-\mathbf{F}_{(2134)}+\mathbf{F}_{(1234)}$.
(1) $p:_{(:, 1)}=\mathbf{F}_{(2341)}+\mathbf{F}_{(2431)}+\mathbf{F}_{(4231)}-2 \mathbf{F}_{(1342)}-\mathbf{F}_{(1432)}-\mathbf{F}_{(4132)}-\mathbf{F}_{(3142)}-\mathbf{F}_{(3412)}+$ $\mathbf{F}_{(1243)}+\mathbf{F}_{(2143)}+\mathbf{F}_{(2413)}$.
(m) $p_{\boldsymbol{:}(\boldsymbol{:}, 1)}=\mathbf{F}_{(3421)}-\mathbf{F}_{(2431)}-\mathbf{F}_{(2314)}+\mathbf{F}_{(1324)}$.
