# MEAN-FIELD LIMIT DERIVATION OF A MONOKINETIC SPRAY MODEL WITH GYROSCOPIC EFFECTS. 

MATTHIEU MÉNARD


#### Abstract

In this paper we derive a two dimensional spray model with gyroscopic effects as the mean-field limit of a system modeling the interaction between an incompressible fluid and a finite number of solid particles. This spray model has been studied by Moussa and Sueur (Asymptotic Anal., 2013), in particular the mean-field limit was established in the case of $W^{1, \infty}$ interactions. First we prove the local in time existence and uniqueness of strong solutions of a monokinetic version of the model with a fixed point method. Then we adapt the proof of Duerinckx and Serfaty (Duke Math. J., 2020) to establish the mean-field limit to the spray model in the monokinetic regime with Coulomb interactions.


## 1. Introduction

The purpose of this paper is to establish the mean-field limit for a system of partial differential equations introduced by Moussa and Sueur in [39] to describe two dimensional spray modeled by an incompressible fluid and a dispersed phase of solid particles with the following interactions: The fluid particles move through the velocity field $V$ generated by the fluid and the solid particles whereas the solid particles are submitted to a gyroscopic effect related to their velocities and to $V$. We define

as the opposite of the Green kernel on the plane. Let $\omega(t, x)$ be the vorticity of the fluid and $f(t, x, \xi)$ be the density of solid particles, then this system can be written:

\rho(t, x)=\int_{\mathbb{R}^{2}} f(t, x, \xi) \mathrm{d} \xi .

Replacing $\nabla^{\perp} g$ with a $W^{1, \infty}$ kernel, the authors derived these equations as the mean-field limit of a model describing the dynamics of a finite number of particles moving in an incompressible fluid. Namely, for $N$ solid particles immersed in a fluid of vorticity $\omega_{N}(t, x)$ with initial condition $\omega_{0}$, if the number of particles becomes large and if at time zero their empirical measure $f_{N}(0)$ is close to a regular density $f_{0}$, then for any time $t\left(f_{N}(t), \omega_{N}(t)\right)$ is
also close to the solution $(f(t), \omega(t))$ of (1.2) starting from $\left(f_{0}, \omega_{0}\right)$. The system modeling the interaction between a fluid of vorticity $\omega_{N}$ and $N$ solid particles with positions $q_{1}, \ldots, q_{N}$ and velocities $p_{1}, \ldots, p_{N}$ is the following:

where $\frac{1}{N}$ represents both the mass of a solid particle and the circulation of velocity around it. This model was established by Glass, Lacave and Sueur in 21 by looking at a rigid body in a fluid whose size goes to zero and its well-posedness was studied in [33] by Lacave and Miot. Remark that we can formally obtain this system from Equation (1.2) if we take

By Theorem 1.2 of [33], we know that there exists a unique global weak solution of System (1.3) on $\mathbb{R}_{+} \times \mathbb{R}^{2}$.

In this paper we adapt the proof of Duerinckx and Serfaty in 48 to extend the mean-field convergence result of 39 for the true Coulombian interaction, that is we prove the convergence of (1.3) to Equation (1.2) in the monokinetic case, or more precisely to the following system:

It can be obtained by taking formally $f(t, x, \xi)=\rho(t, x) \otimes \delta_{\xi=v(t, x)}$ in System (1.2). A rigorous derivation of System (1.4) from (1.2) was proved in 39] replacing $\nabla^{\perp} g$ with a $W^{1, \infty}$ kernel.

Before establishing the mean-field limit, we will justify the local in time existence and uniqueness of strong solutions of System (1.4). The local well-posedness of Euler-Poisson system (that is the system we get if we take $\omega=0$ and add a pressure term in the equation on $v$ ) was studied in [38] in the case $d=3$ using the usual estimates on hyperbolic systems that were proved in (32. In Section 2 we extend this result to System (1.4). We will not study the existence of weak solution of our system, for more details on this subject one can refer to the bibliography of the appendix of 48 .

Mean-field convergence for regular kernels were first established by compactness arguments in [6, 40] or by optimal transport theory and Wasserstein
distances by Dobrushin in [17]. The latest method is the one used in 39] to prove the mean-field convergence of (1.3) to (1.2). In the Coulomb case, the kernel is no longer regular and their proof no longer holds. However, there are other works which prove mean-field limits for some systems with Coulombian or Riesz interactions. Let us consider $N$ particles $x_{1}, \ldots, x_{N}$ following the differential equations:

Then the mean-field limit to a density $\mu$ following

\end{equation*}

has been rigorously justified in different cases:
Schochet proved in [46] the mean-field limit of the point vortex system (that is $K=\frac{1}{2 \pi} \frac{x^{\perp}}{|x|^{2}}$ in dimension two) to a measure-valued solution of Euler equation up to a subsequence, using arguments previously developed in 45 ] and [15] to prove existence of such solutions. This result was extended later to include convergence to vortex sheet in (37].

For sub-coulombic interactions, that is $|K(x)|,|x||\nabla K(x)| \leqslant C|x|^{-\alpha}$ with $0<\alpha<d-1$, the mean-field limit was proved by Hauray in [24] assuming $\operatorname{div}(K)=0$ and using a Dobruschin-type approach. It was also used by Carillo, Choi and Hauray to deal with the mean-field limit of some aggregation models in [11, 12 .

In [18] Duerinckx gave an other proof of the mean-field limit of several Riesz interaction gradient flows using a "modulated energy" that was introduced by Serfaty in [47]. Together they also gave a mean-field limit of Ginzburg-Landau vortices with pinning and forcing effects in [19].

In [48, Serfaty proved the mean-field convergence of such systems where $K$ was a kernel given by Coulomb, logarithmic or Riesz interaction, that is $K=\nabla g$ for $g(x)=|x|^{-s}$ with $\max (d-2,0) \leqslant s<d$ for $d \geqslant 1$ or $g(x)=-\ln |x|$ for $d=1$ or 2 . For this purpose $K * \mu$ was supposed to be lipschitz.

Rosenzweig proved in 44 the mean-field convergence of point vortices without assuming lipschitz regularity for the limit velocity field, using the same energy as in [48] with refined estimates. Remark that it ensures that the point vortices converges to any Yudovich solutions of the Euler equation (see [49]). This result was extended later for higher dimensional systems $(d \geqslant 3)$ in [42] by the same author.

Numerous mean-field limit results were proved for interacting particles with noise with regular or singular kernels in [3, 5, 7, 8, 13, 20, 36, 41].

For systems of order two following Newton's second law:

the mean-field convergence to Vlasov-like equations remains open in the Coulombian case but was established for some singular kernels:

In [26, 25], Hauray and Jabin treated the case of some sub-coulombian interaction, or more precisely for a kernel $K=\nabla g$ where $|\nabla g(x)| \leqslant C|x|^{-s}$ and $|\nabla g(x)| \leqslant C|x|^{-s-1}$ where $0<s<1$. For this purpose they used the same kind of arguments as Hauray did in [24].

In [31, 30], Jabin and Wang treated the case of bounded and $W^{-1, \infty}$ gradients.

In [4, 34, 35, 27] the same kind of result is proved with some cutoff of the interaction kernel.

In the appendix of 48, Duerinckx and Serfaty treated the case of Coulombian interaction kernel to the Vlasov equation in the monokinetic regime, that is the pressureless Euler-Poisson equation. This was used later by Carillo and Choi in 10 to prove the mean-field limit of some swarming models with alignment interactions.

In [23], Han-Kwan and Iacobelli proved the mean-field limit of particles following Newton's second law to the Euler equation in a quasi-neutral regime or in a gyrokinetic limit. This result was improved later by Rosenzweig in 43] who treated the case of quasi-neutral regime for a larger choice of scaling between the number of particles and the coupling constant.

For a general introduction to the subject of mean-field convergence one can have a look at the reviews [22, 29].
1.1. Main results. If $\nu$ is a probability measure on $\mathbb{R}^{2}$, we will denote

Recall that $g$ is the opposite of the Green kernel of the plane:

$\Delta$ will denote the diagonal of $\left(\mathbb{R}^{2}\right)^{2}$ :

The main result in this paper is Theorem 1.6 which proves the mean-field limit of solutions of System (1.3) to solutions of (1.4) with some regularity assumptions. We will use the following definition of weak solutions:

Definition 1.1. We say that $(\rho, \omega, v)$ is a weak solution of (1.4) if

- $\rho, \omega \in \mathcal{C}\left([0, T], L^{1} \cap L^{\infty}\left(\mathbb{R}^{2}, \mathbb{R}\right)\right)$ with compact supports.
- $v \in W^{1, \infty}\left([0, T] \times \mathbb{R}^{2}, \mathbb{R}^{2}\right)$
- The equation on the velocity is satisfied almost everywhere and the continuity equations are satisfied in the sense of distributions, that is for every $\varphi \in W^{1, \infty}\left([0, T], \mathcal{C}_{c}^{1}\left(\mathbb{R}^{2}\right)\right)$ and for every $t \in[0, T]$, we have:

In Section 2 we will prove existence and uniqueness of solutions of (1.4) in a space strictly included in $\mathcal{C}\left([0, T], L^{1} \cap L^{\infty}\right)^{2} \times W^{1, \infty}$ (see Theorem [2.1). For the microscopic system (1.3), we will use the following definition of weak solutions, introduced in [33]:

Definition 1.2. $\left(\omega_{N}, Q_{N}, P_{N}\right)$ is a weak solution of (1.3) on $[0, T]$ if

- $\omega_{N} \in L^{\infty}\left([0, T], L^{1} \cap L^{\infty}\right) \cap \mathcal{C}\left([0, T], L^{\infty}-w^{*}\right)$ with compact support.
- $q_{1}, \ldots, q_{N} \in \mathcal{C}^{2}\left([0, T], \mathbb{R}^{2}\right)$
- The partial differential equation on $\omega_{N}$ is satisfied in the sense of distributions (which means that it also verifies (1.8) and the ordinary differential equations are satisfied in the classical sense.

Remark 1.3. By Theorems 1.4 and 1.5 of [33] we know that for $\omega_{N}(0) \in$ $L^{\infty}\left(\mathbb{R}^{2}\right)$ compactly supported and $q_{1}(0), \ldots, q_{N}(0)$ distincts outside of the support of $\omega_{N}(0)$ there exists a unique weak solution of (1.3) on $[0, T]$ for any $T>0$ and no collision between the solid particles occurs in finite time.

Remark 1.4. One could replace the compact support assumptions by some logarithmic decrease of the solutions $\omega$ and $\rho$ at infinity as done in 18 and 44 but for the sake of simplicity we will only consider solutions with compact support.

In order to show that the limit of a sequence $\left(\omega_{N}, Q_{N}, P_{N}\right)$ of solutions of (1.3) converges to a solution $(\omega, \rho, v)$ of (1.4), we will control a modulated energy similar to the one defined in [48]. Let $X_{N}=\left(x_{1}, \ldots, x_{N}\right) \in\left(\mathbb{R}^{2}\right)^{N}$ be such that $x_{i} \neq x_{j}$ if $i \neq j$ and $\mu$ be a $L^{1} \cap L^{\infty}$ nonnegative function with compact support, then the following quantity is well defined:

This is the "modulated energy" used in [48, 44] to prove the mean-field limit of (1.5) to (1.6). As we will see later this quantity controls the distance between $\mu$ and the empirical distribution on $X_{N}$ in a weak sense. More precisely we have the following proposition proved in [48] (number 3.6 in the article):

Proposition 1.5 (proved in [48). For any $0<\theta \leqslant 1$, there exists $\lambda>0$ and $C>0$ independant of $\mu$ and $X_{N}$ such that for any smooth function $\xi$,

Now let $\rho, \omega, \omega_{N}$ be $\left(L^{1} \cap L^{\infty}\right)\left(\mathbb{R}^{2}, \mathbb{R}\right)$ nonnegative functions with compact supports, $v \in W^{1, \infty}\left(\mathbb{R}^{2}, \mathbb{R}^{2}\right), Q_{N}, P_{N} \in\left(\mathbb{R}^{2}\right)^{N}$ be such that $q_{i} \neq q_{j}$ and
$p_{i} \neq p_{j}$ if $i \neq j$. We define:

where

\rho_{N}=\frac{1}{N} \sum_{i=1}^{N} \delta_{q_{i}} .

$B_{N}$ is a number depending only on $\left\|\rho+\omega-\omega_{N}\right\|_{L^{\infty}}$, which is given by Corollary 3.5 of [48] and ensures that for all $N$,

We can also check that if $\left\|\omega_{N}\right\|_{L^{\infty}}$ is uniformly bounded in $N$, then so is $B_{N}$. Remark that if remove $\frac{B_{N}}{N}+\frac{\ln (N)}{2 N}$ and set $\omega_{N}=\omega=0$ our quantity is the functionnal used by Duerinckx in the appendix of [48] to prove the mean-field limit of particles following (1.7) to the Euler-Poisson equation.

Our main result is the following theorem:
Theorem 1.6. Let $(\rho, \omega, v)$ be a weak solution of Equation (1.4) in the sense of Definition 1.1 and $\left(\omega_{N}, Q_{N}, P_{N}\right)$ be a weak solution of Equation (1.3) in the sense of Definition 1.2. Then we define

Suppose that $\nabla \omega \in L^{\infty}, \nabla v \in \mathcal{C}^{0}\left([0, T] \times \mathbb{R}^{2}, \mathbb{R}^{2}\right)$ and that

Then there exist positive constants $C$ and $\beta$ depending only on $T, \rho, \omega$ and $\left\|\omega_{N}\right\|_{L^{\infty}}$ such that for all $t \in[0, T]$,

We will also prove a coerciveness result about this energy.
Proposition 1.7. Let $Q_{N}, P_{N} \in\left(\mathbb{R}^{2}\right)^{N}, \omega, \omega_{N}, \rho \in L^{1} \cap L^{\infty}\left(\mathbb{R}^{2}, \mathbb{R}\right)$, and $v \in W^{2, \infty}\left(\mathbb{R}^{2}, \mathbb{R}^{2}\right)$. Then there exist positive constants $C$ and $\beta$ such that

In particular, if we assume that

Remark 1.8. The $H^{-5}$ norm is not optimal, but it is sufficient to justify that $\mathcal{H}_{N}$ controls the convergence to a monokinetic distribution in a weak sense.

As a consequence we get that if a sequence of solutions $\left(\omega_{N}, Q_{N}, P_{N}\right)$ of (1.3) satisfying the hypothesis of Theorem 1.6 are such that

Since $\frac{1}{N} \sum_{i=1}^{N} \delta_{\left(q_{i}(t), p_{i}(t)\right)}$ is bounded in the dual of continuous bounded functions, we can extract a subsequence which will converge in the weak-* topology of signed measures $\mathcal{M}\left(\mathbb{R}^{2} \times \mathbb{R}^{2}\right)$. Since it necessarily converges to $\rho(t) \otimes \delta_{\xi=v(t, x)}$, by weak-* compacity we can deduce that for all $t \in[0, T]$,

\frac{1}{N} \sum_{i=1}^{N} \delta_{\left(q_{i}(t), p_{i}(t)\right)} \stackrel{*}{\rightharpoonup} \rho(t) \otimes \delta_{\xi=v(t, x)} \text { in } \mathcal{M}\left(\mathbb{R}^{2}\right)
$$

and thus we have the mean-field convergence of (1.3) to (1.4). One can look at [44, Corollary 1.2] for a more detailed proof about such compacity arguments.
Remark 1.9. If we suppose that $\omega_{N, 0}$ converges to $\omega_{0}$ in $L^{2}$ and that $\rho_{N, 0}$ converges to $\rho_{0}$ in the weak-* topology of signed measures, then the convergence of

$$
\int_{\left(\mathbb{R}^{2} \times \mathbb{R}^{2}\right) \backslash \Delta} g(x-y)\left(\rho_{0}+\omega_{0}-\rho_{N, 0}-\omega_{N, 0}\right)^{\otimes 2}(\mathrm{~d} x \mathrm{~d} y)
$$

to zero can be seen as a well-preparedness condition on the initial data, as stated in the following proposition:
Proposition 1.10. Let us suppose that $\omega_{N, 0}, \omega_{0}, \rho_{0} \in L^{2}\left(\mathbb{R}^{2}, \mathbb{R}\right)$ with compact support, and that $\left(q_{1}^{0}, \ldots, q_{N}^{0}\right)$ are such that $q_{i}^{0} \neq q_{j}^{0}$ if $i \neq j$. Let us also suppose that the support of $\omega_{N, 0}$ and $q_{1}^{0}, \ldots, q_{N}^{0}$ are in a compact $K$ that does not depend on $N$. Then if we suppose

$$
\begin{array}{r}
\omega_{N, 0} \\
\rho_{N, 0} \stackrel{*}{\longrightarrow} \omega_{0} \text { in } \mathcal{M}\left(\mathbb{R}^{2}\right) \\
\frac{1}{N^{2}} \sum_{1 \leqslant i \neq j \leqslant N} g\left(q_{i}^{0}-q_{j}^{0}\right) \\
\underset{N \rightarrow+\infty}{\longrightarrow} \iint g(x-y) \rho_{0}(x) \rho_{0}(y) \mathrm{d} x \mathrm{~d} y
\end{array}
$$

we have

$$
\int_{\left(\mathbb{R}^{2} \times \mathbb{R}^{2}\right) \backslash \Delta} g(x-y)\left(\rho_{0}+\omega_{0}-\rho_{N, 0}-\omega_{N, 0}\right)^{\otimes 2}(\mathrm{~d} x \mathrm{~d} y) \underset{N \rightarrow+\infty}{\longrightarrow} 0
$$

The latter statement strongly relies on the results proved in [18]. One could have more details about this well-preparedness assumptions by reading the introduction of 18 .

The remainder of this paper is organized as follows. In Section 2 we establish local well-posedness for strong solutions of (1.4). Then in Section (3) we provide the proof of Theorem 2.1, Proposition 1.7 and Proposition 1.10 , Sections 2 and 3 are independant from each other.

## 2. Local Well-Posedness

In this section, if $\mu$ be a continuous function defined on $\mathbb{R}^{2}$ with compact support, we will denote

$$
R[\mu]=\sup \left\{x \in \mathbb{R}^{2} ; \mu(x) \neq 0\right\}
$$

and

$$
R_{T}[\mu]:=\sup _{0 \leqslant t \leqslant T} R[\mu(t)]
$$

if $\mu$ depends on time. If B is a Banach space and $1 \leqslant p \leqslant \infty$, we will denote

$$
L_{T}^{p} B=L^{p}([0, T], B)
$$

We will use the same convention for the Hölder spaces $\mathcal{C}_{T}^{k} B$ and the Sobolev spaces $W_{T}^{k, p} B$. Let us also recall that $g$ is the opposite of the Green kernel on the plane defined in (1.1).

C will refer to a constant independant of time and of any other parameter that can change value from one line to another. We will denote $C(A, B)$ for a constant depending only on some quantities A and B .

We want to show that System (1.4) has a unique regular solution in $[0, T]$ for $T$ small enough. In [38], Makino builds such a solution for the following compressible Euler-Poisson system in three dimensions:

$$
\left\{\begin{array}{l}
\partial_{t} u+(u \cdot \nabla) u+\nabla p=F * \rho \\
\partial_{t} \rho+\operatorname{div}(\rho u)=0
\end{array}\right.
$$

where $p$ is a function of $\rho$ and $F=\nabla G$ where $G$ is the Green function on $\mathbb{R}^{3}$. There are three main differences with our system (1.4):
(1) We have no pressure term, but we have a gyroscopic effect.
(2) We have a continuity equation on $\omega$ that we also need to solve.
(3) On the plane $\mathbb{R}^{2}$, the function $V=-\nabla^{\perp} g *(\rho+\omega)$ is not in $L^{2}$ except if we assume that $\int(\rho+\omega)=0$.
In order to deal with the third point, we will assume that $v_{0}=u_{0}+\bar{V}$ where $u_{0} \in L^{2}$ and $\bar{V}$ is a function of $x$ that we will specify later on. If we try to find a solution of (1.4) when $v=u+\bar{V}$, we find that $(u, \rho, \omega)$ evolves according to the following equations:

$$
\left\{\begin{array}{l}
\partial_{t} \omega+\operatorname{div}(\omega V)=0  \tag{2.1}\\
\partial_{t} \rho+\operatorname{div}(\rho v)=0 \\
\partial_{t} u+((u+\bar{V}) \cdot \nabla) u+(u \cdot \nabla) \bar{V}=u^{\perp}+f \\
V=-\nabla^{\perp} g *(\omega+\rho) \\
f=(\bar{V}-V)^{\perp}-(\bar{V} \cdot \nabla) \bar{V} \\
v=u+\bar{V}
\end{array}\right.
$$

Thus if we choose $\bar{V}$ such that $f \in L^{2}$, we will find an equation that we expect to have a solution in $L^{2}$. We can achieve this goal choosing the following value of $\bar{V}$ :

$$
\bar{V}=-\left(\int \omega_{0}+\rho_{0}\right) \nabla^{\perp} g * \chi
$$

where $\chi$ is some compactly supported function such that $\int \chi=1$. We make such a choice because $\int_{\mathbb{R}^{2}} \rho$ and $\int_{\mathbb{R}^{2}} \omega$ are conserved and we will justify later on that for $\mu$ compactly supported,

$$
-\nabla^{\perp} g * \mu(x)=\frac{1}{2 \pi}\left(\int_{\mathbb{R}^{2}} \mu\right) \frac{x^{\perp}}{|x|^{2}}+\underset{|x| \rightarrow \infty}{\mathcal{O}}\left(|x|^{-2}\right)
$$

Since we assumed that $\rho$ and $\omega$ have compact support, we are not concerned by the fact that $V$ is not $L^{2}$ on the whole plane. Remark also that the space

$$
-\left(\int \omega_{0}+\rho_{0}\right) \nabla^{\perp} g * \chi+L^{2}
$$

does not depend on the choice of $\chi$. Now we are able to write the main theorem of this section:

Theorem 2.1. Let $s$ be an integer such that $s \geqslant 3$ and $u_{0} \in H^{s+1}\left(\mathbb{R}^{2}, \mathbb{R}^{2}\right)$, $\rho_{0}, \omega_{0} \in H^{s}\left(\mathbb{R}^{2}, \mathbb{R}\right)$ such that $\omega_{0}$ and $\rho_{0}$ have compact support, then if $T$ is small enough (with respect to some quantity depending only on $\left\|\omega_{0}\right\|_{H^{s}}$, $\left\|\rho_{0}\right\|_{H^{s}},\left\|u_{0}\right\|_{H^{s+1}}, R\left[\omega_{0}\right]$ and $\left.R\left[\rho_{0}\right]\right)$, there exists a unique $(u, \omega, \rho)$ with $(\rho, \omega) \in\left(C_{T} H^{s} \cap C_{T}^{1} H^{s-1}\right)^{2}$ and $u \in C_{T} H^{s+1} \cap C_{T}^{1} H^{s}$ solution of (2.1).

Remark 2.2. By Sobolev embeddings a solution given by Theorem 2.1 is also a solution in the sense of Definition 1.1 that satisfies the hypothesis of Theorem 1.6 and thus this result gives the existence of sufficiently regular solutions of System (1.4) that can be approached as mean-field limits of solutions of System (1.3).

The proof of Theorem 2.1 proceeds as follows:
(1) We fix $T>0$ and define

\begin{gathered}
R_{0}=R\left[\rho_{0}+\omega_{0}\right] \\
M_{0}=\max \left(\left\|\rho_{0}\right\|_{H^{s}},\left\|\omega_{0}\right\|_{H^{s}},\left\|u_{0}\right\|_{H^{s+1}}\right) \\
X_{T}=\left\{(\omega, \rho) \in L_{T}^{\infty} H^{s} \cap C_{T} H^{s-1} \mid \omega(0)=\omega_{0}, \rho(0)=\rho_{0}\right. \\
\|\rho\|_{L_{T}^{\infty} H^{s}} \leqslant 2 M_{0},\|\omega\|_{L_{T}^{\infty} H^{s}} \leqslant 2 M_{0}, R_{T}[\rho+\omega] \leqslant 2 R_{0} \\
\forall t \in[0, T], \int(\rho(t)+\omega(t))=\int\left(\rho_{0}+\omega_{0}\right) \\
\forall t, t^{\prime} \in[0, T],\left\|\rho(t)-\rho\left(t^{\prime}\right)\right\|_{H^{s-1}} \leqslant L\left|t-t^{\prime}\right| \\
\left.\left\|\omega(t)-\omega\left(t^{\prime}\right)\right\|_{H^{s-1}} \leqslant L\left|t-t^{\prime}\right|,\right\}
\end{gathered}
$$

where $L>0$ is a quantity depending only on $R_{0}$ and $M_{0}$. Remark that $X_{T}$ is a subspace of $\left(C_{T} H^{s} \cap C_{T}^{1} H^{s-1}\right)^{2}$. Then we fix $(\omega, \rho) \in X_{T}$ and we define

$$
\begin{align*}
V & =-\nabla^{\perp} g *(\rho+\omega)  \tag{2.3}\\
\bar{V} & =-\left(\int \omega_{0}+\rho_{0}\right) \nabla^{\perp} g * \chi  \tag{2.4}\\
f & =(\bar{V}-V)^{\perp}-\bar{V} \cdot \nabla \bar{V} \tag{2.5}
\end{align*}
$$

Note that we will prove in Subsection 2.1 that $f \in \mathcal{C}_{T} H^{s} \cap L_{T}^{\infty} H^{s+1}$.
(2) In Subsection 2.2 we solve in $C_{T_{1}} H^{s+1} \cap C_{T_{1}}^{1} H^{s}$ the equation

$$
\partial_{t} u+((u+\bar{V}) \cdot \nabla) u+(u \cdot \nabla) \bar{V}=u^{\perp}+f
$$

for initial condition $u_{0}$ and $T_{1} \leqslant T$ small enough depending only on $M_{0}$ and $L$.
(3) In Subsection 2.3 we define $v=u+\bar{V}$ and solve in $\left(C_{T_{1}} H^{s} \cap\right.$ $\left.C_{T_{1}}^{1} H^{s-1}\right)^{2}$ the system

$$
\left\{\begin{array}{l}
\partial_{t} \widetilde{\omega}+\operatorname{div}(\widetilde{\omega} V)=0 \\
\partial_{t} \widetilde{\rho}+\operatorname{div}(\widetilde{\rho} v)=0
\end{array}\right.
$$

(4) In Subsection 2.4 we apply a fixed-point theorem by showing that the map defined on $X_{T_{2}}$ by $(\omega, \rho) \longmapsto(\widetilde{\omega}, \widetilde{\rho})$ is a contraction for the $\mathcal{C}_{T} L^{2}$ norm if $T_{2} \leqslant T_{1}$ is small enough, using the estimates proved for the previous equations.

Remark 2.3. $X_{T}$ is strictly included in $\left(C_{T_{1}} H^{s} \cap C_{T_{1}}^{1} H^{s-1}\right)^{2}$ but since we prove in step (3) that the image of $\Phi$ is contained in $\left(C_{T_{1}} H^{s} \cap C_{T_{1}}^{1} H^{s-1}\right)^{2}$ we have the expected regularity for the solutions of our system.

Remark 2.4. Uniqueness is established in the space $X_{T}$ which is bigger than $\left(C_{T} H^{s} \cap C_{T}^{1} H^{s-1}\right)^{2}$. It ensures uniqueness for the whole system: If $\left(\rho_{1}, \omega_{1}, u_{1}\right)$ and $\left(\rho_{2}, \omega_{2}, u_{2}\right)$ are two solutions of (1.4), then $\left(\rho_{1}, \omega_{1}\right)=\left(\rho_{2}, \omega_{2}\right)$ by uniqueness of the fixed point and $u_{1}=u_{2}$ follows by uniqueness of solutions of equation (2.6). Remark also that using energy estimates one could prove uniqueness in a space of smaller regularity.

Before doing these different steps, we give some results about the BiotSavart kernel that we will need later on. In this section we will use the following definition of uniformly local Sobolev spaces:

Definition 2.5. We define $H_{\mathrm{ul}}^{s}\left(\mathbb{R}^{2}\right)$ as the space of locally $H^{s}$ functions verifying

\|u\|_{H_{\mathrm{ul}}^{s}\left(\mathbb{R}^{2}\right)}=\sup _{x \in \mathbb{R}^{2}}\|u\|_{H^{s}(B(x, 1))}<+\infty
$$

For a more complete introduction to these spaces one can refer to Section 2.2 of 32 .
2.1. Properties of the Biot-Savart kernel on the plane. In this subsection we prove Proposition 2.6 containing several results about the BiotSavart kernel.

Proposition 2.6. Let $s \geqslant 3$ and let $\mu$ be a $H^{s}$ function on $\mathbb{R}^{2}$ with compact support. Denote

$$
V=-\nabla^{\perp} g * \mu
$$

Then we have the following inequalities:
(1) $V \in H_{\mathrm{ul}}^{s+1}$ and $\|V\|_{H_{\mathrm{ul}}^{s+1}} \leqslant C(1+R[\mu])\|\mu\|_{H^{s}}$.
(2) $\|\nabla V\|_{H^{s}} \leqslant C\|\mu\|_{H^{s}}$.
(3) $V \in L^{\infty}$ and we have the three following bounds:

$$
\begin{aligned}
\|V\|_{L^{\infty}} & \leqslant C R[\mu]\|\mu\|_{L^{\infty}} \\
\|V\|_{L^{\infty}} & \leqslant C \sqrt{R[\mu]}\|\mu\|_{H^{1}} \\
\|V\|_{L^{\infty}} & \leqslant C\|\mu\|_{L^{1}}^{\frac{1}{2}}\|\mu\|_{L^{\infty}}^{\frac{1}{2}}
\end{aligned}
$$

(4) $\|(V \cdot \nabla) V\|_{H^{s}} \leqslant C(1+R[\mu])\|\mu\|_{H^{s}}^{2}$.
(5) $V(x)=\frac{1}{2 \pi}\left(\int \mu\right) \frac{x^{\perp}}{|x|^{2}}+\underset{|x| \rightarrow \infty}{\mathcal{O}}\left(|x|^{-2}\right)$.
(6) If $\mu$ has mean zero, then $V \in L^{2}$ and

$$
\|V\|_{L^{2}} \leqslant C\left(R[\mu]+R[\mu]^{3}\right)^{\frac{1}{2}}\|\mu\|_{L^{2}}
$$

The first consequence of this proposition is the following:
Corollary 2.7. Let $\rho_{0}, \omega_{0} \in H^{s}$ with compact support and $\chi$ be a smooth function with compact support, $(\rho, \omega) \in X_{T}$ where $X_{T}$ is the space defined in 2.2. Let us consider the functions $f$ and $\bar{V}$ defined in 2.5 and 2.4, then we have $f \in L_{T}^{\infty} H^{s+1} \cap \mathcal{C}_{T} H^{s}, \bar{V} \in H_{\mathrm{ul}}^{s+2}$ and

$$
\begin{aligned}
\|\bar{V}\|_{H_{\mathrm{ul}}^{s+2}} & \leqslant C\left(R_{0}, M_{0}\right) \\
\|f\|_{L_{T}^{\infty} H^{s+1}} & \leqslant C\left(R_{0}, M_{0}\right)
\end{aligned}
$$

Proof of Proposition 2.6. Let us begin by the second inequality. We have:

$$
\|\nabla V\|_{H^{s}}=\left\|\nabla^{2} g * \mu\right\|_{H^{s}} \leqslant C\|\mu\|_{H^{s}}
$$

by Calderón-Zygmund inequality.
Let us now prove the third inequality:

$$
\|V\|_{L^{\infty}} \leqslant\|\mu\|_{L^{\infty}} \sup _{x \in \mathbb{R}^{2}} \int_{\operatorname{supp}(\mu)} \frac{\mathrm{d} y}{|x-y|}
$$

$$
\begin{aligned}
& \leqslant\|\mu\|_{L^{\infty}} \sup _{x \in \mathbb{R}^{2}} \int_{B(0, R[\mu])} \frac{\mathrm{d} y}{|x-y|} \\
& \leqslant\|\mu\|_{L^{\infty}} \int_{B(0, R[\mu])} \frac{\mathrm{d} y}{|y|} \\
& \leqslant C R[\mu]\|\mu\|_{L^{\infty}}
\end{aligned}
$$

because

$$
x \longmapsto \int_{B(x, R[\mu])} \frac{\mathrm{d} y}{|y|}
$$

reaches its maximum on $x=0$. Now for the second inequality of (3), we deduce in the same way

$$
\begin{aligned}
\|V\|_{L^{\infty}} & \leqslant\|\mu\|_{L^{4}}\left(\int_{B(0, R[\mu])} \frac{\mathrm{d} y}{|y|^{\frac{4}{3}}}\right)^{\frac{3}{4}} \\
& \leqslant C \sqrt{R[\mu]}\|\mu\|_{H^{1}}
\end{aligned}
$$

For inequality (3) we refer to [28, Lemma 1].
The first inequality follows from the two inequalities we just proved: Since all derivatives of $V$ of order $k$ for $1 \leqslant k \leqslant s+1$ belong to $L^{2}$ and since $\|V\|_{L_{\mathrm{ul}}^{2}} \leqslant C\|V\|_{L^{\infty}}$, we get

$$
\begin{aligned}
\|V\|_{H_{\mathrm{ul}}^{s+1}} & \leqslant C\left(\|\mu\|_{H^{s}}+R[\mu]\|\mu\|_{L^{\infty}}\right) \\
& \leqslant C(1+R[\mu])\|\mu\|_{H^{s}}
\end{aligned}
$$

because $H^{s} \hookrightarrow L^{\infty}$.
Now let us prove the fourth point. Let $\alpha$ be a multi-index such that $|\alpha| \leqslant$ $s$, then $\left(\partial^{\alpha} V \cdot \nabla\right) V$ is a combination of $\left.\partial^{\alpha_{1}} V \cdot \nabla\right) \partial^{\alpha_{2}} V$ where $\alpha_{1}+\alpha_{2}=\alpha$. If $\alpha_{1}=0$,

$$
\left\|\left(\partial^{\alpha_{1}} V \cdot \nabla\right) \partial^{\alpha_{2}} V\right\|_{L^{2}} \leqslant\|V\|_{L^{\infty}}\|\nabla V\|_{H^{s}}
$$

If $1 \leqslant\left|\alpha_{1}\right| \leqslant s-1$, then

$$
\begin{aligned}
\left\|\left(\partial^{\alpha_{1}} V \cdot \nabla\right) \partial^{\alpha_{2}} V\right\|_{L^{2}} & \leqslant\left\|\partial^{\alpha_{1}} V\right\|_{L^{\infty}}\|\nabla V\|_{H^{s}} \\
& \leqslant\|\nabla V\|_{H^{s}}^{2}
\end{aligned}
$$

Finally if $\left|\alpha_{1}\right|=s$,

$$
\begin{aligned}
\left\|\left(\partial^{\alpha_{1}} V \cdot \nabla\right) \partial^{\alpha_{2}} V\right\|_{L^{2}} & \leqslant\left\|\partial^{\alpha_{1}} V\right\|_{L^{2}}\|\nabla V\|_{L^{\infty}} \\
& \leqslant\|\nabla V\|_{H^{s}}^{2}
\end{aligned}
$$

We conclude using (2) and (3).
We now prove the fifth claim by a standard argument. Let us set

$$
W(x+i y)=V_{1}(x, y)-i V_{2}(x, y)
$$

Then we have

$$
\begin{aligned}
\left(\partial_{x}+i \partial_{y}\right) W & =\left(\partial_{x} V_{1}+\partial_{y} V_{2}\right)+i\left(\partial_{y} V_{1}-\partial_{x} V_{2}\right) \\
& =\operatorname{div}(V)-i \operatorname{curl}(V) \\
& =0-i \mu
\end{aligned}
$$

Thus $W$ is holomorphic on $\mathbb{C} \backslash B(0, R)$ with $R=R[\mu]$ (since it is a solution of Cauchy-Riemann equations) and we can write it as the sum of a Laurent series:

$$
W(z)=\sum_{i=1}^{+\infty} a_{k} z^{-k}
$$

Remark that since we have $W(z) \underset{z \rightarrow \infty}{\longrightarrow} 0, a_{k}=0$ for $k$ nonpositive. Now we compute $a_{1}$ by a contour integral in the counter clockwise sense:

$$
\begin{aligned}
a_{1} & =\frac{1}{2 i \pi} \int_{\partial B(0, R)} W(z) \mathrm{d} z \\
& =\frac{1}{2 i \pi} \int_{0}^{2 \pi} W\left(R e^{i \theta}\right) R i e^{i \theta} \mathrm{~d} \theta \\
& =\frac{1}{2 \pi} \int_{0}^{2 \pi}\left(V_{1}-i V_{2}\right)(R \cos (\theta), R \sin (\theta))(R \cos (\theta)+i R \sin (\theta)) \mathrm{d} \theta \\
& =\frac{1}{2 \pi} \int_{\partial B(0, R)}\left(V \cdot n+i V^{\perp} \cdot n\right) \mathrm{d} \sigma
\end{aligned}
$$

$n$ beeing the outer normal vector to $B(0, R)$ (or equivalently the inner normal vector to $\left.B(0, R)^{c}\right)$ and $\sigma$ its unit measure. Thus by Stokes theorem,

$$
\begin{aligned}
a_{1} & =\frac{1}{2 \pi} \int_{B(0, R)} \operatorname{div}(V)+\frac{i}{2 \pi} \int_{B(0, R)} \operatorname{div}\left(V^{\perp}\right) \\
& =-\frac{i}{2 \pi} \int_{\mathbb{R}^{2}} \operatorname{curl}(V) \\
& =-\frac{i}{2 \pi} \int_{\mathbb{R}^{2}} \mu
\end{aligned}
$$

Finally, we get

$$
\begin{aligned}
V_{1}+i V_{2} & =\frac{i}{2 \pi}\left(\int \mu\right) \frac{1}{\bar{z}}+O\left(|z|^{-2}\right) \\
& =\frac{1}{2 \pi}\left(\int \mu\right) i \frac{z}{|z|^{2}}+O\left(|z|^{-2}\right)
\end{aligned}
$$

which gives us the fifth claim.
Now let us assume $\int \mu=0$ and bound the $L^{2}$ norm of $V$. Let $\psi=g * \mu$, then by the fifth point of the inequality, $W$ is holomorphic in $B(0, R)^{c}$ and has a holomorphic primitive. Thus we get $\psi(x)=D+O\left(|x|^{-1}\right)$ and for $A$ big enough,

$$
\begin{aligned}
\left|\int_{\partial B(0, A)} V \psi\right| & \leqslant C\|V\|_{L^{\infty}(\partial B(0, A))}\|\psi\|_{L^{\infty}(\partial B(0, A))} 2 \pi A \\
& \leqslant \frac{C D}{A} \underset{A \rightarrow+\infty}{\longrightarrow} 0 .
\end{aligned}
$$

This fact allows us to compute the following integral by parts:

$$
\begin{aligned}
\int|V|^{2} & =\int \nabla \psi \cdot \nabla \psi \\
& =-\int \psi \Delta \psi
\end{aligned}
$$

$$
\begin{aligned}
& =\int \psi \mu \\
& \leqslant\|\psi\|_{L^{\infty}(\operatorname{supp}(\mu))}\|\mu\|_{L^{1}} \\
& \leqslant C R[\mu]\|\mu\|_{L^{2}}\|\psi\|_{L^{\infty}(\operatorname{supp}(\mu))} .
\end{aligned}
$$

Now if $x \in B(0, R[\mu])$, we have

$$
\begin{aligned}

\leqslant & C\left(-\int_{B(x, 1)} \ln (x-y) \| \mu(y) \mid \mathrm{d} y\right. \\
& \left.+\int_{B(0, R[\mu])}(2 R[\mu])|\mu(y)| \mathrm{d} y\right) \\
\leqslant & C\left(1+R[\mu]^{2}\right)\|\mu\|_{L^{2}} .
\end{aligned}
$$

Thus

which is the sixth claim of our proposition.
Now we prove the uniform bounds we need on $f$ and $\bar{V}$ :

\leqslant & \|\nabla g * h\|_{L_{T}^{\infty} L^{2}}+\left\|\nabla^{2} g * h\right\|_{L_{T}^{\infty} H^{s}}+\|(\bar{V} \cdot \nabla) \bar{V}\|_{L_{T}^{\infty} H^{s+1}} \\
\leqslant & C\left(R_{T}[h]+R_{T}[h]^{3}\right)^{\frac{1}{2}}\|h\|_{L_{T}^{\infty} L^{2}}+C\|h\|_{L_{T}^{\infty} H^{s}} \\
& +C\left(1+R_{T}[\chi]\right)\left|\int \rho_{0}+\omega_{0}\right|^{2}\|\chi\|_{L_{T}^{\infty} H^{s+1}}^{2} \\
\leqslant & C\left(R_{0}, M_{0}\right)
\end{aligned}
$$

where we used Claims (4) and (5) of Proposition 2.6 and Calderón-Zygmund inequality.

Now let us justifiy that $f \in \mathcal{C}_{T} H^{s}$. If $t_{1}, t_{2} \in[0, T]$, we have

& +\left\|\nabla^{2} g *\left(\rho\left(t_{1}\right)+\omega\left(t_{1}\right)-\rho\left(t_{2}\right)-\omega\left(t_{2}\right)\right)\right\|_{H^{s-1}} \\
\leqslant & C\left(R_{T}[\rho+\omega]+R_{T}[\rho+\omega]^{3}\right)^{\frac{1}{2}} \\
& \times\left\|\rho\left(t_{1}\right)+\omega\left(t_{1}\right)-\rho\left(t_{2}\right)-\omega\left(t_{2}\right)\right\|_{L^{2}} \\
& +C\left\|\rho\left(t_{1}\right)+\omega\left(t_{1}\right)-\rho\left(t_{2}\right)-\omega\left(t_{2}\right)\right\|_{H^{s-1}}
\end{aligned}
$$

where we used points (6) and (2) of Proposition 2.6 and $f \in \mathcal{C}_{T} H^{s}$ follows from $\rho, \omega \in \mathcal{C}_{T} H^{s-1}$.
2.2. Pressureless Euler equations. In this subsection we prove that there is a unique solution to the following equation

Following the idea of 32, 38], we start by fixing $u \in \mathcal{C}_{T} H^{s+1}$ and solving the linearized equation:

If $s$ is an integer such that $s \geqslant 3, u \in \mathcal{C}_{T} H^{s+1}, \widetilde{u}_{0} \in H^{s+1}$, $\mu$ with compact support and $\widetilde{f} \in L_{T}^{1} H^{s+1} \cap \mathcal{C}_{T} H^{s}$, then (2.7) has a solution $\widetilde{u} \in \mathcal{C}_{T} H^{s+1} \cap \mathcal{C}_{T}^{1} H^{s}$, unique in the space $\mathcal{C}_{T} H^{1} \cap \mathcal{C}_{T}^{1} L^{2}$. Moreover, we have the following estimates:

& \left\|\partial_{t} \widetilde{u}(t)\right\|_{H^{s}} \leqslant C\left(\|\widetilde{f}(t)\|_{H^{s}}+\left(\|u\|_{L_{T}^{\infty} H^{s+1}}+\|\bar{V}\|_{L_{T}^{\infty} H_{\mathrm{ul}}^{s+2}}+1\right)\|\widetilde{u}(t)\|_{H^{s+1}}\right) .
\end{aligned}

Proof. The proof is a direct application of Theorem 1 of [32] which gives the well-posedness result and the estimates: We can rewrite (2.7) as

To apply the theorem we need to prove the following:
(1) $A_{i} \in C_{T} L_{\text {ul }}^{2}$ for $1 \leqslant i \leqslant 3$
(2) $\forall t \in[0, T]\left\|A_{i}(t)\right\|_{s+1, \mathrm{ul}} \leqslant K$ for $1 \leqslant i \leqslant 3$
(3) $A_{1}$ and $A_{2}$ symmetric
(4) $\widetilde{f} \in L_{T}^{1} H^{s+1} \cap C_{T} H^{s}$
(5) $\widetilde{u}_{0} \in H^{s+1}$
where $K=\|\bar{V}\|_{L_{T}^{\infty} H_{\mathrm{ul}}^{s+2}}+\|u\|_{L_{T}^{\infty} H_{\mathrm{ul}}^{s+1}}+C$. The three last points are automatically checked by the assumptions of the theorem. For the first point and the second point, since $u$ is in $\mathcal{C}_{T} H^{s+1}$, we only need to prove that $\bar{V}$ is in $H_{\mathrm{ul}}^{s+2}$, which is given by Corollary 2.7.

As in [32] and [38] we will use the previous estimates to apply a fixed point theorem $u \mapsto \widetilde{u}$ on Equation (2.7) to prove the well-posedness of the non-linear equation (2.6). Let us first recall that we have fixed $u_{0} \in H^{s+1}$, $(\omega, \rho) \in X_{T}$ (where $X_{T}$ is defined in 2.2) and

(1) There exists $T^{*}=T^{*}\left(M_{0}, R_{0}\right) \leqslant T$ such that if $T_{1} \leqslant T^{*}$, there is a unique solution $u \in C_{T_{1}} H^{s+1} \cap C_{T_{1}}^{1} H^{s}$ to (2.6), with

where $\widetilde{L}$ depends only on $M_{0}$ and $R_{0}$ and $c$ are constants to be fixed later on. Let $u \in \widetilde{X}_{T_{1}}$ and $\widetilde{u}$ be the solution of (2.7) associated to $u$. By Theorem 2.8, for $t \leqslant T_{1}$, we have:

Thus for all $T_{1} \leqslant T^{*}$ we have built a map $\Phi: \widetilde{X}_{T_{1}} \longrightarrow \widetilde{X}_{T_{1}}$ such that $\Phi(u)=\widetilde{u}$, where $T^{*}=T^{*}\left(M_{0}, R_{0}\right)$. We will now show that $\Phi$ is a contraction for the induced distance on $X_{T_{1}}$. Let $u$ and $w$ be two elements of $X_{T_{1}}$ and set $U=u-w$. Then $\widetilde{U}=\widetilde{u}-\widetilde{w}$ satisfies:

& \leqslant 4 c M_{0} T_{1} e^{c T_{1}\left(C\left(M_{0}, R_{0}\right)+2 M_{0}+1\right)}\|U\|_{L_{T_{1}}^{\infty} L^{2}}
\end{aligned}
$$

using 2.7 in the last inequality. Thus $\Phi$ is a contraction if $T$ is small enough, so since $\widetilde{X}_{T_{1}}$ is complete (this can be proved in the same way as the closedness of $X_{T}$ which is proved in the beginning of section (2.4), it has a unique fixed point in $\widetilde{X}_{T_{1}}$, thus (2.6) has a unique solution for short time. Remark that the solution we find belongs to the space $L_{T_{1}}^{\infty} H^{s+1} \cap W_{T_{1}}^{1, \infty} H^{s}$. Let us justify that it also belongs to $\mathcal{C}_{T_{1}} H^{s+1} \cap \mathcal{C}_{T_{1}}^{1} H^{s}$ :

Let $\varepsilon>0, t_{1}, t_{2} \in\left[0, T_{1}\right]$ and $\chi_{n}$ be a mollifier. We have:

if $n$ is big enough (see for example Theorem 4.22 of [9]). Thus since $u \in$ $\mathcal{C}_{T_{1}} L^{2}$, if $\left|t_{1}-t_{2}\right|$ is small enough,

Now let us prove the second point of our theorem: Let $u$ and $u^{\prime}$ be two solutions associated to $f_{1}$ and $f_{2}$ defined on $\left[0, T_{1}\right]$ with $T_{1} \leqslant T^{*}\left(M_{0}, R_{0}\right)$. Then $U=u-u^{\prime}$ verifies:

Then by Theorem 1 of [32], for any $0 \leqslant r \leqslant s$ we have:

& \leqslant C e^{c\left(C\left(M_{0}, R_{0}\right)+M_{0}+1\right) T_{1}}\left\|V-V^{\prime}\right\|_{L_{T_{1}}^{1} H^{r}}
\end{aligned}
$$

where we used 2.7 in the last inequality.
2.3. Continuity equations. In this subsection we still fix $s \geqslant 3, u \in$ $C_{T} H^{s+1} \cap C_{T}^{1} H^{s},(\rho, \omega) \in\left(C_{T} H^{s}\right)^{2}, V=-\nabla^{\perp} g *(\rho+\omega), \chi$ smooth with compact support such that $\int \chi=1, \bar{V}=-\left(\int \omega_{0}+\rho_{0}\right) \nabla^{\perp} g * \chi, v=u+\bar{V}$ and we consider the following continuity equations:

Theorem 2.10. Let $u, \rho, \omega$ be as in the upper paragraph, there exists a solution $(\widetilde{\rho}, \widetilde{\omega}) \in \mathcal{C}_{T} H^{s} \cap C_{T}^{1} H^{s-1}$ of (2.8), unique in $C_{T} L^{2}$. Moreover, we have the following estimates:

\|\widetilde{\omega}\|_{L_{T}^{\infty} H^{s}} & \leqslant\left\|\omega_{0}\right\| e^{c T\|\nabla V\|_{L_{T}^{\infty} H^{s}}} \\
\left\|\partial_{t} \widetilde{\omega}\right\|_{L_{T}^{\infty} H^{s-1}} & \leqslant C\left(1+\sqrt{R_{T}[\rho+\omega]}\right)\|\rho+\omega\|_{L_{T}^{\infty} H^{s}}\|\widetilde{\omega}\|_{L_{T}^{\infty} H^{s}} \\
\left\|\partial_{t} \widetilde{\rho}\right\|_{L_{T}^{\infty} H^{s-1}} & \leqslant C\left(\left|\int\left(\rho_{0}+\omega_{0}\right)\right|+\|u\|_{L_{T}^{\infty} H^{s+1}}\right)\|\widetilde{\rho}\|_{L_{T}^{\infty} H^{s}} .
\end{aligned}

Now let $\widetilde{\rho}_{1}$ and $\widetilde{\rho}_{2}$ be two solutions associated to two velocity fields $v_{1}=$ $u_{1}+\bar{V}$ and $v_{2}=u_{2}+\bar{V}$ with same initial conditions, and $\widetilde{\omega}_{1}$ and $\widetilde{\omega}_{2}$ be two solutions associated to two velocity fields $V_{1}$ and $V_{2}$ with same initial conditions, then we have the following estimates:

\left\|\widetilde{\omega}_{1}-\widetilde{\omega}_{2}\right\|_{L_{T}^{\infty} L^{2}} \leqslant C T\left\|V_{1}-V_{2}\right\|_{L_{T}^{\infty} L^{2}}\left\|\widetilde{\omega}_{2}\right\|_{L_{T}^{\infty} H^{3}} \\
\left\|\widetilde{\rho}_{1}-\widetilde{\rho}_{2}\right\|_{L_{T}^{\infty} L^{2}} \leqslant C T\left\|\widetilde{\rho}_{2}\right\|_{L_{T}^{\infty} H^{3}}\left\|v_{2}-v_{1}\right\|_{L_{T}^{\infty} H^{1}} e^{c T\left\|u_{1}\right\|_{L_{T}^{\infty} H^{3}}} .
\end{gathered}

We will also give a general lemma to control the support of a compactly supported solution of a continuity equation:
Lemma 2.11. If $\mu$ is the solution of the following continuity equation,

Proof of Theorem 2.10, Let us know use the previous lemma to prove the $H^{s}$ bound on $\widetilde{\omega}$. Let $\alpha$ be a multi-index such that $|\alpha| \leqslant s$. Then, since $V$ is divergent-free,

& \leqslant\|\nabla V\|_{H^{s}}\|\widetilde{\omega}\|_{H^{s}} .
\end{aligned}

If $\left|\alpha_{1}\right|=s$, then $\alpha_{2}=0$, thus

\end{aligned}
$$

Thus

\left\|\partial^{\alpha} \widetilde{\rho}(t)\right\|_{L^{2}} \leqslant & \left(\left\|\partial^{\alpha} \widetilde{\rho}_{0}\right\|_{L^{2}}\right. \\
& \left.+c \int_{0}^{t}\|\nabla v(\tau)\|_{H^{s}}\|\widetilde{\rho}(\tau)\|_{H^{s}} \mathrm{~d} \tau\right) e^{c \int_{0}^{T}\|\operatorname{div}(v)\|_{L^{\infty}}(\tau) \mathrm{d} \tau} .
\end{aligned}
$$

Summing over all indices $\alpha$, we get

& \leqslant\left(\left\|\widetilde{\rho}_{0}\right\|_{H^{s}}+c \int_{0}^{t}\|\nabla v(\tau)\|_{H^{s}}\|\widetilde{\rho}(\tau)\|_{H^{s}} \mathrm{~d} \tau\right) e^{c \int_{0}^{T}\|u(\tau)\|_{H^{s}} \mathrm{~d} \tau}
\end{aligned}
$$

because $\operatorname{div}(v)=\operatorname{div}(u)$. The corresponding estimate follows by Grönwall's lemma.

Now let us bound the time derivatives of $\widetilde{\omega}$ and $\widetilde{\rho}$. Take $\alpha$ a multi-index with $|\alpha| \leqslant s-1$, then

& \leqslant C\left(\|V\|_{L^{\infty}}+\|\nabla V\|_{H^{s}}\right)\|\widetilde{\omega}\|_{H^{s}} .
\end{aligned}
$$

Now by Proposition 2.6,

\end{aligned}

We do the same estimates for every term composing $\partial^{\alpha}(\operatorname{div}(u) \widetilde{\rho})$, except for

& \leqslant C\left|\int\left(\rho_{0}+\omega_{0}\right)\right|\left\|\partial^{\alpha_{1}} \nabla g * \chi\right\|_{L^{\infty}}\|\widetilde{\rho}\|_{H^{s}} \\
& \leqslant C\left|\int\left(\rho_{0}+\omega_{0}\right)\right|\|\widetilde{\rho}\|_{H^{s}}
\end{aligned}
$$

by Proposition 2.6. Thus we have the estimate we wanted to prove.
Now let us prove the last point of our theorem. Substracting the two continuity equations followed by $\widetilde{\omega}_{1}$ and $\widetilde{\omega}_{2}$, we have

Thus by (2.10),

& \leqslant C T\left\|\widetilde{\rho}_{2}\right\|_{L_{T}^{\infty} H^{3}}\left\|v_{2}-v_{1}\right\|_{L_{T}^{\infty} H^{1}} e^{c T\left\|u_{1}\right\|_{L_{T}^{\infty} H^{3}}}
\end{aligned}
$$

because $\operatorname{div}\left(v_{1}\right)=\operatorname{div}\left(u_{1}\right)$.
Now let us prove lemma 2.11)
Proof of Lemma 2.11. Solving the continuity equation by characteristics, we see that

2.4. Monokinetic spray System. In this section we prove the well-posedness result of system (1.4), that is Theorem 2.1:

& \forall t \in[0, T], \int(\rho(t)+\omega(t))=\int\left(\rho_{0}+\omega_{0}\right), \\
& \forall t, t^{\prime} \in[0, T],\left\|\rho(t)-\rho\left(t^{\prime}\right)\right\|_{H^{s-1}} \leqslant L\left|t-t^{\prime}\right|, \\
& \left.\left\|\omega(t)-\omega\left(t^{\prime}\right)\right\|_{H^{s-1}} \leqslant L\left|t-t^{\prime}\right|\right\}
\end{aligned}
$$

with $L>0$ that we will fix later on. Let us justify that $X_{T}$ is the complete metric space for the distance

It is sufficient to prove that $X_{T}$ is closed in $\left(L_{T}^{\infty} L^{2}\right)^{2}$. Let us consider a sequence of functions $\left(\rho_{N}, \omega_{N}\right)$ in $X_{T}$ and $(\rho, \omega) \in\left(L_{T}^{\infty} L^{2}\right)^{2}$ such that

\begin{align*}
\omega(0) & =\omega_{0} \\
\rho(0) & =\rho_{0} . \tag{2.14}
\end{align*}

Moreover for all $t \in[0, T]$,

\int \mathbf{1}_{B\left(0,2 R_{0}\right)}\left(\rho_{N}^{2}(t)+\omega_{N}^{2}(t)\right) \underset{N \rightarrow+\infty}{\longrightarrow} \int \mathbf{1}_{B\left(0,2 R_{0}\right)}\left(\rho^{2}(t)+\omega^{2}(t)\right)=0
$$

by strong convergence in $L^{2}$. Thus $\rho$ and $\omega$ have compact support and

Finally, compact support and convergence in $L^{2}$ implies convergence in $L^{1}$ so we get that for every $t \in[0, T]$,

Inequalities (2.11), (2.12), (2.13), (2.14), (2.15) and (2.16) gives us that $(\rho, \omega) \in X_{T}$, so $X_{T}$ is closed in $L_{T}^{\infty} L^{2}$.
Now let us build a contraction $X_{T} \longrightarrow X_{T}$. For $(\rho, \omega) \in X_{T}$ fixed, we have defined

- $V=-\nabla^{\perp} g *(\rho+\omega)$
- $\bar{V}=-\left(\int \rho_{0}+\omega_{0}\right) \nabla^{\perp} g * \chi$
- $f=(V-\bar{V})^{\perp}-(\bar{V} \cdot \nabla) \bar{V}$.

By Corollary [2.7, $f \in L_{T}^{\infty} H^{s+1} \cap \mathcal{C}_{T} H^{s}$. Let $T_{1}$ be sufficiently small so that Theorem 2.9 can be applied and $u$ be the solution of (2.6) given by this theorem, $v=u+\bar{V}$, and $(\widetilde{\rho}, \widetilde{\omega})$ be the solution of (2.8) given by Theorem 2.10 According to Theorem [2.9, the smallness of $T_{1}$ depends on $M_{0}$ and $R_{0}$. Now let us justify that for small enough $T_{2} \leqslant T_{1}$, we have $(\widetilde{\rho}, \widetilde{\omega}) \in X_{T_{2}}$. By Theorem 2.9, we have the following estimates:

Remark that

by Proposition [2.6. Moreover by Proposition 2.6 and Theorem 2.9,

Now, by Lemma 2.11 and point (3) of Proposition [2.6, if $0 \leqslant t \leqslant T_{2}$ we have

& \leqslant 2 R_{0}
\end{aligned}

if $T_{2}$ is small enough with respect to $R_{0}$ and $M_{0}$. By Theorem 2.10, we have:

\left\|\partial_{t} \widetilde{\rho}\right\|_{L_{T_{2}}^{\infty} H^{s-1}} & \leqslant C\left(\left|\int \rho_{0}+\omega_{0}\right|+\|u\|_{L_{T_{2}^{2}} H^{s+1}}\right)\|\widetilde{\rho}\|_{L_{T_{2}}^{\infty} H^{s}} \\
& \leqslant C\left(2 R_{0} M_{0}+2 M_{0}\right) 2 M_{0} .
\end{aligned}
$$

Choosing $L$ large enough (with respect to $M_{0}$ and $R_{0}$ ), we have

Thus we have built a map $\Phi:(\rho, \omega) \mapsto(\widetilde{\rho}, \widetilde{\omega})$ such that $\Phi\left(X_{T_{2}}\right) \subset X_{T_{2}}$. We will now prove that $\Phi$ is a contraction for the $L_{T_{2}}^{\infty} L^{2}$ norm.

Let $\left(\rho_{1}, \omega_{1}\right),\left(\rho_{2}, \omega_{2}\right) \in X_{T_{2}},\left(\widetilde{\rho}_{1}, \widetilde{\omega}_{1}\right)=\Phi\left(\rho_{1}, \omega_{1}\right)$ and $\left(\widetilde{\rho}_{2}, \widetilde{\omega}_{2}\right)=\Phi\left(\rho_{2}, \omega_{2}\right)$. By Theorem [2.10, we have

\end{aligned}

\begin{aligned}
& +2 C T_{2} M_{0} e^{2 c T_{2} M_{0}} C e^{C\left(M_{0}, R_{0}\right) T_{2}}\left\|V_{1}-V_{2}\right\|_{L_{T_{2}}^{\infty} H^{1}} \\
\leqslant & C\left(M_{0}, R_{0}, T\right) T_{2}\left\|V_{1}-V_{2}\right\|_{L_{T_{2}}^{\infty} H^{1}}
\end{aligned}
$$

for any $T_{2} \leqslant T_{1} \leqslant T$. Moreover,

\end{aligned}

by Claims (2) and (6) of Proposition 2.6. Thus $\Phi$ is a contraction if $T_{2}$ is small enough (with respect to $M_{0}$ and $R_{0}$ ), so it has a unique fixed point $(\rho, \omega) \in X_{T_{2}}$.

## 3. Mean-field limit

In this section we prove Theorem 1.6, Proposition 1.7 and Proposition 1.10. Let us begin by proving Theorem 1.6.
3.1. Proof of Theorem 1.6. We want to compute the derivative of the functional $\mathcal{H}_{N}=T_{1}+T_{2}+T_{3}+T_{4}+T_{5}+T_{6}$ defined in (1.10). We will denote $\alpha=\omega+\rho$ and $\alpha_{N}=\omega_{N}+\rho_{N}$.

& T_{5}=\left\|\omega(t)-\omega_{N}(t)\right\|_{L^{2}}^{2} \\
& T_{6}=\frac{B_{N}}{N}+\frac{\ln (N)}{2 N} .

Claim: For every $t \in[0, T]$, we have

& +2 \iint_{\mathbb{R}^{2} \times \mathbb{R}^{2} \backslash \Delta} v(t, x) \cdot \nabla g(x-y) \rho_{N}(t, \mathrm{~d} x)\left(\alpha_{N}-\alpha\right)(t, \mathrm{~d} y) \\
= & T_{1,1}+T_{1,2}+T_{1,3} .

& +\frac{2}{N} \sum_{i=1}^{N}\left(v\left(q_{i}\right)-p_{i}\right) \cdot\left(\nabla g *\left(\omega_{N}-\alpha\right)\left(q_{i}\right)+\frac{1}{N} \sum_{\substack{i=1 \\
j \neq i}}^{N} \nabla g\left(q_{i}-q_{j}\right)\right) \\
& =-\frac{2}{N} \sum_{i=1}^{N} \nabla v\left(q_{i}\right):\left(v\left(q_{i}\right)-p_{i}\right)^{\otimes 2} \\
& -\frac{2}{N} \sum_{i=1}^{N} p_{i} \cdot\left(\frac{1}{N} \sum_{\substack{i=1 \\
j \neq i}}^{N} \nabla g\left(q_{i}-q_{j}\right)+\nabla g *\left(\omega_{N}-\alpha\right)\left(q_{i}\right)\right) \\
& +\frac{2}{N} \sum_{i=1}^{N} v\left(q_{i}\right) \cdot\left(\frac{1}{N} \sum_{\substack{i=1 \\

In the incoming computations, we will only find terms which look like $T_{1,2}$, that is, terms depending on $p_{i}$ (which will cancel out) or like $T_{1,3}$, that
is terms of the form:

We will finish our computations grouping all terms corresponding to the same vector field $A$. Let us now compute the time derivative of $T_{2}$. Notice that the energy

- $\left|\nabla g_{\eta}(x)\right| \leqslant \frac{C}{|x|}$.
- $g_{\eta}(-x)=g_{\eta}(x)$
- $\nabla g_{\eta}(-x)=-\nabla g_{\eta}(x)$

For $0 \leqslant s, t \leqslant T$ and $0<\eta<1$, we have

(3.4) $T_{3}(t)-T_{3}(s)=\lim _{\eta \rightarrow 0} \iint g_{\eta}(x-y)(\alpha(t, x) \alpha(t, y)-\alpha(s, x) \alpha(s, y)) \mathrm{d} x \mathrm{~d} y$.

Since $g_{\eta}$ is smooth and $\alpha$ has compact support, we have by (1.8) that

Since $(\rho v+\omega V) * \nabla g_{\eta} \in L^{\infty}\left([0, T], \mathcal{C}^{1}\left(\mathbb{R}^{2}, \mathbb{R}\right)\right)$, we get from the upper equation that $g_{\eta} * \alpha \in W^{1, \infty}\left([0, T], \mathcal{C}^{1}\left(\mathbb{R}^{2}, \mathbb{R}\right)\right)$ and that for almost every $t \in[0, T]$,

& \iint\left|\nabla g_{\eta}(x-y) \cdot(\rho v+\omega V)(\tau, x) \alpha(\tau, y)\right| \mathrm{d} x \mathrm{~d} y \\
& \left.\quad \leqslant \iint \frac{1}{|x-y|}|(\rho v+\omega V)(\tau, x)| \alpha(\tau, y) \right\rvert\, \mathrm{d} x \mathrm{~d} y \\
& \quad \leqslant\|\rho v+\omega V\|_{L_{T}^{\infty} L^{1}} \sup _{\tau \in[0, T] x \in \mathbb{R}^{2}} \int \frac{|\alpha(\tau, y)|}{|x-y|} \mathrm{d} y \\
& \quad \leqslant\left(\|\rho\|_{L_{T}^{\infty} L^{1}}\|v\|_{L_{T}^{\infty} L^{\infty}}+\|\omega\|_{L_{T}^{\infty} L^{1}}\|V\|_{L_{T}^{\infty} L^{\infty}}\right) R_{T}[\alpha]\|\alpha\|_{L_{T}^{\infty} L^{\infty}}
\end{aligned}
$$

where the last inequality follows from the proof of Claim (3) of 2.6. Thus by dominated convergence theorem,

= & T_{4,1}+T_{4,2}+T_{4,3} .
\end{align*}

Proof of Claim 3.5. Recall that

Using $g_{\eta}$ in the same way we did for the previous claim, one can prove that $T_{4}$ is $W^{1, \infty}$ and that for almost every $t \in(0, T)$,

\end{aligned}

Let us compute each term. For the second term in $A_{1}$, remark that:

& =\iint\left(-\int \nabla^{\perp} g(y-x) \alpha(t, x) \mathrm{d} x\right) \cdot \nabla g(y-z) \omega_{N}(t, y) \mathrm{d} y \mathrm{~d} \alpha_{N}(t, z) \\
& =\iint V(t, y) \cdot \nabla g(y-z) \omega_{N}(t, y) \mathrm{d} y \mathrm{~d} \alpha_{N}(t, z) \\
& =\iint V(t, x) \cdot \nabla g(x-y) \omega_{N}(t, x) \mathrm{d} x \mathrm{~d} \alpha_{N}(t, y)
\end{aligned}
$$

It follows that

= & T_{4,1}+T_{4,2}
\end{aligned}

For the second term:

& =-\frac{2}{N} \sum_{i=1}^{N} p_{i} \cdot \nabla g * \alpha\left(q_{i}\right) \\
& =T_{4,3}
\end{aligned}

We now need to differentiate the last term with respect to time.
Claim: For almost every $t \in[0, T]$ we have:

\end{aligned}

= & 2 \int\left(\omega-\omega_{N}^{\eta}\right) \operatorname{div}\left(\omega\left(V-V_{N}\right)+\left(\omega-\omega_{N}^{\eta}\right) V_{N}\right) \\
& +2 \int\left(\omega-\omega_{N}^{\eta}\right) \operatorname{div}\left(\omega_{N}^{\eta} V_{N}-\chi_{\eta} *\left(\omega_{N} V_{N}\right)\right) \\
= & 2 \int\left(\omega-\omega_{N}^{\eta}\right) \nabla \omega \cdot\left(V-V_{N}\right)
\end{aligned}
$$

$$
\begin{aligned}
& +2 \int\left(\omega-\omega_{N}^{\eta}\right) \nabla\left(\omega-\omega_{N}^{\eta}\right) \cdot V_{N} \\
& +2 \int \omega \operatorname{div}\left(\omega_{N}^{\eta} V_{N}-\chi_{\eta} *\left(\omega_{N} V_{N}\right)\right) \\
& -2 \int \omega_{N}^{\eta} \operatorname{div}\left(\omega_{N}^{\eta} V_{N}-\chi_{\eta} *\left(\omega_{N} V_{N}\right)\right)
\end{aligned}

For the first term, remark that for any $1<p<+\infty$, we have $V_{N} \in L_{\mathrm{loc}}^{p}$ and $\omega_{N}^{\eta} \underset{\eta \rightarrow 0}{\longrightarrow} \omega_{N}$ in $L^{q}$ where $\frac{1}{p}+\frac{1}{q}=1$. Thus since $\omega-\omega_{N}$ has compact support and $\nabla \omega \in L^{\infty}$, we have

&= 2 \iint_{\mathbb{R}^{2} \times \mathbb{R}^{2} \backslash \Delta} v(t, x) \cdot \nabla g(x-y) \mathrm{d}\left(\alpha-\alpha_{N}\right)(t, x) \mathrm{d}\left(\alpha-\alpha_{N}\right)(t, y) \\
& \quad-2 \iint_{\mathbb{R}^{2} \times \mathbb{R}^{2} \backslash \Delta} v(t, x) \cdot \nabla g(x-y)\left(\omega-\omega_{N}\right)(t, x) \mathrm{d} x \mathrm{~d}\left(\alpha-\alpha_{N}\right)(t, y) \\
&=\iint_{\mathbb{R}^{2} \times \mathbb{R}^{2} \backslash \Delta}(v(t, x)-v(t, y)) \cdot \nabla g(x-y) \mathrm{d}\left(\alpha-\alpha_{N}\right)(t, x) \mathrm{d}\left(\alpha-\alpha_{N}\right)(t, y) \\
& \quad+2 \int v^{\perp}(t, x) \cdot\left(V-V_{N}\right)(t, x)\left(\omega-\omega_{N}\right)(t, x) \mathrm{d} x

because

& 2 \iint_{\mathbb{R}^{2} \times \mathbb{R}^{2} \backslash \Delta} v(t, x) \cdot \nabla g(x-y) \mathrm{d}\left(\alpha-\alpha_{N}\right)(t, x) \mathrm{d}\left(\alpha-\alpha_{N}\right)(t, y) \\
& \quad=\iint_{\mathbb{R}^{2} \times \mathbb{R}^{2} \backslash \Delta} v(t, x) \cdot \nabla g(x-y) \mathrm{d}\left(\alpha-\alpha_{N}\right)(t, x) \mathrm{d}\left(\alpha-\alpha_{N}\right)(t, y) \\
& \quad+\iint_{\mathbb{R}^{2} \times \mathbb{R}^{2} \backslash \Delta} v(t, y) \cdot \nabla g(y-x) \mathrm{d}\left(\alpha-\alpha_{N}\right)(t, y) \mathrm{d}\left(\alpha-\alpha_{N}\right)(t, x) \\

= & R_{1}+R_{2}+R_{3}

with $A=2\left(v^{\perp}-V^{\perp}-\nabla \omega\right)$. In order to control $R_{3}$, we will need the following result:

since $V$ and $V_{N}$ are divergent free, thus by 1.11

where $C$ is independant of $N$. Now, by Calderón-Zygmund inequality,

& +C\|\nabla v\|_{L^{\infty}}\left(1+\left\|\mu_{N}\right\|_{L^{\infty}}\right) N^{-\frac{1}{2}}
\end{align*}

Now using Lemma 3.1, since $V, v$ and $\nabla \omega$ are in $L^{\infty}$,

\begin{equation*}
R_{3} \leqslant C\left(\mathcal{F}\left(\omega+\rho-\omega_{N}, Q_{N}\right)+\left\|\omega-\omega_{N}\right\|_{L^{2}}^{2}+\frac{\ln (N)}{N}+N^{-\frac{\lambda}{2}}\right) \tag{3.10}
\end{equation*}
$$

Combining inequalities 3.8, 3.9 and 3.10,

$$
\begin{aligned}
\frac{\mathrm{d} \mathcal{H}_{N}}{\mathrm{~d} t} \leqslant & C\left(\frac{1}{N} \sum_{i=1}^{N}\left|v\left(q_{i}\right)-p_{i}\right|^{2}+\left\|\omega-\omega_{N}\right\|_{L^{2}}^{2}\right. \\
& \left.+\mathcal{F}\left(\omega+\rho-\omega_{N}, Q_{N}\right)+N^{-\beta}\right)
\end{aligned}
$$

with $\beta=\min \left(\frac{1}{3}, \frac{\lambda}{2}\right)$. Applying Grönwall's lemma we get

$$
\mathcal{H}_{N}(t) \leqslant\left(\mathcal{H}_{N}(0)+C N^{-\beta}\right) e^{C T}
$$

that is Inequality (1.14).
3.2. Proof of Proposition 1.7. Let $\varphi$ be a smooth test function with compact support in $\mathbb{R}^{4}$. We have:

$$
\begin{aligned}
& \int \varphi(x, \xi)\left(\frac{1}{N} \sum_{i=1}^{N} \delta_{\left(q_{i}, p_{i}\right)}-\rho \otimes \delta_{\xi=v(x)}\right)(\mathrm{d} x \mathrm{~d} \xi) \\
= & \frac{1}{N} \sum_{i=1}^{N}\left[\varphi\left(q_{i}, p_{i}\right)-\varphi\left(q_{i}, v\left(q_{i}\right)\right)\right] \\
& +\frac{1}{N} \sum_{i=1}^{N} \varphi\left(q_{i}, v\left(q_{i}\right)\right)-\int \varphi(x, v(x)) \rho(x) \mathrm{d} x \\
= & T_{1}+T_{2} .
\end{aligned}
$$

Let us bound $T_{1}$ :

$$
\left|T_{1}\right| \leqslant \frac{1}{N} \sum_{i=1}^{N}\left\|\varphi\left(q_{i}, \cdot\right)\right\|_{W^{1, \infty}}\left|p_{i}-v\left(q_{i}\right)\right| .
$$

By Cauchy-Schwarz inequality:

$$
\begin{equation*}
\left|T_{1}\right| \leqslant C\|\varphi\|_{W^{1, \infty}}\left(\frac{1}{N} \sum_{i=1}^{N}\left|p_{i}-v\left(q_{i}\right)\right|^{2}\right)^{\frac{1}{2}} \tag{3.11}
\end{equation*}
$$

For the second term:

$$
\begin{aligned}
\left|T_{2}\right| & =\left|\int \varphi(x, v(x))\left(\rho-\rho_{N}\right)(\mathrm{d} x)\right| \\
& \leqslant\left\|\varphi \circ\left(I_{d}, v\right)\right\|_{H^{2}}\left\|\rho-\rho_{N}\right\|_{H^{-2}} .
\end{aligned}
$$

Let $f=(\mathrm{Id}, \mathrm{v})$, then

$$
\begin{equation*}
\|\varphi \circ f\|_{H^{2}} \leqslant C\left(1+\|\nabla v\|_{W^{1, \infty}}^{2}\right) \sup _{0 \leqslant k \leqslant 2}\left\|\nabla^{k} \varphi \circ f\right\|_{L^{2}} \tag{3.12}
\end{equation*}
$$

Now let $\psi=\nabla^{k} \varphi$ for some $k \in\{0,1,2\}$, then

$$
\begin{aligned}
\|\psi \circ f\|_{L^{2}}^{2} & =\int|\psi(x, v(t, x))|^{2} \mathrm{~d} x \\
& \leqslant \sup _{y} \int|\psi(x, y)|^{2} \mathrm{~d} x \\
& \leqslant\|F\|_{W^{3,1}}
\end{aligned}
$$

where $F(y)=\int|\psi(x, y)|^{2} \mathrm{~d} x$. Remark that

$$
\begin{aligned}
\left|\partial_{y_{i}} F(y)\right| & =2 \int \partial_{y_{i}} \psi(x, y) \cdot \psi(x, y) \mathrm{d} x \\
& \leqslant \int\left|\partial_{y_{i}} \psi(x, y)\right|^{2} \mathrm{~d} x+\int|\psi(x, y)|^{2} \mathrm{~d} x
\end{aligned}
$$

Doing the same computations for all derivatives of $F$ of order less or equal than three and integrating in $y$ gives us

$$
\|F\|_{W^{3,1}} \leqslant C\|\psi\|_{H^{3}}^{2} .
$$

From (3.12) and the upper equation we get

$$
\begin{equation*}
\|\varphi \circ f\|_{H^{2}} \leqslant C\left(1+\|\nabla v\|_{W^{1, \infty}}^{2}\right)\|\varphi\|_{H^{5}} \tag{3.13}
\end{equation*}
$$

Now,

$$
\begin{aligned}
\left\|\rho-\rho_{N}\right\|_{H^{-2}} & \leqslant\left\|\rho+\omega-\rho_{N}-\omega_{N}\right\|_{H^{-2}}+\left\|\omega-\omega_{N}\right\|_{H^{-2}} \\
& \leqslant C\left\|\omega-\omega_{N}\right\|_{L^{2}}+\left\|\rho+\omega-\rho_{N}-\omega_{N}\right\|_{H^{-2}} .
\end{aligned}
$$

By Proposition 1.5 for any $\xi \in \mathcal{C}^{\infty}$,

$$
\begin{aligned}
\left|\int \xi\left(\rho+\omega-\omega_{N}-\rho_{N}\right)\right| \leqslant & C N^{-\lambda}\|\xi\|_{\mathcal{C}^{0, \theta}} \\
& +C\|\xi\|_{\dot{H}^{1}}\left(\mathcal{F}\left(\omega+\rho-\omega_{N}, Q_{N}\right)+N^{-\lambda}\right.
\end{aligned}
$$

$$
\left.+\left(1+\left\|\rho+\omega-\omega_{N}\right\|_{L^{\infty}}\right) N^{-1}+\frac{\ln N}{N}\right)^{\frac{1}{2}} .
$$

Taking $\theta$ small enough to have $H^{2} \hookrightarrow \mathcal{C}^{0, \theta}$, we get

$$
\begin{align*}
\left\|\rho+\omega-\rho_{N}-\omega_{N}\right\|_{H^{-2}} & \leqslant C\left(\mathcal{F}\left(\omega+\rho-\omega_{N}, Q_{N}\right)+N^{-\lambda}\right.  \tag{3.14}\\
& \left.+\left(1+\left\|\rho+\omega-\omega_{N}\right\|_{L^{\infty}}\right) N^{-1}+\frac{\ln N}{N}\right)^{\frac{1}{2}} .
\end{align*}
$$

Combining inequalities 3.11, 3.13 and 3.14,

$$
\begin{aligned}
\left\lvert\, \int \varphi(x, \xi)\left(\frac{1}{N} \sum_{i=1}^{N} \delta_{\left(q_{i}, p_{i}\right)}-\right.\right. & \left.\rho \otimes \delta_{\xi=v(x)}\right) \mid \leqslant C\left(1+\|\nabla v\|_{W^{1, \infty}}^{2}\right)\|\varphi\|_{H^{5}}\left(\mathcal{H}_{N}\right. \\
& \left.+C\left(1+\|\rho\|_{L^{\infty}}+\|\omega\|_{L^{\infty}}+\left\|\omega_{N}^{0}\right\|_{L^{\infty}}\right) N^{-\beta}\right)^{\frac{1}{2}}
\end{aligned}
$$

for some $\beta>0$. Thus we get (1.15). It follows from this estimate that if $H_{N}^{0} \longrightarrow 0$, then

$$
\begin{gathered}
\omega_{N} \underset{L_{T}^{\infty} L^{2}}{\longrightarrow} \omega \\
\frac{1}{N} \sum_{i=1}^{N} \delta_{\left(q_{i}, p_{i}\right)} \underset{L_{T}^{\infty} H^{-5}}{\longrightarrow} \rho \otimes \delta_{\xi=v(t, x)} .
\end{gathered}
$$

Remark that in equation (3.14) we could have taken $H^{1+\alpha} \hookrightarrow \mathcal{C}^{0, \alpha}$ for any positive $\alpha$, and since $\omega_{N} \longrightarrow \omega$ in $L^{2}$, we get

$$
\rho_{N} \underset{H^{a}}{\longrightarrow} \rho
$$

for any $a<-1$, which concludes the proof of Proposition 1.7
3.3. Proof of Proposition 1.10. We have

$$
\begin{aligned}
\int_{\left(\mathbb{R}^{2} \times \mathbb{R}^{2}\right) \backslash \Delta} & g(x-y)\left(\rho_{0}+\omega_{0}-\rho_{N, 0}-\omega_{N, 0}\right)^{\otimes 2}(\mathrm{~d} x \mathrm{~d} y) \\
= & \mathcal{F}\left(\rho_{0}, Q_{N, 0}\right)+\int_{\left(\mathbb{R}^{2} \times \mathbb{R}^{2}\right) \backslash \Delta} g(x-y)\left(\omega_{0}-\omega_{N, 0}\right)^{\otimes 2}(\mathrm{~d} x \mathrm{~d} y) \\
& -2 \int_{\left(\mathbb{R}^{2} \times \mathbb{R}^{2}\right) \backslash \Delta} g(x-y)\left(\omega_{0}-\omega_{N, 0}\right) \otimes\left(\rho_{0}-\rho_{N, 0}\right)(\mathrm{d} x \mathrm{~d} y)
\end{aligned}
$$

As in section 1.4 of [48] we compute

$$
\begin{aligned}
& \iint g(x-y)\left(\omega_{0}(x)-\omega_{N, 0}(x)\right)\left(\omega_{0}(y)-\omega_{N, 0}(y)\right) \mathrm{d} x \mathrm{~d} y \\
& \quad=\int\left(-\Delta g *\left(\omega_{0}-\omega_{N, 0}\right)\right) g *\left(\omega_{0}-\omega_{N, 0}\right) \\
& \quad=\int\left|\nabla g *\left(\omega_{0}-\omega_{N, 0}\right)\right|^{2} \\
& \quad \leqslant C\left(R\left[\omega_{0}-\omega_{N, 0}\right]+R\left[\omega_{0}-\omega_{N, 0}\right]^{3}\right)^{\frac{1}{2}}\left\|\omega_{0}-\omega_{N, 0}\right\|_{L^{2}}
\end{aligned}
$$

using Claim (6) of Proposition 2.6. Moreover,

$$
\begin{aligned}
& 2 \int_{\left(\mathbb{R}^{2} \times \mathbb{R}^{2}\right) \backslash \Delta} g(x-y)\left(\omega_{0}-\omega_{N, 0}\right) \otimes\left(\rho_{0}-\rho_{N, 0}\right)(\mathrm{d} x \mathrm{~d} y) \\
& =\int g * \rho_{0}(x)\left(\omega_{0}-\omega_{N, 0}\right)(x) \mathrm{d} x-\frac{1}{N} \sum_{i=1}^{N} \int g\left(q_{i}^{0}-x\right)\left(\omega_{0}-\omega_{N, 0}\right)(x) \mathrm{d} x \\
& \leqslant\left\|g * \rho_{0}\right\|_{L^{2}\left(B\left(0, R\left[\omega_{0}-\omega_{N, 0}\right]\right)\right.}\left\|\omega_{0}-\omega_{N, 0}\right\|_{L^{2}} \\
& \quad+\frac{1}{N} \sum_{i=1}^{N}\|g\|_{L^{2}\left(B\left(q_{i}, R\left[\omega_{0}-\omega_{N, 0}\right]\right)\right.}\left\|\omega_{0}-\omega_{N, 0}\right\|_{L^{2}}
\end{aligned}
$$

Thus since $\omega_{N, 0}$ and $q_{1}^{0}, \ldots, q_{N}^{0}$ have compact support uniformly in $N$, if

$$
\begin{aligned}
& \left\|\omega_{N, 0}-\omega_{0}\right\| \underset{N \rightarrow+\infty}{\longrightarrow} 0 \\
& \mathcal{F}\left(\rho_{0}, Q_{N, 0}\right) \underset{N \rightarrow+\infty}{\longrightarrow} 0
\end{aligned}
$$

then

$$
\int_{\left(\mathbb{R}^{2} \times \mathbb{R}^{2}\right) \backslash \Delta} g(x-y)\left(\rho_{0}+\omega_{0}-\rho_{N, 0}-\omega_{N, 0}\right)^{\otimes 2}(\mathrm{~d} x \mathrm{~d} y) \underset{N \rightarrow+\infty}{\longrightarrow} 0
$$

It is proved in Theorem 1.1 of [18] that the convergence of $\mathcal{F}\left(\rho_{0}, Q_{N, 0}\right)$ to zero is ensured by the weak-* convergence of $\rho_{N, 0}$ to $\rho_{0}$ and the convergence of $\frac{1}{N^{2}} \sum_{1 \leqslant i \neq j \leqslant N} g\left(q_{i}^{0}-q_{j}^{0}\right)$ to $\iint g(x-y) \rho_{0}(x) \rho_{0}(y) \mathrm{d} x \mathrm{~d} y$, which ends the proof of Proposition 1.10
