¹ Element-Selective Analysis of Ultrafast Demagnetization in Co/Pt ² Multilayers Exhibiting Large Perpendicular Magnetic Anisotropy

We use time-resolved resonant magnetic scattering experiments to investigate the laser induced demagnetization of 9 Co/Pt multilayers with large perpendicular magnetic anisotropy (PMA). Our pump-probe approach, which relies on ex-10 treme ultraviolet (XUV) pulses obtained via high-harmonic generation (HHG), allows to monitor the temporal evolution 11 of the system in an element-selective fashion and thus to disentangle the contributions from permanent and proximity-12 induced magnetic moments. By analyzing the data gathered at the Co $M_{2,3}$ and Pt O_3 edges, we are able to show that, 13 after femtosecond laser irradiation, both components display a very similar loss of magnetic order, with almost identical 14 demagnetization amplitudes and characteristic times, but a small delay (10-20 fs) of the Pt magnetization quenching 15 with respect to Co. Comparing our experiments with literature results therefore suggests that in these 3d-5d multilayers 16 and alloys, the different constituents remain strongly coupled after optical excitation, no matter whether the thin films 17 possess a preferred in-plane or out-of-plane easy magnetization direction. 18

Multilayer thin films and alloys combining 3d and 4d or 19 5d metals such as Co/Pt, Fe/Pt or Co/Pd have been analyzed 20 for decades because of their remarkable magnetic properties, 21 in particular, their capacity to display a large perpendicular 22 anisotropy¹⁻⁴. Recently, these material systems have gener-23 ated great interest in the field of ultrafast magnetism: They 24 turned out to be well-suited tools to study the flow of ultra-25 fast spin and charge currents^{5–8}, to analyze magnetic domain 26 modifications following femtosecond laser irradiation^{9,10}, or 27 all-optical switching phenomena $^{11-13}$ that might pave the way 28 for the development of future spintronic and data storage ap-29 plications. 30

Surprisingly, the sublattice-specific magnetization dynam-31 ics in these systems are still incompletely understood. 32 While the appearence of proximity-induced magnetic mo-33 ments in bulk paramagnetic 4d and 5d components is well-34 established^{14–16}, it is not clear how the ferromagnetic and the 35 induced moments behave when the system is optically excited 36 on ultrashort timescales. In fact, conflicting results have been 37 published in recent years, raising questions about the impact 38 of the sample properties on the ultrafast magnetic response. 39 Willems *et al.*, performed magnetic circular dichroism (MCD) 40 experiments on thin magnetic Pt/Co/Pt sandwiches in the ex-41 treme ultraviolet (XUV) spectral range (at the $M_{2,3}$ edges of 42 Co and O edges of Pt) and concluded that Co and Pt de-43 magnetize simultaneously on femtosecond time scales¹⁷. In 44 a similar study Hofher et al. scrutinized randomly alloyed 45 Fe-Pt thin films using transverse magneto-optical Kerr effect 46 (MOKE) measurements based on high harmonic generation 47 and observed an identical normalized transient de- and re-48 ⁴⁹ magnetization for Fe and Pt¹⁸. Vaskivskyi *et al.* employed

the same technique to analyze chemically disordered Co-Pt
films: the higher accuracy of their measurements allowed to
unravel slight differences in the demagnetization amplitudes
and rates, but overall, the sublattice-specific magnetization
dynamics were found to be very similar¹⁹.

In contrast to these findings - all of them obtained on sam-55 56 ples displaying a characteristic in-plane magnetization – ex-57 periments performed on thin films with pronounced out-ofplane anisotropy hint at very different dynamics in the two 58 59 magnetic sub-systems. In a time-resolved MCD study performed using hard x-ray pulses at the Pt L edge, Yamamoto et al. observed a slow demagnetization of the Pt moment in 61 62 L10-ordered Fe-Pt thin films. With the complementary use 63 of tr-MOKE measurements, they demonstrated that this decay ⁶⁴ time differed by more than a factor of six, when compared to the overall, Fe-dominated magnetization²⁰. In a follow-up 65 study based on polar X-MOKE measurements, similar results 67 were obtained on Co/Pt multilayers. Again, Co was found to demagnetize much faster²¹. 68

A static CCD camera picture demonstrating the presence 152 of magnetic scattering peaks is shown in Fig. 3a. Fig. 3b pro-153 vides a detailed description of the scattering geometry used in 154 our work. Constructive interference, i.e., a magnetic diffrac-155 tion peak is observed when 156

Here, \vec{Q} represents the scattering vector $\vec{Q} = \vec{k}_{s} - \vec{k}_{i}$, i.e., the 158 difference between the incoming and scattered wave vectors \vec{k}_i and \vec{k}_s , while \vec{e}_x is the unit vector in x direction, as shown 160 in Fig. 3b. This allows to write the scattering angle β (the angle between the scattering wavevector \vec{k}_s and the surface of the sample) as a function of the wavelength λ , the incidence angle θ (the angle between the incident wavevector k_i and the 164 surface of the sample) and the periodicity w of the magnetic 165 domains: 166

$$\beta = \arccos(\lambda/w + \cos(\theta)) \tag{2}$$

It is then straightforward to link β to the camera position 168 using the sine rule (note that the camera is always placed per-169 pendicularly to the incoming HHG beam): 170

180 As shown in Fig. 3a, the main magnetic peak, resulting 181 from resonant scattering at the Co $M_{2,3}$ edges, exhibits a sub-182 structure: a second faint satellite maximum can be identified 183 at larger X values. This becomes even more apparent when 184 projecting the data along z, the direction perpendicular to the 185 plane of incidence, as shown in Fig. 3c. Note that the broad-186 ening of the scattering peaks results from the domain size distribution, while our probing harmonics have a relative enature data (dashed gray)²⁴. With this quantitative description of the static data at hand. 206 it is now possible to obtain an element-selective view on the 207 demagnetization dynamics of the system, by analyzing the 208 temporal evolution of the distinct magnetic diffraction spots 209 following optical excitation of the multilayer. Therefore, for 210 each pump-probe delay, we compared the intensities inte-211 grated over the Co $M_{2,3}$ and Pt O_3 peaks^{19,32}. As $M \propto \sqrt{I}$, 212 these data thus provide direct insight into the temporal evolu-213 tion of the Co and induced Pt moment. Note that special care 214 was taken to subtract the background signal, a non-trivial task 215 which has a large impact on the resulting data, considering 216 the very different signal to noise ratios (SNR) of the Co and 217 Pt scattering maxima (Supplementary Material S2). 218

Fig.4a shows time-resolved resonant magnetic scatter-219 ing measurements performed using different IR pump flu-220 ences. In all cases, the measured intensity is found to drop 221 rapidly during the first 200 fs after excitation of the sys-222 tem, the characteristic signature of optically induced ultrafast 223 demagnetization³³. On longer timescales, typically several 224 tens to hundreds of ps, the magnetization recovers as a con-225 sequence of energy transport out of the magnetic thin film. As 226 can clearly be seen in these measurements, data gathered at 227 the Co and Pt edges result in the same time traces, which is 228 the central result of the present letter: irrespective of the em-229 ployed fluence, we observe that the Co and Pt layers display 230 231 an almost identical de- and remagnetization behavior. Note that this holds true for all incidence angles employed in our 232 work $(37^{\circ} < 90 - \theta < 45^{\circ})$. 233

To gain further quantitative insight into the initial femtosec-234 ond dynamics of the Co/Pt multilayers, we fitted the transient 235 magnetic behavior using a double exponential function con-236 voluted with a Gaussian curve to account for the finite width of the excitation pulse²¹: 238

To avoid 331 SUPPLEMENTARY MATERIAL 275 any shortcomings linked to poor SNR, we smoothed the time 276 traces using a moving average filter and fitted exclusively the 277 first 300 fs of the quenching process with a single exponential 278 decay, convoluted with a Gaussian function. As can be seen 279 in Fig. 4c, the characteristic shifts are approximately constant 280 at each edge, but differ significantly between Co and Pt. In 281 contrast, the $\tau_{\rm M}$ values are found to be approximately equal 282 for all 6 harmonics that were scrutinized (data not shown). 283

This unexpected behavior is reminiscent of observations 284 made during ultrafast demagnetization of Fe_{0.2}Ni_{0.8} alloys, 285 where a similar delay of about 18 fs was observed and claimed 286 287 the system³⁴. While these results have been controversially 288 discussed, recent TMOKE and XMCD measurements advo-289 cate the existence of a temporal lag as large as 40-50 fs when 290 341 quenching the magnetization of the two permalloy compo-291 342 nents with ultrafast optical pulses³⁵. Considering the strik-292 343 ingly similar timescales, it is thus tempting to conclude that 344 293 comparable mechanisms are at work here. At the same time, 345 294 346 it appears puzzling that, with regard to the large amount of lit-295 erature devoted to element specific magnetization dynamics in 296 3d-4d and 3d-5d multicomponent systems, this effect has not 349 297 yet been observed. In the present case, two different aspects 350 298 must further be taken into closer consideration. First, it is nec- 351 299 essary to emphasize that we are also sensitive to the size of the $\ensuremath{^{352}}$ 300 353 domains and their distribution, which might impact the result-301 ing analyzed intensities. Note however that our experiments 355 302 do not yield any indication for such modifications. If complex 356 303 changes of the overall spin structure of the sample were to im- 357 304 bact the results, we would also expect a fluence dependence of 358 305 the data, which is not observed here. Secondly, as recently put $\frac{1}{360}$ 306 forward, electron occupancy changes close to the Fermi level 361 307 can have a major impact on the observed time traces when us- 362 308 ing probe beams with small bandwidth^{22,23}. Similar effects ³⁶³ 309 could play a role in the present experiments and therefore de-310 serve further investigation. 311

Thus, to conclude, the present work provides evidence 367 312 313 for a similar femtosecond response of the ferromagnetic and ³⁶⁸ induced moments in Co/Pt multilayer thin films exhibiting 370 314 strong PMA, when these are excited by IR pulses on ultra- 371 315 short timescales. This suggests that the discrepancy between ³⁷² 316 the Co and Pt magnetization dynamics discussed at the be- 373 317 ginning of this letter might be attributed to the edges that are $\frac{374}{375}$ 318 319 put under scrutiny, which raises fundamental questions with 376 320 regard to data interpretation in femtomagnetism experiments 377
