17 ABSTRACT

18 Dickeya are plant pathogenic bacteria able to provoke disease on a wide range of plants. A type 2 secretion system named Out is necessary for bacterial virulence. Its study in D. dadantii 19 showed that it secretes a wide range of pectinolytic enzymes. However, the full repertoire of 20 exoproteins it can secrete has not been identified. No secretion signal present on the protein 21 allows the identification of substrates of a type 2 secretion system. To identify new Out 22 23 substrates, we analyzed *D. dadantii* transcriptome data obtained in plant infection condition and searched for genes strongly induced encoding a protein with a signal sequence. We identified 24 25 four new Out-secreted proteins: the expansin YoaJ, VirK and two proteins of the DUF 4879 26 family, SvfA and SvfB. We showed that SvfA and SvfB are required for full virulence of D. 27 dadantii and showed that Svf proteins are present with a variable number of copies, up to three 28 in D. fanghzongdai, in other Pectobacteriaceae. This work opens the way to the study of the 29 role in virulence of non-pectinolytic proteins secreted by the Out pathway in Pectobacteriaceae.

31 IMPORTANCE

The plant pathogen *Dickeya* rely on a type 2 secretion system named Out for their pathogenicity. Importance of plant cell wall degrading enzymes secreted by this system has been well studied. However, existence and role of other Out-secreted proteins has barely been investigated. By mining *D. dadantii* transcriptome data, we identified four new Out-secreted proteins. We showed that two of them, SvfA and SvfB, are necessary for the full virulence of the bacteria. These findings show that identification of all the proteins secreted by the *Dickeya* Out system is necessary for a better knowledge of the virulence of these bacteria.

42 INTRODUCTION

43 Soft rot Pectobacteriaceae, Dickeya and Pectobacterium, are plant pathogenic bacteria that can provoke disease on a more than 35% of angiosperm plant orders, including both monocot and 44 dicot plants (1). Among those, there is a wide range of plants of agronomic interest such as 45 46 potato, rice, chicory, cabbage or ornementals on which they can cause severe losses. Symptoms are usually soft rot but these bacteria can provoke blackleg or wilting on aerial parts of potato. 47 Recently, disease on woody plants caused by *Dickeya* have been reported (2). There is no 48 efficient way to fight the disease. There are actually twelve species of Dickeya described, 49 isolated either from infected plants (D. chrysanthemi from Chrysanthemum morifolium, D. 50 51 dadantii subsp. dadantii from Pelargonium capitum, D. dadantii subsp. diffenbachiae from 52 Dieffenbachia sp., D. dianthicola from Dianthus caryophillus, D. zeae from Zea mays, D. 53 oryzae from Oryza sativa, D. paradisiaca from Musa paradisiaca, D. solani from Solanum tuberosum, D. fangzhongdai from Pyrus pyrifolia, D. poaceiphila from Saccharum 54 55 officinarum) (3)(4)(5)(6)(7) or from river of lake water (D. aquatica, D. lacustris and D. 56 undicola) (8)(9)(10). The role of protein secretion systems on the onset of the disease provoked 57 by these bacteria has been recognized long ago (11). In contrast to many plant pathogenic 58 bacteria, the type three Hrp secretion system is not the main determinant for Pectobacteriaceae 59 virulence (12). The main virulence factor for these bacteria is a type 2 secretion system (T2SS) named Out. It allows the secretion of enzymes that degrade the components of the plant cell 60 61 wall, leading to the soft rot symptom distinctive of the disease. The first secreted proteins to be 62 identified were pectinases and a cellulase which are easily detectable by simple enzymatic tests 63 (13) (11). The pectinolytic secretome of the model strain D. dadantii 3937 has been studied in detail by cloning the genes of these easily detectable enzymes. D. dadantii secretes nine pectate 64 65 lyases, one pectin methylesterase, one pectin acetylesterase and one rhamnogalacturonate lyase (14). A proteomic analysis of the secreted proteins by 2D gel electrophoresis allowed the 66

identification of two other secreted proteins, the feruloyl esterase FaeD and a protein with 67 68 homology with a Xanthomonas campestris avirulence protein AvrL (15). A search in D. dadantii of homologues of proteins secreted by Pectobacterium atrosepticum (16) led to the 69 characterization of the metal binding protein IbpS (17). Since all the pectinolytic enzymes 70 studied in D. dadantii are present in most of the Dickeya species they are probably not 71 responsible for the host preference observed for these bacteria (18). We hypothesized that 72 73 additional T2SS-secreted proteins specific for some species might exist and play a role in the host preference. To identify such proteins, we analyzed *D. dadantii* transcriptome data, looking 74 for genes induced in plant infection conditions coding proteins with a signal sequence. We 75 76 identified several proteins secreted by the Out machinery and showed that two proteins of the 77 DUF4879 family, SvfA and SvfB are *D. dadantii* virulence factors.

80 **RESULTS**

81

82 Identification of new Out-secreted proteins

To have a more complete knowledge of the proteins secreted by the *D. dadantii* Out T2SS that 83 could be involved in the pathogenicity process, we searched for candidate genes in recently 84 published transcriptome data (19)(20). We selected genes strongly induced during plant 85 infection and coding for a protein possessing a signal sequence. We retained the genes 86 87 Dda3937 01687, Dda3937_00585 (thereafter named SvfA and SvfB, respectively) and 88 Dda3937 00081 (also named yoaJ). We also retained VirK, a protein with a signal sequence identified among the genes controlled by PecS, a regulator of many virulence factors (21). The 89 90 proteins were tagged with a His-tag and their secretion analyzed in the *D. dadantii* wild type strain and an OutD mutant. Proteins SvfA, SvfB, YoaJ and VirK were found in the supernatant 91 92 of the wild type strain but not of the mutant, proving their secretion by the Out machinery (Fig.

93 1). Production of these proteins from a plasmid may explain why secretion was not total in the94 wild type strain.

YoaJ is a PecS-regulated gene (21) and it was found among the most induced genes during 96 Arabidopsis infection or culture in the presence of plant extracts (19). It encodes a protein with 97 homology to expansins. These proteins are able to non-enzymatically loosen cell wall cellulose. 98 99 They are found in all plants where they have a role in cell wall extension and also in many plant pathogenic microorganisms (22). Their role in virulence has been shown in Ralstonia 100 101 solanacearum, in P. atrosepticum, P. Brasiliense and in the plant pathogen Erwinia 102 tracheiphila (23) (24). The role of *D. dadantii* expansin is probably the same. VirK is a protein 103 of unknown function that has homologues in several plant pathogenic bacteria such as R. 104 solanacearum, Agrobacterium tumefaciens, Lonsdalea and Xanthomonas. VirK is controlled 105 by PecS and induced during Arabidopsis infection or culture in the presence of plant extracts 106 (21) (20). No symptom for the D. dadantii virK mutant was observed whatever the plant tested 107 (21). The two proteins SvfA and SvfB are studied in the next paragraphs.

109 SvfA and SvfB are virulence factors

110 svfA and svfB are among the most induced genes during D. dadantii Arabidopsis infection or culture of the bacteria in the presence of plant extracts (19). They are also strongly expressed 111 112 during maceration of potato by D. dianthicola and D. solani (25). The two D. dadantii proteins share 43% identity and 58% similarity in amino acid composition (Fig. 2). SvfA is 187 amino 113 114 acid long (165 for the mature form, 17.5 kDa) and SvfB is 198 amino acid long (177 for the 115 mature form, 18.9 kDa). These proteins belong to the DUF 4879 family of proteins. These 116 proteins have no known function. A protein of this family with low homology with SvfB, YolA, 117 is among the most highly secreted protein of *Bacillus subtilis* (26). YolA is also present in *B*. *cereus* and in the insect pathogen *B. thuringiensis*. *Bacillus* YolA is shorter than SvfA and SvfB,
missing the N-terminal more variable part (Fig. 2).

121 SvfA and SvfB mutants have been constructed and their pathogenicity has been tested on 122 potato. The *svfA* mutant was significantly less aggressive than the wild type while the *svfB* 123 mutant was not affected (Fig. 3A). Virulence of the *svfA* mutant could be restored by 124 introduction of a plasmid bearing the wild type *svfA* (Fig. 3B). Virulence of the double *svfA* 125 *svfB* mutant was further reduced showing that the role of SvfB is additive to that of SvfA (Fig. 126 3A). Thus, genes *Dda3937_01687* and *Dda3937_00585* were named *svfA* and *svfB* for <u>s</u>ecreted 127 <u>v</u>irulence factor A and B.

All attempts to overproduce produce SvfA and SvfB to purify them and study more precisely
their function were unsuccessful because their production was toxic to the bacteria that
overproduce them.

134 Expression of SvfA and SvfB

To try to identify the function of SvfA and SvfB we analyzed the conditions in which their 135 136 genes are expressed. We tested the effect of galacturonate and polygalacturonate, two 137 compounds that are inducers of the expression of the main virulence factors, the pectate lyases, 138 and of glucose, which represses it. We also analyzed the effect of mutation in genes controlling 139 several aspects of *D. dadantii* virulence. KdgR represses the pectinase, pectin degradation and 140 the out genes (27). Its inducer is 2-keto-3-deoxygluconate, a polygalacturonate and 141 galacturonate catabolic derivative. PecS controls the pectinase, other secreted protein, the out genes and those involved in resistance to oxidative stress (28). PecT is a regulator of the pectate 142

lyase, motility and exopolysaccharide synthesis genes (29). Pir regulates hyperinduction of 143 144 pectate lyses in response to plant signal (30). Finally, GacA, the regulator of the two-component regulation system GacA-GacS, is a global regulator required for disease expression in response 145 146 to the metabolic status of the bacteria (31). Expression of *svfA* was slightly induced by polygalacturonate but not by galacturonate (Fig. 4A). However, expression of the gene was not 147 modified in a *kdgR* background indicating that induction by polygalacturonate is not mediated 148 149 by kdgR. Growth in the presence of chicory chunks strongly induced svfA expression as 150 expected from transcriptomic data showing induction in the presence of plant extract. A high 151 concentration of glucose led to a strong induction of the gene expression (Fig. 4A). This 152 regulation is mediated by the catabolite repressor protein CRP since a mutation in the crp gene 153 derepressed *svfA* expression. Thus, Crp is a repressor of *svfA*. Although it had not been detected 154 as a PecS-regulated gene (21), its expression is elevated in a pecS background. A pir mutation 155 derepressed also a little svfA expression. Neither PecT nor GacA significantly regulate svfA 156 expression (Fig. 4A).

Regulation of svfB is quite similar to that of svfA: it was not induced by galacturonate, polygalacturonate or regulated by KdgR, it was induced by glucose and repressed by Crp, and it was repressed by PecS (Fig. 4B). However, few differences can be noted: in contrast to what is observed with svfA, no induction by plant pieces was observed and PecT was a repressor of svfB expression while pir did not seem to control it (Fig. 4B).

165 Occurrence of new secreted proteins in other Dickeya species

166 Presence of *svfA*, *svfB*, *virK* and *yoaJ* was searched in all the *Dickeya* type strains, and in a few

167 *Pectobacterium* strains (Table 1). Presence and number of proteins of the DUF 4879 family is

variable among *Dickeya* species. *svfA* is present in all strains except *D. zeae*, *D. chrysanthemi*, 168 169 D. poaceiphila and D. paradisiaca. svfB is absent in D. chrysanthemi, D. poaceiphila and D. paradisiaca, D. undicola and D. aquatica. A third gene located next to svfA and resulting 170 probably from a duplication is found in *D. fangzhongdai* and *D. undicola*. It has 53% homology 171 with D. dadantii SvfA and 34% with D. dadantii SvfB. It was named svfC. SvfC is shorter that 172 SvfA and SvfB (126 amino acid for the mature protein, 13.2 kDa) and has the same size as B. 173 174 *cereus* YolA (Fig. 2). It possesses a signal sequence, indicating that it could also be secreted by 175 the Out system. Thus, the number of genes of this family in *Dickeya* strains varies from 0 to 3. Homologues of the svf genes can be found in some Pectobacterium strains (Table 1). For 176 177 example, two copies are present in P. carotovorum subsp carotovorum. However, even in a 178 given species the gene may be present or not (presence of a homologue of *svfB* in 10 out of the 179 23 Р. brasiliense strains present in the ASAP data bank 180 (https://asap.ahabs.wisc.edu/asap/home.php). Outside Pectobacteriaceae, homologues of svfB 181 can be found in a few gammaproteobacteriaceae, i.d. in some Photorhabdus, Luteibacter and 182 *Pseudoalteromonas* strains. *voaJ* is present in all *Dickeya* and *Pectobacterium* strains except 183 D. poaceiphila and D. paradisiaca. virK is absent in D. aquatica and in all Pectobacterium 184 strains.

We examined also the presence or absence of genes of other non-pectinolytic proteins known
to be secreted by a T2SS in *Dickeya* or *Pectobacterium: ibpS, nipE, xynA, avrL/avrM* (Table
1). IbpS is a metal binding protein that prevents ROS-induced killing of bacteria (17). NipE is
a toxin that provoke plant cell death (32). XynA is a xylanase that was identified in a corn strain
of *Erwinia chrysanthemi* (33). AvrL is a protein with homology with a *Xanthomonas campestris*avirulence protein AvrL (15). Two very similar proteins, AvrL and AvrM, are encoded by *D*. *dadantii* 3937. AvrL was named Svx in *P. atrosepticum* where a role in virulence has been

193 proven (34). However, its function in *Dickeya* has not been studied. While IbpS and NipE are 194 present in almost all the species, except *D. paradisiaca* and *D. poaceiphila* for NipE, a variation 195 in the presence and number of XynA and AvrL was observed (Table 1). Thus, the repertoire of 196 T2SS-secreted protein known to be important for virulence is very variable from species to 197 species.

200 DISCUSSION

201 The T2SS of Dickeya and Pectobacterium is the main virulence factor of these bacteria. The 202 knowledge of the repertoire of secreted proteins is necessary to better understand the 203 mechanisms of virulence of these bacteria. This analysis has been undertaken with the model 204 strain D. dadantii 3937 and partially with Pectobacterium atrosepticum (35)(16). Dickeya and 205 Pectobacterium are characterized by their ability to degrade pectin and new species are 206 identified by this characteristic on the semi selective Crystal Violet Pectate medium. They all 207 secrete enzymes capable of degrading this polysaccharide (pectate lyases, polygalacturonases, pectin methylesterases) which are produced by all these bacteria. However, recent work shows 208 209 that other proteins are secreted by the Out T2SS (15)(16). In this work we used published transcriptome data to identify new substrates of the Dickeya dadantii T2SS. The most induced 210 211 genes in a transcriptome experiment of *D. dadantii* infecting *A. thaliana* are known virulence genes (pell, prtA, rhiE, paeY, rhaD, ibpS, etc...) (19). However, in this top list some genes have 212 213 no known function. The presence of a signal sequence in their product suggested that these 214 proteins could be substrates of the T2SS necessary for the infection process. We showed here 215 that the proteins SvfA, SvfB and YoaJ present in the top list are substrates of the Out T2SS. 216 YoaJ belongs to the family of expansins, proteins that loosen cellulose fibers. Their role as a 217 virulence factor has been shown in *P. brasiliense* and *P. atrosepticum* (23). It probably has the same function in *D. dadantii*. No function could be predicted for SvfA and SvfB which belong 218

to the DUF 4879 family of proteins. However, a reduction of virulence of a *svfA* mutant and a 219 220 svfA svfB double mutant on potato could be observed proving a role of the proteins in the bacterial pathogenicity. Although an additive effect of the mutations was observed, they could 221 222 not have exactly the same function. The mutants should be tested on various hosts to detect possible differences. It can be supposed that each protein would be more active on one type or 223 one family of plant. Presence of three proteins of this family in D. fanghzongdai could explain 224 225 its wide host range. Presence of homologues of SvfA and SvfB in Photorhabdus and in B. 226 thuringiensis strains, two insect pathogens, indicates that the role of these proteins is not restricted to plant virulence but may participate to a common process of bacterial pathogeny 227 228 such as cell lysis. We showed also here that the PecS-regulated protein VirK is also secreted by 229 Out. No role on virulence had been found for this protein with the chicory leaf model of 230 infection (21). Other models should be tested to find the role of this protein.

Regulation of expression of the *svfA* and *svfB* genes is atypical for a *D*. *dadantii* gene involved 232 233 in pathogeny. While expression of most of the virulence factors is induced in the presence of 234 pectin or its derivatives through the repressor KdgR and repressed by glucose, that of *svfA* and svfB is opposite: it is activated by glucose and not controlled by KdgR. Expression of svfA is 235 236 induced in the presence of plant tissue. This pattern of regulation has been described for *ibpS*, 237 which is also strongly induced in A. thaliana (17). This could correspond to conditions 238 encountered during the early phases of infection: pectin has not yet been degraded and glucose 239 and saccharose are plentiful in plant tissues. svfA and ibpS could be among the earliest gene to 240 be induced at the onset of infection, before the genes involved in pectin degradation. However, 241 regulation of these genes by PecS and PecT shows that *svfA* and *svfB* are fully integrated in the 242 network of regulators that controls D. dadantii virulence.

This work has extended our knowledge of the Out-dependent secretome of *D. dadantii*, showing 244 245 that besides pectinases several other proteins are secreted. If the number of pectinolytic enzymes secreted is almost identical in the various Dickeya species, the number of additional 246 247 secreted proteins varies markedly. Among the proteins we analyzed (Table 1), D. paradisiaca 248 has only one (VirK) while D. fanghzongdai has ten. All the intermediate combinations can be 249 found in the various species. There seems to be less variations in the Pectobacterium strains 250 that we surveyed. It is tempting to speculate that the presence/absence of these proteins could 251 be one of the origin of the host preference of the *Dickeya* strains, providing additional virulence factors necessary to infect certain hosts. Articles that compare Dickeya strains to understand 252 253 what makes their difference in their host range or aggressivity often focus only on the presence 254 of the six known types of secretion systems without analyzing what proteins could be secreted 255 (18)(36)(37). An exhaustive analysis of the secreted proteins would be more informative.

257 Is there other T2SS-secreted proteins to be identified in *Dickeya* strains? No specific signal is 258 present on T2SS-secreted proteins that would allow their identification. 2D gels which were 259 used in previous studies performed on D. dadantii and P. atrosepticum to identify these proteins have a limited sensitivity (15)(34). More sensitive methods such as liquid chromatography-260 261 tandem mass spectrometry (LC-MS/MS) can now be used (38). However, they give many false positive results since periplasmic and cytoplasmic proteins are often found in the culture 262 263 supernatant. The approach we used here allowed the identification of four new secreted 264 proteins. However, all these methods have a drawback. They can only detect proteins that are 265 produced. The rhamnogalacturonate lyase RhiE could only be detected when the bacteria were 266 cultivated in the presence of rhamnose (39). YoaJ and VirK were not induced in D. dianthicola 267 grown on potato (25). Another problem is that a protein may not exist in the strain tested. An 268 analysis of the secretome of several Dickeya strains grown in several conditions will be necessary to have a global view of all the virulence factors that can be secreted by *Dickeya*species and evaluate their potential role in pathogenicity.

272 MATERIAL AND METHODS

273

274 Bacterial strains and growth conditions.

Bacterial strains, phages, plasmids and oligonucleotides used in this study are described in Table 2. *D. dadantii* and *E. coli* cells were grown at 30 and 37°C respectively in LB medium or M63 minimal medium supplemented with a carbon source (0.2%, w/v unless otherwise indicated). When required antibiotics were added at the following concentrations: ampicillin, 100 mg l⁻¹, kanamycin and chloramphenicol, 25 mg l⁻¹. Media were solidified with 1.5% (w/v) agar. Transduction with phage Φ EC2 was performed according to Résibois *et al.* (40)

281 Mutant construction.

To construct strain A6418 that contains a svfA-uidA fusion a 1.3 kb DNA fragment containing 282 283 svfA was amplified with primers 17176H+ and 17176A. The resulting fragment was inserted into 284 the pGEM-T plasmid (Promega). A XbaI site was created by site directed mutagenesis with the 285 primers 17176XbaF and 17176XbaR into the svfA coding sequence and a uidA-kanR cassette was 286 inserted into this XbaI site. To construct strain A6467 that contains a svfB-uidA-kanR fusion and 287 a CmR cassette a 2000bp DNA fragment containing svfB was amplified with the primers 288 15544L2+ and 15544L2-. The resulting fragment was inserted into the pGEM-T plasmid. A XmaI 289 site was created by site directed mutagenesis into svfB coding sequence with the primers 290 15544XmaF and 15544XmaR and a uidA-kanR cassette was inserted into this created XmaI site 291 unique. All the constructs were recombined into the D. dadantii chromosome according to Roeder and Collmer (41). Recombinations were checked by PCR. His-tagged versions of the proteins 292 293 SvfA, SvfB, YolA, VirK were constructed by amplifying the corresponding genes with the primers

294	17176H+ and 17176H-, 15544H+ and 15544H-, 14642H+ and 14642H-, VirKH+ and VirKH-,
295	respectively. The resulting DNA fragments were cloned into plasmid pGEMT.

297 Secretion assays and Western blots.

D. dadantii strains containing the plasmid to test were grown overnight in LB medium in the
presence of the appropriate antibiotic. Culture supernatant containing secreted proteins was
separated from cells by centrifugation at 10,000g for 3 min, and both fractions were loaded onto
12% polyacrylamide gel electrophoresis (SDS-PAGE). The proteins were next transferred onto
Immobilon P membrane (Merck) and probed with Ni-NTA-HRP.

304 Pathogenicity tests.

Bacteria were grown overnight in LB medium, centrifuged and resuspended at OD_{600} 1 in M63 medium. Potatoes were surface sterilized with 70% ethanol and dried. A hole was made with a pipette tip and 10μ l of bacteria were deposited in the hole which was covered with mineral oil. Potatoes were placed over a wet paper in a tray contained in a plastic bag to maintain moisture. After 48h at 30°C, the weight of rotten tissue was measured.

311 Enzymatic assays.

312 β -glucuronidase assays were performed on toluenized extracts of cells grown to exponential 313 phase using the method of Bardonnet *et al* (42). with *p*-nitrophenyl- β -D-glucuronate as the 314 substrate.
