11 Abstract

12 This review concerns the speciation of protactinium in aqueous solution under its both oxidation states +IV and 13 +V. Emphasis is placed on experimental data obtained at trace level but also in macroscopic amount leading to the 14 determination of thermodynamic and structural data. Thus, the complexation of Pa(V) with mineral acids and 15 organic acids, mainly polyamino carboxylic acids (IDA, NTA, EDTA and DTPA) are highlighted and compared. 16 The review also includes the actual knowledge about the Pa(IV) aqueous chemistry pinpointing its spectroscopic

- 17 features.

1.Introduction 19

20

21 The vacant place between Th and U for ekatantalum in the table of Mendeleev was filled in 1913 thanks to the discovery of the isotope ²³⁴Pa independently by Fajans, Russell and Soddy applying radioactive displacement laws 22 to uranium [1-3]. The same year, Fajans and Göhring identified the short-lived ^{234m}Pa and proposed brevium for 23

24 the name of element 91 [4]. A few years later, processing pitchblende, Hahn and Meitner, simultaneously with

25 Soddy and Cranston confirmed the existence of Pa through the identification of an isotope of longer half-life,

26 parent of actinium, ²³¹Pa [5,6]. Initially named protoactinium, element 91 became protactinium in 1949 [7,8].

27 Although the names cited above have gone down in the history of protactinium discovery, the work of Crooks in

28 1900 must not be forgotten: he performed for the first time the separation of uranium from its daughters but failed

29 in the identification of ²³⁴Pa [9].

30 The first studies devoted to the chemical properties of Pa have been conducted by von Grosse at the end of the

31 1920's and in the 1930's. It is noticeable that this pioneering work has highlighted two features of Pa chemistry:

the importance of fluoride (Von Grosse synthesized K₂PaF₇ for the determination of the molar mass of ²³¹Pa) and 32

the limited analogy between Pa and Ta in particular as regards the solubility of Pa/Ta₂O₅ [10, 11]. It is mostly 33

thanks to the isolation of 127g of ²³¹Pa from uranium refinery residues, made available for all interested 34

35 laboratories by UKAEA in 1960's, that investigations could be made on the chemical properties of this element,

- 36 at solid state and in solution [12].
- Solution chemistry studies conducted in 1960's and 1970's involved ²³¹Pa mainly in macro-amount but also ²³³Pa 37

at tracer scale. The latter can be produced either by irradiation of 232 Th in thermal neutron flux as well as by 38

39 purification of its parent ²³⁷Np. Whatever the isotope, the preparation of Pa solution requires efficient separation

40 procedures. For that purpose, different techniques such as co-precipitation, solvent extraction, ion exchange and 41 extraction chromatography, and volatilisation have been used with a plethora of reagents. All these studies

42 contributed to outline the features of the aqueous chemistry of Pa and the associated experimental difficulties

43 leading to irreproducible behaviour. Several reviews dedicated to the analytical chemistry of protactinium are

- 44 available in the literature [7, 8, 13-16].
- 45 After some decades rather poor in publications, a renewed interest in Pa chemistry is observed over the last twenty
- 46 years, that reflects its possible application in various areas.
- 47 As the first actinide with 5f orbitals involved in bonding, Pa chemistry is of fundamental interest for a better
- 48 understanding of 5f elements, especially the interplay of 6d and 5f orbitals [17]. In addition, with many applications
- 49 of different Pa isotopes come the needs of a thorough knowledge of its chemical behaviour [18]. In nuclear
- technology, the use of thorium-based fuels leads to the formation of ²³³Pa as an intermediate in the production of 50

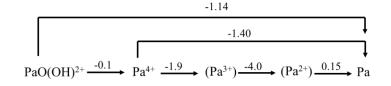
- the fissile ²³³U, and to the formation of ²³¹Pa as a byproduct which contributes to the long-term radiotoxicity [19].
- 52 The reprocessing and waste management of spent Th-fuel should take into account the fate of protactinium: 53 separation steps and the guaranty of safety of radwaste disposal require reliable data on Pa chemistry. The ratio
- 231 Pa/ 235 U is used in geochronology as radiochronometer for young samples (< 200 000 years), and in nuclear
- 55 forensics to date 10-50 years old samples of enriched uranium [20, 21]. An accurate determination of this ratio
- requires the isolation of each radionuclide with high yield and high purity. Finally, a medical application of 230 U
- 57 has been proposed recently for targeted alpha therapy or as generator of 226 Th [22, 23]. The production of 230 U can
- 58 involve either 230 Pa or 231 Pa isotopes. The isotope 230 Pa, parent of 230 U is produced by proton or deuton irradiation
- 59 on natural Th. This uranium isotope can also be formed by irradiation of ²³¹Pa with protons or deutons. Whatever
- the way of production, efficient separations of Pa-U-Th are mandatory. All these applications require a thorough
- 61 knowledge of Pa chemistry, that even today, remains mysterious.
- 62 The present review focuses on the speciation of protactinium (IV) and (V) in aqueous solution deduced from
- experimental studies performed at tracer scale as well as in macroscopic amount. Tracer scale experiments involve
- 64 partition or diffusion methods combined with radiometric techniques or ICP-MS, which unfortunately provide
- 65 little unequivocal information on species composition. The use of additional spectroscopic techniques (UV-Vis,
- 66 IR, Raman, and more recently Time Resolved Laser Fluorescence spectroscopy and X-ray absorption
- spectroscopy) are needed for a complete characterization of the investigated systems. Theoretical calculations, inspite of their significant contribution in the understanding of protactinium chemistry, is out the scope of the present
- 68 spite of their significant contribution in the understanding of prota 69 review.

71 2.Redox properties

- 72
- 73 In aqueous solution, protactinium can exist in oxidation states IV and V, the latter being the most stable like its 74 analogs of group 5, Nb and Ta [7, 8, 24]. The first experimental determination of the standard potential 75 Pa(V)/Pa(IV) has been conducted by Fried et al. [25]. The quantitative oxidation by Np(IV) of a Pa(IV) solution 76 obtained by dissolution of PaCl₄ in deaerated 1 M HCl allowed the authors to conclude that $E_{Pa(V)/Pa(IV)}$ is higher 77 than $E_{ND(IV)/ND(III)}$, that is to say -0.14 V. Moreover, the oxidation of Pa(IV) in sealed cell attributed to an oxidation 78 by protons, has led Fried et al. to estimate E_{Pa(V)/Pa(IV)} to -0.1 V/NHE. In 6 M HCl, Haissinsky et al. have conducted 79 the reduction of Pa(V) at tracer scale using Cr²⁺ and V²⁺ [26]. The potential of the system was monitored with 80 different ratio Cr^{2+}/Cr^{3+} and V^{2+}/V^{3+} , and the authors have estimated the apparent potential at -0.25 V. Because of 81 the uncertainty on the chemical form of the involved species and thus on the impact of acidity on the potential, the
- 82 values of Fried et al. and Haissinsky et al. can only be considered as estimates.
- Scarce direct measurements of Pa(V)/Pa(IV) potential have been performed using polarography [27-30]. One or
 two reduction waves have been observed, depending on the electrolyte and Pa(V) concentration; In neutral NH₄F
- 85 solutions, Ferreira et al. observed a variation of the half-wave potential of the first wave with fluoride
- 86 concentration: $E_{1/2}$ was found to vary between -1.43 and -1.25 V/SCE as fluoride concentration increased from 87 1.02 to 7.94 M [28], but Schwochau et al. determined a single $E_{1/2} = -1.42$ V/SCE with NH₄F ranging from 0.45
- 1.02 to 1.02
- 89 medium, Elson and Ferreira et al. observed the first wave at $E_{1/2} = -1.75$ V/SCE [27, 28]. Whatever the electrolyte
- 90 $(NH_4F, K_2C_2O_4, Na_2(SO_4))$, this first wave has been attributed to the reduction of Pa(V) into Pa(IV) but authors
- 91 disagree with regard to the reversibility of the process. The second wave has been related to catalytic reduction of
- 92 protons or reduction to Pa(III). However, the existence of this oxidation state in aqueous solution was not
- **93** conclusively established.
- $94 \qquad \text{The chemical reduction of Pa(V) has been performed in acidic media under Ar or H_2 using several reagents: Zn(Hg)}$
- 95 [31-37], Zn(Hg) and Cr(II) [31, 38-45], Zn(Hg) and Ti(III) [38], Zn(Hg) and Eu(II) [46] and recently rongalite
- 96 (NaCH₂OHSO₂) [47]. Some authors indicated that the reduction with zinc amalgam alone is slow and does not
- 97 proceed quantitatively, especially with solid amalgam and Pa at tracer scale. The use of additional reducing agent
- 98 significantly improves kinetics and yield of Pa(IV) formation. The choice of reducing agent depends on the
- technique used for the investigation of Pa(IV) chemistry (see Part 4) in order to avoid any interference with the
- 100 measured parameter.

101 Oxidation states lower than 4 have not been observed in aqueous solution. However, in chloride based melts, 102 Mikheev et al. described the reduction to Pa(III) and Pa(II) by cocrystallization with divalent lanthanides [48]. 103 Standard redox potentials of each couple have been determined experimentally (Pa(V)/Pa(IV), estimated using 104 stabilization/destabilization of electron configurations (Pa³⁺/Pa²⁺)) or deduced from MCDF calculations of 105 ionization potentials [49, 50]. Figure 1 presents the Latimer's diagram of protactinium using standard potential 106 available in [50].

- 113 **3. Protactinium(V)**
- 114

112

115 The main feature of Pa(V) aqueous chemistry is a strong tendency towards hydrolysis in non and low complexing 116 media (HClO₄, HCl, HNO₃) that leads to the formation of radiocolloids by condensation of monomeric hydrolysed 117 species, polymerisation and precipitation [7, 8, 13-15, 24]. The unstability of Pa solution is enhanced by an increase 118 in pH and protactinium concentration. According to Starik et al., colloids predominate at pH higher than 5 [51]. 119 Experimentally, this unstability has been observed by a change in absorption spectra, a decrease in distribution 120 ratio with time, and a difference between direct and back extraction. It occurs with unpredictible induction time, 121 depends on the preparation method of Pa solution and also on its age. In non complexing media, stable solutions 122 are obtained only with Pa at tracer scale in highly acidic media. Although these conditions of concentration are 123 suitable for getting reliable data on Pa(V) in the absence of strong ligand, obvioulsy a different behaviour is 124 expected with macroamount of Pa [7, 8, 24].

Another feature of Pa(V), as a result of its high sensitivity to hydrolysis, is its strong sorption on siliceous materials (silica gel, glass, quartz). The sorption ratio reaches values as high as 90-95 % in 1-8 M HClO₄ and 1-10 M HNO₃, 97-99% in perchlorate medium at pH = 1.8 [52]. Although plastic vials (polyethylene for example) seem more suitable for studying Pa chemistry, glass vials have been used in solvent extraction experiments to ensure tightness towards volatil organic solvent. In that case, walls have been chemically processed: Spitsyn et al. and Suzuki et al. have saturated the walls of their containers with hydroxy species of protactinium leading to the formation of M-O-Si.) [53, 54]. Silicone grease as well as « old » vials have also been used [55, 56]. More recently, surface coating

- 132 of glass walls has been performed with parylene C, a hydrophobic polymer [52, 57].
- 133

134 3.1. Hydrolysis

135

136 The speciation of Pa(V) in non-complexing media, has been investigated mainly with Pa at tracer scale using 137 solvent extraction. The organic phase is either composed of beta-diketone (thenoyltrifluoroacetone-TTA, 138 acetylacetone-AA, dibenzoylmethane-DBM), or organophosphorous compounds (bis-(2-ethylhexyl)phosphate-HDEHP, tributylphosphate-TBP) diluted in benzene, toluene or xylene [24]. The distribution of protactinium 139 140 between aqueous and organic phases reflects the competition between the formation of a neutral chelate or solvate 141 in organic phase, and hydrolysis (or complexation) in aqueous phase [58]. However, acid-base properties of beta 142 diketones could lead to significant amount of the anionic form in aqueous phase that can act as ligand. Some 143 formation constants of Pa(V) with ACA (pKa = 8.9) and TTA (pKa = 6.2) are available in the literature [59-62]. 144 To prevent or limit these competitive reactions in aqueous phase, low concentration of extractant and pH much 145 lower than pKa are used. As regards the partition kinetics, it has been proved to be governed by the partition of 146 the extractant in the case of TTA, whatever the composition of the aqueous phase (complexing as well as non-

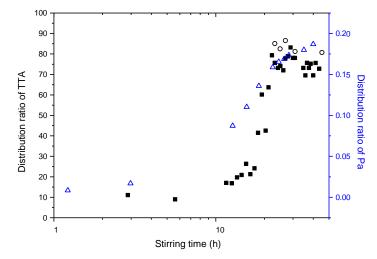


Figure 2: Variation of the distribution ratio of TTA and of Pa(V) as function of the stirring time 25°C, ionic strength

147 complexing medium) as illustrated in Figure 2.

155 Information on the ionic species of Pa(V) at tracer scale have been deduced mainly from the logarithmic variation 156 of the distribution ratio as function of extractant and free protons concentration. Slopes of these linear variations 157 allow one to determine the mean composition of the predominant species in each phase [58, 63]. The literature 158 tends to agree that Pa(V) predominates in the form of a 2-fold charged cation between 0.1-0.2 M and 6 M. The 159 less hydrolyzed form in these media should be written $[PaO(OH)]^{2+}$ instead of $[Pa(OH)_3]^{2+}$. The formulation with 160 one mono oxo bond has been preferred to pure hydroxo species because of an absorption band in UV domain in 161 the range 200-210 nm for fresh solutions of Pa $\sim 10^{-5}$ M in concentrated HClO₄, also observed in other acids and 162 attributed to the Pa oxo bond [24, 64]. This has ruled out the formulation PaO_2^+ postulated by Welch from cation 163 exchange studies in perchloric acid [65]. However, this wavelength domain remains difficult to explore and 164 interferences with concentrated acids could occur [8].

165 Thus, at tracer scale, hydrolysis equilibria in true acidic solutions are most likely [56, 57]:

Writing the neutral species $[Pa(OH)_5]$ is arbitrary: it is equivalent to $[PaO(OH)_3]$ according to Rydberg's formalism [66]. Hydrolysis constants K_1 and K_2 associated to equilibria (1) and (2) are shown in Table 1. The values of K_1^0 and K_2^0 extrapolated at zero ionic strength have been compared with standard data relative to other actinides at different oxidation state available in OCDE-NEA data base [67, 68]. The first hydrolysis constant of Pa(V), K_1^0 is closer to those of An(IV) than of An(V). But the validity of such a comparison is questionable since Pa(V) species is already hydrolyzed. A comparison with actinide aquo ions should involve an equilibrium between PaO³⁺ and [PaO(OH)]²⁺ for which there is no available data in aqueous solution.

Both hydrolysis equilibria of Pa(V) have been found endothermic, with standard enthalpy variation of 5 kJ mol⁻¹ and ~60 kJ mol⁻¹ for equilibria (1) and (2) respectively. No significant entropy variation has been associated to the first hydrolysis equilibrium, whereas a moderate entropic contribution (around 80 J K⁻¹mol⁻¹) seems to be involved in the second hydrolysis equilibrium [67]. Data about the temperature dependence on the hydrolysis of actinides are rather scarce. The first hydrolysis of U⁴⁺, Pu⁴⁺, and PuO₂²⁺ is also endothermic but with high entropic contribution in the case of tetravalent actinides (> 100 J K⁻¹mol⁻¹). Obviously the hydrolysis of Pa(V) is not comparable to that of other actinides.

Literature devoted to the behaviour of Pa(V) in alcaline medium is rather scarce. The formation of an anionic species was deduced from paper and anion exchange chromatography on samples prepared by alkaline fusion and solubilisation of a small fraction of the melt in water [72, 73]. Using DBM in successive direct and back extractions of Pa from aqueous solutions with 7 < pH < 11.04, Guillaumont confirmed the existence of a protactinate ion that should bear a charge -1 and correspond to $[Pa(OH)_6]^-$ [74]. No stability constant could be determined.

3.2. Complexation thermodynamics and structural information of known Pa(V) complexes: fluoride, sulfate and oxalate

194 The complexation of Pa(V) in hydrofluoric, sulfuric and oxalic solutions have been investigated at tracer scale and 195 millimolar scale allowing the determination of both thermodynamic and structural data. Various techniques have 196 been used in this way with mainly solvent extraction and ion exchange at tracer scale, but also potentiometry, 197 conductimetry and spectrophotometry at higher concentration [7, 24, 75]. Structural data were often obtained by a 198 combination of X-ray absorption spectroscopy and theoretical calculations. In that case, the concentration of 199 protactinium needs to be increased (mM scale) and thus, only complexes with higher stoichiometry could be 200 studied. Because the behaviour of Pa(V) in those media has now already been extensively related, the known data 201 will be briefly summarized and compared according to the media.

202 203

3.2.1. Thermodynamic aspects

Fluoride, and sulfate or hydrogenosulfate media are among the most commonly used complexing media for the study of protactinium in solution. Indeed, their complexing power allows to stabilize the protactinium at the + V oxidation state and to ensure a reproducibility of the results. Thus, a high solubility of Pa(V) is observed in hydrofluoric and sulfuric acids, and the complexes formed possess the highest stability in solution. However, different behaviours are observed with each medium, leading to either the formation of oxo and hydroxocomplexes, or the absence of oxo complexes. In each case, the protactinium speciation can be described by two parameters, pH and ligands concentration.

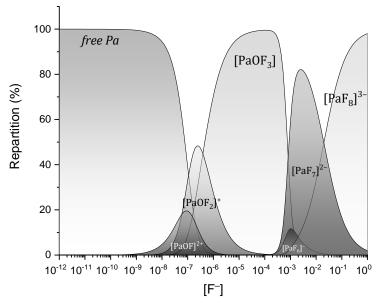




Figure 3: Distribution diagram of Pa-fluoride species at I = 3 M. The species $[PaF_4]^+$ and $[PaOF_4]^-$ have never 224 been detected experimentally. $[PaF_5]$ is a minor species (< 0.5 %).

In fluoride media, several species can occur in solution according to the pH and the fluorine content. However, the 211 212 widest range is observed for $[PaF_7]^{2-}$. Thus, complexes of stoichiometry from 1:1 to 1:8 are expected, with 213 homoleptic complexes from 1:5 to 1:8 and oxo/hydroxo complexes at lower stoichiometry. $[PaF_7]^{2-is}$ present in 214 solution when HF concentration is between 10^{-3} M and 4-8 M, whereas $[PaF_8]^{3-}$ appears in highly concentrated 215 fluoride medium (> 0.5 M) but at low acid conditions $(10^{-7} \text{ M} < [\text{H}^+] < 10^{-2} \text{ M})$ [76]. Otherwise, at hydrofluoric acid concentration lower than 10^{-3} M, oxo and hydroxyfluoro complexes become predominant [24]. The figure 3 216 217 depicts the distribution diagram of Pa(V)-fluoride species. It is worth noting the missing species $[PaF_4]^+$ and 218 [PaOF₄]⁻. These species have never been detected experimentally. Recent theoretical calculations performed to 219 attempt in elucidating this missing suggest that $[PaF_4]^+$ is more stable than $[PaOF_4]^-$ [76]. However, it seems that 220 $[PaF_4]^+$ reacts with one water molecule present in the first hydration sphere to form $[PaF_4OH]$.

226 In oxalic medium, literature is scarcer and more controversial. Various complexes, from 1:1 to 1:4 were observed 227 with and without mono-oxo or/and hydroxyl groups. However, the corresponding formation constants are not 228 always correlated to a suitable equilibrium [24]. Only, the first two complexation constants are consistent between 229 all studies. More recently, three oxalate complexes were determined with their stability constants, leading in each 230 case to the presence of the mono oxo bond: $[PaO(C_2O_4)]^+$, $[PaO(C_2O_4)_2]^-$ and $[PaO(C_2O_4)_3]^{3-}$ [77].

231 In sulfuric medium, the presence of this mono-oxo bond was also identified in complexes of stoichiometry 1:1 to

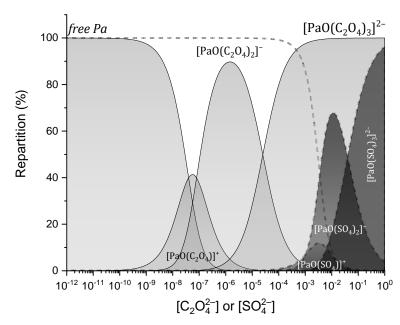
232 1:3. The associated formation constants have been determined at different values of ionic strength and temperature.

233 [24, 78, 79]. In the Figure 4 are merged the speciation diagram of Pa(V)- oxalate and sulfate species. It highlights

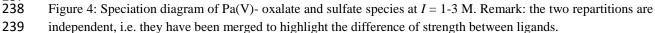
234 the relative strength of both ligands. According to Table 2, the relative capability of these three ligands to form 235 complexes with Pa(V) varies according to the following sequence:

3.2.2. Structural data

244 The presence or not of the mono-oxo bond in the protactinium(V) complexes has been verified mainly in 245 complexes with higher stoichiometry, using X-ray absorption spectroscopy at the Pa L_{III} edge [77, 80, 81]. This 246 technique is suitable to determine the local structure of actinide in solution, however presents some limitation, 247 especially using protactinium. Unlike other actinides, the XANES at the L_{III} edge does not allow to distinguish 248 complexes with a mono-oxo bond from a complex that does not possess one, due to the absence of the characteristic 249 linear transdioxo moiety for Pa(V) compared to other An(V). Thus, the speciation can only be determined from 250 EXAFS measurements, which required the use of protactinium in macro-concentration increasing polymerization 251 phenomenon if the complexation is not strong enough. For these reasons, the experimental structural studies of 252 Pa(V) complexes in solution are rather scarce. Despite these limitations, EXAFS experiments have been conducted 253 in HF, H_2SO_4 and oxalic media [77, 80, 81]. For instance, $[PaF_7]^{2-}$ has been characterized by an EXAFS spectrum 254 depicting a monotonic sinusoidal signal that features a single contribution from seven fluoride ligands located at 255 2.15 Å. For both oxalic and sulfuric medium, EXAFS spectra indicated the presence of a short mono-oxo bond at 1.75 and 1.72 Å. The structure of the $[PaO(C_2O_4)_3]^{3-}$ has been proposed as a complex with three oxalates 256 257 coordinated to Pa in a bidentate fashion (side-on arrangement) [77]. Unlike the oxalate complex, the structure of 258 the sulfate complex remains uncertain but the protactinium seems to be coordinated to sulfates in both monodentate 259 and bidentate fashion [80].

261 3.3 Complexation with polyamino carboxylic acids

262

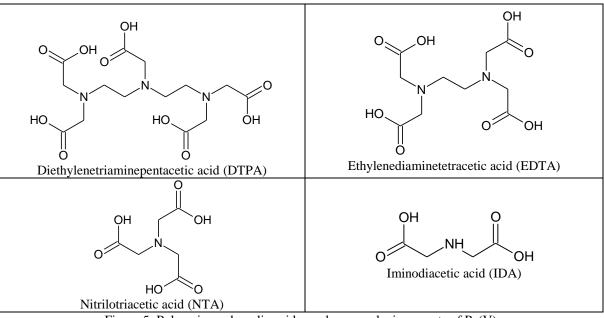
Polyaminocarboxylic acids (PACs) are composed of several nitrogen and oxygen atoms connected to two or more carboxyl groups. Because of their chelating properties, these ligands form strong complexes with metals including actinides. The speciation of PACs depends strongly on the acidity. For example, DTPA is involved in 8 acid dissociation equilibria starting from $[H_8DTPA]^{3+}$. The lack of knowledge of the dissociation constants of PACs at different values of ionic strength and temperature complicates the identification of complexes (protonation state) and may affect the accuracy of complexation constants. 269 Literature data about the complexation of protactinium(V) with aminopolycarboxylic acids are rather scarce. Until

now, only five studies have been dedicated to four of them (Figure 5): ethylenediaminetetraacetic acid (EDTA),

diethylenetriaminepentaacetic acid (DTPA), nitrilotriacetic acid (NTA) and iminodiacetic acid (IDA) [82-86]. In all studies, the Pa(V) complexation has been studied at tracer scale ($C_{Pa} < 10^{-8}$ M) using mainly solvent extraction

and/or ion exchange.

EDTA

From cation and anion exchange chromatography experiments in batch mode, Galateanu concluded that Pa(V) 278 279 forms complex of stoichiometry 1:1 with EDTA. Despite of the narrow range of pH used (2.4-2.7), different 280 complexes according to different protonation states have been proposed: cationic, anionic and neutral, but no 281 associated constant. In contrast, Shiokawa et al. and Ishibashi et al. deduced quantitative information from solvent 282 extraction experiments from HCl, resp. $HClO_4$ with TTA in benzene, resp. xylene [83, 84]. In both cases, the 283 speciation of Pa(V) in absence of ligand is questionable: on one side, $[Pa(OH)_2]^{3+}$ and on the other side a mixture of [PaO(OH)]²⁺ and [PaO(OH)₃], a speciation that is, considering the pH used, not consistent with the hydrolysis 284 constants available in the literature. Concerning the complex, Ishibashi et al. proposed the formulation 285 286 [PaO(OH)(EDTA)]²⁻ but did not exclude the non hydrolyzed species [PaO(EDTA)] and [Pa(EDTA)]. Despite a 287 discrepancy in the speciation, the stability constant obtained in both studies are very close: log $\beta = 22.1 \pm 0.1$ and 288 21.54 ± 0.03 , considering the totally deprotonated form of EDTA. This confirms a strong complexation between 289 Pa(V) and EDTA.

291 DTPA

292 Compared to EDTA, DTPA possesses one additionnel amine group and two additional carboxylic groups (Figure 293 4). Mendes et al. have studied the complexation of Pa(V) with DTPA combining solvent extraction and capillary 294 electrophoresis coupled to ICP-MS (CE-ICP-MS) at tracer scale [85]. From solvent extraction experiments 295 performed at constant ionic strength (0.1-3 M) and temperature (25-50 °C), they deduced the formation of a 1:1 296 complex in presence of DTPA. The authors also used CE-ICP-MS to determine the mean charge of the complex 297 of maximum stoichiometry and thus demonstrated the formation of a neutral complex. The use of DFT calculations 298 reduced the possibility to either [Pa(DTPA)], or [PaO(H₂DTPA)], as the complex formula. Mendes et al. proposed 299 the stability constant log $\beta = 25.34 \pm 0.12$ for the following equilibrium, at 25°C and with an ionic strength equal 300 to 1 M (Na,H)ClO₄.

However, the technique used does not allow one to preclude the presence of the oxo bond corresponding to theformulation [PaO(H₂DTPA)].

305 NTA

304

306 Compared to DTPA and EDTA, NTA is a smaller ligand that presents only one amine function with three 307 carboxylates groups, however NTA is known for still being a good chelating agent. A thermodynamic study has 308 been performed recently on the complexation of Pa(V) with NTA using solvent extraction at tracer scale and CE-309 ICP-MS [86]. Luchini et al., observed with this smaller ligand not only the 1:1 complex but also the 1:2. Coupling 310 this result to the study of the mean charge of the complex of maximum stoichiometry obtained by CE-ICP-MS, 311 they could propose the successive complexes as [PaO(NTA)] and [PaO(NTA)₂]³⁻ with stability constants of 15.16 312 ± 0.06 and 28.46 ± 0.06 , respectively.

IDA

The iminodiacetic acid is the smallest aminopolycarboxylic ligand that has been investigated with Pa(V). Its structure differs from that of the NTA molecule only by the substitution of a carboxylic function by a hydrogen atom. Like NTA, the maximum stoichiometry of the complexes deduced from partition data with Pa at tracer scale was found equal 2 [87]. As expected, the associated stability constants were smaller than for NTA (Table 3).

The values of the complex formation constants of Pa(V) with the different aminopolycarboxylic acids decreases with the size and the number of chelating groups. Thus, as expected, Pa(V)-DTPA form a more stable complex than Pa(V)-EDTA, Pa(V)-NTA and Pa(V)-IDA. Moreover, in presence of the smallest ligands (NTA and IDA), the complex of maximum stoichiometry 1:2 can also be formed. Until now, no experimental structural data have confirmed the speciation proposed for those complexes. Speciation techniques, such as EXAFS or FTIR combined to theoretical calculations would lead to verify those equilibria.

329 **4.Protactinium(IV)**

330

Studying the chemical properties of Pa(IV) in aqueous solutions represents a great challenge because of unstability of this oxidation state. Oxidation to Pa(V) occurs more or less rapidly and like other actinides (IV), its high reactivity results in strong tendency to precipitation for example with fluoride or phosphate. In most of the studies, Pa(IV) has been prepared by chemical reduction of Pa(V) under inert atmosphere leading sometimes to interference

with the property investigated. In solvent extraction experiments involving Pa at tracer scale, the reducing agent

Cr(II) has been found to be co-extracted with Pa in the TTA-benzene phase [41, 42, 44], but the formation of the

- 337 complexes between Cr and extractant can be limited by a judicious choice of pH and extractant concentration. No
- impact of Eu or Ti(III) has been observed [38, 46]. With Pa at millimolar scale, the presence of chloro complexes

of Hg^{2+} or Zn^{2+} , as well as rongalite, a powerful reducing agent used recently interfere with UV absorption bands of Pa(IV), but fortunately not with fluorescence emission.

341 Only one publication provides quantitative information on Pa(IV) hydrolysis at tracer scale [41]. According to 342 Guillaumont, the aquo ion Pa⁴⁺ would predominate for protons concentration higher than 3 M. The following

343 successive equilibra were then proposed:

347 characterized by $\log \beta_1 = -0.14$, $\log \beta_2 = -0.52$ and $\log \beta_3 = -1.77$. Since species differing from water molecules

348 cannot be distinguished, the species $[Pa(OH)_2]^{2+}$ and $[Pa(OH)_3]^+$ are equivalent to PaO^{2+} and $[PaO(OH)]^+$. The 349 corresponding speciation diagram is illustrated in Figure 6.

In non complexing media, polymerisation of Pa(IV) has been found to occur as soon as Pa concentration reaches 10⁻⁶ M. Due to the low solubility of Pa(IV) in perchloric media, UV-Vis spectrum has been registered on sample prepared by dissolution of $PaCl_4$ in HClO₄ [89]. Three bands have been observed at 225, 256 and 277 nm in 1.5

357 M HClO₄ ($C_{Pa} = 1.1 \ 10^{-3} \text{ M}$).

In 3 M HClO₄/HCl mixture and with Pa at tracer scale, the existence of complexes of stoichiometry 1:1 and 1:2 358 359 have been deduced from solvent extraction data [56]. The related constants are presented Table 4. In concentrated 360 HCl, the complex [PaCl₆]²⁻ should be formed according to Muxart et al. However, this is in contradiction with the 361 results of Pluchet et al. deduced from anion exchange chromatography experiments performed in concentrated 362 HCl (6-12 M) [39]. Changes in UV-Vis absorption spectra with HCl concentration have been attributed to the 363 formation of chloro complexes corresponding to the general formula $[PaCl_x]^{(4-x)}$ without any information about the maximum value of x. Moreover, spectra depend on the preparation method of Pa(IV). The presence of chloro 364 complexes of Zn^{2+} or Hg^{2+} [36, 90] might interfere with the absorption band of Pa(IV) at the lowest wavelength. 365 366 This interference is not observed in samples prepared by dissolution of PaCl₄ [36, 89].

In presence of sulphate species, Pa(IV) forms complexes of stoichiometry 1:1 and 1:2 in the form $[Pa(SO_4)_x]^{(5-2x)}$ in strong acidic medium (3 M). Only a complex of stoichiometry 1:1 containing hydroxo group has been observed at higher pH (Table 4). Absorption spectra are characterized by three bands whose position varies slightly with

sulphuric acid and free sulphate concentration. For example, absorption maxima are observed at 232.5, 265 and

371 287.5 nm in 1.4-4 M H₂SO₄, and at 237, 273 and 297 nm in 9 M H₂SO₄ [24, 34, 90].

372 At tracer scale, the fluoro-complexes $[PaF]^{3+}$ and $[PaF_2]^{2+}$ have been proposed by Guillaumont in HClO₄ 3 M and 373 fluoride concentration lower than 10^{-6} M. The very low solubility of PaF₄ hinders the study of successive

374 complexation and thus the characterization of complexes of higher stoichiometry using solvent extraction.

However, solubility of PaF_4 (2 mM) in ammonium fluoride and tetramethylammonium fluoride has been observed

- allowing absorption spectra to be registered [35, 91]. As compared to spectra in other mineral acids, spectra of
- $\label{eq:approx} \textbf{Pa}(IV) \text{ in fluoride media display only two well-defined absorption bands at 250 and 352.5 nm in 15 M NH_4F, the$
- third being a shoulder at around 220 nm [91]. These bands are observed at 323 and 344, with the shoulder at 230

379 nm in $(CH_3)_4NF$. The band at the highest wavelength may correspond the the species $[PaF_8]^{4-}$.

Studies of the complexation of Pa(IV) with chelating agents used as extractants have been performed only with the element at tracer scale [45, 92-94]. Surprisingly, the extraction mechanism has been proved to depend on the β -diketone: Pa(IV) is extracted with 4 TTA and 4 BA (benzoylacetone) molecules and only 2 AA molecules from (Li or Na, H)ClO₄ aqueous solutions [42, 45, 93]. Lundqvist, considering Pa(IV) in the form of PaO²⁺ (equivalent to [Pa(OH)₂]²⁺) as predominant species in aqueous phase, determined the constants associated to the following equilibria:

393 In their study of the complexation of Pa(IV) with EDTA in the system AA/Benzene/(Na,H)ClO₄, Lundqvist et al. 394 have shown the formation of complexes of 1:1 stoichiometry with different protonation states. The complexation 395 constant of PaO²⁺ with EDTA (totally deprotonated form) was found equal $10^{19.2}$ [94].

396Fluorescence spectroscopy has been used several times in order to study the $5f^1 \rightarrow 6d^1$ transition of Pa(IV), but397only in solid matrix until 2004. Those studies have demonstrated the Pa(IV) capacity to fluoresce leading to several398transitions from the lowest 6d level of Pa⁴⁺ to the different 5f levels [95].

399 The first fluorescence spectroscopy study has been reported in the literature in 2004 by Marquardt et al. [37]. They 400 analyzed Pa(IV) solution using Time Resolved Laser Fluorescence spectroscopy with several mineral acids such 401 as perchloric, hydrochloric and sulfuric acids. Thus, a laser excitation into the 6d levels, leads, in aqueous solution, 402 to a single broad band around 460 nm. By comparing the fluorescence emission spectra obtained in the various 403 acids, at different pH, they confirmed the use of TRLFS to study the speciation of Pa(IV) in solution. In HClO4, a 404 weakly complexing ligand, the emission band is observed at 465 nm, whereas with more complexing acids (HCl 405 and H₂SO₄), the emission band was blue-shifted up to 455 nm. Moreover, this hypsochromic shift, corresponding 406 to a complexation phenomenon, was more intense as the concentration of the acid increased. However, no 407 significant changes have been observed on the half-width and the lifetime (15-20 ns). Recently, these results were combined to the first EXAFS analysis performed on Pa^{4+} in solution at the Pa L_{III} 408

409 edge. Thus, Banik et al. have determined from these data and thanks to quantum calculations the hydration

- 410 structure of Pa^{4+} [47]. The difficulty of the measurement is mainly due to the stability of Pa(IV) that can undergo
- 411 photo-oxidation under the beam. By using rongalite as the reducing agent, and in a 6 M HCl, the first EXAFS
- 412 spectrum has been recorded. The white line is observed at 16737.3 eV, which is 4.2 eV below the white line of
- 413 Pa(V). From the EXAFS fitting, Pa^{4+} aquo ion has been found coordinated to nine water molecules with a Pa-O
- distance around 2.43 Å. This distance follows the same trend than the early tetravalent actinides according to their
- 415 ionic radii. Thus, Pa^{4+} , unlike Pa(V), act as the other tetravalent early actinides (from Th^{4+} to Bk^{4+}).

417 **5. Conclusion**

- The chemistry of protactinium is considered "capricious". From the moment it was discovered, it tested analytical chemistry as a whole and forced chemists to use ingenuity to confirm the nature of its chemical species. Whether at trace scale or macro-concentration, information remains often limited. Even today, the new methods recently used (CE-ICPMS, EXAFS) fail to give unequivocal information about the speciation of Pa. The researchers therefore developed complementary multi-technical strategies for extracting information. Today theoretical
- 423 chemistry seems to be one of the keys, not necessarily the only key, to help greatly in elucidating its behavior.
- 424 Unlike Pa(V), Pa(IV) appears to behave like a tetravalent actinide. As the first in the series of tetravalent actinides,
- 425 obtaining basic data is important. Spectroscopic techniques are available for this oxidation state and recent work
- 426 using for example Time-Resolved Laser Fluorescence Spectroscopy or Extended X-Ray Absorption Fine Structure
- 427 spectroscopy seems promising [37, 47].
- 428 The path is still long to master its behaviour in solution while predictive calculations of theoretical chemistry still
- require experimental data. Even today, analytical chemistry is still the most important tool for acquiring all missingdata.
