## Semi-classical Lagrangian intersections

${ }^{2}$ Aix Marseille Univ, Université de Toulon, CNRS, CPT, Marseille, France ; rouleux@univ-tln.fr Abstract: We investigate normal forms of germs of glancing Lagrangian intersections, and their semiclassical counterparts. This is motivated by singularities of Bessel beams, or diffraction problems by an obstacle with a non convex boundary.

## 0/ Introduction

Let $M=\mathbf{R}^{n}$, we restrict essentially to the case $n=2$.
Parametrices of linear PDE's on $M$ make use of symbolic calculus adapted to Lagrangian intersection, see [MelUhl] for high frequency asymptotics, and [AnDoNaRo] for semi-classics in the framework of Maslov canonical operator.

Let $H\left(x, h D_{x} ; h\right)$ be a $h$-PDO whose symbol has the asymptotic expansion $H(x, p ; h) \sim H_{0}(x, p)+$ $h H_{1}(x, p)+\cdots$, and assume that $H_{0}(x, p)=0$ is a smooth, non critical hypersurface, fibrated by Hamiltonian curves. To start with, we shall denote $H_{0}$ simply by $H$.

On the other hand, let $\Lambda \rightarrow T^{*} M$ be a smooth embedded Lagrangian manifold, and $f_{h}$ be a Lagrangian semi-classical distribution microlocally supported on $\Lambda$.

The main concern is to construct the asymptotic outgoing solution of

and in particular to solve Cauchy problem

\begin{equation*}
h D_{t} v_{h}+H\left(x, h D_{x}\right) v_{h}=0,\left.v_{h}\right|_{t=0}=f_{h} \tag{0.3}
\end{equation*}
$$

The local theory amounts to study germs of Lagrangian manifolds and hypersurfaces.
At the classical level the question is about a pair consisting of a Lagrangian submanifold $\Lambda$ (we call the "initial manifold") and a hypersurface $G=\{H=0\}$. We are interested in the set $\Lambda_{1}$ of characteristics of $H$ intersecting $\Lambda$. Global aspects of Lagrangian intersection theory were greatly motivated by Arnold conjectures [Ar] and have been extensively studied (see [ElGr]). Here we simply focus on the germs of the generating functions near an intersection point.

The generic case is when $v_{H}$ is transverse to $\Lambda$ at $t=0$, then $\Lambda_{1}$ is precisely the union of the outgoing/incoming flows $\Lambda_{ \pm}$of $\Lambda$ by the Hamilton vector field $v_{H}$ in $G$, see Theorem 1.1 below. This is the situation considered in [MelUhl] and [AnDoNaRo] : $\Lambda$ and $\Lambda_{+}$intersect cleanly along $\Lambda \cap \Lambda_{+}=\partial \Lambda_{+}$, and ( $\Lambda, \Lambda_{+}$) is called an intersecting pair of Lagrangian manifolds.

Here we want to consider a point $z \in \Lambda$ where the intersection is not clean, i.e. $v_{G} \in T_{z} \Lambda$. We call such a point a glancing point, and denote their set by $\mathcal{G}(\Lambda, G)$. We answer first the question :

- What is the classification of such pairs $(\Lambda, G)$ up to symplectic diffeomorphisms ?

Normal forms which deals with isolated points of non-transversality, called a kiss ([ElGr,p.19]. This is "the generic case", which has been investigated in [ZaMy], using Morse families. We recall the most simple type of kiss in Theorem 1.2 below.

In case $G$ is tangent to $\Lambda$ along a non-singular hypersurface $\ell \subset \Lambda$, we call $(\Lambda, \ell, H)$ a triad.
Of course, such a pair uniquely defines the Lagrangian submanifold $\Lambda_{1}$.
Next we consider the semi-classical level, and try to represent the solution of (0.3) and (0.2) near a glancing point. The first step is to construct the solution of Hamilton-Jacobi equation parametrizing $\Lambda_{1}$, which is generically singular.

A similar problem arises in diffraction theory for the wave equation $H=\partial_{t}^{2}-\Delta_{x}$ in $M=$ $\left(\mathbf{R}_{x}^{n} \backslash \mathcal{O}\right) \times \mathbf{R}_{t}$ outside an obstacle $\mathcal{O}:$ the question here is about the classification of glancing hypersurfaces $(F, G)$ in $T^{*} M$ at some point $z$. Here $G=\left\{\tau^{2}-\xi^{2}=0\right\}$ and $F$ stands for the lift of the boundary of $\mathcal{O}$ in $T^{*} M$. It turns out that $F$ and $G$ play symmetrical roles.

A theorem of Melrose [Hö,Theorem 21.4.8] says that such a pair, near the glancing point $z$, is symplectically equivalent to $F=\left\{x_{1}=0\right\}$ and $G=\left\{g=\xi_{1}^{2}-x_{1}-\xi_{2}=0\right\}$.

The second main question we adress here is the following:

- Given a pair of glancing hypersurfaces $(F, G)$ in $T^{*} M$ at some point $z$, find the germs at $z$ of some Lagrangian manifolds $\Lambda$ transverse to $F$ at $z$ and such that $v_{g} \in T_{z} \Lambda$ ?

There are indeed such one-parameter families of $\Lambda$, for which we compute $A_{z}(\Lambda, G), B_{z}(\Lambda, G)$, see Propositions 3.1-3.2 below.

Next we construct solutions of Hamilton-Jacobi equation for $h D_{t}+\left(h D_{x_{1}}\right)^{2}-x_{1}-h D_{x_{2}}$ with initial condition on $\Lambda$. This, conveniently adapted to dimensions $n \geq 3$, could be applied to the diffractive Cauchy problem above when the obstacle is not necessarily convex at a point of the boundary, see [Le], [Sm].

## 1/ Lagrangian intersections

First recall the situation where $v_{H}$ is transverse to $\Lambda$.
Let $\iota_{0}: \Lambda_{0} \rightarrow T^{*} M$ be a smooth embedded Lagrangian manifold, and $\iota_{1}: \Lambda_{1} \rightarrow T^{*} M$ be a smooth embedded Lagrangian manifold with smooth boundary $\partial \Lambda_{1}$ (isotropic manifold). Following [MelUhl] we say that $\left(\Lambda_{0}, \Lambda_{1}\right)$ is an intersecting pair of Lagrangian manifolds iff $\Lambda_{0} \cap \Lambda_{1}=\partial \Lambda_{1}$ and the intersection is clean, i.e.

$$
\begin{equation*}
\forall z \in \partial \Lambda_{1} \quad T_{z} \Lambda_{0} \cap T_{z} \Lambda_{1}=T_{z} \partial \Lambda_{1} \tag{1.1}
\end{equation*}
$$

(in particular $\Lambda_{0}$ and $\Lambda_{1}$ cannot be transverse). On the set of intersecting pairs of Lagrangian manifolds we define an equivalence relation by saying that $\left(\Lambda_{0}, \Lambda_{1}\right) \sim\left(\Lambda_{0}^{\prime}, \Lambda_{1}^{\prime}\right)$ iff near any $z \in \partial \Lambda_{1}$, $z^{\prime} \in \partial \Lambda_{1}^{\prime}$, there is a symplectic map $\kappa$ such that $\kappa(z)=z^{\prime}$, and a neighbhd $V \subset T^{*} M$ of $z$ such that $\kappa\left(\Lambda_{0} \cap V\right) \subset \Lambda_{0}^{\prime}, \kappa\left(\Lambda_{1} \cap V\right) \subset \Lambda_{1}^{\prime}$. We will call the equivalence class a Lagrangian pair. The following result readily extends [MelUhl, Prop.1.3] in the special case of homogeneous Lagrangian manifolds :

Theorem 1.1 [MelUhl]: All intersecting pairs of manifolds in $T^{*} M$ are locally equivalent. More precisely near each $z \in T^{*} M$, there exists a canonical map $\kappa: T^{*} M \rightarrow T^{*} \mathbf{R}^{n}$ such that $\kappa(z)=(0,0)$,
$\kappa\left(\Lambda_{0} \cap V\right) \subset T_{0}^{*} \mathbf{R}^{n}$ (vertical fiber at 0), and $\kappa\left(\Lambda_{1} \cap V\right) \subset \Lambda_{+}^{0}$, $\Lambda_{+}^{0}$ being the flow-out of $T_{0}^{*} \mathbf{R}^{n}$ by the Hamilton vector field $v_{\xi_{n}}=((0, \cdots, 0,1), 0)$ of $\xi_{n}$, passing through some $(0 ; \xi)=\left(0 ;\left(\xi^{\prime}, 0\right)\right)$ i.e.

$$
\begin{equation*}
\Lambda_{+}^{0}=\left\{(x, \xi) \in T^{*} \mathbf{R}^{n}: x=\left(0, x_{n}\right), \xi=\left(\xi^{\prime}, 0\right), x_{n}>0\right\} \tag{1.5}
\end{equation*}
$$

Lemma 1.1 has its semi-classical counterpart : near a point $z$ of intersecting pair the normal form for $\Lambda$ is given by $\{x=0\}$ and this of $H$ is (say) $h D_{x_{n}}$. This solves locally problem (0.2). Namely, let $f_{h}$ be a Lagrangian distribution defined by its amplitude $a\left(x^{\prime}, x_{n}-t, \xi ; h\right)$, and supported microlocally on the "vertical plane" $\Lambda=\{x=0\}$. Let $\theta_{T} \in C^{\infty}\left(\mathbf{R}_{+}\right)$vanish near $+\infty$ and equal to 1 for $t \leq T$, then

\begin{equation*}
u(x, h)=\frac{i}{h} \int_{0}^{\infty} \theta_{T}(t) d t \int e^{i\left(x^{\prime} \xi^{\prime}+\left(x_{n}-t\right) \xi_{n}\right) / h} a\left(x^{\prime}, x_{n}-t, \xi ; h\right) d \xi \tag{1.6}
\end{equation*}
$$

satisfies $(0.2) \bmod \mathcal{O}\left(h^{\infty}\right)$ whenever $x_{n} \leq T / 2$.
Assume instead that Hamilton foliation of $H$ is simply tangent to $\Lambda$ at some $z_{0} \in \Lambda \cap\{H=0\}$. Then $\Lambda_{1}$ is a singular Lagrangian manifold near $z_{0}$, and the intersection $\Lambda \cap \Lambda_{1}$ is not clean. Such a point $z_{0}$ of non-transversality is called glancing.

Near a glancing point Theorem 1.1 does not apply. So we need to extend (locally) Theorem 1.1 to this situation, by finding the normal form of non Lagrangian (or "glancing") intersection for ( $\Lambda, G$ ) near $z_{0}$.

We have the following :
Theorem 1.2 [ZaMy]: Assume the germs $(\Lambda, G)$ are non-transversal at an isolated point $z_{0} \in T^{*} M$, then $(\Lambda, G)$ has generically the following normal form, up to a symplectic transformation $\kappa_{ \pm}$

\begin{equation*}
\Lambda=\left\{\xi=\frac{\partial \phi_{ \pm}}{\partial x}\right\}, \quad G=\{g=0\} \tag{1.7}
\end{equation*}
$$

where $g(x, \xi)=\xi_{1}$ and the generating functions $\phi_{ \pm}(x)= \pm \frac{x_{1}^{3}}{3}+x_{1} x_{2}^{2}$.
The proof is based on the theory of Morse families, see e.g. [BaWe].
In the case of $\phi_{-}(x)$ we get the two isotropic lines $x_{1}= \pm x_{2}, \xi_{2}= \pm 2 x_{2}^{2}, \xi_{1}=0$ in the intersection of $\Lambda$ with the Hamiltonian level $\xi_{1}=0$. Their extension along the characteristics $\xi_{1}=\xi_{2}=x_{2}=0$ $\left(v_{H}=(1,0 ; 0,0)\right.$ at $\left.z_{0}\right)$ is the union of two Lagrangian submanifolds $\left\{\xi_{1}=0, \xi_{2}= \pm 2 x_{2}^{2}\right\}$.

In the case of $\phi_{+}(x)$, the intersection of $\Lambda$ with $\xi_{1}=0$ reduces to $x=0$.
We are now to define some invariants of $(\Lambda, G)$ at $z=z_{0}$.
Definition 1.3: Define $\Lambda$ locally near $z$ by $f_{1}=f_{2}=0$, with $\left\{f_{i}, f_{j}\right\}=0$. Consider the symmetric matrix

A_{z}=A_{z}(\Lambda, G)=\left(\begin{array}{cc}
\left\{f_{2},\left\{f_{2}, g\right\}\right\} & -\left\{f_{1},\left\{f_{2}, g\right\}\right\} \\
-\left\{f_{2},\left\{f_{1}, g\right\}\right\} & \left\{f_{1},\left\{f_{1}, g\right\}\right\}
\end{array}\right)(z)
$$

and the vector

$$
B_{z}=B_{z}(\Lambda, G)=\binom{\left\{g,\left\{g, f_{1}\right\}\right\}}{\left\{g,\left\{g, f_{2}\right\}\right\}}(z)
$$

Let $z$ be a glancing point for the pair $(\Lambda, G)$ i.e.

$$
g(z)=f_{1}(z)=f_{2}(z)=0,\left\{g, f_{1}\right\}(z)=\left\{g, f_{2}\right\}(z)=0
$$

We distinguish the following 10 possibilities for the 2-jets of $(\Lambda, G)_{z}$ :

$$
\begin{align*}
& \operatorname{det} A_{z}>0, B_{z} \neq 0  \tag{1}\\
& \operatorname{det} A_{z}>0, B_{z}=0  \tag{2}\\
& \operatorname{det} A_{z}<0,{ }^{t} B_{z} A_{z} B_{z} \neq 0  \tag{3}\\
& \operatorname{det} A_{z}<0,{ }^{t} B_{z} A_{z} B_{z}=0, B_{z} \neq 0  \tag{4}\\
& \operatorname{det} A_{z}<0, B_{z}=0  \tag{5}\\
& \operatorname{det} A_{z}=0,{ }^{t} B_{z} A_{z} B_{z} \neq 0  \tag{6}\\
& \operatorname{det} A_{z}=0, A_{z} \neq 0,{ }^{t} B_{z} A_{z} B_{z}=0, B_{z} \neq 0  \tag{7}\\
& \operatorname{det} A_{z}=0, A_{z} \neq 0, B_{z}=0  \tag{8}\\
& A_{z}=0, B_{z} \neq 0  \tag{9}\\
& A_{z}=0, B_{z}=0 \tag{10}
\end{align*}
$$

Remark 1.1: Of course, $A_{z}$ and $B_{z}$ are invariant under symplectic transformations, but they are not uniquely defined. However each of the cases above is preserved by a non-degenerate linear transformation of the type $\binom{f_{1}^{\prime}}{f_{2}^{\prime}}=P\binom{f_{1}}{f_{2}}$, where $P \in \mathrm{GL}(2)$ has variable coefficients. Namely if $A_{z}^{\prime}$ is defined as $A_{z}$ with $f_{1}^{\prime}, f_{2}^{\prime}$ instead of $f_{1}, f_{2}$, then

A_{z}^{\prime}=\left(\operatorname{det} P_{z}\right)^{2 t} P_{z}^{-1} A_{z} P_{z}^{-1}, B_{z}^{\prime}=P_{z} B_{z}
$$

However $A_{z}$ and $B_{z}$ cannot account for higher order terms occurring in the classification of [ZyMa].
Under the hypothesis of Theorem 1.2, an elementary computation shows that $f_{1}=\xi_{1} \mp x_{1}^{2}-$ $x_{2}^{2}, f_{2}=\xi_{2}-2 x_{1} x_{2}, g=\xi_{1}:$

A_{0}^{ \pm}=\left(\begin{array}{cc}
2 & 0 \\
0 & \pm 2
\end{array}\right), \quad B_{ \pm}(0)=\binom{\mp 2}{0}
$$

so we are in case (1) for + , and in case (3) for - .
We turn now to the semi-classical level, and try to solve (0.2) or (0.3). Recall $\Lambda_{t}=\exp t v_{H}(\Lambda)$ verifies $\Lambda_{t+s}=\exp t v_{H}\left(\Lambda_{s}\right)$ for all $t, s \geq 0$. Let $\Gamma_{t}$ be the set of points of $\Lambda_{t}$ such that $v_{H}$ is tangent to $\Lambda_{t}$, we have also $\Gamma_{t+s}=\exp t v_{H}\left(\Gamma_{s}\right)$. So the glancing property is invariant under the Hamiltonian flow.

We can trivially solve in the $\left(\xi_{1}, x_{2}\right)$ coordinates Hamilton-Jacobi equation $\frac{\partial \Psi}{\partial t}+\frac{\partial \Psi}{\partial x_{1}}=0,\left.\Psi\right|_{t=0}=$ $\phi\left(x_{1}, x_{2}\right)$. This gives $\Psi\left(t, x_{1}, x_{2}\right)=\phi\left(-t+x_{1}, x_{2}\right)$, so the condition

$$
\left.\Psi\right|_{t=0}=\phi_{ \pm}
$$

gives

$$
\begin{equation*}
\Psi_{ \pm}\left(t, x_{1}, x_{2}\right)= \pm \frac{1}{3}\left(-t+x_{1}\right)^{3}+\left(-t+x_{1}\right) x_{2}^{2} \tag{1.10}
\end{equation*}
$$

By definition

$$
\Lambda_{1}=\left\{\xi_{1}=\frac{\partial \Psi}{\partial x_{1}}=0, \xi_{2}=\frac{\partial \Psi}{\partial x_{2}}\right\}=\left\{\xi_{1}= \pm\left(-t+x_{1}\right)^{2}+x_{2}^{2}=0, \xi_{2}=2\left(-t+x_{1}\right) x_{2}\right\}
$$

For $\Psi_{+}$we get:

$$
\Lambda_{1}=\left\{\xi_{1}=0, t=x_{1}, x_{2}=0, \xi_{2}=0\right\}
$$

This is a one-dimensional isotropic submanifold because the intersection $\Lambda$ and $G$ is a point. For $\Psi_{-}$ we get:

$$
\Lambda_{1}=\left\{\xi_{1}=0, t=x_{1} \pm x_{2}, \xi_{2}=\mp 2 x_{2}^{2}\right\}
$$

This is a Lagrangian submanifold with a singular line.

## 2/ Examples of non-Lagrangian intersections.

Consider a positively homogeneous Hamiltonian $H(x, p)$ of degree $m$ with respect to $p$. The energy surface should then be specified as $H(x, p)=E$. We first classify points $z=(x, p) \in G=$ $\{H=E\}$ according to $v_{H}(z)$.

Definition 2.1 [AnDoNaRo3]: Let $H$ be positively homogeneous of degree $m$ with respect to $p$. We call a point $z=(x, p)$ such that $-\partial_{x} H(z) \neq 0$ an ordinary point if $\left\langle-\partial_{x} H(z), p\right\rangle \neq 0$, and a special point otherwise. If $-\partial_{x} H(z)=0$ we call $z$ a residual point.

Examples 2.1:
(1) For Tricomi Hamiltonian, $H(x, p)=x_{2} p_{1}^{2}+p_{2}^{2}$, the residual points are those for $p_{1}=0$, the special points those for $p_{1} \neq 0$ but $p_{2}=0$, and the ordinary points those for $p_{1} p_{2} \neq 0$.
(2) For Métivier Hamiltonian, $H(x, p)=p_{1}^{2}+\left(x_{1}^{2}+x_{2}^{2}\right) p_{2}^{2}$, the residual points are given by $p_{2}=0$ or $x=\left(x_{1}, x_{2}\right)=0$, the special points by $p_{2} \neq 0$ and $x \neq 0$, but $\langle p, x\rangle=0$, and the ordinary points by $p_{2}\langle x, p\rangle \neq 0$.
(3) Let $H$ be the "conformal metric" given by

$$
\begin{equation*}
H(x, p)=|p|^{m} \frac{1}{\rho(x)} \tag{2.1}
\end{equation*}
$$

where $\rho$ is a smooth positive function on $M, m \geq 1$. The residual points are the critical points of $\rho$; at a special point, $\langle\nabla \rho, p\rangle=0$, i.e. $v_{H}$ is tangent to the level curves of $\rho$. This example of practical interest was extensively studied in [AnDoNaRo2,3].

Together with $H$ positively homogeneous of degree $m$, consider an initial manifold $\Lambda$. In the following we try to link Lagrangian intersections with the classification above.

We take first $\Lambda=T_{x_{0}}^{*} M \approx\left\{x=x_{0}\right\}$ (conormal bundle to $\left\{x_{0}\right\}$ in $T^{*} M$ ). Then $\Lambda$ intersects cleanly $\Lambda_{+}$along $\partial \Lambda_{+}$.

Consider next the "initial" Lagrangian manifold

$$
\begin{equation*}
\Lambda=\{x=X(\varphi, \psi)=\varphi \omega(\psi), p=P(\varphi, \psi)=\omega(\psi), \varphi \in \mathbf{R}\} \tag{2.3}
\end{equation*}
$$

which is called the "cylinder" ; here $\omega \in \mathbf{S}^{n-1}$ is the unit vector parametrized by $\psi$. This is the wave-front set of semi-classical distributions related with Bessel functions.

Let us check first the Lagrangian intersection in this case. The tangent space $T_{z} \Lambda$ has the parametric equations

$$
\delta X=\omega(\psi) \delta \varphi+\varphi \omega^{\perp}(\psi) \delta \psi, \quad \delta P=\omega^{\perp}(\psi) \delta \psi, \quad \delta \varphi, \delta \psi \in \mathbf{R}
$$

so $v_{H} \in T_{z} \Lambda$ iff there exist $(\delta \psi, \delta \varphi)$ such that

$$
\partial_{p} H=\omega(\psi) \delta \varphi+\varphi \omega^{\perp}(\psi) \delta \psi, \quad-\partial_{x} H=\omega^{\perp}(\psi) \delta \psi
$$

Taking scalar products with $\omega(\psi), \omega^{\perp}(\psi)$, and using Euler identity, we get $\delta \varphi=\left\langle\partial_{p} H, P(\psi)\right\rangle=m H=$ $m E, \delta \psi=\left\langle-\partial_{x} H, \omega^{\perp}(\psi)\right\rangle$. Then, for $z \in \Sigma_{E}$,

$$
\begin{equation*}
\left\langle\partial_{p} H+\varphi \partial_{x} H, \omega^{\perp}(\psi)\right\rangle=0, \quad\left\langle-\partial_{x} H, \omega(\psi)\right\rangle=0, \quad H(z)=0 \tag{2.5}
\end{equation*}
$$

Second relation (2.5) means that $z=(\varphi \omega(\psi), \omega(\psi))$ is a special point (Definition 1.2). Since $\left(\omega(\psi), \omega^{\perp}(\psi)\right.$ form a basis of $\mathbf{R}^{2}$, these relations are necessary and sufficient for $v_{H} \in T_{z} \Lambda$, i.e. $z$ to be glancing.

## Examples 2.2:

(4) When $H=p^{2}$, all points are glancing. When $H=\frac{|p|^{m}}{\rho(x)}, z(0)$ is a glancing point iff

$$
\begin{equation*}
\text { either : } \varphi \neq 0 \text { and } \nabla \rho=0 \text {, or : } \varphi=0 \text { and }\langle\nabla \rho(0), \omega(\psi)\rangle=0 \tag{2.6}
\end{equation*}
$$

Second condition means that if $z(0)=(0, \omega(\psi))$ is a special point.
(5) Assume again $M=\mathbf{R}^{2}$. For $a, b \in \mathbf{R}$, let $\rho(x)=1+a x_{1}^{2}+b x_{2}^{2}$. Consider Hamiltonian on $T^{*} \mathbf{R}^{2}$ of the form

$$
H(x, p)=\frac{\langle\mu, p\rangle}{\rho(x)}
$$

with $\mu=(1,0)$. A computation shows that, with $x_{1}=\varphi \cos \psi, x_{2}=\varphi \sin \psi$

$$
\begin{aligned}
& \left\langle-\partial_{x} H, \omega(\psi)\right\rangle=\frac{2 \varphi \cos \psi}{\rho^{2}(x)}\left(a \cos ^{2} \psi+b \sin ^{2} \psi\right) \\
& -\rho^{2}(x)\left\langle-\partial_{x} H, \omega(\psi)\right\rangle=\left(\rho(x)+2 \varphi^{2} \cos ^{2} \psi(a-b)\right) \sin \psi
\end{aligned}
$$

so choosing $a>b>0$ and $E>1$, we see that $\mathcal{G}(\Lambda, G)=\emptyset$. Otherwise, there may be a unique glancing point near $x=0$.
(6) Consider Hamiltonian with constant coefficients $H(x, p)=\langle\mu, p\rangle$, then when $\omega(\psi)$ is parallel to $\mu$, the corresponding ray is contained entirely in $\Lambda$, so the intersection is not transverse. This corresponds to a triad.
(7) Here is another example of a triad. Consider the scattering problem by an obstacle, e.g. $H=$ $-\Delta$ on $L^{2}\left(\mathbf{R}^{2} \backslash \mathcal{O}\right)$ with Dirichlet boundary conditions on $\partial \mathcal{O}$, and $E=1$ so that the characteristics are parametrized by arc-length.

Let $\ell$ be a Lagrangian submanifold in $\left\{T^{*} \partial \mathcal{O}: p^{2}=1\right\}$ and $\Lambda$ be its preimage under the natural projection $T_{\partial \mathcal{O}}^{*} \mathbf{R}^{2} \rightarrow T^{*} \partial \mathcal{O}$. Then $\left(\Lambda, \ell,\left\{p^{2}=1\right\}\right)$ is a triad and the union of all characteristics in $p^{2}=1$ intersecting $\ell$ is a Lagrangian submanifold $\Lambda_{1}$ with singularities.

For example, $\Lambda_{1}$ has cusps along the ray being tangent to an inflection point of $\partial \mathcal{O}$. If $n=3$ then $\Lambda_{1}$ can have more interesting singularities: open swallow-tails and open Whitney umbrellas (see [Arn], [Gi], [Sch]).

The submanifold $\Lambda_{1}$ gives a short-wave approximation of solutions for the obstacle problem. When $\Lambda_{1}$ is singular this is of particular interest since we cannot resort to standard Maslov canonical operator.

Remark 2.2: When $(\Lambda, G)$ are given by (2.3) and (2.1) and $m=1, G=\{H=E\}$ there is a general Morse family parametrizing $\Lambda_{t}$, of the form

\Phi(x, t, \psi, \varphi, \lambda)=m E t+\varphi+\lambda\langle P(t, \varphi, \psi), x-X(t, \varphi, \psi)\rangle
$$

where $m E t+\varphi$ is an eikonal coordinate, and $(X, P)$ the solution of Hamilton equations $\dot{X}=\partial_{x} H, \dot{P}=$ $-\partial_{x} H$ with prescribed value on $\Lambda$, see [AnDoNaRo3]. But for a glancing Lagrangian intersection, this formula is of little help.

## 3/ Glancing hypersurfaces and Lagrangian intersections.

Let $F, G$ be two smooth hypersurfaces of $T^{*} M$ intersecting transversally at $z$. Recall from [Hö,Definition 21.4.6] $F$ and $G$ are said to be glancing at $z$ iff the Hamilton foliation of $F=\{f=0\}$ and $G=\{g=0\}$ (locally near $z$ ) are simply tangent at $z$.

Stated otherwise, we have $f(z)=g(z)=\{f, g\}(z)=0$ (Poisson bracket), but the second Poisson brackets $\{f,\{f, g\}\}(z),\{g,\{g, f\}\}(z)$ are non zero.

By the theorem of equivalence of glancing hypersurfaces of Melrose [Hö,Theorem 21.4.8] there are local symplectic coordinates $(x, \xi)$ vanishing at $z$ such that $F, G$ are defined resp. by $x_{1}=0$ and $\xi_{1}^{2}-x_{1}-\xi_{2}=0$. Then $g=\xi_{1}^{2}-x_{1}-\xi_{2}=0$ will be the "normal form" of $H$ in these coordinates. (We use the notation $g$ for the normal form of $H$, or $H-E$ ).

We apply this theorem to $G$ being the energy surface $H=E$ (i.e. $g=0$ ) and $F$ an auxiliary hypersurface intersecting $G$ transversally at a glancing point $z$. We want to find germs of Lagrangian manifolds $\Lambda$ such that $\Lambda$ is transverse to $F$ at $z$ but $(\Lambda, G)$ has glancing intersection at $z$. Again, this means that $T_{z} \Lambda \cap\left(T_{z} F\right)^{\sigma}=\{0\}$ and $\mathbf{R} v_{H}(z)=\left(T_{z} G\right)^{\sigma} \subset T_{z} \Lambda$, where superscript $\sigma$ denotes symplectic orthogonal.

All computations below will be carried out in the local symplectic coordinates $(x, \xi)$ vanishing at $z$.

### 3.1 Constructing some phase functions parametrizing $\Lambda$.

The Hamiltonian vector field for $g=\xi_{1}^{2}-x_{1}-\xi_{2}$ takes the form $v_{g}=2 \xi_{1} \partial_{x_{1}}-\partial_{x_{2}}+\partial_{\xi_{1}}$, or using coordinates $(\delta x, \delta \xi)$ in $T T^{*} M$, as

$$
\begin{equation*}
v_{g}=\left(\delta x_{1}, \delta x_{2} ; \delta \xi_{1}, \delta \xi_{2}\right)=\left(2 \xi_{1},-1 ; 1,0\right) \tag{3.2}
\end{equation*}
$$

We know that a general Lagrangian manifold can be parametrized in the mixed representation, so when $n=2$ by one of the following cases

$$
\begin{align*}
& \text { (I) } \Lambda=\left\{\xi=\frac{\partial \phi}{\partial x}\right\}, \text { (II) } \Lambda=\left\{x=-\frac{\partial \phi}{\partial \xi}\right\} \\
& \text { (III) } \Lambda=\left\{x_{1}=-\frac{\partial \phi}{\partial \xi_{1}}, \xi_{2}=\frac{\partial \phi}{\partial x_{2}}, \text { (IV) } \Lambda=\left\{x_{2}=-\frac{\partial \phi}{\partial \xi_{2}}, \xi_{1}=\frac{\partial \phi}{\partial x_{1}}\right\}\right. \tag{3.3}
\end{align*}
$$

To determine $\Lambda$, we write that the glancing intersection of $(\Lambda, G)$ at $z$ should take place at $z=$ $\left(x_{1}, x_{2}, \xi_{1}, \xi_{2}\right)=0$, i.e. for $z$ small enough, $v_{g}(z) \in T_{z} \Lambda$ implies $z=0$. Then we check that $\Lambda$ is transverse to $F$ at $z=0$. There will be of course many possibilities for $\Lambda$, and we content ourselves with a few significant examples.

The linear situation is the case where $\phi$ is quadratic. Cases (I),(II),(III) give one-parameter families of Lagrangian manifolds. We show that Case (IV) does not occur.
Proposition 3.1: Consider first a quadratic phase $\phi=\phi_{0}$.

- In Cases (I),(II),(III) $\phi_{0}$ are one-parameter families taking values

$$
\begin{equation*}
\text { (I) } \phi_{0}(x)=\frac{1}{2}\left(a x_{1}^{2}-2 x_{1} x_{2}\right), \text { (II) } \phi_{0}(\xi)=\frac{1}{2}\left(2 \xi_{1} \xi_{2}+c \xi_{2}^{2}\right), \text { (III) } \phi_{0}\left(x_{2}, \xi_{1}\right)=\frac{1}{2} b\left(\xi_{1}+x_{2}\right)^{2} \tag{3.4}
\end{equation*}
$$

respectively, where $a, b, c \neq 0$. The manifold $\Lambda$ is transverse to $F$ at $z=0$, and the corresponding matrices $A_{z}(\Lambda, G), B_{z}(\Lambda, G)$ in Definition 1.3 are then given by

$$
\begin{align*}
& \text { (I) } A_{z}=2\left(\begin{array}{cc}
1 & a \\
a & a^{2}
\end{array}\right), B_{z}=2\binom{-a}{1}, \text { (II) } A_{z}=2\left(\begin{array}{ll}
0 & 0 \\
0 & 1
\end{array}\right), B_{z}=2\binom{1}{0} \\
& \text { (III) } A_{z}=2\left(\begin{array}{ll}
0 & 0 \\
0 & 1
\end{array}\right), B_{z}=2\binom{1}{0} \tag{3.5}
\end{align*}
$$

So with the notations of Definition 1.3, case (I) is of type (6) or (7) according to $a^{3}+2 a^{2}+1=0$ or not, while cases (II) and and (III) are of type (6).

- Case (IV) does not occur.

Proof:

- Case (I). The quadratic phase takes the form $\phi_{0}=\frac{1}{2}\left(a x_{1}^{2}+2 b x_{1} x_{2}+c x_{2}^{2}\right)$. That $v_{g}$ be tangent to $\Lambda$ at $z$ express as

$$
\begin{equation*}
\left(\delta x_{1}, \delta x_{2} ; a \delta x_{1}+b \delta x_{2}, b \delta x_{1}+c \delta x_{2}\right)=\left(2 \xi_{1},-1 ; 1,0\right) \tag{3.6}
\end{equation*}
$$

By substitution we find $\xi_{1}=\frac{b+1}{2 a}=\frac{c}{2 b}$, so condition $\xi_{1}=0$ gives $b+1=c=0$. Substituting in $\xi_{1}=a x_{1}+b x_{2}$ gives $a x_{1}-x_{2}=0$. Then the condition $z \in G$, namely $g=0$ gives $-x_{1}-\xi_{2}=0$, so altogether $x_{1}=-\xi_{2}=\frac{x_{2}}{a}, \xi_{1}=0$, and $z=\left(x_{1}, a x_{1}, 0,-x_{1}\right)$. Finally the condition $z \in F$ gives $x_{1}=0$, hence $z \in F \cap G$ gives $z=0$. So the phase $\phi_{0}$ defining $\Lambda$ is given by $\phi_{0}=\frac{1}{2}\left(a x_{1}^{2}-2 x_{1} x_{2}\right)$. It is also clear that $\Lambda$ is transverse to $F$ at $z=0$. Let us compute the matrix elements of $A_{z}, B_{z}$. With $f_{j}=\xi_{j}-\frac{\partial \phi}{\partial x_{j}}$, we have

$$
\left\{f_{1},\left\{f_{1}, g\right\}\right\}=2 a^{2},\left\{f_{2},\left\{f_{2}, g\right\}\right\}=2,\left\{f_{1},\left\{f_{2}, g\right\}\right\}=-2 a,\left\{g,\left\{g, f_{1}\right\}\right\}=-2 a,\left\{g,\left\{g, f_{2}\right\}\right\}=2
$$

which gives (3.5)(I).

- Case (II). The phase is of the form $\phi_{0}=\frac{1}{2}\left(a \xi_{1}^{2}+2 b \xi_{1} \xi_{2}+c \xi_{2}^{2}\right)$, Hamilton vector field $v_{g}=\left(-a \delta \xi_{1}-\right.$ $\left.b \delta \xi_{2},-b \delta \xi_{1}-c \delta \xi_{2} ; \delta \xi_{1}, \delta \xi_{2}\right)=\left(2 \xi_{1},-1 ; 1,0\right)$, so necessary condition $\xi_{1}=0$ gives $a=0, b=1$. The condition $z \in G$ gives $z=\left(-\xi_{2},-c \xi_{2} ; 0, \xi_{2}\right)$, and the condition $z \in \Lambda$ gives $-x_{2}=0$, so we get $z=0$. The phase defining $\Lambda$ is given by $\phi_{0}=\frac{1}{2}\left(2 \xi_{1} \xi_{2}+c \xi_{2}^{2}\right)$. Again $\Lambda$ is transverse to $F$ at $z=0$. With $f_{j}=x_{j}+\frac{\partial \phi}{\partial \xi_{j}}$, we have

$$
\left\{f_{1},\left\{f_{1}, g\right\}\right\}=2,\left\{f_{2},\left\{f_{2}, g\right\}\right\}=0,\left\{f_{1},\left\{f_{2}, g\right\}\right\}=0,\left\{g,\left\{g, f_{1}\right\}\right\}=2,\left\{g,\left\{g, f_{2}\right\}\right\}=0
$$

which gives (3.5)(II).

- Case (III). The phase is of the form $\phi_{0}=\frac{1}{2}\left(a \xi_{1}^{2}+2 b x_{2} \xi_{1}+c x_{2}^{2}\right)$, and Hamilton vector field $v_{g}=$ $\left(-a \delta \xi_{1}-b \delta x_{2}, \delta x_{2} ; \delta \xi_{1}, b \delta \xi_{1}+c \delta x_{2}\right)=\left(2 \xi_{1},-1 ; 1,0\right)$, so necessary condition $\xi_{1}=0$ gives $a=b=c$. The condition $z \in G$ gives $z=\left(x_{1},-\frac{x_{1}}{a} ; 0,-x_{1}\right)$, and the condition $z \in \Lambda$ gives $x_{1}=0$, so we get $z=0$ as expected. The phase defining $\Lambda$ is thus given by $\phi_{0}=\frac{a}{2}\left(\xi_{1}+x_{2}\right)^{2}$. Again $\Lambda$ is transverse to $F$ at $z=0$. With $f_{1}=x_{1}+\frac{\partial \phi}{\partial \xi_{1}}, f_{2}=\xi_{2}-\frac{\partial \phi}{\partial x_{2}}$ we have

$$
\left\{f_{1},\left\{f_{1}, g\right\}\right\}=2,\left\{f_{2},\left\{f_{2}, g\right\}\right\}=0,\left\{f_{1},\left\{f_{2}, g\right\}\right\}=0,\left\{g,\left\{g, f_{1}\right\}\right\}=2,\left\{g,\left\{g, f_{2}\right\}\right\}=0
$$

which gives (3.5)(III).

- Case (IV). The quadratic phase takes the form $\phi=\frac{1}{2}\left(a x_{1}^{2}+2 b x_{1} \xi_{2}+c \xi_{2}^{2}\right)$, but Hamilton vector field $v_{g}=\left(\delta x_{1},-b \delta x_{1}-c \delta \xi_{2} ; a \delta x_{1}+b \delta \xi_{2}, \delta \xi_{2}\right)=\left(2 \xi_{1},-1 ; 1,0\right)$ cannot be tangent to $\Lambda$ near $z=0$.

Next we consider $\phi=\phi_{0}+\phi_{1}$, where $\phi_{1}$ is a cubic homogeneous polynomial. The role of the cubic term is suggested by the normal form in Theorem 1.2.
Proposition 3.2: The phase with a cubic term takes the form $\phi=\phi_{0}+\phi_{1}$. The manifold $\Lambda$ is again transverse to $F$ at $z=0$.

- In Case (I) $\phi_{0}$ fixes entirely the one-parameter family

$$
\begin{equation*}
\text { (I) } \phi(x)=\frac{1}{2}\left(a x_{1}^{2}-2 x_{1} x_{2}\right)-\frac{1}{3}\left(a x_{1}-x_{2}\right)^{3}, A_{z}=B_{z}=0 \tag{3.8}
\end{equation*}
$$

which has type (10) in Definition 1.3.

- In Case (III), $\phi_{0}\left(x_{2}, \xi_{1}\right)=\frac{1}{2} b\left(\xi_{1}+x_{2}\right)^{2}$, and $\phi_{1}$ is of the form $\phi_{1}\left(x_{2}, \xi_{1}\right)=\frac{1}{3}\left(a^{\prime} \xi_{1}^{3}+3 b^{\prime} \xi_{1}^{2} x_{2}+\right.$ $3 c^{\prime} \xi_{1} x_{2}^{2}+d^{\prime} x_{2}^{3}$ ). Let $\Delta$ be as in (3.17). If $\Delta \neq 0$ we have

$$
A_{z}=2\left(\begin{array}{cc}
d^{\prime} & -b^{\prime}+c^{\prime} \\
-b^{\prime}+c^{\prime} & 1+b^{\prime}-a^{\prime}
\end{array}\right), B_{z}=2\binom{1-c^{\prime}+2 b^{\prime}}{b^{\prime}+d^{\prime}-c}
$$

which has type (1) in Definition 1.3. If $\Delta=0, z=0$ is glancing iff either $\left(1-c^{\prime}\right) b^{\prime}=0$ or $\left(1-b^{\prime}\right) c^{\prime}=0$.

- In Case (II)

$$
\begin{equation*}
\text { (II) } \phi(\xi)=\frac{1}{2}\left(2 \xi_{1} \xi_{2}+c \xi_{2}^{2}\right)+\frac{1}{3}\left(-\xi_{1}^{3}+3 c^{\prime} \xi_{1} \xi_{2}^{2}+d^{\prime} \xi_{2}^{3}\right) \tag{3.10}
\end{equation*}
$$

- Case (IV) does not occur.


## Proof:

- Case (I). The phase defining $\Lambda$ is $\phi=\phi_{0}+\mathcal{O}\left(|x|^{3}\right)$ with $\phi_{0}=\frac{1}{2}\left(a x_{1}^{2}-2 x_{1} x_{2}\right)$, and

$$
\phi_{1}=\frac{1}{3}\left(a^{\prime} x_{1}^{3}+3 b^{\prime} x_{1}^{2} x_{2}+3 c^{\prime} x_{1} x_{2}^{2}+d^{\prime} x_{2}^{3}\right)
$$

To this order, the condition $v_{g}(z) \in T_{z} \Lambda$ takes the form

$$
\begin{aligned}
& \left(\delta x_{1}, \delta x_{2} ;\left(a+2 a^{\prime} x_{1}+2 b^{\prime} x_{2}\right) \delta x_{1}+\left(-1+2 b^{\prime} x_{1}+2 c^{\prime} x_{2}\right) \delta x_{2}\right. \\
& \left.\quad\left(-1+2 b^{\prime} x_{1}+2 c^{\prime} x_{2}\right) \delta x_{1}+\left(2 c^{\prime} x_{1}+2 d^{\prime} x_{2}\right) \delta x_{2}\right)=\left(2 \xi_{1},-1 ; 1,0\right)
\end{aligned}
$$

which yields the system

$$
\begin{equation*}
-a \xi_{1}+b^{\prime} x_{1}+c^{\prime} x_{2}=2 \xi_{1}\left(a^{\prime} x_{1}+b^{\prime} x_{2}\right), \quad \xi_{1}+c^{\prime} x_{1}+d^{\prime} x_{2}=2 \xi_{1}\left(b^{\prime} x_{1}+c^{\prime} x_{2}\right) \tag{3.12}
\end{equation*}
$$

Eliminating $\xi_{1}$ on the LHS gives

$$
\begin{equation*}
\left(b^{\prime}+a c^{\prime}\right) x_{1}+\left(c^{\prime}+a d^{\prime}\right) x_{2}=2 \xi_{1}\left(\left(a^{\prime}+a b^{\prime}\right) x_{1}+\left(b^{\prime}+a c^{\prime}\right) x_{2}\right) \tag{3.13}
\end{equation*}
$$

The condition $z \in F$ gives $x_{1}=0$. Substituting into (3.13) we get $x_{2}=0$ or $c^{\prime}+a d^{\prime}=2 \xi_{1}\left(b^{\prime}+a c^{\prime}\right)$. Assume $x_{2}=0$, then the condition $z \in G$ gives $\xi_{1}^{2}=x_{1}+\xi_{2}=b^{\prime} x_{1}^{2}+2 c^{\prime} x_{1} x_{2}+d^{\prime} x_{2}^{2}=0$, so $z=0$. Assume instead $c^{\prime}+a d^{\prime}=2 \xi_{1}\left(b^{\prime}+a c^{\prime}\right)$. Then as before $c^{\prime}+a d^{\prime}=0$, so either $\xi_{1}=0$ and (3.12) gives again $x_{2}=0$, so $z=0$. Finally we are left with the condition $b^{\prime}+a c^{\prime}=0$. Altogether we find $\phi=\phi_{0}+\phi_{1}=\frac{1}{2}\left(a x_{1}^{2}-2 x_{1} x_{2}\right)-\frac{1}{3}\left(a x_{1}-x_{2}\right)^{3}$. Again $\Lambda$ is transverse to $F$ at $z=0$. With $f_{j}=\xi_{j}+\frac{\partial \phi}{\partial x_{j}}$, a little computation shows that all second brackets vanish at $z=0$, which gives (3.8). - Case (III). We recall $\psi_{0}$ from (3.4)(III), and try $\phi_{1}=\frac{1}{3}\left(a^{\prime} \xi_{1}^{3}+3 b^{\prime} \xi_{1}^{2} x_{2}+3 c^{\prime} \xi_{1} x_{2}^{2}+d^{\prime} x_{2}^{3}\right)$. With $\phi=\phi_{0}+\phi_{1}$, we have $x_{1}=-\frac{\partial \phi}{\partial \xi_{1}}, \xi_{2}=\frac{\partial \phi}{\partial x_{2}}$, i.e.

$$
\begin{align*}
& x_{1}=-b\left(\xi_{1}+x_{2}\right)-a^{\prime} \xi_{1}^{2}-2 b^{\prime} \xi_{1} x_{2}-c^{\prime} x_{2}^{2} \\
& \xi_{2}=b\left(\xi_{1}+x_{2}\right)+b^{\prime} \xi_{1}^{2}+2 c^{\prime} \xi_{1} x_{2}+d^{\prime} x_{2}^{2} \tag{3.15}
\end{align*}
$$

with $b \neq 0$. The condition for $v_{g}(z)=\left(2 \xi_{1},-1 ; 1,0\right)=\left(\delta x_{1}, \delta x_{2} ; \delta \xi_{1}, \delta \xi_{2}\right) \in T_{z} \Lambda$ gives $\delta \xi_{1}=1$ and $\delta x_{2}=-1$, together with the linear system in $\left(x_{2}, \xi_{1}\right)$

$$
\begin{align*}
& \left(1+a^{\prime}-b^{\prime}\right) \xi_{1}+b^{\prime}\left(1-c^{\prime}\right) x_{2}=0 \\
& \left(b^{\prime}-c^{\prime}\right) \xi_{1}+\left(c^{\prime}-d^{\prime}\right) x_{2}=0 \tag{3.16}
\end{align*}
$$

with determinant

$$
\begin{equation*}
\Delta=\left(1+a^{\prime}\right)\left(c^{\prime}-d^{\prime}\right)+b^{\prime}\left(d^{\prime}-b^{\prime}\right)+b^{\prime} c^{\prime}\left(b^{\prime}-c^{\prime}\right) \tag{3.17}
\end{equation*}
$$

If $\Delta \neq 0$, which holds when ( $a^{\prime}, b^{\prime}, c^{\prime}, d^{\prime}$ ) vary in an open set of $\mathbf{R}^{4}$, then (3.15) has the trivial solution $x_{2}=\xi_{1}=0$. First Eq. (3.15) then gives $x_{1}=0$ (which means $z \in F$ ) and second Eq. (3.15) shows that $\xi_{1}=0$ (which means $z \in G$ ). So $z=0$ as is claimed.

Assume instead $\Delta=0$. Then (3.16) reduces to the first Eq. which has the general solution

$$

x_{2}=\lambda\left(1+a^{\prime}-b^{\prime}\right), \xi_{1}=-\lambda b^{\prime}\left(1-c^{\prime}\right) \tag{3.18}
\end{equation*}

with $\lambda \in \mathbf{R}$. Substituting into $\xi_{1}^{2}-x_{1}-x_{2}=0(z \in G)$ and $x_{1}=0(z \in F)$ leads to the system

& \left(1-b^{\prime}\right) \xi_{1}^{2}-2 c^{\prime} \xi_{1} x_{2}-d^{\prime} x_{2}^{2}=b\left(\xi_{1}+x_{2}\right) \\
& a^{\prime} \xi_{1}^{2}+2 b^{\prime} \xi_{1} x_{2}+c^{\prime} x_{2}^{2}=-b\left(\xi_{1}+x_{2}\right) \tag{3.19}
\end{align*}
$$

Summing up Eq. (3.19), we get rid of the linear term, and substituting (3.17) gives (provided $1+$ $a^{\prime}-b^{\prime} \neq 0$ )

$$
\left(1+a^{\prime}-b^{\prime}\right)\left(c^{\prime}-d^{\prime}\right)+b^{\prime}\left(1-c^{\prime}\right)\left(-b^{\prime} c^{\prime}-b^{\prime}+2 c^{\prime}\right)=0
$$

which combines with $\Delta=0$ to

$$
\left(1-c^{\prime}\right) b^{\prime}\left(1-b^{\prime}\right) c^{\prime}=0
$$

We discuss according to the cases $\left(1-c^{\prime}\right) b^{\prime}=0$ and $\left(1-b^{\prime}\right) c^{\prime}=0$.
In the first case, (3.17) gives $\xi_{1}=0$. The condition $z \in F \cap G$ is then equivalent to $\xi_{1}=\xi_{2}=$ $x_{1}=0$. Substituting into Eq. (3.19) eventually gives $x_{2}=0$, so $z=0$ as claimed.

Assume next $\left(1-c^{\prime}\right) b^{\prime} \neq 0$, but $\left(1-b^{\prime}\right) c^{\prime}=0$. When $c^{\prime}=0, \Delta=0$ reduces to $\left(1+a^{\prime}-b^{\prime}\right) d^{\prime}+b^{\prime 2}=0$, and Eq. (3.19) to

$$
\begin{align*}
& a^{\prime} \xi_{1}^{2}+2 b^{\prime} \xi_{1} x_{2}=-b\left(\xi_{1}+x_{2}\right)  \tag{3.20}\\
& \left(b^{\prime}-1\right) \xi_{1}^{2}+d^{\prime} x_{2}^{2}=-b\left(\xi_{1}+x_{2}\right)
\end{align*}
$$

Summing up again Eq.(3.20) gives the quadratic equation

$$
b^{\prime 2} \xi_{1}^{2}-2 b^{\prime} d^{\prime} \xi_{1} x_{2}+d^{\prime 2} x_{2}^{2}=\left(b^{\prime} \xi_{1}-d^{\prime} x_{2}\right)^{2}=0
$$

or since $b^{\prime} \neq 0, \xi_{1}=\frac{d^{\prime}}{b^{\prime}} x_{2}=0$. Substituting into first Eq.(3.20) yields

$$
x_{2}\left(d^{\prime}\left(a^{\prime} d^{\prime}+2 b^{\prime 2}\right) x_{2}+b b^{\prime}\left(b^{\prime}+d^{\prime}\right)\right)=0
$$

When $x_{2}=0,(3.20)$ gives $\xi_{1}\left(b+a^{\prime} \xi_{1}\right)=0$. Since $b \neq 0$, we must have ( $\xi_{1}$ is small) $\xi_{1}=0$, so $\xi_{1}=x_{2}=0$, and the condition $z \in F \cap G$ is equivalent to $z=0$, which proves our claim.

We are left with the case $c^{\prime} \neq 0$, but $b^{\prime}=1$.

- Case (II).
- Case (IV).

Let's summarize our construction so far:
Theorem 3.3: Let $M=\mathbf{R}^{2}$. Given a point of glancing intersection for the pair of hypersurfaces $(F, G)$, where $G$ takes the form $\{g=0\}$ with $g(x, \xi)=\xi_{1}^{2}-x_{1}-\xi_{2}$, and $F=\left\{x_{1}=0\right\}$ we can choose $\Lambda$ transverse to $F$ and such that $(\Lambda, G)$ has a glancing intersection at $z=0$. It is parametrized by phase
functions $\phi=\phi_{0}+\phi_{1}$ of inequivalent types (I)-(III) (case (IV) cannot occur), $\phi_{0}, \phi_{1}$ are quadratic and cubic polynomials respectively. Moreover all cases (1)-(10) in Definition 1.3 can occur.

### 3.2 Solving Hamilton-Jacobi (HJ) equation in $\left(\xi_{1}, x_{2}\right)$ coordinates.

As before our purpose is to parametrize $\Lambda_{1}$ by a phase function $\Psi\left(x_{1}, x_{2}\right)$ with prescribed value on $\Lambda$. This is the solution of HJ equation for $\left(h D_{x_{1}}\right)^{2}-x_{1}-h D_{x_{2}}$, namely

$$
\begin{equation*}
\left(\frac{\partial \Psi}{\partial x_{1}}\right)^{2}-x_{1}-\frac{\partial \Psi}{\partial x_{2}}=0 \tag{3.25}
\end{equation*}
$$

This equation cannot be solved directly since the Hamilton vector field $v_{g}$ is not transversal to $\Lambda 1$. We search $\Psi$ as the critical value of another phase function $\Phi\left(x_{1}, x_{2}, t\right)$. This will lead to multivalued solutions of (3.25).

Instead of solving directly HJ for $h D_{t}+g\left(x, h D_{x}\right)=h D_{t}+\left(h D_{x_{1}}\right)^{2}-x_{1}-h D_{x_{2}}$, we make a partial Fourier transform quantizing the metaplectic transformation $\left(x_{1}, x_{2} ; \xi_{1}, \xi_{2}\right) \mapsto\left(\xi_{1}, x_{2},-x_{1}, \xi_{2}\right)$, and consider instead HJ equation for $h D_{t}+h D_{\xi_{1}}-h D_{x_{2}}+\xi_{1}^{2}$. A first change variables $\left(t, x_{2}, \xi_{1}\right) \mapsto$ $\left(s^{\prime}=\frac{1}{2}\left(t-x_{2}\right), r^{\prime}=\frac{1}{2}\left(t+x_{2}\right), \xi_{1}\right)$, is followed by $\left(s^{\prime}, r^{\prime}, \xi_{1}\right) \mapsto\left(s=\frac{1}{2}\left(s^{\prime}-\xi_{1}\right), r=\frac{1}{2}\left(s^{\prime}+\xi_{1}\right), r^{\prime}\right)$. The inverse map is given by

$$
\begin{equation*}
x_{2}=r^{\prime}-r-s, \quad \xi_{1}=r-s, \quad t=r^{\prime}+r+s \tag{3.30}
\end{equation*}
$$

and operator $h D_{t}+h D_{\xi_{1}}-h D_{x_{2}}+\xi_{1}^{2}$ is changed to $h D_{s^{\prime}}+h D_{\xi_{1}}+\xi_{1}^{2}$, then to $h D_{r}+(r-s)^{2}$. In the new variables, HJ equation takes the form

$$
\begin{equation*}
\frac{\partial \Phi}{\partial r}+(r-s)^{2}=0 \tag{3.31}
\end{equation*}
$$

and its general solution is given by

$$
\begin{equation*}
\Phi\left(r, r^{\prime}, s\right)=-\frac{1}{3}(r-s)^{3}+\Phi_{0}\left(r^{\prime}, s\right) \tag{3.32}
\end{equation*}
$$

where $\Phi_{0}\left(r^{\prime}, s\right)$ is determined by the initial value at $t=0$, corresponding to $s=-\left(r+r^{\prime}\right)$. This yields the condition

$$
\begin{equation*}
\left.\Phi\right|_{t=0}=\Phi\left(r, r^{\prime},-\left(r+r^{\prime}\right)\right)=-\frac{1}{3}\left(2 r+r^{\prime}\right)^{3}+\Phi_{0}\left(r^{\prime},-r-r^{\prime}\right) \tag{3.33}
\end{equation*}
$$

so we need to express the initial value $\left.\Phi\right|_{t=0}$ on $\Lambda$ in terms of variables $r, r^{\prime}, s$.
We discuss again according to Cases (I)-(III) listed in Proposition 3.1.

- Case (I). We start with the linear case $\phi(x)=\phi_{0}(x)=\frac{1}{2}\left(a x_{1}^{2}-2 x_{1} x_{2}\right)$. Consider partial Legendre transform $x_{1} \mapsto \phi_{0}(x)-x_{1} \xi_{1}$, the critical point is given by $x_{1}=\frac{1}{a}\left(x_{2}+\xi_{1}\right)$, and the critical value $\phi_{\text {crit }}=-\frac{1}{2 a}\left(\xi_{1}+x_{2}\right)^{2}$. Substituting (3.30) at $t=0$ (i.e. $\left.s=-r-r^{\prime}\right)$ gives

$$
\begin{equation*}
\left.\Phi\right|_{t=0}=\phi=-\frac{1}{2 a}\left(3 r^{\prime}+2 r\right)^{2} \tag{3.34}
\end{equation*}
$$

with

$$
\begin{equation*}
\Phi_{0}\left(r^{\prime}, s\right)=-\frac{1}{3}\left(2 s+r^{\prime}\right)^{3}-\frac{1}{2 a}\left(-2 s+r^{\prime}\right)^{2} \tag{3.35}
\end{equation*}
$$

We use (3.32)-(3.33) to express $\Phi$ in the original variables as

$$
\begin{equation*}
\Phi\left(t, \xi_{1}, x_{2}\right)=-\frac{1}{3}\left(t-\xi_{1}\right)^{3}-\frac{1}{3} \xi_{1}^{3}-\frac{1}{2 a}\left(\xi_{1}+x_{2}\right)^{2} \tag{3.36}
\end{equation*}
$$

The map $t \mapsto \Phi\left(t, \xi_{1}, x_{2}\right)$ has a degenerate critical point at $t=\xi_{1}$, with $\partial_{t} \Phi=\partial_{t}^{2} \Phi=0, \partial_{t}^{3} \Phi=-2$. So the situation is similar with the diffraction by an obstacle for the wave equation $[\mathrm{Sj}]$, [ Ta$],[\mathrm{Ro}]$ but $\Phi$ does not arise from a Morse family (with an auxiliary $\theta$-parameter). We add now the cubic term $\phi_{1}(x)=-\frac{1}{3}\left(a x_{1}-x_{2}\right)^{3}$. Consider partial Legendre transform $x_{1} \mapsto \phi_{0}(x)+\phi_{1}(x)-x_{1} \xi_{1}$, the critical point is given by the quadratic equation $a^{3} x_{1}^{2}-2 a\left(a x_{2}+\frac{1}{2}\right) x_{1}+a x_{2}^{2}-x_{2}-\xi_{1}=0$ which yields

$$
x_{1}=\left(1+2 a x_{2}-\sqrt{1-4 a \xi_{1}}\right) /\left(2 a^{2}\right)=\frac{1}{a}\left(x_{2}+\xi_{1}\right)+\xi_{1}^{2}-\frac{a}{4} \xi_{1}^{3}+\mathcal{O}\left(\xi_{1}^{4}\right)
$$

The corresponding critical value of Legendre transform is simply $\phi_{\text {crit }}=-\frac{1}{2 a}\left(\xi_{1}+x_{2}\right)^{2}-\frac{1}{3} \xi_{1}^{3}+\mathcal{O}\left(\xi_{1}^{4}\right)$. Substituting (3.30) at $t=0$ gives as before $\Phi_{0}\left(r^{\prime}, s\right)=-\frac{1}{2 a}\left(r^{\prime}-2 s\right)^{2}+\mathcal{O}\left(\left(r^{\prime}+2 s\right)^{4}\right)$. We use (3.32)-(3.33) to express $\Phi$ in the original variables as

$$
\begin{equation*}
\Phi\left(t, \xi_{1}, x_{2}\right)=-\frac{1}{3} \xi_{1}^{3}-\frac{1}{2 a}\left(\xi_{1}+x_{2}\right)^{2}+\mathcal{O}\left(\xi_{1}^{4}\right) \tag{3.38}
\end{equation*}
$$

which turns out to be independent of $t$, and equals, $\bmod \mathcal{O}\left(\xi_{1}^{4}\right)$, the critical value of (2.54) when the cubic term $\phi_{1}$ is absent.

- Case (II). We consider only the linear case. We make Legendre transform with respect to $\xi_{2}$ variable. The critical point is $\xi_{2}=-\frac{1}{c}\left(x_{2}+\xi_{1}\right)$, and it turns out that the critical value of Legendre transform is $-\frac{1}{2 c}\left(x_{2}+\xi_{1}\right)^{2}$ which gives again the same result as in Case (I) (linear case).
- Case (III). So $\phi\left(x_{2}, \xi_{1}\right)=\phi_{0}\left(x_{2}, \xi_{1}\right)=\frac{1}{2} b\left(\xi_{1}+x_{2}\right)^{2}$ is expressed already in the right coordinates. A simple calculation shows

$$
\begin{equation*}
\Phi\left(t, x_{2}, \xi_{1}\right)=-\frac{1}{3} \xi_{1}^{3}-\frac{1}{3}\left(t-\xi_{1}\right)^{3}+\frac{b}{2}\left(x_{2}+\xi_{1}\right)^{2} \tag{3.39}
\end{equation*}
$$

which gives the same result as in Case (I) (linear case).
We add now the cubic term. A computation similar to Case (I) (with cubic term) gives

$$
\Phi\left(x_{2}, \xi_{1}, t\right)=-\frac{1}{3} \xi_{1}^{3}+\frac{b}{2}\left(x_{2}+\xi_{1}\right)^{2}+\frac{b^{\prime}}{3}\left(x_{2}+\xi_{1}\right)^{3}-\frac{1}{2}\left(t-\xi_{1}\right)^{3}-\frac{1}{2}\left(t+x_{2}\right)^{2}\left(\frac{t-x_{2}}{2}-\xi_{1}\right)+\frac{1}{12}\left(x_{2}+\xi_{1}\right)^{3}
$$

The critical point of $t \mapsto \Phi\left(t, \xi_{1}, x_{2}\right)$ is given by

$$
\left(t-\xi_{1}\right)^{2}+\frac{1}{2}\left(x_{2}+\xi_{1}\right)^{2}=0
$$

which has a real solution iff $q=x_{2}+\xi_{1}=0$. Then $t=\xi_{1}=-x_{2}$ is a degenerate critical point, with $\partial_{t} \Phi=\partial_{t}^{2} \Phi=0, \partial_{t}^{3} \Phi=-3 / 2$, and the critical value is

$$
\begin{equation*}
\Phi_{\text {crit }}=-\frac{1}{3} \xi_{1}^{3}=\frac{1}{3} x_{2}^{3} \tag{3.40}
\end{equation*}
$$

Summing up, we have proved so far:
Proposition 3.4: Let $\Lambda$ be paramerized by a quadratic phase $\phi_{0}$ or with a cubic term $\phi_{0}+\phi_{1}$. The critical point of $t \mapsto \Phi\left(t, \xi_{1}, x_{2}\right)$ is given by $t=\xi_{1}$.

In Case (I) (quadratic phase $\phi_{0}$ ) the critical value of $t \mapsto \Phi\left(t, \xi_{1}, x_{2}\right)$ given in (3.36) is

$$
\begin{equation*}
\Phi_{\text {crit }}\left(\xi_{1}, x_{2}\right)=-\frac{1}{3} \xi_{1}^{3}-\frac{1}{2 a}\left(\xi_{1}+x_{2}\right)^{2} \tag{3.51}
\end{equation*}
$$

For $\phi=\phi_{0}+\phi_{1}, \Phi\left(t, x_{1}, x_{2}\right)$ is independent of $t$, and equal to (3.51) $\bmod \mathcal{O}\left(\xi_{1}^{4}\right)$.
In Case (II) (quadratic phase $\phi_{0}$ ) the critical value of $t \mapsto \Phi\left(t, \xi_{1}, x_{2}\right)$ is again (3.51), with another constant $a$.

In Case (III) (quadratic phase $\phi_{0}$ ) the critical value of $t \mapsto \Phi\left(t, \xi_{1}, x_{2}\right)$ is again (3.51), with another constant a. For $\phi=\phi_{0}+\phi_{1}, t \mapsto \Phi\left(t, \xi_{1}, x_{2}\right)$ has a real critical point iff $q=x_{1}+\xi_{2}=0$, and the critical value is given by (3.40).

Case (IV) does not occur.

## Remarks:

1) Let $J=F \cap G=\left\{x_{1}=0, \xi_{2}=\xi_{1}^{2}\right\}, Q=\{q=0\}$. We note that $q=x_{2}+\xi_{1}$ Poisson commutes with $g=\xi_{1}^{2}-x_{1}+\xi_{2}$, so $G=\{g=0\}$ is the flow out of $J$ through $v_{q}$.
2) In relevant Cases (I)-(III), $\Phi_{\text {crit }}=-\frac{1}{3} \xi_{1}^{3}$ on $Q$.

### 3.3 The phase function $\Phi$ in $\left(x_{1}, x_{2}\right)$ coordinates.

As in $[\mathrm{Sj}]$ we pass from $\left(\xi_{1}, x_{2}\right)$ to $\left(x_{1}, x_{2}\right)$ coordinates by Legendre transform, so $\Psi$ is the critical value of $\xi_{1} \mapsto x_{1} \xi_{1}+\Phi_{\text {crit }}\left(\xi_{1}, x_{2}\right)$, so within hypotheses of Proposition 3.4, and in general case (3.51) we have

$$
\begin{equation*}
\xi_{1}=a x_{1}-x_{2}+\mathcal{O}\left(\left(a x_{1}-x_{2}\right)^{2}\right) \tag{3.52}
\end{equation*}
$$

which gives $\Psi$ by substituting in $\Phi_{\text {crit }}\left(\xi_{1}, x_{2}\right) \ldots$
In case (3.40) we have the system $\xi_{1}^{2}-x_{1}=0, x_{2}+\xi_{1}=0$. or since the critical points belong to energy surface $G=\{g=0\}$

$$
\begin{equation*}
x_{1}=x_{2}^{2}, \quad \xi_{2}=0 \tag{3.53}
\end{equation*}
$$

The caustic is then given by the parabola $x_{1}=x_{2}^{2}$.
