An elementary proof of the compactness of the trace operator on a Lipschitz domain

Abstract

In the setting of bounded strongly Lipschitz domains, we present a short and simple proof of the compactness of the trace operator acting on square integrable vector fields with square integrable divergence and curl, with a boundary condition. We rely on earlier trace estimates established in a similar setting.

1 Introduction and main theorem

The compactness of the trace operator on a bounded strongly Lipschitz domain Ω is well known in the scalar case. In fact it is continuous from $H^1(\Omega)$ to $H^{\frac{1}{2}}(\partial\Omega)$, and the compactness of the injection $H^{\frac{1}{2}}(\partial\Omega) \hookrightarrow L^2(\partial\Omega)$ ensures that $\operatorname{Tr}_{|\partial\Omega}$ maps compactly $H^1(\Omega)$ to $L^2(\partial\Omega)$. By looking coordinate by coordinate the scalar case implies that vector fields in $H^1(\Omega\mathbb{R})$ are also compact. However for less regular vector fields the situation is slightly different. In the study of Maxwell and Navier-Stokes equations, it is interesting to study vector fields $u \in L^2(\Omega, \mathbb{R})$ with div $u \in L^2(\Omega)$ and $\operatorname{curl} u \in L^2(\Omega, \mathcal{M}_d(\mathbb{R}))$, with a boundary condition on either $\nu \cdot u$ or $\nu \wedge u$. A natural boundary condition is $\nu \cdot u = 0$, and in this case the trace operator is still compact. In this paper we investigate a more general boundary condition where $\nu \cdot u$ is only in some L^p spaces (p > 2).

Let $\delta > 0$ and let

$$X_T^{\delta} = \left\{ u \in L^2(\Omega, \mathbb{R}^d); \, \text{div} \, u \in L^2(\Omega), \, \text{curl} \, u \in L^2(\Omega, \mathbb{R}^d) \text{ and } \nu \cdot u \in L^{2+\delta}(\partial\Omega) \right\}$$

and

$$X_N^{\delta} = \left\{ u \in L^2(\Omega, \mathbb{R}^d) \, ; \, \operatorname{div} u \in L^2(\Omega), \, \operatorname{curl} u \in L^2(\Omega, \mathbb{R}^d) \text{ and } \nu \wedge u \in L^{2+\delta}(\partial\Omega, \mathcal{M}_d(\mathbb{R})) \right\}.$$

where Ω is a domain of \mathbb{R}^d .

 X_T^{δ} and X_N^{δ} are Banach spaces when equipped with the natural norms

$$\|u\|_{X_T^{\delta}} = \|u\|_{L^2(\Omega, \mathbb{R}^d)} + \|\operatorname{div} u\|_{L^2(\Omega)} + \|\operatorname{curl} u\|_{L^2(\Omega, \mathcal{M}_d(\mathbb{R}))} + \|\nu \cdot u\|_{L^{2+\delta}(\partial\Omega)}$$
(1)

$$\|u\|_{X_{N}^{\delta}} = \|u\|_{L^{2}(\Omega,\mathbb{R}^{d})} + \|\operatorname{div} u\|_{L^{2}(\Omega)} + \|\operatorname{curl} u\|_{L^{2}(\Omega,\mathcal{M}_{d}(\mathbb{R}))} + \|\nu \wedge u\|_{L^{2+\delta}(\partial\Omega,\mathcal{M}_{d}(\mathbb{R}))}.$$
(2)

We also denote by X_T and X_N the subspaces of X_T^{δ} and X_N^{δ} with (respectively) $\nu \cdot u = 0$ and $\nu \wedge u = 0$ on $\partial \Omega$. Our aim is to prove the following theorem:

Theorem 1.1. Let $\delta > 0$, let $\Omega \subset \mathbb{R}^d$ be a strongly Lipschitz domain. Then the trace operator $\operatorname{Tr}_{|\partial\Omega}$ maps compactly X_T^{δ} (or X_N^{δ}) to $L^2(\partial\Omega, \mathbb{R}^d)$.

The trace operators on the spaces $X_{T,N}$ are well understood for domains with regular boundaries. When Ω has a regular enough boundary, the space X_T and X_N are in fact included in $H^1(\Omega, \mathbb{R}^d)$: for example if Ω is $C^{\frac{3}{2}+\varepsilon}$ [6], if Ω is $C^{1,1}$ [1, Theorems 2.9, 2.12], or even if Ω is convex [9]. If Ω is piece-wise C^{∞} and C^2 -diffeomorphic to a polyhedron, there exists $\varepsilon > 0$ such that X_T and X_N are subsets of $H^{\frac{1}{2}+\varepsilon}(\Omega, \mathbb{R}^3)$, as in [5]. In all those cases, the compactness of the trace operator derives from the scalar case by applying scalar estimates coordinate by coordinate.

If $\nu \cdot u$ is non-zero but in $L^2(\partial\Omega)$, the trace operator is continuous - see for example [7, Theorem 11.2] for a general results for L^p spaces on manifolds. The compactness of the trace operator, however, is not known. In order to obtain compactness, one possibility is to add some regularity to $\nu \cdot u$: consider for example the space $\left\{ u \in L^2(\Omega, \mathbb{R}^d); \text{ div } u \in L^2(\Omega), \text{ curl } u \in L^2(\Omega, \mathcal{M}_d(\mathbb{R})) \text{ and } \nu \cdot u \in H^{\frac{1}{2}}(\partial\Omega) \right\}$. It is a subspace of X_T^{δ} for some $\delta >$

0, and in the case of a $C^{1,1}$ domain in dimension 3, Amrouche and Seloula proved in [2, Theorem 3.5] that it is in fact a subspace of $H^1(\Omega, \mathbb{R}^3)$.

On a Lipschitz domain however, this method fails: ν is only in $L^{\infty}(\partial\Omega, \mathbb{R}^d)$ so $\nu \cdot u$ fails to be in $H^{\frac{1}{2}}(\partial\Omega)$ even when $u \in H^1(\Omega, \mathbb{R}^d)$. Both X_T and X_N are still subspaces of $H^{\frac{1}{2}}(\Omega, \mathbb{R}^d)$ (see [3] for dimension 2 and 3 and [7, Theorem 11.2] for the general result). However Costabel recently proved in [4] that there exist C^1 domains such that X_T and X_N are in none of the $H^{\frac{1}{2}+\varepsilon}(\Omega, \mathbb{R}^d)$ spaces. It is consequently impossible to operate coordinate by coordinate, but we can still prove that the trace operator is compact as soon as the integrability of the boundary condition is better than L^2 . Our main tool is an estimate established in [8]; it can be adapted in the X_T^{δ} or X_N^{δ} settings, allowing us to prove first the continuity, then the compactness of the trace operator.

2 Notations

In this paper we will denote by Ω a bounded strongly Lipschitz domain, i.e. an open connected subset of \mathbb{R}^d , whose boundary can locally be written as the graph of a Lipschitz function and which is only on one side of its boundary.

Definition 2.1. We recall that Ω is a special Lipschitz domain if there exist a basis of \mathbb{R}^d and a Lipschitz function ω from \mathbb{R}^{d-1} to \mathbb{R} such that

$$\Omega = \{ x = (x_h, x_d) \in \mathbb{R}^{d-1} \times \mathbb{R} \; ; \; x_d > \omega(x_h) \}.$$
(3)

Then the outward normal ν at $x = (x_h, \omega(x_h)) \in \partial \Omega$ is defined almost everywhere by:

$$\nu(x_h, \omega(x_h)) = \frac{1}{\sqrt{1 + |\nabla_h \omega(x_h)|^2}} \left(\nabla_h \omega(x_h), -1 \right), \tag{4}$$

where ∇_h is the horizontal gradient acting on the horizontal variable x_h .

Since ω is Lipschitz, its gradient is bounded. Thus there is a constant c > 0 such that $\frac{1}{\sqrt{1+|\nabla_h \omega(x_h)|^2}} \ge c$ for almost every $x_h \in \mathbb{R}^{d-1}$. We can then denote by $\theta \in [0, \frac{\pi}{2}[$ the angle between the vertical direction and the outward normal:

$$\theta = \arccos\left(\inf_{x_h \in \mathbb{R}^{d-1}} \frac{1}{\sqrt{1 + |\nabla_h \omega(x_h)|^2}}\right).$$
(5)

And writing $e = (0_{\mathbb{R}^{d-1}}, -1)$ we get for almost every $x_h \in \mathbb{R}^{d-1}$:

$$0 < \cos \theta \le \frac{1}{\sqrt{1 + |\nabla_h \omega(x_h)|^2}} = e \cdot \nu(x_h, \omega(x_h)).$$
(6)

In order to get a compactness result on the trace operator, we of course need a bounded domain. We can make use of the special Lipschitz case through a finite covering:

Definition 2.2. We recall that $\Omega \subset \mathbb{R}^d$ is a bounded strongly Lipschitz domain if Ω is open, connected, bounded, and there exists a finite cover $(\Omega_k)_{1 \leq k \leq N}$ of $\partial \Omega$ such that for every $k, \Omega \cap \Omega_k$ coincide with a special Lipschitz domain.

Since $\Omega_k \cap \Omega$ coincides with a special Lipschitz domain, it is possible to define a minimal angle between the outward normal and the local vertical direction on each $\partial\Omega \cap \Omega_k$, as in (5): there exist a vector e_k and an angle θ_k such that k, for every $x \in \partial\Omega \cap \Omega$, $\cos \theta_k \leq e_k \cdot \nu(x)$. Since there is a finite number of $\cos \theta_k$, we can define γ as:

$$\gamma = \min\left(\cos\theta_k \ ; \ 1 \le k \le N\right). \tag{7}$$

 γ only depends on $\partial\Omega$ and the choice of the covering $(\Omega_k)_{k\in[0,N]}$. In every case we have $\gamma > 0$.

Finally let us introduce some notations for vectorial analysis: let Ω be either a special Lipschitz or bounded strongly Lipschitz domain, and let $u \in L^2(\Omega, \mathbb{R}^d)$. We denote by $\operatorname{curl} u \in \mathcal{M}_d(\mathbb{R})$ the antisymmetric part of the Jacobian matrix of first order partial derivatives in the sense of distributions:

$$(\operatorname{curl} u)_{i,j} = \frac{1}{\sqrt{2}} (\partial_i u_j - \partial_j u_i) = \frac{1}{\sqrt{2}} (\nabla u - (\nabla u)^T)_{i,j} , \ 1 \le i, j \le d.$$

$$(8)$$

We use on $\mathcal{M}_d(\mathbb{R})$ the scalar product $\langle v, w \rangle = \sum_{i,j=1}^d v_{i,j} w_{i,j}$ for $v = (v_{i,j})_{1 \leq i,j \leq d}$, $w = (w_{i,j})_{1 \leq i,j \leq d} \in \mathcal{M}_d(\mathbb{R})$, and we denote by |.| the associated norm.

We also define the wedge product of two vectors e and f of \mathbb{R}^d by $e \wedge f = \frac{1}{\sqrt{2}} (e_i f_j - e_j f_i)_{1 \leq i,j \leq d} \in \mathcal{M}_d(\mathbb{R}).$

Finally for any $u \in L^2(\Omega, \mathbb{R}^d)$ we can make sense of $\nu \cdot u$ and $\nu \wedge u$ as distributions on $\partial\Omega$, as in [8].

3 Proof of Theorem 1.1

In this section we prove the continuity and compactness of the trace operator. We will only write it in the X_T^{δ} case, as the proof in for X_N^{δ} is exactly similar.

• First we prove the continuity of the operator

$$\operatorname{Tr}_{|\partial\Omega}: X_T^{\delta} \to L^2(\partial\Omega, \mathbb{R}^d).$$
 (9)

Let $u \in X_T^{\delta}$ be a vector field. Applying estimate (4.12) in [8], there exists a constant $C(\Omega)$ such that:

$$\begin{aligned} \left\| \operatorname{Tr}_{|\partial\Omega} u \right\|_{L^{2}(\partial\Omega,\mathbb{R}^{d})}^{2} &\leq \frac{2}{\gamma} \left\| u \right\|_{L^{2}(\Omega,\mathbb{R}^{d})} \left(2 \left\| \operatorname{curl} u \right\|_{L^{2}(\Omega,\mathcal{M}_{d}(\mathbb{R}))} + 2 \left\| \operatorname{div} u \right\|_{L^{2}(\Omega)} + C(\Omega) \left\| u \right\|_{L^{2}(\Omega,\mathbb{R}^{d})} \right) &\qquad (10) \\ &+ \left(\left(\frac{4}{\gamma^{2}} + \frac{2}{\gamma} + 1 \right) \min \left\{ \left\| \nu \wedge u \right\|_{L^{2}(\partial\Omega,\mathcal{M}_{d}(\mathbb{R}))}^{2}, \left\| \nu \cdot u \right\|_{L^{2}(\partial\Omega)}^{2} \right\} \right). \end{aligned}$$

Since Ω is bounded, $L^{2+\delta}(\partial\Omega) \subset L^2(\partial\Omega)$ and there exists a new constant $C(\Omega)$ such that:

$$\begin{aligned} \left\| \operatorname{Tr}_{|\partial\Omega} u \right\|_{L^{2}(\partial\Omega,\mathbb{R}^{d})}^{2} \leq C(\Omega) \left\| u \right\|_{L^{2}(\Omega,\mathbb{R}^{d})} \left(\left\| \operatorname{curl} u \right\|_{L^{2}(\Omega,\mathcal{M}_{d}(\mathbb{R}))} + \left\| \operatorname{div} u \right\|_{L^{2}(\Omega)} + \left\| u \right\|_{L^{2}(\Omega,\mathbb{R}^{d})} \right) & (11) \\ + C(\Omega) \min \left\{ \left\| \nu \wedge u \right\|_{L^{2+\delta}(\partial\Omega,\mathcal{M}_{d}(\mathbb{R}))}^{2}, \left\| \nu \cdot u \right\|_{L^{2+\delta}(\partial\Omega)}^{2} \right\}. \end{aligned}$$

Finally we get $\left\| \operatorname{Tr}_{|\partial\Omega} u \right\|_{L^2(\partial\Omega,\mathbb{R}^d)}^2 \leq C(\Omega) \|u\|_{X_T^{\delta}}^2$, so $\operatorname{Tr}_{|\partial\Omega}$ is bounded from X_T^{δ} to $L^2(\partial\Omega,\mathbb{R}^d)$.

• This estimate on the trace actually allows us to prove the compactness as follow:

Let $(u_n)_{n \in \mathbb{N}}$ be a sequence in X_T^{δ} , bounded by a constant K > 0.

The embedding $X_T^{\delta} \hookrightarrow L^2(\Omega, \mathbb{R}^d)$ is compact, because $X_T^0 \hookrightarrow L^2(\Omega, \mathbb{R}^d)$ is compact (see the third remark after Theorem 11.2 in [7]). We can extract a subsequence, again denoted u, such that:

$$u_n \xrightarrow[n \to \infty]{} u$$
 in $L^2(\Omega, \mathbb{R}^d)$.

Besides the injection $L^{2+\delta}(\partial\Omega) \hookrightarrow L^2(\partial\Omega)$ is also compact, so for any sequence $\nu \cdot u \in L^{2+\delta}(\partial\Omega)$ and for any $\nu \wedge u \in L^{2+\delta}(\partial\Omega, \mathcal{M}_d(\mathbb{R}))$, we can also extract subsequences converging in L^2 .

Let ℓ , k be two integers. Applying estimate (11) to $u_{\ell} - u_k$ we get:

$$\begin{aligned} \left\| \operatorname{Tr}_{|\partial\Omega}(u_{\ell} - u_{k}) \right\|_{L^{2}(\partial\Omega,\mathbb{R}^{d})}^{2} &\leq C(\Omega) \left\| u_{\ell} - u_{k} \right\|_{L^{2}(\Omega,\mathbb{R}^{d})} \left\| u_{\ell} - u_{k} \right\|_{X_{T}^{\delta}} \\ &+ C(\Omega) \min \left\{ \left\| \nu \wedge (u_{\ell} - u_{k}) \right\|_{L^{2}(\partial\Omega,\mathcal{M}_{d}(\mathbb{R}))}^{2}, \left\| \nu \cdot (u_{\ell} - u_{k}) \right\|_{L^{2}(\partial\Omega)}^{2} \right\}. \end{aligned}$$

Since the sequence $(u_n)_{n\in\mathbb{N}}$ is bounded by K, $||u_\ell - u_k||_{X_T^{\delta}} \leq 2K$. Moreover $(u_n)_{n\in\mathbb{N}}$ converges in $L^2(\Omega, \mathbb{R}^d)$, and both $(\nu \wedge u)_{n\in\mathbb{N}}$ and $(\nu \cdot u)_{n\in\mathbb{N}}$ converge in L^2 norms, so $(\operatorname{Tr}_{|\partial\Omega}u_n)_{n\in\mathbb{N}}$ is a Cauchy sequence in $L^2(\partial\Omega, \mathbb{R}^d)$. This proves that if $(u_n)_{n\in\mathbb{N}}$ is bounded in X_T^{δ} , then there exists a subsequence of $(u_n)_{n\in\mathbb{N}}$ such that $(\operatorname{Tr}_{|\partial\Omega}u_n)_{n\in\mathbb{N}}$ converges in $L^2(\partial\Omega, \mathbb{R}^d)$, which proves that the trace operator is compact.
