Limit models for thin heterogeneous structures with high contrast^{*}

Abstract

We investigate two linear diffusion problems, with strongly contrasting diffusivity, in a thin heterogeneous cylinder with a small cross-section of radius h_n , n in \mathbb{N} . In this cylinder we distinguish an inner cylindrical core \hat{C}_n with cross-section of radius $r_n \ll h_n$ and its complementary annulus \hat{I}_n and we treat two complementary cases. In the first case we consider a low conductivity of order δ_n^2 in the core \hat{C}_n and a conductivity of order 1 in the annulus \hat{I}_n ; the opposite situation in the second case. We study the asymptotic behavior of these problems as $h_n \to 0$, $r_n \to 0$, $\frac{r_n}{h_n} \to 0$, and $\delta_n \to 0$. In the first case we prove that the inner core has not any influence on the limit behavior. In the second case, we pinpoint three different limit regimes depending on the ratio $\mu = \lim_n \frac{\delta_n}{h_n}$, according to $\mu = 0$, $0 < \mu < +\infty$, or $\mu = +\infty$. We obtain L^2 -strong convergence for the solution and its gradient. We examine the limit problems and compare them with other models.

Keywords: Thin structure; contrasting diffusivity; degenerating equation; correctors.

1 Introduction

In this paper we investigate two linear diffusion problems, with strongly contrasting diffusivity, in a thin heterogeneous cylinder.

In what follows, x' (resp. y') denotes a generic element (x_1, x_2) (resp. (y_1, y_2)) of \mathbb{R}^2 , moreover (x', x_3) (resp. (y', x_3)) denotes a generic element $x = (x_1, x_2, x_3)$ (resp. (y_1, y_2, x_3)) of \mathbb{R}^3 .

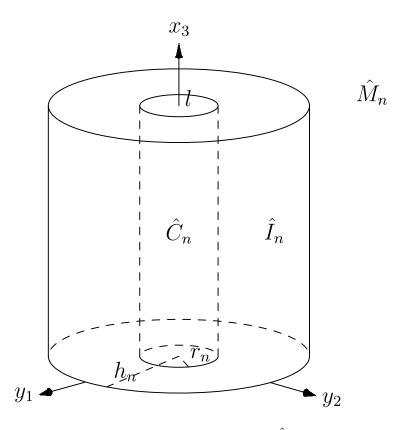


Figure 1: Thin cylinder \hat{M}_n

For every n in \mathbb{N} we consider a thin cylinder \hat{M}_n of \mathbb{R}^3 with height l and with a small crosssection $h_n M'$. In \hat{M}_n we distinguish two thin cylinders with the same height l: an inner core \hat{C}_n with small cross-section $r_n C'$ and its complementary annulus $\hat{I}_n = (h_n M' \setminus r_n \overline{C'}) \times]0, l[$ (see Figure 1), where M' and C' are two open connected sets of \mathbb{R}^2 with Lipschitz boundaries such that $0 \in C' \subset M'$, and h_n and r_n are two small parameters taking values in two vanishing sequences of positive numbers such that

 $r_n \ll h_n$.

In \hat{M}_n we consider the following boundary value problem:

$$\begin{cases} -\operatorname{div}\left(g_{n}(y')A\left(x_{3}\right)D\widehat{u}_{n}(y',x_{3})\right)+b\left(x_{3}\right)\widehat{u}_{n}(y',x_{3})=\widehat{f}_{n}(y',x_{3}), \text{ in } \widehat{M}_{n},\\ (g_{n}(y')A\left(x_{3}\right)D\widehat{u}_{n}(y',x_{3}))\cdot\nu=0, \text{ on } \partial\widehat{M}_{n}, \end{cases}$$

$$(1.1)$$

where A is a coercive matrix with coefficients in $L^{\infty}(]0, l[)$, b is a coefficient in $L^{\infty}(]0, l[)$ which is bounded from below away from zero, \hat{f}_n is a function in $L^2(\hat{M}_n)$, and ν denotes the exterior unit normal to $\partial \hat{M}_n$. For the sake of simplicity in this introduction we assume that the matrix A and the coefficient b depend only on the vertical variable x_3 , but in the paper we treat a more general case with A and b depending on (y', x_3) . As far as function g_n is concerned, we shall consider two cases:

I)
$$g_n = \delta_n^2 \chi_{\hat{C}_n} + \chi_{\hat{I}_n},$$
 II) $g_n = \chi_{\hat{C}_n} + \delta_n^2 \chi_{\hat{I}_n},$

where also δ_n is a small parameter taking values in a vanishing sequence of positive numbers, and $\chi_{\hat{C}_n}$ and $\chi_{\hat{I}_n}$ denote the characteristic function of \hat{C}_n and \hat{I}_n , respectively. In the first case, \hat{M}_n has a very small insulation inner cylindrical core \hat{C}_n with low conductivity of order δ_n^2 enveloped by the annulus \hat{I}_n with conductivity of order 1. In the second case, we have the opposite situation, i.e., \hat{M}_n has a very small inner cylindrical core \hat{C}_n with conductivity of order 1 enveloped by the insulation annulus \hat{I}_n with low conductivity of order δ_n^2 .

In this paper we study the asymptotic behavior of problem (1.1) as $h_n \to 0$, $r_n \to 0$, $\frac{r_n}{h_n} \to 0$, $\delta_n \to 0$, and under suitable assumptions on \hat{f}_n . Precisely, we assume that the rescaling of \hat{f}_n on $M' \times]0, l[$, i.e., $f_n(x', x_3) = \hat{f}_n(h_n x', x_3)$, is L^2 -strongly converging to a function $f(x', x_3)$.

We point out that the peculiarity of this paper is the assumption $\frac{r_n}{h_n} \to 0$ (i.e., $r_n \ll h_n$) combined with the lost of coercivity of the problems when h_n and r_n vanish, due to the vanishing coefficient δ_n^2 in front of the divergence term.

• In the first case (i.e., when $g_n = \delta_n^2 \chi_{\hat{C}_n} + \chi_{\hat{I}_n}$), using the Cauchy-Schwarz inequality, Theorem 3.2 provides that

$$\int_{h_n M'} \widehat{u}_n(x', \cdot) dx' \longrightarrow u \text{ strongly in } L^2(]0, l[), \qquad (1.2)$$

and $u \in H^1([0, l[))$ is the unique weak solution to

$$\begin{cases} -\frac{d}{dx_3} \left(a_0 \frac{du}{dx_3} \right) + |M'| bu = f_0, \text{ in }]0, l[u] \\ \left(a_0 \frac{du}{dx_3} \right) (0) = 0 = \left(a_0 \frac{du}{dx_3} \right) (l), \end{cases}$$

where for a.e. x_3 in]0, l[

$$a_0(x_3) = \int_{M'} A(x_3) \begin{pmatrix} D_{x'} \widetilde{z} \\ 1 \end{pmatrix} \begin{pmatrix} D_{x'} \widetilde{z} \\ 1 \end{pmatrix} dx', \qquad f_0(x_3) = \int_{M'} f(x', x_3) dx',$$

and $\widetilde{z}(\cdot, x_3) \in H^1(M')$ is the unique weak solution to

$$\begin{cases} \int_{M'} \widetilde{z}(x', x_3) dx' = 0, \\ \operatorname{div}_{x'} \left(A'(x_3) D_{x'} \widetilde{z} \right) = 0, \text{ in } M', \\ \left(A'(x_3) D_{x'} \widetilde{z} + \left(\begin{array}{c} A_{13}(x_3) \\ A_{23}(x_3) \end{array} \right) \right) \cdot \nu' = 0, \text{ on } \partial M', \end{cases}$$

with $A' = (A_{\alpha\beta})_{\alpha,\beta=1,2}$ and ν' denoting the unit exterior normal to $\partial M'$.

Note that $a_0(x_3) = |M'| A_{33}(x_3)$ if $A_{13} = A_{23} = 0$ (since in this case $\tilde{z} = 0$). In particular, $a_0 = |M'|$ if A = I.

• In the second case (i.e., when $g_n = \chi_{\hat{C}_n} + \delta_n^2 \chi_{\hat{I}_n}$), the limit behavior of problem (1.1) depends on the

$$\lim_{n} \frac{\partial_n}{h_n} = \mu \in [0, +\infty].$$

Precisely, using the Cauchy-Schwarz inequality, Theorem 4.1 provides that

- if $\mu \in]0, +\infty[$, then

$$\int_{h_nM'} \widehat{u}_n(x',\cdot)dx' \longrightarrow \int_{M'} u(x',\cdot)dx' \text{ strongly in } L^2(]0,l[),$$

where, for a.e. x_3 in $]0, l[, u(\cdot, x_3) \in H^1(M')$ is the unique weak solution to

$$\begin{cases} -\mu^{2} \operatorname{div}_{x'} \left(A'(x_{3}) D_{x'} u(\cdot, x_{3}) \right) + b(x_{3}) u(\cdot, x_{3}) = f(\cdot, x_{3}), \text{ in } M', \\ (A'(x_{3}) D_{x'} u(\cdot, x_{3})) \cdot \nu' = 0, \text{ on } \partial M'. \end{cases}$$
(1.3)

- If $\mu = 0$ or $\mu = +\infty$, then

$$\int_{h_nM'} \widehat{u}_n(x',\cdot)dx' - \frac{1}{b} \int_{h_nM'} \widehat{f}_n(x',\cdot)dx' \longrightarrow 0 \text{ strongly in } L^2(]0,l[).$$

or equivalently,

$$\int_{h_nM'} \widehat{u}_n(x',\cdot)dx' \longrightarrow \frac{1}{b} \oint_{M'} f(x',\cdot)dx' \text{ strongly in } L^2(]0,l[).$$

More generally, in Theorem 3.2 and in Theorem 4.1 we consider the case where the matrix A and the coefficient b depend also on y' and we prove L^2 -strong convergence results for \hat{u}_n and for its gradient. It is not difficult to extend these results to monotone operators.

As far as the first case is concerned (i.e., $g_n = \delta_n^2 \chi_{\hat{C}_n} + \chi_{\hat{I}_n}$), let us point out that convergence (1.2) is the same result which one obtains studying the limit behavior of the following problem (for instance, compare [10],[15], [16], and [19])

$$\begin{cases} -\operatorname{div}\left(A\left(x_{3}\right)D\widehat{u}_{n}(y',x_{3})\right)+b\left(x_{3}\right)\widehat{u}_{n}(y',x_{3})=\widehat{f}_{n}(y',x_{3}), \text{ in } \widehat{M}_{n},\\ (A\left(x_{3}\right)D\widehat{u}_{n}(y',x_{3}))\cdot\nu=0, \text{ on } \partial\widehat{M}_{n}, \end{cases}$$

i.e., roughly speaking, in a first approximation (in $L^2(]0, l[]$ -norm) of the average of the solution on the cross-section of the thin cylinder, the presence of a very small insulation cylindrical core \hat{C}_n with a small conductivity does not give any contribution with respect to considering a conductivity of order 1 everywhere in the original problem. Moreover, in Theorem 3.2 we shall show that $\hat{u}_n(y', x_3)$ and its gradient behave as $u(x_3) + h_n \frac{du}{dx_3}(x_3)\tilde{z}\left(\frac{y'}{h_n}, x_3\right)$ in \hat{I}_n which is a corrector result.

As far as the second case is concerned (i.e., $g_n = \chi_{\hat{C}_n} + \delta_n^2 \chi_{\hat{I}_n}$), h_n is a critical size for δ_n . Precisely, if $\delta_n \simeq h_n$ (i.e., $\mu \in]0, +\infty[$), then the $L^2(]0, l[$)-limit of the average of \hat{u}_n on the cross-section of the thin cylinder is $f_{M'}u(x', \cdot)dx'$, with u the solution to problem

(1.3). Moreover in Theorem 4.1 we shall show that $\widehat{u}_n(y', x_3)$ and its gradient with respect to y' behave as $u\left(\frac{y'}{h_n}, x_3\right)$ in \widehat{M}_n . If $\delta_n \ll h_n$ or $\delta_n \gg h_n$ (i.e., $\mu = 0$ or $\mu = +\infty$), the $L^2(]0, l[)$ -limi is given by $\frac{1}{b} f_{M'} f(x', \cdot) dx'$ (formally, this result can be obtained choosing $\mu = 0$ or $\mu = +\infty$ in problem (1.3)). Indeed, this last result depends on the fact that in this introduction we are assuming b independent of y'. In Theorem (4.1) we shall prove that, more generally (i.e., A and b depend also on y'), the case $\mu = 0$ is different from the case $\mu = +\infty$.

For the sake of completeness and for better understand our result in the second case, we recall what happens when $r_n \simeq h_n \simeq \delta_n$ in the case $g_n = \chi_{\hat{C}_n} + \delta_n^2 \chi_{\hat{I}_n}$. Actually, if for instance one assumes $r_n = rh_n$, r > 0, then the limit problem is a nonlocal one in the sense that the limit diffusion is described by a nonlocal system of two equations in which a two-dimensional problem like (1.3), posed in that case on $M' \setminus rC'$, is associated with a one-dimensional problem involving the diffusion along the vertical axis x_3 of the core. This result was proved in [20] for the Laplacian equation with the homogeneous Dirichlet boundary condition on the extremities of the cylinder and the homogeneous Neumann boundary condition elsewhere (also compare [22] for monotone operators), and in [21] for the linearized elasticity system in a thin beam clamped at the extremities. It is easily seen that the nonlocal effect still appears when the homogeneous Neumann boundary condition is assumed everywhere (just a zero order term in the equation is needed in order to obtain a priori estimates). On the other hand, the results are similar in the opposite situation, i.e., $g_n = \delta_n^2 \chi_{\hat{C}_n} + \chi_{\hat{I}_n}$ and $r_n \simeq h_n \simeq \delta_n$.

Our present result states that if the radius r_n of the core is negligible compared to h_n and if $g_n = \chi_{\hat{C}_n} + \delta_n^2 \chi_{\hat{I}_n}$ with $\delta_n \simeq h_n$, then the nonlocal effect disappears since the limit diffusion inside the core is not perceived and only the diffusion outside the core (which is described by (1.3)) gives a contribution in the limit process.

Eventually, we point that when $r_n \simeq h_n$, but δ_n has a different behavior, it is an easy task to prove that the limit problem is local. We also refer to [6] for nonlocal limits in problems with high contrast in a thin cylinder.

In the homogenization setting, there is a vast literature on problems with highly contrasting coefficients since the founding work of T. Arbogast, J. Douglas, and U. Hornung [1] (see also [4] and [5]). Here, we just recall those papers devoted to the homogenization of fibered structures with high contrast: [2], [3], [7], [9], [11], [17], [18], [20], [21], [22]. Let us point out that as far as the periodic homogenization of fibered media is concerned, the homogenized problem has the same form as the limit problem obtained by the corresponding reduction of dimension occurring in the reference cell, as remarked in [20].

Our paper is structured as follows: in Section 2 we introduce some notations and we fix the assumptions on A and b depending on (y', x_3) . In Section 3 we study the asymptotic behavior of the problem with a low conductivity in the core of the structure. After rescaling the solution on $M = M' \times [0, l[$ by $u_n(x) = \hat{u}(h_n x', x_3)$, we prove that $\delta_n \left(\frac{1}{h_n} D_{x'} u_n, D_{x_3} u_n\right) \chi_{C_n}$ is bounded in $L^2(M)$ and, up to a subsequence, u_n converges to u weakly in $L^2(M)$ and $\left(\frac{1}{h_n} D_{x'} u_n, D_{x_3} u_n\right) \chi_{I_n}$ converges to $\xi = (\xi', \xi_3)$ weakly in $(L^2(M))^3$, where C_n and I_n denote the scaling of \hat{C}_n and \hat{I}_n , respectively. It should be noted that C_n and I_n still depend on n

since \hat{C}_n and \hat{I}_n are dependent also on r_n (and not only on h_n). It is not difficult to show that u is independent of x' and $\xi_3 = D_{x_3}u$, but it is quite complicated to write ξ' in terms of u. To do that we need to adapt an uniform extension operator introduced in [12]. Eventually, using the convergence of the energies allows us to obtain the strong convergence in $L^2(M)$ for u_n and for its rescaled gradient (in particular we prove that $\delta_n \left(\frac{1}{h_n}D_{x'}u_n, D_{x_3}u_n\right)\chi_{C_n}$ converges to zero strongly in $L^2(M)$). In Section 4 we study the asymptotic behavior of the problem with a low conductivity in the annulus of the structure. At first we rewrite the problem so that it can be splited in a part on \widehat{M}_n and a part on \widehat{C}_n . Then we introduce two different rescalings $u_n(x) = \widehat{u}(h_n x', x_3)$ in $M = M' \times]0, l[$ and $\overline{u}_n(x) = \widehat{u}_n(r_n x', x_3)$ in $C = C' \times]0, l[$, and we write the problem satisfied by the couple (u_n, \overline{u}_n) . A priori estimates suggest us that the limit problem depends on the ratio $\mu = \lim_n \frac{\delta_n}{h_n}$ and three different regimes appear according to $\mu = 0$, $0 < \mu < +\infty$, or $\mu = +\infty$. The limit problems are obtained passing to the limit in the equation with suitable test functions which, roughly speaking, take into account the relation between u_n and \overline{u}_n , and using suitable density results. Eventually, thanks to the convergence of the energies we obtain the strong convergences.

2 Definitions and notation

Let $\{h_n\}_{n\in\mathbb{N}}$ and $\{r_n\}_{n\in\mathbb{N}}$ be two sequences in [0,1] such that

In what follows, α, β belong to $\{1, 2\}$ and repeated indices imply the summation.

3 Problem I: a low conductivity in the core of the structure

For every $n \in \mathbb{N}$ consider the following problem

$$\begin{cases} -\operatorname{div}\left(\left(\delta_{n}^{2}\chi_{\hat{C}_{n}}+\chi_{\hat{I}_{n}}\right)A\left(\frac{y'}{h_{n}},x_{3}\right)D\hat{u}_{n}\right)+b\left(\frac{y'}{h_{n}},x_{3}\right)\hat{u}_{n}=\hat{f}_{n}, \text{ in } \hat{M}_{n},\\ \left(\delta_{n}^{2}\chi_{\hat{C}_{n}}+\chi_{\hat{I}_{n}}\right)\left(A\left(\frac{y'}{h_{n}},x_{3}\right)D\hat{u}_{n}\right)\cdot\nu=0, \text{ on } \partial\hat{M}_{n}, \end{cases}$$

where ν denotes the exterior unit normal to $\partial \hat{M}_n$.

The weak formulation of (3.1) is

which admits a unique solution by virtue of the Lax-Milgram Theorem.

The goal of this section is to study the asymptotic behavior of this problem, as n diverges. To this aim set

Let $H_m^1(M') = \left\{ v \in H^1(M') : \int_{M'} v dx' = 0 \right\}$. The Lax-Milgram Theorem ensures that for a.e. x_3 in [0, l] the following problem

admits a unique solution. Moreover, the measurability of A ensures (compare [16], pages 749-50) that the function

Then (2.3), (2.4), (3.4), and (3.6) provide that

$$\begin{split} &\int_0^l \left| \frac{\int_{M'} f dx'}{\sqrt{\int_{M'} b dx'}} \right|^2 dx_3 = \int_M b|u|^2 dx \\ &\leq \liminf \int_M b|u_n|^2 dx \leq \lim_n \left[\left(1 - \delta_n^2\right) \left(\frac{r_n}{h_n}\right)^2 \int_C A\left(\frac{r_n}{h_n}x', x_3\right) D_{r_n} \overline{u}_n D_{r_n} \overline{u}_n dx \\ &+ \delta_n^2 \int_M A D_{h_n} u_n D_{h_n} u_n dx + \int_M b|u_n|^2 dx \right] = \lim_n \int_M f_n u_n dx \\ &= \int_M f u dx = \int_0^l \left| \frac{\int_{M'} f dx'}{\sqrt{\int_{M'} b dx'}} \right|^2 dx_3 = \int_M |\sqrt{b}u|^2 dx, \end{split}$$

i.e.

$$\lim_{n} \int_{M} |\sqrt{b}u_{n}|^{2} dx = \int_{M} |\sqrt{b}u|^{2} dx.$$

Consequently, thanks to (4.32) and (2.4),

$$\sqrt{b}u_n \to \sqrt{b}u$$
 strongly in $L^2(M)$,

which implies

$$u_n \to u = \frac{\int_{M'} f(x', \cdot) dx'}{\int_{M'} b(x', \cdot) dx'} \text{ strongly in } L^2(M),$$
(4.34)

thanks to (4.33) and (2.4), too.

On the other side, (3.4) provides

$$\int_{M'} f_n(x', \cdot) dx' \to \int_{M'} f(x', \cdot) dx' \text{ strongly in } L^2(M).$$

Consequently, again thanks to (2.4),

$$\frac{\int_{M'} f_n(x', \cdot) dx'}{\int_{M'} b(x', \cdot) dx'} \to \frac{\int_{M'} f(x', \cdot) dx'}{\int_{M'} b(x', \cdot) dx'} \text{ strongly in } L^2(M).$$
(4.35)

Then, combining (4.34) with (4.35) gives

$$u_n - \frac{\int_{M'} f_n(x', \cdot) dx'}{\int_{M'} b(x', \cdot) dx'} \to 0 \text{ strongly in } L^2(M),$$
(4.36)

Eventually, (4.10) follows from (4.34) and (4.36) by a changing of variable.
