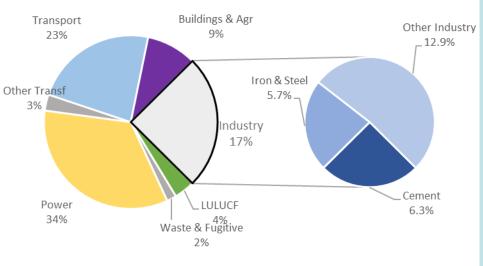

## How to supply materials while meeting the net-zero emissions targets?

- Growing demand for CO2-intensive base materials
- G20 climate change targets of net-zero emissions by 2050-2060
  - Is it possible to reconcile increase in well-being for all (and associated materials demand increase) with aspirations of decarbonization of the world economy?
- We propose to represent steel demand and production in an energy model
- We include hydrogen demand and production associated to emerging uses

### POLES: Prospective Outlook on Long-term Energy Systems

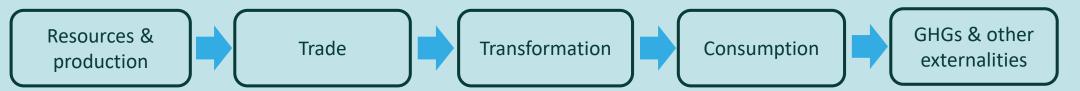
#### Projections of the evolution of the world energy system

- Partial equilibrium, simulation

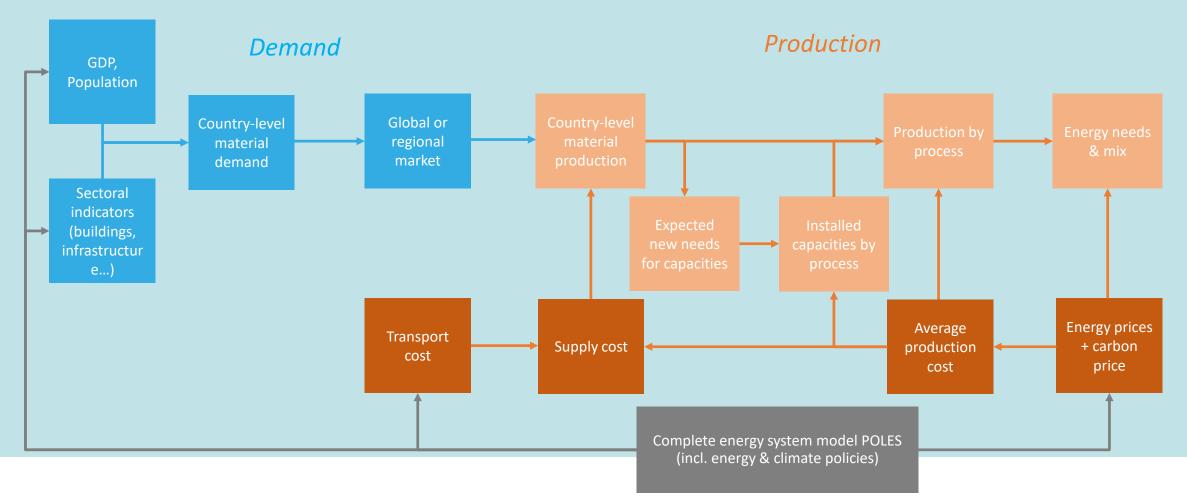
#### Output

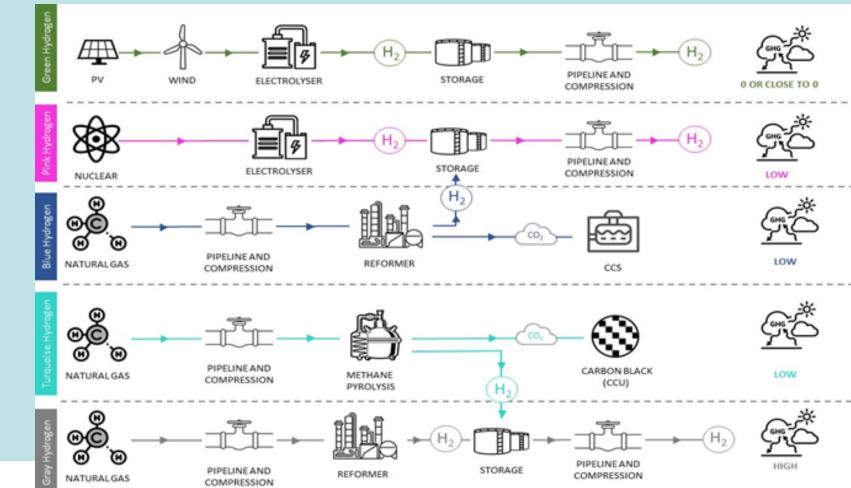

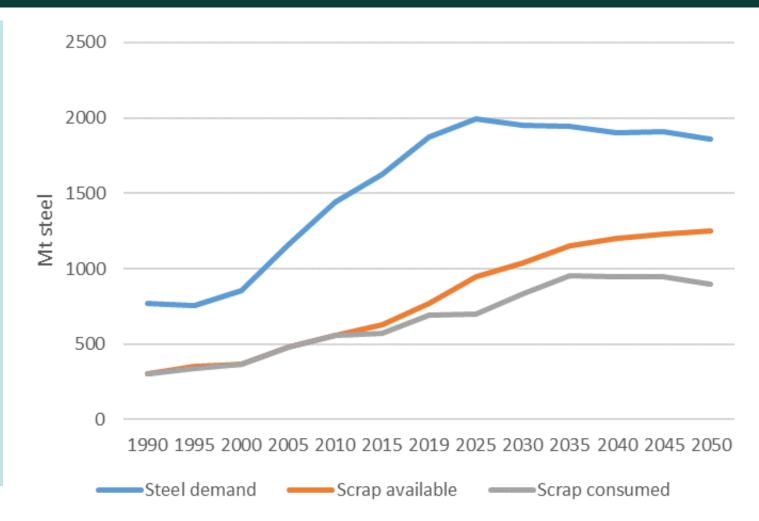

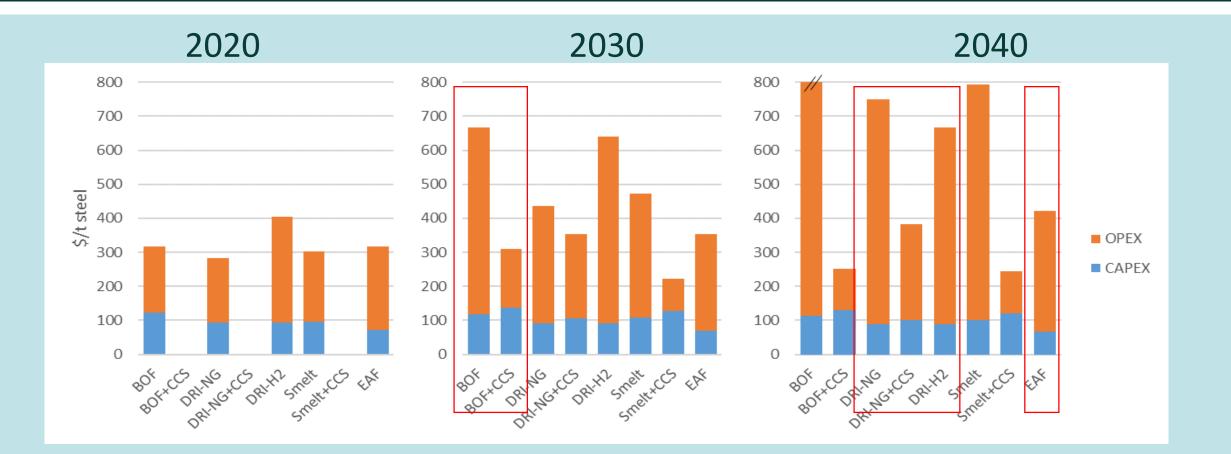
## Projections: World availability of steel scrap

- Rising steel demand
  → increased future availability of scrap
- *Recovery gap*: recovery rate can be increased further
- Economic gap: EAF does not absorb all available scrap (scrap ~ half of production cost of EAF steel, electricity price could increase)

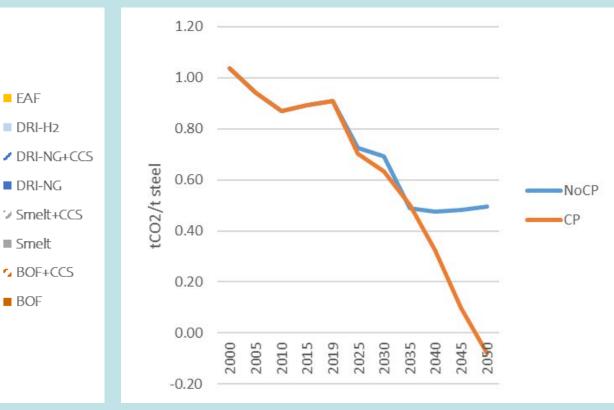

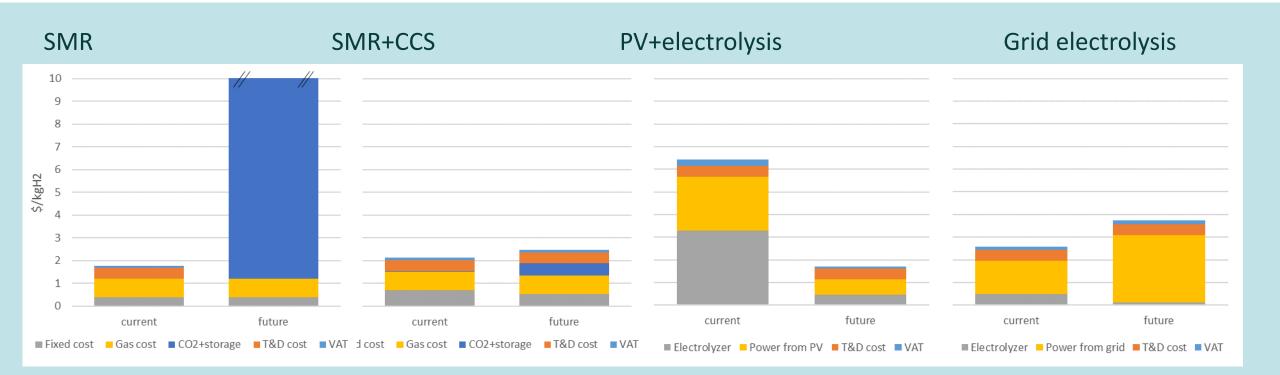

#### Hydrogen: production costs

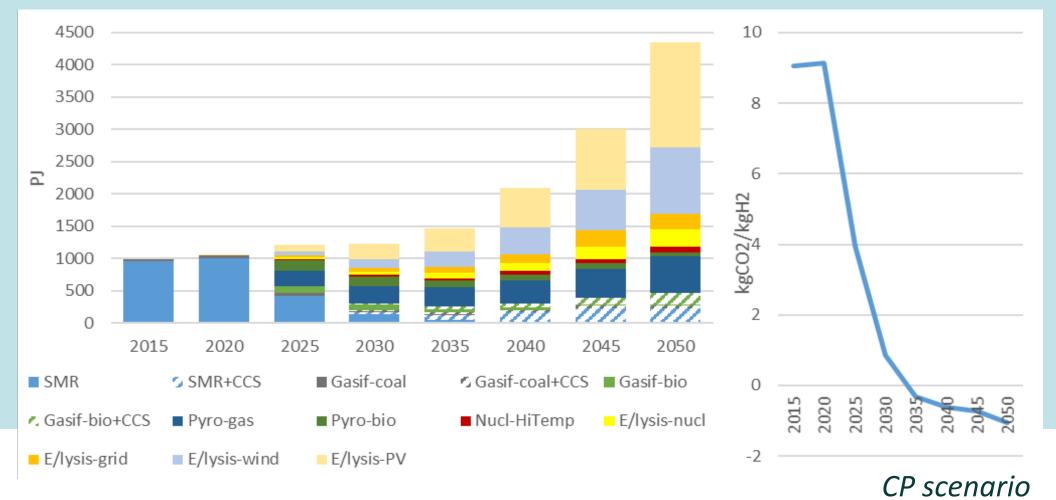

H2 carbon content



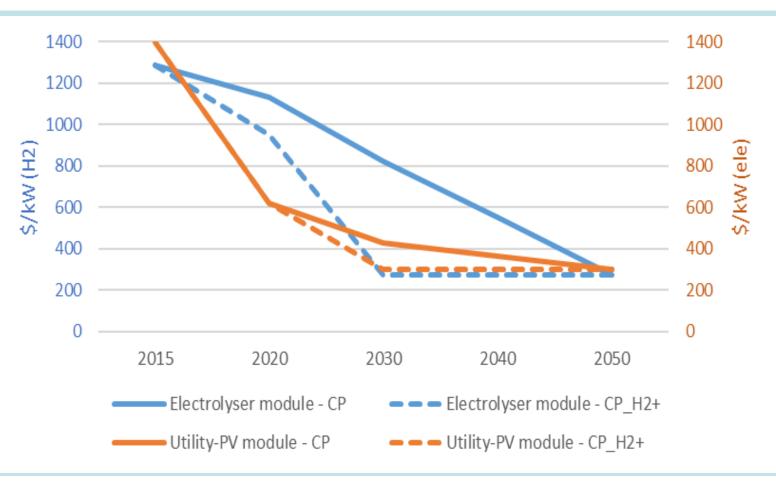

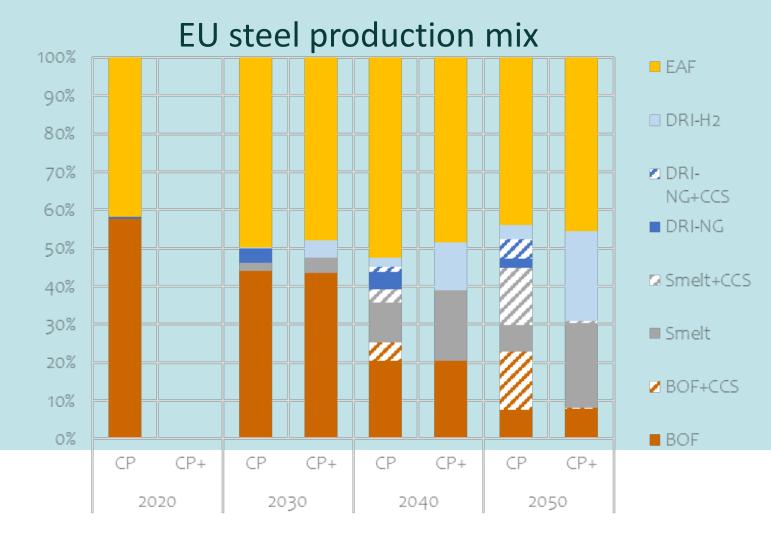
# Variant configuration to encourage hydrogen adoption in steelmaking

- Hydrogen production technology costs: electrolyser, PV modules
- 2. Competitors: delay for CCS
- *3. H2 price:* steel producers choose green & turquoise H2 only
- 4. Enabling factors in the investment environment: no risk premium for new solutions



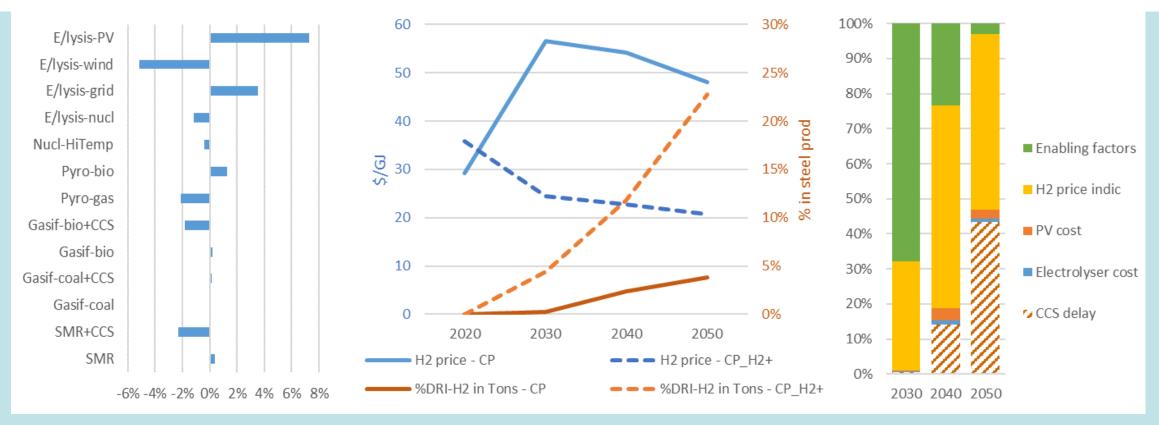

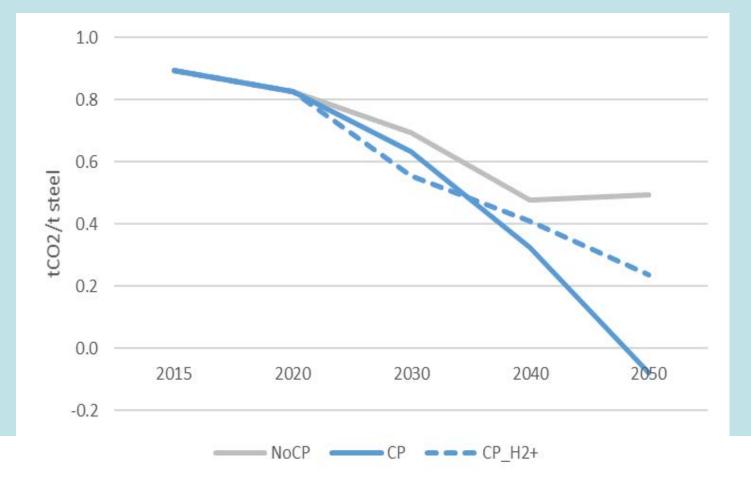
# Variant configuration to encourage hydrogen adoption in steelmaking



→ Importance of decreasing risk perception for new processes
 → H2 market driven by grey/blue H2 production cost

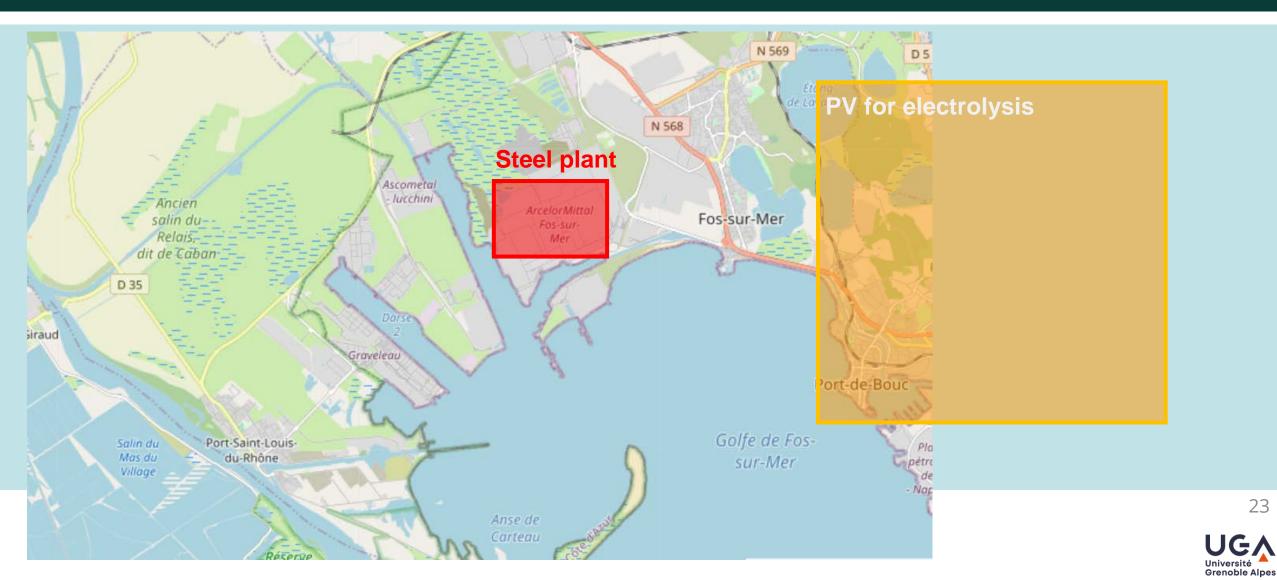
### Wider trade-offs



- Delayed CCS: higher H2 but more emissions
- Consequences on land use of hydrogen electrolysis: 1.8 GW of PV per Mt steel, 14x land area of steel plant
- Opportunity to import low-CO2 steel?

### Prioritising actions over the next 3 decades

Ranking of steel reduction options:

- 1. Material efficiency: revise construction codes in buildings, partial substitution by timber, recycling rate
- 2. Electrify as much as possible mature technology
- **3. CCS**: untested at large scale retrofit on existing plants, start building associated transport storage infrastructure
- **4. Hydrogen**: still costlier invest in R&D of green hydrogen production, use of non-green hydrogen as transitory phase
- **5. Biomass**: consider trade-offs with other sustainability indicators, use when necessary
- **6. Reindustrialisation vs delocalisation**: consider wider social implications, consider carbon content of imported products
