# A Proof of the Tree of Shapes in $n$-D

#### Abstract

In this paper, we prove that the self-dual morphological hierarchical structure computed on a $n$-D gray-level wellcomposed image $u$ by the algorithm of Géraud et al. [1] is exactly the mathematical structure defined to be the tree of shape of $u$ in Najman et al [2]. We recall that this algorithm is in quasi-linear time and thus considered to be optimal. The tree of shapes leads to many applications in mathematical morphology and in image processing like grain filtering, shapings, image segmentation, and so on.


Index Terms-Mathematical Morphology; Tree of Shapes; SelfDual Operators; Well-Composedness; Algorithms.

## I. Introduction

The material presented here is a formal proof that the hierarchical structure provided by the main algorithm in [1] is the tree of shapes presented in [2]. This proof is $n$ dimensional.

## II. Mathematical background

In the following, we consider a $n$-D digital image $u$ as a function defined on a regular cubical $n$-D grid and having integral values (even if we can generalize our case to any totally ordered set); in brief, we have then $u: \mathbb{Z}^{n} \rightarrow \mathbb{Z}$.

Practically a digital image is defined on a finite domain, usually an hyper-rectangle $\left\{\left(z_{1}, \ldots, z_{n}\right) \mid \forall i, 0 \leq z_{i}<N_{i}\right\}$, so the number of points is $N=\prod_{i=1}^{n} N_{i}$, and the space of values is restricted to $\llbracket 0,2^{Q}-1 \rrbracket$, where $Q$ is the quantization. We are interested in computing the tree of shapes of such images.

For generality purpose, we give below some definitions related to a function $f$ defined upon a discrete set $X$ and taking values in a finite set $Y$; we have $f: X \rightarrow Y$. With $X$ having some discrete topology, for any subset $E \subset X$, we denote by $\mathcal{C C}(E)$ the set of connected components of $E$. Given $x \in X$, we denote by $\mathcal{C C}(E, x)$ the connected component of $E$ containing $x$ if $x \in E$; otherwise, we set $\mathcal{C C}(E, x):=\emptyset$.

## A. The tree of shapes in $\mathbb{Z}^{n}$

Let us now consider $X$ as being defined on the regular cubical $n$-D grid $\mathbb{Z}^{n}$ or on one of its subdivisions like $\frac{1}{s} \mathbb{Z}^{n}$ with $s \in \mathbb{N}^{*}$. Furthermore, $X$ is unicoherent in the sense that it is connected and for any two subsets $A, B$ ox $X$, the set $A \cap B$ is connected.

[^0]As usual in discrete topology, to properly deal with subsets of $\mathbb{Z}^{n}$ and with their complementary in $\mathbb{Z}^{n}$, we consider the dual connectivities $c_{2 n}$ and $c_{3^{n}-1}$.

The extension from set to gray-level images is done using what are called threshold sets. For any $\lambda \in \mathbb{R}$, the subsets of $X$ :

$$
\begin{aligned}
{[u<\lambda] } & :=\{x \in X \mid u(x)<\lambda\}, \\
\text { and }[u \geq \lambda] & :=\{x \in X \mid u(x) \geq \lambda\}
\end{aligned}
$$

are respectively called the strict lower threshold set and large upper threshold set of the function $f$ relatively to (the threshold) $\lambda$. The sets $[u<\lambda]$ and $[u \geq \lambda]$ can be understood as binary images.

From these two families of threshold sets, we can deduce two sets, $\mathcal{T}_{<}(u)$ and $\mathcal{T}_{\geq}(u)$, composed of the connected components of respectively lower and upper cuts of $u$ :

$$
\begin{aligned}
& \mathcal{T}_{<}(u)=\left\{\Gamma \in \mathcal{C C}_{c_{2 n}}([u<\lambda])\right\}_{\lambda} \\
& \mathcal{T}_{\geq}(u)=\left\{\Gamma \in \mathcal{C C}_{c_{3^{n}-1}}([u \geq \lambda])\right\}_{\lambda}
\end{aligned}
$$

The elements of $\mathcal{T}_{<}(u)$ and $\mathcal{T}_{\geq}(u)$ respectively give rise to two dual trees 1 the min-tree and the max-tree of $u$.

Let us recall what we call a shape but before let us reintroduce some mathematical basics for mathematical morphology. The saturation operator fills in the cavities of subsets of a topological space $\Omega$ this way for any $\Gamma \subseteq \Omega$ :

$$
\operatorname{Sat}(\Gamma)=\Omega \backslash \mathcal{C C}\left(\Omega \backslash \Gamma, p_{\infty}\right)
$$

In discrete topology, we obtain then for any $\Gamma \subseteq \mathbb{Z}^{n}$ :

$$
\begin{aligned}
\operatorname{Sat}_{c_{3} n-1}(\Gamma) & :=\mathbb{Z}^{n} \backslash \mathcal{C C}_{c_{3^{n}-1}}\left(\mathbb{Z}^{n} \backslash \Gamma\right) \\
\operatorname{Sat}_{c_{2 n}}(\Gamma) & :=\mathbb{Z}^{n} \backslash \mathcal{C C}_{c_{2 n}}\left(\mathbb{Z}^{n} \backslash \Gamma\right)
\end{aligned}
$$

Based on these trees, we can define what we call the sets of shapes:

$$
\begin{aligned}
& \mathcal{S}_{<}(u):=\left\{\operatorname{Sat}_{c_{3} n-1}(\Gamma) ; \Gamma \in \mathcal{T}_{<}(u)\right\} \\
& \mathcal{S}_{\geq}(u):=\left\{\operatorname{Sat}_{c_{2 n}}(\Gamma) ; \Gamma \in \mathcal{T}_{\geq}(u)\right\}
\end{aligned}
$$

$\mathcal{S}_{<}(u)$ is the set of lower shapes of $u, \mathcal{S}_{\geq}(u)$ is the set of upper shapes of $u$. They correspond to the sets of elements of the min- and max-trees when we have filled in their cavities using the saturation operator.

For a given subset $\Gamma \subseteq \Omega$, and for a arbitrarily chosen element $p_{\infty} \in \Omega$, then we call cavity each connected component of $\Omega \backslash \Gamma$ and which does not contain $p_{\infty}$. The connected component of $\Omega \backslash \Gamma$ containing $p_{\infty}$ is called the exterior of $\Gamma$ and can be empty.

The set of all shapes:

$$
\begin{equation*}
\mathfrak{S}(u)=\mathcal{S}_{<}(u) \cup \mathcal{S}_{\geq}(u) \tag{1}
\end{equation*}
$$

forms a tree, the so-called tree of shapes of $u$ [3]. Indeed, for any pair of shapes $\Gamma$ and $\Gamma^{\prime}$ in $\mathfrak{S}$, we have $\Gamma \subset \Gamma^{\prime}$ or $\Gamma^{\prime} \subset$ $\Gamma$ or $\Gamma \cap \Gamma^{\prime}=\emptyset$.

Actually, the shapes are the cavities of the elements of $\mathcal{T}_{<}$ and $\mathcal{T}_{\geq}$. For instance, if we consider a lower component $\Gamma \in$ $[f<\bar{\lambda}]$ and a cavity $H$ of $\Gamma$, this cavity is an upper shape, i.e., $H \in \mathcal{S}_{\geq}$. Furthermore, in a discrete setting, $H$ is obtained after having filled the cavities of a component of $[f \geq \lambda]$.

Figure 1 depicts on a sample image the three components trees $\left(\mathcal{T}_{<}, \mathcal{T}_{\geq}\right.$, and $\left.\mathfrak{S}\right)$. Just note that the Equations so far rely on the pair of dual connectivities, $c_{2 n}$ and $c_{3^{n}-1}$, so discrete topological problems are avoided, and, in addition, we are forced to consider two kind of cuts: strict ones for $c_{2 n}$ and large ones for $c_{3^{n}-1}$.

## B. Cellular complex and Khalimsky grid

Let us recall the definitions relative to $n$-D Khalimsky grids [4], [5]. From the sets $\mathbb{H}_{0}^{1}=\{\{a\} ; a \in \mathbb{Z}\}$ and $\mathbb{H}_{1}^{1}=\{\{a, a+1\} ; a \in \mathbb{Z}\}$, we can define $\mathbb{H}^{1}=\mathbb{H}_{0}^{1} \cup \mathbb{H}_{1}^{1}$ and the set $\mathbb{H}^{n}$ as the $n$-ary Cartesian power of $\mathbb{H}^{1}$. If an element $h \subset \mathbb{Z}^{n}$ is the Cartesian product of $d$ elements of $\mathbb{H}_{1}^{1}$ and $(n-d)$ elements of $\mathbb{H}_{0}^{1}$, we say that $h$ is a $d$-face of $\mathbb{H}^{n}$ and that $d$ is the dimension of $h$. The set of all faces, $\mathbb{H}^{n}$, is called the $n-D$ space of cubical complexes. Figure 3 depicts a set of faces

$\{f, g, h\} \subset \mathbb{H}^{2}$ where $f=\{0\} \times\{1\}, g=\{0,1\} \times\{0,1\}$, and $h=\{1\} \times\{0,1\}$; the dimension of those faces are respectively 0 , 2, and 1. Let us write $s t_{\mathbb{H}^{n}}(h)=\left\{h^{\prime} \in \mathbb{H}^{n} \mid h \subseteq h^{\prime}\right\}$ and $c l_{\mathbb{H}^{n}}(h)=\left\{h^{\prime} \in H^{n} \mid h^{\prime} \subseteq h\right\}$. The pair $\left(H^{n}, \subseteq\right)$ forms a poset and the set $\mathcal{U}=\left\{U \subseteq H^{n} \mid \forall h \in U, s t_{\mathbb{H}^{n}}(h) \subseteq U\right\}$ is a T0-Alexandroff topology on $\mathbb{H}^{n}$. With $E \subseteq \mathbb{H}^{n}$, we have a star operator $s t(E)=\cup_{h \in E} s t_{\mathbb{H}^{n}}(h)$ and a closure operator $c l(E)=\cup_{h \in E} c l_{\mathbb{H}^{n}}(h)$, that respectively gives the smallest open set and the smallest closed set of $\mathcal{P}\left(\mathbb{H}^{n}\right)$ containing $E$.

The set of faces of $\mathbb{H}^{n}$ is arranged onto a grid, the so-called Khalimsky's grid, depicted in gray in Figure 2(b) The set of $n$-faces is denoted by $\mathbb{H}_{n}^{n}$; it is the $n$-Cartesian product of $\mathbb{H}_{1}^{1}$.

## C. Set-Valued Maps

Now let us recall the mathematical background relative to set-valued maps [6]. A set-valued map $\mathrm{U}: X \rightsquigarrow Y$ is characterized by its graph, $\operatorname{Gra}(\mathrm{U})=\{(x, y) \in X \times Y \mid y \in$ $\mathrm{U}(x)\}$. There are two different ways to define the "inverse" of a subset by a set-valued map: $\mathrm{U}^{\oplus}(M)=\{x \in X \mid \mathrm{U}(x) \cap$ $M \neq \emptyset\}$ is the inverse image of $M$ by U , whereas $\mathrm{U}^{\ominus}(M)=$ $\{x \in X \mid \mathrm{U}(x) \subset M\}$ is the core of $M$ by U . Two distinct continuities are defined on set-valued maps. The one we are interested in is the "natural" extension of the continuity of a single-valued function. When $X$ and $Y$ are metric spaces and when $\mathrm{U}(x)$ is compact, U is said to be Upper SemiContinuous (USC) at $x$ if $\forall \varepsilon>0, \exists \eta>0$ such that $\forall x^{\prime} \in$ $B_{X}(x, \eta), \mathrm{U}\left(x^{\prime}\right) \subset B_{Y}(\mathrm{U}(x), \varepsilon)$, where $B_{X}(x, \eta)$ denotes the ball of $X$ of radius $\eta$ centered at $x$. One characterization of USC maps is the following: $U$ is USC if and only if the core of any open subset is open.

A topographical view of a 2D image can be observed in Figure 4 and shows that, using span-based immersion maps, we obtain "continuous" maps (in the sense of set-valued maps).

## D. Interpolation

We are going to immerse a discrete $n$-D function defined on a cubical grid $u: \mathbb{Z}^{n} \rightarrow \mathbb{Z}$ into some larger spaces in order to get some continuity properties. For the domain space, we use the subdivision $X=\frac{1}{2} \mathbb{H}^{n}$ of $\mathbb{H}^{n}$. Every element $z \in \mathbb{Z}^{n}$ is mapped to an element $m(z) \in \frac{1}{2} \mathbb{H}_{n}^{n}$ of dimension $n$ with $z=$ $\left(z_{1}, \ldots, z_{n}\right) \longmapsto m(z)=\left\{z_{1}, z_{1}+\frac{1}{2}\right\} \times \ldots \times\left\{z_{n}, z_{n}+\frac{1}{2}\right\}$. The definition domain of $u, \mathcal{D} \subseteq \mathbb{Z}^{n}$, has thus a counterpart in $X$, that will also be denoted $\mathcal{D}$, and that is depicted in bold in Figure 6
For the value space, we immerse $\mathbb{Z}$ (the set of pixel values) into the larger space $Y=\frac{1}{2} \mathbb{H}^{1}$, where every integer becomes a closed singleton, that is, an element of $\mathbb{H}_{0}^{1}$. Thanks to an "interpolation" function, we can now define from $u$ a setvalued map $\mathrm{U}=\Im(u)$. We have $\mathrm{U}: X \rightsquigarrow Y$ and we set $\forall h \in X, \quad \mathrm{U}(h):=$

$$
\begin{cases}\left\{u\left(m^{-1}(h)\right)\right\} & \text { if } h \in \mathcal{D} \\ \max \left(\mathrm{U}\left(h^{\prime}\right): h^{\prime} \in \operatorname{st}(\operatorname{cl}(h)) \cap \mathcal{D}\right) & \text { if } h \in \frac{1}{2} \mathbb{H}_{1}^{n} \backslash \mathcal{D} \\ \operatorname{span}\left(\mathrm{U}\left(h^{\prime}\right): h^{\prime} \in \operatorname{st}(h) \cap \mathcal{D}\right) & \text { if } h \in X \backslash \frac{1}{2} \mathbb{H}_{1}^{n}\end{cases}
$$

An example of interpolation is given in Figure 5. Actually, whatever $u$, such a discrete interpolation $\mathfrak{I}(u)$ can also be

interpreted as a non-discrete set-valued map $\mathfrak{I}_{\mathbb{R}}(u): \mathbb{R}^{n} \rightsquigarrow \mathbb{R}$ (schematically $\mathfrak{I}_{\mathbb{R}}(u)(x)=\mathfrak{I}(u)(h)$ with $h$ such as $x \in \mathbb{R}^{n}$ falls in $h \in \frac{1}{2} \mathbb{H}^{n}$ ), and we can show that $\Im_{\mathbb{R}}(u)$ is an upper semi-continuous [6] (shortly USC) map.

Such span-based immersions will be called $\mathcal{S I}$-maps in the sequel.

## E. Discrete surfaces and well-composedness

Let us recall the definition of discrete surfaces [8]. Let $Y$ be some partially ordered set (shortly poset) of rank $n \geq 0$. Let $X$ be some subset of $Y$. We say that $X$ is a discrete $(-1)$-surface when $X=\emptyset$. We say $X$ is a 0 -surface if it can be written $\left\{h, h^{\prime}\right\}$ with $h \notin s t_{Y}\left(h^{\prime}\right) \cup c l_{Y}\left(h^{\prime}\right)$. We call $X$ a $k$-surface with $k \geq 1$ when it is connected and when for any $h \in X$, the poset $s t_{Y}(h) \cup c l_{Y}(h) \backslash\{h\}$ is a discrete $(k-1)$-surface.
Furthermore, we call (combinatorial) boundary of a subset $Z$ of $Y$ the set:

$$
\partial Z:=c l_{Y}(Z) \cap c l_{Y}(Y \backslash Z)
$$

We say that $Z$ is (Alexandrov) well-composed (shortly WC) when its boundary is a (possibly empty) separated union of discrete $(n-1)$-surfaces.

Remark 1. We recall that the shapes of a WC SI-map are WC too.

## F. The tree of shapes in $\mathbb{H}^{n}$

Assuming that the domain $X$ of the interpolation $\mathfrak{I}(u)$ is unicoheren $t^{2}$, like $\mathbb{H}^{n} / 2$ or any hyper-rectangle in $\mathbb{H}^{n} / 2$, and

that it set $Y$ of values is $\mathbb{H}^{1} / 2$. Then, threshold sets are defined for any $\lambda \in Y$ in this way [10], [7]:

$$
\begin{aligned}
& {[\mathrm{U} \triangleleft \lambda]=\{x \in X \mid \forall \mu \in \mathrm{U}(x), \mu<\lambda\}} \\
& {[\mathrm{U} \triangleright \lambda]=\{x \in X \mid \forall \mu \in \mathrm{U}(x), \mu>\lambda\}}
\end{aligned}
$$

We can show (see [2]) that, for any $\lambda \in Y$, the threshold sets $[\mathfrak{I}(u) \triangleleft \lambda]$ and $[\Im(u) \triangleright \lambda]$ are well-composed [11] when we use a well-composed interpolation $\mathfrak{I}(u)$ (see [7], [2] for examples of $n$-D well-composed interpolations). Then the combinatorial boundaries of the threshold sets are discrete surfaces. By defining respectively the upper and the lower shapes:

$$
\begin{aligned}
& \mathcal{S}_{\triangleright}=\left\{\operatorname{Sat}(\Gamma) ; \Gamma \in\{\mathcal{C C}([\mathfrak{I}(u) \triangleright \lambda])\}_{\lambda}\right\}, \\
& \mathcal{S}_{\triangleleft}=\left\{\operatorname{Sat}(\Gamma) ; \Gamma \in\{\mathcal{C C}([\mathfrak{I}(u) \triangleleft \lambda])\}_{\lambda}\right\}
\end{aligned}
$$

we obtain then that together these shapes form a set of shapes $\mathfrak{S}_{\mathfrak{I}(u)}$ which is a tree, the tree of shapes.

## G. Some elementary properties about shapes

The following properties of shapes will be useful in the sequel.
Proposition 1 (Lemma 2.5 in [9]). Let $\mathcal{D}$ be a topological space. Then, the Sat operator is monotonic, that is, for any subset $A, B$ of $\mathcal{D}$ :

$$
A \subseteq B \Rightarrow \operatorname{Sat}(A) \subseteq \operatorname{Sat}(B)
$$

Proposition 2 (Lemma 2.4 [9]). Let $\mathcal{D}$ be a topological space. Then, when $A \subseteq \mathcal{D}$ is an open set, then $\operatorname{Sat}(A)$ is open too.

Proposition 3 (Lemma 2.7 [9]). Let $\mathcal{D}$ be a topological space. Then, when $A \subseteq \mathcal{D}$ is connected, then $\operatorname{Sat}(A)$ is connected too.

Proposition 4 (Lemma 2.10 [9]). Let $\mathcal{D}$ be a compact, locally connected, and unicoherent topological space. Let $A$ be a subset of $\mathcal{D}$ such that $\operatorname{Sat}(A) \neq \mathcal{D}$. Then $\operatorname{Sat}(A) \subseteq \operatorname{Sat}(\partial A)$. Furthermore, if $A$ is closed, $\operatorname{Sat}(A)=\operatorname{Sat}(\partial A)$.

Proposition 5 ([8]). Let $\mathcal{D}$ be a $n-D$ finite (unicoherent) hyperrectangle in the $n-D$ Khalimsky grid, and let $p_{\infty}$ be a $n$-face of $\mathcal{D}$ which belongs to $\partial \mathcal{D}$. When a finite set $X$ is an open

regular $W C$ set, then we have the following property for any $x \in \mathcal{D}$ :

$$
\operatorname{Sat}\left(c l_{\mathcal{D}}(X), x\right)=c l_{\mathcal{D}}(\operatorname{Sat}(X, x))
$$

Figures 7 and 8 depict the possible topological issue which arises when we do not work with well-composed images.

## III. Algorithm Description

## A. The main algorithm

Let us begin with an intuitive explanation of the computation of the tree of shapes (see Figure 9). We start from an image $u$ whose domain is a subset of $\mathbb{Z}^{n}$. Then, we compute in $\mathbb{Z}^{n} / 2$ its well-composed max-interpolation. Then, we immerse the interpolation into the $n$-D Khalimsky grid, so we provide some continuity to the new image U representing $u$. We call abusively this procedure the immersion step. Then, based on U , we add a border, from which we start the propagation, and we go deeper and deeper in the image, until we have covered the whole domain of the image. This step is called the tree computation because while we cover the domain of the image, we can deduce the parenthood relationship between the components in the image (we prove it in the next section). Since the propagation has been done over a domain which has been subdivided twice (once with the max interpolation and once to immerse $\mathbb{Z}^{n} / 2$ into $\mathbb{H}^{n} / 2$ ), we have to go back to the initial domain. This last step is called the emersion and removes the secondary pixels to keep only the primary pixels.

## B. The main procedure of the algorithm more in details

The algorithmic description of the procedure presented in the previous subsection is as described in Alg. 1. We start with the procedure called IMMERSION, and we follow with the computation of the tree of shapes in three steps: (1) We use a front propagation algorithm SORT which handles a hierarchical queue and starts from the border of the image and covers progressively the whole domain, it outputs then an array $\mathcal{R}$ of the ordered pixels of the domain of the image, (2) Now that we have $\mathcal{R}$, we use UNION_FIND to deduce the parenthood relationship parent between the pixels of the image, that is, it builds the tree of shapes (but without optimization) of U ; (3)Then the procedure CANONICALIZE_TREE is utilized to optimize the tree so that each pixel has a parent which is the representative of the component it belongs to. This way, we obtain parent which is in fact $\mathfrak{S}(U)$. From it, we can easily deduce $\mathfrak{S}(u)$ by removing the secondary pixels (see the EMERGE prodecure).

## C. The sorting step

The details of the sorting step can be found in Alg 2 To sort the faces of the domain $X$ of $U$, we use a classical front propagation based on a hierarchical queue [12], denoted by $q$, the current level being denoted by $\mathscr{L}$. There are two notable differences with the well-known hierarchical-queuebased propagation. First the $d$-faces, with $d<n$, are intervalvalued so we have to decide at which (single-valued) level to enqueue those elements. The solution is straightforward: a face $h$ is enqueued at the value of the interval $U(h)$ that is the closest to $\mathscr{L}$ (see the procedure PRIORITY_PUSH). Just also note that we memorize the enqueuing level of faces thanks to the image $u^{b}$ (see the procedure SORT). Second, when the queue at current level, $q[\mathscr{L}]$, is empty (and when the hierarchical queue $q$ is not yet empty), we shall decide what the next level to be processed is. We have the choice of taking the next level, either less or greater than $\mathscr{L}$, such that the queue at that level is not empty (see the procedure PRIORITY_POP), even if this choice has no influence on the result $\mathcal{R}$ of the algorithm. The image $U$, in addition with the browsing of level in the hierarchical queue, allows for a propagation that is "continuous" both in domain space and in level space.

## D. Tree Representation

The max-tree algorithm presented in [13] is actually a kind of meta-algorithm that can be "filled in" so that it can serve different aims; in particular, in the present paper, it gives an algorithm to compute the tree of shapes. An extremely simple union-find structure (attributed by Aho to McIlroy and Morris) was shown by Tarjan [14] to be very efficient. This structure, also called disjoint-set data structure or merge-find set, has many advantages that are detailed in [15]; amongst them, memory compactedness, simplicity of use, and versatility. This structure and its related algorithms are of prime importance to handle connected operators [16], [17].

Let us denote by $\mathcal{R}$ the ancestor relationship in trees: we have $a \mathcal{R} p$ iff $a$ is an ancestor of $p . \mathcal{R}$ can be encoded as an array of elements (nodes) so that $a \mathcal{R} p \Leftrightarrow \operatorname{index}_{\mathcal{R}}(a)<$ index $x_{\mathcal{R}}(p)$; browsing that array thus corresponds to a downwards browsing of the tree, i.e., from root to leaves. To con-

struct the max-tree of a given image, we rely on a rooted tree defined by a parenthood function, named parent, and encoded as an $n$-D image (so $\operatorname{parent}(p)$ is an $n$ - D point). When a node of the max-tree contains several points, we choose its first point (with respect to $\mathcal{R}$ ) as the representative for this node; that point is called a component "canonical point" or a "level root". Let $\Gamma$ denote a component corresponding to a node of the max-tree, $p_{\Gamma}$ its canonical element, and $p_{r}$ the root canonical element. The parent function that we want to construct should verify the following four properties:

1) $\operatorname{parent}\left(p_{r}\right)=p_{r}$;
2) $\forall p \neq p_{r}, \operatorname{parent}(p) \mathcal{R} p$;
3) $p$ is a canonical element iff

$$
\left\{p=p_{r}\right\} \vee\{u(\operatorname{parent}(p)) \neq u(p)\}
$$

4) $\forall p, p \in \Gamma \Leftrightarrow\left\{u(p)=u\left(p_{\Gamma}\right)\right\} \wedge\left\{\exists i, \operatorname{parent}^{i}(p)=p_{\Gamma}\right\}$.

The routine UNION_FIND, given in Algorithm 3, is the classical "union-find" algorithm [14] but modified so that it computes the expected morphological tree [13] while browsing pixels following $\mathcal{R}^{-1}$ (see Figure 10, i.e., from leaves to root. Its result is a parent function that fulfills those first four properties. Obtaining the following extra property, "5. $\forall p, \operatorname{parent}(p)$ is a canonical element," is extremely interesting since it ensures that the parent function, when restricted to canonical elements only, gives a "compact" morphological tree. Precisely it allows to browse components while discarding their contents: a traversal is thus limited to one element (one pixel) per component, instead of passing through every image elements (pixels). Transforming the parent function so that property 5 is verified can be performed by a simple postprocessing of the union-find computation. The resulting tree has now the simplest form that we can expect (see Alg. 4); furthermore we have an isomorphism between images and their canonical representations.

The algorithm presented in [13] to compute the max-tree is also able to compute the tree of shapes. The skeleton of this algorithm is the routine COMPUTE_TREE is composed of the steps presented above. In the case of the max-tree, the sorting step provides $\mathcal{R}$ encoded as an array of points sorted by increasing gray-levels in $u$, i.e., such that the array indices satisfy $i d x<i d x^{\prime} \Rightarrow u(\mathcal{R}[i d x]) \leq u\left(\mathcal{R}\left[i d x^{\prime}\right]\right)$. Last, the canonicalization post-processing is trivial [13]. In the case of the tree of shapes, it is also a tree that represents
an inclusion relationship between connected components of the input image. As a consequence an important idea to catch is that the tree of shapes can be computed with the exact same routine, UNION_FIND, as the one used by the max-tree. The major and crucial difference between the max-tree and the tree of shapes computations is obviously the sorting step (see Figure 10). For the UNION_FIND routine to be able to compute the tree of shapes using $\mathcal{R}^{-1}$, the SORT routine has to sort the image elements so that $\mathcal{R}$ corresponds to a downward browsing of the tree of shapes. Schematically, $\mathcal{R}$ contains the image pixels going from the "external" shapes to the "internal" ones (included in the former ones).

## E. The last step: the emersion

Using the canonicalized tree, we can finalize the procedure and emerge the connected components of the tree simply by removing the secondary pixels of the components (see Algo 55).

## IV. The $n$-D PRoof

## A. New mathematical properties

Let us recall that the strict threshold sets of a plain map are open sets.

Proposition 6. Let $U$ be some $\mathcal{S I}$-map on a n-D Khalimsky grid, then any of its strict threshold sets $T$ is regular, that is, it satisfies.

## The direct consequence is that its strict shapes are regular sets

 too.Proof: Let us treat the upper case (see Figure 11) for some value $\lambda \in \mathbb{R}$ (the lower case follows the same reasoning). Let $\lambda$ be some real value, and $[U \triangleright \lambda]$ the corresponding lower set. Now, let us prove its regularity using a double inclusion. First, for any $\lambda \in \mathbb{R},[U \triangleright \lambda]$ is contained in $c l_{\overline{\mathcal{D}}}([U \triangleright \lambda])$, thus $[U \triangleright$ $\lambda]=\operatorname{Int}([U \triangleright \lambda]) \subseteq \operatorname{Int}\left(c l_{\overline{\mathcal{D}}}([U \triangleright \lambda])\right)$, which proves the first inclusion. Second, let us define some $z \in \operatorname{Int}\left(c l_{\overline{\mathcal{D}}}([u \triangleright \lambda))\right.$, then $s t_{\overline{\mathcal{D}}}(z) \subseteq c l_{\overline{\mathcal{D}}}([U \triangleright \lambda])$. The subset $\left(s t_{\overline{\mathcal{D}}}(z)\right)_{n}$ made of the $n$-faces of $s t_{\overline{\mathcal{D}}}(z)$ is contained in $c l_{\overline{\mathcal{D}}}([U \triangleright \lambda])=\partial[U \triangleright$ $\lambda] \sqcup[U \triangleright \lambda]$ (disjoint union). Since $\partial[U \triangleright \lambda]$ does not contain any $n$-face (as every combinatorial boundary), then:

Consequently, for any $p \in\left(s t_{\overline{\mathcal{D}}}(z)\right)_{n}, U(p) \triangleright \lambda$, which leads by using the formula of the span-based immersion to:

$$
U(z):=\operatorname{span}\left\{U(p) ; p \in\left(s t_{\overline{\mathcal{D}}}(z)\right)_{n}\right\} \triangleright \lambda,
$$

then $U(z) \triangleright \lambda$, that is, $z \in[U \triangleright \lambda]$. The proof is done.
Definition 1 (Interior boundaries). Let $\mathbb{H}^{n}$ be the n-D Khalimsky grid, and let $F$ be an open subset of $\mathbb{H}^{n}$. We call interior boundary of $F$ the set $\partial_{\mathrm{int}} F=s t_{\mathbb{H}^{n}}(\partial F) \cap F$.

We recall that a family $\bigcup_{i \in I} X_{i}$ of subsets of a poset $X$ is

said to be a separated union when for any $i, j$ in $I$ with $i \neq j$, $\left(s t_{X}\left(X_{i}\right) \cup c l_{X}\left(X_{i}\right)\right) \cap X_{j}=\emptyset$.

## B. Property of the internal boundaries

Proposition 7. Let $\mathcal{T}$ be an open subset of $\mathbb{H}^{n}$. The set $\partial_{\mathrm{int}}(\mathcal{T})$ can be reformulated this way:

$$
\partial_{\mathrm{int}}(\mathcal{T})=s t_{\mathbb{H}^{n}}(\mathcal{T}) \cap s t_{\mathbb{H}^{n}}\left(\mathbb{H}^{n} \backslash \mathcal{T}\right)

Proof: Let us prove this equality by a double inclusion relationship. When $h$ is an element of $\partial_{\text {int }}(\mathcal{T})=s t_{X}(\partial \mathcal{T}) \cap \mathcal{T}$, then $h$ belongs to $\mathcal{T} \subseteq s t_{X}(\mathcal{T})$ and then $h \in s t_{X}(\mathcal{T})$. In addition, $\mathbb{H}^{n} \backslash \mathcal{T}$ is closed since $\mathcal{T}$ is open by hypothesis, which means that $\mathbb{H}^{n} \backslash \mathcal{T}$ contains its boundary $\partial \mathcal{T}$. This way, we have that $h \in s t_{X}(\partial \mathcal{T}) \subseteq s t_{X}\left(\mathbb{H}^{n} \backslash \mathcal{T}\right)$. This concludes the first implication. Conversely, when $h$ belongs to $\operatorname{st}_{X}(\mathcal{T}) \cap$

$s t_{X}\left(\mathbb{H}^{n} \backslash \mathcal{T}\right)$, then $h$ belongs to $s t_{X}(\mathcal{T})=\mathcal{T}$. Furthermore, $h$ belongs to $s t_{X}\left(\mathbb{H}^{n} \backslash \mathcal{T}\right)$ and then contains (as a face) some other face of $\mathbb{H}^{n} \backslash \mathcal{T}$. However, the only elements of $\mathbb{H}^{n} \backslash$ $\mathcal{T}$ which are adjacent to $\mathcal{T}$ are the elements of $\partial T$, then $h$ contains a face $z$ of $\partial \mathcal{T}$, then $h \in s t_{X}(\partial \mathcal{T})$. This proves the second implication.

## C. Domains of the $\mathcal{S I}$-maps and their (thick) border

From now on, we will use the following notations.
Let the domain $\mathcal{D}$ of the given $\mathcal{S I}$-map $U$ be some nonempty bounded open hyper-rectangular domain in the $n$-D Khalimsky grid $\mathbb{H}^{n}$.

Then, we deduce the "enlarged" domain:

$$
\overline{\mathcal{D}}:=c l_{\mathbb{H}^{n}}\left(s t_{\mathbb{H}^{n}}\left(c l_{\mathbb{H}^{n}}(\mathcal{D})\right)\right)
$$

whose border $\triangle \overline{\mathcal{D}}$ is the set:

$$
\triangle \overline{\mathcal{D}}=\overline{\mathcal{D}} \backslash \mathcal{D}
$$

We naturally extend $U$ to $U_{\text {ext }}$ on $\overline{\mathcal{D}}$ in the following way: we set at $\left\{\mathscr{L}_{\infty}\right\}$ with $\mathscr{L}_{\infty} \in \mathbb{R}$ all the $n$-faces of the border of $\overline{\mathcal{D}}$ and we choose arbitrarily one of the $n$-faces of $\triangle \overline{\mathcal{D}}$ as exterior point $p_{\infty}$. The faces of $\overline{\mathcal{D}} \backslash \mathbb{H}_{n}^{n}$ are then naturally set using a procedure detailed later and which ensures the continuity of the new set-valued image $U_{\text {ext }}$ defined on $\overline{\mathcal{D}}$.

This way, we ensure that any shape $\mathcal{S}$ of $U_{\text {ext }}$ is either the whole domain $\overline{\mathcal{D}}$ or a subset of $\mathcal{D}$. We are thus ensured that for any shape $\mathcal{S}$ of $U_{\text {ext }}$, the boundary $\partial \mathcal{S}$ is equal to $\partial \overline{\mathcal{D}}$ or does not intersect $\partial \overline{\mathcal{D}}$. Furthermore, the complementary in $\overline{\mathcal{D}}$ of any shape $\mathcal{S}$ of any $\mathcal{S I}$-map defined on $\overline{\mathcal{D}}$ is either empty or connected.

For sake of simplicity, we will refer to $U_{e x t}$ by calling $U$.

## D. $\mathcal{P} \mathcal{R}$-cavities and their mathematical properties

Notation 1. Assuming that $\mathscr{L}_{i}$ is the level at step $i$ of the front propagation algorithm (FPA), we can reformulate the front propagation (see Figures 1415 and 16) this way:

- $\mathscr{L}_{0}=\mathscr{L}_{\infty}$ is the level at step 0 ,

- $P_{0}=\mathcal{C C}\left(\left[U=\mathscr{L}_{\infty}\right], p_{\infty}\right)$ is the covered part of $\overline{\mathcal{D}}$ at step 0,
- $\left\{\mathcal{T}_{0}^{j}\right\}_{j \in \mathcal{J}(0)}=\mathcal{C C}\left(\overline{\mathcal{D}} \backslash P_{0}\right)$ is the set of what we call $\mathcal{P} \mathcal{R}$-cavities at step 0 ,
- when $i>0$,

P_{i+1}=P_{i} \cup \bigcup_{j \in \mathcal{J}(i)} \bigcup_{x \in \partial_{\mathrm{int}}\left(\mathcal{T}_{i}^{j}\right)} \mathcal{C C}\left(\left[U=\mathscr{L}_{i+1}\right], x\right)
$$

is the covered domain at step $i$,

- when $i>0$,

$$
\left\{\mathcal{T}_{i+1}^{j}\right\}_{j \in \mathcal{J}(i+1)}=\mathcal{C C}\left(\overline{\mathcal{D}} \backslash P_{i+1}\right)
$$

is the set of what we call $\mathcal{P} \mathcal{R}$-cavities at step $i>0$.

Note: the elements $P_{i}$ are directly deduced from the propagation presented in Alg. 2 and the terms $\mathcal{T}_{i}^{j}$ corresponds to cavities in $\mathbb{H}^{n}$ but will be called $\mathcal{P} \mathcal{R}$-cavities to emphasize that they are obtained thanks to the propagation algorithm.


Fig. 17. Two equivalent representations of the same data on a toy example: at the top, the image $u^{b}$ in a 2D Khalimsky grid, and at the bottom, the corresponding parent $U_{F}$ structure (in dark blue) resulting from the union-find algorithm; the corresponding output from the sort algorithm is $\mathcal{R}=[0, \ldots, 0,1,1,2,3]$, and the levels $\mathscr{L}$ are in the following order: $[0,1,2,3]$. While $P_{i}$ is progressively covering the whole domain $\mathcal{D}$, the structure parent $U_{F}$ grows and represents the way the propagation covers the domain. When a node in parent $_{U F}$ has a value different from the one of its parent, a level-line is crossed, which means that the depth of this branch into the image increases.

Now, let us briefly show that the representation parent $_{U F}$ provided by the union-find algorithm and the image $u^{b}$ provided by the front propagation algorithm are equivalent. They both encode the front propagation, as depicted in Figure 17.

Furthermore, they show the following properties:

## Property 1. At each step $i$ of the front propagation algorithm, the front $P_{i}$ is connected.

Proof: First, the tree resulting from the propagation is connected by construction. Second, two nodes are connected in this tree when they satisfy a covering relationship in the Khalimsky grid (due to the propagation based on the $2 n$-connectivity). Thus, the representation of the tree in the domain $\overline{\mathcal{D}}$ is connected, since a covering relation implies adjacency.

Property 2. At each step $i$ of the front propagation algorithm, the front $P_{i}$ is closed.

Proof: This results from the fact that for any face $h \in \overline{\mathcal{D}}$ which is treated by the front propagation algorithm, all its faces $h^{\prime}$ will satisfy $u^{b}(h) \in U\left(h^{\prime}\right)$, thus all the faces $h^{\prime}$ will be treated at the same step (with the same current level $\mathscr{L}$ ). In other words, when $h$ belongs to $P_{i}$, all the closure of $P_{i}$ is contained in $P_{i}$, which leads to the fact that $P_{i}$ is closed.

Property 3 ( $\mathcal{P R}$-cavities form a hierarchy). The set of $\mathcal{P} \mathcal{R}$ cavities of a SI-map $U$ defined on a domain $\overline{\mathcal{D}}$ satisfies that
for two $\mathcal{P} \mathcal{R}$-cavities $\mathcal{T}, \mathcal{T}^{\prime}$ such that $\mathcal{T} \cap \mathcal{T}^{\prime} \neq \emptyset$, then we have $\mathcal{T} \subseteq \mathcal{T}^{\prime}$ or $\mathcal{T} \supseteq \mathcal{T}^{\prime}$. In other words, the set of $\mathcal{P} \mathcal{R}$-cavities of $U$ is a tree, and we will denote it by $\mathfrak{P R}-\mathfrak{C a v}$.

Proof: By increasingness of the front $P_{i}$, we obtain easily that the connected components of its complementary are nested. Furthermore, $\overline{\mathcal{D}}$ is a superset of any other cavity of $U$. Thus, $\mathfrak{P R}-\mathfrak{C a v}$ is a tree.

Notation 2. Let $\mathcal{T} \subsetneq \overline{\mathcal{D}}$ be a cavity of a $\mathcal{S I}$-map $U$. We denote by parent $\mathfrak{P R}^{-\mathfrak{C a v}}(\mathcal{T})$ the direct parent of $\mathcal{T}$ in $\mathfrak{P R}-\mathfrak{C a v}$. The root of $\mathfrak{P R}-\mathfrak{C a v}$, $\overline{\mathcal{D}}$, has no parent in $\mathfrak{P R}-\mathfrak{C a v}$.

Notation 3. Let $\mathcal{T}$ be a $\mathcal{P} \mathcal{R}$-cavity of a $\mathcal{S I}$-map $U$. We define the following set: next $\mathfrak{P R}_{\mathfrak{R}-\mathfrak{C a v}}(\mathcal{T})=$

\left\{\mathcal{T}^{\prime} \in \mathfrak{P R}-\mathfrak{C a v}(U) ; \mathcal{T}=\boldsymbol{p a r e n t}_{\mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}\left(\mathcal{T}^{\prime}\right)\right\}
$$

Notation 4. Let $\mathcal{T}$ be a $\mathcal{P} \mathcal{R}$-cavity of a SI-map $U$. We denote by children $\mathfrak{P R R}^{-\mathcal{C a v}}(\mathcal{T})$ the set of children of $\mathcal{T}$ in $\mathfrak{P R}-\mathfrak{C a v}(U)$.
Proposition 8. Let $U$ be some $\mathcal{S I}$-map on $\overline{\mathcal{D}}$. For any $\mathcal{P} \mathcal{R}$ cavity $\mathcal{T}$ of $U$, we have the following equality:

$$
\bigcup_{\mathcal{T}^{\prime} \in \text { next }_{\mathfrak{P} \mathfrak{R}-\mathbb{C} \mathfrak{a v}}(\mathcal{T})} \mathcal{T}^{\prime}=\bigcup_{\mathcal{T}^{\prime} \in \text { children }_{\mathfrak{P} \mathfrak{R}-\mathfrak{C} \mathfrak{a v}}(\mathcal{T})} \mathcal{T}^{\prime}
$$

Proof: The first inclusion is immediate. The converse inclusion follows directly from Property 3


Fig. 18. The front $P_{0}$ is depicted in black and shows the propagation on the domain of a $\mathcal{S I}$-map $U$ at the initial step. Then, the remaining (open) $\mathcal{P} \mathcal{R}$ cavity $\mathcal{T}$ (whose boundary is depicted in red) will be partially covered at the next propagation level $\ell=2$ since it is the nearest level among $\{2,3\}$. We can thus affirm that $\mathscr{L}_{*, \mathfrak{P R}-\mathbb{C a v}}(\mathcal{T})=2$. Furthermore, the set $(\mathcal{T})_{*, \mathfrak{P R}-\mathfrak{C a v}}$ is depicted by all the blue faces connected into $[U=2]$ to the pixels of value 2 in the internal boundary of $\mathcal{T}$. This set is also equal to $\mathcal{T}$ minus its children in the hierarchy constructed thanks to the propagation.

The following definition is depicted in Figure 18
Definition 2. Let $U$ be some $\mathcal{S I}$-map on $\overline{\mathcal{D}}$. For some $\mathcal{P} \mathcal{R}$ cavity $\mathcal{T}$ of $U$, we will denote by $\mathscr{L}_{*, \mathfrak{P} \Re-\mathfrak{C a v}}(\mathcal{T})$ the level at which the FPA covered $\mathcal{T}$ starting from the elements of its internal boundary and we call it the proper level of $\mathcal{T}$.
Property 4. Any $\mathcal{P} \mathcal{R}$-cavity $\mathcal{T}$ of a $\mathcal{S I}$-map $U$ is an open subset of $\mathbb{H}^{n}$.

Proof: Let $i$ be some fixed value in $[0, N]$. Since $P_{i}$ is built from a finite union of closed sets, it is closed. The direct consequence is that its complementary is an open set, and then each of its connected components is an open set too.

Property 5. The internal boundary of each $\mathcal{P} \mathcal{R}$-cavity $\mathcal{T}$ of a SI-map $U$ is connected.

Proof: Let us notice that $\partial_{\mathrm{int}} \mathcal{T}_{i}^{j}$ is the intersection of

$$
P_{i} \cup \bigcup_{k \in \mathcal{J}(i) \backslash\{j\}} \mathcal{T}_{i}^{k} \cup \partial_{\mathrm{int}} \mathcal{T}_{i}^{j}

(which is an open connected set) and of $\mathcal{T}_{i}^{j}$ (which is open by Property 4 and connected by definition). Furthermore, their intersection is equal to $\partial_{\mathrm{int}} \mathcal{T}_{i}^{j}$, and their union covers $\overline{\mathcal{D}}$. Since $\overline{\mathcal{D}}$ is unicoherent by hypothesis, then $\partial_{\mathrm{int}} \mathcal{T}_{i}^{j}$ is connected.
Definition 3. Let $U$ be a $\mathcal{S I}$-map on $\overline{\mathcal{D}}$. We say that a $\mathcal{P} \mathcal{R}$ cavity $\mathcal{T}$ different from $\overline{\mathcal{D}}$ is an upper $\mathcal{P} \mathcal{R}$-cavity when the proper level of $\mathcal{T}$ is greater than the one of its parent (positive polarity). At the opposite, we say $\mathcal{T}$ is a lower $\mathcal{P} \mathcal{R}$-cavity when its proper level is lower than the one of its parent (negative polarity). Two $\mathcal{P} \mathcal{R}$-cavities are said to be of the same nature when they are both upper $\mathcal{P} \mathcal{R}$-cavities or both lower $\mathcal{P} \mathcal{R}$ cavities.
Proposition 9. Let $U$ be a $\mathcal{S I}$-map on $\overline{\mathcal{D}}$ and $\mathcal{T}$ be a $\mathcal{P} \mathcal{R}$ cavity of $U$ different from $\overline{\mathcal{D}}$. Let $h$ be an element of $\partial \mathcal{T}$ and
 containing $h$. Then,

$$
\left(\mathcal{T}, \boldsymbol{p a r e n t}_{\mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}(\mathcal{T}), \ldots, \boldsymbol{p a r e n t}_{\mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}^{k-1}(\mathcal{T})\right)
$$

have the same nature (the proper levels are monotonic relatively to $k$ ). The direct consequence is that $U(h)$ contains:

\left[\mathscr{L}_{*, \mathfrak{P R}-\mathfrak{C a v}}\left(\boldsymbol{p a r e n t}_{\mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}^{k}(\mathcal{T})\right), \mathscr{L}_{*, \mathfrak{P R}-\mathfrak{c a v}}(\mathcal{T})\right]
$$

in the upper case, and contains:

$$
\left[\mathscr{L}_{*, \mathfrak{P R}-\mathfrak{C a v}}(\mathcal{T}), \mathscr{L}_{*, \mathfrak{P} \mathfrak{P}-\mathfrak{C a v}}\left(\boldsymbol{p a r e n t}_{\mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}^{k}(\mathcal{T})\right)\right]
$$

in the lower case.
Proof: Let $\mathcal{T}$ be some $\mathcal{P} \mathcal{R}$-cavity different from $\overline{\mathcal{D}}$, and let $h$ be one face of $\partial \mathcal{T}$. We assume without constraint that the first parent of $\mathcal{T}$ containing $h$, denoted by $\operatorname{parent}_{\mathfrak{P} \mathfrak{R}-\mathcal{C a v}}^{k}(\mathcal{T})$, is $\overline{\mathcal{D}}$. Let us treat the case where $\mathcal{T}$ has a positive polarity (its proper level is greater than the one of its parent). We want to prove that the sequence $\left(\mathscr{L}_{*, \mathfrak{P R}-\mathfrak{C a v}}\left(\text { parent }_{\mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}^{l}(\mathcal{T})\right)\right)_{l \in[1, k-1]}$ is strictly decreasing.

For this aim, let us assume that:

$$
\min _{l \in[1, k-1]} \mathscr{L}_{*, \mathfrak{P R}-\mathfrak{C a v}}\left(\text { parent }_{\mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}^{l}(\mathcal{T})\right) \leq \mathscr{L}_{\infty}
$$

then we can observe easily that the level line corresponding to $\mathscr{L}_{\infty}$ will separate $\mathcal{T}$ and one of its parents, that is, they will be in separate branches in the hierarchy $\mathfrak{P R}-\mathfrak{C a v}$, which is impossible by hypothesis.


Now, we want to prove that the sequence $\left(\mathscr{L}_{*, \mathfrak{P R}-\mathfrak{C a v}}\left(\text { parent }_{\mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}^{l}(\mathcal{T})\right)\right)_{l \in[1, k-1]} \quad$ is strictly decreasing. For this aim, we assume that it is not true and thus we choose the parent parent $\mathfrak{P}_{\mathfrak{R}-\mathfrak{C a v}}^{l}(\mathcal{T})$ of $\mathcal{T}$ in this sequence whose polarity is negative and whose level $\mathscr{L}_{*, \mathfrak{P} \Re-\mathfrak{C a v}}$ is minimal. We have then:
$\mathscr{L}_{*, \mathfrak{P} \Re-\mathfrak{C a v}}\left(\operatorname{parent}_{\mathfrak{P R}-\mathfrak{C a v}}^{l-1}(\mathcal{T})\right)>\mathscr{L}_{*, \mathfrak{P} \mathfrak{- c a v}}\left(\operatorname{parent}_{\mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}^{l}(\mathcal{T})\right)$.
It is clear that during the propagation, when the current level increases to cover $\mathcal{T}$, it will reach the level line corresponding to $\mathscr{L}_{*, \mathfrak{P R - C} \mathfrak{C a v}}\left(\right.$ parent $\left._{\mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}^{l}(\mathcal{T})\right)$ before reaching $\mathscr{L}_{*, \mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}\left(\right.$ parent $\left._{\mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}^{l-1}(\mathcal{T})\right)$ and then we will not obtain
 which is a contradiction. The proof is done.
Proposition 10. Let $\mathcal{T}_{i}^{j}$ be a $\mathcal{P} \mathcal{R}$-cavity of $U$ with $i \geq 0$ and $j \in \mathcal{J}(i)$. We call $\mathscr{L}_{\text {par }}=\mathscr{L}_{*, \mathfrak{P R}-\mathfrak{C a v}}\left(\right.$ parent $\left._{\mathfrak{P R}-\mathfrak{C a v}}\left(\mathcal{T}_{i}^{j}\right)\right)$ the level of its parent as a $\mathcal{P} \mathcal{R}$-cavity of $U$. Then, either $\mathscr{L}_{i}^{j}>$ $\mathscr{L}_{\text {par }}$, and we obtain that:

\forall x \in \partial_{\mathrm{int}}\left(\mathcal{T}_{i}^{j}\right), U(x) \triangleright \mathscr{L}_{\text {par }}

or $\mathscr{L}_{i}^{j}<\mathscr{L}_{\text {par }}$, and we obtain that:

In both cases, we have:

Proof: Let us proceed by induction on the step $i$.
Initialization $(i=0)$ : Let $j$ be some fixed value in $\mathcal{J}(0)$. Since $P_{0}$ is the connected component of $\left[U=\mathscr{L}_{\infty}\right]$ containing $p_{\infty}$, we have $\forall x \in \partial_{\mathrm{int}} \mathcal{T}_{0}^{j}, \mathscr{L}_{\infty} \notin U(x)$ since by construction, we have:

Now, let us assume that we arbitrarily choose $x$ and $y$ in $\partial_{\mathrm{int}} \mathcal{T}_{0}^{j}$. Two cases are possible then: either $x$ and $y$ are adjacent, then $U(x) \subseteq U(y)$ or $U(y) \subseteq U(x)$, which means that they are of the same type relatively to $\mathscr{L}_{\infty}$ (both greater or both lower); or they are not adjacent, and we assume that $x$ and $y$ satisfy $U(x) \triangleright \mathscr{L}_{\infty}$ and $U(y) \triangleleft \mathscr{L}_{\infty}$. Thus, by Property 5 , there exists some path $\Pi$ of length $m$ in $\partial_{\text {int }} \mathcal{T}_{0}^{j}$ joining $x$ and $y$. Since $x=\Pi(0)$ and $y=\Pi(m)$ are assumed not to be of the same type, there exists $o^{*} \in[0, m-1]$ satisfying that $\Pi\left(o^{*}\right)$ and $\Pi\left(o^{*}+1\right)$ are not of the same type, which is impossible as just seen before (either $U\left(\Pi\left(o^{*}\right)\right) \subset U\left(\Pi\left(o^{*}+1\right)\right)$ or $\left.U\left(\Pi\left(o^{*}+1\right)\right) \subset U\left(\Pi\left(o^{*}\right)\right)\right)$. Then, all the elements of $\partial_{\text {int }} \mathcal{T}_{0}^{j}$ are of the same type. Furthermore, since $\partial \mathcal{T}_{0}^{j} \subseteq P_{0}$, we have that $\forall x \in \partial \mathcal{T}_{0}^{j}, \mathscr{L}_{\text {par }} \in U(x)$.

Heredity $(i \geq 1):$ we assume that at step $k \in[0, i-1]$, we have that for $j \in \mathcal{J}(k)$, for any $x \in \partial_{\text {int }} \mathcal{T}_{j}^{k}, U(x) \triangleright$ $\mathscr{L}_{*, \mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}\left(\right.$ parent $\left._{\mathfrak{P R}-\mathcal{C a v}}\left(\mathcal{T}_{j}^{k}\right)\right)$ (resp. for any $x \in \partial_{\mathrm{int}} \mathcal{T}_{j}^{k}$, $U(x) \triangleleft \mathscr{L}_{*, \mathfrak{P} \Re-\mathfrak{C a v}}\left(\right.$ parent $\left._{\mathfrak{P R} \text { - } \mathfrak{C a v}}\left(\mathcal{T}_{j}^{k}\right)\right)$ ). Furthermore, for any $x \in \partial \mathcal{T}_{j}^{k}, U(x) \ni \mathscr{L}_{*, \mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}\left(\right.$ parent $\left._{\mathfrak{P R}-\mathfrak{C a v}}\left(\mathcal{T}_{j}^{k}\right)\right)$. We want to prove this property for $i$.

Let $\mathcal{T}_{i}^{j}$ be a $\mathcal{P} \mathcal{R}$-cavity at step $i>0$, we can assume that it has a parent $\mathcal{P} \mathcal{R}$-cavity $\mathcal{T}_{i^{*}}^{j^{*}}$ with $i^{*}<i$ and $j^{*} \in \mathcal{J}\left(i^{*}\right)$, where we have propagated the front using the level

After this, we can deduce that the interior boundary of the $\mathcal{P} \mathcal{R}$-cavity $\mathcal{T}_{i}^{j}$ satisfies:

that is, either $U(p)$ is greater than $\mathscr{L}_{\text {par }}$ or it is lower than $\mathscr{L}_{\text {par }}$. Two cases are then possible:

- When $\mathcal{T}_{i}^{j}$ satisfies:

then we assume without constraint that $\mathcal{T}_{i^{*}}^{j^{*}}$ is an upper $\mathcal{P} \mathcal{R}$-cavity (the proof of the decreasing case is symmetrical). Thus two cases can occur:

- for the elements $p$ of $\partial_{\mathrm{int}} \mathcal{T}_{i}^{j} \cap \partial_{\mathrm{int}} \mathcal{T}_{i^{*}}^{j^{*}}$, we did not have any propagation over $p$, which means that $U(p) \triangleright \mathscr{L}_{\text {par }}$.
- when $p$ belongs to $\partial_{\mathrm{int}} \mathcal{T}_{i}^{j} \backslash \partial_{\mathrm{int}} \mathcal{T}_{i^{*}}^{j^{*}}$, propagation at the level $\mathscr{L}_{\text {par }}$ occurred until $p$ (excluded), which means that $U(p)$ is of type $\triangleleft \mathscr{L}_{\text {par }}$ or $\triangleright \mathscr{L}_{\text {par }}$. Now, let $p^{*}$ be one element of $\partial_{\mathrm{int}} \mathcal{T}_{i}^{j} \cap \partial_{\mathrm{int}} \mathcal{T}_{i^{*}}^{j^{*}}$, with $U\left(p^{*}\right) \triangleright \mathscr{L}_{\text {par }}$. By connectivity of $\partial_{\text {int }} \mathcal{T}_{i}^{j}$, we know that there exists a path joining $p$ and $p^{*}$, then by following the reasoning seen in the initialization, $U(p)$ is of type $\triangleright \mathscr{L}_{\text {par }}$.
Concerning the proof that $\forall x \in \partial \mathcal{T}_{i}^{j}, \mathscr{L}_{\text {par }} \in U(x)$, either we are in the case:

and for any $h \in \operatorname{cl}_{\overline{\mathcal{D}}}\left(\mathcal{T}_{i}^{j}\right) \backslash \mathcal{T}_{i^{*}}^{j^{*}}$, we look for the nearest parent $\mathcal{T}_{i^{* *}}^{j^{* *}}$ of $\mathcal{T}_{i}^{j}$ which contains $h$, and then by Proposition 9 we obtain that $U(h) \supseteq\left[\mathscr{L}_{*, \mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}\left(\mathcal{T}_{i^{* *}}^{j^{* *}}\right), \mathscr{L}_{\left.\left.*, \mathfrak{F} \mathfrak{R}-\mathfrak{C a v}\left(\mathcal{T}_{i}^{j}\right)\right)\right]}\right.$ with:
$\left.\mathscr{L}_{*, \mathfrak{P} \Re-\mathfrak{C a v}}\left(\mathcal{T}_{i^{* *}}^{j^{* *}}\right)<\mathscr{L}_{\text {par }}=\mathscr{L}_{*, \mathfrak{P R - C \mathfrak { C a v }}}\left(\mathcal{T}_{i^{*}}^{j^{*}}\right)<\mathscr{L}_{*, \mathfrak{P} \Re-\mathfrak{C a v}}\left(\mathcal{T}_{i}^{j}\right)\right)$, and thus $\mathscr{L}_{\text {par }} \in U(h)$.

Remark 2. Let $\mathcal{T}$ be some $\mathcal{P} \mathcal{R}$-cavity of a $\mathcal{S I}$-map $U$ not equal to $\mathcal{D}$. When this is an upper $\mathcal{P} \mathcal{R}$-cavity:

$$
\begin{aligned}
\mathscr{L}_{*, \mathfrak{P R}-\mathfrak{C a v}}(\mathcal{T}) & =\sup \left\{\lambda \in \mathbb{R} ; \forall x \in \partial_{\mathrm{int}}(\mathcal{T}), U(x) \triangleright \lambda\right\} \\
& =\min \left\{\lfloor U(x)\rfloor ; \forall x \in \partial_{\mathrm{int}}(\mathcal{T})\right\},
\end{aligned}
$$

and when this is a lower $\mathcal{P} \mathcal{R}$-cavity:

$$
\begin{aligned}
\mathscr{L}_{*, \mathfrak{P R} \mathfrak{R} \mathfrak{C a v}}(\mathcal{T}) & =\inf \left\{\lambda \in \mathbb{R} ; \forall x \in \partial_{\mathrm{int}}(\mathcal{T}), U(x) \triangleleft \lambda\right\} \\
& =\max \left\{\lceil U(x)\rceil ; \forall x \in \partial_{\mathrm{int}}(\mathcal{T})\right\} .
\end{aligned}
$$

Property 6. Let $N$ be the (finite) number of iterations of the FPA. Then, for any value $i \in[0, N-1]$, the set $P_{i}$ is connected and $p_{\infty} \in P_{i}$.

Proof: Let us proceed by induction on $i \geq 0$ :

- Initialization: $P_{1}$ is connected by hypothesis, and $p_{\infty}$ belongs to $P_{1}$.
- Heredity: Let us assume that $P_{i}$ is connected and that $p_{\infty}$ belongs to $P_{i}$ for some value $i \geq 1$. Then, $P_{i+1}$ is the union of $P_{i}$, which is connected, and a set of connected components adjacent to $P_{i}$. Thus, $P_{i+1}$ is connected and $p_{\infty}$ belongs to it.
By applying the induction, we obtain that the property is true for all the possible values of $i$ since $N$ is finite.
Property 7. The $\mathcal{P} \mathcal{R}$-cavities of a $\mathcal{S I}$-map $U$ do not have any cavities.

Proof: For sake of simplicity, let us denote by $\mathcal{T}_{i}$ the set $\cup_{j \in \mathcal{J}(i)} \mathcal{T}_{i}{ }^{j}$.

Let $\left\{H_{l}\right\}_{l \in[1, L]}$ the set of (non-empty) cavities of $\mathcal{T}_{i}$. Now let us choose any fixed $k \in[1, L]$ and its corresponding $H_{k}$, cavity of some $\mathcal{T}_{i}^{j}$. By definition, $H_{k} \subset \operatorname{Sat}\left(\mathcal{T}_{i}\right)$. Then, $s t_{\overline{\mathcal{D}}}\left(H_{k}\right) \subseteq s t_{\overline{\mathcal{D}}}\left(\operatorname{Sat}\left(\mathcal{T}_{i}\right)\right)=\operatorname{Sat}\left(\mathcal{T}_{i}\right)$ by Property 4 Then $s t_{\overline{\mathcal{D}}}\left(H_{k}\right) \subseteq \operatorname{Sat}\left(\mathcal{T}_{i}\right)$. The consequence is that:

$$
s t_{\overline{\mathcal{D}}}\left(H_{k}\right) \backslash \cup_{k \in[1, L]} H_{k} \subseteq \operatorname{Sat}\left(\mathcal{T}_{i}\right) \backslash \cup_{k \in[1, L]} H_{k} \subseteq \mathcal{T}_{i}
$$

At the same time, $H_{k} \subseteq \overline{\mathcal{D}} \backslash \mathcal{T}_{i} \subseteq P_{i}$. Since $P_{i}$ is connected by Property 6, there exists some path $\Pi=\left(h, \ldots, p_{\infty}\right)$ of length $m$ in $P_{i}$ joining $h \in H_{k}$ to $p_{\infty} \in P_{i} \backslash H_{k}$.

Now, let $o^{*}$ be the value $\max _{o \in[1, m]}\{o \in[1, m] \mid \Pi(o) \in$ $\left.H_{k}\right\}$. Then, since $H_{k}$ is a closed set, we know that $\Pi\left(o^{*}+1\right)$ belongs to $s t_{\overline{\mathcal{D}}}\left(H_{k}\right) \backslash H_{k} \subseteq \mathcal{T}_{i} \subseteq \overline{\mathcal{D}} \backslash P_{i}$, then $\Pi\left(o^{*}+1\right)$ belongs (also) to $P_{i}$. We have a contradiction. The set $\cup_{l \in[1, L]} H_{l}$ is then empty.

The following notation is depicted in Figure 18.
Notation 5. Let $\mathcal{T}$ be a $\mathcal{P} \mathcal{R}$-cavity of $U$, then we define:
$(\mathcal{T})_{*, \mathfrak{P R}-\mathfrak{C a v}}=\left(\bigcup_{x \in \partial_{\mathrm{int}} \mathcal{T}} \mathcal{C C}\left(\left[U=\mathscr{L}_{*, \mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}(\mathcal{T})\right], x\right)\right) \cap \mathcal{T}$.

We recall that $\downarrow$ denotes the disjoint union operator. The following property can be observed in Figure 18
Property 8. Let $\mathcal{T}$ be a $\mathcal{P} \mathcal{R}$-cavity of $U$. We have the following equality:

$$
\mathcal{T}=(\mathcal{T})_{*, \mathfrak{P R}-\mathfrak{C a v}} \bigsqcup\left(\bigcup_{\mathcal{T}^{\prime} \in \text { children }_{\mathfrak{P} \mathfrak{R}-\mathfrak{C} \mathfrak{a v}}(\mathcal{T})} \mathcal{T}^{\prime}\right)
$$

or in other words:

$$
(\mathcal{T})_{*, \mathfrak{P R} \mathfrak{C a v}}=\mathcal{T} \backslash\left(\bigcup_{\mathcal{T}^{\prime} \in \text { children }_{\mathfrak{P} \mathfrak{R}-\mathfrak{C} \mathfrak{a v}}(\mathcal{T})} \mathcal{T}^{\prime}\right)
$$

Proof: Let $h$ be an element of some $\mathcal{P} \mathcal{R}$-cavity $\mathcal{T}$ of $U$. Two cases are possible. The first case corresponds to when $h$ belongs to some child $\mathcal{T}^{\prime}$ of $\mathcal{T}$ and then any path starting from $h$ reaching $x \in \partial_{\text {int }}(\mathcal{T}) \cap\left[U=\mathscr{L}_{*, \mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}(\mathcal{T})\right]$ crosses the internal boundary of the direct child $\mathcal{T}^{\prime \prime}$ of $\mathcal{T}$ containing $\mathcal{T}^{\prime}$ on which $U$ is lower or greater than $\mathscr{L}_{*, \mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}(\mathcal{T})$ (see Proposition 10). The case corresponds to when there exists a path in $\left[U=\mathscr{L}_{*, \mathfrak{P} \Re-\mathcal{C a v}}(\mathcal{T})\right] \cap \mathcal{T}$ joining $h$ and $x \in \partial_{\text {int }}(\mathcal{T}) \cap$ $\left[U=\mathscr{L}_{*, \mathfrak{P R}-\mathfrak{C a v}}(\mathcal{T})\right]$. Using Proposition 8 , we conclude the proof.

## E. Mathematical properties of shapes

Definition 4. From now on, for any subset $E$ of $\overline{\mathcal{D}}$, we will denote by $\operatorname{Int}(E)$ the topological interior of $E$, that is, the greatest open set contained in $E$.

1) Properties of shapes of a WC SI-map:

Proposition 11 (Shapes are open). Let $\mathcal{S}$ be some shape of $U$. Then, $\mathcal{S}$ is an open set.

Proof: An upper threshold set is the core [18], [8] image by the interval-valued map of an open interval $] a,+\infty[$, which is then open by upper semicontinuity of the span-based immersion $U$. Thus, its connected components are open. It follows that the saturations of these components, the shapes of $U$, are open by Proposition 2. The same reasoning can be applied to lower shapes.

Proposition 12. Let $\overline{\mathcal{D}}$ be a $n$ - $D$ hyper-rectangle in the $n-D$ Khalimsky grid, and let $p_{\infty}$ be a $n$-face of $\overline{\mathcal{D}}$ which belongs to $\partial \overline{\mathcal{D}}$. When a digital set $\mathcal{S} \subset \overline{\mathcal{D}}$ is an open shape of a WC $\mathcal{S I}$-map, then we have the following property:

$$
\operatorname{Int}(\operatorname{Sat}(\partial \mathcal{S}))=\mathcal{S}
$$

Proof: When we are in the case $\mathcal{S}=\overline{\mathcal{D}}$, we obtain easily:

$$
\operatorname{Sat}(\mathcal{S})=\overline{\mathcal{D}} \backslash \mathcal{C C}\left(\overline{\mathcal{D}} \backslash \partial \overline{\mathcal{D}}, p_{\infty}\right)=\overline{\mathcal{D}}
$$

When $\mathcal{S} \subsetneq \overline{\mathcal{D}}$, we can use Proposition 4 and we obtain:
$\operatorname{Sat}\left(c l_{\overline{\mathcal{D}}}(\mathcal{S})\right)=\operatorname{Sat}\left(\partial c l_{\overline{\mathcal{D}}}(\mathcal{S})\right)=\operatorname{Sat}\left(c l_{\overline{\mathcal{D}}}\left(c l_{\overline{\mathcal{D}}}(\mathcal{S})\right) \backslash \operatorname{Int}\left(c l_{\overline{\mathcal{D}}}(\mathcal{S})\right)\right)$.
Thanks to the idempotency of the closure operator and to Proposition 6 (regularity of the open shape $\mathcal{S}$ ):

$$
\operatorname{Sat}\left(c l_{\overline{\mathcal{D}}}(\mathcal{S})\right)=\operatorname{Sat}\left(c l_{\overline{\mathcal{D}}}(\mathcal{S}) \backslash \mathcal{S}\right)=\operatorname{Sat}(\partial \mathcal{S})
$$

Thanks to Remark 1, $\mathcal{S}$ is WC, and then by Proposition 5 ,

$$
\operatorname{Sat}(\partial \mathcal{S})=\operatorname{Sat}\left(c l_{\overline{\mathcal{D}}}(\mathcal{S})\right)=c l_{\overline{\mathcal{D}}}(\operatorname{Sat}(\mathcal{S}))=c l_{\overline{\mathcal{D}}}(\mathcal{S})
$$

This way,

$$
\operatorname{Int}(\operatorname{Sat}(\partial \mathcal{S}))=\operatorname{Int}\left(c l_{\overline{\mathcal{D}}}(\mathcal{S})\right)=\mathcal{S}
$$

by regularity of $\mathcal{S}$.

Let us now assume that the studied function $U$ is WC.
Notation 6. Let $\mathcal{S}$ be a shape of a $W C \mathcal{S I}$-map $U$. We define the following set:

$$
\boldsymbol{\operatorname { e x x t }}_{\mathfrak{S}}(\mathcal{S})=\left\{\mathcal{S}^{\prime} \in \mathfrak{S}(U) ; \mathcal{S}=\boldsymbol{p a r e n t}_{\mathfrak{S}}\left(\mathcal{S}^{\prime}\right)\right\}
$$

Notation 7. Let $\mathcal{S}$ be a shape of a $W C \mathcal{S I}$-map $U$. We denote


We obtain then easily the following proposition.
Proposition 13. Let $U$ be a $W C \mathcal{S I}$-map on $\overline{\mathcal{D}}$. For any shape $\mathcal{S}$ of $U$, we have the following equality:

$$
\bigcup_{\mathcal{S}^{\prime} \in \operatorname{next}_{\mathfrak{S}}(\mathcal{S})} \mathcal{S}^{\prime}=\bigcup_{\mathcal{S}^{\prime} \in \text { children }_{\mathfrak{S}}(\mathcal{S})} \mathcal{S}^{\prime}
$$

Definition 5 (Levels of shapes). We define:

$$
\mathscr{L}_{*, \mathfrak{S}}(\overline{\mathcal{D}})=\mathscr{L}_{\infty} .
$$

For any shape $\mathcal{S}$ of $U$ different from $\overline{\mathcal{D}}$, we define when this shape is an upper shape:

$$
\begin{aligned}
\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S}) & =\sup \left\{\lambda \in \mathbb{R} ; \forall x \in \partial_{\mathrm{int}}(\mathcal{S}), U(x) \triangleright \lambda\right\} \\
& =\min \left\{\lfloor U(x)\rfloor ; x \in \partial_{\mathrm{int}}(\mathcal{S})\right\},
\end{aligned}
$$

and when this shape is a lower shape, then:

$$
\begin{aligned}
\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S}) & =\inf \left\{\lambda \in \mathbb{R} ; \forall x \in \partial_{\text {int }}(\mathcal{S}), U(x) \triangleleft \lambda\right\} \\
& =\max \left\{\lceil U(x)\rceil ; x \in \partial_{\mathrm{int}}(\mathcal{S})\right\} .
\end{aligned}
$$

This definition is depicted in Figure 19
Notation 8. Let $U$ be some $W C \mathcal{S I}$-map and $\mathfrak{S}$ its tree of shapes. Then for any shape $\mathcal{S}$ of $U$ different from the root $\overline{\mathcal{D}}$ of $\mathfrak{S}$, we denote by parent ${ }_{\mathfrak{S}}(\mathcal{S})$ the direct parent of $\mathcal{S}$ in $\mathfrak{S}$.

Proposition 14. Let $\mathcal{S}$ be some shape of some WC SI-map $U$ with $\mathcal{S} \neq \overline{\mathcal{D}}$, then when $\mathcal{S}$ is an upper shape, it satisfies that $\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})>\mathscr{L}_{*, \mathfrak{S}}\left(\right.$ parent $\left._{\mathfrak{S}}(\mathcal{S})\right)$. Conversely, when $\mathcal{S}$ is a lower shape, it satisfies that $\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})<\mathscr{L}_{*, \mathfrak{S}}\left(\right.$ parent $\left._{\mathfrak{S}}(\mathcal{S})\right)$.

Proof: Let us treat the upper case only, the other case being symmetrical. Let us assume that $\mathcal{S}$ is an upper shape different from $\overline{\mathcal{D}}$, then there exists some connected component $\Gamma \in \mathcal{C C}\left(\left[U \triangleright \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})-\varepsilon\right]\right)$ with $\varepsilon \rightarrow 0^{+}$ such that $\operatorname{Sat}(\Gamma)=\mathcal{S}$. However, if we assume now that $\mathscr{L}_{*, \mathfrak{S}}\left(\operatorname{parent}_{\mathfrak{S}}(\mathcal{S})\right)>\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$, then there exists some face $x \in \operatorname{parent}_{\mathfrak{S}}(\mathcal{S})$ which is neighbor of $\Gamma$ and which satisfies $U(x) \triangleright \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$. By construction of $\Gamma$, it contains $x$, and then we obtain that $\operatorname{Sat}(\Gamma) \supsetneq \mathcal{S}$, which is a contradiction. However, the case $\mathscr{L}_{*, \mathfrak{S}}\left(\right.$ parent $\left._{\mathfrak{S}}(\mathcal{S})\right)=\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$ is impossible, then $\mathscr{L}_{*, \mathfrak{S}}\left(\operatorname{parent}_{\mathfrak{S}}(\mathcal{S})\right)<\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$.

Proposition 15. Let $\mathcal{S}, \mathcal{S}^{\prime}$ be two shapes different from $\overline{\mathcal{D}}$ of a $W C \mathcal{S I}$-map $U$ with $\mathcal{S}^{\prime}=$ parent $_{\mathfrak{S}}(\mathcal{S})$ and with $l_{X}(\mathcal{S}) \nsubseteq \mathcal{S}^{\prime}$. Then, $\mathcal{S}$ and $\mathcal{S}^{\prime}$ are both upper shapes or both lower shapes.

Proof: Let us treat the case where $\mathcal{S}$ is an upper shape (he lower case follows a same reasoning). We assume that $\mathcal{S}^{\prime}$ is a lower shape, then for any $x \in \partial_{\mathrm{int}} \mathcal{S}^{\prime}$, we have $U(x) \triangleleft$ $\mathscr{L}_{*, \mathfrak{S}}\left(\mathcal{S}^{\prime}\right)+\varepsilon$ with $\varepsilon \rightarrow 0^{-}$. Since $c l_{X}(\mathcal{S}) \nsubseteq \mathcal{S}^{\prime}$, then there exists a face $h$ in $c l_{X}(\mathcal{S})$ which does not belong to $\mathcal{S}^{\prime}$, then there exists $x$ in the closure of $h$ which belongs to:

$$
\partial_{\mathrm{int}} \mathcal{S} \cap \partial_{\mathrm{int}} \mathcal{S}^{\prime}
$$

which leads at the same time to $U(x) \triangleright \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})-\varepsilon$ with $\varepsilon \rightarrow 0^{+}$and to $U(x) \triangleleft \mathscr{L}_{*, \mathfrak{S}}\left(\mathcal{S}^{\prime}\right)+\varepsilon^{\prime}$ with $\varepsilon^{\prime} \rightarrow 0^{-}$. Then, we obtain:

$$
\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})-\varepsilon \triangleleft U(x) \triangleleft \mathscr{L}_{*, \mathfrak{S}}\left(\mathcal{S}^{\prime}\right)+\varepsilon^{\prime}
$$

which means that $\mathscr{L}_{*, \mathfrak{S}}\left(\mathcal{S}^{\prime}\right)>\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$, then by Proposition 14, $\mathcal{S}$ is a lower shape. We obtain a contradiction. This concludes the proof.
Proposition 16. Let $\mathcal{S}$ be a shape of a WC SI-map $U$ different from $\overline{\mathcal{D}}$. When $\mathcal{S}$ is an upper shape:
$\forall \lambda \in\left[\mathscr{L}_{*, \mathfrak{S}}\left(\boldsymbol{p a r e n t}_{\mathfrak{S}}(\mathcal{S})\right), \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})\left[, \forall x \in \partial_{\mathrm{int}} \mathcal{S}, U(x) \triangleright \lambda\right.\right.$, and

$$
\forall \lambda \in\left[\mathscr{L}_{*, \mathfrak{S}}\left(\boldsymbol{p a r e n t}_{\mathfrak{S}}(\mathcal{S})\right), \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})\right], \forall x \in \partial \mathcal{S}, U(x) \ni \lambda
$$

and $\mathcal{S}$ is a lower shape:
$\left.\left.\forall \lambda \in] \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S}), \mathscr{L}_{*, \mathfrak{S}} \operatorname{parent}_{\mathfrak{S}}(\mathcal{S})\right)\right], \forall x \in \partial_{\mathrm{int}} \mathcal{S}, U(x) \triangleleft \lambda$, and
$\left.\forall \lambda \in\left[\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S}), \mathscr{L}_{*, \mathfrak{S}} \boldsymbol{p a r e n t}_{\mathfrak{S}}(\mathcal{S})\right)\right], \forall x \in \partial_{\mathrm{int}} \mathcal{S}, U(x) \ni \lambda$.
Proof: Let us treat the upper case only (the other case can be deduced by symmetry). By Proposition 14 , we know that:

$$
\mathscr{L}_{*, \mathfrak{S}}\left(\operatorname{parent}_{\mathfrak{S}}(\mathcal{S})\right)<\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})
$$

Now, let us prove that for any $x \in \partial_{\text {int }} \mathcal{S}$, we have that $U(x) \triangleright \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})-\varepsilon$ with $\varepsilon \rightarrow 0^{+}$. For this aim, we assume that there exists at least one face $h \in \partial_{\text {int }}(\mathcal{S})$ such that $U(h) \ngtr \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})-\varepsilon$. Since $\mathcal{S}$ is an upper shape, there exists a connected component $\Gamma$ of $\left[U \triangleright \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})-\varepsilon\right]$ such that $\operatorname{Sat}(\Gamma)=\mathcal{S}$. However, $h$ does not belong to $\Gamma$. Then, $h$ belongs to $\overline{\mathcal{D}} \backslash \Gamma$. Also, $h \in \partial_{\text {int }}(\mathcal{S})$, then there exists some path $\Pi$ joining $p_{\infty}$ to $h$ in $\overline{\mathcal{D}} \backslash \mathcal{S}$ (since $\overline{\mathcal{D}} \backslash \mathcal{S}$ is connected).

Then, $h$ belongs to $\mathcal{C C}\left(\overline{\mathcal{D}} \backslash \Gamma, p_{\infty}\right)$, and then $h \notin \operatorname{Sat}(\Gamma)$, that is, $\partial_{\text {int }}(\mathcal{S}) \nsubseteq \mathcal{S}$, which is a contradiction. Then all the faces $x$ of $\partial_{\text {int }}$ satisfy the property that $U(x)$ is greater than $\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$. Concerning the property that for any $x \in \partial \mathcal{S}, U(x)$ contains $\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$, it is simply due to the properties of the span-based immersion:

- when $c l_{X}(\mathcal{S}) \subseteq \operatorname{parent}_{\mathfrak{S}}(\mathcal{S})$, each face $x$ of $\partial \mathcal{S}$ is neighbor of a $n$-face $h_{i n}$ of $\partial_{\text {int }} \mathcal{S}$ whose value is $U\left(h_{\text {in }}\right)=v$ with $v \geq \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$ and of an $n$-face $h_{\text {out }}$ in $\left(\operatorname{parent}_{\mathfrak{S}}(\mathcal{S})\right)_{*, \mathfrak{S}}$ with $U\left(h_{\text {out }}\right)=\mathscr{L}_{*, \mathfrak{S}}\left(\operatorname{parent}_{\mathfrak{S}}(\mathcal{S})\right)$, then it contains

$$
\left[\mathscr{L}_{*, \mathfrak{S}}\left(\operatorname{parent}_{\mathfrak{S}}(\mathcal{S})\right), v\right]
$$

and then $\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$,

- when $c l_{X}(\mathcal{S}) \nsubseteq \operatorname{parent}_{\mathfrak{S}}(\mathcal{S})$, we have two possible cases. Either we have $x \in \partial \mathcal{S}$ which belong to parent $_{\mathfrak{S}}(\mathcal{S})$ and we can reason as in the previous case, or $x \in \partial \mathcal{S}$ does not belong to the (direct) parent parent $_{\mathfrak{S}}(\mathcal{S})$. In this last case, we look for the nearest parent $\mathcal{S}^{\prime}$ in $\mathfrak{S}(U)$ which contains $x$. Since it will be an upper shape by Proposition 15, we will have that $\mathscr{L}_{*, \mathfrak{S}}\left(\mathcal{S}^{\prime}\right)$ is lower than $\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$. Now, let us define $v$ as the supremum of (the lower bounds of) $U$ on the $n$-faces of $c l_{X}(x)$; we will obtain $v \geq \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$. We will obtain that $U(x)$ contains:

$$
\left[\mathscr{L}_{*, \mathfrak{S}}\left(\mathcal{S}^{\prime}\right), v\right]
$$

and then $\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$.
This concludes the proof.
Notation 9. Let $\mathcal{S}$ be a shape of $U$. We will define:

$$
(\mathcal{S})_{*, \mathfrak{S}}=\mathcal{S} \backslash\left(\bigcup_{\mathcal{S}^{\prime} \in \text { children }_{\mathfrak{E}}(\mathcal{S})} \mathcal{S}^{\prime}\right)
$$

This notation is depicted in Figure 19.
Remark 3. Let $\mathcal{S}$ be a shape of $U$. Then, any $n$-face $h$ of $(\mathcal{S})_{*, \mathfrak{S}}$ satisfies:

$$
U(h)=\left\{\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})\right\}
$$

Proposition 17 (Separation property of shape boundaries). Let $\mathcal{S}$ be an (open) shape of a $\mathcal{S I}$-map $U$ defined on $\overline{\mathcal{D}}$. Let choose an operator in $\left\{\partial_{\mathrm{int}}, \partial\right\}$. We say that bd $(\mathcal{S})$ separates $\overline{\mathcal{D}}$ in the sense that when we call exterior component the set:

$$
\mathfrak{E}:=\mathcal{C C}\left(\overline{\mathcal{D}} \backslash b d(\mathcal{S}), p_{\infty}\right)
$$

and interior component the set:

$$
\mathfrak{I}=\operatorname{Int}(\operatorname{Sat}(b d(\mathcal{S}))),
$$

then we can assert that any path in $\overline{\mathcal{D}}$ going from the interior component to the exterior component (or the converse) will intersect $b d(\mathcal{S})$. Furthermore, we obtain the following partition of $\overline{\mathcal{D}}$ :

$$
\overline{\mathcal{D}}=\mathfrak{E} \sqcup b d(\mathcal{S}) \sqcup \mathfrak{I} .
$$

Proof: Let us begin with the case $b d=\partial$. Since $\mathcal{S}$ is open, we know by Proposition 12 that:

$$
\mathfrak{I}=\operatorname{Int}(\operatorname{Sat}(\partial \mathcal{S})))=\mathcal{S}
$$

and at the same time we obtain that the exterior component is equal to:

$$
\mathfrak{E}=\overline{\mathcal{D}} \backslash c l_{X}(\mathcal{S}),
$$

which is due to the fact that $\operatorname{Sat}(\partial \mathcal{S})=c l_{X}(\mathcal{S})$ (see the proof of Proposition 12). Then, every path $\Pi$ going from $\mathfrak{E}$ to $\mathcal{S}$ satisfies that it starts from $a \in \mathfrak{E}$ to $b \in \mathcal{S}$ in $\overline{\mathcal{D}}$. Let $\Pi\left(i^{*}\right)$ be the last element of $\Pi$ which is in $\mathfrak{E}$, then $\Pi\left(i^{*}+1\right)$ belongs to $\mathcal{S}$ or to $\partial \mathcal{S}$. Since $\mathfrak{E}$ is open, $\Pi\left(i^{*}+1\right)$ does not belong to $s t_{X}\left(\Pi\left(i^{*}\right)\right.$, otherwise it belongs to $\mathfrak{E}$. Then, $\Pi\left(i^{*}+1\right)$ belongs to $c l_{X}\left(\Pi\left(i^{*}\right)\right) \backslash \mathfrak{E}$, and then to

$$
c l_{X}(\mathfrak{E}) \backslash \mathfrak{E}=\partial \mathfrak{E}=\partial \mathcal{S}
$$

The same reasoning applies when we start from $b$ in $\mathcal{S}$ and then every path $\Pi$ from $\mathfrak{E}$ to $\mathfrak{I}$ intersects $\partial \mathcal{S}$.

Let us treat now the case $b d=\partial_{\text {int }}$. We recall by Proposition 7 that:

$$
\partial_{\mathrm{int}} \mathcal{S}=s t_{X}\left(\mathbb{H}^{n} \backslash \mathcal{S}\right) \cap s t_{X}(\mathcal{S})
$$

or after simplification:

$$
\partial_{\mathrm{int}} \mathcal{S}=s t_{X}(\overline{\mathcal{D}} \backslash \mathcal{S}) \cap \mathcal{S}
$$

Now, let $\Pi$ be a path in $\overline{\mathcal{D}}$ starting from a belonging to:

$$
\mathfrak{E}=\overline{\mathcal{D}} \backslash \mathcal{S}
$$

and going to $b$ belonging to:

$$
\mathfrak{I}=\mathcal{S} \backslash \partial_{\mathrm{int}} \mathcal{S}
$$

Then, there exists $i^{*}$ such that $\Pi\left(i^{*}\right)$ is the last element of $\Pi$ which does not belong to $\mathcal{S}$. It satisfies $\Pi\left(i^{*}+1\right) \in$ $s t_{X}\left(\Pi\left(i^{*}\right)\right) \backslash\left\{\Pi\left(i^{*}\right)\right\}$, then $\Pi\left(i^{*}+1\right)$ belongs to $\mathcal{S}$ and to $s t_{X}(\overline{\mathcal{D}} \backslash \mathcal{S})$, then to $\partial_{\mathrm{int}} \mathcal{S}$. Conversely, if we start from $b$, we denote by $i^{*}$ the index of $\Pi$ such that $\Pi\left(i^{*}\right)$ is the last element in $\mathcal{S}$. Then, $\Pi\left(i^{*}+1\right)$ belongs to $\mathfrak{E}$, then $\Pi\left(i^{*}\right)$ belongs to $s t_{X}(\overline{\mathcal{D}} \backslash \mathcal{S}) \cap \mathcal{S}=\partial_{\mathrm{int}} \mathcal{S}$ and $\Pi$ intersects $\partial_{\mathrm{int}} \mathcal{S}$.

Proposition 18. Let $U$ be some $W C \mathcal{S I}$-map and $\mathcal{S}$ one of its shapes. We have the following property:

$$
\operatorname{Sat}\left(\partial_{\mathrm{int}}(\mathcal{S})\right)=\mathcal{S}
$$

Proof: This proof is depicted in Figure 20 Using the notations of the proof of Proposition 17. we obtain:

$$
\operatorname{Sat}\left(\partial_{\mathrm{int}}(\mathcal{S})\right)=\overline{\mathcal{D}} \backslash \mathcal{C C}\left(\overline{\mathcal{D}} \backslash \partial_{\mathrm{int}}(\mathcal{S}), p_{\infty}\right)
$$

and the two (separated) connected components of $\overline{\mathcal{D}} \backslash \partial_{\text {int }}(\mathcal{S})$ are $\mathfrak{E}$ and $\mathfrak{I}$. However, only $\mathfrak{E}$ contains $p_{\infty}$. Thus,

$$
\mathcal{C C}\left(\overline{\mathcal{D}} \backslash \partial_{\mathrm{int}}(\mathcal{S}), p_{\infty}\right)=\mathfrak{E}
$$

and $\operatorname{Sat}\left(\partial_{\text {int }}(\mathcal{S})\right)=\overline{\mathcal{D}} \backslash \mathfrak{E}=\mathfrak{I} \sqcup \partial_{\text {int }}(\mathcal{S})=\mathcal{S}$. This concludes the proof.

Proposition 19. Let $\mathcal{S}$ be some shape of $U$, then we have the remarkable properties (as depicted in Figure 19):

$$
(\overline{\mathcal{D}})_{*, \mathfrak{S}}=\bigcup_{x \in \triangle \overline{\mathcal{D}}} \mathcal{C C}\left(\left[U=\mathscr{L}_{\infty}\right], x\right)
$$

and when $\mathcal{S} \neq \overline{\mathcal{D}}$ :

$$
(\mathcal{S})_{*, \mathfrak{S}}=\left(\bigcup_{x \in \partial_{\mathrm{int}}(\mathcal{S})} \mathcal{C C}\left(\left[U=\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})\right], x\right)\right) \cap \mathcal{S}
$$

Proof: The case of $\overline{\mathcal{D}}$ is obvious. We can observe that this proposition results from the fact that when we have some face $h$ in some upper shape $\mathcal{S}$ of $U$ (then by Proposition 16 it is a shape of type $\triangleright$ ), four cases are possible:
(1) $\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S}) \in U(h)$ and there exists some path joining $h$ to some $x \in \partial_{\text {int }} \mathcal{S}$ in $\left[U=\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})\right]$. In this case, $h$ belongs to $(\mathcal{S})_{*, \mathfrak{S}}$.
(2) $\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S}) \in U(h)$ but there does not exist any path joining $h$ to some $x \in \partial_{\text {int }} \mathcal{S}$ in $\left[U=\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})\right]$, then there exists two shapes $\mathcal{S}^{\prime}, \mathcal{S}^{\prime \prime} \in \operatorname{children}_{\mathfrak{S}}(\mathcal{S})$ of $U$ such that $\mathscr{L}_{*, \mathfrak{S}}\left(\mathcal{S}^{\prime}\right) \neq \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S}), \mathscr{L}_{*, \mathfrak{S}}\left(\mathcal{S}^{\prime \prime}\right)=\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$, and $\mathcal{S}^{\prime \prime} \subset$ $\mathcal{S}^{\prime} \subset \mathcal{S}$. In this case, $h$ belongs to $\mathcal{S}^{\prime \prime}$ which belongs to the children of $\mathcal{S}$, and then $h \notin(\mathcal{S})_{*, \mathcal{S}}$.
(3) $U(h) \triangleleft \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$, then $\partial_{\text {int }} \mathcal{S}$ (where $U$ is $\triangleright \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})-\varepsilon$ with $\varepsilon \rightarrow 0^{+}$) separates $\overline{\mathcal{D}}$ by Proposition 17 so that we obtain:

$$
\mathcal{C C}\left(\left[U \triangleleft \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})\right], h\right) \subseteq \operatorname{Sat}\left(\partial_{\mathrm{int}} \mathcal{S}\right)
$$

then by Proposition 1 and Proposition 18 .

$$
\mathcal{S}^{\prime}=\operatorname{Sat}\left(\mathcal{C C}\left(\left[U \triangleleft \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})\right], h\right)\right) \subseteq \mathcal{S}
$$

Since $\mathcal{S}^{\prime}$ is a lower shape different from $\overline{\mathcal{D}}, \mathcal{S}^{\prime} \neq \mathcal{S}$, and then $\mathcal{S}^{\prime} \subsetneq \mathcal{S}$. Thus, $h$ belongs to $\mathcal{S}^{\prime}$ which belongs to the children of $\mathcal{S}$, and then $h \notin(\mathcal{S})_{*, \mathfrak{S}}$.
(4) $U(h) \triangleright \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$, then $\partial \mathcal{S}$ (where $U$ contains $\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})$ ) separates $\overline{\mathcal{D}}$ by Proposition 17 so that we obtain:

$$
\mathcal{C C}\left(\left[U \triangleright \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})\right], h\right) \subseteq \operatorname{Int}(\operatorname{Sat}(\partial \mathcal{S}))
$$

which means that $\mathcal{S}^{\prime}=\operatorname{Sat}\left(\mathcal{C C}\left(\left[U \triangleright \mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})\right], h\right)\right) \subseteq$ $\mathcal{S}$, and then there exists a child $\mathcal{S}^{\prime}$ of $\mathcal{S}$ satisfying $h \in \mathcal{S}^{\prime}$, and then $h \notin(\mathcal{S})_{*, \mathfrak{S}}$.

Finally, $h$ belongs to $(\mathcal{S})_{*, \mathfrak{S}}$ iff it belongs to

$$
\left(\bigcup_{x \in \partial_{\mathrm{int}}(\mathcal{S})} \mathcal{C C}\left(\left[U=\mathscr{L}_{*, \mathfrak{S}}(\mathcal{S})\right], x\right)\right) \cap \mathcal{S}
$$

which proves the assertion in the upper case. The same reasoning applies in the lower case. This concludes the proof.

## F. Properties of cavities that are shapes

Proposition 20. Let $U$ be a SI-map, and let $\mathscr{F}$ be a subset of $\overline{\mathcal{D}}$ which is at the same time a shape of $U$ and a $\mathcal{P} \mathcal{R}$-cavity of $U$. Then $\mathscr{L}_{*, \mathfrak{R} \mathfrak{R}-\mathfrak{C a v}}(\mathscr{F})=\mathscr{L}_{*, \mathfrak{S}}(\mathscr{F})$.

Proof: It is a direct consequence of Remark 2
Proposition 21. Let $U$ be a SI-map, and let $\mathscr{F}$ be a subset of $\overline{\mathcal{D}}$ which is at the same time a shape of $U$ and a $\mathcal{P} \mathcal{R}$-cavity of $U$. Then $(\mathscr{F})_{*, \mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}=(\mathscr{F})_{*, \mathfrak{G}}$.

Proof: Let $\mathscr{F}$ be a $\mathcal{P} \mathcal{R}$-cavity and a shape of $U$. Then, thanks to Proposition 20 and to Proposition 19 .

$$
\begin{aligned}
(\mathscr{F})_{*, \mathfrak{P R}-\mathfrak{C a v}} & =\left(\bigcup_{x \in \partial_{\mathrm{int}}(\mathscr{F})} \mathcal{C C}\left(\left[U=\mathscr{L}_{*, \mathfrak{P R}-\mathfrak{C a v}}(\mathscr{F})\right], x\right)\right) \cap \mathscr{F} \\
& =\left(\bigcup_{x \in \partial_{\mathrm{int}}(\mathscr{F})} \mathcal{C} C\left(\left[U=\mathscr{L}_{*, \mathfrak{S}}(\mathscr{F})\right], x\right)\right) \cap \mathscr{F} \\
& =(\mathscr{F})_{*, \mathfrak{S}}
\end{aligned}
$$

The proof is done.

## G. Our main theorem

Theorem 1. Let $U$ be a well-composed SI-map defined on a unicoherent domain $\overline{\mathcal{D}}$. The $\mathcal{P} \mathcal{R}$-cavity hierarchy computed by the FPA is equal to the tree of shapes of $U$. In other words, our FPA algorithm computes the tree of shapes of $U$.

Proof: Let $\mathscr{F}$ be a subset of $\overline{\mathcal{D}}$ which is at the same time a $\mathcal{P} \mathcal{R}$-cavity and a shape of $U$. Thanks to Proposition 21, we obtain that:

$$
(\mathscr{F})_{*, \mathfrak{P R}-\mathfrak{C a v}}=(\mathscr{F})_{*, \mathfrak{S}}
$$

which leads by Property 8 to:

$$
\mathscr{F} \backslash\left(\bigcup_{\mathcal{T} \in \text { children }_{\mathfrak{P} \mathfrak{R}-\mathbb{C} \mathfrak{a} \mathfrak{v}}(\mathscr{F})} \mathcal{T}\right)=(\mathscr{F})_{*, \mathfrak{S}}
$$

Using Notation 9 we obtain:

$$
\bigcup_{\mathcal{T} \in \text { children }_{\mathfrak{P} \mathfrak{R}-\mathfrak{C} \mathfrak{a v}}(\mathscr{F})} \mathcal{T}=\bigcup_{\mathcal{S} \in \text { children }_{\mathfrak{S}}(\mathscr{F})} \mathcal{S}
$$

which can be reformulated by Proposition 13 and Proposition 8

$$
\bigcup_{\mathcal{T} \in \mathbf{n e x t}_{\mathfrak{P} \mathfrak{R}-\mathbb{C} \mathfrak{a v}}(\mathscr{F})} \mathcal{T}=\bigcup_{\mathcal{S} \in \mathbf{n e x t}_{\mathscr{S}}(\mathscr{F})} \mathcal{S}
$$

Furthermore, the elements of $\boldsymbol{n e x t}_{\mathfrak{P} \mathfrak{R}-\mathfrak{C a v}}(\mathscr{F})$ are $\mathcal{P} \mathcal{R}$ cavities, then open by Property 4 , and connected by definition. The elements of $\operatorname{ext}_{\mathfrak{S}}(\mathscr{F})$ are shapes, then open by Proposition 11, and connected by Proposition 3.

The consequence is that:

$$
\begin{align*}
\mathbf{n e x t}_{\mathfrak{P R}-\mathfrak{C a v}}(\mathscr{F}) & =\mathcal{C C}\left(\bigcup_{\mathcal{T} \in \mathbf{n e x t}_{\mathfrak{P} \mathfrak{R}-\mathfrak{C} \mathfrak{a v}}(\mathscr{F})} \mathcal{T}\right)  \tag{2}\\
& =\mathcal{C C}\left(\bigcup_{\mathcal{S} \in \mathbf{n e x t}_{\mathscr{S}}(\mathscr{F})} \mathcal{S}\right)  \tag{3}\\
& =\operatorname{next}_{\mathfrak{S}(\mathscr{F})} \tag{4}
\end{align*}
$$

We obtain thus directly that:

$$
\mathfrak{P R}-\mathfrak{C a v}=\mathfrak{S}
$$

since their root is the same set $\overline{\mathcal{D}}$.
Corollary 1. By following the procedure described in Figure 9 the tree of $\mathcal{P} \mathcal{R}$-cavities computed on $u$ is the tree of shapes of $u$.

## V. Discussion about the tree of shapes

In Corollary 1, we assert that the tree of cavities computed by our algorithm is the tree of shapes of $u$. In fact, when the input image $u$ is already well-composed, the immersion $U$ is well-composed, and thus no topological reparation of $U$ is needed to obtain the property that the output of our algorithm (before the emersion) will be the tree of shapes of $U$. After the emersion, since it is used to remove the additional faces (added during the immersion step), we understand easily that the tree of cavities of $U$ becomes "the" tree of shapes of $u$.

However, when the initial image $u$ is not well-composed, we have to make it well-composed using some topological reparation algorithm, based for example on a min-interpolation (simulating the $2 n$-connectivity for the ones), or a maxinterpolation (simulating the $3^{n}-1$-connectivity for the ones), or even our $n$-D self-dual topological reparation (considering different connectivities depending on the context [10]). Due to this choice that has to be made, there exist several tree of shapes, depending on the choice that has been made about the well-composed interpolation we have chosen before applying our algorithm.

Another important remark is that the algorithm we present here is thus deterministic: assuming we have fixed the wellcomposed interpolation that we used at the beginning of the algorithm, whatever the random propagation during the sort algorithm is (several sequences of levels are possible during the propagation depending on if we increase or decrease the level), the final output is always the tree of shapes. So the algorithm we present here is deterministic. Intuitively, this determinism is justified by the fact that depending on when we increase or decrease the current level, we propagate in different areas of the domain of the image, thus increasing or decreasing has no influence on the final computation.

## VI. Complexity Analysis

Complexity analysis of the algorithm presented here is trivial. The immersion, canonicalization, and emersion are linear. The modified union-find (once augmented with tree
balancing, i.e., union-by-rank) is quasi-linear when values of the input image $u$ have a low quantization (typically 12 bits or less). Last, the time complexity of the sorting step is governed by the use hierarchical queue: it is linear with low quantized dat $\int^{3}$ Eventually, we obtain a quasi-linear algorithm.

## VII. CONCLUSION

We have proven in this paper that the tree computed in the algorithm provided in [1] is indeed the expected tree of shapes. We also know that the tree of shapes is a purely self-dual representation of a cubical image when we work with self-dual well-composed interpolations. For this reason, we propose to focus in the future on the proof that the interpolation provided in [7] is self-dual.
