# A Stochastic Target Problem for Branching Diffusions

#### Abstract

We consider an optimal stochastic target problem for branching diffusion processes. This problem consists in finding the minimal condition for which a control allows the underlying branching process to reach a target set at a finite terminal time for each of its branches. This problem is motivated by an example from fintech where we look for the super-replication price of options on blockchain based cryptocurrencies. We first state a dynamic programming principle for the value function of the stochastic target problem. We then show that the value function can be reduced to a new function with a finite dimensional argument by a so called branching property. Under wide conditions, this last function is shown to be the unique viscosity solution to an HJB variational inequality.

## 1 Introduction

The theory of optimal stochastic control has been extensively developed since the pioneering works in the 1950 decade. One reason for the growing attraction of this theory is the variety of its applications, such as physics, biology, economics or finance.

In the last field, stochastic control theory appears to be a very natural tool as it provides solutions to the optimal portfolio choice issue. The need to control risks related to financial

[^0]investments leads to new stochastic optimization problems. Here, one looks for the minimal initial endowment needed to find a financial strategy whose final position satisfies some given constraints. Such optimization problems are called optimal stochastic target problem and have been widely studied (see e.g. [24, 25, 2, 4, 3]).

The classical stochastic control theory has also been developed for other kind of stochastic processes such as branching diffusions. Those processes describe the evolution of a population of individuals with similar features concerning their dynamics and their reproduction. Branching processes have been first studied by Skorohod [23] and Ikeda et al. [13, 14, 15], who provided Feynmann-Kac presentation of solution to parabolic semi-linear partial differential equations (PDE for short). Since those pioneering works, branching processes have been extensively studied in particular their scaling limits and the link with superprocesses (see [8]). Recently, they were also used by Henry-Labordère et al. [12] for Monte Carlo based numerical approximation of solutions to semilinear parabolic PDEs.

In the case where the branching processes are controlled, Üstünel [27] considers a finite horizon optimization problem. He restricted to Markov controls acting only on the drift coefficient. Following a martingale problem approach, he proved existence of optimal controls under wide conditions. Nisio [21] considers the case where both the drift and diffusion coefficients are controlled. She characterizes the related value function as a viscosity solution to a nonlinear parabolic PDE of HJB type. Then, Claisse [5] extends the previous results by allowing controls that may not preserve independance of the particles and considering the lifespan and the progeny coefficients to depend on the position and the control. Following the approach of Fleming and Soner [11] which relies on a result due to Krylov [19], the value function is approximated by a sequence of smooth value functions corresponding to small perturbations of the initial problem. This is what allows to prove a dynamic programming principle (DPP for short) and to derive a related dynamic programming equation.

In this paper, we investigate a stochastic target problem where the underlying controlled process is a branching diffusion. The problem consists in finding a minimal initial condition for a given target branching diffusion such that it dominates a function of another controlled branching diffusion for each particle alive at a given terminal time.

We then give an extended equivalent formulation of the problem. Indeed, as the starting condition of the target branching process may contain several points, the previous problem is not well posed. We therefore look for the minimal value dominating all starting points such that the related branching process satisfies the terminal constraint.

Such a problem finds an application in mathematical finance, when dealing with the optimal investment on crypto-currencies. For these assets, branching may appear due to their structure, leading to new assets (see e.g. [10]). In this framework, the super-replication issue remains to the best of our knowledge unsolved. Our setting provides a possible solution and we give a detailed example as an illustration.

We adopt a DPP approach to characterize the value function of our branching stochastic target problem. Contrary to [5], our argument do not rely on the existence of regular solution to approximated PDEs but on probabilistic results. We use a measurable selection theorem similar to that of [24]. Combining it with a conditioning property for the law of the controlled process, we get the DPP.

We use it to identify the value function as a solution to a dynamic programming PDE. We first show, as in [5], a branching property. It relates the value function at a given starting condition to the optimal values at its points. This allows to see the value function as a sequence of functions from $[0, T] \times \mathbb{R}^{d}$ to $\mathbb{R}$ indexed by the (countable) set of particle labels. Contrary to the classical branching property, ours writes the value function as a maximum instead of a product. Hence, it
entails irregularity bringing us out of the range of regular solutions.
We therefore adopt the framework of viscosity solutions. The dependence in the label variable leads to adapt the definition of viscosity solutions and to impose a continuous bound in the label. Using the DPP, the value function is shown to be a viscosity solution to a partial differential inequality of two terms. The first one is the classical nonlinear second order operator for classical diffusion processes, written as a supremum of a linear operator over controls that kill the diffusive part. The restriction to these controls is due to the terminal constraint, imposed with probability one (see [4]). The second term expresses a monotonicity with respect to the label. More precisely, the value function taken at some label must be greater than its value on any other offspring label. Surprisingly, our PDE do not contain any polynomial of the value function function as we classically have in PDEs related to branching processes. This is due to the specific structure of the considered control problem. We complete this parabolic PDE property by a terminal condition.

To get a full characterization of our value function, we finally consider the uniqueness to the PDE. Under additional assumptions, we prove a comparison theorem using the classical approach of doubling variable combined with Ishii's lemma. This shows that the value function is the unique viscosity solution to the PDE. As a byproduct we get the continuity of the value function on the parabolic interior of the domain.

The remainder of the paper is organized as follows. In Section 2, we present the branching stochastic target problem and provide an example of application inspired from fintech. In Section 33, we set the dynamic programming principle. We finally show in Section 4 viscosity properties of the value function and provide a uniqueness result to the related PDE. Finally we relegate some technical results needed in the proof of the conditionning property to the appendix.

## 2 The problem

### 2.1 Branching diffusions

We start by a description of the underling controlled processes. As those processes are of branching type, we first introduce the label set.

Label set For $n \geq 1$, a multi-integer $i=\left(i_{1}, \ldots, i_{n}\right) \in \mathbb{N}^{n}$ is simply denoted by $i=i_{1} \ldots i_{n}$. For $n, m \geq 1$ and two multi-integers $i=i_{1} \ldots i_{n} \in \mathbb{N}^{n}$ and $j=j_{1} \ldots j_{m} \in \mathbb{N}^{m}$, we define their concatenation $i j \in \mathbb{N}^{n+m}$ by

To describe the evolution of the particle population, we introduce the set of labels $\mathcal{I}$ defined by

The label $\varnothing$ corresponds to the mother particle. We extend the concatenation (2.1) to the whole set $\mathcal{I}$ by

for all $i \in \mathcal{I}$. When the particle labelled $i=i_{1} \ldots i_{n} \in \mathbb{N}^{n}$ gives birth to $k$ particles, the off-springs are labelled $i 0, \ldots, i(k-1)$. We also define the partial ordering relation $\preceq($ resp. $\prec)$ by

We next write $|i|:=d^{\mathcal{I}}(i, \emptyset)$ for $i \in \mathcal{I}$.
Set of finite measures In the sequel we shall consider finite measure on $\mathcal{I} \times \mathbb{R}^{\ell}$ for $\ell \geq 1$. For that, we endow the set $\mathcal{I} \times \mathbb{R}^{\ell}$ with the metric $d$ defined by

$\mathcal{I} \times \mathbb{R}^{\ell}$ is then separable and complete. We denote by $\mathcal{M}_{F}\left(\mathcal{I} \times \mathbb{R}^{\ell}\right)$ set of the set of finite measures on $\mathcal{I} \times \mathbb{R}^{\ell}$. From Lemma 4.5 [17], $\mathcal{M}_{F}\left(\mathcal{I} \times \mathbb{R}^{\ell}\right)$ endowed with the topology of the weak convergence is Polish. We recall that we say that a sequence $\left(\nu_{n}\right)_{n \geq 0}$ weakly converges to $\nu$ in $\mathcal{M}_{F}\left(\mathcal{I} \times \mathbb{R}^{\ell}\right)$ if $\int f d \nu_{n} \rightarrow \int f d \nu$ as $n \rightarrow+\infty$ for any continuous and bounded function $f$ from $\mathcal{I} \times \mathbb{R}^{\ell}$ to $\mathbb{R}$. A possible metric associated to the weak topology on $\mathcal{M}_{F}\left(\mathcal{I} \times \mathbb{R}^{\ell}\right)$ is the Prokhorov metric (see Lemma 4.3 in [17]). We next define the subset $E_{\ell}$ of $\mathcal{M}_{F}\left(\mathcal{I} \times \mathbb{R}^{\ell}\right)$ by

By Proposition A.6, $E_{d}$ is Polish as well.
Probabilistic setting We fix a deterministic terminal time $T>0$ and a filtered probability space $\left(\Omega, \mathcal{F}, \overline{\mathbb{F}}=\left(\mathcal{F}_{t}\right)_{t \in[0, T]}, \mathbb{P}\right)$ satisfying the usual conditions. Suppose that this probability space is endowed with a family of processes $\left(B^{i}, Q^{i}\right)_{i \in \mathcal{I}}$ such that

- $\left(B_{t}^{i}\right)_{t \in[0, T]}$ is an $\mathbb{F}$-standard Brownian motion in $\mathbb{R}^{m}$ for all $i \in \mathcal{I}$;
- $Q^{i}(\mathrm{~d} t, \mathrm{~d} k)$ is an $\mathbb{F}$-Poisson random measure on $[0, T] \times \mathbb{N}$ with intensity measure $\mathrm{d} t \gamma p_{k} \delta_{k}$ for all $i \in \mathcal{I}$, with $\gamma>0, p_{k} \geq 0$ for $k \geq 0$ and $\sum_{k \geq 0} p_{k}=1, \delta_{k}$ being the Dirac measure at $k$;
- $\left\{B^{i}, Q^{j}, i, j \in \mathcal{I}\right\}$ forms a family of mutually independent processes.

Having in mind these processes, we precise a better probability space.

- Let $\Omega^{0}$ be the space of continuous functions from $[0, T]$ that are $\mathbb{R}^{m}$-valued starting at 0 . Let $\mathbb{F}^{0}:=\left(\mathcal{F}_{t}^{0}\right)_{t \in[0, T]}$ the filtration generated by the canonical process $B\left(\omega^{0}\right):=\omega^{0}, \omega^{0} \in \Omega^{0}$. We endow $\left(\Omega^{0}, \mathcal{F}_{T}^{0}\right)$ with the Wiener measure $\mathbb{P}^{0}$.
- Let $\Omega^{1}$ be the set of measures $\omega^{1}$ on $\mathbb{R}_{+} \times \mathbb{N}$ of the form $\omega^{1}=\sum_{k \geq 0} \delta_{\left(t_{k}, n_{k}\right)}$. Let $\mathbb{F}^{1}:=$ $\left(\mathcal{F}_{t}^{1}\right)_{t \in[0, T]}$ be the filtration generated by the canonical process $Q\left(\omega^{1}\right)=\omega^{1}$ :

We endow $\left(\Omega^{1}, \mathcal{F}_{T}^{1}\right)$ with the Poisson measure $\mathbb{P}^{1}$ of intensity $\mathrm{d} t \gamma \sum_{k \geq 0} p_{k} \delta_{k}$, that is the probability measure such that $Q$ is a Poisson point process with intensity $\mathrm{d} t \gamma \sum_{k \geq 0} p_{k} \delta_{k}$.

Following the structure we expect for $\left\{B^{i}, Q^{j}, i, j \in \mathcal{I}\right\}$, we define the filtered space $(\Omega, \mathcal{F}, \mathbb{F}, \mathbb{P})$, where $\Omega=\left(\Omega^{0} \times \Omega^{1}\right)^{\mathcal{I}}, \mathbb{P}=\left(\mathbb{P}^{0} \otimes \mathbb{P}^{1}\right)^{\otimes \mathcal{I}}, \mathcal{F}$ is the $\mathbb{P}$-augmentation of $\left(\mathcal{F}_{T}^{0} \otimes \mathcal{F}_{T}^{1}\right)^{\otimes \mathcal{I}}$ and $\mathbb{F}=\left(\mathcal{F}_{t}\right)_{t \in[0, T]}$ is the $\mathbb{P}$-augmentation of the filtration $\left(\left(\mathcal{F}_{t}^{0} \otimes \mathcal{F}_{t}^{1}\right)^{\otimes \mathcal{I}}\right)_{t \in[0, T]}$. On this space we extend the definition of the processes $B^{i}$ and $Q^{i}$ for $i \in \mathcal{I}$ as the previously described processes $B$ and $Q$ composed with the projections on each component, i.e.

To stress the dependence in time, we will use the following notations. For $t \in[0, T]$ and $\omega=\left(\omega^{0}, \omega^{1}\right) \in \Omega$, we define the stopped path at time $t$ by $\omega_{. \wedge t}=\left(\omega_{. \wedge t}^{0}, \omega_{. \wedge t}^{1}\right)$ where

Alive particles We define the set $\mathcal{V}_{t}$ of alive particles at time $t$ as follows.

- At time $t=0$, the set is reduced to the mother particle : $\mathcal{V}_{0}=\{\varnothing\}$.
- For a time $t \geq 0$, a particle $i \in \mathcal{V}_{t}$ dies at the first time $\tau_{i}>t$ the related Poisson measure $Q^{i}$ jumps after $t$, i.e.

Controlled population Take $A$ a Polish space with metric $d_{A}$. We assume $d_{A}$ to be bounded (if not so, we replace $d_{A}$ by $d_{A} \wedge 1$ and still have a Polish space). We define a control $\alpha$ as a family $\left(\alpha^{i}\right)_{i \in \mathcal{I}}$ of $\mathbb{F}$-progressively measurable processes valued in $A$. We denote by $\mathcal{A}$ the set of such controls.

Let $\lambda: \mathbb{R}^{d} \times A \rightarrow \mathbb{R}^{d}$ and $\sigma: \mathbb{R}^{d} \times A \rightarrow \mathbb{R}^{d \times m}$ be measurable functions. For a given control $\alpha \in \mathcal{A}$, each particle $i \in \mathcal{I}$ of the controlled population is born, evolves and dies to give birth to off-springs according to the set $\mathcal{V}$ defined above. We denote by $X_{s}^{i}$ the position at time $s$ of a particle $i \in \mathcal{V}_{s}$. For $i \in \mathcal{I}$ alive at time $t$, let $\tau_{i} \geq t$ be the random time of its death, giving birth to $k$ off-springs. The position at a time $s \geq \tau_{i}$ of the off-springs $i 0, \ldots, i(k-1)$ are given by

The process $Z$ takes values in the Polish space $E_{d}$ defined by (2.2).

For a control $\alpha \in \mathcal{A}$ and a function $f:[0, T] \times \mathcal{I} \times \mathbb{R}^{d} \rightarrow \mathbb{R}$ such that $f_{i}(\cdot) \in C^{1,2}\left([0, T] \times \mathbb{R}^{d}\right)$ for all $i \in \mathcal{I}$, the following SDE characterises the behaviour of $Z$ :

for all $s, t \in[0, T]$ such that $s \leq t$.
Target branching diffusion To each alive particle $i \in \mathcal{V}_{s}$, we associate a target position at time $s$ denoted by $Y_{s}^{i}$. Let $\lambda_{Y}: \mathbb{R}^{d} \times \mathbb{R} \times A \rightarrow \mathbb{R}$ and $\sigma_{Y}: \mathbb{R}^{d} \times A \rightarrow \mathbb{R}^{1 \times m}$ be measurable functions. Let $\tau_{i} \geq t$ be the random time of death of $i \in \mathcal{I}$, the target position at time $s \geq \tau_{i}$ is given by

Moreover, the process $Z^{t, \mu, \alpha}$ (resp. ( $\left.\hat{Z}^{t, \hat{\mu}, \alpha}\right)$ ) satisfies (2.7) (resp. 2.11).

We refer to [5, Proposition 2.1] for the proof of this proposition.
Remark 2.1. For any $i \in \mathcal{I}$ the processes $X^{t, \mu, \alpha, i}$ and $Y^{t, \hat{\mu}, \alpha, i}$ are defined on times $s \in[t, T]$ such that $i \in \mathcal{V}_{s}^{t, \mu}$. However, we can extend their definition to the whole interval $[t, T]$. Suppose first that $i$ has no ancestor in $\mathcal{V}_{t}^{t, \mu}$ :

Under the additional regularity assumption on the coefficients with respect to the control, we have a stability result for the branching system.

Subcase 2.1. There exist $j \in \mathcal{V}_{t}^{t, \mu}$ and $\ell_{1}, \ldots, \ell_{k}$ such that $i=j \ell_{1} \ldots \ell_{k}$. We then have

Using Assumption A1 (iii), we can apply Theorem 8.1 in [18] and we get the result.

Using the dominated convergence theorem we get from Step 1

Focusing on conditional laws of the controlled processes, we have a representation result. Define $\mathbb{D}\left([0, T], \mathcal{M}_{F}\left(I \times \mathbb{R}^{m+1}\right)\right)$ as the set of càdlàg functions from $[0, T]$ to $\mathcal{M}_{F}\left(I \times \mathbb{R}^{m+1}\right)$. We endow this set with the Skrorkhod metric related to the Prokhorov distance and the related Borel $\sigma$ algebra. From Doob's functional representation Theorem (see e.g. Lemma 1.13 in [16]) for any control $\alpha$, there exists a $\mathcal{B}([0, T]) \otimes \mathcal{B}\left(\mathbb{D}\left([0, T], \mathcal{M}_{F}\left(I \times \mathbb{R}^{m+1}\right)\right)\right.$-measurable function $\tilde{\alpha}:[0, T] \times$
$\mathbb{D}\left([0, T], \mathcal{M}_{F}\left(I \times \mathbb{R}^{m+1}\right)\right) \rightarrow A^{\mathcal{I}}$ such that $\alpha^{i}(\omega)=\tilde{\alpha}^{i}\left(s, \xi\left(\omega_{. \wedge s}\right)\right)=\tilde{\alpha}^{i}(s, \xi(\omega))$ for any $s \in[0, T]$, $\omega \in \Omega$ and $i \in \mathcal{I}$. In the sequel, we identify the control $\alpha$ with its related function $\tilde{\alpha}$ and we still denote by $\mathcal{A}$ the set of those controls.

For $\alpha \in \mathcal{A}$, an $\mathbb{F}$-stopping time $\tau$ and $\omega \in \Omega$, we define the control $\alpha^{\tau(\omega), \omega}$ by

The proof of this result is postponed to Appendix A.3. It follows the same lines as the proof of Theorem 2 in [6], and relies on a uniqueness property for the related branching martingale controlled problem which is studied in Appendix A.2.

### 2.2 The stochastic target problem

To define the stochastic target problem, let $g: \mathcal{I} \times \mathbb{R}^{d} \rightarrow \mathbb{R}$ be a function satisfying the following assumption.

Assumption A2. The function $g_{i}$ is continuous on $\mathbb{R}^{d}$ for all $i \in \mathcal{I}$.
Fix an initial time $t \in[0, T]$ and an initial population $\mu=\sum_{i \in V} \delta_{\left(i, x_{i}\right)}$. We look for an initial position $y$ for the target process and a control $\alpha \in \mathcal{A}$ such that

for $t \in[0, T]$ and $\mu=\sum_{i \in V} \delta_{\left(i, x_{i}\right)} \in E_{d}$. Since the target processes $Y^{i}$ has an explicit impact only on its drift $\lambda_{Y}$ and not on its diffusion coefficient $\sigma_{Y}$, the reachability set satisfies the following monotonicity property.

Proposition 2.3. Suppose that Assumptions A1 holds. For $\mu=\sum_{i \in V} \delta_{\left(i, x_{i}\right)} \in E_{d}$ and $y \in \mathcal{R}(t, \mu)$ we have $[y, \infty[\subseteq \mathcal{R}(t, \mu)$.
Proof. Fix a control $\alpha=\left(\alpha^{i}\right)_{i \in \mathcal{I}}$ and a starting point $(t, \mu)$. We take $y \in \mathcal{R}(t, \mu), y^{\prime} \geq y$ and write $\hat{\mu}$ (resp. $\left.\hat{\mu}^{\prime}\right)$ for $\sum_{i \in V} \delta_{\left(i, x_{i}, y\right)}\left(\right.$ resp. $\left.\sum_{i \in V} \delta_{\left(i, x_{i}, y^{\prime}\right)}\right), Y^{i}$ (resp. $Y^{\prime i}$ ) for $Y^{t, \hat{\mu}, \alpha, i}$ (resp. $Y^{t, \hat{\mu}^{\prime}, \alpha, i}$ ) and $\delta Y^{i}$ for $Y^{\prime i}-Y^{i}$. From Proposition 2.3 , the closure $\overline{\mathcal{R}(t, \mu)}$ of the reachability set is a half line interval characterized by its lower bound. We then define the value function $v$ as the infimum of $\mathcal{R}$ :

Remark 2.2. The value function $v$ or the reachability set $\mathcal{R}$ might not be well defined in the case where an extinction of the alive population of particle happens before $T$. In this case we take the convention that the terminal condition is always satisfied if $\mathcal{V}_{T}^{t, \mu}=\emptyset$. In the sequel, we keep this convention for other constraints on $\left(X_{\theta}^{t, \mu, \alpha, i}, Y_{\theta}^{t, \hat{\mu}, \alpha, i}\right)$ with $\mathcal{V}_{\theta}^{t, \mu}=\emptyset$ and $\theta$ a stopping time.

We next provide a new formulation of the function $v$.
Proposition 2.4. Under Assumptions A1, the value function function $v$ satisfies the following identity

### 2.3 An example of application from fintech

Fintech is the contraction of the words finance and technology. It refers to recent technologies that allows for the improvement and the automation of the delivery and use of financial services. The field has emerged at the beginning of the 21-st century and covered technologies used by established financial institutions. Since that time, the field has evolved to also include crypto-currencies which are decentralised financial assets. Those assets are based on the block-chain technology. The main idea of that structure is to keep any new transaction registered in a chain by adding new blocks and sharing the extension of the original chain over the network, so that every user keeps in mind the transaction and can certify it. We refer to [20] for a description of how a block-chain base crypto-currency works in the case of the Bitcoin.

Due to the structure of this kind of assets, a fork can appear in the chain (see [10]). In this case, the original asset is transformed into several assets. A natural question that arises is how to evaluate an option on crypto-currencies in this case. We present here the example of the superreplication of options on asset that may fork and show that it is a particular case of the branching stochastic target presented above.

We consider a financial market on which is defined a crypto-currency with price process $\left(S_{t}\right)_{t \in[0, T]}$. We suppose that the process $S$ is a branching diffusion and describe its dynamics. We first define the set $\mathcal{V}_{t}$ of alive particles at time $t \in[0, T]$ as previously done in Section 2.1. The initial condition for the process $S$ is a constant $\left(S_{0}>0\right)$. Assume the version $i \in \mathcal{I}$ of the crypto-currency is alive at time $t \in[0, T]$, dies at some random time $\tau_{i} \geq t$ and gives birth to $k$ new versions $i 0, \ldots, i(k-1)$. The position at a time $s \geq \tau_{i}$ of the new the crypto-currencies are given by

In addition to that asset, we assume that there exists on the market a non-risky asset $S^{0}$ with deterministic interest rate $r>0$ and with initial condition $S_{0}^{0}=1$, that is $S_{t}=e^{r t}$ for $t \in[0, T]$.

An investment strategy consists in a process $\pi=\left(\pi_{t}^{i}\right)_{t \in[0, T], i \in \mathcal{I}}$ of $\mathbb{F}$-progressive processes valued in $[0,1]$, where $\pi_{t}^{i}$ represents the proportion of the wealth invested in the version $S^{i}$ of the cryptocurrency. We denote by $\mathcal{A}$ the set of such strategies. For $\pi \in \mathcal{A}$, we also denote by $V^{V_{0}, \pi}$ the self financing wealth process related to the initial capital $V_{0}$ and strategy $\pi$. According to $(2.19)-(2.20)$ it is given by

We then consider a financial derivative on the asset $S$ that consists in a Put Option but with a strike $K_{i}$ depending on the version of the crypto-currency $S$. Such a product can express the need to hedge againts a decrease of the value of the asset $S$ that depends on the branch.

The computation of the super-replication problem leads to solve the following stochastic target problem

for $\ell=0, \ldots, k-1$ and $s \geq \tau_{i}$ such that version $i \ell$ is alive at time $s$. We observe that the dynamics of the processes $Y$ and $X$ satisfy Assumption A1. We also define the functions $g$ as

y+\left(\left(\frac{b-r}{c}\right)^{2}+r\right)(T-t) \geq \mathbb{E}\left[Y_{T}^{t, \hat{\mu}, \pi, i}\right] \geq \mathbb{E}\left[g_{i}\left(X_{T}^{t, \mu, \pi, i}\right)\right] \geq \log (\kappa)
$$

Therefore,

$$
v(t, \mu) \geq-\left(\left(\frac{b-r}{c}\right)^{2}+r\right)(T-t)+\log (\bar{K}+\kappa), \quad(t, \mu) \in[0, T] \times E_{d}
$$

In particular, $v$ satisfies the growth condition (4.66) of the comparison Theorem 4.5. If we suppose also that $r=0$ and $g_{i}=0$ for $i \in \mathcal{I}$ of the form $i=i_{1} \cdots i_{n}$ with $i_{\ell} \geq I$ for some $\ell$ where $I$ is a given bound, then $v$ also satisfies condition 4.65) of Theorem 4.5.

## 3 Dynamic programming

### 3.1 Measurable selection

In establishing a dynamic programming principle, we need an admissible control as concatenation of admissible controls depending on the position of the branching processes at an intermediary time. For this end, we use a measurable selection approach.

Let $\mathcal{U}$ be the target set defined by

$$
\mathcal{U}(t, \hat{\mu})=\left\{\alpha \in \mathcal{A}: Y_{T}^{t, \hat{\mu}, \alpha, i} \geq g_{i}\left(X_{T}^{t, \mu, \alpha, i}\right) \forall i \in \mathcal{V}_{T}^{t, \mu, \alpha} a . s .\right\}
$$

for $(t, \hat{\mu}) \in[0, T] \times E_{d+1}$ with $\hat{\mu}=\sum_{i \in V} \delta_{\left(i, x_{i}, y_{i}\right)}$ and $\mu=\sum_{i \in V} \delta_{\left(i, x_{i}\right)} \in E_{d}$. Let $S:=[0, T] \times E_{d+1}$ and

$$
D:=\{(t, \hat{\mu}) \in S: \mathcal{U}(t, \hat{\mu}) \neq \emptyset\} .
$$

Our aim is to exhibit a function that associates to each $(t, \hat{\mu}) \in D$ a control $\alpha \in \mathcal{U}(t, \hat{\mu})$ in a measurable way.

We denote by $\mathcal{P}(S)$ the set of probability measures on $\left(S, \mathcal{B}([0, T]) \otimes \mathcal{B}\left(E_{d+1}\right)\right)$ and we endow $\mathcal{A}$ with the Borel $\sigma$-algebra $\mathcal{B}(\mathcal{A})$ related to the distance

$$
\left(\alpha, \alpha^{\prime}\right) \mapsto \sum_{i \in \mathcal{I}} \frac{1}{2^{|i|}} \wedge \mathbb{E} \int_{0}^{T}\left|\alpha_{s}^{i}-\alpha_{s}^{\prime i}\right| \mathrm{d} s
$$

where $|i|=i_{1}+\cdots+i_{n}$ for $i=\left(i_{1}, \ldots, i_{n}\right) \in \mathbb{N}^{n}$ and $n \geq 1$. We then have the following measurable selection result.

Lemma 3.1. Suppose that Assumptions A1 and A2 hold. For each $\nu \in \mathcal{P}(S)$, there exists a measurable function $\phi_{\nu}:(D, \mathcal{B}(D)) \rightarrow(\mathcal{A}, \mathcal{B}(\mathcal{A}))$ such that

$$
\phi_{\nu}(t, \hat{\mu}) \in \mathcal{U}(t, \hat{\mu}) \text { for } \nu \text {-a.e. }(t, \hat{\mu}) \in D .
$$

Proof. $S$ being endowed with the product $\sigma$-algebra $\mathcal{B}([0, T]) \otimes \mathcal{B}\left(E_{d+1}\right)$ is a Borel space as product of Borel spaces. Also $\mathcal{A}$ endowed with $\mathcal{B}(\mathcal{A})$ is a Borel space. Let $C$ be the following set

$$
C:=\{(t, \hat{\mu}) \in S \times \mathcal{A}: \alpha \in \mathcal{U}(t, \hat{\mu})\} .
$$

From Proposition 2.2 and Assumption A2, $C$ is closed and a fortiori a Borel subset of $S \times \mathcal{A}$.

- Step 1: Measurable selector.

Since $C$ is a Borel set, it is analytic by [1, Proposition 7.36]. From the Jankov-von Neumann measurable selection theorem (see e.g. [1, Proposition 7.49]), there exists an analytically measurable function $\phi: D \rightarrow \mathcal{A}$ such that

\{(t, \hat{\mu}, \phi(t, \hat{\mu})):(t, \hat{\mu}) \in S\} \subset C .
$$

- Step 2: Construction of a Borel measurable $\phi_{\nu}$ such that $\phi_{\nu}=\phi \nu$-almost everywhere.

Fix $\nu \in \mathcal{P}(S)$ and denote by $\mathcal{B}_{\nu}(S)$ the completion of the Borel $\sigma$-algebra $\mathcal{B}(S)$ under $\nu$. From [1, Corollary 7.42.1] any analytic set is universally measurable. Therefore $\phi$ is universally measurable, and, from the definition of the universal $\sigma$-algebra, $\phi$ is $\mathcal{B}_{\nu}(S)$-measurable. Since $\mathcal{B}_{\nu}(S)$ is the completion of $\mathcal{B}(S)$ under $\nu$, there exists a Borel measurable map $\phi_{\nu}$ such that $\phi_{\nu}(t, \hat{\mu})=\phi(t, \hat{\mu})$ for $\nu$-almost every $(t, \hat{\mu}) \in S$.

### 3.2 Dynamic programming principle

For $t \in[0, T]$, we denote by $\mathcal{T}_{[t, T]}$ the set of $\mathbb{F}$ stopping times valued in $[t, T]$. The dynamic programming principle may be stated as follows.

Theorem 3.2. Under Assumptions A1 and A2, the value function satisfies

$$
\begin{align*}
& v(t, \mu)=\inf \left\{y \in \mathbb{R}: \exists \alpha \in \mathcal{A}, \exists \hat{\mu}=\sum_{i \in V} \delta_{\left(i, x_{i}, y_{i}\right)} \in E_{d+1}\right. \text { such that } \\
& \left.y_{i} \leq y \forall i \in V \text {, and } Y_{\theta}^{t, \hat{\mu}, \alpha, i} \geq v\left(\theta, \delta_{\left(i, X_{\theta}^{t, \mu, \alpha, i}\right)}\right) \forall i \in \mathcal{V}_{\theta}^{t, \mu} \text { a.s. }\right\} \tag{3.25}
\end{align*}
$$

for any $(t, \mu) \in[0, T] \times E_{d}$ and $\theta \in \mathcal{T}_{[t, T]}$.
Proof. We first define the reachability sets by

$$
\mathcal{Y}(t, \mu):=\left\{\left(y_{i}\right)_{i \in V} \in \mathbb{R}^{V} \quad: \mathcal{U}(t, \hat{\mu}) \neq \emptyset \text { with } \hat{\mu}=\sum_{i \in V} \delta_{\left(i, x_{i}, y_{i}\right)}\right\} .
$$

and

$$
\begin{aligned}
\mathcal{Y}^{\theta}(t, \mu)=\left\{\left(y_{i}\right)_{i \in V} \in \mathbb{R}^{V}: \exists \alpha \in \mathcal{A}\right. \text { such that } \\
\left.\qquad Y_{\theta}^{t, \hat{\mu}, y, \alpha, i} \geq v\left(\theta, \delta_{\left(i, X_{\theta}^{t, \mu, \alpha, i}\right)}\right) \forall i \in \mathcal{V}_{\theta}^{t, \mu} \text { a.s. with } \hat{\mu}=\sum_{i \in V} \delta_{\left(i, x_{i}, y_{i}\right)} \in E_{d+1}\right\} .
\end{aligned}
$$

for $t \in[0, T]$ and $\mu=\sum_{i \in V} \delta_{\left(i, x_{i}\right)} \in E_{d}$ and $\theta \in \mathcal{T}_{[t, T]}$. Fix now $t \in[0, T]$ and $\mu=\sum_{i \in V} \delta_{\left(i, x_{i}\right)} \in E_{d}$. Denote by $v_{\theta}(t, \mu)$ the right hand side of (3.25).

To prove $v(t, \mu) \geq v_{\theta}(t, \mu)$, we show that $\mathcal{Y}(t, \mu) \subset \mathcal{Y}^{\theta}(t, \mu)$. Let $\left(y_{i}\right)_{i \in V} \in \mathcal{Y}(t, \mu)$. By definition there exists $\alpha \in \mathcal{A}$ such that

$$
Y_{T}^{t, \hat{\mu}, \alpha, j} \geq g_{j}\left(X_{T}^{t, \mu, \alpha, j}\right) \quad \forall j \in \mathcal{V}_{T}^{t, \mu}
$$

From the uniqueness of solutions to (2.5)-(2.6) and (2.8)-(2.9) (or equivalently (2.12)-(2.12)) we get the following flow property

& X_{T}^{t, \mu, \alpha, j}=X_{T}^{\theta, \delta}\left(i, X_{\theta}^{t, \mu, \alpha, i}\right), \alpha, j \\
& \theta, \delta \\
& Y_{T}^{t, \hat{\mu}, \alpha, j}=Y_{\theta}^{\left.t, \mu, \alpha, i, Y_{\theta}^{t, \hat{,}, y, \alpha, i}\right)}, \alpha, j
\end{aligned}
$$

for all $i \in \mathcal{V}_{\theta}^{t, \mu}$ and $j \in \mathcal{V}_{T}^{t, \mu}$ such that $i \preceq j$.
We therefore get

$$
Y_{T}^{\theta, \delta}\left(i, X_{\theta}^{t, \mu, \alpha, i}, Y_{\theta}^{t, \hat{\mu}, \alpha, i}\right)^{, \alpha, j} \geq g_{j}\left(X_{T}^{\theta, \delta}\left(i, X_{\theta}^{t, \mu, \alpha, i}\right)^{, \alpha, j}\right), \quad j \in \mathcal{V}_{T}^{\theta, \delta}\left(i, X_{\theta}^{t, \mu, \alpha, i}\right)
$$

for all $i \in \mathcal{V}_{\theta}^{t, \mu}$. Given the definition of the value function $v$, we get $Y_{\theta}^{t, \hat{\mu}, \alpha, i} \geq v\left(\theta, \delta_{\left(i, X_{\theta}^{t, \mu, \alpha, i}\right)}\right)$ for all $i \in \mathcal{V}_{\theta}^{t, \mu}$ a.s. and $\left(y_{i}\right)_{i \in V} \in \mathcal{Y}^{\theta}(t, \mu)$.

We now turn to the reverse inequality $v_{\theta}(t, \mu) \geq v(t, \mu)$. To this end, we prove that $\mathcal{Y}_{\varepsilon}^{\theta}(t, \mu) \subset$ $\mathcal{Y}(t, \mu)$ for any $\varepsilon>0$, where

$$
\mathcal{Y}_{\varepsilon}^{\theta}(t, \mu)=\left\{\left(y_{i}+\varepsilon\right)_{i \in V}:\left(y_{i}\right)_{i \in V} \in \mathcal{Y}^{\theta}(t, \mu)\right\}

Let $\left(y_{i}\right)_{i \in V} \in \mathcal{Y}^{\theta}(t, \mu)$ and $\alpha \in \mathcal{A}$ such that $Y_{\theta}^{t, \hat{\mu}, \alpha, i} \geq v\left(\theta, \delta_{\left(i, X_{\theta}^{t, \mu, \alpha, i}\right)}\right)$ for all $i \in \mathcal{V}_{\theta}^{t, \mu}$ a.s. where $\hat{\mu}=\sum_{i \in V} \delta_{\left(i, x_{i}, y_{i}\right)}$. Fix now $\varepsilon>0$ and set $\hat{\mu}=\sum_{i \in V} \delta_{\left(i, x_{i}, y_{i}\right)}$ and $\hat{\mu}_{\varepsilon}=\sum_{i \in V} \delta_{\left(i, x_{i}, y_{i}+\varepsilon\right)}$. From the definition of the value function and the strict monotonicity of the flow w.r.t. the initial value, we get $Y_{\theta}^{t, \hat{\mu}, \alpha, i}(\omega)<Y_{\theta}^{t, \hat{\mu}_{\varepsilon}, \alpha, i}(\omega) \in \mathcal{Y}\left(\theta, \delta_{\left(i, X_{\theta}^{t, \mu, \alpha, i}\right)}\right)(\omega)$ for all $i \in \mathcal{V}_{\theta}^{t, \mu}$ for $\mathbb{P}$-a.e. $\omega \in \Omega$. Consider the probability measure $\nu$ induced on $S$ by

$$
\omega \mapsto\left(\theta, \hat{Z}_{\theta}^{t, \hat{\mu}_{\varepsilon}, \alpha}\right)(\omega)
$$

and $\phi_{\nu}$ the measurable map defined in Lemma 3.1. We have

$$
\begin{equation*}
Y_{T}^{\tilde{t} \tilde{\mu}, \tilde{y}, \phi_{\nu}(\tilde{t}, \tilde{\mu}, \tilde{y}), i} \geq g_{i}\left(X_{T}^{\tilde{t}, \tilde{,}, \phi_{\nu}(\tilde{t}, \tilde{\mu}, \tilde{y}), i}\right) \quad \forall i \in \mathcal{V}_{T} \mathbb{P} \text {-a.s. for } \nu \text {-a.e. }(\tilde{t}, \tilde{\mu}, \tilde{y}) \in D \tag{3.26}
\end{equation*}
$$

We define $\hat{\Xi}:=\left(\theta, \hat{Z}_{\theta}^{t, \hat{\mu}_{\varepsilon}, \alpha}\right)$ and $\Xi:=\left(\theta, Z_{\theta}^{t, \mu, \alpha}\right)$. For $i_{T} \in \mathcal{V}_{T}^{t, \mu}$, if $i_{\theta} \in \mathcal{V}_{\theta}^{t, \mu}$ such that $i_{\theta} \preceq i_{T}$, the initial conditions at time $\theta$ for $Y_{T}^{i_{T}}$ and $X_{T}^{i_{T}}$ are respectively $\Xi$ and $\hat{\Xi}$.

Binding flow properties with the measurable selector, we can find a negligible set $N_{1}$ of $\mathcal{F}$ such that there exists negligible set $N_{2, \omega_{1}}$ of $\mathcal{F}$ for each $\omega_{1} \in N_{1}^{c}$ such that

$$
Y_{T}^{\hat{\Xi}\left(\omega_{1}\right), \phi_{\nu}\left(\hat{\Xi}\left(\omega_{1}\right)\right), i}\left(\omega_{2}\right) \geq g_{i_{T}}\left(X_{T}^{\Xi\left(\omega_{1}\right), \phi_{\nu}\left(\hat{\Xi}\left(\omega_{1}\right)\right), i}\left(\omega_{2}\right)\right) \quad \forall i \in \mathcal{V}_{T}^{\Xi\left(\omega_{1}\right)}\left(\omega_{2}\right)
$$

for all $\omega_{1} \in N_{1}^{c}$ and $\omega_{2} \in N_{2, \omega_{1}}^{c}$.

We now define the set $\bar{N}:=\left\{\omega: \omega \in N_{1}^{c}, \omega \in N_{2, \omega}\right\}$ and we prove that $\bar{N}$ is negligible. We first have $\bar{N} \subset N_{1}^{c} \cap \bar{N}_{2}$ where

$$
\bar{N}_{2}=\left\{\omega \in \Omega: \exists i \in \mathcal{V}_{T}^{\Xi(\omega)}(\omega), \quad Y_{T}^{\hat{\Xi}(\omega), \phi_{\nu}(\hat{\Xi}(\omega)), i}(\omega)<g_{i}\left(X_{T}^{\Xi(\omega), \phi_{\nu}\left(\hat{\Xi}^{(i)}(\omega)\right), i}(\omega)\right)\right\} .
$$

The set $\bar{N}_{2}$ can be rewritten as

$$
\bar{N}_{2}=\left\{\omega \in \Omega: \prod_{i \in \mathcal{V}_{T}^{\Xi}} \mathbb{1}_{Y_{T}^{\hat{\Xi}}, \phi_{\nu}(\hat{\Xi}), i} \geq g_{i}\left(X_{T}^{\Xi, \phi_{\nu}(\hat{\Xi}), i}\right)(\omega)=0\right\} .
$$

Taking the conditional expectation w.r.t. $\mathcal{F}_{\theta}$, we have up to a negligible set

Using Theorem 2.1 wet get

$$
\begin{aligned}
\bar{N}_{2} & =\left\{\omega \in \Omega: \int_{\Omega} \prod_{i \in \mathcal{V}_{T}^{\Xi(\omega)}\left(\omega \oplus_{\theta} \omega^{\prime}\right)} \mathbb{1}_{Y_{T}^{\hat{\Xi}(\omega), \phi_{\nu}(\hat{\Xi}(\omega)), i}\left(\omega \oplus_{\theta} \omega^{\prime}\right) \geq g_{i}\left(X_{T}^{\Xi(\omega), \phi_{\nu}(\hat{\Xi}(\omega)), i}\left(\omega \oplus_{\theta} \omega^{\prime}\right)\right)} d \mathbb{P}\left(\omega^{\prime}\right)=0\right\} \\
& =\left\{\omega \in \Omega: \mathbb{P}\left(N_{2, \omega}\right)=0\right\} .
\end{aligned}
$$

Therefore we get, up to a negligible set, $\bar{N}_{2} \subset N_{1}$ and $\mathbb{P}\left(\bar{N}_{2}\right)=0$
We now fix $\alpha \in A$ and define the control $\bar{\alpha}=\left(\bar{\alpha}^{i}\right)_{i \in \mathcal{I}}$ by

$$
\bar{\alpha}^{i}(\omega):= \begin{cases}\alpha^{i}(\omega) \mathbb{1}_{[0, \theta(\omega))}+\phi_{\nu}^{i}(\hat{\Xi}(\omega))(\omega) \mathbb{1}_{[\theta(\omega), T]} & \text { if } \omega \in \Omega \backslash \bar{N} \\ a & \text { if } \omega \in \bar{N}\end{cases}
$$

for all $i \in \mathcal{I}$ wirth $a \in A$. Since $\left(Y_{T}^{\hat{\Xi}, \phi_{\nu}(\hat{\Xi})}, X_{T}^{\Xi, \phi_{\nu}(\hat{\Xi}), i}\right)=\left(Y_{T}^{t, \hat{\mu}_{\varepsilon}, \bar{\alpha}, i}, X_{T}^{t, \mu, \bar{\alpha}, i}\right)$ for each $i \in \mathcal{V}_{T}^{t, \mu}$ a.s. and $\bar{N}_{2}$ is negligible, we get $\left(y_{i}+\varepsilon\right)_{i \in V} \in \mathcal{Y}(t, \mu)$.

## 4 PDE characterisation

### 4.1 Branching property

Conditionally to their birth, the alive particles, and consequently their branches, are independent in the uncontrolled case. In out case, this branching property is passed down to the value function in the following way.

Proposition 4.5 (Branching property). Let Assumption A1 holds. The value function $v$ satisfies

$$
\begin{equation*}
v(t, \mu)=\max _{i \in V} v\left(t, \delta_{\left(i, x^{i}\right)}\right) \tag{4.27}
\end{equation*}
$$

for any $\left(t, \mu=\sum_{i \in V} \delta_{\left(i, x^{i}\right)}\right) \in[0, T] \times E_{d}$.

Proof. For $\mu=\sum_{i \in V} \delta_{\left(i, x_{i}\right)} \in E_{d}$, we define

$$
K^{\mu}:=\left\{y \in \mathbb{R}: \exists \alpha \in \mathcal{A}, Y_{T}^{t, \hat{\mu}, \alpha, i} \geq g_{i}\left(X_{T}^{t, \mu, \alpha, i}\right) \forall i \in \mathcal{V}_{T}^{t, \mu, \alpha} a . s . \text { with }, \hat{\mu}=\sum_{i \in V} \delta_{\left(i, x_{i}, y\right)}\right\} .
$$

Proving $v(t, \mu) \geq \max _{i \in V} v\left(t, \delta_{\left(i, x^{i}\right)}\right)$ comes to verify that $K^{\mu} \subseteq \bigcap_{j \in V} K^{\delta_{\left(j, x^{j}\right)}}$, i.e. $K^{\mu} \subseteq K^{\delta_{\left(j, x^{j}\right)}}$ for each $j \in V$. If $y \in K^{\mu}$, there exists $\alpha$ satisfying the constraints in $T$ a.s. With this same $\alpha$, zooming in on the sub-population generated by each $j \in V$, we must satisfy the condition of $K^{\delta_{\left(j, x^{j}\right)}}$. Therefore, $y \in K^{\delta_{\left(j, x^{j}\right)}}$.

Let $j$ be the index that realises the maximum in the righthand side of 4.27). The monotonicity property given by Proposition 2.3 implies $K^{\delta}{ }_{\left(j, x^{j}\right)} \subseteq K^{\delta\left(i, x^{i}\right)}$ for all $i \in V$. Then, if $y \in K^{\delta}{ }_{\left(j, x^{j}\right)}$, let $\alpha^{i}$ be a control for $i \in V$ that meets the demand of $K^{\delta}\left(i, x^{i}\right)$. To prove $y \in K^{\mu}$ we must exhibit a control that satisfies the requirements of such a set. Having a control $\alpha$ taken as $\alpha^{i}$ on the branches generated by each $i \in V$, we meet the conditions of $K^{\mu}$. Therefore, $\max _{i \in V} v\left(t, \delta_{\left(i, x^{i}\right)}\right)=$ $v\left(t, \delta_{\left(j, x^{j}\right)}\right) \leq v(t, \mu)$

From this result, we can focus on the function $\bar{v}$ defined on $\mathcal{I} \times[0, T] \times \mathbb{R}^{d}$ by

$$
\bar{v}_{i}(t, x)=v\left(t, \delta_{(i, x)}\right)
$$

for $(i, t, x) \in \mathcal{I} \times[0, T] \times \mathbb{R}^{d}$. We provide in the next sections a PDE characterisation of the function $\bar{v}$.

### 4.2 Dynamic programming equation

### 4.2.1 The equation on the parabolic interior

In a stochastic target problem, wishing to hit a given target with probability one, we must degenerate along certain directions. Moreover, we also need to control the uncertainty related the possible branching. This property enables the characterisation of the value function $\bar{v}$ as a solution the following PDE

$$
\begin{equation*}
\min \left\{-\partial_{t} \bar{v}_{i}(t, x)+F\left(x, \bar{v}_{i}(t, x), D \bar{v}_{i}(t, x), D_{x}^{2} \bar{v}_{i}(t, x)\right) ; \bar{v}_{i}(t, x)-\sup _{0 \leq k<\bar{K}} \bar{v}_{i k}(t, x)\right\}=0 \tag{4.28}
\end{equation*}
$$

for $(t, x) \in[0, T) \times \mathbb{R}^{d}$, where

$$
\begin{aligned}
\bar{K} & =\sup \left\{k+1 \in \mathbb{N}: p_{k}>0\right\} \\
F(\Theta) & =\sup \left\{\lambda_{Y}(x, y, a)-\lambda(x, a)^{\top} p-\frac{1}{2} \operatorname{Tr}\left(\sigma \sigma^{\top}(x, a) M\right): a \in \mathcal{N}(x, p)\right\}
\end{aligned}
$$

for $\Theta=(x, y, p, M) \in \mathbb{R}^{d} \times \mathbb{R} \times \mathbb{R}^{d} \times \mathbb{S}^{d}$, and

$$
\mathcal{N}(x, p)=\left\{a \in A: N^{a}(x, p)=0\right\} \quad \text { and } \quad N^{a}(x, p)=\sigma_{Y}(x, a)-\sigma(x, a)^{\top} p
$$

for $x, p \in \mathbb{R}^{d}$.
Since the control set $A$ is not necessarily compact, the operator associated to this PDE may not be continuous. We therefore need to define a weak formulation of 4.28). For that, we introduce the relaxed semilimits of $F$ given by

$$
F^{*}(\Theta)=\limsup _{\varepsilon \rightarrow 0, \Theta^{\prime} \rightarrow \Theta} F_{\varepsilon}\left(\Theta^{\prime}\right) \text { and } F_{*}(\Theta)=\liminf _{\varepsilon \rightarrow 0, \Theta^{\prime} \rightarrow \Theta} F_{\varepsilon}\left(\Theta^{\prime}\right)
$$

where

$$
F_{\varepsilon}(\Theta)=\sup \left\{\lambda_{Y}(x, y, a)-\lambda(x, a)^{\top} p-\frac{1}{2} \operatorname{Tr}\left(\sigma \sigma^{\top}(x, a) M\right): a \in \mathcal{N}_{\varepsilon}(x, p)\right\}
$$

for $\Theta=(x, y, p, M) \in \mathbb{R}^{d} \times \mathbb{R} \times \mathbb{R}^{d} \times \mathbb{S}^{d}$ and $\varepsilon \geq 0$, and

$$
\mathcal{N}_{\varepsilon}(x, p)=\left\{a \in A:\left|N^{a}(x, p)\right| \leq \varepsilon\right\} \quad \text { and } \quad N^{a}(x, p)=\sigma_{Y}(x, a)-\sigma(x, a)^{\top} p
$$

for $x, p \in \mathbb{R}^{d}$. Observe that $\left(\mathcal{N}_{\varepsilon}\right)_{\varepsilon \geq 0}$ is non-decreasing so that

Since some $\mathcal{N}_{\mathcal{\varepsilon}}(x, p)$ may be empty, we shall use the standard convention $\sup \emptyset=-\infty$ all over this paper. For ease of notations, we also write $F \varphi(t, x)$ in place of $F\left(x, \varphi(t, x), D \varphi(t, x), D_{x}^{2} \varphi(t, x)\right)$ for a regular function $\varphi$. We similarly use the notations $F^{*} \varphi$ and $F_{*} \varphi$.

As the value function may not be regular, we use the framework of discontinuous viscosity solutions. To this end, we define the lower- and upper-semicontinuous envelopes $f_{*}$ and $f^{*}$ of a locally bounded function $f:[0, T] \times \mathbb{R}^{d} \times \mathcal{I} \rightarrow \mathbb{R}$ by

for $(t, x, i) \in[0, T] \times \mathbb{R}^{d} \times \mathcal{I}$. We are now able to provide the definition of a viscosity solution to (4.28).

Definition 4.1. Let $u:[0, T] \times \mathbb{R}^{d} \times \mathcal{I} \rightarrow \mathbb{R}$ be a locally bounded function.
(i) $u$ is $a$ viscosity supersolution to (4.28) if for any $\left(t_{0}, x_{0}, i_{0}\right) \in[0, T) \times \mathbb{R}^{d} \times \mathcal{I}$ and any $\varphi_{i} \in$ $C^{1,2}\left([0, T] \times \mathbb{R}^{d}\right)$ for $i \in \mathcal{I}$ and $\bar{\varphi} \in C^{0}\left([0, T] \times \mathbb{R}^{d}\right)$ such that

0=\left(u_{i_{0}, *}-\varphi_{i_{0}}\right)\left(t_{0}, x_{0}\right) & =\min _{\mathcal{I} \times[0, T] \times \mathbb{R}^{d}}\left(u_{\cdot, *}-\varphi \cdot\right) .
\end{aligned}
$$

we have

\min \left\{-\partial_{t} \varphi_{i_{0}}\left(t_{0}, x_{0}\right)+F^{*} \varphi_{i_{0}}\left(t_{0}, x_{0}\right) ;\left(\varphi_{i_{0}}-\sup _{0 \leq k<\bar{K}} \varphi_{i_{0} k}\right)\left(t_{0}, x_{0}\right)\right\} \geq 0 .
$$

(ii) $u$ is a viscosity subsolution to (4.28) if for any $\left(t_{0}, x_{0}, i_{0}\right) \in[0, T) \times \mathbb{R}^{d} \times \mathcal{I}$ and any $\varphi_{i} \in$ $C^{1,2}\left([0, T] \times \mathbb{R}^{d}\right)$ for $i \in \mathcal{I}$ and $\bar{\varphi} \in C^{0}\left([0, T] \times \mathbb{R}^{d}\right)$ such that

\min \left\{-\partial_{t} \varphi_{i_{0}}\left(t_{0}, x_{0}\right)+F_{*} \varphi_{i_{0}}\left(t_{0}, x_{0}\right) ;\left(\varphi_{i_{0}}-\sup _{0 \leq k<\bar{K}} \varphi_{i_{0} k}\right)\left(t_{0}, x_{0}\right)\right\} \leq 0 .
$$

(iii) $u$ is $a$ viscosity solution to (4.28) if it is both a viscosity sub and supersolution to (4.28).

We notice that the definition of viscosity solution is slightly different from the classical one as we impose a bound in the label particle $i$ for test functions.

Following [4, we introduce the a continuity assumption on the kernel that is used to prove the subsolution property.

Assumption A3. Let $B$ be a subset of $\mathbb{R}^{d} \times \mathbb{R}^{d}$ such that $\mathcal{N}_{0} \neq \emptyset$ on $B$. Then, for every $\varepsilon>0$, $\left(x_{0}, p_{0}\right) \in \operatorname{int}(B)$, and $a_{0} \in \mathcal{N}_{0}\left(x_{0}, p_{0}\right)$, there exists an open neighborhood $B^{\prime}$ of $\left(x_{0}, p_{0}\right)$ and a locally Lipschitz map $\hat{a}$ defined on $B^{\prime}$ such that $\left|\hat{a}\left(x_{0}, p_{0}\right)-a_{0}\right| \leq \varepsilon$ and

\hat{a}(x, p) \in \mathcal{N}_{0}(x, p) \text { for all }(x, p) \in B^{\prime} .
$$

We are now able to state our result.
Theorem 4.3. Suppose that $\bar{v}$ is locally bounded on $[0, T] \times \mathbb{R}^{d} \times \mathcal{I}$.
(i) Under Assumptions A1, the value function $\bar{v}$ is a viscosity supersolution to 4.28)
(ii) If in addition Assumption A3 holds, $\bar{v}$ is a viscosity subsolution to 4.28)

### 4.2.2 Terminal condition

To get a complete characterisation of the function $\bar{v}$, we need to add a terminal equation to 4.28). By the definition of the stochastic target problem, we have

for every $(x, i) \in \mathbb{R}^{d} \times \mathcal{I}$. The possible discontinuities of $\bar{v}$ might imply that $\bar{v}_{*}$ and $\bar{v}^{*}$ do not agree with the boundary condition (4.31). To get the proper terminal condition, we introduce the set-valued map

together with the signed distance function from its complement set $\mathbf{N}^{c}$ to the origin

where dist stands for the Euclidean distance. Then,

We give the definition of a viscosity solution to 4.33). We recall that the definitions of the envelopes $u^{*}$ and $u_{*}$ of a locally bounded function $u$ are given by 4.30).

Definition 4.2. Let $u:[0, T] \times \mathbb{R}^{d} \times \mathcal{I} \rightarrow \mathbb{R}$ be a locally bounded function.
(i) $u$ is a viscosity supersolution to (4.33) if for any $\left(x_{0}, i_{0}\right) \in \mathbb{R}^{d} \times \mathcal{I}$ and any $\varphi_{i} \in C^{2}\left(\mathbb{R}^{d}\right)$ for $i \in \mathcal{I}$ and $\bar{\varphi} \in C^{0}\left(\mathbb{R}^{d}\right)$ such that

\end{aligned}
$$

we have

\min \left\{\varphi_{i_{0}}(x)-g_{i_{0}}\left(x_{0}\right) ; \delta_{*} \varphi_{i_{0}}\left(x_{0}\right) ; \varphi_{i_{0}}\left(T, x_{0}\right)-\sup _{0 \leq k<\bar{K}} \varphi_{i_{0} k}\left(T, x_{0}\right)\right\} \geq 0 .
$$

(ii) $u$ is $a$ viscosity subrsolution solution to (4.33) if for any $\left(x_{0}, i_{0}\right) \in \mathbb{R}^{d} \times \mathcal{I}$ and any $\varphi_{i} \in C^{2}\left(\mathbb{R}^{d}\right)$ for $i \in \mathcal{I}$ and $\bar{\varphi} \in C^{0}\left(\mathbb{R}^{d}\right)$ such that

we have

\min \left\{\left(\varphi_{i_{0}}(x)-g_{i}(x)\right) \mathbb{1}_{F^{*} \varphi_{i_{0}}(x)<\infty} ; \delta^{*} \varphi_{i_{0}}(x) ; \varphi_{i_{0}}(T, x)-\sup _{0 \leq k<\bar{K}} \varphi_{i_{0} k}(T, x)\right\} \leq 0
$$

(iii) $u$ is a viscosity solution to (4.33) if it is both a viscosity sub and supersolution to (4.33).

The terminal viscosity property is stated as follows.
Theorem 4.4. Suppose that $\bar{v}$ is locally bounded on $[0, T] \times \mathbb{R}^{d} \times \mathcal{I}$.
(i) Under Assumptions A1 and A2, $\bar{v}$ is a viscosity supersolution to 4.33).
(ii) If in addition Assumption A3 holds, $\bar{v}$ is a viscosity subsolution to (4.33).

### 4.3 Viscosity properties on $[0, T) \times \mathbb{R}^{d} \times \mathcal{I}$

### 4.3.1 Viscosity supersolution property

Fix $\left(i_{0}, t_{0}, x_{0}\right) \in \mathcal{I} \times[0, T) \times \mathbb{R}^{d}$ and let $\varphi \in C^{0}\left([0, T] \times \mathbb{R}^{d}\right)$ and $\varphi_{i} \in C^{1,2}\left([0, T] \times \mathbb{R}^{d}\right)$ for $i \in \mathcal{I}$ be such that

0=\left(\bar{v}_{i_{0}, *}-\varphi_{i_{0}}\right)\left(t_{0}, x_{0}\right)=\min _{(i, t, x) \in \mathcal{I} \times[0, T] \times \mathbb{R}^{d}}\left(\bar{v}_{i, *}-\varphi_{i}\right)(t, x) . \tag{4.35}
\end{equation*}
$$

Without loss of generality we can assume this minimum to be strict in $(t, x)$ once fixed $i_{0}$.

Step 1. We first prove that $\varphi_{i_{0}}\left(t_{0}, x_{0}\right)-\sup _{0 \leq \ell \leq k-1} \varphi_{i_{0} k}\left(t_{0}, x_{0}\right) \geq 0$ for any $k$ such that $p_{k}>0$. Let $\left(t_{n}, x_{n}\right)$ be a sequence in $[0, T] \times \mathbb{R}^{d}$ such that

Set $y_{0}:=\varphi_{i_{0}}\left(t_{0}, x_{0}\right), \hat{x}_{0}:=\left(x_{0}, y_{0}\right), y_{n}:=\bar{v}_{i_{0}}\left(t_{n}, x_{n}\right)+1 / n$ and $\hat{x}_{n}:=\left(x_{n}, y_{n}\right)$. Define the stopping time $\theta_{n}=\inf \left\{s \geq t_{n}: Q^{i_{0}}\left(\left(t_{n}, s\right] \times \mathbb{N}\right) \geq 1\right\}$ and the random variable $k_{n}$ such that $Q^{i_{0}}\left(\left(t_{n}, \theta_{n}\right] \times\left\{k_{n}\right\}\right)=1$. From Theorem 3.2, the continuity of the trajectories and since $y_{n}>$ $\bar{v}_{i_{n}}\left(t_{n}, x_{n}\right)$ there exists $\alpha^{n} \in \mathcal{A}$ such that

Y_{\theta_{n}-}^{t_{n}, \delta_{\left(i_{0}, \hat{x}_{n}\right)}, \alpha^{n}, i_{0}} \geq \max _{0 \leq \ell \leq k_{n}-1} \bar{v}_{i_{0} \ell}\left(\theta_{n}, X_{\theta_{n}-}^{t_{n}, \delta_{\left(i_{0}, x_{n}\right)}, \alpha^{n}, i_{0}}\right) \geq \max _{0 \leq \ell \leq k_{n}-1} \varphi_{i_{0} \ell}\left(\theta_{n}, X_{\theta_{n}}^{t_{n}, \delta_{\left(i_{0}, x_{n}\right)}, \alpha^{n}, i_{0}}\right) .
$$

on $\left\{\theta_{n} \leq T\right\}$. To alleviate the notation, we shall denote $X_{t}^{n, i}:=X_{t}^{t_{n}, \delta_{\left(i_{0}, x_{n}\right)}, \alpha^{n}, i}$ and $Y_{t}^{n, i}:=$ $Y_{t}^{t_{n}, \delta_{\left(i_{0}, x_{n}\right)}, y_{n}, \alpha^{n}, i}$ for $n \geq 1$ and $t \in\left[t_{n}, T\right]$. Therefore, we get

$$

which means

\int_{0}^{T} \mathbb{E}\left[\mathbb{1}_{s \leq \theta_{n} \leq T} \mathbb{1}_{Y_{s}^{n, i_{0}}<\max _{0 \leq \ell \leq k-1} \varphi_{i_{0} \ell}\left(s, X_{s}^{n, i_{0}}\right)}\right] \mathrm{d} s=0
$$

for all $k \geq 1$ such that $p_{k}>0$. We therefore get

\mathbb{E}\left[\mathbb{1}_{s \leq \theta_{n} \leq T} \mathbb{1}_{Y_{s}^{n, i_{0}}<\max _{0 \leq \ell \leq k-1} \varphi_{i_{0} \ell}\left(s, X_{s}^{n, i_{0}}\right)}\right]=0 \tag{4.36}
\end{equation*}
$$

for Lebesgue almost all $s \in\left[t_{n}, T\right]$. Since the process $Y^{n, i_{0}}-\max _{0 \leq \ell \leq k-1} \varphi_{i_{0} \ell}\left(\cdot, X^{n, i_{0}}\right)$ is continuous and $\mathbb{P}\left(\theta_{n} \in\left[t_{n}, T\right]\right)>0$, Fatou's Lemma applied to a sequence $\left(s_{k}\right)_{k}$ converging to $t_{n}$ and satisfying (4.36) gives

Assume to the contrary that $\left(-\partial_{t} \varphi_{i_{0}}+F^{*} \varphi_{i_{0}}\right)\left(t_{0}, x_{0}\right)=-2 \eta$ for some $\eta>0$, and let us work towards a contradiction. By definition of $F^{*}$, we may find $\varepsilon \in\left(0, T-t_{0}\right)$, such that

where $B_{\varepsilon}\left(t_{0}, x_{0}\right)$ denotes the ball of radius $\varepsilon$ around $\left(t_{0}, x_{0}\right)$. Let $\partial_{p} B_{\varepsilon}\left(t_{0}, x_{0}\right)=\left\{t_{0}+\varepsilon\right\} \times$ $\operatorname{cl}\left(B_{\varepsilon}\left(t_{0}, x_{0}\right)\right) \cup\left[t_{0}, t_{0}+\varepsilon\right) \times \partial B_{\varepsilon}\left(x_{0}\right)$ denote the parabolic boundary of $B_{\varepsilon}\left(t_{0}, x_{0}\right)$ and observe that

From the definition of the value function and the fact that $y_{n}>\bar{v}_{i_{0}}\left(t_{n}, x_{n}\right)$ for each $n \geq 1$, there exists some $\alpha^{n}$ in $\mathcal{A}$ such that $Y_{T}^{t_{n}, \delta_{\left(i_{0}, x_{n}\right)}, y_{n}, \alpha^{n}, i} \geq g_{i}\left(X_{T}^{t_{n}, \delta_{\left(i_{0}, x_{n}\right)}, \alpha^{n}, i}\right)$ for all $i \in \mathcal{V}_{T}^{t_{n}, \delta_{\left(i_{0}, x_{n}\right)}, \alpha^{n}}$. To alleviate the notation, we shall denote

X_{t}^{n, i}:=X_{t}^{t_{n}, \delta_{\left(i_{0}, x_{n}\right)}, \alpha^{n}, i}, Y_{t}^{n, i}:=Y_{t}^{t_{n}, \delta_{\left(i_{0}, x_{n}\right)}, y_{n}, \alpha^{n}, i} \text { and } \mathcal{V}_{t}^{n}:=\mathcal{V}_{t}^{t_{n}, \delta_{\left(i_{0}, x_{n}\right)}, \alpha^{n}}
$$

for $n \geq 1$ and $t \in\left[t_{n}, T\right]$. Define the following stopping times

\tau_{n} & :=\inf \left\{s \geq t_{n}: \exists i \in \mathcal{V}_{s}^{n}, \quad\left(s, X_{s}^{n, i}\right) \notin B_{\varepsilon}\left(t_{0}, x_{0}\right)\right\} \\
\tau_{n}^{\varepsilon} & :=\inf \left\{s \geq t_{n}: \exists i \in \mathcal{V}_{s}^{n},\left|Y_{s}^{n, i}-\varphi_{i}\left(s, X_{s}^{n, i}\right)\right| \geq \varepsilon\right\} \\
\tau_{n}^{r} & :=\inf \left\{s \geq t_{n}: Q^{i_{0}}\left(\left(t_{n}, s\right] \times \mathbb{N}\right)=1\right\}, \\
\theta_{n} & :=\tau_{n} \wedge \tau_{n}^{\varepsilon} \wedge \tau_{n}^{r} .
\end{aligned}

Let $\left(x_{0}, i_{0}\right) \in \mathbb{R}^{d} \times \mathcal{I}$ and $\varphi_{i} \in C^{2}\left(\mathbb{R}^{d}\right)$ for $i \in \mathcal{I}$ satisfying

$$
0=\bar{v}_{i_{0}, *}\left(T, x_{0}\right)-\varphi_{i_{0}}\left(x_{0}\right)=\min _{\mathcal{I} \times \mathbb{R}^{d}}\left(\bar{v}_{,, *}(T, \cdot)-\varphi .\right)
$$

Without loss of generalities we can take this minimum to be strict in $x$ once fixed $i_{0}$.
Step 1. From the convention $\sup \emptyset:=-\infty$ and since $\bar{v}$ is a viscosity supersolution for (4.28) on $[0, T) \times \mathbb{R}^{d} \times \mathcal{I}$, we have

\delta^{*} \bar{v}_{\cdot, *} \geq 0 \text { on }[0, T) \times \mathbb{R}^{d} \times \mathcal{I}
$$

in the viscosity sense. From the upper-semicontinuity of $\delta^{*}$, we can then deduce by a standard argument (see e.g. proof of Lemma 5.2 in [25]) that $\delta^{*} \varphi\left(x_{0}\right) \geq 0$.

Step 2. We now prove

From the definition of $\bar{v}_{*}$, there exists a sequence $\left(s_{n}, \xi_{n}\right)_{n \geq 1}$ converging to ( $T, x_{0}$ ) such that $s_{n}<T$ for $n \geq 1$ and

\lim _{n \rightarrow \infty} \bar{v}_{i_{0}, *}\left(s_{n}, \xi_{n}\right)=\bar{v}_{i_{0}, *}\left(T, x_{0}\right)
$$

For $n \geq 1$, consider the auxiliary test function

$$
\varphi_{n, i}(t, x):=\varphi_{i}(x)-\frac{1}{2}\left|x-x_{0}\right|^{2}+\frac{T-t}{\left(T-s_{n}\right)^{2}} \quad(t, x, i) \in[0, T] \times \mathbb{R}^{d} \times \mathcal{I}
$$

Let $B_{1}\left(x_{0}\right)$ be the unit open ball in $\mathbb{R}^{d}$ centered at $x_{0}$. Choose $\left(t_{n}, x_{n}\right) \in\left[s_{n}, T\right] \times \bar{B}_{1}\left(x_{0}\right)$, which minimizes the difference $\bar{v}_{i_{0}, *}-\varphi_{n, i_{0}}$ on $\left[s_{n}, T\right] \times \bar{B}_{1}\left(x_{0}\right)$.

We claim that, for $n$ large enough $t_{n}<T$, and $x_{n}$ converges to $x_{0}$. Indeed, for sufficiently large $n$ we have

$$
\left(\bar{v}_{i_{0}, *}-\varphi_{n, i_{0}}\right)\left(s_{n}, x_{0}\right) \leq-\frac{1}{\left(T-s_{n}\right)}<0
$$

On the other hand, for any $x \in \bar{B}_{1}\left(x_{0}\right)$

$$
\left(\bar{v}_{i_{0}, *}-\varphi_{n, i_{0}}\right)(T, x)=\bar{v}_{i_{0, *}}(T, x)-\varphi_{i_{0}}(x)+\frac{1}{2}\left|x-x_{0}\right|^{2} \geq \bar{v}_{i_{0}, *}(T, x)-\varphi_{i_{0}}(x) \geq 0 .
$$

Comparing the two inequalities leads us to conclude that $t_{n}<T$ for large $n$. Let $x^{*}$ be an adherence value of the sequence $\left(x_{n}\right)_{n \geq 1}$. Since $t_{n} \geq s_{n}$ and $\left(t_{n}, x_{n}\right)$ minimizes the difference ( $\bar{v}_{i_{0}, *}-\varphi_{n, i_{0}}$ ), we have

\left(\bar{v}_{i_{0}, *}(T, .)-\varphi_{i_{0}}\right)\left(x^{*}\right)-\left(\bar{v}_{i_{0}, *}(T, .)-\varphi_{i_{0}}\right)\left(x_{0}\right) & \leq \\
\liminf _{n \rightarrow \infty}\left(\bar{v}_{i_{0}, *}-\varphi_{n, i_{0}}\right)\left(t_{n}, x_{n}\right)-\left(\bar{v}_{i_{0}, *}-\varphi_{n, i_{0}}\right)\left(s_{n}, \xi_{n}\right)-\frac{1}{2}\left|x_{n}-x_{0}\right|^{2} & \leq \\
\limsup _{n \rightarrow \infty}\left(\bar{v}_{i_{0}, *}-\varphi_{n, i_{0}}\right)\left(t_{n}, x_{n}\right)-\left(\bar{v}_{i_{0}, *}-\varphi_{n, i_{0}}\right)\left(s_{n}, \xi_{n}\right)-\frac{1}{2}\left|x_{n}-x_{0}\right|^{2} & \leq \\
-\frac{1}{2}\left|x^{*}-x_{0}\right|^{2} &
\end{aligned}
$$

Since $x_{0}$ minimizes the difference $\bar{v}_{i_{0}, *}(T, \cdot)-\varphi_{i_{0}}$ we have

$$
0 \leq\left(\bar{v}_{i_{0}, *}(T, \cdot)-\varphi_{i_{0}}\right)\left(x^{*}\right)-\left(\bar{v}_{i_{0}, *}(T, \cdot)-\varphi_{i_{0}}\right)\left(x_{0}\right) \leq-\frac{1}{2}\left|x^{*}-x_{0}\right|^{2} .
$$

Hence $x^{*}=x_{0}$ and $\left(x_{n}\right)_{n \geq 1}$ converges to $x_{0}$.
We now use the viscosity supersolution property of $\bar{v}$ on $[0, T) \times \mathbb{R}^{d} \times \mathcal{I}$ with the test function $\tilde{\varphi}_{n}=\varphi_{n}+\bar{v}_{*, i_{0}}\left(t_{n}, x_{n}\right)-\varphi_{n, i_{0}}\left(t_{n}, x_{n}\right)$ and we have

$$
\begin{equation*}
\tilde{\varphi}_{n, i_{0}}\left(t_{n}, x_{n}\right)-\sup _{0 \leq k<\bar{K}} \tilde{\varphi}_{n, i_{0} k}\left(t_{n}, x_{n}\right) \geq 0 \tag{4.53}
\end{equation*}
$$

for all $n \geq 1$. We clearly have

$$
\varphi_{i_{0}}\left(x_{n}\right)-\sup _{0 \leq k<\bar{K}} \varphi_{i_{0} k}\left(x_{n}\right)=\tilde{\varphi}_{n, i_{0}}\left(t_{n}, x_{n}\right)-\sup _{0 \leq k<\bar{K}} \tilde{\varphi}_{n, i_{0} k}\left(t_{n}, x_{n}\right) .
$$

Since $x_{n}$ converges to $x_{0}$, we get by sending $n$ to infinity that $\varphi_{i_{0}}\left(x_{0}\right)-\sup _{0 \leq k<\bar{K}} \varphi_{i_{0} k}\left(x_{0}\right) \geq 0$.
Step 3. We now prove the last assertion. Assume that

$$
F^{*} \varphi_{i_{0}}\left(x_{0}\right)<\infty \text { and } \varphi_{i_{0}}\left(x_{0}\right)=\bar{v}_{i_{0}, *}\left(T, x_{0}\right)<g_{i_{0}}
$$

and let us work towards a contradiction. Since $\bar{v} \cdot(T, \cdot)=g$. by the definition of the problem, there is a constant $\eta>0$ such that

$$
\varphi_{i_{0}}-\bar{v}_{i_{0}}(T, \cdot)=\varphi_{i_{0}}-g_{i_{0}} \leq-\eta \text { on } B_{\varepsilon}\left(x_{0}\right)
$$

for some $\varepsilon>0$. Since $x_{0}$ is a strict minimizer, let $\zeta$ be

2 \zeta=\min _{x \in \partial B_{\varepsilon}\left(x_{0}\right)} \bar{v}_{i_{0}, *}(T, x)-\varphi_{i_{0}}(x)>0 .
$$

It follows that there exists $r>0$ such that $\bar{v}_{i_{0}}(t, x)-\varphi_{i_{0}}(x) \geq \zeta>0$ for all $(t, x) \in[T-r, T] \times$ $\partial B_{\varepsilon}\left(x_{0}\right)$. This holds, otherwise, for each $r>0$, we could find $\left(t_{r}, x_{r}\right) \in[T-r, T] \times \partial B_{\varepsilon}\left(x_{0}\right)$ such that $\bar{v}_{i_{0}}\left(t_{r}, x_{r}\right)-\varphi_{i_{0}}\left(x_{r}\right) \leq \zeta$. Sending $r$ to 0 , since $\partial B_{\varepsilon}\left(x_{0}\right)$ is compact, up to a subsequence we would have $\bar{v}_{i_{0}, *}\left(T, x^{*}\right)-\varphi_{i_{0}}\left(x^{*}\right) \leq \zeta$ for some $x^{*} \in \partial B_{\varepsilon}\left(x_{0}\right)$, in contradiction with the definition of $\zeta$.

Therefore, we have

\bar{v}_{i_{0}}(t, x)-\varphi_{i_{0}}(x) \geq \zeta \wedge \eta>0 \text { for }(t, x) \in\left([T-r, T] \times \partial B_{\varepsilon}\left(x_{0}\right)\right) \cup\left(\{T\} \times B_{\varepsilon}\left(x_{0}\right)\right) .

Since $F^{*} \varphi_{i_{0}}\left(x_{0}\right)<\infty$, up to smaller $\varepsilon>0$, we have

\lambda_{Y}(x, y, a)-L^{a} \varphi_{i_{0}}(x) \leq C \quad \text { for all } a \in \mathcal{N}_{\varepsilon}\left(x, D \varphi_{i_{0}}(x)\right)
$$

$$
\text { and }(x, y) \in \mathbb{R}^{d} \times \mathbb{R} \text { such that } x \in B_{\varepsilon}\left(x_{0}\right) \text { and }\left|y-\varphi_{i_{0}}(x)\right| \leq \varepsilon .
$$

for some constant $C>0$. Let $\tilde{\varphi}_{i}(t, x):=\varphi_{i}(x)+2 C(t-T)$. Then, for sufficiently small $r>0$,

$$
\bar{v}_{i_{0}}(t, x)-\tilde{\varphi}_{i_{0}}(t, x) \geq \frac{1}{2}(\zeta \wedge \eta)>0
$$

for $(t, x) \in\left([T-r, T] \times \partial B_{\varepsilon}\left(x_{0}\right)\right) \cup\left(\{T\} \times B_{\varepsilon}\left(x_{0}\right)\right)$, and

$$
-\partial_{t} \tilde{\varphi}_{i_{0}}(t, x)+\lambda_{Y}(x, y, a)-L^{a} \tilde{\varphi}_{i_{0}}(t, x) \leq-C
$$

for all $a \in \mathcal{N}_{\varepsilon}\left(x, D \tilde{\varphi}_{i_{0}}(t, x)\right)$ and $(x, y) \in \mathbb{R}^{d} \times \mathbb{R}$ such that $x \in B_{\varepsilon}\left(x_{0}\right)$ and $\left|y-\tilde{\varphi}_{i_{0}}(t, x)\right| \leq \varepsilon$. By following the same arguments as in Step 3 of Section 4.3.1, the latter inequalities lead to a contradiction of (3.25).

### 4.4.2 Viscosity subsolution

Let $\left(x_{0}, i_{0}\right) \in \mathbb{R}^{d} \times \mathcal{I}$ and $\varphi_{i} \in C^{2}\left(\mathbb{R}^{d}\right)$ for $i \in \mathcal{I}$ satisfying

0=\bar{v}_{i_{0}}^{*}\left(T, x_{0}\right)-\varphi_{i_{0}}\left(x_{0}\right)=\max _{\mathcal{I} \times \mathbb{R}^{d}}\left(\bar{v}_{.}^{*}(T, \cdot)-\varphi\right) .
$$

Without loss of generalities we can take this maximum to be strict in $x$ once have fixed $i_{0}$. We argue by contradiction and assume $\delta_{*} \varphi_{i_{0}}\left(x_{0}\right)>0$ and

$$
\begin{equation*}
4 \eta=\min \left\{\varphi_{i_{0}}\left(x_{0}\right)-g_{i_{0}}\left(x_{0}\right) ;\left(\varphi_{i_{0}}-\sup _{0 \leq k<\bar{K}} \varphi_{i_{0} k}\right)\left(x_{0}\right)\right\}>0 \tag{4.54}
\end{equation*}
$$

Step 1. By 4.32 and Assumption A3, we can find $r>0$ and a locally Lipschitz map $\hat{a}$ satisfying

$$
\begin{equation*}
\hat{a}\left(x, D \varphi_{i_{0}}(x)\right) \in \mathcal{N}_{0}\left(x, D \varphi_{i_{0}}(x)\right) \tag{4.55}
\end{equation*}
$$

for all $x \in B_{r}\left(x_{0}\right)$. Set $\tilde{\varphi}_{i}(t, x):=\varphi_{i}(x)+\sqrt{T-t}$. Since $\partial \tilde{\varphi}_{i}(t, x) \rightarrow-\infty$ as $t \rightarrow T$, we deduce that, for $r, \varepsilon>0$ small enough,

$$
\begin{equation*}
\rho(t, x, y)=-\partial \tilde{\varphi}_{i_{0}}(t, x)+\lambda_{Y}\left(x, y, \hat{a}\left(x, D \tilde{\varphi}_{i_{0}}(t, x)\right)\right)-L^{\hat{a}\left(x, D \tilde{\varphi}_{i_{0}}(t, x)\right)} \tilde{\varphi}_{i_{0}}(t, x) \geq \eta \tag{4.56}
\end{equation*}
$$

for all $(t, x, y) \in[T-r, T) \times \mathbb{R}^{d} \times \mathbb{R}$ such that $x \in B_{r}\left(x_{0}\right)$ and $\left|y-\tilde{\varphi}_{i_{0}}(t, x)\right| \leq \varepsilon$. We can also notice that

$$
\left(\tilde{\varphi}_{i_{0}}-\sup _{0 \leq k<\bar{K}} \tilde{\varphi}_{i_{0} k}\right)\left(t, x_{0}\right)=\left(\varphi_{i_{0}}-\sup _{0 \leq k<\bar{K}} \varphi_{i_{0} k}\right)\left(x_{0}\right)
$$

Therefore, we get from 4.54

$$
\begin{equation*}
\left(\tilde{\varphi}_{i_{0}}-\sup _{0 \leq k<\bar{K}} \tilde{\varphi}_{i_{0} k}\right)(t, x) \geq \eta, \text { for all }(t, x) \in[T-r, T] \times B_{r}\left(x_{0}\right) \tag{4.57}
\end{equation*}
$$

for $r>0$ small enough.
Also observe that, since $\bar{v}_{i_{0}}^{*}-\tilde{\varphi}_{i_{0}}$ is upper-semicontinuous and $\left(\bar{v}_{i_{0}}^{*}-\tilde{\varphi}_{i_{0}}\right)\left(T, x_{0}\right)=0$, we have

$$
\begin{equation*}
\bar{v}_{i_{0}}^{*}(t, x) \leq \tilde{\varphi}_{i_{0}}(t, x)+\varepsilon / 2 \text { for all }(t, x) \in[T-r, T] \times B_{r}\left(x_{0}\right) . \tag{4.58}
\end{equation*}
$$

for $r>0$ small enough. Since $\bar{v} .(T, \cdot)=g$., we have for $r$ small enough

$$
\tilde{\varphi}_{i_{0}}-\bar{v}_{i_{0}}(T, \cdot)=\tilde{\varphi}_{i_{0}}-g_{i_{0}} \geq \eta \quad \text { on } B_{r}\left(x_{0}\right) .
$$

Since $x_{0}$ is a strict maximizer for $v_{i_{0}, *}(T, \cdot)-\varphi_{i_{0}}$, we can define $\zeta>0$ such that

$$
-2 \zeta=\max _{x \in \partial B_{r}\left(x_{0}\right)} \bar{v}_{i_{0}}^{*}(T, x)-\varphi_{i_{0}}(x)<0 .
$$

for $r>0$ small enough. It follows that, for $r>0$ small enough, $\bar{v}_{i_{0}}(t, x)-\tilde{\varphi}_{i_{0}}(x) \leq-\zeta<0$ for all $(t, x) \in[T-r, T] \times \partial B_{r}\left(x_{0}\right)$. This means

\begin{equation*}
\bar{v}_{i_{0}}(t, x)-\tilde{\varphi}_{i_{0}}(x) \leq-\zeta \wedge \eta \text { for all }(t, x) \in\left(\left[T-r^{\prime}, T\right] \times \partial B_{r}\left(x_{0}\right)\right) \cup\left(\{T\} \times B_{r}\left(x_{0}\right)\right) . \tag{4.59}
\end{equation*}
$$

By following the arguments in Step 2 of Section 4.3.2, we see that 4.55, 4.56), 4.57, 4.58, (4.59), lead to a contradiction of (3.25).

### 4.5 Uniqueness

We turn to the uniqueness of solution to the dynamic programming equation (4.28)-(4.33). To this end, we need to introduce additional assumptions. We first recall that the Hausdorff distance $d_{\mathcal{H}}$ on closed subsets of $A$ is defined by

d_{\mathcal{H}}(B, C)=\min \left\{r \geq 0: B \subset C_{r} \text { and } C \subset B_{r}\right\}
$$

for $B, C \subset A$ closed and nonempty, with

$$
\begin{equation*}
D_{r}=\left\{a \in A: \exists a^{\prime} \in D, d_{A}\left(a, a^{\prime}\right) \leq r\right\} \tag{4.60}
\end{equation*}
$$

for any $D \subset A$ and any $r \geq 0$. We use the convention

$$
d_{\mathcal{H}}(B, C)=+\infty
$$

if $B=\emptyset$ or $C=\emptyset$.
Assumption A4. (i) The the functions $\lambda$ and $\sigma$ do not depend on the control, i.e. $\lambda: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ and $\sigma: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d \times m}$.
(ii) There exist two constants $C>0$ and $\eta \in(0,1]$ such that the function $w$ appearing in Assumption $A 1$ (iii) satisfies $w(x) \leq C x^{\eta}$ for $x \in \mathbb{R}_{+}$.
(iii) There exists a constant $C>0$ such that

$$
d_{\mathcal{H}}\left(\mathcal{N}_{\varepsilon}(x, p), \mathcal{N}_{\varepsilon^{\prime}}\left(x^{\prime}, p^{\prime}\right)\right) \leq C\left(\left|p-p^{\prime}\right|+\varepsilon+\varepsilon^{\prime}\right)(1+|x|)+C\left|x-x^{\prime}\right|
$$

for all $\varepsilon, \varepsilon^{\prime} \geq 0, x, x^{\prime}, p, p^{\prime} \in \mathbb{R}^{d}$.
(iv) $\mathcal{N}_{0}(0,0) \neq \emptyset$.

Remark 4.3. Since we use the convention 4.60), the combination of (iii) and (iv) implies that $\mathcal{N}_{\varepsilon}(x, p) \neq \emptyset$ for any $(\varepsilon, x, p) \in \mathbb{R}_{+} \times \mathbb{R}^{d} \times \mathbb{R}^{d}$.

In particular we always have that $\delta \varphi \geq 0$ for any $\varphi \in C^{2}\left(\mathbb{R}^{d}\right)$. Therefore, the terminal viscosity supersolution solution property takes the following form

$$
\begin{equation*}
\min \left\{\varphi_{i}(x)-g_{i}(x) ;\left(\varphi_{i}-\sup _{0 \leq k<\bar{K}} \varphi_{i k}\right)(x)\right\} \geq 0 \tag{4.61}
\end{equation*}
$$

for $(x, i) \in \mathbb{R}^{d} \times \mathcal{I}$ and $\left(\varphi_{j}\right)_{j \in \mathcal{I}}$ a test function according to Definition 4.2 (i).
Lemma 4.2. let $u:[0, T] \times \mathbb{R}^{d} \times \mathcal{I}$ be a lower semi-continuous supersolution of (4.28)-(4.61). Define the function $\Lambda:[0, T] \times \mathbb{R}^{d} \rightarrow \mathbb{R}$ by

$$
\Lambda(t, x)=\theta e^{-\kappa t}\left(1+|x|^{2 \gamma+2}\right), \quad(t, x) \in[0, T] \times \mathbb{R}^{d}
$$

with $\theta, \kappa, \gamma \in \mathbb{R}_{+}$. Then, under Assumptions A1 and A4, for any $\gamma \geq 0$ there exists $\kappa_{0}>0$ such that for any $\kappa \geq \kappa_{0}$ and $\theta>0$, the function $u+\Lambda$ is a supersolution to (4.28)-(4.33).

Proof. Let $\varphi_{j} \in C^{1,2}\left([0, T] \times \mathbb{R}^{d}\right)$ for $j \in \mathcal{I}$ be such that the function $\varphi$. $-(u+\Lambda)$ has a local maximum in $(t, x, i)$ which is equal to 0 and $\bar{\varphi} \in C^{0}\left([0, T] \times \mathbb{R}^{d}\right)$ such that $\sup _{j \in \mathcal{I}}\left|\varphi_{j}\right| \leq \bar{\varphi}$. Since $u$ is a supersolution for 4.28), we have

$$
\min \left\{-\partial_{t}\left(\varphi_{i}-\Lambda\right)(t, x)+F^{*}\left(\varphi_{i}-\Lambda\right)(t, x) ;\left(\left(\varphi_{i}-\Lambda\right)-\sup _{0 \leq k<\bar{K}}\left(\varphi_{i k}-\Lambda\right)\right)(t, x)\right\} \geq 0
$$

We then have

$$
\begin{equation*}
\left(\varphi_{i}-\sup _{0 \leq k<\bar{K}} \varphi_{i k}\right)(t, x)=\left(\left(\varphi_{i}-\Lambda\right)-\sup _{0 \leq k<\bar{K}}\left(\varphi_{i k}-\Lambda\right)\right)(t, x) \geq 0 \tag{4.62}
\end{equation*}
$$

We now prove that

$$
-\partial_{t} \varphi_{i}(t, x)+F^{*} \varphi_{i}(t, x) \geq 0
$$

If $F^{*} \varphi_{i}(t, x)=+\infty$, then the inequality is obvious. Suppose that $F^{*} \varphi_{i}(t, x)<+\infty$. From Assumption A4, we get that $F^{*}$ is locally bounded. Since $u$ is a viscosity supersolution to 4.28, we have

-\partial_{t}\left(\varphi_{i}-\Lambda\right)(t, x)+F^{*}\left(\varphi_{i}-\Lambda\right)(t, x) \geq 0
$$

Using the definition of $\Lambda$ and $F$, Assumption A4 and the continuity of the functions considered, we get

\begin{align*}
& -\partial_{t} \varphi_{i}(t, x)-\theta \kappa e^{-\kappa t}\left(1+|x|^{2 \gamma+2}\right) \\
& +\lim _{\varepsilon \rightarrow 0} \sup _{\substack{|x\\
|\left(\varphi_{i}-\Lambda\right)|\leq \varepsilon\\
| D\left(\varphi_{i}-\Lambda\right)(x)(t, x)-y^{\prime}|\leq \varepsilon| \leq \varepsilon}} \sup _{a \in \mathcal{N}_{\varepsilon}\left(x^{\prime}, p\right)}\left\{\lambda_{Y}\left(x^{\prime}, y^{\prime}, a\right)\right\} \\
& -\lambda(x)^{\top} D \varphi_{i}(t, x)+\theta e^{-\kappa t} \lambda(x)^{\top} D|x|^{2 \gamma+2} \\
& -\frac{1}{2} \operatorname{Tr}\left(\sigma \sigma^{\top}(x) D^{2} \varphi_{i}(t, x)\right)+\theta e^{-\kappa t} \frac{1}{2} \operatorname{Tr}\left(\sigma \sigma^{\top}(x) D^{2}|x|^{2 \gamma+2}\right) \geq 0 . \tag{4.63}
\end{align*}
$$

with $A_{n}^{\prime}$ such that $\lim \sup _{n \rightarrow \infty} \frac{1}{\left|x_{n}-x_{0}\right|^{2}}\left|A_{n}^{\prime}\right|<+\infty$. From the viscosity supersolution property of $\tilde{w}_{i_{0}}$ to 4.67), we have

= & p_{\tilde{u}}^{n}-p_{\tilde{u}}^{n}+\Delta C_{n}^{1}+\Delta C_{n}^{2}+\Delta C_{n}^{3} \tag{4.83}

From (4.75), we have $p_{\tilde{u}}^{n}-p_{\tilde{u}}^{n} \rightarrow 0$ as $n \rightarrow 0$. From the Lipschitz continuity of $\lambda$ and (4.76), we have $\Delta C^{2} \rightarrow 0$ as $n \rightarrow 0$. From (4.82, 4.75, 4.76), and the Lipschitz property of $\sigma$, we also have $\Delta C^{3} \rightarrow 0$ as $n \rightarrow 0$. Following the same argument as in the proof of lemma 4.2, we get from Assumptions A 1 and A 4 and (4.75) $\Delta C_{n}^{1} \rightarrow 0$ as $n \rightarrow \infty$.

Therefore, by sending $n \rightarrow \infty$ into (4.83), we conclude with 4.77) that $\eta\left(\tilde{u}_{i_{0}}\left(t_{0}, x_{0}\right)-\tilde{w}_{i_{0}}\left(t_{0}, y_{0}\right)\right) \leq$ 0 , a contradiction with 4.74.

From Theorems 4.3, 4.4 and 4.5, we get the following characterisation of the function $\bar{v}$.

\end{equation*}
$$

Under Assumptions A1 A2 A3 A4, $\bar{v}$ is the unique viscosity solution to (4.28)-(4.61) satisfying (4.84)-(4.85). Moreover, $\bar{v}$ is continuous on $[0, T) \times \mathbb{R}^{d} \times \mathcal{I}$.

We recall that Section 2.3 provides an example of a value function satisfying conditions 4.28)(4.61).

## A Appendix

## A. 1 Set of atomic finite measures

Proposition A.6. For $\ell \geq 1, E_{\ell}$ is a closed subset of $\mathcal{M}_{F}\left(\mathcal{I} \times \mathbb{R}^{\ell}\right)$ for the topology of the weak convergence of measures.

Proof. Let $\left(\mu_{n}\right)_{n \in \mathbb{N}}$ be a sequence of $E_{\ell}$ such that $\mu_{n}=\sum_{i \in V_{n}} \delta_{\left(i, x_{n}^{i}\right)} \xrightarrow{w} \mu \in \mathcal{M}_{F}\left(\mathcal{I} \times \mathbb{R}^{\ell}\right)$. We prove that $\mu$ is an element of $E_{\ell}$, i.e. it can be written as $\mu=\sum_{i \in V} \delta_{\left(i, x^{i}\right)}$ for some set $V \subseteq \mathcal{I}$, $|V|<\infty$ and some points $\left(x_{i}\right)_{i \in V}$.

Consider the continuous functions $\mathbb{1}_{\{i\} \times \mathbb{R}^{\ell}}$ for $i \in \mathcal{I}$. We then have

\left\langle\mu_{n}, \mathbb{1}_{\{i\} \times \mathbb{R}^{\ell}}\right\rangle= \begin{cases}1 & \text { if } i \in V_{n} \\ 0 & \text { if } i \notin V_{n}\end{cases}

For each $i \in \mathcal{I}$, we have that the sequence $\left(\left\langle\mu_{n}, \mathbb{1}_{\left.\{i\} \times \mathbb{R}^{\ell}\right\rangle}\right\rangle\right)_{n}$ is a convergent sequence in $\{0,1\}$, which is in particular stationary. Let $V$ be defined as follow:

Let $i \in V$. Since the functions previously described converge, they are constant from a certain rank and there exists $n_{i} \in \mathbb{N}$ such that for $n \geq n_{i}$ we have $i \in V_{n}$. For $f \in C\left(\mathbb{R}^{\ell}\right)$ and consider the function $\mathbb{1}_{\{i\}} \otimes f: \mathcal{I} \times \mathbb{R}^{\ell} \rightarrow \mathbb{R}$. We have:

This means that for each $i \in V$ and $f \in C\left(\mathbb{R}^{\ell}\right)$ the sequence $\left(f\left(x_{n}^{i}\right)\right)_{n}$ converges, therefore $\left(x_{n}^{i}\right)_{n}$ converges to a point $x^{i} \in \mathbb{R}^{\ell}$.

We then notice that any continuous and bounded function $f$ on $\mathcal{I} \times \mathbb{R}^{\ell}$ is of the form $f=\sum_{i \in \mathcal{I}} f_{i}$ with $f_{i}$ is continuous and bounded on $\mathbb{R}^{\ell}$. In particular, we get

for $n$ large enough, and

so we have $\mu=\sum_{i \in V} \delta_{\left(i, x^{i}\right)}$.
To finally prove that $\mu \in E_{\ell}$ we need to show that there do not exist $i, j \in V$ such that $i \prec j$. Fix $i, j \in V$. From the previous steps, there exists some n such that $i, j \in V_{n}$. Since $\mu_{n} \in E_{\ell}$, we get $i \nprec j$ and $j \nprec i$. Therefore, we have $\mu \in E_{\ell}$.

## A. 2 Branching martingale controlled problem

We first set our controlled martingale problem. We define the set $\tilde{E}_{m+1}$ as the set of finite measure $\mu$ on $\mathcal{I} \times \mathbb{N} \times \mathbb{R}^{m+1}$ of the form

We denote by $\mathbf{x}$ the canonical process and by $\mathbb{G}=\left(\mathcal{G}_{t}\right)_{t \in[0, T]}$ the canonical filtration on $\mathbf{X}$.

For $\bar{x}=\left(\sum_{i \in \mathcal{V}_{s}} \delta_{\left(i, \hat{x}_{s}^{i}\right)}, \sum_{i \in \mathcal{I}, n \in \mathbb{N}} \frac{1}{2^{2(|i|+n)}} \delta_{\left(i, n, b_{s}^{i}, q_{s}^{, n}\right)}\right)_{s \in[0, T]} \in \mathbf{X}$, we write

\end{equation*}

We also define ${ }^{1} \mathbf{x}$ and ${ }^{2} \mathbf{x}$ the first and second component of the canonical process.

For a given control $\alpha \in \mathcal{A}$, let $\bar{L}^{\alpha}$ be the following second order local operator

Definition A. 4 (Shifted martingale problem). Consider the initial condition $(t, \bar{x}) \in[0, T] \times \mathbf{X}$, and a control $\alpha \in \mathcal{A}$. A probability measure $\overline{\mathbb{P}}, \bar{x}, \alpha$ is a solution to the shifted controlled martingale problem if the process $\bar{M}^{t, \alpha, F_{f, g}}$ is a $\mathbb{G}$-martingale under $\overline{\mathbb{P}}^{t, \bar{x}, \alpha}$ for any $f \in C_{c}^{1,2}\left([0, T] \times \mathcal{I} \times \mathbb{R}^{d+1}\right)$, $g \in C_{c}^{1,2}\left([0, T] \times \mathcal{I} \times \mathbb{R}^{m+1}\right)$, and any $F \in C_{c}^{2}(\mathbb{R})$, and $\overline{\mathbb{P}}^{t, \bar{x}, \alpha}\left(\mathbf{x}_{s}=\bar{x}_{s}\right.$ for $\left.s \in[0, t]\right)=1$.

We then define $\bar{\tau}: \mathbf{X} \rightarrow \mathbb{R}_{+}$by $\bar{\tau}=\tilde{\tau} \circ{ }^{2} \mathbf{x}$ where we recall that ${ }^{1} \mathbf{x}$ and ${ }^{2} \mathbf{x}$ are given by A.86). We observe that $\bar{\tau}$ is a $\mathbb{G}$-stopping time and $g_{Y} \circ{ }^{2} \mathbf{x}$ is $\mathcal{G}_{\bar{\tau}}$-measurable. We therefore have from (A.89)

$$
\begin{aligned}
& \mathbb{E}\left[f\left(\hat{Z}^{t, \hat{\mu}, \alpha}\right) Y\right]=\mathbb{E}^{\overline{\mathbb{P}}^{t},^{1}, \alpha}\left[f\left({ }^{1} \mathbf{x}\right) g_{Y}\left({ }^{2} \mathbf{x}\right)\right] \\
& =\int_{\mathbf{X}} \mathbb{E}^{\overline{\mathrm{P}}^{t^{\prime} \bar{x}^{\prime}}{ }^{1, \bar{x}, \alpha}}\left[f\left({ }^{1} \mathbf{x}\right)\right] g_{Y}\left({ }^{2} \mathbf{x}\left(\bar{x}^{\prime}\right)\right) d \overline{\mathbb{P}}^{t,{ }^{1} \bar{x}, \alpha}\left(\bar{x}^{\prime}\right) .
\end{aligned}
$$

where $\left(\overline{\mathbb{P}}_{\bar{x}}^{t, \bar{x}, \alpha}, \bar{x}^{\prime} \in \mathbf{X}\right)$ stands for a regular conditional probability distribution of $\overline{\mathbb{P}}^{t, \bar{x}, \alpha}$ given $\mathcal{G}_{\bar{\tau}}$. Using Theorem A. 6 we finally get

$$
\begin{aligned}
\mathbb{E}\left[f\left(\hat{Z}^{t, \hat{\mu}, \alpha}\right) Y\right] & =\int_{\mathbf{X}} \mathbb{E}^{\mathbb{P}^{\bar{\tau}\left(\bar{x}^{\prime}\right), \bar{x}^{\prime}, \alpha^{\bar{\tau}\left(\bar{x}^{\prime}\right),,^{\prime} \bar{x}^{\prime}}}\left[f\left({ }^{1} \mathbf{x}\right)\right] g_{Y}\left({ }^{2} \mathbf{x}\left(\bar{x}^{\prime}\right)\right) d \overline{\mathbb{P}}^{t, 1}, \bar{x}, \alpha}\left(\bar{x}^{\prime}\right) \\
& =\int_{\mathbf{X}} F\left(\bar{\tau}\left(\bar{x}^{\prime}\right), \bar{x}^{\prime}, \alpha^{\bar{\tau}\left(\bar{x}^{\prime}\right), \bar{x}^{\prime}}\right) g_{Y}\left({ }^{2} \mathbf{x}\left(\bar{x}^{\prime}\right)\right) d \overline{\mathbb{P}}^{t, \bar{x}^{1}, \alpha}\left(\bar{x}^{\prime}\right)
\end{aligned}
$$

Then, using (A.90), we get

$$
\mathbb{E}\left[f\left(\hat{Z}^{t, \hat{\mu}, \alpha}\right) Y\right]=\int_{\Omega} F\left(\tau(\omega), \hat{Z}_{. \wedge \tau}^{t, \hat{\mu}, \alpha}(\omega), \alpha^{\tau(\omega), \omega}\right) Y(\omega) d \mathbb{P}(\omega) .
$$
