# PONTRYAGIN PRINCIPLE AND ENVELOPE THEOREM

#### Abstract

We provide an improvement of the maximum principle of Pontryagin of the Optimal Control problems. We establish differentiability properties of the value function of problems of Optimal Control with assumptions as low as possible. Notably, we lighten the assumptions by using Gâteaux and Hadamard differentials.

## 1. Introduction

The paper provides envelope theorems for parameterized problems of Optimal Control (problem of Bolza) as

$$

For all parameter $\pi, V[\pi]$ is the value of the problem of $(\mathcal{B}, \pi)$.
We establish properties of the value function $[\pi \mapsto V[\pi]]$ in terms of Gâteaux variation, Gâteaux differentiability and Fréchet continuous differentiability.
We try to establish such results using assumptions as low as possible.
Envelope theorems for static optimization and Calculus of Variations in 4] where references on economic motivations are cited.
To realize that we start by establishing new Pontryagin principles for the problems of Bolza and Mayer without parameter which improve the results of [3] by lightening the assumptions. Moreover, we provide new qualification conditions which are very useful to treat the question of the envelope theorems.
Notice that we provide conditions on the Gâteaux differentials to obtain conditions of Lipschitz, we provide a new result on the differentiability of nonlinear functionals. Moreover, we don't do assumptions on the regularity of the multipliers and the adjoint function with respect to the parameter (as it is often the case in the literature).
We summarize the content of this paper as follows.
In Section 2, we establish the Pontryagin principles for the Optimal Control. In a first subsection, we state the Pontryagin principle for the problem of Bolza, and we

[^0]provide new qualification conditions. In a second subsection, we state the Pontryagin principle for the problem of Mayer, and we give qualification conditions. In a third subsection, we prove the results on the problem of Mayer; in order to do that we use a new multiplier rules which is an improvement of a multiplier rules in [2]. In the last subsection, in order to prove the Pontryagin principle of the problem of Bolza, we transform the problem of Bolza into a problem of Mayer.
In Section 3, we establish envelope theorems for parameterized problems of Optimal Control. In a first subsection, we state envelope theorems. In a second subsection, we prove the first envelope theorem; in order to do that we provide new results on the differentiability of nonlinear integral functionals and we use the new Pontryagin principles and qualification conditions for the problems of Bolza without parameter. In a third subsection, by using the first envelope theorem, we prove that the value function is Gâteaux differentiable at a point. In the last subsection, we prove the last envelope theorem by using the second envelope theorem.

## 2. Statements of the Pontryagin Principles

2.1. Pontryagin principle for the problem of Bolza. $E$ is a real Banach space, $\Omega$ is a non-empty subset of $E, U$ is a Hausdorff topological space, $f:[0, T] \times \Omega \times U \rightarrow$ $E, f^{0}:[0, T] \times \Omega \times U \rightarrow \mathbb{R}, g^{\alpha}: \Omega \rightarrow \mathbb{R}(0 \leq \alpha \leq m)$ and $h^{\beta}: \Omega \rightarrow \mathbb{R}(1 \leq \beta \leq q)$ are functions when $(m, q) \in \mathbb{N}_{*} \times \mathbb{N}_{*}$ where $\mathbb{N}_{*}=\mathbb{N} \backslash\{0\}$.
When $X$ is a Hausdorff topological space, $P C^{0}([0, T], X)$ denotes the space of the piecewise continuous functions from $[0, T]$ into $X$.
As in [3], we specify that $x \in P C^{0}([0, T], X)$ when $x$ is continuous on $[0, T]$ or when there exists a subdivision of $[0, T], 0=\tau_{0}<\tau_{1}<\ldots<\tau_{k}<\tau_{k+1}=T$ such that $x$ is continuous at $t$ when $t \notin\left\{\tau_{i}: 0 \leq i \leq k+1\right\}$ and the right-hand limit $x\left(\tau_{i}+\right)$ exists in $X$ and when $i \in\{0, \ldots, k\}$ and the left hand limit $x\left(\tau_{i}-\right)$ exists in $X$ when $i \in\{1, \ldots, k+1\}$.
We define $N P C_{R}^{0}([0, T], X)$ as the set of the $x \in P C^{0}([0, T], X)$ which are rightcontinuous on $\left[0, T\right.$ [ and left-continuous at $T$. An element of $N P C_{R}^{0}([0, T], X)$ is called a normalized piecewise continuous function, cf. 33.
When $X$ is a real normed vector space, $\mathfrak{O}$ is a non-empty open subset of $X$ and $Y$ is a Hausdorff space. A mapping $\mathfrak{g}:[0, T] \times \mathfrak{O} \rightarrow Y$ is piecewise continuous with a parameter on $[0, T] \times \mathfrak{O}$ when there exists a subdivision of $[0, T], 0=\tau_{0}<\tau_{1}<\ldots<$ $\tau_{k}<\tau_{k+1}=T$ such that for all $i \in\{0, \ldots, k-1\}, \mathfrak{g}$ is continuous on $\left[\tau_{i}, \tau_{i+1}[\times \mathfrak{O}, \mathfrak{g}\right.$ is continuous on $\left[\tau_{k}, \tau_{k+1}\right] \times \mathfrak{O}$, and for all $i \in\{1, \ldots, k\}$, for all $x \in \mathfrak{O}, \lim _{t \rightarrow \tau_{i}-, z \rightarrow x} \mathfrak{g}(t, z)$ exists in $Y$. The space of all the piecewise continuous with a parameter is denoted by $P C P^{0}([0, T] \times \mathfrak{O}, Y)$.
When $X$ is included into a real normed vector space, $P C^{1}([0, T], X)$ denotes the space of the piecewise continuously differentiable functions from $[0, T]$ into $X$. We specify that $x \in P C^{1}([0, T], X)$ when $x$ is continuously differentiable on $[0, T]$ or when $x$ is continuous on $[0, T]$ and there exists a subdivision, $0=\tau_{0}<\tau_{1}<\ldots<$ $\tau_{k}<\tau_{k+1}=T$ such that $x$ is continuously differentiable at $t$ if $t \notin\left\{\tau_{i}: 0 \leq i \leq k+1\right\}$ the right derivative $x_{R}^{\prime}\left(\tau_{i}\right)=x^{\prime}\left(\tau_{i}+\right)$ exists when $i \in\{0, \ldots, k\}$, the left derivative $x_{L}^{\prime}\left(\tau_{i}\right)=x^{\prime}\left(\tau_{i}-\right)$ exists when $i \in\{1, . ., k+1\}$, cf. 3].

As in [3], we consider the extended derivative of $x \in P C^{1}([0, T], X)$ as follows:

Note that if $x \in P C^{1}([0, T], X)$ then $\underline{d} x \in N P C_{R}^{0}([0, T], X)$. Moreover, $\underline{d}$ is a continuous linear operator from $P C^{1}([0, T], X)$ into $N P C_{R}^{0}([0, T], X)$. When $X$ is included in a Banach space, the following relation holds:

where the integral is taken in the sense of Riemann as exposed in 5]. We refer to [3] for the details about these function spaces.
When $X$ is a real normed vector space, $\mathfrak{O}$ is a non-empty open subset of $X, x \in \mathfrak{O}$, $v \in X$, and $Y$ is a real normed vector space. When $\mathfrak{f}: \mathfrak{O} \rightarrow Y$ is a mapping. When it exists $D_{G}^{+} \mathfrak{f}(x ; v)$ denotes the right-directional derivative (also called the right Gâteaux variation) of $\mathfrak{f}$ at $x$ in the direction $v$ cf. [4] (Subsection 2.1). When it exists $D_{G} \mathfrak{f}(x)$ (respectively $D_{H} \mathfrak{f}(x)$, respectively $D_{F} \mathfrak{f}(x)$ ) denotes the Gâteaux (respectively Hadamard, respectively Fréchet) differential of $\mathfrak{f}$ at $x$.
Moreover, when $X$ is a finite product of $n$ real normed spaces, $X:=\prod_{i=1}^{n} X_{i}$, if $i \in\{1, \ldots, n\}, D_{G, i} \mathfrak{f}(x)$ (respectively $D_{H, i} \mathfrak{f}(x)$, respectively $D_{F, i} \mathfrak{f}(x)$ ) denotes the partial Gâteaux (respectively Hadamard, respectively Fréchet) differential of $\mathfrak{f}$ at $x$ with respect to the $i-t h$ vector variable. If $1 \leq i_{1} \leq i_{2} \leq i_{3} \leq n$, $D_{H,\left(i_{1}, i_{2}, i_{3}\right)} \mathfrak{f}(x)$ denotes the Hadamard diffential of the mapping $\left[\left(\mathbf{x}_{i_{1}}, \mathbf{x}_{i_{2}}, \mathbf{x}_{i_{3}}\right) \mapsto\right.$ $\left.\mathfrak{f}\left(x_{1}, \ldots, \mathbf{x}_{i_{1}}, \ldots, \mathbf{x}_{i_{2}}, \ldots, \mathbf{x}_{i_{3}}, \ldots, x_{n}\right)\right]$ at the point $\left(x_{i_{1}}, x_{i_{2}}, x_{i_{3}}\right)$.

We formulate the problem of Bolza:

Generally the controlled dynamical system is present in $(\mathcal{B})$ is formulated as follows: $x^{\prime}(t)=f(t, x(t), u(t))$ when $x^{\prime}(t)$ exists in [3], we explain why the present formulation is equivalent.
If $f^{0}=0,(\mathcal{B})$ is called a problem of Mayer and it is denoted by $(\mathcal{M})$.
When $(x, u)$ is an admissible process for $(\mathcal{B})$ or $(\mathcal{M})$, we consider the following condition of qualification, for $i \in\{0,1\}$.

When $i=0$, this condition is due to Michel [10].
Now we formulate the assumptions for our theorems. Let $\left(x_{0}, u_{0}\right)$ be an admissible process of $(\mathcal{B})$ or $(\mathcal{M})$.

## Conditions on the integrand of the criterion.

(AI2) For all non-empty compact $K \subset \Omega$, for all non-empty compact $M \subset U$, $\sup _{(t, \xi, \zeta) \in[0, T] \times K \times M}\left\|D_{G, 2} f^{0}(t, \xi, \zeta)\right\|<+\infty$.
where $C^{0}$ means the continuity and $E^{*}$ denotes the topological dual space of $E$.

## Conditions on the vector field.

(Av1) $f \in C^{0}([0, T] \times \Omega \times U, E)$, for all $(t, \xi, \zeta) \in[0, T] \times \Omega \times U, D_{G, 2} f(t, \xi, \zeta)$ exists, for all $(t, \zeta) \in[0, T] \times U, D_{F, 2} f\left(t, x_{0}(t), \zeta\right)$ exists and $[(t, \zeta) \mapsto$ $\left.D_{F, 2} f\left(t, x_{0}(t), \zeta\right)\right] \in C^{0}([0, T] \times U, \mathcal{L}(E, E))$.
(Av2) For all non-empty compact $K \subset \Omega$, for all non-empty compact $M \subset U$, $\sup _{(t, \xi, \zeta) \in[0, T] \times K \times M}\left\|D_{G, 2} f(t, \xi, \zeta)\right\|<+\infty$,
where $\mathcal{L}(E, E)$ denotes the space of bounded linear mappings from $E$ into $E$.
Conditions on terminal constraints functions and on terminal part of the criterion.
(AT1) For all $\alpha \in\{0, \ldots, m\}, g^{\alpha}$ is Hadamard differentiable at $x_{0}(T)$.
(AT2) For all $\beta \in\{1, \ldots, q\}, h^{\beta}$ is continuous on a neighborhood of $x_{0}(T)$ and Hadamard differentiable at $x_{0}(T)$.
(AI1) and (AI2) are an improvement of condition (A3) of [3, (Av1) and (Av2) are an improvement of condition (A4) of [3], (AT1) is an improvement of condition (A1) of [3, and (AT2) is an improvement of condition (A2) of 3].
The Hamiltonian of $(\mathcal{B})$ is the function $H_{B}:[0, T] \times \Omega \times U \times E^{*} \times \mathbb{R} \rightarrow \mathbb{R}$ defined by $H_{B}(t, \xi, \zeta, p, \lambda):=\lambda f^{0}(t, \xi, \zeta)+p \cdot f(t, \xi, \zeta)$ when $(t, \xi, \zeta, p, \lambda) \in[0, T] \times \Omega \times U \times$ $E^{*} \times \mathbb{R}$.
Theorem 2.1. (Pontryagin Principle for the problem of Bolza)
When $\left(x_{0}, u_{0}\right)$ is a solution of $(\mathcal{B})$, under (A1), (A2), (Av1), (Av2), (AT1) and (AT2), there exist multipliers $\left(\lambda_{\alpha}\right)_{0 \leq \alpha \leq m} \in \mathbb{R}^{1+m},\left(\mu_{\beta}\right)_{1 \leq \beta \leq q} \in \mathbb{R}^{q}$ and an adjoint function $p \in P C^{1}\left([0, T], E^{*}\right)$ which satisfy the following conditions.
(NN) $\left(\left(\lambda_{\alpha}\right)_{0 \leq \alpha \leq m},\left(\mu_{\beta}\right)_{1 \leq \beta \leq q}\right)$ is non zero.
(Si) For all $\alpha \in\{0, \ldots, m\}, \lambda_{\alpha} \geq 0$.
(S $\ell$ ) For all $\alpha \in\{1, \ldots, m\}, \lambda_{\alpha} g^{\alpha}\left(x_{0}(T)\right)=0$.

Corollary 2.2. In the setting and under the assumptions of Theorem 2.1, if, in addition, we assume that, for all $(t, \xi, \zeta) \in[0, T] \times \Omega \times U$, the partial derivatives with respect to the first variable $\partial_{1} f^{0}(t, \xi, \zeta)$ and $\partial_{1} f(t, \xi, \zeta)$ exist and $\partial_{1} f^{0}$ and $\partial_{1} f$ are continuous on $[0, T] \times \Omega \times U$, then $\bar{H}_{B} \in P C^{1}([0, T], \mathbb{R})$ and, for all $t \in[0, T]$, $\underline{d} \bar{H}_{B}(t)=\partial_{1} H_{B}\left(t, x_{0}(t), u_{0}(t), p(t), \lambda_{0}\right)$.

We introduce other conditions.
$(\mathbf{A} \vee \mathbf{3}) U$ is a subset of real normed vector space $Y$, there exists $\hat{t} \in[0, T]$ s.t. $U$ is a neighborhood of $u_{0}(\hat{t})$ in $Y, D_{G, 3} f\left(\hat{t}, x_{0}(\hat{t}), u_{0}(\hat{t})\right)$ exists and it is surjective and
(LI) $U$ is a subset of a real normed vector space $Y$ s.t. $U$ is a neighborhood of $u_{0}(T)$ in $Y, D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)$ exists and
$\left(\left(D_{H} g^{\alpha}\left(x_{0}(T)\right) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)\right)_{1 \leq \alpha \leq m}\right.$, $\left.\left(D_{H} h^{\beta}\left(x_{0}(T)\right) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)\right)_{1 \leq \beta \leq q}\right)$ is linearly free.
Corollary 2.3. In the setting and under the assumptions of Theorem 2.1, the following assertions hold.
(i) Under $(Q C, 1)$ for $(x, u)=\left(x_{0}, u_{0}\right)$, we have for all $t \in[0, T],\left(\lambda_{0}, p(t)\right) \neq 0$.
(ii) Under $(Q C, 1)$ for $(x, u)=\left(x_{0}, u_{0}\right)$ and (AV3), we can choose $\lambda_{0}=1$.
(iii) Under (LI), we can choose $\lambda_{0}=1$.
(iv) Under (LI), if, in addition, we assume that $D_{G, 3} f^{0}\left(T, x_{0}(T), u_{0}(T)\right)$ exists, then $\left(\left(\lambda_{\alpha}\right)_{0 \leq \alpha \leq m},\left(\mu_{\beta}\right)_{1 \leq \beta \leq q}, p\right) \in \mathbb{R}^{1+m} \times \mathbb{R}^{q} \times P C^{1}\left([0, T], E^{*}\right)$ with $\lambda_{0}=1$, which satisfies the conclusions of Theorem 2.1, are unique.
2.2. Pontryagin principles for the problem of Mayer. The Hamiltonian of $(\mathcal{M})$ is the function $H_{M}:[0, T] \times \Omega \times U \times E^{*} \rightarrow \mathbb{R}$ defined by $H_{M}(t, \xi, \zeta, p):=$ $p \cdot f(t, \xi, \zeta)$ when $(t, \xi, \zeta, p) \in[0, T] \times \Omega \times U \times E^{*}$.

Theorem 2.4. (Pontryagin Principle for the problem of Mayer)
When $\left(x_{0}, u_{0}\right)$ is a solution of $(\mathcal{M})$, under (Av1), (Av2), (AT1) and (AT2), there exist multipliers $\left(\lambda_{\alpha}\right)_{0 \leq \alpha \leq m} \in \mathbb{R}^{1+m},\left(\mu_{\beta}\right)_{1 \leq \beta \leq q} \in \mathbb{R}^{q}$ and an adjoint function $p \in P C^{1}\left([0, T], E^{*}\right)$ which satisfy the following conditions.
(NN) $\left(\left(\lambda_{\alpha}\right)_{0 \leq \alpha \leq m},\left(\mu_{\beta}\right)_{1 \leq \beta \leq q}\right)$ is non zero.
(Si) For all $\alpha \in\{0, \ldots, m\}, \lambda_{\alpha} \geq 0$.
(S $\ell$ ) For all $\alpha \in\{1, \ldots, m\}, \lambda_{\alpha} g^{\alpha}\left(x_{0}(T)\right)=0$.

In the setting and under the assumptions of Theorem 2.4, if in addition we assume that, for all $(t, \xi, \zeta) \in[0, T] \times \Omega \times U$, the partial derivatives with respect to the first variable $\partial_{1} f(t, \xi, \zeta)$ exist and $\partial_{1} f$ are continuous on $[0, T] \times \Omega \times U$, then $\bar{H}_{M} \in P C^{1}([0, T], \mathbb{R})$ and, for all $t \in[0, T], \underline{d} \bar{H}_{M}(t)=$ $\partial_{1} H_{M}\left(t, x_{0}(t), u_{0}(t), p(t)\right)$.

Corollary 2.6. In the setting and under the assumptions of Theorem 2.4, the following assertions hold.
(i) Under $(Q C, 1)$ for $(x, u)=\left(x_{0}, u_{0}\right)$, we have for all $t \in[0, T],\left(\lambda_{0}, p(t)\right) \neq 0$.
(ii) Under $(Q C, 0)$ for $(x, u)=\left(x_{0}, u_{0}\right)$, we have for all $t \in[0, T], p(t) \neq 0$.
(iii) Under $(Q C, 1)$ for $(x, u)=\left(x_{0}, u_{0}\right)$ and (AV3), we can choose $\lambda_{0}=1$.
(iv) Under $(L I)$, the $\left(\left(\lambda_{\alpha}\right)_{0 \leq \alpha \leq m},\left(\mu_{\beta}\right)_{1 \leq \beta \leq q}, p\right) \in \mathbb{R}^{1+m} \times \mathbb{R}^{q} \times P C^{1}\left([0, T], E^{*}\right)$ with $\lambda_{0}=1$, which satisfies the conclusions of Theorem 2.4. are unique.
2.3. Proofs of results for the problem of Mayer. We consider

We also define $I_{i}(a)=I_{i}(a, S):=\left[t_{i}+b_{i}(a), t_{i}+b_{i}(a)+a_{i}[\right.$.
We define $\delta(S)=\min \left\{t_{i+1}-t_{i}: i \in\{1, \ldots, N-1\}, t_{i}<t_{i+1}\right\}$ and $\|a\|_{1}=\sum_{i=1}^{N}\left|a_{i}\right|=\sum_{i=1}^{N} a_{i} \leq \delta(S)$.
When $a \in B_{\|\cdot\|_{1}}(0, \delta(S)) \cap \mathbb{R}_{+}^{N}$, we have $I_{i}(a) \subset[0, T]$ and $I_{i}(a) \cap I_{j}(a)=\emptyset$ when $i \neq j$ and we can define the needlelike variation of $u_{0}$ :

Lemma 2.7. Let $X$ be a metric space, $Y$ be a non empty set, $Z$ be a real normed vector space and $\phi: X \times Y \rightarrow Z$ be a mapping. We assume that: for all non-empty compact subset $K$ of $X$, we have $\sup _{(x, y) \in K \times Y}\|\phi(x, y)\|<+\infty$.
Then, for all non-empty compact subset $K$ of $X$, there exists $\rho>0$ s.t.
$\sup _{(x, y) \in V(K, \rho) \times Y}\|\phi(x, y)\|<+\infty$,
where $V(K, \rho):=\left\{z \in X: d(z, K):=\inf _{k \in K} d(z, k)<\rho\right\}$.
Proof. We proceed by contradiction, we assume that there exists a non-empty compact subset $K \subset X$ s.t. $\forall \varepsilon>0, \forall \gamma \in \mathbb{R}_{+} \exists\left(x^{\varepsilon, \gamma}, y^{\varepsilon, \gamma}\right) \in V(K, \varepsilon) \times Y$, $\left\|\phi\left(x^{\varepsilon, \gamma}, y^{\varepsilon, \gamma}\right)\right\|>\gamma$.
Therefore taking $\varepsilon=\frac{1}{n}, \gamma=n$ with $n \in \mathbb{N}_{*}$, we obtain $\forall n \in \mathbb{N}_{*}, \exists\left(x_{n}, y_{n}\right) \in$ $V\left(K, \frac{1}{n}\right) \times Y,\left\|\phi\left(x_{n}, y_{n}\right)\right\|>n$.
Hence, for all $n \in \mathbb{N}_{*}, \exists u_{n} \in K$ s.t. $d\left(x_{n}, u_{n}\right)=d\left(x_{n}, K\right)<\frac{1}{n}$.
Since $K$ is a compact, there exists $\psi: \mathbb{N}_{*} \rightarrow \mathbb{N}_{*}$ strictly increasing and $z \in K$ s.t. $\lim _{n \rightarrow+\infty} u_{\psi(n)}=z$. Hence, we have also $\lim _{n \rightarrow+\infty} x_{\psi(n)}=z$.

For each non-empty compact subset $K \subset \mathbb{G}$, there exist $\eta>0, \kappa>0$ s.t. for all $x \in K$, for all $x_{1}, x_{2} \in \bar{B}(x, \eta)$, for all $y \in Y,\left\|\phi\left(x_{1}, y\right)-\phi\left(x_{2}, y\right)\right\| \leq \kappa\left\|x_{1}-x_{2}\right\|$.

Proof. Let $K \subset \mathbb{G}, K$ non-empty and compact. From Lemma 2.7 there exists $\rho>0$ s.t. $\kappa:=\sup _{(x, y) \in V(K, \rho) \times Y}\left\|D_{G, 1} \phi(x, y)\right\|<+\infty$.
We set $\eta:=\frac{\rho}{2}$. Let $x \in K$ and $x_{1}, x_{2} \in \bar{B}(x, \eta)$. Since the balls are convex, we have $\left[x_{1}, x_{2}\right] \subset \bar{B}(x, \eta) \subset V(K, \rho)$. Remark 2.9. Note that we don't use a condition of continuity on $\phi$ in Lemma 2.7, we replace it by a condition of boundedness on the compact subsets. It is similar in Lemma 2.8 of $D_{G, 1} \phi$ instead of $\phi$. These lemmas permit us to replace the condition of partial differentiable continuity in (A3) and (A4) of 3 by the conditions (AI2) and ( A V 2 ).

Lemma 2.10. Let $X$ and $Y$ be metric spaces and $\phi \in C^{0}([0, T] \times X, Y)$. The Nemytskii operator $N_{\phi}: P C^{0}([0, T], X) \rightarrow P C^{0}([0, T], Y)$, defined by

Proof. Let $z \in P C^{0}([0, T], X)$; we set $w(t):=\phi(t, z(t))$ when $t \in[0, T]$. Since $\phi$ is continuous, we have, for all $t \in[0, T[, w(t+)=\phi(t, z(t+))$ and, for all $t \in] 0, T]$, $w(t-)=\phi(t, z(t-))$. Since the set of discontinuity points of $z, \operatorname{discont}(z)$, is finite, $\operatorname{discont}(w)$ is necessarily finite, and so $w \in P C^{0}([0, T], Y)$.
We denote by $\mathcal{G}(z)$ the graphic of $z$. Since $z \in P C^{0}([0, T], X), \operatorname{cl}(\mathcal{G}(z))$ is compact and then, we can use the Heine-Schwartz lemma (11 p. 355, note (**)) and assert that : $\forall \varepsilon>0, \exists \mathfrak{d}_{\varepsilon}>0, \forall(t, s) \in[0, T], \forall \xi \in X,|t-s|+d(z(t), \xi) \leq \mathfrak{d}_{\varepsilon} \Rightarrow$ $d(\phi(t, z(t)), \phi(s, \xi)) \leq \varepsilon$. Hence, we have:

The continuity of $N_{\phi}$ at $z$ is proven. Therefore, $N_{\phi}$ is well defined and continuous. Moreover, when $z \in N P C_{R}^{0}([0, T], X)$, since $z$ is right-continous on $[0, T$ [ and $\phi$ is continuous, we have also $N_{\phi}(z) \in N P C_{R}^{0}([0, T], Y)$.

Lemma 2.11. Let $0=s_{0}<s_{1}<\ldots<s_{\mathfrak{n}}<s_{\mathfrak{n}+1}=T$, and, for all $i \in$ $\{0, \ldots, \mathfrak{n}\}, \mathbf{h}_{i} \in P C^{0}([0, T], E)$. We consider $\mathbf{h}:[0, T] \rightarrow E$ defined by $\mathbf{h}(t)=$ $\sum_{0 \leq i \leq \mathfrak{n}-1} 1_{\left[s_{i}, s_{i+1}[ \right.}(t) \mathbf{h}_{i}(t)+1_{\left[s_{\mathfrak{n}}, T\right]}(t) \mathbf{h}_{\mathfrak{n}}(t)$ when $t \in[0, T]$.
We have $\mathbf{h} \in P C^{0}([0, T], E)$.
Proof. Note that discont $(\mathbf{h}) \subset\left\{s_{i}: 0 \leq i \leq \mathfrak{n}+1\right\} \cup \bigcup_{0 \leq i \leq \mathfrak{n}} \operatorname{discont}\left(\mathbf{h}_{i}\right)$, hence discont $(\mathbf{h})$ is finite. When $t \in\left[0, T\left[\right.\right.$, we have $\mathbf{h}(t+)=\sum_{0 \leq i \leq \mathfrak{n}-1} 1_{\left[s_{i}, s_{i+1}[ \right.}(t+) \mathbf{h}_{i}(t+)$ $+1_{\left[s_{\mathfrak{n}}, T\right]}(t+) \mathbf{h}_{\mathfrak{n}}(t+)$ and, when $\left.\left.t \in\right] 0, T\right], \mathbf{h}(t-)=\sum_{0 \leq i \leq \mathfrak{n}-1} 1_{\left[s_{i}, s_{i+1}[ \right.}(t-) \mathbf{h}_{i}(t-)+$ $1_{\left[s_{\mathfrak{n}}, T\right]}(t-) \mathbf{h}_{\mathfrak{n}}(t-)$. We consider the linear mapping $\mathfrak{L}: \mathbb{R}^{N} \rightarrow E$, defined by $\mathfrak{L} \cdot a:=\sum_{i=1}^{N} a_{i} R\left(T, t_{i}\right) \cdot\left[f\left(t_{i}, x_{0}\left(t_{i}\right), v_{i}\right)-f\left(t_{i}, x_{0}\left(t_{i}\right), u_{0}\left(t_{i}\right)\right)\right]$ when $a=\left(a_{1}, \ldots, a_{N}\right) \in \mathbb{R}^{N}$. There exists $\varrho_{1}: \bar{B}_{\|\cdot\|_{1}}(0, \delta(S)) \cap \mathbb{R}_{+}^{N} \rightarrow E$ s.t. $\lim _{a \rightarrow 0} \varrho_{1}(a)=0$ and, for all $a \in \bar{B}_{\|\cdot\|_{1}}(0, \delta(S)) \cap \mathbb{R}_{+}^{N}, z_{a}(T)=z_{0}(T)+\mathfrak{L} \cdot a+\|a\|_{1} \varrho_{1}(a)$.
Proof. For all $a \in \bar{B}_{\|\cdot\|_{1}}(0, \delta(S)) \cap \mathbb{R}_{+}^{N}$, the second member of (2.6) is $\Delta_{a}$, defined by $\Delta_{a}(t):=0$ when $t \notin \bigcup_{1 \leq i \leq N} I_{i}(a)$ and $\Delta_{a}(t):=f\left(t, x_{0}(t), v_{i}\right)-f\left(t, x_{0}(t), u_{0}(t)\right)$ when $t \in I_{i}(a)(1 \leq i \leq N)$. Using Lemma 2.10 and 2.11 we see that $\Delta_{a} \in$ $P C^{0}([0, T], E)$. Since $R(t, \cdot)$ is continuous, $R(t, \cdot) \cdot \Delta_{a} \in P C^{0}([0, T], E)$, hence it is Riemann integrable.

Since $\left(x_{0}, u_{0}\right)$ is a solution of $(\mathcal{M}), a=0$ is a solution of the following finitedimensional optimization problem

where $\left(b_{i}^{*}\right)_{1 \leq i \leq N}$ is the dual basis of the canonical basis of $\mathbb{R}^{N}$.
Since $\tilde{x}$ is Fréchet differentiable at 0 , by using (At1) and (At2), we have, $g^{\alpha} \circ \tilde{x}$ when $\alpha \in\{0, \ldots, m\}$ and $h^{\beta} \circ \tilde{x}$ when $\beta \in\{1, \ldots, q\}$ are Hadamard differentiable at 0 . Moreover, since $\tilde{x} \in C^{0}\left(\bar{B}_{\|\cdot\|_{1}}\left(0, r_{3}\right), \Omega\right)$, by using (Aт2), for all $\beta \in\{1, \ldots, q\}$, $h^{\beta} \circ \tilde{x}$ is continuous on a neighborhood of 0 . Hence we can use the Multiplier rule of 12 (Theorem 2.2) to obtain our result.

With respect to Lemma 5.1 of [3], in Lemma 2.18, the Hadamard differentiability replaces the Fréchet differentiability.
To finish the proof of Theorem [2.4] we exactly proceed as in Subsection 5.2 of 3 . We just recall the schedule of the reasoning. For all $S \in \mathbb{S}$, we consider $K(S)$ which is the set of the $\left(\left(\lambda_{\alpha}\right)_{0 \leq \alpha \leq m},\left(\mu_{\beta}\right)_{1 \leq \beta \leq q}\right) \in \mathbb{R}^{1+m+q}$ which satisfy the conclusions (a,b,c,d) of Lemma 2.18 and $\sum_{0 \leq \alpha \leq m}\left|\lambda_{\alpha}\right|+\sum_{1 \leq \beta \leq q}\left|\mu_{\beta}\right|=1 . \Sigma(0,1)$ being the unit sphere of $\mathbb{R}^{1+m+q}, K(S)$ is a non-empty closed subset of $\Sigma(0,1)$. Since $\Sigma(0,1),(K(S))_{S \in \mathbb{S}}$ possesses the finite intersection property (9, p.31) and consequently we have $\bigcap_{S \in \mathbb{S}} K(S) \neq \emptyset$. An element of this intersection is convenient for the conclusions (NN), (Si), (S $\ell$ ), (AE.M) and (MP.M) of Theorem 2.4. The conclusions (CH.M) is proven by Lemma 5.2 of [3].
The proof of Corollary 2.5 is similar to the proof of Part (II) of Theorem 2.2 in [3] which is given in Subsection 5.3 in [3].
To prove assertion (i) of Corollary 2.6, we proceed by contradiction, we assume the existence of $s \in[0, T]$ s.t. $\left(\lambda_{0}, p(s)\right)=(0,0)$. Since $p(s)=0$, we have $p(T)=0$ since (AE.M) is linear homogeneous, and, from (TC), we have $\sum_{\alpha=1}^{m} \lambda_{\alpha} D_{H} g^{\alpha}\left(x_{0}(T)\right)+$ $\sum_{\beta=1}^{q} \mu_{\beta} D_{H} h^{\beta}\left(x_{0}(T)\right)=0$. Hence using (TC), (Si), (S $\ell$ ), (QC, 1) implies that $\left(\forall \alpha \in\{1, \ldots, m\}, \lambda_{\alpha}=0\right)$ and $\left(\forall \beta \in\{1, \ldots, q\}, \mu_{\beta}=0\right)$. Moreover, since $\lambda_{0}=0$, we obtain a contradiction with (NN).
The proof of assertion (ii) of Corollary 2.6 is similar to the proof of Part (III) of Theorem 2.2 in 3 .
To prove assertion (iii) of Corollary 2.6, we proceed by contradiction; we assume that $\lambda_{0}=0$. Since $D_{G, 3} f\left(\hat{t}, x_{0}(\hat{t}), u_{0}(\hat{t})\right)$ exists, $D_{G, 3} H_{M}\left(\hat{t}, x_{0}(\hat{t}), u_{0}(\hat{t}), p(\hat{t})\right)$ exists and $D_{G, 3} H_{M}\left(\hat{t}, x_{0}(\hat{t}), u_{0}(\hat{t}), p(\hat{t})\right)=p(\hat{t}) \circ D_{G, 3} f\left(\hat{t}, x_{0}(\hat{t}), u_{0}(\hat{t})\right)$. Therefore, by using (MP.M), we have $p(\hat{t}) \circ D_{G, 3} f\left(\hat{t}, x_{0}(\hat{t}), u_{0}(\hat{t})\right)=0$, and since $D_{G, 3} f\left(\hat{t}, x_{0}(\hat{t}), u_{0}(\hat{t})\right)$ is surjective, we have $p(\hat{t})=0$, hence $\left(\lambda_{0}, p(\hat{t})\right)=0$ that is a contradiction with the assertion (i). We have proven that $\lambda_{0} \neq 0$, and it suffices to divide all the multipliers and $p$ by $\lambda_{0}$ to obtain the assertion (iii).
To prove the assertion (iv) of Corollary [2.6 we begin to prove that $\lambda_{0} \neq 0$. To do that, we proceed by contradiction, we assume that $\lambda_{0}=0$.
Since $D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)$ exists, $D_{G, 3} H_{M}\left(T, x_{0}(T), u_{0}(T), p(T)\right)$ exists and we have $D_{G, 3} H_{M}\left(T, x_{0}(T), u_{0}(T), p(T)\right)=p(T) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)$.
From (MP.M), we obtain $p(T) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)=0$.
From (TC), we obtain: $\sum_{\alpha=1}^{m} \lambda_{\alpha} D_{H} g^{\alpha}\left(x_{0}(T)\right) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)$
$+\sum_{\beta=1}^{q} \mu_{\beta} D_{H} h^{\beta}\left(x_{0}(T)\right) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)=p(T) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)=$ 0 , and by using (LI), we obtain $\left(\left(\lambda_{\alpha}\right)_{1 \leq \alpha \leq m},\left(\mu_{\beta}\right)_{1 \leq \beta \leq q}\right)=0$, which is a contradiction with (NN). Hence, we have proven that $\lambda_{0} \neq 0$. Dividing $\lambda_{\alpha}, \mu_{\beta}, p$ by $\lambda_{0}$, we normalize all these terms, and we have $\lambda_{0}=1$. To prove the uniqueness, let $\left(\left(\lambda_{\alpha}^{1}\right)_{0 \leq \alpha \leq m},\left(\mu_{\beta}^{1}\right)_{1 \leq \beta \leq q}, p^{1}\right) \in \mathbb{R}^{1+m+q} \times P C^{1}\left([0, T], E^{*}\right)$ which satisfy the conclusions of the Theorem 2.4 are verified with $\lambda_{0}^{1}=1$.
From (MP.M), we have, $p^{1}(T) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)=0$, therefore, we have $\left(p(T)-p^{1}(T)\right) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)=0$ and from (TC), we obtain $\sum_{\alpha=1}^{m}\left(\lambda_{\alpha}-\right.$ $\left.\lambda_{\alpha}^{1}\right) D_{H} g^{\alpha}\left(x_{0}(T)\right) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)$
$+\sum_{\beta=1}^{q}\left(\mu_{\beta}-\mu_{\beta}^{1}\right) D_{H} h^{\beta}\left(x_{0}(T)\right) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)=0$. Hence, using (LI), $\left(\lambda_{\alpha}\right)_{0 \leq \alpha \leq m}=\left(\lambda_{\alpha}^{1}\right)_{0 \leq \alpha \leq m}$ and $\left(\mu_{\beta}\right)_{1 \leq \beta \leq q}=\left(\mu_{\beta}^{1}\right)_{1 \leq \beta \leq q}$, and consequently, using (TC) we obtain $p(T)=p^{1}(T)$. Using the uniqueness of the solution of a Cauchy problem on (AE.M), we obtain $p=p^{1}$. Corollary [2.6 is proven.
2.4. Proof of the results of the problem of Bolza. As in [3], we transform the problem of Bolza into a problem of Mayer to deduce Theorem 2.1from Theorem 2.4 That is why, we introduce an additional state variable denoted by $\sigma$. We set $\mathfrak{X}:=$ $(\sigma, \xi) \in \mathbb{R} \times \Omega$ as a new state variable; we set $F(t,(\sigma, \xi), \zeta):=\left(f^{0}(t, \xi, \zeta), f(t, \xi, \zeta)\right)$ as the new vectorfield; we set $G^{0}(\sigma, \xi):=\sigma+g^{0}(\xi), G^{\alpha}(\sigma, \xi):=g^{\alpha}(\xi)$ when $\alpha \in$ $\{1, \ldots, m\}$, and we set $H^{\beta}(\sigma, \xi):=h^{\beta}(\xi)$ when $\beta \in\{1, \ldots, q\}$. We formulate the new following problem of Mayer:


Proceeding as in the section 6 of [3], the proofs of Theorem 2.1, of Corollary 2.2 and of assertion (i) of Corollary 2.3 are similar to the proof of Theorem 2.1. Part (I), Part (II), and Part (III) of [3].

Proof of assertion (ii) of Corollary 2.3,
$\overline{\text { First we want to prove that } \lambda_{0} \neq 0 \text {. To do that, we proceed by contradiction, we }}$ assume that $\lambda_{0}=0$. Using (MP.B), we obtain $p(\hat{t}) \circ D_{G, 3} f\left(\hat{t}, x_{0}(\hat{t}), u_{0}(\hat{t})\right)=0$. Since $D_{G, 3} f\left(\hat{t}, x_{0}(\hat{t}), u_{0}(\hat{t})\right)$ is onto, we have necessarily $p(\hat{t})=0$. Since we have assumed $(\mathrm{QC}, 1),\left(\lambda_{0}, p(\hat{t})\right)=(0,0)$ provides a contradiction after assertion (i) of Corollary 2.3. Hence we have proven that $\lambda_{0} \neq 0$. To conclude it sufficies to divide $\lambda_{0}, \ldots, \lambda_{m}, \mu_{1}, \ldots, \mu_{q}$ and $p$ by $\lambda_{0}$.
Proof of assertion (iii) of Corollary 2.3 ,
First we want to prove that $\lambda_{0} \neq 0$. To do that, we proceed by contradiction, we assume that $\lambda_{0}=0$. Using (MP.B), we obtain $p(T) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)=0$. That is why, using (TC), we obtain $\sum_{\alpha=1}^{m} \lambda_{\alpha} D_{H} g^{\alpha}\left(x_{0}(T)\right) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)$ $+\sum_{\beta=1}^{q} \mu_{\beta} D_{H} h^{\beta}\left(x_{0}(T)\right) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)=p(T) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)$ $=0$. From (LI), we obtain ( $\left.\forall \alpha \in\{1, \ldots, m\}, \lambda_{\alpha}=0\right)$ and $\left(\forall \beta \in\{1, \ldots, q\}, \mu_{\beta}=0\right)$; hence we have $\left(\left(\lambda_{\alpha}\right)_{0 \leq \alpha \leq m},\left(\mu_{\beta}\right)_{1 \leq \beta \leq q}\right)=(0,0)$; which contradicts (NN). We have proven that $\lambda_{0} \neq 0$. We conclude as in the proof of (ii).
Proof of assertion (iv) of Corollary 2.3.
From assertion (iii), we know that there exists $\left(\left(\lambda_{\alpha}\right)_{0 \leq \alpha \leq m},\left(\mu_{\beta}\right)_{1 \leq \beta \leq q}\right)$ with $\lambda_{0}=1$, and $p$ which satisfy the conclusions of Theorem 2.1
Let $\left(\left(\lambda_{\alpha}^{1}\right)_{0 \leq \alpha \leq m},\left(\mu_{\beta}^{1}\right)_{1 \leq \beta \leq q}\right)$ with $\lambda_{0}^{1}=1$, and $p^{1}$ which satisfy the conclusions of Theorem 2.1.
Using (MP.B), we have $p^{1}(T) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)+D_{G, 3} f^{0}\left(T, x_{0}(T), u_{0}(T)\right)=$ 0 and $p(T) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)+D_{G, 3} f^{0}\left(T, x_{0}(T), u_{0}(T)\right)=0$. Using twice (TC), we obtain $\sum_{\alpha=1}^{m}\left(\lambda_{\alpha}-\lambda_{\alpha}^{1}\right) D_{H} g^{\alpha}\left(x_{0}(T)\right) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)$
$+\sum_{\beta=1}^{q}\left(\mu_{\beta}-\mu_{\beta}^{1}\right) D_{H} h^{\beta}\left(x_{0}(T)\right) \circ D_{G, 3} f\left(T, x_{0}(T), u_{0}(T)\right)=0$. The linear independence provided by (LI) implies $\left(\forall \alpha \in\{1, \ldots, m\}, \lambda_{\alpha}-\lambda_{\alpha}^{1}=0\right)$ and ( $\forall \beta \in$ $\left.\{1, \ldots, q\}, \mu_{\beta}-\mu_{\beta}^{1}=0\right)$.
Consequently, we have $\left(\left(\lambda_{\alpha}\right)_{0 \leq \alpha \leq m},\left(\mu_{\beta}\right)_{1 \leq \beta \leq q}\right)=\left(\left(\lambda_{\alpha}^{1}\right)_{0 \leq \alpha \leq m},\left(\mu_{\beta}^{1}\right)_{1 \leq \beta \leq q}\right)$. Using twice (TC), we obtain $p(T)=p^{1}(T)$. Using (AE.B) and the uniqueness of the solution of a Cauchy problem, we obtain $p=p^{1}$. We have proven the uniqueness.

## 3. Envelope theorems

$X$ is a Banach space, $Y$ and $Z$ are real normed spaces, $\Omega$ is a non-empty open subset of $X$, and $U$ is a non-empty open subset of $Y, f^{0}:[0, T] \times \Omega \times U \times Z \rightarrow \mathbb{R}$, $f:[0, T] \times \Omega \times U \times Z \rightarrow X g^{i}: \Omega \times Z \rightarrow \mathbb{R}(0 \leq i \leq m)$ and $h^{j}: \Omega \times Z \rightarrow \mathbb{R}$ $(1 \leq j \leq q)$ are mappings. Let $\xi_{0} \in \Omega$, for all $\pi \in Z$, we consider the following problem of Bolza.

The Hamiltonian of Pontryagin of this problem of Bolza is $H_{\pi}:[0, T] \times \Omega \times U \times$ $X^{*} \times \mathbb{R} \rightarrow \mathbb{R}$, defined by $H_{\pi}(t, \xi, \zeta, p, \lambda):=p \cdot f(t, \xi, \zeta, \pi)+\lambda f^{0}(t, \xi, \zeta, \pi)$ when $t \in[0, T], \xi \in \Omega, \zeta \in U, p \in X^{*}$ and $\lambda \in \mathbb{R}$. For each $\pi \in Z$, we denote by $V[\pi]$ the value of $(\mathcal{B}, \pi)$.
3.1. Main results. We fix $\pi_{0} \in Z$ and we consider the following list of conditions.

## Conditions on the solutions.

There exists $\delta \pi \in Z$ s.t. $D_{G}^{+} x\left[\pi_{0} ; \delta \pi\right]$ and $D_{G}^{+} u\left[\pi_{0} ; \delta \pi\right]$ exist.
Conditions on the integrand of the criterion.
(IC1) $f^{0} \in C^{0}([0, T] \times \Omega \times U \times P, \mathbb{R})$, and, $\forall(t, \xi, \zeta, \pi) \in[0, T] \times \Omega \times U \times P$, $D_{G, 2} f^{0}(t, \xi, \zeta, \pi)$ exists. Moreover, for all $\pi \in P$, for all non-empty compact $K$ s.t. $K \subset \Omega \times U, \sup _{(t, \xi, \zeta) \in[0, T] \times K}\left\|D_{G, 2} f^{0}(t, \xi, \zeta, \pi)\right\|<+\infty$.
(IC2) For all $t \in[0, T], D_{H,(2,3,4)} f^{0}\left(t, x\left[\pi_{0}\right](t), u\left[\pi_{0}\right](t), \pi_{0}\right)$ exists. Moreover, for all $\pi \in P, D_{H, 3} f^{0}(T, x[\pi](T), u[\pi](T), \pi)$ exists, and the function $\left[\pi \mapsto D_{H, 3} f^{0}(T, x[\pi](T), u[\pi](T), \pi)\right] \in C^{0}\left(P, Y^{*}\right)$.
(IC3) There exists $\kappa \in \mathcal{L}^{1}\left(([0, T], \mathcal{B}([0, T])), \mathfrak{m}_{1} ; \mathbb{R}_{+}\right)$, there exists $\rho>0$ s.t., $\forall t \in[0, T], \forall\left(\xi_{1}, \zeta_{1}, \pi_{1}\right),\left(\xi_{2}, \zeta_{2}, \pi_{2}\right) \in B_{\|\cdot\|_{1}}\left(\left(x\left[\pi_{0}\right](t), u\left[\pi_{0}\right](t), \pi_{0}\right), \rho\right)$, $\left|f^{0}\left(t, \xi_{1}, \zeta_{1}, \pi_{1}\right)-f^{0}\left(t, \xi_{2}, \zeta_{2}, \pi_{2}\right)\right| \leq \kappa(t)\left\|\left(\xi_{1}, \zeta_{1}, \pi_{1}\right)-\left(\xi_{2}, \zeta_{2}, \pi_{2}\right)\right\|$.
(IC4) For all $(t, \zeta, \pi) \in[0, T] \times U \times P, D_{F, 2} f^{0}(t, x[\pi](t), \zeta, \pi)$ exists and, $\forall \pi \in P$, $\left[(t, \zeta) \mapsto D_{F, 2} f^{0}(t, x[\pi](t), \zeta, \pi)\right] \in C^{0}\left([0, T] \times U, X^{*}\right)$,
where $\mathcal{B}([0, T])$ is the Borel tribe on $[0, T]$ and $\mathfrak{m}_{1}$ is the canonical Borel measure on $[0, T]$.
Notice that (IC1) concerns the continuity and the partial Gâteaux differentiability; (IC2) concerns the Hadamard differentiability, (IC3) concerns a partial Lipschitz condition, and (IC4) concerns the partial Fréchet differentiability. if, $x \in C^{0}\left(P, C^{0}([0, T], \Omega)\right)$ and, for all $t \in[0, T], f^{0}(t, \cdot, \cdot, \cdot)$ is Fréchet differentiable on $\Omega \times U \times P$, and if $D_{F,(2,3,4)} f^{0}$ is continuous on $[0, T] \times \Omega \times U \times P$ then (IC1)-(IC4) are fulfilled. In our approach we want to weaken the conditions on $f^{0}$.
Conditions on the vector field.
(V1) For all $\pi \in P,[(t, \xi, \zeta) \mapsto f(t, \xi, \zeta, \pi)] \in C^{0}([0, T] \times \Omega \times U, X)$, and, for all $(t, \xi, \zeta, \pi) \in[0, T] \times \Omega \times U \times P, D_{G, 2} f(t, \xi, \zeta, \pi)$ exists. Moreover, for all $\pi \in P$, for all non-empty compact $K$ s.t. $K \subset \Omega \times U$, $\sup _{(t, \xi, \zeta) \in[0, T] \times K}\left\|D_{G, 2} f(t, \xi, \zeta, \pi)\right\|<+\infty$.
(V2) For all $t \in[0, T], D_{H,(2,3,4)} f\left(t, x\left[\pi_{0}\right](t), u\left[\pi_{0}\right](t), \pi_{0}\right)$ exist and, for all $\pi \in P$, $D_{H, 3} f(T, x[\pi](T), u[\pi](T), \pi)$ exists.
(V3) For all $(t, \zeta, \pi) \in[0, T] \times U \times P, D_{F, 2} f(t, x[\pi](t), \zeta, \pi)$ exists and, $\forall \pi \in P$, $\left[(t, \zeta) \mapsto D_{F, 2} f(t, x[\pi](t), \zeta, \pi)\right] \in C^{0}([0, T] \times U, \mathcal{L}(X, X))$.
We can do a comment on (V1)-(V3) which is similar to the comment on (IC1)-(IC4) which is given just after (IC4).

## Conditions on the terminal constraints functions and the terminal func-

Conditions on the terminal constraints functions, the terminal function of the criterion and the vector field.
(CVT1) $\left(D_{H, 1} g^{i}\left(x\left[\pi_{0}\right](T), \pi_{0}\right) \circ D_{H, 3} f\left(T, x\left[\pi_{0}\right](T), u\left[\pi_{0}\right](T), \pi_{0}\right)\right.$, $\left.D_{H, 1} h^{j}\left(x\left[\pi_{0}\right](T), \pi_{0}\right) \circ D_{H, 3} f\left(T, x\left[\pi_{0}\right](T), u\left[\pi_{0}\right](T), \pi_{0}\right)\right)_{1 \leq i \leq m, 1 \leq j \leq q}$ is linearly free.

+\sum_{j=1}^{q} \mu_{j}\left[\pi_{0}\right] D_{H, 2} h^{j}\left(x\left[\pi_{0}\right](T), \pi_{0}\right) \cdot \delta \pi  \tag{3.12}\\

We set $\mathfrak{W}:=B\left(\pi_{0}, \mathfrak{a}\right) \cap Q \subset P$. Let $\pi \in \mathfrak{W}$. Note that $\mathfrak{W}$ is an open neighborhood of $\pi$ in $Q$ and, for all $\bar{\pi} \in \mathfrak{W},(x[\bar{\pi}], u[\bar{\pi}])$ is a solution of $(\mathcal{B}, \bar{\pi})$, consequently (SO) is fulfilled $\pi_{0}=\pi$.
$\pi_{0}$ is not present in the conditions (IC1), (IC4), (V1), (V3), (CT2) and (CVT2), that is why using our assumptions this conditions are already verified.
Using our additional assumptions, the conditions (SO-bis), (IC2), (IC3), (V2), (V4) and (CT1) are fulfilled with $\pi_{0}=\pi$.
Besides, the assertions (3.16) implies that (IC3) is fulfilled with $\pi_{0}=\pi$, and the assertion (3.4) imples that (CVT1) with $\pi_{0}=\pi$. Hence, for all $\pi \in \mathfrak{W}$, the assumptions of Corollary 3.2 are fulfilled with $\pi_{0}=\pi$ Therefore, we can use the Theorem 3.1 and we obtain that $V$ is Gâteaux differentiable for every $\pi \in \mathfrak{W}$ and

Besides, using (3.18), we have for all $\pi \in \mathfrak{W}$, for all $t \in[0, T], \varphi_{1}^{0}(t, \pi) \leq 2 \kappa(t)$. Next, using (IC5), we have, for all $t \in[0, T], \lim _{\pi \rightarrow \hat{\pi}} \varphi_{1}^{0}(t, \pi)=\varphi_{1}^{0}(t, \hat{\pi})=0$.
Therefore, using the Dominated Convergence Theorem of Lebesgue, the functional $\psi_{1}^{0}: \mathfrak{W} \rightarrow \mathbb{R}$, defined by, for all $\pi \in \mathfrak{W}, \psi_{1}^{0}(\pi):=\int_{0}^{T} \varphi_{1}^{0}(t, \pi) d t$, is continuous at $\hat{\pi}$ i.e.

Using (IC6), we have, for all $\pi \in \mathfrak{W}, \varphi_{2}^{0}(\cdot, \pi) \in \mathcal{L}^{0}(([0, T], \mathcal{B}([0, T])),(\mathbb{R}, \mathcal{B}(\mathbb{R})))$. Next, using (3.18), we have, $\forall \pi \in \mathfrak{W}, \forall t \in[0, T], \varphi_{2}^{0}(t, \pi) \leq 2 \kappa(t)$. Besides, from (IC5), we have, for all $t \in[0, T], \lim _{\pi \rightarrow \hat{\pi}} \varphi_{2}^{0}(t, \pi)=\varphi_{2}^{0}(t, \hat{\pi})=0$. Hence, using the Dominated Convergence Theorem of Lebesgue, the functional $\psi_{2}^{0}: \mathfrak{W} \rightarrow \mathbb{R}$, defined by, $\psi_{2}^{0}(\pi):=\int_{[0, T]} \varphi_{2}^{0}(t, \pi) d \mathfrak{m}_{1}(t)$ is continuous at $\hat{\pi}$ i.e.

Lemma 3.8. $\Psi_{3} \in C^{0}\left(\mathfrak{W}, Z^{*}\right)$ 。

Proof. Let $\hat{\pi} \in \mathfrak{W}$. We consider the function $\varphi_{2}:[0, T] \times \mathfrak{W} \rightarrow \mathbb{R}$, defined by $\varphi_{2}(t, \pi):=\left\|\mathfrak{f}_{4}(t, \pi)-\mathfrak{f}_{4}(t, \hat{\pi})\right\|$.
From (V6), we have, for all $\pi \in \mathfrak{W}, \varphi_{2}(\cdot, \pi) \in \mathcal{L}^{0}(([0, T], \mathcal{B}([0, T])),(\mathbb{R}, \mathcal{B}(\mathbb{R})))$. Moreover, using (V6), we also have, $\forall \pi \in \mathfrak{W}, \forall t \in[0, T], \varphi_{2}(t, \pi) \leq 2 c(t)$. Besides, from (V5), we have, for all $t \in[0, T], \lim _{\pi \rightarrow \hat{\pi}} \varphi_{2}(t, \pi)=\varphi_{2}(t, \hat{\pi})=0$. Hence, using the Dominated Convergence Theorem of Lebesgue the functional $\psi_{2}: \mathfrak{W} \rightarrow \mathbb{R}$, defined by $\pi \in \mathfrak{W}, \psi_{2}(\pi):=\int_{[0, T]} \varphi_{2}(t, \pi) d \mathfrak{m}_{1}(t)$, is continuous at $\hat{\pi}$ i.e.

From (3.17), remark that

Consequently, using (CT3) and Lemmas 3.5, 3.7 and 3.8, we obtain that, $D_{G} V \in$ $C^{0}\left(\mathfrak{W}, Z^{*}\right)$. Therefore, using Corollary 2, p. 144 in [1], we obtain that $V$ is Fréchet differentiable on $\mathfrak{W}$ and $D_{F} V[\pi]=D_{G} V[\pi]$ for all $\pi \in \mathfrak{W}$, and therefore $D_{F} V \in$ $C^{0}\left(\mathfrak{W}, Z^{*}\right)$.
