# On the global minimum of the energymomentum relation for the polaron

#### Abstract

For the Fröhlich model of the large polaron, we prove that the ground state energy as a function of the total momentum has a unique global minimum at momentum zero. This implies the non-existence of a ground state of the translation invariant Fröhlich Hamiltonian and thus excludes the possibility of a localization transition at finite coupling.


## 1 Introduction

The polaron describes an electron interacting with the quantized optical modes of a polarizable lattice. It poses a classic problem in solid state physics that was initiated by Landau's one-page paper [18] about the possibility of self-trapping of an electron by way of deformation of the lattice. The existence of self-trapping for the polaron was debated in the physics literature over many decades, see e.g. [8, 12, 13, 24, 26, 33, 37, 40, 41]. Mathematically it is related to the existence of a normalizable ground state for the translation invariant Hamiltonian. While for weak coupling, the non-existence of ground states is almost immediately evident, the conclusion is less obvious for strong coupling. In fact, for the semi-classical theory, which is known to be accurate in the limit of strong coupling [5, 22], the translational symmetry is broken on the level of the ground state [20,34]. This supported the idea about the existence of a localization transition at finite coupling.

[^0]In this work, we give a mathematical proof that such a transition does not occur for the Fröhlich Hamiltonian. This Hamiltonian models the large polaron, where the lattice is described by a continuous quantum field with constant dispersion relation. We prove that the translation invariant Hamiltonian does not have a ground state, irrespective of the value of the coupling. To achieve this, we study the energy-momentum relation, that is, the ground state energy as a function of the conserved total momentum, and show that it attains its global unique minimum at momentum zero. The non-existence of ground states is then a simple consequence of this property. Quoting [6, p. 1575], this solves a physically obvious but mathematically long-standing conjecture.

Following H. Fröhlich [9, 10] the large polaron is defined on the Hilbert space

\end{equation*}

with $\mathcal{F}=\bigoplus_{n=0}^{\infty} \bigotimes_{\text {sym }}^{n} L^{2}\left(\mathbb{R}^{3}\right)$ the bosonic Fock space, and governed by the Hamiltonian

$$
\begin{equation*}
H=-\Delta_{x}+N+\phi\left(v_{x}\right), \tag{1.2}
\end{equation*}
$$

where $-\Delta_{x}=\left(-\mathrm{i} \nabla_{x}\right)^{2}, x$ and $-\mathrm{i} \nabla_{x}$ describing the position and momentum of the electron and $N=d \Gamma(1)$ denotes the number operator on Fock space (modeling the energy of the phonon field, whose dispersion relation is constant). The interaction is described by the linear field operator

$$
\begin{equation*}
\phi\left(v_{x}\right)=a\left(v_{x}\right)+a^{*}\left(v_{x}\right) \quad \text { with } \quad v_{x}(y)=v(y-x), \quad v(y)=\sqrt{\alpha} \frac{1}{|y|^{2}} . \tag{1.3}
\end{equation*}
$$

The bosonic creation and annihilation operators, $a^{*}$, $a$, satisfy the usual canonical commutation relations. After setting $\hbar=1$ and the mass of the electron equal to $1 / 2$, the polaron model depends on a single dimensionless parameter $\alpha>0$. In the present work, the choice of $\alpha$ is not relevant, as our statements shall hold equally for all values of the coupling constant.

An important property of the Fröhlich Hamiltonian $H$ is that it defines a translationinvariant system, in the sense that it commutes with the total momentum operator

\left[H,-\mathrm{i} \nabla_{x}+P_{f}\right]=0 \tag{1.4}
\end{equation*}
$$

where $P_{f}=\mathrm{d} \Gamma(-\mathrm{i} \nabla)$ describes the momentum of the phonons. As a consequence, it is possible to simultaneously diagonalize the total momentum and the energy. This simultaneous diagonalization is implemented best by the Lee-Low-Pines transformation [19] $S: \mathscr{H} \rightarrow \int_{\mathbb{R}^{3}}^{\oplus} \mathcal{F} d P$ defined by $F \circ e^{\mathrm{i} P_{f} x}$ where $F$ indicates the Fourier transformation w.r.t. $x$. As is easily revealed
by a direct computation, $S\left(-\mathrm{i} \nabla_{x}+P_{f}\right) S^{*}=\int_{\mathbb{R}^{3}}^{\oplus} P d P$ and $S H S^{*}=\int_{\mathbb{R}^{3}}^{\oplus} H(P) d P$ with

$$
\begin{equation*}
H(P)=\left(P-P_{f}\right)^{2}+N+\phi(v) \tag{1.5}
\end{equation*}
$$

The fiber operator $H(P)$ acts on $\mathcal{F}$ and describes the system at total momentum $P \in \mathbb{R}^{3}$.
Irrespectively of whether we take (1.2) or (1.5) as our starting point, the definition of the model is somewhat formal, since $v \notin L^{2}$. A common way to define the Fröhlich model is to start from the quadratic form associated with $H(P)$ (or $H$ ) and show that it is an infinitesimal perturbation of the form associated with the non-interacting operator $(\alpha=0)$. By the KLMN Theorem this implies the existence of a unique self-adjoint operator associated with the form of $H(P)$ (or $H$ ), which we call the fibered Fröhlich Hamiltonian. For convenience of the reader we give the details in the appendix.

The main topic of this paper is the energy-momentum relation of the polaron, defined as the lowest possible energy as a function of the total momentum

E_{\alpha}(P):=\inf \sigma(H(P)) \tag{1.6}
\end{equation*}
$$

By rotation invariance of the Fröhlich Hamiltonian, $E_{\alpha}(P)=E_{\alpha}(R P)$ for all rotations $R \in$ $O(3)$ and hence $E_{\alpha}(P)=E_{\mathrm{rad}, \alpha}(|P|)$. It was shown by L. Gross [15] that $E_{\alpha}(0) \leq E_{\alpha}(P)$ for all $P \in \mathbb{R}^{3}$. As recently pointed out in a paper by Dybalski and Spohn [6], it is further conjectured that $P=0$ is the unique global minimum

$$
\begin{equation*}
E_{\alpha}(0)<E_{\alpha}(P) \text { for all } P \neq 0 \tag{1.7}
\end{equation*}
$$

While this inequality is not surprising from the physics point of view, its mathematical proof turns out to be less obvious. In fact already Gross' proof for showing that $P=0$ is a global minimum requires a considerable amount of work. In a small neighborhood around zero the strict inequality can be inferred from the finiteness of the effective mass [6] (the effective mass is defined by $\left.\left(M_{\text {eff }, \alpha}\right)^{-1}=\left.E_{\text {rad }, \alpha}^{\prime \prime}(P)\right|_{P=0}\right)$. The goal of this paper is to prove (1.7) for all non-zero $P \in \mathbb{R}^{3}$. A proof was proposed in 1991 by Gerlach and Löwen [13]. However, their argument is not completely rigorous and its validity has been recently debated [6]. Our aim is to follow the idea suggested by Gerlach and Löwen and turn it into a complete mathematical proof. To this end we also benefit from results on the Fröhlich Hamiltonian that became available more recently.

Approaching the problem from a different angle, Dybalski and Spohn provide a proof of (1.7) under the assumption that a central limit theorem for the polaron path measure with two-sided pinning holds, see [6, Sec. 5], in particular Theorem 5.3 and Conjecture 5.2 therein. To our knowledge, this particular version of the central limit theorem, however, has not been rigorously established so far.

At the time of finalizing our paper, we were informed by Polzer about his new work [35] that presents a proof of (1.7) based on a strategy, also in the probabilistic framework, that does not rely on the validity of the central limit theorem with two-sided pinning. In this new approach the polaron path measure is represented as a mixture of Gaussian measures and analyzed with techniques from renewal theory (see also [1, 2, 31]). Among other interesting properties, [35] shows that $E_{\mathrm{rad}, \alpha}(|P|)$ is a monotone increasing function with strict monotonicity below the essential spectrum, i.e., in particular in a neighborhood around $P=0$.

In our proof we follow an operator-theoretic approach that is inspired by $[7,11,13,16$, $17,28,30,39]$. Except for the following lemma, whose proof is based on results from [29] (see Section 2), our presentation is fully self-contained. ${ }^{1}$

Lemma 1.1. Let $\alpha>0$ and set $E_{\alpha}(P)=\inf \sigma(H(P))$.
(i) $\sigma_{\text {ess }}(H(P))=\left[E_{\alpha}(0)+1, \infty\right)$ for all $P \in \mathbb{R}^{3}$
(ii) The set of global minima of $P \mapsto E_{\alpha}(P)$ is non-empty.

Before we continue with our main results, let us give some more remarks on the context of the problem. For the non-interacting model, i.e. for $\alpha=0$, one easily sees that $E_{0}(P)=$ $\min \left\{P^{2}, 1\right\}$ with $P^{2}$ describing the region where the full momentum is on the electron whereas in the constant region it is favorable that the total momentum is carried by a single phonon with the electron at rest. The expectation from physics is that the form of $E_{\alpha}(P)$ remains qualitatively the same also for non-zero $\alpha$. Lemma 1.1(i), also known as the HVZ Theorem, confirms this for the essential spectrum, whose threshold corresponds to an electron at rest and a free phonon. One expects that the shape of $E_{\alpha}(P)$ remains essentially a parabola in a certain region around zero (though with a negative shift $E_{\alpha}(0)$ and with different curvature at $P=0$ ) and that it approaches $E_{\alpha}(0)+1$ as $|P| \rightarrow \infty$. That the expected parabola gives in fact an exact upper bound, $E_{\alpha}(P) \leq E_{\alpha}(0)+P^{2} /\left(2 M_{\mathrm{eff}, \alpha}\right)$ for all $P$ and $\alpha$, was shown in [35]. The mathematical verification of the described picture is particularly interesting in the strong coupling limit $\alpha \rightarrow \infty$, where one can analyze the asymptotic expansion of $E_{\alpha}(P)$ and $M_{\text {eff }, \alpha}$. For results about the strong-coupling limit see [2-5, 21, 22, 27, 38].

As already alluded to at the beginning of the paper, the form of the energy-momentum relation is also related to the existence of a ground state of the translation invariant Hamiltonian $H$. For weak coupling the non-existence is physically evident since for $\alpha=0$ no eigenstates exist. For strong coupling, on the other hand, there is a leading-order contribution of the classical polarization field and hence the interaction cannot be viewed as a perturbation of a translation-invariant Hamiltonian anymore. In fact, in the limit of strong coupling, the ground state energy approaches the corresponding semiclassical energy [5, 22, 34] which is known to

[^1]possess a manifold of localized ground states [20]. This supported the idea that also for the full quantum model, the translational symmetry may be broken on the level of the ground state for sufficiently large coupling, thus resulting in a transition from a delocalized regime (weak coupling) to a localized one (strong coupling). The existence of a ground state for $H$, however, would require that the set of global minima of $E_{\alpha}(P)$ is a set of non-zero Lebesgue measure. As our result implies that the global minimum is unique, this possibility is ruled out and thus we obtain a rigorous proof (see Corollary 1.3) of the non-existence of such a localization transition at any finite value of the coupling parameter.

### 1.1 Main results

The next statement is our main result.
Theorem 1.2. The energy-momentum relation $E_{\alpha}(P)=\inf \sigma(H(P))$ has its unique global minimum at $P=0$, i.e. for every $\alpha>0$ and every $P \neq 0$, we have the strict inequality

$$
\begin{equation*}
E_{\alpha}(0)<E_{\alpha}(P) \tag{1.8}
\end{equation*}
$$

As a corollary we obtain that the Fröhlich Hamiltonian $H$ does not possess a ground state, irrespective of the value of the coupling constant.

Corollary 1.3. There exists no $\alpha \in(0, \infty)$ such that $\inf \sigma(H)$ is an eigenvalue of $H$.
Proof. Suppose on the contrary that there exists an $\alpha \in(0, \infty)$ such that $H$ has a ground state $\Psi_{\alpha} \in \mathscr{H}$. By the Lee-Low-Pines transformation (see introduction),

$$
\begin{equation*}
\inf \sigma(H)=\frac{\int_{\mathbb{R}^{3}} d P\left\langle\Psi_{\alpha}(P), H(P) \Psi_{\alpha}(P)\right\rangle}{\int_{\mathbb{R}^{3}} d P\left\|\Psi_{\alpha}(P)\right\|^{2}} \geq \frac{\int_{\mathbb{R}^{3}} d P E_{\alpha}(P)\left\|\Psi_{\alpha}(P)\right\|^{2}}{\int_{\mathbb{R}^{3}} d P\left\|\Psi_{\alpha}(P)\right\|^{2}} \tag{1.9}
\end{equation*}
$$

with $\Psi_{\alpha}(P)=F\left[e^{\mathrm{i} P_{f} x} \Psi_{\alpha}\right](P) \in \mathcal{F}$ where $F$ is the Fourier transform w.r.t $x$. Note that $\left\|\Psi_{\alpha}(P)\right\|^{2} \in L^{1}\left(\mathbb{R}^{3}\right)$ by Parseval and $e^{\mathrm{i} P_{f} x} \Psi_{\alpha} \in L^{2}\left(\mathbb{R}^{3}, \mathcal{F}\right)$. Now by Theorem 1.2 the set $\left\{P \in \mathbb{R}^{3} \mid E_{\alpha}(P)=E_{\alpha}(0)\right\}$ has Lebesgue measure zero, and hence the right side of (1.9) is strictly larger than $E_{\alpha}(0)$. On the other hand, (1.8) together with the fiber decomposition of $H$ imply that $\inf \sigma(H)=E_{\alpha}(0)$, which yields a contradiction.

Remark 1.1. Our results do not depend on the precise form of $v$. The choice of the sign of $v$ in (1.3) does not matter, as the operator with form factor $\tilde{v}(y)=e^{i \theta} v(y)$ is unitarily equivalent to the one with $v$ via $\Gamma\left(e^{i \theta}\right)$. Moreover, our proof can easily be generalized to all positive (up to a global phase) $v$ satisfying $\hat{v}(k)\left(k^{2}+1\right)^{-s} \in L^{2}\left(\mathbb{R}^{3}\right)$ for some $0 \leq s<1 / 2$. For the sake of conciseness we focus on (1.3)

## 2 Proof of Theorem 1.2

To prove Theorem 1.2 we introduce a suitable (non-physical) auxiliary Hamiltonian and analyze the degeneracy of its ground state. On the one hand, it shall be easily seen that the multiplicity is strictly larger than one if we assume that $P \mapsto E_{\alpha}(P)$ attains its global minimum for some $q \neq 0$. On the other hand, this cannot be the case as it will follow by an abstract result that the ground state of this auxiliary operator is non-degenerate. As mentioned in the introduction, this idea goes back to Gerlach and Löwen [13].

By Lemma 1.1 (ii) there exists a $q \in \mathbb{R}^{3}$ such that $E_{\alpha}(q) \leq E_{\alpha}(P)$ for all $P \in \mathbb{R}^{3}$ and by rotational symmetry, we can assume that $q=(|q|, 0,0)$. For said $q$ we choose $\ell=\ell(q)>0$ such that $q \in(2 \pi / \ell) \mathbb{Z}^{3}$ and consider the Hilbert space

$$
\begin{equation*}
\mathscr{H}_{\ell}=L^{2}\left(\Lambda_{\ell}\right) \otimes \mathcal{F} \tag{2.1}
\end{equation*}
$$

where $\Lambda_{\ell}=[0, \ell]^{3}$ is the three-dimensional cube of side length $\ell$ with periodic boundary conditions, and $\mathcal{F}$ denotes again the bosonic Fock space over $L^{2}\left(\mathbb{R}^{3}\right)$. On this space we define (in the sense of quadratic forms)

$$
\begin{equation*}
h_{\ell}=\left(-\mathrm{i} \nabla_{x}-P_{f}\right)^{2}+N+\phi(v) \tag{2.2}
\end{equation*}
$$

where $-\mathrm{i} \nabla_{x}$ now denotes the gradient on $L^{2}\left(\Lambda_{\ell}\right)$. The reason for restricting the variable $x$ to the torus is that $h_{\ell}$ now has a ground state. Indeed, since $x$ only appears in the gradient, and since the corresponding momenta are restricted to $(2 \pi / \ell) \mathbb{Z}^{3}$, one can readily diagonalize

$$
\begin{equation*}
h_{\ell}=\bigoplus_{P \in \frac{2 \pi}{\ell} \mathbb{Z}^{3}} \pi_{\ell, P} \otimes H(P) \tag{2.3}
\end{equation*}
$$

with $\pi_{\ell, P}=\left|\varphi_{\ell, P}\right\rangle\left\langle\varphi_{\ell, P}\right|$ the projection onto the normalized plane wave $\varphi_{\ell, P}=\ell^{-3 / 2} e^{-\mathrm{i} P x} \in$ $L^{2}\left(\Lambda_{\ell}\right)$ with momentum $P$. Here it is important to note that the Fock space component is described by the fiber Hamiltonian $H(P)$ as defined in (1.5). Also note that since $H(P)$, $P \in \mathbb{R}^{3}$, is self-adjoint and bounded from below, so is $h_{\ell}$. By Lemma 1.1 we know that $E_{\alpha}(q)<$ $\inf \sigma_{\text {ess }}(H(q))$, hence there is an eigenfunction $\xi(q) \in \mathcal{F}$ such that $H(q) \xi(q)=E_{\alpha}(q) \xi(q)$. Since $E_{\alpha}(q) \leq E_{\alpha}(P)$ for all $P \in \mathbb{R}^{3}$, the wave function $\varphi_{\ell, q} \otimes \xi(q) \in \mathscr{H}_{\ell}$ is a ground state of $h_{\ell}$ with eigenvalue $E_{\alpha}(q)$.

The next lemma, whose proof is postponed to the next section, shows that this ground state is actually unique.

Proposition 2.1. For all $\alpha>0$ and any $\ell>0$ for which $\inf \sigma\left(h_{\ell}\right)$ is an eigenvalue (in particular for the value $\ell(q)$ chosen above), this eigenvalue has multiplicity one.

With this at hand, we can prove Theorem 1.2 by way of contradiction. To this end assume
that $q \neq 0$. By rotational symmetry $E_{\alpha}(q)=E_{\alpha}(-q)$ and, since $E_{\alpha}(-q)<\inf \sigma_{\text {ess }}(H(-q))$ by Lemma 1.1, the fiber Hamiltonian $H(-q)$ has an eigenfunction $\xi(-q) \in \mathcal{F}$ with eigenvalue $E_{\alpha}(-q)$. This implies that there is a second ground state of $h_{\ell}$, given by $\varphi_{\ell,-q} \otimes \xi(-q) \in \mathscr{H}_{\ell}$, that is orthogonal to $\varphi_{\ell, q} \otimes \xi(q)$. Thus we arrive at a contradiction to the statement of Proposition 2.1, and therefore we can rule out that $q$ is non-zero. This shows that $P \mapsto E_{\alpha}(P)$ can attain its global minimum only at $q=0$, hence the proof of Theorem 1.2 is complete.

In the remainder of this subsection we prove Lemma 1.1. For that purpose we first state and prove the following general result.

Lemma 2.2. Let $A_{n}, n \in \mathbb{N}$, be a sequence of self-adjoint operators satisfying $\sigma_{\text {ess }}\left(A_{n}\right)=$ $\left[a_{n}, b_{n}\right]$ with $-\infty \leq a_{n} \leq b_{n} \leq \infty$. If $A_{n} \xrightarrow{n \rightarrow \infty} A$ in norm-resolvent sense for some self-adjoint operator $A$, then $a_{n} \xrightarrow{n \rightarrow \infty} a, b_{n} \xrightarrow{n \rightarrow \infty} b$ for some $-\infty \leq a \leq b \leq \infty$ and $\sigma_{\text {ess }}(A)=[a, b]$.

Proof of Lemma 2.2. First assume that $a_{n}, b_{n} \xrightarrow{n \rightarrow \infty} a, b$ for some $-\infty \leq a \leq b \leq \infty$. Since $\sigma_{\text {ess }}\left(A_{n}\right) \neq \varnothing$, the essential spectrum of $A$ cannot be empty [36, Thm. XIII.23]. Now, for $\varepsilon>0$ we choose $N(\varepsilon)$ such that $\left[a_{n}, b_{n}\right] \subset[a-\varepsilon, b+\varepsilon]$ for all $n \geq N(\varepsilon)$. It follows that $\sigma\left(A_{n}\right)$ is purely discrete in $(-\infty, a-\varepsilon) \cup(b+\varepsilon, \infty)$ for all $n \geq N(\varepsilon)$. By [32, Prop. 11.4.31] this implies that $\sigma(A)$ is purely discrete on the same interval and thus, using that $\varepsilon$ was arbitrary, $\sigma_{\text {ess }}(A) \subset[a, b]$. Since $\sigma_{\text {ess }}(A) \neq \varnothing$, we get $\sigma_{\text {ess }}(A)=\{a\}$ if $a=b$.

For $a<b$, let $t \in(a, b) \cap \rho(A)$. By norm-resolvent convergence we have that if $t \in \rho(A)$, then $t \in \rho\left(A_{n}\right)$ for all $n$ sufficiently large [32, Prop. 10.2.4]. Since $\rho\left(A_{n}\right) \subset\left[a_{n}, b_{n}\right]^{c} \xrightarrow{n \rightarrow \infty}[a, b]^{c}$, this contradicts the assumption $t \in(a, b)$. Hence $(a, b) \subset \sigma(A)$, and since the spectrum is closed, $[a, b] \subset \sigma(A)$. This proves $\sigma_{\text {ess }}(A)=[a, b]$ also for $a<b$.

To remove the initial assumption on $a_{n}, b_{n}$, assume there is no $a \in[-\infty, \infty]$ such that $a_{n} \xrightarrow{n \rightarrow \infty} a$ (the same argument applies to $b_{n}$ ). Then there are at least two subsequences of $a_{n}$ with limits $a, \tilde{a} \in[-\infty, \infty], a \neq \tilde{a}$. Applying the argument from above to the two subsequences (and the associated subsequences of $A_{n}$ ) separately leads to the contradiction that $[a, b]=\sigma_{\text {ess }}(A)=[\tilde{a}, b]$.

Proof of Lemma 1.1. The proof is based on the results from [29]. Since the latter considers more regular polaron models with $v \in L^{2}\left(\mathbb{R}^{3}\right)$, we need to introduce the fiber Hamiltonians with UV cutoff. We define $H_{\Lambda}(P)$ as in (1.5) with form factor $v_{\Lambda}$ defined by $\hat{v}_{\Lambda}=\chi_{\Lambda} \hat{v}$ where $\chi_{\Lambda}$ is the characteristic function $k \mapsto \chi_{[0, \Lambda)}(|k|)$. Since $v_{\Lambda} \in L^{2}\left(\mathbb{R}^{3}\right)$, it is easy to verify that $H_{\Lambda}(P)$ is self-adjoint and bounded from below. Denoting $E_{\alpha, \Lambda}(P)=\inf \sigma\left(H_{\Lambda}(P)\right)$, we can quote two important results from [29]: For every $\Lambda>0$
(i') $\sigma_{\text {ess }}\left(H_{\Lambda}(P)\right)=\left[E_{\alpha, \Lambda}(0)+1, \infty\right)$,
(ii') $\lim _{|P| \rightarrow \infty}\left|E_{\alpha, \Lambda}(P)-\inf \sigma_{\text {ess }}\left(H_{\Lambda}(P)\right)\right|=0$.

These statements are given in [29, Thm. 2.1. and Thm. 2.4] for the choice $\omega \equiv 1$.
To show (i), note that by Proposition A.2, we also have $H_{\Lambda}(P) \xrightarrow{\Lambda \rightarrow \infty} H(P)$ in normresolvent sense, which implies $E_{\alpha, \Lambda}(0) \xrightarrow{\Lambda \rightarrow \infty} E_{\alpha}(0)=\inf \sigma(H(0))$. In fact, by [32, Prop. 10.2.4a] there exists a sequence of elements $t_{\Lambda} \in \sigma\left(H_{\Lambda}(0)\right)$ converging to $E_{\alpha}(0)$ as $\Lambda \rightarrow \infty$, in particular $t_{\Lambda} \geq E_{\alpha, \Lambda}(0)$ for all $\Lambda$, which shows that every accumulation point of the sequence $E_{\alpha, \Lambda}(0)$ is no larger than $E_{\alpha}(0)$. On the other hand, by [32, Prop. 10.2.4b] $E_{\alpha, \Lambda}(0)$ has no accumulation point below $E_{\alpha}(0)$, and thus $E_{\alpha, \Lambda}(0) \xrightarrow{\Lambda \rightarrow \infty} E_{\alpha}(0)$, and hence (i) is a consequence of (i') and Lemma 2.2.

To show (ii), we follow the argument from [6, Sec. 4]. First note that by the Lee-LowPines transformation $\mathcal{E}:=\inf _{P \in \mathbb{R}^{3}} E_{\alpha}(P)$ coincides with $\inf \sigma(H)$ and thus $\mathcal{E}>-\infty$. (ii) states that $\mathcal{M}=\left\{P \in \mathbb{R}^{3} \mid E_{\alpha}(P)=\mathcal{E}\right\}$ is a non-empty set. Assuming the opposite, $\mathcal{M}=\varnothing$, implies the existence of a sequence $\left(P_{j}\right)_{j \in \mathbb{N}} \subset \mathbb{R}^{3},\left|P_{j}\right| \rightarrow \infty$, satisfying $\lim _{j \rightarrow \infty} E_{\alpha}\left(P_{j}\right)=\mathcal{E}$. W.l.o.g. we can choose $P_{j}$ such that $\left|P_{j}\right|$ is monotone increasing and $E_{\alpha}\left(P_{j}\right) \in\left(\mathcal{E}, \mathcal{E}+\frac{1}{4}\right)$ for all $j \geq 1$. Further consider $f \in C_{c}^{\infty}(\mathbb{R})$ with $\operatorname{supp}(f) \subseteq\left(\mathcal{E}-\frac{1}{2}, \mathcal{E}+\frac{1}{2}\right)$ and $f(s)=1$ for all $s \in\left(\mathcal{E}-\frac{1}{4}, \mathcal{E}+\frac{1}{4}\right)$. By uniform norm-resolvent convergence of $H_{\Lambda}(P)$ (see Proposition A.2) and [36, Thm. VIII.20], we have

$$
\begin{align*}
0 & =\lim _{\Lambda \rightarrow \infty} \sup _{P \in \mathbb{R}^{3}}\left\|f\left(H_{\Lambda}(P)\right)-f(H(P))\right\| \\
& \geq \lim _{\Lambda \rightarrow \infty} \sup _{j \geq j_{\Lambda}}\left\|f\left(H_{\Lambda}\left(P_{j}\right)\right)-f\left(H\left(P_{j}\right)\right)\right\|=\lim _{\Lambda \rightarrow \infty} \sup _{j \geq j_{\Lambda}}\left\|f\left(H\left(P_{j}\right)\right)\right\| \tag{2.4}
\end{align*}
$$

where the last step follows from (i') and (ii') if we choose $j_{\Lambda}$ large enough. In more detail, for every $\Lambda$, we can choose $j_{\Lambda}$ such that $\sigma\left(H_{\Lambda}\left(P_{j}\right)\right) \cap\left(-\infty, E_{\alpha, \Lambda}(0)+\frac{3}{4}\right)=\varnothing$ for all $j \geq$ $j_{\Lambda}$. Since $\mathcal{E} \leq E_{\alpha}(0) \leq E_{\alpha, \Lambda}(0)+\frac{1}{4}$ (here we use again $E_{\alpha, \Lambda}(0) \xrightarrow{\Lambda \rightarrow \infty} E_{\alpha}(0)$ ), this implies $\sigma\left(H_{\Lambda}\left(P_{j}\right)\right) \cap\left(-\infty, \mathcal{E}+\frac{1}{2}\right]=\varnothing$ for all $j \geq j_{\Lambda}$, and thus $f\left(H_{\Lambda}\left(P_{j}\right)\right)=0$. By assumption, however, $\inf \sigma\left(H\left(P_{j}\right)\right) \in\left(\mathcal{E}, \mathcal{E}+\frac{1}{4}\right)$ for all $j \geq 1$ and thus the right side of (2.4) is one, which is a contradiction.

### 2.1 Proof of Proposition 2.1

In this section we show that the resolvent of $h_{\ell}$ is a positivity improving operator w.r.t. a suitable Hilbert cone using a strategy that was applied to the renormalized Nelson model in [16]. (Compared to the latter we face the additional difficulty that $h_{\ell}$ is an operator on the tensor product $\mathscr{H}_{\ell}$ and not only on $\mathcal{F}$ ). The statement of Proposition 2.1 will then follow from a Perron-Frobenius type argument due to Faris [7]. Let

$$
\begin{equation*}
\mathcal{C}:=\left\{\Psi \in \mathscr{H}_{\ell} \mid \forall n \in \mathbb{N}_{0}:(-1)^{n} \Psi^{(n)}\left(x, y_{1}, \ldots, y_{n}\right) \geq 0\right\} \tag{2.5}
\end{equation*}
$$

This defines a (Hilbert) cone in $\mathscr{H}_{\ell}$ in the sense of [7]. A bounded operator $K$ on $\mathscr{H}_{\ell}$ is called

- positivity preserving (with respect to $\mathcal{C}$ ) if $K u \in \mathcal{C}$ for any $u \in \mathcal{C}$, and
- positivity improving (with respect to $\mathcal{C}$ ) if $\langle K u, v\rangle>0$ for any $u, v \in \mathcal{C} \backslash\{0\}$.

We recall that $v(y)=\sqrt{\alpha}|y|^{-2}>0$ and thus

$$
\begin{equation*}
\hat{v}(k)=\sqrt{\alpha}(4 \pi|k|)^{-1} . \tag{2.6}
\end{equation*}
$$

Taking into account the alternating sign in the definition of $\mathcal{C}$, the interaction energy is negative on $\mathcal{C}$, i.e., $\langle\Psi, a(v) \Psi\rangle \leq 0$ for $\Psi \in \mathcal{C}$. Moreover, $\phi(-v)$ is positivity preserving, which is the key property to be used in the proof of the positivity-improving property in Proposition 2.5 below.

Now consider the self-adjoint positive operator

$$
\begin{equation*}
\mathfrak{h}_{\ell, 0}=\left(-\mathrm{i} \nabla_{x}-P_{f}\right)^{2}+N+1 \tag{2.7}
\end{equation*}
$$

acting on the Hilbert space $\mathscr{H}_{\ell}=L^{2}\left(\Lambda_{\ell}\right) \otimes \mathcal{F}$, which is essentially $\mathfrak{h}_{\ell}$ without the interaction term $\phi(v)$.

Lemma 2.3. The resolvent $\mathfrak{h}_{\ell, 0}^{-1}$ is positivity preserving with respect to the cone $\mathcal{C}$. Its restriction to the zero-phonon space $L^{2}\left(\Lambda_{\ell}\right)$ is positivity improving with respect to the cone of positive functions in $L^{2}\left(\Lambda_{\ell}\right)$.

Proof. The restriction of $\mathfrak{h}_{\ell, 0}^{-1}$ to $L^{2}\left(\Lambda_{\ell}\right)$ is given by the periodization of the resolvent of $-\Delta$ on $\mathbb{R}^{3}$, i.e. it has the integral kernel

$$
\begin{equation*}
\sum_{k \in \mathbb{Z}^{3}} \frac{\mathrm{e}^{-\left|x-x^{\prime}-k \ell\right|}}{4 \pi\left|x-x^{\prime}-k \ell\right|}, \tag{2.8}
\end{equation*}
$$

which converges due to the exponential decay of the numerator and is strictly positive. Similarly, the integral kernel of $\mathfrak{h}_{\ell, 0}^{-1}$ on the $n$-phonon space $\mathcal{F}^{(n)}$ is (as one readily checks using the Fourier transform)

$$
\begin{equation*}
\sum_{k \in \mathbb{Z}^{3}} \frac{\mathrm{e}^{-\sqrt{n+1}\left|x-x^{\prime}-k \ell\right|}}{4 \pi\left|x-x^{\prime}-k \ell\right|} \prod_{j=1}^{n} \delta\left(y_{j}-x-y_{j}^{\prime}+x^{\prime}+k \ell\right), \tag{2.9}
\end{equation*}
$$

which is a non-negative distribution.
Lemma 2.4. The operator $a(v) \mathfrak{h}_{\ell, 0}^{-1}$ is bounded, and $1+a(v) \mathfrak{h}_{\ell, 0}^{-1}$ is invertible, with bounded inverse given by

$$
\left(1+a(v) \mathfrak{h}_{\ell, 0}^{-1}\right)^{-1}=\sum_{j=0}^{\infty}\left(a(-v) \mathfrak{h}_{\ell, 0}^{-1}\right)^{j}
$$

where the sum converges in the operator norm.
Proof. For $n \in \mathbb{N}$ we have using the Fourier transform and Cauchy-Schwarz

$$
\begin{align*}
& \left\|a(v) \mathfrak{h}_{\ell, 0}^{-1 / 2} \Psi^{(n)}\right\|_{L^{2}\left(\Lambda_{\ell}\right) \otimes \mathcal{F}^{(n-1)}}^{2} \\
& =n \sum_{p \in \frac{2 \pi}{\ell} \mathbb{Z}^{3}} \int_{\mathbb{R}^{3(n-1)}} d k_{1} \cdots d k_{n-1}\left|\int d k_{n} \frac{\hat{v}\left(k_{n}\right) \Psi^{(n)}\left(p, k_{1}, \ldots, k_{n}\right)}{\left(\left(p+k_{1}+\cdots k_{n}\right)^{2}+n+1\right)^{1 / 2}}\right|^{2} \\
& \leq n\left\|\Psi^{(n)}\right\|^{2} \sup _{k \in \mathbb{R}^{3}} \int_{\mathbb{R}^{3}} d \xi \frac{|\hat{v}(\xi)|^{2}}{(k+\xi)^{2}+n+1} \\
& \leq(n+1)^{1 / 2}\left\|\Psi^{(n)}\right\|^{2} \frac{\alpha}{(4 \pi)^{2}} \int_{\mathbb{R}^{3}} \frac{d \eta}{\eta^{2}\left(\eta^{2}+1\right)} . \tag{2.10}
\end{align*}
$$

where we used (2.6) and performed the change of variables $\eta=\xi / \sqrt{n+1}$ in the last step. We thus have the inequality

$$
\begin{equation*}
\left\|a(v) \mathfrak{h}_{\ell, 0}^{-1 / 2} \Psi\right\| \leq C\left\|(N+1)^{1 / 4} \Psi\right\| \tag{2.11}
\end{equation*}
$$

which implies that

$$
\begin{equation*}
\left\|a(v) \mathfrak{h}_{\ell, 0}^{-1} \Psi\right\| \leq C\left\|(N+1)^{-1 / 4} \Psi\right\| \tag{2.12}
\end{equation*}
$$

for some constant $C$ that depends on $\alpha$. For $j \in \mathbb{N}$ this implies

$$
\begin{equation*}
\left\|\left(a(v) \mathfrak{h}_{\ell, 0}^{-1}\right)^{j} \Psi\right\| \leq C\left\|\left(a(v) \mathfrak{h}_{\ell, 0}^{-1}\right)^{j-1}(N+j)^{-1 / 4} \Psi\right\| \leq C^{j}(j!)^{-1 / 4}\|\Psi\| \tag{2.13}
\end{equation*}
$$

Since $C^{j}(j!)^{-1 / 4}$ is summable, the Neumann series converges and one easily checks that the limit is the inverse of $1+a(v) \mathfrak{h}_{\ell, 0}^{-1}$.

With the operator $\mathfrak{h}_{\ell, 0}$ we can write the auxiliary operator (2.2) as

$$
h_{\ell}+1=\underbrace{\left(1+a(v) \mathfrak{h}_{\ell, 0}^{-1}\right) \mathfrak{h}_{\ell, 0}\left(1+\mathfrak{h}_{\ell, 0}^{-1} a^{*}(v)\right)}_{=: K} \underbrace{-a(v) \mathfrak{h}_{\ell, 0}^{-1} a^{*}(v)}_{=: T}=K+T .
$$

Proposition 2.5. Let $\alpha>0$. For all $\lambda>-\inf \sigma\left(h_{\ell}\right)$ the resolvent $\left(h_{\ell}+\lambda\right)^{-1}$ is positivity improving with respect to $\mathcal{C}$.

Proof. It is sufficient to prove the statement for one $\lambda>-\inf \sigma\left(h_{\ell}\right)$, by analyticity of the resolvent (see also [29, Lem. A.4]). For sufficiently large $\lambda$ we shall first prove

$$
\left(h_{\ell}+1+\lambda\right)^{-1}=(K+T+\lambda)^{-1}
$$

$$
\begin{equation*}
=(K+\lambda)^{-1}\left(1+T(K+\lambda)^{-1}\right)^{-1}=(K+\lambda)^{-1} \sum_{j=0}^{\infty}\left(-T(K+\lambda)^{-1}\right)^{j} \tag{2.14}
\end{equation*}
$$

To this end, we show that $T$ is infinitesimally $K$-bounded. In fact, by (2.11),

$$
\begin{equation*}
\|T \Psi\| \leq C\left\|(N+1)^{1 / 2} \Psi\right\| \leq \varepsilon\|N \Psi\|+C_{\varepsilon}\|\Psi\| \tag{2.15}
\end{equation*}
$$

for arbitrary $\varepsilon>0$, and moreover,

$$
\begin{align*}
\|N \Psi\| & \leq\left\|N\left(1+\mathfrak{h}_{\ell, 0}^{-1} a^{*}(v)\right) \Psi\right\|+\left\|N \mathfrak{h}_{\ell, 0}^{-1} a^{*}(v) \Psi\right\| \\
& \leq\left\|\mathfrak{h}_{\ell, 0}\left(1+\mathfrak{h}_{\ell, 0}^{-1} a^{*}(v)\right) \Psi\right\|+C\left\|(N+1)^{3 / 4} \Psi\right\| \\
& \leq\left\|\left(1+a(v) \mathfrak{h}_{\ell, 0}^{-1}\right)^{-1}\right\|\|K \Psi\|+\frac{3}{4}\|N \Psi\|+\left(\frac{1}{4} C^{4}+\frac{3}{4}\right)\|\Psi\| . \tag{2.16}
\end{align*}
$$

Proceeding with (2.14), we use that $-T$ is positivity preserving, since it is the product of the three positivity preserving operators $\mathfrak{h}_{\ell, 0}^{-1}$ (see Lemma 2.3) and $a(-v), a^{*}(-v)$ (note the alternating sign in the definition of $\mathcal{C}$ ). The claim will thus follow if we can prove that $(K+\lambda)^{-1}$ improves positivity. As $K \geq 1$, this holds for all $\lambda>-1$ if it holds for $\lambda=0$.

Let $0 \neq \Psi, \Phi \in \mathcal{C}$ and let $n, m$ be so that $\Psi^{(n)} \neq 0, \Phi^{(m)} \neq 0$. Set $\phi:=\left(a(-v) \mathfrak{h}_{\ell, 0}^{-1}\right)^{m} \Phi^{(m)}$ and $\psi:=\left(a(-v) \mathfrak{h}_{\ell, 0}^{-1}\right)^{n} \Psi^{(n)}$. Since $a(-v)$ and $\mathfrak{h}_{\ell, 0}^{-1}$ are positivity preserving, $\phi, \psi$ are nonnegative elements of $L^{2}\left(\Lambda_{\ell}\right)$. Since $v>0$, they do not vanish identically. We thus have

$$
\begin{equation*}
\left\langle\Phi, K^{-1} \Psi\right\rangle=\left\langle\sum_{j=0}^{\infty}\left(a(-v) \mathfrak{h}_{\ell, 0}^{-1}\right)^{j} \Phi, \mathfrak{h}_{\ell, 0}^{-1} \sum_{k=0}^{\infty}\left(a(-v) \mathfrak{h}_{\ell, 0}^{-1}\right)^{k} \Psi\right\rangle \geq\left\langle\phi, \mathfrak{h}_{\ell, 0}^{-1} \psi\right\rangle>0 \tag{2.17}
\end{equation*}
$$

since $\mathfrak{h}_{\ell, 0}$ improves positivity on $L^{2}\left(\Lambda_{\ell}\right)$ by Lemma 2.3. This proves the claim.
Proof of Proposition 2.1. The proposition is proved using the positivity-improving property of $h_{\ell}$ following arguments of [7]. Let $\mathscr{H}_{\ell}^{\mathbb{R}}$ be the subspace of real-valued functions in $\mathscr{H}_{\ell}$. Since $h_{\ell}$ is invariant under complex conjugation, it can be restricted to an operator on $\mathscr{H}_{\ell} \mathbb{R}$. Moreover, any eigenvalue $e$ of $h_{\ell}$ is also an eigenvalue of this restriction and their multiplicity is the same, since the $\mathbb{R}$-linear map of multiplication by the imaginary unit is an isomorphism between the real and imaginary subspaces of $\operatorname{ker}\left(h_{\ell}-e\right)$.

It is thus sufficient to prove that $\inf \sigma\left(h_{\ell}\right)$ is a simple eigenvalue of $\left.h_{\ell}\right|_{\mathscr{H}_{\ell}^{\mathbb{R}}}$. This is equivalent to proving that, for $\lambda>-\inf \sigma\left(h_{\ell}\right)$, the space of real eigenfunctions of $\left(h_{\ell}+\lambda\right)^{-1}$ for its largest eigenvalue $e:=\left(\inf \sigma\left(h_{\ell}\right)+\lambda\right)^{-1}>0$ has dimension one.

Let $\Psi \in \mathscr{H}_{\ell}^{\mathbb{R}}$ be a normalized eigenfunction of $\left(h_{\ell}+\lambda\right)^{-1}$ with eigenvalue $e$. We can write

$$
\begin{equation*}
\Psi=\Psi_{+}-\Psi_{-}, \tag{2.18}
\end{equation*}
$$

where

$$
\begin{equation*}
\Psi_{ \pm}^{(n)}=(-1)^{n} \max \left\{ \pm \Psi^{(n)}, 0\right\} \tag{2.19}
\end{equation*}
$$

so $\Psi_{ \pm} \in \mathcal{C}$ and $\left\langle\Psi_{+}, \Psi_{-}\right\rangle=0$. We then have

$$
\begin{align*}
e & =\left\langle\Psi,\left(h_{\ell}+\lambda\right)^{-1} \Psi\right\rangle \\
& =\left\langle\Psi_{+},\left(h_{\ell}+\lambda\right)^{-1} \Psi_{+}\right\rangle+\left\langle\Psi_{-},\left(h_{\ell}+\lambda\right)^{-1} \Psi_{-}\right\rangle-2 \underbrace{\left\langle\Psi_{-},\left(h_{\ell}+\lambda\right)^{-1} \Psi_{+}\right\rangle}_{\geq 0} \\
& \leq\left\langle\left(\Psi_{+}+\Psi_{-}\right),\left(h_{\ell}+\lambda\right)^{-1}\left(\Psi_{+}+\Psi_{-}\right)\right\rangle \leq e, \tag{2.20}
\end{align*}
$$

since $e$ is the largest eigenvalue and $\left\|\Psi_{+}+\Psi_{-}\right\|=\|\Psi\|=1$. We must thus have equality in (2.20), so

$$
\begin{equation*}
\left\langle\Psi_{-},\left(h_{\ell}+\lambda\right)^{-1} \Psi_{+}\right\rangle=0 \tag{2.21}
\end{equation*}
$$

Since $\left(h_{\ell}+\lambda\right)^{-1}$ improves positivity this implies that either $\Psi_{+}$or $\Psi_{-}$are equal to zero, i.e. $\Psi \in \mathcal{C}$ or $-\Psi \in \mathcal{C}$.

Now assume there exist two orthogonal real eigenfunctions $\Phi, \Psi \in \operatorname{ker}\left(\left(h_{\ell}+\lambda\right)^{-1}-e\right)$. By changing signs if necessary, we may assume that $\Phi, \Psi \in \mathcal{C} \backslash\{0\}$. Then

$$
\begin{equation*}
\langle\Phi, \Psi\rangle=e^{-1}\left\langle\Phi,\left(h_{\ell}+\lambda\right)^{-1} \Psi\right\rangle>0 \tag{2.22}
\end{equation*}
$$

a contradiction, so $e$ is a simple eigenvalue.

## A Definition of the Fröhlich Hamiltonian

In this section we define the Fröhlich Hamiltonian as a self-adjoint operator following the ideas of [17]. For a different proof, based on a commutator trick introduced in [22, 23], see [14].

We will give the construction for the fiber operators $H(P)$, from which $H$ can be obtained by reversing the Lee-Low-Pines transformation. Consider the quadratic form

$$
\begin{equation*}
Q_{P}(\Psi):=\langle\Psi,(H(P)+1) \Psi\rangle=\left\langle\Psi,\left(\left(P-P_{f}\right)^{2}+N+1\right) \Psi\right\rangle+2 \operatorname{Re}\langle\Psi, a(v) \Psi\rangle \tag{A.1}
\end{equation*}
$$

Introducing the positive operator $H_{0}:=\left(P-P_{f}\right)^{2}+N+1$, one easily sees that $Q_{P}$ is well defined on $D\left(H_{0}^{1 / 2}\right)$. Moreover, by inequality (A.4) below, $Q_{P}$ is an infinitesimal perturbation of the form of $H_{0}$. Consequently, by the KLMN Theorem there exists a unique self-adjoint
operator whose form is $Q_{P}$. To make this more explicit, rewrite $Q_{P}$ as

$$
\begin{equation*}
Q_{P}(\Psi)=\left\langle\Psi,\left(1+a(v) H_{0}^{-1}\right) H_{0}\left(1+H_{0}^{-1} a^{*}(v)\right) \Psi\right\rangle-\left\langle\Psi, a(v) H_{0}^{-1} a^{*}(v) \Psi\right\rangle \tag{A.2}
\end{equation*}
$$

From this, we see that $Q_{P}$ is associated with the operator

$$
\begin{equation*}
H(P)+1=\underbrace{\left(1+a(v) H_{0}^{-1}\right) H_{0}\left(1+H_{0}^{-1} a^{*}(v)\right)}_{=: K(P)} \underbrace{-a(v) H_{0}^{-1} a^{*}(v)}_{=: T(P)}=K(P)+T(P) . \tag{A.3}
\end{equation*}
$$

Proposition A.1. For $\alpha>0$ and $P \in \mathbb{R}^{3}$ the quadratic form $Q_{P}$ is the form of the self-adjoint operator $H(P)+1$ given by (A.3) with domain

$$
D(H(P))=\left\{\Psi \in \mathcal{F} \mid\left(1+H_{0}^{-1} a^{*}(v)\right) \Psi \in D\left(H_{0}\right)\right\} .
$$

Proof. By the same proof as in (2.11) we have for $\Psi \in D\left(N^{1 / 4}\right)$

$$
\begin{equation*}
\left\|a(v) H_{0}^{-1 / 2} \Psi\right\| \leq C\left\|(N+1)^{1 / 4} \Psi\right\| . \tag{A.4}
\end{equation*}
$$

Hence, by the proof of Lemma 2.4, the operator $1+a(v) H_{0}^{-1}$ and its adjoint are boundedly invertible. This implies that $D(H(P))$ is dense, since $D\left(H_{0}\right)$ is. Moreover, $K(P)$ is a symmetric, invertible operator and thus self-adjoint. The proof is completed by showing that $T(P)$ is infinitesimally $K(P)$-bounded as in (2.15), (2.16).

In the proof of Lemma 1.1 we used that the operators with cutoff $H_{\Lambda}(P)$ converge to $H(P)$ in norm-resolvent sense. We give a proof of this fact in the following proposition (see also [14]).

Proposition A.2. Let $\hat{v}_{\Lambda}(k)=\hat{v}(k) \chi_{[0, \Lambda)}(|k|)$, then the family of self-adjoint operators

$$
H_{\Lambda}(P)=\left(P-P_{f}\right)^{2}+N+\phi\left(v_{\Lambda}\right)
$$

with domain $D\left(H_{\Lambda}(P)\right)=D\left(H_{0}\right)$ converges to $H(P)$ in norm-resolvent sense as $\Lambda \rightarrow \infty$ uniformly in $P \in \mathbb{R}^{3}$.

Proof. Recall that $H_{0}=\left(P-P_{f}\right)^{2}+N+1$. The bounds on the difference of the resolvents will manifestly be independent of $P$, so we will not emphasize this at every step. Let

$$
\begin{equation*}
K_{\Lambda}(P):=\left(1+a\left(v_{\Lambda}\right) H_{0}^{-1}\right) H_{0}\left(1+H_{0}^{-1} a^{*}\left(v_{\Lambda}\right)\right) \tag{A.5}
\end{equation*}
$$

and

$$
\begin{equation*}
T_{\Lambda}(P)=-a\left(v_{\Lambda}\right) H_{0}^{-1} a^{*}\left(v_{\Lambda}\right) \tag{A.6}
\end{equation*}
$$

so that $H_{\Lambda}(P)+1=K_{\Lambda}(P)+T_{\Lambda}(P)$, similarly as in (A.3). Then with $z=1 \pm i$

$$
\begin{align*}
& \left(H_{\Lambda}(P)+z\right)^{-1}-(H(P)+z)^{-1}=\left(K_{\Lambda}(P)+T_{\Lambda}(P) \pm i\right)^{-1}-(K(P)+T(P) \pm i)^{-1} \\
& =\left(H_{\Lambda}(P)+z\right)^{-1}\left(a\left(v-v_{\Lambda}\right) H_{0}^{-1} H_{0}\left(1+H_{0}^{-1} a^{*}(v)\right)(H(P)+z)^{-1}\right.  \tag{A.7}\\
& \left.\quad+\left(H_{\Lambda}(P)+z\right)^{-1}\left(1+a\left(v_{\Lambda}\right) H_{0}^{-1}\right) H_{0}\left(1+H_{0}^{-1} a^{*}\left(v-v_{\Lambda}\right)\right)\right)(H(P)+z)^{-1}  \tag{A.8}\\
& \quad+\left(H_{\Lambda}(P)+z\right)^{-1}\left(T(P)-T_{\Lambda}(P)\right)(H(P)+z)^{-1} . \tag{A.9}
\end{align*}
$$

By an analogous bound to (2.10), we have

$$
\begin{equation*}
\left\|a\left(v-v_{\Lambda}\right) H_{0}^{-1 / 2} \Psi\right\| \leq \frac{\sqrt{\alpha}}{4 \pi}\left(\int_{|k|>\Lambda} \frac{d k}{k^{2}\left(k^{2}+1\right)}\right)^{1 / 2}\left\|(N+1)^{1 / 2} \Psi\right\| \tag{A.10}
\end{equation*}
$$

whence $\left\|a\left(v-v_{\Lambda}\right) H_{0}^{-1}\right\|$ tends to zero as $\Lambda \rightarrow \infty$. Since $H_{0}\left(1+H_{0}^{-1} a^{*}(v)\right)(H(P)+z)^{-1}$ is a bounded operator by construction of $H(P)$, this shows that (A.7) tends to zero in norm.

Since $\left|\hat{v}_{\Lambda}(k)\right| \leq|\hat{v}(k)|$ we have

$$
\begin{equation*}
\left\|a\left(v_{\Lambda}\right) H_{0}^{-1 / 2} \Psi\right\| \leq C\left\|(N+1)^{1 / 4} \Psi\right\| \tag{A.11}
\end{equation*}
$$

uniformly in $\Lambda$. With this, the bounds from the proof of Proposition A. 1 hold for $H_{\Lambda}(P)$ uniformly in $\Lambda$ and (A.8) tends to zero for the same reason as (A.7).

To conclude, note that by (A.10) and (A.11) we have

$$
\begin{equation*}
\left\|\left(T_{\Lambda}(P)-T(P)\right) \Psi\right\| \leq C_{\Lambda}\left\|(N+1)^{3 / 4} \Psi\right\| \tag{A.12}
\end{equation*}
$$

with $\lim _{\Lambda \rightarrow \infty} C_{\Lambda}=0$. Then, since $N$ is $H(P)$-bounded by construction of $H(P)$, the expression (A.9) also tends to zero in norm as $\Lambda \rightarrow \infty$, which proves the claim.
