# Waves in a random medium: Endpoint Strichartz estimates and number estimates

#### Abstract

In this article we reconsider the problem of the propagation of waves in a random medium in a kinetic regime. The final aim of this program would be the understanding of the conditions which allow to derive a kinetic or radiative transfer equation. Although it is not reached for the moment, accurate and somehow surprising number estimates in the Fock space setting, which happen to be propagated by the dynamics on macroscopic time scales, are obtained. Keel and Tao endpoint Strichartz estimates play a crucial role after being combined with a Cauchy-Kowalevski type argument. Although the whole article is focussed on the simplest case of Schrödinger waves in a gaussian random potential of which the translation into a QFT problem is straightforward, several intermediate results are written in a general setting in order to be applied to other similar problems.

## 1 Introduction

The asymptotic analysis or random homogenization of wave propagation in a random medium, in a kinetic or diffusive regime has motivated several works in the recent decades. It is not our purpose here to give an exhaustive list but we think essentially of two different approaches: the one initiated by G. Papanicolaou and coauthors (see e.g. [FGPS, Pap, RPK]) with a rather complete review by J. Garnier in [Gar] and the one proposed by L. Erdös, H.T. Yau and later with M. Salmhofer in [ErYa][EYS1][EYS2]. Those two approaches formulate their results in terms of a kinetic (or diffusive) evolution equation for some weak limit of scaled Wigner functions. The main difference between the two approaches can be summarized as follows : The first approach presented in [Gar] modeled on the problem of randomly layered media (see [FGPS]) focusses on space-time wave functions, by solving a space-time PDE (it can be a Schrödinger or a wave equation) with random coefficients but with a smooth and essentially deterministic right-hand side. With

[^0]very strong assumptions on the right-hand side of the equation, essentially deterministic and smooth, a kinetic equation is written for the distributional weak limit of the Wigner function associated with the space-time wave function. The work of [ErYa][EYS1][EYS2] is concerned with Cauchy problems, at the quantum level for the Schrödinger equation and semiclassically at a classical level for a linear Boltzmann equation in [ErYa] or a heat equation in [EYS1][EYS2]. The strategy of this second approach consists after writing a Dyson expansion (the iteration of Duhamel's formula), in making an accurate combinatorial analysis of Feynman diagrams which label all the random interaction terms of the expanded Dyson series. This Dyson expansion technique was actually already used for a similar problem by H. Spohn in [Spo]. The final step which gives the asymptotic behaviour of the Wigner transform, essentially relies on the accurate control and expression of the remaining terms of the series by using stationary phase asymptotic expressions for the many oscillating integrals. The results of this second approach always require strong assumptions on the initial data at the initial time $t=0$ and prove weak convergence results at the macroscopic time $t \neq 0$.

The main difficulty in this problem is concerned with the control of recollisions and especially the proof that the asymptotic evolution is Markovian, or given by some semigroup associated to a kinetic of heat equation, although the multiple scattering process of waves could destroy this markovian aspect. Depending on the asymptotic regime, the effective asymptotic evolution could be affected by some memory or non local in time effect. In the considered asymptotic problems, it must be checked that those memory effects vanish asymptotically. In the approach reviewed in [Gar] which is concerned with rather general random fields, this is proved by estimating higher moments. In the approach of [ErYa] the combinatorial accurate analysis of Feynman diagrams, is reminiscent of the accurate control of recollision terms by G. Gallavotti in [Gal] for the classical Lorentz gas problem (Wind tree model). Both approaches bring accurate information about a difficult problem in slightly different frameworks and with various range of applications.

However those results remain unsatifactory from the mathematical point of view and for the following reason: The dynamics of (quantum) waves is given by a semigroup (actually a unitary group when there is no dissipation) and the asymptotic kinetic or diffusive limits are also given by well defined (semi)-groups. In the Cauchy problem approach, one does not yet understand the dynamically stable class of initial data which makes the derivation of a classical kinetic or heat equation possible. Actually the results of [ErYa][EYS1][EYS2] are themselves puzzling because with very specific initial data at time $t=0$, they prove the asymptotic expected behaviour at the macroscopic time $t \neq 0$. But this means that the time evolved quantum state at the macroscopic time $t / 2 \neq 0$, enters in the class of admissible initial data for which the asymptotic evolution can be proved for a nonzero time interval (at the macroscopic scale). Such initial data do not enter in the very specfic class considered at time $t=0$. In the space time approach reviewed in [Gar] the strong assumptions on the right-hand side compared with the weak convergence results of the wave function, have been considered in a negative way. Actually what is called "statistical stability" is shown to fail with rough data (see [Bal]). But no positive answer for a general class of random right-hand side seems to emerge. Although the two approaches are about slightly different problems, they seem related at least for some basic random processes on which we will focus in this article.
Our hope is that such an analysis about the propagation of random waves in a ran-
dom medium should lead to results relying on dynamically stable hypotheses. We are led in this direction by the strategy followed by the second author with Z. Ammari in [AmNi1][AmNi2] where they managed to give a general and robust class of initial data, dynamically stable, such that the quantum mean field dynamics can be followed.
About this very technical question a first attempt was tried by the first author in [Bre]. The idea was to exploit the link between gaussian random fields (and possibly other fields like the poissonian random fields) with quantum field theory. It rapidly appears that the asymptotic problem, of waves in a random medium in a gaussian random field in the kinetic regime, cannot be thought as an infinite semiclassical problem like the bosonic mean field problem. It has some similarities but the strength of the free wave propagator and the translation invariance lead to non quadratic and non "semiclassical" Wick quantized operators. For this reason the coherent state method presented in [Bre] led to an accurate Ansatz, only for $O\left(h^{1 / 2}\right)$ macroscopic times, where $h>0$ is the chosen small parameter, and the derivation of a linear Boltzmann equation was possible only by forcing the markovian nature of the asymptotic evolution by reinitializing on some intermediate time scale the random potential. It was not at all satisfactory. Actually the number estimates that we prove in this article confirm that a coherent state approach cannot work for those problems.

Another issue of this problem is the good understanding of the dispersive properties of the free wave propagator with the asymptotic behaviour of waves in a random medium. The different behaviours expected in small dimension, $d \leq 2$ for the Schrödinger equation in the kinetic regime compared to $d \geq 3$, are closely linked with the time integrability of the dispersion relation ( $L^{1}-L^{\infty}$ estimates). In the community of nonlinear PDE's, Strichartz estimates are known to be more robust and effective than the pointwise in time $L^{1}-L^{\infty}$ estimate. With the endpoint Strichartz estimates proved by Keel and Tao in [KeTa], those inequalities are now well adapted for linear critical problems. This article shows that they actually lead to very accurate and somehow surprising "number estimates" with some non trivial consequences.

Before giving the outline of this text, let us point out some limitations and features of the present analysis:

- We are not yet able to derive a full kinetic equation, except if one makes some connection with the existing results of [ErYa]. The class of good initial data for which an asymptotic equation can be written is not yet identified.
- We work essentially with the Schrödinger equation in the presence of a gaussian random potential in the kinetic regime, as what we think to be the simplest, and richest model problem from the point of view of available structures.
- Once the two previous points are made clear, the interested reader will realize that several argument, especially the one making use of Strichartz estimates, have been written in a sufficiently general framework in order to be transposed in another framework.
- Some results like the possibility to define Wigner measures for all times, the localization in energy of the propagation phenomena, the class of potential corre-
sponding to the scale invariant potential for Strichartz estimates, definitely bring a partial but accurate information.

Our main results are about accurate number estimates, stated in Proposition 4.5 in a rather general abstract setting and in Theorem 5.1 for the case of our model problem of the Schrödinger equation with a gaussian translation invariant potential in the kinetic regime and dimension $d \geq 3$.

## Outline of the article;

a) In Section 2 the link between gaussian Hilbert spaces and the bosonic Fock space is recalled and the equations in which we are interested are explicitely written.
b) In Section 3 the translation invariance is used in order to make appear in a crucial way the center of mass variable, with respect to the position of the field variable. The expression of the creation and annihiliation operators are given explicitely in the center of mass and relative variables and finally $L^{p}$-estimates are carefully checked for those creation and annihilation operators under the suitable assumptions on the potential.
c) Section 4 reviews the known results about endpoint Strichartz estimates, and gives consequences in connection with the $L^{p}$-estimate in the center of mass given in Section 3. Then a rather general fixed point is proved which combines endpoint Strichartz estimates with an adaptation of Cauchy-Kowalevski techniques.
d) In Section 5, the general assumptions of Section 4 are checked in the framework of the Schrödinger equation with a gaussian random field in the kinetic regime and ambient dimension $d \geq 3$.
e) Consequences and a priori information, for the asymptotic evolution of Wigner functions are given in Section 6, withouth computing them.
f) Finally various approximation or stability results are deduced as consequences of the general estimates proved in Sections 4, 5 and 6.

Before starting, be aware of the following assumed framework and conventions:

All our Hilbert spaces, real or complex, are separable. All measures are assumed sigma-finite. On a set $\mathscr{X}$ endowed with a sigma-set, a generic sigma-finite measure will be denoted dx , while the normal calligraphy $d x$ will be reserved for the Lebesgue measure on $\mathscr{X}=\mathbb{R}^{d}$. When $(\mathscr{X}, \mathbf{d x})$ and $(\mathscr{Y}, \mathbf{d y})$ are two sigma-finite measured spaces, the notation $L_{x}^{p} L_{y}^{q}, 1 \leq p, q \leq+\infty$, is used for $L^{p}\left(\mathscr{X}, \mathbf{d x} ; L^{q}(\mathscr{Y}, \mathbf{d y})\right)$. However a more general version of $L_{x}^{p} L_{y}^{q}$ will be introduced in Subsection 3.2.

## 2 Random fields and Fock space

### 2.1 Gaussian Hilbert space and random fields

Let $\mathscr{G}$ be the stochastic gaussian measure (see e.g. [Jan]) on the Lebesgue measured space $\left(\mathbb{R}^{d}, \mathscr{L}, d y\right)$. This defines a real Hilbert gaussian space indexed by $L^{2}\left(\mathbb{R}^{d}, d y ; \mathbb{R}\right)$ which is generated, as a Hilbert space, by the centered real gaussian variables $X_{A} \sim N(0,|A|)$, with $A$ measurable set of $\mathbb{R}^{d}$ and $|A|=\int_{A} d y$. By Minlös theorem (see [Sim]) the space
$L^{2}(\Omega, \mathscr{G} ; \mathbb{R})$ which contains powers of those gaussian processes can be realized with $\Omega=$ $\mathscr{S}^{\prime}\left(\mathbb{R}^{d}, d y ; \mathbb{R}\right)$.
Complex valued elements $F \in L^{2}(\Omega, \mathscr{G} ; \mathbb{C})$ are written $F=\operatorname{Re} F+i \operatorname{Im} F, \operatorname{Re} F, \operatorname{Im} F \in L^{2}(\Omega, \mathscr{G} ; \mathbb{R})$ handled by the $\mathbb{R}$-linearity of the decomposition.
Once the complexification is fixed in this order (see [Jan] for an accurate description of various complex structures of gaussian measures), the chaos decomposition of elements in $F \in L^{2}(\Omega, \mathscr{G} ; \mathbb{C})$ can be written

- with the assumed symmetry of the $F_{n}$ components,

Assumptions on the real potential function $V$ will be specified later but we can already compute the product $\mathcal{V}(x, \omega) F(x, \omega)$ by making use of Wick formula (see e.g. [Jan]-Theorem 3.15)

### 2.2 The Fock space presentation

The chaos decomposition (1) provides the isomorphism between $L^{2}(\Omega, \mathscr{G} ; \mathbb{C})$ and the bosonic Fock space

The above direct sum is also the Hilbert completed direct sum. Note that the Fock space norm (8) differs from the $\mathfrak{h}^{\circ n}$-norm chosen in [Jan] in adequation with Wick products by a factor $\sqrt{n!}$. The unitary operator from $L^{2}(\Omega, \mathscr{G} ; \mathbb{C})$ to $\Gamma\left(L^{2}\left(\mathbb{R}_{y}^{d}, d y ; \mathbb{C}\right)\right)$ is thus given by

The Fock space $\Gamma(\mathfrak{h})$ is endowed with densely defined Wick-quantized operators. For a monomial symbol $b(z)=\left\langle z^{\otimes q}, \tilde{b} z^{\otimes p}\right\rangle$ with $\tilde{b} \in \mathscr{L}\left(\mathfrak{h}^{\otimes p} ; \mathfrak{h}^{\otimes q}\right)$, the Wick quantization $b^{\text {Wick }}$ is defined on $\bigoplus_{n \in \mathbb{N}}^{\text {alg }} \mathfrak{h}^{\odot n}$ by

Remember also that more generally, if $(A, D(A))$ generates a strongly continuous semigroup of contractions $e^{t A}, t \geq 0$, then $\Gamma\left(e^{t A}\right) f_{n}=\left[e^{t A}\right]^{\otimes n} f_{n}$ defines a strongly continuous semigroup of contractions $\Gamma\left(e^{t A}\right)$ on $\Gamma(\mathfrak{h})$ with generator denoted by ( $d \Gamma(A), D(d \Gamma(A))$ ), which extends the above definition of $d \Gamma(A)$. In particular this makes sense for $A=-i B$ with $(B, D(B))$ self-adjoint on $\mathfrak{h}$ and $(d \Gamma(B), D(d \Gamma(B)))$ is a self-adjoint operator on $\Gamma(\mathfrak{h})$ when $(B, D(B))$ is self-adjoint on $\mathfrak{h}$.
According to (5)(6), random $L^{2}\left(\mathbb{R}^{d}, d x ; \mathbb{C}\right)$ functions $F(x, \omega)$ can be written as elements $f$ of $L^{2}\left(\mathbb{R}^{d}, d x ; \mathbb{C}\right) \otimes \Gamma\left(L^{2}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)\right)$,

\text { with } \quad & f_{n} \in L_{\mathrm{sym}}^{2}\left(\mathbb{R}_{x}^{d} \times \mathbb{R}^{d n}, d x d y_{1} \cdots d y_{n} ; \mathbb{C}\right), \\
& \|F\|_{L^{2}\left(\mathbb{R}^{d} \times \Omega, d x \otimes \mathscr{G}\right)}^{2}=\sum_{n=0}^{\infty}\left\|f_{n}\right\|_{L^{2}\left(\mathbb{R}^{d} \times \mathbb{R}^{d n}, d x d y_{1} \cdots d y_{n}\right)}^{2},
\end{array}
$$

and where $L_{\text {sym }}^{2}$ refers to the exchange symmetry in the $y$-variables.
When $V \in L^{2}\left(\mathbb{R}^{d}, d y ; \mathbb{R}\right)$ and $\mathscr{V}(x, \omega)=\int_{\mathbb{R}^{d}} V(y-x) X_{y} d y$, the Wick product formula (7) for $\mathcal{V}(x, \omega) F(x, \omega)$ is transformed into

With the notation $D_{y}=\frac{1}{i} \partial_{y}=\left(\begin{array}{c}\frac{1}{i} \partial_{y^{1}} \\ \vdots \\ \frac{1}{i} \partial_{y^{d}}\end{array}\right)$ the operator $\left(x \cdot D_{y}, D\left(x \cdot D_{y}\right)\right)$, with $x \cdot D_{y}=\sum_{k=1}^{d} x^{k} D_{y^{k}}$, is essentially self-adjoint on $\mathscr{S}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)$ for all $x \in \mathbb{R}^{d}$. This defines a strongly continuous unitary representation of the additive group $\left(\mathbb{R}_{x}^{d},+\right)$ on $L^{2}\left(\mathbb{R}_{x}^{d}\right) \otimes \Gamma\left(L^{2}\left(\mathbb{R}_{y}^{d}\right)\right)$ given by

e^{-i x \cdot d \Gamma\left(D_{y}\right)}\left(\bigoplus_{n=0}^{\infty} f_{n}\left(x, y_{1}, \ldots, y_{n}\right)\right)=\bigoplus_{n=0}^{\infty} f_{n}\left(x, y_{1}-x, \ldots, y_{n}-x\right)
$$

Therefore the above unitary correspondence $F(x, \omega) \mapsto f(x,-x)$ gives a unitary correspondence

F \in L^{2}\left(\mathbb{R}^{d} \times \Omega, d x \otimes \mathscr{G} ; \mathbb{C}\right) \mapsto f \in L^{2}\left(\mathbb{R}^{d}, d x ; \mathbb{C}\right) \otimes \Gamma\left(L^{2}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)\right) \tag{11}
\end{equation*}
$$

while (10) becomes for $V \in L^{2}\left(\mathbb{R}^{d}, d y ; \mathbb{R}\right)$

We now translate a general pseudo-differential operator in the $x$-variable, $a^{\text {Weyl }}\left(x, D_{x}\right) \otimes$ $\mathrm{Id}_{L^{2}(\Omega, \varphi ; C)}$ under the above transformation (11).
When $\mathfrak{h}$ is a complex Hilbert space, we recall that $L^{2}\left(\mathbb{R}^{d}, d x ; \mathbb{C}\right) \otimes \mathfrak{h}$ equals $L^{2}\left(\mathbb{R}^{d}, d x ; \mathfrak{h}\right)$ and

- the Fourier transform, with the normalization

F u(\xi)=\int_{\mathbb{R}^{d}} e^{-i \xi \cdot x} u(x) d x, \quad F^{-1} v(x)=\int_{\mathbb{R}^{d}} e^{i x \cdot \xi} v(\xi) \frac{d \xi}{(2 \pi)^{d}},
$$

is unitary from $L^{2}\left(\mathbb{R}^{d}, d x ; \mathfrak{h}\right)$ to $L^{2}\left(\mathbb{R}^{d}, \frac{d \xi}{(2 \pi)^{d}} ; \mathfrak{h}\right)$;

- $\mathscr{S}\left(\mathbb{R}^{d} ; \mathfrak{h}\right), \mathscr{S}^{\prime}\left(\mathbb{R}^{d} ; \mathfrak{h}\right)$ and the Fourier transform have the same properties as in the scalar case $\mathfrak{h}=\mathbb{C}$.

Be aware that the behavior of the Fourier transform when $\mathfrak{h}$ is a general Banach space is more tricky according to [Pee]. So when $\mathfrak{h}$ is a Hilbert space, we consider pseudodifferential operators in the $x$-variable of the form $a^{\text {Weyl }}\left(x, D_{x}\right)=a^{\text {Weyl }}\left(x, D_{x}\right) \otimes \mathrm{Id}_{\mathfrak{h}}$ for a symbol $a \in \mathscr{S}^{\prime}\left(\mathbb{R}_{x, \xi}^{2 d} ; \mathbb{C}\right)$ given by its Schwartz' kernel

\left[a^{\mathrm{Weyl}}\left(x, D_{x}\right)\right](x, y)=\int_{\mathbb{R}^{d}} e^{i(x-y) \cdot \xi} a\left(\frac{x+y}{2}, \xi\right) \frac{d \xi}{(2 \pi)^{d}} .
$$

When $\mathfrak{h}=\mathbb{C}, a^{\text {Weyl }}\left(x, D_{x}\right)$ is a continuous endomorphism of $\mathscr{S}\left(\mathbb{R}_{x}^{d} ; \mathbb{C}\right)$ and $\mathscr{S}^{\prime}\left(\mathbb{R}^{d} ; \mathbb{C}\right)$ with the formal adjoint $\bar{a}^{\mathrm{Weyl}}\left(x, D_{x}\right)$ and the alternative representations:

- When $v, u \in \mathscr{S}\left(\mathbb{R}^{d} ; \mathbb{C}\right)$,

\left\langle v, a^{\text {Weyl }}\left(x, D_{x}\right) u\right\rangle=\int_{\mathbb{R}^{2 d}} a(x, \xi) W[v, u](x, \xi) \frac{d x d \xi}{(2 \pi)^{d}}

where $W[v, u]$ is the Wigner function of the pair $[v, u]$ (or the Weyl symbol of $|u\rangle\langle v|$ ), given by

and which belongs to $\mathscr{S}\left(\mathbb{R}^{2 d} ; \mathbb{C}\right)$.

- By setting $\llbracket P, X \rrbracket=p_{\xi} \cdot x-p_{x} \cdot \xi$ for $P=\left(p_{x}, p_{\xi}\right), X=(x, \xi)$ in $\mathbb{R}^{2 d}=T^{*} \mathbb{R}^{d}$, and

\mathscr{F} a(P)=\int_{\mathbb{R}^{2 d}} e^{i[P P, X]} a(X) \frac{d X}{(2 \pi)^{d}}
$$

we have $a=\mathscr{F}(\mathscr{F} a)$ in $\mathscr{S}^{\prime}\left(\mathbb{R}^{2 d}\right)$. When $\mathscr{F} a \in L^{1}\left(\mathbb{R}^{2 d} ; \mathbb{C}\right)$,

a^{\mathrm{Weyl}}\left(x, D_{x}\right)=\int_{\mathbb{R}^{2 d}} \mathscr{F} a(P) \tau_{P} \frac{d P}{(2 \pi)^{d}},
$$

where $\tau_{P}=e^{i\left(p_{\xi} \cdot x-p_{x} \cdot D_{x}\right)}=\left[e^{i\left(p_{\xi} \cdot x-p_{x} \cdot \xi\right)}\right]^{\text {Weyl }}\left(x, D_{x}\right)$ is the unitary phase translation

$$
\tau_{P} u(x)=e^{i p_{\xi} \cdot\left(x-p_{x} / 2\right)} u\left(x-p_{x}\right) .
$$

In particular, the above integral is a $\mathscr{L}\left(L^{2}\left(\mathbb{R}^{d}, d x ; \mathbb{C}\right)\right.$ )-integral when $\mathscr{F} a \in L^{1}\left(\mathbb{R}^{2 d}, d P ; \mathbb{C}\right)$ and a fortiori when $a \in \mathscr{S}\left(\mathbb{R}^{2 d} ; \mathbb{C}\right)$.

With those two remarks, for a general $a \in \mathscr{S}^{\prime}\left(\mathbb{R}^{2 d} ; \mathbb{C}\right)$ the integral

can be interpreted as the weak limit

a^{\mathrm{Weyl}}\left(x, D_{x}\right)=\underset{n \rightarrow \infty}{\mathrm{w}-\lim _{\infty}} \int_{\mathbb{R}^{2 d}} \mathscr{F} a_{n}(P) e^{i\left(p_{\xi} \cdot x-p_{x} \cdot D_{x}\right)} \frac{d P}{(2 \pi)^{d}},
$$

where $a_{n} \in \mathscr{S}\left(\mathbb{R}^{2 d} ; \mathbb{C}\right)$ is any approximation of $a \in \mathscr{S}^{\prime}\left(\mathbb{R}^{2 d} ; \mathbb{C}\right)$.
While considering the $a^{\text {Weyl }}\left(x, D_{x}\right) \otimes \operatorname{Id}_{\mathfrak{h}}$, the same construction makes sense after noticing that for $u, v \in \mathscr{S}\left(\mathbb{R}^{d} ; \mathfrak{h}\right)$, the Wigner transform $W[v, u]$ belongs to $\mathscr{S}\left(\mathbb{R}_{x, ;}^{2 d} ; \mathscr{L}^{1}(\mathfrak{h})\right)^{2}$ and

\left\langle v, a^{\text {Weyl }}\left(x, D_{x}\right) u\right\rangle=\operatorname{Tr}\left[\left[a^{\text {Weyl }}\left(x, D_{x}\right) \otimes \operatorname{Id}_{\mathfrak{h}}\right]|u\rangle\langle v|\right]=\int_{\mathbb{R}^{2 d}} a(x, \xi) \operatorname{Tr}[W[v, u]](x, \xi) \frac{d x d \xi}{(2 \pi)^{d}} .

We apply this with $\mathfrak{h}=L^{2}(\Omega, \mathscr{G} ; \mathbb{C})$ and $\mathfrak{h}=\Gamma\left(L^{2}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)\right)$ : We start from

the correspondance

a^{\text {Weyl }}\left(x, D_{x}\right) F \mapsto e^{i x \cdot d \Gamma\left(D_{y}\right)} a^{\text {Weyl }}\left(x, D_{x}\right) e^{-i x \cdot d \Gamma\left(D_{y}\right)} f,
$$

and

e^{i x \cdot \lambda} e^{i\left(p_{\xi} \cdot x-p_{x} \cdot D_{x}\right)}\left(e^{-i x \cdot \lambda} \times\right)=e^{i\left(p_{x} \cdot x-p_{x} \cdot\left(D_{x}-\lambda\right)\right)} \quad \text { for all } \lambda \in \mathbb{R}^{d}
$$

which gives by the functional calculus, the equality of unitary operators

e^{i x \cdot d \Gamma\left(D_{y}\right)} e^{i\left(p_{\xi} \cdot x-p_{x} \cdot D_{x}\right)}\left(e^{-i x \cdot d \Gamma\left(D_{y}\right)}\right)=e^{i\left(p_{x} \cdot x-p_{x} \cdot\left(D_{x}-d \Gamma\left(D_{y}\right)\right)\right)} .
$$

We deduce that for $a \in \mathscr{S}^{\prime}\left(\mathbb{R}^{2 d} ; \mathbb{C}\right), a^{\text {Weyl }}\left(x, D_{x}\right) F \in \mathscr{S}^{\prime}\left(\mathbb{R}_{x}^{d} ; L^{2}(\Omega, \mathscr{G} ; \mathbb{C})\right)$ is transformed into

a^{\text {Weyl }}\left(x, D_{x}\right) F \mapsto a^{\text {Weyl }}\left(x, D_{x}-d \Gamma\left(D_{y}\right)\right) f \in \mathscr{S}^{\prime}\left(\mathbb{R}^{d} ; \Gamma\left(L^{2}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)\right)\right) . \tag{13}
\end{equation*}

with

a^{\mathrm{Weyl}}\left(x, D_{x}-d \Gamma\left(D_{y}\right)\right)=\mathrm{w}_{n \rightarrow \infty} \lim _{\mathbb{R}^{2 d}} \mathscr{F} a_{n}(P) e^{i\left(p_{\xi} \cdot x-p_{x} \cdot\left(D_{x}-d \Gamma\left(D_{y}\right)\right)\right)} \frac{d P}{(2 \pi)^{d}} .
$$

Let us continue by applying the Fourier transform in the $x$-variable with

and set for $f \in \mathscr{S}^{\prime}\left(\mathbb{R}_{x}^{d} ; \Gamma\left(L^{2}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)\right)\right)$

\hat{f}=F_{x} f \in \mathscr{S}^{\prime}\left(\mathbb{R}^{d} ; \Gamma\left(L^{2}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)\right)\right) .
$$

With

F_{x} a^{\text {Weyl }}\left(x, D_{x}\right) F_{x}^{-1}=a^{\text {Weyl }}\left(-D_{\xi}, \xi\right)
$$

[^2]where the functional calculus leads to $F_{x} a^{\mathrm{Weyl}}\left(x, D_{x}-d \Gamma\left(D_{y}\right)\right) F_{x}^{-1}=a^{\mathrm{Weyl}}\left(-D_{\xi}, \xi-d \Gamma\left(D_{y}\right)\right)$, we obtain the unitary correspondence

& F(x, \omega)=\sum_{n=0}^{\infty} \int_{\mathbb{R}^{d n}} \frac{1}{\sqrt{n!}} f_{n}\left(x, y_{1}-x, \ldots, y_{n}-x\right): X_{y_{1}} \cdots X_{y_{n}}: d y_{1} \cdots d y_{n} \tag{15}
\end{align*}

and where (12) and (13) become

& \underbrace{a^{\mathrm{Weyl}}\left(x, D_{x}\right) F}_{\in \mathscr{S}^{\prime}\left(\mathbb{R}_{\xi}^{d} ; L^{2}(\Omega, \mathscr{G} ; \mathbb{C})\right)} \mapsto \underbrace{a^{\mathrm{Weyl}}\left(-D_{\xi}, \xi-d \Gamma\left(D_{y}\right)\right) \hat{f}}_{\in \mathscr{S}^{\prime}\left(\mathbb{R}_{\xi}^{d} ; \Gamma\left(L^{2}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)\right)\right)} \tag{17}

From this point of view, the Fock space and functional analysis presentation is simpler than sticking with the usual chaos decomposition (4) where Fourier transforms and pseudo-differential operators do not seem to have simple probabilistic interpretation.

Remark 2.1. As a final remark, all the above constructions can be tensorized with an additional separable Hilbert space $\mathfrak{h}^{\prime}=L^{2}(Z, \mathbf{d z} ; \mathbb{C})$.

### 2.3 Our problem

We aim at studying the stochastic partial differential equation

i \partial_{t} F=-\Delta_{x} F+\sqrt{h} V F  \tag{18}\\
F(t=0)=F_{0}
\end{array}\right.
$$

where

- $V$ is the translation invariant gaussian random field

$$
\mathcal{V}(x, \omega)=\int_{\mathbb{R}^{d}} V(y-x) X_{y} d y
$$

with $V \in L^{2}\left(\mathbb{R}^{d} ; \mathbb{R}\right)$;

- the solution $F(t, x, \omega, z)$ is seeked in $\mathscr{C}^{0}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d} \times \Omega \times Z, d x \otimes \mathscr{G} \otimes \mathbf{d z} ; \mathbb{C}\right)\right)$;
- $h>0$ is a small parameter which will tend to 0 .

In particular we will consider the asymptotic behavior of quantities

$$
\begin{equation*}
\left\langle F\left(\frac{t}{h}\right), a^{\mathrm{Weyl}}\left(h x, D_{x}\right) F\left(\frac{t}{h}\right)\right\rangle_{L^{2}\left(\mathbb{R}^{d} \times \Omega \times Z\right)}=\int_{Z} \mathbb{E}\left[\left\langle F\left(\frac{t}{h}, z\right), a^{\mathrm{Weyl}}\left(h x, D_{x}\right) F\left(\frac{t}{h}, z\right)\right\rangle_{L^{2}\left(\mathbb{R}^{d}, d x\right)}\right] \mathbf{d z}(z) \tag{19}
\end{equation*}
$$

for $a \in S\left(1, d x^{2}+d \xi^{2}\right)$ and $t \in[0, T]$. Remember that the symbol class $S\left(1, d x^{2}+d \xi^{2}\right)$ is the set of $\mathscr{C}^{\infty}$-functions on $\mathbb{R}^{2 d}$ with all derivatives bounded on $\mathbb{R}^{2 d}$.
Note that the variable $z \in Z$ does not appear in the equation. The dynamics is thus well defined when it is defined for $Z=\left\{z_{0}\right\}$ and $\mathbf{d z}=\delta_{z_{0}}$. A sufficient condition was provided in [Bre] by making use of Nelson commutator method.

Lemma 2.2. Proposition 4.4 in [Bre]: Assume $V \in H^{2}\left(\mathbb{R}^{d} ; \mathbb{R}\right)$ then the operator $-\Delta_{x}+$ $\sqrt{h} V$ is essentially self-adjoint on $\bigoplus_{n \in \mathbb{N}}^{\operatorname{alg}} \mathscr{S}\left(\mathbb{R}_{x}^{d} ;\left(L^{2}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)\right)^{\odot n}\right)$ which is a dense subset of $L^{2}\left(\mathbb{R}_{x}^{d}, d x ; L^{2}(\Omega, \mathscr{G} ; \mathbb{C})\right)=L^{2}\left(\mathbb{R}^{d} \times \Omega, d x \otimes \mathscr{G} ; \mathbb{C}\right)$ by $(4)$.

Remark 2.3. A side corollary of our analysis says that the dynamics is well defined under the assumption $V \in L^{r_{\sigma}^{\prime}}\left(\mathbb{R}^{d} ; \mathbb{R}\right)$ with $r_{\sigma}^{\prime}=\frac{2 d}{d+2}$ in dimension $d \geq 3$, See Subsection 7.4 at the end of the article.

Lemma 2.2 provides a natural self-adjoint realization of $-\Delta_{x}+\sqrt{h} \mathcal{V}$ in $\mathfrak{h}=L^{2}\left(\mathbb{R}^{d} \times \Omega \times\right.$ $Z, d x \otimes \mathscr{G} \otimes \mathbf{d z} ; \mathbb{C})$ and any initial datum $F_{0} \in \mathfrak{h}$ defines a unique solution $F \in \mathscr{C}^{0}(\mathbb{R} ; \mathfrak{h})$.
There are various reasons for introducing an additional variable $z \in Z$, and this trick will be used repeatedly. One of them is the following: Starting with $Z=\left\{z_{0}\right\}$ and $\mathbf{d z}=\delta_{z_{0}}$, one may consider instead of $F\left(\frac{t}{h}\right)=U_{\mathcal{V}}\left(\frac{t}{h}\right) F_{0}$ with $U_{\mathcal{V}}(t)=e^{-i t\left(-\Delta_{x}+\sqrt{h} \mathcal{V}\right)}$, the evolution of a state

$$
\varrho\left(\frac{t}{h}\right)=U_{\mathscr{V}}\left(\frac{t}{h}\right) \varrho_{0} U_{\mathscr{V}}^{*}\left(\frac{t}{h}\right)
$$

with $\varrho_{0} \in \mathscr{L}^{1}\left(L^{2}\left(\mathbb{R}^{d} \times \Omega ; \mathbb{C}\right)\right), \varrho_{0} \geq 0, \operatorname{Tr}\left[\varrho_{0}\right]=1$ possibly replacing $\left\|F_{0}\right\|_{L^{2}}=1$. By writing $\varrho_{0}=\varrho_{0}^{1 / 2} \varrho_{0}^{1 / 2}$ one gets

We will see that the variable $\xi \in \mathbb{R}^{d}$ and even some part $Y^{\prime}$ of the variable $Y=\left(y_{1}, \ldots, y_{n}\right)$, when the total number is fixed to $n$, can be taken as another parameter like $z \in Z$ for some points of the analysis. This leads to a parameter $z^{\prime}$-dependent, $z^{\prime}=\left(\xi, Y^{\prime}, z\right) \in \mathbb{R}^{d} \times \mathbb{R}^{d n^{\prime}} \times Z$, analysis in $L^{2}\left(\mathbb{R}^{d\left(n-n^{\prime}\right)}, d Y^{\prime \prime}\right)$. Those parameters appear in Section 3 by introducing the center of mass $Y^{\prime \prime}=y_{G}=\frac{y_{1}+\cdots+y_{n}}{n}$ and the relative coordinates $y_{j}^{\prime}=y_{j}-y_{G}$, a general functional framework for parameter dependent Strichartz estimates and their consequences are presented in Section 4 and finally those are detailled in Section 5 for (20).

## 3 The Fock space and the center of mass

According to (20) our stochastic dynamics has been translated in a parameter dependent dynamics in the Fock space. We shall consider an additional unitary transform using the center of mass and the relative variables

in the $n$-particles sector, $n \geq 1$. It trivializes the free dynamics when $V \equiv 0$ or $V \equiv 0$. The expression of the interaction term $\sqrt{2 h} \phi(V)$ becomes more tricky but various general estimates are given here.

### 3.1 The unitary transform associated with the center of mass

We shall use the following notations for $n \geq 1$ :

- A generic element of $\mathbb{R}^{d n}$ will be written

\left[a_{G}^{*}(V) f_{G, n}\right]\left(y_{G}, Y_{n+1}^{\prime}\right)=\sqrt{n+1} S_{n+1}\left[V\left(y_{G}+y_{n+1}^{\prime}\right) f_{G, n}\left(y_{G}-\frac{y_{n+1}^{\prime}}{n}, Y_{n}+\frac{y_{n+1}^{\prime}}{n}\right)\right]
$$

with $Y_{n}=\left(y_{1}^{\prime}, \ldots, y_{n}^{\prime}\right)$.

### 3.2 General $L_{x}^{p} L_{y}^{q}$ spaces

When ( $\mathscr{X}, \mathbf{d x}$ ) and ( $\mathscr{Y}, \mathbf{d y}$ ) are sigma-finite measured spaces $L_{x}^{p} L_{y}^{q}, 1 \leq p, q \leq+\infty$, denotes the space $L_{x}^{p} L_{y}^{q}=L^{p}\left(\mathscr{X}, \mathbf{d} \mathbf{x} ; L^{q}(\mathscr{Y}, \mathbf{d y})\right)$. This shortened notation is especially useful when estimates are written in those spaces, like in Strichartz estimates (see Section 4). However the final space of the unitary map $U_{G}$ in (28) shows already that the product space $\mathscr{X} \times \mathscr{Y}$ is too restrictive. Below is a convenient generalization.

Definition 3.4. Let $\left(\mathscr{X}_{n}, \mathbf{d} \mathbf{x}_{\mathbf{n}}\right)_{n \in \mathscr{N}}$ and $\left(\mathscr{Y}_{n}, \mathbf{d y}_{\mathbf{n}}\right)_{n \in \mathcal{N}}$ be at most countable families $(\mathscr{N} \subset$ $\mathbb{N}$ ) of sigma-finite measured spaces. Let $\mathscr{X}=\sqcup_{n \in \mathscr{N}} \mathscr{X}_{n}$ and $\mathscr{Y}=\sqcup_{n \in \mathscr{N}} \mathscr{Y}_{n}$ be endowed with the measures $\mathbf{d x}=\Sigma_{n \in \mathcal{N}} \mathbf{d} \mathbf{x}_{\mathbf{n}}$ and $\mathbf{d y}=\Sigma_{n \in \mathcal{N}} \mathbf{d y}_{\mathbf{n}}$. In this framework, the space $L_{x}^{p} L_{y}^{q}$, $1 \leq p, q \leq+\infty$, will denote the closed subspace of $L^{p}\left(\mathscr{X}, \mathbf{d} \mathbf{x} ; L^{q}(\mathscr{Y}, \mathbf{d y})\right)$ given by

L_{x}^{p} L_{y}^{q}=\left\{f \in L^{p}\left(\mathscr{X}, \mathbf{d} \mathbf{x} ; L^{q}(\mathscr{Y}, \mathbf{d y})\right), \quad f(x, y)=\sum_{n \in \mathscr{N}} 1_{\mathscr{X}_{n}}(x) 1_{\mathscr{O}_{n}}(y) f(x, y) \quad \text { a.e. }\right\}
$$

The above definition is coherent with the specific product case, which is the particular case $\mathscr{N}=\{0\}$. The differences will be clear from the different frameworks when $\left(\mathscr{X}_{n}, \mathbf{d x}_{\mathbf{n}}\right)_{n \in \mathcal{N}}$ and $\left(\mathscr{Y}_{n}, \mathbf{d y}_{\mathbf{n}}\right)_{n \in \mathcal{N}}$ will be specified.
The two following properties of the product case are still valid in this extended framework:

- The dual of $L_{x}^{p} L_{y}^{q}, 1 \leq q, p<+\infty$ is $L_{x}^{p^{\prime}} L_{y}^{q^{\prime}}$ with $\frac{1}{q^{\prime}}+\frac{1}{q}=1$ and $\frac{1}{p^{\prime}}+\frac{1}{p}=1$.
- Minkowski's inequality says

Below are examples, associated with the decomposition associated with the introduction of the center of mass (23) and the relative coordinates (24), where those notations will be used

The notation $L_{\left(Y_{n}^{\prime}, z^{\prime}\right), \mathrm{sym}}^{p} L_{y_{G}}^{q}$ will stand for the closed subspace of functions which are symmetric with respect to the variables $Y_{n}^{\prime} \in \mathscr{R}_{n}$.

- $\mathscr{N}=\{0,1\}$ with

With the same convention as above for $L_{\left(Y^{\prime}, z^{\prime}\right), \mathrm{sym}}^{p} L_{y_{G}}^{q}$, which refers to the symmetry for the $Y^{\prime} \in \mathscr{R}$ variable, the formula (28) becomes

The general spaces $L_{\left(Y^{\prime}, z^{\prime}\right) \text { sym }}^{2} L_{y_{G}}^{p}, 1 \leq p \leq+\infty$, will be especially useful after Section 4.

## 3.3 $L_{y_{G}}^{p}$-Estimates for $a_{G}(V)$ and $a_{G}^{*}(V)$

General $L^{p}$-esptimates, or more precisely $L_{\left(Y^{\prime}, z\right) \text {,sym }}^{2} L_{y_{G}}^{p}$-estimates, are proved in this paragraph for the operators $a_{G}(V)$ and $a_{G}^{*}(V)$. The use of the center of mass and the $L_{y_{G}}^{p}$ spaces, will be extremely useful for the application of Strichartz estimates in Section 4. Let us start with a simple application of Young's inequality.

Lemma 3.5. For any $q^{\prime}, p^{\prime} \in[1,2]$ such that $q^{\prime} \leq p^{\prime}$, let $r^{\prime} \in[1,2]$ be defined by $\frac{1}{r^{\prime}}=\frac{1}{2}+\frac{1}{q^{\prime}}-$ $\frac{1}{p^{\prime}}$. The inequality

holds for all $V \in L^{r^{\prime}}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)$ and all $\varphi \in L^{p^{\prime}}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)$.
Proof. The conditions $\frac{1}{r^{\prime}}+\frac{1}{p^{\prime}}=\frac{1}{2}+\frac{1}{q^{\prime}}, 1 \leq q^{\prime} \leq p^{\prime} \leq 2$, ensure

Young's inequality with $\frac{1}{\tilde{r}}+\frac{1}{\tilde{p}}=\frac{1}{\frac{2}{q^{\prime}}}+1$ and $\tilde{r}, \tilde{p}, \frac{2}{q^{\prime}} \geq 1$ yields

\left.\left\|V\left(y_{G}+y^{\prime}\right) \varphi\left(y_{G}\right)\right\|_{L_{y^{\prime}}^{2} L_{y_{G}}^{q^{\prime}}} \leq\left\||V|\left(y_{G}-y^{\prime}\right)|\varphi|\left(y_{G}\right)\right\|_{L_{y^{2}}^{2}} L_{y_{G}}^{q^{\prime}}=\| \mid V(-)\right)\left.\right|^{q^{\prime}} & *|\varphi|^{q^{\prime}} \|_{L^{2 / q} / q^{\prime}}^{1 / q^{\prime}} \\
& \leq\left\||V|^{q^{\prime}}\right\|_{L^{r}}^{1 / q^{\prime}}\left\||\varphi|^{q^{\prime}}\right\|_{L^{p}}^{1 / q^{\prime}}
\end{aligned}
$$

By taking $\tilde{p}=\frac{p^{\prime}}{q^{\prime}} \in[1,2]$ and $r^{\prime}=\tilde{r} q^{\prime}$ we obtain

The first result concerns the action of $a_{G}(V)$ and $a_{G}^{*}(V)$ on a fixed finite particles sector.

Proposition 3.6. For any $p^{\prime}, q^{\prime} \in[1,2]$ such that $q^{\prime} \leq p^{\prime}, 2 \leq p \leq q \leq+\infty$, let $r^{\prime} \in[1,2]$ be defined by $\frac{1}{r^{\prime}}=\frac{1}{2}+\frac{1}{q^{\prime}}-\frac{1}{p^{\prime}}$ like in Lemma 3.5. For any $V \in L^{q^{\prime}}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right) \cap L^{r^{\prime}}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)$, the creation and annihilation operators satisfy the following estimates:

& \forall n>0, \forall f_{G, n} \in L_{\left(Y_{n}^{\prime}, z\right), \text { sym }}^{2} L_{y_{G}}^{p^{\prime}},\left\|a_{G}^{*}(V) f_{G, n}\right\|_{L_{\left(y_{n+1}^{\prime, ~}\right.}^{2}} L_{y_{G}}^{q^{\prime}} \leq\|V\|_{L^{r^{\prime}}} \sqrt{n+1}\left\|f_{G, n}\right\|_{L_{\left(y_{n}^{\prime}, 2\right)}^{2}} L_{y_{G}}^{p^{\prime}},  \tag{37}\\
& \forall f_{G, 1} \in L_{z}^{2} L_{y_{G}}^{q},\left\|a_{G}(V) f_{G, 1}\right\|_{L_{z}^{2}} \leq\|V\|_{L^{q^{\prime}}}\left\|f_{G, 1}\right\|_{L_{z}^{2} L_{y_{G}}^{q}},  \tag{38}\\
& \forall n>1, \forall f_{G, n} \in L_{\left(Y_{n}^{\prime}, z\right), \text { sym }}^{2} L_{y_{G}}^{q},\left\|a_{G}(V) f_{G, n}\right\|_{L_{\left(Y_{n-1}^{\prime}, n\right)}^{2}} L_{y_{G}}^{p} \leq\|V\|_{L^{r^{\prime}}} \sqrt{n}\left\|f_{G, n}\right\|_{L_{\left(Y_{n}^{\prime}, 2\right)}^{2}} L_{y_{G}}^{q} . \tag{39}

A notable case is when $q^{\prime}=r^{\prime}$ and $p^{\prime}=p=2$.
Proof. The variable $z \in Z$ is actually a parameter which can be forgotten because our estimates are uniform w.r.t. $z \in Z$.
For (36) it suffices to notice $\left[a_{G}^{*}(V) f_{G, 0}\right]\left(y_{G}\right)=f_{G, 0} \times V\left(y_{G}\right)$.
The estimate of $a_{G}^{*}(V) f_{G, n}$ for $n>0$ relies on Lemma 3.5. We start from the expression (34)

The symmetrization $S_{n+1}$ simply takes the average of $n+1$-terms which have all the same form as

We can therefore forget the symmetrization $S_{n+1}$ for proving the upper bound (37). When $n>1$ integrations must be performed with respect to the independent variables $\left(y_{2}^{\prime}, \ldots, y_{n}^{\prime}\right) \in$ $\mathbb{R}^{d(n-1)}$. Remember that $\left(y_{2}^{\prime}, \ldots, y_{n}^{\prime}, y_{n+1}^{\prime}\right)$ are coordinates on $\mathscr{R}^{n+1}$ such that $y_{1}^{\prime}=-y_{2}^{\prime} \cdots-$ $y_{n}^{\prime}-y_{n+1}^{\prime}, d \mu_{n+1}\left(Y_{n+1}^{\prime}\right)=(n+1)^{d} d y_{2}^{\prime} \cdots d y_{n+1}^{\prime}$ and that the quantity

$$

When $y_{n+1}^{\prime} \in \mathbb{R}^{d}$ is fixed, setting $y_{1}^{\prime}=-\sum_{j=2}^{n}\left(y_{h}^{\prime}+\frac{y_{n+1}^{\prime}}{n}\right)$ and $Y_{n}^{\prime}=Y_{n}+\frac{y_{n+1}^{\prime}}{n}$, provides the coordinates $\left(y_{2}^{\prime}+\frac{y_{n+1}^{\prime}}{n}, \ldots, y_{n}^{\prime}+\frac{y_{n+1}^{\prime}}{n}\right)$ on $\mathscr{R}^{n}$ with $d \mu_{n}\left(Y_{n}^{\prime}\right)=n^{d / 2} d y_{2}^{\prime} \cdots d y_{n}^{\prime}$, and then $\| V\left(y_{G}+\right.$ $\left.y_{n+1}^{\prime}\right) f_{G, n}\left(y_{G}-\frac{y_{n+1}^{\prime}}{n}, Y_{n}+\frac{y_{n+1}^{\prime}}{n}\right) \|_{L^{2}\left(\mathbb{R}^{d(n-1)}, d y_{2}^{\prime} \cdots d y_{n}^{\prime} ; L_{y_{G}}^{q^{\prime}}\right)}$ equals $\left.n^{-d / 2}\left\|V\left(y_{G}+y_{n+1}^{\prime}\right) f_{G, n}\left(y_{G}-\frac{y_{n+1}^{\prime}}{n}, Y_{n}^{\prime}\right)\right\|_{L_{Y_{n}^{\prime}}^{2} \prime_{y_{G}}^{q^{\prime}}}=n^{-d / 2}\left\|V\left(\tilde{y}_{G}+\frac{n+1}{n} y_{n+1}^{\prime}\right) f_{G, n}\left(\tilde{y}_{G}, Y_{n}^{\prime}\right)\right\|_{L^{2}\left(Y_{n}^{\prime} L_{\tilde{y}_{G}}^{q^{\prime}}\right.}\right)$.

We deduce

\begin{aligned}
& \left\|V\left(y_{G}+y_{n+1}^{\prime}\right) f_{G, n}\left(y_{G}-\frac{y_{n+1}^{\prime}}{n}, Y_{n}+\frac{y_{n+1}^{\prime}}{n}\right)\right\|_{L_{Y_{n+1}^{\prime}}^{2} L_{y_{G}}^{q^{\prime}}} \\
& \quad \leq \frac{(n+1)^{d / 2}}{n^{d / 2}}\| \| V\left(\tilde{y}_{G}+\frac{n+1}{n} y_{n+1}^{\prime}\right) f_{G, n}\left(\tilde{y}_{G}, Y_{n}^{\prime}\right)\left\|_{L_{Y_{n}^{\prime}}^{2} L_{\tilde{y}_{G}}^{q^{\prime}}}\right\|_{L^{2}\left(\mathbb{R}^{d}, d y_{n+1}^{\prime}\right)} \\
& \quad \leq\| \| V\left(\tilde{y}_{G}+y^{\prime}\right) f_{G, n}\left(\tilde{y}_{G}, Y_{n}^{\prime}\right)\left\|_{L_{Y_{n}^{\prime}}^{2}, \tilde{y}_{G} q^{\prime}}\right\|_{L^{2}\left(\mathbb{R}^{d}, d y^{\prime}\right)} \\
& \quad \leq\| \| V\left(\tilde{y}_{G}+y^{\prime}\right) f_{G, n}\left(\tilde{y}_{G}, Y_{n}^{\prime}\right)\left\|_{L^{2}\left(\mathbb{R}^{d}, d y^{\prime} ; L_{\tilde{y}_{G}}^{q^{\prime}}\right.}\right\|_{L_{Y_{n}^{\prime}}^{2}}
\end{aligned}
$$

after using the change of variable $y^{\prime}=\frac{n+1}{n} y_{n+1}^{\prime}$ in $\mathbb{R}^{d}$ for the third line and $L_{y^{\prime}}^{2} L_{Y_{n}^{\prime}}^{2}=L_{Y_{n}^{\prime}}^{2} L_{y^{\prime}}^{2}$ for the last one. We now use Lemma 3.5 with

for almost all $Y_{n}^{\prime} \in \mathscr{R}^{n}$ and $1 \leq q^{\prime} \leq p^{\prime} \leq 2, \frac{1}{r^{\prime}}=\frac{1}{2}+\frac{1}{q^{\prime}}-\frac{1}{p^{\prime}}$. Integrating w.r.t. $Y_{n}^{\prime} \in \mathscr{R}^{n}$ gives

The estimates with $a_{G}(V)$ follow by duality using

\left\|a_{G}(V) f_{G, n+1}\right\|_{L_{Y_{n+1}^{\prime}}^{2} L_{y_{G}}^{p}=\sup _{\left\|f_{G, n}\right\|_{L_{Y_{n}^{\prime}}^{2}}^{L_{y_{G}}^{p^{\prime}}}}=1}\left|\left\langle a_{G}(V) f_{G, n+1}, f_{G, n}\right\rangle\right| .
$$

Indeed, if $\left\|f_{G, n}\right\|_{L_{Y_{n}}^{2} L_{y_{G}}^{p^{\prime}}}=1$, then

& \leq\left\|f_{G, n+1}\right\|_{L_{Y_{n+1}^{\prime}}^{2}} L_{y_{G}}^{q}\left\|a_{G}^{*}(V) f_{G, n}\right\|_{L_{Y_{n}}^{2}, L_{y_{G}}^{q^{\prime}}} \\
& \leq \begin{cases}\|V\|_{L^{q^{\prime}}}\left\|f_{G, 1}\right\|_{L_{G}}^{q} & \text { when } n=0, \\
\|V\|_{L^{\prime}} \sqrt{n+1}\left\|f_{G, n+1}\right\|_{L_{Y_{n+1}^{\prime}}^{2}} L_{y_{G}}^{q}, & \text { when } n>0,\end{cases}
\end{aligned}

which implies the bounds (38) and (39).
Remark 3.7. Instead of Young's inequality one could use the more general BrascampLieb inequality (see[BrLi][Lie]). This would not change the result (up to multiplicative constants). One may wonder whether it is possible to improve Lebesgue's exponent, in particular the integrability by reaching exponents $p<2$ in (39) by strengthening the assumptions on $V$. Actually it is not. Take $V \in \mathscr{S}\left(\mathbb{R}^{d}\right)$ and $\varphi \in L^{2}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)$, then $a(V) \varphi^{\otimes n}=$ $\sqrt{n}\langle V, \varphi\rangle \varphi^{\otimes n-1}$ and $a_{G}(V) U_{G}^{-1}\left(\varphi^{\otimes n}\right)$ cannot be put in $L_{z, Y_{n-1}^{\prime}}^{2} L_{y_{G}}^{p}$ with $p<2$ in general.
Proposition 3.8. Take $\alpha, \alpha^{\prime} \in \mathbb{R}, \alpha<\alpha^{\prime}$ and for $1 \leq q^{\prime} \leq p^{\prime} \leq 2,2 \leq p \leq q \leq+\infty$, and let $r^{\prime} \in[1,2]$ be defined by $\frac{1}{r^{\prime}}=\frac{1}{2}+\frac{1}{q^{\prime}}-\frac{1}{p^{\prime}}$. For any $V \in L^{r^{\prime}}\left(\mathbb{R}^{d}\right) \cap L^{q^{\prime}}\left(\mathbb{R}^{d}\right)$, the following estimates hold

& \forall f \in e^{-\alpha^{\prime} N} L_{z, Y^{\prime}, \mathrm{sym}}^{2} L_{y_{G}}^{q},\left\|e^{\alpha N} a_{G}(V) f\right\|_{L_{z, Y^{\prime}}^{2} L_{y_{G}}^{p}} \leq \frac{\max \left(\|V\|_{L^{r^{\prime}}}\|V\|_{L^{q^{\prime}}}\right) e^{-\alpha}\left\|e^{\alpha^{\prime} N} f\right\|_{L_{z, Y^{\prime}}^{2},} L_{y_{G}}^{q} .}{} . \tag{41}

Again, a notable case is when $q^{\prime}=r^{\prime}$ and $p=p^{\prime}=2$.

## 4 Strichartz estimates in the center of mass variable

Here we review the celebrated results of Keel and Tao in [KeTa] and adapt them to our framework. We shall use like those authors the short notations

- $a(z) \lesssim b(z)$ for the uniform inequality

where $C$ is a constant which depends only on the following data: the dimension $d$ or the free one particle evolution on $\mathbb{R}^{d}$;

- for $1 \leq p, q \leq+\infty$, various uses of the general notation $L_{x}^{p} L_{y}^{q}$ introduced in Definition 3.4 will be specified;
- except in specified cases, $L_{x}^{p}$ is used for $2 \leq p \leq+\infty$ while $L_{x}^{p^{\prime}}$ is used for $1 \leq p^{\prime} \leq 2$.


### 4.1 Endpoint Strichartz estimates

Keel and Tao's results about endpoint Strichartz estimates (see [KeTa]) written with uniform inequalities, obviously induce a parameter dependent version which will be needed. They start with a time-dependent operator $U(t): \mathfrak{h}_{\text {in }} \rightarrow L_{x}^{2}=L^{2}(X, \mathbf{d x} ; \mathbb{C})$ where $t \in \mathbb{R}$ and $\mathfrak{h}_{\text {in }}$ is a (separable) Hilbert space of initial data. We rather consider a parameter dependent operator $U\left(t, z_{1}\right): \mathfrak{h}_{\text {in }} \rightarrow L_{x}^{2}$ defined for $\left(t, z_{1}\right) \in \mathbb{R} \times Z_{1}$ such that

while $U^{*}\left(t, z_{1}\right)$ may be defined only on a dense set of $L_{x}^{1}$.
On the measured space $\left(Z_{1}, \mathbf{d z}_{1}\right)$ the map $\left(t, z_{1}\right) \mapsto U\left(t, z_{1}\right) f \in L_{x}^{2}$ is assumed measurable for all $f \in \mathfrak{h}_{\text {in }}$ and $U(t): L^{w}\left(Z_{1}, \mathbf{d z}_{1} ; \mathfrak{h}_{\text {in }}\right) \rightarrow L_{z_{1}}^{w} L_{x}^{2}$, where $L_{z_{1}}^{w} L_{x}^{2}=L^{w}\left(Z_{1}, \mathbf{d z}_{\mathbf{1}} ; L^{2}(X, \mathbf{d x})\right)$ here, is defined by pointwise multiplication $(U(t) f)\left(z_{1}\right)=U\left(t, z_{1}\right) f\left(z_{1}\right)$.
The set of $\operatorname{sharp} \sigma$-admissible space-time exponents is given by

q, r \geq 2 \quad \frac{1}{q}+\frac{\sigma}{r}=\frac{\sigma}{2}
$$

and the dual exponents are denoted by $q^{\prime}, r^{\prime}, \frac{1}{q}+\frac{1}{q^{\prime}}=1, \frac{1}{r}+\frac{1}{r^{\prime}}=1$ with $1 \leq q^{\prime}, r^{\prime} \leq 2$, $\frac{1}{q^{\prime}}+\frac{\sigma}{r^{\prime}}=\frac{\sigma+2}{2}$.
We will consider cases where $\sigma>1$ and the endpoint Strichartz estimates for $P=\left(2, \frac{2 \sigma}{\sigma-1}\right)$ holds true. The results for sharp $\sigma$-admissible pairs ( $q, r$ ) and ( $\tilde{q}, \tilde{r}$ ) are:

- the homogeneous estimate

- the retarded estimate

\end{equation*}

where $s<t$ can be replaced by $s>t$.

Keel and Tao's results are written in [KeTa] with $Z_{1}=\left\{z_{0}\right\}$ and $\mathbf{d} \mathbf{z}_{1}=\delta_{z_{0}}$, but the uniform inequalities with respect to $z_{1} \in Z_{1}$ can be integrated afterwards for data in $L_{z_{1}}^{w}$.
By requiring $\sigma>1$, the endpoint estimate allows to take $q=\tilde{q}^{\prime}=2$ with the endpoint exponents $r_{\sigma}=\frac{2 \sigma}{\sigma-1}$ and $r_{\sigma}^{\prime}=\frac{2 \sigma}{\sigma+1}$. This is a very convenient framework for fixed point and bootstrap method in our linear setting.

Below are the typical inequalities which will be used. In our applications like in Subsection 3.3, the vaccuum sector plays a separate role and it is convenient to use the general Definition 3.4 for $L_{z}^{w} L_{x}^{q}$

At this level the action of the dynamics $U(t) U(s)^{*}$ is considered only on the $L_{z_{1}}^{w} L_{x}^{q}$ component.

Proposition 4.1. Consider $L_{z}^{2} L_{x}^{q}=L_{z_{0}}^{2} \oplus L_{z_{1}}^{2} L_{x}^{2}$ like in (47) and according to Definition 3.4. Assume that there is a dense Banach space $D$ in $L_{z_{1}, x}^{2}=L_{z_{1}}^{2} L_{x}^{2}$ such that $D \subset L_{z_{1}}^{2} L_{x}^{r_{\sigma}}$ and $U(t) U(s)^{*} u \in L_{z_{1}}^{2} L_{x}^{r_{\sigma}}$ is measurable with respect to $t, s \in \mathbb{R}$ for all $u \in D$ with the uniform estimate $\left\|U(t) U(s)^{*} u\right\|_{L_{z_{1}}^{2} L_{x}^{r \sigma}} \lesssim\|u\|_{D}$ for almost all $t, s \in \mathbb{R}$.
Assume that the bounded operator $B_{t, s}^{*}: L_{z}^{2} L_{x}^{2} \rightarrow L_{z_{1}}^{2} L_{x}^{r_{\sigma}^{\prime}}$ and its adjoint $B_{t, s}: L_{z_{1}}^{2} L_{x}^{r_{\sigma}} \rightarrow$ $L_{z}^{2} L_{x}^{2}$ are strongly measurable with respect to $(t, s) \in[0, T] \times[0, T]$ with the assumption

for all non zero $n \in \mathbb{N}$.
When $B_{t, s}^{\sharp}=B_{t, s}^{\sharp} 1_{s<t}$ or $B_{t, s}^{\sharp}=B_{t, s}^{\sharp} 1_{s>t}\left(B^{\sharp}=B^{*}\right.$ resp. $\left.B^{\sharp}=B\right)$, the domain of integration $[0, T]^{n}$ can be replaced by the corresponding $n$-dimensional simplex $0<t_{1}<\ldots<t_{n}<T$ or $T>t_{1} \ldots>t_{n}>0$.

Remark 4.2. The dense subspace $D$ is introduced in order to get a dense domain of $L^{1}\left([0, T] ; L_{z_{1}, x}^{2}\right)$ where $A_{T}$ is well defined by its integral formula. The extension to the whole space $L^{1}\left([0, T] ; L_{z_{1}, x}^{2}\right)$ is proved by using the fact that $L^{\infty}\left([0, T] ; L_{z_{1}, x}^{2}\right)$ is the dual of $L^{1}\left([0, T] ; L_{z_{1}, x}^{2}\right)$ and it cannot be done in the other way.
Examples where the dense subset $D$ is easy to construct are when $L^{2}(X, \mathbf{d x} ; \mathbb{C})=L^{2}\left(\mathbb{R}^{d}, d x ; \mathbb{C}\right)$ and $U(t) U(s)^{*}: H^{\mu}\left(\mathbb{R}^{d} ; \mathbb{C}\right) \rightarrow H^{\mu}\left(\mathbb{R}^{d} ; \mathbb{C}\right)$ are measurable and uniformly bounded w.r.t. $t, s \in \mathbb{R}$ for some $\mu>d / 2$. In this simple case, the set $D$ can be $L^{2}\left(Z_{1}, \mathbf{d z}_{1} ; H^{\mu}\left(\mathbb{R}^{d} ; \mathbb{C}\right)\right)$ with $\mu>\frac{d}{2}$.
Proof. Let us start with $A_{T}^{*}$. When $f \in L^{\infty}\left([0, T], d t ; L_{z}^{2} L_{x}^{2}\right)$ the function $1_{[0, T]} f$ belongs to $L_{z}^{2} L_{t, x}^{2}$ and, for almost all $t_{0} \in[0, T]$, the function $(z, s, x) \mapsto B_{t_{0}, s}^{*} 1_{[0, T]}(s) f(s)$ belongs to $L_{z_{1}}^{2} L_{s}^{2} L_{x}^{r_{\sigma}^{\prime}}$. The inhomogeneous endpoint Strichartz estimate implies for almost all $t_{0} \in[0, T]$

\end{equation*}

This proves firstly that $A_{T}^{*}$ acts continuously on $L^{\infty}\left([0, T] ; L_{z}^{2} L_{x}^{2}\right)$. The property $\operatorname{Ran} A_{T}^{*} \subset$ $L^{\infty}\left([0, T] ; L_{z_{1}, x}^{2}\right)$ comes from the assumption $B_{t, s}^{*}: L_{z}^{2} L_{x}^{2} \rightarrow L_{z_{1}}^{2} L_{x}^{r_{\sigma}^{\prime}}$ and the redundant multiplication by $1_{Z_{1}}(z)$ in (50). Secondly iterating (55) with $\left(t_{0}, s\right)=\left(t_{n+1}, t_{n}\right)$ leads to (53). Consider now $A_{T} f$ when $f=1_{Z_{1}}(z) f \in L^{1}\left([0, T] ; L_{z_{1}, x}^{2}\right)$. For $f$ in the dense subspace $L^{1}([0, T] ; D)$ of $L^{1}\left([0, T] ; L_{z_{1}, x}^{2}\right)$, our assumptions ensure that $A_{T} f$ belongs to $L^{\infty}\left([0, T] ; L_{z}^{2} L_{x}^{2}\right) \subset$ $L^{1}\left([0, T] ; L_{z}^{2} L_{x}^{2}\right)$ with

This proves that $A_{T}$ extends as a continuous operator $L^{1}\left([0, T] ; L_{z_{1}, x}^{2}\right) \rightarrow L^{1}\left([0, T] ; L_{z}^{2} L_{x}^{2}\right)$ and the formula contains the extension by 0 on $L^{1}\left([0, T] ; L_{z_{0}}^{2}\right)$, with $L^{1}\left([0, T] ; L_{z}^{2} L_{x}^{2}\right)=$ $L^{1}\left([0, T] ; L_{z_{0}}^{2}\right) \oplus L^{1}\left([0, T] ; L_{z_{1}, x}^{2}\right)$. Its adjoint is $\tilde{A}_{T}^{*}: L^{\infty}\left([0, T] ; L_{z}^{2} L_{x}^{2}\right) \rightarrow L^{\infty}\left([0, T] ; L_{z}^{2} L_{x}^{2}\right)$. The estimate (53) for $\tilde{A}_{T}^{*}$ with $\left(\left\|B_{t, s}^{*}\right\|, t_{k}\right)$ replaced by ( $\left\|B_{s, t}^{*}\right\|=\left\|B_{s, t}\right\|, t_{n+1-k}$ ) yields (54).

This gives a hint of times scales with respect to $\beta$, e.g. when $\beta^{2} T \leq C$ here, where iterative methods lead to convergent series or the associated fixed point methods can be used. We will use some refined versions of the scaling rule $\beta^{2} T \leq C$. Although the $L_{t}^{p}$ spaces estimates are written with $p=+\infty$ and $p=1$, this scaling really relies on the endpoint Strichartz estimate with $p=2$.
We complete our general corollaries of endpoint Strichartz estimates with a result which combines the action of operators like $B_{t, s}$ and $B_{t, s}^{*}$ in Proposition 4.1.

The free dynamics or more precisely $U(t) U(s)^{*}: F^{2} \rightarrow F^{2}$ is assumed to preserve the number of particles

- The measured space ( $X_{1}, \mathbf{d} \mathbf{x}_{1}$ ) is nothing but $\left(\mathbb{R}^{d}, d y_{G}\right)$ in the center of mass variable and the $z_{1}=\left(Y^{\prime}, z^{\prime}\right)$-dependent one particle operators $U_{1}\left(t, z_{1}\right): \mathfrak{h}_{\text {in }} \rightarrow L^{2}\left(\mathbb{R}^{d}, d y_{G} ; \mathbb{C}\right)$ and its adjoint are assumed to satisfy the estimate (42)(43) with $\sigma>1$. Remember $r_{\sigma}^{\prime}=\frac{2 \sigma}{\sigma+1}$ and $r_{\sigma}=\frac{2 \sigma}{\sigma-1}$.

Because $Z_{0}=Z^{\prime}$ corresponds to the vacuum sector, $N=0$, on which $a_{G}(V)$ vanishes while the range of $a_{G}(V)^{*}$ lies in the non vacuum sector $N \geq 1$, the range $B_{t, s}^{*}$ lies naturally in $L_{z_{1}}^{2} L_{y_{G}}^{r_{\sigma}^{\prime}}, z_{1}=\left(Y^{\prime}, z^{\prime}\right)$, once the proper
estimates are checked while it adjoints $B_{t, s}$ sends $L_{z_{1}}^{2} L_{y_{G}}^{r_{\sigma}}$ into $L_{z}^{2} L_{y_{G}}^{2}$ and is naturally extended by 0 on the vacuum sector $L_{z_{0}}^{2}$.

## 5 Consequences of Strichartz estimates for our model problem

The general results of Section 4 are applied to our model problem presented in Subsection 2.3.

### 5.1 Validity of the general hypotheses and main result

Let us consider (20)

Our complete parameter is thus

The dense subset $D$ in $L_{z_{1}}^{2} L_{y_{G}}^{2}$ such that $D \subset L^{2}\left(Z_{1}, \mathbf{d z}_{1} ; L^{r_{\sigma}}\left(\mathbb{R}^{d}, d y_{G} ; \mathbb{C}\right)\right.$ ), with $r^{\sigma}=\frac{2 d}{d-2}$ and $d \geq 3$ here, is simply $D=L^{2}\left(Z_{1}, d z_{1} ; H^{\mu}\left(\mathbb{R}^{d}\right)\right)$ with $\mu>d / 2$. Remember that the dense subset $D$ was introduced in Proposition 4.1 for the dense a priori definition of the operator $A_{T}$ on $L^{1}\left([0, T] ; L_{z, x}^{2}\right)$ (see Remark 4.2 and the proof of Proposition 4.1).
Below are reviewed assumptions on $V$ :

1. If $V \in L^{\frac{2 d}{d+2}}\left(\mathbb{R}^{d}, d y ; \mathbb{R}\right)$, the assumptions of Proposition 4.5 are satisfied with $C_{V}=$ $1+\|V\|_{L \frac{2 d}{d+2}}>0$ and $r_{\sigma}^{\prime}=\frac{2 \sigma}{\sigma+1}=\frac{2 d}{d+2}$.
2. If $V \in H^{2}\left(\mathbb{R}^{d} ; \mathbb{R}\right)$ then (95) (or (96)) defines a unitary dynamics with a rather well understood domain of its generator in $L^{2}\left(\mathbb{R}^{d} \times Z^{\prime \prime}, \frac{d \xi}{(2 \pi)^{d}} \otimes \mathbf{d z} \mathbf{z}^{\prime \prime} ; \Gamma\left(L^{2}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)\right)\right) \simeq L_{z}^{2} L_{y_{G}}^{2}$.

We will always assume $V \in L^{r_{\sigma}^{\prime}}$ in the sequel, and depending on the statement we might assume that $V \in H^{2}$ or not.

If $V \in H^{2}\left(\mathbb{R}^{d} ; \mathbb{R}\right)$, the unique solution $t \mapsto u_{G}^{h}(t)=U_{G}^{-1} \hat{f}^{h}(t) \in \mathscr{C}^{0}\left(\mathbb{R} ; L_{z}^{2} L_{y_{G}}^{2}\right)$ to (96) satisfies

## 6 Semiclassical measures

We will check here that semiclassical (or Wigner) measures for our model problem presented in Section 2.3 can be defined simultaneously for all macroscopic times $t \in]-\hat{T}_{\alpha_{1}}, \hat{T}_{\alpha_{1}}[$.

### 6.1 Framework

Below are reviewed a few properties of semiclassical measures or Wigner measures. We refer the reader e.g. to [CdV][Ger][GMMP][HMR][LiPa][Sch] for various presentations of those now well known objects.
a) The Anti-Wick quantization on $\mathbb{R}^{d}$ is defined by

It is a non negative quantization for which

A natural separable subspace of $L^{\infty}\left(T^{*} \mathbb{R}^{d} ; \mathbb{C}\right)$ is

resp. $\quad \mathscr{C}^{0}\left(T^{*} \mathbb{R}^{d} \sqcup\{\infty\} ; \mathbb{C}\right)=\mathscr{C}_{0}^{0}\left(T^{*} \mathbb{R}^{d} ; \mathbb{C}\right) \oplus \mathbb{C} 1=\left\{a \in \mathscr{C}^{0}\left(T^{*} \mathbb{R}^{d} ; \mathbb{C}\right), \lim _{X \rightarrow \infty} a(X) \in \mathbb{C}\right\}$, endowed with the $\mathscr{C}^{0}$ norm, of which the dual is the space $\mathscr{M}_{b}\left(T^{*} \mathbb{R}^{d} ; \mathbb{C}\right)$ (resp. $\left.\mathscr{M}_{b}\left(T^{*} \mathbb{R}^{d} \sqcup\{\infty\} ; \mathbb{C}\right)\right)$ of bounded Radon measures on $T^{*} \mathbb{R}^{d}\left(\right.$ resp. $\left.T^{*} \mathbb{R}^{d} \sqcup\{\infty\}\right)$.
b) For a bounded family $\left(\varrho_{h}\right)_{h \in] 0, h_{0}[ }$ of normal states $\varrho_{h} \in \mathscr{L}^{1}\left(L^{2}\left(\mathbb{R}^{d}, d x ; \mathbb{C}\right)\right), \varrho_{h} \geq 0$, $\operatorname{Tr}\left[\varrho_{h}\right]=1$, the set of semiclassical measures on $T^{*} \mathbb{R}^{d}$ (resp. $T^{*} \mathbb{R}^{d} \sqcup\{\infty\}$ ) is defined as the weak ${ }^{*}$ limit point in $\mathscr{M}_{b}\left(T^{*} \mathbb{R}^{d} ; \mathbb{R}_{+}\right)\left(\right.$resp. $\left.\mathscr{M}_{b}\left(T^{*} \mathbb{R}^{d} \sqcup\{\infty\} ; \mathbb{R}_{+}\right)\right)$of $\frac{\sigma^{\text {Wick }}\left(\rho_{h}\right)}{(2 \pi h)^{d}}$ with

This is extended by linearity for any bounded family $\left(\varrho_{h}\right)_{h \in] 0, h_{0}}$ in $\mathscr{L}^{1}\left(L^{2}\left(\mathbb{R}^{d}, d x ; \mathbb{C}\right)\right)$. The set of semiclassical measures is denoted by

The compactification $T^{*} \mathbb{R}^{d} \sqcup\{\infty\}$ is just a way to count the mass of $\left(\varrho_{h_{k}}\right)_{k \in \mathbb{N}^{*}}$ which is not caught by the compactly supported obervables $a \in \mathscr{C}_{0}^{\infty}\left(T^{*} \mathbb{R}^{d} ; \mathbb{C}\right)$.
e) Semiclassical measures are transformed by the dual action of semiclassical Fourier integral operator on $a^{\text {Weyl }}\left(h x, D_{x}\right), a \in \mathscr{C}_{0}^{\infty}\left(T^{*} \mathbb{R}^{d} ; \mathbb{C}\right)$.
f) When $\mathscr{M}\left(\varrho_{h, 1}, h \in \mathscr{E}\right)=\left\{\mu_{1}\right\}$ and $\mathscr{M}\left(\varrho_{h, 2}, h \in \mathscr{E}\right)=\left\{\mu_{2}\right\}$ the total variation between $\mu_{1}$ and $\mu_{2}$ is estimated by

By assuming ( $\Lambda, d_{\Lambda}$ ) separable, sufficient conditions for this property are either

- For all given $a \in \mathscr{C}_{0}^{\infty}\left(T^{*} \mathbb{R}^{d} ; \mathbb{C}\right), \operatorname{Tr}\left[a^{\mathrm{Weyl}}\left(h x, D_{x}\right) \varrho_{h}(\lambda)\right]$ is an equicontinuous family of continuous functions from $\Lambda$ to $\mathbb{C}$, or
- The map $(P, \lambda) \mapsto \operatorname{Tr}\left[\tau_{P}^{h} \varrho_{h}(\lambda)\right]$ is an equicontinuous family of continuous functions from $T^{*} \mathbb{R}^{d} \times \Lambda$ to $\mathbb{C}$.

For the first characterization, apply a diagonal extraction process for a dense countable subset of $\left(\Lambda, d_{\Lambda}\right)$ (and a dense countable subset of $\mathscr{C}_{0}^{0}\left(T^{*} \mathbb{R}^{d}\right)$ lying in $\mathscr{C}_{0}^{\infty}\left(T^{*} \mathbb{R}^{d} ; \mathbb{C}\right)$ ) and then apply the various characterisations of elements of $\mathscr{M}\left(\varrho_{h}(\lambda), h \in \mathscr{E}\right)$.

Like in our problem, semiclassical measures can be defined for bounded families $\varrho_{h} \in$ $\mathscr{L}^{1}\left(L^{2}\left(\mathbb{R}^{d} \times Z^{\prime}, d x \otimes \mathbf{d z}^{\prime} ; \mathbb{C}\right)\right)$ after using observables $a^{\mathrm{Weyl}}\left(h x, D_{x}\right) \otimes \operatorname{Id}_{L_{z}^{2}}$.
When $\left(\varrho_{h}\right)_{h \in] 0, h_{0}}$ is a family of states, $\varrho_{h} \geq 0$ and $\operatorname{Tr}\left[\varrho_{h}\right]=1$, the relationship with the study of pure states can be done in two ways:

- Firstly by writing a general state as a convex combination of pure states, provided that this convex decomposition is explicit enough to follow the behaviour as $h \rightarrow 0^{+}$.
- Secondly by writing $\varrho_{h}=\varrho_{h}^{1 / 2} \varrho_{h}^{1 / 2}$ and taking $\Psi_{h}=\varrho_{h}^{1 / 2} \in \mathscr{L}^{2}\left(L^{2}\left(\mathbb{R}^{d} \times Z^{\prime}, d x \otimes \mathbf{d z}^{\prime} ; \mathbb{C}\right)\right) \sim$ $L^{2}\left(\mathbb{R}^{d} \times \boldsymbol{Z}^{\prime} \times \hat{Z}, d x \otimes \mathbf{d z}^{\prime} \otimes \mathbf{d} \hat{\mathbf{z}} ; \mathbb{C}\right)$ where $\hat{Z}$ is another copy of $\mathbb{R}^{d} \times \boldsymbol{Z}^{\prime}$ with $\mathbf{d} \hat{\mathbf{z}}=d x \otimes \mathbf{d} \mathbf{z}^{\prime}$. Then

### 6.2 Equicontinuity

The following result, which is the first useful information about semiclassical measures, before computing them, comes from the equicontinuity directly deduced from Proposition 5.2. The unitary transforms introduced in Section 2.3 and Section 3 in order to transform (18) into (96) and $a^{\mathrm{Weyl}}\left(h x, D_{x}\right) \otimes \mathrm{Id}$ into $a^{\mathrm{Weyl}}\left(-h D_{\xi}, \xi-D_{y_{G}}\right)$ are not recalled here and the results are directly formulated for the initial problem (18) and the semiclassical observables $a^{\mathrm{Weyl}}\left(h x, D_{x}\right) \otimes \mathrm{Id}$.

by the unitary transform $U_{G}$ associated with the center of mass $y_{G}$ of Section 3 , the translation invariance and its Fourier variable $\xi \in \mathbb{R}^{d}$ and the relative coordinates $Y^{\prime} \in \mathscr{R}$. The variable $z_{1} \in Z_{1}$ is nothing but $z_{1}=\left(\xi, Y^{\prime}, \hat{z}\right) \in \mathbb{R}^{d} \times \mathscr{R} \times \hat{Z}$ with $\mathbf{d} \mathbf{z}_{1}=\frac{d \xi}{(2 \pi)^{d}} \otimes \mu \otimes \mathbf{d} \hat{\mathbf{z}}$. The subscript ${ }_{\text {sym }}$ refers to the symmetry in the variable $Y^{\prime} \in \mathscr{R}$. All the assumptions of Theorem 5.1 have been checked in Section 5. In particular we can use Proposition 5.2-b) with

This ends the proof.

## 7 Approximations

With our number estimates stated in Section 5, various approximations can be considered for the general class of initial data $\left(\varrho_{h}(0)\right)_{h \in] 0, h_{0}[ }, \varrho_{h}(0) \in \mathscr{L}^{1}\left(L^{2}\left(\mathbb{R}^{d} \times \Omega, d x \otimes \mathscr{G} ; \mathbb{C}\right)\right.$ ), $\varrho_{h}(0) \geq 0, \operatorname{Tr}\left[\varrho_{h}(0)\right]=1$ under the sole additional assumption $\operatorname{Tr}\left[e^{\alpha_{1} N} \varrho_{h}(0) e^{\alpha_{1} N}\right] \leq C_{\alpha_{1}}$. Before computing the evolution of the semiclassical measures $\left(\mu_{t}\right)_{t \in]-\hat{T}_{\alpha_{1}}, \hat{T}_{\alpha_{1}}[ }$ given by Proposition 6.1 (this will be done in a subsequent article), it provides useful a priori information for them.

### 7.1 Truncation with respect to the number operator $N$

For $\varepsilon>0$, let $\chi_{\varepsilon}:[0,+\infty) \rightarrow[0,1]$ be a decaying function such that

according to (56) and $\sqrt{h}\left(a_{G, \varepsilon}(V)+a_{G, \varepsilon}^{*}(V)\right)$ is an $\mathscr{O}_{\varepsilon}(\sqrt{h})$ bounded self-adjoint perturbation of $\left(\xi-D_{y_{G}}\right)^{2}$. Additionally for $\varepsilon>0$ the estimates of Proposition 3.6 hold true when $a_{G}(V)$ and $a_{G}^{*}(V)$ are replaced by $a_{G, \varepsilon}(V)$ and $a_{G, \varepsilon}^{*}(V)$. Actually, (39) with $n>1$ and (37) with $n>0$ become

All the analysis can thus be carried out with $a_{G}(V)$ and $a_{G}^{*}(V)$ replaced by $a_{G, \varepsilon}(V)$ and $a_{G, \varepsilon}^{*}(V)$, either with estimates which are uniform in $\varepsilon \in] 0,1[$, or by replacing the $N$-dependent estimates by constants $C_{\varepsilon}$ depending on $\left.\varepsilon \in\right] 0,1[$.
In particular the solution $v_{G, \varepsilon}^{h}$ to

The formulation of Theorem $5.1 u_{G}^{h}(t)=U_{\mathcal{V}}(t) u_{G, 0}^{h}=U\left(\frac{t}{h}\right) u_{G, 0}^{h}+u_{\infty}^{h}(t)$ where $\left(u_{q}^{h}\right)_{q \in\{\infty, 2,1\}}$ is a solution of a fixed point problem, solved in Proposition 4.5, where only $\|V\|_{L^{r_{\sigma}^{\prime}}}, r_{\sigma}^{\prime}=\frac{2 d}{d+2}$, is used, allows to consider perturbations of $V$, which can be done separately in the the terms $a_{G}(V)$ and $a_{G}^{*}(V)$ and with complex valued perturbations.

Estimates for all the terms of the right-hand side have essentially been proved for Proposition 4.5 and for Theorem 5.1. Although they are written for $V_{1}=V_{2}$ real-valued in Theorem 5.1 the generalization is straightforward (like in Proposition 4.5) and upper bounds are proportional the $L^{r_{\sigma}^{\prime}}$ of the potential which is either $\left(V_{1,2}-V_{1,1}\right)$ or $\left(V_{2,2}-V_{2,1}\right)$.
The time interval ]- $T_{\alpha_{1}}, T_{\alpha_{1}}$ [=]- $2 \hat{T}_{\alpha_{1}}, 2 \hat{T}_{\alpha_{1}}$ [ is actually chosen like in Proposition 4.5 such that $\left\|L_{\tilde{V_{1}}}\right\|_{\mathscr{L}\left(\mathscr{E}_{\alpha_{1},-\alpha_{1}}, \gamma\right)} \leq \frac{1}{2}$ and this ends the proof.

\exists C>0, \forall t \in]-\hat{T}_{\alpha_{1}}, \hat{T}_{\alpha_{1}}\left[, \quad\left\|\varrho_{h}(t)-\varrho_{h, \tilde{\mathcal{V}}}(t)\right\|_{\mathscr{L}^{1}\left(L_{x, \omega}^{2}\right)} \leq C\left[\left\|V_{1}-V\right\|_{L^{r_{\sigma}^{\prime}}}+\left\|V_{2}-V\right\|_{L^{r_{\sigma}^{\prime}}}\right] .\right.
$$

When the subset $\mathscr{E} \subset] 0, h_{0}[, 0 \in \overline{\mathscr{E}}$, is chosen such that

$$
\forall t \in]-\hat{T}_{\alpha_{1}}, \hat{T}_{\alpha_{1}}\left[, \quad \mathscr{M}\left(\varrho_{h}(t), h \in \mathscr{E}\right)=\left\{\mu_{t}\right\} \quad \text { and } \quad \mathscr{M}\left(\varrho_{h, \tilde{\mathcal{V}}}(t), h \in \mathscr{E}\right)=\left\{\mu_{t, \tilde{V}}\right\}\right.
$$

Then the total variation of $\mu_{t}-\mu_{t, \tilde{\mathcal{V}}}$ is estimated by

$$
\left.\exists C^{\prime}>0, \forall t \in\right]-\hat{T}_{\alpha_{1}}, \hat{T}_{\alpha_{1}}[, \quad\left|\mu_{t}-\mu_{t, \tilde{\eta}}\right|(\underbrace{T^{*} \mathbb{R}^{d}}_{\text {or } T^{*} \mathbb{R}^{d} \sqcup\{\infty\}}) \leq C^{\prime}\left[\left\|V_{1}-V\right\|_{L^{r_{\sigma}^{\prime}}}+\left\|V_{2}-V\right\|_{L^{r_{\sigma}^{\prime}}}\right] .
$$

Proof. It suffices to write

$$
\varrho_{h, \tilde{V}}(t)-\varrho_{h}(t)=\left[u_{G, \tilde{V}}^{h}\left(\frac{t}{h}\right)-u_{G}^{h}\left(\frac{t}{h}\right)\right]\left[u_{G, \tilde{V}}^{h}\left(\frac{t}{h}\right)\right]^{*}+\left[u_{G}^{h}\left(\frac{t}{h}\right)\right]\left[u_{G, \tilde{V}}^{h}\left(\frac{t}{h}\right)-u_{G}^{h}\left(\frac{t}{h}\right)\right]^{*}
$$

and to remember that Hilbert-Schmidt norms correspond to $L_{z, y_{G}}^{2}$-norms estimated in Proposition 7.4.

### 7.4 Quantum dynamics with low regularity

We conclude with an easy application of Proposition 7.4 which says that the dynamics $\left(U_{\mathcal{V}}(t)\right)_{t \in \mathbb{R}}$ is actually well defined under the sole assumption

$$
\begin{equation*}
V \in L^{r_{\sigma}^{\prime}}\left(\mathbb{R}^{d} ; \mathbb{R}\right) \quad, \quad r_{\sigma}^{\prime}=\frac{2 d}{d+2} \quad d \geq 3 \tag{132}
\end{equation*}
$$

with good approximations when $V_{n} \in L^{r_{\sigma}^{\prime}}\left(\mathbb{R}^{d} ; \mathbb{R}\right) \cap H^{2}\left(\mathbb{R}^{d} ; \mathbb{R}\right)$ satisfies $\lim _{n \rightarrow \infty}\left\|V_{n}-V\right\|_{L^{r_{\sigma}^{\prime}}}=$ 0 .

Proposition 7.6. Let $V$ belong to $L^{r_{\sigma}^{\prime}}\left(\mathbb{R}^{d} ; \mathbb{R}\right)$ and let $\left(V_{n}\right)_{n \in \mathbb{N}}$ be a sequence in $L^{r_{\sigma}^{\prime}}\left(\mathbb{R}^{d} ; \mathbb{R}\right) \cap$ $H^{2}\left(\mathbb{R}^{d} ; \mathbb{R}\right)$ such that $\lim _{n \rightarrow \infty}\left\|V-V_{n}\right\|_{L^{\prime_{\sigma}^{\prime}}}=0$. Then for any $t \in \mathbb{R}$ the unitary operator $U_{\mathcal{V}_{n}}(t)$ converges strongly to a unitary operator $U_{\mathcal{V}}(t)$.
Therefore $\left(U_{\mathcal{V}}(t)\right)_{t \in \mathbb{R}}$ is a strongly continous unitary group in $L^{2}\left(\mathbb{R}^{d} \times Z^{\prime \prime}, d x \otimes \mathbf{d z}^{\prime \prime} ; \Gamma\left(L^{2}\left(\mathbb{R}^{d}, d y ; \mathbb{C}\right)\right)\right)=$ $L_{z, \text { sym }}^{2} L_{y_{G}}^{2}$ with a self-adjoint generator denoted $\left(-\Delta_{x}+\sqrt{h} V, D\left(-\Delta_{x}+\sqrt{h} V\right)\right)$.
The convergence $\left(-\Delta_{x}+\sqrt{h} \mathcal{V}_{n}, D\left(-\Delta_{x}+\sqrt{h} \mathcal{V}_{n}\right)\right)$ to $\left(-\Delta_{x}+\sqrt{h} \mathcal{V}, D\left(-\Delta_{x}+\sqrt{h} \mathcal{V}\right)\right)$ holds in the strong resolvent sense.

Remark 7.7. Although the dynamics $\left(U_{\mathcal{V}}(t)\right)_{t \in \mathbb{R}}$ and its self-adjoint generator $\left(-\Delta_{x}+\right.$ $\left.\sqrt{h} \mathcal{V}, D\left(-\Delta_{x}+\sqrt{h} V\right)\right)$ is well defined for $V \in L^{r_{\sigma}^{\prime}}\left(\mathbb{R}^{d} ; \mathbb{R}\right)$, we have no information on the domain $D\left(-\Delta_{x}+\sqrt{h} V\right)$. The approximation process by $V_{n} \in L^{r_{\sigma}^{\prime}}\left(\mathbb{R}^{d} ; \mathbb{R}\right) \cap H^{2}\left(\mathbb{R}^{d} ; \mathbb{R}\right)$ for which a core of $\Delta_{x}+\sqrt{h} V_{n}$ is given by Proposition 4.4 in [Bre] recalled in Lemma 2.2, provides a substitute for the analysis.

It could be interesting to see if this Schrödinger type approach relying on endpoint Strichartz estimates could be applied to other quantum field theoretic problem and whether it would bring additional information of tools as compared with the euclidean approach (see [Sim] and refences therein).

Proof. Actually we can work here with $h=1$. The convergence of

$$
U_{V_{n}}(t) u_{G, 0}=U(t) u_{G, 0}+u_{\infty, \gamma_{n}}(t)
$$

is deduced from the convergence (see Proposition 7.4) of $u_{\infty, \mathcal{V}_{n}}(t)$ to $u_{\infty, \mathcal{V}}(t)$ when $e^{\alpha_{1} N} u_{G, 0} \in$ $L_{z, \mathrm{sym}}^{2} L_{y_{G}}^{2}$ for some $\alpha_{1}>0$.
From $\left\|U_{フ_{n}}(t) u_{G, 0}\right\|_{L_{z, \mathrm{sym}}^{2} L_{y_{G}}^{2}}=\left\|u_{G, 0}\right\|_{L_{z, \mathrm{sym}}^{2} L_{y_{G}}^{2}}$ we deduce $\left\|U_{\mathcal{V}}(t) u_{G, 0}\right\|_{L_{z, \mathrm{sym}}^{2} L_{y_{G}}^{2}}=\left\|u_{G, 0}\right\|_{L_{z, \mathrm{sym}}^{2} L_{y_{G}}^{2}}$. This finally provides the extension of $U_{\mathcal{V}}(t) u_{G, 0}$ for any $u_{G, 0} \in L_{z, \text { sym }}^{2} L_{y_{G}}^{2}$ with the convergence of $U_{\mathcal{V}_{n}}(t) u_{G, 0}$ to $U_{\mathcal{V}}(t) u_{G, 0}$, because $e^{-\alpha_{1} N} L_{z, \text { sym }}^{2} L_{y_{G}}^{2}$ is dense in $L_{z, \text { sym }}^{2} L_{y_{G}}^{2}$. Passing from the strong convergence of unitary groups to the strong resolvent convergence of generators is standard.
