DDOMP¹ Introduction

The Data and Digital Output Management Plan and Workbook (DDOMP) is to be used by the PARSEC team to (i) establish the policies the team will follow, (ii) document the operational procedures necessary to comply with those policies, and (iii) organize the planned activities necessary to manage PARSEC data, software, and other digital outputs. It is a working document.

This checklist is a summary of the team resources and the Data and Digital Output Management Schedule. As a PARSEC team member, you are responsible for supporting the activities defined in this checklist and further described in the full DDOMP. This is part of the Code of Conduct all members signed.

Once (in the lifetime of the researcher)

1. For your **ORCID profile**, activate the automatic updates from Crossref and DataCite. Reference [this page for instructions](#). To set up an ORCID profile, reference this [site](#).

Weekly

1. **Track Non Peer-Reviewed Digital Outputs** (to include Datasets, Software, Conferences, Posters, Presentations, training Materials, Workshop Materials, etc.)

All non peer-reviewed digital outputs published in Zenodo, or similar repository is to be listed in the tracking sheet managed in our Google Drive. A recent published version is here: [Non Peer-Reviewed Digital Output Tracking Tool](#)

Make sure you include acknowledgement of the Belmont Forum, and your country funder(s). Use the PARSEC logo.

2. **Update Dataset Log:** working log of datasets reviewed for use by the project.

Datasets reviewed by the PARSEC project team members are to be added to the log along with information about usefulness or concerns. The Dataset Log is managed in our Google Drive. A recent published version is here: [Dataset Log](#)

Note: published PARSEC datasets are included in Non Peer-Reviewed Digital Output above.

3. **Update Software Log:** working log to software reviewed by the project (to include Models, Notebooks, Workflow, etc.)

Software reviewed by the PARSEC project team members is to be added to the log along with information about usefulness or concerns. The Software Log is managed in our Google Drive. A recent published version is here: [Software Log](#)

Note: published PARSEC software is included in Non Peer-Reviewed Digital Output above.

Monthly

1. For any **planned peer-reviewed publications**, all supporting digital objects including datasets and software must be preserved and cited in your paper. Ensure all contributions to the digital objects (such as datasets) are accurately captured in the author/creator list.

Preservation tasks:

- Ensure all datasets and software used in your research are preserved and cited in the references section. Ensure these products are listed in the “Non Peer-Reviewed Digital Output Tracking Sheet” managed on the Google Drive.
- List your publication in the **Scholarly Publications** tracking sheet for the current reporting year. A recent published version is here: [Scholarly Publications](#)

Quarterly (every three months)

1. Update your ORCID profile and ensure that it is current and complete.
