# Diastereoselective Synthesis of PerfluoroalkylmethylSubstituted 1,2,3,4-Tetrahydroquinolines Derivatives through 1-Iodo-1,3-Bis(acetoxy) Synthons

#### Abstract

: Novel 2-perfluoroalkylmethyl,4-arylamino substituted tetrahydroquinolines (THQ) were expeditiously synthesized from perfluoroalkyl iodides $\mathrm{R}_{\mathrm{F}}-\mathrm{I}$ and monosubstituted anilines. First, radical bis-addition of vinylacetate on $\mathrm{R}_{\mathrm{F}}-\mathrm{I}$ afforded gem-iodoacetoxy derivatives (newly characterized by NMR and MS) being actually masked/activated aldol synthons. Their reaction in 1:4 ratio with arylamines afforded title THQ under mild conditions in good yields (60-95\%) and diastereoselectivities (65:35-95:5 cis/trans isomer ratio); m-substituted anilines regiospecifically lead to 7-substituted THQ. Mechanistic investigation suggested the THQ formation to proceed through Michael then imine addition of two aniline units on an $\mathrm{R}_{\mathrm{F}}$-substituted crotonaldehyde intermediate; then through the cyclization of the resulting bis(arylamino/imino) intermediate through electrophillic aromatic substitution. Various $\mathrm{R}_{\mathrm{F}}$ ( $\mathrm{C}_{6}, \mathrm{C}_{2}, \mathrm{C}_{4}$ ) and arylamine substitutions ( $p-, 0-, m$ - alkyl, alkoxyl, halogen...) were thus exemplified.


## Introduction

1,2,3,4-tetrahydroquinolines (THQ, 1) belonging to a class of benzo-fused nitrogen heterocycles are privileged scaffolds ${ }^{1-3}$ present in many bioactive alkaloids, ${ }^{3 f-\mathrm{g}}$ coordination ligands, ${ }^{3-\mathrm{c}}$ and functional materials. ${ }^{3}$ Numerous natural and synthetic analogs of tetrahydroquinolines (1) or chiral tetrahydroquinolines (2) display a wide range of biological activities and were used as (chemo)therapeutic agents including antiviral, ${ }^{4}$ antiparasitic, ${ }^{5}$ antimicrobial, ${ }^{6}$ antitumor, ${ }^{7}$ antiinflammatory ${ }^{8}$ etc., besides acting as ligands of G -coupled protein receptors ${ }^{9}$ and nuclear receptors such as androgen receptor modulators,,$^{10}$ glucocorticoid receptor, ${ }^{11}$ and retinoid receptor. ${ }^{12}$

Particularly, chiral 2 -substituted 1,2,3,4-tetrahydroquinolines derivatives (2) are the most valuable. ${ }^{1 f, 3, c, d, 13}$ and exhibit interesting biochemical activities. ${ }^{3,14}$ For example, 2-methyltetrahydroquinoline ( $\mathbf{2}, \mathrm{R}=\mathrm{H}, \mathrm{R}^{1}=\mathrm{CH}_{3}$, Scheme 1 ) is naturally occurring in human brain, and its derivatives ( $\mathbf{2}, \mathrm{R}=\mathrm{OH}, \mathrm{R}^{1}=$ alkyl) have been discussed as affine ligands for CNS receptors ${ }^{14}$ possessing sedative and antinociceptive activities ${ }^{14 c, d}$ (Scheme 1).



Scheme 1. Structure of 1,2,3,4-tetrahydroquinoline (THQ) and of its neuro-active derivatives.
The development of new efficient and convenient synthetic approaches toward these heterocyclic molecules remains an active research area. ${ }^{1-3}$ One of these approaches is the Povarov reaction, ${ }^{15}$ an hetero-Diels-Alder variant in which a functionalized $N$-aryl aldimine (3), as azadiene, and an activated olefin (4), as dienophile, are coupled (Scheme 2). This reaction and its multicomponent version ${ }^{16}$ (in situ condensation of anilines (5), aldehydes (6), and electron-rich alkenes (7) using acid catalysts under mild conditions) can provide tetrahydroquinoline derivatives (1) with several degrees of structural diversity (Scheme 2).


Scheme 2. Two- and three-component Povarov reactions.
Besides, other approaches for efficient synthetic methods for tetrahydroquinolines have gained considerable research interest,,$^{17-18}$ and numerous catalytic methods have been established. ${ }^{1-3,17-21}$ The
most used methods proceed through hydrogenation of quinolines (reaction a on Scheme 3), ${ }^{19}$ photocyclization asymmetric transfer hydrogenation (reaction b, Scheme 3), ${ }^{20}$ and organo- or metalcatalyzed cascade reactions (examples in reactions $\mathbf{c}$ and $\mathbf{d}$, Scheme 3). ${ }^{21}$ Generally, although affording good to excellent yields, these methods require the use of expensive ligands and toxic metals.

However, in the wide spectrum of described synthetic routes, ${ }^{1-3,15-21}$ versatile methods toward trifluoroethyl/perfluoroalkylmethyl derivatives from simple starting materials, are limited compared to trifluoromethylated/perfluoroalkylated compounds ${ }^{22}$ - in spite of the increasing interest of trifluoromethyl and perfluoroalkyl-containing heterocycles, ${ }^{23-25}$ for which considerable attention has been focused to developing new synthetic methodologies during the past years since these compounds are now widely recognized as important organic compounds showing interesting biological activities for their potential use in medicinal, agricultural and scientific fields. ${ }^{23,24}$ Indeed, the introduction of a trifluoromethyl or a perfluoroalkyl group into molecules could potentially enhance a range of positive effects such as steric, electrostatic interaction, acidity, lipophilicity. ${ }^{23}$

In this paper, we report an original synthetic pathway toward perfluoroalkylmethyl substituted THQ in two steps, starting from perfluoroalkyl iodide and substituted aniline substrates. First, we prepared and characterized new 1-iodo-1,3-bis(acetoxy)4-perfluoroalkylbutane compounds 10-10" (Scheme 4; noteworthy, since the gem-iodoacetoxy group is a masked aldehyde, 10-10" are also masked aldols, as such deserving of further investigation however beyond the scope of the present report). Then we investigated the reactivity of this new tri-functional gem-iodoacetoxy derivative with substituted anilines, leading to the stereoselective synthesis of new substituted 4-arylamino-2-perfluoroalkylmethyl-1,2,3,4-tetrahydroquinolines 15a-o.

The numbering scheme for the investigated examples in compound series 10,14 and 15 , is the following: (i) in compounds 15 the letter a-o denotes the aryl substituent inherited from the aniline substrate 14; (ii) the appended ' or " in series 8, 10 and 15 denotes the perfluoroalkyl chain being $R_{F}=$ $C_{2} F_{5}$ or $C_{4} F_{9}$ respectively instead of (most exemplified) $R_{F}=C_{6} F_{13}$. For instance, 15a is derived from 14a and $\mathbf{1 0}\left(R_{F}=C_{6} F_{13}\right) ; \mathbf{1 5 n}$ ' is derived from $\mathbf{1 4 n}$ and $\mathbf{1 0}^{\prime}\left(R_{F}=C_{2} F_{5}\right)$. In general and mechanistic discussions (unless stating precise examples) compound numbers $\mathbf{8}, \mathbf{1 0}, 15$ and 16 stand for the whole series regardless of the $R_{F}$ length.

## Results and Discussion

## I. Synthesis of 1,3-diacetoxy-4-perfluoroalkyl-1-iodobutane compounds 10-10"

In continuity with our previous investigations on the synthesis and reactivity of gem-iodoacetoxy derivatives, ${ }^{26-28}$ here we report that 1,3-diacetoxy-4-perfluoroalkyl-1-iodobutane compounds 10-10" can be formed upon radical reaction of perfluoroalkyl iodide ( $\mathrm{R}_{\mathrm{F}}-\mathrm{I}$ ) 8-8'" with an excess of vinyl acetate 9 in good to excellent yields (88-95\%), accompanied by the formation of minor amounts of 1-acetoxy-2-perfluoroalkyl-1-iodoethane 11 in $5-12 \%$ yield (Scheme 5). Either $\mathrm{Et}_{3} \mathrm{~B}$ /air (at room temperature) or AIBN (upon heating to $80^{\circ} \mathrm{C}$ ) is efficient as the radical initiator, allowing the reaction to proceed with similar reaction times and yields, however with better 10 vs. 11 selectivity upon $\mathrm{Et}_{3} \mathrm{~B} /$ air initiation.


Scheme 5. Conditions, yields and chemoselectivities of the radical reaction of perfluoroalkyl iodides 8-8" with 3.5 equivalents of vinyl acetate 9 .

Thorough screening of reactants stoichiometries and reaction conditions (upon ${ }^{19} \mathrm{~F}$ NMR monitoring), allowed to identify optimized conditions giving best overall yields: namely 1 equivalent of perfluoroalkyl iodides 8-8", 3.5 equivalents of vinyl acetate 9 and either 0.04 equivalent of triethylborane $\mathrm{Et}_{3} \mathrm{~B}$ (plus air) or 0.1 equivalent of AIBN under inert atmosphere (bubbling Ar), strirring
either at room temperature ( $\mathrm{Et} \mathrm{t}_{3} \mathrm{~B}$ ), or heating below $80^{\circ} \mathrm{C}$ (AIBN). Reactions were typically completed within 30-90 minutes. At the end of the reaction assessed by TLC and ${ }^{19} \mathrm{~F}$ NMR monitoring, column chromatography over silica gel eluted with petroleum ether/ethyl acetate: $95 / 5 \mathrm{v} / \mathrm{v}$, allows to separate the resulting products $\mathbf{1 0 - 1 0 \prime}$ and 11-11" and to isolate the desired 1,3-diacetoxy-4-perfluoroalkyl-1iodobutane compounds $\mathbf{1 0} \mathbf{- 1 0 \prime \prime}$ (mixtures of syn/anti isomers) as yellow brownish oils, therefore fully characterized. Compounds $\mathbf{1 0} \mathbf{- 1 0 \prime}$ are rather stable at room temperature; nevertheless they are better stored at $-20^{\circ} \mathrm{C}$ in a freezer - previously prepared gem-iodoacetoxy compounds 11-11" did not show significant decomposition after several months at $-20^{\circ} \mathrm{C}$, as monitored by TLC and NMR spectroscopy (the brief description of $\mathbf{1 1 - 1 1 "}$ in our previous works, ${ }^{26}$ has been completed here with full NMR, MS and elemental analysis characterisation; see experimental section and Supporting Information).

It was found most convenient to proceed in bulk reactants without solvent, ${ }^{26,28,29}$ since highly electrophilic perfluoroalkyl radicals readily abstract hydrogen atoms from usual organic solvents. ${ }^{30}$ Finally, a better bis-/mono-adduct (10-10"/11-11") chemoselectivity was achieved upon radical initiation by $\mathrm{Et}_{3} \mathrm{~B} /$ air rather than with AIBN, possibly because the former does not requires heating.

## II. Structure determination of 1,3-diacetoxy-4-perfluoroalkyl-1-iodobutane compounds 1010"

The structures of the 1,3-diacetoxy-4-perfluoroalkyl-1-iodobutane compounds 10-10" were confirmed without ambiguity by ${ }^{1} \mathrm{H}$ and ${ }^{19} \mathrm{~F}$ NMR spectroscopy and supported by mass spectrometry data. Compounds 10-10" having two asymmetric centers, exist as two diastereomers, here named according to the relative positions of 1-iodo and 3-acetoxy substituents on Scheme 6 - therefore syn$\mathbf{1 0} \mathbf{- 1 0 \prime \prime}$ is $(1 R, 3 R / 1 S, 3 S)$ while anti-10-10' is $(1 R, 3 S / 1 S, 3 R)$.

Structure of $\operatorname{syn}(1 R, 3 R / 1 S, 3 S$, top) and anti ( $1 R, 3 S / 1 S, 3 R$, bottom) diastereomer configurations of compounds 10-10'" (syn/anti naming refers to 1-iodo vs. 3-acetoxy related positions). Anti configuration exemplified on $\mathrm{C}_{6} \mathrm{~F}_{13}$ derivative anti- $\mathbf{1 0}$ to explicit atom numbering of $\mathrm{R}_{\mathrm{F}}$ chain and $\mathrm{H}^{2 \mathrm{a}} / \mathrm{H}^{2 b}$ relative configurations (clearly identified only for anti- stereomer). Atom label numbers and colors follow ${ }^{1} \mathrm{H} /{ }^{19} \mathrm{~F}$ NMR assignments, cf. Figures 1-2, Tables 1-2 and Supporting Information.

## II-1. NMR description of syn-/anti-1,3-diacetoxy-1-iodo-4-perfluorohexylbutane 10

Typical of such characterization, is the example of spectroscopic analysis of 1,3-diacetoxy-1-iodo-4perfluorohexylbutane 10 that will be described in detail. The mass spectrum of $\mathbf{1 0}$ showed the molecular ion ( $\mathrm{M} \cdot \mathrm{H}^{+}$) peak at $\mathrm{m} / \mathrm{z}$ : 619, which was consistent with the expected compound structure. In the ${ }^{1} \mathrm{H}$ NMR spectra of syn- and anti-10 mixtures, the two diastereomers can be distinguished clearly
since the methyl resonances of acetyl groups of appear as four distinct singlets between $\delta_{H} 2-2.2 \mathrm{ppm}$. Then one pair of diastereotopic protons $\mathrm{H}^{4}$ resonate between $\delta_{H} 2.2-2.5 \mathrm{ppm}$ and showed unresolved mutliplets and a second pair of diastereotopic protons $\mathrm{H}^{2}$ showed unresolved signals $\delta_{H} 2.5-2.9 \mathrm{ppm}$. Furthermore, isomeric $\mathrm{H}^{3}$ protons signals of anti- and syn- isomers are well separated in all the compounds. $\mathrm{H}^{3}$ protons of syn- isomers is deshielded and appears at $\delta_{H} 5.6 \mathrm{ppm}$ in comparison to that of anti-isomers that appears at $\delta_{H} 5.4 \mathrm{ppm}$. Finally, $\mathrm{H}^{1}$ protons appeared as two overlapped signals at $\delta_{H} 6.7-6.8 \mathrm{ppm}$, however the signal of proton $\mathrm{H}^{1}$ of the major anti-isomer appeared to be a doublet of doublets ( ${ }^{3} \mathrm{H}_{\mathrm{H}-\mathrm{H} 2}=10.7$ and 2.8 Hz ) (Figure 1 and Table 1).

In the ${ }^{19} \mathrm{~F}$ NMR spectrum of syn- and anti-10 mixtures, two overlapped pairs of symmetrically disposed doublets of doublets of doublets ( $d d d$ ) seen between -115 ppm and -112 ppm readily recognized as two AB -systems. The two $d d d$ at $\delta_{\mathrm{F}}-114.4$ and $\delta_{\mathrm{F}}-112.6 \mathrm{ppm}$ part of the first AB -system are attributed to $\alpha-\mathrm{CF}_{2}$ groups of anti-10 and show a geminal ${ }^{19} \mathrm{~F},{ }^{19} \mathrm{~F}$ coupling, causing a doublet splitting with ${ }^{2} \int_{\mathrm{Fa}-\mathrm{F} \alpha^{\prime}}$ $=282 \mathrm{~Hz}$, and is split further into a doublet of doublets by coupling with vicinal nonequivalent $\mathrm{H}^{4}$ protons ( ${ }^{3} J_{F / \alpha / \alpha^{\prime}-\mathrm{H} 4}=22.5$ and 11.2 Hz ). However, the two doublet of doublets at -113.9 and -112.8 ppm part of a second AB -system are attributed to $\alpha-\mathrm{CF}_{2}$ groups of syn- $\mathbf{1 0}$ and show a geminal ${ }^{19} \mathrm{~F}-{ }^{19} \mathrm{~F}$ coupling, causing a doublet splitting with ${ }^{2} J_{F \alpha-F \alpha^{\prime}}=225.8 \mathrm{~Hz}$, and is split further into a doublet of doublets ( ${ }^{3} \mathrm{~J}_{\mathrm{F} \alpha / \alpha^{\prime}-\mathrm{H}}=20.5$ and 11 Hz ) (Table 1). In the cases of $\mathbf{1 0 - 1 0}$ " fluorine atoms $\mathrm{F}_{\alpha}$ and $\mathrm{F}_{\alpha^{\prime}}$ of $\alpha-\mathrm{CF}_{2}$ groups are magnetically non-equivalent, which could occur when the group is adjacent to a chiral center or when a restricted rotation around nearby $\mathrm{C}-\mathrm{C}$ bonds occurs. ${ }^{31}$

The signals seen at $-121.9,-123,-123.7$ and -126.4 ppm are attributed to $\beta-\mathrm{CF}_{2}, \gamma-\mathrm{CF}_{2}, \delta-\mathrm{CF}_{2}$ and $\varepsilon$ $\mathrm{CF}_{2}$ respectively, while the multiplet at -81.1 ppm is assigned to the $\omega-\mathrm{CF}_{3}$ end-group (Table 1).

Diastereomer ratios of $\mathbf{1 0} \mathbf{- 1 0 1}$ were determined by ${ }^{1} \mathrm{H}$ and ${ }^{19} \mathrm{~F}$ NMR on basis of integration of $\mathrm{H}^{3}$ and functional $\alpha-\mathrm{CF}_{2}$ resonances of major and minor products in the crude isomer mixtures, showing 72:28 to 80:20 anti-/syn- ratios, the latter increasing with the perfluoroalkyl chain length from $\mathrm{C}_{2} \mathrm{~F}_{5}$ to $\mathrm{C}_{6} \mathrm{~F}_{13}$, thus showing that the anti-/syn- diastereoselectivity significantly depends on the steric hindrance of the $R_{F}$ chain.

## II-2. Stereochemistry determination of the diastereomer anti-10

The major anti- diastereomer was further separated from the minor syn- isomer by flashchromatography of the isomer mixture with petroleum ether/ethyl acetate ( $98: 2 \mathrm{v} / \mathrm{v}$ ), then fully characterized by MS and NMR spectrometry.

It is known ${ }^{32-33}$ that the determination of relative configuration of diastereomers of such acyclic 1,3difunctional derivatives based on ${ }^{1} \mathrm{H}$ NMR analyses is challenging due to the overlap of proton signals in their spectra. ${ }^{32}$ Some alternative methods were described, ${ }^{33}$ for example, in the case of 1,3 -diols diastereomers, the assignment of the relative stereochemistry of the 1,3 -syn and 1,3 -anti diols was confirmed using derivatization with formation of rigid cyclic structures, such as acetonides. Thus, acetonide ${ }^{13} \mathrm{C}$ NMR chemical shifts could be correlated to their syn/anti configuration. ${ }^{33}$ Very few works describe diastereomeric syn-/anti- discrimination of conformationally flexible molecules using NMR coupling constants. ${ }^{34}$ Nevertheless, examples of stereochemical assignments of some acyclic fluorinated diastereomers using ${ }^{1} \mathrm{H}$ NMR coupling constants have been reported. ${ }^{35}$ Gem-iodoacetoxy chiral compounds bearing bulky acetoxy substituents, ${ }^{29}$ have been described as sterically hindered from rotation along their $\mathrm{C}-\mathrm{C}$ bonds resulting in unequal population of their possible rotational conformations, ${ }^{29}$ what led to clear splitting patterns and sharp ${ }^{1} \mathrm{H}$ NMR signals. ${ }^{29 \mathrm{a}}$ In the case of compounds 10 having two chiral centers separated by a methylene group ( $-\mathrm{CH}_{2}$-), well resolved proton NMR signals are obtained.

The starting point for the stereochemical assignment of anti-10 was the observation of a doublet of doublets for proton $\mathrm{H}^{1}$ showing an anti-coupling constant with $\mathrm{H}^{2 b}$ proton ( ${ }^{3} J_{(a n t i-) \mathrm{H} 1-\mathrm{Hzb}}=10.7 \mathrm{~Hz}$ ), followed by a syn-coupling constant with $\mathrm{H}^{2 \mathrm{a}}\left({ }^{3} \int_{\text {(syn-H1-H2a }}=2.8 \mathrm{~Hz}\right.$ ) (Figure 2 and Table 2). It is generally
assumed that in rigid molecular conformations two vicinal protons with syn disposition exhibit smaller ${ }^{3} /_{\mathrm{H}-\mathrm{H}}$ couplings constants than for the anti-relationship. ${ }^{36}$
$\mathrm{H}^{2 \mathrm{a}}$ and $\mathrm{H}^{2 \mathrm{~b}}$ protons show two clear doublets of doublets of doublets (ddd) at $\delta_{H} 2.55 \mathrm{ppm}$ and $\delta_{H} 2.7$ ppm, formed first by a geminal-coupling between these methylene non-equivalent protons $\left({ }^{2} J_{\mathrm{H} 2 \mathrm{a}-\mathrm{H} 2 \mathrm{~b}}=\right.$ 14.6 Hz ) followed by two vicinal couplings of each of $\mathrm{H}^{2 \mathrm{a}}$ and $\mathrm{H}^{2 \mathrm{~b}}$ protons with $\mathrm{H}^{1}$ and $\mathrm{H}^{3}$ protons $\left({ }^{3} J_{\mathrm{H} 2 \mathrm{a}}\right.$ $\mathrm{H}_{3}=10.2 \mathrm{~Hz},{ }^{3} \mathrm{~J}_{\mathrm{H} 2 \mathrm{a}-\mathrm{H} 1}=2.8 \mathrm{~Hz}$ and ${ }^{3} \mathrm{~J}_{\mathrm{H} 2 \mathrm{~b}-\mathrm{H} 1}=10.7 \mathrm{~Hz},{ }^{3} \mathrm{~J}_{\mathrm{H} 2 \mathrm{~b}-\mathrm{H} 3}=3 \mathrm{~Hz}$ ) (Figure 2 and Table 2).

However, $\mathrm{H}^{3}$ proton forming a broad multiplet at $\delta_{H} 5.4 \mathrm{ppm}$, its stereochemistry could be deduced form the two lasting coupling constants in the $d d d$-signals of $\mathrm{H}^{2 \mathrm{a}}$ and $\mathrm{H}^{2 b}$ protons. The magnitudes of these couplings were consistent with proton $\mathrm{H}^{3}$ showing an anti-coupling constant with $\mathrm{H}^{2 a}$ proton


This was confirmed in the ${ }^{1} \mathrm{H}-{ }^{1} \mathrm{H}$ COSY chart where clear cross peaks are observed between resonances of both $\mathrm{H}^{2 \mathrm{a}}$ and $\mathrm{H}^{2 b}$ with those of both $\mathrm{H}^{1}$ and $\mathrm{H}^{3}$; what is consistent with a configuration where $\mathrm{H}^{3}$ occupies an anti-position relatively to $\mathrm{H}^{1}$ (otherwise $\mathrm{H}^{2}$ resonances would have been doublets of triplets), hence the naming anti-10 of this diastereomer (Figure 2 and Table 2).

Moreover, the protons of the two acetyl groups resonate as two distinct singlets at $\delta_{H} 2.0$ and 2.1 ppm . However, the two non-equivalent protons $\mathrm{H}^{4}$ appear as complex multiplets between $\delta_{H} 2.2-2.5 \mathrm{ppm}$, due to vicinal couplings with both $H^{3}$ and non-equivalent fluorine atoms $F_{\alpha}$ and $F_{\alpha^{\prime}}$ of the $\alpha-C F_{2}$ group, as confirmed in ${ }^{19} F$ NMR spectra where the latter give rise to an $A B$ system, whereas $F_{\alpha}$ and $F_{\alpha^{\prime}}$ atoms forming the $A$ - and B-parts, appear each as a doublet of doublets of doublets (ddd) at $\delta_{F}-112.5 \mathrm{ppm}$ and $\delta_{\mathrm{F}}-114.5 \mathrm{ppm}$. Both signals show geminal $\mathrm{F}_{\alpha^{-}} \mathrm{F}_{\alpha^{\prime}}$ coupling, causing a doublet splitting with ${ }^{2} J_{\mathrm{F} \alpha-\mathrm{F} \alpha^{\prime}}=$ 282 Hz , then $\mathrm{F}-\mathrm{H}$ coupling with the two vicinal $\mathrm{H}^{4}$ protons split further into doublets of doublets ${ }^{3} J_{\text {(anti- }}$ )Fa/ $\alpha^{\prime}-H 4=22.5$ and $^{3} J_{(s y n-) F \alpha / \alpha^{\prime}-H 4}=11.2 \mathrm{~Hz}$.

The signals of $\beta-C_{2}, \gamma-\mathrm{CF}_{2}, \delta-\mathrm{CF}_{2}$ and $\varepsilon-\mathrm{CF}_{2}$ groups appear as unresolved multiplets at $\delta_{\mathrm{F}}-122,-123.1$, -123.8 and -126.5 ppm respectively, finally the $-\mathrm{CF}_{3}$ end-group signal resonate at $\delta_{\mathrm{F}}-81.2 \mathrm{ppm}$ (Table 2).

## III. Mechanism of formation of 1,3-diacetoxy-4-perfluoroalkyl-1-iodobutane compounds 10-10"

Most likely, the formation of vinylacetate adducts proceeds through the well-known atom transfer radical chain reaction ${ }^{29-30}$ (Scheme 7), starting with the formation of perfluoroalkyl radicals $R_{F}{ }^{\bullet}$ from $\mathrm{R}_{\mathrm{Fl}}$ (after initiation by $\mathrm{Et}_{3} \mathrm{~B} /$ air or AIBN ), followed by the addition of $\mathrm{R}_{\mathrm{F}}{ }^{\circ}$ on 9 to form a radical monoadduct 12. The latter $\mathbf{1 2}$ can either further react on another $\mathbf{9}$ to form bis-adduct radical $\mathbf{1 3}$ (irreversible reaction), or reversibly abstract an iodine atom from another $R_{F} I$ to generate a new $R_{F}{ }^{\circ}$ radical and the iodo monoadduct 11-11" (present as minor products at the end of the reaction ${ }^{28 \mathrm{a}}$ ). Accordingly, the radical 13 will eventually react with an $R_{F}$ to generate a new $R_{F} \cdot$ radical and the iodo-bis-adduct 10-10".

While oligomerization of 9 might extend beyond the bis-adduct (until exhaustion of monomer 9), neither tris- nor further adducts were detected (the formation of which thus being likely limited to minute amounts). Both the good overall yield, bis-/mono-adduct ratio and the absence of oligomers, suggest the propagation step (addition of 9 on a radical) to be a bit slower than the initiation step, while anyway quite slower than the (reversible) iodine transfer process. ${ }^{30}$

## IV. Synthesis of 2-(perfluoroalkylmethyl)-1,2,3,4-tetrahydro-N-(R-phenyl)quinolin-4-amine 15a-o

In a next step (Scheme 8), the reaction of 1,3-diacetoxy-4-perfluoroalkyl-1-iodobutane 10-10" with various anilines 14a-o, lead to the formation of 2-(perfluoroalkylmethyl)-1,2,3,4-tetrahydro- $N$-( R -phenyl)quinolin-4-amine (THQ) 15a-o in fair to excellent yields ( $60-95 \%$ ), while moderate to good stereoselectivity occurred in favor of cis diastereomers (Table 3) according to ${ }^{1} \mathrm{H}$ and ${ }^{19} \mathrm{~F}$ NMR analysis of products.

In light of our previous works on the reactivity of gem-iodoacetoxy derivatives 11-11" with arylamines $14,{ }^{27-28}$ the reaction of 1,3 -diacetoxy-4-perfluorohexyl-1-iodobutane $\mathbf{1 0}$ with aniline $\mathbf{1 4}$ was first carried out according to our previously reported reaction conditions, ${ }^{28 b}$ namely a $3 / 1$ stoichiometric ratio of aniline 14 a vs. 10 in refluxing anhydrous dichloroethane $\left(83^{\circ} \mathrm{C}\right)$, resulting in poor yield ( $28 \%$ ) of THQ 15a while the reactant 10 readily underwent degradation. Further screening of conditions showed that a $4: 1$ stoichiometric ratio of aniline $\mathbf{1 4 a}$ vs. 10 in refluxing dichloromethane greatly increased the yields of THQ 15 up to ca. $95 \%$.

A typical procedure for this reaction begins with dissolving bis(acetoxy)iodobutane 10 and 4 equivalents of aniline 14a in anhydrous dichloromethane ( $5 \mathrm{~mL} / 1 \mathrm{~g}$ of 10) then heating to reflux, the reactions thus being typically completed within $3-8$ hours. A straightforward work-up through (i) filtering off the excess anilinium salts that had precipitated at the end of the reaction, then (ii) alkaline extraction, followed by (iii) flash-chromatography, allowed to isolate the THQ 15a (clear yellowish oil) as a mixture of cis- (major) and trans- (minor) diastereomers, the NMR structure determination of which is detailed in the next section.

Such optimized reaction conditions were applied to study the scope of 2,4-disubstituted THQ 15a-o synthesis, the results of which are listed in Table 3. In all cases the products $\mathbf{1 5}$ were isolated as mixtures of cis/trans diastereomer which were fully characterized by ${ }^{1} \mathrm{H}$ and ${ }^{19} \mathrm{~F}$ NMR, MS and elemental analysis (cis/trans diastereomeric ratios were assessed after integration of characteristic resonances). In some examples ( $\mathbf{1 5 a} \mathbf{, 1 5 b}, \mathbf{1 5 d}, \mathbf{1 5 j}$ and $\mathbf{1 5 n}$ ) the major cis- diastereomer could further be isolated by column chromatography from the isomer mixture, what helped the structural determination of the series; unfortunately in spite of many attempts, no crystals suitable for X -ray analysis of $\mathbf{1 5 a - 0}$ could be obtained.

Unsubstituted aniline 14a gave the corresponding 1,2,3,4-THQ 15a-a" in excellent yields (entries 1-3). Alkyl- and alkoxy-substituted arylamines $14 \mathrm{~b}-\mathrm{g}$ and $14 \mathrm{k}-\mathrm{n}$ afforded the corresponding products $\mathbf{1 5 b} \mathbf{- 1 5 g}$ ' and 15k-15n' in good to excellent yields (entries 4-11, 16-21). Noteworthy, electronwithdrawing groups such as chloro and nitro on the arylamine ring ( $\mathbf{1 4 h} \mathbf{- j}$ and $\mathbf{1 4 0}$ ) were well tolerated in the reaction, the corresponding substituted THQ 15h-15j' and $\mathbf{1 5 0}$ being formed in moderate yields while longer reaction times were required (entries 12-15, 22). Also noteworthy, ortho-substituted anilines $\mathbf{1 4 b} \mathbf{b} \mathbf{e} \mathbf{h}, \mathbf{k}, \mathbf{n}$ unsurprisingly lead to lower yields (entries $4,8,12,16,20-21$ ) likely because of higher steric hindrance against cyclization.

Unlike ortho- or para- subsitutions where only one THQ regiosiomer is possible, the reaction of metasubstituted anilines $\mathbf{1 4 c} \mathbf{c} \mathbf{f} \mathbf{i} \mathbf{i}, \mathrm{l}$ (entries $5,9,13,17$ ) could theoretically produce two regioisomers, namely 5- and 7-substituted THQ (Scheme 8). Actually the only detected regioisomer was the 7-substituted THQ 15c,f,i,I - although rather entangled, aromatic range ${ }^{1} \mathrm{H}$ NMR resonances exhibit two characteristic singlets (e.g. at $\delta_{H} 6.35$ and 6.4 ppm for 15 c ), what cannot occur with the 5 - regioisomer. Besides the inherently higher steric hindrance of a 5-substitution on 15 (vicinal to the 4- exocyclic arylamine) compared to a distant 7 -substitution (similar hindrance may already occur in the preceeding transition state), stereoelectronic effects of the meta-substituent may also influence the 7-vs. 5- regioselectivity of THQ formation; ${ }^{28 b, e}$ additional studies would be necessary to fully elucidate this aspect.

Although incompletely stereoselective, the formation of THQ neatly favors the formation of the cis diastereomer, the latter being largely predominant in THQ 15 derived from non-substituted or para/meta-substituted anilines ( $\mathbf{1 5 a} \mathrm{a}-\mathrm{a} \mathrm{\prime} \mathrm{\prime}, \mathbf{1 5 c}-\mathrm{d}^{\prime}, \mathbf{1 5 f}-\mathrm{g}^{\prime}, \mathbf{1 5 i} \mathrm{j} \mathrm{j}^{\prime}, \mathbf{1 5 1}-\mathrm{m}^{\prime}, \mathbf{1 5 0}$, cis/trans dr ranging from 8:2 to $9: 1$ ). However the stereoselectivity was quite weaker in the case of ortho-substituted anilines derivatives 15b, 15e, 15h, 15k and $\mathbf{1 5 n - n}$ ' (bearing either an alkyl, alkoxy or halogen group), correlatively to the lower overall THQ yield observed in this ortho- series compared to the others. Previous studies concluded from the Gibbs free energy profile of the Povarov THQ formation that the corresponding cis-THQ-isomer are being the kinetic control product. ${ }^{15,37}$ Accordingly, in our case the reaction of $\mathbf{1 0 - 1 0 "}$ with $\mathbf{1 4 a - o}$ is kinetically highly stereoselective leading to the formation of THQ cis-15a-o as major stereoisomers.

## V. Structure determination of 2-(perfluoroalkylmethyl)-1,2,3,4-tetrahydro-N-(R-phenyl)quinolin-4-amine 15a-0

In a first approach, the spectroscopic and elemental analysis data of compounds $\mathbf{1 5}$ are consistent with a 2,4 -substituted $1,2,3,4$-tetrahydroquinoline structure; especially, ${ }^{1} \mathrm{H} /{ }^{13} \mathrm{C} /{ }^{19} \mathrm{~F} 1 \mathrm{D}$ and 2 D NMR spectra showed the presence of two isomers in unequal amounts (ratios ranging from 6:4 to 9:1 according to ${ }^{1} \mathrm{H}$ and ${ }^{19} \mathrm{~F}$ resonance integration). Most likely the latter correspond to both cis- and transconfigurations of both $R_{F}$ and arylamine substituents on the THQ. Further elucidation of the relative configuration was done after isolation of the major isomer (what was possible for a few examples in the series 15a-0).

Published experimental data about structural and conformational properties of tetrahydroheterocycles containing pnictogen ( $\mathrm{N}, \mathrm{P}, \mathrm{As}$ ) or chalcogen ( $\mathrm{O}, \mathrm{S}, \mathrm{Se}$ ) atoms, show that equilibrium conformation of these heterocycles is a half-chair in all cases. ${ }^{38,39}$ These results were applied to the conformational analysis of $1,2,3,4$-tetrahydroquinolines in which $n-\pi$ conjugation between the lone pair of the heteroatom and the $\pi$-system of the aromatic nucleus, significantly influence the ring conformation. ${ }^{388,40,41}$

While the nitrogen atom and carbon on position 4 must be coplanar with the condensed benzene moiety, carbons $\mathrm{C}^{2}$ and $\mathrm{C}^{3}$ can be either on opposite sides with respect to the plane (generating halfchair conformation I, Scheme 9) or on the same side (generating boat conformation II): in the latter case, though, severe eclipsing at the $\mathrm{C}^{2}-\mathrm{C}^{3}$ bond can be expected. Another possibility is represented by sofa conformation III, exhibiting just one carbon out of the plane and possibly less effective eclipsing than the boat. For this reason, sofa conformations received much attention as possible competitors of half-chairs. ${ }^{42}$ However, it had been concluded from X-ray and NMR analyses that 1,2,3,4tetrahydroquinoline compounds preferentially adopt a half-chair conformation I with the $C^{4}$ atom bearing pseudo-axial and pseudo-equatorial bonds (Scheme 9). ${ }^{40-43}$

The assignment of cis-/trans-configurations was based on both the scalar coupling constant between protons $\mathrm{H}^{2}$ (or $\mathrm{H}^{4}$ ) with $\mathrm{H}^{3}{ }_{a x}$ and $\mathrm{H}^{3}$ eq and their multiplicity values, as well as the chemical shifts of aliphatic protons. ${ }^{25,40,42 a}$ In such cyclic systems, the Karplus-Conroy rule predicts high ${ }^{3}{ }^{3}$ 期 values (1015 Hz ) for the trans-di-axial interaction of two vicinal protons and low ${ }^{3}{ }_{\mathrm{HH}}$ values $(2-5 \mathrm{~Hz})$ for the staggered 1,2-axial-equatorial or 1,2-di-equatorial interactions of protons. ${ }^{44}$

NMR spectra of pure cis- and trans-2-(perfluorohexylmethyl)-1,2,3,4-tetrahydro- $N$-(phenyl)quinolin-4amine $\mathbf{1 5 a}$ are typical of the series and will be discussed in detail. While the configuration of cis-15a was first determined by ${ }^{1} \mathrm{H}$ NMR analysis of the isolated stereomer, ${ }^{40}$ for better overall clarity hereafter NMR data were taken form the spectrum of the cis+trans mixture. Thus, the small triplet couplings (J $=3.1 \mathrm{~Hz}$ ) appearing at $\delta 4.5 \mathrm{ppm}$ which should be considered as a doublet of doublets with two close splitting values $\left({ }^{3} J_{\mathrm{H} 4-\mathrm{H} 3 \mathrm{x}} \approx{ }^{3} J_{\mathrm{H} 4-\mathrm{Hzeq}}\right)$, is characteristic of a pseudo-equatorial $\mathrm{H}^{4}$ as reported earlier. ${ }^{25,40,42}$ Furthermore, the triplet of doublets of doublets ( $J=10.1$ and 2.5 Hz ) at $\delta_{H} 3.8 \mathrm{ppm}$ corresponds to coupling of $\mathrm{H}^{2}$ with vicinal $\mathrm{CH}_{2}$ group then further almost identical coupling constants with $\mathrm{H}^{3}{ }_{\mathrm{ax}}$ and $\mathrm{H}^{3}{ }_{\text {eq }}\left({ }^{3} \mathrm{H}_{22-\mathrm{Hzax}} \approx{ }^{3} \mathrm{H}_{\mathrm{H} 2-\mathrm{Hzeq}} \approx 2.5 \mathrm{~Hz}\right.$ ) is characteristic of an equatorial $\mathrm{H}^{2}$ proton ${ }^{40,42}$ (Scheme 9).

The overall coupling constants for equatorial $\mathrm{H}^{2}$ and pseudo-equatorial $\mathrm{H}^{4}$ resonances, are consistent with a cis orientation of the corresponding substituents on carbon 2 and carbon 4 positions namely an axial $\mathrm{R}_{\mathrm{F}}-\mathrm{CH}_{2}$ - group and a pseudoaxial-arylamine group (Scheme 9).

Moreover, $\mathrm{H}^{3}{ }_{\mathrm{ax}}$ resonance at $\delta 2.1 \mathrm{ppm}$ is a doublet of doublet of doublets ( $J=12.8$ and 2.5 Hz ) with a large coupling constant with the geminal $\mathrm{H}^{3}$ eq $\left({ }^{2}{ }_{\mathrm{H} 3 \mathrm{ax}-\mathrm{H} \text { eq }}=12.8 \mathrm{~Hz}\right)$ and two identical coupling constants with di-equatorial $\mathrm{H}^{2}$ and $\mathrm{H}^{4}\left({ }^{3} \mathrm{H}_{\mathrm{Hzax}} \mathrm{H}_{2} \approx{ }^{3} \mathrm{H}_{\mathrm{H} a \mathrm{ax}} \mathrm{H} \approx 2.5 \mathrm{~Hz}\right.$ ), whereas $\mathrm{H}^{3}{ }_{\text {eq }}$ resonance at $\delta 1.7 \mathrm{ppm}$ is as a
 methylene $\mathrm{CH}_{2}-\mathrm{R}_{\mathrm{F}}$ shows a multiplet at $\delta 2.25 \mathrm{ppm}$, the amine protons gave a broad signal between $\delta$ 3.5 and 4.4 ppm and finally the aromatic protons resonate between $\delta 6.4$ and 7.4 ppm . (Supporting Information p. S42)

Analysis of the ${ }^{1} \mathrm{H}$ resonances of trans-15a (on NMR spectra of the cis+trans mixture) showed that the hydrogen bound to carbon 4 is pseudo-axial. Thus, $\mathrm{H}^{4}$ appeared as a doublet of doublets ( $\delta 4.8 \mathrm{ppm}$, ${ }^{3} J_{\mathrm{H} 4-\mathrm{H} 3 \mathrm{ax}}=10.1 \mathrm{~Hz}$ and ${ }^{3} \mathrm{~J}_{\mathrm{H} 4-\mathrm{H} 3 \mathrm{eq}}=5.3 \mathrm{~Hz}$ ), the large coupling constant of 10.1 Hz thus confirming the trans di-axial arrangement of $\mathrm{H}^{4}$ and $\mathrm{H}^{3}$ (Scheme 9).

The resonance of $\mathrm{H}^{2}$ at $\delta 3.9 \mathrm{ppm}$ give rise to a triplet of doublets of doublets due to its vicinal coupling to $\mathrm{CH}_{2}-\mathrm{R}_{\mathrm{F}}$ methylene protons ( ${ }^{3} \mathrm{H}_{\mathrm{H} 2} \mathrm{CH} 2=11.1 \mathrm{~Hz}$ ) and to small vicinal couplings with both $\mathrm{H}^{3}{ }_{\mathrm{ax}}$ and $\mathrm{H}^{3}$ eq $\left({ }^{3} J_{\mathrm{H} 2-\mathrm{Hzax}} \approx{ }^{3} \mathrm{~J}_{\mathrm{H} 2-\mathrm{H} 3 \mathrm{eq}} \approx 2.9 \mathrm{~Hz}\right)$ what supports an equatorial position for $\mathrm{H}^{2}$.

From these results, it appears that for the minor trans-diastereomer, the carbon-2 perfluoroalkylmethyl substituent is axial and the carbon-4 phenylamine group is pseudo-equatorial (Scheme 9).

However, multiplicities and couplings for $\mathrm{H}^{3}{ }_{\mathrm{ax}}, \mathrm{CH}_{2}-\mathrm{R}_{\mathrm{F}}$ and $\mathrm{H}^{3}{ }_{\text {eq }}$ resonances at $\delta 2.3 ; 2.25$ and 1.7 ppm respectively, were difficult to determine by ${ }^{1} \mathrm{H}$ NMR because of signal overlap. Attempts to improve signal separation using high-temperature NMR or another solvent, were unsuccessful. However, a consideration of two-dimensional ${ }^{1} \mathrm{H}-{ }^{1} \mathrm{H}$ COSY data facilitated assignment of resonances to appropriate protons. Additionally, amine protons gave a broad signal at $\delta_{H} 3.5-4.4 \mathrm{ppm}$ and finally the aromatic protons resonate between $\delta_{H} 6.4$ and 7.4 ppm . (Supporting Information p. S44).

Accordingly, NMR signals of aliphatic protons were fully interpreted and assigned for both cis- and trans- isomers of all of 15a-o derivatives. Striking differences occur between 2,4-cis and 2,4-trans diastereomers, not only in ${ }^{3} J_{\mathrm{H}-\mathrm{H}}$ couplings (as expected) but also in the chemical shifts of $\mathrm{H}^{2}, \mathrm{H}^{3}$ ax and $\mathrm{H}^{4}$ resonances.

The assessed stereochemistry is highlighted in Scheme 9, where cis- and trans-configurations of THQ 15a are shown in the half-chair conformations. ${ }^{40,42}$

## VI. Mechanism of THQ 15a-o formation

In order to better understand the mechanism of THQ formation, the reaction was monitored by ${ }^{19} \mathrm{~F}$ NMR analysis of aliquots of the medium (after dilution in $\mathrm{CDCl}_{3}$ ), comparing with ${ }^{19} \mathrm{~F}$ NMR spectra of the (reactant) perfluoroalkyl derivative 10 and of the already isolated THQ 15. The consumption of 10 was accompanied by the formation of the intermediate 16 identified as 4-perfluoroalkylbut-2-enal ( $R_{F}-$ crotonaldehyde, Scheme 10). Subsequently, 16 gradually disappeared while the final THQ 15 was gradually formed. Besides, the side product arylacetamide was detected in the medium, while nonconsumed arylamine 14 was recovered (as a salt) in precipitates at the end of the reaction.

Isolation of the intermediate 16 was easier upon a change of reaction conditions, namely a 2:1 stoichiometry of 14 vs. 10 (instead of $4: 1$ ), lower concentration ( $15 \mathrm{mLCH}_{2} \mathrm{Cl}_{2}$ per 1 g of 10 instead of $5 \mathrm{~mL} / \mathrm{g}$ ) and operating at room temperature instead of reflux for 1 h , although 10 was not fully consumed while small amounts of THQ were already formed. After work-up and chromatography, 16 was isolated as an oil in moderate yield (20-48\%) and characterized by ${ }^{1} \mathrm{H},{ }^{13} \mathrm{C}$ and ${ }^{19} \mathrm{~F}$ NMR, MS and elemental analysis. The reaction of 16 with excess arylamine 14 was subsequently investigated in refluxing dichloromethane (in the presence of hydrogen iodide to mimic the conditions induced by in situ formation of 16), where the expected THQ 15 was formed with similar cis/trans diastereoselectivity, however in significantly lower yields (40-60\%) than upon starting from 10 and 14.

On basis of above observations and of the knowledge of gem-iodoacetoxy-perfluoroalkyl derivative reactivity, ${ }^{26-28}$ the postulated mechanism involved in THQ formation (Scheme 10) begins with a nucleophilic attack by the arylamine 14 on the 1 -acetoxy group of 10 , which leads to the elimination of hydrogen iodide and acetanilide. The next step is a concerted trans-elimination of acetic acid assisted by another aniline molecule, which affords the substituted crotonaldehyde 16. Subsequently, 16 may then undego a Michael attack by the nitrogen lone pair of 14, what generates an amino-enol intermediate which can tautomerize into the corresponding $\beta$-amino-carbonyl derivative; the later then undergoes a nucleophilic addition by another arylamine 14 to afford the $\beta$-amino-imine intermediate 17. Finally, the cyclization of 17 through an intramolecular electrophilic aromatic substitution, affords the final THQ 15 (both the 5/7 regioselectivity and cis/trans diastereoselectivity being determined by this cyclization step, Scheme 10). Although the postulated intermediate 17 (aromatic imine) is expected to be rather stable, it was not detected in the reaction medium under the conditions of THQ formation; what suggests the final cyclization step to be rather fast once $\mathbf{1 7}$ would be formed. The lower efficiency when proceeding in two steps through isolation of 16, leaves room for alternate pathways or concerted/catalytic processes; the elucidation of which will require further investigation.

## Conclusion

In this paper, two original series of perfluoroalkyl derivatives including tetrahydroquinolins, have been prepared and described. First, we developed a simple and efficient method for the preparation of so far undescribed trifunctional gem-iodoacetoxy derivatives 10-10" (1-iodo,1,3-diacetoxy-4perfluoroalkylbutane) through the bis-addition of vinyl acetate on a perfluoroalkyliodide $\mathrm{R}_{\mathrm{F}}\left(\mathrm{R}_{\mathrm{F}}=\mathrm{C}_{6} \mathrm{~F}_{13}\right.$, $\mathrm{C}_{4} \mathrm{~F}_{9}, \mathrm{C}_{2} \mathrm{~F}_{5}$ ) through an iodine atom transfer radical chain reaction. Chemoselective bis-addition (although not total over single addition) was best achieved upon $\mathrm{Et}_{3} \mathrm{~B} /$ air radical initiation at room temperature ( $90: 10$ to $95: 5$ selectivity) rather than AIBN initiation at $80^{\circ} \mathrm{C}$. Compounds $\mathbf{1 0} \mathbf{- 1 0 \prime \prime}$ were formed as mixtures of diastereomers in 80:20 anti-/syn- ratio (if necessary the major anti- isomer could be further isolated) and were characterized by ${ }^{1} \mathrm{H} /{ }^{19} \mathrm{~F}$ NMR and mass spectrometry. Besides, since the gem-iodoacetoxy group is a masked aldehyde ${ }^{28 \mathrm{a}}$ (inter alia having the same oxidation degree), compounds 10-10" are masked/activated aldols; given the high popularity of this synthon, ${ }^{45} \mathbf{1 0 - 1 0 \prime \prime}$ or derivatives would deserve of future extensive reactivity investigation with a perspective of new aldol-based syntheses of perfluoroalkyl-containing compounds.

In the subsequent study described here, gem-iodoacetoxy compounds 10-10" became the substrate for a new, efficient, diastereoselective one-pot synthesis of functionalized 1,2,3,4tetrahydroquinolines 15 bearing 2 -perfluoroalkylmethyl and 4 -arylamino substituents. Thus the reaction of $\mathbf{1 0} \mathbf{- 1 0 \prime \prime}$ with substituted anilines in $1: 4$ stoichiometry under mild conditions (refluxing dichloromethane for a few hours), afforded the $\mathrm{R}_{\mathrm{F}}$ /arylamine-substituted THQ 15 with fair to excellent yields (60-95\%). The reaction was exemplified with various $R_{F}\left(C_{6} F_{13}, C_{4} F_{9}, C_{2} F_{5}\right)$ and monosubstituted anilines ( $0-/ m-/ p$ - alkyl, alkoxyl, halogeno, nitro), the resulting THQ derivatives $15 \mathrm{a}-\mathrm{o}$ being fully
characterized by ${ }^{1} \mathrm{H},{ }^{13} \mathrm{C}$ and ${ }^{19} \mathrm{~F}$ NMR and mass spectrometry. As for the gem-iodoacetoxy compounds 10-10", the structure of THQ 15a-o was determined on basis of NMR chemical shifts and couplings.

THQ examples involving meta- substituted arylamines were regiospecific in favor of (less sterically hindered) 7 -substituted regioisomers. In all examples the formation of THQ was diastereoselective, the cis-stereoisomer being formed in 65:35 to 95:5 ratio over the trans- isomer - in favorable cases, the major isomer cis- $\mathbf{1 5}$ could further be isolated from the cis/trans mixture. THQ $\mathbf{1 5}$ derived from nonor meta-/para-substituted anilines, were formed in very good yields and diastereoselectivities; however in the presence of ortho- or electron-withdrawing substituents, lower yields and stereoselectivities were achieved. Mechanistic investigation revealed the intermediacy of an $\mathrm{R}_{\mathrm{F}}$ crotonaldehyde 16, the reaction of which with 14 also leads to THQ 15, although much less efficiently. The key step is believed to be the regio- and stereoselective cyclization of a bis(arylamino/imino) intermediate $\mathbf{1 7}$ through electrophillic aromatic substitution. While further investigation would be necessary to better understand the mechanism and stereoselectivity of THQ formation, this first, multicomponent synthesis of 2-perfluoroalkylated THQ, may be useful to access new, highly functionalized heterocycles of importance in medicinal chemistry.

## Experimental Section

Materials and methods. All reaction solvents were purchased from commercial suppliers and distilled before use. All synthetic reactions were performed in oven-dried glassware, their progress being monitored by thin layer chromatography (TLC) using silica gel plates, and/or by ${ }^{19} \mathrm{~F}$ NMR spectroscopy of aliquots. Chromatographic column purifications were performed on silica gel ( $40-63 \mu \mathrm{~m}$ ), typically using $30 \times$ weight of eluted sample. ${ }^{1} \mathrm{H},{ }^{13} \mathrm{C}$ and ${ }^{19} \mathrm{~F}$ NMR spectra were recorded in either CDCl 3 solution on an Avance $300(300 \mathrm{MHz})$ or an Avance $400(400 \mathrm{MHz})$ spectrometer (Bruker, Billerica, MA, USA). Chemical shifts are reported in ppm, using the solvent chemical shift as a reference (or added $\mathrm{CFCl}_{3}$ for ${ }^{19} \mathrm{~F}$ ). Abbreviations used in the description of NMR spectra: s: singlet, d: doublet, t : triplet, q : quadruplet, bs: broad signal. Coupling constants (J) are given in Hertz. Mass spectra (either low- or high-resolution) were recorded on a SX102 mass spectrometer (JEOL, Tokyo, Japan) in $\mathrm{FAB}^{+}$mode, using 3-nitrobenzyl alcohol matrix. Elemental analyses were carried out on a Flash 2000 elemental analyzer (Thermo Finnigan, Waltham, MA, USA). Warning: radical initiators such as $\mathrm{Et}_{3} \mathrm{~B}$ or AIBN may cause explosions when heated at gram scale in pure or concentrated state. Special care must be taken e.g. upon evaporation of crude reaction mixtures.

## Synthesis of 1,3-diacetoxy-1-iodo-4-(tridecafluorohexyl)-butane 10 ( $\mathrm{Et}_{3} \mathrm{~B}$ initiation)

To a mixture of 10 mL or $20.63 \mathrm{~g}\left(4.62 \times 10^{-2} \mathrm{~mole}\right)$ of tridecafluoro-1-iodohexane 8 (1 equiv.) and 14.9 $\mathrm{mL}(13.92 \mathrm{~g}, 0.161$ mole) of vinyl acetate 9 ( 3.5 equiv.) in a three-necked flask equipped with a reflux condenser, was added 0.9 mL of 1.0 M triethylborane solution in hexane $\left(0.925 \times 10^{-3} \mathrm{~mol}_{\mathrm{Et}}^{3} \mathrm{~B}, 0.01\right.$ equiv.) under stirring. Dry air was injected in the reaction. After stirring for 15 minutes, additional 0.01 equiv. of $1.0 \mathrm{M}_{3} \mathrm{~B}$ in hexane and dry air were introduced in the mixture (after some induction delay, important heat release occurred in the medium). The mixture was then stirred for 60 minutes with several dry air injections. After complete consumption of starting material $\mathbf{8}$ (monitoring by ${ }^{19}$ F NMR analysis of aliquots), the mixture was allowed to cool to r.t., then was chromatographed on silica gel (eluent: petroleum ether/ethyl acetate, $95: 5 \mathrm{v} / \mathrm{v}$ ) to afford 27.15 g (yield: $95 \%$ ) of 1,3-diacetoxy-4-(tridecafluorohexyl)-1-iodobutane $\mathbf{1 0}$ as a yellow brownish liquid, as a mixture of diastereomers in the ratio anti-10 : syn-10 = 80:20 ( ${ }^{1} \mathrm{H}$ and ${ }^{19} \mathrm{~F}$ NMR); and 1.23 g (yield: 5\%) of side-product 1-acetoxy-2-(tridecafluorohexyl)-1-iodoethane 11.

## Synthesis of 1,3-diacetoxy-1-iodo-4-(tridecafluorohexyl)-butane 10 (AIBN initiation)

In a round bottom flask fitted with a reflux condenser and a magnetic stirrer, were mixed 11 mL ( 22.69 $\mathrm{g}, 5.08 \times 10^{-2} \mathrm{~mole}$ ) of tridecafluoro-1-iodohexane 8 ( 1 equiv.), 15.31 g ( 0.178 mole) of vinyl acetate 9 ( 3.5 equiv.) and then 0.83 g ( $5.08 \times 10^{-3}$ mole, 0.1 equiv.) of azo-bis-isobutyronitrile (AIBN). The mixture was carefully deaerated by bubbling argon under stirring at $r t$, then heated to $80^{\circ} \mathrm{C}$ for 90 minutes, while a vigorous reflux was observed. When the reaction was completed (complete consumption of 8 monitored by ${ }^{19} \mathrm{~F}$ NMR of aliquots) the mixture was allowed to cool to r.t., then was separated by column chromatography over silica gel (eluent: petroleum ether/ethyl acetate $95 / 5 \mathrm{v} / \mathrm{v}$ ) to afford 27.66 g (yield: 88\%) of the desired 1,3-diacetoxy-4-(tridecafluorohexyl)-1-iodobutane 10 (mixture of diastereomers in the ratio anti-10 : syn-10=80:20) as a yellow brownish liquid; and 3.24 g (yield:12\%) of the side-product 1-acetoxy-2-(tridecafluorohexyl)-1-iodoethane 11.
Nota. For either $\mathrm{Et}_{3} \mathrm{~B} / \mathrm{AIBN}$ initiation method, unreacted vinyl acetate that might remain mixed with $\mathbf{1 0}$ or $\mathbf{1 1}$ chromatographic fractions, was easily distilled off on a rotary evaporator.

## Synthesis of substituted cis-/trans-2-(perfluoroalkylmethyl)-4-(arylamino)-1,2,3,4tetrahydroquinolines 15a-0.

In a round-bottomed flask fitted with a magnetic stirrer and a reflux condenser, $1.5 \mathrm{~g}\left(2.42 \times 10^{-3} \mathrm{~mole}\right)$ of 1,3-diacetoxy-1-iodo-4-(tridecafluorohexyl)-butane 10 (1 equiv.) and 0.9 g of aniline 14 a ( $9.7 \times 10^{-3}$ mole, 4 equiv.) were dissolved in 7.5 mL of anhydrous dichloromethane ( 5 mL per 1 g of 10) then stirred upon heating to reflux for 4 h until complete consumption of $\mathbf{1 0}$ (monitored by ${ }^{19} \mathrm{~F}$ NMR analysis of aliquots). The mixture was then allowed to cool to room temperature, then arylammonium salt precipitates were filtered off through a glass filter then washed twice with dichloromethane. The combined filtrates were extracted three times with water, twice with $3 \%$ aqueous $\mathrm{NaHCO}_{3}$, then repeatedly washed with water until the pH of the aqueous layer reached neutrality ( pH tape test). The organic layer was dried over sodium sulphate then the solvent was evaporated in vacuo to give the crude product which was purified by column chromatography on silica gel (eluent: petroleum ether/ethyl acetate $90: 10, \mathrm{v} / \mathrm{v}$ ) to afford pure tetrahydroquinoline 15 a ( 1.21 g , yield: $90 \%$ ) as a yellowish oil, mixture of cis-/trans-diastereomers in the ratio cis-15a : trans-15a $78: 22\left({ }^{1} \mathrm{H}\right.$ and ${ }^{19} \mathrm{~F}$ NMR). The major (cis) diastereomer was subsequently isolated from the cis/trans mixture by further chromatography (same eluent). Both the cis/trans mixture and isolated cis-diastereomer, were characterized by ${ }^{1} \mathrm{H}$ and ${ }^{19} \mathrm{~F}$ NMR, MS and elemental analysis.

## Isolation of intermediate (E)-5,5,6,6,7,7,8,8,9,9,10,10,10-tridecafluorodec-2-enal 16

A solution of $1.88 \mathrm{~g}\left(3.04 \times 10^{-3}\right.$ mole, 1 equiv.) of 1,3-diacetoxy-1-iodo-4-(tridecafluorohexyl)-butane 10 in 28.5 mL dichloromethane ( 15 mL DCM per 1 g of 10 ) was prepared in a round-bottom flask. To this were added 0.56 g ( $6.08 \times 10^{-3}$ mole, 2 equiv.) of aniline 14 a then the solution was stirred at room temperature for 4 hours until the formation of intermediate 16 was observed by ${ }^{19} \mathrm{~F}$ NMR monitoring of aliquots. Arylamonium salt precipitates were then filtered off and washed with dichloromethane, then the combined filtrates were extracted twice with water, twice with 0.1 M HCl , then twice with water. The organic layer was dried over sodium sulphate and the solvent was evaporated to give the crude product which was purified by column chromatography on silica gel (eluent: with petroleum ether/ethyl acetate $95 / 5, \mathrm{v} / \mathrm{v}$ ) to afford 0.56 g (yield: $48 \%$ ) of pure compound 16 as a liquid; identified by ${ }^{1} \mathrm{H}$ NMR as the ( E ) isomer.

Reactivity study: formation of THQ 15a from isolated intermediate 16 and aniline 14a
On a $10-100-\mathrm{mg}$ scale, $5,5,6,6,7,7,8,8,9,9,10,10,10$-tridecafluorodec- 2 -enal 16 (1 equiv.) was reacted with 2 equivalents of aniline 14a in dichloromethane ( $5 \mathrm{~mL} / 1 \mathrm{~g}$ of 16). The mixture was stirred under reflux at $40^{\circ} \mathrm{C}$ for 8 hours, with monitoring by ${ }^{19} \mathrm{~F} \mathrm{NMR} \mathrm{spectroscopy} \mathrm{of} \mathrm{aliquots} \mathrm{(diluted} \mathrm{in} \mathrm{CDCl}_{3}$ ). At the end of the reaction, chromatography on silica gel column (eluent: petroleum ether/ ethyl acetate: $90 / 10 ; \mathrm{v} / \mathrm{v}$ ) left a yellow liquid exhibiting identical physical characterization as the previously isolated

THQ 15a. The same reaction was repeated on several examples, starting from either substrate 16, 16’ or 16 " and various arylamines 14a-0 with identical results; yields in 15a-0: 40 to $60 \%$.
