# HITCHIN FIBRATION UNDER RAMIFIED COVERINGS 

THIAGO FASSARELLA AND FRANK LORAY


#### Abstract

We are interested in studying the variation of the Hitchin fibration in moduli spaces of parabolic Higgs bundles, under the action of a ramified covering. Given a degree two map $\pi: Y \rightarrow X$ between compact Riemann surfaces, we may pull back a Higgs bundle from $X$ to $Y$, the lifted Higgs bundle tends to have many apparent singularities, then we perform a suitable birational transformation in order to eliminate them. This correspondence preserves the Hitchin fibrations and then its restriction to a general fiber gives a map between Abelian varieties. The aim of this paper is to describe this map.


## 1. Introduction

Let $X$ be a compact Riemann surface of genus $g_{X}$ and let $D=t_{1}+\cdots+t_{n}$ be a divisor on it determined by $n$ distinct points. These points are called parabolic points. We are interested in moduli spaces of Higgs bundles on $X$ with simple poles on $D$. Higgs bundles were originally introduced by Hitchin [7, 8] (see also [16]), without parabolic structure, and then extended to parabolic context in [19, 20, 21, 11, 15]. The Hitchin fibration is defined on these moduli spaces and it is a source of remarkable applications [6, 9, 17, 18]. In this paper we study the behavior of a degree two ramified covering with respect to this fibration.

Let $\omega_{X}$ denote the canonical sheaf of $X$. A rank two Higgs bundle on $(X, D)$ consists of a rank two holomorphic vector bundle $E$ on $X$, endowed with a homomorphism $\theta: E \rightarrow$ $E \otimes \omega_{X}(D)$, which has nilpotent residual matrix $\operatorname{Res}\left(\theta ; t_{i}\right)$ at each parabolic point. For any integer $d$, there is a moduli space $\mathcal{H}(X, D, d)$ parametrizing Higgs bundles over $(X, D)$, with fixed degree $\operatorname{deg} E=d$. Actually, we consider triples $(E, \mathbf{p}, \theta)$ where $\mathbf{p}$ intends to be the parabolic direction, described just below. See Section 3.2 for the detailed definition. The definition of these moduli spaces also depends on a choice of a weight vector (a sequence of reals numbers $\left.0 \leq \mu_{i} \leq 1, i=1, \ldots, n\right)$ which gives a notion of slope-stability. The moduli space $\mathcal{H}(X, D, d)$ is a normal variety of dimension $2\left(n-3+4 g_{X}\right)$, if it is nonempty. For instance see [21, Theorem 5.2] and our Remark 3.4.

Closely related, is the moduli space of parabolic vector bundles $\operatorname{Bun}(X, D, d)$, which is a normal variety of dimension $n-3+4 g_{X}$, if the stable locus is nonempty. An element of it consists of a pair $(E, \mathbf{p})$, where the additional data $\mathbf{p}$ refers to a one dimensional subspace on the fiber of $E$ over each parabolic point. There is a rational map $\mathcal{H}(X, D, d) \rightarrow \operatorname{Bun}(X, D, d)$ which associates to a Higgs field its underlying parabolic vector bundle, where the parabolic

[^0]direction over $t_{i}$ coincides with the kernel of $\operatorname{Res}\left(\theta ; t_{i}\right)$. It turns out that the fiber of this map, at a generic point, identifies with the cotangent space $T_{(E, \mathbf{p}, \theta)}^{*} \operatorname{Bun}(X, D, d)$. In addition, $\mathcal{H}(X, D, d)$ admits a symplectic structure which coincides with that of $T^{*} \operatorname{Bun}(X, D, d)$, given by the Liouville form.

An important player on this subject is the Hitchin map $H_{X}$, it associates to a Higgs bundle its characteristic polynomial. This map is known to be an algebraically integrable system, which turns out to say that the fiber over a generic point is Lagrangian and isomorphic to an Abelian variety. This last consists of the Picard variety

$$
H_{X}^{-1}(s) \simeq \operatorname{Pic}^{\mathfrak{n}}\left(X_{s}\right)
$$

(of the corresponding spectral curve $X_{s}$ ) which parametrizes line bundles of degree $\mathfrak{n}=$ $d+n+2\left(g_{X}-1\right)$ on $X_{s}$. This correspondence is reviewed in Section 2, as well as the notion of spectral curve, which appears as a 2:1 cover $q_{s}: X_{s} \rightarrow X$.

The main goal of this paper is to study the behavior of a degree two ramified covering $\pi: Y \rightarrow X$, between compact Riemann surfaces, with respect to the Hitchin fibration. We can pull back parabolic Higgs bundles from $X$ to $Y$. The lifted Higgs field, after pull back, tends to have apparent singularities, as well as the corresponding spectral curve has many singular points. In order to eliminate them, we perform a suitable elementary transformation, and this process gives a correspondence $\Phi$ between moduli spaces, which we now describe.

Assume that $\pi$ is branched over the points $x_{1}, \ldots, x_{n}, n \geq 1$, and let $B=\sum_{i=1}^{n} x_{i}$ be the reduced divisor on $X$ defined by them. Let $R=\sum_{i=1}^{n} y_{i}$ be the corresponding divisor on $Y$ defined by the set of ramification points, with $\pi\left(y_{i}\right)=x_{i}$. Let $T=\sum_{i=1}^{k} t_{i}, k \geq 0$, be a reduced divisor on $X(T=0$ when $k=0)$ formed by points outside the support of $B$. We consider a map between moduli spaces

$$
\Phi: \mathcal{H}(X, B+T, 0) \longrightarrow \mathcal{H}\left(Y, \pi^{*} T,-n\right)
$$

which is defined by doing the pull back $\pi^{*}$ followed by an elementary transformation elem $_{R}$ over $R$ (see Section 2.4 for the detailed definition). This map preserves the Hitchin fibration and we denote by

$$
\Phi_{s}: H_{X}^{-1}(s) \rightarrow H_{Y}^{-1}(r)
$$

its restriction to a given fiber.
Assuming $2 g_{X}+n-4 \geq 0$, with strict inequality if $k=0$, we assure that the generic spectral curve in both moduli spaces is smooth and irreducible (see Proposition 4.1). We show that there is an étale morphism $\xi_{s}: Y_{r} \rightarrow X_{s}$ of degree two between spectral curves (Proposition 4.2), and the modular map $\Phi_{s}$ is determined by $\xi_{s}^{*}$, up to a translation. This is the main result of this paper, Theorem 5.1 in the main text.

Theorem 1.1. Assume that $2 g_{X}+n-4 \geq 0$, with strict inequality if $k=0$. Then $\Phi$ is a rational map of degree two onto its image, and it preserves the Hitchin fibrations. Moreover, its restriction to a general Hitchin fiber is the map

$$
\Phi_{s}: \operatorname{Pic}^{\mathfrak{n}}\left(X_{s}\right) \longrightarrow \operatorname{Pic}^{\tilde{\mathfrak{n}}}\left(Y_{r}\right)
$$

which sends a line bundle $M$ in $\operatorname{Pic}^{\mathfrak{n}}\left(X_{s}\right)$ to the line bundle $\xi_{s}^{*}(M)\left(q_{r}^{*}(-R)\right)$ in $\operatorname{Pic}^{\tilde{\mathfrak{n}}}\left(Y_{r}\right)$.

We finish the paper by applying Theorem 1.1 to a degree two morphism $\pi: Y \rightarrow \mathbb{P}^{1}$ where $g_{Y} \in\{1,2\}$. Let us briefly describe each case.

In the former case $g_{Y}=1$, we consider the moduli space $\mathcal{H}\left(\mathbb{P}^{1}, \Lambda\right)$ of $S L_{2}$-Higgs bundles, i.e. having vanishing trace and trivial determinant line bundle, on $\left(\mathbb{P}^{1}, \Lambda\right)$, where $\Lambda$ is given by branch points $\{0,1, \lambda, \infty\}$ of $\pi$ with an extra point $t$. After multiplication by a suitable line bundle to redress the determinant, we get a modular map $\Phi_{0}: \mathcal{H}\left(\mathbb{P}^{1}, \Lambda\right) \rightarrow \mathcal{H}(Y, D)$ to the moduli space $\mathcal{H}(Y, D)$ of $S L_{2}$-Higgs bundles over the elliptic curve $Y$, with simple poles on $D=t_{1}+t_{2}$, with $\pi\left(t_{i}\right)=t$. The spectral curve $X_{s}$, on the $\mathbb{P}^{1}$ side, has genus 2 ; on the elliptic side, the spectral curve $Y_{r}$ has genus 3.

In the second case $g_{Y}=2$, we consider the moduli space $\mathcal{H}\left(\mathbb{P}^{1}, B\right)$ of $S L_{2}$-Higgs bundles over $\left(\mathbb{P}^{1}, B\right)$, where $B$ is formed by branch points of $\pi$. After renormalization of the determinant line bundle, we get a modular $\Phi_{0}: \mathcal{H}\left(\mathbb{P}^{1}, B\right) \rightarrow \mathcal{H}(Y)$ map with values on the moduli space $\mathcal{H}(Y)$ of holomorphic Higgs bundles (without parabolic points) over $Y$. The spectral curve $X_{s}$ over $\mathbb{P}^{1}$ has genus 3 , and over $Y$, the spectral curve $Y_{r}$ has genus 5. In this context, Theorem 1.1 yields the following result, which corresponds to Corollaries 5.2 and 5.3 in the main text.

Corollary 1.2. Let the notation be as above. In both cases $g_{Y}=1,2$, the modular map $\Phi_{0}$ is dominant and its restriction to a smooth Hitchin fiber is the degree two map

\begin{aligned}
\Phi_{0, s}: \operatorname{Pic}^{\mathfrak{n}}\left(X_{s}\right) & \rightarrow \operatorname{Prym}\left(Y_{r} / Y\right) \\
M & \mapsto \xi_{s}^{*}(M) \otimes q_{r}^{*}\left(L_{0}(-R)\right)
\end{aligned}
$$

where $L_{0}$ is a square root of $\mathcal{O}_{Y}(R)$ and $\operatorname{Prym}\left(Y_{r} / Y\right)$ is the Prym variety of the covering $q_{r}: Y_{r} \rightarrow Y$.

## 2. BASIC TOOLS

2.1. Notations and conventions. Throughout this paper, we assume that $X$ is a compact Riemann surface of genus $g_{X} \geq 0$. As usual, we denote by $\mathcal{O}_{X}$ its structural sheaf and by $\omega_{X}$ its canonical sheaf. When $L$ is a line bundle on $X$ we let $L^{-1}$ be its dual. If $E$ is a vector bundle on $X$ we often write $\Gamma(E)$ for $\mathrm{H}^{0}(X, E)$.
2.2. Spectral curve. Let $L$ be a line bundle on $X$. We denote by $\mathbf{P}$ the ruled surface $\mathbb{P}\left(\mathcal{O}_{X} \oplus L^{-1}\right)$ which is the projectivization of the rank two vector bundle $\mathcal{O}_{X} \oplus L^{-1}$. Let $q: \mathbf{P}=\mathbb{P}\left(\mathcal{O}_{X} \oplus L^{-1}\right) \rightarrow X$ be the natural projection and let $\mathcal{O}_{\mathbf{P}}(1)$ be the hyperplane bundle along the fibers. We note that $q_{*}\left(\mathcal{O}_{\mathbf{P}}\right)=\mathcal{O}_{X}$ and $q_{*}\left(\mathcal{O}_{\mathbf{P}}(1)\right)=\mathcal{O}_{X} \oplus L^{-1}$, see for example [5, II - Proposition 7.11].

The ruled surface $\mathbf{P}$ contains two disjoint sections $\mathbb{P}\left(\mathcal{O}_{X}\right)$ and $\mathbb{P}\left(L^{-1}\right)$ corresponding to the embedding of $\mathcal{O}_{X}$ and $L^{-1}$, respectively. The embedding of $\mathcal{O}_{X} \hookrightarrow q_{*}\left(\mathcal{O}_{\mathbf{P}}(1)\right)=\mathcal{O}_{X} \oplus L^{-1}$ gives a section $\mathbf{w}$ of $\mathcal{O}_{\mathbf{P}}(1)$, via the adjoint formula (cf. [5, II - Section 5]) which has $\mathbb{P}\left(L^{-1}\right)$ as its zero set. Similarly, since

$$
q_{*}\left(q^{*} L \otimes \mathcal{O}_{\mathbf{P}}(1)\right) \simeq L \otimes\left(\mathcal{O}_{X} \oplus L^{-1}\right)=L \oplus \mathcal{O}_{X}
$$

by the projection formula, we obtain a section $\mathbf{z}$ of $q^{*} L \otimes \mathcal{O}_{\mathbf{P}}(1)$ which has $\mathbb{P}\left(\mathcal{O}_{X}\right)$ as its zero set.

Given $s=\left(s_{1}, s_{2}\right) \in \Gamma(L) \oplus \Gamma\left(L^{2}\right)$, we define the spectral curve $X_{s} \subset \mathbf{P}$ as the zero locus of the section

$$
\mathbf{z}^{2}+q^{*}\left(s_{1}\right) \cdot \mathbf{z} \cdot \mathbf{w}+q^{*}\left(s_{2}\right) \cdot \mathbf{w}^{2} \in \mathrm{H}^{0}\left(\mathbf{P}, q^{*}\left(L^{2}\right) \otimes \mathcal{O}_{\mathbf{P}}(2)\right) .
$$

It comes with a degree two map

$$
q_{s}: X_{s} \rightarrow X
$$

which is the restriction of $q$ to $X_{s}$. Notice that in a local open subset $U$ of $X$ where $\left.\mathbf{P}\right|_{U} \simeq U \times \mathbb{P}_{(w: z)}^{1}$, the spectral curve has equation

$$
z^{2}+s_{1} z w+s_{2} w^{2}=0
$$

Equivalently, we can define a structure of commutative ring on $\mathcal{O}_{X} \oplus L^{-1}$ induced by $s$ :

$$
\begin{equation*}
\left(a_{0}, a_{1}\right) \cdot\left(b_{0}, b_{1}\right):=\left(a_{0} b_{0}-s_{2} a_{1} b_{1}, a_{0} b_{1}+a_{1} b_{0}-s_{1} a_{1} b_{1}\right) . \tag{2.1}
\end{equation*}
$$

This makes $\mathcal{O}_{X} \oplus L^{-1}$ an $\mathcal{O}_{X}$-algebra, which will be denoted by $\mathcal{A}_{s}$, and is locally given by

$$
\begin{equation*}
\mathcal{A}_{s}(U)=\frac{\mathcal{O}_{X}(U)[z]}{\left(z^{2}+s_{1} z+s_{2}\right)} . \tag{2.2}
\end{equation*}
$$

The spectral curve may be seen as

$$
X_{s}=\operatorname{Spec}\left(\mathcal{A}_{s}\right)
$$

We often write simply

$$
\begin{equation*}
X_{s}=\operatorname{Spec}\left(\mathcal{O}_{X} \oplus L^{-1}\right) \tag{2.3}
\end{equation*}
$$

where $\mathcal{O}_{X} \oplus L^{-1}$ is considered as $\mathcal{O}_{X}$-algebra. Note that

$$
\begin{equation*}
\left(q_{s}\right)_{*} \mathcal{O}_{X_{s}}=\mathcal{O}_{X} \oplus L^{-1} \tag{2.4}
\end{equation*}
$$

The (arithmetic) genus of $X_{s}$ is given by

$$
\begin{equation*}
g_{X_{s}}:=\operatorname{dim} \mathrm{H}^{1}\left(X_{s}, \mathcal{O}_{X_{s}}\right)=\operatorname{deg} L+2\left(g_{X}-1\right)+1 \tag{2.5}
\end{equation*}
$$

see [2, Remark 3.2].
2.3. BNR correspondence. Let us briefly recall the correspondence between $\mathcal{O}_{X^{-}}$ homomorphisms $\theta: E \rightarrow E \otimes L$ having the same characteristic polynomial $P_{s}$ and torsion free sheaves $M_{\theta}$ of rank one on $X_{s}$ (cf. [2, Proposition 3.6]).

Let $E$ be a rank two holomorphic vector bundle on $X$ and let $\theta \in \Gamma(\mathcal{E} n d(E) \otimes L)$ be a homomorphism with $s_{1}=-\operatorname{tr}(\theta) \in \Gamma(L)$ and $s_{2}=\operatorname{det}(\theta) \in \Gamma\left(L^{2}\right)$. By Cayley-Hamilton theorem it satisfies the equation $P_{s}(\theta)=0$, where $P_{s}(z)=z^{2}+s_{1} z+s_{2}$ is the characteristic polynomial and

$$
P_{s}(\theta)=\theta^{2}+s_{1} \cdot \theta+s_{2} \cdot I
$$

must be seen as a homomorphism $E \rightarrow E \otimes L^{2}$.
Let us assume that $X_{s}$ is integral, i.e. irreducible and reduced, which turns out to say that $\mathcal{A}_{s}$ is a sheaf of integral domains. We have a canonical isomorphism

$$
\mathcal{E} n d(E) \otimes L \simeq \mathcal{H o m}_{\mathcal{O}_{X}}\left(L^{-1}, \mathcal{E} n d(E)\right)
$$

which associates $\theta \in \mathcal{E} n d(E) \otimes L$ to the $\mathcal{O}_{X}$-homomorphism

$$
\begin{aligned}
L^{-1} & \rightarrow \mathcal{E} n d(E) \\
z & \rightarrow \theta_{z}
\end{aligned}
$$

where $\theta_{z}(e)=\theta(e) \cdot z$. Thus the homomorphism $\theta$ induces a structure of $\mathcal{A}_{s}$-module on $E$

\Theta: \mathcal{A}_{s} \times E \rightarrow E \tag{2.6}
\end{equation*}

which is locally given by (see (2.2))

$$
\begin{aligned}
\Theta_{U}: \mathcal{A}_{s}(U) \times E(U) & \rightarrow E(U) \\
(a+b z, e) & \rightarrow\left(a I+b \theta_{z}\right) \cdot e
\end{aligned}
$$

It defines a sheaf $M_{\theta}$ of $\mathcal{A}_{s}$-modules on $X_{s}$, which comes with a multiplication

$$
\begin{equation*}
(a+b z) \odot e:=\left(a I+b \theta_{z}\right) \cdot e \tag{2.7}
\end{equation*}
$$

for any $a+b z \in \mathcal{A}_{s}, e \in E$. Since $X_{s}$ is integral then $M_{\theta}$ is also torsion free.
Conversely, if $M$ is a torsion free sheaf of rank one on $X_{s}$ then $E=\left(q_{s}\right)_{*} M$ is a locally free $\mathcal{O}_{X}$-module of rank two with an $\mathcal{O}_{X}$-linear map

$$
\Theta: \mathcal{A}_{s} \times E \rightarrow E
$$

The section $\mathbf{z}$ of $q_{s}^{*} L$ gives a family of endomorphisms

$$
\begin{aligned}
\theta_{U}: E(U) & \rightarrow E(U) \\
s & \mapsto \Theta(z, s)
\end{aligned}
$$

for each open set $U$ of $X$ such that $\left.\mathbf{P}\right|_{U} \simeq U \times \mathbb{P}_{(w: z)}^{1}$, which glue together to give a global homomorphism $\theta: E \rightarrow E \otimes L$ satisfying $\theta^{2}+s_{1} \theta+s_{2} I=0$. Since $X_{s}$ is integral then $P_{s}(z)=z^{2}+s_{1} z+s_{2}$ is irreducible over the function field of $X$. Thus $P_{s}$ is the characteristic polynomial of $\theta$.

Summarizing the discussion above, here is the version of BNR correspondence [2, Proposition 3.6] needed for our purposes:

Proposition 2.1. Assume that the spectral curve $X_{s}$ is integral. Then there is a bijective correspondence between isomorphism classes of torsion free rank one sheaves on $X_{s}$ and isomorphism classes of pairs $(E, \theta)$ where $E$ has rank two and $\theta: E \rightarrow E \otimes L$ is an $\mathcal{O}_{X^{-}}$ homomorphism having characteristic polynomial $P_{s}$.

We conclude this section with a lemma which will be useful in the sequel.
Lemma 2.2. Let $M$ be the torsion free sheaf of rank one on $X_{s}$ associated to $\theta: E \rightarrow E \otimes L$. Then $M$ is a line bundle on $X_{s}$ if and only if for every point $x \in X$ the $\mathbb{C}$-linear map $\theta_{x}: E_{x} \rightarrow E_{x} \otimes L_{x} \simeq E_{x}$ is not of the form $\lambda I$, where $\lambda \in \mathbb{C}$ and $I: E_{x} \rightarrow E_{x}$ is the identity.

Proof. First assume that $M$ is a line bundle on $X_{s}$, i.e. it has rank one as $\mathcal{A}_{s}$-module. Then for any $x \in X$ there exist an open subset $U \subset X$ containing $x$ and $v \in M(U)$ such that every $e \in M(U)$ writes as

$$
e=(a+b z) \odot v, \quad a+b z \in \mathcal{A}_{s}(U)
$$

This means that any section $e \in E(U)$ can be written as

$$
e=(a+b z) \odot v=a v+b \theta(v), \quad a, b \in \mathcal{O}_{X}(U)
$$

In particular, $v$ and $\theta(v)$ are $\mathbb{C}$-linearly independent when considered as elements of $E_{x}$, which implies that $\theta_{x} \neq \lambda I$, for all $\lambda \in \mathbb{C}$. Reciprocally, assuming that $\theta_{x} \neq \lambda I$ for all $\lambda \in \mathbb{C}$, there exist an open neighbourhood $U$ of $x$ and $v \in E(U)$ such that $v$ and $\theta(v)$ are $\mathcal{O}_{X}(U)$-linearly independent. This implies that $v \in M(U)$ generates $M(U)$ as $\mathcal{A}_{s}(U)$-module.
2.4. Elementary transformations. We next introduce strongly parabolic endomorphisms and elementary transformations. The goal of this section is the behavior of $M_{\theta}$ (cf. Section 2.3) with respect to elementary transformations.

Fix $t_{1}, \ldots, t_{n} \in X$ distinct points and denote by $D=t_{1}+\cdots+t_{n}$ the divisor determined by them.

A quasiparabolic vector bundle $(E, \mathbf{p}), \mathbf{p}=\left\{p_{i}\right\}$, of rank two on $(X, D)$ consists of a holomorphic vector bundle $E$ of rank two on $X$ and for each $i=1, \ldots, n$, a 1-dimensional linear subspace $p_{i} \subset E_{t_{i}}$. We refer to the points $t_{i}$ 's as parabolic points, and to the subspaces $p_{i} \subset E_{t_{i}}$ as the parabolic direction of $E$ at $t_{i}$.

There is a correspondence between quasiparabolic vector bundles, called elementary transformation, which we now describe. We consider the following exact sequence of sheaves

$$
0 \rightarrow E^{\prime} \xrightarrow{\alpha} E \xrightarrow{\beta} \bigoplus_{i=1}^{n} E / p_{i} \rightarrow 0
$$

where $E / p_{i}$ intends to be a skyscraper sheaf determined by $E_{t_{i}} / p_{i}$, i.e., for an open subset $U$ of $X$ we have $\left(E / p_{i}\right)(U)=E_{t_{i}} / p_{i}$ if $p_{i} \in U$ and $\{0\}$ otherwise. The map $\beta$ sends $s$ to $\oplus_{i=1}^{n} s\left(t_{i}\right)$. If $E$ is locally generated by $e_{1}, e_{2}$ as $\mathcal{O}_{X}$-module near $t_{i}$ with $e_{1}\left(t_{i}\right) \in p_{i}$, then $E^{\prime}$ is locally generated by $e_{1}, e_{2}^{\prime}$, with $e_{2}^{\prime}=x e_{2}$, where $x$ is a local coordinate. In particular $E^{\prime}$ is locally free of rank two. We view $E^{\prime}$ as a quasiparabolic vector bundle ( $E^{\prime}, \mathbf{p}^{\prime}$ ) of rank two over $(X, D)$ putting $p_{i}^{\prime}:=\operatorname{ker} \alpha_{t_{i}}$. We call it the elementary transformation of $(E, \mathbf{p})$ over $D$ :

$$
\operatorname{elem}_{D}(E, \mathbf{p}):=\left(E^{\prime}, \mathbf{p}^{\prime}\right)
$$

Notice that we have the following equality

$$
\operatorname{det} E^{\prime}=\operatorname{det} E \otimes \mathcal{O}_{X}(-D)
$$

An endomorphism $f: E \rightarrow E$ is called parabolic if $f\left(p_{i}\right) \subseteq p_{i}$ for every $i=1, \ldots, n$. We denote by $\mathcal{E} n d(E, \mathbf{p})$ the sheaf of parabolic endomorphisms. A parabolic endomorphism is called strongly parabolic if $f\left(E_{t_{i}}\right) \subseteq p_{i}$ and $f\left(p_{i}\right)=0$ for every $i=1, \ldots, n$. The sheaf of strongly parabolic endomorphisms of $E$ will be denoted by $\mathcal{S E} n d(E, \mathbf{p})$.

Given a parabolic homomorphism $\theta: E \rightarrow E \otimes L$, i.e.

$$
\theta \in \Gamma(\mathcal{E} n d(E, \mathbf{p}) \otimes L)
$$

we can perform an elementary transformation $\operatorname{elem}_{D}$ on the pair $(E, \theta)$, centered in $\mathbf{p}$. For instance, since $\theta$ is parabolic with respect to $\mathbf{p}$, then $\theta\left(E^{\prime}\right) \subset E^{\prime} \otimes L$ and its restriction induces a homomorphism

$$
\theta^{\prime}: E^{\prime} \rightarrow E^{\prime} \otimes L
$$

which is parabolic with respect to the direction $\mathbf{p}^{\prime}$ of $E^{\prime}$. If $e_{1}, e_{2}$ are local sections which generate $E$ near a parabolic point $t_{i}$ with $e_{1}\left(t_{i}\right) \in p_{i}$ then $\theta$ is given by

$$
\theta=\left(\begin{array}{cc}
a & b \\
x c & d
\end{array}\right)
$$

while

$$
\theta^{\prime}=\left(\begin{array}{cc}
a & x b \\
c & d
\end{array}\right)
$$

Note that trace and determinant do not change after an elementary transformation.
The condition of been strongly parabolic, i.e. $\theta \in \Gamma(\mathcal{S E} n d(E, \mathbf{p}) \otimes L)$ yields

$$
\left\{\begin{array}{l}
\operatorname{tr}(\theta) \in \Gamma(L(-D)) \\
\operatorname{det}(\theta) \in \Gamma\left(L^{2}(-D)\right)
\end{array}\right.
$$

and in this case the spectral curve $X_{s}$, determined by

$$
s=(-\operatorname{tr} \theta, \operatorname{det} \theta) \in \Gamma(L) \oplus \Gamma\left(L^{2}\right)
$$

ramifies over $D$.
Before stating the next result, we introduce some notation. For this, let $\theta: E \rightarrow E \otimes L$ be a parabolic homomorphism with respect to $\mathbf{p}$ and assume that the corresponding spectral curve $X_{s}$ is integral. We shall consider the curve $X_{\theta} \subset \mathbb{P} E$, defined by eigendirections of $\theta$, and let

$$
W_{\mathbf{p}}=p_{1}+\cdots+p_{n}
$$

be the divisor defined by parabolic directions, see Figure 1. There is a birational morphism

$$
\eta: X_{\theta} \rightarrow X_{s}
$$

which associates to each eigendirection the corresponding eigenvalue, and then it defines a divisor

$$
W_{\mathbf{p}, s}=\eta\left(p_{1}\right)+\cdots+\eta\left(p_{n}\right)
$$

on $X_{s}$. If in addition $X_{s}$ is smooth, then $\eta$ is an isomorphism. Note that when $\theta$ is strongly parabolic, and then $X_{s}$ ramifies over $D$, one has $W_{\mathbf{p}, s}=\left(q_{s}^{*} D\right)_{r e d}$. The subscript red denotes the effective reduced divisor defined by the support of $q_{s}^{*} D$.

The next result describes the behavior of $M_{\theta}$ (cf. Section 2.3) under elementary transformations.

Proposition 2.3. Assume that the spectral curve $X_{s}$ is integral. Let $M_{\theta}$ be a line bundle on $X_{s}$ corresponding to a parabolic homomorphism $\theta \in \Gamma(\mathcal{E} n d(E, \mathbf{p}) \otimes L)$. Let $M_{\theta^{\prime}}$ be the torsion free sheaf corresponding to $\theta^{\prime} \in \Gamma\left(\mathcal{E} n d\left(E^{\prime}, \mathbf{p}^{\prime}\right) \otimes L\right)$, obtained by performing an elementary transformation over $D$. Then

$$
M_{\theta^{\prime}}=M_{\theta} \otimes \mathcal{I}
$$

where $\mathcal{I}$ is the ideal sheaf of the subscheme consisting of the support of $q_{s}^{*} D-W_{\mathbf{p}, s}$.


Figure 1. Divisor $W_{\mathbf{p}}$ defined by parabolic directions.
Proof. The homomorphism $\theta: E \rightarrow E \otimes L$ induces a structure of $\mathcal{O}_{X_{s}}$-module

$$
\Theta: \mathcal{O}_{X_{s}} \times E \rightarrow E
$$

on $E$ and $M_{\theta}$ is just $E$ with this structure. See Section 2.3. Let $M_{\theta^{\prime}}$ be the torsion free sheaf of rank one associated to $\theta^{\prime}$. Since $\theta^{\prime}$ is the restriction of $\theta$ to $E^{\prime}$, then $M_{\theta^{\prime}}$ is the $\mathcal{O}_{X_{s}}$-submodule of $M_{\theta}$ determined by the restriction $\Theta^{\prime}$ of $\Theta$ to $E^{\prime}$

$$
\Theta^{\prime}: \mathcal{O}_{X_{s}} \times E^{\prime} \rightarrow E^{\prime}
$$

It is enough to analyse the behavior of $M_{\theta}$ at a point $t$ of the support of $D$, because outside it does not change. We may assume, without loss of generality, that $t=0, p_{0}=\binom{1}{0}$, and

$$
\theta=\left(\begin{array}{cc}
a & b \\
x c & d
\end{array}\right)
$$

and the spectral curve $X_{s}$ has local equation

$$
X_{s}=\left\{(x, z): z^{2}-(a+d) z+(a d-x b c)=0\right\} .
$$

Since $M_{\theta}$ is a line bundle, then there is a generator $v$ for the $\mathcal{O}_{X_{s}}$-module $M_{\theta}$, i.e., any local section $e$ of $M_{\theta}$, can be written as

$$
e=(\alpha+\beta z) \odot v \in M_{\theta}
$$

with $\alpha+\beta z \in \mathcal{O}_{X_{s}}\left(\alpha, \beta \in \mathcal{O}_{X}\right.$, cf. (2.7)), meaning that any local section $e$ of $E$ can be written as

$$
e=(\alpha I+\beta \theta)(v) \in E
$$

Sections of $E^{\prime}$ are those of the form $e^{\prime}=\alpha v+\beta \theta(v) \in E$, such that

$$
e_{0}^{\prime}=\left(\alpha_{0} I+\beta_{0} \theta_{0}\right)\left(v_{0}\right)
$$

is proportional to $p_{0}=\binom{1}{0}$, and the subscript means evaluation at the point $x=0$. Since

$$
\alpha_{0} I+\beta_{0} \theta_{0}=\left(\begin{array}{cc}
\alpha_{0}+\beta_{0} a_{0} & \beta_{0} b_{0} \\
0 & \alpha_{0}+\beta_{0} d_{0}
\end{array}\right)
$$

one obtains that $\alpha_{0}+\beta_{0} d_{0}=0$, because $v_{0}$ is not proportional to $p_{0}$. This last implies that the regular function $\alpha+\beta z \in \mathcal{O}_{X_{s}}$ vanishes at the point $\left(0, d_{0}\right) \in X_{s}$, which corresponds to the second eigendirection of $\theta$ when $a_{0} \neq d_{0}$. When both eigendirections coincide, for instance when $X_{s}$ is singular or has a smooth ramification point, then $\alpha+\beta z$ vanishes at this point.

We conclude that the sections of $M_{\theta^{\prime}}$ are those sections of $M_{\theta}$ which vanish at the support of the divisor $q_{s}^{*} D-W_{\mathbf{p}, s}$. This gives $M_{\theta^{\prime}}=M_{\theta} \otimes \mathcal{I}$ and this concludes the proof of the proposition.

Corollary 2.4. With the same notation of Proposition 2.3, if $X_{s}$ is smooth and irreducible, and $\theta$ is strongly parabolic then

$$
M_{\theta^{\prime}}=M_{\theta}\left(-\left(q_{s}^{*} D\right)_{r e d}\right)
$$

Proof. When $\theta$ is strongly parabolic, $X_{s}$ ramifies over every point in the support of $D$, then $q_{s}^{*} D-W_{\mathbf{p}, s}=\left(q_{s}^{*} D\right)_{\text {red }}$. In addition, since $X_{s}$ is smooth then $\mathcal{I}=\mathcal{O}_{X_{s}}\left(-\left(q_{s}^{*} D\right)_{\text {red }}\right)$.
2.5. Pullback and twist. Let $Y$ be another compact Riemann surface and assume that $\pi: Y \rightarrow X$ is a finite morphism. Given $s=\left(s_{1}, s_{2}\right) \in \Gamma(L) \oplus \Gamma\left(L^{2}\right)$, let $Y_{r}^{*}$ be the spectral curve associated to $r=\pi^{*} s \in \Gamma\left(\pi^{*} L\right) \oplus \Gamma\left(\pi^{*} L^{2}\right)$. The superscript $*$ in $Y_{r}^{*}$ will be justified in Section 4, where a normalization $Y_{r}$ of $Y_{r}^{*}$ is constructed for our purposes.

We note that

$$
Y_{r}^{*}=Y \times_{X} X_{s}
$$

because, since $\pi$ is finite and thus affine, we can assume $\pi$ : Spec $B \rightarrow \operatorname{Spec} A, X_{s}=\operatorname{Spec} A_{s}$ and $Y_{r}^{*}=\operatorname{Spec} B_{\pi^{*} s}$ with

$$
A_{s}=\frac{A[z]}{\left(z^{2}+s_{1} z+s_{2}\right)} \text { and } B_{\pi^{*} s}=\frac{B[z]}{\left(z^{2}+\pi^{*} s_{1} z+\pi^{*} s_{2}\right)}
$$

and then we see that $B_{\pi^{*} s}=B \otimes_{A} A_{s}$. In terms of sheaves of algebras, we have

$$
\mathcal{B}_{\pi^{*} s}=\mathcal{O}_{Y} \otimes_{\pi^{-1}\left(\mathcal{O}_{X}\right)} \pi^{-1}\left(\mathcal{A}_{s}\right)
$$

where $\mathcal{B}_{\pi^{*} s}$ denotes the structural sheaf of $Y_{r}^{*}$.
In particular, there is a lifting $\pi_{s}: Y_{r}^{*} \rightarrow X_{s}$ making the following diagram commute

and which is locally given by the natural homomorphism $A_{s} \rightarrow A_{s} \otimes_{A} B=B_{\pi^{*} s}$. The next result describes the behavior of $M_{\theta}$ (cf. Section 2.3) under pullback.

Proposition 2.5. Assume that both spectral curves $X_{s}$ and $Y_{r}^{*}$ are integral. Let $\theta: E \rightarrow$ $E \otimes L$ be a homomorphism with characteristic coefficient $s$ and let $M$ be the torsion free sheaf of rank one on $X_{s}$ associated to $\theta$. Then $\pi_{s}^{*} M$ is the torsion free sheaf of rank one associated to $\pi^{*} \theta$.

Proof. The pullback of $M$ by $\pi_{s}: Y_{r}^{*} \rightarrow X_{s}$ is given by

$$
\pi_{s}^{*} M=\pi_{s}^{-1}(M) \otimes_{\pi_{s}^{-1}\left(\mathcal{O}_{X_{s}}\right)} \mathcal{O}_{Y_{r}^{*}}
$$

If $U \subset Y$ and $V \subset X$ are local affine open sets where

$$
\pi: U=\operatorname{Spec} B \rightarrow V=\operatorname{Spec} A
$$

let us denote by $\tilde{U} \subset Y_{r}^{*}$ and $\tilde{V} \subset X_{s}$ their respective inverse images. We can write

$$
\left(\pi_{s}^{*} M\right)(\tilde{U})=M(\tilde{V}) \otimes_{A_{s}} B_{\pi^{*} s}
$$

Since the $A_{s}$-module structure on $M(\tilde{V})$ is induced by $\theta$, then the $B_{\pi^{*} s}$-module structure on $\left(\pi_{s}^{*} M\right)(\tilde{U})$ is induced by $\pi^{*} \theta$. Which is equivalent to give a $B_{\pi^{*} s}$-module structure on

$$
\pi^{*}(E)(U)=E(V) \otimes_{A} B
$$

induced by $\pi^{*} \theta$. It turns out to say that $\pi_{s}^{*} M$ coincides with $\pi^{*}(E)$ with $\mathcal{B}_{\pi^{*} s}$-module structure induced by $\pi^{*} \theta$. This shows that $\pi_{s}^{*} M$ is the torsion free sheaf of rank one associated to $\pi^{*} \theta$.

We finish this section by analyzing the behavior of $M$ under twist.
Proposition 2.6. Assume that $X_{s}$ is integral. Let $\theta: E \rightarrow E \otimes L$ be a homomorphism with characteristic coefficient $s$ and let $M$ be the torsion free sheaf of rank one on $X_{s}$ associated to $\theta$. Let $L_{0}$ be a line bundle on $X$ and let $\theta_{L_{0}}: E \otimes L_{0} \rightarrow\left(E \otimes L_{0}\right) \otimes L$ be the homomorphism induced by $\theta$. Then the torsion free sheaf of rank one on $X_{s}$ associated to $\theta_{L_{0}}$ is $M \otimes q_{s}^{*} L_{0}$.
Proof. Let $M_{L_{0}}$ be the torsion free sheaf of rank one on $X_{s}$ associated to $\theta_{L_{0}}$. It follows from projection formula that

$$
\left(q_{s}\right)_{*}\left(M \otimes q_{s}^{*} L_{0}\right)=\left(\left(q_{s}\right)_{*}(M)\right) \otimes L_{0}=E \otimes L_{0}
$$

and then $M \otimes q_{s}^{*} L_{0}$ and $M_{L_{0}}$ have the same pushforward via $q_{s}$. The reader can check that the structure of $\mathcal{A}_{s}$-module on $E \otimes L_{0}$ induced by $\theta_{L_{0}}$ coincides with that of $M \otimes q_{s}^{*} L_{0}$.

## 3. Parabolic Higgs bundles and Hitchin fibration

3.1. Parabolic vector bundles. Let $(E, \mathbf{p})$ be a quasiparabolic vector bundle. Fix a weight vector $\mu=\left(\mu_{1}, \ldots, \mu_{n}\right)$ of real numbers $0 \leq \mu_{i} \leq 1$. The parabolic slope of $(E, \mathbf{p})$ with respect to $\mu$ is

$$
\operatorname{Slope}^{\mu}(E)=\frac{\operatorname{deg} E+\sum_{i=1}^{n} \mu_{i}}{2}
$$

where $\operatorname{deg} E=\operatorname{deg}(\operatorname{det} E)$. Let $N \subset E$ be a line subbundle. For each $i=1, \ldots, n$, set

$$
\text { Slope }^{\mu}{ }_{i}(N, E)= \begin{cases}\mu_{i} & \text { if } N_{t_{i}}=p_{i}, \\ 0 & \text { if } N_{t_{i}} \neq p_{i} .\end{cases}
$$

The parabolic slope of $N \subset E$ with respect to $\mu$ is

$$
\operatorname{Slope}^{\mu}(N, E)=\operatorname{deg} N+\sum_{i=1}^{n} \operatorname{Slope}_{i}^{\mu}(N, E) .
$$

A quasiparabolic vector bundle ( $E, \mathbf{p}$ ) is $\mu$-semistable (respectively $\mu$-stable) if for every line subbundle $N \subset E$ we have

$$
\operatorname{Slope}^{\mu}(N, E) \leq \operatorname{Slope}^{\mu}(E)
$$

(respectively Slope $^{\mu}(N, E)<$ Slope $^{\mu}(E)$ ). A parabolic vector bundle is a quasiparabolic vector bundle together with a weight vector $\mu$. We say that a parabolic vector bundle is semistable if the corresponding quasiparabolic vector bundle is $\mu$-semistable.

For each $d \in \mathbb{Z}$ and a weight vector $\mu$, there is a moduli space $\operatorname{Bun}_{\mu}(X, D, d)$, parametrizing rank two parabolic vector bundles $(E, \mathbf{p})$ on $(X, D)$, with $\operatorname{deg} E=d$, which are semistable. If $N$ is a line subbundle with $\operatorname{deg} N=d$, we denote by $\operatorname{Bun}_{\mu}(X, D, N)$ the subvariety of $\operatorname{Bun}_{\mu}(X, D, d)$ given by those parabolic vector bundles with $\operatorname{det} E=N$.

The moduli space $\operatorname{Bun}_{\mu}(X, D, d)$ has a structure of a normal projective variety of dimension $n-3+4 g_{X}$, if the stable locus is not empty, see [13, 3]. By twisting vector bundles with a fixed line bundle $L_{0}$, we see that $\operatorname{Bun}_{\mu}(X, D, N) \cong \operatorname{Bun}_{\mu}\left(X, D, N \otimes L_{0}^{2}\right)$.

Elementary transformations give correspondences between moduli spaces. The stability condition is preserved after an appropriate modification of weights, if $(E, \mathbf{p})$ is $\mu$-semistable then $\operatorname{elem}_{D}(E, \mathbf{p})$ is $\mu^{\prime}$-semistable with

$$
\mu^{\prime}=\left(1-\mu_{1}, \ldots, 1-\mu_{n}\right)
$$

In particular, this gives a map

$$
\operatorname{elem}_{D}: \operatorname{Bun}_{\mu}(X, D, N) \rightarrow \operatorname{Bun}_{\mu^{\prime}}\left(X, D, N \otimes \mathcal{O}_{X}(-D)\right)
$$

3.2. Parabolic Higgs bundles. A parabolic Higgs bundle is a triple $(E, \mathbf{p}, \theta)$ where $(E, \mathbf{p})$ is a quasiparabolic vector bundle over $(X, D)$ and

$$
\theta \in \Gamma\left(\mathcal{S E} n d(E, \mathbf{p}) \otimes \omega_{X}(D)\right)
$$

is a strongly parabolic homomorphism in the sense of Section 2.4. We say that $\theta$ is a parabolic Higgs field. We note that been strongly parabolic means that for each point $t \in X$ lying in the support of $D$, the endomorphism

$$
\operatorname{Res}(\theta ; t) \in \operatorname{End}\left(E_{t}\right)
$$

is nilpotent with respect to the parabolic direction of $E_{t}$. The nilpotency condition means that if $p \subset E_{t}$ is the parabolic direction, then

$$
\operatorname{Res}(\theta ; t)(p)=0 \quad \text { and } \quad \operatorname{Res}(\theta ; t)\left(E_{t}\right) \subset p .
$$

A line subbundle $N \subset E$ is called invariant under $\theta: E \rightarrow E \otimes \omega_{X}(D)$ if

$$
\theta(N) \subset N \otimes \omega_{X}(D)
$$

We say that $\theta$ is irreducible if it does not admit invariant line subbundle.

Fix a weight vector $\mu \in[0,1]^{n}$. A parabolic Higgs bundle $(E, \mathbf{p}, \theta)$ on $(X, D)$ is called $\mu$-semistable (respectively $\mu$-stable) if for every line subbundle $N \subset E$ invariant under $\theta$, we have

$$
\operatorname{Slope}^{\mu}(N, E) \leq \operatorname{Slope}^{\mu}(E)
$$

(respectively $\left.\operatorname{Slope}^{\mu}(N, E)<\operatorname{Slope}^{\mu}(E)\right)$. We say that $(E, \mathbf{p}, \theta)$ is $\mu$-unstable if it is not $\mu$-semistable. Note that an irreducible Higgs field is stable for any choice of weight vector.

Given $d \in \mathbb{Z}$, let $\mathcal{H}_{\mu}(X, D, d)$ be the moduli space of $\mu$-semistable parabolic Higgs bundles $(E, \mathbf{p}, \theta)$ on $(X, D)$ with $\operatorname{deg} E=d$. If $N$ is a line bundle of degree $d$, we denote by $\mathcal{H}_{\mu}(X, D, N)$ the subvariety of $\mathcal{H}_{\mu}(X, D, d)$ given by those parabolic Higgs bundles with fixed determinant $\operatorname{det} E=N$.

The moduli space $\mathcal{H}_{\mu}(X, D, d)$ is a quasiprojective variety of dimension $2\left(n-3+4 g_{X}\right)$, see $[20,21,4]$.

Similar to parabolic vector bundles, given $(E, \mathbf{p}, \theta)$ we can perform an elementary transformation elem $_{D}$ on it, see Section 2.4, and this provides a correspondence between moduli spaces of Higgs bundles

$$
\operatorname{elem}_{D}: \mathcal{H}_{\mu}(X, D, N) \rightarrow \mathcal{H}_{\mu^{\prime}}\left(X, D, N \otimes \mathcal{O}_{X}(-D)\right)
$$

3.3. Hitchin map and its fibers. Let $(E, \mathbf{p}, \theta) \in \mathcal{H}_{\mu}(X, D, d)$ be a parabolic Higgs bundle. Since $\operatorname{Res}\left(\theta ; t_{i}\right)$ is nilpotent for every parabolic point $t_{i} \in X$, one obtains

$$
\left\{\begin{array}{l}
\operatorname{tr}(\theta) \in \Gamma\left(\omega_{X}\right) \\
\operatorname{det}(\theta) \in \Gamma\left(\omega_{X}^{\otimes 2}(D)\right) \subset \Gamma\left(\omega_{X}^{\otimes 2}(2 D)\right) .
\end{array}\right.
$$

In order to simplify notation we shall write $\Sigma_{D}$ for the vector space

$$
\begin{equation*}
\Sigma_{D}=\Gamma\left(\omega_{X}\right) \oplus \Gamma\left(\omega_{X}^{\otimes 2}(D)\right) \tag{3.1}
\end{equation*}
$$

The Hitchin map is defined as

$$
\begin{array}{rlrl}
H_{X}: \mathcal{H}_{\mu}(X, D, d) & \longrightarrow & \Sigma_{D} \\
(E, \mathbf{p}, \theta) & \longmapsto(-\operatorname{tr}(\theta), \operatorname{det}(\theta)) .
\end{array}
$$

Let $s \in \Sigma_{D}$. Using the correspondence of Section 2.3 we get an identification between the Jacobian variety of $X_{s}$ and the fiber of $H_{X}$ over $s$, when $X_{s}$ is integral. Then, we are led to investigate the existence of integral spectral curves. To do this, we need a couple of results.

Proposition 3.1. Let $(E, \mathbf{p}, \theta)$ be a parabolic Higgs bundle on $(X, D)$ and let $s=$ $(-\operatorname{tr} \theta, \operatorname{det} \theta)$. If the spectral curve $X_{s}$ is non-integral then $\operatorname{det} \theta \in \Gamma\left(\omega_{X}^{\otimes 2}\right)$.
Proof. If $X_{s}$ is non-integral then the characteristic polynomial $P_{s}(z)=z^{2}-\operatorname{tr} \theta z+\operatorname{det} \theta$ is reducible over the function field of $X$. Hence, near a parabolic point $t_{i}$ in the support of $D$ we can write

$$
P_{s}(z)=(z-a)(z-b)
$$

with $a, b \in \mathcal{O}_{X}(U)$. The nilpotence condition on $\theta$ implies that $a+b$ and $a b$ vanish at $t_{i}$. In particular, $a$ and $b$ vanish at $t_{i}$ and then $\operatorname{det} \theta \in \Gamma\left(\omega_{X}^{\otimes 2}(2 D)\right)$ has a zero of order at least two at $t_{i}, i=1, \ldots, n$, which means that $\operatorname{det} \theta \in \Gamma\left(\omega_{X}^{\otimes 2}\right)$.
Proposition 3.2. Let $(E, \mathbf{p}, \theta)$ be a parabolic Higgs bundle on $(X, D)$. If $\theta$ has an invariant line bundle $N \subset E$, then $X_{s}$ is non-integral.

Proof. We will show that the characteristic polynomial $P_{s}(z)=z^{2}-\operatorname{tr} \theta z+\operatorname{det} \theta$ is reducible over the function field of $X$. Taking a Zariski open subset $U$ of $X$ and $e \in N(U)$ there exists $\lambda \in \omega_{X}(D)(U)$ such that

$$
\theta(e)=\lambda \cdot e .
$$

In particular, the rational function $z-\lambda$ on $X$ divides $P_{s}(z)$.
Let us assume that $X_{s}$ is integral and let $M$ be a line bundle on $X_{s}$. We can compute the degree of $E=\left(q_{s}\right)_{*} M$ using (2.4) and the following identity

$$
\begin{equation*}
\operatorname{det}(E) \simeq \operatorname{det}\left(\left(q_{s}\right)_{*} \mathcal{O}_{X_{s}}\right) \otimes \operatorname{Nm}(M) \tag{3.2}
\end{equation*}
$$

where $\operatorname{Nm}(M)$ is the norm map (see [5, Cap. IV Ex. 2.6]). The result is

$$
\operatorname{deg} M=\operatorname{deg} E+\operatorname{deg} L
$$

where $L=\omega_{X}(D)$, and this yields

$$
\operatorname{deg} M=\operatorname{deg} E+\operatorname{deg} D+2 g_{X}-2
$$

This computation can be extended to torsion free rank one sheaves on $X_{s}$. Therefore, given $d \in \mathbb{Z}$ we are led to define

$$
\mathfrak{n}=\mathfrak{n}(d):=d+\operatorname{deg} D+2 g_{X}-2
$$

Let us denote by $\overline{\operatorname{Pic}}^{\text {n }}\left(X_{s}\right)$ the variety parametrizing isomorphism classes of torsion free sheaves of rank one on $X_{s}$ of degree $\mathfrak{n}$ and let $\operatorname{Pic}^{\mathfrak{n}}\left(X_{s}\right)$ denote its corresponding subset formed by line bundles. For an irreducible curve having only planar singularities, $\overline{\mathrm{Pic}}^{\mathrm{n}}\left(X_{s}\right)$ is an irreducible variety that contains $\operatorname{Pic}^{\mathfrak{n}}\left(X_{s}\right)$ as a dense open subset (c.f. [1]). If $X_{s}$ has a non-planar singularity then $\overline{\operatorname{Pic}}^{\mathfrak{n}}\left(X_{s}\right)$ has at least two irreducible components (c.f. [10]).

As we have seen in Section 2.3, there is a bijective correspondence between $\overline{\operatorname{Pic}}^{\mathrm{n}}\left(X_{s}\right)$ and isomorphism classes of pairs $(E, \theta)$ where $E$ is a vector bundle of rank two and degree $d$, and $\theta: E \rightarrow E \otimes \omega_{X}(D)$ is a homomorphism with $\operatorname{tr}(\theta)=-s_{1}$ and $\operatorname{det}(\theta)=s_{2}$. In particular we have the following result (see also [12]).

Proposition 3.3. Assuming that $s=\left(s_{1}, s_{2}\right) \in \Sigma_{D}$, with

$$
s_{2} \in \Gamma\left(\omega_{X}^{2}(D)\right) \backslash \Gamma\left(\omega_{X}^{2}\left(D-t_{i}\right)\right), \forall i=1, \ldots, n
$$

then $X_{s}$ is integral and there is a bijective correspondence

$$
\overline{\operatorname{Pic}}^{n}\left(X_{s}\right) \longleftrightarrow H_{X}^{-1}(s)
$$

Moreover, any Higgs bundle in $H_{X}^{-1}(s)$ is irreducible.
Proof. Our hypothesis on $s_{2}$ ensures, in particular, that $s_{2} \notin \Gamma\left(\omega_{X}^{\otimes 2}\right)$, then $X_{s}$ is integral by Proposition 3.1.

Let $L=\omega_{X}(D)$. For each $M \in \overline{\operatorname{Pic}}^{\mathfrak{n}}\left(X_{s}\right)$ we can associate a pair $(E, \theta)$, where $\theta$ : $E \rightarrow E \otimes L$ is a homomorphism with characteristic polynomial $s$, see Section 2.3. Since $s_{2}$ lies in the subspace $\Gamma\left(L^{2}(-D)\right)$ of $\Gamma\left(L^{2}\right)$ then any residual matrix $\operatorname{Res}\left(\theta ; t_{i}\right)$ has vanishing determinant. This and $\operatorname{tr}(\theta) \in \Gamma(L(-D))$ yield $\theta$ strongly parabolic. Note that $\operatorname{Res}\left(\theta ; t_{i}\right)$ is non-null because $s_{2} \notin \Gamma\left(L^{2}\left(-D-t_{i}\right)\right)$. Thus the parabolic direction $p_{i} \subset E_{t_{i}}$ is defined as the kernel of $\operatorname{Res}\left(\theta ; t_{i}\right)$. Now we show that $(E, \mathbf{p}, \theta)$ is $\mu$-semistable. Actually, we can show that $\theta$ is irreducible and this also completes the last assertion of the statement of the
proposition. Indeed, by Proposition 3.2, if there is a line subbundle $N \subset E$ invariant by $\theta$, then $\operatorname{det}(\theta)=s_{2} \in \Gamma\left(\omega_{X}^{\otimes 2}\right)$ and this gives a contradiction.

Conversely, for each pair $(E, \theta)$ with characteristic coefficient $s$, BNR correspondence gives an element $M \in \overline{\operatorname{Pic}}^{n}\left(X_{s}\right)$. This finishes the proof of the proposition.
Remark 3.4. Let $\mathcal{U}=\Gamma\left(\omega_{X}^{2}(D)\right) \backslash \cup_{i=1}^{n} \Gamma\left(\omega_{X}^{2}\left(D-t_{i}\right)\right)$ be the open set given by Proposition 3.3. If $2 g_{X}+\operatorname{deg} D-4 \geq 0$ then $\mathcal{U}$ is nonempty. To see this, note that this inequality yields $\operatorname{deg} \omega_{X}^{2}(D) \geq 2 g_{X}$ and then $\omega_{X}^{2}(D)$ has no base points. In particular, by Proposition 3.3, if $2 g_{X}+\operatorname{deg} D-4 \geq 0$ then there exist irreducible parabolic Higgs Higgs fields $\theta: E \rightarrow$ $E \otimes \omega_{X}(D)$, and therefore $\mathcal{H}_{\mu}(X, D, d)$ contains stable Higgs bundles for any choice of weight vector $\mu$.

We finish this section by considering traceless Higgs fields. In view of Lemma 2.2 and the next result, Higgs fields having non-vanishing residual part at every parabolic point play a key role. We say that $\theta: E \rightarrow E \otimes \omega_{X}(D)$ is nowhere-holomorphic in $D$ if

$$
\operatorname{Res}\left(\theta ; t_{i}\right) \neq 0
$$

for every $t_{i}$ at the support of $D$.
Proposition 3.5. Let $s=\left(0, s_{2}\right) \in \Sigma_{D}$. Assume that $X_{s}$ is integral and smooth at every point over the complement of the support of $D$. Then there is a bijective correspondence

$$
\operatorname{Pic}^{\mathfrak{n}}\left(X_{s}\right) \longleftrightarrow\left\{(E, \mathbf{p}, \theta) \in H_{X}^{-1}(s): \theta \text { is nowhere-holomorphic in } D\right\}
$$

Proof. By Lemma 2.2 there is a bijective correspondence between $\operatorname{Pic}^{\mathfrak{n}}\left(X_{s}\right)$ and the isomorphism classes of pairs $(E, \theta)$ where $E$ has degree $d, \theta: E \rightarrow E \otimes \omega_{X}(D)$ is a homomorphism with $\operatorname{tr}(\theta)=0$ and $\operatorname{det}(\theta)=s_{2}$, and $\theta_{x}$ is not of the form $\lambda I$ for every $x \in X$.

Since $\operatorname{tr} \theta=0$, then $\theta_{x}=\lambda I$ if and only if $\theta_{x}=0$. But, $\theta_{x}$ is nonvanishing at every point over the complement of the support of $D$, because $X_{s}$ is smooth at that point. For a point $t_{i}$ of the support of $D$, we have

$$
\theta_{t_{i}}=\operatorname{Res}\left(\theta ; t_{i}\right)
$$

and then $\theta_{t_{i}} \neq 0, \forall i=1, \ldots, n$, if and only if $\theta$ is nowhere-holomorphic in $D$. To conclude the proof of the proposition we note that, in this case, the parabolic direction over $t_{i}$ is determined by kernel of $\operatorname{Res}\left(\theta ; t_{i}\right)$.

## 4. Spectral curves under degree two ramified coverings

Let $\pi: Y \rightarrow X$ be a finite morphism of degree two between irreducible smooth complex curves. Assume that $\left\{x_{1}, \ldots, x_{n}\right\}, n \geq 1$, is the set of branch points and let $B=\sum_{i=1}^{n} x_{i}$ be the reduced divisor on $X$ defined by them. Let $R=\sum_{i=1}^{n} y_{i}$ be the divisor on $Y$ formed by ramification points: $\pi\left(y_{i}\right)=x_{i}$.

Let us consider a reduced divisor $T=\sum_{i=1}^{k} t_{i}, k \geq 0$, on $X$ formed by points outside the support of $B$. We put $T=0$ when $k=0$. Then we can write

$$
\pi^{*}(T+B)=\pi^{*}(T)+2 R
$$

Note that $\pi$ induces a linear map (see (3.1) for the definition of $\Sigma_{D}$ )

$$
\pi^{*}: \Sigma_{T+B} \rightarrow \Sigma_{\pi^{*}(T)}
$$

because poles over branch points became regular after pullback.
We want to pull back Higgs fields over $(X, T+B)$ to Higgs fields over $\left(Y, \pi^{*}(T)\right)$. Let us first investigate the relation between their spectral curves.
4.1. General spectral curve. In this section we start with an element $s \in \Sigma_{T+B}$, which gives a spectral curve $X_{s}$. Since $\pi^{*}(s)$ becomes regular over ramification points, we can see it as an element $r=\pi^{*}(s) \in \Sigma_{\pi^{*}(T)}$. Let $Y_{r}$ be the corresponding spectral curve given by $r$.

We set $L=\omega_{X}(T+B)$ and consider the respective spectral curve (cf. (2.3))

$$
X_{s}=\operatorname{Spec}\left(\mathcal{O}_{X} \oplus L^{-1}\right)
$$

with its degree two map $q_{s}: X_{s} \rightarrow X$. The divisor $R_{q_{s}}$ of ramification points of $q_{s}$ is given by zeros of $s_{1}^{2}-4 s_{2}$ and since $s$ lies in the subspace $\Sigma_{T+B}$, then $q_{s}$ ramifies over every point in the support of $T+B$, i.e.

$$
R_{q_{s}}-(T+B) \geq 0
$$

Note that

$$
\pi^{*} L \simeq \omega_{Y}\left(R+\pi^{*}(T)\right)
$$

Following Section 2.5, the element

$$
r=\pi^{*} s \in \Gamma\left(\pi^{*} L\right) \otimes \Gamma\left(\pi^{*} L^{2}\right)
$$

gives the spectral curve

$$
Y_{r}^{*}=\operatorname{Spec}\left(\mathcal{O}_{Y} \oplus\left(\pi^{*} L\right)^{-1}\right)=Y \times_{X} X_{s}
$$

which is singular over a point lying in the support of $R$. To avoid singular points of $Y_{r}^{*}$, it is convenient to switch $\pi^{*} L$. Then we consider

$$
N=\pi^{*} L(-R)=\omega_{Y}\left(\pi^{*} T\right)
$$

and the element

$$
r=\pi^{*} s \in \Sigma_{\pi^{*}(T)} \subset \Gamma(N) \oplus \Gamma\left(N^{2}\right)
$$

gives the spectral curve

$$
Y_{r}=\operatorname{Spec}\left(\mathcal{O}_{Y} \oplus N^{-1}\right)
$$

We summarize the discussion above in Figure 2.


Figure 2. Three spectral curves.

Proposition 4.1. Assume that $2 g_{X}+n-4 \geq 0$, with strict inequality if $k=0 \quad(n=\operatorname{deg} B$ and $k=\operatorname{deg} T$ ). If $s$ is a general element of $\Sigma_{B+T}$, then $X_{s}$ and $Y_{r}$ are irreducible and smooth.

Proof. The hypothesis $2 g_{X}+n-4 \geq 0$ ensures that $X_{s}$ is integral for general $s \in \Sigma_{B+T}$, see Remark 3.4. The locus of sections $s \in \Sigma_{B+T}, s=\left(s_{1}, s_{2}\right)$, such that $X_{s}$ is smooth is open and nonempty. Besides that if $s_{2}$ has only simple zeros then the same holds for $\pi^{*}\left(s_{2}\right) \in \Sigma_{\pi^{*}(T)}$. In particular, the curve $Y_{r}$ is smooth for general $r=\pi^{*}(s)$. Now we show that $Y_{r}$ is integral.

First let us assume $k>0$ and let $y$ be a point with $\pi(y)=t_{i}$, where $t_{i}$ lies in the support of $T$. If $s_{2} \notin \Gamma\left(\omega_{X}^{\otimes 2}\left(B+T-t_{i}\right)\right)$ then $\pi^{*} s_{2} \notin \Gamma\left(\omega_{Y}^{\otimes 2}\left(\pi^{*} T-y\right)\right)$ because $\pi$ is étale at $y$. Therefore we can use Proposition 3.3 again to conclude that $Y_{r}$ is integral.

Now suppose $k=0$. We claim that the image of $\pi^{*}: \Sigma_{B+T} \rightarrow \Sigma_{\pi^{*}(T)}$ intersects the open subset of $\Sigma_{\pi^{*}(T)}$ formed by all sections for which the spectral curve is integral. To do this, we can assume $s_{1}=0$. A section $s_{2} \in \Gamma\left(\omega_{Y}^{\otimes 2}\right)$ gives a reducible spectral curve if and only if it lies in the image of the map $\psi: \Gamma\left(\omega_{Y}\right) \rightarrow \Gamma\left(\omega_{Y}^{\otimes 2}\right), a \mapsto a^{2}$. By Riemann-Roch theorem, the injective linear map $\pi^{*}: \Gamma\left(\omega_{X}^{\otimes 2}(B)\right) \rightarrow \Gamma\left(\omega_{Y}^{\otimes 2}\right)$ has image of dimension $3\left(g_{X}-1\right)+n$, whereas the image of $\psi$ has dimension at most $g_{Y}$. Thus if $3\left(g_{X}-1\right)+n>g_{Y}$, the claim above will follow. By Riemann-Hurwitz formula, the previous inequality is equivalent to $2 g_{X}+n-4>0$. This concludes the proof of the proposition.

### 4.2. A map between spectral curves.

Proposition 4.2. Let the notation be as above. The following statements hold:
(1) there is a morphism $\xi_{s}: Y_{r} \rightarrow X_{s}$ of degree two making the following diagram commute

(2) if $X_{s}$ is smooth then $Y_{r}$ is the normalization of $Y_{r}^{*}$;
(3) $\xi_{s}$ is étale when $X_{s}$ and $Y_{r}$ are smooth and irreducible.

Proof. First we show the statement about the existence of $\xi_{s}$. Following Section 4.1, setting $L=\omega_{X}(T+B)$ and $N=\omega_{Y}\left(\pi^{*} T\right)$ we have

$$
\left\{\begin{array}{l}
X_{s}=\operatorname{Spec}\left(\mathcal{O}_{X} \oplus L^{-1}\right) \\
Y_{r}^{*}=\operatorname{Spec}\left(\mathcal{O}_{Y} \oplus\left(\pi^{*} L\right)^{-1}\right)=Y \times_{X} X_{s} \\
Y_{r}=\operatorname{Spec}\left(\mathcal{O}_{Y} \oplus N^{-1}\right) .
\end{array}\right.
$$

Since $\left(\pi^{*} L\right)^{-1} \subset N^{-1}$, this gives an inclusion $i: \mathcal{O}_{Y} \oplus\left(\pi^{*} L\right)^{-1} \rightarrow \mathcal{O}_{Y} \oplus N^{-1}$ of $\mathcal{O}_{Y}$-modules. Note that their structure of commutative ring induced by $\pi^{*} s$ (c.f. (2.1)) are compatible and thus $\mathcal{O}_{Y} \oplus\left(\pi^{*} L\right)^{-1}$ is a subring of $\mathcal{O}_{Y} \oplus N^{-1}$. In particular $i$ yields a map $\varphi_{s}: Y_{r} \rightarrow Y_{r}^{*}$. Then we set $\xi_{s}=\pi_{s} \circ \varphi_{s}$, where $\pi_{s}: Y_{r}^{*} \rightarrow X_{s}$ is given by (2.8). Note that $\left(\pi^{*} L\right)^{-1}$ and $N^{-1}$ coincide when restricted to an open set $U$ away from the support of $R$, then $\left.\varphi_{s}\right|_{U}$ is an isomorphism. Since $\pi_{s}: Y_{r} \rightarrow X_{s}$ has degree two, this concludes the proof of (1).

Now if $X_{s}$ is smooth then $s_{2}$ has only simple zeros. Consequently, the same is true for $\pi^{*} s_{2}$, seen as a section of $\Gamma\left(N^{2}\right)$. This shows that $Y_{r}$ is smooth and then $\varphi_{s}: Y_{r} \rightarrow Y_{r}^{*}$ is the normalization of $Y_{r}^{*}$. This proves (2).

When $X_{s}$ and $Y_{r}$ are smooth and irreducible, we can use (2.5) and Riemann-Hurwitz formula to conclude (3).

In view of Proposition 4.2 we conclude this section with the following well-known result, see also [14, Lemma p. 332]. Here, we include a proof for the convenience to the reader.

Proposition 4.3. Let $\xi: Z \rightarrow W$ be an étale morphism of degree 2 between compact Riemann surfaces. Then the induced morphism $\xi^{*}: \operatorname{Pic}^{0}(W) \rightarrow \operatorname{Pic}^{0}(Z)$ has degree 2 onto its image.

Proof. There is a correspondence between étale morphisms of degree 2 and 2-torsion elements in $\operatorname{Pic}^{0}(W)$. We recall briefly this correspondence. Let $L \in \operatorname{Pic}^{0}(W)$ be a 2-torsion point, $\mathbf{P}=\mathbb{P}\left(\mathcal{O}_{W} \oplus L\right)$ and $q: \mathbf{P} \rightarrow W$ the natural projection. Roughly speaking, the curve $Z$ can be seen as the inverse image of the unit section of $L^{2} \simeq \mathcal{O}_{W}$ under the map $L \rightarrow L^{2}$ which sends $a$ to $a^{2}$. The subvariety $\mathbb{P}\left(\mathcal{O}_{W}\right) \subset \mathbf{P}$ is the zero locus of a section

$$
\mathbf{z}: \mathcal{O}_{\mathbf{P}} \rightarrow q^{*}(L) \otimes \mathcal{O}_{\mathbf{P}}(1)
$$

and $\mathbb{P}(L)$ is the zero locus of a section

$$
\mathbf{w}: \mathcal{O}_{\mathbf{P}} \rightarrow \mathcal{O}_{\mathbf{P}}(1)
$$

and $\xi=\left.q\right|_{Z}$. If we denote by $s$ a nonzero section of $L^{2}$, the curve $Z \subset \mathbf{P}$ corresponds to the zero locus of the section

$$
\mathbf{z}^{2}-q^{*}(s) \cdot \mathbf{w}^{2} .
$$

Note that $s$ is not a power $a^{2}$ of a section $a$ of $L$, otherwise $L$ would be trivial.
Now we can show that $\xi^{*}(L)=\mathcal{O}_{Z}$. To see this, observe that $\mathbf{z}$ and $\mathbf{w}$ do not vanish in $Z$, then the restriction of $\mathcal{O}_{\mathbf{P}}(1)$ and $q^{*}(L) \otimes \mathcal{O}_{\mathbf{P}}(1)$ to $Z$ are trivial. It follows that

$$
\xi^{*}(L)=\left.\left(q^{*}(L) \otimes \mathcal{O}_{\mathbf{P}}(1)\right)\right|_{Z}
$$

is trivial.
Assume that $M \in \operatorname{Pic}^{0}(W)$ is a line bundle with $\xi^{*}(M)=\mathcal{O}_{Z}$. Then projection formula yields

$$
\mathcal{O}_{W} \oplus L \simeq \xi_{*}\left(\mathcal{O}_{Z}\right)=\xi_{*}\left(\left(\pi^{*} M\right) \otimes \mathcal{O}_{Z}\right) \simeq M \oplus(M \otimes L)
$$

In particular, $M \oplus(M \otimes L)$ has a nonzero section. Since $M$ and $L$ have degree zero, one obtains that either $M$ is $\mathcal{O}_{W}$ or $M \otimes L$ is $\mathcal{O}_{W}$. This concludes the proof of the proposition.

## 5. A map between moduli spaces

5.1. Main result. We keep the notation of Section 4 , where $B$ and $R$ denote the divisors of branch points and ramification points of $\pi: Y \rightarrow X$, respectively. Also, let $T$ be an effective reduced divisor on $X$ whose support does not intersect the support of $B$.

In this section we will consider a rational map between moduli spaces of parabolic Higgs bundles

$$
\begin{equation*}
\Phi: \mathcal{H}_{\mu}(X, B+T, 0) \rightarrow \mathcal{H}_{\mu^{\prime}}\left(Y, \pi^{*}(T),-n\right) \tag{5.1}
\end{equation*}
$$

This map is defined by doing $\pi^{*}$ followed by an elementary transformation over $R$

$$
(\mathcal{E}, \theta) \xrightarrow[\pi^{*}]{\nrightarrow}\left(\pi^{*} \mathcal{E}, \pi^{*} \theta\right) \underset{\operatorname{elem}_{R}}{\longrightarrow}\left(\left(\pi^{*} \mathcal{E}\right)^{\prime},\left(\pi^{*} \theta\right)^{\prime}\right)
$$

where $\mathcal{E}=(E, \mathbf{p})$. We describe below each step of this correspondence.
At first, $\Phi$ might send each semistable Higgs bundle to an unstable Higgs bundle. So, in view of Proposition 4.1, we assume that $2 g_{X}+n-4 \geq 0$, with strict inequality if $k=0$ ( $n=\operatorname{deg} B$ and $k=\operatorname{deg} T$ ). Let us fix $s \in \Sigma_{B+T}$ such that $X_{s}$ and $Y_{r}$ are integral.

We can define a correspondence

$$
(E, \mathbf{p}, \theta) \mapsto \Phi(E, \mathbf{p}, \theta)
$$

which associates a Higgs bundle on $(X, T+B)$, with characteristic coefficient $s$ to a Higgs bundle on $\left(Y, \pi^{*}(T)\right)$ with characteristic coefficient $r=\pi^{*} s$, by doing the following series of transformations:
(1) Let $(E, \mathbf{p}, \theta)$ be a parabolic Higgs bundle, with $\operatorname{deg} E=0$, and with characteristic coefficient $s$.
(2) Pulling back $(E, \mathbf{p}, \theta)$ to $Y$ via $\pi$, we obtain a parabolic Higgs bundle $\left(\pi^{*}(E, \mathbf{p}), \pi^{*} \theta\right)$ on $\left(Y, \pi^{*}(B+T)\right)$ with characteristic coefficient $r \in \Sigma_{\pi^{*}(T)}$.
(3) After performing an elementary transformation over $R$ (cf. Section 2.4), the resulting parabolic Higgs bundle

$$
\Phi(E, \mathbf{p}, \theta):=\left(\left(\left(\pi^{*} E\right)^{\prime}, \mathbf{p}^{\prime}\right),\left(\pi^{*} \theta\right)^{\prime}\right)
$$

is regular over each ramification point, and $\operatorname{deg}\left(\pi^{*} E\right)^{\prime}=-n$. Then we get a parabolic Higgs bundle over $\left(Y, \pi^{*}(T)\right)$. Since $X_{s}$ and $Y_{r}$ are integral, $\theta$ and $\left(\pi^{*} \theta\right)^{\prime}$ are irreducible (cf. Proposition 3.2), then they are both stable.
This correspondence gives a rational map between moduli spaces of parabolic Higgs bundles

$$
\begin{equation*}
\Phi: \mathcal{H}_{\mu}(X, B+T, 0) \rightarrow \mathcal{H}_{\mu^{\prime}}\left(Y, \pi^{*}(T),-n\right) \tag{5.2}
\end{equation*}
$$

which makes the following diagram commute


We want to investigate the behavior of $\Phi$ with respect to the Hitchin fibration. Let us consider its restriction to a (general) Hitchin fiber

$$
\Phi_{s}: H_{X}^{-1}(s) \rightarrow H_{Y}^{-1}(r)
$$

with $r=\pi^{*} s$. When $X_{s}$ and $Y_{r}$ are irreducible and smooth, then

$$
H_{X}^{-1}(s) \simeq \operatorname{Pic}^{\mathfrak{n}}\left(X_{s}\right) \quad \text { and } \quad H_{Y}^{-1}(r) \simeq \operatorname{Pic}^{\tilde{\mathfrak{n}}}\left(Y_{r}\right)
$$

where $\mathfrak{n}=k+n+2 g_{X}-2$ and $\tilde{\mathfrak{n}}=2 k-n+2 g_{Y}-2$. This gives a map

$$
\Phi_{s}: \operatorname{Pic}^{\mathfrak{n}}\left(X_{s}\right) \rightarrow \operatorname{Pic}^{\tilde{\mathfrak{n}}}\left(Y_{r}\right)
$$

In the next result we show that this map is determined by $\xi_{s}^{*}$ (see Proposition 4.2), up to a translation on the target.

Theorem 5.1. Assume that $2 g_{X}+n-4 \geq 0$, with strict inequality if $k=0$. Then $\Phi$ is a rational map of degree two onto its image which preserves the Hitchin fibrations. Moreover, its restriction to a general Hitchin fiber is the map

$$
\Phi_{s}: \operatorname{Pic}^{\mathfrak{n}}\left(X_{s}\right) \longrightarrow \operatorname{Pic}^{\tilde{n}}\left(Y_{r}\right)
$$

which sends a line bundle $M$ in $\operatorname{Pic}^{\mathfrak{n}}\left(X_{s}\right)$ to the line bundle $\xi_{s}^{*}(M)\left(q_{r}^{*}(-R)\right)$ in $\operatorname{Pic}^{\tilde{\mathrm{n}}}\left(Y_{r}\right)$, where $\xi_{s}$ is given by Proposition 4.2.

Proof. By Proposition 4.1, $X_{s}$ and $Y_{r}$ are irreducible and smooth for general $s$. We want to show that $\Phi_{s}(M)=\xi_{s}^{*}(M)(-S)$ for any line bundle $M$ on $X_{s}$, of degree $\mathfrak{n}$. Recall that $\xi_{s}$ is a composition $\xi_{s}=\pi_{s} \circ \varphi_{s}$

where $\pi_{s}$ is the natural projection of the fiber product $Y_{r}^{*}=Y \times_{X} X_{s}$ and $\varphi_{s}$ is the normalization of $Y_{r}^{*}$, see Proposition 4.2 and Figure 2.

The map $\Phi$ is defined using two correspondences, the former is a pullback and the second is an elementary transformation followed by a suitable reduction to the curve $Y_{r}$ (c.f. Section 4.1). Thus we need to follow the behavior of $M$ under these correspondences:

$$
\operatorname{Pic}^{\mathfrak{n}}\left(X_{s}\right) \xrightarrow[\pi_{s}^{*}]{\longrightarrow} \operatorname{Pic}^{2 \mathfrak{n}}\left(Y_{r}^{*}\right) \underset{{ }_{\text {lem }}}{\longrightarrow} \operatorname{Pic}^{2 \mathfrak{n}}\left(Y_{r}^{*}\right) \underset{\varphi_{s}^{*}}{\longrightarrow} \operatorname{Pic}^{\tilde{\mathfrak{n}}}\left(Y_{r}\right) .
$$

Let $(E, \mathbf{p}, \theta)$ be the Higgs bundle which corresponds to $M \in \operatorname{Pic}^{\mathfrak{n}}\left(X_{s}\right)$. By Proposition $2.5, \pi_{s}^{*} M$ is the line bundle in $\operatorname{Pic}^{2 \mathfrak{n}}\left(Y_{r}^{*}\right)$ corresponding to $\left(\pi^{*}(E, \mathbf{p}), \pi^{*} \theta\right)$, and it follows from Proposition 2.3 that the elementary transformation elem ${ }_{R}$ transforms $\pi_{s}^{*} M$ into $\pi_{s}^{*} M \otimes \mathcal{I}$, where $\mathcal{I}$ is the ideal sheaf of $\left(\zeta_{r}^{*} R\right)_{r e d}$ given by the $2: 1$ cover $\zeta_{r}: Y_{r}^{*} \rightarrow Y$.

The last operation is given by the normalization of $Y_{r}^{*}$. Since $\xi_{s}=\pi_{s} \circ \varphi_{s}$, then

$$
\Phi_{s}(M)=\varphi_{s}^{*}\left(\pi_{s}^{*} M \otimes \mathcal{I}\right)=\xi_{s}^{*}(M) \otimes \varphi_{s}^{*}(\mathcal{I})
$$

The conclusion follows from the fact that $Y_{r}$ is smooth, and then $\varphi_{s}^{*}(\mathcal{I})=\mathcal{O}_{Y_{r}}(-S)$ is the ideal sheaf of $S=q_{r}^{*} R$, where $q_{r}: Y_{r} \rightarrow Y$ is the $2: 1$ cover.

To see that $\Phi$ has degree two onto its image, first remark that $\pi^{*}$ of (5.3) is a one-to-one map between Hitchin basis and Proposition 4.3.

We close the paper by presenting two situations where the modular map $\Phi$ is dominant, which deal with pullback of $S L_{2}$-Higgs bundles over $\mathbb{P}^{1}$ via $\pi: Y \rightarrow \mathbb{P}^{1}$, where $g_{Y} \in\{1,2\}$. By $S L_{2}$ we mean that $\theta: E \rightarrow E \otimes \omega_{X}(D)$ has vanishing trace and $E$ has trivial determinant line bundle.
5.2. The case $\left(g_{X}, g_{Y}\right)=(0,1)$. Let us consider the degree two elliptic cover $\pi: Y \rightarrow \mathbb{P}^{1}$, branched over four distinct points $\{0,1, \lambda, \infty\}$. Let us fix $t_{1}, t_{2} \in Y$ with $\pi\left(t_{1}\right)=\pi\left(t_{2}\right)=t$, $t \notin\{0,1, \lambda, \infty\}$.

On the $\mathbb{P}^{1}$ side, we consider the moduli space $\mathcal{H}\left(\mathbb{P}^{1}, \Lambda\right)$ of irreducible $S L_{2}$ parabolic Higgs bundles over $\left(\mathbb{P}^{1}, \Lambda\right)$, where $\Lambda=0+1+\lambda+\infty+t$. On the elliptic side, we consider the moduli moduli space $\mathcal{H}(Y, D)$ of irreducible $S L_{2}$ parabolic Higgs bundles over $(Y, D)$, where $D=t_{1}+t_{2}$.

It turns out that $\mathcal{H}\left(\mathbb{P}^{1}, \Lambda\right)$ and $\mathcal{H}(Y, D)$ have the same dimension: four. We can associate to a Higgs bundle in $\mathcal{H}\left(\mathbb{P}^{1}, \Lambda\right)$ a Higgs bundle in $\mathcal{H}(Y, D)$ by doing the pullback $\pi^{*}$ followed by a composition of an elementary transformation elem $_{R}$ over the divisor

$$
R=w_{0}+w_{1}+w_{\lambda}+w_{\infty}
$$

formed by ramification points of $\pi$. This is our map $\Phi$. Note that, starting with a vector bundle $E$ of degree 0 on $\mathbb{P}^{1}$, the transformed vector bundle on $Y$ has determinant $\mathcal{O}_{Y}(-R)$, then degree -4 . Since $R \sim 4 w_{\infty}$, we then perform a last transformation, twisting by $\mathcal{O}_{Y}\left(2 w_{\infty}\right)$, which results in trivial determinant.

This correspondence gives a map

$$
\Phi_{0}: \mathcal{H}\left(\mathbb{P}^{1}, \Lambda\right) \longrightarrow \mathcal{H}(Y, D)
$$

which consists in $\left[\otimes \mathcal{O}_{Y}\left(2 w_{\infty}\right)\right] \circ \Phi$, and fits in the following commutative diagram

(both spaces of quadratic differentials are two dimensional).
Over $\mathbb{P}^{1}$, the smooth spectral curve $X_{s}$ has genus 2 and is branched over 6 distinct points $0,1, \lambda, \infty, t, \rho$. The corresponding Hitchin fiber $\operatorname{det}^{-1}(s)$ is isomorphic $\operatorname{Pic}^{3}\left(X_{s}\right)$. Over $Y$, the generic spectral curve $Y_{r}$ is a hyperelliptic curve of genus 3 branched over 4 distinct points $t_{1}, t_{2}, u_{1}, u_{2}$, with $\rho=\pi\left(u_{1}\right)=\pi\left(u_{2}\right)$. The fiber $\operatorname{det}^{-1}(r)$ over $Y_{r}$ is an Abelian variety isomorphic to the Prym variety

$$
\operatorname{Prym}\left(Y_{r} / Y\right)=\left\{M \in \operatorname{Pic}^{2}\left(Y_{r}\right): \operatorname{det}\left(\left(q_{r}\right)_{*} M\right)=\mathcal{O}_{Y}\right\} .
$$

Since $q_{r}$ is a ramified covering, then $\operatorname{Prym}\left(Y_{r} / Y\right)$ is an irreducible variety, this follows from [14, (iv) in p. 329].

We can choose local coordinates where

$$
\left\{\begin{array}{l}
X_{s}=\left\{(x, w) \quad: \quad w^{2}=x(x-1)(x-\lambda)(x-t)(x-\rho)\right\} \\
Y_{r}=\left\{(x, y, z) \quad: \quad y^{2}=x(x-1)(x-\lambda) \text { and } z^{2}=(x-t)(x-\rho)\right\}
\end{array}\right.
$$

and both curves fit in the commutative diagram below

where

$$
\mathbb{P}_{\rho}^{1}=\left\{(x, z) \quad: \quad z^{2}=(x-t)(x-\rho)\right\} .
$$

The étale $\operatorname{map} \xi_{s}: Y_{r} \rightarrow X_{s}$ is the same of Proposition 4.2, explicitly given here by $(x, y, z) \mapsto$ $(x, y z)$.

In this context, Theorem 5.1 can be written as
Corollary 5.2. The rational map $\Phi_{0}: \mathcal{H}\left(\mathbb{P}^{1}, \Lambda\right) \rightarrow-\mathcal{H}(Y, D)$ has degree two. Moreover, its restriction to a general fiber of the Hitchin map is a morphism of degree two given by

$$
\begin{aligned}
\Phi_{0, s}: \operatorname{Pic}^{3}\left(X_{s}\right) & \rightarrow \operatorname{Prym}\left(Y_{r} / Y\right) \\
M & \mapsto \xi_{s}^{*}(M)\left(S_{0}\right)
\end{aligned}
$$

where $S_{0}=q_{r}^{*}\left(2 w_{\infty}-R\right)$.
In a forthcoming paper, we will give the full description (at singular Hitchin fibers) of the $\operatorname{map} \Phi_{0}$.
5.3. The case $\left(g_{X}, g_{Y}\right)=(0,2)$. We now take a degree two morphism $\pi: Y \rightarrow \mathbb{P}^{1}$ from a curve $Y$ of genus 2. It is branched over 6 distinct points $t_{1}, \ldots, t_{6}$ of $\mathbb{P}^{1}$. Let $B=t_{1}+\cdots+t_{6}$ be the reduced divisor on $\mathbb{P}^{1}$ defined by those points, and let $R=w_{1}+\cdots+w_{6}$ be the divisor on $Y$ formed by ramification points of $\pi$.

Let us consider the moduli space $\mathcal{H}\left(\mathbb{P}^{1}, B\right)$ of irreducible $S L_{2}$-Higgs bundles over $\left(\mathbb{P}^{1}, B\right)$. Over $Y$, we consider the moduli space $\mathcal{H}(Y)$ of irreducible holomorphic $S L_{2}$-Higgs bundles over $Y$, without parabolic points. These moduli spaces have both dimension 6 .

The spectral curve on the $\mathbb{P}^{1}$ side has genus 3 and the corresponding smooth Hitchin fiber is isomorphic to $\operatorname{Pic}^{4}\left(X_{s}\right)$. Over $Y$, the spectral curve $Y_{r}$ has genus 5 and the smooth Hitchin fiber $\mathcal{H}(Y)$ is isomorphic to

$$
\operatorname{Prym}\left(Y_{r} / Y\right)=\left\{M \in \operatorname{Pic}^{2}\left(Y_{r}\right): \operatorname{det}\left(\left(q_{r}\right)_{*} M\right)=\mathcal{O}_{Y}\right\}
$$

which is three dimensional, and irreducible ([14, (iv) in p. 329]).
We consider the correspondence $\Phi_{0}: \mathcal{H}\left(\mathbb{P}^{1}, B\right) \rightarrow \mathcal{H}(Y)$ given by $\left[\otimes L_{0}\right] \circ$ elem $_{R} \circ \pi^{*}$, where $L_{0}$ is a square root of $\mathcal{O}_{Y}(R)$. Note that the following diagram is commutative

where the Hitchin basis are three dimensional. From Theorem 5.1, we obtain a result similar to Corollary 5.2:

Corollary 5.3. The rational map $\Phi_{0}: \mathcal{H}\left(\mathbb{P}^{1}, B\right) \rightarrow \mathcal{H}(Y)$ has degree two and its restriction to a general fiber of the Hitchin map consists of

$$
\begin{aligned}
\Phi_{0, s}: \operatorname{Pic}^{4}\left(X_{s}\right) & \rightarrow \operatorname{Prym}\left(Y_{r} / Y\right) \\
M & \mapsto \xi_{s}^{*}(M) \otimes q_{r}^{*}\left(L_{0}(-R)\right) .
\end{aligned}
$$
