# Photocatalyzed hydrosilylation in silicone chemistry

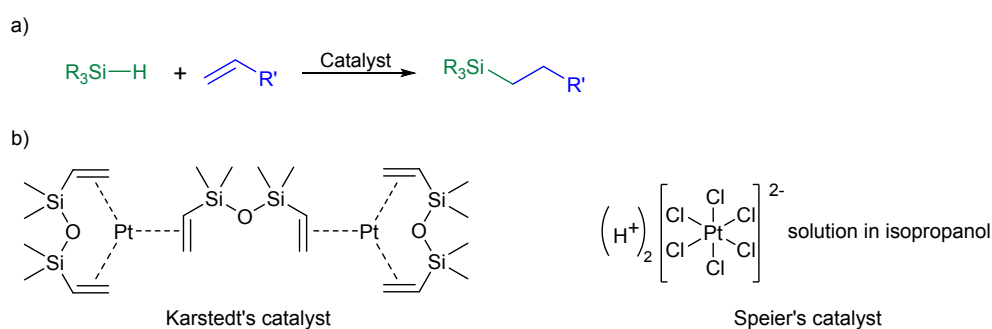
**KEYWORDS:** Hydrosilylation, Photoactivation, Photocatalyst, Silicones, 3D printing

**ABSTRACT.** Hydrosilylation is widely used in silicone chemistry to crosslink formulations so as to generate elastomer materials. Most often, heat is the easiest way to activate a platinum catalyst that proceeds to reaction, but photoirradiation is an alternative way to promote hydrosilylation in a fast and mild way. The open and patent literatures dealing with light-induced hydrosilylation are exhaustively reviewed here. First, various promoters, including metal (photo)catalyst, co-catalysts and inhibitors, are systematically described. Some kinetics provided by the very few available academic papers are disclosed as well. Throughout the review, proposed applications, mainly in coatings, are reported, whereas potential applications in 3D printing are specifically disclosed as a separate final chapter. Prospects about the pros

and cons of the photohydrosilylation technique compared to other irradiation-promoted catalytic systems used in silicones, close the article.

## 1. Introduction

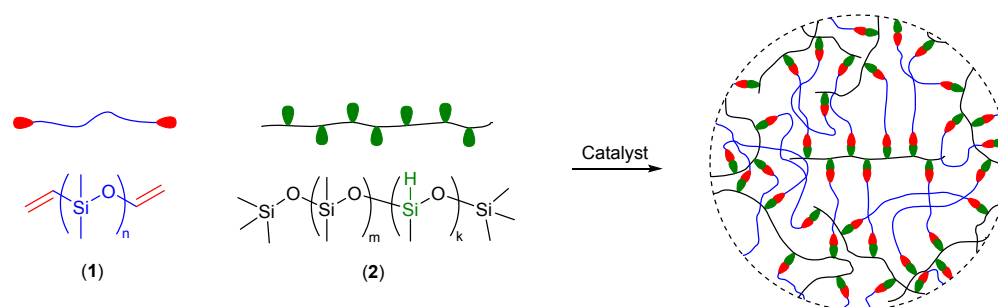
Hydrosilylation is a well-studied reaction occurring between hydrogen-silicon bond and a multiple bond<sup>1</sup>; a general scheme of hydrosilylation using an example of alkene and silane is presented in Figure 1a. Since the second half of the 20<sup>th</sup> century, hydrosilylation has found many applications in organic<sup>2</sup> and in polymer chemistries<sup>3</sup>. The complexes of such transition metals as platinum<sup>2</sup>, rhodium<sup>4,5</sup>, ruthenium<sup>6-8</sup>, palladium<sup>9,10</sup>, nickel<sup>11</sup>, iron<sup>12</sup> and iridium<sup>13,14</sup> were described as catalysts for this reaction; most commercially used are the complexes of platinum, typically Karstedt's and Speier's catalysts (see structures in Figure 1b)<sup>3</sup>.

In polymer chemistry, hydrosilylation is widely applied to the production of crosslinked silicone elastomers (Figure 2). Usually long divinyl-terminated poly(dimethylsiloxane) chains (**1**) (divinyl-PDMS) are crosslinked by adding oligomeric crosslinking chains such as poly(dimethylsiloxane-co-

1  
2 methyl-hydrogenosiloxane) (2)<sup>15</sup> and very small quantities (5–10 ppm) of Pt-catalyst<sup>3</sup>. Final materials  
3  
4  
5 are generally characterized by improved chemical and temperature resistances, and better mechanical  
6  
7  
8 properties (tensile strength, tear strength, gas permeability) than silicones obtained by other  
9  
10  
11 crosslinking methods<sup>3</sup>. Moreover, the low toxicity of employed catalysts allows using these materials  
12  
13  
14  
15 in biomedical and healthcare applications<sup>16</sup>.

34  
35 One particularly interesting method of polymer crosslinking is radiation curing (for recent reviews  
36  
37 on polysiloxane radiation curing, see<sup>17,18</sup>). Usually, crosslinking through light, electron beam or  
38  
39 gamma irradiation leads to shorter curing time, less heat generation and, in case of the latter two,  
40  
41  
42 without requiring the use of metal catalyst,<sup>17</sup> making the process particularly economical in e.g. fast-  
43  
44  
45 curing of films. For photoinitiated curing, silicone oils are functionalized by various groups, e.g.  
46  
47  
48 acrylate, thiol, epoxide, or vinyl<sup>15,18</sup> and crosslinked by radical or cationic means. One main  
49  
50

2 their strong unpleasant odor<sup>15</sup>. Cationic crosslinking is fast<sup>20</sup> but highly sensitive to moisture and still  
3  
4  
5 proceeds after the light is off (which may be good or not, depending on the technology developed).  
6  
7

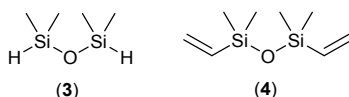
8  
9 In all these processes, the presence of organic (non-silicone) crosslinks may limit the thermal stability  
10  
11  
12 of obtained materials.  
13  
14

15  
16 Hydrosilylation-cured silicone elastomers usually do not show these disadvantages (short ethylene  
17  
18 bridges formed by hydrosilylation do not have limitations of other organic crosslinks) and there are  
19  
20 photoactive catalysts that are available for photocuring of silicone oils. Surprisingly, up to now, there  
21  
22 has been no review on photohydrosilylation in polymer chemistry, despite a significant number of  
23  
24  
25 patents and scientific article published in the past 50 years. In contrast to photoinduced  
26  
27  
28 hydrosilylation in organic synthesis that has been reviewed<sup>21</sup>, photohydrosilylation in polymer  
29  
30  
31 chemistry was usually cited only as a small part in larger reviews of hydrosilylation<sup>3,22</sup> and did not  
32  
33  
34 cover exhaustively published materials. Here, we review the topic of light-induced hydrosilylation  
35  
36  
37 for silicone curing. We present works according first to the type of catalyst and then the nature of  
38  
39  
40 cocatalyst that have been chosen (photosensitizer and radical photoinitiators). Then we review  
41  
42  
43 photoactive systems where inhibitors were introduced, allowing an increase in the shelf life of liquid  
44  
45  
46 resins. A final part about application of photohydrosilylation in 3D printing is given before  
47  
48  
49 concluding with a short discussion on pros and cons of photohydrosilylation.

## 59 **2. Preliminary works on silicone photohydrosilylation.**

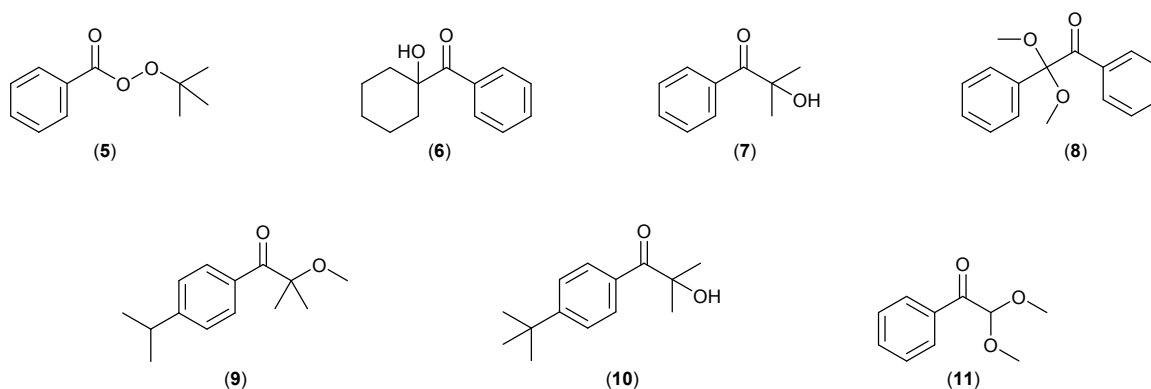
1  
2 The present section describes early basic studies where non-photoactive catalysts or simple radical  
3  
4  
5  
6 initiators were used together with powerful lamps. To our knowledge, the first example of  
7  
8  
9 photocatalyzed hydrosilylation involving siloxanes was reported by Faltynek in 1981<sup>23</sup> who used  
10  
11  
12 1,1,3,3-tetramethyldi-siloxane (3) and 1,3-divinyltetramethyl-siloxane (4) (Figure 3) as model  
13  
14  
15 compounds to study the photocatalytic activity of rhodium (I) complexes with phosphine and  
16  
17  
18 phosphite ligands. It was shown that in the presence of  $\text{ClRh}(\text{O}_2)(\text{PPh}_3)$  in benzene or cumene,  
19  
20  
21 hydrosilylation occurred faster under irradiation at 366 nm than in the dark, even if the reaction  
22  
23  
24  
25  
26 required several hours.



34 **Figure 3.** Model siloxanes for photohydrosilylation described in<sup>23</sup>.

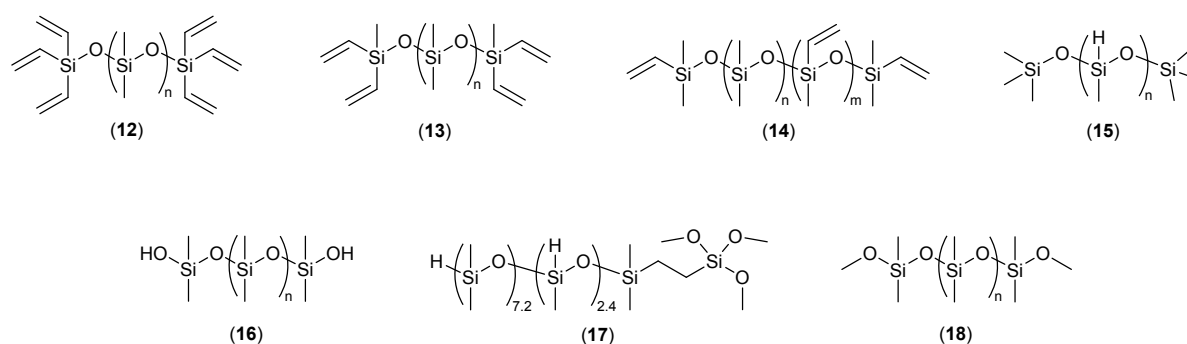

37  
38 Many examples of early crosslinked polysiloxane synthesis by photohydrosilylation can be found  
39  
40  
41 in the patent literature. General Electric (GE) Company developed coatings based on polysiloxane  
42  
43  
44 containing different amounts of methylvinylsiloxo, methylhydrogenosiloxo and dimethylsiloxo  
45  
46  
47 units<sup>24</sup>. They used tert-butyl peroxybenzoate (5, Figure 4) as a radical initiator for curing under 160  
48  
49  
50  
51  
52  
53

55  
56  
57  
58  
59  
60 w/cm high pressure mercury lamp (UV-7000 from Ushio Electric Co., Ltd.). The adhesion of obtained  
coatings to different substrates was excellent, contrary to comparative examples where

methylvinylsiloxy or methylhydrogensiloxy units were omitted. This result may indicate that crosslinking happened by hydrosilylation reaction as Si-H and vinyl groups are necessary here.

Shin-Etsu Chemical Co., Ltd. reported photohydrosilylation of several vinyl-containing silicone oils (1, 12 – 14) with poly(methylhydrogensiloxane) (15) (Figures 2 and 5)<sup>25</sup>. The inventors refer to the employed catalyst as “platinum-vinylsiloxane complex” without any information about its structure or composition. It may correspond to the well-known Karstedt’s catalyst<sup>26</sup> that is not usually considered as a photoactive one.



**Figure 5.** Silicone oils described in this review as components of photohydrosilylation formulations.

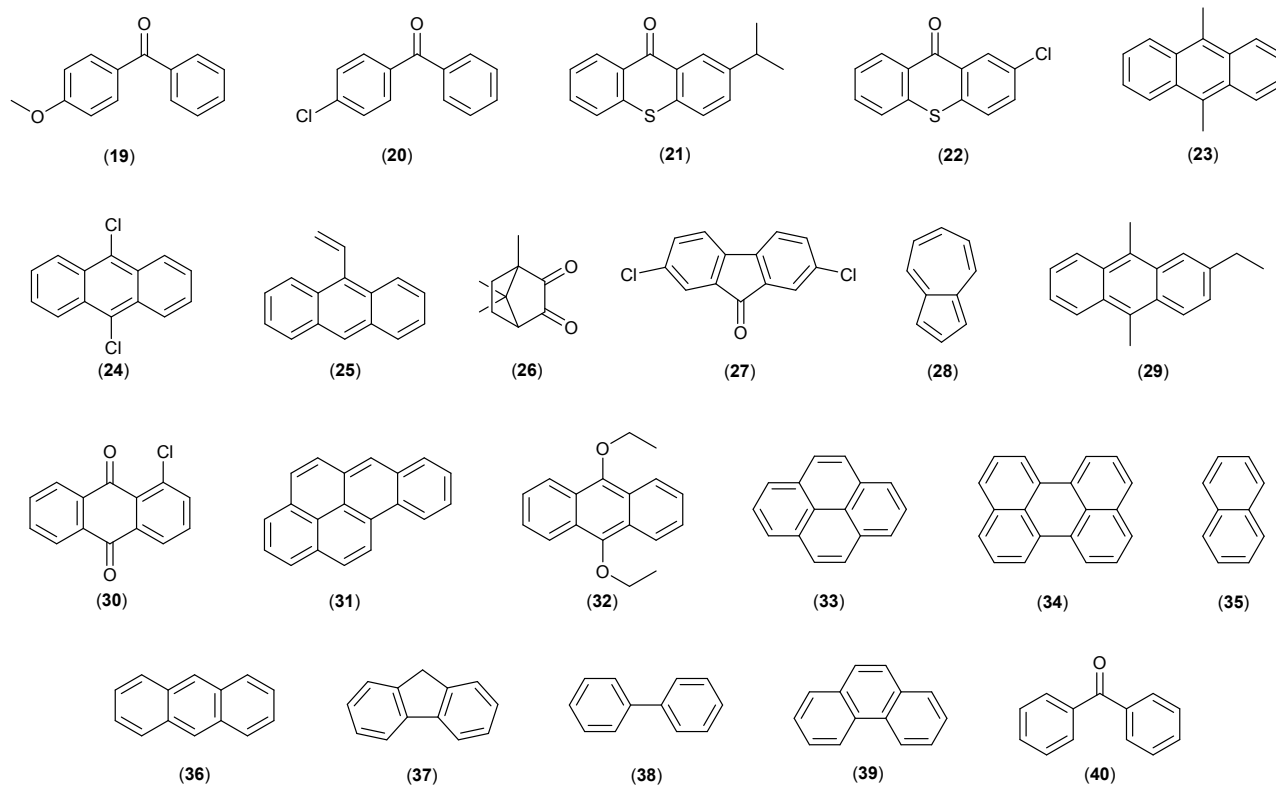

2 Nevertheless, the formulations containing above-mentioned silicone oils and catalyst (150 ppm of  
3  
4  
5 Pt) were used to prepare coatings by photocuring the samples at a distance of 8 cm under two high  
6  
7  
8  
9 pressure mercury lamps each having an output of 2 kW and a linear output density of 80 W/cm. It  
10  
11  
12 was clearly shown that the various vinyl-containing silicones present different activity in the  
13  
14  
15 described conditions. The least active divinyl-PDMS (1) based coating required 10 sec of exposure  
16  
17  
18 to obtain a tack-free surface, while for the most active one, bis(trivinylsilyl)-polydimethylsiloxane  
19  
20  
21 (12), only 0.6 sec of exposure was sufficient to remove the tackiness. In the same patent<sup>25</sup>, it was  
22  
23  
24 shown that adding ceric oxide (CeO<sub>2</sub>) could accelerate hydrosilylation reaction under UV-light: a  
25  
26  
27 formulation containing 2.8 wt.% of this compound was cured in an impressive 0.4 sec. Also, this  
28  
29  
30 company presented a similar study using Speier's catalyst (H<sub>2</sub>PtCl<sub>6</sub>) in the presence of  
31  
32

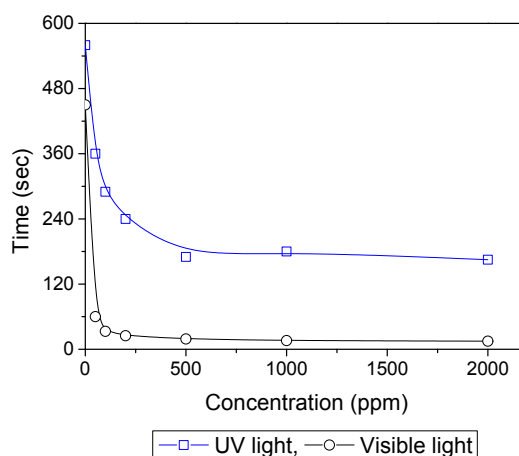
**Figure 6.** Structures of the compounds tested as photosensitizers in photohydrosilylation systems mentioned in this review.

33 photosensitizers 19 and 7 (Figures 4 and 6)<sup>27</sup>. Using the same UV lamp and the silicone oils described  
34  
35  
36 in the previous patent, they obtained extremely quick curing times (between 0.1 and 2 sec).  
37  
38  
39 Unfortunately, for both catalysts, there is no information about dark curing, shelf life or possible  
40  
41  
42 heating of the formulations below the powerful UV lamp. For H<sub>2</sub>PtCl<sub>6</sub>-based system, a blank  
43  
44  
45 experiment without sensitizers was also missing. Such data would be interesting to clarify whether  
46  
47  
48 these catalysts have photoactivity or if they have been activated by the heat of the UV lamp.

### 3. Photohydrosilylation with diene-Pt complexes.

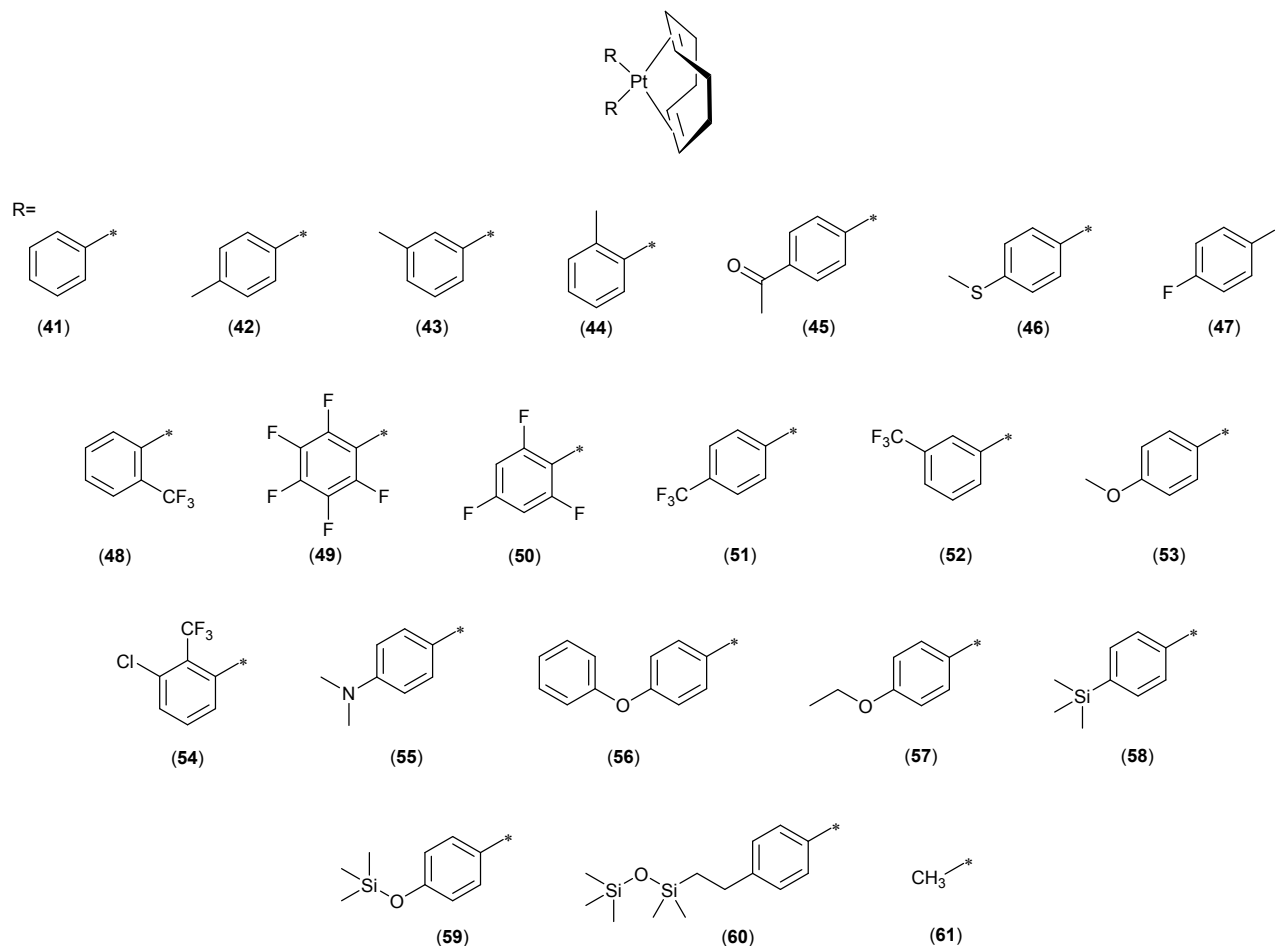


### 3.1. Patent literature.

Minnesota Mining and Manufacturing (3M) Company patented UV-activated hydrosilylation between divinyl-PDMS (**1**) and poly(methylhydrogenosiloxane) (**15**) using Pt complexes bearing 1,5-cyclooctadiene (COD) and aromatic ligands (**41** – **60**, Figure 7)<sup>28</sup>. They prepared formulations containing 180 ppm of platinum to hand coat them on polyester film and study photohydrosilylation. They used 20 watt “black” light lamp at a distance of 2.5 cm and measured the time required to convert the coating to a non-smearing surface. For almost all formulations, from 2.5 to 4.5 min were required. The only two exceptions were i) the complex bearing perfluorophenyl ligand (**49**) that required 15 min to cure under irradiation and ii) the one bearing 4-dimethylaminophenyl (**55**) that cured the resin in the dark in 4 minutes (and was thus not tested under UV-light).

The catalytic activity of four of these Pt-complexes (di(4-methylphenyl)-Pt(COD) (42), di(4-trifluoromethylphenyl)-Pt(COD) (51), di(4-methoxyphenyl)-Pt(COD) (53) and di(4-trimethylsilylphenyl)-Pt(COD) (58), 200 ppm Pt content) was studied in the presence of a number of photosensitizers (20 – 28, Figure 6, 500 ppm)<sup>29</sup>. The curing was performed under UV-light (six 15 watt “black” light lamps, maximum output at 365 nm) as well as under visible light (“Visilux” 2

1  
2 dental curing light, wavelength 400 – 500 nm). The power of visible light source is not mentioned in  
3  
4  
5  
6 the patent, which does not allow to compare the efficiency of these two types of irradiation. For  
7  
8  
9 fluorine- and silicon-containing catalysts (51, 58), the tested additives (22, 23) only slowed down the  
10  
11  
12 reaction under both sources of light, while for other Pt-complexes, certain sensitizers provoked an  
13  
14  
15 accelerating effect. The most pronounced sensitizing effect was achieved for the couple di(4-  
16  
17 methoxyphenyl)-Pt(COD) (53)/2-chlorothioxanthone (22), the time required to obtain tack-free  
18  
19 polymer was reduced from 530 to 172 sec under UV-light and from 480 to 25 sec under visible light.  
20  
21  
22  
23  
24  
25  
26 The influence of sensitizer concentration was studied for this system ((53)/(22), see Figure 8). It can  
27  
28  
29 be seen that cure time decreased with an increase of sensitizer content up to 500 ppm, while further  
30  
31  
32 increasing this concentration did not noticeably accelerate the reaction.  
33

9 and visible (400 – 500 nm) light<sup>29</sup>.

10  
11  
12  
13 Later, a similar but simpler catalyst ((COD)PtMe<sub>2</sub>) (**61**, Figure 7) was employed by inventors from  
14  
15  
16 Shin-Etsu Chemical Co., Ltd. to produce silicone templating mother molds<sup>30</sup> (the term “mother mold”  
17  
18  
19 is used in the patent to refer to the mold obtained by casting around a master model). The formulation  
20  
21  
22 contained 30 ppm of Pt and no additional components apart from vinyl and Si-H containing MQ-  
23  
24  
25 resins (highly branched silicone resin<sup>33</sup>) and divinyl-PDMS (**1**). The composition was cured for  
26  
27  
28  
29  
30 10 min (2.0 J/cm<sup>2</sup>) in a rectangular exposure chamber where 40-W fluorescent lamps emitting UV  
31  
32  
33 light at a center wavelength of 370 nm were disposed at each wall (six lamps overall). The obtained  
34  
35  
36 sample were characterized by hardness of 34 Shore A, elongation of 400 %, tensile strength of  
37  
38  
39 3.4 MPa, tear strength of 7.4 N/mm and light transmittance at 370 nm of 36 %. The formulation was  
40  
41  
42  
43 utilized to obtain molds that were successfully used to replicate a model.

44  
45  
46 The 3M Company proposed another method of UV-activated silicone hydrosilylation by using a  
47  
48  
49 new type of platinum catalyst containing cyclopentadienyl (Cp) or its derivatives as a ligand (**62** –  
50  
51  
52 **70**, Figure 9)<sup>34,35</sup>. Cyclopentadienyl-platinum complexes are known to well absorb UV light<sup>36</sup>. The  
53  
54  
55 gel-time (time required to achieve a state in which the resin no longer flows) under “black” light (20  
56  
57  
58 watt) was measured between 16 and 40 sec for these catalysts (Pt concentration 200 ppm), while  
59

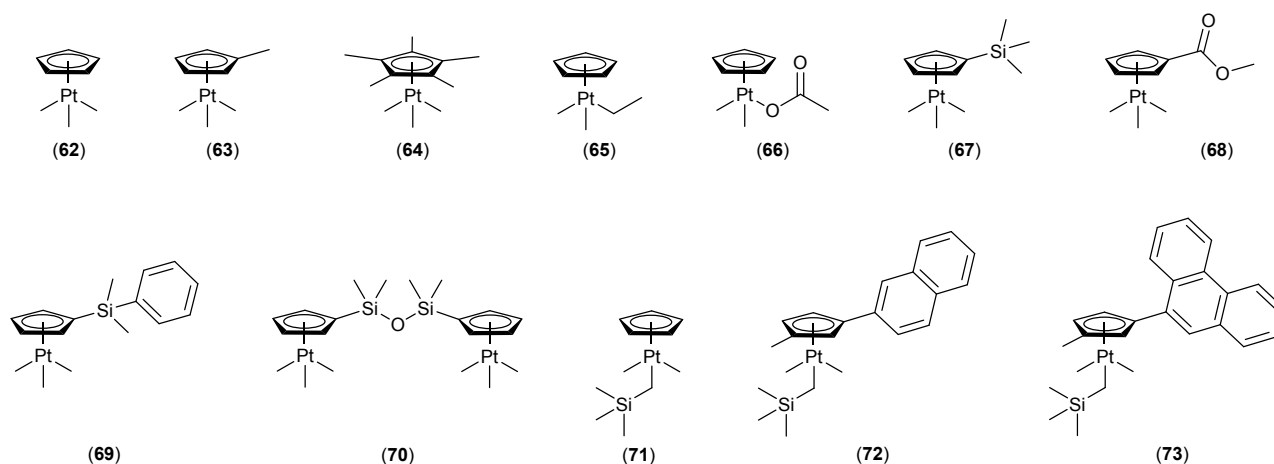

2 without irradiation at room temperature, the gel time was 30 h for (methoxycarbonyl-Cp)-  
3  
4  
5 trimethylplatinum (**68**) (most active) and more than 1550 h for (Cp)trimethylplatinum (**62**).  
6  
7

8  
9 Interestingly, it was also shown that the crosslinking of these formulations can occur in the dark after  
10  
11 exposure to “black” light: after 10 sec of exposure, it took from 16 to 160 sec to reach the gel point,  
12  
13  
14  
15 depending on the catalyst.  
16  
17

18  
19 In a following study, the same company modified the system based on (Cp)trimethylplatinum (**62**)  
20  
21 to use it for visible light curing (“Visilux” 2 dental curing light, wavelength 400 – 500 nm)<sup>37</sup>. Several  
22  
23 photosensitizers were tested to accelerate curing, the most effective ones being 2-chlorothioxanthone  
24  
25  
26 (**22**), 9,10-dimethylantracene (**23**), 9,10-dichloroanthracene (**24**), 2-ethyl-9,10-dimethylantracene  
27  
28  
29 (**29**), 1-chloro-anthraquinone (**30**), benzo[a]pyrene (**31**) and 9,10-diethoxyanthracene (**32**) (see Figure  
30  
31  
32  
33  
34

6). The inventors measured the time of exposure required to get tack-free polymers in the presence  
of 960 ppm of Pt, which is quite concentrated. They found that 2-chlorothioxanthone (**22**) was again  
the most active photosensitizer in these conditions, for which only 33 sec of exposure were required  
(compared to 117 sec for the formulation without photosensitizer). Also, it was shown that in the  
presence of 9,10-dimethylantracene(**23**), the cure speed could be enhanced by increasing the  
platinum content up to 2000 ppm; further addition of the catalyst almost did not accelerate the  
reaction. Moreover, the influence of sensitizer concentration was studied with 2-ethyl-9,10-  
dimethylantracene (**29**). It was found that an increase of concentration from 200 to 1500 ppm led to

1  
2 a decrease in required cure time from 77 to 37 seconds; higher concentrations of sensitizer were not  
3  
4  
5  
6 tested. The use of such photocurable resin for preparation of dental impressions was described in this  
7  
8  
9 patent. For this purpose, the formulation of silicone oils (divinyl-PDMS (1) and  
10  
11  
12 poly(dimethylsiloxane-co-methylhydrogenosiloxane) (2)) with 900 ppm of platinum, 1000 ppm of 2-  
13  
14  
15 chlorothioxanthone (22) and 9 % of fumed silica was used; about 2 min of exposure was required to  
16  
17  
18 obtain completely tack-free resin. Finally, they demonstrated that (Cp)trimethylplatinum (62) based  
19  
20  
21  
22 compositions show good adhesion (2 – 4 N/100 mm) to polycarbonate and polybutylene  
23  
24  
25 terephthalate and can be used as sealants for connector plugs and sockets<sup>38</sup>.

26  
27  
28  
29 Besides, Wacker Chemie AG demonstrated that coating of connectors plugs can be accelerated by  
30  
31  
32 preheating photocurable formulations with (methyl-Cp)trimethylplatinum (63) to 100 – 125 °C before  
33  
34  
35 application<sup>39</sup>. Such treatment decreases the viscosity of the formulation, allowing better spreading on  
36  
37  
38 the surface of the plugs. They also suggested to use vinyl-functionalized MQ resin instead of silica  
39  
40  
41 to obtain transparent materials<sup>40</sup>. Shin-Etsu Chemical Co., Ltd. showed that (methyl-  
42  
43  
44 Cp)trimethylplatinum (63)-based formulations could be kept in the dark at 40 °C for a month without  
45  
46  
47 thickening<sup>41</sup>. After this prolonged storage, the catalyst could still be activated by UV light (50 sec,  
48  
49  
50 100 mW/cm<sup>2</sup>) leading to complete curing in 1 h at 25 °C  
51  
52  
53  
54  
55  
56  
57  
58

### 3.2. Academic works.

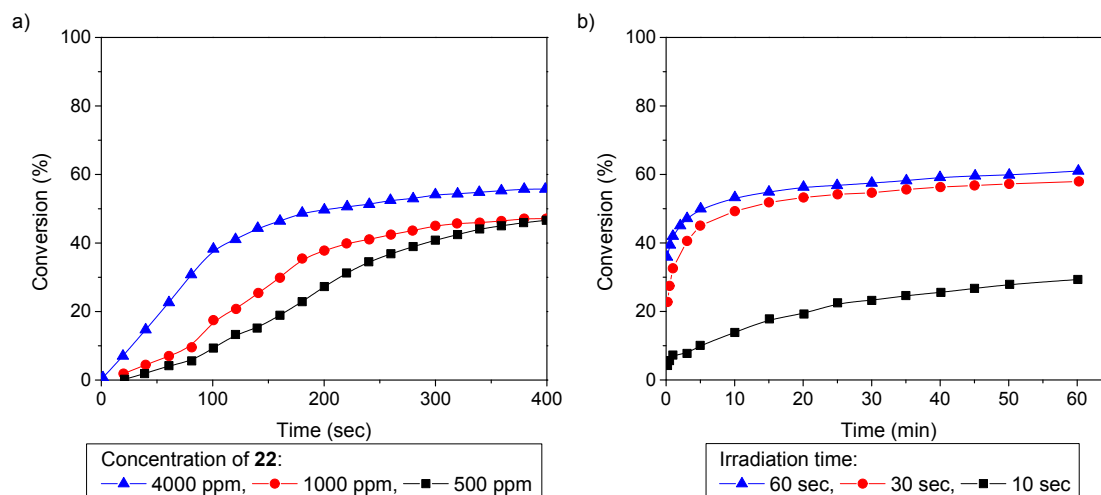
(Methyl-Cp)trimethylplatinum (63)/2-chlorothioxanthone (22) initiating system was recently studied in academia by Marchi *et al.*<sup>2</sup>. The reaction between divinyl-PDMS (1) and poly(methylhydrogenosiloxane) (15) (equimolar amounts of vinyl and Si-H groups) under UV and visible lights in the presence of 1000 ppm of (methyl-Cp)trimethylplatinum (63) (corresponding to 610 ppm of Pt content) was studied. First, they tested some concentrations of 2-chlorothioxanthone (22) between 500 and 4000 ppm (Figure 10a) and found that the highest concentration increased Si-H conversion at the beginning of the reaction, but in all cases the conversion could hardly reach 55 % even after 400 sec of exposure to visible light (Astralis 5 gun lamp by Ivoclar Vivadent, intensity 500 mW/cm<sup>2</sup>, wavelength 380 – 515 nm). A blank experiment without photosensitizer showed that the catalyst alone is not active under this type of light, while exposure of this formulation to UV light

1  
2 resulted in relatively quick Si-H conversion (80 % in about 150 sec). Also, dark-curing was studied  
3  
4  
5  
6 after 10, 30 and 60 sec of visible light exposure (1000 ppm of the catalyst and 4000 ppm of the  
7  
8  
9 sensitizer) (Figure 10b). After 10 sec of exposure, the conversion increased from 5 to 30 % during 1  
10  
11  
12 hour of dark-curing, indicating that the catalyst remained active for long time. Dark curing after 30  
13  
14  
15 or 60 sec of exposure had very similar kinetics and reached about 60 % of conversion in 1 h.

16  
17  
18  
19 To evaluate the maximum cure depth attainable, the surface of a thick layer of the same formulation  
20  
21  
22 was exposed to visible light for 2 or 4 min and, after 10 min of dark-curing, samples of 0.9 and 1.4 cm  
23  
24  
25 thicknesses, respectively, were characterized. Unfortunately, the authors did not explain whether full  
26  
27  
28 curing occurred by light penetration or by diffusion of activated catalyst. Thermogravimetric analysis  
29  
30  
31 (TGA) of the samples obtained under UV and visible lights showed similar decomposition profile  
32  
33  
34 with main degradation starting at about 300 °C and resulting to about 70 % of residue at 800 °C. Such  
35  
36  
37 high residue value is quite surprising in the absence of silica. It may be partly explained by two main  
38  
39  
40 factors: i) the ability of (methyl-Cp)trimethylplatinum (**63**) to catalyze the formation of heat-resistant  
41  
42  
43 inorganic substance (ceramization) from silicone at high temperature, similarly to Karstedt's  
44  
45  
46 catalyst<sup>43</sup>; ii) the generation of a dense crosslinked network coherent with the high functionality of  
47  
48  
49 poly(methylhydrogenosiloxane) (**15**), compared to poly(dimethylsiloxane-co-  
50  
51  
52 methylhydrogenosiloxane) (**2**) that is generally used in commercial hydrosilylation formulations.  
53  
54  
55  
56  
57  
58  
59 Dynamic mechanical analysis (DMA) showed  $T_g$  values of -102 and -96 °C for the sample obtained  
60



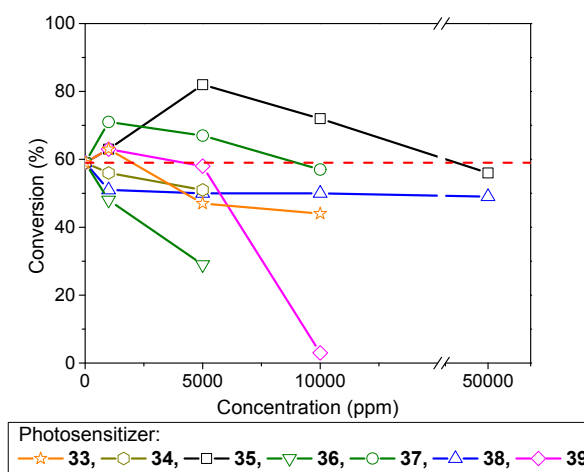
under visible and UV lights, respectively. These values are much higher than  $T_g$  of commonly used PDMS elastomers ( $\sim 120^\circ\text{C}$ ), which a priori confirms the very high crosslink density of the network.

Recently, Xiang *et al.* studied the influence of several other photosensitizers on photohydrosilylation in the presence of the same catalyst (**63**) in order to decrease the required Pt concentration<sup>44</sup>. First, they studied the reaction between divinyl-PDMS (**1**) and poly(methylhydrogenosiloxane) (**15**) under UV light (365 nm LED, 33 mW/cm<sup>2</sup>) at different catalyst concentrations (50 – 400 ppm, corresponding to 30 – 245 ppm of Pt content). It was found that, in these conditions, 400 ppm of the Pt complex is required to reach Si-H conversion close to 100 % in 300 sec. At 50 ppm of catalyst concentration, conversion did not exceed 50 % after the same time of exposure. Based on these results, the authors chose 100 ppm as a catalyst content to study the

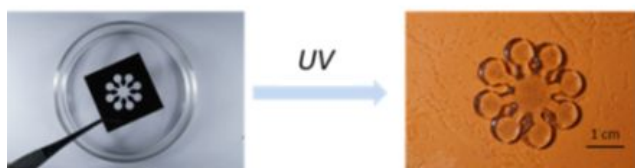
1  
2 influence of various photosensitizers (33 – 39, Figure 6). Figure 11 shows the Si-H conversion in the  
3  
4  
5 presence of different concentrations of the sensitizers after 100 sec of exposure (we specifically  
6  
7  
8 selected this reaction time to clearly show the influence of the sensitizer on polymerization kinetics,  
9  
10  
11 all things being equal). It could be seen that some compounds (pyrene (33), naphthalene (35), fluorene  
12  
13  
14 (37) and phenanthrene (39)) accelerated hydrosilylation up to a certain concentration, but adding  
15  
16  
17 more of these compounds had the reverse effect and slowed down the reaction. The other three studied  
18  
19  
20 compounds (perylene (34), anthracene (36) and biphenyl (38)) decreased the reaction rate even at the  
21  
22  
23 lowest tested concentration. The authors did not provide clear explanation of the different influence  
24  
25  
26 of these molecules, but as naphthalene showed more pronounced accelerating effect, it was selected  
27  
28  
29 as the most suitable sensitizer for UV-activated hydrosilylation. The cured samples obtained with and  
30  
31  
32 without this photosensitizer were analyzed by tensile test, DMA and TGA. It was found that the  
33  
34  
35 presence of naphthalene during curing resulted in higher values of stress and elongation at break,  
36  
37  
38 higher  $T_g$  and larger solid residue at 800 °C (Table 1). This difference in properties was explained by  
39  
40  
41 higher conversion of naphthalene-assisted reaction and consequently higher crosslinking density.  
42  
43  
44  
45  
46 Finally, the example of photolithography using one of the developed resins was demonstrated (Figure  
47  
48  
49  
50  
51  
52  
53  
54  
55  
56  
57  
58  
59  
60  
12). Exposure to UV-light while applying a shadow mask resulted in an object with the corresponding  
negative shape. Still, low resolution could be noticed.

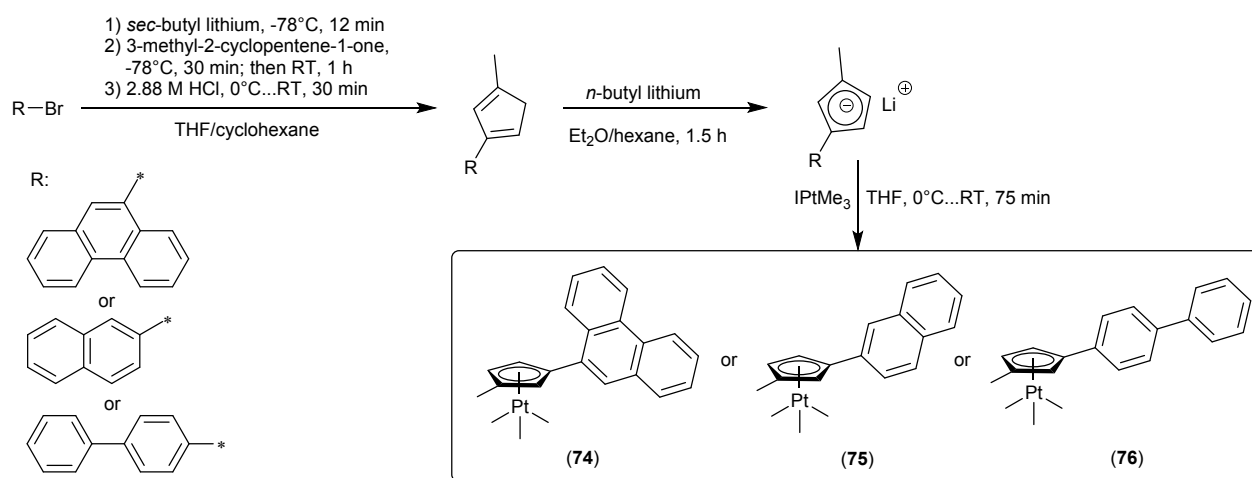

### 8 9 *3.3. New platinum chemistry.*

10  
11  
12  
13 The GE Company raised an issue about the bad compatibility of such photosensitizers as  
14  
15 anthracene-based ones and suggested a synthesis of cyclopentadienyl-based Pt-complexes containing  
16  
17 chromophore groups (Figure 13)<sup>45</sup>. To study the efficiency of these new complexes, divinyl-PDMS  
18  
19 (1), Si-H containing silicone (SL6020 from GE Silicone Product Division) and the new Pt catalysts  
20  
21 were cured using an RPC UV processor, PPG model 1202, which was fitted with 400 – 500 W  
22  
23 mercury arc lamps, at a line speed of 50 – 100 cm/sec (layer thickness: 0.013 to 0.13 mm). For  
24  
25 comparison, in case of (methyl-Cp)trimethylplatinum(63)-catalyzed reaction, it was required  
26  
27 200 ppm of Pt and 1800 ppm of phenanthrene (39) to reach a non-smear state at a line speed of  
28  
29 50 cm/sec and using a 400 W lamp. Whereas, synthesized [1-methyl-3-(9'-phenanthryl)-  
30  
31 cyclopentadienyl] trimethylplatinum (74) solely achieved non-smear coating at a line speed of  
32  
33 100 cm/sec with a 400 W lamp, using only 100 ppm of Pt. Also, the inventors estimated the shelf life  
34  
35 of the formulations (100 ppm of Pt) by measuring the time required in the absence of light to show a  
36  
37 viscosity increase sufficient to interfere with free flow when shaken. This time was 24 – 48 h for  
38  
39 (methyl-Cp)trimethylplatinum(63)-based formulation, against 96 – 144 h for new synthesized  
40  
41 complexes (74 – 76).  
42  
43  
44  
45  
46  
47  
48  
49

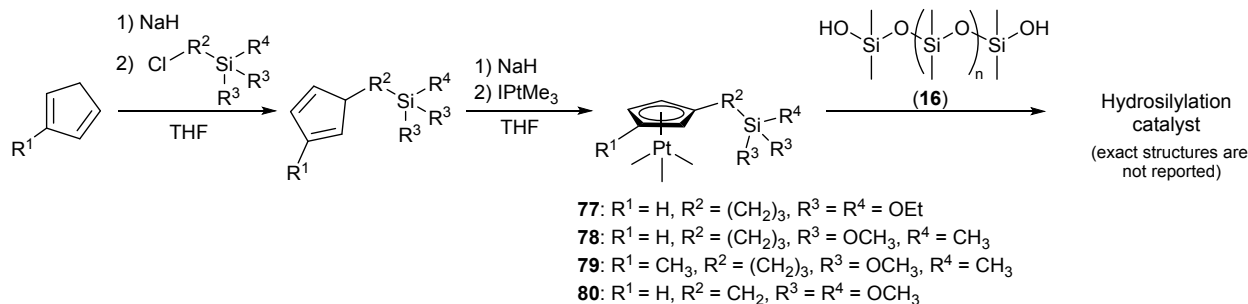
The GE Company also reported the synthesis of silicon-containing platinum complexes (**71** – **73**, Figure 9) and tested them as catalysts for photohydrosilylation<sup>46</sup>. First, they showed that the bath life (time of “viscosity increase sufficient to interfere with free flow when shaken”) of the formulations containing divinyl-PDMS (**1**), poly(dimethylsiloxane-co-methylhydrogenosiloxane) (**2**) and complexes **72** or **73** (96 h) was longer than the formulation with (methyl-Cp)trimethylplatinum (**63**) (24 – 48 h). The formulations with complexes **71** and **72** were used to treat Kraft paper under an exposition to a fluorescent light source. 1 h was required to obtain tack-free paper treated with the formulation of **71** and ‘only’ 26 min for the formulation with **72**. Both catalysts were more active in these conditions than (methyl-Cp)trimethylplatinum (**63**) that required > 24 h.

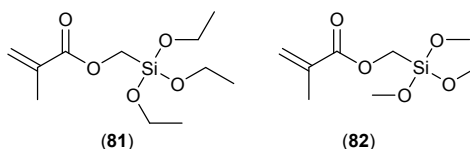


**Figure 14.** Synthesis of hydrosilylation catalyst linked to polymer chain reported by Wacker Chemie AG<sup>47</sup>.

Another modification of cyclopentadienyl-based Pt catalyst was patented by Wacker Chemie AG<sup>47</sup>. To decrease the volatility of Pt-catalyst that can be a problem during vacuum treatment of the formulation, the inventor suggested a synthesis of platinum complexes containing hydrolysable silyl

groups (**77** – **80**) for subsequent co-hydrolysis with dihydroxy-PDMS (**16**) (Figure 14). The obtained catalysts were tested in hydrosilylation crosslinking and demonstrated slightly higher activity under UV light (230 – 400 nm, 70 mW/cm<sup>2</sup>) than (methyl-Cp)trimethylplatinum (**63**).

### 3.4. Application of (methyl-Cp)trimethylplatinum (**63**)-based formulations.

Momentive Performance Materials GmbH disclosed the use of (methyl-Cp)trimethylplatinum (**63**)-based formulations for production of thick-walled silicone molding products or of thick-walled silicone coatings<sup>48</sup>. (XA) Flash lamp (xenon) (Blassing, Essen) (emission power of 34.9 J/individual flash at 12.5 Hz) was employed to conduct photo-hydrosilylation of the silicone oils filled (or not) with silica to obtain objects of up to 50 mm in thickness. The obtained materials had hardness between 20 and 60 Shore A depending on the formulation. One of the obtained samples was subjected to tensile test, giving an elongation at break of 670% and a tensile strength of 4.8 MPa. This work was followed by a patent application of Wacker Chemie AG<sup>49</sup> where they suggested similar formulations

1  
2 with the same catalyst (**63**), but they used only short UV irradiation (1 sec) to fix the shape of the  
3  
4  
5 resin and thermal curing at 140 °C (5 min) afterwards. The inventors explained that this method  
6  
7 improved the adhesion of the silicone to the support material. Also, it was demonstrated that adhesion  
8  
9 of such compositions to polybutylene terephthalate and polyamide could be improved by addition of  
10  
11  
12 alkoxy silanes, namely (triethoxysilyl)methyl methacrylate (**81**) or (trimethoxysilyl)methyl  
13  
14  
15 methacrylate (**82**) (Figure 15)<sup>50</sup>.

31  
32 Interestingly, (methyl-Cp)trimethylplatinum (**63**) was quite widely employed in silicone  
33  
34 formulations to produce transparent silicone resins that can be used in optical devices; solely in the  
35  
36 year 2021, five patent applications were published<sup>51-55</sup>. Also, the same catalyst was applied to light-  
37  
38 emitting-diode (LED) encapsulating materials<sup>56-58</sup>, in the latter case using a very low content of  
39  
40 (methyl-Cp)-trimethylplatinum (**63**) (5 ppm)<sup>58</sup>. To do so, Shin-Etsu Chemical Co., Ltd. used  
41  
42 photocuring only to fix the shape of the deposited resin before thermal curing, similarly to previously-  
43  
44 mentioned Wacker's patent<sup>49</sup>. The same company reported the use of zeolite as a filler for such  
45  
46 photoactive formulations<sup>59</sup>: the mixture containing 60 wt% of high silica zeolite HiSiv 3000 was  
47  
48  
49  
50  
51  
52  
53  
54  
55  
56  
57

1  
2 cured by a UV beam of 5 J/cm<sup>2</sup> to obtain a material with a hardness of 50 Shore A. It was also shown  
3  
4  
5 that thermal post-curing for 2 h at 200 °C could increase the hardness to 75 Shore A.

#### 9 **4. Photohydrosilylation with Pt $\beta$ -diketonates complexes.**

##### 11 *4.1. Pt bis( $\beta$ -diketonates)*

12  
13  
14  
15 The 3M Company reported in the nineties another type of photoactive catalyst (Pt(II)  $\beta$ -diketonates)  
16  
17 for silicone hydrosilylation reaction<sup>60,61</sup>. Pt(II) acetylacetonate (Pt(acac)<sub>2</sub>) (**83**) and its derivatives (**84**  
18  
19 - **86**) (Figure 16) were suggested as catalysts for photohydrosilylation and they were compared to  
20  
21 (Cp)trimethylplatinum (**62**) and (phenyldimethylsilyl-Cp)-trimethylplatinum (**69**) (see Figure 9). The  
22  
23 formulations containing divinyl-PDMS (**1**), poly(methylhydrogenosiloxane) (**15**) and various Pt-  
24  
25 complexes were tested for photo-curing under visible light source (“Visilux” 2 dental curing light,  
26  
27 (Cp)trimethylplatinum (**62**) and (phenyldimethylsilyl-Cp)-trimethylplatinum (**69**) (see Figure 9). The  
28  
29 formulations containing divinyl-PDMS (**1**), poly(methylhydrogenosiloxane) (**15**) and various Pt-  
30  
31 complexes were tested for photo-curing under visible light source (“Visilux” 2 dental curing light,  
32  
33 wavelength 400 – 500 nm). It was found that 50 ppm was the optimal Pt concentration in case of  
34  
35 Pt(acac)<sub>2</sub> (**83**); tack-free polymer could be obtained after 37 sec of exposure, while an increase of the  
36  
37 catalyst concentration up to 1000 ppm did not lead to faster curing (for the record, an increase of  
38  
39 concentration of cyclopentadienyl-containing complexes resulted in faster curing up to 1000 ppm of  
40  
41 Pt content<sup>60,61</sup>). In the presence of 50 ppm of Pt in the form of Pt(acac)<sub>2</sub> (**83**), cure depth could reach  
42  
43 6 cm after 120 sec of exposure. Photocuring with other  $\beta$ -diketonate complexes was performed under  
44  
45 similar conditions; Pt(II) benzoylacetonate (**84**) had very similar activity to Pt(acac)<sub>2</sub> (**83**), but the  
46  
47 other two catalysts (**85**, **86**) were less active and required about 2 times longer exposure to obtain  
48  
49  
50  
51  
52  
53  
54

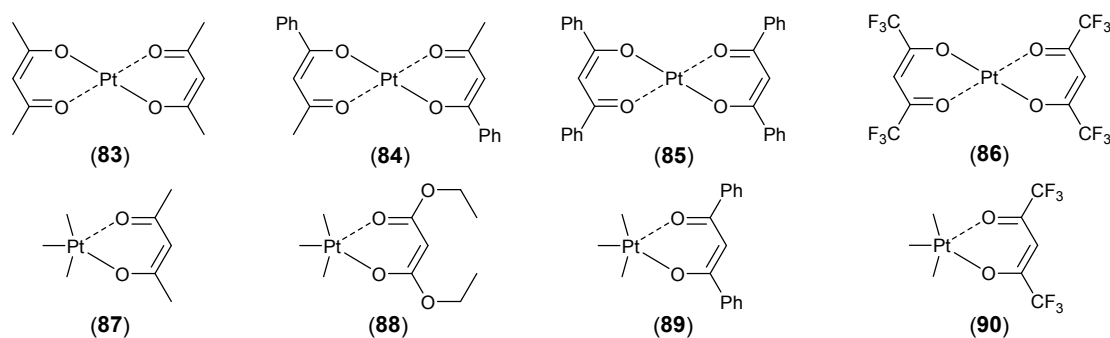

2 tack-free polymer. Also the formulations with Pt(acac)<sub>2</sub> (**83**) were tested under “Caulk-Hanovia” UV-  
3  
4  
5 light with maximum output at 366 nm. The catalyst was active in these conditions, but almost 6 times  
6  
7  
8 longer exposure was required than under the visible light. This result is surprising knowing that this  
9  
10  
11 catalyst absorbs well in UV region<sup>62</sup>; unfortunately, in the patent<sup>60</sup>, there is no information about the  
12  
13  
14 power of UV and visible light sources, which could explain the slower curing under UV light. The  
15  
16  
17 authors then present thorough tests of self-stability of described formulations at 4, 25 and 50 °C. It  
18  
19  
20 was found that Pt(acac)<sub>2</sub> (**83**) leads to more stable formulations than (Cp)trimethylplatinum (**62**). For  
21  
22  
23 instance, Pt(acac)<sub>2</sub> (**83**) formulation with 200 ppm of Pt content remained fluid for 24 – 48 hours at  
24  
25  
26 50 °C and more than 150 days at room temperature. The formulations with 990 ppm of Pt were stable  
27  
28  
29 at 4 and 25 °C for more than 200 days. Finally, they showed few examples of applications of such  
30  
31  
32 formulations with addition of up to 7.5% of fumed silica to produce silicone gaskets or a tyodont  
33  
34  
35  
36  
37  
38  
39  
40  
41  
42 dentition.

43  
44  
45 Shin-Etsu Chemical Co., Ltd. also demonstrated that hydrosilylation formulation containing  
46  
47  
48 Pt(acac)<sub>2</sub> (**83**) (5 ppm of platinum content) could be kept for 1 month at 40 °C and that the catalyst  
49  
50  
51 could be subsequently activated by UV light (50 sec, 100 mW/cm<sup>2</sup>) resulting in complete cure in  
52  
53  
54 1 hour<sup>41</sup>.

55  
56  
57 In an article, Sangermano *et al.* studied photohydrosilylation silicone curing catalyzed by Pt(acac)<sub>2</sub>  
58  
59  
60 (**83**) under UV-light (medium pressure mercury lamp (Italaquartz, Milano), 50 mW/cm<sup>2</sup>)<sup>63</sup>. In contrast

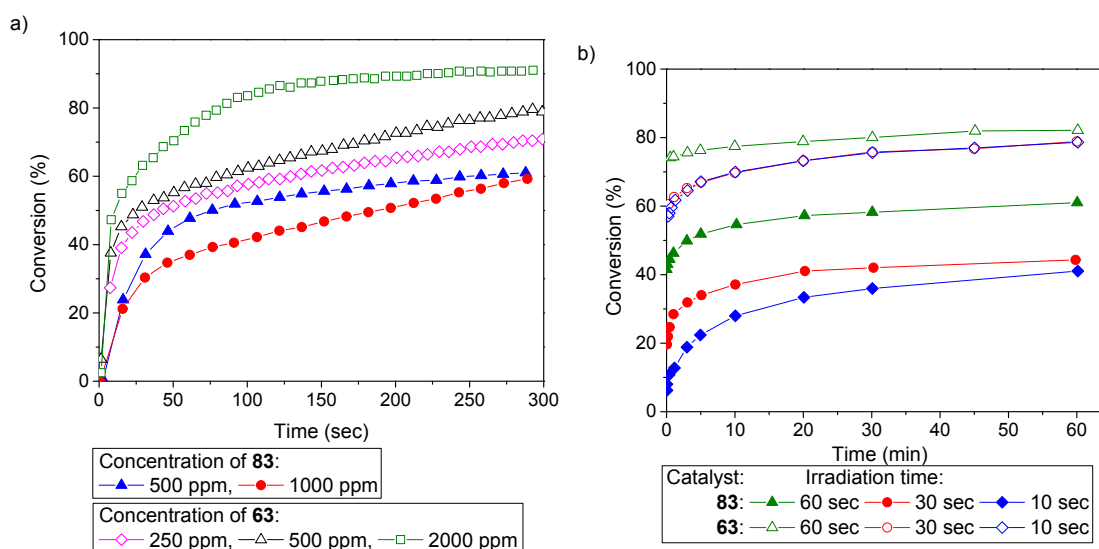
1  
2 to above described patent<sup>60</sup>, they worked with much higher catalyst concentrations (500 or 1000 ppm  
3  
4  
5  
6 corresponding to 250 and 500 ppm of Pt content, respectively) and longer exposure time (5 min).  
7  
8  
9 500 ppm of catalyst concentration was selected as an optimal one, because a higher concentration did  
10  
11  
12 not accelerate the curing (Figure 17a), and it was claimed that at lower catalyst content, it was not  
13  
14  
15 possible to obtain a fully cured tack-free sample. Layers of different thicknesses (1, 2, 3 and 4 cm)  
16  
17  
18 were cured for 5 min under a UV light, even the thickest sample cured full-depth. Nevertheless, IR  
19  
20  
21 analysis of the bottom side of the samples showed the presence of unreacted Si-H groups that  
22  
23  
24  
25  
26 increased with the depth of the sample.

48  
49 Besides, dark curing after short UV-irradiation was studied; it was found that after 10, 30 or 60 sec,  
50  
51  
52 the conversion of Si-H groups continued to increase for at least one hour (from 7, 20 and 40 % to 40,  
53  
54  
55 43 and 60 %, respectively) (Figure 17b). The authors explain this dark curing as well as deep curing  
56  
57  
58  
59 by the formation of less active colloidal platinum, however it is not clear how they came to this  
60

conclusion. The question of deep and dark curing was addressed in more details in a following paper of the same authors<sup>64</sup>. They found out that in these conditions (500 ppm of Pt(acac)<sub>2</sub>, 50 mW/cm<sup>2</sup>), curing can proceed via a thermal-frontal mechanism: the UV light activates the catalyst on the surface of the sample and the heat released by exothermal hydrosilylation generates a thermal front with the activation of the catalyst in the deeper layers of the formulations. A temperature of up to 85 °C was detected on the depth of 1 cm from the surface.

In the next work of the same research group, the authors compared the activity of Pt(acac)<sub>2</sub> (**83**) to (methyl-Cp)trimethylplatinum (**63**) as catalysts of UV-activated hydrosilylation<sup>65</sup>. It was shown that even in the presence of a 'low' concentration (250 ppm) of (methyl-Cp)trimethylplatinum (**63**),

1  
2 hydrosilylation occurs at higher rate than in the presence of Pt(acac)<sub>2</sub> (**83**) (500 ppm) (Figure 17a).  
3  
4  
5 Moreover, the reaction can be accelerated by increasing (methyl-Cp)trimethylplatinum (**63**) content  
6  
7  
8 to 500 or 2000 ppm (Figure 17a). It was shown that dark curing as well as thermal front reaction  
9  
10 occurred for each catalyst, but Cp-containing complex resulted in higher conversion during shot  
11  
12 exposure, leading to smaller conversion change in the dark (from 58 to 80% after 10 sec with  
13  
14  
15 1000 ppm of (methyl-Cp)trimethylplatinum (**63**)) (Figure 17b).  
16  
17  
18  
19  
20  
21

22 One more article compares this UV-activated process to thermal hydrosilylation in the presence of  
23  
24 Pt(acac)<sub>2</sub> (**83**)<sup>66</sup>. The thermally-induced reaction was much slower and required 3 h at 150 °C to reach  
25  
26 83% of conversion in comparison to less than 5 min under UV-light. TGA of thermally and photo-  
27  
28 cured samples showed that they had similar stability with main decomposition around 400 °C, but,  
29  
30 more interestingly, the final residue at 800 °C was around 20 – 30 % for both samples, indicating that  
31  
32 this catalyst did not (or not efficiently) catalyze ceramization of silicone at high temperature, in  
33  
34 contrast to Cp-based system described above (Section 3.2)<sup>42,44</sup>. To complete the picture, it is worth  
35  
36 mentioning that in 1993, Yang developed a method to follow the reaction of photohydrosilylation by  
37  
38 IR spectroscopy<sup>67</sup> and this (or similar) method was employed by Sangermano's team in reviewed-  
39  
40 above works, but the catalyst used in this work was not mentioned.  
41  
42  
43  
44  
45  
46

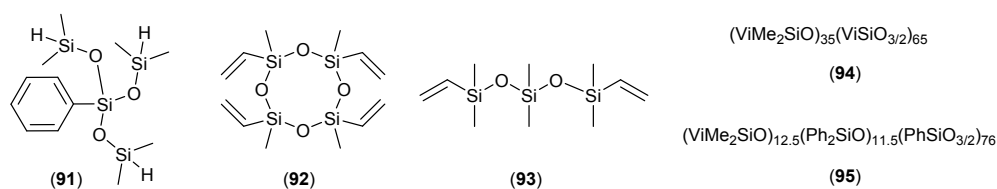
54  
55 Quite recently, a full study describing simple molecules engaged in photohydrosilylation with  
56  
57 Pt(acac)<sub>2</sub> (**83**) under UV-light (Dymax UV curing chamber with a UV bulb part number of 38560,  
58  
59  
60

1  
2 wavelength from 380 nm to visible light, intensity 350 mJ/cm<sup>2</sup>) was reported in a patent published by  
3  
4  
5 Dow Corning Corporation (Table 2)<sup>68</sup>. An interesting finding is that reactive groups in vinyl-based  
6  
7  
8 molecules must be separated by at least 4 atoms, otherwise, the molecules with close positions of  
9  
10 vinyl-groups require extended exposure time or do not cure (Examples 1, 2, 3 and 8 in Table 2). This  
11  
12 phenomenon was explained in the patent by “undesirable complexing with the photoactivated  
13  
14 hydrosilylation catalyst”. Apart from this, there is no explanation of the choice of the reagents. It can  
15  
16 be noticed that the inventors used several low-molecular compounds, one linear oligomer as H-Si  
17  
18 reactant (Examples 8 – 15 in Table 2) and one branched oligomer as vinyl reactant (Example 4 in  
19  
20 Table 2). It is worth noting that in some cases the curing required less than 10 sec (Examples 4, 7, 12  
21  
22 – 15 in Table 2) and in certain examples even at low concentration of catalyst (Examples 14, 15 in  
23  
24 Table 2). The formulations 13 and 15 from the Table 2, were also reprocessed by adding silica  
25  
26 (diameter of 50 μm) and 2 cm thick layers were subjected to 9 sec of UV-exposure followed by 10 sec  
27  
28 delay, after which the entire thickness of the samples was solidified. Unfortunately, exact  
29  
30 compositions of these formulations are not clear; for the first one the silica content is declared to be  
31  
32 70%, which is much higher than commonly used values, whereas silica content in the second one was  
33  
34 not mentioned at all.  
35

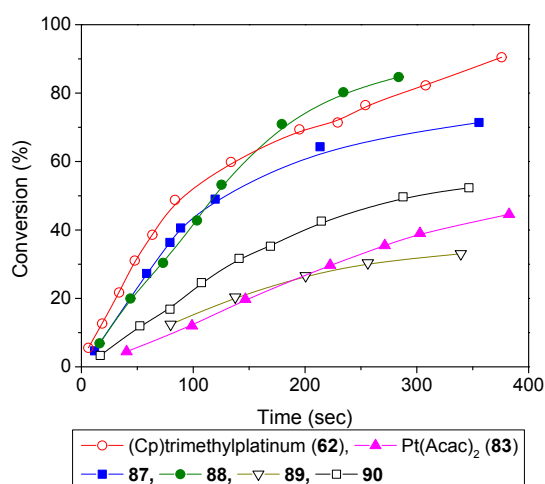

#### 4.2. Pt mono( $\beta$ -diketonates).

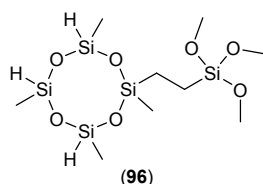
Four other platinum complexes with  $\beta$ -diketonate single ligands (**87** – **90**, Figure 16) were synthesized and studied in photohydrosilylation reaction<sup>69,70</sup>. The kinetics of crosslinking reaction between divinyl-PDMS (**1**) and poly(dimethylsiloxane-co-methylhydrogenosiloxane) (**2**) were studied and activities of the complexes were compared to Pt(acac)<sub>2</sub> (**83**) and (Cp)trimethylplatinum (**62**) (Figure 19). Irradiation was performed using an air-cooled HPK125W medium-pressure mercury lamp whose emission was filtered by a water-containing quartz cell and a Pyrex glass plate (wavelength range not given). It was found that the activity of the complexes with methyl (**87**) and ethoxy (**88**) groups were close to (Cp)trimethylplatinum (**62**), while the other two catalysts (**89**, **90**) were less active and closer to Pt(acac)<sub>2</sub> (**83**).

#### 4.3. Applications of Pt $\beta$ -diketonates formulations.

1  
2 An interesting application of Pt(acac)<sub>2</sub> (**83**) was patented by Shin-Etsu Chemical Co., Ltd.<sup>71</sup>. They  
3  
4  
5 prepared adhesive photocurable compositions to be used in the production of Fresnel lenses with a  
6  
7  
8 glass substrate for concentrator solar power systems. Similarly to the described above systems,  
9  
10  
11  
12 divinyl-PDMS (**1**), bis(trivinylsilyl)-polydimethylsiloxane (**12**), poly(methylhydrogenosiloxane) (**15**)  
13  
14  
15 (see Figures 2 and 5) were used. To promote the adhesion of the resins, one of two alkoxy-containing  
16  
17  
18 siloxanes (**17** or **96**, Figures 5 and 20) was employed. With Pt content around 30 ppm, the curing time  
19  
20  
21 was only 0.8 sec, but most probably this short exposure activated the catalyst that remained active  
22  
23  
24 after the exposure and dark curing took place (hardness was measured after 5 or 48 h). The higher  
25  
26  
27 crosslinking speed in comparison to previously described Pt(acac)<sub>2</sub>-based system<sup>60</sup> can be explained  
28  
29  
30 either by the reactivity of used components or by the employed UV source. Here the authors did not  
31  
32  
33 provide the wavelength of the UV radiation nor the commercial name of the lamp, only intensity of  
34  
35  
36 250 mW/cm<sup>2</sup> was reported. The hardness of obtained materials was measured by Type A Durometer  
37  
38  
39 according to JIS K-6253 5 hours and 2 days after curing. The values were between 19 and 52 after 5  
40  
41  
42 hours and increased to 37 – 58 after 2 days.  
43

2 Recently, it was demonstrated that that Pt(acac)<sub>2</sub> (**83**)-based silicone composition can be filled with  
3  
4  
5  
6 zeolite to obtain ethylene absorbing material,<sup>72</sup> while filling with aluminum powder allowed to obtain  
7  
8  
9 thermally conductive grease<sup>73–75.a</sup>. Similarly to (methyl-Cp)trimethylplatinum (**63**) the catalysts **83**  
10  
11  
12 and **86** found applications in silicone formulations used for encapsulating LEDs<sup>57,76,77</sup>.

### 15 16 **5. Pt-catalyzed hydrosilylation in the presence of radical photoinitiators.**

17  
18  
19 In contrast to the described above systems using photoactive catalyst, the GE Company disclosed  
20  
21  
22 a method to cure silicone by hydrosilylation under UV-light using a free-radical-type photoinitiator  
23  
24  
25 and a Pt-based catalyst generally used in thermally-activated hydrosilylation<sup>78</sup>. The inventor explains  
26  
27  
28 that the radical photoinitiator first crosslink the surface and then Pt catalyst allows finishing the  
29  
30  
31 hydrosilylation at room or hot temperature. Polysiloxane chains containing methyl-hydrogenosiloxy,  
32  
33  
34 methyl-vinylsiloxy, and dimethylsiloxy units were cured in the presence of “platinum-octyl alcohol  
35  
36  
37 complex” (Pt content 2 – 3 ppm) as hydrosilylation catalyst, 4.5 % of *t*-butylperbenzoate (**5**) (Figure  
38  
39  
40  
41  
42  
43

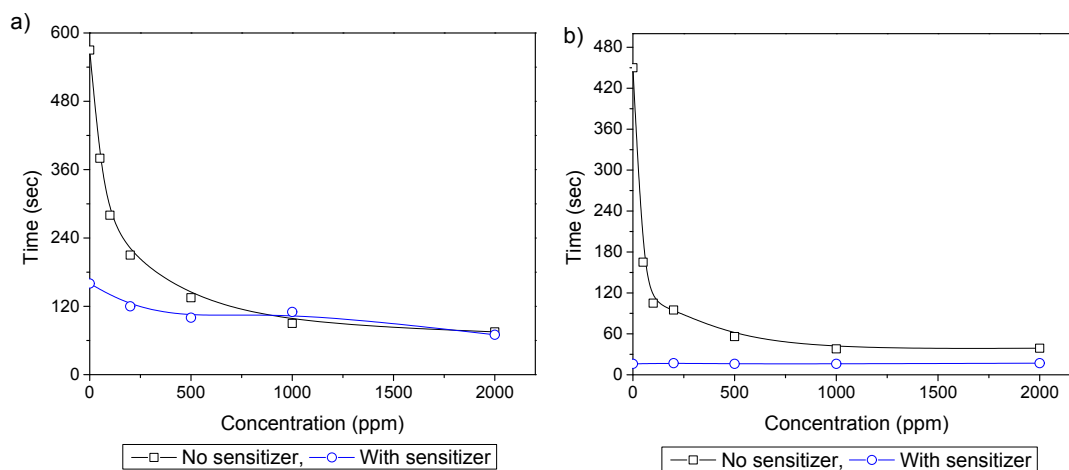

2 complex were reported). It was found that a layer thickness of up to 0.1 mm could be completely  
3  
4  
5 cured at a UV lamp power of 400 W and conveyor line speed of up to 50 cm/sec. UV exposure of a  
6  
7  
8 thicker layer (0.2 mm) resulted in “soft” cure or, in other words, a cure confined to the surface, but  
9  
10  
11  
12 after 17 hours at room temperature, the sample was completely cured. This result can be compared to  
13  
14  
15 the one described above (Section 3.3) and more recently patented system with Cp-based photoactive  
16  
17  
18 catalyst (**74**)<sup>45</sup>: much higher Pt-content (100 ppm) was required under the same UV exposure even if  
19  
20  
21  
22 newly synthesized catalyst (**74**) allowed to double the conveyor line speed (100 cm/sec).  
23  
24

25  
26 Whereas the GE Company used radical photoinitiators to activate an otherwise non-photoactive  
27  
28  
29 system, the 3M Company applied radical initiators to accelerate an already-photoactive systems<sup>31</sup>.  
30  
31

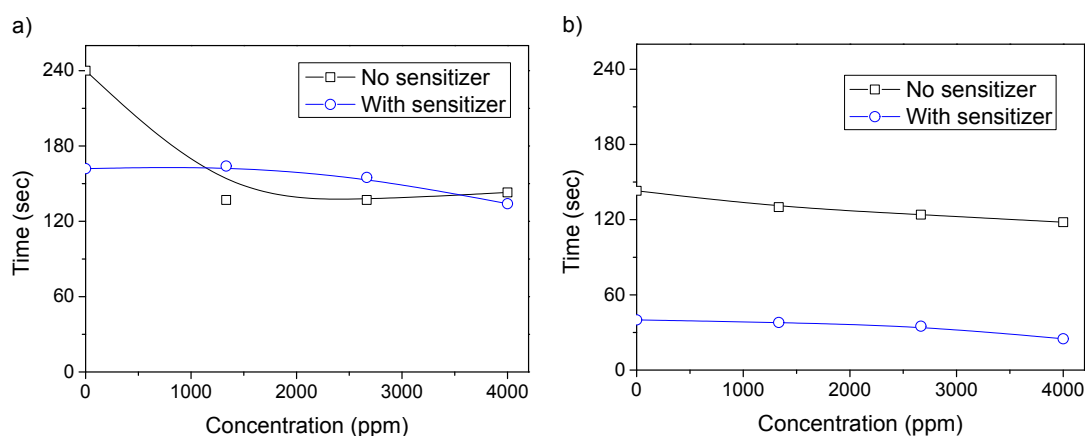
32  
33 The catalytic activity of four of COD-Pt complexes (di(4-methylphenyl)-Pt(COD) (**42**), di(4-  
34  
35 trifluoromethylphenyl)-Pt(COD) (**51**), di(4-methoxyphenyl)-Pt(COD) (**53**) and di(4-  
36  
37 trimethylsilylphenyl)-Pt(COD)) (**58**) (Figure 7) (200 ppm Pt content) in the presence of radical  
38  
39 photoinitiators (**6 – 9**, Figure 4) was studied. In contrast to the sensitizer study<sup>29</sup>, all tested radical  
40  
41  
42  
43 initiators (apart from one exception: di(4-trimethylsilylphenyl)-Pt(COD)) (**58**) with Darocur 1173 (**7**)  
44  
45  
46 under visible light) accelerated the curing with all four catalysts under UV (“black” light, 365 nm)  
47  
48  
49 and visible light (“Visilux” 2 dental curing light, 400 – 500 nm) systems. Irgacure 651 (**8**) was the  
50  
51  
52  
53 most effective whatever the considered catalyst. The influence of its concentration in curing was  
54  
55  
56  
57  
58  
59 studied in an example with di(4-methoxyphenyl)-Pt(COD) (**53**) catalyst (Figure 21). It was found that  
60

1  
2 under UV light, required cure time decreased when Irgacure 651 (**8**) content was increased at least to  
3  
4  
5 2000 ppm (Figure 21a), but under visible light the minimum cure time was at 1000 ppm, and further  
6  
7  
8 increase of **8** concentration did not influence the reaction time (Figure 21b). Also, the influence of  
9  
10  
11 Irgacure 651 (**8**) was studied in the presence of a photosensitizer (2-chlorothioxanthone) (**22**) (Figure  
12  
13  
14  
15  
16 21). Interestingly, in this case, Irgacure 651 (**8**) did not influence so drastically the cure time under  
17  
18  
19 UV-light and did not accelerate the reaction under visible light at all. The inventors did not explain  
20  
21  
22 such findings, nor did they provide any evidence that it acts as a radical initiator as well. It could be  
23  
24  
25 suggested that in these conditions, the aromatic ketones play the role of photosensitizers (as in the  
26  
27  
28 patent<sup>27</sup>, see section 3a and 3b) so that in the presence of a more active sensitizer, its contribution is  
29  
30  
31 less noticeable.

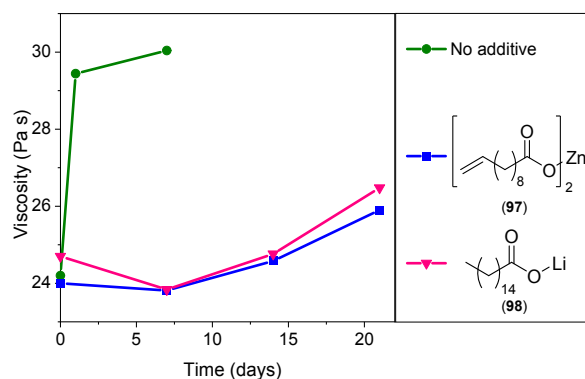
**Figure 22.** Influence of Darocur 1173 (**7**) concentration on the required cure time without and with 1000 ppm of 2-chlorothioxanthone (**22**) as a photosensitizer under UV (a) and visible (b) light<sup>79</sup>.

The 3M Company also tested the influence of radical photoinitiators on silicone hydrosilylation curing catalyzed by (methyl-Cp)trimethylplatinum (**63**)<sup>79</sup>. They tested Irgacure 651 (**8**), Irgacure 184 (**6**), Darocur 1173 (**7**), Darocur 1116 (**9**) in the presence of 960 ppm of Pt-catalyst and found that all tested compounds accelerated the curing. Darocur 1173 (**7**) was selected to study the influence of its concentration on cure time with and without a photosensitizer (**22**) (Figure 22). It did not accelerate the curing, except under UV-light at low concentration in the absence of sensitizer. Same as in previously described system<sup>31</sup>, the role of the added aromatic ketones was not explained.

## 6. Increase of shelf life of photoactive hydrosilylation formulations.

### 6.1. Photoactive formulations without inhibitor.

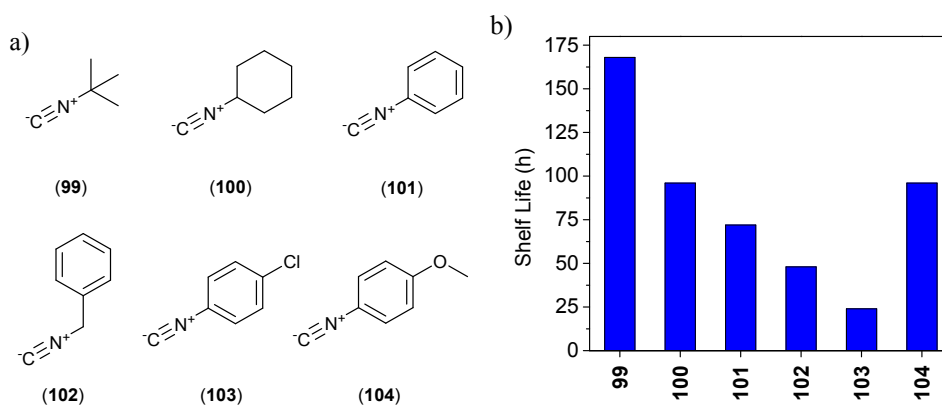
While studying the stability of photohydrosilylation mixtures, researchers from Wacker Chemie AG found out that silicone formulations for hydrosilylation might contain strong protic acid

1  
2 impurities ( $pK_a < 2.5$ ) coming from PDMS synthesis (acidic catalyst is used) or from fumed silica  
3  
4  
5  
6 (chlorosilanes generate hydrogen chloride).<sup>80</sup> In the patent, it was demonstrated, using model  
7  
8  
9 compounds, that after the removal of this trace amount (1 – 10 ppm) of strong protic acids by thorough  
10  
11  
12 purification, the stability of hydrosilylation formulation increased. Complete removal of traces of  
13  
14  
15 strong acids may be too difficult in case of polymeric formulations; as a simpler solution, it was  
16  
17  
18 shown that some salts of fatty acids (**97**, **98**, Figure 23) can trap free protons and improve the stability  
19  
20  
21 of (methyl-Cp)trimethylplatinum (**63**)-based photohydrosilylation compositions (Figure 23). More  
22  
23  
24 importantly, the formulations with such additives could be crosslinked by UV light (exact conditions  
25  
26 were not provided) after 8 weeks of storage, while the base composition could not be completely  
27  
28  
29 cured by means of UV irradiation after 7 days of storage.

54 palmitate (**98**) (282 ppm)<sup>80</sup>.

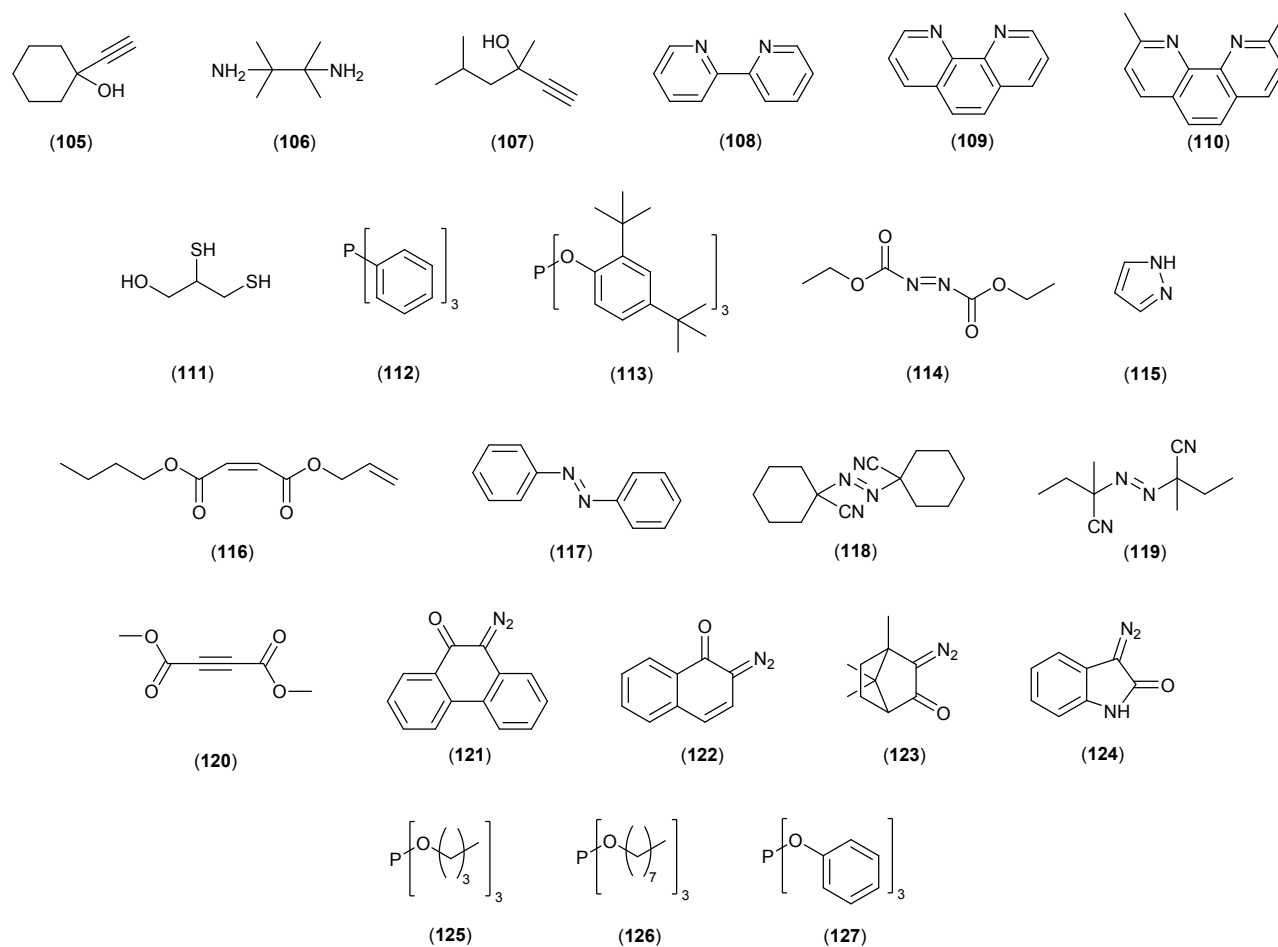
1  
2 Three Bond Company suggested using isocyanide “inhibitors” (**99** – **104**, Figure 24a) to improve  
3  
4  
5 the shelf life of Pt-catalyzed photocuring silicones<sup>81</sup>. They described the synthesis procedure to  
6  
7  
8 introduce these isocyanide molecules into new complexes and test them in photo-curing. The  
9  
10  
11 complexes were synthesized from potassium hexachloroplatinate(IV) ( $K_2PtCl_6$ ) and one of the  
12  
13  
14 following isocyanides: *t*-butyl isocyanide (**99**), cyclohexyl isocyanide (**100**), phenyl isocyanide (**101**),  
15  
16  
17 benzyl isocyanide (**102**), 4-chloro-phenyl isocyanide (**103**) or 4-methoxy-phenyl isocyanide (**104**).  
18  
19  
20 The complexes were separated from the reaction mixtures, purified by recrystallization from ethanol,  
21  
22  
23 and analyzed by IR spectrometry. Unfortunately, the structures of the obtained catalysts were not  
24  
25  
26 presented. The activity of the synthesized complexes was tested with divinyl-terminated PDMS  
27  
28  
29 (molar mass of 60 kg/mol) and Si-H functionalized oligomers (molar mass of 2000 g/mol) at 30 ppm  
30  
31  
32 of catalyst content. 10 g of each formulation was subjected to 2 J of UV exposure. It was found that  
33  
34  
35 all catalysts are active in these conditions, but only the complexes with aliphatic isocyanides (**99**,  
36  
37  
38  
39 **100**) resulted in materials fully insoluble in toluene. The samples obtained with aromatic ligands (**101**  
40  
41  
42  
43 – **104**) contained from 45 to 75 % of toluene insoluble fraction. The stability of the formulations was  
44  
45  
46 tested at 50 °C and it was found that those containing isocyanides with aliphatic ligands (**99**, **100**) and  
47  
48  
49 with 4-methoxy-phenyl group (**104**) had the longest shelf life (Figure 24b).  
50  
51  
52  
53

### 6.2. Photoactive formulations containing an inhibitor.

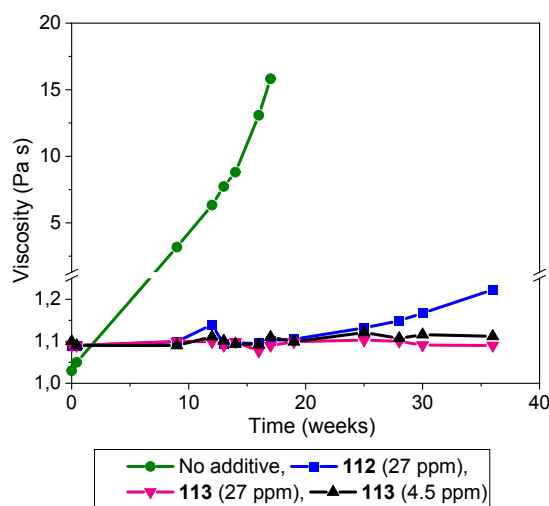


**Figure 25.** Inhibitors of hydrosilylation employed in photo-curing silicone formulations.

Shin-Etsu Chemical Co., Ltd. studied hydrosilylation reaction by photoactive catalysts in the presence of inhibitors (**105**, **106**, Figure 25) in order to develop low-crosslink-density silicone gels for damping materials<sup>32</sup>. The following catalytic systems were employed (catalyst/inhibitor): Pt(acac)<sub>2</sub> (**83**) (400 ppm)/1-ethynylcyclohexanol (**105**) (500 ppm), Pt(acac)<sub>2</sub> (**83**) (400 ppm)/tetramethylethylenediamine (**106**) (8 ppm), Me<sub>2</sub>Pt(COD) (**61**) (400 ppm)/ 1-ethynylcyclohexanol (**105**) (500 ppm). The shelf life of these compositions was not studied, but it was demonstrated that without UV light, they did not crosslink after 30 min, even at 120 °C. On the contrary, 400 seconds of UV exposure (100 mW/cm<sup>2</sup>) was enough to crosslink these formulations. Recently, Elantas Beck GmbH patented similar photohydrosilylation formulations with (methyl-Cp)trimethylplatinum (**63**) (30 ppm) and 1-ethynylcyclohexanol (**105**) or 3,5-dimethyl-1-hexyn-3-ol (**107**) (19 ppm)<sup>82</sup>. Such formulations had a shelf life at room temperature of more than 3 months.

Another attempt to improve the shelf life of photoactive hydrosilylation compositions was published by Wacker Chemie AG<sup>83</sup>. They suggested using bidentate ligands (108 – 111, Figure 25) with cyclopentadienyl-based Pt complexes as catalysts; unfortunately, the structures of most of them are unclear, because only ambiguous names were provided. The shelf life of studied mixtures was several days without inhibitors and more than 8 months in the presence of bidentate inhibitors (108 – 111). Gelling time of these formulations was determined as the time required to double the dynamic starting viscosity after 10 sec of UV exposure (70 mW/cm<sup>2</sup>). These values were between 20 and



40 sec for inhibitor-free systems and almost did not change with the addition of the inhibitor. The same company also patented some hydrosilylation formulations containing triphenylphosphine (**112**) or tris(2,4-di-tert-butylphenyl)phosphite (**113**) as inhibitors to increase the shelf life of the mixtures<sup>84</sup>. SiH- and vinyl containing silicone mixture (SEMICOSIL® 912 by Wacker Chemie AG) was mixed with (methyl-Cp)trimethylplatinum (**63**) (30 ppm of Pt content) and the evolution of viscosity was studied with and without inhibitors (Figure 26). In the presence of organophosphorus inhibitors, the viscosity did not evolved significantly after 36 weeks, while inhibitor-free composition crosslinked after 19 weeks. It was shown that such formulations can crosslink in 11 – 13 min after short exposure to UV light (60 sec, 6 mW, 320-500 nm), but photoactivity after prolonged shelf time was not tested.

### 6.3. Karstedt's-catalyst-based formulations.

#### 6.3.1. Diethyl azodicarboxylate (DEADC) as a photoactive inhibitor.

As an alternative to photosensitive catalysts, it was proposed that room-temperature active catalyst paired with photosensitive inhibitors could be used to achieve light-induced hydrosilylation. To our knowledge, the first example of such process was reported by the GE Company<sup>85</sup>. They prepared silicone formulations containing 90 ppm of Pt in the form of Karstedt's catalyst and 900 or 1800 ppm of diethyl azodicarboxylate (DEADC, **114**, Figure 25) and studied their photohydrosilylation under UV light (Hanovia medium pressure UV lamp, 300 W/in). It was found that in the presence of 1800 ppm of the inhibitor, 3.15 J/cm<sup>2</sup> of UV exposure is required to obtain smear-free film on Al-support. At lower inhibitor concentration (900 ppm), the required exposure is reduced to 2.5 J/cm<sup>2</sup>. Also, shelf life was measured for these formulations at 25 °C under "normal room lightning conditions", the value obtained were >6 h and >4 h for 1800 ppm and 900 ppm of DEADC, respectively. Interestingly, benzophenone (**40**, Figure 6) was tested as a potential photosensitizer, but it only slowed down the curing and slightly increased the shelf life of the formulation. The increase of Pt concentration to 135 ppm did not accelerate the curing, but reduced the shelf life to 2.5 h. Several experiments were performed at a lower Pt concentration (around 18 ppm); higher dose of UV light was required for curing (7.2 J/cm<sup>2</sup>), but even at much lower DEADC concentration (around 450 ppm), the shelf life was >30 h. Note that several other compounds happened to be unsuitable as

1  
2 photosensitive inhibitor: pyrazole (115) (900 ppm) and butylallylmaleate (116) (1800 ppm)  
3  
4  
5 completely prevented the curing even after elevated dose of UV exposure (8 – 10 J/cm<sup>2</sup>), while  
6  
7  
8 azobenzene (117) (1800 ppm), 1,1'-azobis(cyanocyclohexane) (118 (900 ppm) and 2,2'-azobis(2-  
9  
10 methylbutyronitrile) (119) (900 ppm) were not efficient enough, the shelf life of formulations  
11  
12  
13 containing them being less than 10 min.  
14  
15  
16  
17  
18

19 DEADC was also studied by Cavezzan *et al* as an inhibitor of hydrosilylation.<sup>86</sup> Silicone  
20  
21 formulations containing Karstedt's catalyst (60 ppm Pt content) and from 800 to 3000 ppm of  
22  
23 DEADC were subjected to thermal curing (100 °C) with or without preliminary UV treatment  
24  
25  
26 (0.2 sec, Philips type HOK6 UV lamp, linear density 8 kW/m). It was found that at the lowest DEADC  
27  
28  
29 concentration, the curing time could be reduced from 15 to 10 sec by preliminary UV treatment, and  
30  
31  
32 at the maximum concentration, the effect was even more pronounced (from 100 to 15 sec). To explain  
33  
34  
35 the role of the azo compound, the inventors showed by <sup>195</sup>Pt NMR spectroscopy that DEADC forms  
36  
37  
38 a paramagnetic complex with platinum that becomes diamagnetic after UV irradiation, consequently  
39  
40  
41 the platinum is activated and DEADC converted to corresponding hydrazine. More interestingly, in  
42  
43  
44 the range of tested DEADC concentrations (800 – 3000 ppm), the shelf life at 20 °C increased from  
45  
46  
47 6 h to >30 days. The same inventor demonstrated the application of similar hydrosilylation  
48  
49  
50 formulations with DEADC to produce photoresists<sup>87</sup>. The silicone mixture containing 50 ppm of Pt  
51  
52  
53 in form of Karstedt's catalyst and 400 ppm of DEADC was spread on monocrystalline silicon and a  
54  
55  
56  
57  
58  
59  
60

1  
2 part of the surface was protected with a cover opaque to UV irradiation. Then, the film was exposed  
3  
4  
5 to UV irradiation (Tamarack Scientific Inc. instrument, model PRX 350-4, fitted with a 350W, HBO  
6  
7  
8 type mercury lamp) for 5 min followed by development in toluene for 5 to 10 sec. Adherent  
9  
10  
11 polysiloxane film remained on the irradiated region, while no trace of silicone material could be  
12  
13  
14  
15 detected in the unexposed region.

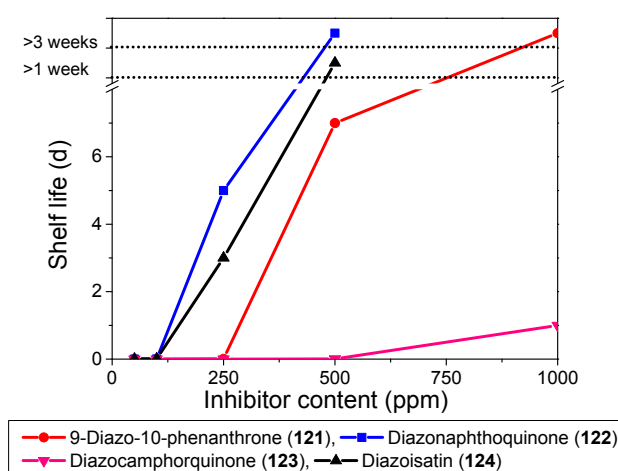
### 18 19 *6.3.1. Other photoactive inhibitors.* 20

21  
22 The GE Company suggested to use dimethylacetylenedicarboxylate (DIMAC, **120**, Figure 25) as  
23  
24  
25 an inhibitor of silicone hydrosilylation that is deactivated by UV light<sup>88</sup>. They did not explain the  
26  
27  
28 exact role of DIMAC in promoting inhibition. We can suppose that this molecule serves as a ligand  
29  
30  
31 of Pt to generate complexes<sup>89</sup> not active in hydrosilylation. Whereas, UV-exposure could promote  
32  
33  
34 either isomerization of the complex<sup>89</sup> or 2+2 photocycloaddition<sup>90</sup> to release the active Pt catalyst. It  
35  
36  
37 was shown that a formulation of divinyl-PDMS (**1**) with poly(methylhydrogenosiloxane) (**15**)  
38  
39  
40 containing Karstedt's catalyst (25 ppm of Pt content) and 1000 ppm of DIMAC (**120**) could be cured  
41  
42  
43 to smear-free coating by exposure to 1.5 – 4.5 J/cm<sup>2</sup> (depending on the substrate).<sup>88</sup> To verify that the  
44  
45  
46 reaction was actually induced by UV light and not by the heat produced by the UV lamp, they tested  
47  
48  
49 the curing under a less powerful lamp (UV Products, Inc. table top lamp, 115 V, 0.35 A. 6 J/(cm<sup>2</sup>·h))  
50  
51  
52  
53 under temperature control. 2.5 h was required to obtain smear-free surface, while the temperature of  
54  
55  
56 the sample did not change during the exposure (24 °C), confirming photo-activation rather than  
57  
58  
59  
60

1  
2 thermal curing. To test the shelf life of the studied formulation, the change of viscosity with time was  
3  
4  
5 studied at 25 and at 4 °C. It was shown that in both cases, the viscosity started to increase after 1 h,  
6  
7  
8 and went from 624 to 9000 mPa·s after 24 h of storage at 25 °C. At 4 °C, the viscosity increase was  
9  
10  
11 less noticeable, i.e. from 760 to 1240 mPa·s in 24 h. These results indicate that DIMAC (**120**) does  
12  
13  
14 not completely inhibit hydrosilylation, but only slows down the reaction. Another patent<sup>91</sup> is claimed  
15  
16  
17 to be a continuation of this research, but to our understanding, it does not contain any new  
18  
19  
20  
21  
22 information.  
23  
24

25  
26 Wacker Chemie AG reported the use of  $\alpha$ -diazoketones (**121** – **124**, Figure 25) as photoactive  
27  
28 inhibitors for hydrosilylation catalysts<sup>92</sup>. The mixtures containing divinyl-PDMS (**1**),  
29  
30 poly(dimethylsiloxane-co-methyl-hydrogenosiloxane) (**2**), hydrophobic silica (20%) and Karstedt's  
31  
32 catalyst (30 ppm of Pt content) were used to test the shelf life of photohydrosilylation mixtures in the  
33  
34

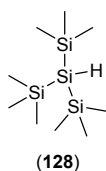


**Figure 27.** Shelf life dependence of inhibitor content for hydrosilylation formulations containing 30 ppm of Pt in form of Karstedt's catalyst. (Exact values were not reported for “>1 week” and “>3 weeks”)<sup>92</sup>. Lines are only guides for the eyes.

35 presence of these inhibitors (Figure 27). Studied  $\alpha$ -diazoketones showed different influence on the  
36  
37  
38 shelf life: the least active diazocamphorquinone (**123**) could extend the shelf life only to 1 day even  
39  
40  
41 at its highest tested content (1000 ppm), while with the most active diazonaphthoquinone (**122**), a  
42  
43  
44 shelf life of more than 3 weeks was achieved. It was also shown that formulations containing 500  
45  
46  
47 ppm of inhibitors **121**, **122** or **124** could be crosslinked by exposure to UV light (365 nm, 250mW)  
48  
49  
50 during 30 minutes after 1 to 15 days of storage. <sup>1</sup>H NMR analyses of a mixture containing Karstedt's  
51  
52  
53 catalyst and 9-diazophenanthrone (**121**) showed that this diazo-compound substituted olefin ligands  
54  
55  
56  
57  
58  
59  
60

in Pt-complex, this can explain the inhibiting effect of this molecule. Unfortunately, the inventors did not provide any information about the mechanism of photodeactivation of the inhibitor. It can be suggested that exposure to UV-light resulted in photolysis of diazo compound by releasing the  $N_2$  and Wolff rearrangement<sup>93-95</sup> producing substances that are no longer active inhibitors of Pt-catalyst.

Shin-Etsu Chemical Co., Ltd. reported the use of trialkylphosphites (125 – 127, Figure 25) in combination with Karstedt's catalyst to conduct hydrosilylation under UV light (high pressure mercury lamp, 100 mW/cm<sup>2</sup>, 365 nm)<sup>96</sup>. The inventors prepared mixtures of divinyl-PDMS (1) and poly(dimethylsiloxane-co-methylhydrogenosiloxane) (2) in the presence of 15 ppm of Pt. The longest shelf life (400 h) was achieved with 37 ppm of tributyl phosphite (125) while trioctyl phosphite (126)

1  
2 (62 ppm) and triphenyl phosphite (**127**) (47 ppm) resulted in slightly shorter shelf life (~350 h). The  
3  
4  
5 formulations with **125** or **127** required 1.5 J/cm<sup>2</sup> (15 sec) of exposure to get completely cured, the  
6  
7  
8 mixture with **126** was slightly less active and required 2.0 J/cm<sup>2</sup> (20 sec) of exposure. Later Shin-  
9  
10 Etsu Chemical Co., Ltd. suggested to use radical photoinitiators (**6**, **7**, **11**, Figure 4) in such  
11  
12 formulations to oxidize tributyl phosphite (**125**) and re-activate platinum catalyst<sup>97,98</sup>. Surprisingly,  
13  
14  
15 the example testing the formulation without any photoinitiator required less exposure (1.5 J/cm<sup>2</sup>) than  
16  
17  
18 formulations with **6**, **7** or **11** (2.0 J/cm<sup>2</sup>) to get the same depth of curing (2 mm).  
19  
20  
21  
22  
23  
24

25  
26 Recently, Bluestar Silicones France SAS patented a photoactivatable inhibiting system for silicone  
27  
28 hydrosilylation curing<sup>99</sup>. They used Karstedt's catalyst (~ 60 ppm of Pt) and 1-ethynyl-1-  
29  
30 cyclohexanol (**105**) as an inhibitor. It was shown that in the presence of 570 ppm of the inhibitor, the  
31  
32 shelf life of the formulation was 25 h, while under the UV light (mercury lamp, 5.6 W/cm<sup>2</sup>), the resin  
33  
34  
35 cured in 24 minutes. It was also found that the curing could be accelerated by adding a radical  
36  
37

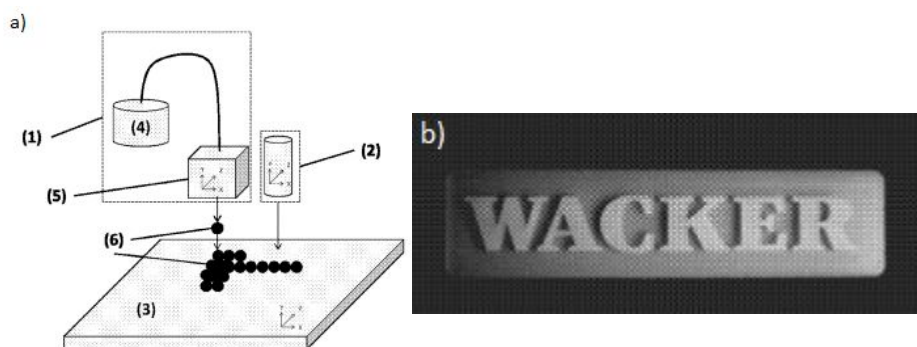
**Figure 28.** Tris(trimethylsilyl)silane employed by Bluestar Silicones France SAS to accelerate hydrosilylation silicone curing<sup>99</sup>.

38 photoinitiator and tris(trimethylsilyl)silane (**128**) (Figure 28). The best result was obtained using  
39  
40  
41 205 ppm of Omnirad 102 (**10**, Figure 4) and 3.6 ppm of tris(trimethylsilyl)silane (**128**), the curing  
42  
43  
44 time was reduced to 11 minutes, but shelf life was slightly shorter as well (19 h). The authors claim  
45  
46  
47 that the inhibitor, the photoinitiator and tris(trimethylsilyl)silane (**128**) have synergistic effect  
48  
49  
50 allowing a good inhibition that can be suppressed by UV light, but they did not provide an explanation  
51  
52  
53  
54  
55  
56  
57  
58  
59 about the role of each component of the system.

## 7. Photohydrosilylation in 3D printing

One of the very topical application of photo-induced crosslinking is 3D printing<sup>100</sup>. The first mentioning of photohydrosilylation for 3D printing is granted to Dow Corning Corporation<sup>68</sup>. They suggested the described-above formulations based on Pt(acac)<sub>2</sub> (**83**) (Section 4.1, Table 2) for 3D printing by several methods requiring photocurable resin (binder jetting, material extrusion, material jetting, stereolithography); here however, examples of actual 3D printing were not provided. Wacker Chemie AG patented 3D printing of silicone elastomer articles by depositing droplets of curable silicone following by UV or IR irradiation (Figure 29a)<sup>101</sup>. They used formulations containing divinyl-PDMS (**1**), poly(dimethylsiloxane-co-methyl-hydrogenosiloxane) (**2**), hydrophobized silica and (methyl-Cp)trimethylplatinum (**63**) (30 ppm of Pt content). “Bluepoint 4” UV emitter from Dr. Hönle AG, based on high pressure mercury lamp, was used as the UV source. An example of 3D printed object is presented in Figure 29b. It was also demonstrated that vinyl-functionalized MQ-resin can be used to obtain completely transparent 3D printed objects<sup>101,102</sup>. Later this company suggested the use of poly(ethylene glycol)-based material as a support of silicone resin during printing; such support



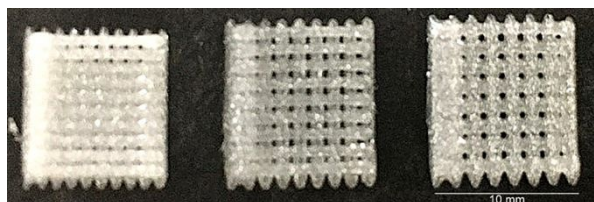
could be removed by dissolving in water after the print<sup>103</sup>. This method was further developed by improving the rheology<sup>104,105</sup> of the formulations and precision of the 3D printing<sup>106,107</sup>. Finally, the technique was applied to produce anatomical silicone models<sup>108</sup>, that were evaluated by surgical residents of the University of California and rated as fairly realistic<sup>109</sup>.

Momentive Performance Materials patented a process for the continuous manufacturing of shaped articles from photohydrosilylation crosslinkable formulations<sup>110</sup>. They prepared mixtures containing polysiloxane with vinyl groups (14), poly(dimethylsiloxane-co-methyl-hydrogenosiloxane) (2), tetramethyldivinyl-disilazane, OH-terminated PDMS (16), dimethoxy-terminated PDMS (18), (methyl-Cp)trimethylplatinum (63) (4 ppm of Pt content) and from 17 to 29% of fumed silica. These mixtures were shaped by extrusion followed by exposure to the light of iron- or mercury-doped UV lamps. Extruded materials were characterized by hardness from 20 to 51 Shore A and could keep the

1  
2 shape in time. This work was followed by another one published by Sandler *et al.*<sup>111</sup>. They suggested  
3  
4  
5 to use commercially available UV-curable silicone resin (Silopren UV LSR 2030 by Momentive  
6  
7  
8 Performance Materials) to 3D print drug-loaded drug delivery devices. Although it is not easy to find  
9  
10 information about the composition of the employed commercial resin, there are indications that it  
11  
12 contains (methyl-Cp)trimethylplatinum (**63**)<sup>112</sup> and, most probably, a formulation similar to the one  
13  
14  
15 described above<sup>110</sup>. The formulation was mixed with 0.5 – 1.5% of the drug (Prednisolone) and  
16  
17  
18 applied for 3D printing by extrusion printing with the BioBots 1 Desktop Bioprinter (USA) at room  
19  
20  
21 temperature and under the exposure of LED UVA light source MTE UV303 professional flashlight  
22  
23  
24 (China), with an intensity of 20 mW/cm<sup>2</sup> and a wavelength of 365 nm. Relatively simple grids were  
25  
26  
27 printed (Figure 30) and property of the material and drug release were studied. Swelling tests were  
28  
29  
30 performed in hexane and it was shown that additional UV post-curing for 3 minutes decreased  
31  
32  
33 swelling degree from 271 to 150 %, as well as reduced soluble fraction from 21 to 5 %. This result  
34  
35  
36 was explained by a higher degree of crosslinking after additional curing and was confirmed by tensile  
37  
38  
39 tests: the sample after additional exposure had 4.89 N load at break, while the sample without post  
40  
41  
42 curing only 3.37 N. The main advantage of the described method of drug carrier manufacture is that  
43  
44  
45 it does not require any heating (all steps are carried out at room temperature), which is important for  
46  
47  
48 heat-sensitive drugs.

## 8. Conclusive discussion

Starting from the eighties, companies like 3M and GE developed several photoactive catalytic systems for photohydrosilylation. In general, the required time for crosslinking ranges between 10 sec and several minutes, depending on lighting conditions and concentrations applied. From our systematic review, it seems that Cp-based photoactive Pt catalysts allow to achieve a shorter UV curing time than Pt ( $\beta$ -diketonates) or COD-based Pt catalysts<sup>29,65,69</sup>, but the lack of systematic comparable systems makes this comparison rather difficult. Moreover, it is seen that curing is usually faster under UV light than under visible light<sup>28,29,34,42,44,60,79</sup> which can be explained by better absorption of UV light by employed catalysts. Photosensitizers and radical photoinitiators are both capable to accelerate the hydrosilylation reaction, but despite the recent interest from academic research groups, there are still no real comprehension about the mechanisms of reaction in the presence of these co-catalysts. Increasing content of catalyst and or co-catalyst was not proved to systematically accelerate curing rates<sup>44,60,63</sup> except for Cp-based catalyst<sup>60,65</sup>. On the other hand, large concentrations of

1  
2 functional groups, both on vinyl and SiH molecules<sup>68</sup>, or more powerful light source<sup>34</sup> effectively  
3  
4  
5 reduce the non-smear time. Another striking information from this review is that results can be quite  
6  
7  
8 different between patents and articles, even when they show a priori similar systems<sup>60,63</sup>. The influence  
9  
10  
11 of dark curing could be a tentative explanation for the observed different reactivities described in  
12  
13  
14  
15  
16 most studies.

17  
18  
19 If we compare hydrosilylation to other reported light-curing techniques (see Table 3), the first  
20  
21  
22 striking trend is that time for Si-H/Si-Vinyl photo-catalyzed reaction is much longer than usually  
23  
24  
25 required for radical (acrylate or thiol-ene) crosslinking<sup>15</sup>. Moreover, hydrosilylation-crosslinking still  
26  
27  
28 occurs in the dark alike cationic photopolymerization. Meanwhile, hydrosilylation formulations are  
29  
30  
31 more attractive as harmless and odorless starting materials. And last but not the least, hydrosilylation-  
32  
33  
34 prepared silicone materials do not contain linkages in the polymer network that could potentially  
35  
36  
37 compromise the final material properties, e.g. in long-term thermal ageing particularly sought for  
38  
39  
40  
41  
42 silicone elastomers.

43  
44  
45  
46 Photohydrosilylation formulations already found applications as photocurable coatings, materials  
47  
48  
49 for silicone molds, insulators and resins for photolithography. Recently, the examples of 3D printing  
50  
51  
52 using such formulations were demonstrated. Wacker commercialized silicone printing by depositing  
53  
54  
55 droplets of the resin (ACEO company) while Momentive's resin was used for extrusion printing of  
56  
57  
58 drug-loaded objects. This application is probably the most promising for future development of  
59  
60

1  
2 photohydrosilylation systems. Besides, more active and more controlled catalytic systems could open  
3  
4  
5  
6 up new possibilities for higher resolutions and faster 3D printing. Already described photosensitive  
7  
8  
9 catalysts of silicone hydrosilylation always contain expensive Pt, but there are recent examples in the  
10  
11  
12 open literature of metal-free photohydrosilylation catalysts <sup>113,114</sup> that could potentially be exploited  
13  
14  
15  
16 for silicone curing.
