Regularization of closed positive currents and extension theory

Abstract In this note we extend to any bidimension (p,p) the Demailly theorem of regularization of closed positive (1,1)-currents on a compact Kähler manifold X of dimension n. When the manifold X is projective, we get explicitly a closed regularization with bounded negative part, constructed by using the space $C_p(X)$ of effective algebraic cycles of X of dimension p. This space can be injected in the space of divisors of $C_{n-p-1}(X)$ and we arrive at an intrinsic construction of the Skoda potential associated with a closed positive current of X. On another hand, in the case of a divisor D of X, we give an explicit bound for the degree of an irreducible component of the singular locus D_{sing} , involving the geometry of X. Lastly when X is embedded in the projective space \mathbb{P}_N , we prove the existence of a closed current extending in the generalized sense a given closed current of X, by using here a space of cycles. As an application, we obtain a characterization of the cohomology classes contained in some algebraic hypersurface of X.

1. Regularization of closed positive currents on a compact Kähler manifold

Let T be a closed positive (q, q)-current on a compact Kähler manifold X of dimension n. We use the writing

$$T = \Theta + \mathrm{dd^c} S$$

where Θ is a \mathcal{C}^{∞} differential (q,q)-form closed in X and S is a differential (q-1,q-1)-form with $\mathrm{L}^1_{\mathrm{loc}}$ coefficients in X, such that ∂S and $\overline{\partial} S$ are with $\mathrm{L}^1_{\mathrm{loc}}$ coefficients in X.

Let (U_{α}) be a finite covering of X with open sets of coordinate maps and let (λ_{α}) be a \mathcal{C}^{∞} partition of the unit subordinate to (U_{α}) . Let $S_{\alpha,\varepsilon}$ be a smooth differential (q-1,q-1)-form with compact support in U_{α} , weakly converging in U_{α} to $\lambda_{\alpha}S_{|U_{\alpha}} = \lambda_{\alpha}S$ when $\varepsilon \to 0^+$. We set

$$\tilde{T}_{\epsilon} = \Theta + \mathrm{dd^c}(\sum_{\alpha} S_{\alpha,\varepsilon})$$

which is a differential (q,q)-form of class \mathcal{C}^{∞} closed in X, weakly converging in X to T when $\varepsilon \to 0^+$. First we have

$$\tilde{T}_{\varepsilon} = \Theta + \sum_{\alpha} (\lambda_{\alpha} T - \lambda_{\alpha} \Theta)_{\varepsilon} + \sum_{\alpha} (\mathrm{dd^{c}} S_{\alpha, \varepsilon} - (\lambda_{\alpha} \mathrm{dd^{c}} S)_{\varepsilon}).$$

When the index α is fixed, $\mathrm{dd}^{\mathrm{c}}S_{\alpha,\varepsilon} - (\lambda_{\alpha}\mathrm{dd}^{\mathrm{c}}S)_{\varepsilon}$ converges weakly in U_{α} to

$$R_{\alpha} = \mathrm{dd^{c}}(\lambda_{\alpha} S_{|U_{\alpha}}) - \lambda_{\alpha} (\mathrm{dd^{c}} S_{|U_{\alpha}}),$$

which is only a differential (q, q)-form with L^1_{loc} coefficients in U_{α} (see [4]). But when α varies, the relation

$$\sum_{\alpha} R_{\alpha} = 0 \tag{1}$$

is satisfied i.e. there is a compensation of the singularities of the R_{α} .

There is a regularization $R_{\alpha,\varepsilon}$ of $R_{\alpha} = \mathrm{dd^c}(\lambda_{\alpha}S_{|U_{\alpha}}) - (\lambda_{\alpha}T_{|U_{\alpha}} - \lambda_{\alpha}\Theta_{|U_{\alpha}})$ which satisfies supp $R_{\alpha,\varepsilon}$ is a compact in U_{α} and $\sum_{\alpha} R_{\alpha,\varepsilon}$ is uniformly bounded in X. We write in U_{α} a homotopy formula

$$R_{\alpha,\varepsilon} = \mathrm{dd^c} S_{\alpha,\varepsilon} + V_{\alpha,\varepsilon}$$

and then we decompose $V_{\alpha,\varepsilon} = (\lambda_{\alpha}T)_{\varepsilon} - (\lambda_{\alpha}\Theta)_{\varepsilon}$ where $(\lambda_{\alpha}T)_{\varepsilon} \geq 0$ is of class \mathcal{C}^{∞} with compact support in U_{α} and weakly converging to $\lambda_{\alpha}T$ in U_{α} .

Since $(\lambda_{\alpha}T)_{\varepsilon} \geq 0$, we arrive in such a way at

$$\tilde{T}_{\varepsilon} \geq \Theta - \sum_{\alpha} (\lambda_{\alpha} \Theta)_{\varepsilon} + \text{smooth term}$$

thus the negative part of \tilde{T}_{ε} is uniformly bounded in X i.e. there is constant C such that $\tilde{T}_{\varepsilon} \geq -C\omega^{q}$, where ω is a Kähler metric on X.

When Z is an effective algebraic cycle of X of codimension q, since

$$\lim_{\varepsilon \to 0^+} \int_{Y} (\tilde{T}_{\varepsilon} + C\omega^q) \wedge [Z] \wedge \omega^{n-2q} = \lim_{\varepsilon \to 0^+} \int_{Y} (\{\tilde{T}_{\varepsilon}\} + C\{\omega\}^q) \wedge \{Z\} \wedge \{\omega\}^{n-2q}$$

is finite, there is a sequence $\varepsilon_j \stackrel{>}{\to} 0$ such that $\tilde{T}_{\varepsilon_j|Z}$ is weakly converging in Z. Then the sequence $\int_X T_{\varepsilon_j} \wedge \theta$ is convergent for each $\theta = i_*v$ where $i:Z \to X$ is the natural injection and v is a smooth differential form of bidimension (q,q) in Z.

So we have a version in any bidegree (q,q) of the Demailly regularization theorem (see [1]).

Proposition 1. There is a sequence of smooth differential (q,q)-forms T_j weakly converging in X to T and satisfying $T_j \geq -C\omega^q$ for all j, where C is a constant and ω is a Kähler metric on X.

Proof. We can assume that T = [Z] where Z is an effective algebraic cycle of X of dimension p = n - q. We denote by $\lambda : \tilde{X} \to X$ the blowing up of X along Z. When θ is a (p,p)-current in X, the intersection number

$$\int_{X} [Z] \wedge \theta = \int_{\tilde{X}} \lambda^{*}[Z] \wedge \lambda^{*}\theta \tag{2}$$

is well defined. In fact, $\lambda^*\theta$ is a current in \tilde{X} by [11] and $\lambda^*[Z] = [H] \wedge \gamma$, where H is the exceptional divisor in \tilde{X} and γ is a smooth closed differential (q-1,q-1)-form in \tilde{X} . Then $[H] \wedge \lambda^*\theta$ is defined by division of distributions.

We consider the vector space $\mathcal{W} = \{(p,p)\text{-currents }\theta \text{ in }X \text{ of order }0 \text{ with sing supp }\theta \subset Z\}$, in other words $\theta \in \mathcal{W}$ when $\theta = \theta_{\text{abs}} + \theta_{\text{sing}}$ where θ_{abs} is with $\mathrm{L}^1_{\mathrm{loc}}$ coefficients in X and smooth in $X \setminus Z$ while θ_{sing} is with measure coefficients and supp $\theta_{\mathrm{sing}} \subset Z$. In particular $\mathcal{W} \supset \mathcal{D}_{p,p}(X)$ with $\mathcal{D}_{p,p}(X)$ the space of smooth differential (p,p)-forms in X and $\mathcal{W} = \overline{\mathcal{D}_{p,p}(X)}$ if the topology of \mathcal{W} is given by setting $\theta_j \to \theta$ in \mathcal{W} when θ_j converges to θ for the weak topology of currents of order 0 in X and $\theta_{j|X\setminus Z}$ converges to $\theta_{|X\setminus Z|}$ for the \mathcal{C}^∞ topology in $X\setminus Z$.

On the one hand we set $L(\theta_{abs}) = \int_Z \theta_{abs}$ which is possibly infinite and always equal to $\lim_j \int_Z \theta_j$ for a sequence of differential (p,p)-forms θ_j with L^1_{loc} coefficients in X converging to θ for the L^1_{loc} topology and such that $\theta_{j|Z}$ is L^1_{loc} for each j. On another hand we set $L(\theta_{sing}) = \int_X [Z] \wedge \theta_{sing}$ as being the

previous intersection number. We claim the existence of a family of smooth closed differential forms T_{ε}

of type (q,q) in X such that $L(\theta) = \lim_{\varepsilon \to 0^+} \int_X T_\varepsilon \wedge \theta$ for all $\theta \in \mathcal{W}$. In fact, if for each sequence of smooth closed differential forms T_j of type (q,q) in X, there is an element $\theta \in \mathcal{W}$ such that $\lim_{j} \int_{X} T_{j} \wedge \theta \neq L(\theta)$, there would be thanks to [12] an element $\theta \in \mathcal{W}$ such that $L(\theta) = 1$ and θ is d-exact in X. Since $L(\theta)$ is finite, $L(\theta_{abs})$ is finite too and thus it can be calculated by the formula (2). So $L(\theta)$ can be calculated by the same formula, which implies $L(\theta) = 0$ since θ is d-exact in X. This is a contradiction.

We prove now that the negative part of T_{ε} is bounded. With $g \geq 0$ any $\mathcal{L}^1_{\mathrm{loc}}$ function in X smooth in $X \setminus Z$ and with $\alpha_1, \ldots, \alpha_p$ any set of differential (1,0)-forms smooth in X, we take $\theta = gi\alpha_1 \wedge \overline{\alpha}_1 \wedge \ldots \wedge \overline{\alpha}_p$ $i\alpha_p \wedge \overline{\alpha}_p$. Then

$$\lim_{\varepsilon \to 0^+} \int_X g T_\varepsilon \wedge i\alpha_1 \wedge \overline{\alpha}_1 \wedge \ldots \wedge i\alpha_p \wedge \overline{\alpha}_p = \int_Z g i\alpha_1 \wedge \overline{\alpha}_1 \wedge \ldots \wedge i\alpha_p \wedge \overline{\alpha}_p > -\infty$$

implies that the negative part of $T_{\varepsilon} \wedge i\alpha_1 \wedge \overline{\alpha}_1 \wedge \ldots \wedge i\alpha_p \wedge \overline{\alpha}_p$, which is weakly converging in X to 0, is bounded. So there exists a constant $C \geq 0$ such that $T_{\varepsilon} \geq -C\omega^q$.

2. Regularization of closed positive currents on a projective manifold

Let X be a connected projective complex manifold with dim X = n and let $C_p(X)$ be the space of algebraic cycles on X of dimension p = n - q. We consider the closed positive (q, q)-current T = [Z] with $Z \in C_p(X)$.

Let \mathcal{I} : {continuous differential forms of type (p,p) on X} \to {continuous functions on $C_p(X)$ } be the integral transformation defined by

$$\mathcal{I}(\theta)(Z) = \int_{Z} \theta = \langle [Z], \theta \rangle = \langle \delta_{Z}, \mathcal{I}(\theta) \rangle = \langle ({}^{t}\mathcal{I})(\delta_{Z}), \theta \rangle \Leftrightarrow [Z] = ({}^{t}\mathcal{I})(\delta_{Z})$$

where δ_Z denotes the Dirac measure at the point $Z \in C_p(X)$ (see [5]). As pointed out by Jean-Pierre Demailly, this formula gives a natural way to approximate closed positive currents on X (see [9]).

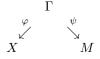
Let M be the connected component of Z in $C_p(X)$ and let χ_j be a sequence of non negative smooth functions on $C_p(X)$, with support in M and weakly converging on $C_p(X)$ to the Dirac mass δ_Z . We decompose $\chi_j = \alpha_j + \delta_j$ on M where $({}^t\mathcal{I})(\delta_j) = T_j$ is \mathcal{C}^0 on X and where $\alpha_j \to 0$ weakly. In fact, let \mathcal{S} be the set of distributions u orthogonal to the χ such that $({}^t\mathcal{I})(\chi)$ is \mathcal{C}^0 . We take α_j such that

$$\int_{M} \chi_{j} u = \int_{M} \alpha_{j} u \text{ for all } u \in \mathcal{S}$$

and α_j uniformly bounded $\Rightarrow |\int_M \chi_j u|$ bounded for all $u \in \mathcal{S}$. To describe the elements $u \in \mathcal{S}$, we consider a (p,p)-current θ in X of order 0 and we calculate the intersection number

$$\int_X ({}^t\mathcal{I})(\chi) \wedge \theta = \lim_{\varepsilon} \int_X ({}^t\mathcal{I})(\chi) \wedge \theta_{\varepsilon} = \lim_{\varepsilon} \int_M \chi \mathcal{I}(\theta_{\varepsilon})$$

by means of a regularization θ_{ε} of θ . If $({}^t\mathcal{I})(\chi)$ is of class \mathcal{C}^0 , it is equal to $\int_M \chi \mathcal{I}(\theta)$ and we obtain the condition $\int_M \chi u = 0$ where $u = \mathcal{I}(\theta) - \lim_{\varepsilon} \mathcal{I}(\theta_{\varepsilon})$. But $\mathcal{I}(\theta)$ is obtained from θ by means of a double fibration



i.e. $\mathcal{I}(\theta) = \psi_* \varphi^* \theta$. The direct image ψ_* is weakly continuous, while the inverse image φ^* is not necessarily weakly continuous, since φ is not necessarily a submersion. We can only say that there is a proper algebraic subset $A \subset X$ such that $\Gamma \setminus \varphi^{-1}(A) \xrightarrow{\varphi} X \setminus A$ is a submersion. Note that $\varphi^*\theta$ is defined by flatification and by applying the existence due to Poly of the inverse image by blowing up. Then the distribution

$$u = \psi_* \varphi^* (1_A \theta)$$

is of order 0 and not necessarily equal to 0. But we can assume that $\chi_j \geq 0$ satisfies the supplementary

condition $|\int_M \chi_j u|$ bounded. In fact, this implies the condition $|u(Z)| \leq C \int_M |u|$. As a conclusion T_j is a closed \mathcal{C}^0 differential form that converges weakly to [Z] on X. Moreover we have $T_i \geq -C({}^t\mathcal{I})(1)$.

If the cohomology class $\{Z\}$ of Z in X contains a smooth closed differential (q,q)-form $\Theta > 0$, then $({}^t\mathcal{I})(1)$ is continuous in X (see [10]).

In the general case $\Theta \geq -C\omega_{|X}^q$ for some constant $C \geq 0$ and ω the Fubini-Study differential (1,1)form in \mathbb{P}_N . We approximate $[Z] + C\omega_{|X}^q$ by algebraic cycles Y with real coefficients such that $\{Y\} \geq 0$ (see [2]). If C is large enough, we can assume Y with positive coefficients. First we approximate [Y] by smooth closed differential (q,q)-forms with bounded negative part, then we obtain a closed regularization T_i of [Z] of type (q,q) with bounded negative part.

2.1. Skoda potential of a closed positive current of X

For T a closed positive (q,q)-current on X with q=n-p, we now express the Skoda potential U associated to T by means of the Chow transform $\mathcal{C}(T)$, which is obtained by integrating T on the effective algebraic cycles of X of dimension q-1 i.e. $\mathcal{C}(T)$ is obtained from T by means of the double fibration

$$\begin{array}{ccc}
\Gamma & & & \\
\varphi & & \searrow \\
X & & C_{q-1}(X)
\end{array}$$

with $\Gamma \subset X \times C_{q-1}(X)$ the incidence manifold.

We denote by $j: X \hookrightarrow P(V)$ an embedding of X into $P(V) = \mathbb{P}_N$ and by $\rho: G(p+1,V^*) \longrightarrow$ $C_{q-1}(X)$ the induced meromorphic map from the Grassmannian to the cycle space, which associates $c = X \cap P(\ker \lambda_0) \cap \ldots \cap P(\ker \lambda_p)$ to a subspace $\operatorname{vect}(\lambda_0, \ldots, \lambda_p) \in G(p+1, V^*) = G(q, V) = \mathbb{G}_{q-1, N}$. Here $P(\ker \lambda_i)$ is the projective subspace of \mathbb{P}_N defined by the linear equation $\lambda_i = 0$.

We consider the irreducible component M of the cycles $c = X \cap P(\ker \lambda_0) \cap ... \cap P(\ker \lambda_p)$ in $C_{q-1}(X)$. Denote by d_M the dimension of M and by $d = d_M - p - 1$ the dimension of a generic fiber of φ restricted to $\psi^{-1}(M)$. We set $\Omega = \psi_* \varphi^*(\omega_{|X}^q)$ with ω the Fubini-Study form on \mathbb{P}_N (see [13]).

With \mathcal{A} the positive smooth differential (d,d)-form equal to Ω^{d_M-p-1} on M, we define on X the (1,1)-current

$$T_1 = \varphi_* \psi^* (\mathcal{A} \wedge \mathcal{C}(T)_{|M}) = \varphi_* \psi^* (\mathcal{A} \wedge (\psi_* \varphi^* T)_{|M})$$

which is an integral transform of T.

Proposition 2. The closed positive (1,1)-current T_1 on X satisfies $T_1 = \beta + \mathrm{dd}^c U$ with U the Skoda potential associated to T and β a closed smooth differential (1,1)-form on X. Thus we have the equalities (i) $\beta = \varphi_* \psi^* (\mathcal{A} \wedge \mathcal{C}(\Theta)_{|M})$ if T is cohomologous to Θ smooth on X,

(ii) $\nu(T_1,x) = C_M \nu(T,x)$ for the Lelong numbers at each point $x \in X$ with a constant C_M depending on M only.

Proof. By writing $T = \Theta + dd^c S$, we have

$$C(T)_{|M} = C(\Theta)_{|M} + \mathrm{dd^c}C(S)_{|M}$$

with $C(S)(c) = \int_X S \wedge [c]$ and $[c] = [X \cap \mathbb{P}_{N-p-1}] = \omega_{|X}^{p+1} + \mathrm{dd^c} \gamma_c$ the integration current associated to a cycle $c \in M$. In other words γ_c is a Green form in X of the cycle c. Up to a smooth function of c, we have $C(S)(c) = \int_X T \wedge \gamma_c$. To calculate the Lelong numbers of U, we can replace U(x) by

$$\int_X T \wedge \left(\int_{\substack{c \in M \\ c \ni x}} \gamma_c \Omega^d \right).$$

When $y \in X$ varies, to calculate $d_y d_y^c \int_{c \in M} \gamma_c(y) \Omega^d$ we are reduced to calculate $\int_{c \in M} [c](y) \Omega^d$. But

$$\left(\int_{s\in G(q,V)} [s](y)\Phi_x\right)_{|X} = \int_{s\in G(q,V)} [X\cap s](y)\Phi_x = K \int_{c\in M \atop c\ni x} [c](y)\Omega^d$$

where Φ_x is a volume form on $\{s \in G(q, V), s \ni x\}$ and K is a constant, since the volume of $\{s \in G(q, V), s \ni x \text{ and } X \cap s = c\}$ does not depend on (c, x) such that $c \ni x$. So the conclusion relies on the calculation of $\int_{s \in G(q, V)} [s](y) \Phi_x$ that is to say on the case of the Skoda potential for $\mathbb{P}_N = P(V)$.

2.2 Irreducible components of the singular locus for a divisor of X

We give here a bound for the degree of an irreducible component of the singular locus of divisor, similar to those of [1, 6].

Let $D = s^{-1}(0)$ be an effective divisor in X where $s \in H^0(X, L)$ with a holomorphic line bundle $L = \mathcal{O}(D)$.

For $k \in \mathbb{N}$, we denote by $J^k s \in H^0(X, J^k L)$ the holomorphic section of k-jets of s. We consider the strictly decreasing sequence $E_0 \supset E_1 \supset \ldots \supset E_m$ of algebraic subsets of D defined by

$$E_l = \{J^{k_{l-1}}s = 0\} = \dots = \{J^{k_l-1}s = 0\}$$

for $1 \le l \le m$ and by $E_0 = \{J^0s = 0\} = \dots = \{J^{k_0-1}s = 0\}$, where $1 \le k_0 < \dots < k_m$ and $\{J^{k_m}s = 0\} = \emptyset$ while $\{J^{k_m-1}s = 0\} \ne \emptyset$.

In other words, on $E_l \setminus E_{l+1}$, the multiplicity of D is k_l for $0 \le l \le m-1$ and on E_m the multiplicity of D is k_m . So the sequence $1 \le k_0 < \ldots < k_m$ is the sequence of different multiplicities of D.

We set $d_l = \dim E_l$ in such a way that $d_0 \ge d_1 \ge ... \ge d_m$ with $d_0 = n - 1$ and $n = \dim X$.

Let C be an irreducible component of E_l of dimension d_l which is not contained in E_{l+1} . Since $C = \overline{C \setminus (C \cap E_{l+1})}$, the generic multiplicity of D along C is equal to k_l . Note that if $C \subset E_{l+1}$, then $d_l = d_{l+1}$.

The integration current of bidimension (d_l, d_l) in X associated to the algebraic cycle of dimension d_l in X defined by $J^{k_{l-1}}s \in H^0(X, J^{k_{l-1}}L)$ can be written

$$\sum_{C \not\subset E_{l+1}} \nu(J^{k_{l-1}}s,C)[C] + \sum_{C \subset E_{l+1}} \nu(J^{k_{l-1}}s,C)[C]$$

with $\nu(J^{k_{l-1}}s,C)$ the generic multiplicity of $J^{k_{l-1}}s$ along C. Its cohomology class in X is equal to

$$c_{n-d_l}(J^{k_{l-1}}L) - c_{n-d_l}(\mathcal{F}_l)$$

where \mathcal{F}_l is the coherent sheaf in X of generic rank equal to rank $(J^{k_{l-1}}L)-1$, whose dual \mathcal{F}_l is the sheaf of germs of holomorphic sections of $(J^{k_{l-1}}L)^*$ equal to 0 on $J^{k_{l-1}}s$.

Proposition 3. If the Chern class $c_{n-d_l}(\mathcal{F}_l)$ is ≥ 0 in X, then we have the following inequality

$$\sum_{C \not\subset E_{l+1}} \nu(J^{k_{l-1}}s,C)\{C\} \le c_{n-d_l}(J^{k_{l-1}}L)$$

for the cohomology classes of bidimension (d_l, d_l) in X.

We use a \mathcal{C}^{∞} isomorphism $J^kL \simeq \bigoplus_{0 \leq j \leq k} (S^j T^*X \otimes L)$, which gives the equality

$$c(J^k L) = \prod_{0 \le j \le k} c(S^j T^* X \otimes L)$$

for the total class Chern of J^kL on X. Lastly recall that for E a holomorphic vector bundle of rank r on X, we have the equality

$$c(E \otimes L) = \sum_{0 \le m \le r} (1 + c_1(L))^{r-m} c_m(E)$$

since L is of rank 1. In such a way $c_{n-d_l}(J^{k_{l-1}}L)$ becomes a polynomial in $c_1(L)$ of degree $n-d_l$ and whose coefficients depend only on the Chern classes of the S^jT^*X .

3. Extension to \mathbb{P}_N of closed (q,q)-currents in X

Let X be a closed complex submanifold in \mathbb{P}_N of dimension n and let $i_0: X \hookrightarrow \mathbb{P}_N$ be the canonical injection. Let T be a closed smooth differential form on X of bidimension (p,p) with p=n-q.

Proposition 4. There is a closed (q,q)-current S on \mathbb{P}_N having a restriction $S_{|X}$ equal to T, that is to say such that, for all smooth differential (p,p)-forms u in X, the current S has an intersection number with the direct image $i_{0*}u$ in \mathbb{P}_N equal to the intersection number of T with u in X.

Proof. Since every closed (q,q)-current on \mathbb{P}_N is a weak limit of algebraic cycles of codimension q, we search

$$S = \int_{A \in C_{N-q}(\mathbb{P}_N)} [A] \mu(A)$$

for some distribution μ on the cycle space $C_{N-q}(\mathbb{P}_N)$. This can be written $S=({}^t\mathcal{R})(\mu)$ where

$$\mathcal{R}: \mathcal{D}_{N-q,N-q}(\mathbb{P}_N) \rightarrow \mathcal{C}^{\infty}(C_{N-q}(\mathbb{P}_N))$$

is the Radon transform obtained by integration on the algebraic cycles of dimension N-q.

We define the intersection number $\int_{\mathbb{P}_N} S \wedge i_{0*}u = \lim_j \int_{\mathbb{P}_N} S \wedge \varphi_j(u)$ for some sequence $\varphi_j(u)$ of smooth differential (N-q,N-q)-forms in \mathbb{P}_N weakly converging in \mathbb{P}_N to $i_{0*}u$. Then this number can be expressed as being

$$\lim_{j} \int_{C_{N-q}(\mathbb{P}_N)} \mu \mathcal{R} (\varphi_j(u)) \tag{3}$$

and we can choose μ in order to obtain $\int_X T \wedge u$ for each smooth differential (p,p)-form u in X. In fact, we define a closed (q,q)-current \tilde{T} in X by $\lim_j \int_{C_{N-q}(\mathbb{P}_N)} \mu \mathcal{R}(\varphi_j(u)) = \int_X \tilde{T} \wedge u$ and we can force $\tilde{T} = T$.

So the Proposition 4 can be stated in the following way.

Proposition 5. There is a transform $\varphi_j: \mathcal{D}_{p,p}(X) \to \mathcal{D}_{N-q,N-q}(\mathbb{P}_N)$ satisfying : $\varphi_j(u)$ converges weakly in \mathbb{P}_N to $i_{0*}u$ and $\int_{\mathbb{P}_N} S \wedge \varphi_j(u) \to \int_X T \wedge u$ when $j \to \infty$.

Proof. For each smooth differential (p,p)-form u in X, we choose a sequence $\varphi_j(u)$ weakly converging in \mathbb{P}_N to $i_{0*}u$, such that if $u \notin \text{Im } \partial + \text{Im } \overline{\partial}$, there is no sequences v_i and w_i of smooth differential forms such that $\varphi_j(u) - \partial v_j - \overline{\partial} w_j \to 0$ for the \mathcal{C}^{∞} topology. Then S is a continuous linear form on $\mathcal{D}_{N-q,N-q}(\mathbb{P}_N)$ equal to 0 on Im ∂ + Im $\overline{\partial}$ and equal to $\int_X T \wedge u$ on $\lim_j \varphi_j(u)$.

3.1. Case
$$X = \mathbb{P}_{N-1} \subset \mathbb{P}_N$$

The existence of S can also be seen as a consequence of an integral representation formula of Bochner-Martinelli type in $\mathbb{P}_N \setminus X$, for $\varphi \in \mathcal{D}_{N-q,N-q}(\mathbb{P}_N)$.

For example let us assume that $X = \mathbb{P}_{N-1}$, in such a way that $\mathbb{P}_N \setminus X = \mathbb{C}^N$ and let us write the integration current $[D_{\mathbb{C}^N}]$ on the diagonal $D_{\mathbb{C}^N}$ of $\mathbb{C}^N \times \mathbb{C}^N$ as being

$$[D_{\mathbb{C}^N}] = \mathrm{dd^c} K$$

with $K(w, w') = -\frac{1}{(N-1)2^N} \frac{(\mathrm{dd}^c \| w - w' \|^2)^{N-1}}{\| w - w' \|^{2(N-1)}}$ for $(w, w') \in \mathbb{C}^N \times \mathbb{C}^N$ (see [3, 7]). The integral kernel K has $\mathrm{L}^1_{\mathrm{loc}}$ coefficients in $\mathbb{C}^N \times \mathbb{C}^N$ in other words $w \to K(w, .)$, which is with values in the space of differential forms L^1_{loc} in \mathbb{C}^N , is L^1_{loc} with respect to $w \in \mathbb{C}^N$. For $w \in \mathbb{C}^N$, we define the potential

$$U(w) = \int_{w' \in \mathbb{C}^N} K(w, w') \wedge \varphi(w')$$

which is a differential (N-q-1,N-q-1)-form with L^1_{loc} coefficients in \mathbb{C}^N . In effect, by writing $\varphi = \varphi_1 - \varphi_2$ with each φ_i smooth positive, we can assume that φ is smooth positive of bidimension (q,q)in \mathbb{P}_N . Then by writing $\varphi \leq C\omega^{N-q}$ for some constant $C \geq 0$, this local integrability is a consequence of the following result.

Proposition 6. For φ a closed positive current of bidimension (q,q) in \mathbb{P}_N , the potential U is L^1_{loc} in

Proof. With $\tau = \varphi_{|\mathbb{C}^N} \wedge (\frac{i}{2}\partial \overline{\partial} ||w'||^2)^q/q!$ the trace measure of $\varphi_{|\mathbb{C}^N}$, we use the Fubini formula

$$\int_{\|w\| < R_0} (\frac{i}{2} \partial \overline{\partial} \|w\|^2)^N / N! \int_{w' \in \mathbb{C}^N} \frac{\tau(w')}{\|w - w'\|^{2(N-1)}} = \int_{w' \in \mathbb{C}^N} k(R_0, w') \tau(w')$$

with a function $k(R_0, w') = \int_{\|w\| < R_0} \frac{(\frac{i}{2}\partial \overline{\partial} \|w\|^2)^N/N!}{\|w-w'\|^{2(N-1)}}$ equal to $CR_0^{2N} \|w'\|^{-2N+2}$ when $\|w'\| > R_0$.

Then we express

$$\int_{\|w'\|>R_0} \|w'\|^{-2N+2} \tau(w') = \int_{r=R_0}^{+\infty} r^{-2N+2} d\mathcal{M}(r)$$

with

$$\mathcal{M}(r) = \int_{\|w'\| < r} \tau(w') = \frac{\pi^q}{q!} r^{2q} \{ \nu(\varphi_{\mid \mathbb{C}^N}, 0) + \int_{0 < \|w'\| < r} \varphi_{\mid \mathbb{C}^N} \wedge (\operatorname{dd^c} \log \|w'\|)^q \}.$$

Note that $(\mathrm{dd^c} \log \|w'\|)^q = \sigma^*(\omega^q)_{|\mathbb{C}^N}$ with $\mathbb{P}_N \setminus \{[1,0,\ldots,0]\} \xrightarrow{\sigma} \mathbb{P}_{N-1}$ the orthogonal projection. Since $\varphi \wedge \sigma^*(\omega^q)$ is known to be defined in \mathbb{P}_N whole, we have $\mathcal{M}(r) = O(r^{2q})$ when $r \to +\infty$. So $\int_{\|w'\|>R_0} k(R_0,w')\tau(w')$ is convergent and U(w) is a differential (N-q-1,N-q-1)-form with L^1_{loc} coefficients in $||w|| < R_0$.

To see that U is not with L^1_{loc} coefficients in \mathbb{P}_N , we use again the Fubini formula

$$\int_{w \in \mathbb{C}^N} \frac{(\frac{i}{2} \partial \overline{\partial} \|w\|^2)^N / N!}{(1 + \|w\|^2)^{q+1}} \int_{w' \in \mathbb{C}^N} \frac{\tau(w')}{\|w - w'\|^{2(N-1)}} = \int_{w' \in \mathbb{C}^N} k(w') \tau(w')$$

with a function $k(w') = \int_{w \in \mathbb{C}^N} \frac{(\frac{i}{2}\partial \overline{\partial} \|w\|^2)^N/N!}{\|w-w'\|^{2(N-1)}(1+\|w\|^2)^{q+1}} \le C\|w'\|^{-2q}$ for $\|w'\|$ large enough. Then we express

$$\int_{\|w'\|>R_0} \|w'\|^{-2q} \tau(w') = \int_{r=R_0}^{+\infty} r^{-2q} d\mathcal{M}(r)$$

with $\mathcal{M}(r) \simeq Kr^{2q}$ when $r \to +\infty$.

But U extends as a (N-q-1, N-q-1)-current \tilde{U} in \mathbb{P}_N . In fact, assume that \mathbb{P}_{N-1} is given by $X_0=0$ in the homogeneous coordinates X_j associated to the basis (e_0,\ldots,e_N) of \mathbb{C}^{N+1} . In such a way $w_j=\frac{X_j}{X_0}$ for each $1\leq j\leq N$. We have

$$\tilde{U} = \operatorname{pr}_{1*}(\tilde{K} \wedge \operatorname{pr}_2^*(\varphi_{|\mathbb{C}^N}))$$

where \tilde{K} is an extension of K in $\mathbb{P}_N \times \mathbb{C}^N$ obtained by writing $w_j - w_j' = \frac{X_j/X_l}{X_0/X_l} - w_j' = \frac{(X_j/X_l) - w_j'(X_0/X_l)}{X_0/X_l}$ for some $1 \leq l \leq N$ such that $X_l \neq 0$ and by applying the division theorem of Hörmander-Lojasiewicz. When φ is again a smooth differential (N-q,N-q)-form in \mathbb{P}_N , we have in \mathbb{C}^N the equality

$$dd^{c}U = \operatorname{pr}_{1*}\left(dd^{c}K \wedge \operatorname{pr}_{2}^{*}(\varphi_{|\mathbb{C}^{N}})\right) - \operatorname{pr}_{1*}\left(d^{c}K \wedge \operatorname{pr}_{2}^{*}(d\varphi_{|\mathbb{C}^{N}})\right) + \operatorname{pr}_{1*}\left(dK \wedge \operatorname{pr}_{2}^{*}(d^{c}\varphi_{|\mathbb{C}^{N}})\right) + \operatorname{pr}_{1*}\left(K \wedge \operatorname{pr}_{2}^{*}(dd^{c}\varphi_{|\mathbb{C}^{N}})\right)$$

which can be written as being

$$\varphi_{|\mathbb{C}^N} - \mathrm{dd}^{\mathrm{c}}U = \mathrm{pr}_{1*} \big(\mathrm{d}^{\mathrm{c}}K \wedge \mathrm{pr}_2^* (\mathrm{d}\varphi_{|\mathbb{C}^N}) \big) - \mathrm{pr}_{1*} \big(\mathrm{d}K \wedge \mathrm{pr}_2^* (\mathrm{d}^{\mathrm{c}}\varphi_{|\mathbb{C}^N}) \big) - \mathrm{pr}_{1*} \big(K \wedge \mathrm{pr}_2^* (\mathrm{dd}^{\mathrm{c}}\varphi_{|\mathbb{C}^N}) \big).$$

In the same way the residual (N-q, N-q)-current

$$R = \varphi - \mathrm{dd^c} \tilde{U} - \left\{ \mathrm{pr}_{1*} \left(\mathrm{d^c} \tilde{K} \wedge \mathrm{pr}_2^* (\mathrm{d} \varphi_{|\mathbb{C}^N}) \right) - \mathrm{pr}_{1*} \left(\mathrm{d} \tilde{K} \wedge \mathrm{pr}_2^* (\mathrm{d^c} \varphi_{|\mathbb{C}^N}) \right) - \mathrm{pr}_{1*} \left(\tilde{K} \wedge \mathrm{pr}_2^* (\mathrm{dd^c} \varphi_{|\mathbb{C}^N}) \right) \right\}$$

is with support in \mathbb{P}_{N-1} .

Lemma 1. The currents $\frac{X_0}{X_l}R$, $\overline{\frac{X_0}{X_l}}R$ and in the same way $\frac{dX_0}{X_l} \wedge R$, $\frac{d\overline{X_0}}{\overline{X_l}} \wedge R$ are locally flat where $X_l \neq 0$. **Proof.** First the previous expression of R gives the formula

$$\begin{split} \frac{X_0}{X_l} R &= \frac{X_0}{X_l} \varphi - \mathrm{dd^c} \mathrm{pr}_{1*} \big(\frac{X_0}{X_l} \tilde{K} \wedge \mathrm{pr}_2^* (\varphi_{\mid \mathbb{C}^N}) \big) + \mathrm{pr}_{1*} \big(\frac{X_0}{X_l} \tilde{K} \wedge \mathrm{pr}_2^* (\mathrm{dd^c} \varphi_{\mid \mathbb{C}^N}) \big) \\ &+ \mathrm{d} \big(\frac{X_0}{X_l} \big) \wedge \mathrm{pr}_{1*} \big(\tilde{K} \wedge \mathrm{pr}_2^* (\mathrm{d^c} \varphi_{\mid \mathbb{C}^N}) \big) - \mathrm{d^c} \big(\frac{X_0}{X_l} \big) \wedge \mathrm{pr}_{1*} \big(\tilde{K} \wedge \mathrm{pr}_2^* (\mathrm{d} \varphi_{\mid \mathbb{C}^N}) \big) \\ &- \mathrm{d^c} \big(\frac{X_0}{X_l} \big) \wedge \mathrm{pr}_{1*} \big(\mathrm{d} \tilde{K} \wedge \mathrm{pr}_2^* (\varphi_{\mid \mathbb{C}^N}) \big) + \mathrm{d} \big(\frac{X_0}{X_l} \big) \wedge \mathrm{pr}_{1*} \big(\mathrm{d^c} \tilde{K} \wedge \mathrm{pr}_2^* (\varphi_{\mid \mathbb{C}^N}) \big) \\ &+ \mathrm{pr}_{1*} \big(\frac{X_0}{X_l} \mathrm{d} \tilde{K} \wedge \mathrm{pr}_2^* (\mathrm{d^c} \varphi_{\mid \mathbb{C}^N}) \big) - \mathrm{pr}_{1*} \big(\frac{X_0}{X_l} \mathrm{d^c} \tilde{K} \wedge \mathrm{pr}_2^* (\mathrm{d} \varphi_{\mid \mathbb{C}^N}) \big). \end{split}$$

With $w_l = \frac{X_l}{X_0}$, we have the expression

$$\tilde{K} = K_{0,0} + w_l \operatorname{d}(\frac{1}{w_l}) \wedge K_{1,0} + \overline{w}_l \operatorname{d}(\frac{1}{\overline{w}_l}) \wedge K_{0,1} + |w_l|^2 \operatorname{d}(\frac{1}{w_l}) \wedge \operatorname{d}(\frac{1}{\overline{w}_l}) \wedge K_{1,1}$$

where $K_{0,0}, K_{1,0}, K_{0,1}, K_{1,1}$ are differential forms with coefficients which are L^1_{loc} in $\mathbb{P}_N \times \mathbb{C}^N$. In fact, K(w, w') is proportional to

$$||w - w'||^{-2N+2} \sum_{1 \le j \le N} (\mathrm{d}w_1 - \mathrm{d}w_1') \wedge \ldots \wedge (\widehat{\mathrm{d}w_j - \mathrm{d}w_j'}) \wedge \ldots \wedge (\mathrm{d}w_N - \mathrm{d}w_N')$$
$$\wedge (\mathrm{d}\overline{w}_1 - \mathrm{d}\overline{w}_1') \wedge \ldots \wedge (\widehat{\mathrm{d}w_j - \mathrm{d}\overline{w}_j'}) \wedge \ldots \wedge (\mathrm{d}\overline{w}_N - \mathrm{d}\overline{w}_N')$$

and when we calculate U(w) we need the component of K(w, w') which is of bidegree (N-1-q, N-1-q) in w and of bidegree (q, q) in w'. Therefore we have to consider terms of the type

$$\|w-w'\|^{-2N+2} \mathrm{d}w_{\{1,\ldots,N\}\setminus jK} \wedge \mathrm{d}w'_K \wedge \mathrm{d}\overline{w}_{\{1,\ldots,N\}\setminus jL} \wedge \mathrm{d}\overline{w}'_L$$

where jK and jL are subsets of $\{1,\ldots,N\}$ with q+1 elements. For $j\neq l$, we write

$$\mathrm{d}w_j = \frac{\mathrm{d}(\frac{X_j}{X_l})}{\frac{X_0}{Y_i}} - \frac{X_j}{X_l} \frac{\mathrm{d}(\frac{X_0}{X_l})}{(\frac{X_0}{Y_i})^2}$$

and $dw_l = -\frac{d(\frac{X_0}{X_l})}{(\frac{X_0}{X_l})^2}$. So $dw_{\{1,...,N\}\setminus jK}$ can be written

$$\frac{\text{smooth form}}{\left(\frac{X_0}{X_l}\right)^{N-1-q}} + \frac{\left(\text{smooth form}\right) \wedge \operatorname{d}\left(\frac{X_0}{X_l}\right)}{\left(\frac{X_0}{X_l}\right)^{N-q}}$$

if jK contains l, while it can be written only $\frac{(\text{smooth form}) \wedge d(\frac{X_0}{X_l})}{(\frac{X_0}{X_l})^{N-q}}$ if jK does not contain l. As a conclusion we obtain terms of the type

$$\|w - w'\|^{-2N+2} dw'_K \wedge d\overline{w}'_L \wedge \left(\frac{\alpha}{(\frac{X_0}{X_l})^{N-1-q}} + \frac{\beta \wedge d(\frac{X_0}{X_l})}{(\frac{X_0}{X_l})^{N-q}}\right) \wedge \left(\frac{\gamma}{(\frac{\overline{X_0}}{\overline{X_l}})^{N-1-q}} + \frac{\delta \wedge d(\frac{\overline{X_0}}{\overline{X_l}})}{(\frac{\overline{X_0}}{\overline{X_l}})^{N-q}}\right)$$

where $\alpha, \beta, \gamma, \delta$ are smooth differential forms. For U(w), we arrive at terms proportional to

$$V\alpha \wedge \gamma \text{ or } V\beta \wedge \gamma \wedge \frac{\operatorname{d}(\frac{X_0}{X_l})}{\frac{X_0}{X_l}} \text{ or } V\alpha \wedge \delta \wedge \frac{\operatorname{d}(\frac{\overline{X_0}}{\overline{X_l}})}{\frac{\overline{X_0}}{\overline{X_l}}} \text{ or } V\beta \wedge \delta \wedge \frac{\operatorname{d}(\frac{X_0}{X_l}) \wedge \operatorname{d}(\frac{\overline{X_0}}{\overline{X_l}})}{|\frac{X_0}{X_l}|^2}$$

where we set

$$V(w) = \frac{1}{\left|\frac{X_0}{X_l}\right|^{2(N-1-q)}} \int_{w' \in \mathbb{C}^N} \frac{\mathrm{d}w_K' \wedge \mathrm{d}\overline{w}_L' \wedge \varphi(w')}{\|w - w'\|^{2N-2}} = \int_{y \in \mathbb{C}^N} \frac{\mathrm{d}y_K \wedge \mathrm{d}\overline{y}_L \wedge \varphi\left(\left\lfloor \frac{X_0}{X_l} e_0 + y \right\rfloor\right)}{\|\frac{X_0}{X_l} w - y\|^{2N-2}}$$

with $\frac{X_0}{X_I}w=(\frac{X_1}{X_I},\ldots,\frac{X_N}{X_I})$. When $\frac{X_0}{X_I}\to 0$, the function V(w) has a finite limit equal to

$$\int_{y\in\mathbb{C}^N} \frac{\mathrm{d}y_K \wedge \mathrm{d}\overline{y}_L \wedge \varphi(0, y_1, \dots, y_N)}{\|(\frac{X_1}{X_l}, \dots, \frac{X_N}{X_l}) - y\|^{2N-2}}.$$

By similar formulae, we prove that $\frac{\overline{X}_0}{\overline{X}_l}R$ and $\frac{\mathrm{d}X_0}{X_l}\wedge R$ as well as $\frac{\mathrm{d}\overline{X}_0}{\overline{X}_l}\wedge R$ are locally flat in the sense of Federer, where $X_l\neq 0$.

Note that $\frac{X_0}{X_l}\varphi$, $\frac{\overline{X}_0}{\overline{X}_l}\varphi$ and $\frac{\mathrm{d}X_0}{X_l}\wedge\varphi=\frac{\mathrm{d}(X_0\varphi)-X_0\mathrm{d}\varphi}{X_l}$ as well as $\frac{\mathrm{d}\overline{X}_0}{\overline{X}_l}\wedge\varphi$ have no components along \mathbb{P}_{N-1} .

By the structure theorem of Federer, we can write $\frac{X_0}{X_l}R=i_{0*}v$ with i_0 the injection $\mathbb{P}_{N-1}\hookrightarrow\mathbb{P}_N$ where v is some current of bidimension (q,q) in \mathbb{P}_{N-1} . So there is a current u of bidimension (q,q) in \mathbb{P}_{N-1} such that $R=i_{0*}u$ modulo a current annihilated by $\frac{X_0}{X_l}$ and $\frac{\overline{X}_0}{\overline{X}_l}$. By the second part of the Lemma 1, we obtain

$$R = i_{0*}u + \partial(\frac{\overline{X}_l}{\overline{X}_0}) \wedge a + \overline{\partial}(\frac{X_l}{X_0}) \wedge b$$

where a,b are some currents in the coordinates $\frac{X_1}{X_0},\ldots,\frac{X_N}{X_0}$. Since $\partial R_{\varphi}=R_{\partial\varphi}$ and $\overline{\partial} R_{\varphi}=R_{\overline{\partial}\varphi}$, necessarily we have a=0=b and we can write $R=R_{\varphi}=i_{0*}u_{\varphi}$ where $u_{\varphi}=u$ is some current of bidimension (q,q) in \mathbb{P}_{N-1} .

The extended (q,q)-current S of T to \mathbb{P}_N is obtained by setting

$$\int_{\mathbb{P}_N} S \wedge \varphi = \int_{\mathbb{P}_{N-1}} T \wedge u_{\varphi} \tag{4}$$

for all smooth differential (N-q,N-q)-forms φ in \mathbb{P}_N . Since $u_{\mathrm{d}\varphi}=\mathrm{d}u_{\varphi}$, we have that $\mathrm{d}S=0$ in \mathbb{P}_N .

3.2. Cohomology classes contained in an algebraic hypersurface of X

The extended current S can be used to characterize the property that the cohomology class $\{T\}$ is contained in an algebraic hypersurface of X.

Proposition 7. The cohomology class $\{T\}$ is contained in an algebraic hypersurface of X if and only if the extended current S is of order 0 in \mathbb{P}_N .

Proof. If S is of order 0, then μ is a measure and we can apply the Lebesgue-Nikodym decomposition theorem $\mu = \mu_{\text{abs}} + \mu_{\text{sing}}$. We define $S_0 = ({}^t\mathcal{R})(\mu_{\text{abs}})$ and $S_1 = ({}^t\mathcal{R})(\mu_{\text{sing}})$, thus $\{S_{0|X}\} = \{S_0\}_{|X}$. By (3), we know that supp μ_{sing} is independent of T, so it is an algebraic subset. In fact,

supp
$$\mu_{\text{sing}} = \{ A \in C_{N-q}(\mathbb{P}_N), A \text{ non transverse to } X \}$$

and we have an algebraic stratification $\Sigma_0 \supset \Sigma_1 \supset \ldots \supset \Sigma_q$ with

$$\Sigma_i = \{ A \in C_{N-q}(\mathbb{P}_N), \dim(A \cap X) \ge n - q + i \}$$

for $0 \le i \le q$ and $n = \dim X$. Since S can be restricted to X, we have $1_{\Sigma_a} \mu = 0$ and we can decompose

$$\mu = \sum_{0 \le i \le q-1} 1_{\Sigma_i \setminus \Sigma_{i+1}} \mu$$

which gives $S = S_0 + S_{1,1} + \ldots + S_{1,q-1}$. In other words $A \in \Sigma_i \setminus \Sigma_{i+1} \Leftrightarrow \dim(A \cap X) = n - q + i$, thus

$$S_{1,i} = \int_{A \in \Sigma_i \setminus \Sigma_{i+1}} [A] \mu(A)$$

and we can calculate the restriction current in X by

$$S_{1,i|X} = \int_{A \in \Sigma_i \backslash \Sigma_{i+1}} [A]_{|X} \mu(A) = \int_{A \in \Sigma_i \backslash \Sigma_{i+1}} \mu(A) j_* u$$

where $j:A\cap X\hookrightarrow X$ is the natural injection and u is a closed (i,i)-current in $A\cap X$ depending on A. At the cohomological level we write

$$\{S_{1,i|X}\} = \int_{A \in \Sigma_i \setminus \Sigma_{i+1}} \mu(A) j_*\{u\}$$

and we use that the subspace of $H^{q,q}(X)$ of the finite sums $\sum j_*\{u\}$ is closed. In such a way, we obtain that the cohomology class $\{S_{1,i|X}\}$ is contained in some $A\cap X$ with A such that $\dim(A\cap X)=n-q+i$. As a conclusion $\{S_{1|X}\}$ is contained in an algebraic hypersurface of X.

Conversely, when the cohomology class $\{T\}$ is contained in an algebraic hypersurface of X, we write $T=i_*r+\mathrm{dd^c}\tilde{v}=(\mathrm{dd^c}v)$ where $i:X\cap H\hookrightarrow X$ is the canonical injection with $H\subset \mathbb{P}_N$ an algebraic hypersurface and where v is a differential (q-1,q-1)-form smooth in $X\setminus X\cap H$ and $\mathrm{L}^1_{\mathrm{loc}}$ in X such that $\mathrm{dd^c}v$ calculated generically is $\mathrm{L}^1_{\mathrm{loc}}$ in X.

We extend v to \mathbb{P}_N by V a differential (q-1,q-1)-form \mathcal{L}^1_{loc} in \mathbb{P}_N such that $\mathrm{dd}^c V$ calculated generically is \mathcal{L}^1_{loc} in \mathbb{P}_N . In fact, there is an open covering (U_α) of \mathbb{P}_N with a family (ρ_α) of holomorphic submersions $\rho_\alpha: U_\alpha \to X \cap U_\alpha$ such that $\rho_{\alpha|X \cap U_\alpha} = \mathrm{id}_{X \cap U_\alpha}$. When (λ_α) is a smooth partition of the unity subordinated to (U_α) , we take $V = \sum_\alpha \lambda_\alpha \rho_\alpha^*(v_{|X \cap U_\alpha})$.

Then $T = S_{|X}$ with $S = (\mathrm{dd^c}V) = j_*R + \mathrm{dd^c}\tilde{V}$ where $j: H \hookrightarrow \mathbb{P}_N$ is the canonical injection and R is a (q-1,q-1)-current closed of order 0 in H.

Without assuming S of order 0, for all $B \in \mathbb{G}_{q,N}$, we can express, in a similar way to (4), the intersection number of S and [B] as being

$$\int_{\mathbb{P}_N} S \wedge [B] = \int_X T \wedge w_{[B]}$$

where $w_{[B]}$ is some current of bidimension (q,q) in X. When S is of order 0, this intersection number, which can be calculated by Fourier transform (see [8]), is continuous with respect to $B \in \mathbb{G}_{q,N}$.

On another hand, there is a family of smooth differential (q,q)-forms S_{ε} weakly converging in \mathbb{P}_N to S such that

$$\int_{\mathbb{P}_N} S \wedge [B] = \lim_{\varepsilon} \int_B S_{\varepsilon} = \lim_{\varepsilon} \mathcal{J}(S_{\varepsilon})(B)$$

with \mathcal{J} : {continuous differential forms of type (q,q) on \mathbb{P}_N } \to {continuous functions on $\mathbb{G}_{q,N}$ } the Radon transformation defined for projective subspaces B in \mathbb{P}_N of dimension q. Then $\mathcal{J}(S_{\varepsilon})$ converges weakly in $\mathbb{G}_{q,N}$ to $\mathcal{J}(S)$, which is constant on $\mathbb{G}_{q,N}$, since S is closed. Thus for almost every $B \in \mathbb{G}_{q,N}$, we have

$$\int_{\mathbb{P}_N} S \wedge [B] = (\deg S)(\deg B) = \deg S.$$

When the cohomology class $\{T\}$ is contained in an algebraic hypersurface of X, we obtain the condition $\int_X T \wedge w_{[B]} = (\deg S)(\deg B) = \deg S$ for all $B \in \mathbb{G}_{q,N}$.

Remark 1. We can give an explicit construction of S by using the King formula.

In fact, let $D_{\mathbb{P}_N}$ be the diagonal in $\mathbb{P}_N \times \mathbb{P}_N$, which can be written $D_{\mathbb{P}_N} = f^{-1}(0)$ where f is a holomorphic section of a Hermitian holomorphic vector bundle E over $\mathbb{P}_N \times \mathbb{P}_N$. Then $D_X = (f_{|X \times X})^{-1}(0)$ and we have the expression

$$[D_X] = -(\mathrm{dd^c} \log ||f||)_{|(X \times X) \setminus D_X}^n + \mathrm{dd^c} \gamma$$

for the integration current on D_X in $X \times X$, where the differential (n-1, n-1)-form γ is L^1_{loc} in $X \times X$ and smooth in $(X \times X) \setminus D_X$. In $\mathbb{P}_N \times X$, we define the closed (n, n)-current of order 0

$$\mathcal{K} = -(\mathrm{dd^c} \log ||f||)_{|\mathbb{P}_N \times X}^n + \mathrm{dd^c} \mathcal{G}$$

where \mathcal{G} is an extension to $\mathbb{P}_N \times X$ of γ obtained as in the proof of the Proposition 7.

We denote by $\pi_1: \mathbb{P}_N \times X \to \mathbb{P}_N$ and by $\pi_2: \mathbb{P}_N \times X \to X$ the natural projections and we set $E_0 = \pi_{1*}(\mathcal{K} \wedge \pi_2^*T)$ which is a closed (q,q)-current of order 0 in \mathbb{P}_N . Now we calculate the intersection number

$$\int_{\mathbb{P}_N} E_0 \wedge i_{0*} u = \int_{\mathbb{P}_N \times X} \mathcal{K} \wedge \pi_1^* i_{0*} u \wedge \pi_2^* T = \int_{\mathbb{P}_N \times X} \mathcal{K} \wedge [X \times X] \wedge \pi_1^* \tilde{u} \wedge \pi_2^* T$$

where \tilde{u} is a smooth extension of the smooth differential form u to \mathbb{P}_N .

In view to express the current $[X \times X] = \pi_1^* [X]$ in $\mathbb{P}_N \times X$, we write $X = \{P_j = 0\}$ with (P_j) a finite family of homogeneous polynomials on \mathbb{C}^{N+1} and $m_j = \deg P_j$ for each j. We set $\rho([x]) = \sum_j \frac{|P_j(x)|^2}{\|x\|^{2m_j}}$ which satisfies $X = \rho^{-1}(0)$ in \mathbb{P}_N and

$$[X] = \delta_{\rho} \frac{(\mathrm{dd^{c}} \rho)^{N-n}}{2^{N-n}(N-n)} = \lim_{\lambda \to 0^{+}} \{ \lambda \rho^{\lambda - (N-n)} \frac{(\mathrm{dd^{c}} \rho)^{N-n}}{2^{N-n}(N-n)} \}$$

with δ_{ρ} the distribution which is the residue at the pole -(N-n) of the meromorphic map $\mathbb{C} \ni \lambda \to \rho^{\lambda}$. We define in $\mathbb{P}_N \times X$ the current product of closed currents

$$\mathcal{K} \wedge [X \times X] = (\delta_{\rho} \circ \pi_1) \mathcal{K} \wedge \pi_1^* \left(\frac{(\mathrm{dd^c} \rho)^{N-n}}{2^{N-n} (N-n)} \right)$$

which is closed too and annihilated by the $P_j \circ \pi_1$ and their conjugates. With

$$\alpha = \mathrm{d^c} \big(\frac{1}{2^n (n-1)} \big(\frac{\mathrm{dd^c} \|f\|^2}{\|f\|^2} \big)^{n-1} \big)_{|\mathbb{P}_N \times X}$$

we have $-(\mathrm{dd^c}\log \|f\|)_{\mathbb{P}_N\times X}^n=\mathrm{d}\alpha$ and we set actually

$$-(\delta_{\rho} \circ \pi_1)(\mathrm{dd^c} \log ||f||)_{|\mathbb{P}_N \times X}^n = \mathrm{d}((\delta_{\rho} \circ \pi_1)\alpha) - \mathrm{d}(\delta_{\rho} \circ \pi_1) \wedge \alpha$$

where the products with α are obtained by the division theorem. Otherwise we have

$$-(\delta_{\rho} \circ \pi_1)(\mathrm{dd^c} \log \|f\|)_{|\mathbb{P}_N \times X}^n = -\lim_{\lambda \to 0^+} \lambda(\rho \circ \pi_1)^{\lambda - (N-n)}(\mathrm{dd^c} \log \|f\|)_{|\mathbb{P}_N \times X}^n$$

where $-(\mathrm{dd^c} \log ||f||)_{|\mathbb{P}_N \times X}^n$ is the direct image by a blowing up of a closed smooth differential form and the weak limit when $\lambda \to 0^+$ is calculated thanks to the Bernstein equation.

So there is a closed (n, n)-current \mathcal{L} in $\mathbb{P}_N \times X$ such that supp $(\mathcal{L}_{|X \times X}) = D_X$ and

$$\mathcal{K} \wedge [X \times X] = i_*([D_X] - \mathcal{L}_{|X \times X})$$

with $i: X \times X \to \mathbb{P}_N \times X$ the natural injection. The order of \mathcal{L} is not equal to 0, because the codimension of the polar set changes by blowing up. In such a way we can express the restriction

$$E_{0|X} = T - (\pi_{1|X\times X})_* (\mathcal{L}_{|X\times X} \wedge (\pi_{2|X\times X})^* T).$$

Therefore we take $S = \pi_{1*}((\mathcal{K} + \mathcal{L}) \wedge \pi_2^*T)$ which satisfies $S_{|X} = T$ in the sense of the Proposition 4. Lastly the differential form u_{φ} is given by $u_{\varphi} = \pi_{2*}((\mathcal{K} + \mathcal{L}) \wedge \pi_1^*\varphi)$.
