## Superconductivity in the crystallogenide $LaFeSiO_{1-\delta}$ with squeezed FeSi layers

Pnictogens and chalcogens are both viable anions for promoting Fe-based superconductivity and intense research activity in the related families has established systematic correlation between the Feanion height and the superconducting critical temperature  $T_c$ , with an optimum Fe-anion height of ~ 1.38 Å. Here, we report the discovery of superconductivity in a novel compound LaFeSiO<sub>1- $\delta$ </sub> that incorporates a crystallogen element, Si, and challenges the above picture: considering the strongly squeezed Fe-Si height of 0.94 Å, the superconducting transition at  $T_c = 10$  K is unusually high. In the normal state, the resistivity displays non-Fermi-liquid behavior while NMR experiments evidence weak antiferromagnetic fluctuations. According to first-principles calculations, the Fermi surface of this material is dominated by hole pockets without nesting properties, which explains the strongly suppressed tendency towards magnetic order and suggests that the emergence of superconductivity materializes in a distinct set-up, as compared to the standard  $s_{\pm}$ - and d-wave electron-pocketbased situations. These properties and its simple-to-implement synthesis make LaFeSiO<sub>1- $\delta$ </sub> a particularly promising platform to study the interplay between structure, electron correlations and superconductivity.

#### **10 INTRODUCTION**

Iron-based superconductors (IBSC) are presently a 11 well established class of unconventional superconductors, 12 <sup>13</sup> spanning multiple structural families [1]. At their core, IBSCs consist of a square planar lattice of Fe atoms, 14 tetrahedrally coordinated by pnictogen or chalcogen el-15 ements X (typically X = As or Se) placed above and 16 below the Fe plane. Different spacers can be intercalated 17 between this central structural unit, thereby forming the 18 different IBSC families. It turns out that the supercon-<sup>20</sup> ducting critical temperature  $(T_c)$  can be correlated with <sup>21</sup> the X anion height from the Fe plane  $h_{\text{Fe-}X}$  (shown in <sup>22</sup> Fig. 2b), with the maximum  $T_c \simeq 56$  K corresponding <sup>23</sup> to  $h_{\text{Fe-}X} \sim 1.38$  Å [2, 3]. At the optimal height, the  $FeX_4$  tetrahedra becomes regular with the X-Fe-X angle 24  $\alpha = 109.47^{\circ}$ . The IBSC class has recently been extended 25 to other layered materials where pnictogen/chalcogen 26 atoms are replaced by Ge in YFe<sub>2</sub>Ge<sub>2</sub> and by Si in LaFe-27 SiH and LaFeSiF<sub>x</sub> [4–6]. This is very interesting because 28 it further establishes the prospect of finding more IBSCs. 29 Simultaneously, it is also surprising since the use of crys-30 31 tallogens -i.e. group 14 elements has been discussed as detrimental to superconductivity since a ferromagnetic 32 ground state should become favoured as opposed to the 33 anti-ferromagnetic ground state which is normally asso-34 ciated with the parent compounds of IBSCs [7]. 35

In this work, we report a further extension of the ironar crystallogen superconductors with the synthesis of the as novel compound LaFeSiO<sub>1- $\delta$ </sub>. This compound represents <sup>39</sup> a new intriguing member of the so-called 1111 family <sup>40</sup> not only for evading ferromagnetism but also, and per-<sup>41</sup> haps more importantly, because of its exceptional crys-<sup>42</sup> tal structure (Fig. 2a) where the Fe-Si height drops to <sup>43</sup> 0.94(1) Å. This parameter is far away from what is con-<sup>44</sup> sidered the optimal geometry for superconductivity in <sup>45</sup> the IBSCs, and indeed produces drastic changes in the <sup>46</sup> electronic properties as we show below. Yet, supercon-<sup>47</sup> ductivity is observed below onset  $T_c = 10$  K with a small <sup>48</sup>  $\delta = 10$  % oxygen deficit in the compound. This find-<sup>49</sup> ing thus challenges the current notion that crystallogens <sup>50</sup> should be avoided when searching for new IBSCs, and <sup>51</sup> provides a qualitatively new platform to further scruti-<sup>52</sup> nize the link between the crystal structure and the elec-<sup>53</sup> tronic properties in Fe-based superconductors.

### 54 RESULTS

#### <sup>55</sup> Synthesis and Crystallographic structure

56 Polycrystalline LaFeSiO<sub>1- $\delta$ </sub> samples were synthesized 57 from the non-superconducting, weak Pauli paramagnet 58 LaFeSi precursor [8] (see details in Methods). Fig. 1 <sup>59</sup> shows the energy dispersive X-ray spectroscopy (EDX) 60 spectrum of one crystallite measured after oxygenation <sup>61</sup> in a transmission electron microscope (TEM). The ele-62 mental composition deduced from the spectrum confirms 63 the atomic ratio 1:1:1 for the elements La, Fe and Si 64 as in the precursor. In addition, we observe an intense peak at 0.525 keV. This peak corresponds to the  $K_{\alpha_1}$ 66 electronic transition of oxygen, which shows that oxy-67 gen is present. The inset in Fig. 1 shows the hk0-<sup>68</sup> plane of the 3D electron diffraction patterns obtained <sup>69</sup> from the crystallite. This cut reveals that the tetragoro nal P4/nmm space-group symmetry of the precursor is 71 preserved after oxygenation. Furthermore, the analysis

It is also interesting to consider the resulting angle 109 110  $\alpha$ (Si-Fe-Si) of the FeSi<sub>4</sub> tetrahedral unit as this is of-111 ten used as a measure of the tetrahedral geometry. The  $T_c$  is normally optimised around the regular tetrahedron 113 value namely  $\alpha = 109.47^{\circ}$  [11, 13–15]. In LaFeSiO<sub>1- $\delta$ </sub> the 114  $\alpha$  angle is found to be  $\alpha = 130.9$  (8)°, resulting from the <sup>115</sup> compression of the Fe-Si layer along the *c*-axis upon in-<sup>116</sup> sertion of oxygen. The lation between  $h_{Fe-Si}$  and  $T_c$  currently proposed in the 103 magnetic susceptibility of pyrolytic carbon, the strongest literature for iron pnictides or -chalcogenides, this geom- 104 non-superconducting diamagnetic substance known in 165 the literature [20]. Therefore, the diamagnetic signal ob-166 served in these measurements again evidences superconductivity in LaFeSiO<sub>1- $\delta$ </sub>. 167

We note that the measured volume susceptibility is a 169 linear combination of contributions from the supercon-170 ducting LaFeSiO $_{1-\delta}$  phase and the ferromagnetic back-171 ground, the two having opposite signs. Therefore, the <sup>172</sup> apparent susceptibility yields just a lower bound for the 173 estimate of the superconducting volume fraction, which 174 is 15%. Such moderate superconducting volume fraction, 175 as well as the relatively broad transition observed in the 176 resistivity, may also be linked to chemical inhomogeneity 177 on the oxygen site arising from the sluggish nature of the 178 oxygenation process. #### <sup>197</sup> Normal-state properties

In the normal state, the resistivity varies as  $T^{\alpha}$  as found 198 in other Fe-based superconductors [21–23]. While enlarg-199 ing the fitting range tends to decrease  $\alpha$  and to degrade 200 the fit quality, a good fit to  $T^{1.4}$  is obtained up to 80 K as 201 shown in Fig. 3a. Finding  $\alpha \neq 2$  is typical of non Fermi-202 <sup>203</sup> liquid behavior. Considering the established correlation between the resistivity exponent  $\alpha$  and the strength of 204 spin fluctuations [24–26], the value  $\alpha \simeq 1.4$  suggests that 205 charge carriers in LaFeSiO<sub>1- $\delta$ </sub> are scattered off spin fluc-206 tuations of similar strength as moderately overdoped Fe-207 based pnictides, tetragonal  $\text{FeSe}_{1-x}S_x$  [27] or  $\text{YFe}_2\text{Ge}_2$ 208 [28]. As we now explain, the presence of spin fluctua-209 tions is supported by our <sup>29</sup>Si nuclear magnetic resonance 210 (NMR) results. 211

First, we observe that the Knight shift K decreases 212 213 from room T down to low T (Fig. 4a). As in most Fe-214 based superconductors of various doping levels, this be-215 havior reflects the decrease of the static, uniform spin <sup>216</sup> susceptibility  $\chi_{\rm spin}(q=0)$  upon cooling (see for example refs. [25, 26, 29-32]). Visibly, the Fe d electrons produce a transferred hyperfine field at Si sites, just as they do at 218 <sup>219</sup> As/Se sites in iron pnictides/chalcogenides. <sup>29</sup>Si NMR thus promises to be a sensitive probe of the electronic 220 properties in this new family of Fe-based superconduc-221 tors. 222

Here, in LaFeSiO<sub>1- $\delta$ </sub>, we find that the spin-lattice re-223 224 laxation rate  $1/T_1$  divided by temperature T increases  $_{225}$  at low T (Fig. 4c), which signifies that the low-energy  $(\sim \mu eV)$  spin fluctuations strengthen upon cooling. The 226 observed ~ 50 % enhancement of  $1/(T_1T)$  resembles data 227 in the middle of the overdoped regime of 1111 or 122 fam-228 229 ilies of iron-based superconductors, for which spin fluctuations are relatively weak [25, 26, 29–38]. > The NMR data also provide evidence of spatial hetero-263 <sup>264</sup> geneity, as observed in several Fe-based materials [33–38]:  $_{265}$  upon cooling below  $\sim 100$  K, the moderate increase of 266 the line width (Fig. 4b) indicates that the distribution 267 of Knight shift values broadens. The concomitant devi-<sup>268</sup> ation from 1 of the stretching exponent  $\beta$  (Fig. 4d and 269 Methods) shows that a distribution of  $T_1$  values develops 270 alongside with the growth of spin fluctuations. The dis-<sup>271</sup> tributed K and  $T_1$  likely stem from spatial variations of <sup>272</sup> the electronic spin polarization around defects [42, 43].

> Finally, we notice that  $1/(T_1T)$  no longer increases be-273  $_{\tt 274}$  low 20 K and even drops somewhat below 10 K, that is, <sup>275</sup> below a temperature close to the zero-field  $T_c$  (Fig. 4c).  $_{276}$  This is surprising since the magnetic field of 15 T used 277 in the NMR experiment should be close to the supercon-278 ducting upper critical field  $H_{c2}$  (see above) and thus we 279 would expect to see essentially no sign of superconduc-<sup>280</sup> tivity down to our lowest temperature of 1.7 K. That the 281 stretching exponent  $\beta$  concomitantly reverts its T depen-<sup>282</sup> dence (Fig. 4d) suggests that both the spectral weight 283 and the inhomogeneity of low-energy spin fluctuations 284 are reduced below 10 K. This behavior is unlikely to 285 arise from inhomogeneous superconductivity in the sam-286 ple or from freezing of spin fluctuations at the NMR 287 timescale [33] as both mechanisms should not lessen the 288 inhomogeneity. More work is however required to under-289 stand this interesting pseudogap-like behavior that paral- $_{290}$  lels earlier observations in LiFeP [40] as well as in Co and <sup>291</sup> F-doped LaFeAsO [37, 38, 44]) and  $\text{FeSe}_{1-x}S_x$  [31, 45].

In this way, the hole doping introduced 309 by the As  $\rightarrow$  Si substitution is absorbed in a non-rigid-310 band-shift fashion and results in tiny electron pockets at 311 312 the zone edge (M-A line). When it comes to superconductivity, however, the band that mainly absorbs this 313 doping remains passive in the standard picture (see e.g. 314 [47]). Moreover, one of the electron pockets around the 315 M-A line looses its Fe- $3d_{x^2-y^2}$  content in favor of a Si-2p316 character due to the hybridization with the presumably 317 passive band that now crosses the Fermi level at the zone 318 319 edge and further provides the Fermi-surface sheet with the largest area. This drastically deteriorates the nesting 320 of the Fermi surface, and thereby the tendency towards 321 single-stripe AFM order as we discuss below. 322
