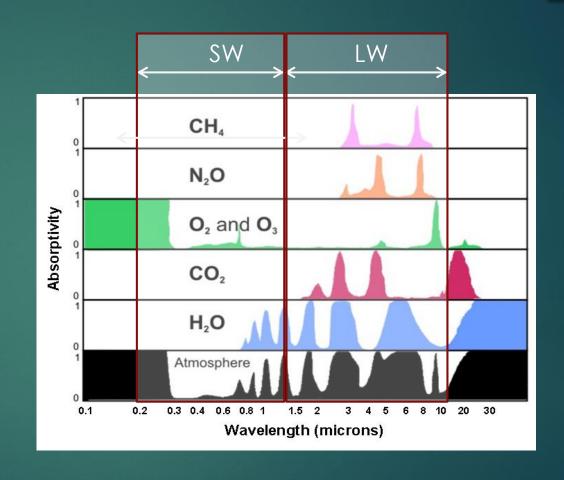

Changes in atmospheric greenhouse gases

Part 1. Long lived greenhouse gases

- 70-75% of SW (solar) radiation passes throu<gh the atmosphere
- 15-30% of the earth LW radiation escapes from the top of the atmosphere
- The LW trapped by GHG heats the lower troposphere by ~ +18°C



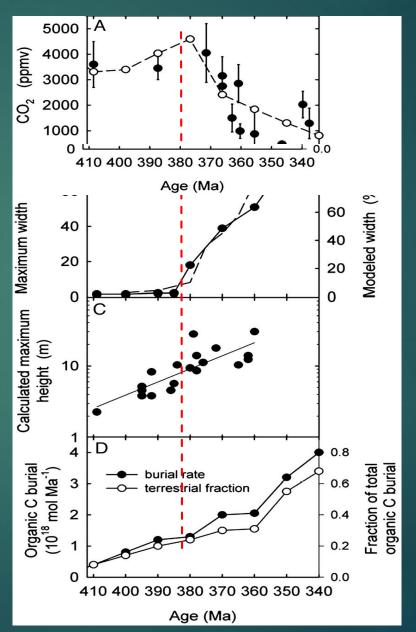
Part1. Concise history of the GHG atmospheric concentration:

Link with land colonisation

- CO₂ atmospheric concentration
- Conductive plant tissues (tracheids)
- Wood (lignin), leaves
- Trees (coniferous)

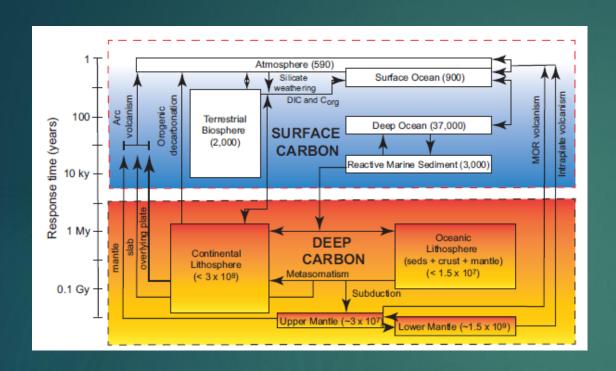

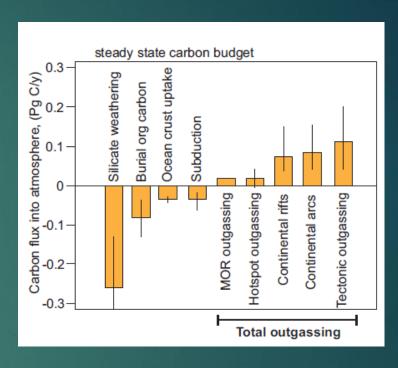


Part 1. The control of the GHG concentration: long term processes (10⁶ – 10⁸ yrs)



 Atmospheric carbon is ~3 10⁻⁷ of earth carbon and 1,3% of surface carbon

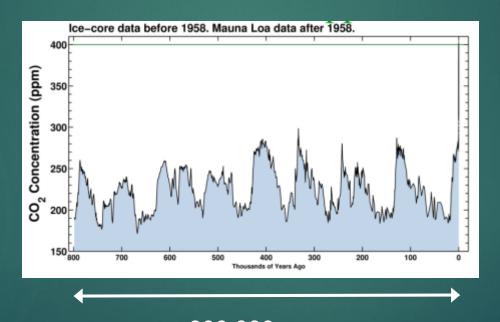
 Atmospheric carbon content is controlled ultimately by the balance between sources and sinks

Part 1. Atmospheric carbon, past 800 000 years.









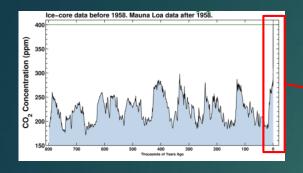
800.000 years [CO₂] varied from 180 to 290 ppmv in response to glaciations episodes

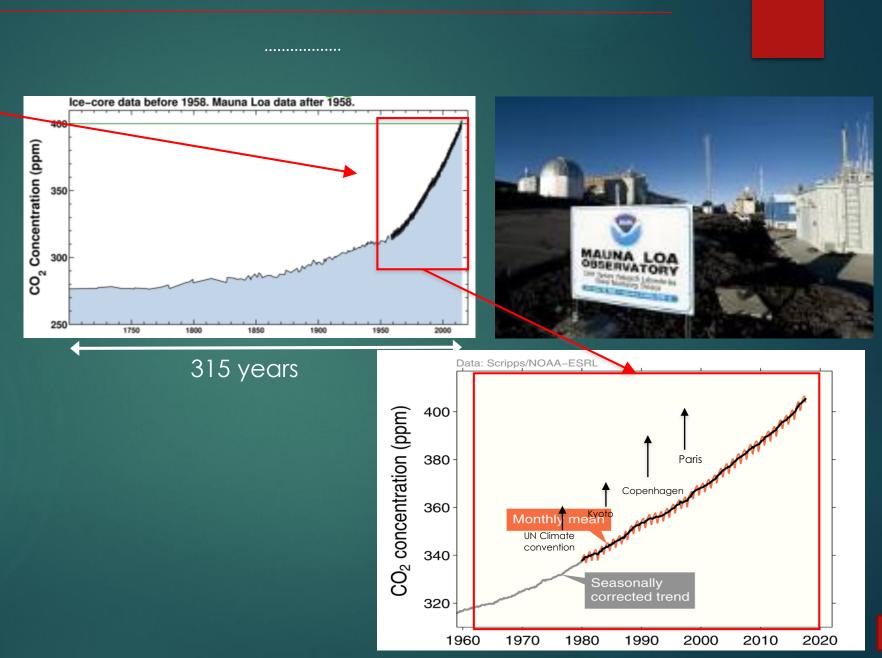

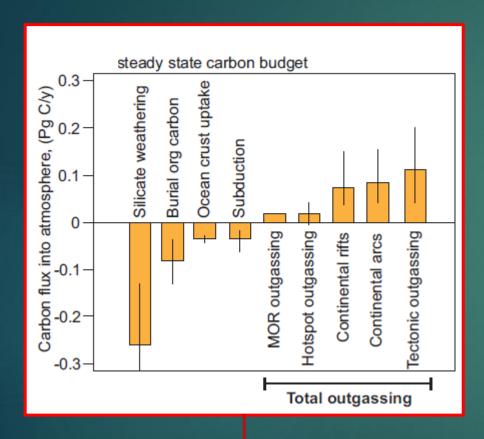

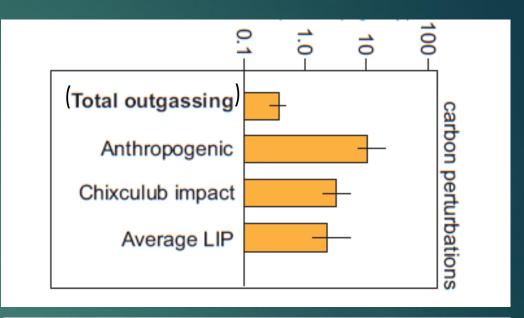

Fossil fuel emission (2010)



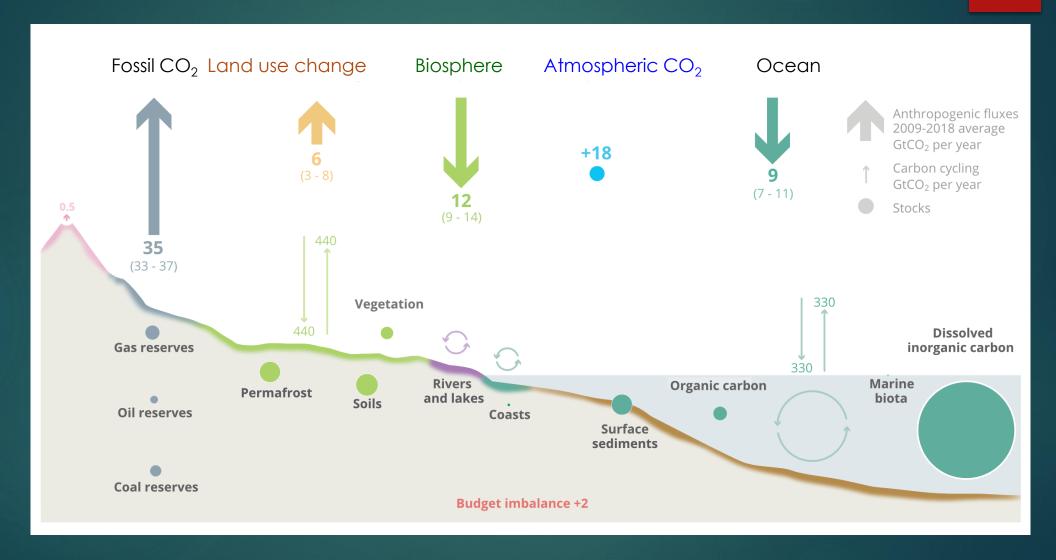
Disturbances in the carbon flux into the atmosphere (PgC.yr-1).

- Anthropogenic are fossil C emissions
- Chicxulub refers to the end-Cretaceous asteroid impact having led to mass extinction
- LIP to the large igneous provinces.

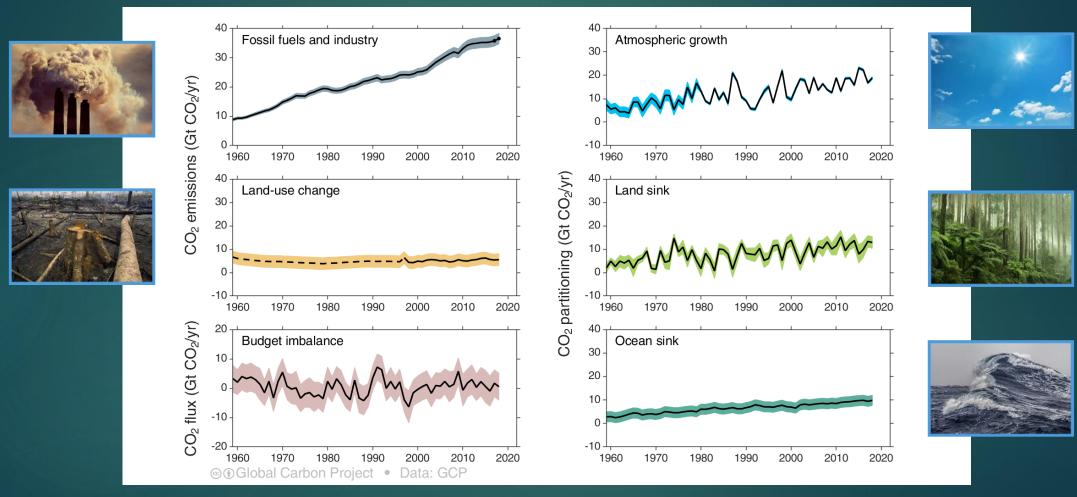

Recent changes in the surface carbon budget

The sinks have continued to grow with increasing emissions, but climate change will affect carbon cycle processes in a way that will exacerbate the increase of CO₂ in the atmosphere

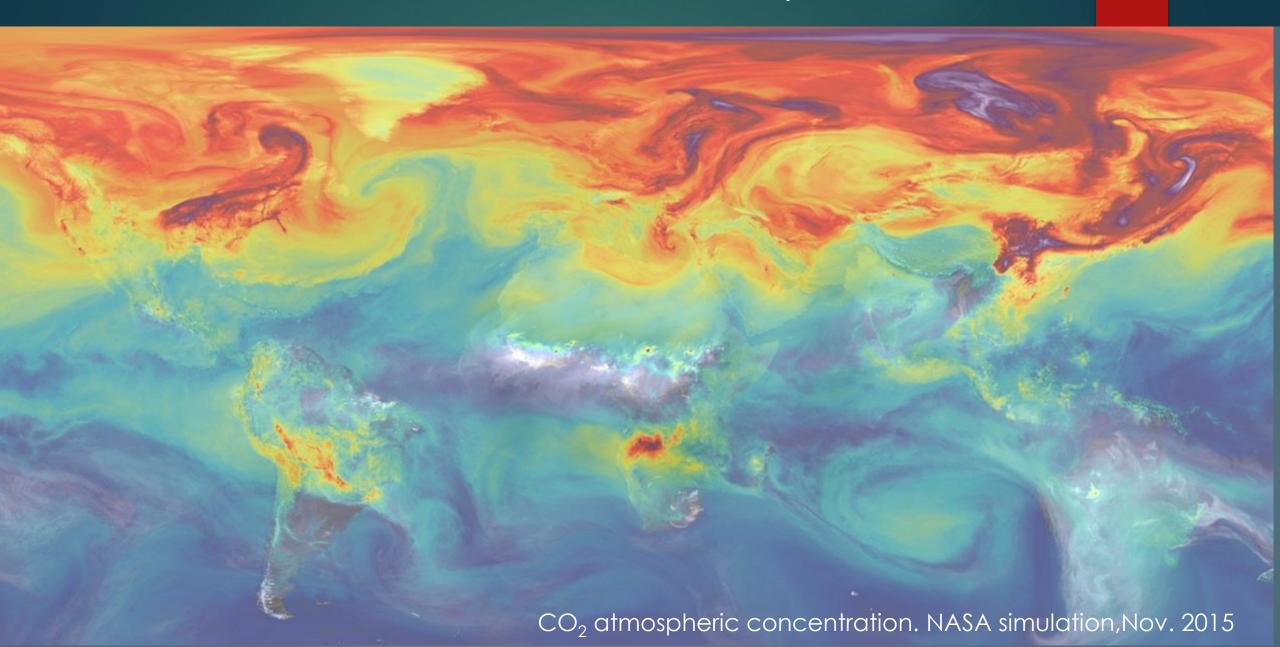


The budget imbalance is the total emissions minus the estimated growth in the atmosphere, land and ocean.

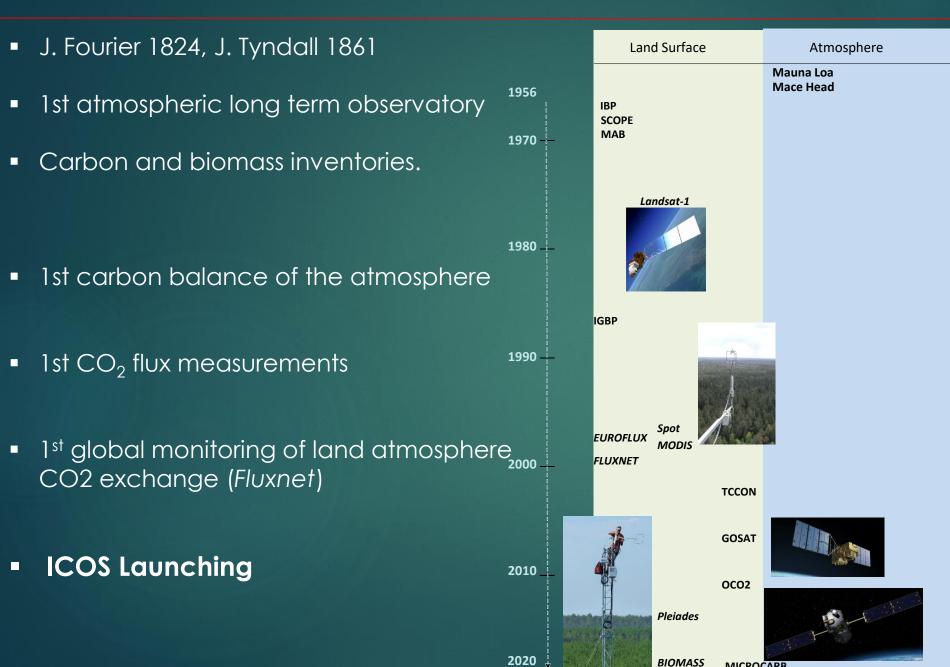
It reflects the limits of our understanding of the carbon cycle.

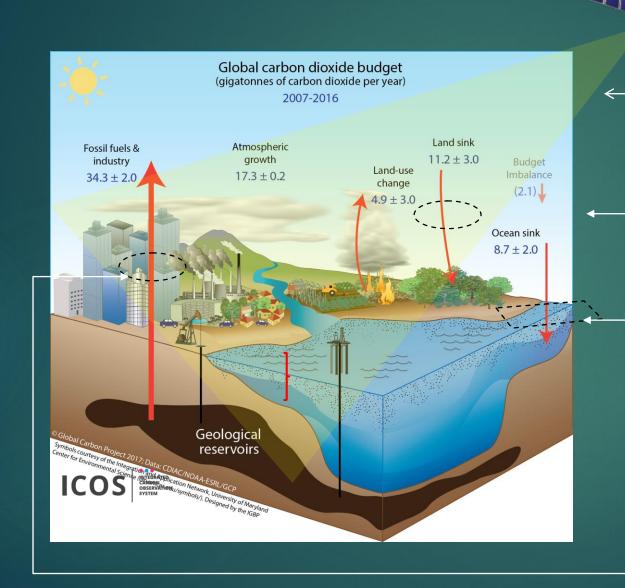

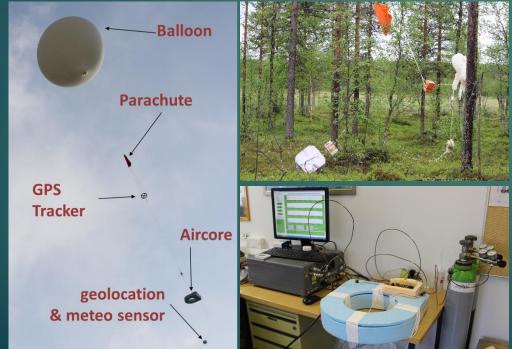


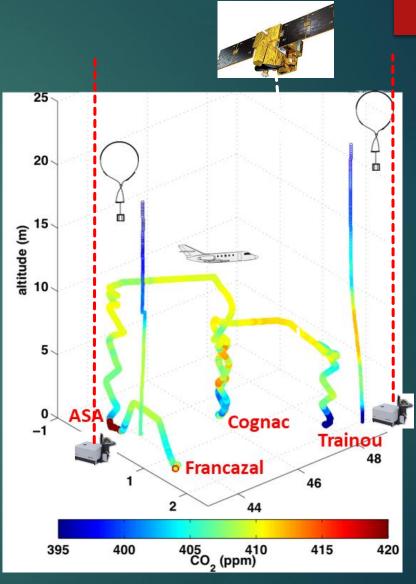




Part 2. Aircores: vertical sampling of the atmosphere



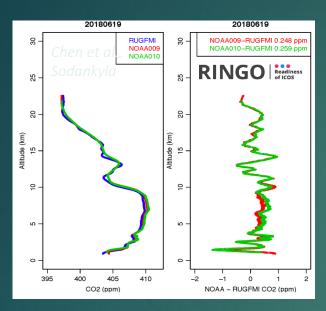




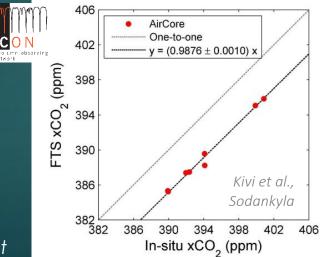

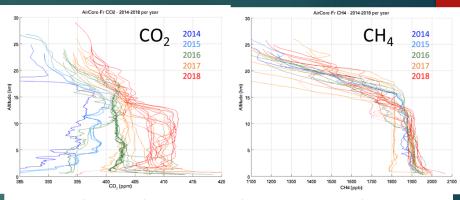

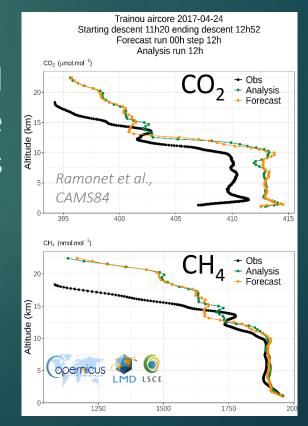

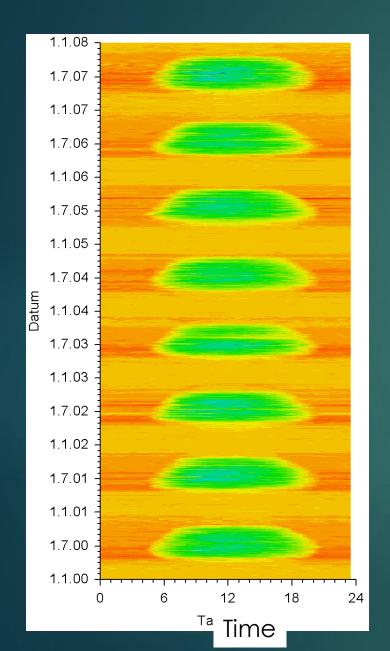

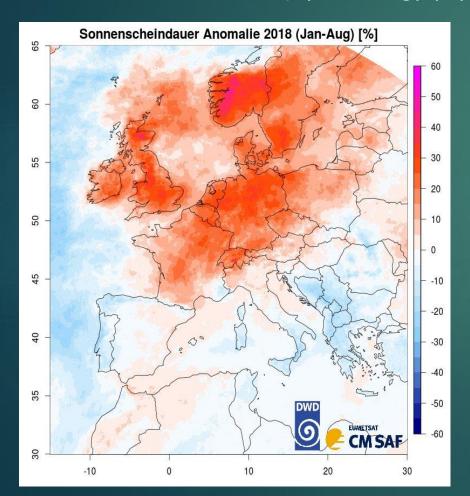

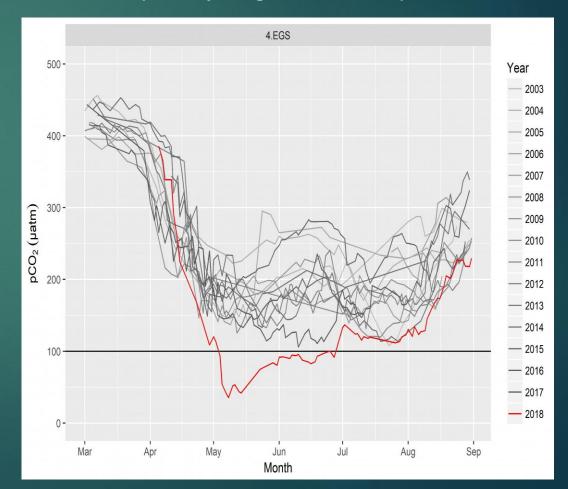

Sunshine hour anomaly (Jan-Aug) (%)

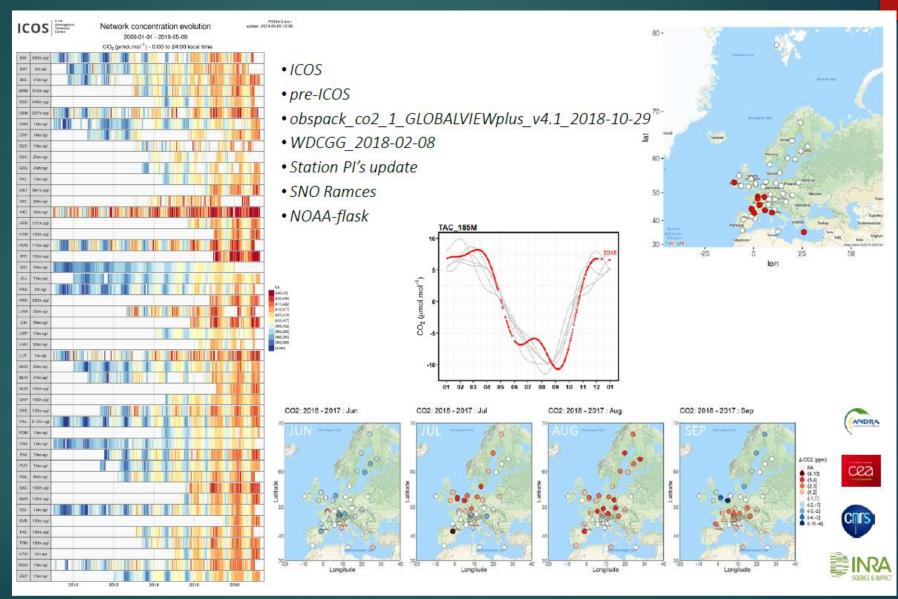

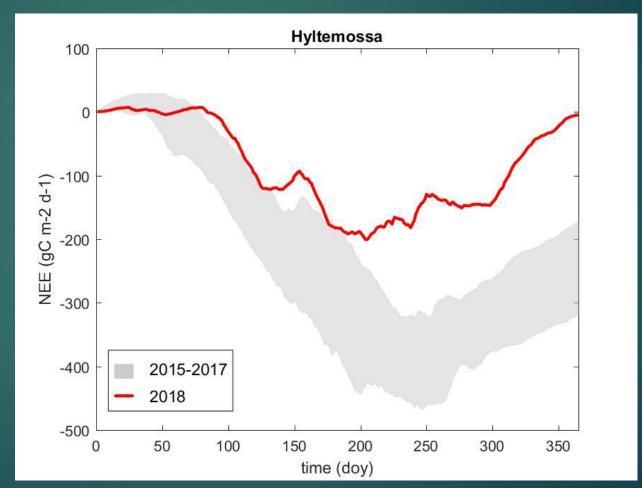


[CO₂] air seasonal cycles

Part 3.

How could we see the unseen?

- GHG exchange with land surface is changing continuously in response to:
 - CO₂ concentration,
 - Climate,
 - Ozone, nitrogen & sulfur deposition,
 - Management...

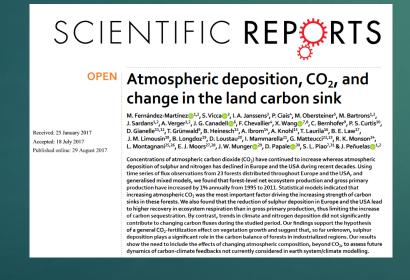
Effects are:

- Non-linear, accumulative or transient
- o Interacting:
 - \Rightarrow antagonistic (CO₂ × O₃),
 - \Rightarrow synergestic (CO₂ × N, T × VPD)
- Heterogeneous in temporal and spatial domains

Are we able to observe and understand the temporal variations in land surface GHG?







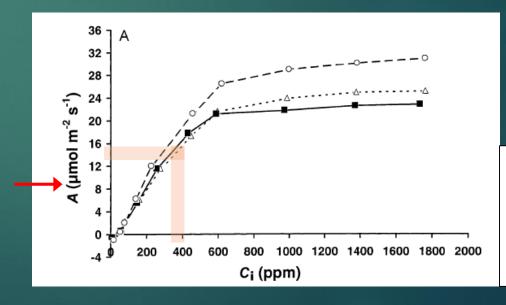


The CO₂ case

Well documented temporal evolution since 1958 (see previous slides)

Well-known effect on CO₂ uptake at leaf and plant level:

The [CO2]_a change from 1995 to 2015, (+ 40 ppm) enhances leaf photosynthesis (A) by 12-15%

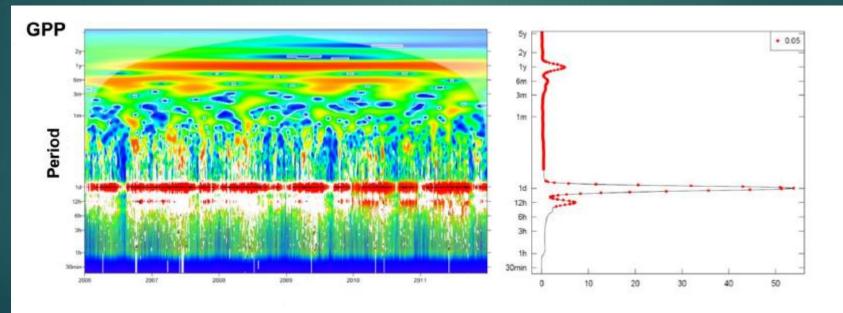
The CO₂ case

What to observe?

→ Gross CO₂ uptake by land surface, GPP

At which resolution / scale ?

→ Instantaneous values (hour) and temporal integrals (year)



Power spectrum of GPP at the Puechabon forest site 2006-2011.

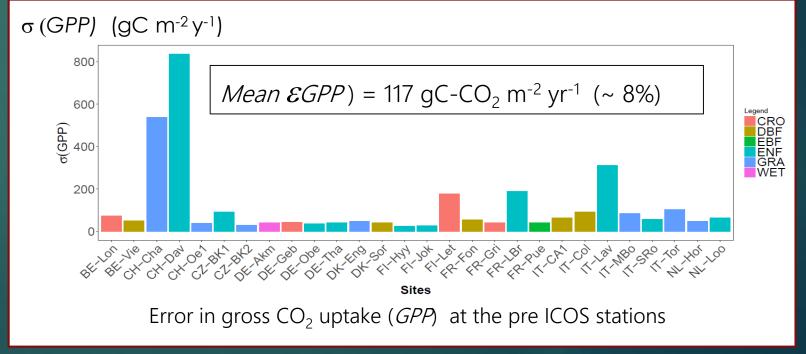

1^{st} step . Assessment of the uncertainty in GPP measurements arepsilon(GPP)

- u* filtering,
- Random uncertainty
 - Instrument noise
 - Covariance sampling error

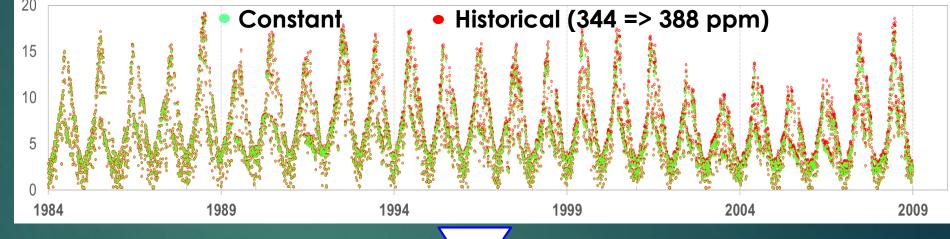




2nd step. Expected magnitude of [CO₂] impact on GPP: model results

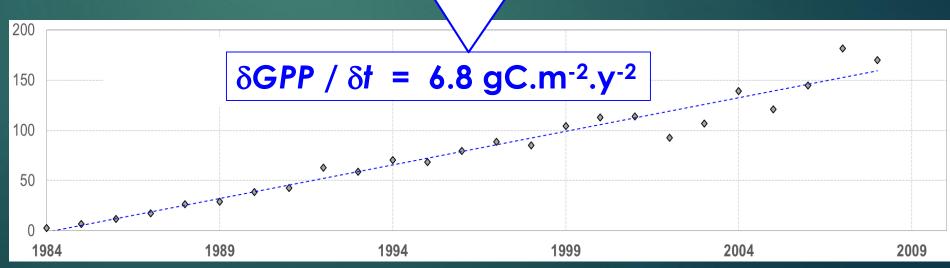
30yr old coniferous forest – Gross CO₂ uptake (GPP)

Daily GPP (gC.m⁻² d⁻¹)



Annual drift δGPP (Hist – Const)

(gC.m⁻² y⁻²)



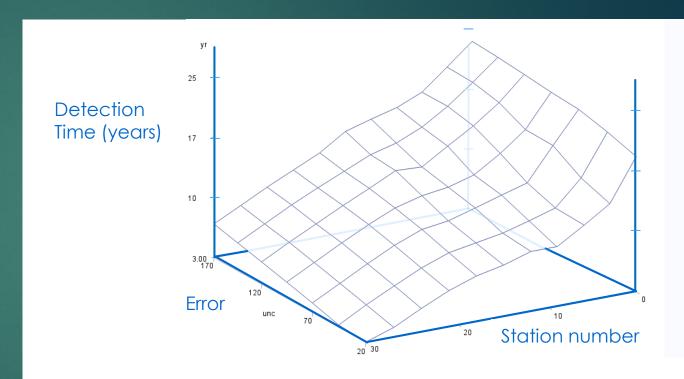
Can we see the unseen?

3rd step. Modelling the sensitivity of station network to the [CO2] drift

- → Simple regression model applied to an ensemble of 2500 virtual networks
- → GPP modelled as :

$$\frac{\partial (GPP)}{\partial t} \times t + \beta (IAV) + \mathcal{N}(GPP, \mathcal{E}(GPP))$$

(IAV being the natural residual varibility.)



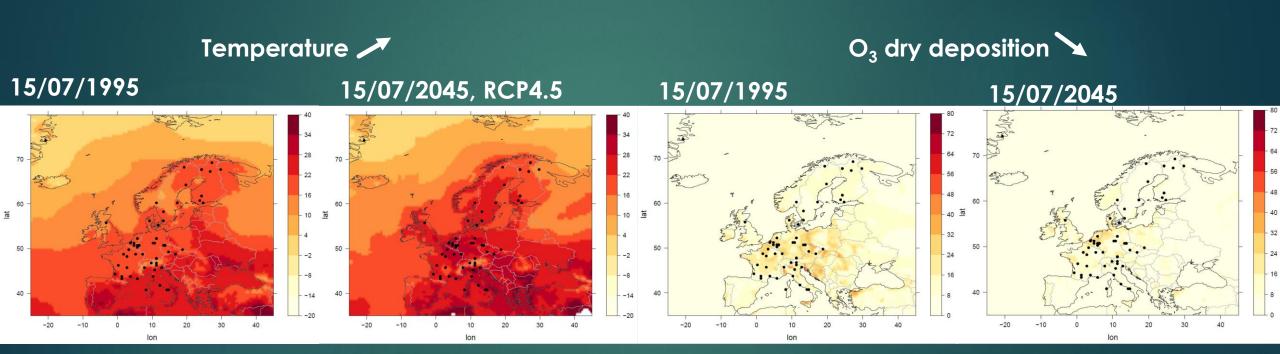
Detection threshold surface for $\delta y/\delta t = 0.015$

The plotted area delimits the duration and size needed for detecting a temporal trend in $\delta GPP / \delta t = -1.5\%$ yr-1 (p=0,05).



4th step. Designing an optimal ecosystem network 2020-2050

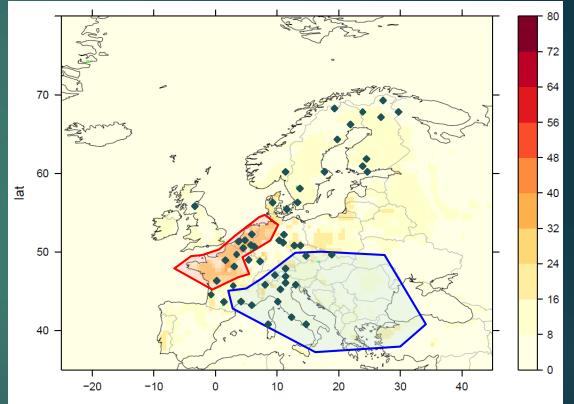
Projection of expected changes in Ecosystem drivers along 2020-2040





4th step. Designing an optimal ecosystem network 2020-2050

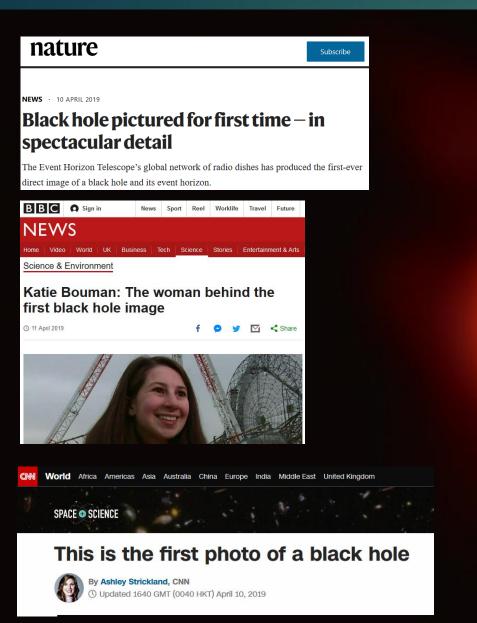
- Partitioning Europe among homogenous eco(iso)zones
 - = Subdomains where changes in O_2 , N, CO_2 and climate are homogenous. Ex.:
 - O₃ ecozones:
 no change, n = 22 stations
 enhanced, n = 10 stations
 decreased, n = 12 stations
- Ensure the completeness and coverage of relevant variables in each subdomain
