Hierarchical null controllability of a semilinear degenerate parabolic equation with a gradient term

Abstract

In this paper, we apply the hierarchical strategy to a semilinear weakly degenerate parabolic equation involving a gradient term. We use the Stackelberg-Nash strategy with one leader which tries to drive the solution to zero and two followers intended to solve a Nash equilibrium corresponding to a bi-objective optimal control problem. Since the system is semilinear, the functionals are not convex in general. To overcome this difficulty, we first prove the existence and uniqueness of the Nash quasi-equilibrium, which is a weaker formulation of the Nash equilibrium. Next, with additional conditions, we establish the equivalence between the Nash quasi-equilibrium and the Nash equilibrium. We establish a suitable Carleman inequality for the adjoint system and then an observability inequality. Based on this observability inequality, we prove the null controllability of the linearized system. Then, due to the Kakutani's fixed point Theorem, we obtain the null controllability of the main system.

1 Introduction

Let $\Omega = (0,1) \subset \mathbb{R}$. Let ω , ω_1 and ω_2 be three nonempty subsets of Ω with $\omega_i \cap \omega = \emptyset$, i = 1,2. For the real number T > 0, we denote $Q = (0,T) \times \Omega$, $\omega_T = (0,T) \times \omega$, $\omega_{1,T} = (0,T) \times \omega_1$ and $\omega_{2,T} = (0,T) \times \omega_2$. We are interested in the following degenerate semilinear parabolic equation:

$$\begin{cases} y_t - (a(x)y_x)_x + F(y, y_x) &= h\chi_{\omega} + v^1\chi_{\omega_1} + v^2\chi_{\omega_2} & \text{in } Q, \\ y(t, 0) = y(t, 1) &= 0 & \text{on } (0, T), \\ y(0, \cdot) &= y^0 & \text{in } \Omega, \end{cases}$$
(1.1)

where y = y(t, x) denotes the state, $v^i = v^i(t, x)$, i = 1, 2 and h = h(t, x) are different control functions whose act on the system through the subsets ω_i and ω respectively. These functions v^i and h represent

respectively the followers and leader controls. Here, $\chi_{\mathcal{A}}$ denotes the characteristic function of the set \mathcal{A} . The function $y^0 \in L^2(\Omega)$ is the initial data. We denote by $y_t := \frac{\partial y}{\partial t}$ and $y_x := \frac{\partial y}{\partial x}$, the partial derivative of y with respect to t and x respectively.

The function $a := a(\cdot)$ represents the dispersion coefficient and we assume that it satisfies the following hypothesis

$$a \in \mathcal{C}([0,1]) \cap \mathcal{C}^1((0,1]), \quad a > 0 \text{ in } (0,1] \text{ and } a(0) = 0,$$

 $\exists \tau \in [0,1) : xa'(x) \le \tau a(x), \ x \in [0,1].$ (1.2)

For further need, we consider as in [18] a function $\beta(x)$ such that

$$\frac{\beta(x)}{x} \in L^{\infty}(\Omega). \tag{1.3}$$

Assumption 1.1 The function $F : \mathbb{R} \times \mathbb{R} \to \mathbb{R}$ satisfies the following:

- (H_1) F(0,0) = 0,
- (H_2) $F \in \mathcal{C}^2(\mathbb{R} \times \mathbb{R}),$
- (H₃) there exists K > 0: $|F(s,p) F(s',p')| \le K[|s-s'| + |p-p'|]$, $\forall s,s',p,p' \in \mathbb{R}$, i.e. F is a globally Lipschitz function,
- (H_4) $F(s,p) = F_1(s,p)s + F_2(s,p)p$, for every $(s,p) \in \mathbb{R}^2$,
- (H₅) there exists $M_1 > 0$: $|F_1(s,p)| + \frac{1}{\beta(x)}|F_2(s,p)| \le M_1, \ \forall (s,p) \in \mathbb{R}^2$,

$$(H_6) \exists M_2 > 0: \sum_{i=1}^2 |D_i F(s, p)| + \sum_{i,j=1}^2 |D_{ij}^2 F(s, p)| \le M_2, \ \forall (s, p) \in \mathbb{R}^2,$$

where D_iF and D_{ij}^2F are respectively the first and second order partial derivatives of F.

Remark 1

- (a) From (1.2), it follows that the function $x \mapsto \frac{x^2}{a(x)}$ is non-decreasing on (0,1].
- (b) Using the point (a) and the assumption (1.3) on $\beta(x)$, we observe that

$$\frac{\beta^2(x)}{a(x)} \le C \frac{x^2}{a(x)} \le \frac{C}{a(1)}, \quad \text{for a.e } x \in (0,1) \text{ where, } C > 0.$$
 (1.4)

Then, we deduce that for almost every $x \in (0,1)$,

$$|\beta(x)| \le L\sqrt{a(x)}, \text{ where } L > 0.$$
 (1.5)

These results will be useful in order to prove the existence of the solution for the linearized problem (2.1).

Remark 2

The system (1.1) can models the dispersion of a gene in a given population. In this case, x represents the gene type and y := y(t, x) is the distribution of individuals at time t and of gene type x of the population. Genetically speaking, such a property of degeneracy is natural since it means that if each population is not of gene type, it cannot be transmitted to its offspring [16].

In this paper, we apply the Stackelberg-Nash strategy introduced in [37] to the system (1.1). It has been applied for the first time in the context of the control of evolution equations by J. L. Lions in [27, 28]. In the last years, other authors have used hierarchical control in the sense of Lions, see for instance [30, 31, 36, 21, 2, 38, 32, 35].

In [7], the authors developed the first hierarchical results in the context of exact controllability framework for a class of parabolic equations (linear and semi-linear). These results were improved in [6] by imposing some weak conditions on observations domains for the followers. This same idea were also applied for the wave equation in [5]. The authors in [4] dealt with the Stackelberg-Nash exact controllability of parabolic equations with distributed and boundary controls. In the context of hierarchical strategy for coupled systems, Kéré et al. [25], considered a bi-objective control strategy for a coupled parabolic equations with a finite constraints on one of the states. The authors in [23] and [22] studied a Stackelberg-Nash strategy for a cascade system of parabolic equations.

More recently in [33], J. Limaco et al. applied the Stackelberg-Nash strategy to a coupled quasi-linear parabolic system with controls acting in the interior on the domain. N. Carreño and M. C. Santos in [13] applied the Stackelberg-Nash strategy to the Kuramoto-Sivashinsky equation with a distributed leader, and two followers. In [34], the author studied the Stackelberg-Nash strategy for a non-linear parabolic equation in an unbounded domain. In [24], D. N. Huaman applied the Stackelberg-Nash strategy to control a quasi-linear parabolic equations in dimensions 1, 2 or 3. Recently, in [9], the authors applied the hierarchical control to the anisotropic heat equation with dynamic boundary conditions and drift terms.

In all the above cited works, the hierarchic strategy were applied to non degenerate systems. To the best of our knowledge, the only work dealing with hierarchical strategy applied to a degenerate equation is the one in [3], were the authors studied the Stackelberg-Nash strategy for both linear and semilinear degenerate parabolic equations. Here, the non linearities involve the first derivative. This inclusion of a first-order term in the expression of F in (1.1) has not been addressed before to our best knowledge.

In this paper we are interested in the Stackelberg-Nash null controllability strategy for the degenerate problem with a gradient term (1.1). To be more specific, for i=1,2, we introduce the non-empty open sets $\omega_{i,d} \subset \Omega$, representing the observation domains of the followers, and the fixed target functions $y_{i,d} \in L^2((0,T);\omega_{i,d})$. Let us define the following cost functional

$$J_i(h; v^1, v^2) = \frac{\alpha_i}{2} \int_0^T \int_{\omega_{i,d}} |y - y_{i,d}|^2 dx dt + \frac{\mu_i}{2} \int_0^T \int_{\omega_i} |v^i|^2 dx dt, \ i = 1, 2,$$
 (1.6)

where α_i and μ_i are two positive constants.

We aim to choose the controls v^i and h in order to achieve two different objectives:

• The main goal is to choose h such that the following null controllability objective holds:

$$y(T, \cdot; h; v^1, v^2) = 0 \text{ in } \Omega.$$

$$(1.7)$$

• The second goal is the following: given the functions $y_{i,d}$ and h, we want to choose the control v^i minimizing J_i given by (1.6). This means that, throughout the interval (0,T), the control v^i will be chosen such that:

the solution $y(t, x; h; v^1, v^2)$ of (1.1) remains "not too far" from a desired target $y_{i,d}(t, x)$ in the observability domain $\omega_{i,d}$, i = 1, 2.

(1.8)

Our goal is to prove that, for any initial data $y^0 \in L^2(\Omega)$, there exist a control $h \in L^2(\omega_T)$ (called leader) and an associated Nash equilibrium $(\hat{v}^1, \hat{v}^2)^t = (\hat{v}^1(h), \hat{v}^2(h))^t \in \mathcal{H} = L^2((0,T); L^2(\omega_1)) \times L^2((0,T); L^2(\omega_2))$ (called followers) such that the associated state y of system (1.1) satisfies (1.7). To do this, we follow the Stackelberg-Nash strategy described as follows:

1. For each choice of the leader h, we look for a Nash equilibrium pair for the costs J_i , i = 1, 2 given by (1.6). That is, find the controls $(\hat{v}^1, \hat{v}^2)^t = (\hat{v}^1(h), \hat{v}^2(h))^t \in \mathcal{H}$ satisfying

$$J_1(h; \hat{v}^1, \hat{v}^2) \le J_1(h; v^1, \hat{v}^2), \quad \forall v^1 \in L^2((0, T); L^2(\omega_1)), J_2(h; \hat{v}^1, \hat{v}^2) \le J_2(h; \hat{v}^1, v^2), \quad \forall v^2 \in L^2((0, T); L^2(\omega_2)),$$

or equivalently

$$J_{1}(h; \hat{v}^{1}, \hat{v}^{2}) = \min_{v^{1} \in L^{2}((0,T); L^{2}(\omega_{1}))} J_{1}(h; v^{1}, \hat{v}^{2}),$$

$$J_{2}(h; \hat{v}^{1}, \hat{v}^{2}) = \min_{v^{2} \in L^{2}((0,T); L^{2}(\omega_{2}))} J_{2}(h; \hat{v}^{1}, v^{2}).$$
(1.9)

2. Once the Nash equilibrium has been identified and fixed for each h, we look for a control \bar{h} such that

$$y(T, \cdot; \bar{h}; \hat{v}^1(\bar{h}), \hat{v}^2(\bar{h})) = 0 \text{ in } \Omega.$$
 (1.10)

Remark 3

(a) In the linear case, the functionals J_i , i = 1, 2 are differentiable and convex and the pair (\hat{v}^1, \hat{v}^2) is a Nash equilibrium for (J_1, J_2) if and only if

$$\frac{\partial J_1}{\partial v^1}(h; \hat{v}^1, \hat{v}^2)(v^1, 0) = 0, \quad \forall v^1 \in L^2((0, T); L^2(\omega_1)), \quad \hat{v}^i \in L^2((0, T); L^2(\omega_i)), \\
\frac{\partial J_2}{\partial v^2}(h; \hat{v}^1, \hat{v}^2)(0, v^2) = 0, \quad \forall v^2 \in L^2((0, T); L^2(\omega_2)), \quad \hat{v}^i \in L^2((0, T); L^2(\omega_i)).$$
(1.11)

(b) In the semi-linear framework, the corresponding functionals J_1 and J_2 are not convex in general. For this reason, we must consider the following weaker definition of Nash equilibrium.

Definition 1.1

Let the leader control h be given. The pair (\hat{v}^1, \hat{v}^2) is called a Nash quasi-equilibrium of functionals (J_1, J_2) if the condition (1.11) is satisfied.

In the case where only a leader control is exerted on ω , i.e. $v^1 \equiv v^2$, the null controllability of the following degenerate diffusion equation, has been already investigated

$$W_t - (x^{\alpha} W_x)_x + k(t, x)W = h(t, x)\chi_{\omega}, \ (t, x) \in Q,$$
(1.12)

$$W(t,0) = 0 \text{ if } 0 < \alpha < 1, \tag{1.13}$$

$$(x^{\alpha}W)(t,0) = 0 \text{ if } \alpha \ge 1, \ t \in (0,T),$$
 (1.14)

$$W(t,1) = 0, \quad t \in (0,T),$$
 (1.15)

$$W(0,\cdot) = W_0(x), \ x \in \Omega, \tag{1.16}$$

where $\alpha > 0$ and $k \in L^{\infty}(Q)$. It was shown that the system (1.12)-(1.16) is null controllable if $0 < \alpha < 2$ [11, 12, 1], while not null controllable if $\alpha \ge 2$ [10]. Note that if $0 < \alpha < 1$, the degeneracy of (1.12) is

weak, while strong if $\alpha \geq 1$. In [19], Flores and Teresa considered the degenerate convection-diffusion equation

$$y_t - (x^{\alpha} y_x)_x + x^{\alpha/2} b(t, x) y_x + k(t, x) y = h(t, x) \chi_{\omega}, \ (t, x) \in Q,$$
(1.17)

with $b \in L^{\infty}(Q)$ and proved that the system (1.17) and (1.13)-(1.16) is null controllable for $0 < \alpha < 2$. In (1.17), the gradient term depends on α and we said that the convection term can be controlled by the diffusion term. In [18], the authors presented a null controllability result for the system (1.1) and (1.14). The main result has been obtained after the proof of a new Carleman inequality for a degenerate linear parabolic equation with first order terms. F. Xu et et al. in [41] proved the null controllability of the semilinear degenerate system (1.1) and (1.14) with $a(x) = x^{\alpha}$, $0 < \alpha < 2$. The authors in [39], studied the degenerate convection-diffusion equation with the convection term independent of α

$$y_t - (x^{\alpha} y_x)_x + (b(t, x)y)_x + k(t, x)y = h(t, x)\chi_{\omega}, \ (t, x) \in Q,$$
(1.18)

and proved that the system (1.18) and (1.13)-(1.16) is null controllable for $0 < \alpha < 1/2$. The authors in [40] considered the degenerate equation

$$y_t - (x^{\alpha} y_x)_x + b(t, x)y_x + k(t, x)y = h(t, x)\chi_{\omega}, \ (t, x) \in Q,$$
(1.19)

and showed that the system (1.19) and (1.13)-(1.16) is null controllable for $0 < \alpha < 1$ if $b, b_x, b_{xx}, b_t \in L^{\infty}(Q)$, i.e. $b \in W^{2,1}_{\infty}(Q)$.

1.1 Main results

The next result establish the equivalence between the Nash quasi-equilibrium and the Nash equilibrium under some additional conditions. More precisely, we have the following result.

Proposition 1.1

Let us assume that $a(\cdot)$ satisfies (1.2), $y_{i,d} \in L^{\infty}((0,T); \omega_{i,d})$ and Assumption 1.1 are satisfied. Assume that $h \in L^2(\omega_T)$ and μ_i , i = 1, 2 are sufficiently large. Then, if (\hat{v}^1, \hat{v}^2) is a Nash quasi-equilibrium for J_i , i = 1, 2, there exists a constant C > 0 independent of μ_i , i = 1, 2 such that

$$D_i^2 J_i(h; \hat{v}^1, \hat{v}^2) \cdot (w^i, w^i) \ge C \|w^i\|_{L^2((0,T); L^2(\omega_i))}^2, \ \forall w^i \in L^2((0,T); L^2(\omega_i)), \ i = 1, 2.$$
 (1.20)

In particular, the functionals (J_1, J_2) are convex in (\hat{v}^1, \hat{v}^2) and therefore the pair (\hat{v}^1, \hat{v}^2) is a Nash equilibrium for J_i , i = 1, 2 of the system (1.1).

To state the main result of this paper, we impose the following assumptions:

$$\omega_{1,d} = \omega_{2,d} := \omega_d \tag{1.21}$$

and

$$\omega_d \cap \omega \neq \emptyset. \tag{1.22}$$

The main result of this paper is the following:

Theorem 1.1

Let T > 0 and $y_0 \in L^2(\Omega)$. Suppose that (1.22)-(1.21) holds and μ_i , i = 1, 2 are large enough, $a(\cdot)$ satisfies (1.2) and the Assumption 1.1 are satisfied. Then, there exists a positive real weight function $\kappa = \kappa(t)$ blowing up at t = T such that for any $y_{i,d} \in L^2((0,T);\omega_{i,d})$ satisfying

$$\int_0^T \int_{\omega_d} \kappa^{-2} |y_{i,d}|^2 dx dt < +\infty, \quad i = 1, 2,$$
(1.23)

there exist a control $\bar{h} \in L^2(\omega_T)$ and an associated Nash equilibrium $(\hat{v}^1, \hat{v}^2) \in \mathcal{H} = L^2((0, T); L^2(\omega_1)) \times L^2((0, T); L^2(\omega_2))$ such that the corresponding solution to (1.1) satisfies (1.10).

The rest of the paper is organized as follows. In Section 2, we introduce some weighted function spaces needed to establish some well posedness results. Section 3 deals with the proof of existence and characterization of Nash-quasi equilibrium. Under some conditions, we prove equivalence between Nash equilibrium and Nash-quasi equilibrium in Section 4. In Section 5, we prove some suitable Carleman inequalities and we deduce the null controllability result in Section 6. A conclusion is given in Section 7.

2 Well-posedness result

Throughout this paper, the usual norm in $L^{\infty}(Q)$ will be denoted by $\|\cdot\|_{\infty}$. In this section, we consider the following linear problem

$$\begin{cases}
y_t - (a(x)y_x)_x + a_0y + \beta(x)b_0y_x &= h\chi_\omega + v^1\chi_{\omega_1} + v^2\chi_{\omega_2} & \text{in } Q, \\
y(t,0) = y(t,1) &= 0 & \text{on } (0,T), \\
y(0,\cdot) &= y^0 & \text{in } \Omega,
\end{cases}$$
(2.1)

where $a_0, b_0 \in L^{\infty}(Q), y^0 \in L^2(\Omega)$ and $h\chi_{\omega}, v^1\chi_{\omega_1}, v^2\chi_{\omega_2} \in L^2(Q)$.

The following assumption will help us to prove the existence result of problem (2.1).

Assumption 2.1

Let the constant L be defined by (1.5). Then there exists a constant $\alpha > 0$ such that

$$a_0(t,x) \ge \alpha \text{ for all } (t,x) \in Q \text{ and } \alpha > \frac{1}{2}L^2 ||b_0||_{\infty}^2.$$

In order to prove the well-posedness of the degenerate system (2.1), we introduce the following weighted Hilbert spaces (in the sequel, abs. cont. means absolutely continuous):

$$H_a^1(\Omega) = \{u \in L^2(\Omega) : u \text{ is abs. cont. in } [0,1] : \sqrt{a}u_x \in L^2(\Omega), \ u(0) = u(1) = 0\},$$

endowed with the norm

$$||u||_{H_a^1(\Omega)}^2 = ||u||_{L^2(\Omega)}^2 + ||\sqrt{a}u_x||_{L^2(\Omega)}^2, \quad u \in H_a^1(\Omega)$$

and

$$H_a^2(\Omega) = \{ u \in H_a^1(\Omega) : a(x)u_x \in H^1(\Omega) \},$$

endowed with the norm

$$||u||_{H_a^2(\Omega)}^2 = ||u||_{H_a^1(\Omega)}^2 + ||(a(x)u_x)_x||_{L^2(\Omega)}^2.$$

Next, we set

$$\mathbb{H}:=L^2((0,T);H^1_a(\Omega))\cap\mathcal{C}([0,T];L^2(\Omega)).$$

Let $(H_a^1(\Omega))'$ be the topological dual space of $H_a^1(\Omega)$. If we set

$$W_a(0,T) = \left\{ \rho \in L^2((0,T); H_a^1(\Omega)); \rho_t \in L^2\left((0,T); (H_a^1(\Omega))'\right) \right\}. \tag{2.2}$$

Then $W_a(0,T)$ endowed with the norm

$$\|\rho\|_{W_{\sigma}(0,T)}^{2} = \|\rho\|_{L^{2}((0,T);H_{\sigma}^{1}(\Omega))}^{2} + \|\rho_{t}\|_{L^{2}((0,T);(H_{\sigma}^{1}(\Omega))')}^{2}$$
(2.3)

is a Hilbert space. Moreover, we have the continuous embedding

$$W_a(0,T) \subset C([0,T], L^2(\Omega)).$$
 (2.4)

Remark 4

Under the hypothesis (1.2), $H_a^1(\Omega)$ is compactly embedded in $L^2(\Omega)$ (see [1]).

Let us recall the following existence result retrieved from [29, Page 37].

Theorem 2.1 Let $(F, ||\cdot||_F)$ be a Hilbert space. Let Φ be a subspace of F endowed with a pre-Hilbert scalar product $(((\cdot, \cdot)))$ and the corresponding norm $|||\cdot|||$. Moreover, let $E: F \times \Phi \to \mathbb{C}$ be a sesquilinear form. Assume that the following hypothesis hold:

1. The embedding $\Phi \hookrightarrow F$ is continuous, that is, there is a constant $C_1 > 0$ such that

$$\|\varphi\|_F \le C_1 \||\varphi|\| \quad \forall \varphi \ in \ \Phi. \tag{2.5}$$

- 2. For all $\varphi \in \Phi$, the mapping $u \mapsto E(u, \varphi)$ is continuous on F.
- 3. There is a constant $C_2 > 0$ such that

$$E(\varphi, \varphi) \ge C_2 |||\varphi|||^2 \quad \text{for all } \varphi \in \Phi.$$
 (2.6)

If $\varphi \mapsto L(\varphi)$ is a semi-linear continuous form on Φ , then there exists a function $u \in F$ verifying

$$E(u,\varphi) = L(\varphi)$$
 for all $\varphi \in \Phi$.

The weak solution of problem (2.1) is defined as follows.

Definition 2.1 We shall say that a function $y \in \mathbb{H}$ is a weak solution to (2.1) if the following equality

$$-\int_{Q} y\phi_{t} dx dt + \int_{Q} a(x)y_{x}\phi_{x} dx dt + \int_{Q} a_{0}y\phi dx dt + \int_{Q} \beta(x)b_{0}y_{x}\phi dx dt$$

$$= \int_{Q} (h\chi_{\omega} + v^{1}\chi_{\omega_{1}} + v^{2}\chi_{\omega_{2}}) \phi dx dt + \int_{\Omega} y^{0}(x) \phi(0, x) dx,$$
(2.7)

holds, for every

$$\phi \in \mathbb{V} = \{ \phi \in \mathbb{H} : \phi_t \in L^2(Q), \, \phi(T, \cdot) = 0 \text{ in } \Omega \}.$$

$$(2.8)$$

Remark 5 We observe the following:

(a) The space V endowed with the norm defined by

$$\|\phi\|_{\mathbb{V}}^2 := \|\phi\|_{L^2((0,T);H^1_s(\Omega))}^2 + \|\phi(0,\cdot)\|_{L^2(\Omega)}^2$$

is a Hilbert space.

(b) If $\varphi \in \mathbb{V}$, then $\phi_t \in L^2(Q) \hookrightarrow L^2((0,T); (H_a^1(\Omega))')$. Consequently, $\phi \in W_a(0,T)$. Therefore, $\phi(0,\cdot)$ and $\phi(T,\cdot)$ exist and belong to $L^2(\Omega)$.

Using Theorem 2.1, the following proposition shows that the problem (2.1) is well posed.

Proposition 2.1

Assume that $a(\cdot)$ satisfies (1.2) and Assumptions 1.1 are valid. Let $y^0 \in L^2(\Omega)$, $a_0, b_0 \in L^{\infty}(Q)$, $h \in L^2(\omega_T)$ and $(v^1, v^2)^t \in \mathcal{H} = L^2((0, T); L^2(\omega_1)) \times L^2((0, T); L^2(\omega_2))$. Then, the system (2.1) admits a unique weak solution $y \in \mathbb{H}$ in the sense of Definition 2.1. Moreover, there exists a constant $C = C(T, \|a_0\|_{\infty}, \|b_0\|_{\infty}) > 0$ such that the following estimation holds:

$$||y(T,\cdot)||_{L^{2}(\Omega)}^{2} + ||y||_{L^{2}((0,T);H_{a}^{1}(\Omega))}^{2} \le C\left(||v^{1}||_{L^{2}(\omega_{1,T})}^{2} + ||v^{2}||_{L^{2}(\omega_{2,T})}^{2} + ||h||_{L^{2}(\omega_{T})}^{2} + ||y^{0}||_{L^{2}(\Omega)}^{2}\right). \tag{2.9}$$

The proof of Proposition 2.1 can be found in the Appendix.

Similar to the linear problem (2.1), we give the definition of weak solution to the semilinear system (1.1).

Definition 2.2 A function y is called the weak solution of the problem (1.1) if $y \in \mathbb{H}$ and for any function $\phi \in \mathbb{V}$, the following equality holds

$$-\int_{Q} y\phi_{t} dx dt + \int_{Q} a(x)y_{x}\phi_{x} dx dt + \int_{Q} F(y, y_{x})\phi dx dt$$

$$= \int_{Q} (h\chi_{\omega} + v^{1}\chi_{\omega_{1}} + v^{2}\chi_{\omega_{2}}) \phi dx dt + \int_{\Omega} y^{0}(x) \phi(0, x) dx.$$
(2.10)

The following result of existence and uniqueness of solutions to system (1.1) is proved in the Appendix.

Theorem 2.2

For any $y^0 \in L^2(\Omega)$, $h \in L^2(\omega_T)$ and $(v^1, v^2)^t \in \mathcal{H}$, the system (1.1) has a unique weak solution $y \in \mathbb{H}$ in the sense of Definition 2.2. .

We state the Hardy-Poincaré inequality which is a standard tool in the analysis of degenerate systems. The following result is proved in [1, Proposition 2.1].

Proposition 2.2 (Hardy-Poincaré inequality)

Assume that $a:[0;1] \longrightarrow \mathbb{R}_+$ is in $\mathcal{C}([0;1])$, a(0)=0 and a>0 on (0;1]. Furthermore, assume that a is such that there exists $\theta \in (0;1)$ such that the function $x \longmapsto \frac{a(x)}{x^{\theta}}$ is non-increasing in neighbourhood of x=0. Then, there is a constant $\overline{C}>0$ such that for any z, locally absolutely continuous on (0;1], continuous at 0 and satisfying z(0)=0 and $\int_0^1 a(x)|z'(x)|^2 dx < +\infty$, the following inequality holds

$$\int_0^1 \frac{a(x)}{x^2} |z(x)|^2 dx < \overline{C} \int_0^1 a(x) |z'(x)|^2 dx.$$
 (2.11)

Moreover, under the same hypothesis on z and the fact that the function $x \mapsto \frac{a(x)}{x^{\theta}}$ is non-increasing on (0;1], then the inequality (2.11) holds with $\overline{C} = \frac{4}{(1-\theta)^2}$.

3 Characterization of Nash quasi-equilibrium

In this section, we give the following characterization of Nash quasi-equilibrium pair (see Definition 1.1) (\hat{v}^1, \hat{v}^2) of system (1.1) for functionals J_i , i = 1, 2 given by (1.6).

Proposition 3.1

Let $h \in L^2(\omega_T)$ and assume that μ_i , i = 1, 2 are sufficiently large. Let also $(\hat{v}^1, \hat{v}^2) \in \mathcal{H}$ be the Nash quasi-equilibrium pair for (J_1, J_2) . Then, there exist $p^i \in \mathbb{H}$ such that the Nash quasi-equilibrium pair $(\hat{v}^1, \hat{v}^2) \in \mathcal{H}$ is characterized by

$$\hat{v}^i = -\frac{1}{\mu_i} p^i \quad in \quad (0, T) \times \omega_i, \ i = 1, 2,$$
 (3.1)

where (y, p^1, p^2) is the solution of the following optimality systems

and

$$\begin{cases}
-p_t^i - (a(x)p_x^i)_x + D_1 F(y, y_x) p^i - \left(\beta(x) \left[\frac{D_2 F(y, y_x)}{\beta(x)}\right] p^i\right)_x &= \alpha_i (y - y_{i,d}) \chi_{\omega_{i,d}} & in \quad Q, \\
p^i(t, 0) = p^i(t, 1) &= 0 & on \quad (0, T), \\
p^i(T, \cdot) &= 0 & in \quad \Omega.
\end{cases}$$
(3.3)

Proof

If (\hat{v}^1, \hat{v}^2) is a Nash quasi-equilibrium in the sense of the Definition 1.1, then we have

$$\alpha_i \int_0^T \int_{\omega_{i,d}} (y - y_{i,d}) z^i dx \, dt + \mu_i \int_0^T \int_{\omega_i} \hat{v}^i v^i \, dx \, dt = 0, \text{ for all } v^i \in L^2((0,T); L^2(\omega_i)), \quad (3.4)$$

where z^i is the solution of

Now, let p^i be the solution of the following (adjoint) system

$$\begin{cases} -p_t^i - \left(a(x)p_x^i\right)_x + D_1 F(y, y_x) p^i - \left(\beta(x) \left[\frac{D_2 F(y, y_x)}{\beta(x)}\right] p^i\right)_x &= \alpha_i \left(y - y_{i,d}\right) \chi_{\omega_{i,d}} & \text{in} \quad Q, \\ p^i(t, 0) = p^i(t, 1) &= 0 & \text{on} \quad (0, T), \\ p^i(T, \cdot) &= 0 & \text{in} \quad \Omega. \end{cases}$$

If we multiply the first equation of this latter system by z^i solution of (3.5) and we integrate by parts over Q, we obtain

-p_t^i - (a(x)p_x^i)_x + b_1p^i - (\beta(x)b_2p^i)_x &= \alpha_i (y - y_{i,d}) \chi_{\omega_{i,d}} & \text{in } Q, \\
p^i(t,0) = p^i(t,1) &= 0 & \text{on } (0,T), \\
p^i(T,\cdot) &= 0 & \text{in } \Omega,
\end{cases}$$
(3.7)

where $a_i, b_i \in L^{\infty}(Q), i = 1, 2.$

Next, we consider the adjoint systems for (3.6)-(3.7).

\psi_t^i - (a(x)\psi_x^i)_x + b_1\psi^i + \beta(x)b_2\psi_x^i &= -\frac{1}{\mu_i}\rho\chi_{\omega_i} & \text{in } Q, \\
\psi^i(t,0) = \psi^i(t,1) &= 0 & \text{on } (0,T), \\
\psi^i(0,\cdot) &= 0 & \text{in } \Omega,
\end{cases}$$
(3.9)

where $\rho^T \in L^2(\Omega)$.

Remark 6

- 1. Notice that the existence and uniqueness of a solution for (3.2)-(3.3) guaranteed by Proposition 2.1 implies the existence and uniqueness of a Nash quasi-equilibrium in the sense of Definition 1.1.
- 2. Using some ideas of [7, 34], we can prove the following estimate

$$\|(\hat{v}_1, \hat{v}_2)\|_{\mathcal{H}} \le C \left(\sum_{i=1}^2 \|y_{i,d}\|_{L^2((0,T)\times\omega_{i,d})} + \|h\|_{L^2(\omega_T)} + \|y^0\|_{L^2(\Omega)} \right), \tag{3.10}$$

where $C = C(\|a_1\|_{\infty}, \|a_2\|_{\infty}, T, \alpha_1, \alpha_2)$ is a positive constant.

4 On the convexity of J_i , i = 1, 2

In this section, we prove Proposition 1.1 establishing the equivalence between Nash quasi-equilibrium and Nash equilibrium in the semilinear case. We recall that

$$J_i(h; v^1, v^2) = \frac{\alpha_i}{2} \int_0^T \int_{\omega_i} |y - y_{i,d}|^2 dx dt + \frac{\mu_i}{2} \int_0^T \int_{\omega_i} |v^i|^2 dx dt, \ i = 1, 2.$$

Proof of Proposition 1.1.

Let $h \in L^2(\omega_T)$ be given and let (\hat{v}_1, \hat{v}_2) be the associated Nash quasi-equilibrium. For any $w^1, w^2 \in L^2(\omega_{1,T})$ and $s \in \mathbb{R}$, we denote by $y^s = (y_1^s, y_2^s)$ the solution of the following system

and we set $y := y^s|_{s=0}$.

$$D_1 J_1(h; \hat{v}^1 + sw^1, \hat{v}^2) \cdot w^2 - D_1 J_1(h; \hat{v}^1, \hat{v}^2) \cdot w^2 = s\mu_1 \int_0^T \int_{\omega_1} w^1 w^2 \, dx dt + \alpha_1 \int_0^T \int_{\omega_{1,d}} (y^s - y_{1,d}) z^s \, dx dt - \alpha_1 \int_0^T \int_{\omega_{1,d}} (y - y_{1,d}) z \, dx dt,$$

$$(4.2)$$

where z^s is the derivative of the state y^s with respect to $\hat{v}^1 + sw^1$ in the direction w^2 , that is z^s is the solution to

$$\begin{cases} z_t^s - (a(x)z_x^s)_x + D_1 F(y^s, y_x^s) z^s + \beta(x) \left[\frac{D_2 F(y^s, y_x^s)}{\beta(x)} \right] z_x^s &= w^2 \chi_{\omega_1} & \text{in} \quad Q, \\ z^s(t, 0) = z^s(t, 1) &= 0 & \text{on} \quad (0, T), \\ z^s(0, \cdot) &= 0 & \text{in} \quad \Omega. \end{cases}$$
(4.3)

We will also use the notation $z := z^s|_{s=0}$.

Let us introduce the adjoint of (4.3)

(4.4)

and let us use the notation $p := p^s|_{s=0}$.

Multiplying the first equation of (4.3) by p^s and integrating by parts over Q, we obtain

Note that, the following limits exist

$$\eta = \lim_{s \to 0} \frac{1}{s} (p^s - p)$$
 and $\phi = \lim_{s \to 0} \frac{1}{s} (y^s - y)$

and verify the following systems:

\phi_{t} - (a(x)\phi_{x})_{x} + D_{1}F(y, y_{x})\phi + \beta(x) \left[\frac{D_{2}F(y, y_{x})}{\beta(x)}\right]\phi_{x} = w^{1}\chi_{\omega_{1}} & \text{in } Q, \\
\phi(t, 0) = \phi(t, 1) = 0 & \text{on } (0, T), \\
\phi(0, \cdot) = 0 & \text{in } \Omega
\end{cases}$$
(4.7)

and

$$\begin{cases}
-\eta_{t} - (a(x)\eta_{x})_{x} + D_{1}F(y, y_{x})\eta - \left(\beta(x) \left[\frac{D_{2}F(y, y_{x})}{\beta(x)}\right]\eta\right)_{x} + \mathcal{G}(p, \phi) &= \alpha_{1}\phi\chi_{\omega_{1,d}} & \text{in} \quad Q, \\
\eta(t, 0) = \eta(t, 1) &= 0 & \text{on} \quad (0, T), \\
\eta(T, \cdot) &= 0 & \text{in} \quad \Omega,
\end{cases}$$
(4.8)

where

$$\mathcal{G}(p,\phi) = D_{11}^2 F(y,y_x) p\phi + D_{12}^2 F(y,y_x) p\phi_x - (D_{21}^2 F(y,y_x) p\phi)_x - (D_{22}^2 F(y,y_x) p\phi_x)_x.$$

Thus, from (4.6)-(4.8) for $w^2 = w^1$, we have

From a similar argument as in the proof of Proposition 1.4 [7], we can prove that there exists a constant C > 0 independent of h, ϕ , ψ such that

for another positive constant C independent of μ_1 and μ_2 . For μ_i sufficiently large, the functional J_i , i = 1, 2 given by (1.6) are convex and thus, the pair (\hat{v}^1, \hat{v}^2) is a Nash equilibrium in the sense of (1.9).

5 Carleman estimates

The goal of this section is to establish some Carleman estimates for systems (3.8)-(3.9). Let us begin by introducing some weight functions.

Since $\omega_d \cap \omega \neq \emptyset$ (recall (1.22)), then there exist a non-empty open set $\mathcal{O}_1 \subseteq \omega_d \cap \omega$ and a function $\sigma \in \mathcal{C}^2([0,1])$ such that

$$\begin{cases}
\sigma(x) > 0 & \text{in} \quad (0,1), \quad \sigma(0) = \sigma(1) = 0, \\
\sigma_x(x) \neq 0 & \text{in} \quad [0,1] \setminus \mathcal{O}_0,

where $\mathcal{O}_0 \subseteq \mathcal{O}_1$ is an open subset. The existence of such a function σ is proved in [20]. Let $\tau \in [0,1)$ be as in the assumption (1.2) and $r,d \in \mathbb{R}$ be such that

$$r \ge \frac{4ln(2)}{\|\sigma\|_{\infty}} \text{ and } d \ge \frac{5}{a(1)(2-\tau)}.$$
 (5.2)

Then, the interval $I = \left[\frac{a(1)(2-\tau)(e^{2r\|\sigma\|_{\infty}}-1)}{d\ a(1)(2-\tau)-1}, \frac{4(e^{2r\|\sigma\|_{\infty}}-e^{r\|\sigma\|_{\infty}})}{3d}\right]$ is non-empty (see [8]). Let $\lambda \in I$. For r, d satisfying (5.2), we define the following functions:

Using the second assumption in (5.2) on d, we observe that

$$\delta(x) < 0, \quad \forall x \in [0, 1].$$

Moreover, we have that $\Theta(t) \to +\infty$ as t tends to 0^+ and T^- . Under assumptions (5.2) and the choice of the parameter λ , the weight functions φ and Φ defined by (5.3) satisfy the following inequalities which are needed in the sequel:

To prove the forthcoming theorems, we use the following Carleman estimate in the degenerate case proved in [18].

Proposition 5.1

Consider the following system with $G_0, G_1 \in L^2(Q)$ and $z_T \in L^2(\Omega)$

Assume that (1.2) and (1.3) are satisfied and let T > 0 be given. Then, there exist two positive constants C and s_0 , such that every solution of (5.5) satisfies, for all $s \ge s_0$, the following inequality:

$$\mathcal{I}(z) \le C \left(\int_0^T \int_{\mathcal{O}_1} |z|^2 e^{2s\varphi} \, dx \, dt + \int_Q \left(|G_0|^2 + s^2 \Theta^3 \frac{\beta^2(x)}{a(x)} |G_1|^2 \right) e^{2s\varphi} \, dx \, dt \right), \tag{5.6}$$

where

$$\mathcal{I}(z) = \int_{Q} \left(s^3 \Theta^3 \frac{x^2}{a(x)} z^2 + s \Theta a(x) z_x^2 \right) e^{2s\varphi} dx dt$$
 (5.7)

and the functions Θ and φ are given by (5.3).

Using this latter proposition, we prove the following result.

Proposition 5.2

Let us consider

-z_t - (a(x)z_x)_x + a_0z &= G_2 + (\beta(x)G_1)_x & in \quad Q, \\
z(t,0) = z(t,1) &= 0 & on \quad (0,T), \\
z(T,\cdot) &= z_T & in \quad \Omega,
\end{cases} (5.8)$$

where $G_1, G_2 \in L^2(Q)$, $a_0 \in L^{\infty}(Q)$ and $z_T \in L^2(\Omega)$.

Assume that (1.2) and (1.3) are satisfied and let T > 0 be given. Then, there exist two positive constants C and s_1 , such that every solution of (5.8) satisfies, for all $s \ge s_1$, the following inequality:

$$\mathcal{I}(z) \le C \left(\int_0^T \int_{\mathcal{O}_1} |z|^2 e^{2s\varphi} \, dx \, dt + \int_Q \left(|G_2|^2 + s^2 \Theta^3 \frac{\beta^2(x)}{a(x)} |G_1|^2 \right) e^{2s\varphi} \, dx \, dt \right), \tag{5.9}$$

where $\mathcal{I}(\cdot)$ is given by (5.7).

Proof. To prove the inequality (5.9), we apply the relation (5.6) with $G_0 = G_2 - a_0 z$. Hence, there are two positive constants C and s_0 , such that for all $s \ge s_0$, the following inequality holds:

$$\mathcal{I}(z) \le C \left(\int_0^T \int_{\mathcal{O}_1} |z|^2 e^{2s\varphi} \, dx \, dt + \int_Q \left(|G_0|^2 + s^2 \Theta^3 \frac{\beta^2(x)}{a(x)} |G_1|^2 \right) e^{2s\varphi} \, dx \, dt \right).$$

On the other hand, using Young's inequality, we have

$$\int_{Q} |G_0|^2 e^{2s\varphi} \, dx \, dt \le 2 \left(\int_{Q} |G_2|^2 e^{2s\varphi} \, dx \, dt + ||a_0||_{\infty}^2 \int_{Q} |z|^2 e^{2s\varphi} \, dx \, dt \right).$$

Now, applying Hardy-Poincaré inequality (2.11) to the function $e^{s\varphi}z$, the fact that $x \mapsto \frac{x^2}{a(x)}$ is non-decreasing and thanks to the definition of φ , it follows that

$$\begin{split} \int_{Q} |z|^{2} e^{2s\varphi} \, dx \, dt & \leq & \frac{1}{a(1)} \int_{Q} \frac{a(x)}{x^{2}} |z|^{2} e^{2s\varphi} \, dx \, dt \\ & \leq & \frac{C}{a(1)} \int_{Q} a(x) \left((e^{s\varphi} z)_{x} \right)^{2} \, dx \, dt \\ & \leq & \frac{C}{a(1)} \left(\int_{Q} s^{2} \lambda^{2} \Theta^{2} \frac{x^{2}}{a(x)} e^{2s\varphi} z^{2} \, dx \, dt + \int_{Q} a(x) e^{2s\varphi} z_{x}^{2} \, dx \, dt \right). \end{split}$$

Thus,

$$\int_{Q} |G_{0}|^{2} e^{2s\varphi} dx dt \leq 2 \int_{Q} |G_{2}|^{2} e^{2s\varphi} dx dt
+2\|a_{0}\|_{\infty}^{2} \frac{C}{a(1)} \left(\int_{Q} s^{2} \lambda^{2} \Theta^{2} \frac{x^{2}}{a(x)} e^{2s\varphi} z^{2} dx dt + \int_{Q} a(x) e^{2s\varphi} z_{x}^{2} dx dt \right).$$

Using the fact that there exists a positive constant M_3 such that

$$1 < M_3 \Theta \quad \text{and} \quad \Theta^2 < M_3 \Theta^3, \tag{5.10}$$

we obtain

Taking $s \ge s_1 = \max(s_0, 2C_0)$, we obtain (5.9). This completes the proof.

The next result is the classical Carleman estimate in a suitable interval $(b_1, b_2) \subset [0, 1]$ proved in [15, 17].

Proposition 5.3

We consider the following system with $H, H_0 \in L^2(Q_b)$ and $a \in C^1([b_1; b_2])$ is a strictly positive function,

Then, there exist two positive constants C and s_2 , such that every solution of (5.11) satisfies, for all $s \geq s_2$, the following inequality holds

$$\mathcal{K}(z) \le C \left(\int_0^T \int_{\mathcal{O}_1} s^3 \eta^3 |z|^2 e^{2s\Phi} \, dx \, dt + \int_{Q_b} \left(|H_0|^2 + s^2 \eta^2 |H|^2 \right) e^{2s\Phi} \, dx \, dt \right), \tag{5.12}$$

where

$$K(z) = \int_{Q_b} (s^3 \eta^3 z^2 + s \eta z_x^2) e^{2s\Phi} dx dt$$
 (5.13)

and the functions η and Φ are defined as in (5.3).

Now, we state and prove the last result of this section.

Proposition 5.4

We consider the following system

where $H, H_0 \in L^2(Q_b)$, $a_0 \in L^{\infty}(Q)$ and $a \in C^0([b_1; b_2])$ is a strictly positive function.

Then, there exist two positive constants C and s_3 , such that every solution of (5.11) satisfies the following inequality holds for all $s \geq s_3$

$$\mathcal{K}(z) \le C \left(\int_0^T \int_{\mathcal{O}_1} s^3 \eta^3 |z|^2 e^{2s\Phi} \, dx \, dt + \int_{Q_b} \left(|H_1|^2 + s^2 \eta^2 |H|^2 \right) e^{2s\Phi} \, dx \, dt \right), \tag{5.15}$$

where $K(\cdot)$ is defined in (5.13).

Proof. To prove the relation (5.15), we apply the relation (5.12) with $H_0 = H_1 - a_0 z$. Therefore, there are two positive constants C and s_2 , such that for all $s \ge s_2$, we have

Observing that s > 1 and $\eta^{-1} \in L^{\infty}(Q_b)$, it follows from the latter inequality that, there exists C > 0 such that

Choosing $s \ge s_3 = \max \left(s_2, 2 \|a_0\|_{\infty}^2 C \right)$ in this latter inequality, we obtain (5.15). This completes the proof. \blacksquare

5.1 An intermediate Carleman estimate

In this section, we establish an observability inequality for the adjoint systems (3.8)-(3.9). This inequality will allows us to prove the null controllability of system (3.2)-(3.3).

Since $\omega_{1,d} = \omega_{2,d} := \omega_d$ (see (1.21)) and if we set $\varrho = \alpha_1 \psi^1 + \alpha_2 \psi^2$, then we can simplify (3.8)-(3.9) as follows

\varrho_{t} - (a(x)\varrho_{x})_{x} + b_{1}\varrho + \beta(x)b_{2}\varrho_{x} &= -\left(\frac{\alpha_{1}}{\mu_{1}}\chi_{\omega_{1}} + \frac{\alpha_{2}}{\mu_{2}}\chi_{\omega_{2}}\right)\rho & \text{in } Q, \\
\varrho(t,0) &= \varrho(t,1) &= 0 & \text{on } (0,T), \\
\varrho(0,\cdot) &= 0 & \text{in } \Omega.
\end{cases} (5.17)$$

Before going further, we consider the following result useful for the rest of the paper.

Lemma 5.1 (Caccioppoli's inequality)[26]

Let \mathcal{O}' be a subset of \mathcal{O}_1 such that $\mathcal{O}' \subseteq \mathcal{O}_1$. Let ρ and ϱ be the solution of (5.16) and (5.17) respectively. Then, there exists a positive constant C such that

where the weight functions φ and Θ are defined by (5.3).

Now, we state and prove one of the important result of this paper which is the intermediate Carleman inequality for the solutions of systems (5.16)-(5.17).

Theorem 5.1

Assume that the coefficient $a(\cdot)$ verifies (1.2). Then, there exists a constant $C_1 > 0$ such that every solution ρ and ϱ of (5.16) and (5.17) respectively, satisfy, for any s large enough, the following inequality

\widetilde{\rho}(T,\cdot) &= \widetilde{\rho}_T^T & \text{in } \Omega
\end{cases}$$
(5.21)

and

$$\begin{cases}
\widetilde{\varrho}_{t} - (a(x)\widetilde{\varrho}_{x})_{x} + b_{1}\widetilde{\varrho} + \beta(x)b_{2}\widetilde{\varrho}_{x} &= \widetilde{\mathcal{G}}_{2} & \text{in } Q, \\
\widetilde{\varrho}(t,0) = \widetilde{\varrho}(t,1) &= 0 & \text{on } (0,T), \\
\widetilde{\varrho}_{2}(0,\cdot) &= 0 & \text{in } \Omega,
\end{cases} (5.22)$$

where

$$\widetilde{\mathcal{G}}_1 = \widetilde{\varrho}\chi_{\omega_d} - (a(x)\xi_x \ \rho)_x - \xi_x \ a(x)\rho_x - \beta(x)a_2\xi_x\rho$$

and

$$\widetilde{\mathcal{G}}_2 = -\left(\frac{\alpha_1}{\mu_1}\chi_{\omega_1} + \frac{\alpha_2}{\mu_2}\chi_{\omega_2}\right)\widetilde{\rho} - (a(x)\xi_x \ \varrho)_x - \xi_x \ a(x)\varrho_x + \beta(x)b_2\xi_x\varrho.$$

Applying the Carleman estimate (5.9) to system (5.21) with $G_1 = a_2 \tilde{\rho}$ and $G_2 = \tilde{\mathcal{G}}_1$, we obtain

+ C \int_{0}^{T} \int_{\mathcal{O}_{1}} e^{2s\varphi} |\widetilde{\rho}|^{2} dx dt + C \int_{Q} s^{2} \Theta^{3} \frac{\beta^{2}(x)}{a(x)} |a_{2}\widetilde{\rho}|^{2} e^{2s\varphi} dx dt.$$
(5.23)

From the definition of ξ , we have

$$\int_{Q} |(a(x)\xi_{x}\rho)_{x} + a(x)\xi_{x}\rho_{x}|^{2}e^{2s\varphi} dx dt = \int_{Q} ((a(x)\xi_{x})_{x}\rho + 2a(x)\xi_{x}\rho_{x})^{2}e^{2s\varphi} dx dt
\leq \int_{Q} \left[2((a(x)\xi_{x})_{x})^{2}|\rho|^{2} + 8(a(x)\xi_{x})^{2}|\rho_{x}|^{2} \right]e^{2s\varphi} dx dt
\leq C \int_{0}^{T} \int_{\mathcal{O}'} (|\rho|^{2} + |\rho_{x}|^{2}) e^{2s\varphi} dx dt.$$
(5.24)

In the other hand, using the fact that $x \mapsto \frac{x^2}{a(x)}$ is non-decreasing on (0,1], thanks to Hardy-Poincaré inequality (2.11) applied to the function $e^{s\varphi}\widetilde{\varrho}$ and using the definition of φ , we get

Using (5.10), we obtain

$$\int_{O} |\widetilde{\varrho}\chi_{\omega_{d}}|^{2} e^{2s\varphi} dx dt \leq C \left(\int_{O} \Theta a(x) \widetilde{\varrho}_{x}^{2} e^{2s\varphi} dx dt + \int_{O} s^{2} \Theta^{3} \frac{x^{2}}{a(x)} \widetilde{\varrho}^{2} e^{2s\varphi} dx dt \right). \tag{5.25}$$

\leq \|a_{2}\|_{\infty}^{2}L^{2} \int_{0}^{T} \int_{\mathcal{O}'} a(x)|\rho|^{2}e^{2s\varphi} dx dt.$$

Due to the fact that a(x) is bounded for all $x \in \mathcal{O}'$, we deduce

$$\int_{Q} |\beta(x)a_{2}\xi_{x}\rho|^{2} e^{2s\varphi} dx dt \le C(\|a_{2}\|_{\infty}) \int_{0}^{T} \int_{\mathcal{O}'} |\rho|^{2} e^{2s\varphi} dx dt.$$
 (5.28)

Combining (5.23)-(5.28), we obtain

$$\mathcal{I}(\widetilde{\rho}) \leq C \int_0^T \int_{\mathcal{O}'} (\rho^2 + \rho_x^2) e^{2s\varphi} \, dx \, dt + C \int_Q \left(\Theta a(x) \widetilde{\varrho}_x^2 + s^2 \Theta^3 \frac{x^2}{a(x)} \widetilde{\varrho}^2 \right) e^{2s\varphi} \, dx \, dt + C \int_Q \left(\Theta a(x) \widetilde{\rho}_x^2 + s^2 \Theta^3 \frac{x^2}{a(x)} \widetilde{\varrho}^2 \right) e^{2s\varphi} \, dx \, dt.$$
 (5.29)

Arguing in the same way as in (5.29) with $\tilde{\varrho}$ solution of (5.22), we get

Adding (5.29) and (5.30) and taking s large enough, we obtain

\overline{\rho}(t,0) &= \overline{\rho}(t,1) &= 0 & \text{on} \quad (0,T), \\
\overline{\rho}_1^T, \quad \overline{\rho}(T,\cdot) &= \overline{\rho}^T & \text{in} \quad \Omega,
\end{cases} (5.32)$$

and

$$\begin{cases}
\overline{\varrho}_t - (a(x)\overline{\varrho}_x)_x + b_1\overline{\varrho} + \beta(x)b_2\overline{\varrho}_x &= \overline{\mathcal{G}}_2 & \text{in} \quad Q_\alpha, \\
\overline{\varrho}(t,0) &= \overline{\varrho}(t,1) &= 0 & \text{on} \quad (0,T), \\
\overline{\varrho}(0,\cdot) &= 0 & \text{in} \quad \Omega,
\end{cases} (5.33)$$

where

$$\overline{\mathcal{G}}_1 = \overline{\varrho} \chi_{\mathcal{O}_d} - (a(x)\vartheta_x \ \rho)_x - \vartheta_x \ a(x)\rho_x - \beta(x)a_2\vartheta_x\rho$$

and

$$\overline{\mathcal{G}}_2 = -\left(\frac{\alpha_1}{\mu_1}\chi_{\omega_1} + \frac{\alpha_2}{\mu_2}\chi_{\omega_2}\right)\overline{\rho} - (a(x)\vartheta_x \ \varrho)_x - \vartheta_x \ a(x)\varrho_x + \beta(x)b_2\xi_x\varrho.$$

Since on Q_{α} all the above systems are non degenerate, applying the classical Carleman estimate (5.15) to system (5.32) with $H = \beta(x)a_2\overline{\rho}$ and $H_1 = \overline{\mathcal{G}}_1$, one obtains

because $\eta(t,x) := \Theta(t)e^{r\sigma(x)} \le \Theta(t)e^{r\|\sigma(x)\|_{\infty}}$.

Using the definition of the function ϑ , we have

$$\leq C \int_{0}^{T} \int_{Q'} (\rho^{2} + \rho_{x}^{2}) e^{2s\Phi} dx dt. \tag{5.35}$$

On the other hand, since $x \mapsto \frac{x^2}{a(x)}$ is non-decreasing on (0,1] and thanks to Hardy-Poincaré inequality (2.11) to the function $e^{s\Phi}\overline{\varrho}$, we get

We have $\overline{\rho} = \vartheta \rho$ and since ϑ is bounded on \mathcal{O}_1 , we deduce that

 (5.37)

Using the fact that $|\beta(x)| \leq L\sqrt{a(x)}$ (see Remark 1) and the definition of ϑ , we have

Arguing as in (5.40) to $\overline{\rho}$ solution of (5.33), we obtain

$$\mathcal{I}(\rho) + \mathcal{I}(\varrho) \le C_1 \int_0^T \int_{\mathcal{O}_1} s^3 \Theta^3(\rho^2 + \varrho^2) e^{2s\Phi} \, dx \, dt.$$

This completes the proof of Theorem 5.1. ■

5.2 An observability inequality result

This part is devoted to the observability inequality of systems (5.16)-(5.17). This inequality is obtained by using the intermediate Carleman estimate (5.19).

Under the assumptions of Theorem 5.1, there exists a constant $C_2 > 0$, such that every solution (ρ, ϱ) to (5.16)-(5.17), satisfies, for s large enough, the following inequality:

$$J_{3} = -\int_{Q} (a(x)(u\xi)_{x})_{x} \rho \varrho dx dt, J_{4} = -2 \int_{Q} a(x)(u\xi)_{x} \rho \varrho_{x} dx dt,$$

$$J_{5} = \int_{Q} (a_{1} - b_{1})u\xi \rho \varrho dx dt, J_{6} = \int_{Q} \beta(x)u\xi \rho(a_{2} - b_{2})\varrho_{x} dx dt, J_{7} = \int_{Q} \beta(x)a_{2}(u\xi)_{x} \rho \varrho dx dt.$$

$$\leq \frac{\delta_{1}}{2} \int_{Q} s^{3} \Theta^{3} \frac{x^{2}}{a(x)} e^{2s\varphi} |\varrho|^{2} dx \, dt + C_{\delta_{1}} \int_{0}^{T} \int_{\mathcal{O}_{2}} s^{5} \Theta^{13} \frac{a(x)}{x^{2}} e^{2s(2\Phi - \varphi)} |\rho|^{2} dx \, dt,$$

for any $\delta_1 > 0$.

$$J_{3} \leq C \int_{Q} s^{5} \Theta^{5} e^{2s\Phi} \xi |\rho \varrho| \, dx \, dt$$

$$\leq \frac{\delta_{2}}{2} \int_{Q} s^{3} \Theta^{3} \frac{x^{2}}{a(x)} e^{2s\varphi} |\varrho|^{2} dx \, dt + C_{\delta_{2}} \int_{0}^{T} \int_{\mathcal{O}_{2}} s^{7} \Theta^{7} \frac{a(x)}{x^{2}} e^{2s(2\Phi - \varphi)} |\rho|^{2} dx \, dt,$$

for any $\delta_2 > 0$.

$$J_4 \leq C \int_Q s^4 \Theta^4 a(x) e^{2s\Phi} \xi |\rho \varrho_x| \, dx \, dt$$

$$\leq \frac{\delta_3}{2} \int_Q s \Theta a(x) e^{2s\varphi} |\varrho_x|^2 dx \, dt + C_{\delta_3} \int_0^T \int_{\mathcal{O}_2} s^7 \Theta^7 a(x) e^{2s(2\Phi - \varphi)} |\rho|^2 dx \, dt,$$

for some $\delta_3 > 0$.

Since $|\beta(x)| \leq L\sqrt{a(x)}$, we have

$$\leq \frac{\delta_{6}}{2} \int_{Q} s^{3}\Theta^{3}\frac{x^{2}}{a(x)}e^{2s\varphi}|\varrho|^{2}dx dt + C_{\delta_{6}}(\|a_{2}\|_{\infty}) \int_{0}^{T} \int_{\mathcal{O}_{2}} s^{5}\Theta^{5}\frac{a(x)}{x^{2}}\beta^{2}(x)e^{2s(2\Phi-\varphi)}|\rho|^{2}dx dt.$$

Since $|\beta(x)| \leq L\sqrt{a(x)}$, we have

$$J_7 \leq \frac{\delta_6}{2} \int_{\mathcal{O}} s^3 \Theta^3 \frac{x^2}{a(x)} e^{2s\varphi} |\varrho|^2 dx dt + C_{\delta_6} (\|a_2 - b_2\|_{\infty}) \int_0^T \int_{\mathcal{O}_2} s^5 \Theta^5 \frac{a^2(x)}{x^2} e^{2s(2\Phi - \varphi)} |\rho|^2 dx dt,$$

for any $\delta_6 > 0$.

Finally, choosing the constants δ_i such that $\delta_1 = \delta_2 = \delta_4 = \delta_6 = \frac{1}{4C_1}$ and $\delta_3 = \delta_5 = \frac{1}{2C_1}$, where C_1 is the constant obtained to Theorem 5.1, it follows from (5.50) and the previous inequalities that

Combining (5.19) with (5.51) and taking μ_i , i = 1, 2 large enough, we obtain

+ C \int_0^T \int_{\mathcal{O}_2} s^7 \Theta^7 a(x) e^{2s(2\Phi - \varphi)} |\rho|^2 dx dt + C(\|a_2 - b_2\|_{\infty}) \int_0^T \int_{\mathcal{O}_2} s^5 \Theta^5 e^{2s(2\Phi - \varphi)} |\rho|^2 dx dt
+ C(\|a_2\|_{\infty}) \int_0^T \int_{\mathcal{O}_2} s^5 \Theta^5 \frac{a^2(x)}{x^2} e^{2s(2\Phi - \varphi)} |\rho|^2 dx dt.$$

Then in view of the definition of φ and Θ , the functions $\widetilde{\varphi}(.,x)$ and $\widetilde{\Theta}(\cdot)$ are of class \mathcal{C}^1 on [0,T[. We have the following result.

Under the assumptions of Proposition 5.5, there exist a positive constant $C = C(C_2, \|a_1\|_{\infty}, \|a_2\|_{\infty}, \|b_1\|_{\infty}, \|b_2\|_{\infty}, \mu_1, \mu_2, T) > 0$ and a positive weight function κ such that every solution (ρ, ψ^i) of (3.8)-(3.9), satisfies the following inequality:

6 Null controllability of semilinear degenerate system

In this section, we end the proof of Theorem 1.1. More precisely, we prove that the linear systems (3.6)-(3.7) are null controllable. Thanks to the Proposition 5.6, the following result holds.

where $C = C(C_2, ||a_1||_{\infty}, ||a_2||_{\infty}, ||b_1||_{\infty}, ||b_2||_{\infty}, \mu_1, \mu_2, \alpha_1, \alpha_2, T) > 0.$

For every $z \in \mathbb{Z}$, we define

$$I(z) = \{\bar{h}^z \in L^2(\omega_T), \ (y^z, p^{i,z}) \text{ solution of } (6.14) - (6.15) \text{ satisfies } (1.10) \text{ with } \bar{h}^z \text{ verifying } (6.18) \}$$

$$(6.20)$$

and

$$\Lambda(z) = \left\{ (y^z, p^{i,z}) : (y^z, p^{i,z}) \text{ is the state associated to a control } \bar{h}^z \in I(z) \text{ and } (y^z, p^{i,z}) \text{ satisfies (6.19)} \right\}.$$
(6.21)

In this way, we introduce a multivalued mapping

$$z \longmapsto \Lambda(z)$$
.

We want to prove that this mapping has a fixed point y. Of course, this will imply that there exists a control $\bar{h} \in L^2(\omega_T)$ such that the solution of (3.2)-(3.3) satisfies (1.10).

To this end, we will use the Kakutani's fixed point Theorem that can be applied on Λ . Proceeding as in [33, 8], we can prove the following properties for every $z \in Z$.

Proposition 6.2

- 1. $\Lambda(z)$ is a non empty, closed and convex set of Z.
- 2. $\Lambda(z)$ is a bounded and compact set of Z.
- 3. The application $z \mapsto \Lambda(z)$ is upper hemi-continuous.

This end the proof of Theorem 1.1 and furthermore the proof of null controllability of system (1.1). ■

7 Conclusion

In this paper, we established the Stackelberg-Nash null controllability of a semilinear degenerate parabolic equation with a non-linearity involving a gradient term. We proved that we can act on the system with one leader and two followers. Since the system is semilinear, the functionals are not convex in general. To overcome this difficulty, we first obtain the existence and uniqueness of the Nash quasi-equilibrium, which is a weaker formulation of the Nash equilibrium. Next, with additional conditions, we established the equivalence between the Nash quasi-equilibrium and the Nash equilibrium. Finally, after establishing suitable Carleman estimates, we proved an observability inequality allowing us to obtain our null controllability result.

8 Appendix

8.1 Proof of Proposition 2.1

Proof.

We proceed in three steps.

Step 1. We show the estimate (2.9). Make the change of variable $z(t, x) = e^{-rt}y(t, x)$, $(t, x) \in Q$, for some t > 0 where t = 0 wh

$$\begin{cases}
z_t - (a(x)z_x)_x + a_0z + \beta(x)b_0z_x + rz &= (h\chi_\omega + v^1\chi_{\omega_1} + v^2\chi_{\omega_2})e^{-rt} & \text{in } Q, \\
z(t,0) = z(t,1) &= 0 & \text{on } (0,T), \quad (8.1) \\
z(0,\cdot) &= y^0 & \text{in } \Omega.
\end{cases}$$

If we multiply the first equation in (8.1) by z and integrate by parts over Q, we obtain

$$\int_{Q} z_{t} z \, dx dt - \int_{Q} (a(x)z_{x})_{x} z \, dx dt + \int_{Q} rz^{2} \, dx dt = -\int_{Q} a_{0}z^{2} \, dx dt - \int_{Q} \beta(x)b_{0}z_{x}z \, dx dt + \int_{Q} z(h\chi_{\omega} + v^{1}\chi_{\omega_{1}} + v^{2}\chi_{\omega_{2}})e^{-rt} \, dx dt.$$

This latter equality becomes

$$\frac{1}{2} \|z(T,\cdot)\|_{L^{2}(\Omega)}^{2} - \frac{1}{2} \|z(0,\cdot)\|_{L^{2}(\Omega)}^{2} + \|\sqrt{a(x)}z_{x}\|_{L^{2}(Q)}^{2} + r\|z\|_{L^{2}(Q)}^{2}
\leq \int_{Q} a_{0}z^{2} dxdt + \int_{Q} \beta(x)b_{0}z_{x}z dxdt + \int_{Q} z(h\chi_{\omega} + v^{1}\chi_{\omega_{1}} + v^{2}\chi_{\omega_{2}})e^{-rt} dxdt.$$
(8.2)

We have

$$\int_{Q} a_0 z^2 \, dx dt \le \|a_0\|_{\infty} \|z\|_{L^2(Q)}^2. \tag{8.3}$$

Using the fact that $|\beta(x)| \leq L\sqrt{a(x)}$ (see (1.5)), we have

$$\int_{Q} \beta(x)b_{0}z_{x}z \, dxdt \leq \int_{Q} L\sqrt{a(x)}b_{0}z_{x}z \, dxdt
\leq \frac{1}{2}L^{2}\|b_{0}\|_{\infty}^{2}\|z\|_{L^{2}(Q)}^{2} + \frac{1}{2}\|\sqrt{a(x)}z_{x}\|_{L^{2}(Q)}^{2}.$$
(8.4)

Due to the fact that $e^{-rt} \leq 1$, $\forall t \in [0, T]$, we get

$$\int_{Q} z(h\chi_{\omega} + v^{1}\chi_{\omega_{1}} + v^{2}\chi_{\omega_{2}})e^{-rt} dxdt \leq \int_{Q} z(h\chi_{\omega} + v^{1}\chi_{\omega_{1}} + v^{2}\chi_{\omega_{2}}) dxdt
\leq \frac{3}{2}\|z\|_{L^{2}(Q)}^{2} + \frac{1}{2}\|v^{1}\|_{L^{2}(\omega_{1,T})}^{2} + \frac{1}{2}\|v^{2}\|_{L^{2}(\omega_{2,T})}^{2} + \frac{1}{2}\|h\|_{L^{2}(\omega_{T})}^{2}.$$
(8.5)

Combining (8.3)-(8.5) with (8.2), one obtains

$$\begin{split} &\frac{1}{2}\|z(T,\cdot)\|_{L^2(\Omega)}^2 + \frac{1}{2}\|\sqrt{a(x)}z_x\|_{L^2(Q)}^2 + \left(r - \|a_0\|_{\infty} - \frac{1}{2}L^2\|b_0\|_{\infty}^2 - \frac{3}{2}\right)\|z\|_{L^2(Q)}^2 \\ &\leq \frac{1}{2}\|y^0\|_{L^2(\Omega)}^2 + \frac{1}{2}\|v^1\|_{L^2(\omega_{1,T})}^2 + \frac{1}{2}\|v^2\|_{L^2(\omega_{2,T})}^2 + \frac{1}{2}\|h\|_{L^2(\omega_{T})}^2. \end{split}$$

Taking r such that $r = ||a_0||_{\infty} + \frac{1}{2}L^2||b_0||_{\infty}^2 + 2$, we obtain

$$\|z(T,\cdot)\|_{L^2(\Omega)}^2 + \|z\|_{L^2((0,T);H^1_\sigma(\Omega))}^2 \le \|y^0\|_{L^2(\Omega)}^2 + \|v^1\|_{L^2(\omega_{1,T})}^2 + \|v^2\|_{L^2(\omega_{2,T})}^2 + \|h\|_{L^2(\omega_T)}^2.$$

Since $z = e^{-rt}y$, we deduce the existence of a constant $C = C(T, ||a_0||_{\infty}, ||b_0||_{\infty}) > 0$ such that the following estimation holds:

$$\|y(T,\cdot)\|_{L^2(\Omega)}^2 + \|y\|_{L^2((0,T);H_a^1(\Omega))}^2 \le C\left(\|v^1\|_{L^2(\omega_{1,T})}^2 + \|v^2\|_{L^2(\omega_{2,T})}^2 + \|h\|_{L^2(\omega_T)}^2 + \|y^0\|_{L^2(\Omega)}^2\right)$$

and we deduce the inequality (2.9).

Step 2. We prove existence by using Theorem 2.1. First of all, it is clear that for any $\phi \in \mathbb{V}$, we have

$$\|\phi\|_{L^2((0,T);H^1_a(\Omega))} \le \|\phi\|_{\mathbb{V}}$$

This shows that we have the continuous embedding $\mathbb{V} \hookrightarrow L^2((0,T); H^1_a(\Omega))$. Now, let $\phi \in \mathbb{V}$ and consider the bilinear form $\mathcal{A}(\cdot,\cdot)$ defined on $L^2((0,T); H^1_a(\Omega)) \times \mathbb{V}$ by:

$$\mathcal{A}(y,\phi) = -\int_{Q} y\phi_t \, dx \, dt + \int_{Q} a(x)y_x \phi_x \, dx \, dt + \int_{Q} a_0 y\phi \, dx \, dt + \int_{Q} \beta(x)b_0 y_x \phi \, dx \, dt. \tag{8.6}$$

Using Cauchy Schwarz inequality, Remark 5 and the fact that $|\beta(x)| \leq L\sqrt{a(x)}$, we get that

$$\begin{aligned} |\mathcal{A}(y,\phi)| & \leq & \|y\|_{L^{2}(Q)} \|\phi_{t}\|_{L^{2}(Q)} + \|\sqrt{a(x)}y_{x}\|_{L^{2}(Q)} \|\sqrt{a(x)}\phi_{x}\|_{L^{2}(Q)} + \|a_{0}\|_{\infty} \|y\|_{L^{2}(Q)} \|\phi\|_{L^{2}(Q)} \\ & + & \|\sqrt{a(x)}y_{x}\|_{L^{2}(Q)} \|Lb_{0}\|_{\infty} \|\phi\|_{L^{2}(Q)} \\ & \leq & \sqrt{2} \left[\|\phi_{t}\|_{L^{2}(Q)}^{2} + \|\sqrt{a(x)}\phi_{x}\|_{L^{2}(Q)}^{2} + (\|a_{0}\|_{\infty}^{2} + L^{2}\|b_{0}\|_{\infty}^{2}) \|\phi\|_{L^{2}(Q)}^{2} \right]^{1/2} \|y\|_{L^{2}((0,T);H_{a}^{1}(\Omega))}. \end{aligned}$$

This means that there is a constant $C = C(\phi, ||a_0||_{\infty}, ||b_0||_{\infty}) > 0$ such that

$$|\mathcal{A}(y,\phi)| \leq C||y||_{L^2((0,T);H^1(\Omega))}.$$

Consequently, for every fixed $\phi \in \mathbb{V}$, the functional $y \mapsto \mathcal{A}(y,\phi)$ is continuous on $L^2((0,T); H^1_a(\Omega))$. Next, we have that for every $\phi \in \mathbb{V}$,

$$\mathcal{A}(\phi,\phi) = -\int_{Q} \phi \phi_{t} \, dx \, dt + \int_{Q} a(x) \phi_{x}^{2} \, dx \, dt + \int_{Q} a_{0} \phi^{2} \, dx \, dt + \int_{Q} \beta(x) b_{0} \phi_{x} \phi \, dx \, dt. \tag{8.7}$$

Due to Assumption 1.1, we get

$$\int_{Q} a_0 \phi^2 dx dt \ge \alpha \|\phi\|_{L^2(Q)}^2.$$

Using (8.4), one have

$$\int_{Q} \beta(x)b_0\phi_x\phi \ dxdt \ge -\frac{1}{2}L^2\|b_0\|_{\infty}^2\|\phi\|_{L^2(Q)}^2 - \frac{1}{2}\|\sqrt{a(x)}\phi_x\|_{L^2(Q)}^2.$$

Combining the two latter inequalities with (8.7) and using again Assumption 1.1, we obtain

$$\mathcal{A}(y,\phi) \geq \frac{1}{2} \|\phi(0,\cdot)\|_{L^{2}(\Omega)}^{2} + \frac{1}{2} \|\sqrt{a(x)}\phi_{x}\|_{L^{2}(Q)}^{2} + \left(\alpha - \frac{1}{2}L^{2}\|b_{0}\|_{\infty}^{2}\right) \|\phi\|_{L^{2}(Q)}^{2}$$
$$\geq \min\left\{\frac{1}{2}, \left(\alpha - \frac{1}{2}L^{2}\|b_{0}\|_{\infty}^{2}\right)\right\} \|\phi\|_{\mathbb{V}}^{2}.$$

Finally, let us consider the linear functional $\mathcal{L}(\cdot): \mathbb{V} \to \mathbb{R}$ defined by

$$\mathcal{L}(\phi) := \int_{Q} (h\chi_{\omega} + v^{1}\chi_{\omega_{1}} + v^{2}\chi_{\omega_{2}}) \phi \, dx \, dt + \int_{\Omega} y^{0}(x) \, \phi(0, x) \, dx.$$

Then using Remark 5, we obtain

$$|\mathcal{L}(\phi)| \leq \|h\chi_{\omega} + v^{1}\chi_{\omega_{1}} + v^{2}\chi_{\omega_{2}}\|_{L^{2}(Q)} \|\phi\|_{L^{2}(Q)} + \|y^{0}\|_{L^{2}(\Omega)} \|\phi(0, \cdot)\|_{L^{2}(\Omega)}$$

$$\leq (\|h\chi_{\omega} + v^{1}\chi_{\omega_{1}} + v^{2}\chi_{\omega_{2}}\|_{L^{2}(Q)} + \|y^{0}\|_{L^{2}(\Omega)}) \|\phi\|_{\mathbb{V}}$$

$$\leq C\|\phi\|_{\mathbb{V}},$$

where $C = C(T, h, v^1, v^2) > 0$. Therefore, $\mathcal{L}(\cdot)$ is continuous on \mathbb{V} . Thus, it follows from Theorem 2.1 that there exists $y \in L^2((0,T); H^1_a(\Omega))$ such that

$$\mathcal{A}(y,\phi) = \mathcal{L}(\phi), \quad \forall \varphi \in \mathbb{V}.$$
 (8.8)

We have shown that the system (2.1) has a solution $y \in L^2((0,T); H_a^1(\Omega))$ in the sense of Definition 2.1. In addition, using the first equation of (2.1), we deduce that $y_t \in L^2((0,T); (H_a^1(\Omega))')$. So $y \in W_a(0,T)$ and using Remark 4, it follows that $y \in \mathbb{H}$.

Step 3. We prove uniqueness. Assume that there exist y_1 and y_2 solutions to (2.1) with the same right hand side h, v^1 , v^2 and initial datum y^0 . Set $z := e^{-rt}(y_1 - y_2)$. Then z satisfies

$$\begin{cases}
z_t - (a(x)z_x)_x + a_0z + \beta(x)b_0z_x + rz & = 0 & \text{in } Q, \\
z(t,0) = z(t,1) & = 0 & \text{on } (0,T), \\
z(0,\cdot) & = 0 & \text{in } \Omega.
\end{cases}$$
(8.9)

So, if we multiply the first equation in (8.9) by z, and integrate by parts over Q, we obtain

$$\frac{1}{2}\|z(T,\cdot)\|_{L^2(\Omega)}^2 + \frac{1}{2}\|\sqrt{a(x)}z_x\|_{L^2(Q)}^2 + \left(r - \|a_0\|_{\infty} - \frac{1}{2}L^2\|b_0\|_{\infty}^2\right)\|z\|_{L^2(Q)}^2 \le 0.$$

Choosing $r = ||a_0||_{\infty} + \frac{1}{2}L^2||b_0||_{\infty}^2 + \frac{1}{2}$ in this latter inequality, we deduce that

$$||z||_{L^2((0,T);H_a^1(\Omega))}^2 \le 0.$$

Hence z=0 in Q and then, $y_1=y_2$ in Q and we have shown uniqueness. This complete the proof. \blacksquare

8.2 Proof of Theorem 2.2

Proof.

We divide the proof into two steps.

Step 1. We prove the existence of the weak solution to the problem (1.1) by using the Schauder fixed point theorem. We proceed as in Theorem 2.1 [41].

For any $z \in L^2((0,T); H^1_a(\Omega))$, it holds that

$$F(z, z_x) - F(0, 0) = \int_0^1 \frac{\partial}{\partial r} F(rz, rz_x) dr$$

= $\int_0^1 z D_1 F(rz, rz_x) dr + \int_0^1 z_x D_2 F(rz, rz_x) dr$.

Define

$$d_1(z) = \int_0^1 D_1 F(rz, rz_x) dr$$
 and $d_2(z) = \frac{1}{\beta(x)} \int_0^1 D_2 F(rz, rz_x) dr$.

Then

$$F(z, z_x) - F(0, 0) = d_1(z)z + \beta(x)d_2(z)z_x.$$

Moreover, using the point (H_5) of Assumption 1.1, one get

$$||d_1||_{\infty} \le M_2, \quad ||d_2||_{\infty} \le M_2.$$
 (8.10)

Now, the system (1.1) becomes

$$\begin{cases} y_t - (a(x)y_x)_x + d_1(z)y + \beta(x)d_2(z)y_x &= h\chi_{\omega} + v^1\chi_{\omega_1} + v^2\chi_{\omega_2} & \text{in } Q, \\ y(t,0) = y(t,1) &= 0 & \text{on } (0,T), \\ y(0,\cdot) &= y^0 & \text{in } \Omega. \end{cases}$$
(8.11)

It follows from Proposition 2.1 that the problem (8.11) admits a unique weak solution $y \in \mathbb{H}$. Define the mapping $\Lambda : L^2((0,T); H^1_a(\Omega)) \longrightarrow L^2((0,T); H^1_a(\Omega))$ as follows:

$$\Lambda(z) = y, \ z \in L^2((0,T); H_a^1(\Omega)),$$

where y is the weak solution to problem (8.11). Proceeding as in [41], we can prove that the operator Λ is continuous and compact. Moreover the range of Λ is bounded. The operator Λ satisfies the hypotheses of the Schauder fixed point theorem. Therefore, Λ admits a fixed point $y \in L^2((0,T); H_a^1(\Omega))$ such that $y = \Lambda(y) \in \mathbb{H}$ is a weak solution to the problem (1.1).

Step 2. Now, we want to prove the uniqueness of the weak solution. Assume that \tilde{y} and \bar{y} are two weak solutions to the system (1.1) and set

$$W = \tilde{y} - \bar{y}$$
.

Observe that

$$F(\tilde{y}, \tilde{y}_x) - F(\bar{y}, \bar{y}_x) = \theta_1(t, x)W + \theta_2(t, x)W_x, (t, x) \in Q$$

where

$$\theta_1(t,x) = \int_0^1 D_1 F(r\tilde{y} + (1-r)\bar{y}, r\tilde{y}_x + (1-r)\bar{y}_x) dr,$$

$$\theta_2(t,x) = \frac{1}{\beta(x)} \int_0^1 D_2 F(r\tilde{y} + (1-r)\bar{y}, r\tilde{y}_x + (1-r)\bar{y}_x) dr.$$

Then W is the solution to the following problem

$$\begin{cases} W_t - (a(x)W_x)_x + \theta_1(t, x)W + \beta(x)\theta_2(t, x)W_x &= 0 \text{ in } Q, \\ W(t, 0) = W(t, 1) &= 0 \text{ on } (0, T), \\ W(0, \cdot) &= 0 \text{ in } \Omega. \end{cases}$$

Thanks to (H_5) and (H_6) of Assumption 1.1, there exists a positive constant M such that

$$\|\theta_1\|_{\infty}, \|\theta_2\|_{\infty} \leq M.$$

It follows from Proposition 2.1 that

$$W=0$$
 in Q .

Then

$$\tilde{y} = \bar{y} \text{ in } Q.$$

The proof is complete. ■
