# Introduction

On average, pulmonary rehabilitation (PR) in patients with chronic obstructive pulmonary disease (COPD) improves quality of life, dyspnea, and exercise tolerance (grade A). However, some patients show no improvement and are considered "non-responders" (NR). NR are found for all types of variables (biological, psychosocial..) and represent a worrying number of patients (30 to 50% depending on the variables considered)<sup>1</sup>. Despite its major importance (major predictor of survival in particular)<sup>2</sup>, the existence of NR on muscle strength after RP has never been specifically studied. Thus, our objectives were 1) to assess the prevalence of non responders in terms of quadriceps muscle strength (NR-QMS), and if so, 2) to define the characteristics of NR-QMS and 3) to identify the predictors of non response.

## Methods

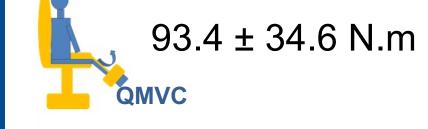
# Retrospective study:

- COPD patients (Tiffeneau index <0.70)</p>
- Admitted for a pulmonary rehabilitation program (PR) between May 2019 and December 2020.
- Quadriceps maximal voluntary isometric contraction (QMVC) assessed before and after PR
- Complying with RGPD ethic rules

### Participants (n=62):









# **Pulmonary rehabilitation:**

Inpatient stay at the Clinique du souffle « Les Clarines »

4-weeks program including muscle strenghtening 5 days a week

Resistance training consisted of a 65-75% of maximal repetition maximum test

### **Outcomes:**

- Before PR (T1): > Anthropometric characteristics: Age, body mass, height, body mass index (BMI) and muscle mass index (MMI)
- Disease severity: BODE index
- ➤ Respiratory function: FEV<sub>1</sub>
- Blood gases: PaO<sub>2</sub>, PaCO<sub>2</sub>

#### Before (T1) and after (T2) PR:

- Exercise tolerance (6MWT) and quality of life (VQ11)
- Quadriceps maximal voluntary isometric contraction

## **Statistical analyses:**

#### **Identification of NR-QMS:**

➤ NR-QMS if QMVC improvement after PR < MCID\* (7.5 N.m)<sup>3</sup>

### **Prediction of nonresponse to PR:**

- Logistic regression analysis (stepwise)
  - Dependent variable : Non-response
  - Independant variables: Pre PR anthropometric characteristics, disease severity, blood gases, pulmonary function, exercise tolerance, quality of life and muscle strength.

\*MCID = Minimum clinically relevant difference

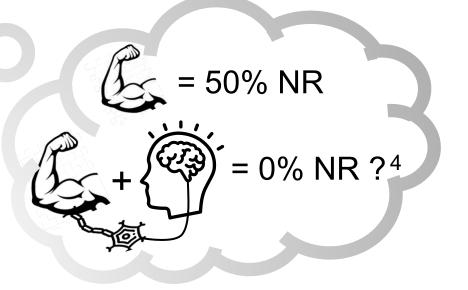
# Conclusions

**50%** of patients are **non-responders**!

Efficacy assessement of PR on muscle strength cannot be based on mean values Their identification is therefore essential!

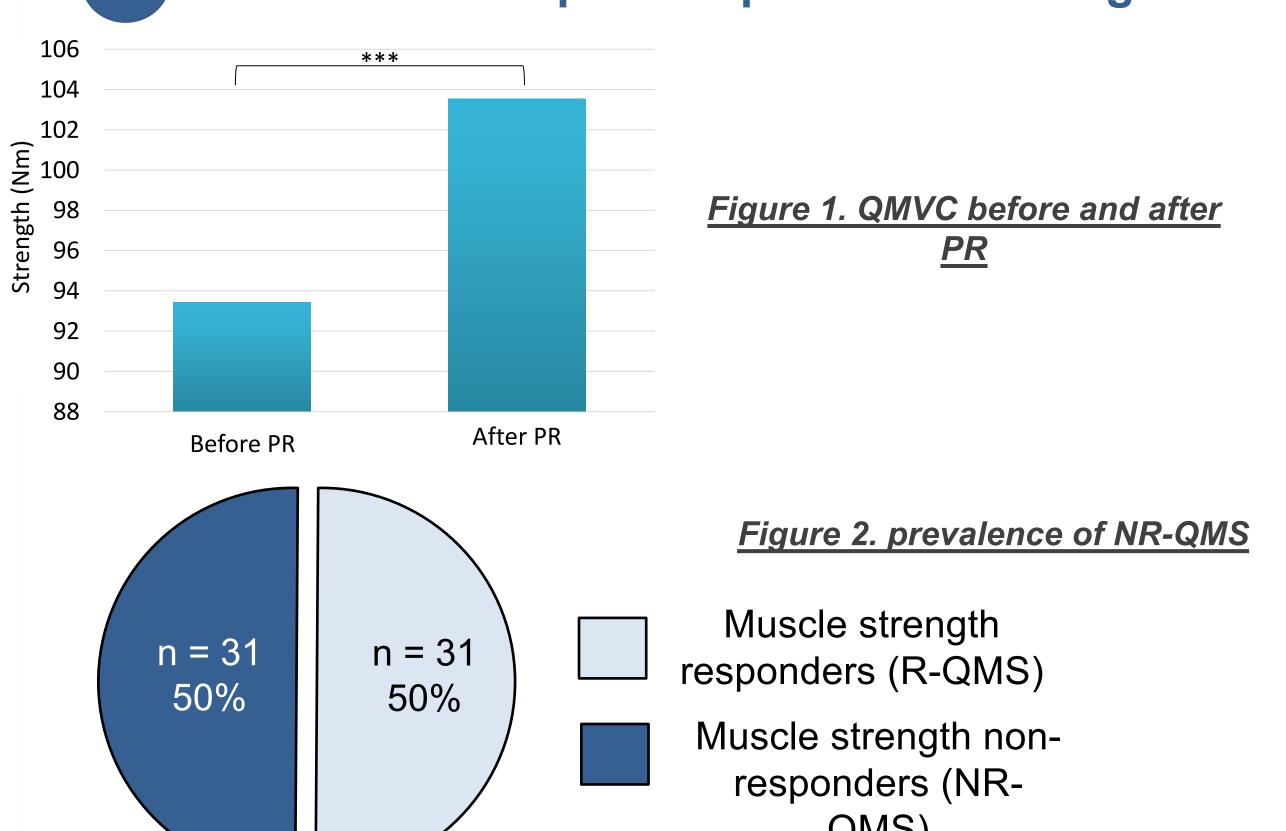
Should we talk about nonresponders or inappropriate programs?





# Results

# PR effects on quadriceps muscle strength



→ Patients show a mean increase in strength (+10 ± 13 N.m)

50% of the patients have a force evolution lower than the MCID and are non-responders

→ NR-QMS had significantly lower height, body mass, and PaO<sub>2</sub> than QMS-R



# PREDICTION OF NON-RESPONSE

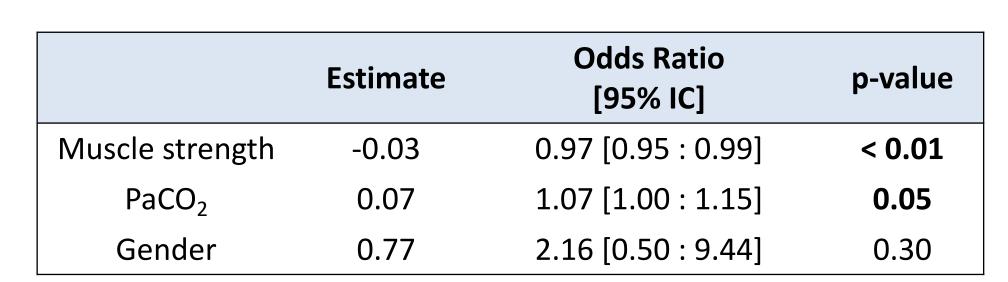


Table 2. Results of stepwise logistic regression

- **→** Low pre PR QMVC and high PaCO<sub>2</sub> are significant predictors of non-response.
  - → Gender was added to the model because it substantially improved the prediction performance

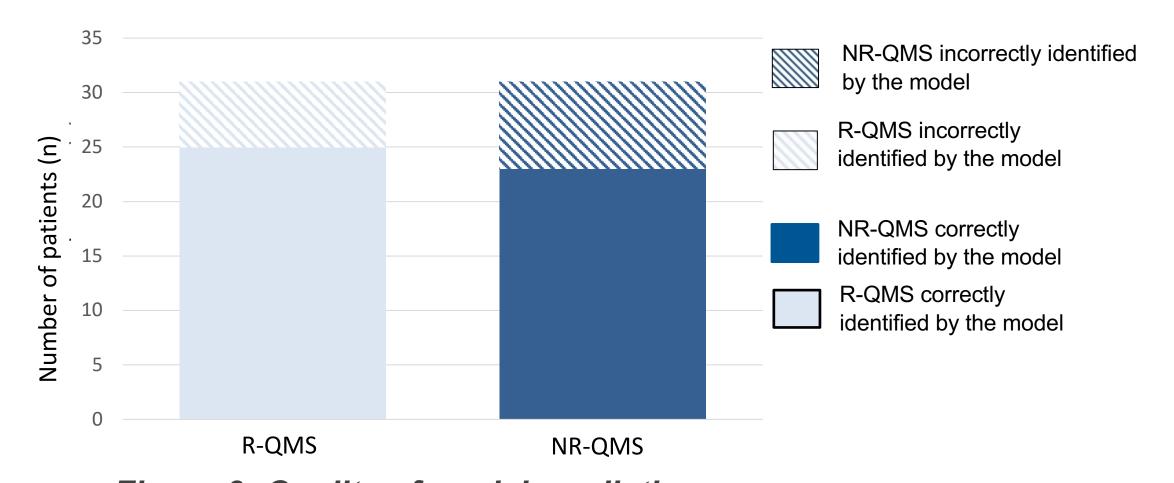


Figure 3: Quality of model prediction

→ This model has a specificity of 81% and a sensitivity of 74%.
