BACKGROUND

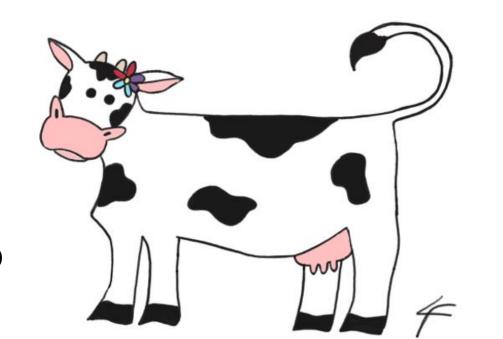


Bovine brucellosis (BB), mainly caused by Brucella abortus, causes significant economic losses in the bovine sector

- Paraguay is divided into 2 regions:
 - Eastern region: large cattle population, extensive production
 - Western region: large number of cattle farms, intensive production

The general objective of this work was to develop a bovine

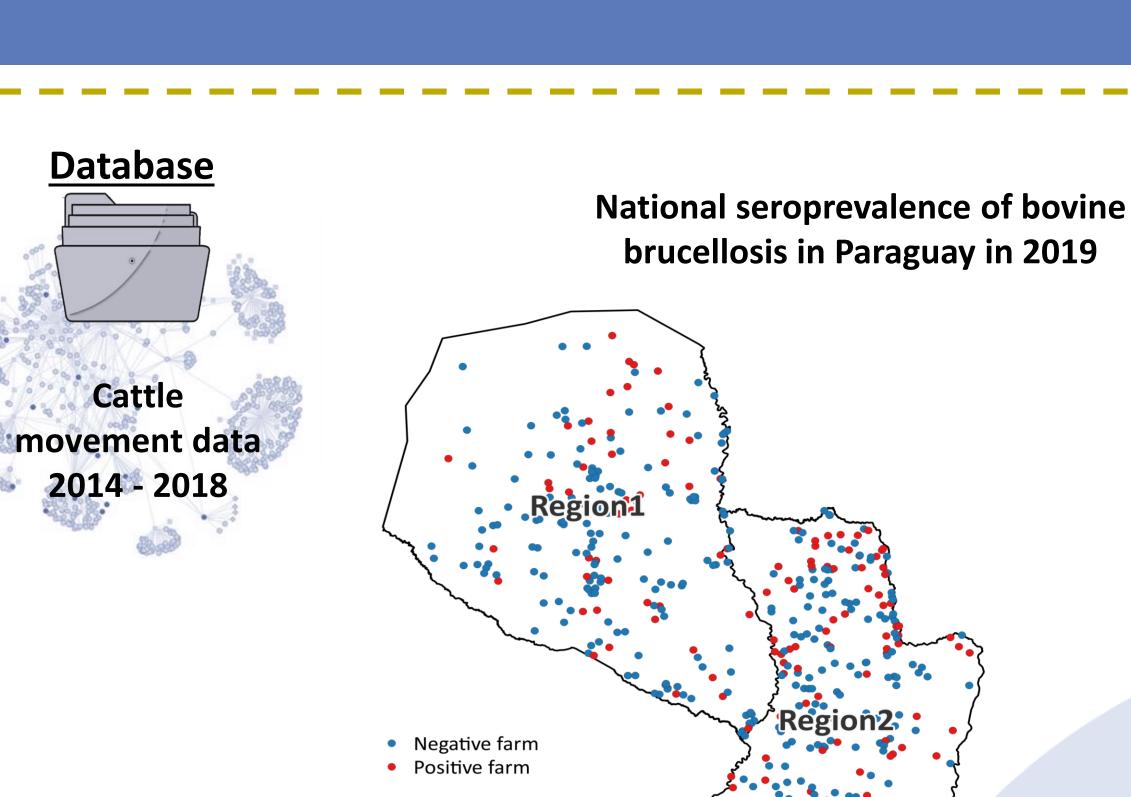
In Paraguay, where livestock farming is the main economic activity, bovine brucellosis is an endemic disease and one of the main cattle diseases

- 3 categories of farm size according to the number of cows:
 Small family farms with <20 cows
 - Medium commercial farms with **20-80 cows**

PRELIMINARY RESULTS

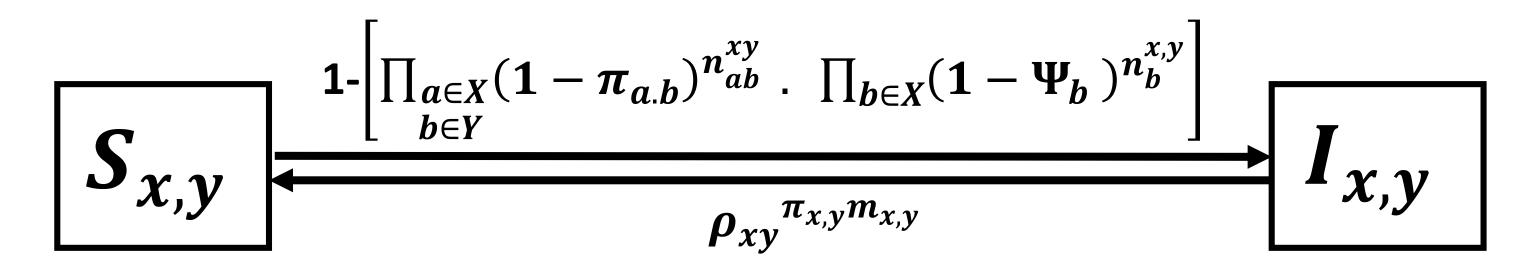
• Large commercial farms with >80 cows

Model formulation:

We developed a deterministic model for the transmission of brucellosis by the trade of cows, based on a database of cattle movements between farms. Epidemiological units were farms. Time step was annual.



State variables: $S_{x,y}$ and $I_{x,y}$, number of susceptible/infected farms in region $x \in X$ of size $y \in Y$ Data: n_u^v number of animals sold by u to v, with u = x, y for a farm of region x and size y, and u = x for a market of region x

 $m_{x,y}$ median size for a farm of region x and size category yCalculated variable: Ψ_y proportion of infected animals in market of region y

Parameter estimation by minimizing the log-likelihood of seroprevalence data at the simulated

Location of negative and positive sampled cattle farms

When fitting the model we took into account the 2 regions and the 3 farm sizes

epidemiological equilibrium

- $oldsymbol{\pi}_{x,y}$ within-farm prevalence in farms of region x and size y
- $ho_{x,y}$ yearly culling probability of an infected animal in farms of region x and size y

Model choice: a total of 16 comparative models were compared that combined 4 possible parameterizations of $\pi_{x,y}$ and $\rho_{x,y}$: same value for all regions and farm sizes, farm size-specific values, region-specific values, both farm size and region-specific values. The model with region-specific values of $\pi_{x,y}$ and farm size-specific values of $\pi_{x,y}$ and farm size-specific values of $\rho_{x,y}$ was selected based on AIC (1,138).

Model fit: in 96% of farms, the observed number of positive animals was within the 95% confidence interval of the prediction

DISCUSSION AND PERSPECTIVES

Data on animal movement and the resulting contacts between farms can be represented in the form of networks. Several studies have shown how the spread of diseases follows the structure of these commercial networks. Our model shows a balance between the bovine brucellosis transmission between farms through cow trade, and an increasing yearly culling probability of infected animals according to farm size. This could be explained by differences in the professionalization of breeders and in the production types (e.g. fattening of cull cows in largest farms). In the future, this work could help predict results of the implementation of bovine brucellosis control methods in Paraguay.
