Abstract: The side chain of methionine residues is long enough to establish NH…S H-bonds with neighboring 15 carbonyl groups of the backbone, giving rise to so-called intra-residue 6^{δ} and inter-residue 7^{δ} H-bonds. The aim 16 of the present article is to document how substitution of sulfur by a selenium atom affects H-bonding of the Met 17 system. This was investigated both experimentally and theoretically by conformation-resolved optical spectros-18 copy, following an isolated molecule approach. The present work emphasizes the similarities of the Met and 19 Sem residues, in terms of conformational structures, energetics, NH···Se/S H-bond strength and NH stretch spec-20 tral shifts, but also reveals subtle behavior differences between them. It provides evidence for the sensitivity of 21 the H-bonding network with the folding type of the Sem/Met side chains, where a simple flip of the terminal 22 part of the side chain can induce an extra 50 cm⁻¹ spectral shift of the NH stretch engaged in a 7⁸ NH···S/Se bond. 23

Keywords: Seleno-methionine ; H-bonding ; side chain-backbone interactions ; gas phase ; conformational analysis ; conformation-selective spectroscopy ; laser ; quantum chemistry

1. Introduction

Selenium is essential to the living world.[1, 2] Despite chemical and physical properties 28 close to those of sulfur, namely similar outer valence-shell configuration and electron 29 affinities, nature has taken advantage of its specific properties, in particular its redox 30 properties, to provide proteins with resistance mechanisms to permanent oxidation.[2] 31 In proteins, Se is thus present in two residues, Se-cystein, one of the proteinogenic amino 32 acids, and the non-genetically coded seleno-methionine (Se-Met, or in short Sem).[1] The 33 latter is randomly incorporated in proteins due to several factors: first, it mimics the 34 chemical properties of the sulfur-based amino acid methionine (Met), preventing the 35 genetic code machinery to discriminate between Met and Se-Met [3]; second, methionine 36 being an essential amino acid, it is taken from the diet, and finally, seleno-methionine is 37 abundant in some plant-originated food, such as Brazil nuts, grassland legumes and 38 soybeans [1, 4], although with marked fluctuations depending upon the crop region.[5] 39 This leads to an isosteric replacement of sulfur by selenium, which is thought to have 40 little effects on the structure [1]: for instance the existence of such heavy atom mutants 41

has been widely used by physicists to improve structural information, e.g. by facilitating42the phasing problem in x-ray crystallography.[1, 6]43

Despite the expected similarities between chalcogens, Se differ from S through a few 44 features, potentially critical for structural issues, namely its van der Waals radius, its 45 polarisability and nucleophilic properties.[1, 2] Se is also often thought as a weaker 46 nucleophile and thus a weaker H-bonding acceptor [1, 2]. These views, however, have 47 been recently questioned [7-9], especially in view of studies on model thio- and seleno-48 compounds, led under isolated conditions, which provided evidence for strong 49 interactions of S and Se heteroatoms with NH groups; an information considered as 50 transferable to proteins.[9] Optical IR and UV spectroscopic studies of model systems of 51 biological relevance, indeed, have recently targeted the S heteroatom[9-13] and more 52 recently selenium.[9, 14, 15] In most cases, various models of biomolecules are complexed 53 with a dimethylsulfide or dimethylselenide, which enables modeling the acceptor H-54 bonding properties of the chalcogen divalent heteroatom. 55

However, experimental data on directly relevant models of protein chains like amino 56 acid or peptides remains seldom. Although S-based side-chain-backbone local H-bond 57 interactions have been documented with Cys[16-18] and Met[19] (Scheme 1), only 58 experimental results on Se-Cys[18] were recently reported together with a Protein Data 59 Bank survey suggesting the occurrence of strong H-bonding with Se.[9] The aim of the 60 present work is to document the local interactions of the Se heteroatom of a Se-Met 61 residue in a two-residue model of a protein chain. Taking a gas phase approach, the 62 conformational diversity and H-bonding content of a model of peptide chain containing 63 a Se-Met residue, namely the Ac-Sem-Phe-NH2 (Scheme 2), were probed using IR and 64

UV state-of-the-art spectroscopic diagnostics and assigned by comparison with quantum69chemistry calculations.[20, 21] The presence of the Phe residue in the sequence is justified70by the need of a near-UV chromophore in the system in order to perform IR-UV71spectroscopy. The chemical protections of the Sem-Phe sequence were chosen in order to72avoid any side effects due to ends that would not be relevant to a protein chain, and thus73to mimic properly a segment of such a chain, i.e., containing complete -CONH- peptide74bonds.75

At stake is the understanding of the backbone folding (presence of C5, C7 or C10 H-79 bonds, stabilizing respectively extended, γ -turn or β -turn structures) in these model 80 backbones and its interplay with the local H-bonding interactions that Se can establish 81 with the backbone NH groups, namely the so-called 6^{δ} intra-residue or 7^{δ} inter-residue 82 main chain-side chain H-bonds.[22] Despite their local character, these bonds are 83 expected to sample, at least partially, the diversity of NH…Se inetractions encountered 84 in proteins. Comparison of these results with those on the related sulfur compound (Ac-85 Met-Phe-NH₂)[19] is also carried out to document the specificities of Se relative to S as 86 well as the effect of the long side chain of methionine. 87

2. Methods

The gas phase spectroscopy of the peptide samples was recorded using experimental set-90 up and procedures described elsewhere. [21, 23] Sample vaporization was carried out 91 using a home-made laser-desorption equipment, based on a pulsed valve, generating gas 92 pulses, which expanded in an efficiently pumped vacuum chamber (pressure of 2 10-5 93 torr during operation). A solid pellet, made of pressed powder of the peptide of interest 94 mixed with graphite, was placed at the exit nozzle (1 mm diameter) of the pulsed valve, 95 operating with a 30:70 mixture of Ne:He at a backing pressure of 20 bars. The output of 96 a frequency-doubled YAG laser (0.1-2 mJ/pulse) was sent through an optical fiber on the 97 surface of the pellet, causing the sample vaporization. Laser-desorbed molecules were 98 then entrained and cooled down by the pulsed supersonic expansion, and after passing 99 through a skimmer, entered the extraction region of a time-of-flight mass spectrometer, 100 where optical interaction with pulsed ns lasers took place. The resulting ions were then 101 detected on a microchannel plate detector, according to their m/z mass channel. The 102 YAG-pumped dye laser (NarrowScan, Radiant) was scanned to record mass-selected UV 103 spectra, through resonant two-photon ionization (R2PI). Conformer-selective IR 104 spectroscopy in the NH stretch region was obtained through double resonance IR/UV 105 spectroscopy: the IR laser (LaserVision OPO) was scanned whereas the UV laser was 106 tuned to a transition of the desired conformer, leading to a depletion of the ion signal 107 when this specific conformer absorbed the IR light. The IR spectra were obtained by 108 comparing UV signals with IR laser on and off, according to a procedure described 109 previously.[23] 110

The IR spectra obtained are then compared to simulated spectra obtained for the most 111 stable conformations of the peptide. Regarding theoretical calculations, conformational 112

exploration was carried out using the OPLS_2005 force field model within the 113 Macromodel suite, [24] followed by a quantum chemistry level optimization carried out 114 using the TurboMole package [25] at the DFT-D level of theory (RI-B97-D3(BJ-abc)/def2-115 TZVPPD), which has been proved to be relevant for the conformation description of gas 116 phase peptides.[21, 26] Among the numerous conformations found by the molecular 117 mechanic calculation, the candidates that were optimized at the DFT level of theory – 118 approximately a hundred- were chosen firstly on the ground of relative energies given 119 by the force field, and secondly as representative of different families of structures, using 120 a home-made script to regroup the conformers in structural clusters. The latter point was 121 important in order to make sure that the DFT calculations were representative of the 122 whole conformational landscape. 123

Theoretical energetics was obtained at both 0 K and 300 K, the latter being usually 124 relevant for describing the conformational distribution of desorbed peptides.[21, 27] The 125 theoretical gas phase spectra were then obtained from the theoretical harmonic 126 frequencies, once scaled using mode-dependent scaling factors, calibrated from linear 127 fits of the correlation between experimental and harmonic NH stretch frequencies (fscaled 128 = a + b.f^{harmonic}) on a large library of gas phase peptides (cf. Supp. Info. of Ref. [28]). The 129 scaling factors (a, b) applied to the harmonic frequencies were recalculated for the level 130 of theory presently used: for a peptide NH stretch mode: $a = 372.8 \text{ cm}^{-1}$ and b = 0.86953; 131 for a carboxamide NH₂ symmetric stetch mode, $a = 1209.8 \text{ cm}^{-1}$ and b = 0.63115 and for 132 its antisymmetric counterpart, $a = 1324.1 \text{ cm}^{-1}$ and b = 0.60872. This procedure usually 133 provides a typical accuracy of 20 cm⁻¹ in the NH stretch range.[26] The assignment is 134 eventually derived from the best fit between experimental spectra and those of the most 135 stable peptide structures calculated at 300 K. [26] 136

Finally, a Natural Bonding Orbital (NBO) analysis of the NH···S/Se H-bonding 137 interactions was carried out to quantify the stabilizing role of electron delocalization 138 through H-bonding effects on remarkable conformations of the capped Sem-Phe and 139 Met-Phe dipeptides studied as well as on the (thio/seleno-dimethylether...trans-140 methylacetamide; in short S/Se(Me)²··· MAA) intermolecular model reference system, in 141 a similar way as in a previous study on the amide-amide interactions in peptides. [29] 142 Calculations [30-32] were performed on the RI-B97-D3(BJ)-abc/TZVPPD structures using 143 the NBO module [33] of the Gaussian 16 software, [34] following a procedure described 144 in detail previously. [22, 29] 145

In order to characterize the NH···Se/S H-bonding in relevant conformations, the 159 stabilization energies resulting from the electron delocalization between NBOs of the H- 160 bond proton acceptor (Se) and donor (NH), i.e., the donating NBO (Lewis-like occupied 161 lone pairs of the Sem/Met side chain Y atom, Y = S or Se, labelled n_Y and n'_Y) and the 162 accepting unoccupied σ_{NH}^* NBO respectively, were summed up to provide a total 163 stabilization energy, noted ΣE_{HB} , due to the H-bond considered. 164

3. Conformational landscapes

The exploration of the conformational landscape of Ac-Sem-Phe-NH₂, coupled to 167 quantum chemistry structure optimisations, led to two types of structures: 168

either, overall folded forms based on the presence of a β -turn; stabilized by a C10 H-bond, 170 or, more or less extended forms, based on C5 or C7 backbone local interactions, where 171 the two ends of the molecule do not interact with each other (Figure 1). 172

- The folded backbone forms are additionally stabilized by a side-chain/main chain 173 intra-residue H-bond, forming a 6-membered ring, where the side chain heteroatom Se 174 plays the role of proton acceptor. According to a terminology used previously [21], 175 based on the H-bonding status of the successive NH bonds along the backbone, these 176 conformations belong to a 6^{δ} - π -10 folded backbone family: the number stands for the 177 length of the ring formed by the H-bond concerned, the δ superscript for a backbone-side 178 chain H-bond bridging a NH bond with a side chain acceptor in a δ position relative to 179 the main chain, and π for a NH- π interaction with Phe ring. The structural analysis shows 180 that the intra- residue 6^{δ} H-bond can take place with a specific side chain folding, 181

described by a *gauche*+ (*g*+) and *gauche*- (*g*-) orientation of the χ_1 and χ_2 dihedrals (i.e., the N-C^{α}-C^{β}-C^{γ} and C^{α}-C^{β}-C^{γ}-Se dihedrals) respectively. Two possible orientations of the 205 terminal methyl group of the Sem side chain (described by the C^{β}-C^{γ}-Se-C^{ϵ} χ_3 dihedral) 206 can take place: *gauche*- and *anti* (*a*) respectively, which give rise to significantly different 207 H-bond lengths and strengths (see below). For the sake of simplicity, the Sem side chain 208 conformation is thus identified by the orientation of the terminal group (*g*- or *a*). Similarly 209 the Phe side chain can take three possible orientations (*g*+, *g*- or *a*) depending on the χ_1 210 dihedral, but in the present case *g*+ conformations are favoured by the formation of an 211 intraresidue NH- π H-bond. For the sake of identification, conformations have thus been 212 labelled with the Sem and Phe side chains' orientations, given as indices on the symbol 213 (5, 7, 6^{δ}, 7^{δ}, π , or f (for free)) that indicates the H-bonding status of the NH group of the 214 corresponding residue.

- The extended or semi-extended forms correspond to the succession of local conformational preferences of the basic peptide backbone, found with Ala or residues, i.e., the so-called C5 or C7 structures corresponding to β -sheet or γ -turns respectively, the latter folding existing under two chiral forms, the inverse and direct γ -turns, labelled L or D respectively. The key point here is the fact that the presence of the Sem side chain does locally stabilize an extended C5 backbone conformation, thanks to the formation of a 7^{δ} inter-residue H-bond. Again the Sem side chain end adopts conformations where such a bond can form (χ_1 and χ_2 having a and g+ orientations respectively), but the orientation of the terminal methyl group of the Sem side chain (described by the χ_3 dihedral) can occur either in an *a* or a *g*+ orientation.

As a consequence, the semi-extended and extended forms (Fig. 1) exhibit a 5-7^{δ}-7 and a 226 5-7^{δ}/5- π backbone resp., the 7^{δ}/5 notation standing for a second NH group simultaneously 227 involved in 7^{δ} and C5 interactions. Finally, depending on the Phe side chain orientation, 228 additional π H-bonds can form. In semi-extended forms with a Phe *g*+ orientation, the 229 second NH group is simultaneously involved in a 7^{δ} H-bond and a π interaction with the 230

Phe side chain (notation $7^{\delta}/\pi_{g^+}$ in Fig. 1), without strongly affecting the overall backbone structure, the 7^{δ} H-bonds and their relative strengths.

Regarding the relative stability of the three families (Figure 2), The β -turn family is by far the most stable one compared to the extended and semi-extended forms. The latter being however much richer, because, in contrast to the other families, different Phe orientations can lead to comparable stabilities, due to various opportunities of interactions involving the Phe side chain with other parts of the molecule. Additionally, related structures differing by the absence of one of the interaction (and hence entropically favoured) or to the presence of an alternative form (7_{D} H-bond instead of 7_{L}) tend to enhance the family population at high (room) temperature, which has been found to be the relevant temperature to describe the conformational population in the supersonic expansion (due to the rapid conformational freezing taking place in it).[27, 28]

4. Experimental results and assignments 4.1. UV spectroscopy

The near UV spectrum of the Ac-Sem-Phe-NH² compound, obtained using the resonant two-photon ionization technique, was composed of several narrow bands (Fig. 3a) ranging over more than 150 cm⁻¹. Noticeably, it presented an intense band, located at 37556 cm⁻¹ (A band), and doublets around 37650 cm⁻¹ (D and B bands) and 37500 cm⁻¹ (C and C'). Owing to the similarity expected between Met and Sem dipeptides, the spectrum was compared with that of the Met-related dipeptide, namely Ac-Met-Phe-NH2, for

which a doublet of UV features, labelled A and B (Fig. 3a), was previously [19] assigned 286 to a folded 6^{δ} - π -10 β -turn form (A) and a semi-extended 5-7^{δ}-7 structure (B), 287 corresponding to different H-bonding of the Met side chain to the backbone. Interestingly 288 the band A of the Sem molecule is located in the same range as the A-B UV doublet of 289 Ac-Met-Phe-NH₂. However, owing to the proximity of the doublet lines, belonging to 290 different conformations, it appears difficult to infer an assignment out of sole UV data. 291 More interesting, the D-B doublet seems to have a counterpart in the Met molecule, but 292 D appears more intense band in the Sem molecule. Finally and may-be the most 293 interesting point is the C-C' doublet, which does not show any counterpart in Met. This 294 relatively red-shifted position is strikingly close to that observed for the extended forms 295 of Ac-Phe-NH₂, [35] Ac-Ala-Phe-NH₂, Ac-Gly-Phe-NH₂ [36], Ac-Cys-Phe-NH₂[17] and 296 Ac-Sec-Phe-NH₂ [22] molecules, suggesting a conformational population with Sem 297 differing from that observed with Met. In support of this, we noticed that the C-C' 298 doublet is found to appear in hot conditions of the supersonic expansion, more precisely, 299 at short delays between the pulsed valve aperture and the desorption laser pulse. 300

4.2 IR spectroscopy

4.2.1 Conformational population of Ac-Sem-Phe-NH₂

In order to access the conformational and structural content underlying the UV spectra, 306 double resonance IR/UV experiments were carried out to cover in the NH stretch region, 307 by probing each of the intense (labelled) bands of the UV spectrum of Fig. 3a. The IR 308 spectra obtained (Fig. 3b and 3c) turned out to exhibit different natures. Whereas four 309 NH stretch bands are expected due to the four NH oscillators of the molecule (as 310 illustrated by the IR spectra of the Met compound [19]), which is observed in UV bands 311 A, B and C, the intense D band showed a more complex IR pattern, with one extra band 312 at 3452 cm⁻¹ (marked with an asterisk in Fig. 3b), which was eventually interpreted as a 313 hybrid IR spectrum composed of a main component (D conformer) superimposed with 314 a minor additional population (whose nature will be discussed below). In addition, the 315 IR spectrum obtained from C' being identical to that from C, C' was assigned to a vibronic 316 band at 12 cm-1 from the C origin. As a result, only four different IR spectra were found 317 (Figure 3) demonstrating the existence of four different conformers, populated in the 318 expansion. 319

Taking advantage of the absence of coupling between the NH stretch modes of the 321 molecules, interesting qualitative information was readily derived from the examination 322 of IR spectra. In each spectrum, the position of the vibrational bands reveals the type of 323 interaction undergone by the corresponding NH bonds [21]: below 3400 cm⁻¹ a H-bond 324 $(7^{\delta}, 6^{\delta}, \text{ or C10})$, in the 3420-3460 cm⁻¹ weak interactions such as C5 or π bonds, and around 325 3530 cm⁻¹, the asymmetric stretch band of NH₂. A careful examination showed a marked 326 resemblance of A and D IR spectra (provided that the band of the D spectrum that is 327 marked with an asterisk is discarded). The main difference stems fom the strength of the 328 strongest H-bond, suggesting a shared backbone structure. In contrast, B and C showed 329 different patterns, as testified by the spectral position of the antisymmetric NH₂ stretch. 330 In B, the asymmetric NH₂ stretch band appear as a weak, noisy band at 3520 cm⁻¹, which 331

revealed an H-bond engaged NH, whereas the blue position at 3540 cm⁻¹ in C suggested 332 the involvement in a significantly weaker interaction, typically a π -type H-bond. 333 Moreover, B exhibited the strongestH-bond of all the observed forms. 334

For a more detailed analysis, the experimental spectra were compared with the 336 theoretical IR spectra of the most stable forms obtained in the conformational analysis of 337 Ac-Sem-Phe-NH₂ (Fig. 2). Following a procedure successfully used previously,[23] the 338 theoretical spectra obtained for the most stable forms of each family at 300 K (Table S1) 339 were compared to the experimental spectra, and assessed according to the RMS and 340 maximum unsigned error to the experimental bands. 341

The examination shows that in most cases, a quite good agreement was met for one of 343 these low energy structures, and that in most of the cases it was possible to distinguish between *a* and *g*+ Sem side chain orientations. 345

The good agreement of A and D spectra with the two most stable 6^{δ} - π -10 conformational 347 family (RMS and unsigned maximum errors lower than 8 and 13 cm⁻¹ resp.) provided a 348 straightforward assignment of A and D to β -turn structures ($6^{\delta_a}-\pi_{g^+}-10$ and 349 $6^{\delta_g-\pi_{g^+}-10}$, with *a* and *g*- χ_3 Sem side chains respectively (Fig. 3b). The *g*+ side chain in D 350 provided a slightly better 6^{δ} H-bond approach and distance (248 pm vs. 251 pm) than the 351 a form as testified by the spectral red-shift of ~ 20 cm⁻¹ for the corresponding IR band 352 relative to A. In both cases the orientation of the Phe side chain (g+) enables the formation 353 of a π H-bond. Satisfactorily conformer A exhibits a UV frequency (37557 cm⁻¹) that 354 matches that of such a β -turn in absence of any other group interacting with Phe (Cf. the 355 transition of the β -turn B of Ac-Gly-Phe-NH₂ at 37562 cm⁻¹ [36]). The blue shift of the 356 band of conformer D should then be ascribed to the interaction between the Se lone pairs 357 and the Phe ring, which are facing each other in this structure. 358

At this stage, the origin of the asterisk-marked additional band in the IR spectrum D at 359 3452 cm⁻¹ should be discussed. It is located in the region of weakly H-bonded NHs, 360 between π -bonded and free NHs.[26] Several hypotheses can be put forward : i) the 361 occurrence of Fermi resonance between the NH mode involved in the π H-bond and a 362 CO stretch mode in the 1730 cm⁻¹ region, the latter being however not confirmed by 363 calculations, or ii) it may arise from another oscillator, e.g. an H-bonded OH stretch of a 364 water molecule ; its presence in the IR spectrum would be due to the presence of an 365 hydrate of monomer D in the supersonic expansion : if a water molecule solvates an 366 acceptor site located far from the UV chromophore (e.g. the Se atom), the UV features of 367 the complex can coincide with those of the corresponding monomer, its IR bands are 368 expected to differ essentially by the water bands, the symmetrical OH stretch being 369 possibly located in the region considered.[13, 28] Finally since post-photoionisation 370 fragmentation is often encountered in these systems, [28] the hydrate's signatures are 371 anticipated in the monomer mass channel. 372

Conformer B exhibited a different IR pattern (Figure 3c), which was well accounted for 374 by two conformations among the most stable ones within the 5-7^b-7 backbone family at 375 300 K (see supplementary materials ; Table S1), namely the 5_a - 7^b_{g+} -7_L and 5_a - 7^b_{g-} -7_L forms. 376 The red shift of the 7^δ band indicates unambiguously an *a* χ_3 dihedral for Sem, leading to 377

a NH····Se approach with a short distance of 259 and 249 pm for g+ and g- Phe side chains 378 respectively. It will be noted that despite the 7^{δ} NH···Se distances are comparable to or 379 longer than the 6^{δ} H-bonds, the resulting spectral shifts indicate a stronger H-bonding, 380 suggesting that the 7^{δ} H-bond benefits from a much more efficient geometrical approach 381 [29] than its 6^{δ} counterpart. This point will be further discussed in Section 5.3. 382

A further assignment in terms of Phe side chain orientation (g+ vs. g-) is difficult to propose. It is nevertheless interesting to notice that the semi-extended form with a 7_D Hbond (5_a -7 $_{g}^{a}$ -7_D) that also provides a fair spectral match can be discarded due to its unfavorable energetics. 386

In contrast, for the C form a good match is found for the lowest 5_a -7 $b/5_a$ - π extended 387 backbone conformation, despite a relatively surprising unfavorable energetics (ΔG of 7.6 388 kJ/mol). Again the red shift of the 7^{δ} band pleads in favor of an *a* orientation of the Sem 389 side chain χ_3 over its g+ challenger, this latter being additionally still higher in energy at 390 low temperature (Fig. 2). The assignment to an extended form, at least on the Phe residue, 391 is supported by the remarkable UV spectral features of C: the *a* Phe side chain makes the 392 structure around Phe very similar to that of the main conformer $\beta_{L}(anti)$ of the Ac-Phe-393 NH2 (NAPA) molecule, accounting for both the range of its UV transition (cf. 34500 cm⁻¹ 394 in NAPA) and its Franck-Condon activity, namely the presence of the C' band assigned 395 to a vibronic band, associated to an active low frequency mode in the S1 state (18 cm⁻¹ in 396 NAPA). 397

5. Discussion

5.1 Revisiting the spectroscopy of Ac-Met-Phe-NH₂

The present results on the selenomethionine capped dipeptide was also an opportunity 401 to revisit previous investigations on its sulfur equivalent. For this purpose a landscape 402 investigation was also carried out at the same level of theory as for the Sem compound. 403 The results (Figure 2) illustrate the striking similarities between these conformational 404 spaces, which share the same three backbone family pattern. They differ essentially by 405 minor energetics changes, the extended forms appearing slightly more unfavoured in 406 Met than in Sem dipeptides, as well as the semi-extended forms 5_{a} -7⁶-7^L, having a ag+a407 Met side chain. 408

IR spectra were also calculated at the same level of theory ; satisfactorily the results were 409 qualitatively comparable to those obtained previously [19] at a more modest level of 410 theory for a more limited set of conformations, but seemed to achieve a better match to 411 experiment. 412

Figure 4a compares the IR spectra of conformations assigned to a β -turn (6^{δ} - π -10 family), 413 namely conformation A of the MetPhe sequence, and A and D for the SemPhe sequence, 414 with relevant theoretical spectra. The experimental spectra of conformations A present 415 marked similarities, suggesting the same assignment, a conclusion partly supported by 416 the slightly better agreement met for the $6^{\delta_a-\pi_{g^{+}}-10}$ form, although its challenger ($6^{\delta_{g^{+}}-\pi_{g^{+}}-10}$ 417 10), would not have been rejected on sole theoretical grounds (also see Table S2). The 418 band A of the MetPhe sequence, previously assigned to the 6°_{g+} - π_{g+} -10 structure by Biswal 419 et al. [19] (conf a in this reference), is eventually assigned to the $6\delta_a$ - π_{g^+} -10 form. 420

Interestingly UV data (Fig. 3a) provide additional information: It supports the 443 assignment since in both sequences the band A is found in the same spectral region 444 (37560 cm⁻¹), accordingly to the weak substitution effect expected. Additionnally, it also 445 suggests a prediction : the band at 37650 cm⁻¹ with Met (not investigated in [19]), which 446 coincides with the D band of Sem, can be tentatively assigned to the $6^{\circ}_{g+}-\pi_{g+}-10$ form of 447 this molecule. 448

In passing, here, one will notice that the g+g-g- Met/Sem side chain gives rise to a slightly stronger 6^{δ} H-bond. This point will be further discussed later on.

Regarding the semi-extended form (conformer B) of the Met-Phe sequence, it was 452 previously assigned to the $5_{g+7}\delta_{g-7D}$ conformation by Biswal et al. [19] This form, as 453 one of the most stable semi-extended forms (Fig. 2), is indeed one possibility, but 454 alternative assignments, with comparable energetic and IR fitting scores are also possible, 455 namely the $5_{g+}-7^{\delta}/\pi_{g+}-7_{L}$ and $5_{g+}-7^{\delta}_{g-}-7_{L}$ forms (See Fig. 4b and Table S2). Concerning the 456 absence of such a 5_{g+7} ^o-7^L form in the Sem-Phe sequence, energetic data at 300 K (Fig. 2) 457 suggest that such backbone with Sem is less stabilized relative to its 5a-7⁶-7^L counterpart 458 with Met. It could be that these forms correspond to the weak (not probed) UV bands in 459 the vicinity of band A in the Sem-Phe spectrum of Figure 3a. 460

As far as the extended form C is concerned, its absence in the Met-Phe sequence [19] 462 should probably be ascribed to a less complete exploration of the experimental 463 conditions in this early study. As a matter of fact, depending on the expansion conditions 464 chosen when recording the UV spectra, the C-C' conformer can be easily overlooked. 465

5.2 Comparing the H-bonding patterns of Sem and Met

The striking similarity of the IR spectra of bands A of the Sem-Phe and Met-Phe 468 sequences (Figure 4a) suggests close H-bonding features in these conformations, in 469 particular very similar 6^{δ} H-bond strengths for S and Se heteroatoms, with a slight 470 advantage to Se, which exhibits, for a same conformation, a red shift increase of ~ 15 471 cm⁻¹. As far as the B bands are concerned (Figure 4a), however, the situation seems to be 472 much more contrasted. Whereas the C7 and C5 backbone H-bond features remain 473 unchanged (C5) or in the same region (within 30 cm⁻¹ for C7), it is no longer the case for 474 the 7⁸ bonds, whose spectral shifts differ by typically 65 cm⁻¹. While one could be tempted 475 to assign the observation to a specific property of Se compared to S, the examination of 476 the theoretical spectra (Figure 4b) within the rich semi-extended family (See Figure 2) 477 suggests another reason. Calculations confirm the robustness of the backbone bands 478 within the family, but also provides evidence for a significant dependence of the 7⁸ bond 479 with the χ_3 dihedral of the Sem/Met side chain, which corresponds to different 480 presentations of the heteroatom lone pair to the NH H-bond donor, the anti χ_3 dihedral 481 providing typically a 50 cm⁻¹ increase in the IR red shift than its g+ counterpart (Figure 482 4b). 483

As a conclusion, the significant change in the 7^{δ} H-bond strength when substituting Se to 484 S should rather be ascribed to a change in side chain conformation (from the 5_{g+7} ⁰⁻⁷ with 485 S to the 5_{a} - 7^{b} -7 with Se), rather than to an intrinsic Se property. The lack of experimental 486 data on the same forms for the S and Se compounds precludes experimental evidence for 487 the relative H-bonding strengths for this backbone arrangement, but calculations confirm 488 that, for a same conformation, the effect of substituting Se to S on the 7^{δ} H-bond strength 489 remains modest, with a red shift increase remaining smaller than 15 cm⁻¹ for ag+a side 490 chains (5a-7^{δ}-7 conformations) and nearly inexistent for *ag*+*g*+ side chains. 491

5.3 General considerations from NBO analysis

The stabilization energy due to H-bonding has been analyzed using the NBO tool for a 494 selected series of conformations, capable of accounting for the observations -i.e. those 495 mentioned in Figure 4 as well as the most stable extended form $5_{a}-7^{\circ}/5_{a}-\pi$ – together with, 496 for reference, the Me-Se/S-Me--trans-methylacetamide intermolecular complex. Follow-497 ing an approach previously derived for amide-amide NH…OC interactions in peptides, 498 [29] which enables to decouple the effect of the geometrical approach to that of the H-499 bond distance, the variation of the NBO stabilization (in a semi-log plot) with the 500 NH…Se/S distance is drawn in Figure 5. 501

First of all, regarding the Se/S comparison, this plot demonstrates that for a given 502 conformation, the S-compound exhibits a systematic shorter NH…Y distance of ~12 pm 503 for the S compounds, readily assigned to the shorter van der Waals radius of S compared 504 to Se.[37] In contrast, the stabilization energy between S and Se remains rather similar, 505 with slight variations depending on the H-bond type. Se gives rise to a slightly stronger 506

effect for the 7^{δ} and in 6^{δ} bonds in *ag+a* and *g+g-g-* side chains respectively, in qualitative 507 agreement with the spectral red shifts found theoretically between the Se and S 508 compounds for the corresponding conformations. In the alternative side chains, *ag+g+* 509 and *g+g-a* respectively, the difference is less obvious, again in agreement with the 510 robustness of the 7^{δ} band in presence of *ag+g+* side chain (Figure 4b). 511

Second, one notices that the 7^{δ} bonds of the Se/S compounds are fairly aligned on a same trend (colored strips in Fig. 5), in a way similar to that reported in amide-amide NH…OC interactions within a set of peptide conformations, which share a same donor – acceptor geometrical approach. This suggests that the approaches provided by the 7° bonds (in blue in Figure 6) have a similar efficiency from the H-bonding point of view.[29] The difference in H-bond NH···Se/S distance between the ag+g+ and ag+a side chains in Sem or Met as well as between the semi-extended and extended forms, should be thus ascribed to different covalent constrains in both the side chain and the backbone, which respectively hamper or favor the formation of the H-bond. At this stage, comparison with the constrain-free MAA···S/SeMe2 intermolecular complexes is quite enlightening since the fact that the complex points in the Fig. 5 plot (stars) lie close to the 7^{δ} lines demonstrates that the side chain folding adopted for the formation of 7° bonds provides a H-bonding efficiency comparable to the best possible in absence of constrains, i.e., that of the intermolecular complex (in magenta in Figure 6). This has clearly to be assigned to

the increased flexibility of the Met/Sem side chain provided by its two methylene groups, which enables the acceptor to find a favorable interaction geometry with the acceptor. Going further into the analysis of the 7^{δ} series, the positions of the points relative to that of the complex also provides insights on the role of covalent (intrinsic to the side chains and the backbone) or non-covalent interactions (implicating both side chain and backbone) in favoring or hampering the formation of a short H-bond for this approach. The long H-560

bond 7^{δ} distances (e.g., in extended conformations) correspond to frustrated structures 570 having a good approach but whose covalent constrains hampers the bond shortening, in 571 particular the presence of the 7^L fold on the C-terminus side of the molecule. 572 Alternatively, short distances (e.g., in the 5_{a} - 7^{δ}_{g} -7L conformation) should be assigned to 573 non-covalent interactions, between the side chain terminal methyl group and the Cterminus carbonyl group, which tends to compress the NH…S distance and enhance the 575 H-bond. 576

Third, the points representing the 6^{δ} bonds in Fig. 5 fall below the 7^{δ} line, suggesting a less efficient geometrical approach for H-bonding (Fig 6 in green), possibly in link with the difference in the orientation of the peptide bond of the donor. However, the H-bond 6^{δ} distance shorter than in the intermolecular complexes again suggests that this H-bond benefits from constrains which tend to compress the H-bond within this approach, in particular through non covalent interactions between the Sem/Met and Phe side chains.

Besides these considerations, the NBO analysis also enables us to examine the correlation 583 between the calculated NH stretch frequency and the total stabilization energy (noted 584 @E_{NH}), taking into account all the interactions that contribute to the electron 585 delocalization towards the σ^*_{NH} interaction (see Tables S3 & S4), namely beyond the 586 NH···S H-bond, the accompanying C5 and π interactions in extended 5-7 $^{\delta}/_{5a}-\pi$ and 587 semi-extended 5-7 $^{8}/\pi$ -7L conformations respectively. The corresponding plot (Figure 7) 588 demonstrates that, in contrast to what was observed for the amide-amide NH…OC 589 interactions, the dependence of the spectral shift with the delocalisation-induced 590 stabilization energy seems to depend significantly on the geometrical approach. A 591 similar deviation is also found in the correlation between the NH stretch spectral shift 592 and the population of the σ^*NH NBO (Fig S2). 593

Finally, the present data allow us to range the Sem/Met 7^{δ} and 6^{δ} H-bonds with respect 608 to their 5^{γ} and 6^{γ} counterparts in the related seleno-cysteine and cysteine residues, which 609 exhibit a shorter side chain. Obviously both NH stretch IR spectroscopy Cys[16-18] and 610 NBO analysis Cys[17, 18] provide evidence for weaker H-bonding in these covalently 611 more constrained systems. 612

6. Conclusions

The present experimental and theoretical, conformation-resolved, comparative study 616 of local side chain-backbone NH···S/Se H-bonds of the Met/Sem residues illustrates the 617 strong conformational similarities of the folding properties of these two residues. The 618 conformational landscapes of the capped Met/Sem-Phe sequences studied are very 619 similar: in both cases the same low lying conformations, belonging to three different 620 backbone families, are present. The main differences stem from slightly different 621 energetics among the families. Regarding the structures, the interaction distances with 622 Se are larger, due to the larger van der Waals radius. However, both the wavefunction 623 NBO analysis and the observation of NH stretch frequencies suggest that the interaction 624 strength remain similar, with a slight difference in favor of one or the other, depending 625 on the conformation considered. 626

Depending on the local side chain-backbone H-bond considered (intra-residue 6^{δ} or 627 interresidue 7⁸), the side chain folding differ (with χ_1, χ_2 dihedrals of g+, g- and a, g+ types 628

respectively). For both foldings, however, the terminal -Me-Se/S-Me group can adopt a 629 χ_3 dihedral of g or of a type. The present NBO analysis shows that the latter orientation 630 strongly affects the H-bond strength, essentially because it controls the NH···S/Se 631 distance. As a matter of fact, 7^{δ} bonds with an *a* terminal side chain orientation exhibits 632 the stronger and the shorter H-bonds. The trend is reversed for the 6^{δ} bonds. Regarding 633 the diversity of strengths, the 7^{δ} bonds are found to be strongly dependent upon the 634 environment, the bonds being enhanced or frustrated depending on the conformation. 635 A unique 6^{δ} bond was found, but this may be due to their appearance in a restricted 636 number of conformations (β -turns). The spectral red shift they generate is significantly 637 lower than that of the 7^{δ} bonds, which is interpreted in terms of a different and less 638 effective approach of the H-bond acceptor S/Se to the backbone NH of the same residue, 639 presumably because of a lesser flexibility of the side chain. In the same line, for a similar 640 total NBO stabilization energy, 6^{δ} bonds exhibit a lower red shift than their 7^{δ} 641 counterparts (but comparable to the intermolecular MAA...S/SeMe₂ complex), 642 suggesting that the correlation between NBO stabilization energies and spectral shifts 643 might not be as linear as previously reported [9] when the geometrical approaches are 644 taken into account. 645

The present work also shows that the optical spectroscopic results, which at first glance, 647 suggest that Sem leads apparently to larger red shifts, must be confronted to an in-depth 648 conformational analysis in order to reach valid comparisons: the apparent increase in red 649 shift was just a consequence of a simple population transfer, between S and Se, in which 650 the side chain terminal end is flipped from a g+ to an a orientation. 651

Finally, the optical spectroscopic results clearly show that experimental spectral NH 652 stretch red shifts of up to 200 cm⁻¹ can be reached for some conformations, illustrating 653 the strength of the interaction, especially compared to amide-amide NH···OC bonds in 654 natural peptides, whose largest red shift does not exceed 140 cm⁻¹.[38] In this regard, 655 these present results support the conclusion of the recently published survey of NH···Se bonds in proteins, which emphasized the presence of strong NH···Se bonds in proteins, 657 [9] but suggests that they remain close in strength to the NH···S bonds. 658
