

Enantioselective Hydrophosphonylation of *N*-Boc Imines using Chiral Guanidine—Thiourea Catalysts

The enantioselective hydrophosphonylation of N-Boc imines was investigated using a new family of pseudo-symmetric guanidine—thiourea catalysts, providing α -amino phosphonates in moderate to high yields with good enantioselectivity. The catalyst was heterogenized by polymerization with styrene and the resulting catalyst was applied to reactions under continuous-flow conditions.

Guanidines are well-known common organic functions that have interesting chemical and biological properties. They can be found in natural products¹ and have become increasingly attractive in the field of organocatalysis.² The guanidine functional group can be used as a superbase to deprotonate high pK_a pronucleophiles,³ and synergic catalysis can be obtained by combining guanidine with H-bond donors. Indeed, combining strong Brønsted base and H-bond donor allows bifunctional catalysis to be performed by activating both nucleophile and electrophile at the same time. In the past few years, several guanidine—H-bond donor catalysts have been developed and were found to be very efficient for several reactions.⁴

Nagasawa *et al.* reported the synthesis and use of linear and conformationally flexible guanidine—bis-thiourea/urea catalysts in multiple reactions, providing good yields and good enantioselectivity.⁵ It was shown by Eyring analysis that enantioinduction by Nagasawa's guanidine—thioureas was entropy-driven because of the flexibility of the methylene or ethylene linker (Scheme 1). Although it was shown that the control of catalyst flexibility can have a beneficial impact on the catalysis,⁶ rigidification of catalyst scaffolds remains a common strategy to achieve highly enantioselective reactions, as it can allow for stabilization of transition states and induce better definition of chiral binding pockets by steric repulsion.

Especially in the field of hydrogen bond catalysis, rigidity plays an important role, and many researchers have reported rigid thiourea catalysts bearing constrained diamine ligands such as chiral cyclohexane diamine or diphenylethylene diamine.⁷ Therefore, by using such kind of diamine structure instead of methylene or ethylene chiral spacer we could access new constrained guanidine—bis-thiourea catalysts. This new kind of structure could allow for efficient reactions such as Michael and Mannich-type reactions. For instance, Nagasawa *et al.* achieved a highly enantioselective entropy-driven addition of malonates to *N*-Boc imines using a guanidine—thiourea catalyst.⁸ Additionally, Tan *et al.* reported an efficient enantioselective phospha-Mannich reaction of benzyl phosphinates with *N*-Ts imines catalyzed by a guanidinium—guanidine catalyst.⁹

With this information in hand, we decided to develop new rigid guanidine–thiourea catalysts to perform asymmetric

reactions. The catalyst design was carried out first to have a small library of guanidine-thiourea catalysts bearing rigid catalyst backbones, and those were applied for the catalytic asymmetric hydrophosphonylation of imines which appeared to be an important reaction to access α -amino phosphonates. α -Amino phosphonates are very versatile compounds that are nowadays used in numerous fields because of their remarkable biological properties¹⁰ and because they can be used as amino-acid analogues and/or useful synthetic intermediates.¹¹ Even though three-components reaction involving carbonyl amine and phosphite was developed (Kabachnik-Fields reaction), 12 the direct nucleophilic addition of phosphonates to imines (Pudovik reaction) remains a straightforward way to synthesize α -amino phosphonates.¹³ The catalytic addition of nucleophiles to imines has been studied widely and several catalytic systems have been developed.¹⁴ However, only few examples of asymmetric phospha-Mannich reaction on ketimine/aldimine using chiral superbase catalysts were reported.^{9,15} Although the reaction can be performed using common bases, the use of organic superbases could drastically increase the efficiency of the reaction. Here, we report the synthesis of spatially constrained guanidine-thiourea catalysts and their use in the asymmetric hydrophosphonylation of N-Boc imines.

As a starting point, *N*-Boc imine **1a** and diethyl phosphonate **(2a)** were selected as model substrates for screening to optimize the reaction conditions. Several chiral guanidine—thiourea catalysts were synthesized using three different diamines: (*R*,*R*)-1,2-diaminocyclohexane, (*R*,*R*)-1,2-diphenylethylene diamine and *N*-Boc-(*S*)-2-(aminoethyl) pyrrolidine, which was directly synthesized from *N*-Boc-L-proline in four steps. All five guanidine—thiourea catalysts were synthesized by using adapted procedures (Chart 1).¹⁶

Compounds **C1** and **C2** were synthesized first and tested for the asymmetric hydrophosphonylation reaction, giving the desired product **3aa** in 76% and 68% yield, respectively. We hypothesized that using a secondary amine on the guanidine moiety would lead to a better definition of the chiral environment by making the upper part of the catalyst more hindered; however, the use of **C2** gave 28% ee compared with 49% ee for **C1** (Table 1, entries 1-2). Compound **C3** was then synthesized using a bulkier diamine and provided better

results, affording product 3aa in 83% yield with 86% ee. At this point, the efficiency of the catalyst was investigated, and catalyst loading was modified (entries 3-5). The guanidinethiourea catalysts were found to be very efficient for this reaction; with 5 mol% of C3 catalyst, full conversion was reached after only 2 hours. The same reaction using cinchona derivatives such as quinine usually require much longer reaction times (typically 2-3 days).17 Another prolinebasedcatalyst, C4, was also synthesized and used in the hydrophosphonylation reaction, providing 24% yield with 16% ee (entry 6). We assume that the specific structure of this catalyst might be responsible for loss of efficiency because the secondary thioureas can only form one hydrogen bond. Finally, one example of a flexible guanidine-thiourea catalyst was synthesized by following Nagasawa's procedure. 16 In this case, similar results to those obtained with C1 were obtained and product 3aa was obtained in 70% yield with 51% ee (entry 7).

Having identified the best catalyst to perform the asymmetric hydrophosphonylation of phosphonate **1a** and imine **2a** (Table 1), conditions were optimized starting with the solvents. As a general tendency, the reaction provided higher ees and yields in hydrocarbon solvents (entries 5 and 8–11). The use of polar solvents, such as THF or EtOAc (entries 13 and 14), led to lower yields and enantioselectivities. In the case of an ether, only 15% yield was obtained (entry 15), and only a trace amount of product was isolated when acetonitrile was used (entry 12). Finally, *m*-xylene was selected as the best solvent, and reducing the catalyst loading was investigated. When 2 mol% of **C3** was employed, good ee was obtained but the yield dropped even in longer reaction time (entry 16). Next, the scope of the reaction and the influence of a range of parameters were investigated with *m*-xylene (Scheme 2).

The effect of the N-protecting groups was briefly investigated and it was found that substrates with carbamate-type protecting groups, such as Boc and Cbz, gave higher enantioselectivities than those with a Ts group (Scheme 2, 3aa, 4aa, 5aa). Indeed, carbamate groups can provide a better interaction with the thiourea moiety of the catalyst by forming hydrogen bonds with the oxygen of the carbonyl bond and the nitrogen of the carbamate moiety. A range of phosphonate nucleophiles were then used and although similar yields were obtained, bulkier phosphonates such as diisopropyl or dibenzyl phosphonates (Scheme 2, 3ab, 3ac) led to a moderate drop of ee compared with 3aa. However, no reaction occurred when

tert-butyl phosphonate was used. Diphenyphosphonate was also tested, but both yield and ee were lower (ଅଧିକ)./D1OB01953H

The scope of imine substrates was finally investigated (Scheme 2, **3ba-ma**). From imines bearing electron-withdrawing groups (Scheme 2, **3ba-da**; **3la-ma**) to imines bearing proups (Scheme 2, **3ba-da**; **3la-ma**) to imines bearing heteroaromatic moieties (Scheme 2, **3fa-ga**), a wide range of imines were tolerated. In the case of **3ea**, because of the poor solubility of the substrate in *m*-xylene, a lower yield (41%) was obtained, even when the reaction was run for 48h. Otherwise, yields generally varied from 52% for product **3la** to 91% for product **3fa**. The *R*-absolute configuration of product **3aa** was determined by X-ray diffraction analysis (see Supporting Information). An aliphatic imine was also investigated. Due to instability of the imines, the imine precursor was treated with Cs₂CO₃ in situ to form the imine, however the desired product was obtained in low yield with only 37% enantioselectivity.

The 3D structure of C3·HCl salt was also obtained by X-ray diffraction (see Figure 1). The C3·HCl salt crystallized as a dimer in the P1 space group cell. Interestingly, the thiourea moieties played an important role in the crystal structure, with both sulfur atoms being linked to the central guanidine by hydrogen bonds. Notably, the chloride anion formed a bridge between two molecules of the catalyst by forming hydrogen bonds between the guanidinium proton and the acidic protons of the thioureas moieties of the second C3·HCl molecule, resulting in the formation of layers.

Based on previous studies investigating the mechanism of several guanidine-thiourea catalyzed reactions¹⁸, we assume that the reaction proceeds in three major steps (Figure 2). First, the guanidine acts as a strong Brønsted base to deprotonate the phosphonate and form the guanidinium phosphonate salt I (Figure 2). After activation of the phosphorus nucleophile by deprotonation, the second thiourea of the catalyst interacts with the electrophile through hydrogen-bond formation with the carbamate moiety of the N-Boc imine to provide intermediate II (Figure 2). Owing to the synergic activation of the phosphonate and imine by the catalyst, an optimum chiral environment is obtained because of the strong interactions of the guanidinium and thiourea moieties with the substrates. Finally, after the reaction of the phosphonate and the imine in the chiral pocket provided by the catalyst through hydrogen bonds, the chiral α -amino phosphonate product is obtained and the free base guanidine C3 is regenerated.



With the results obtained in the homogeneous system, we decided to immobilize our catalyst on a polymeric matrix in order to perform the synthesis of α -amino phosphonates under continuous-flow conditions. Regarding the similar results obtained previously when performing the reaction in toluene or m-Xylene (Table 1), we decided to perform the continuous-flow experiment in toluene which appears to be a

more common and practical alternative. First, a polymerizable monomer bearing a vinyl styrene group on the baring a vinyl styrene group on the baring a procedure similar to those used for other catalysts. Then, polymerization of C6 was performed under suspension polymerization conditions by mixing C6·HCl salt, styrene and divinyl benzene. The free-base polymer was obtained by stirring the polymer in a mixture of DCM and aq. K_2CO_3 . After washing and drying, the ability of the resulting polymer PS-C6 to catalyze the asymmetric hydrophosphonylation was assessed using C6 and C6 under batch heterogeneous conditions (Scheme 3) in Toluene. Product C6 awas obtained in C6 yield with C6 which appeared to be slightly lower than those obtained under homogeneous conditions.

The polymer was then mixed with Celite and packed in a reactor (5×1 cm) for testing under continuous-flow conditions. The reaction between 1a and 2a under continuous-flow conditions was run for 5 hours and data were collected after stabilization of the system (Scheme 4). Under these conditions, the flow reaction appeared to be less efficient than homogeneous and heterogeneous batch conditions. During the first hour, 70% conversion was observed, but conversion progressively decreased over time because of deactivation of the catalyst; however, the ee seemed to be stable. Relative to the conversion, the isolated yield also seemed to be reasonable.

In conclusion, we have developed a new series of guanidine—thiourea catalysts, synthesized from constrained diamine ligands, which were found to be highly effective for the asymmetric hydrophosphonylation of N-Boc imines, providing α -amino phosphonates with yields up to 91% and ee up to 87%. Moreover, the catalyst was successfully heterogenized by polymerization with styrene, and the α -amino phosphonate was also synthesized under continuous-flow conditions.
