

Leaf litter morphological traits, saprophagous macroarthropods body mass and phylogenetic affiliation explain their feeding behavior and faeces properties.






Figure 2 – Saprofagous macroarthropod physiological trait relationships to species fresh body mass (g). Ci and Cm= individual and mass-specific consumption rate, H= diet diversity Fi and Fm = individual and mass-specific faeces production rate, A= assimilation rateThe grey line is the linear regression with 95% confidence interval when the relationships was significant, dashed otherwise.












Figure S5 GRAPHICAL ABSTRACT – Feeding preferences (mass-specific consumption rate) of six widespread saprophagous macroarthropods species for four mixed litter species of contrasted quality resulting in faeces of different physico-chemical properties.



1. **Litter** species differ in their chemical, physical and morphological characteristic defining the available resource mean quality
2. **Animals feeding preferences** for particular litter trait values change the actual ingested resource (diet) mean quality
3. **Animals** species differ in their feeding & physiological traits
4. **Faeces** production & characteristics depend on animal identity
5. **Class**-specific digestive track structure leads to differences in faeces characteristics
6. **Body mass** is a simple predictor of complex physiological traits
