BIFURCATION RESULTS FOR NONLINEAR EIGENVALUE PROBLEMS INVOLVING THE (p, q) -LAPLACE OPERATOR.

Abstract. In this paper, we analyze an eigenvalue problem for nonlinear elliptic operators involving homogeneous Dirichlet boundary conditions in a open smooth bounded domain. We prove bifurcation results from trivial solutions and from infinity for the considered nonlinear eigenvalue problem. We also show the existence of multiple solutions of the nonlinear problem using variational methods.

1. INTRODUCTION

Assume $\Omega \subset \mathbb{R}^N$ $(N \geq 2)$ is an open bounded domain with smooth boundary ∂ Ω. In [8], the authors investigated the asymptotic behavior of the spectrum and the existence of multiple solutions of the following nonlinear eigenvalue problem

$$
\begin{cases}\n-\Delta_p u - \Delta u = \lambda u & \text{on } \Omega, \\
u = 0 & \text{on } \partial\Omega,\n\end{cases}
$$
\n(1.1)

where $-\Delta_p$ denotes the p-Laplace operator. In [8] it was shown that for $p > 2$ there exist eigenvalue branches emanating from $(\lambda_k, 0)$, and for $1 < p < 2$ there exist eigenvalue branches emanating from (λ_k, ∞) , where λ_k stands as the k-th Dirichlet eigenvalue of the Laplacian. In this paper, we consider the following q-homogenous eigenvalue problem with a perturbation by a p-Laplace term:

$$
\begin{cases}\n-\Delta_p u - \Delta_q u = \lambda |u|^{q-2}u & \text{in } \Omega \\
u = 0 & \text{on } \partial\Omega.\n\end{cases}
$$
\n(1.2)

The operator Δ_s , formally defined as $\Delta_s u := \text{div}(|\nabla u|^{s-2} \nabla u)$ for $s = p, q \in (1, \infty)$ is the s-Laplacian, $\lambda \in \mathbb{R}$ is a parameter. The (p, q) -Laplace operator given by $-\Delta_p - \Delta_q$ appears in a wide range of applications that include biophysics [10], plasma physics [15] and reaction-diffusion equations [2, 9]. The (p, q) -Laplace operator has been widely studied; for some results related to our studies, see e.g., $[4-6, 12, 14]$. We say that λ is a "first eigenvalue", if the corresponding eigenfunction u is positive or negative.

Note that by taking $q = 2$ in equation (1.2), we recover the case of equation (1.1). We remark however that for $q = 2$ equation (1.2) describes bifurcation (caused by a p-Laplace operator) from the *linear* equation $-\Delta u - \lambda u$, while for $q \neq 2$ we prove for equation (1.2) the existence of bifurcation branches (again forced by a p-Laplace operator) from the eigenvalues of a nonlinear, but q-homogenous equation. Indeed, it was shown in [11] that there exists a nondecreasing sequence of *variational* positive eigenvalues $\{\lambda_k^D(q)\}_k$ tending to $+\infty$ as $k \to \infty$ for the following nonlinear and qhomogenous eigenvalue problem

$$
\begin{cases}\n-\Delta_q u = \lambda |u|^{q-2}u & \text{in } \Omega, \\
u = 0 & \text{on } \partial\Omega.\n\end{cases}
$$
\n(1.3)

Moreover, it is known that the first eigenvalue of problem (1.3) is characterized in the variational point of view by,

$$
\lambda_1^D(q) := \inf_{u \in W_0^{1,q}(\Omega) \backslash {\{0\}}} \left\{ \frac{\int_{\Omega} |\nabla u|^q \, dx}{\int_{\Omega} |u|^q \, dx} \right\}.
$$

We consider the sets

$$
D_1(q) = \{ u \in W_0^{1,q}(\Omega) \setminus \{0\} : \int_{\Omega} |u|^q dx = 1 \},\
$$

and Σ , the class of closed symmetric (with respect to the origin) subsets of $W_0^{1,q}$ $C^{1,q}_0(\Omega)\backslash\{0\},$ i.e,

> $\Sigma = \{A \subset W_0^{1,q}$ $C_0^{1,q}(\Omega)\backslash\{0\}$: A closed, $A = -A$.

For $A \in \Sigma$, we define

$$
\gamma(A) = \inf \{ k \in \mathbb{N} : \exists \varphi \in C(A, \mathbb{R}^k \setminus \{0\}), \ \varphi(-x) = -\varphi(x) \}.
$$

If such $\gamma(A)$ does not exist, we then define $\gamma(A) = +\infty$. The number $\gamma(A) \in \mathbb{N} \cup \{+\infty\}$ is called the Krasnoselski genus of A. Let us consider the family of sets

$$
\Sigma_k = \{ A \subset \Sigma \cap D_1(q) : \ \gamma(A) \ge k \}.
$$

Following the proof in [11], one shows that one has the following variational characterization of $\lambda_k^D(q)$, for $k \in \mathbb{N}$,

$$
\lambda_k^D(q) = \inf_{A \in \Sigma_k} \sup_{u \in A} \int_{\Omega} |\nabla u|^q dx.
$$

In this paper, we discuss the nonlinear variational eigenvalues of equation (1.2). Our main results are:

- 1) For every fixed $\rho > 0$ there exists a sequence of eigenvalues $(\lambda_k^D(p,q;\rho))_k$ with corresponding eigenfunctions $\pm u_k(p,q;\rho)$ satisfying $\int_{\Omega} |u_k(p,q;\rho)|^q dx =$ ρ , with $\lambda_k^D(p,q;\rho) \to +\infty$ as $k \to \infty$.
- 2) The variational eigenvalues $\lambda_k^D(q)$ of equation (1.3) are bifurcation points from 0 if $p > q$, and bifurcation points from infinity for $1 < p < q$, for the nonlinear eigenvalues $\lambda_k(p,q;\rho)$.
- 3) For fixed $\lambda \in (\lambda_k^D(q), \lambda_{k+1}^D(q))$ there exist k eigenvalues of (1.2) with $\lambda = \lambda_1^D(p,q;\rho_1) = \cdots = \lambda_k^D(p,q;\rho_k)$, with corresponding eigenfunctions $\pm u_k(p,q;\rho)$ such that $\int_{\Omega} |u_k|^q = \rho_k$

The paper is organized as follows. In section 2, we discuss the variational spectrum of the nonlinear problem (1.2) for $u \in D_\rho$ with fixed $\rho > 0$. In section 3 we give some auxiliary results, and in section 4 we discuss the first eigenvalues of equation (1.2). Then, in section 5 we discuss the bifurcation phenomena, and finally in section 6 we prove the multiplicity result.

The standard norm of the Lebesgue space $L^s(\Omega)$ and the Sobolev space $W_0^{1,s}$ $\mathcal{O}^{1,s}(\Omega)$ will be denoted respectively by $\|\cdot\|_s = (\int_{\Omega} |\cdot|^s dx)^{1/s}$ and $\|\cdot\|_{1,s} = (\int_{\Omega} |\nabla(\cdot)|^s dx)^{1/s}$. We also denote by \langle , \rangle , the duality product between $W_0^{1,s}$ $\chi_0^{1,s}(\Omega)$ and its dual.

2. THE SPECTRUM OF PROBLEM (1.2)

In this section we show that equation (1.2) has for every given $\rho > 0$ a sequence of eigenvalues $\lambda_k^D(p,q,\rho)$, with associated eigenfunctions $u_k(p,q,\rho)$ and $\int_{\Omega} |u_k(p,q,\rho)|^q dx =$ ρ .

Definition 2.1. We say that $u \in W_0^{1,p}$ $\int_0^{1,p}(\Omega)$ $(i f p > q)$ or $u \in W_0^{1,q}$ $\int_0^{1,q}$ (Ω) (if $p < q$) is a weak solution of problem (1.2) if the following integral equality holds:

$$
\int_{\Omega} |\nabla u|^{p-2} \nabla u \cdot \nabla v \, dx + \int_{\Omega} |\nabla u|^{q-2} \nabla u \cdot \nabla v \, dx = \lambda \int_{\Omega} |u|^{q-2} u \, v \, dx,\qquad(2.1)
$$

for all $v \in W_0^{1,p}$ $V_0^{1,p}(\Omega) \cap W_0^{1,q}$ $\mathcal{O}^{1,q}(\Omega)$. We say that $\lambda \in \mathbb{R}$ is an eigenvalue of problem (1.2) if there exists an eigenfunction $u_{\lambda} \in (W_0^{1,p}$ $V_0^{1,p}(\Omega) \cap W_0^{1,q}$ $\mathcal{O}_0^{1,q}(\Omega)$ associated to λ such that relation (2.1) holds.

We say that $\lambda_1^D(p,q,\rho)$ is a first eigenvalue of equation (1.2) if the corresponding eigenfunction $u_1(p, q; \rho)$ is a minimizer of the following expression, for some $\rho > 0$,

$$
c_1(p,q;\rho) := \inf_{\{u \in W_0^{1,p}(\Omega) \cap W_0^{1,q}(\Omega), \int_{\Omega} |u|^q = \rho\}} \left(\frac{1}{p} \int_{\Omega} |\nabla u|^p dx + \frac{1}{q} \int_{\Omega} |\nabla u|^q dx\right). \tag{2.2}
$$

Note that $\lambda_1^D(p,q;\rho)$ satisfies

$$
\int_{\Omega} |\nabla u_1|^p dx + \int_{\Omega} |\nabla u_1|^q dx = \lambda_1^D(p, q; \rho) \int_{\Omega} |u_1|^q dx = \lambda_1^D(p, q; \rho) \rho.
$$

Proposition 2.2. If it holds $\lambda \leq \lambda_1^D(q)$ then problem (2.1) has no nontrivial solutions.

Proof. Suppose by contradiction that there exists $\lambda < \lambda_1^D(q)$ which is an eigenvalue of problem (1.2) with $u_{\lambda} \in (W_0^{1,p})$ $V_0^{1,p}(\Omega) \cap W_0^{1,q}$ $\{0\}\setminus\{0\}$ the corresponding eigenfunction. Let $v = u_\lambda$ in relation (2.1), we then have

$$
\int_{\Omega} |\nabla u_{\lambda}|^p dx + \int_{\Omega} |\nabla u_{\lambda}|^q dx = \lambda \int_{\Omega} |u_{\lambda}|^q dx.
$$

On the other hand, we have

$$
\lambda_1^D(q) \int_{\Omega} |u_{\lambda}|^q dx \le \int_{\Omega} |\nabla u_{\lambda}|^q dx, \tag{2.3}
$$

and subtracting by λ Ω $|u_\lambda|^q dx$ from both sides of (2.3), it follows that

$$
(\lambda_1^D(q) - \lambda) \int_{\Omega} |u_{\lambda}|^q dx \le \int_{\Omega} |\nabla u_{\lambda}|^q dx - \lambda \int_{\Omega} |u_{\lambda}|^q dx.
$$

This implies that

$$
0<(\lambda_1^D(q)-\lambda)\int_{\Omega}|u_\lambda|^qdx\leq \int_{\Omega}|\nabla u_\lambda|^qdx+\int_{\Omega}|\nabla u_\lambda|^pdx-\lambda\int_{\Omega}|u_\lambda|^qdx=0.
$$

Hence $\lambda < \lambda_1^D(q)$ is not an eigenvalue of problem (1.2) with $u_\lambda \neq 0$.

Now, assume that $\lambda = \lambda_1^D(q)$ is an eigenvalue of equation (1.2), thus there exists an eigenfunction $u_{\lambda_1^D(q)} \in (W_0^{1,p})$ $V_0^{1,p}(\Omega) \cap W_0^{1,q}$ $\Lambda_0^{1,q}(\Omega)$ associated to $\lambda_1^D(q)$ such that relation (2.1) holds. Letting $v = u_{\lambda_1^D(q)}$ in (2.1) , we obtain

$$
\int_{\Omega}|\nabla u_{\lambda_1^D(q)}|^pdx+\int_{\Omega}|\nabla u_{\lambda_1^D(q)}|^qdx=\lambda_1^D(q)\int_{\Omega}|u_{\lambda_1^D(q)}|^qdx.
$$

Since

$$
\lambda_1^D(q) \int_{\Omega} |u_{\lambda_1^D(q)}|^q dx \le \int_{\Omega} |\nabla u_{\lambda_1^D(q)}|^q dx,
$$

it follows that

$$
\int_{\Omega} |\nabla u_{\lambda_1^D(q)}|^p dx + \int_{\Omega} |\nabla u_{\lambda_1^D(q)}|^q dx \le \int_{\Omega} |\nabla u_{\lambda_1^D(q)}|^q dx
$$

and then $u_{\lambda_1^D(q)} = 0$ by the Poincaré inequality. This concludes the proof. \Box

Proposition 2.3. The first eigenfunctions u_1^{λ} associated to some $\lambda \in (\lambda_1^D(q), \infty)$ are *positive or negative in* Ω .

Proof. Let $u_1^{\lambda} \in (W_0^{1,p})$ $V_0^{1,p}(\Omega) \cap W_0^{1,1}$ $\binom{1}{0}$ (0)) \setminus {0} be a first eigenfunction associated to $\lambda \in$ $(\lambda_1^D(q), \infty)$, then

$$
\int_{\Omega}|\nabla u_{1}^{\lambda}|^{p}dx+\int_{\Omega}|\nabla u_{1}^{\lambda}|^{q}dx=\lambda\int_{\Omega}|u_{1}^{\lambda}|^{q}dx,
$$

which means that u_1^{λ} achieves the infimum in the definition of $\mu_1(p,q;\rho)$, with $\rho =$ 1 $\frac{1}{q} \int_{\Omega} |u|^q$. On the other hand, we have $\|\nabla |u_1^{\lambda}|\|_{1,s} = \|\nabla u_1^{\lambda}\|_{1,s}$ for $s = p, q$ and $\||u_1^{\lambda}||_q =$ $||u_1^{\lambda}||_q$ since $|\nabla |u_1^{\lambda}| = |\nabla u_1^{\lambda}|$ and $||u_1^{\lambda}|| = |u_1^{\lambda}|$ almost everywhere. Then, it follows that $|u_1\rangle$ achieves also the infimum in the definition of $\mu_1(p,q;\rho)$. Therefore by the Harnack inequality, we have $|u_1\rangle > 0$ for all $x \in \Omega$ and consequently $u_1\rangle$ is either positive or negative in Ω . \Box

The Palais-Smale condition plays an important role in the minimax argument, and we recall here its definition.

Definition 2.4. A C^1 functional I defined on a smooth submanifold M of a Banach space X is said to satisfy the Palais-Smale condition on M if any sequence $\{u_n\} \subset M$ satisfying that $\{I(u_n)\}_n$ is bounded and $(I|_M)'(u_n) \to 0$ as $n \to +\infty$ has a convergent subsequence.

Next, we start the discussion about the existence of eigenvalues for problem (1.2). We note that these eigenvalues depend on $\rho(u) = \int_{\Omega} |u|^q dx$. The proofs of the following two theorems rely on [1, Proposition 10.8].

Theorem 2.5. Let $p > q$. Then, for a given $p > 0$, there exists a nondecreasing sequence of critical values $c_k(p,q;\rho)$ with associated nonlinear eigenvalues $\lambda_k^D(p,q;\rho) \to$ $+\infty$, as $k \to +\infty$ and with corresponding eigenfunctions $u_k(p,q;\rho) \in W_0^{1,p}$ $\int_0^{1,p}(\Omega)$ for problem (1.2).

Proof. Let $D_{\rho}(p,q) = \{u \in W_0^{1,p}\}$ $\sum_{n=0}^{\infty}$ and $\sum_{k}(p,q) = \{A \subset D_{\rho}(p,q), A \in \mathbb{R}^d\}$ Σ and $\gamma(A) \geq k$, where $\Sigma = \{A \subset W_0^{1,p}\}$ $C_0^{1,p}(\Omega) : A \text{ closed}, A = -A$. Set

$$
c_k(p,q;\rho) = \inf_{A \in \Sigma_k(p,q)} \sup_{u \in A} \left(\frac{1}{p} \int_{\Omega} |\nabla u|^p dx + \frac{1}{q} \int_{\Omega} |\nabla u|^q dx \right) > 0 \tag{2.4}
$$

Let us show that $I(u) = \frac{1}{u}$ p Z Ω $|\nabla u|^p dx +$ 1 q Z Ω $|\nabla u|^q dx$ satisfies the Palais-Smale (PS) condition on $D_{\rho}(p,q)$. Let $\{u_n\} \subset D_{\rho}(p,q)$ a (PS) sequence, i.e, for all $n, K > 0$ $|I(u_n)| \leq K$ and $(I|_{D_\rho})'(u_n) \to 0$ in $W^{-1,p'}(\Omega)$ as $n \to \infty$. We first show that $\{u_n\} \subset$ $D_{\rho}(p,q)$ is bounded in $W_0^{1,p}$ $u_0^{1,p}(\Omega)$. Since $u_n \in W_0^{1,q}$ $\mathcal{O}_0^{1,q}(\Omega)$, with the Poincaré inequality, we have $\int_{\Omega} |u_n|^q dx \leq K \int_{\Omega} |\nabla u_n|^q dx$ and it follows that

$$
K \ge |I(u_n)| \ge \frac{q}{p} \int_{\Omega} |\nabla u_n|^p dx + \frac{1}{C} \int_{\Omega} |u_n|^q dx = \frac{q}{p} ||u_n||_{1,p}^p + \frac{\rho}{C}.
$$

Then $\{u_n\} \subset D_\rho(p,q)$ is bounded in $W_0^{1,p}$ $_{0}^{\text{1,p}}(\Omega)$. We can assume that up to a subsequence, still denoted $\{u_n\}$, there exists $u \in W_0^{1,p}$ $v_0^{1,p}(\Omega)$ such that $u_n \rightharpoonup u$ in $W_0^{1,p}$ $u_0^{1,p}(\Omega)$ and $u_n \to u$ in L^q . Now, we show that u_n converges strongly to u in $W_0^{1,p}$ $\int_0^{1,p}(\Omega)$. Since $(I|_{D_\rho})'(u_n) \to 0$ in $W^{-1,p'}(\Omega)$ as $n \to \infty$, there exists $\mu_n \in \mathbb{R}$ and $\varepsilon_n \to 0$ in $W_0^{-1,p'}$ $C^{-1,p}(\Omega)$ such that $I'(u_n)v - \mu_n \int_{\Omega} |u_n|^{q-2} u_n v = \langle \varepsilon_n, v \rangle$. We have $I'(u_n)u_n - \mu_n \int_{\Omega} |u_n|^q \to 0$, and since $I'(u_n)u_n \le c I(u_n) \le c$ it follows that $|\mu_n| \le c$. From this we obtain that $I'(u_n)(u_n$ $u) \to 0$ and $I'(u)(u_n - u) \to 0$ as $n \to \infty$. Therefore,

$$
o(1) = \langle I'(u_n) - I'(u), u_n - u \rangle = \int_{\Omega} (|\nabla u_n|^{p-2} \nabla u_n - |\nabla u|^{p-2} \nabla u) \cdot \nabla (u_n - u) dx + \underbrace{\int_{\Omega} (|\nabla u_n|^{q-2} \nabla u_n - |\nabla u|^{q-2} \nabla u) \cdot \nabla (u_n - u) dx}_{:=Q}.
$$

Using Lemma 3.3 below and the fact that the underbraced quantity Q is positive (see Remark 3.1), it follows that

$$
\langle I'(u_n) - I'(u), u_n - u \rangle \ge c_2 \|u_n - u\|_{1,p}^p.
$$

This shows that u_n converges strongly to u in $W_0^{1,p}$ $\chi_0^{1,p}(\Omega)$ as $n \to \infty$ since $\langle I'(u_n) I'(u), u_n - u \rangle \to 0$ as $n \to \infty$.

In order to end the proof, let us show that if $c = c_k(p,q) = \cdots = c_{k+m-1}(p,q)$, then the set K_c of critical points of I at the critical level c has a genus $\gamma(K_c) \geq m$. We consider the level set at c,

$$
K_c := \{ u \in D_{\rho}(p, q) : I(u) = c , I'(u) = 0 \}.
$$

We have that K_c is compact since the functional I satisfies the Palais-Smale condition and $0 \notin K_c$ since $c > 0 = I(0)$. In addition, we have $I(u) = I(-u)$. Hence $K_c \in$ Σ. Assume by contradiction that $γ(K_c) ≤ m - 1$. Take $A_ε ∈ Σ_{k+m-1}$ such that $\sup_{A_{\varepsilon}} I(u) \leq c + \varepsilon$. By the properties of the genus, there exists a δ -neighborhood N_{δ} of K_c such that $\gamma(N_\delta) = \gamma(K_c)$, and $\gamma(A_\varepsilon \setminus N_\delta) \ge \gamma(A_\varepsilon) - \gamma(N_\delta) \ge k + m - 1 - (m - 1) = k$. By the deformation theorem there exists a homeomorphism $\eta(1, \cdot)$ such that $I(u) \leq$ $c - \varepsilon$, for $u \in \eta(1, A_{\varepsilon} \setminus N_{\delta})$. Then we arrive at the contradiction

$$
c = \inf_{A \in \Sigma_k} \sup_{u \in A} I(u) \le \sup_{\eta(1, A_{\varepsilon} \setminus N_{\delta})} I(u) \le c - \varepsilon
$$

Hence, $\gamma(K_c) \geq m$.

With a compactness argument one shows that $c_k(p,q;\rho) \to \infty$ as $k \to \infty$.

For the corresponding eigenvalues $\lambda_k^D(p,q,\rho)$ we then have

$$
\int_{\Omega} |\nabla u_k|^p dx + \int_{\Omega} |\nabla u_k|^q dx = \lambda_k^D(p, q; \rho) \int_{\Omega} |u_k|^q dx = \lambda_k^D(p, q; \rho) \rho
$$

Thus $\lambda_k^D(p,q;\rho)$ $\rho > c_k(p,q;\rho)$, for all k (and fixed ρ), and hence also $\lambda_k^D(p,q;\rho) \to \infty$ as $k \to \infty$. \Box

For $p < q$ one has the analogous result:

Theorem 2.6. Let $p < q$ be given. Then, for a given $\rho > 0$, there exists a nondecreasing sequence of critical values $c_k(p,q;\rho)$ with associated nonlinear eigenvalues $\lambda_k^D(p,q;\rho) \to$ $+\infty$, as $k \to +\infty$ and with corresponding eigenfunctions $u_k(p,q;\rho) \in W_0^{1,q}$ $\int_0^{1,q}(\Omega)$ for problem (1.2).

Proof. Let $D_{\rho}(p,q) = \{u \in W_0^{1,q}\}$ $\sum_{n=0}^{\infty} 1, q(\Omega)$: $\int_{\Omega} |u|^q dx = \rho$, and $\Sigma_k(p, q) = \{A \subset \Sigma : \gamma(A \cap$ $D_{\rho}(p,q) \geq k \},$ where $\Sigma = \{ A \subset W_0^{1,q} \}$ $Q_0^{1,q}(\Omega): A \text{ closed}, A = -A.$ Set

$$
b_k(p,q) = \inf_{A \in \Sigma_k(p,q)} \sup_{u \in A} \left(\frac{1}{p} \int_{\Omega} |\nabla u|^p dx + \frac{1}{q} \int_{\Omega} |\nabla u|^q dx \right) > 0.
$$

Similar to the proof of Theorem 2.5, one shows that:

- (i) the functional $I(u) = \frac{1}{u}$ p Z Ω $|\nabla u|^p dx +$ 1 q Z Ω $|\nabla u|^q dx$ satisfies the (PS) condition on $D_{\rho}(p,q)$, and
- (ii) if $b = b_k(p, q) = \cdots = b_{k+m-1}(p, q)$, then the set K_b of critical points of I at the critical level b has a genus $\gamma(K_b) \geq m$.

□

We note that the results of Theorem 2.5-2.6 are illustrated in figure 1 in section 6.

3. Auxiliary results

Remark 3.1. Let $p > q$. We recall that the nonlinear operator $\Theta : W_0^{1,p}$ $i_{0}^{1,p}(\Omega) \rightarrow$ $W^{-1,q'}(\Omega) \subset W^{-1,p'}(\Omega)$ defined by

$$
\langle \Theta u, v \rangle = \int_{\Omega} |\nabla u|^{p-2} \nabla u \cdot \nabla v \, dx + \int_{\Omega} |\nabla u|^{q-2} \nabla u \cdot \nabla v \, dx
$$

is continuous and so it is demi-continuous. The operator Θ is said to be demi-continuous if Θ satisfies that whenever $u_n \in W_0^{1,p}$ $v_0^{1,p}(\Omega)$ converges to some $u \in W_0^{1,p}$ $C^{1,p}(\Omega)$ then $\Theta u_n \rightharpoonup$ Θu as $n \to \infty$.

In addition, we claim that the operator Θ satisfies the following condition: for any $u_n \in W_0^{1,p}$ $v_0^{1,p}(\Omega)$ satisfying $u_n \rightharpoonup u$ in $W_0^{1,p}$ $C_0^{1,p}(\Omega)$ and \limsup $\limsup_{n\to\infty} \langle \Theta u_n, u_n - u \rangle \leq 0$, then $u_n \to u$ in $W_0^{1,p}$ $C_0^{1,p}(\Omega)$ as $n \to \infty$. The same result hold in the case where $p < q$.

Indeed, assume that $u_n \rightharpoonup u$ in $W_0^{1,p}$ $C_0^{1,p}(\Omega)$ and \limsup $\max_{n\to\infty} \langle \Theta u_n, u_n - u \rangle \leq 0.$ Hence u_n converges strongly to u in $L^p(\Omega)$ and one has

$$
0 \geq \limsup_{n \to \infty} \langle \Theta u_n - \Theta u, u_n - u \rangle
$$

=
$$
\limsup_{n \to \infty} \int_{\Omega} \left[|\nabla u_n|^{p-2} \nabla u_n - |\nabla u|^{p-2} \nabla u + |\nabla u_n|^{q-2} \nabla u_n - |\nabla u|^{q-2} \nabla u \right] \cdot \nabla (u_n - u) dx.
$$

On the other hand, for any $\nabla u_n, \nabla u \in (L^p(\Omega))^N$, one has,

$$
\int_{\Omega} \left(|\nabla u_n|^{p-2} \nabla u_n - |\nabla u|^{p-2} \nabla u \right) \cdot \nabla (u_n - u) dx = \int_{\Omega} (|\nabla u_n|^p + |\nabla u|^p - |\nabla u_n|^{p-2} \nabla u_n \cdot \nabla u
$$
\n
$$
= |\nabla u|^{p-2} \nabla u \cdot \nabla u_n dx
$$
\n
$$
\geq \int_{\Omega} (|\nabla u_n|^p + |\nabla u|^p) dx - \left(\int_{\Omega} |\nabla u_n|^p dx \right)^{1/p'} \times \left(\int_{\Omega} |\nabla u|^p dx \right)^{1/p} -
$$
\n
$$
- \left(\int_{\Omega} |\nabla u_n|^p dx \right)^{1/p} \times \left(\int_{\Omega} |\nabla u|^p dx \right)^{1/p'}
$$
\n
$$
= \left[\left(\int_{\Omega} |\nabla u_n|^p dx \right)^{\frac{p-1}{p}} - \left(\int_{\Omega} |\nabla u|^p dx \right)^{\frac{p-1}{p}} \right] \times \left[\left(\int_{\Omega} |\nabla u_n|^p dx \right)^{\frac{1}{p}} - \left(\int_{\Omega} |\nabla u|^p dx \right)^{\frac{1}{p}} \right]
$$
\n
$$
= (\|u_n\|_{1,p}^{p-1} - \|u\|_{1,p}^{p-1}) (\|u_n\|_{1,p}^p - \|u\|_{1,p}^p) \geq 0.
$$

We then deduce from this inequality that $\int_{\Omega} |\nabla u_n|^p dx \to \int_{\Omega} |\nabla u|^p dx$ as $n \to \infty$ and similarly $\int_{\Omega} |\nabla u_n|^q dx \to \int_{\Omega} |\nabla u|^q dx$ as $n \to \infty$. Consequently u_n converges strongly to u in $W_0^{1,p}$ $C_0^{1,p}(\Omega) \subset W_0^{1,q}$ $\zeta_0^{1,q}(\Omega)$.

Proposition 3.2. Assume that $p > q$. If $(\lambda, 0)$ is a bifurcation point of solutions of problem (1.2) then λ is an eigenvalue of problem (1.3).

Proof. Since $(\lambda, 0)$ is a bifurcation point from zero of solutions of problem (1.2) , there is a sequence of nontrivial solutions of problem (1.2) such that $\lambda_n \to \lambda$ and $||u_n||_{1,p} \to 0$ in $W_0^{1,p}$ $L^{1,p}(\Omega)$. We then have

$$
\int_{\Omega} |\nabla u_n|^{p-2} \nabla u_n \cdot \nabla v \, dx + \int_{\Omega} |\nabla u_n|^{q-2} \nabla u_n \cdot \nabla v \, dx = \lambda_n \int_{\Omega} |u_n|^{q-2} u_n v \, dx, \tag{3.1}
$$

Let $w_n = u_n / ||u_n||_{1,p}$. Plugging this change of variable into equation (3.1), we get

$$
||u_n||_{1,p}^{p-q} \int_{\Omega} |\nabla w_n|^{p-2} \nabla w_n \cdot \nabla v \, dx + \int_{\Omega} |\nabla w_n|^{q-2} \nabla w_n \cdot \nabla v \, dx = \lambda_n \int_{\Omega} |w_n|^{q-2} w_n v \, dx \tag{3.2}
$$

With Remark 3.1, it follows that

$$
||u_n||_{1,p}^{p-q} \int_{\Omega} |\nabla w_n|^{p-2} \nabla w_n \cdot \nabla v \, dx + \int_{\Omega} |\nabla w_n|^{q-2} \nabla w_n \cdot \nabla v \, dx \to \int_{\Omega} |\nabla w|^{q-2} \nabla w \cdot \nabla v \, dx
$$

as $n \to \infty$ since $||u_n||_{1,p} \to 0$ by assumption and $\lambda_n \int_{\Omega} |u_n|^{q-2} u_n v dx$ converges to $\lambda \int_{\Omega} |u|^{q-2}uv \, dx$ as $n \to \infty$. Thus, we obtain that

$$
\int_{\Omega} |\nabla w|^{q-2} \nabla w \cdot \nabla v \, dx = \lambda \int_{\Omega} |u|^{q-2} uv \, dx
$$

(Ω).

for all $v \in W_0^{1,p}$ 0

The following lemma will be used in some occasions.

Lemma 3.3 ([13]). There exist constants c_1, c_2 such that for all $x_1, x_2 \in \mathbb{R}^N$, we have the following vector inequalities for $1 < s < 2$

$$
(|x_2|^{s-2}x_2-|x_1|^{s-2}x_1)\cdot(x_2-x_1)\ge c_1(|x_2|+|x_1|)^{s-2}|x_2-x_1|^2,
$$

and for $s > 2$

$$
(|x_2|^{s-2}x_2-|x_1|^{s-2}x_1)\cdot(x_2-x_1)\geq c_2|x_2-x_1|^s.
$$

4. First eigenvalues

In this section we prove that every $\lambda > \lambda_1^D(q)$ is a first eigenvalue of problem (1.2).

We define the energy functional $E_\lambda : W_0^{1,p}$ $V_0^{1,p}(\Omega) \cap W_0^{1,q}$ $C_0^{1,q}(\Omega) \to \mathbb{R}$ associated to relation (2.1) by

$$
E_{\lambda}(u) = \frac{1}{p} \int_{\Omega} |\nabla u|^p dx + \frac{1}{q} \int_{\Omega} |\nabla u|^q dx - \frac{\lambda}{q} \int_{\Omega} |u|^q dx. \tag{4.1}
$$

Lemma 4.1. Suppose that $p > q$. Then for each $\lambda > 0$, the functional E_{λ} defined in (4.1) is coercive.

Proof. If $p > q$, We have that $W_0^{1,p}$ $V_0^{1,p}(\Omega) \subset W_0^{1,q}$ $_{0}^{\text{1,q}}(\Omega)$ and the following inequalities hold true

(i)
$$
\frac{1}{p} \int_{\Omega} |\nabla u|^p dx + \frac{1}{q} \int_{\Omega} |\nabla u|^q dx \ge \frac{1}{p} \int_{\Omega} |\nabla u|^p dx,
$$

(ii)
$$
\int_{\Omega} |\nabla u|^q dx \le C \|u\|_{1,p}^q \text{ (using the Hölder inequality)}.
$$

With items (i) and (ii) we obtain $E_{\lambda}(u) \geq \frac{1}{n}$ $\frac{1}{p}||u||_{1,p}^p - \tilde{C}||u||_{1,p}^q$ and consequently $E_\lambda(u) \to$ $+\infty$ as $||u||_{1,p} \to +\infty$.

Remark 4.2. We notice that E_{λ} is not bounded below if $p < q$ and $\lambda > \lambda_1^D(q)$ since for every $u = u_1$, the first eigenfunction of (1.3) with $\int_{\Omega} |u_1|^q dx = 1$, we have

$$
E_{\lambda}(tu) = \frac{t^{p}}{p} ||u_{1}||_{1,p}^{p} + \frac{t^{q}}{q} (\lambda_{1}^{D}(q) - \lambda) \to -\infty
$$

as $t \to \infty$.

Theorem 4.3. Let $p > q$. Then every $\lambda \in (\lambda_1^D(q), \infty)$ is a first eigenvalue of problem $(1.2).$

Proof. Standard arguments show that $E_{\lambda} \in C^{1}(W_{0}^{1,p})$ $L_0^{1,p}(\Omega), \mathbb{R}$ with its derivative given by

$$
\langle E'_{\lambda}(u),v\rangle = \int_{\Omega} |\nabla u|^{p-2} \nabla u \cdot \nabla v \, dx + \int_{\Omega} |\nabla u|^{q-2} \nabla u \cdot \nabla v \, dx - \lambda \int_{\Omega} |u|^{q-2} u \, v \, dx,
$$

for all $v \in W_0^{1,p}$ $C_0^{1,p}(\Omega) \subset W_0^{1,q}$ $\mathcal{L}_0^{1,q}(\Omega)$. On the other hand E_λ is weakly lower semi-continuous on $W_0^{1,p}$ $W_0^{1,p}(\Omega) \subset W_0^{1,q}$ $\int_0^{1,q}(\Omega)$ since E_λ is a continuous convex functional. This fact and Lemma 4.1 allow one to apply a direct calculus of variations result in order to obtain the existence of global minimum point of E_λ . We denote by u_0 such a global minimum point, i.e, $E_{\lambda}(u_0) = \min_{u \in W_0^{1,p}(\Omega)} E_{\lambda}(u)$. We observe that for $u_0 = sw_1$ (where w_1 stands

for the corresponding eigenfunction of $\lambda_1^D(q)$, we have

$$
E_{\lambda}(u_0) = \frac{s^p}{p} \int_{\Omega} |\nabla w_1|^p dx + \frac{s^q}{q} (\lambda_1^D(q) - \lambda) < 0
$$

for s small enough. So there exists $u_{\lambda} \in W_0^{1,p}$ $E_{\lambda}^{1,p}(\Omega)$ such that $E_{\lambda}(u_{\lambda}) < 0$. But $E_{\lambda}(u_0) \leq$ $E_{\lambda}(u_{\lambda})$ < 0, which implies that $u_0 \in W_0^{1,p}$ $\langle L_0^{1,p}(\Omega)\setminus\{0\}\rangle$. We also have that $\langle E_\lambda'(u_0),v\rangle =$ $0, \forall v \in E$, and this concludes the proof. \Box

To treat the case where $p < q$, we constrain E_{λ} on the Nehari set

$$
\mathcal{N}_{\lambda} = \{ u \in W_0^{1,q}(\Omega) / u \neq 0, \ \langle E_{\lambda}'(u), u \rangle = 0 \}
$$

= $\{ u \in W_0^{1,q}(\Omega) / u \neq 0, \ \int_{\Omega} |\nabla u|^p dx + \int_{\Omega} |\nabla u|^q dx = \lambda \int_{\Omega} |u|^q dx \}.$
the functional E_{λ} reads as $E_{\lambda}(u) = \frac{1}{\lambda} \int_{\Omega} |\nabla u|^p dx > 0$

On \mathcal{N}_{λ} , the functional E_{λ} reads as $E_{\lambda}(u) = (\frac{1}{p} - \frac{1}{q})$ $\frac{1}{q}$) Ω $|\nabla u|^p dx > 0.$

This shows at once that E_λ is coercive in the sense that if $u \in \mathcal{N}_\lambda$ satisfies $||u||_{1,p} \to \infty$, then $E_{\lambda}(u) \rightarrow \infty$.

We define $m = \inf_{u \in \mathcal{N}_{\lambda}} E_{\lambda}(u)$, and we show through a series of propositions that m is attained by some $u \in \mathcal{N}_{\lambda}$ which is a critical point of E_{λ} considered on the whole space $W_0^{1,q}$ $C_0^{1,q}(\Omega) \subset W_0^{1,p}$ $C_0^{1,p}(\Omega)$ and therefore a solution to equation (1.2).

Proposition 4.4. The set \mathcal{N}_{λ} is not empty for $\lambda > \lambda_1^D(q)$.

Proof. Since $\lambda > \lambda_1^D(q)$ there exists $u \in W_0^{1,q}$ $_{0}^{1,q}(\Omega)$ not identically zero such that $\int_{\Omega} |\nabla u|^q dx < \lambda \int_{\Omega} |u|^q dx$. We then see that $tu \in \mathcal{N}_{\lambda}$ for some $t > 0$. Indeed, $tu \in \mathcal{N}_{\lambda}$ is equivalent to

$$
t^{p} \int_{\Omega} |\nabla u|^{p} dx + t^{q} \int_{\Omega} |\nabla u|^{q} dx = t^{q} \lambda \int_{\Omega} |u|^{q} dx,
$$

which is solved by $t = \left(\frac{\int_{\Omega} |\nabla u|^{p} dx}{\lambda \int_{\Omega} |u|^{q} dx - \int_{\Omega} |\nabla u|^{q} dx} \right)^{\frac{1}{q-p}} > 0.$

Proposition 4.5. Every minimizing sequence for E_λ on \mathcal{N}_λ is bounded in $W_0^{1,q}$ $\mathcal{L}_0^{1,q}(\Omega)$.

Proof. Let $\{u_n\}_{n\geq 0} \subset \mathcal{N}_{\lambda}$ be a minimizing sequence of $E_{\lambda}|_{\mathcal{N}_{\lambda}}$, i.e. $E_{\lambda}(u_n) \to m =$ $\inf_{v \in \mathcal{N}_{\lambda}} E_{\lambda}(v)$. Then

$$
\lambda \int_{\Omega} |u_n|^q \, dx - \int_{\Omega} |\nabla u_n|^q \, dx = \int_{\Omega} |\nabla u_n|^p \, dx \to \left(\frac{1}{p} - \frac{1}{q}\right)^{-1} m, \text{ as } n \to \infty. \tag{4.2}
$$

Suppose on the contrary that $\{u_n\}_{n\geq 0}$ is not bounded i.e. Ω $|\nabla u_n|^q dx \to \infty$ as $n \to \infty$. Then we have Ω $|u_n|^q$ dx $\rightarrow \infty$ as $n \rightarrow \infty$, using relation (4.2). We set $w_n = \frac{u_n}{\|u_n\|}$ $\frac{u_n}{\|u_n\|_q}$. Since $\int_{\Omega} |\nabla u_n|^q dx < \lambda \int_{\Omega} |u_n|^q dx$, we deduce that $\int_{\Omega} |\nabla w_n|^q dx < \lambda$, for each n and $||w_n||_{1,q} \leq \lambda^{1/q}$. Hence $\{w_n\} \subset W_0^{1,q}(\Omega)$ is bounded in $W_0^{1,q}(\Omega)$ is bounded in $W_0^{1,q}$ $L_0^{1,q}(\Omega)$. Therefore there exists $w_0 \in W_0^{1,q}$ $v_0^{1,q}(\Omega)$ such that $w_n \rightharpoonup w_0$ in $W_0^{1,q}$ $C_0^{1,q}(\Omega) \subset W_0^{1,p}$ $v_0^{1,p}(\Omega)$ and $w_n \to w_0$ in $L^q(\Omega)$. Dividing relation (4.2) by $||u_n||_q^p$, we get

$$
\int_{\Omega} |\nabla w_n|^p \ dx = \frac{\lambda \int_{\Omega} |u_n|^q \ dx - \int_{\Omega} |\nabla u_n|^q \ dx}{\|u_n\|_q^p} \to 0 \text{ as } n \to \infty,
$$

since $\lambda \int_{\Omega} |u_n|^q dx - \int_{\Omega} |\nabla u_n|^q dx \rightarrow \left(\frac{1}{p} - \frac{1}{q}\right)$ $\frac{1}{q}$ $\Big)^{-1}$ $m < \infty$ as $n \to \infty$ and $||u_n||_q^p \to \infty$ as $n \to \infty$. On the other hand, since $w_n \to w_0$ in $W_0^{1,p}$ $\mathcal{O}_0^{1,p}(\Omega)$, we infer that Ω $|\nabla w_0|^p dx \leq$ $\lim_{n\to\infty}$ inf \int Ω $|\nabla w_n|^p dx = 0$ and consequently $w_0 = 0$. Therefore $w_n \to 0$ in $L^q(\Omega)$, which is a contradiction since $||w_n||_q = 1$. Hence, $\{u_n\}_{n\geq 0}$ is bounded in $W_0^{1,q}$ $C_0^{1,q}(\Omega)$. \Box

Proposition 4.6. We have $m = \inf_{u \in \mathcal{N}_{\lambda}} E_{\lambda}(u) > 0$.

Proof. Assume by contradiction that $m = 0$. Then, for $\{u_n\}_{n\geq 0}$ as in Proposition 4.5, we have

$$
0 < \lambda \int_{\Omega} |u_n|^q \, dx - \int_{\Omega} |\nabla u_n|^q \, dx = \int_{\Omega} |\nabla u_n|^p \, dx \to 0, \text{ as } n \to \infty. \tag{4.3}
$$

By Proposition 4.5, we deduce that $\{u_n\}_{n\geq 0}$ is bounded in $W_0^{1,q}$ $C_0^{1,q}(\Omega)$. Therefore there exists $u_0 \in W_0^{1,q}$ $u_0^{1,q}(\Omega)$ such that $u_n \rightharpoonup u_0$ in $W_0^{1,q}$ $C_0^{1,q}(\Omega) \subset W_0^{1,p}$ $u_0^{1,p}(\Omega)$ and $u_n \to u_0$ in $L^q(\Omega)$.

Thus 1 Ω $|\nabla u_0|^p \leq \lim_{n\to\infty} \inf$ Ω $|\nabla u_n|^p dx = 0$. Consequently $u_0 = 0$, $u_n \rightharpoonup 0$ in $W_0^{1,q}$ $\chi_0^{1,q}(\Omega) \subset W_0^{1,p}$ $L^{1,p}(\Omega)$ and $u_n \to 0$ in $L^q(\Omega)$. Writing again $w_n = \frac{u_n}{\|u_n\|}$ $\frac{u_n}{\|u_n\|_q}$ we have

$$
0 < \frac{\lambda \int_{\Omega} |u_n|^q \, dx - \int_{\Omega} |\nabla u_n|^q \, dx}{\|u_n\|_q^q} = \|u_n\|_q^{p-q} \int_{\Omega} |\nabla w_n|^p \, dx,
$$

and

$$
\int_{\Omega} |\nabla w_n|^p dx = \|u_n\|_q^{q-p} \left(\lambda - \int_{\Omega} |\nabla w_n|^2 dx\right) \to 0 \text{ as } n \to \infty,
$$

since $||u_n||_q \to 0$ and $p < q$, $\{w_n\}_{n \geq 0}$ is bounded in $W_0^{1,q}$ $v_0^{1,q}(\Omega)$. Next since $w_n \rightharpoonup w_0$, we $deduce that$ Ω $|\nabla w_0|^p dx \le \lim_{n\to\infty} \inf$ Ω $|\nabla w_n|^p dx = 0$ and we have $w_0 = 0$. This is a contradiction since $||w_n||_q = 1$ for each n. Thus $m > 0$. □

Proposition 4.7. There exists $u \in \mathcal{N}_{\lambda}$ such that $E_{\lambda}(u) = m$.

Proof. Let $\{u_n\}_{n>0} \subset \mathcal{N}_\lambda$ be a minimizing sequence, i.e., $E_\lambda(u_n) \to m$ as $n \to$ ∞ . Thanks to Proposition 4.5, we have that $\{u_n\}$ is bounded in $W_0^{1,q}$ $_{0}^{\prime 1,q}(\Omega)$. It follows that there exists $u_0 \in W_0^{1,q}$ $u_0^{1,q}(\Omega)$ such that $u_n \rightharpoonup u_0$ in $W_0^{1,q}$ $U_0^{1,q}(\Omega) \subset W_0^{1,p}$ $\zeta_0^{1,p}(\Omega)$ and strongly in $L^q(\Omega)$. The results in the two propositions above guarantee that $E_{\lambda}(u_0) \leq \lim_{n \to \infty} \inf E_{\lambda}(u_n) = m.$ Since for each n we have $u_n \in \mathcal{N}_{\lambda}$, then

$$
\int_{\Omega} |\nabla u_n|^q \, dx + \int_{\Omega} |\nabla u_n|^p \, dx = \lambda \int_{\Omega} |u_n|^q \, dx \quad \text{for all } n. \tag{4.4}
$$

Assuming $u_0 \equiv 0$ on Ω implies that Ω $|u_n|^q$ dx \rightarrow 0 as $n \rightarrow \infty$, and by relation (4.4) we obtain that $\int |\nabla u_n|^q dx \to 0$ as $n \to \infty$. Combining this with the fact that Ω u_n converges weakly to 0 in $W_0^{1,q}$ $\chi_0^{1,q}(\Omega)$, we deduce that u_n converges strongly to 0 in $W_0^{1,q}$ $U_0^{1,q}(\Omega)$ and consequently in $W_0^{1,p}$ $_{0}^{\prime 1,p}(\Omega)$. Hence we infer that

$$
\lambda \int_{\Omega} |u_n|^q \, dx - \int_{\Omega} |\nabla u_n|^q \, dx = \int_{\Omega} |\nabla u_n|^p \, dx \to 0, \text{ as } n \to \infty.
$$

Next, using similar argument as the one used in the proof of Proposition 4.6, we will reach to a contradiction, which shows that $u_0 \neq 0$. Letting $n \to \infty$ in relation (4.4), we deduce that

$$
\int_{\Omega} |\nabla u_0|^q \ dx + \int_{\Omega} |\nabla u_0|^p \ dx \leq \lambda \int_{\Omega} |u_0|^q \ dx.
$$

If there is equality in the above relation then $u_0 \in \mathcal{N}_{\lambda}$ and $m \leq E_{\lambda}(u_0)$. Assume by contradiction that

$$
\int_{\Omega} |\nabla u|^q \, dx + \int_{\Omega} |\nabla u|^p \, dx < \lambda \int_{\Omega} |u|^q \, dx. \tag{4.5}
$$

Let $t > 0$ be such that $tu_0 \in \mathcal{N}_{\lambda}$, i.e.,

$$
t = \left(\frac{\lambda \int_{\Omega} |u_0|^q dx - \int_{\Omega} |\nabla u_0|^q dx}{\int_{\Omega} |\nabla u_0|^p dx}\right)^{\frac{1}{p-q}}.
$$

We note that $t \in (0,1)$ since $1 < t^{p-q}$ (using (4.5)). Finally, since $tu_0 \in \mathcal{N}_{\lambda}$ with $t \in (0,1)$ we have

$$
0 < m \le E_\lambda(tu_0) = \left(\frac{1}{p} - \frac{1}{q}\right) \int_\Omega |\nabla(tu_0)|^p \, dx = t^p \left(\frac{1}{p} - \frac{1}{q}\right) \int_\Omega |\nabla u_0|^p \, dx
$$
\n
$$
= t^p E_\lambda(u_0)
$$
\n
$$
\le t^p \lim_{k \to \infty} \inf E_\lambda(u_k) = t^p m < m \text{ for } t \in (0, 1),
$$

and this is a contradiction which assures that relation (4.5) cannot hold and consequently we have $u_0 \in \mathcal{N}_{\lambda}$. Hence $m \leq E_{\lambda}(u_0)$ and $m = E_{\lambda}(u_0)$.

Theorem 4.8. Let $p < q$. Then every $\lambda \in (\lambda_1^D(q), \infty)$ is a first eigenvalue of problem $(1.2).$

Proof. Let $u \in \mathcal{N}_{\lambda}$ be such that $E_{\lambda}(u) = m$ (thanks to Proposition 4.7). We show that $\langle E'_{\lambda}(u), v \rangle = 0$ for all $v \in W_0^{1,q}$ $0^{1,q}(\Omega)$. We recall that for $u \in \mathcal{N}_{\lambda}$, we have

$$
\int_{\Omega} |\nabla u|^q \ dx + \int_{\Omega} |\nabla u|^p \ dx = \lambda \int_{\Omega} |u|^q \ dx.
$$

Let $v \in W_0^{1,q}$ ^{$\int_0^{1,q}(\Omega)$}. For every δ in some small interval $(-\varepsilon,\varepsilon)$ certainly the function $u+\delta v$ does not vanish identically. Let $t(\delta) > 0$ be a function such that $t(\delta)(u + \delta v) \in \mathcal{N}_{\lambda}$, namely

$$
t(\delta) = \left(\frac{\lambda \int_{\Omega} |u + \delta v|^q \, dx - \int_{\Omega} |\nabla(u + \delta v)|^q \, dx}{\int_{\Omega} |\nabla(u + \delta v)|^p \, dx}\right)^{\frac{1}{p-q}}.
$$

The function $t(\delta)$ is a composition of differentiable functions, so it is differentiable. The precise expression of t' does not matter here. Observe that $t(0) = 1$. The map $\delta \mapsto t(\delta)(u + \delta v)$ defines a curve on \mathcal{N}_{λ} along which we evaluate E_{λ} . Hence we define $\gamma : (-\varepsilon, \varepsilon) \to \mathbb{R}$ as $\gamma(\delta) = E_{\lambda}(t(\delta)(u+\delta v))$. By construction, $\delta = 0$ is a minimum point for γ . Consequently

$$
0 = \gamma'(0) = \langle E'_{\lambda}(t(0)u), t'(0)u + t(0)v \rangle = t'(0)\langle E'_{\lambda}(u), u \rangle + \langle E'_{\lambda}(u), v \rangle = \langle E'_{\lambda}(u), v \rangle
$$

using the fact that $\langle E'_{\lambda}(u), u \rangle = 0$ because $u \in \mathcal{N}_{\lambda}$. We then obtained that $\langle E'_{\lambda}(u), v \rangle =$ 0 for all $v \in W_0^{1,q}$ 0 (Ω) .

5. Bifurcation

In this section we discuss bifurcation phenomena for problem (1.2). We begin with the following.

Definition 5.1. A real number μ is called a bifurcation point of (1.2) if and only if there is a sequence (u_n, μ_n) of solutions of (1.2) such that $u_n \neq 0$ and

 $\mu_n \to \mu$, $\|u_n\|_{1,s} \to 0$, as $n \to \infty$, $s = p$ (if $p > q$), or $s = q$ (if $p < q$).

Observations: Define $F: W_0^{1,p}$ $V_0^{1,p}(\Omega) \cap W_0^{1,q}$ $t_0^{1,q}(\Omega) \to \mathbb{R}$ by

$$
F(u) = \frac{\frac{1}{p} \int_{\Omega} |\nabla u|^p dx + \frac{1}{q} \int_{\Omega} |\nabla u|^q dx}{\frac{1}{q} \int_{\Omega} |u|^q dx}, \text{ for all } u \in W_0^{1,p}(\Omega) \cap W_0^{1,q}(\Omega).
$$

By setting $u = re_1$, where e_1 stands as the normalized eigenfunction associated to the eigenvalue $\lambda_1^D(q)$ of the q-homogenous equation (1.3), we then have

$$
F(re_1)=\frac{\frac{r^{p-q}}{p}\int_{\Omega}|\nabla e_1|^pdx+\frac{1}{q}\int_{\Omega}|\nabla e_1|^qdx}{\frac{1}{q}\int_{\Omega}|e_1|^qdx}.
$$

We distinguish two cases:

- (i) Assume that $p > q$. Thus we find that $F(re_1) \to \lambda_1^D(q)$ as $r \to 0$, which indicates bifurcation in 0 from $\lambda_1^D(q)$.
- (ii) Assume that $p < q$. We find that $F(re_1) \to \infty$ as $r \to 0$, which indicates there is no bifurcation in 0 from $\lambda_1^D(q)$. One is lead to look for bifurcation at infinity.

Our aim is to show that the variational q-homogenous eigenvalues $\lambda_k^D(q)$ of equation (1.3) are bifurcation points for the nonlinear eigenvalues $\lambda_k^D(p,q;\rho)$ of equation (1.2). More precisely, we will show that

$$
\lambda_k^D(p,q;\rho) \to \lambda_k^D(q) \text{ as } \rho \to 0.
$$

As in section 2, let $D_{\rho}(p,q) = \{u \in W_0^{1,p}\}$ $C_0^{1,p}(\Omega) \setminus \{0\} \subset W_0^{1,q}$ $\int_0^{1,q}(\Omega)\setminus\{0\} : \int_{\Omega}|u|^q dx = \rho\}$ and

 $\Gamma_{k,\rho} = \{A \subset D_\rho(p,q) : A \text{ symmetric}, A \text{ compact}, \gamma(A) \geq k\}.$

By the definition of $\lambda_k^D(q)$ we know that for $\varepsilon > 0$ small there is $A_{\varepsilon} \in \Gamma_{k,1}$ such that

$$
\sup_{\{u \in A_{\varepsilon}, \int_{\Omega} |u|^q dx = 1\}} \int_{\Omega} |\nabla u|^q dx \leq \lambda_k^D(q) + \varepsilon.
$$

We want to approximate A_{ε} by a finite-dimensional set. Since A_{ε} is compact, for every $\delta > 0$ there exist a finite number of points $x_1, \ldots, x_{n(\delta)}$ such that

$$
A_{\varepsilon} \subset \bigcup_{i=1}^{n(\delta)} B_{\delta}(x_i). \tag{5.1}
$$

Let $E_n = \text{span}\{x_1, \ldots, x_{n(\delta)}\}$, and set

$$
P_n A_\varepsilon := \{ P_n x, \quad x \in A_\varepsilon \},\tag{5.2}
$$

where $P_n x \in E_n$ is such that

$$
||x - P_n x||_{1,q} = \inf\{||x - z||_{1,q}, \ z \in E_n\}.
$$

We claim that $\gamma(P_nA_\varepsilon) \geq k$. Clearly, P_nA_ε is symmetric and compact. Furthermore, $0 \notin P_n A_\varepsilon$; indeed since A_ε is compact, and $0 \notin A_\varepsilon$, there is small ball $B_\tau(0)$ such that

 $A_\varepsilon \cap B_\tau(0) = \emptyset$. Now, choose $\delta > 0$ in (5.1) such that $\delta < \tau/2$. Then, for $x \in A_\varepsilon$ there is $x_i \in E_n$, for some $i \in \{1, \ldots, n(\delta)\}\$, such that $||x - x_i||_{1,q} < \delta$, and hence

$$
||x - P_n x||_{1,q} = \inf\{||x - z||_{1,q}, \ z \in E_n\} \le ||x - x_i||_{1,q} < \tau/2
$$

and thus $P_nA_{\varepsilon} \cap B_{\tau/2}(0) = \emptyset$.

Finally, we have to show that $\gamma(P_nA_\varepsilon) \geq k$. This is again by approximation: since $\gamma(A_{\varepsilon}) \geq k$, there exist a continuous and odd map $g: A_{\varepsilon} \to \mathbb{R}^k \setminus \{0\}$. Then by Tietze extension theorem there exist a continuous and odd map $\tilde{g}: W_0^{1,q}$ $C_0^{1,q}(\Omega) \to \mathbb{R}$ such that $\tilde{g}_{|A_{\varepsilon}}=g$. By continuity and compactness of A_{ε} we can conclude that

 $\tilde{g}_{|P_nA_\varepsilon}:W_0^{1,q}$ $C_0^{1,q}(\Omega) \to \mathbb{R}^k \setminus \{0\}$. Now, again by approximation, we conclude that there is a $n = n(\varepsilon)$ such that

$$
\sup_{\{u \in P_n A_\varepsilon\}} \int_{\Omega} |\nabla u|^q dx \leq \lambda_k^D(q) + 2\varepsilon.
$$

Finally, note that by homogeneity

$$
\inf_{A \in \Gamma_{k,\rho}} \sup_{u \in A} \int_{\Omega} |\nabla u|^q dx = \lambda_k^D(q) \, \rho
$$

and hence also

$$
\sup_{\{u \in \rho P_n A_\varepsilon\}} \int_{\Omega} |\nabla u|^q dx \le \left(\lambda_k^D(q) + 2\varepsilon\right) \rho. \tag{5.3}
$$

Recall that by (2.4) we have, for each integer $k > 0$,

$$
c_k(p,q;\rho) = \inf_{A \in \Gamma_{k,\rho}} \sup_{u \in A} \left\{ \frac{1}{p} \int_{\Omega} |\nabla u|^p dx + \frac{1}{q} \int_{\Omega} |\nabla u|^q dx \right\}
$$

We first prove the following lemma which is useful for the bifurcation result from zero.

Lemma 5.2. Let $p > q$. For any integer $k > 0$ and $p > 0$, $\varepsilon > 0$, there exists a positive constant $C(\varepsilon)$ such that the following estimate holds:

$$
|c_k(p,q;\rho) - \frac{1}{q} \lambda_k^D(q) \rho| \le C(\varepsilon)\rho^{p/q} + 2\varepsilon \rho.
$$

Proof. For any $k > 0$, we clearly have $c_k(p, q; \rho) \geq \frac{1}{q}$ $\frac{1}{q}\,\lambda^D_k(q)\,\rho.$ By (5.3) we can estimate

$$
c_k(p, q, \rho) = \inf_{A \in \Gamma_{k, \rho}} \sup_{u \in A} \left\{ \frac{1}{p} \int_{\Omega} |\nabla u|^p dx + \frac{1}{q} \int_{\Omega} |\nabla u|^q dx \right\}
$$

\n
$$
\leq \sup_{u \in \rho} \sup_{P_n A_\varepsilon} \left\{ \frac{1}{p} \int_{\Omega} |\nabla u|^p dx + \frac{1}{q} \int_{\Omega} |\nabla u|^q dx \right\}
$$

\n
$$
\leq \sup_{u \in \rho} \frac{1}{P_n A_\varepsilon} \int_{\Omega} |\nabla u|^p dx + \sup_{u \in \rho} \frac{1}{P_n A_\varepsilon} \int_{\Omega} |\nabla u|^q dx
$$

\n
$$
\leq \frac{1}{p} \int_{\Omega} |\nabla v|^p dx + \frac{1}{q} (\lambda_k^D (q) + 2\varepsilon) \rho
$$

for some $v \in \rho P_n A_\varepsilon$ with $\int_{\Omega} |v|^q dx = \rho$. Since $P_n A_\varepsilon$ is finite-dimensional, there exists a positive constant $C(\varepsilon)$ such that

$$
\left(\int_{\Omega} |\nabla v|^p dx\right)^{1/p} \le C(\varepsilon) \left(\int_{\Omega} |v|^q dx\right)^{1/q}
$$

and hence

$$
\int_{\Omega} |\nabla v|^p dx \le C(\varepsilon) \left(\int_{\Omega} |v|^q dx \right)^{p/q} = C(\varepsilon) \rho^{p/q}.
$$

Finally, we get

$$
0 \le c_k(p,q;\rho) - \frac{1}{q} \lambda_k^D(q) \rho \le C(\varepsilon) \rho^{p/q} + 2\varepsilon \rho.
$$

□

5.1. Bifurcation from zero.

Here, we show that for equation (1.2), for $p > q$, there is a branch of first eigenvalues bifurcating from $(\lambda_k^D(q), 0) \in \mathbb{R}^+ \times W_0^{1,p}$ $\mathcal{L}_0^{1,p}(\Omega)$.

Theorem 5.3. Let $1 < q < p < \infty$. Then for each integer $k > 0$ the pair $(\lambda_k^D(q), 0)$ is a bifurcation point of problem (1.2).

An illustration of the bifurcation results obtained in Theorem 5.3 is given by the figure 1 below.

Proof. We aim to show that $\lambda_k^D(p,q;\rho) \to \lambda_k^D(q)$ and $||u_k||_{1,p} \to 0$, as $\rho \to 0^+$. Thanks to Lemma 5.2 we have

$$
\frac{1}{p}\int_{\Omega}|\nabla u_k|^pdx\leq C_n(\varepsilon)\rho^{p/q}+2\varepsilon\rho
$$

Furthermore

$$
0 \leq \lambda_k^D(p, q; \rho) \rho - \lambda_k^D(q) \rho
$$

\n
$$
= \int_{\Omega} |\nabla u_k|^p dx + \int_{\Omega} |\nabla u_k|^q dx - \lambda_k^D(q) \rho
$$

\n
$$
= \frac{q}{p} \int_{\Omega} |\nabla u_k|^p dx + \int_{\Omega} |\nabla u_k|^q dx - \lambda_k^D(q) \rho + (1 - \frac{q}{p}) \int_{\Omega} |\nabla u_k|^p dx
$$

\n
$$
= q c_k(p, q; \rho) - \lambda_k^D(q) \rho + (1 - \frac{q}{p}) \int_{\Omega} |\nabla u_k|^p dx
$$

\n
$$
\leq C (C_n(\varepsilon) \rho^{p/q} + 2\varepsilon \rho)
$$

Since $\varepsilon > 0$ is arbitrary we get the first claim.

Let us prove that $||u_k||_{1,p} \to 0$ as $\rho \to 0^+$. Letting $v = u_k$ in relation (2.1), we have

$$
\int_{\Omega} |\nabla u_k|^p \, dx + \int_{\Omega} |\nabla u_k|^q \, dx = \lambda_k^D(p, q; \rho) \int_{\Omega} |u_k|^q \, dx.
$$

Therefore

$$
\int_{\Omega} |\nabla u_k|^p dx \leq \lambda_k^D(p, q; \rho) \int_{\Omega} |u_k|^q dx \leq C_k \rho
$$

Hence Ω $|\nabla u_k|^p dx \to 0$ as $\rho \to 0$. This complete the proof.

5.2. Bifurcation from infinity.

The goal is to prove that if $p < q$, there is a branch of first eigenvalues bifurcating from $(\lambda_k^D(q),\infty).$

For $u \in W_0^{1,q}$ $u_0^{-1,q}(\Omega)$, $u \neq 0$, we set $w = u/||u||_{1,q}^2$. We have $||w||_{1,q} = \frac{1}{||u||}$ $\frac{1}{\|u\|_{1,q}}$ and $|\nabla w|^{p-2}\nabla w| = \frac{1}{|w-2|}$ $\frac{1}{\|u\|_{1,q}^{2(p-1)}}|\nabla u|^{p-2}\nabla u, \ |\nabla w|^{q-2}\nabla w$

$$
= \frac{1}{\|u\|_{1,q}^{2(q-1)}} |\nabla u|^{q-2} \nabla u, \ |w|^{q-2} w = \frac{1}{\|u\|_{1,q}^{2(p-1)}} |u|^{q-2} u
$$

Introducing this change of variable in (2.1), we find that,

$$
||u||_{1,q}^{2(p-q)} \int_{\Omega} |\nabla w|^{p-2} \nabla w \cdot \nabla v \, dx + \int_{\Omega} |\nabla w|^{q-2} \nabla w \cdot \nabla v \, dx = \lambda \int_{\Omega} |w|^{q-2} w \, v \, dx
$$

for every $v \in W_0^{1,q}$ $C_0^{1,q}(\Omega)$. This leads to the following nonlinear eigenvalue problem (for $1 < p < q < \infty$)

$$
\begin{cases}\n-||w||_{1,q}^{2(q-p)}\Delta_p w - \Delta_q w &= \lambda |w|^{q-2}w & \text{in } \Omega\\
w &= 0 & \text{on } \partial\Omega.\n\end{cases}
$$
\n(5.4)

Proposition 5.4. Assume that $p < q$. If $(\lambda, 0)$ is a bifurcation point of solutions of problem (5.4) then λ is an eigenvalue of problem (1.3).

Proof. Since $(\lambda, 0)$ is a bifurcation point from zero of solutions of problem (5.4), there is a sequence of nontrivial solutions of problem (5.4) such that $\lambda_n \to \lambda$ and $||w_n||_{1,q} \to 0$ in $W_0^{1,q}$ $\mathcal{O}^{1,q}(\Omega)$. We then have

$$
||w_n||_{1,q}^{2(q-p)} \int_{\Omega} |\nabla w_n|^{p-2} \nabla w_n \cdot \nabla v \, dx + \int_{\Omega} |\nabla w_n|^{q-2} \nabla w_n \cdot \nabla v \, dx = \lambda_n \int_{\Omega} |w_n|^{q-2} w_n v \, dx. \tag{5.5}
$$

By using the argument in Remark 3.1 and then passing to limit, we complete the proof. \Box

Let us consider a small ball $B_r(0) := \{ w \in W_0^{1,q} \}$ $\|u_0^{r_1,q}(\Omega) \setminus \{0\} / \|w\|_{1,q} < r \}$, and the operator

$$
T := -\| \cdot \|_{1,q}^{2(q-p)} \Delta_p - \Delta_q : W_0^{1,q}(\Omega) \subset W_0^{1,p}(\Omega) \to W^{-1,p'}(\Omega) \subset W^{-1,q'}(\Omega).
$$

Proposition 5.5. Let $1 < p < q$. There exists $r > 0$ such that the mapping $T: B_r(0) \subset W_0^{1,q}$ $\chi_0^{1,q}(\Omega) \to W^{-1,q'}(\Omega)$ is strongly monotone, i.e., there exists $C > 0$ such that

$$
\langle T(u) - T(v), u - v \rangle \ge C ||u - v||_{1,q}^q, \text{ for } u, v \in B_r(0) \subset W_0^{1,q}(\Omega)
$$

with $r > 0$ sufficiently small.

Proof. Using that $-\Delta_p$ is strongly monotone on $W_0^{1,p}$ $_{0}^{1,p}(\Omega)$ on the one hand and the Hölder inequality on the other hand, we have

$$
\langle T(u) - T(v), u - v \rangle = \|\nabla u - \nabla v\|_{q} + \left(\|u\|_{1,q}^{2(q-p)}(-\Delta_{p}u) - \|v\|_{1,q}^{2(q-p)}(-\Delta_{p}v), u - v \right)
$$

\n
$$
= \|u\|_{1,q}^{2(q-p)}((-\Delta_{p}u) - (-\Delta_{p}v), u - v)
$$

\n
$$
+ \left(\|u\|_{1,q}^{2(q-p)} - \|v\|_{1,q}^{2(q-p)} \right) (-\Delta_{p}v, u - v)
$$

\n
$$
\geq \|\nabla u - \nabla v\|_{q} - \left| \|u\|_{1,q}^{2(q-p)} - \|v\|_{1,q}^{2(q-p)} \right| \|\nabla v\|_{p}^{p-1} \|\nabla (u - v)\|_{p}
$$

\n
$$
\geq \|\nabla u - \nabla v\|_{q} - \left| \|u\|_{1,q}^{2(q-p)} - \|v\|_{1,q}^{2(q-p)} \right| C \|v\|_{1,q}^{p-1} \|u - v\|_{1,q} (5.6)
$$

By the Mean Value Theorem, we obtain that there exists $\theta \in [0, 1]$ such that

$$
\begin{aligned}\n\left| \|u\|_{1,q}^{2(q-p)} - \|v\|_{1,q}^{2(q-p)} \right| &= \left| \frac{d}{dt} \left(\|u + t(v-u)\|_{1,q}^{2} \right)^{q-p} |_{t=\theta}(v-u) \right| \\
&= \left| (q-p) \left(\|u + \theta(v-u)\|_{1,q}^{2} \right)^{q-p} 2 \left(u + \theta(v-u), v-u \right)_{1,q} \right| \\
&\leq 2(q-p) \|u + \theta(v-u)\|_{1,q}^{q-p} \|u + \theta(v-u)\|_{1,q} \|u-v\|_{1,q} \\
&= 2(q-p) \|u + \theta(v-u)\|_{1,q}^{2q-p} \|u-v\|_{1,q} \\
&\leq 2(q-p) \left((1-\theta) \|u\|_{1,q} + \theta \|v\|_{1,q} \right)^{2q-p} \|u-v\|_{1,q} \\
&\leq 2(q-p) r^{2q-p} \|u-v\|_{1,q}.\n\end{aligned}
$$

Thus, continuing with the estimate of equation (5.6), we get

$$
\langle T(u) - T(v), u - v \rangle \ge ||u - v||_{1,q}^q - 2(q - p)r^{2q-1}C||u - v||_{1,q}^2,
$$

and hence, for $r \to 0$ we end the proof.

We first show the existence of variational eigenvalues of the nonlinear equation (5.4) .

Theorem 5.6. Let $1 < p < q$ be given. Then, for a fixed $p > 0$, there exists a non-decreasing sequence of eigenvalues $\tilde{\lambda}_k^D(p,q;\rho)$, with corresponding eigenfunctions $w_k(p,q;\rho) \in W_0^{1,q}$ $C_0^{1,q}(\Omega)$ for the nonlinear eigenvalue problem (5.4) .

We again rely on [1, Proposition 10.8] for the proof of Theorem 5.6.

Proof. Let $O_{\rho}(p,q) = \{w \in W_0^{1,q}\}$ $\int_0^{1,q}(\Omega)$: $\int_{\Omega} |w|^q dx = \rho \},$ and $\Sigma_{k,\rho}(p,q) = \{A \subset$ Σ : $\gamma(A \cap O_{\rho}(p,q)) \geq k$, where $\Sigma = \{A \subset W_0^{1,q}$ $Q_0^{1,q}(\Omega)$: A closed, $A = -A$. Set

$$
d_k(p,q;\rho) = \inf_{A \in \Sigma_{k,\rho}(p,q)} \sup_{u \in A} \left(\frac{q}{p} ||w||_{1,q}^{2(q-p)} \int_{\Omega} |\nabla w|^p \, dx + \int_{\Omega} |\nabla w|^q \, dx \right) > 0. \tag{5.7}
$$

We show that:

- (i) the functional $F(w) = \frac{q}{q}$ p $||w||_{1,q}^{2(q-p)}$ $\int_{Ω}$ $|\nabla w|^p dx +$ Ω $|\nabla w|^q dx$ satisfies the (PS) condition on $O_o(p,q)$, and
- (ii) if $d = d_k(p,q) = \cdots = d_{k+m-1}(p,q)$, then the set K_d of critical points of I at the critical level d has a genus $\gamma(K_d) \geq m$.

We prove (i). Let $\{w_j\} \subset O_\rho(p,q)$ a (PS) sequence, i.e, for all j, $M > 0$ $|F(w_j)| \le$ M and $F'(w_j) \to 0$ in $W^{-1,q'}(\Omega)$ as $j \to \infty$. We first show that $\{w_j\}$ is bounded in $O_\rho(p,q) \subset W_0^{1,p}$ $w_0^{1,p}(\Omega)$. Since $w_j \in W_0^{1,q}$ $0^{1,q}(\Omega)$, with the Poincaré inequality, we have $\int_{\Omega} |w_j|^q dx \leq C \int_{\Omega} |\nabla w_j|^q dx$ and it follows that

$$
M \ge |F(w_j)| \ge \frac{q}{p} ||w_j||_{1,q}^{2(q-p)} \int_{\Omega} |\nabla w_j|^p dx + \frac{1}{C} \int_{\Omega} |w_j|^q dx
$$

$$
\ge ||w_j||_{1,p}^{2q-p} + \frac{\rho}{C}, \text{ since } W_0^{1,q}(\Omega) \subset W_0^{1,p}(\Omega).
$$

Then $\{w_j\}$ is bounded in $O_\rho(p,q) \subset W_0^{1,q}$ $_{0}^{\text{1,}q}(\Omega)$. We can assume that up to a subsequence still denoted $\{w_j\}$, there exists $w \in O_\rho(p,q) \subset W_0^{1,q}$ $U_0^{1,q}(\Omega)$ such that $w_j \rightharpoonup w$ in $O_\rho(p,q) \subset$ $W_0^{1,q}$ ^{1,q}(Ω). Now, we show that w_j converges strongly to w in $O_\rho(p,q) \subset W_0^{1,q}$ $_{0}^{\prime 1,q}(\Omega)$. Since $F'(w_j) \to 0$ in $W^{-1,q'}(\Omega)$ as $j \to \infty$, we have $F'(w_j)(w_j - w) \to 0$ and $F'(w)(w_j - w) \to 0$ 0 as $j \to \infty$. We have

$$
\langle F'(w_j) - F'(w), w_j - w \rangle
$$

= $q \int_{\Omega} (||w_j||_{1,q}^{2(q-p)} |\nabla w_j|^{p-2} \nabla w_j - ||w||_{1,q}^{2(q-p)} |\nabla w|^{p-2} \nabla w) \cdot \nabla (w_j - w) dx$
+ $q \int_{\Omega} (|\nabla w_j|^{q-2} \nabla w_j - |\nabla w|^{q-2} \nabla w) \cdot \nabla (w_j - w) dx.$

Thanks to Proposition 5.5, it follows that

$$
\langle F'(w_j) - F'(w), w_j - w \rangle \ge C \|w_j - w\|_{1,q}^q.
$$

Therefore $||w_j - w||_{1,q} \to 0$ as $j \to +\infty$ and w_j converges strongly to w in $W_0^{1,q}$ $\mathcal{O}^{1,q}(\Omega).$

The proof of (ii) is similar to the last part of the proof of Theorem 2.5. \Box

Theorem 5.7. Let $p < q$. Then for each integer $k > 0$ the pair $(\lambda_k^D(q, \rho), \infty)$ is a bifurcation point of problem (1.2) .

The proof of Theorem 5.7 will follow immediately from the following remark, and the proof that $(\lambda_k^D(q, \rho), 0)$ is a bifurcation point of (5.4), which will be shown in Theorem 5.11 below.

Remark 5.8. With the change of variable, we have that the pair $(\lambda_k^D(q, \rho), \infty)$ is a bifurcation point for the problem (1.2) if and only if the pair $(\lambda_k^D(q, \rho), 0)$ is a bifurcation point for the problem (5.4) .

Before we proceed to the proof of Theorem 5.11 below, we show the following lemma.

Lemma 5.9. Let $1 < p < q < \infty$. For any integer $k > 0$ and $\rho > 0$, $\varepsilon > 0$, there exists a positive constant $D(\varepsilon)$ such that the following estimate holds:

$$
|d_k(p,q;\rho) - \lambda_k^D(q,\rho)| \le (D(\varepsilon) + \varepsilon)\rho^{\frac{2q-p}{p}}
$$

q;\rho) is given by (5.7), and $\lambda_k^D(q,\rho) = \inf_{A \in \Gamma_{k,\rho}} \sup_{u \in A} \int_{\Omega} |\nabla u|^q dx = \lambda_k^D(q)\rho.$

Proof. For any $k > 0$, we clearly have $d_k(p, q; \rho) \geq \lambda_k^D(p, \rho)$. As in (5.2), we choose P_nA_ε such that

$$
\sup_{\{w \in P_n A_\varepsilon, \int_{\Omega} |w|^q dx = 1\}} \int_{\Omega} |\nabla w|^q dx \le \lambda_k^D(q, \rho) + \varepsilon
$$

and so

where $d_k(p,$

$$
\sup_{\{w \in P_n A_{\varepsilon,\rho}, \int_{\Omega} |w|^q dx = \rho\}} \int_{\Omega} |\nabla w|^q dx \le (\lambda_k^D(q,\rho) + \varepsilon)\rho,
$$

where $P_n A_{\varepsilon,\rho} = \{ w \in P_n A_{\varepsilon} : \int_{\Omega} |w|^q dx = \rho \}.$ Then

$$
d_k(p, q; \rho) = \inf_{A \in \Gamma_{k, \rho}} \sup_{u \in A} \left\{ \frac{q}{p} ||w||_{1, q}^{2(q-p)} \int_{\Omega} |\nabla w|^p dx + \int_{\Omega} |\nabla w|^q dx \right\}
$$

\n
$$
\leq \sup_{u \in P_n A_{\varepsilon, \rho}} \left\{ \frac{q}{p} ||w||_{1, q}^{2(q-p)} \int_{\Omega} |\nabla w|^p dx + \int_{\Omega} |\nabla w|^q dx \right\}
$$

\n
$$
\leq \sup_{u \in P_n A_{\varepsilon, \rho}} \frac{q}{p} ||w||_{1, q}^{2(q-p)} \int_{\Omega} |\nabla w|^p dx + \sup_{w \in P_n A_{\varepsilon, \rho}} \int_{\Omega} |\nabla w|^q dx
$$

\n
$$
\leq \frac{q}{p} ||v||_{1, q}^{2(q-p)} \int_{\Omega} |\nabla v|^q dx + (\lambda_k^D(q) + \varepsilon) \rho \text{ since } p < q,
$$

\n
$$
\leq \frac{q}{p} ||v||_{1, q}^{2q-p} + (\lambda_k^D(q) + \varepsilon) \rho
$$

for some $v \in P_n A_{\varepsilon,\rho}$ with $\int_{\Omega} |v|^q dx = \rho$. Since $P_n A_{\varepsilon}$ is finite-dimensional, there exists a positive constant $D_n(\varepsilon)$ such that $\int_{\Omega} |\nabla v|^q dx \leq D_n(\varepsilon) (\int_{\Omega} |v|^q dx)^{p/q} = D_n(\varepsilon) \rho^{q/p}$ and

$$
||v||_{1,q}^{2q-p} \le D_n(\varepsilon)\rho^{\frac{2q-p}{p}}
$$

Finally, we get

$$
0 \le d_k(p, q; \rho) - \lambda_k^D(q, \rho) \le D_n(\varepsilon) \rho^{\frac{2q-p}{p}} + \varepsilon \rho \le (D_n(\varepsilon) + \varepsilon) \rho^{\frac{2q-p}{p}}
$$

 $\varepsilon > 1.$

since $\frac{2q-p}{p}$

Remark 5.10. We recall that the k-th eigenvalue of equation (5.4) satisfies

$$
\tilde{\lambda}_k^D(p,q;\rho)\rho = ||w||_{1,p}^{2(q-p)} \int_{\Omega} |\nabla w|^p dx + \int_{\Omega} |\nabla w|^q dx, \quad with \quad \rho = \int_{\Omega} |w|^q dx.
$$

So, proceding as in Theorem 5.3 one obtains that $\tilde{\lambda}_k^D(p,q;\rho) \to \lambda_k^D(q)$ as $\rho \to 0^+$.

Theorem 5.11. The pair $(\lambda_k^D(q), 0)$ is a bifurcation point of problem (5.4) for any $k > 0$ and $p < q < \infty$.

Proof. In order to prove Theorem 5.11, it suffices to prove that $\tilde{\lambda}_k^D(p,q;\rho) \to \lambda_k^D(q,\rho)$ and $||w_k||_{1,q} \to 0$ as $\rho \to 0^+$. The fact that $\tilde{\lambda}_k^D(p,q;\rho) \to \lambda_k^D(q)$ as $\rho \to 0^+$ follows from Lemma 5.9 and Remark 5.10.

It remains to prove that $||w_k||_{1,q} \to 0$ as $\rho \to 0^+$. For any $k > 0$, we have

$$
||w_k||_{1,q}^{2(q-p)} \int_{\Omega} |\nabla w_k|^p dx + \int_{\Omega} |\nabla w_k|^q dx = \tilde{\lambda}_k^D(p,q;\rho) \int_{\Omega} |w_k|^q dx
$$

$$
\leq C_k \int_{\Omega} |w_k|^q dx
$$

$$
= C_k \rho \to 0 , \text{ as } \rho \to 0
$$

Therefore $||w_k||_{1,q} \to 0$, and since $p < q$, by the Hölder inequality there exists a positive constant C_1 such that $\int_{\Omega} |\nabla w_k|^p dx \leq C_1 ||w_k||_{1,q}^p$, and so also $||w_k||_{1,p} \to 0$. This completes the proof. \Box

6. Multiplicity results

In this section we prove a multiplicity result: we show that for fixed $\lambda \in (\lambda_k^D(q), \lambda_{k+1}^D(q))$ there exist at least k pairs of eigenfunctions $\pm u_i^{\lambda}(p,q), i = 1,\ldots,k$, such that $(\lambda, \pm u_i^{\lambda}(p,q))$ solve equation (2.1), i.e.

$$
\lambda = \lambda_1^D(p, q, \rho_1) = \cdots = \lambda_k^D(p, q; \rho_k), \text{ with } \rho_i = \int_{\Omega} |u_i^{\lambda}(p, q)|^q dx.
$$

We distinguish again the two cases $p < q$ and $p > q$. The proofs rely on variational methods.

Theorem 6.1. Let $1 < q < p < \infty$ or $1 < p < q < \infty$, and suppose that $\lambda \in$ $(\lambda_k^D(q), \lambda_{k+1}^D(q))$. Then equation (1.2) has at least k pairs of nontrivial solutions.

Proof. We split the proof into two parts.

Part 1: $p < q$.

In this case we will make use of [1, Proposition 10.8]. We consider the functional $J_{\lambda}:W_0^{1,q}$ $\mathcal{O}_0^{1,q}(\Omega)\backslash\{0\} \to \mathbb{R}$ associated to the problem (1.2) defined by

$$
J_{\lambda}(u) = \frac{q}{p} \int_{\Omega} |\nabla u|^p dx + \int_{\Omega} |\nabla u|^q dx - \lambda \int_{\Omega} |u|^q dx.
$$

The functional J_{λ} is not bounded from below on $W_0^{1,q}$ $C_0^{1,q}(\Omega)$, so we consider again the constraint set \mathcal{N}_{λ} , on which we minimize the functional J_{λ} . We recall that the constraint set is given by

$$
\mathcal{N}_{\lambda} := \{ u \in W_0^{1,q}(\Omega) \backslash \{0\} : \langle J'_{\lambda}(u), u \rangle = 0 \}.
$$

On \mathcal{N}_{λ} , we have $J_{\lambda}(u) = \left(\frac{1}{p} - \frac{1}{q}\right)$ $\frac{1}{q}$) Ω $|\nabla u|^p dx > 0$. We clearly have that J_λ is even and bounded from below on \mathcal{N}_{λ} . Next we show that every Palais-Smale (PS) sequence for J_{λ} has a converging subsequence on \mathcal{N}_{λ} . Let $(u_n)_{n\geq 0}$ be a (PS) sequence, i.e, $|J_{\lambda}(u_n)| \leq C$, for all *n*, for some $C > 0$ and $J'_{\lambda}(u_n) \to 0$ in $W^{-1,q'}(\Omega)$ as $n \to +\infty$, with $\frac{1}{q} + \frac{1}{q'}$ $\frac{1}{q'}=1.$ We first show that the sequence $(u_n)_{n\geq 0}$ is bounded on \mathcal{N}_{λ} . Suppose that $(u_n)_{n\geq 0}$ is not bounded, so \int Ω $|\nabla u_n|^q dx \to +\infty$ as $n \to +\infty$. Since $J_\lambda(u_n) = (\frac{1}{p} - \frac{1}{q})$ $\frac{1}{q}$) Ω $|\nabla u_n|^p dx$, we have Ω $|\nabla u_n|^p dx \leq c$. On \mathcal{N}_{λ} , we have

$$
0 < \int_{\Omega} |\nabla u_n|^p \, dx = \lambda \int_{\Omega} |u_n|^q \, dx - \int_{\Omega} |\nabla u_n|^q \, dx,\tag{6.1}
$$

and hence $\int |u_n|^q dx \to +\infty$. Let $v_n = \frac{u_n}{||u_n||}$ Ω $J\Omega$ $\frac{u_n}{\|u_n\|_q}$ then $\int_{\mathbb{R}} |\nabla v_n|^q dx < \lambda$ (using (6.1)) and hence v_n is bounded in $W_0^{1,q}$ ^{1,q}(Ω). Therefore there exists $v_0 \in W_0^{1,q}$ $v_0^{\text{1},q}(\Omega)$ such that $v_n \rightharpoonup v_0$ in $W_0^{1,q}$ $L^{1,q}(\Omega)$ and $v_n \to v_0$ in $L^q(\Omega)$. Dividing (6.1) by $||u_n||_q^p$, we have

$$
\frac{\lambda \int_{\Omega} |u_n|^q dx - \int_{\Omega} |\nabla u_n|^q dx}{\|u_n\|_q^p} = \int_{\Omega} |\nabla v_n|^p dx \to 0,
$$

since λ Ω $|u_n|^q$ dx – Ω $|\nabla u_n|^q dx = \left(\frac{1}{n}\right)$ p − 1 q $|J_{\lambda}(u_n), |J_{\lambda}(u_n)| \leq C$ and $||u_n||_q^p \to +\infty$. Now, since $v_n \rightharpoonup v_0$ in $W_0^{1,q}$ $V_0^{1,q}(\Omega) \subset W_0^{1,p}$ $L^{1,p}(\Omega)$, we infer that

$$
\int_{\Omega} |\nabla v_0|^p dx \le \liminf_{n \to +\infty} \int_{\Omega} |\nabla v_n|^p dx = 0,
$$

and consequently $v_0 = 0$. So $v_n \to 0$ in $L^q(\Omega) \subset L^p(\Omega)$ and this is a contradiction since $||v_n||_q = 1$. Thus $(u_n)_{n\geq 0}$ is bounded on \mathcal{N}_{λ} . Now, we show that u_n converges strongly to u in $W_0^{1,q}$ $\mathcal{O}_{\mathcal{O}_{\mathcal{C}}}^{1,q}(\Omega).$

We have \int Ω $|u_n|^{q-2}u_n dx \to 0$ Ω $|u|^{q-2}u \, dx$ as $n \to \infty$ and since $J'_{\lambda}(u_n) \to 0$ in $W^{-1,q'}(\Omega)$, $u_n \rightharpoonup u$ in $W_0^{1,q}$ $J'_{0}(0)$, we also have $J'_{\lambda}(u_n)(u_n-u) \to 0$ and $J'_{\lambda}(u)(u_n-u) \to 0$ as $n \to +\infty$. We recall that with the computations made in Remark 3.1, we have for $1 < p < \infty$

$$
\int_{\Omega} \left(|\nabla u_n|^{p-2} \nabla u_n - |\nabla u|^{p-2} \nabla u \right) \cdot \nabla (u_n - u) \, dx \geq (||u_n||_{1,p}^{p-1} - ||u||_{1,p}^{p-1}) (||u_n||_{1,p}^p - ||u||_{1,p}^p) \geq 0
$$

Then,

$$
\langle J'_{\lambda}(u_{n}) - J'_{\lambda}(u), u_{n} - u \rangle = q \left[\int_{\Omega} \left(|\nabla u_{n}|^{p-2} \nabla u_{n} - |\nabla u|^{p-2} \nabla u \right) \cdot \nabla (u_{n} - u) \, dx \right] + q \left[\int_{\Omega} \left(|\nabla u_{n}|^{q-2} \nabla u_{n} - |\nabla u|^{q-2} \nabla u \right) \cdot \nabla (u_{n} - u) \, dx \right] - \lambda q \left[\int_{\Omega} \left(|u_{n}|^{q-2} u_{n} - |u|^{q-2} u \right) \cdot (u_{n} - u) \, dx \right] \geq q \left[\int_{\Omega} \left(|\nabla u_{n}|^{q-2} \nabla u_{n} - |\nabla u|^{q-2} \nabla u \right) \cdot \nabla (u_{n} - u) \, dx \right] - \lambda q \left[\int_{\Omega} \left(|u_{n}|^{q-2} u_{n} - |u|^{q-2} u \right) \cdot (u_{n} - u) \, dx \right].
$$

Using Lemma 3.3, it follows that

$$
\langle J'_{\lambda}(u_n) - J'_{\lambda}(u), u_n - u \rangle \ge C \|u_n - u\|_{1,q}^q - \lambda q \left[\int_{\Omega} \left(|u_n|^{q-2} u_n - |u|^{q-2} u \right) \cdot (u_n - u) \, dx \right].
$$

Therefore $||u_n - u||_{1,q} \to 0$ as $n \to +\infty$ and u_n converges strongly to u in $W_0^{1,q}$ $\mathcal{O}^{1,q}(\Omega).$

Let $\Sigma = \{A \subset \mathcal{N}_{\lambda} : A \text{ closed and } -A = A\} \text{ and } \Gamma_j = \{A \in \Sigma : \gamma(A) \geq j\},\$ where $\gamma(A)$ denotes the Krasnoselski's genus. We show that $\Gamma_j \neq \emptyset$, for $j \in \{1, \ldots, k\}$.

Let $\lambda \in (\lambda_j^D(q), \lambda_{j+1}^D(q))$ and choose $S_j^{\varepsilon} \in \Sigma \cap \{\int_{\Omega} |u|^q dx = 1\}$ such that

$$
\sup_{v \in S_j^{\varepsilon}} \int_{\Omega} |\nabla v|^q dx \leq \lambda_j^D(q) + \varepsilon, \quad \varepsilon := \frac{\lambda - \lambda_j^D(q)}{2}.
$$

Then, for $v \in S_j^{\varepsilon}$ we set

$$
\rho(v) = \left[\frac{\int_{\Omega} |\nabla v|^p dx}{\lambda \int_{\Omega} |v|^q dx - \int_{\Omega} |\nabla v|^q dx}\right]^{\frac{1}{q-p}},
$$

with

$$
\lambda \int_{\Omega} |v|^q dx - \int_{\Omega} |\nabla v|^q dx \ge \lambda \int_{\Omega} |v|^q dx - (\lambda_j^D(q) + \varepsilon) \int_{\Omega} |v|^q dx
$$

$$
= (\lambda - \lambda_j^D(q) - \varepsilon) \int_{\Omega} |v|^q dx
$$

$$
= [\lambda - \lambda_j^D(q) - (\frac{\lambda - \lambda_j^D(q)}{2})] \int_{\Omega} |v|^q dx
$$

$$
= \frac{\lambda - \lambda_j^D(q)}{2} \int_{\Omega} |v|^q dx > 0, \text{ for all } v \in S
$$

Hence, $\rho(v)v \in \mathcal{N}_{\lambda}$, and then $\rho(S_j^{\varepsilon}) \in \Sigma$, and $\gamma(\rho(S_j^{\varepsilon})) = \gamma(S_j^{\varepsilon}) = j$ for $1 \le j \le k$.

ε j .

It is then standard [1, Proposition 10.8] to conclude that

$$
\sigma_{\lambda,j} = \inf_{A \in \Gamma_j} \sup_{u \in A} J_{\lambda}(u), \ \ 1 \le j \le k, \ \ \text{for any} \ \ k \in \mathbb{N}^*
$$

yields k pairs of nontrivial critical points for J_{λ} , which gives rise to k nontrivial solutions of problem (1.2).

Part 2: $p > q$.

In this case, we will rely on the following theorem.

Theorem (Clark, [7]) .

Let X be a Banach space and $G \in C^1(X,\mathbb{R})$ satisfying the Palais-Smale condition with $G(0) = 0$. Let $\Gamma_k = \{ A \in \Sigma : \gamma(A) \geq k \}$ with $\Sigma = \{ A \subset X : A =$ $-A$ and A closed }. If $c_k = \inf_{A \in \Gamma_k} \sup_{u \in A}$ $\sup_{u \in A} G(u) \in (-\infty, 0)$, then c_k is a critical value.

We consider the C^1 functional $J_\lambda: W_0^{1,p}$ $C_0^{1,p}(\Omega) \subset W_0^{1,q}$ $\chi_0^{1,q}(\Omega) \to \mathbb{R}$

$$
J_{\lambda}(u) = \frac{q}{p} \int_{\Omega} |\nabla u|^p dx + \int_{\Omega} |\nabla u|^q dx - \lambda \int_{\Omega} |u|^q dx.
$$

Let $\Gamma_k = \{ A \subset W_0^{1,q} \}$ $C_0^{1,q}(\Omega)\setminus\{0\},\;\; A \text{ compact},\;\; A=-A,\;\;\gamma(A)\geq k\},\text{ and for }\varepsilon>0\text{ small}$ let $A_{\varepsilon} \in \Gamma_k$ such that

$$
\sup_{\{u \in A_{\varepsilon}, \int_{\Omega} |u|^q dx = 1\}} \int_{\Omega} |\nabla u|^q dx \le \lambda_k^D(q) + \varepsilon.
$$

We would like to show that

$$
-\infty < \alpha_{\lambda,k} = \inf_{A \in \Gamma_k} \sup_{u \in A} J_\lambda(u) \tag{6.2}
$$

are critical values for J_{λ} . We clearly have that $J_{\lambda}(u)$ is an even functional for all $u \in W_0^{1,p}$ $U_0^{1,p}(\Omega)$, and also J_λ is bounded from below on $W_0^{1,p}$ $J_{\lambda}^{1,p}(\Omega)$ since J_{λ} is coercive on $W_0^{1,p}$ $\mathcal{L}_0^{1,p}(\Omega)$.

We show that $J_{\lambda}(u)$ satisfies the (PS) condition. Let $\{u_n\}$ be a Palais-Smale sequence, i.e., $|J_\lambda(u_n)| \leq M$ for all $n, M > 0$ and $J'_\lambda(u_n) \to 0$ in $W^{-1,p'}(\Omega)$ as $n \to \infty$. We first show that $\{u_n\}$ is bounded in $W_0^{1,p}$ $\mathcal{O}^{1,p}(\Omega)$. We have

$$
M \geq |C||u_n||_{1,p}^p - C'||u_n||_{1,p}^q \geq |C||u_n||_{1,p}^{p-q} - C'||u_n||_{1,p}^q,
$$

and so $\{u_n\}$ is bounded in $W_0^{1,p}$ $U_0^{1,p}(\Omega)$. Therefore, $u \in W_0^{1,p}$ $C_0^{1,p}(\Omega)$ exists such that, up to subsequences that we will denote by $(u_n)_n$ we have $u_n \rightharpoonup u$ in $W_0^{1,p}$ $u_0^{1,p}(\Omega)$ and $u_n \to u$ in $L^q(\Omega)$. Arguing as in Part 1, we obtain that $||u_n - u||_{1,p} \to 0$ as $n \to +\infty$, and so u_n converges to u in $W_0^{1,p}$ $C_0^{1,p}(\Omega) \subset W_0^{1,q}$ $\mathcal{L}_0^{1,q}(\Omega)$.

As in section 5, we approximate A_{ε} by a finite-dimensional set. Next, we show that there exists sets D^{ε} of genus greater of equal to k such that sup $\sup_{u\in D^{\varepsilon}} J_{\lambda}(u) < 0$. For any

 $s \in (0,1)$, we define the set $D^{\varepsilon}(s) := s \cdot (P_n A_{\varepsilon})$ and so $\gamma(D^{\varepsilon}(s)) = \gamma(P_n A_{\varepsilon}) \geq k$. We have, for any $s \in (0,1)$

$$
\sup_{u \in D^{\varepsilon}} J_{\lambda}(u) = \sup_{u \in P_n A_{\varepsilon}} J_{\lambda}(su)
$$
\n
$$
\leq \sup_{u \in P_n A_{\varepsilon}} \left\{ \frac{qs^p}{p} \int_{\Omega} |\nabla u|^p dx + s^q \int_{\Omega} |\nabla u|^q dx - \lambda s^q \int_{\Omega} |u|^q dx \right\}
$$
\n
$$
\leq \sup_{u \in P_n A_{\varepsilon}} \left\{ \frac{qs^p}{p} c(n)^p ||u||_{1,q}^p + s^q (\lambda_k^D(q) + \varepsilon - \lambda) \right\} < 0
$$

for $s > 0$ sufficiently small.

Finally, we conclude that $\alpha_{\lambda,k}$ are critical values for J_λ thanks to Clark's Theorem. \Box
