In the French context of "race for diplomas" (Erner, 2014) where the feeling of "becoming adult" is delayed (Lannegrand-Willems et al., 2011), emerging adults particularly have to adjust to the transitional period of starting university. During emerging adulthood:

Family environment (Picard & Marc, 1996)
Attachment (Konrath et al., 2014)
Self-determination (Vansteenkiste & Ryan, 2013)
Home leaving (Kins et al., 2009)

Adjustment

Aim of the study

Determine the relations between all these dimensions and their influence on emerging adults' psychosocial adjustment during the transitional period of starting university.

N = 1,142 freshman emerging adults (70.7% women;  $M_{age}$  = 18.4;  $SD_{age}$  = 0.6) recruited in different curricula.


Family environment – Relations with parents (Delhaye et al., 2012) + Relations with family (Olson, 1985 and Moos & Moos, 1994).

Attachment – Attachment representations (Collins & Read, 1990).

Self-determination – Motivation (Vallerand et al., 1989) + Satisfaction/frustration of the basic needs (Chen et al., 2015).

Home leaving – 3 indicators: living arrangement + return to family home + feeling of living at family home (see Kins et al., 2009).

Psychosocial adjustment – Self-worth (Neeman & Harter, 2012) + Depression (Beck & Beamsderfer, 1974) + Psychological well being (Ryff & Keyes, 1995).



## Home leaving patterns

 $L^2 = 30.42$ , df = 27, p = .29; BIC = 6389.42


Co-resident / Still live with parents + still considered living at the parental home (n = 59.4%)

Semi-independent / Leave the family house + go back once in two weeks + still considered living at the parental home (n = 22.6%)

Independent / Leave the family house + go back in varying degree + do not considered living at the parental home (n = 18.0%)

### Structural equation modeling

 $\chi^2$  (315) = 1853.28, CFI = .93, RMSEA = .07[.068-.074], TLI = .92, and SRMR = .08





Home leaving patterns were in line with the literature with independent pattern which go back more frequently.

Attachment and self-determination directly influenced emerging adults' psychosocial adjustment whereas family environment and home leaving patterns seemed to be mediated by other variables.

Attachment appeared to be a core variable in understanding emerging adults' adaptation to a new context of life.
