#### 16 ABSTRACT

17

18 The Amazon forest is an important and primordial ecosystem, as it controls the 19 dynamics of soil organic matter (SOM) in addition to being considered one of the most 20 important carbon reservoirs in the world. Based on that, this study evaluated the molecu-21 lar properties of humic (HA) and fulvic (FA) acid from Amazon soil, with and without 22 Cu(II) ions, by Time Resolved Laser Fluorescence Spectroscopy (TRLFS) and Fluorescence Spectroscopy (FS). Fluorescence excitation-emission matrix (EEM) was obtained 23 24 by FS, and EEM spectra were treatment by canonical polyadic/parallel factor analysis (EEM-CP/PARAFAC). The results showed that the humification index (A<sub>465nm</sub>) deter-25 26 mined by FS is directly dependent on fluorophores CII/CI ratio in these soils with depth 27 (r = 0.89), especially for HA samples, in which demonstrated that the CII consist more 28 complex and humified structure of the SOM. The decay of the lifetime showed the pres-29 ence of static quenching in the humic fractions. From the decay life data provided by 30 TRLFS and the different correlations with carbon content and A<sub>465nm</sub>, it can be deduced that fluorescence suppression modifies the molecular properties of the humic fractions 31 32 with the addition of Cu(II) ions, such as altering the mobility and availability of the 33 metal in the complexation reactions in these Amazonian Spodosols, mainly for fulvic fraction. 34

## 38 1. Introduction

39 Geochemical studies of soil formation in tropical regions, such as the Amazon 40 Forest, are important and primordial, as it controls the dynamics of soil organic matter (SOM), and considered to be one of the most important carbon reservoirs in the world 41 (Cerri et al. 2000; Mafra et al. 2007; Carvalho et al. 2010; Anjos et al. 2021; Huamán et 42 43 al. 2021; Zaman, 2022). The Amazonian vegetation is quite diversified covering 44 different soil formations, especially the Spodosols systems. These soils are 45 characterized by having an organic litter on a thick sandy horizons overlying more 46 clayey horizons, and the organic matter (OM) produced in the superficial horizon is 47 transferred and accumulated in a deeper profile around 1 to 3 m, forming horizons rich 48 in OM (known as Spodic horizons, Bhs) (Montes et al. 2011; Lucas et al. 2012; Ishida 49 et al. 2014; 2018). Hydromorphic Spodosols from the upper Rio Negro basin can 50 accumulate large amounts of organic carbon in the surface layer around  $14 \pm 1$  Pg of 51 Carbon (Cerri et al. 2000; Montes et al. 2011), demonstrating a high carbon storage 52 capacity in these soils in which can contribute to  $CO_2$  mitigation in this ecosystem and global scale. 53

54 The main components of SOM are humic substances (HS), i.e. humic acids (HA), 55 fulvic acids (FA) and humin (HU), which can be obtained by acid/alkali extractions (Stevenson, 1994). These naturally occurring by-products of SOM have been 56 57 systematically studied (Nebbioso et al. 2015; Olk et al 2019a,b; Machado et al. 2020). 58 Fluorescence spectroscopy is frequently used in the literature to rapidly assess the 59 structural and molecular characteristics of OM and their humic fractions (Senesi and D'Orzio, 2005; Tadini et al. 2015, 2018, 2020; Liu et al., 2020; Mohinuzzaman, et al. 60 61 2020; Soares da Silva et al. 2020; Mielnik et al. 2021; Rinot et al. 2021), recently 62 highlighting the use of Time Resolved Laser Fluorescence Spectroscopy (TRLFS) 63 (Nicolodelli et al. 2017; Nouhi et al., 2018; Dos Santos et al., 2020a,b). This technique can measure the decay of the fluorescence intensity of a sample after excitation, 64 65 allowing the determination of the fluorescence lifetime in sample fluorophores (Millar, 1996). Besides, it can discriminate different chemical species, such as OM, fluorescent 66 67 metallic ion and their complexes, since they can have different decay lifetime and 68 spectral shapes (Nouhi et al., 2018; Dos Santos et al., 2020a,b).

In the literature there are many studies using the TRLFS for proteins and nucleic acids characterization, especially tryptophan, due to its fluorescence being very sensitive to environmental factors (Collins et al. 2011). However, there are few studies that

use this technique in the characterization of fluorophores in humic fractions, especially
HA and FA (Lukman et al. 2012; Nouhi et al., 2018; Dos Santos et al., 2020a,b) and this
technique has been growing mainly in the last two years (Figure S1).

75 An important characteristic of humic fractions in soil is their availability to inter-76 act with metals by complexation reactions in which are responsible for biological availability, accumulation and mobility in the soil environment (Senesi et al. 1991). An es-77 78 sential of growth of plants at soil is copper, which acting important metabolic reactions 79 such as photosynthesis and protein synthesis (Yruela, 2005; Gonzaga et al. 2020). Based 80 on this, the hypothesis of this study is that the interaction of divalent metal ion (repre-81 sented by the copper(II) metal) with SOM, will affect its humification process due to the 82 formation of the metallic complex (Cu(II)-SOM) in which will be verified by TRLFS. 83 To test this hypothesis and obtain a higher level of molecular and complexation knowl-84 edge of the humic (HA) and fulvic acids (FA) from Amazon Spodosols with and without added Cu(II) ions, it will be using the Time Resolved Laser Fluorescence Spec-85 86 troscopy (TRLFS), Fluorescence Spectroscopy (emission-excitation matrix, EEM) and mathematical method known as canonical polyadic/parallel factor analysis (CP/ 87 88 PARAFAC).

## 90 2. Materials and Methods

#### 91 2.1. Study area

92 The study area is located to the north of the city of Barcelos, near the Demeni 93 River (0° 15' 18" N; 62° 46' 36" W) and the soils were classified as Spodosol according 94 Soil Taxonomy (Soil Survey Staff, 2014). The area is tropical climate with average temperature of 26°C and 3,000 mm of mean annual rainfall (Alvares et al. 2013). The 95 96 samples were from: (a) a permanently waterlogged Spodosol covered by herbaceous 97 meadow of shrubs and grass, locally named "campina" (P1); (b) a seasonally waterlogged Spodosol (P3) and (c) a well-drained Spodosol under rainforest vegetation 98 99 (P4) (Figure 1), more details in Tadini et al. (2018).

#### 106 *2.2. Preparation of the samples for analysis*

107 Soils samples at different depths (0 to 390 cm) were collected at the different 108 pedologic horizon types according described in Tadini et al. 2018. To isolate the humic 109 (HA) and fulvic (FA) acids fractions, the procedure recommended by the International 110 Society of Humic Substances was used (Swift, 1996). Detailed information regarding 111 extraction and purification of the humic fractions can be found in Figure S2 in 112 Supplementary Material.

115 To allow spectroscopic fluorescence comparison ionic strength and pH were con-116 trolled. The dilution factor was chosen to have no inner effect at final concentration following the description in Tadini et al (2018) in which a concentration test was previ-117 ously performed to verify the best condition to be used in these studies. The HA and FA 118 samples were dissolved in a 0.05 mol L<sup>-1</sup> sodium bicarbonate solution (NaHCO<sub>3</sub>) ob-119 taining a solution with a concentration of 12.5 mg  $L^{-1}$  of AF or AH (pH = 8.0) and left 120 in an ultrasonic homogenizer for 10 minutes to complete dissolution all the samples. A 121 122 spectrofluorimeter (model LS50B from Perkin Elmer) equipped with a Xenon lamp 123 (240 V) and connected to a computer was used.

- 125 2.3.1. Humification Index (A<sub>465nm</sub>)

The emission spectra with excitation at 465 nm (slit 10 nm) were obtained with scanning from 480 to 700 nm (slit 10 nm), open filter, 500 nm.min<sup>-1</sup> scan speed and the photomultiplier tension was at 700 V. The humification index ( $A_{465nm}$ ) was determined using the total area under the emission fluorescence with excitation at 465 nm with a concentration solution of 12.5 mg L<sup>-1</sup> in pH = 8.0 for HA and FA (Milori et al. 2002)

## 133 2.3.2. Emission-Excitation matrix (EEM)

134 The EEM fluorescence spectra were acquired for each humic fractions (totalizing 40 EEM samples of the three soils sites) in the scan range between 240-700 nm 135 (slit 10 nm) for emission and 220-510 nm for excitation (slit 10 nm), at 700 nm.min<sup>-1</sup> 136 137 scan speed as described in Tadini et al. (2020). Sensitivity was checked every day using 138 ultrapure Raman peak emission. The spectra were treated using mathematical method known as canonical polyadic/parallel factor analysis (CP/PARAFAC) (Bro, 1997; Mur-139 140 phy et al. 2013). The CP/PARAFAC analysis decomposes the fluorescence signals from the EEM spectra dataset into simple and independent fluorescent components, in which 141 142 result at the specifically excitation and emission spectrum (Murphy et al. 2013).

## 144 2.4. Time-Resolved Laser Fluorescence Spectroscopy (TRLFS)

145 A volume of 480  $\mu$ L of a 8 mg L<sup>-1</sup> solution of HA or FA in 1,000  $\mu$ L of Sodium 146 Acetate Buffer Solution (0.001 mol L<sup>-1</sup>) were added in a quartz cuvette completed to 147 have a final volume to 3,300  $\mu$ L with deionized water (pH=8). The prepared sample 148 solution was left for 10 minutes under a nitrogen gas atmosphere to eliminate the O<sub>2</sub> that

can induce photodegradation, and then the measurement was performed using a 149 150 Quantaurus (Tau J from Hamatsu model C11367). The time resolved laser fluorescence 151 spectra were acquired in the scan range between 300-700 nm for emission and with 152 excitation at 280 nm (LED light source with 5 MHz), while the maximum emission 153 intensity was 300 counts with counting rate 5.0%, time range 50 ns and filter open. A 154 known concentration of Cu(II) ions was added to each HA and AF sample and analyzed 155 by TRLFS. The first HA or FA samples don't have concentration of copper  $(C_0)$ , whereas  $C_{0.26}$  contained 0.26 mg L<sup>-1</sup> of Cu(II) (Dos Santos et al., 2020a,b). 156

157 The fluorescence decay curve was determined by a one-exponential function, 158 according to equation 1:

160 Where  $T_1$  (s) is value of fluorescence lifetime and  $a_1$  ( $\lambda$ ) is the emission 161 wavelength coefficient related to component at t=0, and t the time in s. The average 162 lifetime ( $T_m$ ) in this study was determined following to equation 2:

165 Where  $T_m$  is average lifetime  $(T_{1,x})$  for each horizons x=A, B to N and N is 166 number of horizons were determined in the specific soil or area.

## 169 3. Results and Discussion

170 *3.1. Molecular properties of soil organic matter* 

Figure 2 shows the fluorescence spectrum ( $\lambda_{ex} = 465$  nm) for the sample of HA and FA extracted from the Hydromorphic Spodosol (a and b), seasonally Hydromorphic Spodosol (c and d) and Well-drained Spodosol (e and f).

180 The emission spectra for humic fractions (Fig. 2) presented a typical wide band with a maximum intensity around 500-550 nm (Milori et al. 2002; Fuentes et al. 2006; 181 182 Tadini et al. 2018). The excitation in 465 nm is more resonant with aromatic and resistant groups (Milori et al. 2002) that can associate the SOM transformation stage in 183 184 these soils. Since, the maximum intensity of fluorescence was observed with depth for 185 all Spodosol areas (P1, P3 and P4) in which can be suggests the relevant presence of 186 molecular components, such as aromatic polycondensation structure (Fuentes et al. 187 2006; Tadini et al. 2018). The change in fluorescence to longer wavelengths can be 188 reflecting on a higher concentration of more humified groups especially in these Bh 189 deepest of these Spodosol. From these two-dimensional spectra, it was possible to determine the humification index described by Milori et al. (2002), as shown in Figure 3 190

197 Figure 3, showed an increase HA and FA humification indices during the depth for the Hydromorphic Spodosol (P1) that the highest values found in the deeper Bh-C 198 199 horizons (Bh-C 240 and Bh-C 260) and the lowest values were verified in the superficial horizons. The same behavior was verified to seasonally Hydromorphic 200 201 Spodosol (P3) that highlighted the deeper Bh horizons have highest humification index (Bh 280-310 and Bh 335-350). Particularly, for P3, in the Bh 180-183 horizon showed 202 203 an exception behavior comparison other Bh horizons (P1 and P4), in which the higher 204 value A<sub>465nm</sub> was from FA fraction that suggest in this horizon FA is more humified than 205 HA. In Well-drained Spodosol (P4) for HA there was a gradual increase during the 206 depth, that highest values were obtained for the deepest horizons, Bh 370-380 and Bh-C 207 380-390. These results suggest that the humic fractions at the surface horizons include 208 simple, labile and poorly humified compounds, whereas the more complex humified 209 compounds are leached and accumulated or retained at deeper horizons, especially in 210 the HA fractions in these areas (Tadini et al. 2018). So, the Amazonian soils humification indices (A<sub>465nm</sub>) presented the following descending order: P4 > P3 > P1211 for HA samples and P3 > P1 > P4 for FA samples. 212

Figure 4 showed the fluorophores obtained by EEM-CP/PARAFAC of the humic fractions without Cu(II) ions. It can be observed contribution of two components (CI and CII) for both HA and FA from Amazon Spodosols, whose the core consistency diagnostic (CORCONDIA) were of 93.84 and 97.09% for the HA and FA, respectively.

Figure 4a and 4c refers the A peak (CI,  $\lambda ex/\lambda em$ : 275-320/460nm) and A-C peak 221 222 (CI,  $\lambda ex/\lambda em$ : 320-360/400-460 nm) which are characteristic of soil humic and fulvic acids compounds, respectively. The CII for HA (Figure 4b) showed two excitation 223 224 peaks ( $\lambda$ ex/ $\lambda$ em: 300/525nm e  $\lambda$ ex/ $\lambda$ em: 455/525nm) that refers the complex structure 225 and it is referred as soil humic-like component in literature. Figure 4d showed one peak 226 (CII for FA,  $\lambda ex/\lambda em$ : 275/500 nm) that can be typically attributed to fulvic-like from soil (Stedmon et al., 2003; Coble et al., 2014; Morais et al. 2021; Tadini et al. 2020; 227 228 2022). As expected HA present higher emission wavelength compare to FA due to the 229 longer humification process inducing  $\pi$ -conjugation and redshift (Senesi et al. 1991; 230 Tadini et al. 2018).

231 Figure 5 showed the correlation obtained by HA and FA humification index 232  $(A_{465nm})$  between CII/CI ratios. In Fig. 5a, a good positive correlation was observed (r = 0.89) for all HA samples, demonstrating that the humification index  $(A_{465nm})$  is directly 233 234 dependent on CII/CI ratio in these soils. Since, the CII is the most complex fluorophore with aromatic and humified characteristics present in SOM (Fig. 4), in which suggesting 235 236 the fluorophore CII is acting on the humification index mainly in the deeper horizons of 237 the HA samples, highlighting the Bh horizons from P4 Spodosols that showed higher values of A<sub>465nm</sub> evidenced in this study. A different behavior was observed for the FA 238 fraction which is not correlated with the humification index (see in Fig. 5b, r = 0.48) 239 which suggests the FA composition is less diversified and simpler than the HA 240 241 structure, and besides, the FA humification index showed a proportion of ten times lower than the HA fractions that corroborating the structure of FA is simpler than HA. 242

## 249 3.2. Lifetime properties of humic fractions

The humic fractions for this study showed one-exponential decay of lifetime ( $T_1$ ) as described in Table S1 and besides, an interesting factor is that T1 decays faster for FA samples (4,81 ns) than for HA samples (4,53 ns) (t=0.055) (Table S1). Then, it can be suggest the variability is smaller for HA samples (2%) than for FA fractions (10 %), in which its means the FA samples may be more reactive than HA, and thus, the FA fractions are easier to bind to metals than HA fractions which can cause a variation of the lifetime in these fractions (Fig. S4).

257 Figure 6 showed that when Cu(II) ions were added, there was an increase in the 258 lifetime (Tm) of the P1 and P3 profile of the HA samples and the P4 profile of the FA 259 sample, while the P4 profile of the HA sample decreased the Tm and at the profiles P1 260 and P3 of the FA samples did not changed of the Tm. Studies in the literature using 261 humic (Dos Santos et al. 2020a) and fulvic (Dos Santos et al. 2020b) acids extracted from Terra Mulata soils in Amazonia and HA extracted from the Saint Lawrence 262 263 Estuary in Canada (Nouhi et al. 2018) with Cu(II) showed that for Cu(II) complexation 264 the lifetime decrease (due to quenching process) that can be observed for HA at the P4

area and for FA at the P1 and P3 areas (Figure 6). To regarding the samples showed an 265 increase of the lifetime, P1 and P3 for HA fraction and the P4 for FA fraction, 266 267 distinguished by low SOM transformation evidenced of the low A<sub>465nm</sub> (Figure 3) and 268 the presence of simpler structure (Figure 4) in which can be suggesting these fractions are participating of the complexation reactions and will be influencing the mobility and 269 270 metal availability in these soil profiles. Moreover, the dependence of the relative amplitudes of the fluorescence decay of FA remained almost unchanged in the soil 271 272 samples P1 and P3, which showed an invariance of the lifetime values of FA after the 273 addition of the metal, suggesting that there was no energy transfer between the singlet 274 states of FA and Cu(II), thus suggest the quenching process in these profiles is static 275 quenching.

Study realized by Tadini et al. (2019) evaluating the same P1 and P4 areas showed the HA fraction had few variation of C content during the depth whereas FA fraction had high C variation with depth and an increase value at the deeper horizons. In this study, P4 area for FA showed differently behavior lifetime ( $T_m$ ) compared others areas P1 and P3, this increase of lifetime added Cu(II) in this area (Figure 6) may be suggest the decrease amount of C present in the FA structure influencing the mechanism

287 of fluorescence quenching due to the complexation process in this fraction, as 288 confirmed by data correlation observed in Figure S5 (Supplementary Material). In 289 Figure S5a, a good negative correlation was observed (r = -0.677) for all FA samples 290 after interaction with Cu(II), demonstrating that the interaction of Cu(II) by influencing 291 of the C amount in SOM structure, especially for FA from P4 soil (see in Fig. S5b, r = -292 0.944) that can be suggesting the functional protection and influence the carbon 293 persistence in these Podzols. Besides, study describe by Tadini et al. (2020) employed 294 the same samples from Amazonian Spodosols observed the HA needed 10 times more 295 carbon in their structures to complex ions metallic than FA fractions using the 296 fluorescence suppression analysis of Cu(II) and Al(III) ions.

297 Figure S6 (Supplementary Material) showed the correlation obtained for HA and 298 FA of the humification index  $(A_{465nm})$  vs. lifetime  $(T_1)$  with Cu(II) ions (a) and without 299 Cu(II) ions (b) for different profiles of soils. It can be observed moderate positive 300 correlation Pearson, r = 0.614 and r = 0.629 for lifetime (T<sub>1</sub>) to HA and FA (Fig.S6a), 301 respectively. These results suggested lifetime  $(T_1)$  for the HA and FA fractions may be 302 related to the same origin of groups of chemical sites, that it is corroborates to EEM-303 CP/PARAFAC data (Figure 4b and 4d). These results showed the CII that refers more 304 complex structures (e.g. condensed and aromatic groups) can be conferring a greater aromaticity and recalcitrant carbon in these soils, and consequently, increase the 305 humification index in these humic fractions. Besides, FA fractions showed that when 306 307 interacting with Cu(II) metal it decreases its humification (Figure S6b), thus demonstrating these fractions have greater mobility and availability of metal 308 309 complexation than HA these soils. Thus, the employment of the advanced technique, as 310 TRLFS, in this study provided key insights to evaluate the molecular features and 311 carbon sequestration mechanism in the Amazonian Spodosols.

## 313 4. Conclusions

Conventional Fluorescence and TRLFS reveal differences in the molecular properties of humic fractions samples from Amazon soils with and without Cu(II) ions complexation. From of the use of fluorescence spectroscopy technique, a strong positive correlation was observed (r = 0.89) between humification index and EEM-CP/ PARAFAC components ratio for HA samples, demonstrating that the humification index (A<sub>465nm</sub>) is directly related on CII/CI ratio in these soils and increasing with depth, and besides, demonstrated the CII consisted by the OM more complex and humified. 321 The decay of the lifetime given by the time-resolved fluorescence, it was concluded that 322 static quenching is mostly probable in these soils. The results suggested lifetime  $(T_1)$  for 323 the HA and FA fractions may be related to the same origin of groups of chemical sites 324 as more humified characteristics determined by the fluorophore CII from EEM-CP/ 325 PARAFAC before interaction with Cu(II) ions. Besides, the complexation reaction of 326 Cu(II) metal with the FA fraction is dependent on the carbon amount present in the 327 SOM in these soils in which may be suggesting affect of the carbon persistence in these 328 Amazonian Spodosols. Moreover, this study highlights the possibility of employing 329 TRLFS since it stands out as an excellent spectroscopic indicator for soils' molecular 330 parameter.
