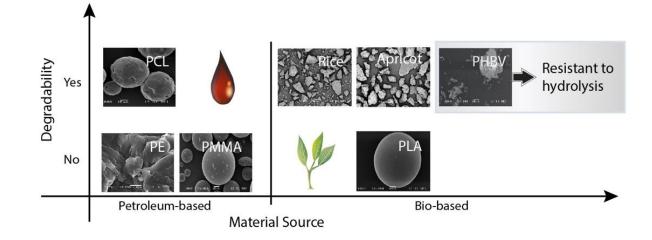
#### 28 Abstract:

29 Plastic microbeads have been produced at very large scales since several decades for cosmetics 30 and personal care products, a large amount of which being directly transported in the oceans. 31 To better understand their biodegradability in marine environment and evaluate their possible 32 replacement by biodegradable polymers, seven polymer types were studied including three conventional petroleum-based polymers (PE, PMMA and PCL), two bio-based polymers (PLA 33 and PHBV) and two natural products (rice seeds and apricot kernel). We used several 34 35 innovative approaches by both the experimental design and the set of multidisciplinary techniques to follow the successive steps of biodegradation together with abiotic degradation 36 37 under seawater conditions. Congruent signs of biodegradability were observed by oxygen 38 consumption, weight loss, and modification of molecular weight, <sup>1</sup>H NMR and mass spectrometry profiles. We found that microbeads made of PHBV, PCL, rice and in a lesser 39 40 extent apricot were biodegradable under our conditions, while not for microbeads made of PE, 41 PMMA and PLA. Taking into consideration of industrial application, PHBV could be the ideal 42 material to replace the conventional microbeads, since the material is resistant to hydrolysis, 43 but susceptible to microbial degradation, as shown by the <sup>1</sup>H NMR results. This study provides the first time arguments for the use of biodegradable substitutes to replace conventional 44 45 microbeads to support the recent legislative rules aiming to reduce the pollution by primary 46 microplastics in the oceans.

- 50 Highlights:
- The biodegradation of 7 polymers in the marine environment was investigated to 52 challenge their application as potential substitutes of the conventional microbeads used 53 in cosmetics and personal care products.
- Innovative 2-stepwise experiments were designed to mimic realistic marine conditions.
- The four biodegradation steps were characterized, including biodeterioration,
   biofragmentation, bioassimilation and mineralization.
- The biosourced PHBV is proposed as the best biodegradable polymer tested to replace
   the conventional microbeads.

#### 62 **1. Introduction**

63 Accumulation of plastics in the marine environment has been observed in ocean gyres, on beaches and in sediments worldwide [1]. The major source of plastic at sea arises from 64 mismanaged plastic waste and from riverine inputs [2]. Beside entanglement and ingestion of 65 66 macro debris by large vertebrates (birds, turtles etc.) [3], adverse effects on marine organisms 67 were particularly due to microplastics with proven transfer along the food chain [4]. Within microplastics, distinction has been made between small microplastics (25  $\mu$ m –1 mm) that can 68 69 be as abundant as large microplastics (1-5 mm) in the oceans [5]. Another distinction has been 70 made between "primary microplastics" purposefully manufactured to be of millimeter size (e.g. 71 microbeads and plastic pellets) and "secondary microplastic" that result from breaking down of 72 larger plastic pieces due to UV light, waves or abrasion [6].

73 Microbeads are primary microplastics commercially available in particle sizes ranging from 10 74 µm to 1 mm, which are used in hundreds of products, often as abrasive scrubbers, including 75 face washes, body washes, cosmetics, and cleaning supplies [7]. After use, microbeads included 76 in personal care products are poured down the drain and cannot be collected for recycling. 77 Wastewater treatment plant is generally not a sufficient solution to prevent microbeads 78 pollution [8]. Microbeads from personal care and cosmetics products could be a significant 79 source of microplastics pollution in the ocean [8–11]. It has been estimated that about 8 trillion 80 microbeads were emitted into aquatic habitats per day from the United States [7].

As an alternative way to relieve the problem, it has been also advised to replace the conventional
microplastic, generally made of polyethylene (PE) or polymethyl methacrylate (PMMA) by

biodegradable' microparticles. Biodegradable plastics can be petroleum-based polymers such
as polycaprolactone (PCL), or bio-based polymers (so-called 'biosourced') such as poly(Dlactide) (PLA) and polyhydroxyalcanoates (PHAs). Other natural compounds such as rice seeds
and apricot kernels have already been used as exfoliating material by some manufacturers and
are considered as bio-based polymers [12].

88 Most of scientific studies on plastic biodegradation were conducted under controlled laboratory 89 conditions by using soil or compost, but very few studies investigated the aquatic media and 90 especially the marine environment [13–15]. By now, few standard methods could be applied to 91 assess the biodegradability of plastics under marine conditions, but several scientists underlined 92 the drawbacks and biases of these methods [16-18]. Several authors underlined the need of 93 convergent results from combined approaches, including proof of mineralization by microorganisms together with tests of chemical structure alteration in order to conclude on the 94 biodegradability of a polymer [19,20]. Another concern is the necessity to mimic biological, 95 physical and chemical conditions of the marine environment during the tests. 96

97 The aim of this study was to test the biodegradability under marine conditions of bio-based 98 (PLA, PHBV, apricot kernels and rice seeds) and petroleum-based polymers (PCL), as 99 substitutes of conventional microbeads (PE, PMMA) for cosmetics. We used microbeads of 50 100 to 250 µm diameter, which were commercially available or laboratory-made by solvent 101 emulsion-evaporation technique. Biodegradability tests were performed in a two-steps protocol 102 including a first 2-months incubation of each polymer type with natural seawater communities, 103 followed by a transfer of the plastic together with its natural microbial biofilm to a marine

104 minimum medium with no other carbon source than the plastic for another 2-months. We 105 hypothesized that bio-sourced polymers may have a greater biodegradation capability 106 compared to petroleum-based polymers under marine conditions. Here, we combined different 107 methodological approaches including weight loss, continuous biological oxygen consumption 108 (optical fiber luminescent sensor), changes in molecular weight (high temperature size 109 exclusion chromatography), size and surface properties (laser diffraction particle size analyzer 110 and scanning electron microscopy), carbonyl index (Fourier transform infrared spectroscopy) 111 and release of oligomers (<sup>1</sup>H nuclear magnetic resonance spectroscopy and Liquid 112 Chromatography-High Resolution Mass Spectrometry).

#### 114 **2. Materials and Methods:**

#### 115 2.1. Production of petroleum-based and bio-based microbeads

116 The petroleum-based microbeads PE and PMMA were supplied by Good Fellow company 117 (Lille, France). Natural microparticles were manufactured by cryogrinding of the rice seeds (Rice Exfoliator 200, Lessonia, Saint Thonan, France) so called "rice" hereafter and apricot 118 119 kernels (Apricot Exfoliator 200, Lessonia, Saint Thonan, France) so called "apricot" hereafter. 120 PE, PMMA, rice and apricot were sieved in order to recover the microparticles for which the 121 diameter was ranging from 50 to 250 µm. 122 PCL (CAPA 6800, Perstorp Company, Sweden), PLA (7001D, Nature Works, Blair, USA) and PHBV (ENMAT Y1000P with a HV molar ratio of 3%, Tianan Biological Materials Co. Ltd., 123

124 China) were obtained as pellets and transformed in spherical microbeads by solvent emulsion-

125 evaporation technique (see Method S1 and Table S1 for material preparation of PCL, PLA and126 PHBV).

127 2.2. Microparticle characterization

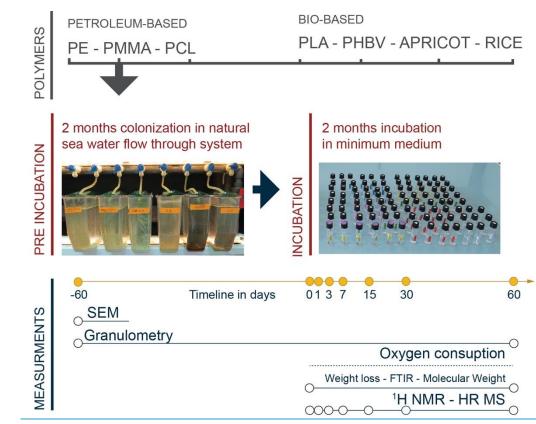
Microparticle surface morphologies were observed at the step of microbeads production by using a Jeol JSM-6031 scanning electron microscope (SEM). Prior to any observation, the fracture surfaces were coated with a thin gold layer by means of a Polaron sputtering apparatus.

131 2.3. Experimental setup

132 A two phases stepwise experiment was designed in order to evaluate the biodegradability of the 133 conventional petroleum-based and bio-based polymers under marine conditions (Fig. 1). The 134 first step consisted in the formation of a mature biofilm in natural seawater, as previously 135 described [21,22]. Briefly, each microparticle type (called "microbeads" hereafter) was 136 incubated for a period of 2-months in 1.8L aquarium (Sodispan, Spain) with direct circulation 137 to the sea. Seawater was pumped at 14 m depth in the Banyuls Bay close to the SOLA 138 observatory station of the Laboratoire Arago (SOLA station - NW Mediterranean Sea). A flow rate of 50 ml.min<sup>-1</sup> was chosen to ensure a sufficient renewal of natural bacteria (every 30 min) 139 140 and the surface outlet water was filtered at 50 µm. Each aquarium contained 12 grams of each 141 microbead types (PE, PMMA, PCL, PLA, PHBV, apricot and rice) added for a 2-months period. 142 Throughout the experiment, seawater temperature (between 18.3°C and 25.3°C) and salinity 143 (38.5) in the aquarium were similar to seawater from the Banyuls bay. 144 Second, about 10 mg of dry microbeads were transferred under sterile conditions to 4.9 mL

145 closed glass vials (Interchim, Montluçon, France) containing 2 mL of minimum medium (called

146 "MM" hereafter) with microbeads as sole carbon source (see Method S2 for MM composition). 147 Vials were incubated in the dark at 18°C under agitation at 110 rpm (orbital agitator) for a period 148 of 2 months (called "biotic condition" hereafter). In addition, controls were incubated and 149 sampled in the same way and consisted in triplicate vials containing 2 mL of MM with 150 microbeads of the same composition but previously sterilized overnight in 70% ethanol and 151 evaporation under UV sterile hood (called "abiotic condition" hereafter). A total of 130 vials 152 were needed to follow the different parameters detailed below in triplicate samples taken after 153 0,1, 3, 7, 15, 30 and 60 days of incubation (Fig. 1).

#### 163 2.4. Continuous oxygen measurement and biodegradation

164 During the second step of the experiment (Fig. 1), triplicate vials with each microbead type 165 were equipped with an optical fiber luminescent oxygen sensor (Presens, SP-PSt3-YAU) using 166 the instrument of Stand-alone Fiber Optic Oxygen Meter (Fibox 4, Germany). Oxygen sensors 167 were placed in the liquid phase to obtain the concentration of dissolved oxygen. Oxygen 168 concentration was manually measured daily in the abiotic (PE and PHBV) and biotic conditions 169 in minimum medium and oxygen was converted from mole concentration to total oxygen in 170 vial with the Henry's law (oxygen equilibrium confirmed between the two phases) and ideal 171 gas law. In the case of PHBV, vials were opened under a sterile laminar flow hood after 15 days 172 to ensure that oxygen was not limiting for bacterial growth and closed again. In this case, oxygen concentration was always maintained > 15  $\mu$ mol.L<sup>-1</sup> and the re-opening for 10 minutes 173 174 was enough to return to initial values (around 230 µmol.L<sup>-1</sup>). For all polymer types, biological 175 oxygen demand (BOD) was computed from the difference of oxygen concentration. The 176 consumption of oxygen in abiotic condition served as a negative control. The percentage of 177 biodegradation was expressed as the ratio of the oxygen consumption over the theoretical 178 amount of consumed oxygen for complete degradation (ThOD), as previously described [23].

179 2.5. Size change

180 The size distribution of the microparticles were measured at the beginning (D-60) and at the 181 end of the experiment (D60) (Fig. 1) with a laser diffraction particle size analyzer (Malvern 182 Mastersizer 2000 model with a Scirocco 2000 module) through granulometry analyses. The 183 particles were analyzed according to a model of spherical particles of polystyrene and according

- 184 to the Fraunhofer diffraction theory [24]. Each measurement was an average of 15 scans and
- 185 each sample was analyzed, thus providing the number, volume and length of the particles.

186 *2.6. Weight loss* 

187 Microbeads weight was measured on *D0* and *D60* of the incubation in MM in triplicates (Fig.
188 1). The pellet was washed twice with distillated water to remove salts with 1 min centrifugation
189 at 13000 rpm, then lyophilized and immediately weighed in analytical balance with the
190 precision of 0.1 mg (ENTRIS1241-1S, Sartorius).

191 2.7. Molecular weight

192 Molecular weight was determined for each polymer before colonization and at the end of the 193 incubation in MM (Fig 1). High temperature size exclusion chromatography (HT-SEC) 194 analyses were performed using a Viscotek system (Malvern Instruments) equipped with a 195 combination of three columns (Polefin 300 mm × 8 mm I. D. from Polymer Standards Service, 196 porosity of 1000 Å, 100 000 Å and 1 000 000 Å). Samples were dissolved in the mobile phase (tetrahydrofuran) with a concentration of 5 mg mL<sup>-1</sup> and 200  $\mu$ L of sample solutions were 197 injected and eluted in tetrahydrofuran using a flow rate of 1 mL min<sup>-1</sup> at 25 °C. The same 198 199 procedure was applied to polyethylene samples using 1,2,4-trichlorobenzene at 150 °C to 200 dissolve the sample and as mobile phase. The mobile phase was stabilized with 2,6-di(tertbutyl)-4-methylphenol (200 mg  $L^{-1}$ ). Online detection was performed with a differential 201 202 refractive index detector, a multichrom right angle light scattering detector, and a viscometer 203 detector. A universal calibration curve, obtained with polystyrene standards (Polymer Standards Service, Mainz, Germany) in the range of 0.5–7.106 kg mol<sup>-1</sup>, was used to calculate the molar
mass distribution of the samples. OmniSEC software version 5.12 (Malvern Panalytical, UK)
was used for the calculations. The typical evaluated accuracy for this technique is close to 10%.

207 2.8. Fourier Transform Infrared (FTIR) spectroscopy

208 Fourier Transform Infrared (FTIR) analyses were performed on microbeads on D0 and D60 of 209 the incubation in MM in biotic condition (Fig. 1). After collection, the supernatant was removed and samples were dried at  $60^{\circ}$  in an aerated oven until constant weight to eliminate trace of 210 water. FTIR measurements were carried out using a Nicolet<sup>TM</sup> 380 FT-IR (ThermoFisher 211 212 Scientific) in ATR (Attenuated Total Reflectance) mode. For each sample, the total amount of 213 microbeads (10 mg or less) was compressed against a diamond crystal with a constant force. FTIR spectra were collected using 16 scans from 4000 cm<sup>-1</sup> to 400 cm<sup>-1</sup>, with a resolution of 4 214 cm<sup>-1</sup>. To assess the variation between spectra, the characteristic absorption bands were realized 215 216 using Omnic Specta software (Thermo Fisher Scientific). For each polymer, manual assessment 217 of absorption band was done and compared to the literature. The calculations for carbonyl and 218 crystallinity index are detailed for each polymer in the supporting material (Table S2-8). 2.9. Characterization of the degradation products by <sup>1</sup>H NMR spectroscopy 219 <sup>1</sup>H NMR spectroscopy analysis were carried out to assess the release of degradation products 220 221 (oligomers) from microbeads as sole carbon source for the biofilms incubated in minimum

- medium for 0, 1, 3, 7, 15, 30 and 60 days in abiotic and biotic condition (Fig. 1). For each point,
- samples (microbeads + liquid media) were transferred to 2 mL Eppendorf tube and centrifuged
- to remove the microbeads. Supernatants (540  $\mu$ l) were supplemented with 60  $\mu$ L of a 2 mM

225 solution of TSPd<sub>4</sub> (sodium tetra deuterated tri methylsilyl propionate, Eurisotop) in deuterated water (D<sub>2</sub>O, Eurisotop). D<sub>2</sub>O signal was used for locking and shimming while TSPd<sub>4</sub> 226 227 constituted a reference for chemical shifts (0 ppm) and quantification. <sup>1</sup>H NMR spectra were 228 recorded on a Bruker Avance 500 MHz spectrometer, equipped with a 5 mm inverse-triple tuned (TXI) <sup>1</sup>H/<sup>13</sup>C/<sup>15</sup>N with z-gradient coil probe (Bruker Biospin Wissenbourg, France), with 229 5 mm-diameter tubes containing 600 µl of sample. 128 scans were collected (90° pulse, 3.24 s 230 231 acquisition time, 4.0 s relaxation delay, 4789.272 Hz SW, 65536 data points). Water signal was 232 eliminated by pre-saturation. An exponential filter was applied before Fourier transformation, 233 and a baseline correction was performed on spectra before integration. Under these conditions, 234 the limit of quantification is in the range of 0.01 mM. The relative quantity of oligomers was 235 expressed using the TSPd<sub>4</sub> as the reference.

236 2.10. Liquid Chromatography- High Resolution Mass Spectrometry

When detected by NMR spectroscopy, the degradation products were then identified by High Resolution Mass Spectrometry. The extracts were analyzed using Electrospray Ionization (ESI) with a Q-Exactive Orbitrap<sup>TM</sup> mass spectrometer (Thermo Scientific) providing a mass accuracy lower than 3 ppm and an ultra-high resolution over 100 000. Briefly, 5  $\mu$ l of supernatant from extracted samples were analyzed using positive and negative ion mode. The ion source and the capillary heater were set to operate at 3.2 kV and 320 °C. Nitrogen gas was used for nebulizing and as the damping and collision gas in the mass analyzer.

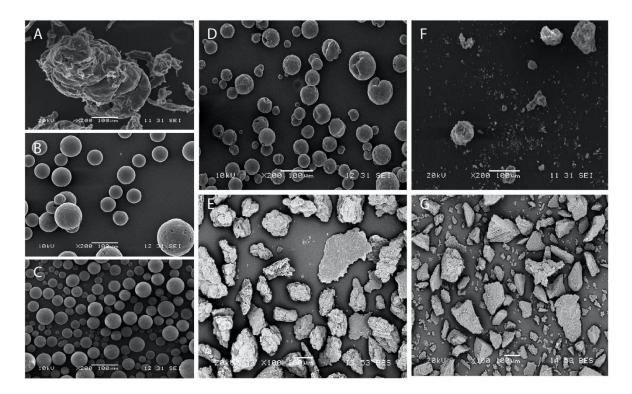

245 **3. Results** 

#### 246 *3.1. Temporal changes of microparticle sizes*

247 The SEM images of the raw particles showed significantly different size, sphericity and 248 roughness properties depending on how the material was obtained (Fig. 2). The production of 249 microbeads by cryo-grinding increased the roughness and the size distribution of particle 250 compared to the solvent emulsion-evaporation technique. Size distribution estimated by 251 granulometry for PLA, PCL and PHBV microparticles was centered approximately 100 µm 252 (median diameter between 88 and 126 µm depending on the types of bioplastics) (Table 1). The 253 PE microparticles were the largest with a median diameter around 280 µm. On the other hand, 254 those made of PMMA were the smallest since their median diameter is around 60 µm. Natural 255 microparticles made from rice or apricot had much more heterogeneous dimensions over a wide 256 range of sizes confirming SEM observations. The median diameter for these microparticles was 257 estimated to be around 120 and 160 µm, respectively.

After 2-months of incubation in natural seawater followed by 2-months incubation in minimum medium, sample aggregation was observed for most samples except for PHBV. No change of the size distribution was observed for the PMMA. For PLA and PE, values of the median diameter were similar. For rice, median diameter was higher after 4 months, with no smaller particles. For PCL, apricot and PHBV (Fig. S1), decreases of the median diameters were observed with the decrease of bigger particles.

#### 269 3.2. Temporal dynamic of oxygen consumption

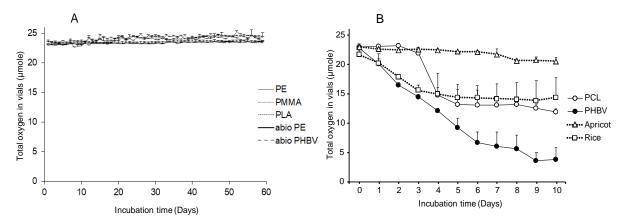




Fig. 3 Oxygen consumption (in µmole) after incubation in minimum medium with microbeads

270 The dissolved oxygen was recorded daily for the first 15 days for the triplicates. No oxygen 271 consumption was observed for abiotic control, as illustrated by PE and PHBV abiotic conditions 272 in Fig. 3A. In biotic condition, the continuous evolution of oxygen consumption by bacteria in 273 minimum medium with each polymer as sole carbon source showed different patterns according 274 to the polymer types. Polymers including PE, PMMA and PLA did not show any sign of oxygen 275 consumption. On the contrary, a drastic decrease of 19 µmole was observed for PHBV during 276 the first 10 days, PCL, Rice and Apricot also showed significant oxygen consumption of 11.1, 277 7.3, and 2.4 µmole for the same period, respectively (Fig. 3B). The biological oxygen demand 278 was then calculated for the first 10 days, before the first opening of the vials to avoid oxygen

279 limitation for PHBV in biotic conditions. being aware of the possibility of oxygen limitation 280 for PHBV. The percentages of biodegradation were  $4.1\pm0.4\%$  (average and standard deviation), 281  $1.0\pm0.1\%$ ,  $3.8\pm1.9\%$  and  $0.5\pm0.2\%$  for PHBV, PCL, rice and apricot, respectively. It has to be 282 noted that vials with rice became visually very turbid, which may affect the transmission of 283 luminescence and then underestimate the oxygen consumption and resulting percentage of 284 biodegradation. The two different oxygen consumption patterns have clearly classified the 285 materials into two groups: the degradable and non-degradable ones (Fig. 3).

294 *3.3. Weight loss* 

- 295 Weight loss measurement on *D0* and *D60* of the incubation in MM separated the polymers in 2
- 296 groups similar to those obtained by oxygen measurement (Table 1). No weight loss was found
- 297 on polymer for PE, PMMA and PLA. Apricot showed 5.9±8.8% of weight loss, when PCL,
- 298 PHBV showing about 17.8±7.2% and 17.0±6.1%. Rice had the highest weight loss with
  299 80.1±4.8%.
- 300 *3.4. Changes in the molecular weight*

Significant signs of degradation were only observed for PCL that showed a decrease by 30%
of average molecular weight (Mn) (from 33 000 to 23 000 g mol<sup>-1</sup>) and an increase of their
polydispersity index (1.7 to 2.0) that indicates a higher molecular weight dispersion (Table 1).
No significant change was found for PE, PMMA and PLA microbeads. Measurement of the
molecular weight was not applicable for the, PHBV, rice and apricot.

306 *3.5. Modification of the chemical properties* 

307 The composition of microbeads incubated under biotic conditions was controlled by FTIR after

308 2 months of incubation in MM. No biodegradability could be found for PE, PMMA and PLA

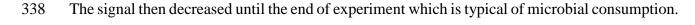
- 309 (Fig. S2-4). Moreover, the absence of characteristic carbonyl band at 1720 cm<sup>-1</sup> indicate that
- 310 PE microbeads did not undergo photodegradation.
- 311 The FTIR spectra of PCL microbeads showed a decrease of carbonyl index and a concomitant
- 312 increase of crystallinity index (Table1, Fig. S5). Such pattern is typical of ester bonds cleavage
- in amorphous region of the polymer chains and confirms the reduction of the molecular weight
- 314 of the polymer. Rice microbeads presented a spectrum characteristic of starch with specific

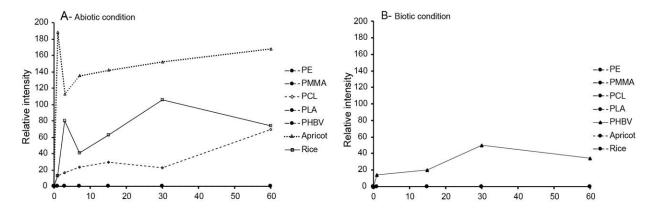
monosaccharides and polysaccharides signals (Fig. S6). The strong modification of the spectra over time revealed a transformation of starch constituent amylopectin, amylose into simple monomer of glucose (Fig. S7). The FTIR analysis of apricot microbeads presented a typical spectrum of lignocellulosic material. The spectra of these sample did not change over time, thus indicating a low transformation of the material as observed by weight loss measurements (Fig. S8). An increase of the crystallinity index was observed for PHBV samples, suggesting the possible cleavage of ester bonds in amorphous region of the polymer chains (Table 1, Fig. S9).

# 322 *3.6. Products release during the biodegradation*

323 Under abiotic conditions, <sup>1</sup>H NMR signal was detected only in the supernatant of PCL, rice and 324 apricot samples incubated in minimum media while no signal was recorded for the other 325 materials (Fig. 4A). This indicate the release of small molecular weight compounds from these 326 polymer matrixes in the aqueous medium when no biological process occurs. The extraction of 327 oligomers quickly started after incubation. The integration of the total NMR signal clearly 328 showed a gradual release of oligomers during the 60 days of incubation (Fig. 4A). By 329 comparison with the literature data, the signal attribution confirms the identification of short 330 chains of PCL oligomers and typical signal of carbohydrates such as glucose was observed for 331 the oligomers extracted from rice and apricot samples (Fig. S10 and Table S9). It is worth to 332 notice that oligomers from PCL, rice and apricot were not detected under biotic conditions, 333 suggesting an assimilation concomitant to their production. On the contrary, the PHBV 334 microbeads did not release any measurable oligomers under abiotic conditions but a signal was 335 recorded in presence of microorganisms, thus confirming the biotic degradation of polymers

336 (Fig. 4B). The release of oligomers (3-hydroxyvalerate, 3-hydroxybutyrate repeating unit)
337 started slowly after one day of incubation with microorganisms and increased up to 30 days.

#### 346 3.7. LC Orbitrap TM Mass Spectrometry

347 The oligomers detected in the supernatant were analyzed by mass spectrometry to identify their molecular composition. Analysis of PCL, rice and apricot supernatants confirmed the presence 348 349 of small molecular weight compounds corresponding to the abiotic degradation of the polymer 350 matrix into various size of oligomers (Fig. S11 and Table S10). Under abiotic conditions, the 351 ester hydrolysis of PCL generated caprolactone oligomers that were identified as monomer, 352 dimer and trimer of polycaproic acid oligomers. As well, the mass spectra obtained from rice and apricot supernatant provided a complex profile of low molecular weight compounds. 353 354 Carbohydrates and amino acids were detected in rice samples while degradation products from lignin and fatty acids were identified in apricot samples, resulting from the transformation of 355

the raw material by abiotic processes. Finally, the PHBV microbeads incubated with
microorganisms released various dimer/trimer units of hydroxy-butyrate and hydroxy-valerate.
In our conditions, PHBV microbeads were more sensitive to enzymatic cleavage than to abiotic
degradation processes.

#### 361 **4. Discussion**

362 4.1. An original multidisciplinary approach for the estimation of polymer biodegradability in
 363 the marine environment

Standard test procedures for estimating polymer biodegradability are commonly based on 364 365 measurements of biological O<sub>2</sub> demand or CO<sub>2</sub> consumption, which are giving indication on 366 the complete biomineralization of the material by microorganisms [17]. In this study, we 367 combined the standard test together with other methodologies in order (i) to confirm the 368 standard test results based on biomineralization processes and (ii) to give more insights on the 369 other steps involved in biodegradation that include also the biodeterioration, biofragmentation 370 and the bioassimilation of the polymers [25]. Physico-chemical and structural modification of 371 the microbeads and evidence of biodeterioration were assessed by granulometry, gravimetry 372 and FTIR spectroscopy and size exclusion chromatography, <sup>1</sup>H NMR and high-resolution mass 373 spectrometry were performed to identify degradation products (monomers and oligomers) in 374 biotic and abiotic conditions and then give information on the biofragmentation. Finally, <sup>1</sup>H 375 NMR analysis also showed the bioassimilation of the polymers. To our knowledge, this is the 376 first time that molecular analysis was used to identify the biofragmentation products (i.e.

oligomers) and their bioassimilation in polymer degradation by complex natural microbial communities. Here, we propose that NMR spectroscopy and mass spectrometry provide new and highly informative results on the molecular fragments of the polymers that can be generated during its biodegradation. Moreover, it brings a complementary information on direct assimilation of polymers by microorganisms, that are missing parameter in the classic methodological approaches which focus either on the growth of microorganisms or on the loss of material properties, thus addressing the biodeterioration with indirect processes.

384 While there is no harmonized indication today for the preparation of the microbial inoculum to 385 test its polymer biodegradation capabilities, convergent views indicated that incubation with 386 pre-selected isolated strains, as it is specified for regional standard tests [26,27], do not mimic 387 the large diversity of microorganisms living on plastics in the natural conditions, the so-called 388 'plastisphere' [28,29]. Complex natural marine inocula were adopted by two international 389 standards [30,31], where it is unfortunately indicated that the inocula could be stored for a 390 month at 4 °C, which drastically increase the possibility of a strong modification of the plastic-391 degrading community [32]. Another novelty of our study is to propose an original two-steps 392 protocol to test the polymer biodegradability by a natural mature biofilm. The first step of 393 formation of the mature biofilm was performed by incubating the polymer types in natural 394 seawater [21]. The second step is the biodegradability test, where the polymers with its mature 395 biofilm were transferred into a minimal medium with no other carbon source and energy. This 396 procedure is classically used to test the capability of microorganisms to degrade various organic

397 compounds or pollutants [33,34], but this is the first time that the complex biofilm community398 has been used for polymer degradation under marine condition.

Finally, another originality of our study is that no other feasibility study exists ranging from the bio-based and biodegradable microparticle design to the evaluation of its fate at sea. Most of the biodegradation study so far were using commercially plastics, mainly in the form of film [17,15] and to a less extent in powder [35,36], rarely in the form of microbeads. The successful use of cryogrinding and solvent emulsion-evaporation techniques showed that such approaches may be useful to conduct further studies on other polymer types or for the production of biodegradable substitutes to replace conventional microbeads [37–39].

406 4.2. Successive steps of biodegradability by complex marine bacterial communities for bio407 based and petroleum-based polymers

408 Our multidisciplinary approach provides the first evidence of the successive steps involved in 409 polymer biodegradation in seawater. These steps have been theoretically proposed by several 410 authors [18], but never evidenced before by a complementary set of techniques on the same 411 samples and by involving a complex mature biofilm grown under natural seawater conditions. 412 Here, we have highlighted a group of polymers including PCL, PHBV, apricot and rice showing 413 congruent signs of biodegradation, and another group made of PE, PMMA and PLA that gave 414 no sign of biodegradation under our conditions. We prove here that PCL, PHBV, rice and 415 apricot microbeads undergo a succession of physico-chemical transformation (as revealed by 416 FTIR) that lead to the biofragmentation of the material (weight loss, molecular weight) resulting 417 in the release of short length oligomers (mass spectrometry, <sup>1</sup>H NMR). Then, these 418 hydrosoluble compounds can be readily assimilated by the microorganisms (<sup>1</sup>H NMR) and 419 support the respiratory activity of the biofilm (BOD). This sequential process does not occur 420 for PE, PMMA and PLA microbeads, as no or slight oxidation can be initiated in our 421 experimental time frame.

422 Our results are congruent with other studies describing PHBV and PCL as biodegradable 423 polymers under natural conditions in soil [40,41]. Other studies found no sign of biodegradation 424 for PLA in freshwater [42]. PCL films were also found to present less biodegradability potential 425 in freshwater than under marine condition, probably due to very different bacterial communities 426 inhabiting these ecosystems [43].

Interestingly, we found that one of the bio-based polymers (PLA) did not fall into the group of biodegradable polymers and contrariwise, one of the petroleum-based polymers (PCL) showed clear signs of biodegradation. These counterintuitive results underline again that bio-based polymers does not necessary mean environmental degradable polymers, and inversely petroleum-based polymer does not necessary mean non-biodegradable products, as already mentioned elsewhere [16].

433 *4.3. A set of congruent results for each polymer type* 

434 *4.3.1. Biodegradation of PCL.* We found that the weight loss for PCL was 17.8% under our 435 experimental conditions. Besides, *Lu et al.* [44] found a weight loss around 18% for 2 month 436 period in natural seawater environment. Oxygen consumption confirmed the presence of 437 biodegradation, while an unusual behavior was observed for PCL, with a steep decrease of 438 oxygen concentration after 3 days (Fig. 3), which could be attributed to the modification of 439 bacteria community and/or the availability of the dissolved oligomers. The release of oligomers 440 in abiotic condition proved here that a slight hydrolysis of PCL occurred in seawater without 441 any other biological attack, which did not be realized by some other tests [42]. There was no signal captured by <sup>1</sup>H NMR for PCL in biotic condition, indicating the rapid utilization of the 442 443 oligomers released by abiotic processes and the presence of bioassimilation activity, which is 444 consistent with other evidence of biotic degradation of PCL in seawater by others [43, 45, 46]. Finally, the increase of crystallinity index from the FTIR results together with the reduction of 445 446 molecular weight confirmed the degradability of PCL in seawater.

4.3.2. Biodegradability of PHBV. In our conditions, PHBV showed a weight loss of 17% (2 447 448 month and a biodegradability of 4.1% (10 days). The weight loss was also reported for PHBV 449 with different degree of degradation. For instances, a study performed in natural seawater from 450 coastal France showed relatively lower value, with the 30% weight loss for a period of 6-months 451 for plastic film[35], the observed differences could result from the material size and shape. 452 During this study, <sup>1</sup>H NMR assay showed oligomer release only in biotic but not in abiotic 453 condition, thus making evidence of an efficient biofragmentation of PHBV by the marine 454 bacteria which was under or beyond their capability to assimilate the large amount of oligomer 455 produced. Thus, our research showed the stability of PHBV by the analysis of the released of 456 the oligomers (<sup>1</sup>H NMR). Abiotic degradation has not been observed under other seawater 457 conditions within 6 months incubation at 25°C by weight loss assay [47]. In addition, negligible 458 abiotic degradation (weight loss) was also found after 21 days under composting conditions at 459 60 °C [48]. Therefore, together with our results, PHBV could be described as quite resistant to moisture or abiotic attack. We also found an increase of crystallinity index that showed the
preference of the biofilm to attack amorphous region of the polymer, further proving previous
described results [49–51].

463 *4.3.3. Biodegradation of apricot and rice.* It is noteworthy that it was the first study which 464 performed the degradation test on the two natural materials in the marine environment. Both 465 the results of oxygen consumption and <sup>1</sup>H NMR confirmed its degradability in marine 466 conditions. Under abiotic condition, carbohydrates such as glucose was gradually released from 467 rice and apricot, and the released soluble carbohydrate fraction was readily assimilated by the 468 microorganisms. Previous studies on rice straw also showed a high biodegradation rate in the 469 soil and freshwater environments [52,53].

4.3.4. Other polymers. No sign of biodegradation was detected by our set of complementary
techniques for PE, PMMA and PLA. Beside their chemical structures and properties (carboncarbon bonds and/or crystallinity), the environmental conditions (relatively low temperature,
salinity, low nutrients and others) may also be a cause of limited degradation in seawater [54,55].
The lack of obvious oxidation of these polymers limit their fragmentation, the production of
intermediate products (< 1500 Da) and thus their assimilation by microbes in marine</li>
environment [18,56,57].

477 Our multidisciplinary techniques gave congruent results for the polymer biodegradability, 478 except for the aggregation problem from granulometry results probably due to the formation of 479 extracellular polymeric substances after the bacterial colonization [58]. It has been noticed that 480 PCL, rice and apricot could gradually release the oligomers, thus the weight loss measurement of the three polymers could be overestimated. With the complementary techniques, such as
 oxygen consumption and <sup>1</sup>H NMR results, etc. the three materials showed biodegradable in the
 marine environment.

484

#### 485 **5.** Conclusions

An increasing number of countries have implemented laws to restrict the production of microbeads over the world. We present here that, out of the seven materials, microbeads made of PHBV could be good candidate for substitution of conventional microplastics classically made of PE or PMMA, since the material is quite resistant to hydrolysis and susceptible to microbial degradation, as proved from this study.

491 Our study presented several novelties regarding its experimental design but also by the various 492 and complementary technologies used. We advise here that not only respirometry tests 493 classically used in standard tests, but rather a multidisciplinary approach reflecting the 4 steps 494 of biodegradation should be considered for further studies dealing with the biodegradability of 495 polymers in the environment. It includes other banned single-used plastics such as plastic bags, 496 straws, disposable dishes, cotton swabs (such as Q-tips) and coffee stirrers.

We also underlined that clear distinction should be made with bio-based polymers that may not be biodegradable (such as PLA), when less sustainable substitute materials showed clear signs of biodegradation at sea (such as the petroleum-based PCL). Finally, further studies are needed to evaluate the toxicity of the polymers and their degradation products, as well as the release of additives generally supplemented by manufacturers in the microplastic composition.
