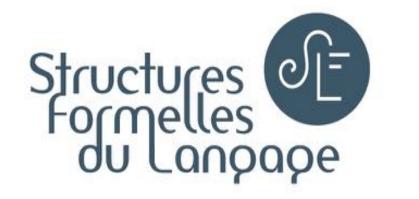

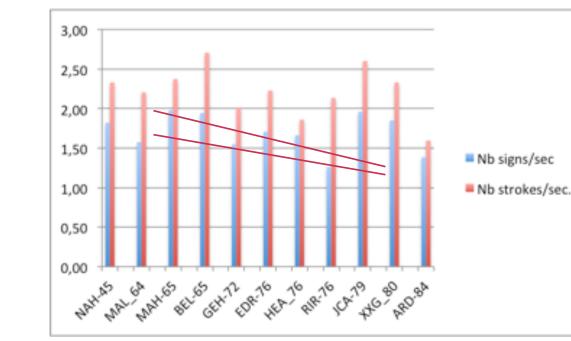

3. Measures and avenues of investigation

From the literature we know

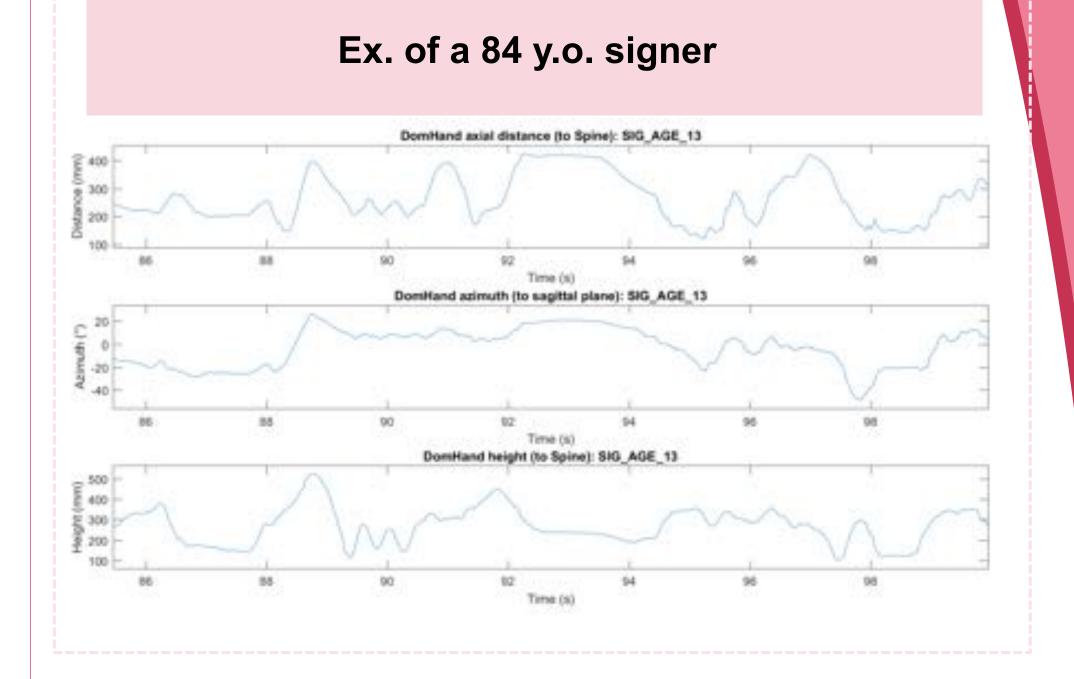
- ✓ Older people (+65y.) commonly present a loss of hand strength / use gestures with reduced amplitude (Carmeli et al. 2003)
- ✓ Speech rate is vulnerable to the aging process (Duchin & Mysak 1987)
- ✓ There is a correlation between an increase in age and longer mean sign duration (Börstell et al. 2016)
- ✓ Motion capture allows for more abstract movement descriptors to be extracted and

1) Which impact of ageing on the prosody of LSF?

□ With a focus on signing rate

- □ A collection of interactions between or with older deaf signers in LSF
- □ Testing mocap systems
 - □ 3D data to complement analysis on the basis of 2D
 - □ a step forward to get semi-automatic annotation

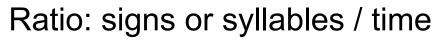
2. Method and data

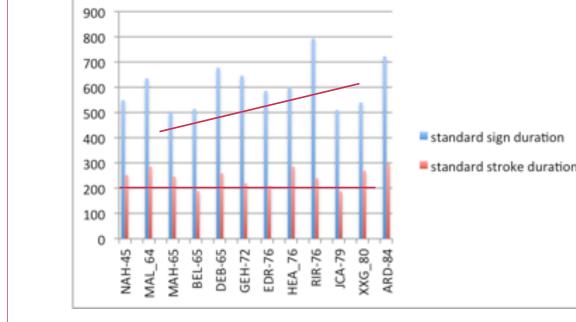
We adopted an articulatory ('phonetic') and data-based perspective Considering prosodic patterns that result from the combination of movements of manual and non-manual articulators

(Wilbur 2009, Crasborn & van der Kooij 2013)

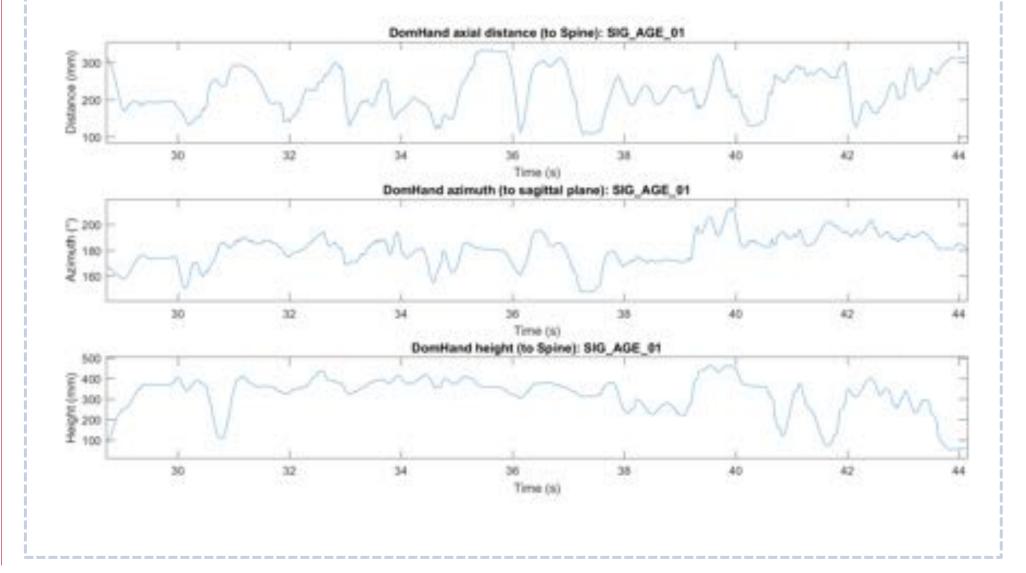

We adapted our recording protocol from CorpAGEst (Bolly & Boutet 2018)

Sign and stroke standard duration

1) We noted

- \checkmark variations in rate within the older group (65 vs 84 y.o) and between older and young adult signers
- \checkmark the stroke duration (vs sign duration) remains relatively stable about 0.25sec (Wilbur & Nolen 1986)
- \checkmark the variation stems from the
- \checkmark relatives or friends as interviewers
- ✓ 6 10 min interviews
- \checkmark themes of the evolution of transport, access to care, culture and new technologies

duration and nature of transitions

Frequency of body mvts as a marker?

2) The use of a motion capture system

- \checkmark is feasible with older signers
- \checkmark allows us to complement video data and to connect signing rate, range of motion as measurements of prosodic characterization for the older signers' production
- \checkmark offers avenues of investigation by illustrating that the recorded older signers
 - \checkmark are making fewer movements than the recorded younger ones
 - ✓ have a more contrasted, less homogeneous manual amplitude than younger ones
 - \checkmark make more held movements than younger ones
 - \checkmark raise their hands as high as younger ones, but don't stay high as long

4. In Progress

♦ Short term: to complete annotations and measures for the older corpus and younger data for comparison, and relevance of each marker.

Perception Neuron (Inertial Measurement Unit sensors), to measure acceleration and relative position differences on xyz axis

 Semi-automatic detection of pauses or holds on mocap data and a finer analysis of articulation adjustment of older signers

◆ Longer term: to study (i) the linguistic specificities in the productions collected in interaction (speech turn, signing space, lexical and morphosyntactic variations, prosody in LSF), (ii) the possible markers of aging, whether ordinary or disturbed, in connection with existing studies on the articulatory manifestations of language or cognitive disorders (Tyrone & Woll, 2008; Tyrone, 2014) and (iii) adaptive strategies of older signers.
