# Non trivial zeros of the Zeta function using the differential equations

#### Abstract

In this paper, we investigate a relation between the differential equations and the non trivial zeros of the Zeta function.

### 1 Main result

Consider the representation of the Riemann Zeta function  $\zeta$  defined by the Abel summation formula [[1], page 14 Equation 2.1.5] as

$$\zeta(s) := -\frac{s}{1-s} - s \int_{1}^{+\infty} \frac{\{t\}}{t^{1+s}} dt, \quad \Re(s) \in (0,1), \quad \Im(s) \in \mathbb{R}^*, \tag{1}$$

where  $\{t\}$  is the fractional part of the real t. Define the non trivial zeros of the function  $\zeta$  in the following sense

**Definition 1.** Let be  $s \in \mathbb{C}$ . We say that s is a non trivial zero of the function  $\zeta$  if

$$|\zeta(s)| = 0$$
 and  $\Re(s) \in (0,1)$ ,  $\Im(s) \in \mathbb{R}^*$ .

**Theorem 2.** [Riemann hypothesis] Let  $s \in \mathbb{C}$  be a non-trivial zero of the function  $\zeta$ . Then  $\Re(s) = \frac{1}{2}$ .

# 2 Main Proposition

For every  $r \in (0,1)$  and  $\tau \in \mathbb{R}^*$  the Equation (1) implies,

$$\frac{\zeta(r+i\tau)}{r+i\tau} = -\frac{1}{1-r-i\tau} - \int_{1}^{+\infty} u^{-i\tau-1-r} \{u\} du.$$

The aim is to studies the differential equation of solutions the functions

$$t\mapsto \psi_{\tau,r}(z,t):=t^{r+i\tau}\Big[z+\int_1^t u^{-i\tau-1-r}\{u\}du\Big],\quad z\in\mathbb{C},\ t\geq 1.$$

We focus only on the bounded solutions (there is a unique bounded solution. All other solutions are oscillating and diverge to infinity in norm). More precisely, the strategy to prove the Theorem 2, is to prove that  $\sup_{t\geq 1} |\psi_{\tau,r}(\frac{1}{1-r-i\tau},t)| < +\infty$  implies  $r=\frac{1}{2}$ . In other words  $|\frac{\zeta(r+i\tau)}{r+i\tau}|=0$  implies  $r=\frac{1}{2}$ .

For every  $\tau \in \mathbb{R}^*$  and  $r \in (0,1)$  we consider the following differential equation

$$\frac{d}{dt}x = (r+i\tau)\frac{x}{t} + \frac{1}{t}\{t\},$$

$$t \in \mathbb{R}_+/\mathbb{N}, \quad x(1) = \frac{1}{1-r-i\tau}, \quad x: [1,+\infty) \to \mathbb{C}.$$
(2)

**Lemma 3.** For every  $\tau \in \mathbb{R}^*$  and  $r \in (0,1)$  there exists a unique continuous solution  $\psi_{\tau,r}(t): [1,+\infty) \to \mathbb{C}$  of the differential equation (2). Further,

$$\psi_{\tau,r}(t) = t^{r+i\tau} \int_0^t u^{-i\tau - 1 - r} \{u\} du, \quad \forall t \ge 1.$$

*Proof.* Let be  $r \in (0,1)$  and  $\tau \in \mathbb{R}^*$  fixed. Since  $\{u\} = u$  for every  $u \in (0,1)$  then

$$t^{r+i\tau} \int_0^t u^{-i\tau-1-r} \{u\} du = \frac{t}{1-r-i\tau}, \quad \forall t \in [0,1].$$

Since  $0 \le \{u\} \le 1$  for every  $u \ge 1$  then the function

$$t \mapsto t^{r+i\tau} \int_0^t u^{-i\tau - 1 - r} \{u\} du,$$

is continuous and  $C^1$  on  $\mathbb{R}_+/\mathbb{N}$ . The Equation (2) is a non-homogeneous linear differential equation. The unique continuous solution  $\psi_{\tau,r}(t):[1,+\infty)\to\mathbb{C}$  such that  $\psi_{\tau,r}(1)=\frac{1}{1-r-i\tau}$  is given by

$$\psi_{\tau,r}(t) = t^{r+i\tau} \int_0^t u^{-i\tau - 1 - r} \{u\} du, \ \forall t \ge 0.$$

**Proposition 4.** Let be  $\tau \in \mathbb{R}^*$  and  $r \in (0,1)$ . Consider the continuous solution  $\psi_{\tau,r}(t): [1,+\infty) \to \mathbb{C}$  of the differential equation (2). Suppose that  $\sup_{t\geq 1} |\psi_{\tau,r}(t)| < +\infty$ , then  $r = \frac{1}{2}$ .

Notation 5. Denote

$$p(t) := \int_0^t \left( \{u\} - \frac{1}{2} \right) du, \quad \forall t \ge 0,$$

where we recall that  $\{u\}$  is the fractional part of the real u.

**Lemma 6.** The function p is a continuous 1-periodic function and  $\max_{t \in [0,1]} |p(t)| \leq \frac{1}{2}$ .

*Proof.* The function  $u \mapsto \{u\}$  is 1-periodic, then there exists a continuous 1-periodic function  $p : \mathbb{R} \to \mathbb{R}$  such that

$$\int_0^t \{u\} du = t \int_0^1 \{u\} du + p(t), \quad \forall t \ge 0.$$

Since

$$\int_0^1 \{u\} du = \int_0^1 u \ du = \frac{1}{2},$$

we get

$$\int_0^t \{u\} du = t\frac{1}{2} + p(t), \quad \forall t \ge 0.$$

We have

$$\max_{t \in [0,1]} |p(t)| \leq \max_{t \in [0,1]} \Big| \int_0^t \Big(\{u\} - \frac{1}{2}\Big) du \Big| \leq \frac{1}{2}.$$

More precisely, the function p is a piecewise  $C^{\infty}$ , continuous on  $\mathbb{R}$  and 1-periodic. By Dirichlet Theorem, the Fourier series

$$n \mapsto \sum_{k=-n}^{n} a_k \exp(ik2\pi t),$$

converge uniformly on  $\mathbb{R}_+$  to the function  $t \mapsto p(t)$ , where  $(a_k)_k \subset \mathbb{C}$  are the Fourier coefficients of the function p.

$$\int_0^t \left( \{v\} - \frac{1}{2} \right) dv = \sum_{j \in \mathbb{Z}} a_j \exp(ij2\pi t), \quad \forall t \ge 0.$$

By definition of the Fourier coefficients we have

$$a_{j} = \int_{0}^{1} \exp(-ij2\pi u) \left( \int_{0}^{u} \left( \{v\} - \frac{1}{2} \right) dv \right) du$$
$$= \frac{1}{2} \int_{0}^{1} \exp(-ij2\pi u) u(u - 1) du = \frac{1}{(2j\pi)^{2}}, \quad \forall j \in \mathbb{Z}^{*},$$

and

$$a_0 = \frac{1}{2} \int_0^1 u(u-1)du = -\frac{1}{12}.$$

The function p satisfies

$$p(t) = \sum_{j \in \mathbb{Z}^*} \frac{1}{(j2\pi)^2} \Big( \exp(ij2\pi t) - 1 \Big), \quad \forall t \ge 0.$$

**Lemma 7.** Let be  $\tau \in \mathbb{R}^*$  and  $r \in (0,1)$ . Let  $\psi_{\tau,r}(t) : [1,+\infty) \to \mathbb{C}$  be the continuous solution of the differential equation (2). Suppose that  $\sup_{t>1} |\psi_{\tau,r}(t)| < +\infty$ . Then

$$\left| \psi_{\tau,r}(t) + \frac{1}{2} \frac{1}{r + i\tau} \right| < \frac{|1 + r + i\tau|}{1 + r} t^{-1}, \ \forall t > 1.$$

*Proof.* Let be  $r \in (0,1)$  and  $\tau \in \mathbb{R}^*$  fixed. By Lemma 3

$$\psi_{\tau,r}(t) = t^{r+i\tau} \int_0^t u^{-i\tau - 1 - r} \{u\} du, \quad \forall t > 0.$$
 (3)

Suppose that

$$\sup_{t\geq 1} |\psi_{\tau,r}(t)| < +\infty.$$

Since

$$\sup_{t \ge 1} |\psi_{\tau,r}(t)| < +\infty \implies \Big| \int_0^{+\infty} u^{-i\tau - 1 - r} \{u\} du \Big| = 0,$$

then

$$\int_0^t u^{-i\tau - 1 - r} \{u\} du = - \int_t^{+\infty} u^{-i\tau - 1 - r} \{u\} du, \quad \forall t > 1.$$

Equation (3) can be written as

$$\psi_{\tau,r}(t) = -t^{r+i\tau} \int_{t}^{+\infty} u^{-i\tau - 1 - r} \{u\} du, \quad \forall t > 1.$$
 (4)

Consider the function p given in the Notation 5. By Lemma 6, the function p is 1-periodic, then it is bounded. Use the integration part formula in Equation (4),

$$\psi_{\tau,r}(t) = -\frac{1}{2} \frac{1}{r + i\tau} - (i\tau + 1 + r)t^{i\tau + r} \int_{t}^{+\infty} u^{-i\tau - 2 - r} \Big( p(u) - p(t) \Big) du,$$

Since

$$|p(u) - p(t)| < 1, \quad \forall u \ge t > 1,$$

we obtain

$$\left| \psi_{\tau,r}(t) + \frac{1}{2} \frac{1}{r + i\tau} \right| < |1 + r + i\tau| t^r \int_t^{+\infty} u^{-2-r} dt dt = \frac{|1 + r + i\tau|}{1 + r} t^{-1}.$$

Proof of the Proposition 4. Let be  $r \in (0,1)$  and  $\tau \in \mathbb{R}^*$ . For every  $n \geq 1$ , use the change of variable

$$\psi_{\tau,r,n}(t) := (r+i\tau)\psi_{\tau,r}(\exp(t)) - \frac{r+i\tau}{1-r-i\tau} \exp(t) - n, \quad \forall t \in \left[\ln(n), \ln(n+1)\right].$$

Use the fact  $\{u\} = u - n$  for every  $u \in [n, n + 1)$ . The Equation (2) implies

$$\frac{d}{dt}\psi_{\tau,r,n}(t) = (r+i\tau)\psi_{\tau,r,n}(t), \quad \forall t \in \Big[\ln(n), \ln(n+1)\Big).$$

Integrate,

$$\psi_{\tau,r,n}(\ln(n+1)) = \left(\frac{n+1}{n}\right)^{r+i\tau} \psi_{\tau,r,n}(\ln(n)), \quad \forall n \ge 1.$$

Use the fact

$$\Pi_{k=1}^n \left(\frac{k+1}{k}\right)^{r+i\tau} = (n+1)^{r+i\tau}, \quad \forall n \ge 1.$$

We obtain

$$\Pi_{k=1}^n \psi_{\tau,r,k}(\ln(k+1)) = (n+1)^{r+i\tau} \Pi_{k=1}^n \psi_{\tau,r,k}(\ln(k)), \quad \forall n \ge 1.$$

Then

$$\Pi_{k=1}^{n} |\psi_{\tau,r,k}(\ln(k+1))|^{2} = (n+1)^{2r} \Pi_{k=1}^{n} |\psi_{\tau,r,k}(\ln(k))|^{2}, \quad \forall n \ge 1.$$
 (5)

By definition of  $\psi_{\tau,r,n}$ , for every  $n \geq 1$  we have

$$\psi_{\tau,r,k}(\ln(k+1)) = (r+i\tau)\psi_{\tau,r}(k+1) - \frac{r+i\tau}{1-r-i\tau}(k+1) - k$$
$$= (r+i\tau)\psi_{\tau,r}(k+1) - \frac{r+i\tau}{1-r-i\tau}(k+1) - k$$
$$= \psi_{\tau,r,k+1}(\ln(k+1)) + 1, \quad \forall k \ge 1.$$

The Equation (5), implies

$$\Pi_{k=1}^{n-1}|\psi_{\tau,r,k+1}(\ln(k+1))+1|^2=n^{2r}\Pi_{k=1}^{n-1}|\psi_{\tau,r,k}(\ln(k))|^2,\quad\forall n\geq 2,$$

in other words

$$\Pi_{k=2}^{n} |\psi_{\tau,r,k}(\ln(k)) + 1|^{2} 
= n^{2r} |\psi_{\tau,r,1}(0)|^{2} \Pi_{k=2}^{n-1} |\psi_{\tau,r,k}(\ln(k))|^{2}, \quad \forall n \ge 3.$$
(6)

Since

$$\psi_{\tau,r}(1) = \frac{1}{1 - r - i\tau},$$

and by the definition of  $\psi_{\tau,r,n}$  we get

$$\psi_{\tau,r,1}(0) = -1$$

The Equation (6) implies

$$\Pi_{k=2}^{n} |\psi_{\tau,r,k}(\ln(k)) + 1|^2 = n^{2r} \Pi_{k=2}^{n-1} |\psi_{\tau,r,k}(\ln(k))|^2, \quad \forall n \ge 3,$$

equivalent to

$$\Pi_{k=2}^{n} k^{-2r} |\psi_{\tau,r,k}(\ln(k)) + 1|^2 = \Pi_{k=2}^{n-1} k^{-2r} |\psi_{\tau,r,k}(\ln(k))|^2, \quad \forall n \ge 3.$$
 (7)

Then for every  $m > n \ge 3$  we get

$$\Pi_{k=n+1}^m k^{-2r} |\psi_{\tau,r,k}(\ln(k)) + 1|^2 = \Pi_{k=n}^{m-1} k^{-2r} |\psi_{\tau,r,k}(\ln(k))|^2.$$

For every  $m > n \ge 3$  we have obtained

$$\Pi_{k=n}^{m-1} \left(\frac{k}{k+1}\right)^{2r} |\psi_{\tau,r,k+1}(\ln(k+1)) + 1|^2 = \Pi_{k=n}^{m-1} |\psi_{\tau,r,k}(\ln(k))|^2.$$
 (8)

Suppose that  $\sup_{t\geq 1} |\psi_{\tau,r}(t)| < +\infty$ . By The Lemma 7 we have

$$\left| (r+i\tau)\psi_{\tau,r}(t) + \frac{1}{2} \right| < \frac{|1+r+i\tau|^2}{1+r}t^{-1}, \ \forall t > 1.$$

By the definition of  $\psi_{\tau,r,k}$ , we obtain

$$\left| \psi_{\tau,r,k}(\ln(k)) + \frac{1}{2} + \frac{k}{1 - r - i\tau} \right| < \frac{|1 + r + i\tau|^2}{1 + r} \frac{1}{k}, \quad \forall k \ge 1,$$

Which can be written as

$$\psi_{\tau,r,k}(\ln(k)) = -\frac{1}{2} - \frac{k}{1 - r - i\tau} + \frac{1}{k}\theta_{\tau,r,k}, \quad \forall k \ge 1,$$

where

$$\theta_{\tau,r,k} := k\psi_{\tau,r,k}(\ln(k)) + \frac{k}{2} + \frac{k^2}{1 - r - i\tau}, \quad \forall k \ge 1,$$

and satisfies

$$|\theta_{\tau,r,k}|<\frac{|1+r+i\tau|^2}{1+r}, \quad \forall k\geq 1.$$

For every  $m > n \ge 3$ , the Equation (8) implies

$$\Pi_{k=n}^{m-1} \left(\frac{k}{k+1}\right)^{2r} \left| \frac{k+1}{1-r-i\tau} - \frac{1}{2} - \frac{\theta_{\tau,r,k+1}}{k+1} \right|^{2} \\
= \Pi_{k=n}^{m-1} \left| \frac{k}{1-r-i\tau} + \frac{1}{2} - \frac{\theta_{\tau,r,k}}{k} \right|^{2}.$$

Use the fact  $m > n \approx +\infty$  implies

$$\frac{\prod_{k=n}^{m-1} \left| k + 1 - \frac{1}{2} (1 - r - i\tau) - \frac{1}{k+1} \theta_{\tau,r,k+1} (1 - r - i\tau) \right|^2}{\prod_{k=n}^{m-1} u_{r,k}} \approx 1,$$

$$\frac{\prod_{k=n}^{m-1} \left| k + \frac{1}{2} (1 - r - i\tau) - \frac{1}{k} \theta_{\tau,r,k} (1 - r - i\tau) \right|^2}{\prod_{k=n}^{m-1} v_{r,k}} \approx 1,$$

where

$$u_{r,k} := (k+1)^2 - (1-r)(k+1),$$
  
 $v_{r,k} := k^2 + (1-r)k, \quad \forall k \ge 3.$ 

We get

$$m > n \approx +\infty \implies \prod_{k=n}^{m-1} \left(\frac{k}{k+1}\right)^{2r} u_{r,k} \approx \prod_{k=n}^{m-1} v_{r,k}$$

Which is satisfied if

$$\sup_{m>n>>1} \left| \Pi_{k=n}^{m-1} \left( \frac{k}{k+1} \right)^{2r} u_{r,k} - \Pi_{k=n}^{m-1} v_{r,k} \right| = 0.$$

We deduce that  $r = \frac{1}{2}$ .

Remark 8. In the previous Proof, by the notation

$$S_{\tau,r}(n) = \prod_{k=2}^{n} \frac{\psi_{\tau,r,k}(\ln(k))}{\psi_{\tau,r,k}(\ln(k)) + 1}, \quad n \ge 2.$$

remark that

$$\psi_{\tau,r,n+1}(\ln(n+1)) + 1 = \psi_{\tau,r,n}(\ln(n+1)) = -(n+1)^{r+i\tau} S_{\tau,r}(n).$$

We get

$$S_{\tau,r}(n+1) = \frac{(n+1)^{r+i\tau} S_{\tau,r}(n) + 1}{(n+1)^{r+i\tau} S_{\tau,r}(n)} S_{\tau,r}(n).$$

In other words,

$$S_{\tau,r}(n+1) = \frac{1}{(n+1)^{r+i\tau}} + S_{\tau,r}(n),$$

we obtain the Riemann series

$$S_{\tau,r}(n) = S_{\tau,r}(2) - 1 - \frac{1}{2^{r+i\tau}} + \sum_{k=1}^{n} \frac{1}{k^{r+i\tau}}.$$

## 3 Proof of the Theorem 2

Proof of the Theorem 2. Let be  $x \in (0,1)$  and  $\tau \in \mathbb{R}^*$ . Suppose that  $|\zeta(x+i\tau)| = 0$ . By the Equation (1) we have,

$$\frac{\zeta(x+i\tau)}{x+i\tau} = -\int_0^{+\infty} u^{-i\tau-1-x} \{u\} du.$$

Then

$$\left| \int_0^{+\infty} u^{-i\tau - 1 - x} \{u\} du \right| = 0.$$

**Implies** 

$$\int_0^t u^{-i\tau - 1 - x} \{u\} du = -\int_t^{+\infty} u^{-i\tau - 1 - x} \{u\} du, \quad \forall t \ge 1.$$

$$\sup_{t\geq 1} \left| t^{x+i\tau} \int_0^t u^{-i\tau-1-x} \{u\} du \right| = \sup_{t\geq 1} \left| t^{x+i\tau} \int_t^{+\infty} u^{-i\tau-1-x} \{u\} du \right|$$

$$\leq \sup_{t\geq 1} \left[ t^x \int_t^{+\infty} u^{-1-x} du \right] \leq \frac{1}{x}. \tag{9}$$

Let  $\psi_{\tau,x}(t):[1,+\infty)\to\mathbb{C}$  be the unique continuous solution of the differential equation (2). By Lemma 3 and the Equation (9) we have,

$$\sup_{t\geq 1} |\psi_{\tau,x}(t)| < +\infty,$$

Thanks to the Main Proposition 4 we get  $x = \frac{1}{2}$ .
