France and the British Isles from 1640 to 1789

Introduction

Among many, one of the Atlantic history's achievements has been to reconnect the metropolis to their colonial territories. There is still much work to be done, notably in France where the scholarship has for long been divided between the ancient regime specialists and the colonial historians. John Pocock's *Atlantic Archipelago* has been instrumental in the creation of a new British history, which looks out to the open seas. But in retrospect, the Atlantic turn also helps to form a new understanding of the relations between France and Britain. The notion of otherness that has been famously used by Linda Colley to describe the Anglo-British enmities was first used to describe relations between the Europeans and non-Europeans in a colonial context. Furthermore, connected and transnational histories that have been applied to the Atlantic are now put to good use to Franco-British case. Comparisons between bordering regions appear to be at least as significant as national entities. The growth of a more European outlook is also having an impact on the old Franco-British couple. Relocated in a wider continental context, their relations are no longer described as the long and straight duel dating back from the Middle Age. As the limits of a strictly national approach became more apparent, more attention has been dedicated to the cultural transfers and the multifaceted circulation of individuals and knowledge. While the existence of hostile sentiments was beyond doubt, there was a wide gamut of transactions that united the French, the English, the Irish, and the Scottish in one way or another. As for the large time span, it starts with two major political upheavals, the first British Revolution and the Fronde and ends with the Industrial and the French Revolutions, the famous "dual Revolution" vindicated by E. Hobsbawm, which could be felt from both sides of the English Channel up to the French Revolution. Although 1640 and 1789 are no longer seen as definitive watershed, they still constitute a convenient time frame to elaborate on a very dynamic subject.

General Overview

For a general and long-lasting reflection on comparative history, one can start with the pioneer work by [Bloch 2011](#) and then much later with the collective initiative of both French and British historians around [Bédarida, et al. 1979](#). Inspired by the latter, [Genet and Ruggiu 2007](#) provides some recent contributions on the Franco-British exchange from the middle ages to the 1960s. The paradigm of the "Second Hundred Years War" is amply commented and criticized by [Scott 1992](#) and [Crouzet 1996](#). An emblematic symbol of both the interactions and hostilities between France and Britain, the significance of the English Channel has been reconsidered by [Morieux 2016](#). It demonstrates that the strength of local and provincial identities shared from both sides of the channel were not made redundant by the slow creation of a national and maritime border. While [Colley 1992](#) clearly demonstrates the birth of a British national sentiment against the French, [Conway 2011](#) inserts the relations between France and Britain into a wider European perspective. Against a gradualist or even a "glacialist" view of the Ancien Régime, [Jones and Wharman 2002](#) provides a culturalist approach stressing the reality of the revolutionary transformations that took place after 1750 in both countries.

Primary Sources

There is a considerable number of printed sources that deals with the subjects. The [Voltaire Foundation](#) has been involved in a long-last critical edition of an emblematic author. [Kekewich 1994](#) is a very useful anthology with a vast quantity of documents on political and social history. Some other anthologies deal with more specific field such as the history of science ([Bret, et al. 2010](#)) and the Huguenots ([Barrell 1989](#)). Travel literature has been too often used to provide plenty of quotations to support arguments on the xenophobic or cosmopolite nature of the English. Although much dated, the edition of emblematic Young's travels by [Betham-Edwards 1889](#) is now accessible on Gallica. More closely contextualized and with much caution, travel narratives could be useful, mostly from a literary perspective. On a good presentation of travel writing, see, for example, [Bohls, et al. 2005](#). Cartoons and prints have been also mobilized extensively to make similar points on Francophobia or to provide illustrative material. When closely studied, they could offer more. [Dupuy 2002](#) offers an interesting case study on the representation of Calais.

Franco-British Comparative Histories

The comparison between the two political systems was already widespread in the 18th-century. In the 20th century, Marc Bloch demonstrated the need for more scholarly comparisons. At first, they concerned the fields of social and economic history, in peculiar during the 1960s and 1970s around the notions of “first industrialization” or the so-called 18th-century agricultural revolution. From the 1980s and 1990s onward, various European comparative research programs were financed to reconstitute the origins of the modern state, and this led to the rehabilitation of a comparative political history. At first, this initiative did not meet much scrutiny from the British historians who were mostly focused on the emerging Atlantic history. Then in the 2000s, new historical Britain and France work appeared that better captured the negotiation processes that took place around obtaining consent and the various geographical scales through which political power is enacted or contested.

Embracing National Legacies

Proponents of a global history may be accused of underestimating the strength of their own national background. Ideas are not conceived in the air. As [Richter 2006](#) suggests, 18th-century contemporaries were already much involved in establishing Franco-British juxtaposition from their own philosophical point of view. Circulation of ideas were then already hindered by patriotic bias. A similar point can be made in the current historiographies where national identity and disciplinary legacies affect the circulation of topics and notions ([Cosandey and Descimon 2002](#); [Poncet 2010](#); [Meyzie 2017](#)). Some major political upheavals were treated very differently in the English and the French historians, the latter developed their own singular interpretation of the 17th-century British revolutions as seen by the French ([Jettot 2012](#)) while [Davis 2015](#) suggests a different take on the popular political contestations from what it has been argued before.

Comparisons between Political Systems: Monarchies and States

Respective historiographical legacies in Britain and France have an impact on comparative practices. [Asch 2015](#) provides a useful starting point as its approach is strongly influenced by the "Baroque state." A notion that was very influential in the English historical literature, nobly since Lewis Namier. [Genet 1997](#) offers a view on the British and French states in a European frame with the two comparative research programs concerning the modern state's genesis and the origins of the modern state. They stressed the major and mutual interplays between war, fiscalism, bureaucracy, and society in the state formation. This led to much debate on the Weberian definition of modernization and state. After the classical work of [Bloch 1983](#), [Asch 2014](#), and [Asch 2017](#) analyzes the sacral kingship in the two countries. Other social sciences (only slightly mentioned here) also practiced comparisons, generally focused on the two monarchies' political modernity: [Root 1994](#) studies the links between political and economic, and [Ertman 1997](#) analyzes the relations between polity and characters of state infrastructures. It appears also that Franco-British comparison could not be separated from a wider European scene. [Pincus 2009](#) suggests the existence of two competing models of modernization in France and the United Provinces.

Comparisons between Fiscal and Financial Systems

In the research programs conducted on a European scale, the British and French monarchies were seen through an evolutionist perspective. Institutions and fiscal systems were tied together and gave birth to the rise of fiscal states competing with each other’s. General speaking it seems that the rise of the fiscal-military states has undermined the idea of an exceptional and liberal British state.

General Perspectives

In the introduction, [Béguin 2015](#) offers both a long-term and a European outlook. As a leading authority on the “new fiscal history” in the 1990s and 2000s, [Bonney 2004](#) provides a

precise account on the fiscal pressures in both monarchies. Along with the major and seminal works of [Mathias and O'Brien 1976](#) and [Hoffman and Norberg 1994](#), [Nye 2007](#) offers an accurate analysis on the specifics of fiscal policy. A collection of [Félix and Dubet 2018](#) insists on the porous limits within the financial and administrative spheres and the resultant tensions. A selected reference on numerous works concerning the fiscal-military state gives the opportunity to consider the latter notion from a comparative perspective: [Brewer 2016](#) exposes the author's retrospective view on his work; [Minard 2018](#) addresses its historiographical impact. Beyond the Anglo-British duet, [Enciso 2017](#) adds Spain to the interpretative framework and [Brewer and Hellmuth 1999](#) includes the German perspective thereby delivering a very stimulating outlook.

Political and Administrative Practices

Similar political practices are notable from both sides of the channel: some of them derive from the early modern history such as patronage or clientelism and are pregnant during the period; others appeared in conjunction with the rise of the state such as increasing bureaucracy or development of state papers and archives. Similar concerns were expressed, when it comes to the confusions between public and private interests, to the royal prerogatives and to resilience of a civic culture.

Practices of Monarchical Powers

[Giry-Deloison and Mettam 1995](#) offers a useful testimony of the importance of the topics of patronage and clientele in the British and French historiographies. The influential works of Lewis Namier in Britain and Roland Mousnier in France explain partially this durable interest; it was also stimulated by discussions during the 1980s and 1990s with the contribution of American historians. [Asch, et al. 2011](#) connects patronages and clientele with the question of corruption. The topic of corruption comes in different forms and shapes, with works concerning political corruption such as [Kerkhoff, et al. 2013](#); administrative corruption such as [Kroeze, et al. 2018](#); and fiscal corruption such as [Félix and Dubet 2018](#) (cited under [Comparisons between Fiscal and Financial Systems: General Perspectives](#)). The collective work by [Reinhard 1996](#) argues that the relations between states and power elites were structured by different rationales in both countries, although some approaches, stressing the need to negotiate political authority and to obtain the elites' "social collaboration" (to use William Beik's expression), allow some relevant comparisons. The two states evolved often at the same pace and were equally concerned with reforms, briefly treated by [Minard 2009](#) or the organization of the administrative archives ([Genet and Ruggiu 2011](#)).

A Shared Franco-British History: Wars, Exchanges, and Transfers

Some publications have made the similar assumption that social elites on both sides of the Channel were enamored with their neighbors’ culture or manners. A strident Anglomania was matched by a similar Gallomania. While simultaneously other influential works have stressed the way the two monarchies have come to define themselves as being opposed to each other. The emergence of a patriotic identity was hinged on the rejection of the hereditary enemy. Whether it be travel accounts or diaries, there is enough evidence to make a case in both opposite directions. These contributions are not necessarily contradictory, when they are closely contextualized and linked to some individuals, groups, or political events. This abundant scholarship is also challenged by other strands of research that highlight the importance of transfers and circulation in many fields.

A Wide Gamut of Political Interactions

The debates around the contested notion of a Second Hundred Year War has led to a profound renewal of the diplomatic and military history. While the account of the many battles on land and seas rightly occupy a vast amount of publications, more attention is also paid by to the peace negotiations and the interplay between foreign policy, representative institutions, and interest groups.

On Foreign Policy

In the continuity of a seminal work by [Thomson, et al. 1968](#), the diplomatic involvement of courts and monarchs has been further probed through the “society of princes” in [Bély 1990](#), a notion that facilitates the understanding of the peace process and the involvement of spies, politicians, lawyers, and so on. From a high politics approach, there was a continuous urge in the governments to fight the “natural enemy” for [Black 1986](#), although [Dziembowski 1998](#) suggests a significant shift of opinion among the French ministers in the period 1750. From a bottom-up perspective, it has been noted that modest actors, merchants, industrialists, and even fishermen were also involved in the making of peace treaties, from Utrecht to the Peace of Amiens (1802), which are analyzed in [Jessenne, et al. 2008](#). Increasingly, collusions and complementarities between the diplomatic and the parliamentary forms of representation came to be openly discussed ([Jettot 2012](#)). Diplomatic activities were no stranger to enlightenment practices and debates up to the French revolution ([Bélissa 1998](#)). This is not to

say that confessional politics disappeared from the negotiations, as demonstrated in [Claydon and McBride 1998](#), and the pope was also a significant actor ([Glickman 2013](#)). Relations between France and Britain are also better appreciated by considering the importance of third parties such as the United Provinces, an approach adopted by [Levillain 2010](#).

Reporting and Censoring Political News

The numerous channels of communication between France and Britain explained why knowledge and rumors on major political events such as the Fronde, analyzed in [Knachtel 1967](#) and [Benigno 2010](#), up to 1789 ([Philp 2004](#)), spread rapidly, were duly commented on, and were often recycled in a domestic context. Gazettes and newsletters were the main conduits. On the circulation of periodicals French and English, see [Haffemayer 2018](#) and [Curelly 2012](#). The well-connected Huguenot minority was also instrumental, notably when connected to the coffee house networks (see [Harvey and Grist 2006](#)). Migration and politics

Beyond the circulation of news, most work has been done on the individuals and communities that were affected by Franco-British relations and residing abroad, sometimes in dire circumstances. A fairly extensive bibliography has now been dedicated to the exiled communities of Huguenots. It would be fairly impossible to provide an exhaustive account. Among the most accessible contributions on the Jacobite court, [Corp 2004](#) and [Szechi 1994](#) are the most helpful. The Huguenot community has been well accounted for by a series of collective essays, notably [Scouloudi 1987](#), and the persistent confrontation led also to a significant circulation of soldiers and war prisoners. [Glozier 2004](#) is devoted to the involvement of Scottish soldiers in the French army, while the conflicting identities raised by the nationality and the diverse social status of the prisoners are convincingly dealt with by [Anderson 1960](#), [Morieux 2013](#), and [Charters 2014](#).

Intellectual History and Cultural Transfers

The political and the diplomatic circumstances could not account on their own for the circulation of individuals, ideas, and knowledge on both sides of the channel. There is a well-established scholarship related to the history of ideas and to the most prominent thinkers. Recently more attention is being paid to the material conditions through which ideas, prints, and manuscripts circulate. One should consider the many slippery forms of transmissions caused by translations, personal network, and correspondences.

Generalities

[Werner and Bénédicte 2004](#) stresses the limits of any comparative history, arguing that it led to overestimate the national boundaries and provides pictures of the compared objects that are too static. The project of a “entangled history” inspired many recent works. [Thomson, et al. 2010](#) surveys many case-studies related to various forms of cultural transfers. [Hayes 2009](#) combines a history of translation theory with a study of the cross-channel circulation of publications. [Stedman 2013](#) addresses the subject also with a strong theoretical apparatus with a gender approach. In a more descriptive and detailed manner, [Grieder 1985](#) and [Eagles 2000](#) point to the strength of cosmopolitanism in the French and English elite despite a growing patriotic culture. Two publications, [Ogéé 2005](#) and [Doig and Medlin 2007](#), deliver various examples of cultural exchanges in literature, art, and politics that were part of a European Enlightenment. [Black 1992](#) offers an accessible synthesis on the well-known practice of the Grand Tour.

Exchanges and Controversies between Prominent Thinkers

Prominent thinkers, philosophers, and historians, such as Hobbes, Locke, Voltaire, Montesquieu, or Hume have been the subject of substantial and important publications. It would be illusory to provide a satisfying account. Among the many studies on Voltaire in England, [Rousseau 1976](#) is very helpful as a main authority, along with [Cottret 1992](#) on Bolingbroke and his French audience. The history of ideas and the question of influence have been criticized for being too abstract and unable to provide a convincing account of the channels through which ideas are being transmitted and understood. [Roche 2000](#) demonstrates that some famous English travelers failed to access to the Parisian life. On the circulation republican ideas, [Hammersley 2010](#) provides a convincing account on a long 18th century. [Skinner 1966](#) addresses the reception of Hobbes in France, while [Savonius 2004](#) on Algernon Sidney provides also some stimulating thoughts. [Tillet 2001](#) explores the French reception of the English constitutionalists notably with Montesquieu acting as a powerful intermediary.
