RESOLVENT AND SPECTRAL ASYMPTOTICS FOR THIN-LAYER TRANSMISSION PROBLEMS IN THE LARGE COUPLING LIMIT

ABSTRACT. This work is concerned with a singular perturbation problem that involves a thin layer in the large coupling limit. Such a problem appears in the study of electromagnetic wave guides that contain supra-conductor bodies. We derive resolvent asymptotics for this problem by using boundary layer tools with uniform *a priori* estimates. This result will be useful to derive spectral asymptotics for this problem. This issue is a work in progress.

1. INTRODUCTION

This work is motivated by the study of the asymptotic behavior of eigenvalues related to a singular perturbation problem that involves a thin layer in the large coupling limit. Such a problem appears in the study of electromagnetic wave guides with supra-conductors. We refer the reader to several works that concern mathematical studies with electromagnetic wave guides, see for instance [1, 7, 2, 3].

An asymptotic expansion of the eigenvalues as the conductivity tends to infinity has been derived in [3]. However this result does not apply when the subdomain that represents a supra-conductor is a vanishing sheet. In this work we tackle this problem by considering vanishing supra-conductive layer of thickness ε where the conductivity is scaled like ε^{-2} . This is why there is a main difference between this work and the work in Ref. [3] all the more since we consider a transmission problem across a thin layer.

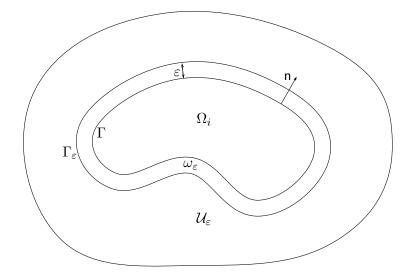


Figure 1 – A cross-section of the domain Ω and the subdomains $\Omega_i, \omega_{\varepsilon}, \mathcal{U}_{\varepsilon}$

Let us describe now the mathematical model. Throughout the paper we denote by $\Omega \subset \mathbb{R}^3$ a simply connected domain. Let Ω_i be a simply connected subdomain of Ω and let ω_{ε} be a thin layer of constant thickness ε surrounding Ω_i such that Ω contains $\Omega_i \cup \overline{\omega_{\varepsilon}}$, see Figure 1. For the sake of simplicity we further assume that the boundaries $\partial\Omega$ and $\Gamma = \partial\Omega_i$ are connected. Now the exterior domain is defined as $\mathcal{U}_{\varepsilon} = \Omega \setminus (\Omega_i \cup \overline{\omega_{\varepsilon}})$ and the boundary of the subdomain $\overline{\Omega_i} \cup \omega_{\varepsilon}$ is denoted by Γ_{ε} . We denote by n the outward unit normal at Γ .

In all that follows, unless specified, all the considered domains are smooth domains in \mathbb{R}^3 .

Notation 1.1. For any set $\mathcal{O} \subset \mathbb{R}^3$ we denote by $L^2(\mathcal{O})$ and $H^s(\mathcal{O})$ the classical Sobolev spaces.

Let $\varepsilon > 0$. We consider the self-adjoint operator $\mathcal{H}^{\varepsilon}$ on $L^{2}(\Omega)$ with domain $H^{2}(\Omega) \cap H^{1}_{0}(\Omega)$ and defined by

$$\mathcal{H}^{\varepsilon} = -\Delta + \frac{1}{\varepsilon^2} \mathbf{1}_{|\omega_{\varepsilon}|}$$

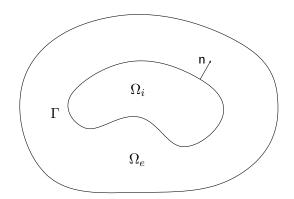


Figure 2 – A cross-section of the domain Ω and the subdomains Ω_i , Ω_e

The limit operator is $\mathcal{H}^0 = -\Delta$ defined on $\mathrm{H}^2(\Omega_i) \cap \mathrm{H}^1_0(\Omega_i) \times \mathrm{H}^2(\Omega_e) \cap \mathrm{H}^1_0(\Omega_e)$ where Ω_e denotes the limit domain $\mathcal{U}_{\varepsilon}$ when $\varepsilon \to 0$, *i.e.* $\Omega_e = \Omega \setminus \overline{\Omega}_i$ (see Figure 2).

In this work we derive an asymptotic expansion of the resolvent of $\mathcal{H}^{\varepsilon}$ when ε tends to 0. We denote by $\mathcal{R}^{\varepsilon}(\xi) := (\mathcal{H}^{\varepsilon} - \xi \mathcal{I})^{-1}$ the resolvent of $\mathcal{H}^{\varepsilon}$, defined on $L^2(\Omega)$ with values in $H^2(\Omega) \cap H^1_0(\Omega)$ for $\xi \notin \operatorname{spec} \mathcal{H}^{\varepsilon}$.

Let $f \in L^2(\Omega)$. The spectral problem writes

(1.1)
$$-\Delta u - \xi u + \frac{1}{\varepsilon^2} \mathbf{1}_{|\omega_{\varepsilon}} u = f \quad \text{in} \quad \Omega \,.$$

This problem is well-posed and has a unique solution u_{ε} in $\mathrm{H}^{2}(\Omega) \cap \mathrm{H}^{1}_{0}(\Omega)$ when ξ is not an eigenvalue of the operator $\mathcal{H}^{\varepsilon}$.

Notation 1.2. We denote by f_i (resp. f_e) the restriction of any function f to Ω_i (resp. Ω_e).

2. Asymptotic expansion for the resolvent

Let $\varepsilon > 0$. We consider the self-adjoint operator $\mathcal{H}^{\varepsilon}$ on $L^{2}(\Omega)$ with domain $H^{2}(\Omega) \cap H^{1}_{0}(\Omega)$ and defined by

$$\mathcal{H}^{\varepsilon} = -\Delta + \frac{1}{\varepsilon^2} \mathbf{1}_{|\omega_{\varepsilon}} \; .$$

For $\xi \notin \text{spec } \mathcal{H}^{\varepsilon}$, we denote by $\mathcal{R}^{\varepsilon}(\xi) = (\mathcal{H}^{\varepsilon} - \xi \text{Id})^{-1}$ the resolvent operator. For $f \in L^2(\Omega)$, we denote by u^{ε} the restriction of $\mathcal{R}^{\varepsilon}(\xi)(f)$ to Ω_i , v^{ε} the restriction of $\mathcal{R}^{\varepsilon}(\xi)(f)$ to ω_{ε} , and w^{ε} the restriction of $\mathcal{R}^{\varepsilon}(\xi)(f)$ to $\mathcal{U}_{\varepsilon}$, By the resolvent equation, we have:

(2.1)
$$-\Delta u^{\varepsilon} - \xi u^{\varepsilon} = f_{|\Omega_i} \qquad \text{in} \quad \Omega_i$$

(2.2)
$$-\Delta v^{\varepsilon} - \xi v^{\varepsilon} + \frac{1}{\varepsilon^2} v^{\varepsilon} = f_{|\omega_{\varepsilon}|} \qquad \text{in } \omega_{\varepsilon}$$
(2.2)
$$\Delta w^{\varepsilon} - \xi w^{\varepsilon} - f_{\varepsilon} \qquad \text{in } \mathcal{U}$$

(2.3)
$$-\Delta w^{\varepsilon} - \xi w^{\varepsilon} = f_{|\mathcal{U}^{\varepsilon}} \qquad \text{in } \mathcal{U}_{\varepsilon}$$

(2.4) $u^{\varepsilon} = v^{\varepsilon}$ on Γ (2.5) $v^{\varepsilon} = w^{\varepsilon}$ on Γ_{ε}

(2.6)
$$\partial_{\mathbf{n}} u^{\varepsilon} = \partial_{\mathbf{n}} v^{\varepsilon}$$
 on Γ

(2.7)
$$\partial_{\mathbf{n}} v^{\varepsilon} = \partial_{\mathbf{n}} w^{\varepsilon}$$
 on Γ_{ε}

(2.8) $w^{\varepsilon} = 0$ on $\partial \Omega$.

2.1. Ansatz. Outside the thin layer, we look for an expansion on the form:

(2.9)
$$u^{\varepsilon}(x) \approx \sum_{j \ge 0} \varepsilon^j U^j(x) \quad \text{in} \quad \Omega_i \,,$$

(2.10)
$$w^{\varepsilon}(x) \approx \sum_{j \ge 0} \varepsilon^j W^j(x) \quad \text{in} \quad \mathcal{U}_{\varepsilon} \,,$$

where the terms U^j and W^j are defined in ε -independent domains Ω_i and $\Omega_e := \Omega \setminus \Omega_i$. We emphasize that the terms W^j are defined in the thin layer ω_{ε} .

In the thin layer, we denote by $d: \omega_{\varepsilon} \to \mathbb{R}^+$ the euclidean distance to Γ , $d(x) = dist(x, \Gamma)$ and by $\mathsf{P}(x)$ the orthogonal projection of x on Γ . We describe the solution v^{ε} on the following way:

(2.11)
$$v^{\varepsilon}(x) \approx \sum_{j \ge 0} \varepsilon^{j} \left(W^{j}(x) + V^{j} \left(\frac{d(x)}{\varepsilon}, \mathsf{P}(x) \right) \right) \quad \text{in} \quad \omega_{\varepsilon} \,,$$

where the profiles V^j are defined on $[0,1] \times \Gamma$:

$$\begin{array}{rccc} V^j: & [0,1] \times \Gamma & \to & \mathbb{C} \\ & & (z,\sigma) & \mapsto & V^j(z,\sigma) \end{array}$$

In ω_{ε} , we will work with the variables (z, σ) .

2.2. Geometrical and analytical tools for the thin layer. We use the following notations (see also [6]) : $x = (x_1, x_2, x_3)$ denotes the cartesian coordinates in \mathbb{R}^3 , and we set

$$\partial_i = \frac{\partial}{\partial x_i}, \quad \partial_z = \frac{\partial}{\partial z}, \quad \partial_{zz} = \frac{\partial^2}{\partial z^2}$$

By simple calculations there holds (see also [5])

$$\begin{split} \Delta\left(x\mapsto V(\mathsf{P}(x),\frac{d(x)}{\varepsilon})\right) &= \quad \varepsilon^{-2}\partial_{\mathsf{z}\mathsf{z}}V(\mathsf{P}(x),\mathsf{z}) + \varepsilon^{-1}G_{\varepsilon\mathsf{z}}(\mathsf{P}(x))\partial_{\mathsf{z}}V(\mathsf{P}(x),\mathsf{z}) \\ &+ \Delta_{\Gamma_{\varepsilon\mathsf{z}}}V(\mathsf{P}(x),\mathsf{z}) \quad \text{with} \quad \mathsf{z} = \frac{d(x)}{\varepsilon} \;, \end{split}$$

where G is defined as

$$G_s(\sigma) = \frac{1}{\gamma_s(\sigma)} \frac{\partial \gamma_s}{\partial s}(\sigma) \;.$$

Here $\gamma_s(\sigma) = \det (\mathrm{Id} + s \mathrm{dn}(\sigma))$ and for $\sigma \in \Gamma$, the differential $\mathrm{dn}(\sigma)$ is a linear map from the tangent plane $T_{\sigma}\Gamma$ of Γ at the point σ into $T_{\mathsf{n}(\sigma)}S^2$ where S^2 is the unit sphere.

Proposition 2.1.

$$\frac{1}{2} \leq \gamma_s(\sigma) \leq \frac{3}{2}$$

In addition, since for $x \in \omega_{\varepsilon}$, we have: $x = \mathsf{P}(x) + \varepsilon \frac{\mathrm{d}(x)}{\varepsilon} \nu(\mathsf{P}(x)) = \sigma + \varepsilon z \nu(\sigma)$, we perform the Taylor expansion of the functions $\varphi : \omega_{\varepsilon} \longrightarrow \mathbb{C}$ writing:

$$\varphi(x) = \varphi(\mathsf{P}(x)) + \mathrm{d}(x)\frac{\partial\varphi}{\partial\nu}(\mathsf{P}(x)) + \dots, = \varphi(\sigma) + \varepsilon z \frac{\partial\varphi}{\partial\nu}(\sigma) + \dots$$

Then we insert the Ansatz (2.9)-(2.10)-(2.11) in equations (2.1)-(2.8) and we perform the identification of terms with the same power in ε .

2.3. Characterisation of the profiles at order ε^0 . Taking the order ε^0 in (2.1), we obtain that:

(2.12)
$$-\Delta U^0 - \xi U^0 = f \quad \text{in} \quad \Omega_i$$

Taking the order ε^0 in (2.3), we have:

(2.13)
$$-\Delta W^0 - \xi W^0 = f \quad \text{in} \quad \Omega_e$$

From (2.2) at order ε^{-2} , we obtain that:

(2.14)
$$-\partial_{zz}V^0 + V^0 + W^0(\sigma) = 0 \quad \text{in} \quad [0,1] \times \Gamma$$

By solving this ODE, we obtain that:

(2.15)
$$V^0(z,\sigma) = -W^0(\sigma) + \alpha_0(\sigma) \sinh z + \beta_0(\sigma) \cosh z.$$

From (2.6) at order ε^{-1} , we have

$$0 = \partial_{\mathsf{z}} V^0(0,\sigma),$$

so we obtain that $\beta_0(\sigma) = 0$ for all $\sigma \in \Gamma$.

From (2.7) at order ε^{-1} , we obtain that

$$0 = \partial_{\mathsf{z}} V^0(1,\sigma),$$

so, with (2.15), we obtain that

 $\beta_0(\sigma) = 0.$

Thus, we have:

$$(2.16) V^0(z,\sigma) = -W^0(\sigma)$$

Since W^0 satisfies (2.13), then W^0 and $\frac{\partial W^0}{\partial \nu}$ have no jump at Γ_{ε} . In particular, writing (2.5), we obtain that

$$V^0(1,\sigma) = 0.$$

Coupling this relation with (2.16), we obtain that

(2.17)
$$V^{0}(z,\sigma) = 0 \text{ for } z \in [0,1] \text{ and } \sigma \in \Gamma.$$

Therefore, with (2.16),

(2.18)
$$W^0(\sigma) = 0 \text{ for all } \sigma \in \Gamma$$

Writing (2.5) at order ε^0 , we have

$$U^0(\sigma) = V^0(0,\sigma)$$
 for $\sigma \in \Gamma$.

So, with (2.17),

(2.19)
$$U^0(\sigma) = 0 \text{ for all } \sigma \in \Gamma.$$

Equation (2.8) at order ε^0 yields $W^0 = 0$ on $\partial\Omega$. Therefore, coupling (2.12) and (2.19), U^0 is characterized by:

(2.20)
$$\begin{cases} -\Delta U^0 - \xi U^0 = f \text{ in } \Omega_i, \\ U^0 = 0 \text{ in } \partial \Omega_i. \end{cases}$$

In addition, coupling (2.13) and (2.18), W^0 is characterized by:

(2.21)
$$\begin{cases} -\Delta W^0 - \xi W^0 = f \text{ in } \Omega_e, \\ W^0 = 0 \text{ in } \partial \Omega_e. \end{cases}$$

2.4. Characterisation of the profiles at order ε^1 . Taking the order ε^1 in (2.1), we obtain that:

$$(2.22) -\Delta U^1 - \xi U^1 = 0 in \Omega_t$$

Taking the order ε^1 in (2.3), we have:

$$(2.23) \qquad \qquad -\Delta W^1 - \xi W^1 = 0 \quad \text{in} \quad \Omega_e \; .$$

From (2.2) at order ε^{-1} , we obtain that:

(2.24)
$$-\partial_{zz}V^1 + V^1 + W^1(\sigma) + z\frac{\partial W^0}{\partial \nu}(\sigma) = 0 \quad \text{in} \quad [0,1] \times \Gamma .$$

By solving this ODE, we obtain that:

(2.25)
$$V^{1}(\mathsf{z},\sigma) = -W^{1}(\sigma) - \mathsf{z}\frac{\partial W^{0}}{\partial \nu}(\sigma) + \alpha_{1}(\sigma)\sinh\mathsf{z} + \beta_{1}(\sigma)\cosh\mathsf{z}.$$

From (2.6) at order ε^0 , we have

$$\frac{\partial U^0}{\partial \nu}(\sigma) = \partial_{\mathsf{z}} V^1(0,\sigma)(\sigma) + \frac{\partial W^0}{\partial \nu}(\sigma).$$

so we obtain that

(2.26)
$$\alpha_1(\sigma) = \frac{\partial U^0}{\partial \nu}(\sigma) \text{ for all } \sigma \in \Gamma$$

From (2.7) at order ε^0 , we obtain that

$$0 = \partial_{\mathsf{z}} V^{1}(1, \sigma) = -\frac{\partial W^{0}}{\partial \nu}(\sigma) + \alpha_{1}(\sigma) \cosh 1 + \beta_{1}(\sigma) \sinh 1,$$

so, with (2.25) and (2.26), we obtain that

$$\beta_1(\sigma) = \frac{1}{\sinh 1} \left(\frac{\partial W^0}{\partial \nu}(\sigma) - (\cosh 1) \frac{\partial U^0}{\partial \nu}(\sigma) \right).$$

Thus, we have:

(2.27)
$$V^{1}(z,\sigma) = -W^{1}(\sigma) + \frac{\partial W^{0}}{\partial \nu}(\sigma) \left(-z + \frac{\cosh z}{\sinh 1}\right) + \frac{\partial U^{0}}{\partial \nu}(\sigma) \left(\sinh z - \coth 1 \cosh z\right).$$

Using (2.5) at order ε^1 , we obtain that $V^1(1,\sigma) = 0$, so:

$$W^{1}(\sigma) = (-1 + \coth 1) \frac{\partial W^{0}}{\partial \nu}(\sigma) - \frac{1}{\sinh 1} \frac{\partial U^{0}}{\partial \nu}(\sigma)$$

Therefore, we obtain that

$$V^{1}(\mathbf{z},\sigma) = \frac{\partial W^{0}}{\partial \nu}(\sigma) \left(1 - \mathbf{z} + \frac{\cosh \mathbf{z} - \cosh \mathbf{1}}{\sinh \mathbf{1}}\right) + \frac{\partial U^{0}}{\partial \nu}(\sigma) \left(\sinh \mathbf{z} - \coth \mathbf{1} \cosh \mathbf{z} + \frac{1}{\sinh \mathbf{1}}\right).$$

Using (2.5) at order ε^1 , we obtain that for $\sigma \in \Gamma$:

(2.30)
$$U^{1}(\sigma) = V^{1}(0,\sigma) + W^{1}(\sigma) = \frac{1}{\sinh 1} \frac{\partial W^{0}}{\partial \nu}(\sigma) - \frac{\cosh 1}{\sinh 1} \frac{\partial U^{0}}{\partial \nu}(\sigma).$$

Therefore, coupling (2.22) and (2.30), U^1 is characterized by:

$$\begin{cases} -\Delta U^1 - \xi U^1 = 0 \text{ in } \Omega_i, \\ U^1(\sigma) = \frac{1}{\sinh 1} \frac{\partial W^0}{\partial \nu}(\sigma) - \coth 1 \frac{\partial U^0}{\partial \nu}(\sigma) \text{ in } \partial \Omega_i. \end{cases}$$

In addition, coupling (2.23), (2.28), and (2.8) at order ε^1 , W^1 is characterized by:

(2.32)
$$\begin{cases} -\Delta W^{1} - \xi W^{1} = f \text{ in } \Omega_{e}, \\ W^{1}(\sigma) = (-1 + \coth 1) \frac{\partial W^{0}}{\partial \nu}(\sigma) - \frac{1}{\sinh 1} \frac{\partial U^{0}}{\partial \nu}(\sigma) \text{ in } \Gamma, \\ W^{1} = 0 \text{ on } \partial \Omega. \end{cases}$$

We denote by **H** the space of the functions $f \in L^2(\Omega)$ such that the restrictions of f respectively in Ω_i and Ω_e are respectively in $H^1(\Omega_i)$ and $H^1(\Omega_e)$, endowed with the Hilbert norm:

$$\|f\|_{\mathbf{H}} = \left(\|f_{|\Omega_i|}\|_{\mathrm{H}^1(\Omega_i)}^2 + \|f_{|\Omega_e|}\|_{\mathrm{H}^1(\Omega_e)}^2\right)^{\frac{1}{2}}.$$

2.5. Equation for the remainder. We write:

$$\begin{cases} u^{\varepsilon}(x) = U^{0}(x) + \varepsilon U^{1}(x) + \varepsilon a^{\varepsilon}(x) & \text{for } x \in \Omega_{i}; \\ v^{\varepsilon}(x) = W^{0}(x) + \varepsilon W^{1}(x) + \varepsilon V^{1}(\mathsf{P}(x), \frac{\mathrm{d}(x)}{\varepsilon}) + \varepsilon b^{\varepsilon}(x) & \text{for } x \in \omega_{\varepsilon}; \\ w^{\varepsilon}(x) = W^{0}(x) + \varepsilon W^{1}(x) + \varepsilon c^{\varepsilon}(x) & \text{for } x \in \mathcal{U}_{\varepsilon}. \end{cases}$$

The remainder term satisfies:

where d^ε is defined on ω_ε by $d^\varepsilon=d_1^\varepsilon+d_2^\varepsilon+d_3^\varepsilon+d_4^\varepsilon$ with:

2.6. Estimates of the right-hand-side terms. Since ξ is in the circle of center λ^0 and of radius η_0 , there exists a constant *C* such that for all $f \in \mathbf{H}$,

$$\|U^1\|_{H^2(\Omega_i)} + \|W^1\|_{H^2(\Omega_e)} \le C \|f\|_{\mathbf{H}}.$$

From (2.42), by trace theory, we obtain that:

$$\begin{aligned} \|g^{\varepsilon}\|_{\mathrm{L}^{2}(\Gamma)} &\leq \|\frac{\partial W^{1}}{\partial \nu}\|_{H^{\frac{1}{2}}(\Gamma)} + \|\frac{\partial U^{1}}{\partial \nu}\|_{H^{\frac{1}{2}}(\Gamma)}, \\ &\leq K\left(\|\nabla W^{1}\|_{\mathrm{H}^{1}(\Omega_{e})} + \|\nabla U^{1}\|_{\mathrm{H}^{1}(\Omega_{i})}\right), \end{aligned}$$

so,

$$(2.43) ||g^{\varepsilon}||_{\mathrm{L}^{2}(\Gamma)} \leq K ||f||_{\mathrm{H}}.$$

In order to estimate d_1^{ε} and d_2^{ε} , we prove the following proposition:

Proposition 2.2. We denote by N the dimension of the space. We define 2^* by $\frac{1}{2} = \frac{1}{N} + \frac{1}{2^*}$ (for $N = 2, 2^* = +\infty$). Then for all $p \in [2, 2^*[(2, 2^*] \text{ for } N \neq 2)$, there exists a constant K_p such that for all $\varepsilon > 0$, we have:

$$\forall v \in H^2(\Omega_e), \ \left\| \frac{1}{\varepsilon^2} \left(v(\cdot) - v(\mathsf{P}(\cdot)) \right) \right\|_{\mathrm{L}^2(\omega_{\varepsilon})} \leq \frac{K_p}{\varepsilon^{\frac{1}{2} + \frac{1}{p}}} \|v\|_{H^2(\Omega_e)}$$

and

$$\forall v \in H^{3}(\Omega_{e}), \ \left\| \frac{1}{\varepsilon^{3}} \left(v(\cdot) - v(\mathsf{P}(\cdot)) - \frac{\partial v}{\partial \nu}(\mathsf{P}(\cdot)) \right) \right\|_{\mathrm{L}^{2}(\omega_{\varepsilon})} \leq \frac{K_{p}}{\varepsilon^{\frac{1}{2} + \frac{1}{p}}} \|v\|_{H^{3}(\Omega_{e})}$$

Proof. We assume that v is smooth. For $x \in \omega_{\varepsilon}$, we have $x = P(x) + d(x)\nu(P(x))$, so, using the variables s = d(x) and $\sigma = P(x)$ and Taylor's formula:

$$\begin{split} \|v(\cdot) - v(\mathsf{P}(\cdot))\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} &= \int_{s=0}^{\varepsilon} \int_{\sigma\in\Gamma} \gamma_{s}(\sigma) |v(\sigma + s\nu(\sigma)) - v(\sigma)|^{2} d\sigma \mathrm{d}s, \\ &= \int_{s=0}^{\varepsilon} \int_{\sigma\in\Gamma} \gamma_{s}(\sigma) \left| \int_{\tau=0}^{s} \nabla v(\sigma + \tau\nu(\sigma)) \cdot \nu(\sigma) d\tau \right|^{2} ds \, d\sigma, \\ &\leq \int_{s=0}^{\varepsilon} \int_{\sigma\in\Gamma} \gamma_{s}(\sigma) \left(\int_{0}^{s} |\nabla v(\sigma + \tau\nu(\sigma))|^{2} d\tau \right) s \, ds \, d\sigma, \\ &\leq \varepsilon^{2} 3 \int_{\omega_{\varepsilon}} |\nabla v|^{2} dx \quad (\text{using Proposition 2.1}). \end{split}$$

By Sobolev embedding, for all $p \in [2, 2^{\star}[$ ($[2, 2^{\star}]$ for $N \neq 2$),

$$\|\nabla v\|_{\mathrm{L}^p(\mathcal{U})} \le C_p \|v\|_{H^2(\mathcal{U})}.$$

So, by Hölder inequality,

$$\begin{aligned} \|\nabla v\|_{\mathcal{L}^{2}(\omega_{\varepsilon})} &\leq \|\nabla v\|_{\mathcal{L}^{p}(\omega_{\varepsilon})}(\operatorname{meas}(\omega_{\varepsilon}))^{\frac{1}{2}-\frac{1}{p}}, \\ &\leq (K\varepsilon)^{\frac{1}{2}-\frac{1}{p}}C_{p}\|v\|_{H^{2}(\mathcal{U})}. \end{aligned}$$

Therefore,

$$\left\|\frac{1}{\varepsilon^2}\left(v(\cdot)-v(\mathsf{P}(\cdot))\right)\right\|_{\mathrm{L}^2(\omega_{\varepsilon})} \leq \frac{\sqrt{3}KC_p}{\varepsilon^{\frac{1}{2}+\frac{1}{p}}} \|v\|_{H^2(\mathcal{U})}.$$

In addition, by Taylor expansion at order 2, for $\sigma \in \Gamma$ and $s \in [0, \varepsilon]$, we have:

$$\begin{aligned} \left| v(\sigma + s\nu(\sigma)) - v(\sigma) - \frac{\partial v}{\partial \nu}(\sigma) \mathrm{d}(x) \right| &= \left| \int_0^s (s - \tau) D^2 v(\sigma + \tau s)(\nu(\sigma), \nu(\sigma)) d\tau \right|, \\ &\leq s \int_0^s \left| D^2 v(\sigma + \tau s) \right| d\tau. \end{aligned}$$

Therefore,

$$\begin{split} \left\| v(x) - v(\mathsf{P}(x)) - \frac{\partial v}{\partial \nu}(\mathsf{P}(x)) \mathrm{d}(x) \right\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} &= \int_{0}^{\varepsilon} \int_{\Gamma} \gamma_{s}(\sigma) \left| v(\sigma + s\nu(\sigma)) - v(\sigma) - \frac{\partial v}{\partial \nu}(\sigma) s \right|^{2} ds \, d\sigma, \\ &\leq \int_{0}^{\varepsilon} \int_{\Gamma} \gamma_{s}(\sigma) \left| s \int_{0}^{s} |D^{2}v(\sigma + \tau s)| d\tau \right|^{2} ds d\sigma, \\ &\leq \int_{0}^{\varepsilon} \int_{\Gamma} \gamma_{s}(\sigma) s^{3} \int_{0}^{s} |D^{2}v(\sigma + \tau s)|^{2} d\tau ds d\sigma, \\ &\leq 3\varepsilon^{4} \int_{\omega_{\varepsilon}} |D^{2}v(x)|^{2} dx. \end{split}$$

By Sobolev embedding, for all $p \in [2, 2^{\star}[([2, 2^{\star}] \text{ for } N \neq 2),$

$$\|D^2v\|_{\mathrm{L}^p(\mathcal{U})} \le C_p \|v\|_{H^3(\mathcal{U})},$$

so

$$\|D^2 v\|_{\mathrm{L}^2(\omega_{\varepsilon})} \le \|D^2 v\|_{\mathrm{L}^p(\mathcal{U})}(\mathrm{meas}(\omega_{\varepsilon}))^{\frac{1}{2}-\frac{1}{p}} \le C_p \|v\|_{H^3(\mathcal{U})}(K\varepsilon)^{\frac{1}{2}-\frac{1}{p}},$$

thus,

$$\left\|\frac{1}{\varepsilon^3}\left(v(x)-v(\mathsf{P}(x))-\frac{\partial v}{\partial \nu}(\mathsf{P}(x))\mathrm{d}(x)\right)\right\|_{\mathrm{L}^2(\omega_{\varepsilon})} \leq \frac{\sqrt{3}KC_p}{\varepsilon^{\frac{1}{2}+\frac{1}{p}}}\|v\|_{H^3(\mathcal{U})}.$$

We take $K_p = \sqrt{3}KC_p$, and we conclude the proof of Proposition 2.2 by a density argument.

Corollary 2.3. For all $p \in [2, 2^*]$ ($[2, +\infty)$ in the case N = 2), there exists K_p such that for all $\varepsilon > 0$, for all $f \in \mathbf{H}$,

$$\|d_1^{\varepsilon}\|_{\mathrm{L}^2(\omega_{\varepsilon})} \leq \frac{K_p}{\varepsilon^{\frac{1}{2} + \frac{1}{p}}} \|f\|_{\mathbf{H}},$$

and

$$\|d_2^{\varepsilon}\|_{\mathcal{L}^2(\omega_{\varepsilon})} \leq \frac{K_p}{\varepsilon^{\frac{1}{2} + \frac{1}{p}}} \|f\|_{\mathbf{H}}.$$

From (2.29), we have:

$$\begin{split} \|d_{3}^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} &= \int_{0}^{\varepsilon} \int_{\Gamma} \gamma_{s}(\sigma) \left| \frac{1}{\varepsilon} G_{s}(\sigma) \partial_{z} V^{1}(\frac{s}{\varepsilon}, \sigma) + \xi V^{1}(\frac{s}{\varepsilon}, \sigma) \right|^{2} ds \, d\sigma \\ &\leq \frac{K}{\varepsilon^{2}} \int_{0}^{\varepsilon} \int_{\Gamma} \left(|\frac{\partial W^{0}}{\partial \nu}(\sigma)|^{2} + |\frac{\partial U^{0}}{\partial \nu}(\sigma)|^{2} \right) d\sigma ds, \\ &\leq \frac{K}{\varepsilon} \left(\|W^{0}\|_{H^{3}(\Omega_{\varepsilon})}^{2} + \|U^{0}\|_{H^{3}(\Omega_{i})}^{2} \right). \end{split}$$

Therefore

(2.44)
$$\|d_3^{\varepsilon}\|_{\mathrm{L}^2(\Omega_{\varepsilon})} \leq \frac{C}{\varepsilon^{\frac{1}{2}}} \|f\|_{\mathbf{H}}.$$

2.7. Variational estimates for the remainder term. Multiplying (2.33) by the conjugate of a^{ε} and integrating on Ω_i , multiplying (2.34) by the conjugate of b^{ε} and integrating on ω_{ε} , multiplying (2.35) by the conjugate of c^{ε} and integrating on $\mathcal{U}_{\varepsilon}$, after integrations by part and after summation, we obtain:

$$\begin{aligned} \|\nabla a^{\varepsilon}\|_{\mathrm{L}^{2}(\Omega_{i})}^{2} + \|\nabla b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} + \|\nabla c^{\varepsilon}\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})}^{2} + \frac{1}{\varepsilon^{2}}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} = \\ \int_{\Gamma} g^{\varepsilon}\overline{b^{\varepsilon}} + \int_{\omega_{\varepsilon}} d^{\varepsilon}\overline{b^{\varepsilon}} - \xi \left(\|a^{\varepsilon}\|_{\mathrm{L}^{2}(\Omega_{i})}^{2} + \|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} + \|c^{\varepsilon}\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})}^{2}\right). \end{aligned}$$

So,

$$\begin{aligned} \|\nabla a^{\varepsilon}\|_{\mathrm{L}^{2}(\Omega_{i})}^{2} + \|\nabla b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} + \|\nabla c^{\varepsilon}\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})}^{2} + \frac{1}{\varepsilon^{2}}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} \leq \\ & |\xi| \left(\|a^{\varepsilon}\|_{\mathrm{L}^{2}(\Omega_{i})}^{2} + \|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} + \|c^{\varepsilon}\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})}^{2} \right) \\ & + \|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}\|d^{\varepsilon}_{1} + d^{\varepsilon}_{2} + d^{\varepsilon}_{3}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})} + \|g^{\varepsilon}\|_{\mathrm{L}^{2}(\Gamma)}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\Gamma)} \\ & + \left|\int_{\omega_{\varepsilon}} d^{\varepsilon}_{4}\overline{b^{\varepsilon}}\right|. \end{aligned}$$

We claim the following lemma proved in Section 3.1.

Lemma 2.4. There exists a constant C > 0 independent of ε such that for any $\xi \in C(\lambda^0, \eta)$, for any $u \in H^1(\Omega_i)$ such that $-\Delta u - \xi u \in L^2(\Omega_e)$, we have :

(2.46)
$$\|u\|_{L^{2}(\Omega_{i})} \leq C \left(\|u\|_{L^{2}(\Gamma)} + \|(-\Delta u - \xi u)\|_{L^{2}(\Omega_{i})} \right) ,$$

and for any $v \in H^1(\mathcal{U}_{\varepsilon})$ such that v = 0 on $\partial\Omega$ and such that $-\Delta v - \xi v \in L^2(\mathcal{U}_e)$, we have :

(2.47)
$$\|v\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})} \leq C\left(\|v\|_{\mathrm{L}^{2}(\Gamma_{\varepsilon})} + \|(-\Delta v - \xi v)\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})}\right)$$

We claim the following Lemma, proved in [4] (see Inequality (2.1) in Proposition 2.1., page 822).

Lemma 2.5. There exists constants $C, \varepsilon_0 > 0$ such that for all $\varepsilon \in (0, \varepsilon_0)$, for all $q \in H^1(\omega_{\varepsilon})$,

$$\|\mathbf{q}\|_{\mathbf{L}^{2}(\partial\omega_{\varepsilon})}^{2} \leqslant C\left(\frac{1}{\varepsilon}\|\mathbf{q}\|_{\mathbf{L}^{2}(\omega_{\varepsilon})}^{2} + \|\mathbf{q}\|_{\mathbf{L}^{2}(\omega_{\varepsilon})}\|\nabla\mathbf{q}\|_{\mathbf{L}^{2}(\omega_{\varepsilon})}\right)$$

Since a^{ε} (resp. c^{ε}) satisfies (2.33) in Ω_i (resp. (2.35) in $\mathcal{U}_{\varepsilon}$), we obtain with Lemma 2.4 and the transmission condition (2.36) (resp. (2.37)) that there exists C independent of $\varepsilon > 0$ and $\xi \in \mathcal{C}(\lambda^0, \eta)$ such that:

$$\|a^{\varepsilon}\|_{\mathrm{L}^{2}(\Omega_{i})}^{2}+\|c^{\varepsilon}\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})}^{2}\leq C\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\partial\omega_{\varepsilon})}^{2}.$$

Using now Lemma 2.5, we obtain that:

(2.48)
$$\|a^{\varepsilon}\|_{\mathrm{L}^{2}(\Omega_{i})}^{2} + \|c^{\varepsilon}\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})}^{2} \leq \frac{C}{\varepsilon} \|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} + C\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})} \|\nabla b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}.$$

Using Corollary 2.3, Estimate (2.44), we obtain that there exists a constant C such that for all $\varepsilon > 0$, for all $\xi \in C(\lambda^0, \eta)$ and for all $f \in \mathbf{H}$,

(2.49)
$$\|d_1^{\varepsilon} + d_2^{\varepsilon} + d_3^{\varepsilon}\|_{L^2(\omega_{\varepsilon})} \leq \frac{C}{\varepsilon^{\frac{1}{2} + \frac{1}{p}}} \|f\|_{\mathbf{H}}.$$

In addition, coupling Lemma 2.5 and Estimate (2.43), we obtain that: (2.50)

$$\|g^{\varepsilon}\|_{\mathrm{L}^{2}(\Gamma)}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\Gamma)} \leq C\sqrt{\varepsilon}\|f\|_{\mathbf{H}}\frac{1}{\varepsilon}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})} + C\varepsilon^{\frac{1}{2}}\|f\|_{\mathbf{H}}\left(\frac{1}{\varepsilon}\|b_{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}\right)^{\frac{1}{2}}\|\nabla b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{\frac{1}{2}}.$$

Let us estimate the last right-hand-side term in (2.45). We denote by $B^{\varepsilon} = b^{\varepsilon} \circ \Psi$, where:

$$\begin{array}{rccc} \Psi: & [0,\eta_0] \times \Gamma & \to & \omega_{\eta_0} \\ & & (s,\sigma) & \mapsto & \sigma + s\nu(\sigma). \end{array}$$

$$\begin{split} \int_{\omega_{\varepsilon}} d_4^{\varepsilon} \overline{b^{\varepsilon}} &= \int_{s=0}^{\varepsilon} \int_{\sigma \in \Gamma} \gamma_s(\sigma) (\Delta_{\Gamma_s} V^1(\frac{s}{\varepsilon}, \sigma)) \overline{B^{\varepsilon}(s, \sigma)} ds \, d\sigma, \\ &= -\int_{s=0}^{\varepsilon} \int_{\sigma \in \Gamma} \gamma_s(\sigma) \nabla_{\Gamma_s} V^1(\frac{s}{\varepsilon}, \sigma) \overline{\nabla_{\Gamma_s} B^{\varepsilon}(s, \sigma)} ds, \end{split}$$

So,

$$\begin{split} \left| \int_{\omega_{\varepsilon}} d_{4}^{\varepsilon} \overline{b^{\varepsilon}} \right| &\leq \int_{s=0}^{\varepsilon} \int_{\sigma \in \Gamma} \gamma_{s}(\sigma) \left| \nabla_{\Gamma_{s}} V^{1}(\frac{s}{\varepsilon}, \sigma) \right| \left| \nabla_{\Gamma_{s}} B^{\varepsilon}(s, \sigma) \right| ds \, d\sigma \\ &\leq \| \nabla b^{\varepsilon} \|_{\mathrm{L}^{2}(\omega_{\varepsilon})} \| \nabla_{\Gamma_{s}} V^{1}(\frac{s}{\varepsilon}, \sigma) \|_{\mathrm{L}^{2}(\omega_{\varepsilon})}, \\ &\leq \| \nabla b^{\varepsilon} \|_{\mathrm{L}^{2}(\omega_{\varepsilon})} \left(\| \frac{\partial U^{0}}{\partial \nu} \|_{\mathrm{H}^{1}(\Gamma)} + \| \frac{\partial W^{0}}{\partial \nu} \|_{\mathrm{H}^{1}(\Gamma)} \right) \sqrt{\varepsilon}, \end{split}$$

thus, using (2.41), we obtain:

(2.51)
$$\left|\int_{\omega_{\varepsilon}} d_4^{\varepsilon} \overline{b^{\varepsilon}}\right| \le C\sqrt{\varepsilon} \|\nabla b^{\varepsilon}\|_{\mathrm{L}^2(\omega_{\varepsilon})} \|f\|_{\mathbf{H}}.$$

Therefore, from (2.45), (2.48), (2.49), (2.50), and (2.51), we obtain that there exists a constant C independent of $\varepsilon > 0$, $\xi \in C(\lambda^0, \eta)$ and $f \in \mathbf{H}$ such that

$$\begin{split} \|\nabla a^{\varepsilon}\|_{\mathrm{L}^{2}(\Omega_{i})}^{2} + \|\nabla b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} + \|\nabla c^{\varepsilon}\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})}^{2} + \frac{1}{\varepsilon^{2}}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} \leq \\ \frac{C}{\varepsilon}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} + C\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}\|\nabla b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})} + \frac{C}{\varepsilon^{\frac{1}{2}+\frac{1}{p}}}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}\|f\|_{\mathbf{H}} \\ + C\sqrt{\varepsilon}\|f\|_{\mathbf{H}^{\frac{1}{\varepsilon}}}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})} + C\varepsilon^{\frac{1}{2}}\|f\|_{\mathbf{H}}\left(\frac{1}{\varepsilon}\|b_{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}\right)^{\frac{1}{2}}\|\nabla b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{\frac{1}{2}} + C\varepsilon^{\frac{1}{2}}\|\nabla b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}\|f\|_{\mathbf{H}} \\ \leq \frac{1}{\varepsilon}\frac{1}{\varepsilon}\frac{1}{\varepsilon}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})} + C\varepsilon^{\frac{1}{2}}\|f\|_{\mathbf{H}^{\frac{1}{\varepsilon}}}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} + C\varepsilon^{\frac{1}{2}}\|\nabla b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}\|f\|_{\mathbf{H}^{\frac{1}{\varepsilon}}} \\ \leq \frac{1}{\varepsilon}\frac{1}{\varepsilon}\frac{1}{\varepsilon}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})} + C\varepsilon^{\frac{1}{2}}\|f\|_{\mathrm{H}^{\frac{1}{\varepsilon}}}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} + C\varepsilon^{\frac{1}{2}}\|\nabla b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}\|f\|_{\mathrm{H}^{\frac{1}{\varepsilon}}} \\ \leq \frac{1}{\varepsilon}\frac{1}{\varepsilon}\frac{1}{\varepsilon}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})} + C\varepsilon^{\frac{1}{2}}\|f\|_{\mathrm{H}^{\frac{1}{\varepsilon}}}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} + C\varepsilon^{\frac{1}{2}}\|\nabla b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} \\ \leq \frac{1}{\varepsilon}\frac{1}{\varepsilon}\frac{1}{\varepsilon}\frac{1}{\varepsilon}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})} + C\varepsilon^{\frac{1}{2}}\|f\|_{\mathrm{H}^{\frac{1}{\varepsilon}}}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} + C\varepsilon^{\frac{1}{2}}\|\nabla b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} \\ \leq \frac{1}{\varepsilon}\frac$$

$$\leq \frac{1}{2} \frac{1}{\varepsilon^2} \|b^{\varepsilon}\|_{\mathrm{L}^2(\omega_{\varepsilon})}^2 + \frac{1}{2} \|\nabla b^{\varepsilon}\|_{\mathrm{L}^2(\omega_{\varepsilon})}^2 + C\varepsilon^{1-\frac{2}{p}} \|f\|_{\mathbf{H}}^2 \quad (\text{by Young inequality}).$$

So, after absorption, we obtain that there exists C such that:

(2.52)
$$\|\nabla a^{\varepsilon}\|_{\mathrm{L}^{2}(\Omega_{i})}^{2} + \|\nabla b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} + \|\nabla c^{\varepsilon}\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})}^{2} + \frac{1}{\varepsilon^{2}}\|b^{\varepsilon}\|_{\mathrm{L}^{2}(\omega_{\varepsilon})}^{2} \leq C\varepsilon^{1-\frac{2}{p}}\|f\|_{\mathbf{H}}^{2}$$

Reusing (2.48), we obtain also that:

(2.53)
$$\|a^{\varepsilon}\|_{\mathrm{L}^{2}(\Omega_{i})}^{2} + \|c^{\varepsilon}\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})}^{2} \leq C\varepsilon^{2-\frac{2}{p}}\|f\|_{\mathrm{H}}^{2}.$$

3. TECHNICAL LEMMA : UNIFORM A PRIORI ESTIMATES

3.1. Geometrical tools in the thin layer. In this part, we refer to [4]. For $\sigma \in \Gamma$, we denote by $\nu(\sigma)$ the outward unitary normal. We remark that $\nu : \Gamma \longrightarrow S^{N-1}$ is smooth since Γ is regular. We define Ψ by:

$$\begin{array}{rcl} \Psi: &]0, \eta_0[\times\Gamma & \to & \omega_{\eta_0} \\ & & (s,\sigma) & \mapsto & \sigma + s\nu(\sigma). \end{array}$$

Since Γ is a smooth compact surface without boundary, we can fix $\eta_0 > 0$ such that Ψ is a \mathcal{C}^{∞} -diffeomorphism and so that for all $\varepsilon \in]0, \eta_0[$,

$$\Psi(]0,\varepsilon[\times\Gamma) = \omega_{\varepsilon}.$$

We define $\gamma : [0, \eta_0] \times \Gamma \to \mathbb{R}$ by:

$$\gamma_s(\sigma) = \det(Id + s \, d\nu(\sigma)),$$

and we have:

$$\int_{\omega_{\eta_0}} F(x) \, dx = \int_{s=0}^{\eta_0} \int_{\sigma \in \Gamma} F(\Psi(s,\sigma)) \gamma_s(\sigma) d\sigma \, ds.$$

Since $\gamma_0(\sigma) = 1$ for all $\sigma \in \Gamma$, even if it means reducing η_0 , we assume that

(3.1)
$$\forall s \in [0, \eta_0[, \forall \sigma \in \Gamma, \frac{1}{2} \le \gamma_s(\sigma) \le \frac{3}{2}]$$

We denote ∇_{Γ} , div_{Γ} and Δ_{Γ} the gradient, divergence and Laplacian operators on the submanifold Γ .

For $v : \Gamma \longrightarrow \mathbb{C}$ and $s \in [0, \eta_0]$, we define $\nabla_{\Gamma_s} v$ by:

$$\nabla_{\Gamma_s} \mathbf{v}(\sigma) = (Id + s \, d\nu(\sigma))^{-1} \nabla_{\Gamma} \mathbf{v}(\sigma),$$

so that: for $v: \omega_{\eta_0} \to \mathbb{C}$, denoting $V = v \circ \Psi$, we have:

$$\nabla v(x) = \frac{\partial V}{\partial s}(\mathbf{d}(x), \mathsf{P}(x))\nu(\mathsf{P}(x)) + \left(\nabla_{\Gamma_{\mathbf{d}(x)}}V\right)(\mathbf{d}(x), \mathsf{P}(x)).$$

We define the operator $\operatorname{div}_{\Gamma_s}$ as the adjoint of ∇_{Γ_s} for the $L^2(\Gamma)$ -inner product: for $Y : \Gamma \longrightarrow T_{\Gamma}$ a tangent vector field defined on Γ , we set:

$$\left(\operatorname{div}_{\Gamma_{s}}Y\right)(\sigma) = \frac{1}{\gamma_{s}(\sigma)}\operatorname{div}_{\Gamma}\left(\gamma_{s}(\operatorname{Id} + s\,d\nu)^{-1}Y\right)(\sigma),$$

so that if $z: \omega_{\eta_0} \longrightarrow \mathbb{R}^N$ is a vector field, denoting $Z = z \circ \Psi$, $Z_N(s, \sigma) = (Z(s, \sigma) \cdot \nu(\sigma))$ and $Z_T(s, \sigma) = Z(s, \sigma) - Z_N(s, \sigma)\nu(\sigma)$, we have:

$$\operatorname{div} z(x) = \frac{\partial Z_N}{\partial s} (\operatorname{d}(x), \mathsf{P}(x)) + G_{\operatorname{d}(x)}(\mathsf{P}(x)) Z_N(\operatorname{d}(x), \mathsf{P}(x)) + \left(\operatorname{div}_{\Gamma_{\operatorname{d}(x)}} Z_T\right) (\operatorname{d}(x), \mathsf{P}(x)),$$

where

$$G_s(\sigma) = \frac{1}{\gamma_s(\sigma)} \frac{\partial \gamma_s}{\partial s}(\sigma).$$

We define the operator Δ_{Γ_s} by:

$$\Delta_{\Gamma_s} = \operatorname{div}_{\Gamma_s} \circ \nabla_{\Gamma_s},$$

so that for $v: \omega_{\eta_0} \to \mathbb{C}$, denoting $V = v \circ \Psi$, we have:

$$\Delta v(x) = \frac{\partial^2 V}{\partial s^2}(\mathbf{d}(x), \mathsf{P}(x)) + G_{\mathbf{d}(x)}(\mathsf{P}(x))\frac{\partial V}{\partial s}(\mathbf{d}(x), \mathsf{P}(x)) + (\Delta_{\Gamma_{\mathbf{d}(x)}}V)(\mathbf{d}(x), \mathsf{P}(x)).$$

3.2. Geometrical tools for $\mathcal{U}_{\varepsilon}$. Let $\chi : \mathbb{R} \to \mathbb{R}$ be a smooth non-decreasing function such that:

$$\forall x \le 0, \ \chi(x) = -1,$$
$$\forall x \ge n, \ \chi(x) = 0$$

$$\forall x \ge \eta_0, \ \chi(x) = 0.$$

For $\varepsilon > 0$ such that $\varepsilon \leq \frac{\eta_0}{4}$, we define ϕ_{ε} by:

$$\begin{cases} \phi_{\varepsilon}: \mathcal{U}_{\varepsilon} \to \Omega_{e} \\ x \mapsto x + \varepsilon \chi(\mathbf{d}(x) - \varepsilon) \nu(\mathsf{P}(x)) \end{cases}$$

We remark that if $x \in \mathcal{U}_{\varepsilon}$ with $d(x) \ge \varepsilon + \eta_0$, then $\phi_{\varepsilon}(x) = x$. In addition, ϕ_{ε} is a \mathcal{C}^{∞} diffeomorphism from $\mathcal{U}_{\varepsilon}$ onto Ω_e . We denote by $\phi_{\varepsilon,k}$ the k-th coordinate of ϕ_{ε} .

For $w: \mathcal{U}_{\varepsilon} \to \mathbb{C}$, we define $w: \Omega_e \to \mathbb{C}$ by:

$$w = \mathbf{w} \circ \phi_{\varepsilon}.$$

We have, for all $j \in \{1, \ldots N\}$,

$$\frac{\partial w}{\partial x_j} = \sum_{k=1}^N \frac{\partial \mathsf{w}}{\partial \mathsf{x}_k} (\phi_\varepsilon(x)) \frac{\partial \phi_{\varepsilon,k}}{\partial x_j}(x)$$

so

$$\frac{\partial^2 w}{\partial x_j^2} = \sum_{k=1}^N \sum_{l=1}^N \frac{\partial^2 \mathsf{w}}{\partial \mathsf{x}_k \partial \mathsf{x}_l} (\phi_\varepsilon(x)) \frac{\partial \phi_{\varepsilon,k}}{\partial x_j}(x) \frac{\partial \phi_{\varepsilon,l}}{\partial x_j}(x) + \sum_{k=1}^N \frac{\partial \mathsf{w}}{\partial \mathsf{x}_k} (\phi_\varepsilon(x)) \frac{\partial^2 \phi_{\varepsilon,k}}{\partial x_j^2}(x)$$

Therefore,

$$\Delta w(x) = \sum_{k,l} a_{k,l}^{\varepsilon}(\phi_{\varepsilon}(x)) \frac{\partial^2 \mathbf{w}}{\partial \mathbf{x}_k \partial \mathbf{x}_l}(\phi_{\varepsilon}(x)) + \sum_{k=1}^N b_k^{\varepsilon}(\phi_{\varepsilon}(x)) \frac{\partial \mathbf{w}}{\partial \mathbf{x}_k}(\phi_{\varepsilon}(x)),$$

where $a_{k,l}^{\varepsilon}: \Omega_e \longrightarrow \mathbb{R}$ and $b_k^{\varepsilon}: \Omega_e \longrightarrow \mathbb{R}$ are defined by:

$$\forall x \in \mathcal{U}_{\varepsilon}, \quad a_{kl}^{\varepsilon}(\phi_{\varepsilon}(x)) = \nabla \phi_{\varepsilon,k}(x) \cdot \nabla \phi_{\varepsilon,l}(x) \quad \text{and} \quad b_{k}^{\varepsilon}(\phi_{\varepsilon}(x)) = \Delta \phi_{\varepsilon,k}(x).$$

For $\mathbf{x} \in \Omega_e$ such that $\mathbf{d}(\mathbf{x}) \geq \varepsilon + \eta_0$, $\phi_{\varepsilon}(\mathbf{x}) = \mathbf{x}$ so that $a_{kl}^{\varepsilon}(\mathbf{x}) = \delta_{kl}$ and $b_k^{\varepsilon}(\mathbf{x}) = 0$. For $\mathbf{x} \in \Omega_e$ such that $\mathbf{d}(\mathbf{x}) \leq \varepsilon + \eta_0$, we have: $x = \phi_{\varepsilon}^{-1}(\mathbf{x}) \in \omega_{\eta_0}$ and:

$$\frac{\partial \phi_{\varepsilon,k}}{\partial x_j}(x) = \delta_{jk} + \varepsilon \left(\chi'(\mathbf{d}(x) - \varepsilon) \nu_j(\mathsf{P}(x)) \nu_k(\mathsf{P}(x)) + \chi(\mathbf{d}(x) - \varepsilon) \nabla \nu_k(\mathsf{P}(x)) \cdot \frac{\partial \mathsf{P}(x)}{\partial x_j} \right).$$

Thus, $a_{k,l}^{\varepsilon}(\mathbf{x}) = \delta_{kj} + \widetilde{a_{k,l}}^{\varepsilon}(\mathbf{x})$, where $\widetilde{a_{k,l}}^{\varepsilon}(\mathbf{x})$ is of order ε and tends uniformly to zero when ε tends to zero. In the same way, $b_k^{\varepsilon}(\mathbf{x})$ is of order ε and tends uniformly to zero when ε tends to zero. We denote, for $\mathbf{w} \in \mathrm{H}^2(\Omega_e)$:

$$\mathcal{K}^{\varepsilon} \mathsf{w} = \sum_{(k,l), \ k \neq l} a_{kl}^{\varepsilon} \frac{\partial^2 \mathsf{w}}{\partial \mathbf{x}_k \partial \mathbf{x}_l} + \sum_{k=1}^N b_k^{\varepsilon} \frac{\partial \mathsf{w}}{\partial \mathbf{x}_k},$$

so that

$$\Delta w(x) = (\Delta \mathsf{w} + \mathcal{K}^{\varepsilon} \mathsf{w}) \, (\phi_{\varepsilon}(x)),$$

and there exists a constant C such that for all $\varepsilon > 0$, for all $w \in H^2(\Omega_e)$, we have:

$$\|\mathcal{K}^{\varepsilon} \mathbf{w}\|_{\mathrm{L}^{2}(\Omega_{e})} \leq C \varepsilon \|\mathbf{w}\|_{\mathrm{H}^{2}(\Omega_{e})}.$$

For $\varepsilon \geq 0$, we denote by $\mathcal{L}^{\varepsilon}$ the operator $-\Delta$ defined on $\mathrm{H}^{2}(\mathcal{U}_{\varepsilon}) \cap \mathrm{H}^{1}_{0}(\mathcal{U}_{\varepsilon})$. This operator is positive and self-adjoint for the $\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})$ -scalar product. Its resolvent is compact, so that its spectrum only contains a sequence of real eigenvalues tending to $+\infty$.

Let us prove the following lemma:

Lemma 3.1. Let $\lambda_0 \in \text{Spec}(\mathcal{H}^0)$ and $\eta > 0$ such that $\text{Spec}(\mathcal{H}^0) \cap \overline{B(\lambda_0, \eta)} = \{\lambda_0\}$. Then there exists $\varepsilon_0 > 0$ such that for all $\varepsilon \in]0, \varepsilon_0[$,

$$\mathsf{Spec}(\mathcal{L}^{\varepsilon}) \cap \mathcal{C}(\lambda_0,\eta) = \emptyset.$$

Proof. If it is not the case, there exists a sequence of positive numbers $(\varepsilon_n)_n$ tending to zero when n tends to $+\infty$, there exists a sequence $(\xi_n)_n$ of points of $\mathcal{C}(\lambda_0, \eta)$, and there exists a sequence $(u_n)_n$ such that for all $n, u_n \in \mathrm{H}^2(\mathcal{U}_{\varepsilon_n}) \cap \mathrm{H}^1_0(\mathcal{U}_{\varepsilon_n})$ is an eigenvector of $\mathcal{L}^{\varepsilon}$ associated to the eigenvalue ξ_n .

We denote $u_n = u_n \circ (\phi_{\varepsilon_n})^{-1}$, so that we have:

(3.3)
$$\mathbf{u}_n \in \mathrm{H}^2(\Omega_e) \cap \mathrm{H}^1_0(\Omega_e) \text{ and } -\Delta \mathbf{u}_n - \mathcal{K}^{\varepsilon_n} \mathbf{u}_n = \xi_n \mathbf{u}_n.$$

Since $u_n \neq 0$, we can assume that $||u_n||_{\mathbf{H}^2(\Omega_e)} = 1$. Thus we can extract subsequences still denoted (ε_n) , (ξ_n) and (u_n) such that ξ_n tends to $\xi_\infty \in \mathcal{C}(\lambda_0, \eta)$ and u_n tends to u_∞ weakly in $\mathrm{H}^2(\Omega_e)$ and strongly in $\mathrm{H}^1(\Omega_e)$ by compactness of the embedding $\mathrm{H}^2(\Omega_e) \subset \mathrm{H}^1(\Omega_e)$.

By taking the weak limit in (3.3) and using (3.2), we obtain that

(3.4)
$$\mathsf{u}_{\infty} \in \mathrm{H}^{2}(\Omega_{e}) \cap \mathrm{H}^{1}_{0}(\Omega_{e}) \text{ and } -\Delta \mathsf{u}_{\infty} = \xi_{\infty} \mathsf{u}_{\infty}.$$

In addition, writing that $-\Delta u_n = \xi_n u_n + \mathcal{K}^{\varepsilon_n} u_n$, using again (3.2), we obtain that $-\Delta u_n$ tends strongly in $L^2(\Omega_e)$ to $-\Delta u_\infty$, so that u_n tends strongly to u_∞ in $H^2(\Omega_e)$. So, $\|u_\infty\|_{H^2(\Omega_e)} = 1$, thus $u_\infty \neq 0$ and by (3.4), we obtain that $\xi_\infty \in \text{Spec}(\mathcal{L}^0) \cap \mathcal{C}(\lambda_0, \eta)$, which is false.

With the previous lemma, for $\varepsilon > 0$ small enough, for all $\xi \in C(\lambda_0, \eta)$, $\mathcal{L}^{\varepsilon} - \xi \mathbb{I}$ is inversible. We give a uniform estimate of the resolvent operator in the following lemma:

Lemma 3.2. There exists $\varepsilon_0 > 0$ and C such that for all $\xi \in C(\lambda_0, \eta)$, for all $\varepsilon \in]0, \varepsilon_0[$, for all $f \in L^2(\mathcal{U}_{\varepsilon})$, there exists a unique $u \in H^2(\mathcal{U}_{\varepsilon}) \cap H^1_0(\mathcal{U}_{\varepsilon})$ such that $-\Delta u - \xi u = f$ in $\mathcal{U}_{\varepsilon}$. Moreover,

$$\|u\|_{\mathrm{H}^{2}(\mathcal{U}_{\varepsilon})} \leq C \|f\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})}.$$

Proof. If it is not the case, there exists a sequence (ε_n) tending to 0, a sequence $(\xi_n)_n$ of points of $\mathcal{C}(\lambda_0, \eta)$, a sequence (f_n) with $f_n \in L^2(\mathcal{U}_{\varepsilon_n})$ and $u_n \in H^2(\mathcal{U}_{\varepsilon_n}) \cap H^1_0(\mathcal{U}_{\varepsilon_n})$ such that $-\Delta u_n - \xi_n u_n = f_n$ in $\mathcal{U}_{\varepsilon_n}$ and:

$$\begin{split} \|u_n\|_{\mathrm{H}^2(\mathcal{U}_{\varepsilon_n})} &> n\|f_n\|_{\mathrm{L}^2(\mathcal{U}_{\varepsilon_n})}.\\ \text{We denote } \mathsf{u}_n &= u_n \circ (\phi_{\varepsilon_n})^{-1} \text{ and } \mathsf{f}_n = f_n \circ (\phi_{\varepsilon_n})^{-1}. \text{ We have:}\\ &-\Delta \mathsf{u}_n - \mathcal{K}^{\varepsilon_n} \mathsf{u}_n - \xi_n \mathsf{u}_n = \mathsf{f}_n \text{ in } \Omega_e \end{split}$$

and:

$$\|\mathbf{u}_n\|_{\mathrm{H}^2(\Omega_e)} > Cn \|\mathbf{f}_n\|_{\mathrm{L}^2(\Omega_e)}.$$

Since $u_n \neq 0$, we can divide by its $H^2(\Omega_e)$ -norm. We denote

$$\tilde{\mathsf{u}}_n = rac{\mathsf{u}_n}{\|\mathsf{u}_n\|_{\mathrm{H}^2(\Omega_e)}} \quad \mathrm{and} \quad \tilde{\mathsf{f}}_n = rac{\mathsf{f}_n}{\|\mathsf{u}_n\|_{\mathrm{H}^2(\Omega_e)}}.$$

We have, for all n:

$$\|\tilde{\mathsf{u}}_n\|_{\mathrm{H}^2(\Omega_e)} = 1 > n \|\tilde{\mathsf{f}}_n\|_{\mathrm{L}^2(\Omega_e)}$$

and

$$(3.5) \qquad -\Delta \tilde{u}_n - \mathcal{K}^{\varepsilon_n} \tilde{u}_n - \xi_n \tilde{u}_n = \tilde{f}_n \text{ in } \Omega_e.$$

By extracting a sub sequence, we can assume that ξ_n tends to $\xi_{\infty} \in C(\lambda_0, \eta)$, and \tilde{u}_n tends to a limit \tilde{u}_{∞} weakly in $H^2(\Omega_e)$ and strongly in $H^1(\Omega_e)$. In addition, we remark that \tilde{f}_n tends to zero strongly in $L^2(\Omega_e)$. Taking the weak limit in (3.5), we obtain that:

(3.6)
$$\tilde{u}_{\infty} \in \mathrm{H}^{2}(\Omega_{e}) \cap \mathrm{H}^{1}_{0}(\Omega_{e}) \quad \text{and} \quad -\Delta \tilde{u}_{\infty} - \xi_{\infty} \tilde{u}_{\infty} = 0 \text{ in } \Omega_{e}.$$

In addition, using (3.2) and (3.5), we obtain that $\Delta \tilde{u}_n$ converges strongly in $L^2(\Omega_e)$. Since its limit is the weak limit $\Delta \tilde{u}_\infty$, then \tilde{u}_n converges strongly in $H^2(\Omega_e)$ to \tilde{u}_∞ . So $\|\tilde{u}_\infty\|_{H^2(\Omega_e)} = 1$, and $\tilde{u}_\infty \neq 0$. Therefore, with (3.6), ξ_∞ is in Spec(\mathcal{L}^0), which leads to a contradiction.

Proof of Lemma 2.4

Inequality (2.46) is proved by duality arguments in [3] (see Lemma 2.1, on page 95). We use the same method and uniform estimates proved in Lemma 3.2 to establish (2.47). Let ε_0 given by Lemma 3.2. Let $\varepsilon \in (0, \varepsilon_0)$ and $\xi \in C(\lambda_0, \eta)$. We fix $v \in H^1(\mathcal{U}_{\varepsilon})$ such that $-\Delta v - \xi v$ belongs to $L^2(\mathcal{U}_{\varepsilon})$. Let $f \in L^2(\mathcal{U}_{\varepsilon})$. By Lemma 3.2, there exists $w \in H^2(\mathcal{U}_{\varepsilon}) \cap H^1_0(\mathcal{U}_{\varepsilon})$ such that $-\Delta w - \xi w = f$ in $\mathcal{U}_{\varepsilon}$. Moreover,

$$||w||_{\mathrm{H}^{2}(\mathcal{U}_{\varepsilon})} \leq C ||f||_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})},$$

where C does not depend on $\varepsilon,\,f$ or $\xi.$ We have:

$$\begin{split} \int_{\mathcal{U}_{\varepsilon}} vf &= \int_{\mathcal{U}_{\varepsilon}} v(-\Delta w - \xi w) = \int_{\mathcal{U}_{\varepsilon}} (-\Delta v - \xi v)w + \int_{\Gamma_{\varepsilon}} v \frac{\partial w}{\partial \nu}. \end{split}$$

Therefore:
$$\begin{aligned} \left| \int_{\mathcal{U}_{\varepsilon}} vf \right| &\leq \quad \| -\Delta v - \xi v\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})} \|w\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})} + \|v\|_{\mathrm{L}^{2}(\Gamma_{\varepsilon})} \|\frac{\partial w}{\partial \nu}\|_{\mathrm{L}^{2}(\Gamma_{\varepsilon})} \\ &\leq \quad C\left(\| -\Delta v - \xi v\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})} + \|v\|_{\mathrm{L}^{2}(\Gamma_{\varepsilon})}\right) \|f\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})} \end{split}$$

This is true for all $f \in \mathrm{L}^2(\mathcal{U}_\varepsilon)$ so: $\|v\|_{\mathrm{L}^2(\mathcal{U}_\varepsilon)} \leq$

$$\|v\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})} \leq C\left(\|-\Delta v - \xi v\|_{\mathrm{L}^{2}(\mathcal{U}_{\varepsilon})} + \|v\|_{\mathrm{L}^{2}(\Gamma_{\varepsilon})}\right).$$
