# SIGN-CHANGING STATIONARY SOLUTIONS AND BLOWUP FOR THE TWO POWER NONLINEAR HEAT EQUATION IN A BALL

Abstract. Consider the nonlinear heat equation

$$
\begin{equation*}
u_{t}=\Delta u+|u|^{p-1} u-|u|^{q-1} u, \tag{0.1}
\end{equation*}
$$

where $t \geq 0$ and $x \in \Omega$, the unit ball of $\mathbb{R}^{N}, N \geq 3$, with Dirichlet boundary conditions. Let $h$ be a radially symmetric, sign-changing stationary solution of (0.1). We prove that the solution of (0.1) with initial value $\lambda h$ blows up in finite time if $|\lambda-1|>0$ is sufficiently small and if $1<q<p<p_{S}=\frac{N+2}{N-2}$ and $p$ sufficiently close to $p_{S}$. This proves that the set of initial data for which the solution is global is not star-shaped around 0 .

## 1. Introduction

This paper studies finite-time blowup of sign-changing, regular solutions of the initial value problem

\end{array}\right.
$$

Here, $u=u(t, x) \in \mathbb{R}, t \geq 0, x \in \Omega$, and

\end{equation*}
$$

[^0]is the (open) unit ball of $\mathbb{R}^{N}$,
\[

Furthermore, we consider

1<q<p<p_{S} \tag{1.4}
\end{equation*}
$$

where

$$
\begin{equation*}
p_{S}=\frac{N+2}{N-2} \tag{1.5}
\end{equation*}
$$

It is well known that the initial value problem (1.1) is locally well-posed in $C_{0}(\Omega)$, where $C_{0}(\Omega)$ is the Banach space of continuous functions on $\bar{\Omega}$ that vanish on $\partial \Omega$, with the sup norm. More precisely, given $u_{0} \in C_{0}(\Omega)$, there exists a maximal time $0<T_{u_{0}} \leq \infty$ and a unique function $u \in C\left(\left[0, T_{u_{0}}\right), C_{0}(\Omega)\right) \cap C\left(\left(0, T_{u_{0}}\right), C^{2}(\bar{\Omega})\right) \cap C^{1}\left(\left(0, T_{u_{0}}\right), C_{0}(\Omega)\right)$ which is a classical solution of (1.1) on $\left(0, T_{u_{0}}\right)$ and such that $u(0)=u_{0}$. Furthermore if $T_{u_{0}}<\infty$, then $\lim _{t \uparrow T_{u_{0}}}\|u(t)\|_{\infty}=\infty$, and we say that $u$ blows up in finite time. In addition, if $v \in C\left([0, T), C_{0}(\Omega)\right) \cap C\left((0, T), C^{2}(\bar{\Omega})\right) \cap C^{1}\left((0, T), C_{0}(\Omega)\right)$ is a supersolution of (1.1), i.e $v_{t}-\Delta v \geq|v|^{p-1} v-|v|^{q-1} v, v_{\mid \partial \Omega} \geq 0$ and $v(0) \geq u_{0}$, then $v(t) \geq u(t)$ as long as both $u$ and $v$ are defined. The notion of subsolution is defined with reversed inequalities, yielding the analogous conclusion. See, for example Proposition 52.6 in [17].

We define the set $\mathcal{G}$ by

\mathcal{G}=\left\{u_{0} \in C_{0}(\Omega), T_{u_{0}}=\infty\right\}
$$

It is interesting to study the geometrical properties of the set $\mathcal{G}$. First of all we note that every solution $h$ of

-\Delta h=|h|^{p-1} h-|h|^{q-1} h  \tag{1.6}\\
h_{\mid \partial \Omega}=0
\end{array}\right.
$$

is a stationary, hence global, solution of (1.1), whose initial value is of course $u_{0}=h$, and so is in $\mathcal{G}$. Since the nonlinearity $|s|^{p-1} s-|s|^{q-1} s$ satisfies the properties of [3, Theorem 1.1, p. 15], it follows that the set $\mathcal{G}$ is not convex. As $u(t)=0$ is a solution of (1.1) one can ask if $\mathcal{G}$ has the weaker property of being star-shaped around 0 . The aim of this paper is to prove that $\mathcal{G}$ is not star-shaped.

This result is already well-known in the case of a single power nonlinearity

$$
\left\{\begin{array}{l}
u_{t}=\Delta u+|u|^{p-1} u  \tag{1.7}\\
u_{\mid \partial \Omega}=0
\end{array}\right.
$$

In particular, it is proved in [2] that if $h$ is a radially symmetric, sign-changing stationary solution of the problem (1.7), with $\Omega=B_{1}$, then the solution of (1.7) with initial value $\lambda h$ blows up in finite time if $|\lambda-1|>0$ is sufficiently small and if $p$ is subcritical and sufficiently close to $p_{S}=\frac{N+2}{N-2}$. More precisely, there exists $1<\underline{p}<p_{S}=\frac{N+2}{N-2}$ such that if $\underline{p}<p<p_{S}$
and if $h \in C_{0}(\Omega)$ is a radially symmetric, sign-changing stationary solution of (1.7), then there exists $\varepsilon>0$ such that if $0<|\lambda-1|<\epsilon$, then the classical solution of (1.7) with the initial condition $u(0)=\lambda h$ blows up in finite time. In particular, $\mathcal{G}$, for the problem (1.7), is not star-shaped.

The fact that $h$ changes sign is fundamental in this affirmation. In fact in the case where $h>0$ it follows from the comparison principle of the heat equation that if $0<\lambda \leq 1$, then the solution is global and if $\lambda>1$, then $u$ blows up in finite time. For an elementary proof of the case $\lambda>1$, see Theorem 17.8 in [17]. We remark, as was done in [2], that if $h$ changes sign, then $h$ and $\lambda h$ are not comparable if $\lambda \neq 1$.

In addition to the result in [2], it is known that $\mathcal{G}$ for the problem (1.7) is not star-shaped in several other circumstances :

- $N=3, \Omega=B_{1}$ and $p>1$ sufficiently near to 1 , see [4] ;
- $N \geq 3, \Omega$ is a general domain and $p<p_{S}$ sufficiently near to $p_{S}$ or $p=p_{S}$, see $[14,15]$;
- $N=2, \Omega=B_{1}$ or $\Omega$ is a general domain and $p$ sufficiently large, see $[8,9]$.

See $[5,6,7,10,11,12,16]$ for other properties of the set $\mathcal{G}$ for the problem (1.7).
We now turn to problem (1.1), and we recall the following explosion criterion, see $[2$, Proposition B.1, p. 447].

Proposition 1.1 ( [2, Proposition B.1, p. 447]). Let $\Omega \subset \mathbb{R}^{N}$ be a smooth bounded domain. Let $g \in C^{1}(\mathbb{R}, \mathbb{R})$ satisfy $g(0)=0$,

\begin{equation*}
s^{2} g^{\prime}(s) \geq(1+\epsilon) s g(s) \tag{1.8}
\end{equation*}
$$

and

$$
\begin{equation*}
|g(s)| \leq C\left(1+|s|^{\beta}\right) \tag{1.9}
\end{equation*}
$$

for all $s \in \mathbb{R}$, where $\epsilon>0$ and $1 \leq \beta<\frac{N+2}{N-2}$. Let $\psi \in C_{0}(\Omega)$ be a solution of the equation

$$
\left\{\begin{array}{l}
-\Delta \psi=g(\psi)  \tag{1.10}\\
\psi_{\mid \partial \Omega}=0
\end{array}\right.
$$

Let $u_{0} \in C_{0}(\Omega)$ and let $u \in C\left(\left[0, T_{u_{0}}\right) ; C_{0}(\Omega)\right)$ be the maximal solution of

$$
\left\{\begin{array}{l}
u_{t}=\Delta u+g(u),  \tag{1.11}\\
u_{\mid \partial \Omega}=0,
\end{array}\right.
$$

with the initial condition $u(0)=u_{0}$. If $\psi^{+} \neq 0$ and $u_{0} \geq \psi, u_{0} \neq \psi$, then $u$ blows up in finite time. Similarly if $\psi^{-} \neq 0$ and $u_{0} \leq \psi, u_{0} \neq \psi$, then $u$ blows up in finite time.

Remark 1.2. Note that if $1<q<p<p_{S}$, then $g(s)=|s|^{p-1} s-|s|^{q-1} s$ satisfies (1.8) with $\epsilon=q-1$ and (1.9) with $C$ sufficiently large and $\beta=p$.

It is immediate that if $h$ is a positive solution of (1.6) with $1<q<p<p_{S}$, and if $u$ is the solution of (1.1) with initial value $u(0)=\lambda h$, then for $0<\lambda \leq 1, u$ is global (by the comparison principle) and if $\lambda>1$, then $u$ blows up in finite time (by Proposition 1.1).

The question remains as to whether or not the result in [2], cited above, concerning sign-changing solutions to (1.7) also carries over to sign-changing solutions of (1.1).

The point of view in this paper is to fix a value of $q$ with

1<q<p_{S} \tag{1.12}
\end{equation*}
$$

and then consider all $p$ with

$$
\begin{equation*}
q<p<p_{S} \tag{1.13}
\end{equation*}
$$

In fact we will ultimately consider what happens as $p \rightarrow p_{S}$. The main purpose of this paper is to establish the following result.

Theorem 1. Assume (1.2)-(1.3). Given $1<q<p_{S}=\frac{N+2}{N-2}$. It follows that there exists $1<q<\underline{p}<p_{S}$ with the following property. If $\underline{p}<p<p_{S}$ and if $h_{p} \in C_{0}(\Omega)$ is a radially symmetric stationary solution of (1.1) which takes both positive and negative values, then there exist $0<\underline{\lambda}<1<\bar{\lambda}$ such that if $\underline{\lambda}<\lambda<\bar{\lambda}$ and $\lambda \neq 1$, then the classical solution of (1.1) with the initial condition $u(0)=\lambda h$ blows up in finite time.

The first observation is that there does exists a radially symmetric, sign-changing stationary solution of (1.1), since the nonlinearity $|s|^{p-1} s-|s|^{q-1} s$ satisfies the hypothesis of [13, Theorem 2 , p. 376]. More precisely, if we consider the problem:

$$
\left\{\begin{array}{l}
h^{\prime \prime}+\frac{N-1}{r} h^{\prime}+|h|^{p-1} h-|h|^{q-1} h=0  \tag{1.14}\\
h(0)=a>0, \quad h^{\prime}(0)=0
\end{array}\right.
$$

It is well-known by [13] that (1.14) admits a unique solution $h \in C^{2}([0, \infty), \mathbb{R})$, which we denote sometimes by $h_{p}(r, a)$ to emphasize the dependence on $a$. Recall that we are fixing a value of $q$ satisfying (1.12) and letting $p$ vary in the interval (1.13). Under these conditions, by Theorem 2 in [13] for all integer $m \geq 0$, there exists $a_{p, m}$ such that
a) $h_{p}\left(1, a_{p, m}\right)=0$,
b) $h_{p}\left(r, a_{p, m}\right)$ has precisely $m$ zeros in $(0,1)$.

In particular, $h_{p}\left(\cdot, a_{p, m}\right)$, considered as a function on $\Omega=B_{1}$, is a radially symmetric solution of (1.6) which changes sign precisely $m$ times.

Now, let $h_{p}$ be any nontrivial solution of (1.6) and consider the linearized operator $F_{p}$ on $L^{2}(\Omega)$ defined by

$$
\left\{\begin{array}{l}
D\left(F_{p}\right)=H^{2}(\Omega) \cap H_{0}^{1}(\Omega)  \tag{1.15}\\
F_{p} u=-\Delta u-\left(p\left|h_{p}\right|^{p-1}-q\left|h_{p}\right|^{q-1}\right) u, \quad u \in D\left(F_{p}\right) .
\end{array}\right.
$$

We recall the following result from [3].
Theorem 2 ([3, Corollary 2.5, p. 18]). Let $h_{p} \in C_{0}(\Omega)$ be a sign-changing solution of (1.6). Let $\varphi_{p}$ be a positive eigenvector of the self-adjoint operator $F_{p}$ given by (1.15), corresponding to the first eigenvalue. Suppose that

$$
\int_{\Omega} h_{p} \varphi_{p} \neq 0
$$

It follows that there exists $\epsilon>0$ such that if $0<|1-\lambda|<\epsilon$, then the solution of (1.1) with the initial value $u_{0}=\lambda h_{p}$ blows up in finite time.

To prove Theorem 1, it thus suffices to establish the following.
Theorem 3. Assume (1.2)-(1.3). Given $1<q<p_{S}=\frac{N+2}{N-2}$. It follows that there exists $1<q<\underline{p}<p_{S}$ with the following property. If $\underline{p}<p<p_{S}$ and if $h_{p} \in C_{0}(\Omega)$ is a radially symmetric stationary solution of (1.1) which takes both positive and negative values, then

$$
\int_{\Omega} h_{p} \varphi_{p} \neq 0
$$

Where $\varphi_{p}$ is a positive eigenvector of the self-adjoint operator $F_{p}$ given by (1.15), corresponding to the first eigenvalue.

The proof of Theorem 3 is based on rescaling argument. Contrary to the case of single power nonlinearity, a rescaled function $v_{p}$ defined by (2.4) below in terms of $h_{p}$, where $h_{p}$ is a radially symmetric stationary solution of (1.1) doesn't satisfy the same differential equation satisfied by $h_{p}$, which make the situation more difficult. Also, unlike the case of the single power nonlinearity, there exist some solutions $v_{p}(r)$ of the problem (2.5) below which do not tend to zero as $r \rightarrow \infty$.

The rest of the paper is devoted to proving Theorem 3, which as already noted, implies Theorem 1 when combined with Theorem 2. Our basic approach follows that in [2]. However because of the differences just noted between the single power and the two power cases, many of the arguments in [2] do not immediately apply for the current situation.

Remark 1.3. The results in this paper are equally valid for

$$
u_{t}=\Delta u+|u|^{p-1} u-c|u|^{q-1} u
$$

for any $c>0$. The case where $c<0$ is not as clear, since in that case, the proof of Proposition 2.1 below is no longer valid.

## 2. Stationary solutions

The proof of Theorem 3 exploits strongly the radial symmetry of the stationary solutions. By abuse of notation we will use the same letter, for example $h$, to denote a radially symmetric function $h: \mathbb{R}^{N} \rightarrow \mathbb{R}$, and the corresponding function $h:[0, \infty) \rightarrow \mathbb{R}$ such that, $h(x)=h(|x|), \forall x \in \mathbb{R}^{N}$. Throughout this paper, we will use this convention without further comment.

Any radially symmetric solution $h_{p} \in C_{0}(\Omega)$ of (1.6) satisfies the ODE

$$
\left\{\begin{array}{l}
h_{p}^{\prime \prime}+\frac{N-1}{r} h_{p}^{\prime}+\left|h_{p}\right|^{p-1} h_{p}-\left|h_{p}\right|^{q-1} h_{p}=0  \tag{2.1}\\
h_{p}^{\prime}(0)=h_{p}(1)=0
\end{array}\right.
$$

Since $h_{p} \neq 0$, it follows by uniqueness for the ODE (2.1) that $h_{p}(0) \neq 0$. Therefore, since if $u$ satisfies (1.1) then $-u$ satisfies the same problem, it suffice to prove Theorem 3 under the additional assumption

$$
\begin{equation*}
h_{p}(0)>0 . \tag{2.2}
\end{equation*}
$$

In the rest of this paper we set

$$
h_{p}(0)=a_{p}>0
$$

Clearly $h_{p}(r)=h_{p}\left(r, a_{p}\right)$, where $h_{p}\left(., a_{p}\right)$ is the solution of (1.14) with $a=a_{p}$. We let $\lambda_{p}>0$ be such that

$$
\begin{equation*}
\lambda_{p}^{\frac{2}{p-1}}=a_{p} \tag{2.3}
\end{equation*}
$$

also we define

$$
\begin{equation*}
v_{p}(r)=\lambda_{p}^{-\frac{2}{p-1}} h_{p}\left(\frac{r}{\lambda_{p}}, \lambda_{p}^{\frac{2}{p-1}}\right) \tag{2.4}
\end{equation*}
$$

A simple calculation shows that $v_{p}$ satisfies

$$
\left\{\begin{array}{l}
v^{\prime \prime}+\frac{N-1}{r} v^{\prime}+|v|^{p-1} v-\lambda_{p}^{-\frac{2}{p-1}(p-q)}|v|^{q-1} v=0  \tag{2.5}\\
v(0)=1, \quad v^{\prime}(0)=0
\end{array}\right.
$$

As such, $v_{p}$ may be considered as a function $[0, \infty) \rightarrow \mathbb{R}$. It is known by $[13$, Lemma $1, \mathrm{p}$. 371] that $a_{p} \geq 1$. In fact, if $0<a_{p} \leq\left(\frac{p+1}{q+1}\right)^{\frac{1}{p-q}}$ then $h_{p}\left(r, a_{p}\right)>0$ for all $r>0$. Thus,

$$
\begin{equation*}
\lambda_{p} \geq 1 \tag{2.6}
\end{equation*}
$$

We have also

$$
\begin{equation*}
v_{p}\left(\lambda_{p}\right)=0 \tag{2.7}
\end{equation*}
$$

Proposition 2.1. Let $\lambda_{p}$ defined in (2.3), then

$$
\begin{equation*}
\lambda_{p} \underset{p \rightarrow p_{S}}{\longrightarrow} \infty \tag{2.8}
\end{equation*}
$$

Proof. Suppose to the contrary that $\lambda_{p} \nrightarrow \infty$ as $p \rightarrow p_{S}$. It follows that there exists a subsequence $\left(p_{k}\right)$ such that $p_{k} \underset{k \rightarrow \infty}{\longrightarrow} p_{S}$ and

$$
\begin{equation*}
\lambda_{p_{k}} \underset{k \rightarrow \infty}{\longrightarrow} \bar{\lambda} \tag{2.9}
\end{equation*}
$$

where $1 \leq \bar{\lambda}<\infty$, by (2.6). By continuous dependence it follows that

$$
\begin{equation*}
v_{p_{k}} \underset{k \rightarrow \infty}{\longrightarrow} \bar{v} \tag{2.10}
\end{equation*}
$$

uniformly on all compact intervals $[0, M] \subset[0, \infty)$, where $\bar{v}$ satisfies

$$
\left\{\begin{array}{l}
\bar{v}^{\prime \prime}+\frac{N-1}{r} \bar{v}^{\prime}+|\bar{v}|^{p_{S}-1} \bar{v}-\bar{\lambda}^{-\frac{2}{p_{S}-1}\left(p_{S}-q\right)}|\bar{v}|^{q-1} \bar{v}=0,  \tag{2.11}\\
\bar{v}(0)=1, \quad \bar{v}^{\prime}(0)=0
\end{array}\right.
$$

It follows from (2.7), (2.9) and (2.10) that

$$
\begin{equation*}
\bar{v}(\bar{\lambda})=0 . \tag{2.12}
\end{equation*}
$$

And so $\bar{v}$ satisfies the equation

$$
\left\{\begin{array}{l}
-\Delta \bar{v}=|\bar{v}|^{p_{S}-1} \bar{v}-\bar{\lambda}^{-\frac{2}{p_{S}-1}\left(p_{S}-q\right)}|\bar{v}|^{q-1} \bar{v}  \tag{2.13}\\
\bar{v}_{\mid \partial B(0, \bar{\lambda})}=0
\end{array}\right.
$$

If we apply the Pohozaev identity as was done in [1, Remark 1.2, p. 442], and if we set $g(u)=|u|^{p_{S}-1} u-\bar{\lambda}^{-\frac{2}{p_{S}-1}}\left(p_{S}-q\right)|u|^{q-1} u$ and $G(u)=\frac{|u|^{p_{S}+1}}{p_{S}+1}-\bar{\lambda}^{-\frac{2}{p_{S}-1}\left(p_{S}-q\right)} \frac{|u|^{q+1}}{q+1}$, we obtain

$$
\begin{align*}
\frac{2-N}{2} \int_{B(0, \bar{\lambda})} g(\bar{v}) \bar{v}+N \int_{B(0, \bar{\lambda})} G(\bar{v}) & =\bar{\lambda}^{-\frac{2}{p_{S}-1}\left(p_{S}-q\right)}\left[\frac{N-2}{2}-\frac{N}{q+1}\right] \int_{B(0, \bar{\lambda})}|\bar{v}|^{q+1} \\
& =\frac{1}{2} \int_{\partial B(0, \bar{\lambda})}(x . \nu)\left(\frac{\partial \bar{v}}{\partial \nu}\right)^{2} \geq 0 \tag{2.14}
\end{align*}
$$

From (2.14), one can conclude that

$$
\begin{equation*}
0 \leq\left(\frac{N-2}{2}-\frac{N}{q+1}\right) \bar{\lambda}^{-\frac{2}{p_{S}-1}\left(p_{S}-q\right)}\|\bar{v}\|_{L^{q+1}(B(0, \bar{\lambda}))}^{q+1} \tag{2.15}
\end{equation*}
$$

Since $q<p_{S}$ inequality (2.15) is possible only if $\bar{v}=0$, which contradicts $\bar{v}(0)=1$.

Let now $w_{p}$ be the solution of

$$
\left\{\begin{array}{l}
w^{\prime \prime}+\frac{N-1}{r} w^{\prime}+|w|^{p-1} w=0  \tag{2.16}\\
w(0)=1, \quad w^{\prime}(0)=0
\end{array}\right.
$$

It is well-known and easy to verify that $w_{p_{S}}$ given by

$$
\begin{equation*}
w_{p_{S}}(r)=\left(1+\frac{1}{N(N-2)} r^{2}\right)^{-\frac{N-2}{2}} \tag{2.17}
\end{equation*}
$$

is the solution of (2.16) with $p=p_{S}$.
Proposition 2.2. Let $v_{p}$ defined by (2.4) and $w_{p_{S}}$ by (2.17), then

$$
\begin{equation*}
v_{p} \underset{p \rightarrow p_{S}}{ } w_{p_{S}} \tag{2.18}
\end{equation*}
$$

uniformly on bounded sets of $[0, \infty)$.
Proof. By Proposition $2.1 \lambda_{p} \rightarrow \infty$ as $p \rightarrow p_{S}$, and so by continuous dependence we can conclude that

$$
v_{p} \underset{p \rightarrow p_{S}}{\longrightarrow} w_{p_{S}}
$$

uniformly on bounded sets of $[0, \infty)$.

Proposition 2.3. Given $1<q<p_{S}$ and $0<\eta<p_{S}-q$. There exist $M, C>0$ such that for all $p \in\left[q+\eta, p_{S}\right)$ and $r \geq 0$,

\begin{equation*}
\left|v_{p}(r)\right| \leq M \text { and }\left|v_{p}^{\prime}(r)\right| \leq C \tag{2.19}
\end{equation*}
$$

\frac{1}{2} v_{p}^{\prime}(r)^{2}+\frac{1}{p+1}\left|v_{p}(r)\right|^{p+1}-\frac{1}{q+1} \lambda_{p}^{-\frac{2}{p-1}(p-q)}\left|v_{p}(r)\right|^{q+1} & \leq \frac{1}{p+1}-\frac{1}{q+1} \lambda_{p}^{-\frac{2}{p-1}(p-q)} \\
& \leq \frac{1}{p+1} \tag{2.21}
\end{align*}
$$

Now since $\lambda_{p}$ satisfies (2.6), it follows from (2.21) that

The following lemma is one of the key points which differ from the calculations in [2]. Compare Lemma 3.3 in [2]. Indeed, Lemma 3.3 in [2] cannot be true in the present context since not all solutions $v_{p}$ of (2.5) tend to 0 as $r \rightarrow \infty$. We do obtain, however, a similar estimate, valid only for $r \leq \lambda_{p}$.

Lemma 2.4. Given $1<q<p_{S}$ and $0<\eta<p_{S}-q$. There exists a constant $\gamma=\gamma(N, q)$ such that

= & -\frac{N-2}{r} v_{p}^{\prime}(r)^{2}-\frac{1}{r^{2}} v_{p}(r) v_{p}^{\prime}(r)+\frac{1}{r} v_{p}(r) v_{p}^{\prime \prime}(r) \\
= & -\frac{N-2}{r} v_{p}^{\prime}(r)^{2}-\frac{1}{r^{2}} v_{p}(r) v_{p}^{\prime}(r)+ \\
& \quad \frac{1}{r} v_{p}(r)\left[-\frac{N-1}{r} v_{p}^{\prime}(r)-\left|v_{p}(r)\right|^{p-1} v_{p}(r)+\lambda_{p}^{-\frac{2}{p-1}(p-q)}\left|v_{p}(r)\right|^{q-1} v_{p}(r)\right] .
\end{aligned}
$$

From (2.19), (1.3), the fact that $1 \leq r \leq \lambda_{p}, 1<q<p$, Young's inequality (applied twice) and denoting $\alpha:=\frac{p-q}{p+1}+\frac{2}{p-1}(p-q)$, one can find the estimate

& \quad+\lambda_{p}^{-\frac{2}{p-1}(p-q)} \frac{q}{(q+1) r}\left|v_{p}(r)\right|^{q+1} \\
& \leq-\frac{2 N-5}{2 r} v_{p}^{\prime}(r)^{2}-\frac{p}{(p+1) r}\left|v_{p}(r)\right|^{p+1}+\frac{1}{2}\left[\frac{(N-1)^{2}}{r^{3}} v_{p}(r)^{2}+\frac{1}{r} v_{p}^{\prime}(r)^{2}\right] \\
& \quad+\frac{q}{q+1}\left|v_{p}(r)\right|^{q+1} r^{-\frac{q+1}{p+1}} r^{-\alpha} \\
& \leq \frac{(N-1)^{2}}{2 r^{3}} v_{p}(r)^{2}-\frac{p}{(p+1) r}\left|v_{p}(r)\right|^{p+1} \\
& \quad+\frac{q}{(p+1) r}\left|v_{p}(r)\right|^{p+1}+\frac{q(p-q)}{(q+1)(p+1)} r^{-\alpha \frac{p+1}{p-q}} \\
& \leq \frac{(N-1)^{2}}{2 r^{3}} M^{2}+\frac{q\left(p_{S}-q\right)}{(q+1)^{2}} r^{-\alpha \frac{p+1}{p-q}} .
\end{aligned}
$$

Now since $\alpha \frac{p+1}{p-q}=1+2 \frac{p+1}{p-1} \geq 3$, we obtain that for $1 \leq r \leq \lambda_{p}$

One can conclude now for all $s \in\left[1, \lambda_{p}\right]$, for all $p \in\left[q+\eta, p_{S}\right)$ that

& \leq \frac{1}{q+1} \frac{1}{r^{\frac{2}{p_{S}-1} \eta}} M^{q+1}+\frac{M \cdot C}{r}+B \frac{1}{r}
\end{aligned}
$$

Finally, using (2.19) one can conclude that there exists $\gamma>0$ such that

It follows from (2.18) that there exists $p_{0} \leq \bar{p}<p_{S}$ such that if $\bar{p}<p<p_{S}$ then

## 3. The linearized operator

We have also that $l_{p}$ is the first eigenvalue associated to the eigenvector $\psi_{p}$ of the self-adjoint operator $L_{p}$ defined on $L^{2}\left(\Omega_{p}\right)$ by

for all $w \in H_{0}^{1}\left(\Omega_{p}\right)$, so that

Proposition 3.1 ( [2, Proposition 3.4, p. 439]). If $L_{*}$ is defined by (3.14) and $\lambda_{*}$ is defined by (3.15), then the following properties hold.
(i) $\lambda_{*}<0$ and $\lambda_{*}$ is an eigenvalue of $L_{*}$.
(ii) There exists a unique eigenvector $\psi_{*}$ of $L_{*}$ corresponding to the eigenvalue $\lambda_{*}$ which is positive, radially decreasing with $\left\|\psi_{*}\right\|_{L^{2}\left(\mathbb{R}^{N}\right)}=1$.
(iii) If $\left(u_{n}\right)_{n \geq 1} \subset H^{1}\left(\mathbb{R}^{N}\right)$ is a minimizing sequence of (3.15) and $u_{n} \geq 0$, then $u_{n} \rightarrow \psi_{*}$ in $L^{2}\left(\mathbb{R}^{N}\right)$ as $n \rightarrow \infty$.

& =l_{p}+\int_{\mathbb{R}^{N}}\left[p\left|\widetilde{v}_{p}\right|^{p-1}-p_{S} w_{p_{S}}^{p_{S}-1}\right] \widetilde{\psi}_{p}^{2}-q \lambda_{p}^{-\frac{2}{p-1}(p-q)} \int_{\mathbb{R}^{N}}\left|\widetilde{v}_{p}\right|^{q-1} \widetilde{\psi}_{p}^{2} \tag{3.22}
\end{align*}

It follows from (3.22), Proposition 2.3 and (3.18) that

\lambda_{*}-l_{p} \leq\left\|p\left|\widetilde{v}_{p}\right|^{p-1}-p_{S} w_{p_{S}}^{p_{S}-1}\right\|_{L^{\infty}\left(\mathbb{R}^{N}\right)}+q M^{q-1} \lambda_{p}^{-\frac{2}{p-1}(p-q)}, \forall p \in\left[q+\eta, p_{S}\right) \tag{3.23}
\end{equation*}
$$

One can conclude now by applying Proposition 2.6 and Proposition 2.1 that

$$
\begin{equation*}
\limsup _{p \rightarrow p_{S}}\left(\lambda_{*}-l_{p}\right) \leq 0 \tag{3.24}
\end{equation*}
$$

Next, we would like to use $\psi_{*}$ as a test function in (3.13), but $\psi_{*} \notin H_{0}^{1}\left(\Omega_{p}\right)$. Thus, we need to approximate $\psi_{*}$ by a sequence in $H_{0}^{1}\left(\Omega_{p}\right)$. Consider a smooth radial cut-off function $\eta: \mathbb{R}^{N} \rightarrow[0,1]$ such that $\eta(r)=1$ for $r \leq \frac{1}{2}$ and $\eta(r)=0$ for $r \geq 1$. Setting

$$
\begin{equation*}
k_{p}(r)=\eta\left(\frac{r}{\lambda_{p}}\right) \psi_{*}(r) \tag{3.25}
\end{equation*}
$$

and

$$
\begin{equation*}
u_{p}=\frac{k_{p}}{\left\|k_{p}\right\|_{L^{2}\left(\mathbb{R}^{N}\right)}} \tag{3.26}
\end{equation*}
$$

it follows from Lemma 3.2 (since $\lambda_{p} \rightarrow \infty$ as $p \rightarrow p_{S}$ ) that

$$
\begin{equation*}
\left\|u_{p}-\psi_{*}\right\|_{H^{1}\left(\mathbb{R}^{N}\right)} \underset{p \rightarrow p_{S}}{\longrightarrow} 0 \tag{3.27}
\end{equation*}
$$

Moreover $u_{p} \in H_{0}^{1}\left(\Omega_{p}\right)$, so that

$$
\begin{equation*}
l_{p} \leq J_{p}\left(u_{p}\right)=\lambda_{*}-J_{*}\left(\psi_{*}\right)+J_{*}\left(u_{p}\right)-J_{*}\left(u_{p}\right)+J_{p}\left(u_{p}\right) . \tag{3.28}
\end{equation*}
$$

On the one hand we have by Proposition 2.6 and Proposition 2.1 that

$$
\begin{align*}
\left|J_{*}\left(u_{p}\right)-J_{p}\left(u_{p}\right)\right| & =\left|\int_{\mathbb{R}^{N}}\left[p\left|\widetilde{v}_{p}\right|^{p-1}-q \lambda_{p}^{-\frac{2}{p-1}(p-q)}\left|\widetilde{v}_{p}\right|^{q-1}-p_{S} w_{p_{S}}^{p_{S}-1}\right] u_{p}{ }^{2}\right| \\
& \leq\left.\int_{\mathbb{R}^{N}}|p| \widetilde{v}_{p}\right|^{p-1}-\left.p_{S} w_{p_{S}}^{p_{S}-1}\left|u_{p}^{2}+q \lambda_{p}^{-\frac{2}{p-1}(p-q)} \int_{\mathbb{R}^{N}}\right| \widetilde{v}_{p}\right|^{q-1} u_{p}^{2} \\
& \leq\left\|p\left|\widetilde{v}_{p}\right|^{p-1}-p_{S} w_{p_{S}}^{p_{S}-1}\right\|_{L^{\infty}\left(\mathbb{R}^{N}\right)}+q M^{q-1} \lambda_{p}^{-\frac{2}{p-1}(p-q)} \xrightarrow[p \rightarrow p_{S}]{\longrightarrow} 0 .(3 \tag{3.29}
\end{align*}
$$

On the other hand, using the fact that $\left|J_{*}\left(\psi_{*}\right)-J_{*}\left(u_{p}\right)\right| \leq\left|\left\|\nabla u_{p}\right\|_{L^{2}\left(\mathbb{R}^{N}\right)}^{2}-\left\|\nabla \psi_{*}\right\|_{L^{2}\left(\mathbb{R}^{N}\right)}^{2}\right|+$ $p_{S} \int_{\mathbb{R}^{N}}\left|u_{p}^{2}-\psi_{*}^{2}\right|$, it easily follows from (3.27) and the dominated convergence theorem that

$$
\begin{equation*}
\left|J_{*}\left(\psi_{*}\right)-J_{*}\left(u_{p}\right)\right| \underset{p \rightarrow p_{S}}{\longrightarrow} 0 \tag{3.30}
\end{equation*}
$$

We deduce from (3.29) and (3.30) that

$$
\begin{equation*}
-\liminf _{p \rightarrow p_{S}}\left(\lambda_{*}-l_{p}\right)=\limsup _{p \rightarrow p_{S}}\left(l_{p}-\lambda_{*}\right) \leq 0 . \tag{3.31}
\end{equation*}
$$

We can confirm so by (3.24) and (3.31) that

$$
\liminf _{p \rightarrow p_{S}}\left(\lambda_{*}-l_{p}\right)=\limsup _{p \rightarrow p_{S}}\left(\lambda_{*}-l_{p}\right)=\lim _{p \rightarrow p_{S}}\left(\lambda_{*}-l_{p}\right)=0 .
$$

The result follows now.

Lemma 3.4. Given $q \in\left(1, p_{S}\right)$ and $\eta \in\left(0, p_{S}-q\right)$. There exists $C>0$ such that

$$
\begin{equation*}
\left|\widetilde{\psi}_{p}(r)\right|+\left|\psi_{*}(r)\right| \leq C \frac{1}{r^{\frac{N-1}{2}}} \leq C \tag{3.32}
\end{equation*}
$$

for all $r \geq 1$ and $q+\eta \leq p<p_{S}$.

Proof. Fix $q \in\left(1, p_{S}\right)$ and $\eta \in\left(0, p_{S}-q\right)$. We affirm first that

$$
\begin{equation*}
l_{p}<0 \quad \text { for all } p \in\left(q, p_{S}\right) \tag{3.33}
\end{equation*}
$$

In fact, since $l_{p}$ satisfies (3.6), it suffice to prove that $\theta_{p}<0$. We have on the one hand since $p>q$

$$
\begin{align*}
\left(\int_{\Omega_{p}} h_{p}^{2}\right) \theta_{p} & \leq \int_{\Omega_{p}}\left|\nabla h_{p}\right|^{2}-\int_{\Omega_{p}}\left(p\left|h_{p}\right|^{p-1}-q\left|h_{p}\right|^{q-1}\right) h_{p}^{2} \\
& \leq \int_{\Omega_{p}}\left|\nabla h_{p}\right|^{2}-q \int_{\Omega_{p}}\left(\left|h_{p}\right|^{p+1}-\left|h_{p}\right|^{q+1}\right) \tag{3.34}
\end{align*}
$$

On the other hand since $h_{p}$ satisfies (2.1) it follows that

$$
\begin{equation*}
\int_{\Omega_{p}}\left|\nabla h_{p}\right|^{2}=\int_{\Omega_{p}}\left(\left|h_{p}\right|^{p+1}-\left|h_{p}\right|^{q+1}\right) \tag{3.35}
\end{equation*}
$$

It follows from (3.34) and (3.35) since $q>1$ that $\theta_{p}<0$.
We complete now our proof. Since $l_{p}<0$, we deduce from (3.13) and Proposition 2.3 that

$$
\begin{equation*}
\left\|\nabla \widetilde{\psi}_{p}\right\|_{L^{2}\left(\mathbb{R}^{N}\right)}^{2} \leq p_{S}\left(M^{q-1}+M^{p_{S}-1}\right), \quad \forall p \in\left[q+\eta, p_{S}\right) \tag{3.36}
\end{equation*}
$$

By (3.18), (3.36) and Strauss' radial lemma [18] that

$$
\begin{equation*}
\left|\widetilde{\psi}_{p}(r)\right| \leq c \sqrt{1+p_{S}\left(M^{q-1}+M^{p_{S}-1}\right)} \frac{1}{r^{\frac{N-1}{2}}} \tag{3.37}
\end{equation*}
$$

for all $r \geq 1$.
A similar argument applies to $\psi_{*}$ which completes the proof.

Lemma 3.5. Given $q \in\left(1, p_{S}\right)$ and $\eta \in\left(0, p_{S}-q\right)$. There exist $R, C>0, \theta>0$ and $q+\eta \leq p_{0}<p_{S}$ such that

$$
\begin{equation*}
\left|\widetilde{\psi}_{p}(r)\right|+\left|\psi_{*}(r)\right| \leq C e^{-\theta r} \tag{3.38}
\end{equation*}
$$

for all $r \geq R$ and $p_{0} \leq p<p_{S}$.
Proof. Fix $q \in\left(1, p_{S}\right)$ and $\eta \in\left(0, p_{S}-q\right)$. We start first by showing that there exists $R$, $C>0, \theta>0$ and $q+\eta \leq p_{0}<p_{S}$ such that

$$
\begin{equation*}
\left|\psi_{p}(r)\right| \leq C e^{-\theta r} \tag{3.39}
\end{equation*}
$$

for all $r \geq R$ (with $r \leq \lambda_{p}$ ) and $p_{0} \leq p<p_{S}$. It follows from (3.8) that $\psi_{p}$ satisfies

$$
\begin{equation*}
-\psi_{p}^{\prime \prime}(r)-\frac{N-1}{r} \psi_{p}^{\prime}(r)-\left\{\left[p\left|\widetilde{v}_{p}(r)\right|^{p-1}-q \lambda_{p}^{-\frac{2}{p-1}(p-q)}\left|\widetilde{v}_{p}(r)\right|^{q-1}\right]+l_{p}\right\} \psi_{p}(r)=0, \tag{3.40}
\end{equation*}
$$

for all $0 \leq r<\lambda_{p}$. We would like to use a method of energy in equation (3.40), but the term $-\left[p\left|\widetilde{v}_{p}(r)\right|^{p-1}-q \lambda_{p}^{-\frac{2}{p-1}(p-q)}\left|\widetilde{v}_{p}(r)\right|^{q-1}\right]-l_{p}$ is difficult to handle so we may estimate it. On the one hand, since $\left.\left.|p| \widetilde{v}_{p}(r)\right|^{p-1}-q \lambda_{p}^{-\frac{2}{p-1}(p-q)}\left|\widetilde{v}_{p}(r)\right|^{q-1} \right\rvert\, \leq L(r) \underset{r \rightarrow \infty}{\longrightarrow} 0$ by Corollary 2.5 and the fact that $p \in\left[q+\eta, p_{S}\right)$, it follows that there exists $R>0$, such that for all $r \geq R$

$$
\begin{equation*}
-\left[p\left|\widetilde{v}_{p}(r)\right|^{p-1}-q \lambda_{p}^{-\frac{2}{p-1}(p-q)}\left|\widetilde{v}_{p}(r)\right|^{q-1}\right] \geq \frac{\lambda_{*}}{4} \tag{3.41}
\end{equation*}
$$

On the other hand, since $-l_{p} \rightarrow-\lambda_{*}$ as $p \rightarrow p_{S}$ by Lemma 3.3, it follows that there exists $p_{0} \in\left[q+\eta, p_{S}\right)$ such that for all $p_{0} \leq p<p_{S}$

$$
\begin{equation*}
-l_{p} \geq-\frac{3}{4} \lambda_{*} \tag{3.42}
\end{equation*}
$$

Finally one can conclude from (3.41) and (3.42) that there exist $R>0$ and $q+\eta \leq p_{0}<p_{S}$ such that

$$
\begin{equation*}
-\left[p\left|\widetilde{v}_{p}(r)\right|^{p-1}-q \lambda_{p}^{-\frac{2}{p-1}(p-q)}\left|\widetilde{v}_{p}(r)\right|^{q-1}\right]-l_{p} \geq-\frac{\lambda_{*}}{2}>0 \tag{3.43}
\end{equation*}
$$

for all $p_{0} \leq p<p_{S}$ and all $r \geq R$. By choosing $p_{0}$ possibly larger, we also may assume that $\lambda_{p}>R$ for $p_{0} \leq p<p_{S}$. Since $\psi_{p} \geq 0$, we deduce from (3.40) and (3.43) that

$$
\begin{equation*}
\psi_{p}^{\prime \prime}+\frac{N-1}{r} \psi_{p}^{\prime} \geq-\frac{\lambda_{*}}{2} \psi_{p} \tag{3.44}
\end{equation*}
$$

for all $R \leq r \leq \lambda_{p}$. We now claim that

$$
\begin{equation*}
\psi_{p}^{\prime}(r)<0 \tag{3.45}
\end{equation*}
$$

for all $p_{0} \leq p<p_{S}$ and all $R<r<\lambda_{p}$. We argue by contradiction and suppose that $\psi_{p}^{\prime}\left(r_{p}\right) \geq 0$ for some $p_{0} \leq p<p_{S}$ and some $R<r_{p}<\lambda_{p}$. Since $\psi_{p}\left(\lambda_{p}\right)=0$, there exists $r_{p} \leq r_{p}^{\prime}<\lambda_{p}$ such that $\psi_{p}^{\prime}\left(r_{p}^{\prime}\right)=0$ and $\psi_{p}^{\prime \prime}\left(r_{p}^{\prime}\right) \leq 0$. This is impossible by (3.44) since $\lambda *<0$. Multiplying (3.44) by $\psi_{p}^{\prime}<0$, see that

$$
\psi_{p}^{\prime \prime} \psi_{p}^{\prime}+\frac{N-1}{r} \psi_{p}^{\prime} \psi_{p}^{\prime} \leq-\frac{\lambda_{*}}{2} \psi_{p} \psi_{p}^{\prime}
$$

which implies

$$
\begin{equation*}
\left(\psi_{p}^{\prime 2}+\frac{\lambda_{*}}{2} \psi_{p}^{2}\right)^{\prime} \leq 0 \tag{3.46}
\end{equation*}
$$

for $R \leq r \leq \lambda_{p}$. It follows from (3.46) that

$$
\left[\psi_{p}^{\prime 2}+\frac{\lambda_{*}}{2} \psi_{p}^{2}\right](r) \geq \psi_{p}^{\prime}\left(\lambda_{p}\right)^{2} \geq 0
$$

for $R<r<\lambda_{p}$. Since $\psi_{p}>0$ and $\psi_{p}^{\prime}<0$, we obtain that $\psi_{p}^{\prime}+\sqrt{-\frac{\lambda_{*}}{2}} \psi_{p} \leq 0$ for $R<r<\lambda_{p}$, so that

$$
\psi_{p}(r) \leq \psi_{p}(R) e^{\sqrt{-\frac{\lambda_{*}}{2}} R} e^{-\sqrt{-\frac{\lambda_{*}}{2}} r}
$$

for $R<r<\lambda_{p}$. By choosing $R \geq 1$ we have $\psi_{p}(R) \leq C$ by Lemma 3.4. The exponential decay follows. As remarked in [2], the proof for $\psi_{*}$ is similar. This completes the proof.

Lemma 3.6. $\tilde{\psi}_{p}$ and $\psi_{*} \in L^{1}\left(\mathbb{R}^{N}\right)$. Moreover, $\left\|\tilde{\psi}_{p}-\psi_{*}\right\|_{L^{1}\left(\mathbb{R}^{N}\right)} \rightarrow 0$ as $p \rightarrow p_{S}$.
Proof. The proof is similar to the proof of Lemma 3.7 in [2].

Proof of Theorem 3. Fix $q \in\left(1, p_{S}\right)$ and $0<\eta<p_{S}-q$. Let $h_{p} \in C_{0}(\Omega)$ be a radially symmetric, sign-changing stationary solution of (1.1). Let $\varphi_{p}$ be the positive eigenvector normalized in $L^{2}(\Omega)$ of the self-adjoint operator $F_{p}$ given by (3.1), corresponding to the first eigenvalue. We have from Proposition 2.3

$$
\begin{aligned}
\left|\int_{\Omega_{p}} v_{p} \psi_{p}-\int_{\mathbb{R}^{N}} w_{p_{S}} \psi_{*}\right| & =\left|\int_{\mathbb{R}^{N}} \widetilde{v}_{p} \widetilde{\psi}_{p}-\int_{\mathbb{R}^{N}} w_{p_{S}} \psi_{*}\right| \\
& \leq\left|\int_{\mathbb{R}^{N}} \widetilde{v}_{p}\left(\widetilde{\psi}_{p}-\psi_{*}\right)\right|+\left|\int_{\mathbb{R}^{N}}\left(\widetilde{v}_{p}-w_{p_{S}}\right) \psi_{*}\right| \\
& \leq M\left\|\widetilde{\psi}_{p}-\psi_{*}\right\|_{L^{1}\left(\mathbb{R}^{N}\right)}+\left\|\psi_{*}\right\|_{L^{1}\left(\mathbb{R}^{N}\right)}\left\|\widetilde{v}_{p}-w_{p_{S}}\right\|_{L^{\infty}\left(\mathbb{R}^{N}\right)},
\end{aligned}
$$

$\forall p \in\left[q+\eta, p_{S}\right)$. It follows so by Lemma 3.6, Proposition 2.6 that

$$
\int_{\Omega} v_{p} \varphi_{p} \underset{p \rightarrow p_{S}}{\longrightarrow} \int_{\mathbb{R}^{N}} w_{p_{S}} \psi_{*}>0
$$

We can now conclude from (3.9)that there exists $1<q<\underline{p}<p_{S}$ such that if $\underline{p}<p<p_{S}$, then

$$
\int_{\Omega} h_{p} \varphi_{p}>0 .
$$

This finishes the proof.
