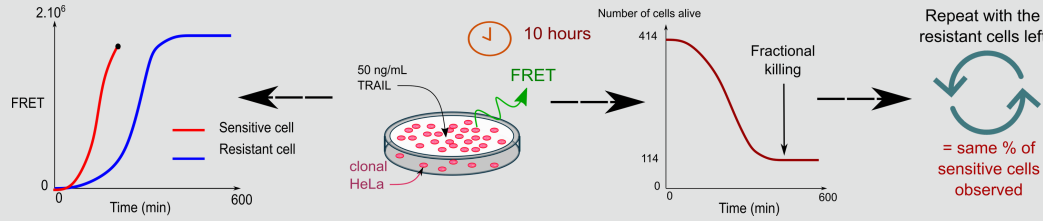

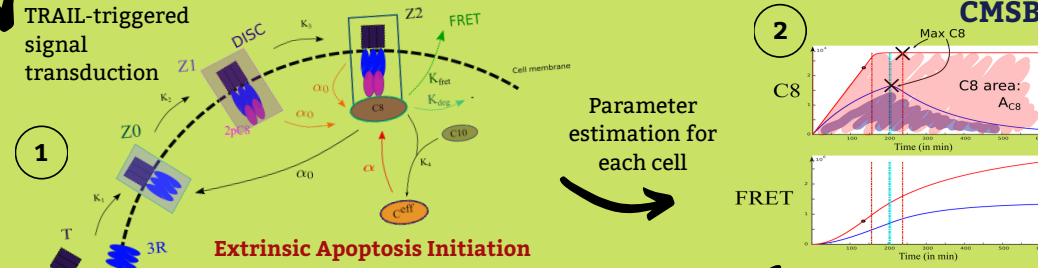

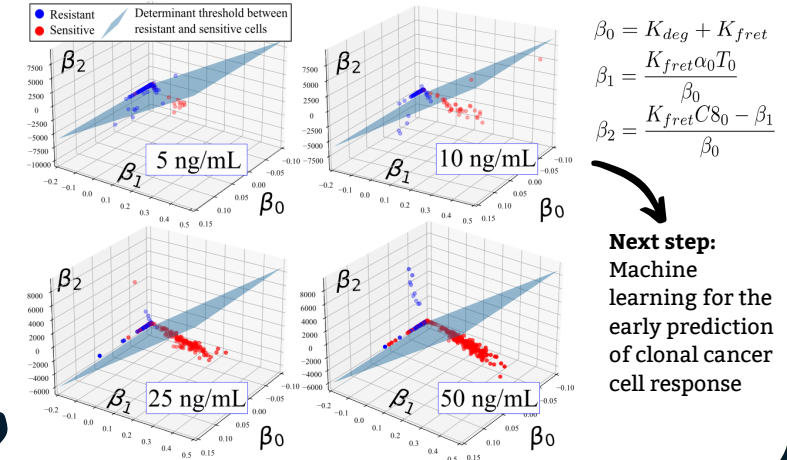
## 1 - Studying non-genetic resistance in cancer - Roux *et al.*, MSB 2015



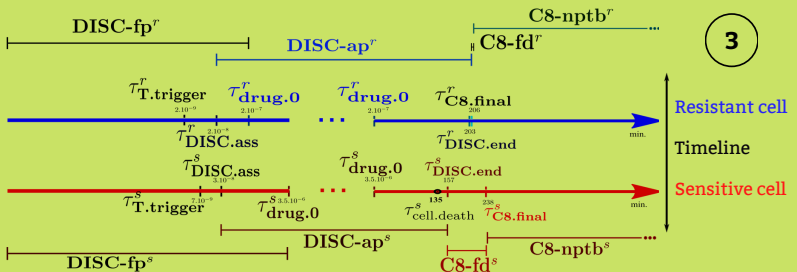
