## Millennial-timescale quantitative estimates of climate dynamics in central Europe from earthworm calcite granules in loess deposits

Ice core and marine archives provide detailed quantitative records of last glacial climate changes, whereas comparable terrestrial records from the mid-latitudes remain scarce. Here we quantify warm season land-surface temperatures and precipitation over millennial timescales for central Europe for the period spanning 45,000–22,000 years before present that derive from two temporally overlapping loess-palaeosol-sequences, dated at high resolution by radiocarbon on earthworm calcite granules. Interstadial temperatures were 1–4 °C warmer than stadial climate, a temperature difference which is strongly attenuated compared to Greenland records. We show that climate in the Rhine Valley was significantly cooler during the warm season and overall drier with annual precipitation values reduced by up to 70% compared to the present day. We combine quantitative estimates with mesoscale wind and moisture transport modelling demonstrating that this region was dominated by westerlies and thereby inextricably linked to North Atlantic climate forcing, although ameliorated.

Over the last glacial period, the climate of the Northern Hemisphere experienced numerous abrupt variations on millennial to centennial timescales. Our understanding of these changes is underpinned by the Greenland ice core<sup>1</sup> and North Atlantic marine<sup>2</sup> records; terrestrial responses and feedbacks are less well documented. Climatic variations include the Dansgaard-Oeschger cycles which comprise mild Greenland Interstadial events (GIs), defined by sudden decadal warming followed by gradual centennial cooling, bundled with Greenland stadial phases (GSs), characterized by abrupt cooling and more stable cold conditions<sup>1,3,4</sup>, as well as short-lived, particularly cold Heinrich Events which are evidenced by coarse-grained layers of ice-rafted debris preserved within North Atlantic marine sediments<sup>5</sup>. Heinrich events are associated with a significant drop in sea-surface temperatures (SST)<sup>6</sup>, are coeval with the most prominent GSs, and typically occurred towards the end of sequences of GIs of decreasing amplitude (Bond-cycles)<sup>7</sup>. These short-term climate variations were likely triggered by a sudden slowdown of the Atlantic Meridional Overturning Circulation (AMOC) and are associated with increased North Atlantic sea ice cover<sup>8</sup>.

Within the terrestrial realm, these changes manifested in the landscape and ecology, yet quantitative reconstructions of these responses elude us still. On the European continent, evidence of millennial-timescale climate variations similar to the North Atlantic and Greenland records has been observed within loess-palaeosol sequences<sup>9–14</sup>, lake sediments<sup>15–18</sup>, continental margins<sup>19,20</sup>, speleothems<sup>21–23</sup> and tufa<sup>24</sup>, yet so far quantitative data on climate parameters such as temperature and rainfall are seldom available. These limitations constrain our understanding of the different influences of Atlantic air masses or the extent of ice sheets on continental Europe in response to climatic changes<sup>25</sup>.

Here we provide quantitative estimates of temperature and precipitation for central Europe from terrestrial loess deposits at millennial-timescales comparable with the Greenland ice core and North Atlantic marine records. Compared with other terrestrial archives, loess deposits are widespread within the ca. 45–55° N latitudinal belt<sup>26–28</sup> and characterized by high sedimentation rates within which climatic information is preserved. Loess accumulation rates of up to 1 mm yr<sup>-1</sup> ensure high resolution coverage of (sub-)millennial climatic cycles, expressed in the stratigraphy by alternating stadial primary loess and interstadial palaeosol units<sup>9,11,12,29,30</sup>. The physical properties of loess sediments depend on the intensity and duration of interstadial and stadial conditions and sedimentation rates<sup>12,31</sup>; past climatic reconstruction is additionally facilitated by analysis of fossil mollusc assemblages<sup>32–38</sup>, land snail shell carbonate clumped isotope thermometry<sup>10</sup>, the isotopic signal of organic matter<sup>39,40</sup>, and lipid and plant wax biomarkers<sup>41–43</sup>.

We make use of a singular material for quantitative, high resolution palaeoclimate reconstruction from loess sediments, which can be analyzed not only as palaeothermometers<sup>44</sup> and palaeo-rainfall gauges<sup>45</sup>, but can also be directly dated using radiocarbon<sup>11,12</sup>, fossil earthworm calcite granules (ECGs). ECGs are secreted daily at the soil surface<sup>46</sup> by various earthworm species (*Lumbricus terrestris* being the most productive<sup>47</sup>), comprise rhombohedral low-Mg calcite crystals which are resistant to diagenetic alteration and experience limited vertical mixing within the loess sediment column<sup>48,49</sup>. The oxygen and carbon isotopic compositions of ECGs provide direct proxies for warm-season land-surface temperature (LSTws)<sup>44</sup> and precipitation<sup>45</sup>.

Our quantitative dataset based on coupled stable isotope composition and radiocarbon dating of ECGs provides a record of high temporal resolution, spanning 45,000–22,000 years cal BP (late Marine Isotope Stage 3 and MIS 2), from two temporally

overlapping loess-palaeosol sequences. The Schwalbenberg<sup>12,50</sup> and Nussloch<sup>11,29</sup> sequences are located c. 180 km from one another along a northwest–southeast transect in the non-glaciated zone in the Rhine River valley of western Germany and therefore reflect terrestrial responses to oscillating climates of the last glacial period for central Europe (Fig. 1). We embed our climate reconstructions within Bayesian age models for both sequences, facilitating precise correlation between both one another and with other archives from the North Atlantic region. We combine our results with continental-scale simulations of wind and precipitation trajectories for the last glacial maximum in order to more meaningfully understand potential teleconnections between continental Europe, the Fennoscandian ice sheet and the North Atlantic Ocean.

## Results

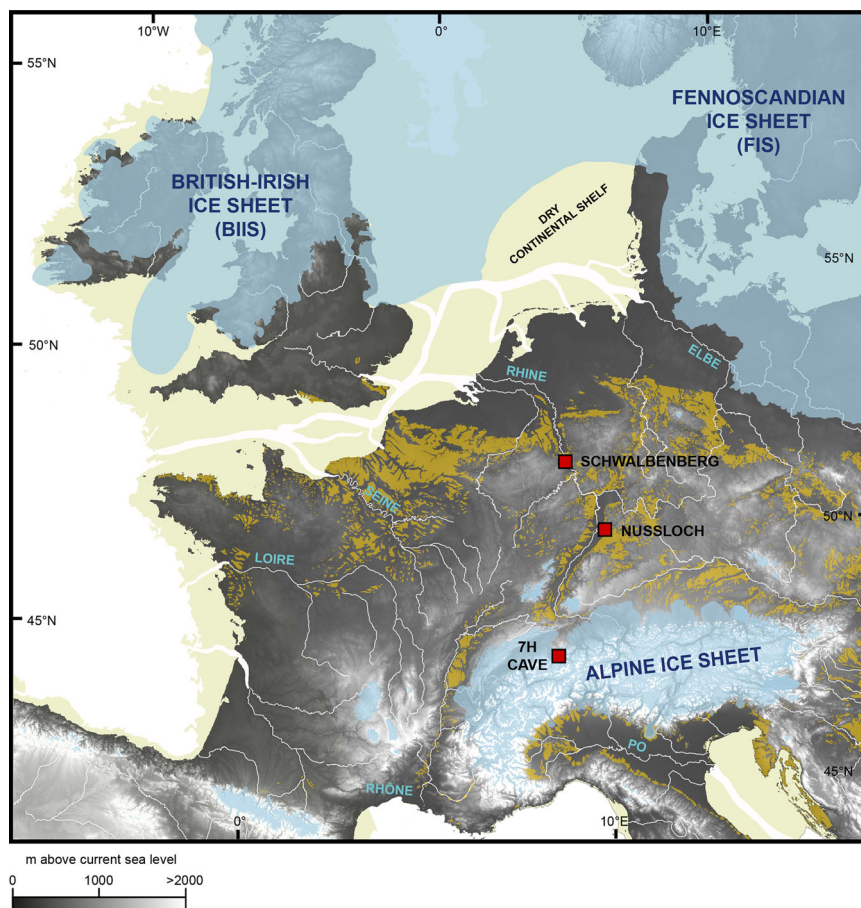
**Stratigraphy.** The Schwalbenberg profile is located on the left bank of the Rhine in its Middle Valley, at the confluence of the Rhine and Ahr rivers near the city of Remagen. The locality forms a gently south-eastward sloping plateau<sup>12,50</sup> (Fig. 1); sediment thickness reaches 30 m and spans the last Interglacial-Glacial Cycle<sup>12</sup>. The aeolian sediments at Schwalbenberg are assumed to derive from adjacent river systems and the Rhenish Massif uplands. The 6 m-thick Schwalbenberg RP1 profile is exposed on the southeastern flank of the plateau and spans late MIS 3 and MIS 2, with a distinct unconformity separating the lower from the upper part of the section. Late MIS 3 is resolved in high resolution by multiple pedocomplexes (Calcaric Cambisols) and a tundra gley, overlain by a cyclic succession of MIS 2 loess and tundra gley horizons (Fig. 2)<sup>12,50</sup>.

Nussloch is situated on the eastern margin of the Upper Rhine Valley (Fig. 1). The aeolian sediments of this locality are up to 17 m thick and are assumed to derive from local deflation of the Rhine alluvial plain to the west, accumulating at the junction between the Kraichgau and Odenwald uplands as NNW-SSE elongated ridges named “gredas”<sup>29</sup>. A combination of topography and strong northwesterly wind regimes<sup>29</sup> facilitated high dust accumulation rates at Nussloch during MIS 2. The lower 5 m dates to late MIS 3 and comprises arctic and boreal brown soils alternating with primary loess and tundra gley horizons, overlain by 12 m of MIS 2 age alternating primary loess and tundra gley layers (Fig. 3)<sup>29</sup>.

Both Schwalbenberg and Nussloch preserve evidence of periglacial and permafrost activity to varying degrees. They are situated between the Last Glacial Maximum (LGM) extents of the Alpine and Fennoscandian ice sheets. Tundra gley horizons are present at both sites and reflect short-term phases of formation and subsequent degradation of active permafrost layers<sup>29</sup>. During GI 6, a Calcaric Cambisol developed at Schwalbenberg, coeval with tundra gleys at Nussloch, suggesting that permafrost features were significantly weaker at Schwalbenberg compared to Nussloch, possibly due to the leeward position and southerly aspect of the former.

**Age-depth models and temporal resolution.** Our chronologies for both Schwalbenberg (RP1, Fig. 2) and Nussloch (NUSS P8, Fig. 3) profiles were established using radiocarbon dating of ECGs (Supplementary Data 1). We undertook Bayesian age modelling using Bacon software<sup>51</sup> (see “Methods”) (Fig. 4 and Supplementary Data 1).

Our chronology for Schwalbenberg RP1 is based on 22 dates and spans 39,963–38,162 to 22,150–21,426 cal BP (Fig. 2). We constrain the timespan of the unconformity between units 12 and 13 as a ~5 ka hiatus spanning 30,970–30,199 to 24,619–23,863 cal BP. Sedimentation rates range from ~0.5 to 0.6 mm yr<sup>-1</sup> for MIS

3 and post 22 cal kBP, reaching a peak of  $2.0 \text{ mm yr}^{-1}$  between 23 and 22 cal kBP.

We undertake Bayesian age-depth modelling and calculation of sedimentation rates based on published ECG data for the Nussloch P8 profile<sup>11</sup>. Age-depth modelled calibrated dates range from 47,862–45,354 to 22,752–21,577 cal BP, showing that the Nussloch P8 profile predates Schwalbenberg RP1 by c. 7 ka (Fig. 3). Between 43 and 32 cal kBP, Nussloch sedimentation rates are comparable to those at Schwalbenberg RP1 ( $\sim 0.5$  to  $0.6 \text{ mm yr}^{-1}$ ). Short-lived peaks (up to  $1 \text{ mm yr}^{-1}$ ) in dust accumulation during MIS 2 were constrained to c. 30, 25.5, and 24 cal kBP.

**Stable isotope composition.** ECGs were collected from 5 cm thick vertical slices according to published methods, 23 samples from Schwalbenberg and 18 from Nussloch. From each sample we extracted 30 granules, measuring the carbon and oxygen isotope values on 690 individual ECGs from Schwalbenberg (Fig. 4, Supplementary Data 2, and Supplementary Fig. 1). The Nussloch record incorporates an already published stable isotope dataset (12 samples representing 360 analyses)<sup>44,45</sup>, to which an additional 180 analyses from 6 samples were undertaken (Fig. 4, Supplementary Data 2, and Supplementary Fig. 2).

At Schwalbenberg, ECGs extracted from the interstadial phases (9 samples, representing 270 analyses) yielded mean values of  $-12.5 \pm 1.0 \text{ ‰}$  for  $\delta^{13}\text{C}$  and  $-4.5 \pm 1.8 \text{ ‰}$  for  $\delta^{18}\text{O}$ . Results for samples from stadial phases (14 samples, representing 420 analyses) yielded mean  $\delta^{13}\text{C}$  and  $\delta^{18}\text{O}$  values of  $-12.2 \pm 1.0 \text{ ‰}$

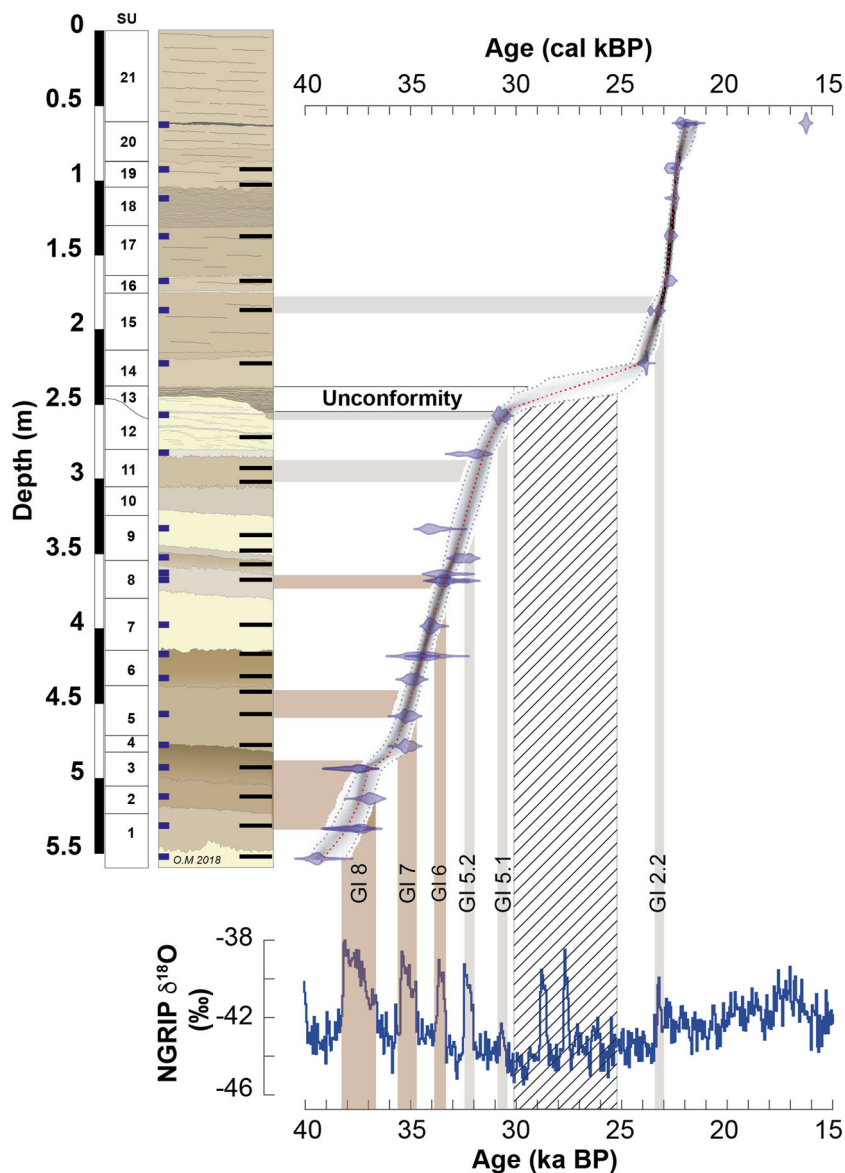
and  $-4.8 \pm 1.8 \text{ ‰}$  respectively. ECG stable isotope results are statistically different for interstadial and stadial phases; T-test results yield  $p$ -values of 0.04 and  $8.9 \times 10^{-6}$  for  $\delta^{13}\text{C}$  and  $\delta^{18}\text{O}$  respectively.

The mean carbon isotopic composition values for ECGs from Nussloch are  $-12.4 \pm 0.9 \text{ ‰}$  for interstadials (14 samples representing 420 analyses) and  $-11.7 \pm 0.9 \text{ ‰}$  for stadial phases (4 samples representing 120 analyses). Mean oxygen values of ECGs during interstadials and stadials are  $-5.2 \pm 1.9 \text{ ‰}$  and  $-6.3 \pm 1.7 \text{ ‰}$  respectively. T-test values of  $1.6 \times 10^{-15}$  and  $2.3 \times 10^{-8}$  for our mean carbon and oxygen isotope ratio values also indicate significant statistical differences between interstadial and stadial phases.

#### Quantitative estimates of terrestrial climate parameters.

Transfer functions were used to convert the ECG stable carbon and oxygen isotope compositions into estimates of annual precipitation<sup>45</sup> and warm-season land-surface temperature<sup>44</sup>.

Since the main source of carbon in ECGs derives from a mixture of litter and soil organic matter<sup>52,53</sup>, the  $\delta^{13}\text{C}$  values of plants can be estimated by accounting for the fractionation factor ( $-11.7 \pm 1.5 \text{ ‰}$ ) that results from the difference between the carbon ingested by the earthworms and that which is integrated into the ECGs<sup>54</sup>. This fractionation factor includes the carbon isotope fractionation between amorphous calcium carbonate (ACC) and calcite produced by the earthworm ( $\epsilon \text{ calcite-ACC} = -1.2 \pm 0.5 \text{ ‰}$ )<sup>55</sup>. The mean  $\delta^{13}\text{C}$  values of plants

calculated from the carbon isotope composition of the ECG at Schwalbenberg ( $-24.0 \pm 1.0\text{‰}$ ) and at Nussloch ( $-24.0 \pm 0.9\text{‰}$ ) for the period from 45 to 20 cal kBP indicate that the main source of organic matter derived from  $\text{C}_3$  plants<sup>40</sup>. Following calculation of the  $\delta^{13}\text{C}$  values of plants, we used a published empirical equation assuming a linear relationship between  $\text{C}_3$  plant leaf discrimination ( $\Delta^{13}\text{C}_{\text{plants}}$ ) and mean annual precipitation (MAP) computed by ref. <sup>56</sup> compiled from 480 modern sites<sup>57</sup> (Eq. 1).

The  $\Delta^{13}\text{C}_{\text{plants}}$  is dependent on the  $\delta^{13}\text{C}$  of plants ( $\text{‰ VPDB}$ ) and calculated from the  $\delta^{13}\text{C}$  of ECG and from  $\delta^{13}\text{C}$  values of atmospheric  $\text{CO}_2$  ( $\delta^{13}\text{C}_{\text{atm}}$ ) which were estimated from air bubbles trapped within the Vostok ice core between 50 and 20 ka<sup>58</sup>. We propagated the root mean squared error ( $\sigma = 0.14$ ) through our calculations of MAP (Supplementary Data 2).

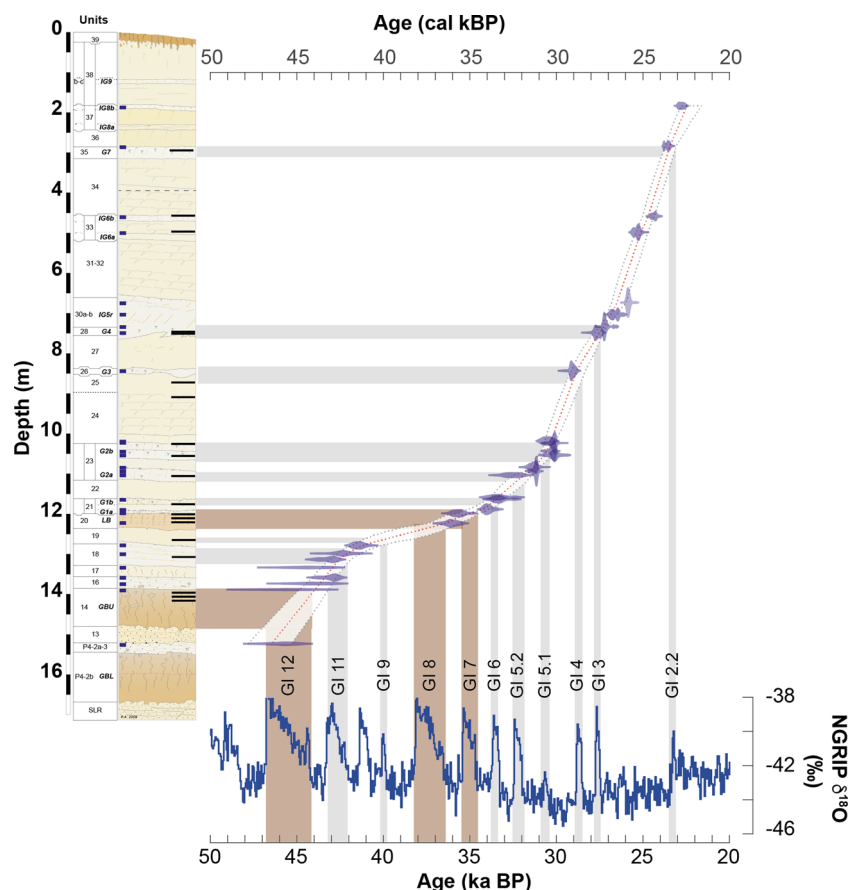
ECG oxygen isotope composition is related both to crystallization temperature and the isotopic composition of soil water<sup>59</sup>. Based on an empirical equation using observations of modern earthworm response to temperature and taking into account the vital effect (Eqs. 2 and 3)<sup>59</sup>, it then remains to identify the  $\delta^{18}\text{O}$  value of soil water in order to quantify the temperature.

T(K) and  $\delta^{18}\text{O}$  (‰V - SMOW)

Based on clumped isotope data, the  $\delta^{18}\text{O}$  values of soil water are not clearly biased toward seasonal  $\delta^{18}\text{O}$  values of meteoric water ( $\delta^{18}\text{O}_{\text{mw}}$ ) and are primarily controlled by the annual  $\delta^{18}\text{O}_{\text{mw}}$ <sup>60,61</sup>. In periglacial environment,  $\delta^{18}\text{O}$  values of soil water are likely dependent on freeze/thawing cycles. Therefore, as a first approximation, we assumed that the  $\delta^{18}\text{O}$  values of the granules

are dependant of the annual  $\delta^{18}\text{O}_{\text{mw}}$  values, which are themselves linearly dependent on mean annual air temperature at mid- to high latitudes<sup>62,63</sup>.

We established a linear equation (Eq. 4) relating mean annual weighted  $\delta^{18}\text{O}_{\text{mw}}$  to mean annual air temperature ( $T_a$ ) by compiling modern rainfall data from 80 mid-high latitude European stations from the Global Network of Isotopes in Precipitation (GNIP-IAEA) (Supplementary Data 3 and Supplementary Fig. 3):

$$\delta^{18}\text{O}_{\text{mw}} = [0.68 \pm 0.08]T_a - [14.7 \pm 0.6]; R^2 = 0.80 \quad (4)$$

To better constrain our paleotemperature estimates, we used a linear equation relating daily ground temperature ( $T_{\text{soil}}$ ) to daily air temperature ( $T_a$ ) under snow-free conditions at West Dock and Franklin Bluffs in Alaska, for the time period spanning from 1987 to 1992 as follows<sup>64,65</sup>:

$$T_{\text{soil}} = 0.89 * T_a + 3.40 \quad (5)$$

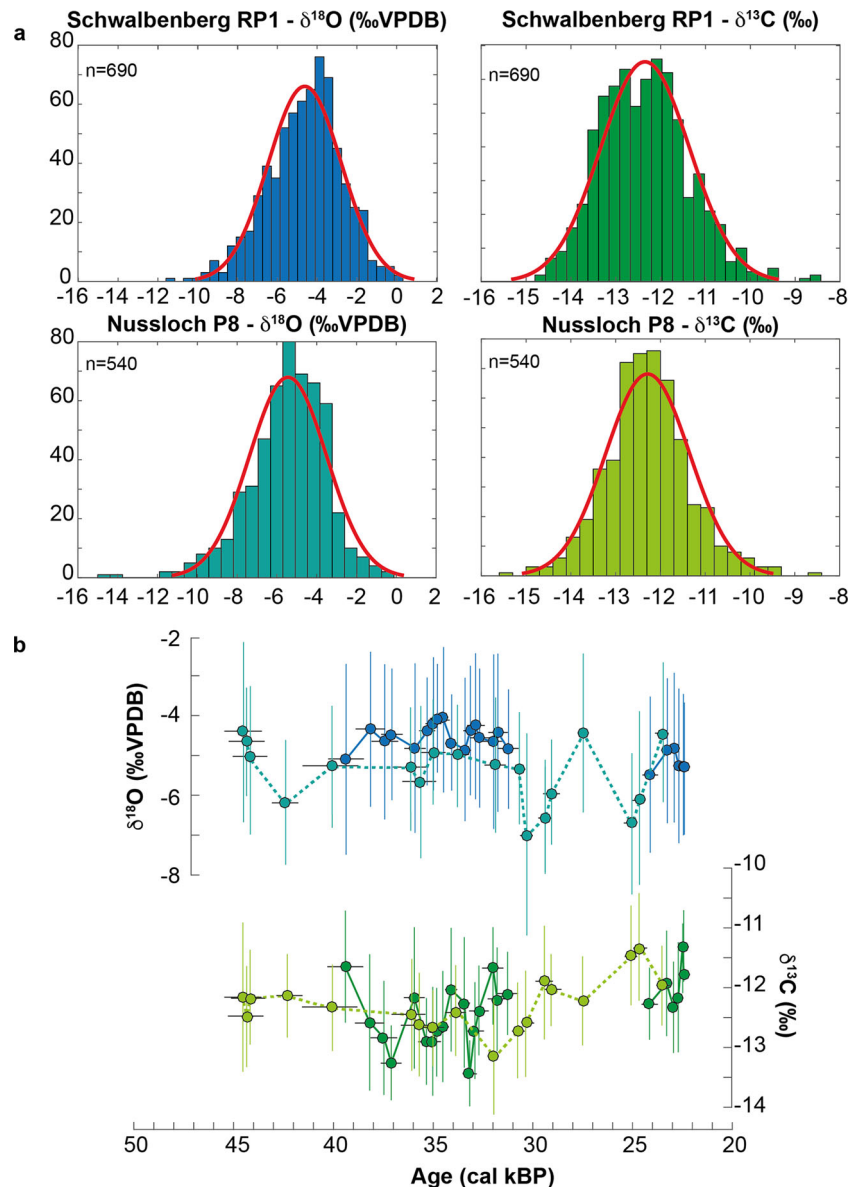
This equation is in agreement with the assumption that air temperatures are  $\sim 3^\circ\text{C}$  colder than soil temperatures (Supplementary Data 2) as is typical for present-day periglacial environments<sup>64,66</sup>.

The time interval covered in this study (late MIS 3-2) oversaw substantial changes in hemispheric ice volume and, consequently in the oxygen isotope ratios of both sea and meteoric water. These needed to be accounted for in our calculations. During MIS 3 and MIS 2, a drop in sea level between  $\sim 60$  and 120 m below the modern datum<sup>67</sup> contributed to a major reshaping of northwest European palaeogeography (Fig. 1)<sup>68</sup>. The  $\delta^{18}\text{O}$  of seawater at the

MIS 2 lowest stand was  $0.8 \pm 0.1\text{‰}$ <sup>69</sup>; we took MIS 3  $\delta^{18}\text{O}$  values to be intermediate between MIS 2 and the Holocene ( $0\text{‰}$ ; SMOW reference)<sup>70,71</sup> and assume a value of  $0.5\text{‰}$ .

We calculated land-surface temperatures for the season of greatest ECG production by estimating the  $\delta^{18}\text{O}$  values of meteoric water (Eq. 4), taking into account the ice volume effect and by combining Eqs. (2), (3), (4) and (5). Since earthworms produced ECGs during the active layer thawing season<sup>49</sup> (May to September, the five warmest months of the year; data from Global Terrestrial Network for Permafrost <http://gtnpdatabase.org>), we propose that the oxygen isotope composition of ECGs records LSTs rather than mean annual land-surface temperature (LST). We reported the distribution of the 30 values for each sample of 5 cm thick at  $1\sigma$  (Fig. 5).

At Schwalbenberg, LSTs range from  $8.8 \pm 4.7$  to  $12.9 \pm 3.3^\circ\text{C}$ , and MAP values from  $215 \pm 172$  to  $518 \pm 270\text{ mm yr}^{-1}$  (Supplementary Data 2). Nussloch temperatures were cooler ( $5.0 \pm 6.7$  to  $12.0 \pm 5.5^\circ\text{C}$ ) but recorded comparable annual precipitation ( $224 \pm 175$  to  $490 \pm 265\text{ mm yr}^{-1}$ ) (Supplementary Data 2). The Rhine Valley is particularly cold with a mean value of  $7.3 \pm 4.7^\circ\text{C}$  during the GS 3 (26–25 ka), a stadial coeval with Heinrich Stadial 2. At Nussloch, the GS 5.1 is slightly cooler with a mean LSTs of  $5.0 \pm 6.7^\circ\text{C}$ . The timing of the warmest summer phases varies between the two sites; the warmest temperatures occurred at Schwalbenberg during GI 7 ( $\sim 35$  ka) and during GI 12 ( $\sim 45.5$  ka) at Nussloch, although it should be noted that GI 12 was not exposed at Schwalbenberg RP1. The timing of the driest conditions also varies between the sites: at Schwalbenberg these prevailed  $\sim 22$  ka (during the LGM), and at Nussloch were coeval

with the coldest phase (Henrich stadial 2). The wettest conditions occurred during the transition from GI 6 to GS 6 (~33 ka), and during GI 5.2 (32 ka), at Schwalbenberg and Nussloch, respectively. We note that apparent discrepancies in the timing of extreme values between sites reflects the lack of temporally overlapping data for the respective phases.

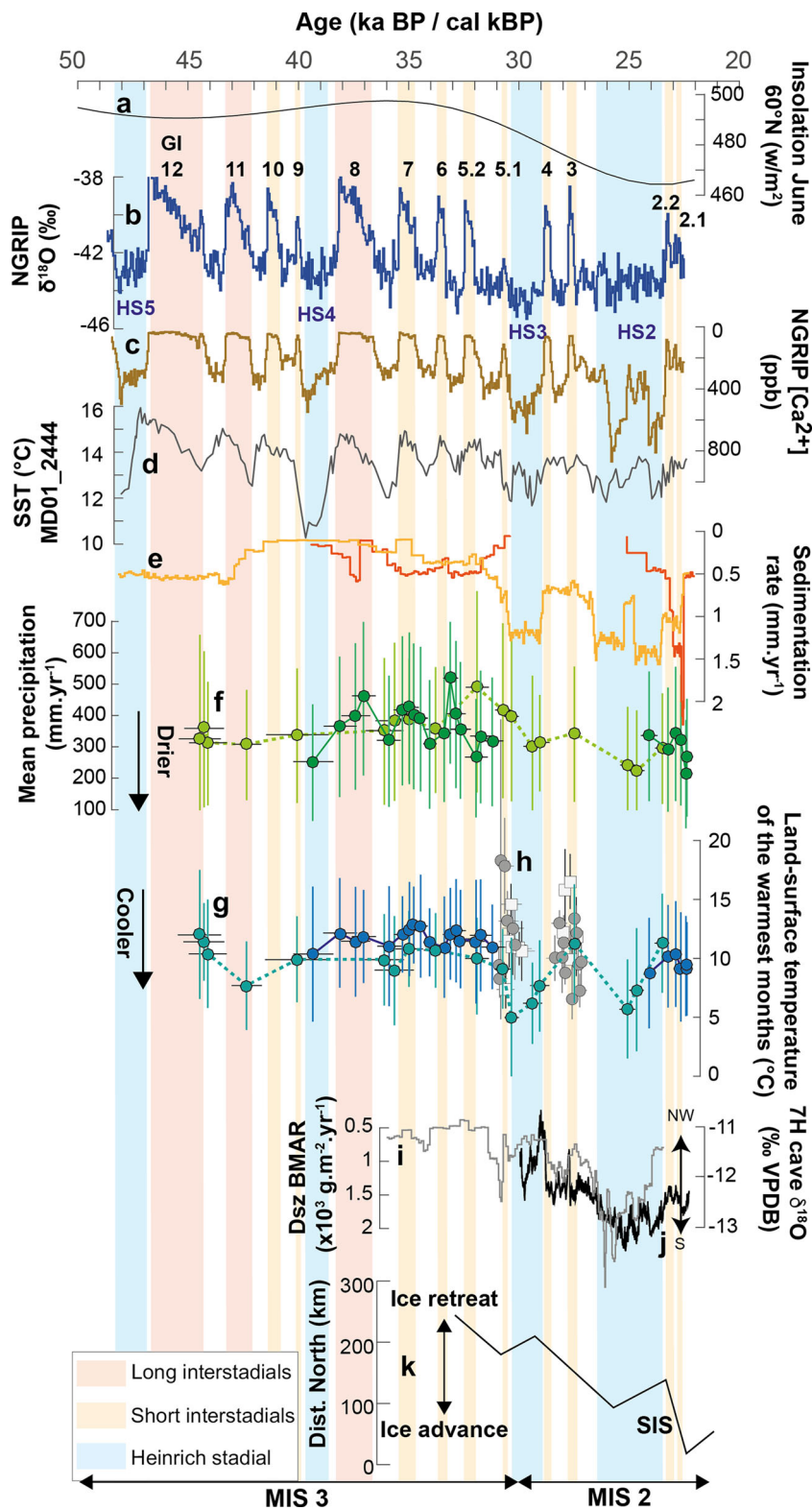
#### Climate simulations: modelling of wind and precipitation regimes.

Our simulations of wind regimes and precipitation arriving at Nussloch and Schwalbenberg were undertaken for two time slices: the present day (1989–2018) and LGM (21 ka) (Fig. 6 and Supplementary Figs. 4, 5). Our results indicate that for both time periods, the two sites experience spatial differences in general circulation and the trajectories of air masses responsible for dust transport. At Nussloch in the present day, south-westerlies prevail throughout the year, with reduced wind intensities in the summer months and steady winds in the winters; during the

LGM, north-westerly and southerly winds dominated which were steady in summer. By contrast, Schwalbenberg presently experiences more unstable, stronger, predominantly south-westerly winds, with higher speeds in autumn and winter; by contrast, during the LGM only summer west/north-westerly winds were comparable with the present day in intensity and steadiness, with easterlies more pronounced in other seasons (Fig. 6 and Supplementary Figs. 4, 5). LGM precipitation derived from south-westerly air masses at Schwalbenberg, whereas at Nussloch, precipitation derived from westerlies.

#### Discussion

Previous studies have demonstrated that the Schwalbenberg<sup>12,72,73</sup> and Nussloch<sup>11,14,29,34,49,74</sup> sequences preserve stadial-interstadial climate variability at high temporal resolution. Our new age modelling and geochemical data, combined with wind regime modelling for the present day and LGM time slices, provide the first



opportunity to meaningfully investigate terrestrial palaeoclimate change in central Europe over millennial timescales. Our quantitative climatic estimates are derived from in situ ECG response to contemporary conditions at the land surface and are therefore independent of sedimentation rates or direct wind transport vectors. As such, they provide insights into terrestrial climate parameters at sufficiently high resolution for comparison with other archives from Europe and the North Atlantic region (Fig. 5).

Our estimations for the period 45.5–22.5 cal kBP indicate temperatures 3.3–11.8 °C cooler and significantly drier conditions than experienced in the present day (Table 1). Modern (1961–1990) warm season mean temperatures at Schwalbenberg and Nussloch are 16.2 and 16.8 °C and modern rainfall is 654 and 784 mm yr<sup>-1</sup> respectively<sup>75</sup>. During the last glacial period, the northern site of Schwalbenberg yields higher LSTws than Nussloch throughout, which may be attributed to local

influences such as the south-facing aspect (i.e., insolation was more intensive at this locality). We observe comparable mean annual precipitation values and variability throughout the investigated time period at both Schwalbenberg and Nussloch, with Nussloch being even drier over the entire period covered (Fig. 5).

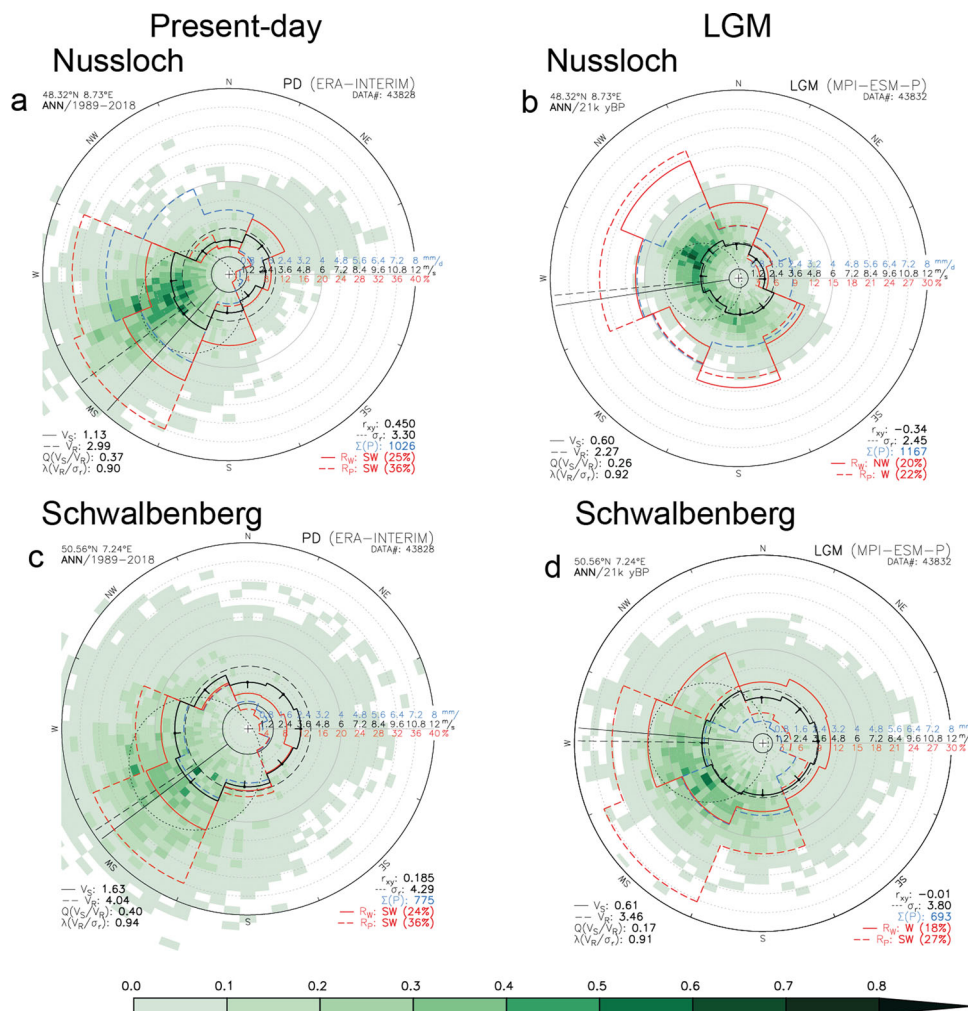
Overall, MIS 2 was c. 2.5 °C cooler than late MIS 3 at both sites and is interpreted to relate to the global cooling towards the LGM (Fig. 5). We are aware that uncertainties associated with our quantitative estimates of climate parameters are sizeable (Supplementary Data 2, “Methods”). Nevertheless, statistical tests (T-test) are showing that the mean values of LSTws between MIS 3 and MIS 2 are statistically different at both site (Supplementary Table 2). Our estimates are in agreement with other (lower resolution) quantitative estimates for past climate parameters in terrestrial central Europe based on palaeoecological transfer functions (malacofauna<sup>35,37,38</sup>, chironomids<sup>76</sup> and diatoms<sup>77</sup>, biomarker-based studies<sup>78,79</sup>), stable isotope composition of loess carbonates<sup>44,80</sup> and of large mammal remains<sup>81</sup> which provide mean temperatures for the warmest season ranging from 14 to 8 °C during MIS 3 and MIS 2. We suggest that the milder climatic fluctuations observed in the terrestrial mid-latitudes were driven at multiple scales by insolation and local topography. At local scales, direct insolation may have led to comparably high local summer temperatures, even during colder periods (MIS 3 stadials). Our mean annual precipitation estimates for the Rhine valley are consistent with the precipitation values modelled by the BIOME 4 inverse model simulation using  $\delta^{13}\text{C}$  of soil organic matter<sup>39,74</sup>, revealing driest (and coldest) values for the LGM. In comparison, the late MIS 3 was characterized by wetter conditions. Observations of palaeosol development indicate increased vegetation density at both sites at this time and agree with vegetation changes indicated by the Schwalbenberg and Nussloch mollusc fauna<sup>73,82</sup>, Nussloch biomarker-based studies<sup>43</sup> as well as palaeoecological reconstructions from the nearby Eifel maar lakes<sup>15,17</sup> and Bergsee<sup>18</sup>.

At millennial-timescale, our data show that the stadial phases in the Rhine Valley were on average 1–4 °C cooler during summer and significantly drier with less than half of the interstadial precipitation (Fig. 5, Supplementary Data 2). The lowest MAP estimates occurred during GS2.1 at Schwalbenberg and during GS3 at Nussloch with precipitation reduced by 67 and 71% respectively from present-day averages. The amplitude of ~10 °C difference between temperature from the coldest stadials (GS 3) and today in the Rhine Valley is in agreement with groundwater noble gas records which indicate a 7–10 °C terrestrial cooling at 40°N during the LGM<sup>83</sup>.

The interstadial between the Heinrich Stadials 2 and 3 (GI 3) recorded warmer temperatures (11.3 ± 5.0 °C) at Nussloch, a

phase which was characterized by abrupt warming in the Greenland region<sup>84</sup> (Fig. 5). We compare our estimates with growing season temperatures based on clumped isotope data from land snails in the Dunaszekcső loess profile of southern Hungary. The interstadials GI 5.1 and GI 3 were 7 °C warmer than at Nussloch<sup>10</sup>. A cooling between 4 and 7 °C was quantified for the stadial phases during 31–26.5 cal kBP<sup>10</sup>, suggesting a more continental climate in eastern Europe than central Europe during the last glacial period. This might be due to the more eastern and southern air mass influences in eastern Europe compared to central Europe which is mostly influenced by North Atlantic climate and the westerlies<sup>85</sup>. Continental response at the transition from stadial to interstadial condition in Europe was—within dating uncertainties - both rapid and synchronous, albeit not as pronounced as in the Greenland (+10 to 15 °C) and Mediterranean Sea regions (SST: +3 to 5 °C) (Fig. 5). During MIS 2 interstadials, high concentrations of mollusc shells combined with high juvenile mortality rates suggest increasing summer temperatures with abrupt temperature decreases during the transitions into the winter season reflecting contrast in seasonality during interstadials<sup>34,86</sup>. High contrast seasonality might also influence stadial phases in the Rhine Valley, as permafrost evidence in the stratigraphy<sup>12,29</sup> suggest particularly cold winter temperatures.

Increased precipitation in the Rhine Valley is recorded between 33 and 31 cal kBP (GI 6 and GI 5.2) and is coeval with the onset of the build-up of the British Island Ice Sheet (BIIS) and the covering of the Baltic Sea by the Fennoscandian ice sheet (FIS)<sup>87</sup>. Subsequent to the rainfall increase, stepwise drying is then recorded at Nussloch over the millennia from 31 to 23 cal kBP and correlates with both a weakening of the AMOC and synchronous and rapid growth of the FIS<sup>87–89</sup>, enhancing continental effective aridity on a global scale<sup>89</sup>. The isotope composition of organic carbon along with the litho- and pedostratigraphy of the Schwalbenberg REM3 key loess-palaeosol sequence<sup>12,72</sup> documents this period of overall increasing effective aridity in the formation of thick loess deposits reaching up to 8 m (superordinate sediment unit SSU E) within an interval of approximately 5,000 years duration. This unit (SSU E) is, however, strongly eroded and truncated in the Schwalbenberg RP1 section. During this time period, the Laurentide Ice Sheet reached its maximum extent (GS 3, from 27 to 23 ka) leading to significantly reduced precipitation in north-western Europe<sup>90</sup>, which is also reflected by the absolute minimum at Nussloch. This also resulted in a southward shift of the jet stream over southern Europe<sup>85,91,92</sup> immediately preceding the LGM, suggesting a weakening of the North Atlantic Oscillation (NAO)<sup>93</sup> associated with a strengthened Siberian High<sup>9</sup> and an increase of the sea ice cover<sup>94</sup> thereby leading to a reduction of the moisture amount over the North Atlantic with a weakening of the westerlies and a cooling of the air masses. These

mechanisms have probably triggered pre-LGM aridification and cooling in the Rhine Valley.

The integration of sedimentation rate calculations (based on age-depth modelling) and wind regime reconstructions suggests that the two Rhenish sites provide contrasting information relating to atmospheric circulation. At Nussloch, dust accumulated almost continuously from 50 to 20 cal kBP and reach peaks during Heinrich stadials 3 and 2 from 30 to 23 cal kBP. The timing of Nussloch peak sedimentation rates was coeval with dust peaks in the Greenland ice cores and suggest periods of stronger winds and drier conditions at Nussloch, likely to indicate phases of significant transitions in Northern Hemisphere wind regimes (Fig. 5). This trend is also observed in eastern Europe from the Dunaszekcső loess-palaeosol profile<sup>9</sup>. During this time period, the sedimentation rates of both Nussloch and Dunaszekcső loess sequences correlated with the oxygen isotopic composition of the Sieben Hengste Cave (7H) used to reconstruct changes in moisture sources in the Alps<sup>21</sup>, implying that the increased dust deposition over western and eastern central Europe was caused by large-scale atmospheric re-organization<sup>9</sup> (Fig. 5). By contrast, the

Schwalbenberg RP1 section located down slope at the rim of the plateau was prone to erosion at c. 25 cal kBP removing sediments that would cover the period 30–25 cal kBP (Fig. 5). However, it is important to note that this period is characterized by a significant increase of the sedimentation rates in the REM 3 core located in the interfluvial position<sup>12,72</sup>.

Our combined geochemical and climate modelling results indicate that not only westerly but also southwesterly and northwesterly winds were responsible for LGM moisture transported into the Rhine Valley, and that the steadiness of the dominant winds varied significantly between the seasons (Supplementary Figs. 4, 5). Our wind and precipitation reconstructions for the present day and LGM time slices primarily reflect changes to the general circulation pattern: the hemispheric extent of the extratropical jet, and typical location and intensity of (anti)cyclonic systems. We assume that the general circulation pattern is important for identifying dust and atmospheric moisture transport pathways<sup>85,95</sup> (Fig. 6 and Supplementary Figs. 3, 4). During the LGM, the main source of moisture to the Rhine Valley derived from the westerlies (SW

and NW), which may have been weakened during phases of ice sheet volume expansion due to a reduction of evaporation over the North Atlantic Ocean and associated westward expansion of the high-pressure centres over the BIIS and FIS. Cooler and drier conditions during such episodes (GS) are also likely to have affected seasonality by shortening warm seasons (Figs. 5, 6 and Supplementary Figs. 4, 5).

To conclude, this study generates new millennial-timescale quantitative terrestrial climate estimates for the Rhine Valley, in central Europe. We see our approach as a first step towards setting up spatially widely distributed data on land-surface temperatures based on ECGs derived from loess-palaeosol sequences, which can be compared with other methods such as land snail shell carbonate clumped isotope thermometry. Our air circulation models for the present-day and LGM time slices help us contextualize the impact of extreme climate phases on terrestrial environments. Our dataset hints at significant correlation between changes in sea ice cover and extent of periglacial aeolian environments (such as the Rhine Valley deposits) over continental Europe during the second half of the last glacial period. Although the correlation between temperature and precipitation recorded within the Rhine Valley with higher latitude ice sheet dynamics suggests a passive, and more moderate response to hemispheric climate drivers, such environments provide an appropriate and quantitative illustration of changes occurring during abrupt climatic transitions. Overall, we observe comparable trends between loess records from western and eastern central Europe and isotopic proxies from the Greenland ice cores confirming that the Schwalbenberg and Nussloch and archives from central Europe were directly influenced by changes in the North Atlantic climate during the last glacial period.

## Methods

**Sampling strategy.** Continuous columns of 10 litres samples were taken throughout the 5.5 m-thick Schwalbenberg profile RP1 at Remagen and throughout the 17 m-thick profile P8 at Nussloch. Schwalbenberg RP1 is located immediately at the northern edge of a former archaeological excavation site<sup>12,96</sup>. Nussloch P8 is situated about 50 m southeast of the reference profile P4<sup>29</sup>. Before sampling, we refreshed and cleaned both sections by removing vertically about 50 cm of sediments. ECG were sampled at 5 cm resolution by collecting 10 l of sediments. After wet sieving at 0.5 mm, ECG with a diameter larger than 0.8 mm were extracted under a binocular microscope. For stable isotope analyses, we selected 23 samples throughout the profile RP1 at Schwalbenberg (Supplementary Fig. 1). For Nussloch profile P8, we analyzed 7 new samples (each 5 cm thick) that we added to the 11 previously published<sup>44,45</sup> for this profile (Supplementary Fig. 2). ECGs were selected from tundra gley units and brown soil horizons and loess units.

**Radiocarbon dating.** Sample preparation and radiocarbon analysis protocol followed the procedure as described by ref.<sup>11</sup>. After cleaning the ECGs by ultrasonic bath, 100 µg (gas source) or 1000 µg (solid source) per dating sample were crushed in an agate mortar. All samples were then leached with 0.01 M HNO<sub>3</sub> at room temperature for 30 min and rinsed with Milli-Q water to remove superficial contamination and to oxidize any remaining organic matter. Samples are then introduced into the bottom of a two-fingers reactor and 1 cm<sup>3</sup> of pure H<sub>3</sub>PO<sub>4</sub> is added into the lateral reservoir. The reactor with the wet sample and H<sub>3</sub>PO<sub>4</sub> is then connected to the semi-automated vacuum line<sup>97</sup>. The sample is finally dried on the line, and the reactor is manually rotated to pour H<sub>3</sub>PO<sub>4</sub> onto the samples. Subsequent steps (reduction for solid source and physical measurement) are either performed by the Laboratoire de Mesure du Carbone 14, Saclay<sup>98</sup> (LMC14, lab code SacA) on a traditional large AMS or by the <sup>14</sup>C research group of the LSCE, Gif-sur-Yvette (lab codes GifA for chemistry and ECHO for physical measurement) on both solid and gas source of the ECHO MICADAS<sup>99–101</sup>. To control the impact of chemical treatment and of the combustion, “blank” and international standards were run. Results are expressed in F<sup>14</sup>C as recommended by Reimer et al.<sup>102</sup> and provided as <sup>14</sup>C ages (BP) following Stuiver and Polach (1977)<sup>103</sup> convention (Supplementary Data 1). Replicates and triplicates from six samples of 5-cm thick in RP1 have been performed to check the reliability between the two methods, the gas source using 10 times less materials (Supplementary Data 1).

**Age-depth models and sedimentation rates.** The chronologies of Schwalbenberg and Nussloch profiles were determined using radiocarbon analyses on ECG (Figs. 2, 3 and Supplementary Data 1). We derived age-depth models using the software BACON 2.2<sup>51</sup> based on Bayesian statistics. For Nussloch, we selected the radiocarbon ages (29 samples) of the profile P8 as age control points prior to running the Bayesian age model. For Schwalbenberg, the model is based on 23 age control points. On average, at Schwalbenberg, the resolution of one radiocarbon sample is about every 20 cm whereas at Nussloch the resolution is about every 60 cm. Probability distributions of calibrated radiocarbon ages were generated using IntCal20<sup>104</sup> in the Bacon code  $cc=1$ . In Bacon programme<sup>51</sup>, two prior distributions (gamma distribution for the accumulation rate and beta distribution for the accumulation memory) are constrained. We used the default values: *accumulation (acc).shape*=1.5 for the gamma distribution; *memory(mem.)mean*=0.7 and *mem.strength*=4 for the beta distribution. The mean accumulation rate was changed to 50 yr cm<sup>-1</sup> according to information available from calibrated <sup>14</sup>C dates and we run our sequences with 50 and 135 sections respectively for Schwalbenberg and for Nussloch. We choose a resolution of 5 cm for the age-modelling to obtain an individual age for each stable isotope sample. The age-modelling data are compiled in the Supplementary Data 1. The sedimentation rates for both profiles were calculated based on age modelling output at 5 cm resolution.

**Stable isotope analysis of earthworm calcite granules.** We followed the procedure for the extraction of the ECGs and the preparation protocol from refs. <sup>44,45</sup>. After cleaning in an ultrasonic bath with deionized water (2 times 5 min), thirty ECGs were extracted from each layer for stable isotope analysis based on the absence of impurities and the well-preserved surface crystals. We performed 180 (30 times 6 layers of 5 cm thickness) and 690 (30 times 23 layers of 5 cm thickness) stable isotope analyses for Nussloch and Schwalbenberg, respectively. Individual granules were crushed, and an aliquot between 200 and 300 µm of carbonate powder was digested with phosphoric acid at 70 °C. The liberated CO<sub>2</sub> gas was analyzed using a Thermo Finnigan GasBench II preparation device interfaced with a Thermo Delta V advantage mass spectrometer at the Max Plank Institute of Chemistry in Mainz. All δ<sup>13</sup>C and δ<sup>18</sup>O values are reported on the Vienna-Pee Dee Belemnite (V-PDB) scale. The long-term standard deviation of a routinely analyzed in-house CaCO<sub>3</sub> standard was <0.1‰ (1σ) for both carbon and oxygen isotope ratios. The CaCO<sub>3</sub> standards are calibrated using NBS19, NBS18 and IAEA 603. The data are reported in Supplementary Data 2.

**Limits and uncertainties for the quantification of the climate parameters and temporal resolution of age models.** The uncertainties of our method are related to sampling, chronology, representativeness and the past precipitation and temperature estimations. The two profiles (Schwalbenberg RP1 and Nussloch P8) have been sampled at 5 cm resolution which represents between 50 and 150 years and the ECGs were extracted from 10 l of sediments (~15 kg of sediment). By taking 15 kg of sediment, we reduce the uncertainties associated with the distribution of ECGs inside one sample of 5 cm thickness. Furthermore, ECG concentration is well correlated with the loess palaeosol pedostratigraphy in Northern France<sup>48</sup> and in the Upper Rhine Valley<sup>49</sup>.

Age-depth modelling is based on 28 and 29 radiocarbon analyses for Schwalbenberg and Nussloch, respectively (Supplementary Data 1). The uncertainties for radiocarbon analysis are in the same order as the maximal counting errors in the NGRIP GICC05 chronology<sup>3</sup>.

Today earthworms daily produce granules when they are active. We assumed that during the last glacial period, earthworms were active during the warmer half of the year from May to September<sup>49</sup>. The concentrations of the granules (per sediment volume) produced by *Lumbricus terrestris* during the last glacial period is low compared to present-day data<sup>46</sup>. This might be due to either lower productivity of the earthworms because of climate conditions or lower earthworm populations or both. Experiments are still necessary to better constrain parameters that mostly influence the granule production.

We extracted and analyzed 30 individual granules per sample for the stable isotope analyses (one sample is thus made of 30 replicates) to be as representative as possible. To estimate the precipitation, we used a modern dataset between δ<sup>13</sup>C of C<sub>3</sub> plants and MAP so we assumed that this relation did not change during the last glacial period. We calculated and propagated the root squared error through our estimation of the MAP (Fig. 5 and Supplementary Data 2). The distribution of 30 replicates for each sample of 5 cm-thick are sizeable. However, the comparison between the mean values of MIS 3 and MIS 2 are significantly different at both sites (Supplementary Table 1).

To estimate the past temperature, we used a fractionation equation that took into account the vital effect of the earthworms<sup>59</sup>. Based on clumped isotope data<sup>60</sup>, we assumed that the δ<sup>18</sup>O value of soil water is not seasonally biased. Soil water evaporation is unfortunately not possible to quantify over past period, thus we did not take into account this parameter in our equation. Moreover, to estimate the δ<sup>18</sup>O value of the rain we used modern data and assumed that present-day δ<sup>18</sup>O-T gradients are also valid under glacial climate conditions (Supplementary Fig. 3 and Supplementary Data 3). We corrected the data for -0.5 and -0.8‰ according to the method developed by ref. <sup>81</sup>. We reported the distribution of the 30 values for

each sample of 5 cm thick at 1σ. The uncertainties are sizeable (Fig. 5) however, the T-test indicated that the LSTws mean values are significantly different between Schwalbenberg and Nussloch and between MIS 3 and MIS 2 (Supplementary Table 1).

We should be aware that both methods give us a first approximation of climate parameter estimates.

**Wind dynamics model reconstructions.** Wind and precipitation statistics are derived from the instantaneous values of 10-metre winds and total precipitation sampled at 6-hourly (synoptic) intervals from continuous 30 years output of the respective atmospheric general circulation model products. For the present-day conditions, we use the output of the ERA INTERIM reanalysis<sup>105</sup> at 1° by 1° horizontal resolution covering the 1989–2018 period. Note that reanalysis precipitation data are based on forecasted fields. For the LGM conditions, we use the output of the MPI-ESM-P model (simulation r1i1p1-P, approx. 1.88° horizontal resolution) participated in the Climate Model Intercomparison Project, Phase 5 (CMIP5). MPI-ESM-P combines the coupled general circulation models for the atmosphere ECHAM6 and ocean MPIOM and the land surface model JSBACH with vegetation cover prescribed to pre-industrial reconstructions<sup>106</sup>. LGM climate simulated in MPI-ESM-P compared well with to date available proxy data<sup>107</sup>. Values are sampled in respective model grid cells without interpolation.
