 10 occurrence and abundances for each zone of the wasteland site. No rare or endangered species  
 11 were reported. The size of Orthoptera and diurnal Lepidoptera communities was assessed by  
 12 semi-abundance coefficients: - was for one specimen, + was for two to five specimens, ++ was  
 13 for six to twelve specimens, +++ was assigned when a species reached at least thirteen  
 14 specimens.

22 considered to have a significant impact on soil quality.

Fig. S1. Wasteland of the glass industry characterized by a well-vegetated ecosystem. Southern view taken in July 2019.



