8 The role emotions play in the dynamics of cultural phenomena has long been neglected. ## 14 Main text

Which role do emotions play in the dynamics of cultural phenomena? Upon reading the superb 15 collection of articles gathered by Chentsova-Dutton (2020), one cannot but agree that emotions 16 17 are, as Rimé nicely puts it, 'at the service of cultural construction' (Rimé, 2019). Emotion 18 programs are thought to have evolved to respond to recurrent problems faced by early members 19 of our lineage, and which enabled them to respond to challenges and strive in ancestral environments (Tooby & Cosmides, 2008). In this light, they allow individuals to take into 20 21 account what is *relevant* for them in their environment (Sander, 2013), whether because the event is of 'biological significance' (LeDoux, 1989) to them, or that it passes their 'novelty 22 check' (Scherer et al., 2001). The biological and social significance of emotions is even greater, 23 when one considers that they are often associated with facial (Ekman, 1997), bodily (De Gelder, 24 2006; Grèzes et al., 2007, 2013), vocal (Sauter et al., 2010), verbal (Devillers & Vasilescu, 25

2003) and even chemosensory signals (De Groot et al., 2014), which can in turn be picked up by members of the audience (Dezecache et al., 2013), through so-called emotional contagion or emotional transmission (Dezecache et al., 2015). This process then facilitates learning about features of our environment and solutions that can be used to deal with them, through associative learning (Olsson et al., 2020). In humans, ostensive communication (sensu Sperber & Wilson, 1987) also facilitates the mutual recognition of solutions to recurrent problems and their integration in publicly acknowledged group-specific behavioral repertoires (Kashima et al., 2020). The attractive character of solutions (and the emotions they trigger in individuals observing them) act as a force that selects cultural solutions over others, and actively transform behavioral repertoires (Eriksson & Strimling, 2020).

While we overall agree that the above-mentioned process actively participates in the construction and maintenance of cultural phenomena, at least two important aspects remain unanswered and threaten the usefulness of such theoretical narrative. First, signals associated with the experience of emotion (which may inappropriately be called 'emotional signals') are probably only contingently read-outs of the affective state expressers experience (Crivelli & Fridlund, 2018, 2019). Indeed, environmental challenges cause emotions in individuals which can then be shared with other members of a community (Kashima et al., 2020; Rimé, 2019), provided there is a match between the emotion being felt and associated expressive displays (Dezecache et al., 2013, 2015). This is never guaranteed. 

47 Second, this narrative is certainly very informative with regards to explaining the current 48 functioning of cultural phenomena in humans, and contributing to a comprehensive account of 49 what human culture is, yet, it remains desperately silent about the origin of culture and how 50 emotions may have themselves helped in setting cultural evolution in motion, beyond modern

humans. We understand this is a different question from the one posed in Rimé (2019) and Kashima et al. (2020). This question though has an important epistemological virtue: it invites to parsimony. We reckon this is a valuable exercise for it can reveal the necessary conditions for the emergence of cultural phenomena and ignoring more incidental features. This could eventually help provide a parsimonious answer to the question of which psychological elements are necessary for a species to show culture, or for culture to appear at all. Finally, it can illuminate the role of emotions in early forms of culture.

Modern humans (Homo Sapiens) have only been around for a few hundred thousand years in their behaviorally modern form (Powell et al., 2009). Among the small subset of species under scientific study, humans are not the only one that show forms of culture, or group-specific behaviors that cannot be explained by genetic or environmental singularities (Whiten et al., 1999). Convergent evidence also suggests that cultural evolution (or 'dynamics', Kashima et al. 2020) is also present in some animals (Whiten, 2019), at least in limited forms, with an increasing number of cases documented in line with the increasing impact of humans on their environment (Gruber et al., 2019). Yet, the debate on animal cultures has stalled for many years, owing to often unrealistic cognitively-loaded criteria set for attributing culture to other species than humans, particularly with respect to social processes, with the bar being raised each time a particular species threatens to reach the imposed threshold (Gruber, 2020).

The consideration that chimpanzee communities display forms of culture without language and without clear signs that cultural items are being mutually acknowledged and recognized as such by community members (in other words: chimpanzees have culture, but may not know that they do) (Gruber et al., 2015) invites us to revisit the proposals of Rimé (2019) and Kashima and colleagues (2020), and appreciate that two possibilities are offered: first, neither emotional

sharing nor mutual recognition are necessary for cultural phenomena to appear; or, second, emotional sharing is present in a larger number of species than suggested, and may even provide an elegant way to come out of the conundrum of animal culture. Note that such argument can also be made regarding early hominin cultures, whose brain organization may have differed from ours (Bruner, 2018; Gruber, 2020).

The question then becomes: do emotions play any role in the emergence of non-human and early human cultural forms? Beyond the largely cognitive layer attached to modern human cultures, can these forms truly be considered 'primeval', not because of their seemingly ancestral state, but rather because of the direct impact of emotion on their development? Affective variables certainly do play a role in the display of animal cultural behavior: physiological forces like thirst, hunger and other motivational forces surely make organisms more likely to invest physical and cognitive efforts in solving environmental problems (Gruber et al., 2016). They also likely make organisms pay attention to their conspecifics when facing environmental problems, in search for solutions. In fact, the emotions of the agents - regardless of whether they are being shared or not with others - may be one of the leading forces behind social learning, as recently argued by Dukes and Clément (2017; 2019), with the novel framework of Affective Social Learning. These solutions in turn, could become cultural, without language nor mutual recognition. Elsewhere, some of us have argued that emotions provide a fertile ground to study culture and communication in non-humans (Gruber & Sievers, 2019; Sievers & Gruber, 2020). In this light, emotions may truly be one of the leading forces in the emergence of culture across species.
