# Elastic Metasurface made of elliptic shape pillars for acoustic wave focusing

#### Abstract

We numerically propose the design of a metasurface for focusing the flexural Lamb waves propagating on a plate. The metasurface consists of a line of pillars of elliptic shape with a gradient in their ellipticity. We first determine an elliptic pillar that allows the superposition of two resonances (one compresional and one bending) in order to obtain a phase shift of $2 \pi$ around the resonance. Then, the metasurface is built by chosing the ellipticity of each pillar at a given position based on the generalized Snell's law for the selected focal point. We demonstrate the capacity of this design for subwavelength focusing of the incident plane wave at any targeted point.


Keywords-Metasurface, elastic wave, focusing

## I. Introduction

Metasurfaces are sub-wavelength planar metamaterials that allow the manipulation and control of incident acoustic/elastic waves, in particular to achieve anomalous refraction and reflection scatterings. They have known a great deal of attention during the last decade, in particular for acoustic and elastic waves [1-3]. The metasurface is in general constituted by a repetition of a set of unit cells where each unit produces a specific phase shift of the incident wave such that the phase shifts of all the units span a range of $2 \pi$. Therefore, the application of a generalized Snell-Descartes law allows the realization of various functionalities in the behavior of the scattered waves. In this work, we are interested by the capacity of a pillared metasurface for the focusing of flexural Lamb waves propagating along a thin plate. The metasurface consists of a set of pillars, each producing a sufficiently high transmission and a specific phase shift of the incident wave, with a span of all the phase shifts over $2 \pi$. We recently proposed such a design exhibiting sub-wavelength focusing by using cylindrical pillars of varying heights [4]. The principle of the design consists of starting from a reference pillar where the geometrical parameters are adapted such as to superimpose two resonances of the pillar, the second bending and the first compressional modes in our case [5]. This is an essential feature of the structure because the transmission phase shift at resonance reaches $2 \pi$ which cannot be achieved with separated resonances. The functionality of the design was also demonstrated experimentally [6]. However, from a technological point of view, the fabrication of pillars with varying heights is difficult to achieve at the micro or nanoscale. Therefore, in this work, we propose a
different approach based on the utilization of pillars of elliptical shape and of constant height. In this numerical study, we show that the ellipticity can be used as the adjustable parameter to bring the bending and compressional modes in superposition. The design of the proposed metasurface consists of an array of resonant pillars of different ellipticity parameters, allowing to realize a gradient phase shift fully covering a $2 \pi$ range

## II. NORMAL MODES FOR A LINE OF IDENTICAL PILLARS

The numerical analysis was performed with the help of the finite element method (COMSOL MULTIPHYSICS). In these calculations, the plate and pillars are made of silicon and the plate thickness is $\mathrm{e}=145 \mu \mathrm{~m}$. We determine the frequencies of the lowest resonant modes, hereafter called $\mathrm{C}_{1}$ for the compressional mode and $\mathrm{B}_{1}$ and $\mathrm{B}_{2}$ for the two bending modes, as a function of the pillars parameters by calculating the transmission through a line of identical pillars. The plate is submitted to an incident antisymmetric Lamb wave $\mathrm{A}_{0}$ whose main component is out-of-plane $u_{z}$ at the frequency of 7.48 MHz , corresponding to a wavelength of $\lambda=445 \mu \mathrm{~m}$ (as discussed below, this frequency corresponds to the resonance frequency associated with the superposition of the 2 modes $B_{2}$ and $\mathrm{C}_{1}$ ). One of the parameters of the ellipse is fixed to the value $e_{1}=20 \mu \mathrm{~m}$ while the other $\mathrm{e}_{2}$ can vary along the direction of propagation of the incident wave. All the geometrical parameters are reported in figure 1.

The method we used to compute the resonances is described as follows: an oscillating force is applied normally to the surface of the plate, along a line [AB] parallel to the crystallographic direction (100) of the silicon (referred as to $x$ axis in the following) and the resulting displacements are

recorded as a function of frequency, on a line [CD] located on the other side of the pillars row. An infinite line of identical pillars is obtained by using the Periodic Boundary Conditions along the direction perpendicular to the incident wave and Perfect Matched Layers (PML) located at each end of the plate are used to avoid any reflection from the boundaries of the plate. In the explored frequency range $(0-10 \mathrm{MHz})$, the three first resonance modes manifest themselves by more or less sharp dips in the transmission curve and can be unambiguously ascribed to eigenmodes corresponding to the two first bending modes $B_{1}$ and $B_{2}$, and to the first compressional mode $\mathrm{C}_{1}$ (figure. 2). While $\mathrm{B}_{1}$ and $\mathrm{C}_{1}$ are rather insensitive to the parameter $e_{2}$ defining the elliptic shape of the pillar, $\mathrm{B}_{2}$ mode shifts rapidly toward high frequencies when $\mathrm{e}_{2}$ increases (figure 3.a). Finally, the $B_{2}$ and $C_{1}$ modes end up overlapping, at the frequency of 7.48 MHz , for the value $\mathrm{e}_{2}=50 \mu \mathrm{~m}$. (figure 3.b)
As a consequence, for this specific value of $e_{2}$ for which two resonance modes are superimposed, a span of the phase shift over $2 \pi$ can be produced by varying the ellipticity of the pillars around the preceding value.

Therefore, we can now design a gradient-phase meta-line of pillars to realize anomalous transmitted wave fronts based on the generalized Snell law:

## III. SUBWAVELENGTH FOCUSING

As an illustration of anomalous transmission, we present a structure allowing to focus a transmitted Lamb wave $\mathrm{A}_{0}$ at any point of the surface $\mathrm{M}\left(\mathrm{x}_{0}, \mathrm{y}_{0}\right)$. To do that, a line of 21 elliptic pillars spaced by $150 \mu \mathrm{~m}$ is arranged along the x direction perpendicular to wave propagation. The phase profile $\Phi(\mathrm{x})$ along this direction is determined according to the relation:

Where $\lambda=445 \mu \mathrm{~m}$ is the wavelength of the $\mathrm{A}_{0}$ Lamb mode at 7.48 MHz . The phase of the central pillar $(\mathrm{x}=0)$ is set to $-\pi$, corresponding to the strongest resonant status. The discrete theoretical phases $\Phi(\mathrm{x})$ of the 20 other pillars in the line are calculated from the previous equation as a function of their positions x and compared to the numerical calculation of the

phase as a function of $e_{2}$. A span of the phase shift over $2 \pi$ is obtained for $\mathrm{e}_{2}$ values ranging from $10 \mu \mathrm{~m}$ to $210 \mu \mathrm{~m}$. Figure 4 shows the focusing effect at a point M with coordinates $(0, F)$ where $F$ is the focal length fixed to $F=\lambda=445 \mu \mathrm{~m}$. Figure 5 shows the transmitted intensity around the focal point which highlights a significant focusing effect with a sub-wavelength FWHM ( $\sim 0.37 \lambda$ ).

## VI. CONCLUSION

We proposed a type of pillared elastic metasurface consisting of a line of gradient resonant pillars with elliptic shape base of subwavelength dimension, on a homogeneous plate, which is able to provide a $2 \pi$ phase range manipulation and high transmissions. A particularly striking advantage of this structure is that, due to their constant height, it is possible to fabricate a microscale sample using nanofabrication facilities. The experimental validation is ongoing.
