# RATIONAL MAPS WITH INTEGER MULTIPLIERS 

XAVIER BUFF, THOMAS GAUTHIER, VALENTIN HUGUIN, AND JASMIN RAISSY


#### Abstract

Let $O_{K}$ be the ring of integers of an imaginary quadratic field. Recently, Zhuchao Ji and Junyi Xie proved that rational maps whose multipliers at all periodic points belong to $O_{K}$ are power maps, Chebyshev maps or Lattès maps. Their proof relies on a non-archimedean result by Benedetto, Ingram, Jones and Levy. In this note, we show that one may avoid using this non-archimedean result by considering a differential equation instead.


## Introduction

Let $d \geq 2$ be an integer. Let $f: \widehat{\mathbb{C}} \rightarrow \widehat{\mathbb{C}}$ be a rational map of degree $d$, where $\widehat{\mathbb{C}}:=\mathbb{C} \cup\{\infty\}$ is the Riemann sphere. Consider a sequence $\left(z_{n}\right)_{n \geq 0}$ satisfying $z_{0} \in \widehat{\mathbb{C}}$ and $z_{n+1}=f\left(z_{n}\right)$ for $n \geq 0$. The point $z_{0}$ is a periodic point of period $k$ if $z_{k}=z_{0}$ for some minimal $k \geq 1$. In that case, the multiplier of $f$ at $z_{0}$ is the eigenvalue of $\mathrm{D}_{z_{0}} f^{\circ k}: \mathrm{T}_{z_{0}} \widehat{\mathbb{C}} \rightarrow \mathrm{~T}_{z_{0}} \widehat{\mathbb{C}}$.

The rational map $f$ is

- a power map if it is conjugate to $z \mapsto z^{ \pm d}$;
- a Chebyshev map if it is conjugate to $\pm T_{d}$ where $T_{d}$ is the unique polynomial of degree $d$ satisfying $T_{d}\left(z+z^{-1}\right)=z^{d}+z^{-d}$;
- a Lattès map if there exist a torus $\mathbb{T}=\mathbb{C} / \Lambda$, with $\Lambda \subset \mathbb{C}$ a lattice of rank 2 , a holomorphic endomorphism $L: \mathbb{T} \rightarrow \mathbb{T}$ and a nonconstant holomorphic $\operatorname{map} \Theta: \mathbb{T} \rightarrow \widehat{\mathbb{C}}$ such that the following diagram commutes:


Power maps, Chebyshev maps and Lattès maps are called finite quotients of affine maps by Milnor [M] and exceptional maps by Ji and Xie JX. In this note, we will use the second terminology.

As observed by Milnor in [M], if $f$ is exceptional, the multipliers of $f$ at all periodic points are contained in a discrete subring of $\mathbb{C}$, thus in the ring of integers of some imaginary quadratic field. Milnor conjectured that the converse is true. In [H1 the third author proved the conjecture when $d=2$ and in JX Ji and Xie proved the conjecture for all $d \geq 2$.

[^0]Theorem 1 (Ji-Xie). Assume that $O_{K}$ is the ring of integers of some imaginary quadratic field and $f: \widehat{\mathbb{C}} \rightarrow \widehat{\mathbb{C}}$ is a rational map of degree $d \geq 2$ whose multipliers all lie in $O_{K}$. Then $f$ is a power map, a Chebyshev map or a Lattès map.

In this note, we present their proof with a minor modification for one of the arguments. More precisely, our main contribution is Proposition 1 .

After writing this note, the third author [H2] proved the following stronger result.
Theorem 2 (Huguin). Assume that $K$ is a number field and $f: \widehat{\mathbb{C}} \rightarrow \widehat{\mathbb{C}}$ is a rational map of degree $d \geq 2$ whose multipliers all lie in $K$. Then $f$ is a power map, a Chebyshev map or a Lattès map.

## 1. ExCEptional maps

Ritt $[\mathrm{R}$ gave the following characterization of exceptional maps.
Lemma 1 (Ritt). Assume that $f: \widehat{\mathbb{C}} \rightarrow \widehat{\mathbb{C}}$ is a rational map of degree $d \geq 2$, $\phi: \mathbb{C} \rightarrow \widehat{\mathbb{C}}$ is a nonconstant holomorphic map, $\alpha: \mathbb{C} \rightarrow \mathbb{C}$ is an affine map and $\tau: \mathbb{C} \rightarrow \mathbb{C}$ is a nontrivial translation such that

- $\phi \circ \alpha=f \circ \phi$ and
- $\phi \circ \tau=\phi$.

Then, $f$ is an exceptional map.
The following generalization is essentially due to Ji and Xie (compare with JX, Lemma 2.9]).

Lemma 2. Assume that $f: \widehat{\mathbb{C}} \rightarrow \widehat{\mathbb{C}}$ is a rational map of degree $d \geq 2, \phi: \mathbb{C} \rightarrow \widehat{\mathbb{C}}$ is a nonconstant holomorphic map and $\alpha_{1}: \mathbb{C} \rightarrow \mathbb{C}$ and $\alpha_{2}: \mathbb{C} \rightarrow \mathbb{C}$ are affine maps such that

- $\alpha_{1}$ and $\alpha_{2}$ do not commute and
- $\phi \circ \alpha_{1}=f \circ \phi=\phi \circ \alpha_{2}$.

Then, $f$ is an exceptional rational map.
Proof. First, note that the affine map

$$
\tau:=\alpha_{1} \alpha_{2}^{-1} \alpha_{1} \alpha_{2} \alpha_{1}^{-2}: \mathbb{C} \rightarrow \mathbb{C}
$$

is a nontrivial translation. Indeed, the differentials of $\alpha_{1}$ and $\alpha_{2}$ are linear maps, thus commute. Therefore, we have $\mathrm{D} \tau=\mathrm{id}: \mathbb{C} \rightarrow \mathbb{C}$. In addition, $\tau \neq \mathrm{id}$ since otherwise

$$
\begin{aligned}
\alpha_{1} \alpha_{2}^{-1} \alpha_{1} \alpha_{2} \alpha_{1}^{-2}=\mathrm{id} & \Longrightarrow \alpha_{1} \alpha_{2}^{-1} \alpha_{1} \alpha_{2}=\alpha_{1}^{2} \\
& \Longrightarrow \alpha_{2}^{-1} \alpha_{1} \alpha_{2}=\alpha_{1} \\
& \Longrightarrow \alpha_{1} \alpha_{2}=\alpha_{2} \alpha_{1}
\end{aligned}
$$

contradicting the fact that $\alpha_{1}$ and $\alpha_{2}$ do not commute.
Second, observe that

$$
\phi \circ \alpha_{1} \alpha_{2}=f \circ \phi \circ \alpha_{2}=f \circ 2 \circ \phi=f \circ \phi \circ \alpha_{1}=\phi \circ \alpha_{1}^{2},
$$

so that

$$
\phi \circ \tau=\phi \circ \alpha_{1} \alpha_{2}^{-1} \alpha_{1} \alpha_{2} \alpha_{1}^{-2}=\phi \circ \alpha_{2} \alpha_{2}^{-1} \alpha_{1} \alpha_{2} \alpha_{1}^{-2}=\phi \circ \alpha_{1}^{2} \alpha_{1}^{-2}=\phi
$$

The result then follows from Lemma 1.

## 2. EsCaping quadratic-LIKE maps

An escaping quadratic-like map is a covering map $g: U \rightarrow V$ of degree 2 between open subsets of $\mathbb{C}$, with $V$ simply connected, and $U$ compactly contained in $V$. If $g: U \rightarrow V$ is such a map, then $U$ has two connected components $U_{1}$ and $U_{2}$, each of which is simply connected.
Lemma 3. If $f: \widehat{\mathbb{C}} \rightarrow \widehat{\mathbb{C}}$ is a rational map of degree $d \geq 2$, there exist an integer $n \geq 1$ and open sets $U \Subset V \subset \mathbb{C}$, such that the restriction $f^{\circ n}: U \rightarrow V$ is an escaping quadratic-like map.

We say that such a restriction of $f^{\circ n}$ is an escaping quadratic-like map associated to $f$.

Proof. Let $z_{1} \in \mathbb{C}$ be a repelling periodic point for $f$ of period $r \geq 1$ which is not contained in the forward orbit of a critical point of $f$. Let $V_{1} \subset \mathbb{C}$ be a simply connected neighborhood of $z_{1}$ such that the inverse branch $h_{1}$ of $f^{\circ r}$ fixing $z_{1}$ is defined on $V_{1}$ with $h_{1}\left(V_{1}\right) \Subset V_{1}$. Since $z_{1}$ is in the Julia set of $f$ and since the iterated preimages of $z_{1}$ are dense in the Julia set of $f$ which contains no isolated point, there exist $z_{2} \in V_{1} \backslash\left\{z_{1}\right\}$ and an integer $s \geq 1$ such that $f^{\circ s}\left(z_{2}\right)=z_{1}$. Let $V \subset V_{1}$ be a simply connected neighborhood of $z_{1}$ such that

- $h_{1}(V) \Subset V$,
- the inverse branch $h_{2}$ of $f^{\circ s}$ sending $z_{1}$ to $z_{2}$ is defined on $V$ and
- $h_{2}(V) \Subset V_{1} \backslash\left\{z_{1}\right\}$.

Let $m_{1} \geq 1$ be sufficiently large so that $W_{2}:=h_{1}^{\circ m_{1}} \circ h_{2}(V) \Subset V$. Let $m_{2} \geq 1$ be sufficiently large so that $W_{1}:=h_{1}^{\circ m_{2}}(V) \Subset V \backslash W_{2}$. Set

$$
k_{1}:=h_{1}^{\circ m_{2}}: V \rightarrow W_{1} \quad \text { and } \quad k_{2}:=h_{1}^{\circ m_{1}} \circ h_{2}: V \rightarrow W_{2}
$$

Note that $k_{1}$ is an inverse branch of $f^{\circ n_{1}}$ with $n_{1}:=m_{2} r$ and $k_{2}$ is an inverse branch of $f^{\circ n_{2}}$ with $n_{2}:=m_{1} r+s$. Set

$$
n:=n_{1} n_{2}=m_{2} r\left(m_{1} r+s\right) \quad \text { and } \quad U:=k_{1}^{\circ n_{2}}(V) \cup k_{2}^{\circ n_{1}}(V) .
$$

Then, the restriction of $f^{\circ n}$ from $U$ to $V$ is an escaping quadratic-like map associated to $f$.

## 3. Affine escaping quadratic-Like maps

An escaping quadratic-like map $g: U \rightarrow V$ is affine if the restriction of $g$ to each connected component of $U$ coincides with the restriction of an affine map.

In addition, two escaping quadratic-like maps $g_{1}: U_{1} \rightarrow V_{1}$ and $g_{2}: U_{2} \rightarrow V_{2}$ are conjugate if there exists a holomorphic isomorphism $\phi: V_{2} \rightarrow V_{1}$ such that the relation $\phi \circ g_{2}=g_{1} \circ \phi$ holds on $U_{2}$.
Lemma 4. Let $f: \widehat{\mathbb{C}} \rightarrow \widehat{\mathbb{C}}$ be a rational map of degree $d \geq 2$. If an escaping quadratic-like map associated to $f$ is conjugate to an affine escaping quadratic-like map, then $f$ is an exceptional map.

Proof. Assume that $f^{\circ n}: U \rightarrow V$ is an escaping quadratic-like map associated to $f$, that $g: U^{\prime} \rightarrow V^{\prime}$ is an affine escaping quadratic-like map and that $\phi: V^{\prime} \rightarrow V$ conjugates $g: U^{\prime} \rightarrow V^{\prime}$ to $f^{\circ n}: U \rightarrow V$, i.e.,

$$
\phi \circ g=f^{\circ n} \circ \phi
$$

By assumption, $U^{\prime}$ has two connected components $U_{1}^{\prime}$ and $U_{2}^{\prime}$ and the restrictions of $g$ to $U_{1}^{\prime}$ and $U_{2}^{\prime}$ coincide with the restrictions of affine maps $\alpha_{1}: \mathbb{C} \rightarrow \mathbb{C}$ and $\alpha_{2}: \mathbb{C} \rightarrow \mathbb{C}$ to $U_{1}^{\prime}$ and $U_{2}^{\prime}$. The relations $\phi \circ \alpha_{1}=f^{\circ n} \circ \phi$ and $\phi \circ \alpha_{2}=f^{\circ n} \circ \phi$ hold on $U^{\prime}$. Since the affine maps $\alpha_{1}: \mathbb{C} \rightarrow \mathbb{C}$ and $\alpha_{2}: \mathbb{C} \rightarrow \mathbb{C}$ are repelling, we may use any of those two relations to extend $\phi: V^{\prime} \rightarrow V$ to a global meromorphic map $\hat{\phi}: \mathbb{C} \rightarrow \widehat{\mathbb{C}}$. We then have

$$
\hat{\phi} \circ \alpha_{1}=f^{\circ n} \circ \hat{\phi}=\hat{\phi} \circ \alpha_{2} \quad \text { on } \mathbb{C} .
$$

The affine maps $\alpha_{1}$ and $\alpha_{2}$ have distinct fixed points, respectively in $U_{1}^{\prime}$ and $U_{2}^{\prime}$. Thus, they do not commute. It follows from Lemma 2 that $f^{\circ n}$ is an exceptional map, and so, $f$ is an exceptional map (a rational map is exceptional if and only if its iterates are exceptional).

## 4. The proof of Theorem 1

It follows from Lemma 3 and Lemma 4 that Theorem 1 is a consequence of the following result.

Proposition 1. Let $O_{K}$ be the ring of integers of some quadratic imaginary field. If $g$ is an escaping quadratic-like map whose multipliers at all periodic points belong to $O_{K}$, then $g$ is conjugate to an affine escaping quadratic-like map.

The proof will occupy the rest of the note. From now on, we assume that $g: U \rightarrow V$ is an escaping quadratic-like map whose multipliers at all periodic points belong to $O_{K}$. Let $U_{1}$ and $U_{2}$ be the two connected components of $U$. Set:

$$
g_{1}:=\left.g\right|_{U_{1}}, \quad g_{2}:=\left.g\right|_{U_{2}}, \quad h_{1}:=g_{1}^{-1}: V \rightarrow U_{1} \quad \text { and } \quad h_{2}:=g_{2}^{-1}: V \rightarrow U_{2}
$$

Let $p_{1} \in U_{1}$ be the unique (repelling) fixed point of $g_{1}: U_{1} \rightarrow V$ and let $\lambda_{1}$ be its multiplier. Similarly, let $p_{2} \in U_{2}$ be the unique (repelling) fixed point of $g_{2}: U_{2} \rightarrow V$ and let $\lambda_{2}$ be its multiplier.

The sequence of univalent maps $\psi_{n}: V \rightarrow \mathbb{C}$ defined by

$$
\psi_{n}(z):=\frac{h_{1}^{\circ n}(z)-p_{1}}{h_{1}^{\circ n}\left(p_{2}\right)-p_{1}}
$$

converges to a univalent map $\psi: V \rightarrow \mathbb{C}$ such that $\psi\left(p_{1}\right)=0, \psi\left(p_{2}\right)=1$ and $\psi \circ g_{1}=\lambda_{1} \times \psi$. Replacing $g$ by $\psi \circ g \circ \psi^{-1}$ if necessary, we may therefore assume that

$$
p_{1}=0, \quad p_{2}=1 \quad \text { and } \quad g_{1}(z)=\lambda_{1} z
$$

We need to prove that $g_{2}$ is an affine map.
4.1. A special sequence of periodic points. In their proof, Ji and Xie consider a particular sequence of periodic points of $g$. This sequence may be defined as follows. For $n \geq 0$, let $z_{n}$ be the unique fixed point of the map $h_{2} \circ h_{1}^{\circ n}: V \rightarrow U_{2}$. Then, $z_{n}$ is a periodic point of $g$ of period $n+1$. In particular the multiplier $\rho_{n}$ of $g$ at $z_{n}$ belongs to $O_{K}$. Note that as $n \rightarrow+\infty$, we have that

$$
z_{n} \rightarrow \alpha:=h_{2}(0)
$$

so that

$$
z_{n}=h_{2}\left(\frac{z_{n}}{\lambda_{1}^{n}}\right)=\alpha+\frac{\beta}{\lambda_{1}^{n}}+\mathrm{o}\left(\frac{1}{\lambda_{1}^{n}}\right) \quad \text { with } \quad \beta:=\alpha h_{2}^{\prime}(0)
$$

Then,

$$
\rho_{n}=\lambda_{1}^{n} g_{2}^{\prime}\left(z_{n}\right)=\lambda_{1}^{n} a+b+\mathrm{o}(1) \quad \text { with } \quad a:=g_{2}^{\prime}(\alpha) \quad \text { and } \quad b:=\beta g_{2}^{\prime \prime}(\alpha)=\alpha \frac{g^{\prime \prime}(\alpha)}{g^{\prime}(\alpha)}
$$

Lemma 5. We have that $\rho_{n}=a \lambda_{1}^{n}+b$ for $n$ large enough.
Proof. Write $\rho_{n}=a \lambda_{1}^{n}+b+\varepsilon_{n}$ with $\varepsilon_{n} \rightarrow 0$ as $n \rightarrow+\infty$. We have that

$$
\underbrace{\lambda_{1} \rho_{n}-\rho_{n+1}}_{\in O_{K}}=\left(\lambda_{1}-1\right) b+\underbrace{\lambda_{1} \varepsilon_{n}-\varepsilon_{n+1}}_{n \rightarrow+\infty} .
$$

Thus, $\left(\lambda_{1}-1\right) b$ belongs to the closure of $O_{K}$, i.e., to $O_{K}$.
Since $O_{K}$ is discrete, we have that $\lambda_{1} \rho_{n}-\rho_{n+1}=\left(\lambda_{1}-1\right) b$ for $n$ large enough, i.e., $\varepsilon_{n+1}=\lambda_{1} \varepsilon_{n}$. Since $\left|\lambda_{1}\right|>1$ and $\varepsilon_{n} \rightarrow 0$ as $n \rightarrow+\infty$, we have that $\varepsilon_{n}=0$ for $n$ large enough.

### 4.2. A differential equation.

Lemma 6. The holomorphic map $g_{2}: U_{2} \rightarrow V$ satisfies the differential equation

$$
\begin{equation*}
\forall z \in U_{2}, \quad g_{2}^{\prime}(z)=a+b \frac{g_{2}(z)}{z} \tag{E}
\end{equation*}
$$

Proof. Note that for $n$ large enough, we have that

$$
\lambda_{1}^{n} g_{2}\left(z_{n}\right)=z_{n} \quad \text { and } \quad g_{2}^{\prime}\left(z_{n}\right)=\frac{\rho_{n}}{\lambda_{1}^{n}}=a+\frac{b}{\lambda_{1}^{n}}=a+b \frac{g_{2}\left(z_{n}\right)}{z_{n}}
$$

Since the sequence $\left(z_{n}\right)_{n \geq 1}$ accumulates at $h_{2}(0) \in U_{2}$, the function $g_{2}$ satisfies the differential equation (E).

Remark. Equation $(\mathrm{E})$ is linear and so, may be easily solved. However, we shall not use the explicit form of the solutions.

Lemma 7. We have that

$$
\frac{g_{2}^{\prime}(\alpha)}{\lambda_{2}}=1+\frac{\nu}{1-\lambda_{2}} \quad \text { with } \quad \alpha:=h_{2}(0) \quad \text { and } \quad \nu:=p_{2} \frac{g_{2}^{\prime \prime}\left(p_{2}\right)}{g_{2}^{\prime}\left(p_{2}\right)}
$$

Proof. Evaluating Equation (E) at $z=p_{2}=g_{2}\left(p_{2}\right)$, we obtain

$$
\lambda_{2}=g_{2}^{\prime}\left(p_{2}\right)=a+b
$$

In addition, differentiating Equation (E), we obtain

$$
\forall z \in U_{2}, \quad g_{2}^{\prime \prime}(z)=b\left(\frac{g_{2}^{\prime}(z)}{z}-\frac{g_{2}(z)}{z^{2}}\right) .
$$

Since $\lambda_{2}=g_{2}^{\prime}\left(p_{2}\right)$ and $a=g_{2}^{\prime}(\alpha)$, we have that

$$
\nu=p_{2} \frac{g_{2}^{\prime \prime}\left(p_{2}\right)}{g_{2}^{\prime}\left(p_{2}\right)}=\left(\lambda_{2}-g_{2}^{\prime}(\alpha)\right)\left(1-\frac{1}{\lambda_{2}}\right) .
$$

This last equality may be rewritten in the required form.
4.3. Conclusion. For each integer $k \geq 1$, consider the escaping quadratic-like map $g^{k}: U_{1} \cup h_{2}^{\circ k}(V) \rightarrow V$ defined by

$$
g^{k}(z)= \begin{cases}\lambda_{1} z & \text { if } z \in U_{1} \\ g_{2}^{\circ k}(z) & \text { if } z \in h_{2}^{\circ k}(V)\end{cases}
$$

Then, all the periodic points of $g^{k}$ are periodic points of $g$ and their multipliers still belong to $O_{K}$. In addition, $g^{k}$ fixes $p_{2}$ with multiplier $\lambda_{2}^{k}$.

According to Lemma 7, we have that

$$
\frac{\left(g_{2}^{\circ k}\right)^{\prime}\left(\alpha_{k}\right)}{\lambda_{2}^{k}}=1+\frac{\nu_{k}}{1-\lambda_{2}^{k}} \quad \text { with } \quad \alpha_{k}:=h_{2}^{\circ k}(0) \quad \text { and } \quad \nu_{k}:=p_{2} \frac{\left(g_{2}^{\circ k}\right)^{\prime \prime}\left(p_{2}\right)}{\left(g_{2}^{\circ k}\right)^{\prime}\left(p_{2}\right)}
$$

A rather elementary computation (in fact, it is the composition rule for nonlinearities) yields

$$
\nu_{k}=\nu_{1}+\lambda_{2} \nu_{1}+\lambda_{2}^{2} \nu_{1}+\cdots+\lambda_{2}^{k-1} \nu_{1}=\frac{1-\lambda_{2}^{k}}{1-\lambda_{2}} \nu_{1}
$$

In particular,

$$
\frac{\nu_{k}}{1-\lambda_{2}^{k}}=\frac{\nu_{1}}{1-\lambda_{2}}
$$

does not depend on $k \geq 1$. As a consequence, for all $k \geq 1$,

$$
\frac{g_{2}^{\prime}\left(\alpha_{k+1}\right)}{\lambda_{2}} \cdot \frac{\left(g_{2}^{\circ k}\right)^{\prime}\left(\alpha_{k}\right)}{\lambda_{2}^{k}}=\frac{\left(g_{2}^{\circ(k+1)}\right)^{\prime}\left(\alpha_{k+1}\right)}{\lambda_{2}^{k+1}}=\frac{\left(g_{2}^{\circ k}\right)^{\prime}\left(\alpha_{k}\right)}{\lambda_{2}^{k}}
$$

Thus,

$$
\forall k \geq 1, \quad g_{2}^{\prime}\left(\alpha_{k+1}\right)=\lambda_{2}
$$

The sequence $\left(\alpha_{k}\right)_{k \geq 2}$ accumulates at $p_{2} \in U_{2}$. So, $g_{2}^{\prime}(z)=\lambda_{2}$ for all $z \in U_{2}$ and $g_{2}$ is an affine map as required. This completes the proof of Proposition 1 .
